20 Abstract

Active films made of chitosan and fish gelatin blends containing 5% (w/wt of polymers) of 21 tyrosol, ferulic acid or caffeic acid were prepared by the casting method. The kinetic of release 22 was assessed in water or in 1% (w/v) NaCl solution, at three temperatures (4, 25 and 32°C). 23 Partition ($K_{f/S}$) and the effective diffusivity (D) was modelled which allowed to characterize 24 the release mechanism. Tyrosol has a faster release at a higher concentration than the other 25 26 antioxidants, because of its structure and a lower level of intermolecular interactions with the biopolymer matrix. There is less effect of temperature and of the salt content on the release of 27 tyrosol contrarily to the phenolic acids. The NaCl solution (food simulant) induced 28 conformational changes in the biopolymer network due to the modifications of the interactions 29 between the gelatin, chitosan and antioxidants, inducing a less strengthen network and a faster 30 31 release.



34 **1. Introduction**

Nowadays, the shelf life of food could be prolonged by using antioxidant and barrier packaging 35 materials without a negative effect on consumers (Zhu et al., 2012). This is considered as one 36 of the promising innovative technology for food preservation able to reduce food loss (Zhu et 37 al., 2012). Natural antioxidants are incorporated into biopolymeric matrices intended to be in 38 39 contact with the food product with a very low restriction to contact ability according safety and regulation reasons (Otero-Pazos et al., 2016). Phenolic acids and tyrosol are recognized 40 effective natural antioxidants for food and pharmaceutical applications and GRAS classified, 41 mainly extracted from plants (coffee, olive oil and leaves) (Banerjee et al., 2017) and very 42 often cited for the development of sustainable active bio-based packaging films (Benbettaïeb 43 et al., 2019). 44

45 Natural biopolymers (proteins or polysaccharides) are manufactured for packaging materials. Indeed, this trend tends to satisfy the consumer demand for safe materials but also satisfy to 46 47 environmental issues by using renewable and biodegradables matters coming from agri-food by-products and wastes (Benbettaïeb et al., 2018). Chitosan is a polysaccharide with 48 biodegradable, biofunctional, and intrinsic antimicrobial properties which is able to entrapped 49 50 bioactive compounds (Moradi et al., 2012). Gelatin, is obtained from the hydrolysis of collagen collected in animal slaughterhouses and fish processing plants where collagen is considered as 51 a waste. Gelatin has excellent film-forming abilities and is able to interact with chitosan (Hoque 52 et al., 2011, Benbettaïeb et al., 2014). At appropriate pH, the gelatin and chitosan have opposite 53 charges which allow to settle ionic interactions able to strengthen and stabilize the gelatin-54 chitosan network. Chemical interaction between chitosan and gelatin was previously 55 56 demonstrated using FTIR in a previous work (Benbettaïeb et al., 2014).

57 When antioxidants are incorporated into bio-based films, they could migrate into the food or in liquid simulant. The release of these natural antioxidant in the media permits to reduce the 58 amount of chemical additives loaded in foods. Reduction of synthetic additives in food, as well 59 60 as in packaging material is sought by both the consumers and regulations. Therefore, the substitution of synthetic antioxidants by natural ones (Ma et al., 2017, Piñeros-Hernandez et 61 al., 2017), such as plant extracts (Qin et al., 2015), essential oils (Moradi et al., 2016) and 62 phenolic compounds (flavonoids, tannin and phenolic acid) is of great interest (Benbettaïeb et 63 al., 2018). The release consists of the transfer by diffusion of small molecules from the 64 65 packaging material into the food or into food simulants. Diffusivity is a molecular mechanism described by the Fick's laws, considering both an effective diffusion coefficient (D) and a 66 partition coefficient (K_{f/S}). D reveals how fast the antioxidant (=migrant) is transferred whereas 67 68 the K_{f/S}, equal to the ratio of antioxidant amount between the packaging and food (or simulant) 69 when diffusion reaches the equilibrium. Some parameters related to the food or to the antioxidant itself (polarity, solubility, hydrophobicity, pH, ionic strength, water activity..), or 70 71 related to the surroundings (temperature, pressure, relative humidity...) may affect the behavior of the antioxidant release. The polymer matrix characteristics are also strongly responsible of 72 the release mechanism such as the network mesh, its polarity, its density or crystallinity (Tapia-73 Blácido et al., 2018, Gutiérrez and Álvarez 2017). Also, chemical interactions between the 74 75 polymer chains and the antioxidant could affect the release process. Indeed, salt could induce 76 "salting-in" or "salting-out" effects with proteins, which improved the release (lower retention and faster diffusion) or reduced the release respectively (Endo et al., 2011). The aim of the 77 present work was to investigate the effect of the salt content and of the temperature of the 78 79 medium on the release kinetics of three naturals antioxidants incorporated in bio-based chitosan-gelatine films. A mathematical modelling was used in order to model the kinetics of 80 release. In this way, we chose three temperatures: 4°C as refrigeration temperature of many 81

foods, 25°C is the consumption temperature and 32°C is the ambient temperature in sub-arid
regions. The NaCl content of food simulant was chosen at 1% (w/v) corresponding to the
maximum recommended concentration of salt in foods according the European Commission
(2016).

Hypothesis: temperature and NaCl presence in food simulant affect differently the release of
tyrosol or phenolic acids from a gelatine-chitosan film.

89 2. Materials and methods

90 **1.2. Preparation of the active film**

The bioactive films were prepared according to Benbettaïeb et al,. (2018): 2 grams of chitosan 91 powder were dispersed in 100 mL of water-acetic acid solution (1% v/v) under a 6000 rpm 92 agitation (Ultra Turrax RW16 basic- IKA-WERKE) at 25°C. In the same time, another solution 93 94 of 6% (w/v) of fish gelatin powder was dispersed in water at 70°C. The two solutions were mixed at a ratio 1:1 (w/w) under stirring at 50°C. The pH was adjusted at 5.5 in order to favor 95 electrostatic interactions between the two biopolymers and to prevent phase separation. At this 96 pH, the gelatin is negatively charged (the iso-electric point of gelatin is about 4.5) while 97 chitosan is positively charged (pKa of the chitosan amino group is about 6.5). This favors the 98 ionic interactions between amino groups (-NH³⁺) of chitosan and carboxylate (-COO⁻) groups 99 of gelatin which allows to strengthen the network and thus improves the film-forming 100 properties. 101

Glycerol (plasticizer) was added at 10% (w/w of dry matter). Each antioxidant compound was
loaded in separate film-forming solution under stirring at concentration 5% (w/wt of dry
mater). 30 mL of the mixed solution was poured into plastic Petri dishes and dried at 45% RH
at 25°C for 1 day in a climatic chamber (KBF 240 Binder, ODIL, France). The films were then

peeled off from the Petri dishes after drying and stored in controlled conditions (25°C - 50 %
RH) prior analysis.

108 2.2. Methodology of the release kinetic measurement

The release kinetics of the antioxidants from the films was carried out by determining the rate 109 of migration from the biopolymer film when immersed in water or in 1% (w/v) NaCl solution 110 (food stimulant) adapted from (Benbettaïeb et al., 2018).. The release process was followed by 111 the determination of the concentration of antioxidant in the food simulant at 4, 25 and 32°C. 112 To do that, 60mg of each film sample were immersed in 100 mL of the simulant in a glass vial 113 and kept under magnetic agitation at 120 rpm. The ratio film/simulant corresponds as close as 114 possible to the regulation for migration tests described in the Directive EC/89/109 (European 115 116 Commission 1989). Then, 2 mL of the release medium were periodically sampled and the OD 117 was read until equilibrium. The 2mL sampled were returned into the simulant in order to keep constant the volume until equilibrium. The antioxidant concentration of the samples was 118 determined by UV-vis spectrophotometry (Biochrom WPA Lightwave II UV/Visible 119 spectrophotometer) at 222 nm for tyrosol, 325 nm for ferulic and caffeic acid. A series of 120 standard solutions for each antioxidant was used for calibration, according to the Beer-121 Lambert's law. The release of each antioxidant was carried out at in triplicate. The solubility 122 of the antioxidant in water was not a limitation as the concentrations used are very low 123 compared to their limit of solubility. Indeed, the tyrosol has a water solubility of 124 g/L, 124 ferulic acid of 15 g/L and caffeic acid of 1 g/L. If all the antioxidant loaded in films are released, 125 according to the ratio film/simulant used, the maximum concentration potentially reached in 126 the simulant would be 0.03 g/L. 127

130 2.3. Determination of the effective diffusion (D) and partition (Kt/s) coefficients of the 131 antioxidants

The effective diffusion coefficient (D, m².s⁻¹) was determined using a relationship derived from 132 the Fick's second law equation (transient state) for a unidirectional diffusion in one-dimension 133 (Crank 1975). This model considered a limited volume of film in a limited volume of solution 134 (simulant or water) for a plane sheet (film). The model describing this phenomenon (Equation 135 1) considers 1) the initial maximum concentration of the antioxidant in the film is uniformly 136 distributed at t=0; 2) the initial concentration in the simulant equals to zero at initial time; there 137 is no boundary effect (because the medium is perfectly stirred); and the diffusivity is supposed 138 non-concentration-dependent nor time-dependent. 139

141 $C_t \text{ (mg/L)}$, the antioxidant concentration over time in the release medium; $C_{\infty} \text{ (mg/L)}$, the 142 antioxidant concentration at equilibrium in the release medium; L, the half thickness of the film 143 (m); q_n , the non-zero positive roots of $\tan(q_n) = -\alpha q_n$ (n values ranging from1 and 6); α 144 determined from $\alpha = \frac{V_s}{(K_{f,S} \times V_f)}$; V_s , the release medium volume (m³); V_f , the film volume (m³) 145 and $K_{f,S} = \frac{C_{f,\infty}}{C_{S,\infty}}$ the partition coefficient of the antioxidant between film and simulant (solution) 146 at equilibrium; and $C_{f,\infty}$ and $C_{S,\infty}$, the equilibrium concentrations of the antioxidant (mg/L) in 147 the film and in the food simulant, respectively.

Equation 1 fit to the experimental data by minimising the sum of the square of the differences between measured and predicted values, using the Levenberg–Marquardt algorithm, and considering D as adjustable parameter. Modelling was performed using MATLAB/Simulink software environment (MATLAB 8.5-2015). The means value of effective diffusion of eachformulation was calculated from the triplicate analyses.

The coefficient of determination (R²) and the Root Mean Square Error (RMSE, mg/L) were
determined from each measure:

where, \hat{y} and y were respectively predicted and experimental residual values, and N, is the number of experiment point.

There was an acceptable fitting between the theoretical values and the experimental data for the all antioxidants ($R^2 > 0.94$ and RMSE < 0.1 mg/L) for the three temperatures and for the salt content.

162 **2.4. Statistical analyses**

All the data were at least triplicated and the statistical analysis was done using an independent sample t-test with the statistical software SPSS 13.0 (SPSS Inc., Chicago, IL). A standard deviation (p-value < 0.05) at the 95% confidence level was used to compare the data according the NaCl content and the temperature.

168 **3. Results and Discussion**

At pH 5.5, gelatin is negatively charged (the iso-electric point of gelatin is about 4.5) while chitosan is positively charged (pKa of the chitosan amino group is about 6.5). This favors the ionic interactions between amino groups $(-NH^{3+})$ of chitosan and carboxylate $(-COO^{-})$ groups of gelatin. At this pH, both ferulic acid (pKa=4.58) and caffeic acid (pKa 4.62) exhibit negative charges whereas tyrosol (pKa=10.17] has positive charges. This implies the antioxidants could
modify differently the electrostatic interactions between gelatin and chitosan, modifying the
network structure and thus changing the retention/release behaviors.

177 Phenolic acids are slower released and in a less amount than that of tyrosol (Figure 1). Less than 10 min was necessary to achieve the release of tyrosol, whereas the release of others 178 antioxidants required at least 30 or 40 min whatever the temperature or the nature of the liquid 179 medium (water or 1% NaCl solution). Moreover, tyrosol was less retained in the film, 180 corresponding to a retention of 30-40%. The higher retentions of ferulic acid or caffeic acid 181 (up to 65%) could be attributed to the charge-charge interactions occurring between the 182 polymer network and the acids. Indeed, this is related to the negative groups (carboxylate 183 184 group) of the phenolic acids and to the positive groups of gelatine or chitosan (ammonium groups). The charge-charge interactions between phenolic acid and protein (and or chitosan) 185 186 could explain the stronger impact of caffeic and ferulic acid on the properties of the chitosangelatin film. In contrast, tyrosol (without carboxylate (-COO) groups), is not able to make a 187 charge-charge interaction with the protein or chitosan (Benbettaïeb et al., 2018). The effect of 188 phenolic acids on film structure and release was displayed by FTIR: the shifts on amide I and 189 amide III band are more related to the changes in the structural organization of the network 190 which induced the changes in diffusivity and kinetic. Caffeic and ferulic acids are thus able to 191 cross-link the biopolymers as previously displayed for the same films. Consequently, the 192 effective diffusion coefficient (Table 1) of the phenolic acids in water is from 5 to 18 times 193 smaller than that of the tyrosol that is not involved in the network strengthening (no 194 195 crosslinking). Also, the chemical structure of tyrosol without double bond in the lateral chain makes it more flexible and thus could enhance its diffusion in polymers compared to caffeic or 196 ferulic acids. 197

198 The temperature influences significantly the release in the water of the two phenolic acids, reducing the time to reach equilibrium and increasing the amount of antioxidant released, 199 whereas it seems having only a very weak effect on the tyrosol release behaviour (figure 1). 200 201 However, and as expected, the release mechanism is temperature dependent. The increase of temperature leads to a greater biopolymer chain mobility that makes the effective diffusion 202 higher for all the compounds and whatever the medium (Table 1). Indeed, D increases for all 203 the antioxidants from 2 to 4 times when the temperature rises from 4 to 32°C, but this seems 204 also dependent on the medium. As the charge-charge and ionic interactions are temperature 205 206 dependent (Howell 2005), the partition coefficient of the phenolic acids is significantly affected, reduced up to 80 times in water, but much less when NaCl solution was used. The 207 K_{f/S} of tyrosol is much lower than that of phenolic acids because tyrosol is very hydrophilic 208 (log P = 0.62) and water soluble (water solubility ws = 124 g.L^{-1}) compared to the caffeic acid 209 $(\log P = 1.42, ws < 1 g.L^{-1})$ or ferulic acid $(\log P = 1.64, ws = 15 g.L^{-1})$. It is thus logical that 210 tyrosol is more and faster released in water with the temperature increase. 211

The NaCl presence in the liquid medium induced conformational change within the biopolymer 212 matrix because it diffuses from the solution into the film. This modifies the interactions 213 214 between the gelatin and chitosan, inducing a less strengthen network and thus a faster release 215 particularly for the phenolic acids. Indeed, the enhanced ionic strength of the food simulant 216 increased the activity of the phenolic compounds, thus improving the driving force for 217 migration into the simulant. The diffusion coefficient of all the compounds is from 2 to 7 times higher when NaCl was added (Table1). In the case of tyrosol, there is no significant effect of 218 NaCl on the released amount and rate because of the retention of tyrosol in film is not related 219 220 to ionic or charge-charge interactions. Moreover, as demonstrated by Sow and Yang (2015), a 221 salting-out effect of NaCl on the gelatin could be supposed and thus may explain the release behaviour observed. Indeed, these authors displayed that salt induce a conformational change 222

of fish gelatin from helices toward aggregates that are denser and tends to excludes small molecules entrapped in. Yoshida *et al.*, (2008) and Tasaki *et al.*, (2009) demonstrated that salt presence allows to faster the release of small molecules (drugs) from polyelectrolyte gels and films.

From this work, the efficacy of active films containing natural phenolic was dependent of both the media composition and the storage temperature. Understanding these factors effect on diffusivity and partition could help us to tune the controlled release and adapt the concept of this kind of active packaging film to food application.

232 **4.** Conclusion

The release into water or 1% (w/v) NaCl solution of the active compounds entrapped in films 233 based on gelatin-chitosan blends suits a Fickian behaviour. The lowest effective diffusivity and 234 235 released quantity were observed for ferulic acid or caffeic acid compared to tyrosol. Indeed, tyrosol weakly interacted with the biopolymer chains and did not involve electrostatic 236 interactions, explaining that tyrosol release was less sensitive to NaCl. As expect, the 237 temperature increases the diffusivity and is predominant on the solubility. Indeed, even if the 238 partition coefficient of phenolic acids decreased with temperature, the rate of transfer increased 239 240 with temperature. The presence of NaCl allow the less strengthening of chitosan-gelatin network which excludes the entrapped antioxidants and thus faster the release of phenolic 241 acids. The efficacy of active films maybe dependent of the food composition and temperature 242 243 for natural phenolic acid whereas it is not influenced for non-charged compounds such as tyrosol. 244
