Co2(CO)8 as an efficient catalyst for the synthesis of functionalized polymethylhydrosiloxane oils and unconventional cross-linked materials

We report here the use of $Co_2(CO)_8$ as a cheap and structurally simple alternative to precious metals for the functionalization of polymethylhydrosiloxane (PMHS) with terminal alkenes. This catalytic system at 0.1 mol% loading was found capable of hydrosilylating PMHS with one or two different alkenes in up to >99% efficiency under mild conditions. More importantly, we investigated the synthesis of cross-linked PMHS materials and found that both traditional dienes and unconventional tethers (such as esters and 5-hexen-2-one) led to fast and effective cross-linking of PMHS via hydrosilylation of C=C and C=O bonds, and further formation of Si-O-Si bridges between the PMHS chains. Additionally, we demonstrate here the potential of using renewable resources such as oleic acid derivatives as suitable cross-linkers to prepare bio-sourced cross-linked silicone materials.

Introduction

Polyorganosiloxanes, commonly known as silicones, are semiinorganic polymers, which have found a wide use in many applications (for example elastomers, coatings, sealants etc.) due to their unique physical and chemical properties. To date, platinum-based complexes are the most widely used catalysts in siloxane hydrosilylation and cross-linking reactions involved in the preparation of silicone materials.1,2 Although Pt-catalysts are highly effective at very low ppm levels for the functionalization of polysiloxanes, these processes lead in the end to the large scale loss of valuable precious-metal based catalyst which cannot be recycled.³ Consequently, from an economical and environmental point of view, the use of platinum and other noble metal catalysts should be avoided in the modern-day synthesis of siloxane materials.‡ Therefore, the development of environmentally benign catalytic systems should be on the forefront of silicone science. While currently, the dominance of Pt-based catalysts is still undisputed in the functionalization of silicone Si-H bonds, first row transition metal complexes have more and more contested their use. The applicability of the latter complexes in alkene hydrosilylation with small-size molecular silanes has been well covered by recent reviews,4–6 however the functionalization of long-chain polysiloxane oils by non-precious catalysts is still underexplored.² To the best of our knowledge, the current types of ARTICLE

functionalization of polysiloxane Si-H bonds are limited to the formation of new Si-O-R (R=alkyl, aryl, acyl) and Si-R (R=alkyl) bonds (Scheme 1) in polysiloxane oils. For example, Cu^7 and Zn^8 based catalysts, and tris(pentafluorophenyl)borane (B(C₆F₅)₃)⁹ are known to catalyze the synthesis of functionalized PMHS (polymethylhydrosiloxane) via dehydrogenative coupling using alcohols or carboxylic acids (Scheme 1a). However, when the formation of new Si-C bond is preferred, there is only one example in the literature where a non-precious metal Ni complex was successfully used to functionalize PMHS with 1 hexene or 1-octene (Scheme 1a).¹⁰ Additionally, there are examples from the Nagashima's group where Co and Fe isocyanide complexes have found use in functionalization of terminal SiMe₂-H groups of polydimethylsiloxanes (PMDS) with α-methylstyrene and styrene with yields up to 99% (Scheme 1_b , $1¹¹$

The current number of examples describing the cross-linking of PMHS (or its ethyl analogues) with non-precious metal catalysts are also limited, as most of them involve the hydrosilylation of polydimethylsiloxanes containing terminal or internal vinyl groups (vPDMS) (Scheme 2a).¹¹⁻¹⁶ It should be noted that only two examples in the literature report the use of non-precious metal catalysts for the cross-linking of PMHS with short alkenes (Scheme 2b). The first one employs a Co catalyst to cross-link PMHS chains with short alkenes (1-octene and dodecene) *via* dehydrogenative hydrosilylation followed by hydrosilylation.¹⁷ The second example uses a Mn(II) catalyst to hydrosilylate 1,2,4-trivinylcyclohexane with PMHS to form cross-linked polymers.¹⁴

In search for an efficient earth-abundant transition metal catalyst for the hydrosilylation process, our group previously described the preparation and use of simple cobalt nanoparticles (NP) as effective catalysts for the synthesis of silicone oils *via* alkene hydrosilylation with MD'M (1,1,1,3,5,5,5 heptamethyltrisiloxane).¹⁸ These cobalt NPs were derived from $Co₂(CO)₈$, which has previously been used in alkene hydrosilylation with monomeric silanes,⁴ but examples with polymeric silanes are scarce as only one example where crosslinking of polymethylphenylvinylsiloxane with polymethylphenylhydrosiloxane is described using $Co_2(CO)_{8}.^{19}$ We therefore investigate here the use of $Co₂(CO)₈$ for the synthesis of functionalized PMHS oils and cross-linked materials in attempt to step closer to the goal of using active non-precious metal complexes in the silicone industry.

Results and discussion

Throughout this study, all the reactions were carried out with $Co₂(CO)₈$ (0.1 mol% compared to Si-H units in PMHS) at 60 °C unless stated otherwise and all the products depicted in various Tables and Schemes represent simplified structures of (poly)functionalized siloxane materials which do not correspond to block-polymers. The absence of trace amount of Pt in $Co_2(CO)_8$ was verified by ICP-MS (inductively coupled plasma mass-spectrometry) analysis and the Pt content (if any) was below the 0.05 ppm detection limit of the apparatus.

Additionally, the yields expressed throughout the work correspond to the ¹H NMR yield of Si-H bonds functionalization. In Table 1, we represent the scope of alkenes tested for PMHS functionalization under mild conditions(60 °C for 24 h) and with a molar alkene C=C/Si-H ratio of 1:1. Using 1-octene in the functionalization process gave rise to 57% of alkylated PMHS **1a** (Table 1, entry 1) and additionally to considerable amount (43%) of internal octene isomers. Switching from this linear substrate to a cyclic analogue, vinylcyclohexane (entry 2), led to an improved yield of 77% of **1b** alongside with the formation of internal isomers (23%). Notably, non-isomerizable *tert*-butyl ethylene (TBE, entry 3) was incorporated into the PMHS chain in **1c** with 79% efficiency, while styrene demonstrated quantitative hydrosilylation of Si-H bonds in **1d** (entry 4). Using the more sterically hindered heptamethyl-3-vinyltrisiloxane (MDViM) (entry 5) gave rise to 65% of functionalized product **1e**. It should be noted that all the products in entries 1-5 were formed exclusively as *anti*-Markovnikov hydrosilylated products. Additionally, we used 1,3-cyclohexadiene (entry 6) to introduce a C=C bond to the hydrosilylated product, which could offer further reactivity for the functionalized PMHS oil. The reaction between 1,3-cyclohexadiene and PMHS led to 1,2 and 1,4-addition products in approximate ratio of 6:1 (based on ²⁹Si NMR - see ESI) in **1f**, knowing that both isomers are known to occur for dienes in presence of $Co_2(CO)_8$.²⁰ In all examples in Table 1, ²⁹Si chemical shifts in the range of -19 to -27 ppm confirm the formation of new Si-C bonds *via* C=C bond hydrosilylation (see ESI). of Notice in a straighted the angle of the formula a metallic one can be the content in the straight and decrease the content in the straight of the straight

To further demonstrate the versatility of this catalytic system, we performed the double functionalization of PMHS with two different alkenes in a one-pot reaction. Treatment of PMHS (1.0 eq) with styrene (0.6 eq) and MD^{Vi}M (0.6 eq) in the

presence of $Co_2(CO)_8$ successfully led to 77% of Si-H functionalization in **1g** (Scheme 3). Since PMHS reaction with styrene led to faster styrene incorporation when using 1.2 eq of styrene, compared to that of MD^{VI}M when used separately (Table 1 entry 4 *vs* entry 5), we therefore expected a higher level of styrene incorporation into the final product. Surprisingly, the experimental result demonstrates that only 28% of Si-H bonds were functionalized with styrene and 49% with MD^{Vi}M in 1g.[§] This last result is a rare example of a one-pot double functionalization of a polymethylhydrosiloxane derivative and highlights the versatility and the potential of using simple nonprecious metal catalysts, such as $Co₂(CO)₈$, in this process. Considering the lack of examples in the literature, the results in Table 1 and in Scheme 3 represent considerable expansion of the alkene scope in the functionalization of PMHS using a nonprecious metal catalyst with up to >99% efficiency.

Inspired by these results, we turned our interest towards the cross-linking of polymethylhydrosiloxanes with traditional short-chain tethers containing two terminal C=C bonds. For example, the reactions between PMHS (1.0 eq of Si-H) and 0.5 eq. of the dienes (i.e. 1.0 eq of C=C), namely divinyltetramethyldisiloxane (DVTMS) or diethyl diallylmalonate (DEDAM), led to the expected cross-linking of PMHS chainsin products **2a** and **2b** respectively (Scheme 4). The gelation processfor both substrates occurred *via* double alkenyl group hydrosilylation, but not quantitatively as evidenced by the presence of unreacted olefin ¹H and ¹³C signals in solid state NMR spectra (See ESI). Somewhat surprisingly, the ²⁹Si CPMAS spectrum of the reaction product after DEDAM incorporation exhibits one low intensity resonance at -66 ppm, which

corresponds to a newly formed Si-O-Si bridge (for comparison of various²⁹Si chemical shifts in functionalized polysiloxanes 98 ESI pages S7-S8) in addition to the expected resonance at -21 ppm (corresponding to MeSi(OSi=)₂(alkyl) subunit). Such Si-**O**-Si bonds could be generated through a similar mechanism than that proposed in the Ir-catalyzed deoxygenation and dehydration of carboxamides.²¹ Here, we thus hypothesize that, in the presence of $Co₂(CO)₈$ and PMHS the unsaturated carbonyl substrates can undergo similar deoxygenation process leading to the Si-**O**-Si bridges as depicted in Scheme 5. Thus, this Si-O-Si bridge could arise from the hydrosilylation of the carbonyl group of the ester RCOOR', yielding a $[MeSi(OSi\equiv)_{2}(O-1)]$ C(R)(OR')H] subunit, which, after a subsequent reduction step, leads to RCH₂OR' and a newly formed Si-O-Si bridge. While carbonyl group hydrosilylation has been employed in the crosslinking of ethylene-vinyl acetate copolymer with hydrideterminated PDMS, 21 the cross-linking of PMHS arising from deoxygenative reduction of C=O group in ester to form Si-O-Si bridge is, to the best of our knowledge, an unprecedented reactivity in the field of cross-linked siloxane materials. Previously, Nagashima's work on precious metal catalyzed amide reduction with PMHS has led to corresponding amines and insoluble cross-linked PMHS gel as a side-product.²²⁻²⁵ For comparison, the Darcel's group has reported the use of $Co₂(CO)₈$ and PMHS as an effective combination to deoxygenatively reduce amides to corresponding amines without mentioning the formation of gelous materials.²⁶ Very recently, $B(C_6F_5)_3$ catalyzed cross-linking of PMHS chains through hydrosilylation of carbonyl groups in α -diketones was demonstrated by Hawker and co-workers.²⁷ In this latter example, no Si-O-Si bridge formation from C=O group was reported.  $\frac{0}{I}$ reaction between PMHS and vinyl terminated esters is catalyzed With this additional and unconventional cross-linking capability in mind, we decided to investigate the use of unsaturated esters as promising tethers for the synthesis of functionalized polysiloxane materials. Entries 1 and 2 in Table 2 demonstrate how simple unsaturated acetates can be used as cross-linkers *via* the double reactivity of the C=C and C=O functionalities at 60 °C for **3a** and **3b**. Additionally, entry 3 indicates that the cross-linking procedure is not limited only to alkenyl acetates but can also be extended to alkyl alkenoates as demonstrated in **3c**. Furthermore, comparing the curing time for entries 1-3, we see that faster reaction occurred for substrates that have the two hydrosilylable functionalities further apart from each other. For comparison, when the by Pt-based systems, only the vinyl moiety is hydrosilylated without reactivity on the carbonyl group.²⁸ Moving towards more industrially relevant esters, we tested methyl methacrylate (MMA) and allyl methacrylate (AMA) in the cross-

linking reaction. The former is known to polymerize in the presence of $Co(OAc)_2$ and to react with PMHS to give semiinterpenetrating networks.²⁹ However, in our case the reaction between PMHS and MMA (entry 4) led to the cross-linked product **3d** *via* the hydrosilylation of both the C=C bond and the ester functionalities (evidenced from solid-state ¹³C and ²⁹Si spectra, see ESI). On a further note, it is known in literature that when Pt-based catalysts are used instead, the reaction between PMHS and other alkyl acrylates leads to the expected alkene hydrosilylation product without the ester group reduction.³⁰ When AMA (entry 5), which contains an additional allyl group, is used in the presence of $Co_2(CO)_8$ and PMHS, the reduction of the ester group wassuppressed and cross-linking in **3e** occurred *via* hydrosilylation of the two C=C bonds only (evidenced from solid state ¹³C and ²⁹Si spectra, see ESI). For comparison, allyl (meth)acrylates have previously been incorporated into PMHS chains through the exclusive hydrosilylation of the allyl group, without evidence of cross-linking through the C=C bond in the alkenoate part of the molecule nor *via* ester group reduction.31,32 This result from entry 5 suggests that, in the presence of multiple C=C and C=O bonds, the cross-linking is faster *via* the hydrosilylation of two C=C bonds. While unsaturated esters (entries 1-5) have demonstrated excellent aptitude as unconventional tethers, the duestion about the reactivity of the carbonyl group remains to be explored further. When the same reaction was carried out with hex-5-ene-2-one (entry 6), which is a less reactive carbonyl compound, the gelation of **3f** took <90 min to cross-link PMHS chains *via* C=C and C=O bond hydrosilylation, and *via* Si-O-Si bond formation.

On a general note, while all the examples in Table 2 show the formation of cross-linked products in <90 min, this did not result in complete hydrosilylation of all active Si-H groups, as evidenced by DRIFT, 1 H and 29 Si solid-state NMR spectra (see ESI). Additionally, the scheme depicting the cross-linked products in Table 2 illustrates that the formation of each new Si-O-Si bridge between the PMHS chains was accompanied by the formation of reduced sidechain after full reduction of the carbonyl group in the incorporated substrate. It should be noted that all the obtained gels were colored (Table 2) and in comparison to known colorless gels formed via non-precious metal catalyzed cross-linking^{11,16,31}, our gels did not undergo discoloration under air in 24 h. However, while the gels were colored, they yielded slightly colored or white solids after drying at 60 °C overnight.^{§§} Interestingly, in the case of AMA (entry 5) the product was intense blue hard glassy solid, while all the other products in Table 2 were soft gels that could easily be punctured and sliced. In order to illustrate the potential of $Co₂CO₈$ to catalyze the formation of gels, the reaction was carried out with DEDAM and MMA using a lower Co loading of 0.01 mol%. A gel was obtained within 2 h when MMA was used but no gel could be formed with DEDAM even after one day of reaction. These results show that the Co loading could be decreased to prepare a gel on the case-by-case basis depending on the olefinic reagent. Here $\frac{1}{\sqrt{2}}$

Examples in Table 2 have demonstrated the possibility to use various (un)saturated ester and carbonyl group containing substrates as effective tethers in polymethylhydrosiloxane cross-linking. Considering the end-product's lifetime and its eventual release to the environment, we feel that the environmental impact can be minimized³³ with the use of biosourced tethers, such as fatty acid derivatives. Based on the analogy of the esters used in Table 2, we believe that Si-O-C linkage formed from fatty acid derivatives would offer an ideal target for facile degradation pathway under acid- or basecatalyzed hydrolysis.34,35

In Scheme 6a, we demonstrated that the reaction between methyl oleate and PMHS led to the gel **3h** within 60 min. Similar gel **3i** was formed in 90 min with the use of oleic acid (Scheme 6b). As the last example for PMHS cross-linking, we tested olive oil, which contains mostly oleic acid based triglycerides³⁶ and therefore offers high ester group density. As seen on Scheme 6c, 1 mol% of $Co_2(CO)_{8}$ catalyzed the cross-linking reaction in <10 min to yield **3j**. Excerpts of ²⁹Si NMR spectra of all three products (Scheme 6d) confirm the presence of silyl acetal groups(-57 to -62 ppm) and the formation of Si-O-Si bridges(*ca*. -66 ppm). However, the similarities between gels **3h**-**3j** end here, as the extent of C=C and C=O group hydrosilylative reduction varies between those samples. For example, methyl oleate gel **3h** has undergone full reduction of ester groups to

silyl acetal groups (99.3 ppm in 13 C NMR) and the complete hydrosilylation of the C=C bonds (evidenced by the lack of C=C signals in ¹³C and formation of new Si-C bonds in ²⁹Si NMR). The C=C bond hydrosilylation of oleic acid derivatives by $Co₂(CO)₈$ is somewhat unexpected, as we demonstrated recently that while cobalt NPs in solution can tandem isomerize-hydrosilylate internal C=C bonds of methyl oleate to the terminal position with MD'M (monomeric analogue of PMHS), such reactivity was not seen with $Co_2(CO)_{8}.$ ¹⁸ On the other hand, the products from PMHS cross-linking using oleic acid and olive oil, **3i** and **3j**, have mainly reacted via the carboxylic group (formation of Si-O-C and Si-O-Si bonds in ²⁹Si NMR, Scheme 6d), while leaving the C=C bond mostly untouched (low intensity of the Si-C peak between -21 to -24 ppm in ²⁹Si NMR, Scheme 6d). We also carried out test reactions with oleic acid derivatives and MD'M under the same reaction conditions and, in all cases, no C=C, C=O or COOH hydrosilylation was observed. The different behavior of oleic acid and olive oil from that of the methyl oleate may be due to

the reactive nature of COOH group in oleic acid and the close proximity of three C=O groups in the olive oil, which leads to preferential C=O group reduction than to new Si-C bond formation after C=C bond hydrosilylation. Additionally, we would like to emphasize that the reaction with olive oil (Scheme 6c) was successfully carried out on a gram-scale, demonstrating the potential of using $Co₂(CO)₈$ and possibly other non-precious metal catalysts for the synthesis of biosourced cross-linked siloxanes materials.

Conclusions

In this study, we have demonstrated the use of simple $Co₂(CO)₈$ as an excellent non-noble metal catalyst for the synthesis of mono- and bi-functionalized PMHS oils in a one-pot reaction, with catalyst loadings as low as 0.1 mol%. Importantly, this catalytic system offered a unique method for the cross-linking of PMHS with traditional dienes and unconventional organic
