The Feshbach-Schur map and perturbation theory

Abstract

This paper deals with perturbation theory for discrete spectra of linear operators. To simplify exposition we consider here self-adjoint operators. This theory is based on the Feshbach-Schur map and it has advantages with respect to the standard perturbation theory in three aspects: (a) it readily produces rigorous estimates on eigenvalues and eigenfunctions with explicit constants; (b) it is compact and elementary (it uses properties of norms and the fundamental theorem of algebra about solutions of polynomial equations); and (c) it is based on a self-contained formulation of a fixed point problem for the eigenvalues and eigenfunctions, allowing for easy iterations. We apply our abstract results to obtain rigorous bounds on the ground states of Helium-type ions.

1 Set-up and result

The eigenvalue perturbation theory is a major tool in mathematical physics and applied mathematics. In the present form, it goes back to Rayleigh and Schrödinger and became

a robust mathematical field in the works of Kato and Rellich. It was extended to quantum resonances by Simon, see [2, 5, 6, 11, 12, 13, 14, 15] for books and a book-size review.

A different approach to the eigenvalue perturbation problem going back to works of Feshbach and based on the Feshbach-Schur map was introduced in [1] and extended in [4, 3].

In this paper, we develop further this approach proposing a self-contained theory in a form of a fixed point problem for the eigenvalues and eigenfunctions. It is more compact and direct than the traditional one and, as we show elsewhere, extends to the nonlinear eigenvalue problem.

We show that this approach leads naturally to bounds on the eigenvalues and eigenfunctions with explicit constants, which we use in an estimation of the ground state energies of the Helium-type ions.

The approach can handle tougher perturbations, non-isolated eigenvalues (see [1, 4]) and continuous spectra as well as discrete ones. In this paper, we restrict ourselves to the latter. Namely, we address the eigenvalue perturbation problem for operators on a Hilbert space of the form

$$H = H_0 + W, \tag{1.1}$$

where H_0 is an operator with some isolated eigenvalues and W is an operator, small relative to H_0 in an appropriate norm. The goal is to show that H has eigenvalues near those of H_0 and estimate these eigenvalues.

Specifically, with $\|\cdot\|$ standing for the vector and operator norms in the underlying Hilbert space, we assume that

(A) H_0 is a self-adjoint, non-negative operator ($H_0 \ge \beta > 0$);

(B) W is symmetric and form-bounded with respect to H_0 , in the sense that

$$\|H_0^{-\frac{1}{2}}WH_0^{-\frac{1}{2}}\| < \infty.$$

(C) H_0 has an isolated eigenvalue $\lambda_0 > 0$ of a finite multiplicity, *m*.

Here $\|\cdot\|$ is the operator norm and H_0^{-s} , 0 < s < 1, is defined either by the spectral theory or by the explicit formula

$$H_0^{-s} := c \int_0^\infty (H_0 + \omega)^{-1} \frac{d\omega}{\omega^s},$$

where $c := \left[\int_0^\infty (1+\omega)^{-1} \frac{d\omega}{\omega^s} \right]^{-1}$.

It turns out to be useful in the proofs below to use the following form-norm

$$||W||_{H_0} := ||H_0^{-\frac{1}{2}}WH_0^{-\frac{1}{2}}||_{\mathcal{H}_0}$$

Let *P* be the orthogonal projection onto the span of the eigenfunctions of H_0 corresponding to the eigenvalue λ_0 and let $P^{\perp} := \mathbf{1} - P$. Let γ_0 be the distance of λ_0 to

the rest of the spectrum of H_0 , and $\lambda_* := \lambda_0 + \gamma_0$. In what follows, we often deal with the expression

$$\Phi(W) := \frac{\lambda_0 \lambda_*}{\gamma_0} \|P^{\perp} W P\|_{H_0}^2.$$
(1.2)

The following theorem proven in Section 2 is the main result of this paper.

Main Theorem 1.1. Let Assumptions (A)-(C) be satisfied and assume that, for some 0 < b < 1 and 0 < a < 1 - b,

$$\|P^{\perp}WP^{\perp}\|_{H_0} \le \frac{b\gamma_0}{\lambda_*},\tag{1.3}$$

$$\|PWP\| + k\Phi(W) < a\gamma_0, \tag{1.4}$$

$$k\Phi(W) < \frac{1}{2}(a\gamma_0 - \|PWP\|), \tag{1.5}$$

where $k := \frac{1}{1-a-b}$. Then the spectrum of the operator H near λ_0 consists of isolated eigenvalues λ_i of the total multiplicity m satisfying, together with their normalized eigenfunctions φ_i , the following estimates

$$|\lambda_i - \lambda_0| \le \|PWP\| + k\Phi(W), \tag{1.6}$$

$$\|\varphi_i - \varphi_{0i}\| \le k \sqrt{\frac{\Phi(W)}{\gamma_0}},\tag{1.7}$$

where φ_{0i} are appropriate eigenfunctions of H_0 corresponding to the eigenvalue λ_0 .

Remark 1 (Comparison with [3]). A similar result was already proven in [3]. Here, the theory is made self-contained and formulated as the fixed point problem and the bounds are tightened.

Remark 2 (Conditions on *W*) The fine tuning the conditions (1.3)-(1.5) on *W* is used in application of this theorem to atomic systems in Section 3.

Note that because of the elementary estimate

$$\Phi(W) \le \frac{1}{\gamma_0} \| PWP^{\perp}WP \|,$$

see (3.11) below, the computation of ||PWP|| and $\Phi(W)$ reduces to computing the largest eigenvalues of the simple $m \times m$ -matrices PWP, -PWP and $PWP^{\perp}WP$.

Remark 3 (Higher-order estimates and non-degenerate λ_0). In fact, one can estimate λ_i (as well as the eigenfunctions φ_i) to an arbitrary order in $||P^{\perp}WP||_{H_0}/\gamma_0$. As a demonstration, we derive (after the proof of Theorem 1.1) the second-order estimate of the eigenvalue in the rank-one (m = 1) case

$$|\lambda_1 - \lambda_0 - \langle W \rangle| \le k \Phi(W), \tag{1.8}$$

where φ_0 is the eigenfunction of H_0 corresponding to λ_0 , $\langle W \rangle := \langle \varphi_0, W \varphi_0 \rangle$.

For degenerate λ_0 , we would like to prove a similar bound on $|\lambda_i - \lambda_0 - \mu_i|$, where μ_i is the corresponding eigenvalue of the $m \times m$ -matrix *PWP*. Here, we have a partial result (proven at the end of the next section) for the lowest eigenvalue λ_1 of *H*:

$$\lambda_0 + \mu_{\min} - k\Phi(W) \le \lambda_1 \le \lambda_0 + \mu_{\min}, \tag{1.9}$$

where μ_{\min} denotes the smallest eigenvalue of the matrix *PWP*.

Remark 4 (Non-self-adjoint *H*). With the sacrifice of the explicit constants in (1.6) and (1.7) (mostly coming from (2.5)), the self-adjointness assumption on *H* can be removed. However, for the problem of quantum resonances, one can still obtain explicit estimates.

In the rest of this section H is an abstract operator not necessarily self-adjoint or of the form (1.1). Our approach is grounded in the following theorem (see [4], Theorem 11.1).

Theorem 1.2. Let *H* be an operator on a Hilbert space and *P* and *P*^{\perp}, a pair of projections such that $P + P^{\perp} = 1$. Assume $H^{\perp} := P^{\perp}HP^{\perp}$ is invertible on Ran P^{\perp} and the expression

$$F_P(H) := P(H - HR^{\perp}H)P, \qquad (1.10)$$

where $R^{\perp} := P^{\perp}(H^{\perp})^{-1}P^{\perp}$, defines a bounded operator. Then F_P , considered as a map on the space of operators, is isospectral in the following sense:

- (a) $\lambda \in \sigma(H)$ if and only if $0 \in \sigma(F_P(H \lambda))$;
- (b) $H\psi = \lambda \psi$ if and only if $F_P(H \lambda) \varphi = 0$;
- (c) dim $Null(H \lambda) = \dim NullF_P(H \lambda)$.
- (d) ψ and φ in (b) are related as $\varphi = P\psi$ and $\psi = Q_P(\lambda)\varphi$, where

$$Q_P(\lambda) := P - P^{\perp} (H^{\perp} - \lambda)^{-1} P^{\perp} H P.$$
(1.11)

Finally, $F_P(H)^* = F_{P^*}(H^*)$ and therefore, if H and P are self-adjoint, then so is $F_P(H)$.

A proof of this theorem is elementary and short; it can be found in [1], Section IV.1, pp 346-348, and [4], Appendix 11.6, pp 123-125.

The map F_P on the space of operators, is called the *Feshbach-Schur map*. The relation $\psi = Q_P(\lambda)\varphi$ allows us to reconstruct the full eigenfunction from the projected one. By statement (a), we have

Corollary 1.3. Assume there is an open set $\Lambda \subset \mathbb{C}$ such that $H - \lambda$, $\lambda \in \Lambda$, is in the domain of the map F_P , i.e. $F_P(H - \lambda)$ is well defined. Define the operator-family

$$H(\lambda) := F_P(H - \lambda) + \lambda P,$$

and let $v_i(\lambda)$, for λ in Λ , denote its eigenvalues counted with multiplicities. Then the eigenvalues of H in Λ are in one-to-one correspondence with the solutions of the equations

$$v_i(\lambda) = \lambda. \tag{1.12}$$

Concentrating on the eigenvalue problem, Corollary 1.3 shows that the original problem

$$H\psi = \lambda\psi, \tag{1.13}$$

is mapped into the equivalent eigenvalue problem,

$$H(\lambda)\varphi = \lambda\varphi, \tag{1.14}$$

nonlinear in the spectral parameter λ , but on the smaller space Ran P.

Since the projection *P* is of a finite rank, the original eigenvalue problem (1.13) is mapped into an equivalent lower-dimensional/finite-dimensional one, (1.14). Of course, we have to pay a price for this: at one step we have to solve a one-dimensional fixed point problem that can be equivalently seen as a non-linear eigenvalue problem and invert an operator in Ran P^{\perp} .

We call this approach the *Feshbach-Schur map method*, or *FSM method*, for short. It is rather compact, as one easily see skimming through this paper and entirely elementary.

We call $H(\lambda)$ the *effective Hamiltonian* (matrix) and write as

$$H(\lambda) = PHP + U(\lambda), \tag{1.15}$$

with the self-adjoint *effective interaction*, or a Schur complement, $U(\lambda)$, defined as

$$U(\lambda) := -PHP^{\perp}(H^{\perp} - \lambda)^{-1}P^{\perp}HP.$$
(1.16)

It is shown in Lemma 2.1 below that (1.16) defines a bounded operator family.

We mention here some additional properties discussed in [3].

Proposition 1.4. Let *H* be self-adjoint, let Λ be the same as in Corollary 1.3, let *m* be the rank of *P* and let the eigenvalues of $H(\lambda)$, $\lambda \in \Lambda \cap \mathbb{R}$, be labeled in the order of their increase counting their multiplicities so that

$$\nu_1(\lambda) \le \ldots \le \nu_m(\lambda). \tag{1.17}$$

Then we have that (a) a solution of the equation $v_i(\lambda) = \lambda$, for $\lambda \in \Lambda \cap \mathbb{R}$, is the *i*-th eigenvalue, λ_i , of *H* and vice versa; (b) v_i is differentiable in λ and $v'_i(\lambda) \le 0$, for $\lambda \in \Lambda \cap \mathbb{R}$.

Proof. (a) By (1.17), $\lambda_i = v_i(\lambda_i) < v_{i+1}(\lambda) = \lambda_{i+1}$ (except for the level crossings), which proves the result. For (b), by the explicit formula

$$U'(\lambda) := -PHP^{\perp}(H^{\perp} - \lambda)^{-2}P^{\perp}HP \le 0,$$

we have $U'(\lambda) \leq 0$, which by the Hellmann-Feynman theorem (cf. (2.19)) implies $v'_i(\lambda) \leq 0$.

Remark 5 (Perturbation expansion). In the context of Hamiltonians of form (1.1) satisfying Assumptions (A)-(C), the FSM leads to a perturbation expansion to an arbitrary order. Indeed, in this case, *P* is the orthogonal projection onto Null($H_0 - \lambda_0$), $P^{\perp} := \mathbf{1} - P$ and $U(\lambda)$ can be written as

$$U(\lambda) := -PWP^{\perp}(H^{\perp} - \lambda)^{-1}P^{\perp}WP.$$

Now, using the notation $A^{\perp} := P^{\perp}AP^{\perp}|_{\operatorname{Ran}P^{\perp}}$ and expanding

$$(H^{\perp} - \lambda)^{-1} = (H_0^{\perp} + W^{\perp} - \lambda)^{-1}$$

in W^{\perp} and at the same time iterating fixed point equation (1.12), we generate a perturbation expansion for eigenvalues *H* to an arbitrary order (see also Remark 2 above).

The paper is organized as follows. In Section 2, we present the proof of the main result, Theorem 1.1. Section 3 uses this result to obtain bounds of the ground-state energy of Helium-type ions.

2 Perturbation estimates

We want to use Theorem 1.2(b, c) to reduce the original eigenvalue problem to a simpler one. In this section, we assume that Conditions (A)-(C) of Section 1 are satisfied. Recall that γ_0 is the distance of λ_0 to the rest of the spectrum of H_0 and the expression $\Phi(W)$ is defined in (1.2). First, we prove that the operator $F_P(H - \lambda)$ is well-defined for $\lambda \in \Omega$, where, with *a* the same as in Theorem 1.1,

$$\Omega := \{ z \in \mathbb{C} : |z - \lambda_0| \le a \gamma_0 \}.$$
(2.1)

Recall that *P* denotes the orthogonal projection onto Null $(H_0 - \lambda_0)$ and $P^{\perp} := \mathbf{1} - P$. Denote

$$H^{\perp} := P^{\perp} H P^{\perp}|_{\operatorname{Ran} P^{\perp}}$$
 and $R^{\perp}(\lambda) := P^{\perp} (H^{\perp} - \lambda)^{-1} P^{\perp}$

and recall $k = \frac{1}{1-a-b}$. We have

Lemma 2.1. Recall $\lambda_* := \lambda_0 + \gamma_0$ and assume (1.3). Then, for $\lambda \in \Omega$, the following statements hold

(a) The operator $H^{\perp} - \lambda$ is invertible on Ran P^{\perp} ;

- (b) The inverse $R^{\perp}(\lambda) := P^{\perp}(H^{\perp} \lambda)^{-1}P^{\perp}$ defines a bounded, analytic operatorfamily;
- (c) The expression

$$U(\lambda) := -PHR^{\perp}(\lambda)HP \tag{2.2}$$

defines a finite-rank, analytic operator-family, bounded as

$$\|U(\lambda)\| \le k\Phi(W). \tag{2.3}$$

(d) $U(\lambda)$ is symmetric for any $\lambda \in \Omega \cap \mathbb{R}$ and therefore $H(\lambda)$ is self-adjoint as well.

Proof. With the notation $A^{\perp} := P^{\perp}AP^{\perp}|_{\operatorname{Ran}P^{\perp}}$, we write

$$H^{\perp} = H_0^{\perp} + W^{\perp}.$$

To prove (a), we let $H_{\lambda} := H_0^{\perp} - \lambda$ and use the factorization $H_{\lambda} = |H_{\lambda}|^{\frac{1}{2}} V_{\lambda} |H_{\lambda}|^{\frac{1}{2}}$, where V_{λ} is a unitary operator, and use that, for $\lambda \in \Omega$, the operator H_{λ} is invertible and therefore we have the identity

$$H^{\perp} - \lambda = |H_{\lambda}|^{\frac{1}{2}} [V_{\lambda} + K_{\lambda}] |H_{\lambda}|^{\frac{1}{2}}, \qquad (2.4)$$

where $K_{\lambda} := |H_{\lambda}|^{-\frac{1}{2}} W^{\perp} |H_{\lambda}|^{-\frac{1}{2}}$. Next, for $\lambda \in \Omega$, we have $||H_{0}^{\perp}|H_{\lambda}|^{-1} P^{\perp}|| = f(\lambda)$, where

$$f(\lambda) := \sup\left\{ \left| \frac{s}{s-\lambda} \right| : s \ge 0, |s-\lambda_0| \ge \gamma_0 \right\}.$$

Assuming $|\lambda - \lambda_0| \le a\gamma_0$ and using

$$\left|\frac{s}{s-\lambda}\right| \le 1 + \left|\frac{\lambda}{s-\lambda}\right| \le 1 + \frac{\lambda_0 + a\gamma_0}{(1-a)\gamma_0} = \frac{\lambda_*}{(1-a)\gamma_0},$$

we obtain

$$f(\lambda) \leq \frac{\lambda_*}{(1-a)\gamma_0}$$

Since $H_0^{\frac{1}{2}}|H_\lambda|^{-\frac{1}{2}}P^{\perp} = (H_0|H_\lambda|^{-1}|_{\operatorname{Ran}P^{\perp}})^{\frac{1}{2}}P^{\perp}$, we have for $\lambda \in \Omega$,

$$\|H_0^{\frac{1}{2}}|H_\lambda|^{-\frac{1}{2}}P^{\perp}\| \le \left[\frac{\lambda_*}{(1-a)\gamma_0}\right]^{\frac{1}{2}},\tag{2.5}$$

which implies in particular that $||K_{\lambda}|| \leq \frac{\lambda_*}{(1-a)\gamma_0} ||W^{\perp}||_{H_0}$. By the assumption (1.3), i.e., $||W^{\perp}||_{H_0} \leq \frac{b\gamma_0}{\lambda_*}$, we have

$$\|K_{\lambda}\| \le \frac{b}{1-a}.\tag{2.6}$$

Since 1 - a > b, by (2.4), the operator $H^{\perp} - \lambda$ is invertible and its inverse is analytic in $\lambda \in \Omega$, which proves (a) and (b).

We show that statement (c) is also satisfied. Since $PH_0 = H_0P$ and $PP^{\perp} = 0$, we have

$$PHP^{\perp} = PWP^{\perp}, \quad P^{\perp}HP = P^{\perp}WP.$$

These relations and definition (2.2) yield

$$U(\lambda) = -PWR^{\perp}(\lambda)WP.$$
(2.7)

Inverting (2.4) on Ran P^{\perp} and recalling the notation $R^{\perp}(\lambda) := P^{\perp}(H^{\perp} - \lambda)^{-1}P^{\perp}$ gives

$$R^{\perp}(\lambda) = |H_{\lambda}|^{-\frac{1}{2}} P^{\perp} [V_{\lambda} + K_{\lambda}]^{-1} P^{\perp} |H_{\lambda}|^{-\frac{1}{2}}.$$
 (2.8)

Now, using identity (2.8), estimate (2.5) and (2.6), we find, for $\lambda \in \Omega$,

$$\|H_0^{\frac{1}{2}}R^{\perp}(\lambda)H_0^{\frac{1}{2}}\| \le \frac{k\lambda_*}{\gamma_0}.$$
(2.9)

Furthermore, by the eigen-equation $H_0P = \lambda_0 P$, we have

$$\|H_0^{\frac{1}{2}}P\|^2 = \lambda_0. \tag{2.10}$$

Using expression (2.7) and estimates (2.9) and (2.10), we arrive at inequality (2.3). The analyticity follows from (2.7) and the analyticity of $R^{\perp}(\lambda)$.

For (d), since H_0 , W and P are self-adjoint, then so are $U(\lambda)$, for any $\lambda \in \Omega \cap \mathbb{R}$, and, since $U(\lambda)$ is bounded, $H(\lambda)$ is self-adjoint as well.

Proof of Theorem 1.1. Let Ω be given by equation (2.1). Recall that, by Lemma 2.1 and Theorem 1.2, the $m \times m$ matrix-family $H(\lambda) := F_P(H - \lambda) + \lambda P$, with F_P given in (1.10), is well defined, for each $\lambda \in \Omega$, and can be written as (1.15). Since $PHP = \lambda_0 P + PWP$, Eq. (1.15) can be rewritten as

$$H(\lambda) = \lambda_0 P + PWP + U(\lambda). \tag{2.11}$$

Eqs (2.3) and (2.11) imply the inequality

$$\|H(\lambda) - \lambda_0 P - PWP\| \le k\Phi(W). \tag{2.12}$$

By a fact from Linear Algebra, for each $\lambda \in \Omega \cap \mathbb{R}$, the total multiplicity of the eigenvalues of the $m \times m$ self-adjoint matrix $H(\lambda)$ is m.

Denote by $v_i(\lambda)$, i = 1, 2, ..., m, the eigenvalues of $H(\lambda)$, repeated according to their multiplicities. Eq (2.12) yields

$$|v_i(\lambda) - \lambda_0| \le \|PWP\| + k\Phi(W). \tag{2.13}$$

Indeed, let $P_i(\lambda)$ be the orthogonal projection onto Null $(H(\lambda) - v_i(\lambda))$. Then

$$H(\lambda)P_i(\lambda) = v_i(\lambda)P_i(\lambda),$$

which, due to (2.11) and $P_i(\lambda)P = P_i(\lambda)$, can be rewritten as

$$(v_i(\lambda) - \lambda_0)P_i(\lambda) = (PWP + U(\lambda))P_i(\lambda).$$

Equating the operator norms of both sides of this equation and using (2.12) and $||P_i(\lambda)|| = 1$ gives (2.13).

By Corollary 1.3, the eigenvalues of *H* in the interval $\Omega \cap \mathbb{R}$ are in one-to-one correspondence with the solutions of the equations

$$v_i(\lambda) = \lambda \tag{2.14}$$

in $\Omega \cap \mathbb{R}$. If this equation has a solution, then, due to (2.13), this solution would satisfy (1.6). Thus, we address (2.14). Let

$$\Omega' := \{ z \in \mathbb{R} : |z - \lambda_0| \le r\gamma_0 \},\tag{2.15}$$

with

$$r := \frac{1}{\gamma_0} \big(\|PWP\| + k\Phi(W) \big).$$

By our assumption (1.4), r < a < 1 - b.

Recall that by the definition, a branch point is a point at which the multiplicity of one of the eigenvalue families (branches) changes. One could think on a branch point as a point where two or more distinct eigenvalue branches intersect. Our next result shows that the eigenvalue branches of $H(\lambda)$ could be chosen in a differentiable way and estimates their derivatives.

Proposition 2.2. The following statements hold.

- i) The eigenvalues $v_i(\lambda)$ of $H(\lambda)$ and the corresponding eigenfunctions can be chosen to be differentiable for $\lambda \in \Omega'$.
- ii) The derivatives $v'_i(\lambda), \lambda \in \Omega'$, are bounded as

$$|\nu_i'(\lambda)| \le \frac{k}{a-r} \frac{\Phi(W)}{\gamma_0}.$$
(2.16)

iii) $v_i(\lambda)$ maps the interval Ω' into itself.

Consequently, since by (1.5) the r.h.s. of (2.16) is < 1, the equations $v_i(\lambda) = \lambda$ have unique solutions in Ω' .

Proof. Proof of (i) for simple λ_0 . For a simple eigenvalue λ_0 , *P* is a rank-one projection on the space spanned by the eigenvector φ_0 of H_0 corresponding to the eigenvalue λ_0 and therefore Eq. (2.11) implies that $H(\lambda) = v(\lambda)P$, with

$$\nu(\lambda) := \lambda_0 + \langle \varphi_0, (W + U(\lambda))\varphi_0 \rangle.$$

This and Lemma 2.1 show that the eigenvalue $v(\lambda)$ is analytic.

Proof of (i) for degenerate λ_0 . We pick an *arbitrary* point μ in Ω' and let $P_{\mu i}$ be the orthogonal projections onto the eigenspaces of $H(\mu)$ corresponding to the eigenvalues $v_i(\mu)$, i.e. for a fixed *i*, $P_{\mu i}$ projects on the spans of all eigenvectors with the same eigenvalue $v_i(\mu)$. We now show that, in a neighbourhood of μ , the eigenfunctions $\chi_i(\lambda)$ can be chosen in a differentiable way. We introduce the system of equations for the eigenvalues $v_i(\lambda)$ and corresponding eigenfunctions $\chi_i(\lambda)$:

$$\nu_i(\lambda) = \frac{\langle \chi_i(\lambda), H(\lambda)\chi_i(\lambda) \rangle}{\|\chi_i(\lambda)\|^2},$$
(2.17)

$$\chi_i(\lambda) = \chi_i(\mu) - R^{\perp}(\nu_i(\lambda), \lambda) W_{\lambda} \chi_i(\mu), \qquad (2.18)$$

where

$$R^{\perp}(\nu,\lambda) := P^{\perp}_{\mu i} (P^{\perp}_{\mu i} H(\lambda) P^{\perp}_{\mu i} - \nu)^{-1} P^{\perp}_{\mu i}, \qquad W_{\lambda} := U(\lambda) - U(\mu).$$

The expression on the right side of (2.18) is the *Q*-operator for $H(\lambda)$ and $P_{\mu i}$ defined according to (1.11) and applied to $\chi_i(\mu)$. Note that systems (2.17)-(2.18) for different indices *i* are not coupled. Furthermore, since $\chi_i(\mu)$ and $R^{\perp}(v_i(\lambda), \lambda)W_{\lambda}\chi_i(\mu)$ are orthogonal, we have $\|\chi_i(\lambda)\| \ge \|\chi_i(\mu)\|$; and $\chi_i(\lambda)$ and $\chi_j(\lambda)$ are almost orthogonal for $i \ne j$. Assuming this system has a solution $(v_i(\lambda), \chi_i(\lambda))$, we see that, by Theorem 1.2(d), with $P = P_{\mu i}, \chi_i(\lambda)$ are eigenfunctions of $H(\lambda)$ with the eigenvalues $v_i(\lambda)$ and (2.17) follows from the eigen-equation $H(\lambda)\chi_i(\lambda) = v_i(\lambda)\chi_i(\lambda)$.

For each *i*, we can reduce system (2.17)-(2.18) to the single equation for $v_i(\lambda)$, by treating $\chi_i(\lambda)$ in (2.17) as given by (2.18). This leads to the fixed point problem for the functions $v_i(\lambda)$:

$$v = F_i(v, \lambda),$$

where

$$F_i(\nu,\lambda) := \frac{\langle \chi_i(\nu,\lambda), H(\lambda)\chi_i(\nu,\lambda) \rangle}{\|\chi_i(\nu,\lambda)\|^2},$$

$$\chi_i(\nu,\lambda) := \chi_i(\mu) - R^{\perp}(\nu,\lambda)W_{\lambda}\chi_i(\mu).$$

Notice that since $P_{\mu i}^{\perp} H(\lambda) P_{\mu i}^{\perp}$ are self-adjoint, the resolvent $R^{\perp}(\nu, \lambda)$ and its derivatives in ν are uniformly bounded in a neighbourhood of $(\nu_i(\mu), \mu)$, which does not contain branch points, except, possibly, for μ .

To be more specific, the resolvent $R^{\perp}(\nu, \lambda)$ is uniformly bounded in a neighbourhood $\Omega_{\mu i}$ of $(\nu_i(\mu), \mu)$ whether μ is a branch point or not, as long as $\Omega_{\mu i}$ does not contain any other branch point than μ . Hence $F_i(v, \lambda)$ is differentiable in v and λ and $|\partial_v F_i(v, \lambda)| \to 0$, as $\lambda \to \mu$ (since $\partial_v \chi_i(v, \lambda) = R^{\perp}(v, \lambda)^2 W_{\lambda} \chi_i(\mu)$ and therefore

$$\|\partial_{\nu}\chi_{i}(\nu,\lambda)\| \leq \|R^{\perp}(\nu,\lambda)^{2}(H_{0}+\alpha)^{\frac{1}{2}}\|\|W_{\lambda}\|_{H_{0},\alpha}\|(H_{0}+\alpha)^{\frac{1}{2}}\chi_{i}(\mu)\| \to 0,$$

as $\lambda \to \mu$). Moreover, $v_i(\mu) - F_i(v_i(\mu), \mu) = 0$. Let $f_i(v, \lambda) := v - F_i(v, \lambda)$. Then, by the above, $f_i(v_i(\mu), \mu) = 0$ and $|\partial_v f_i(v, \lambda) - 1| \to 0$, as $\lambda \to \mu$. Thus, the implicit function theorem is applicable to the equation $f_i(v, \lambda) = 0$ and shows that there is a unique solution $v_i(\lambda)$ in a neighbourhood of $(v_i(\mu), \mu)$ and that this solution is differentiable in λ .

Next, we have

Lemma 2.3. We have, for $\lambda \in \Omega'$,

$$\nu_i'(\lambda) = \frac{\langle \chi_i(\lambda), U'(\lambda)\chi_i(\lambda) \rangle}{\|\chi_i(\lambda)\|^2}.$$
(2.19)

(Eq. (2.19) is closely related to the widely used Hellmann-Feynman theorem.)

Proof. Let $\hat{\chi}_i(\lambda) := \frac{\chi_i(\lambda)}{\|\chi_i(\lambda)\|}$. Writing equation (2.17) as

$$\nu_i(\lambda) = \langle \hat{\chi}_i(\lambda), H(\lambda) \hat{\chi}_i(\lambda) \rangle$$

and differentiating this with respect to λ , we obtain

$$v_i'(\lambda) = \langle \hat{\chi}_i(\lambda), H'(\lambda) \hat{\chi}_i(\lambda) \rangle + \eta(\lambda),$$

where $\eta(\lambda) := \langle \hat{\chi}'_i(\lambda), H(\lambda)\hat{\chi}_i(\lambda) \rangle + \langle \hat{\chi}_i(\lambda), H(\lambda)\hat{\chi}'_i(\lambda) \rangle$. Now, moving $H(\lambda)$ in the last term to the l.h.s. and using that $H(\lambda)\hat{\chi}_i(\lambda) = v_i(\lambda)\hat{\chi}_i(\lambda)$, we find

$$\eta(\lambda) = v_i(\lambda) [\langle \hat{\chi}'_i(\lambda), \hat{\chi}_i(\lambda) \rangle + \langle \hat{\chi}_i(\lambda), \hat{\chi}'_i(\lambda) \rangle] = v_i(\lambda) \partial_\lambda \langle \hat{\chi}_i(\lambda), \hat{\chi}_i(\lambda) \rangle = 0,$$

which implies (2.19).

To prove Eq. (2.16), we use formula (2.19) above and the normalization of $\hat{\chi}_i(\lambda)$ to estimate $\nu'_i(\lambda)$ as

$$|\nu_i'(\lambda)| \le \|U'(\lambda)\|. \tag{2.20}$$

To bound the r.h.s. of (2.20), we use the analyticity of $U(\lambda)$ in Ω and estimate (2.3). Indeed, by the Cauchy integral formula, we have

$$\|U'(\lambda)\| \leq \frac{1}{R\gamma_0} \sup_{|\lambda'-\lambda|=R\gamma_0} \|U(\lambda')\|,$$

with $R \le a - r$, so that $\{\lambda' \in \mathbb{C} : |\lambda' - \lambda| < R\gamma_0\} \subset \Omega$, for $\lambda \in \Omega'$. This, together with (2.3) and under the conditions of Lemma 2.1, gives the estimate

$$\|U'(\lambda)\| \le \frac{k}{a-r} \frac{\Phi(W)}{\gamma_0},\tag{2.21}$$

for $\lambda \in \Omega'$. Combining Eqs. (2.20) and (2.21), we arrive at (2.16).

Due to the definition of r after (2.15), we can rewrite estimate (2.13) as

$$|v_i(\lambda) - \lambda_0| \le r\gamma_0.$$

By (2.15), this shows that $v_i(\lambda)$ maps the interval Ω' into itself which proves (iii).

Hence, under condition (1.4), the fixed point equations $\lambda = v_i(\lambda)$ have unique solutions on the interval Ω' , proving Proposition 2.2.

By Corollary 1.3, the eigenvalues of H in Ω' are in one-to-one correspondence with the solutions of the equations $v_i(\lambda) = \lambda$. By Proposition 2.2, these equations have unique solutions, say, λ_i . Then, estimate (2.13) implies inequality (1.6).

To obtain estimate (1.7), we recall from Theorem 1.2 that $Q(\lambda_j)\varphi_{0j} = \varphi_j$, where the operator $Q(\lambda)$ is given by

$$Q(\lambda) := \mathbf{1} - R^{\perp}(\lambda) P^{\perp} W P,$$

 λ_j are the eigenvalues of *H* and φ_{0j} are eigenfunctions of H_0 corresponding to λ_0 . This gives

$$\varphi_{0j} - \varphi_j = \varphi_{0j} - Q(\lambda_j)\varphi_{0j} = R^{\perp}(\lambda_j)P^{\perp}WP.$$
(2.22)

Now, as in the derivation of (2.9), using identity (2.8), estimates (2.5) and

$$|||H_{\lambda}|^{-\frac{1}{2}}|| \le \frac{1}{\sqrt{(1-r)\gamma_0}}$$

and the estimate $||K_{\lambda}|| \leq \frac{b}{1-a}$, see (2.6), we find, for $\lambda \in \Omega'$,

$$\|R^{\perp}(\lambda)H_{0}^{\frac{1}{2}}\| \le \frac{k\lambda_{*}^{\frac{1}{2}}}{\gamma_{0}},$$
(2.23)

noting that r < a. sing inequalities (2.23) and (2.10), we estimate the r.h.s. of (2.22) as

$$\|R^{\perp}(\lambda_j)P^{\perp}WP\| \le k\sqrt{\frac{\Phi(W)}{\gamma_0}}.$$

This, together with (2.22), gives (1.7). This proves Theorem 1.1.

Remark 6. Differentiating (2.18) with respect to λ , setting $\lambda = \mu$, using $W_{\lambda=\mu} = 0$ and $W'_{\lambda} = U'(\lambda)$ and changing the notation μ to λ , we find the following formula for $\chi'_i(\lambda)$:

$$\chi_i'(\lambda) = -R^{\perp}(\nu_i(\lambda), \lambda)U'(\lambda)\chi_i(\lambda).$$

Finally we prove the relations (1.8) and (1.9) stated in the introduction.

Proof of (1.8). Eq. (2.11) gives

$$H(\lambda) = (\lambda_0 + \langle W \rangle + \langle U(\lambda) \rangle)P,$$

where we use the notation $\langle A \rangle := \langle \varphi_0, A\varphi_0 \rangle$. Since *P* is a rank one projection, it follows that $H(\lambda)$ has only one eigenvalue and this eigenvalue is

$$\nu_1(\lambda) = \lambda_0 + \langle W \rangle + \langle U(\lambda) \rangle.$$

This formula and estimate (2.3) show that $v_1(\lambda)$ obeys the estimate

$$|\nu_1(\lambda) - \lambda_0 - \langle W \rangle| \le k \Phi(W).$$

By Proposition 2.2, the eigenvalue λ_1 of *H* satisfies the equation $\lambda_1 = v_1(\lambda_1)$. Then the estimate above implies inequality (1.8).

Proof of Eq (1.9). Let *W* be symmetric and denote by μ_{\min} the smallest eigenvalue of the matrix *PWP*. Then $U(\lambda) \leq 0$ and (2.11) implies $H(\lambda) \leq \lambda_0 P + PWP$. This, together with $\inf A \leq \inf B$ for $A \leq B$, gives the upper bound $v_1(\lambda) \leq \lambda_0 + \mu_{\min}$ on the smallest eigenvalue-branch $v_1(\lambda)$ of $H(\lambda)$.

For the lower bound, Eqs (2.3) and (2.11) imply the following estimate

$$\lambda_0 + \mu_{\min} - k\Phi(W) \le \nu_1(\lambda).$$

The last two estimates and the equation $v_i(\lambda) = \lambda$ (see (1.12)) yield (1.9).

3 Application: The ground state energy of the Heliumtype ions

In this section, we will use the inequalities obtained above to estimate the ground state energy of the Helium-type ions, which is the simplest not completely solvable atomic quantum system. For simplicity, we assume that the nucleus is infinitely heavy, but we allow for a general nuclear charge $ze, z \ge 1$. Then the corresponding Schrödinger operator (describing 2 electrons of mass *m* and charge -e, and the nucleus of infinite mass and charge ze) is given by

$$H_{z,2} = \sum_{j=1}^{2} \left(-\frac{\hbar^2}{2m} \Delta_{x_j} - \frac{\kappa z e^2}{|x_j|} \right) + \frac{\kappa e^2}{|x_1 - x_2|},$$
(3.1)

acting on the space $L^2_{sym}(\mathbb{R}^6)$ of L^2 -functions symmetric (or antisymmetric) w.r.t. the permutation of x_1 and x_2^2 . Here $\kappa = \frac{1}{4\pi\varepsilon_0}$ is Coulomb's constant and ε_0 is the vacuum

²By the Pauli principle, the product of coordinate and spin wave functions should antisymmetric w.r.t. permutation of the particle coordinates and spins. Hence, in the two particle case, after separation of spin variables, coordinate wave functions could be either antisymmetric or symmetric.

permittivity. For z = 2, $H_{z,2}$ describes the Helium atom, for z = 1, the negative ion of the Hydrogen and for $2 < z \le 94$ (or ≤ 103 , depending on what one counts as stable elements), Helium-type positive ion. (We can call (3.1) with z > 103 a *z-ion*.)

It is well known that $H_{z,2}$ has eigenvalues below its continuum. Variational techniques give excellent upper bounds on the eigenvalues of $H_{z,2}$, but good lower bounds are hard to come by. Thus, we formulate

Problem 3.1. *Estimate the ground state energy of* $H_{z,2}$ *.*

The most difficult case is of z = 1, the negative ion of the hydrogen, and the problem simplifies as z increases.

Here we present fairly precise bounds on the ground state energy of $H_{z,2}$ implied by our actual estimates. However, the conditions under which these estimates are valid impose rather sever restrictions in z. We introduce the reference energy

$$E^{\text{ref}} := \frac{\kappa^2 e^4 m}{\hbar^2} = \alpha^2 m c^2$$

(twice the ground state energy of the hydrogen, or 2Ry), where *c* is the speed of light in vacuum and

$$\alpha = \kappa \frac{e^2}{\hbar c}$$

is the fine structure constant, whose numerical value, approximately 1/137. Let $E_{\#}^{(z)}$ stand for either $E_{z,2}^{\text{sym}}/E^{\text{ref}}$ or $E_{z,2}^{\text{as}}/E^{\text{ref}}$, the ground state energy of $H_{z,2}$ on either symmetric or anti-symmetric functions. We have

Proposition 3.2. Assume $z \ge 31.25$ for the symmetric space and $z \ge 170$ for the anti-symmetric one. Then the ground state energy of $H_{z,2}$ is bounded as

$$-c^{\#}z^{2} + w_{1}^{\#}z - \frac{10w_{2}^{\#}}{\gamma_{0}^{\#}} \le E_{\#}^{(z)} \le -c^{\#}z^{2} + w_{1}^{\#}z,$$
(3.2)

where, for symmetric functions, c = 1, $\gamma_0 = \frac{3}{8}$ and $w_1 \approx 0.6$ and $w_2 \approx 0.27$, defined in equations (3.13) and (3.15), and, for anti-symmetric functions, $c^{as} = \frac{5}{8}$, $\gamma_0^{as} = \frac{5}{72}$ and $w_1^{as} \approx 0.20$ and $w_2^{as} \approx 0.01$, defined in (3.12).

The approximate values of w_1 , w_2 , w_1^{as} and w_2^{as} are computed numerically in Appendix B. Here we report the stable digits of our computations.

The inequalities $z \ge 31.25$ and $z \ge 170$ come from condition (1.3), while estimates (3.2), from (1.8), with b = 0.8 and a = 0.1 (which give k = 10).

Table 1 compares the result for symmetric functions with computations in quantum chemistry. (We did not find results for the antisymmetric space.)

We observe that, except for z = 50, the results of [16, 17, 18] lie in the interval provided by the estimation (3.2).

Table 1: Comparison of non-rigorous computations (see [8, 9, 16, 17, 18]) with the main part $-E_{z,2}^{\text{sym,lead}} := z^2 - w_1 z$ in equation (3.2), its relative contribution of the error estimation $\Delta_z := 10w_2/(-E_{z,2}^{\text{sym,lead}}\gamma_0)$ and the relative difference defined by $\text{err}_z := |E_{\text{exact}} - E_{z,2}^{\text{sym,lead}}|/(-E_{z,2}^{\text{sym,lead}})$.

For computations of the relativistic and QED contributions, see [10, 18, 19].

Now, we derive some consequences of estimates (3.2).

Let z_* be the smallest z for which the error bound in the symmetric case is less than or equal to the smallest explicit (subleading) term w_1 . Inequality (3.2) shows that the latter bound is satisfied for z such that $w_1z \ge \frac{10w_2}{\gamma_0}$, which shows that $z_* = \frac{10w_2}{w_1\gamma_0}$ and consequently,

 $z_* \approx 12.$

According to equation (3.2), the symmetric ground state energy is lower than the anti-symmetric one, if $-z^2 + w_1 z < -\frac{5}{8}z^2 + w_1^{as}z - 160 w_2^{as}$. Using the values $w_1 \approx 0.6, w_2 \approx 0.3, w_1^{as} \approx 0.20$ and $w_2^{as} \approx 0.01$, we find that, based on (3.2), the ground state is symmetric and therefore its spin is 0 for

$$z \ge \frac{4}{3}\left(\frac{2}{5} + \sqrt{\frac{4}{25} + \frac{96}{5}}\right) = \frac{8}{3} \approx 2.6.$$

We conjecture that the symmetric ground state energy is lower than the anti-symmetric one for all *z*'s.

Finally, note that on symmetric functions, the eigenvalue of the unperturbed operator is simple and on anti-symmetric ones, has the degeneracy 4, see below.

Proof of Proposition 3.2. First, we rescale the Hamiltonian (3.1) as $x \to x/\mu$, with

$$\mu := \frac{z \kappa e^2 m}{\hbar^2} = \frac{z}{\text{the Bohr radius}},$$

to obtain

$$U_{\mu}^{-1}H_{z,2}U_{\mu} = \frac{z^{2}\kappa^{2}e^{4}m}{\hbar^{2}}H^{(z)},$$

where $U_{\mu}: \psi(x) \to \mu^{3} \psi(\mu x)$ and $H^{(z)}$ is the rescaled Hamiltonian given by

$$H^{(z)} = \sum_{j=1}^{2} \left(-\frac{1}{2} \Delta_{x_j} - \frac{1}{|x_j|} \right) + \frac{1/z}{|x_1 - x_2|}.$$

Thus, it suffices to estimate the ground state energy of $H^{(z)}$. We consider

$$W = \frac{1/z}{|x_1 - x_2|}$$

as the perturbation and $\sum_{j=1}^{2} \left(-\frac{1}{2}\Delta_{x_j} - \frac{1}{|x_i|}\right)$ as the unperturbed operator.

First, we consider the rescaled Hamiltonian $H^{(z)}$ on the *symmetric* functions subspace. On symmetric functions, the ground state energy of $\sum_{j=1}^{2} \left(-\frac{1}{2}\Delta_{x_{j}} - \frac{1}{|x_{j}|}\right)$ is -1 (see below), so we shift the operator $H^{(z)}$ by $1 + \beta$, for some $\beta > 0$, so that

$$H^{(z)} + 1 + \beta = H_0 + W,$$

with

$$H_0 := \sum_{j=1}^2 \left(-\frac{1}{2} \Delta_{x_j} - \frac{1}{|x_j|} \right) + 1 + \beta \text{ and } W = \frac{1/z}{|x_1 - x_2|}.$$

Now, the ground state energy of H_0 is β and we can use inequality (1.8) and Proposition 1.4(c) to estimate the ground state energy of $H^{(z)} + 1 + \beta$.

By the HVZ theorem, the spectrum of H_0 on symmetric functions consists of the continuum $[e_1 + 1 + \beta, \infty)$ and the eigenvalues $e_m + e_n + 1 + \beta, m, n \ge 1$, where $e_n, n = 1, 2, \ldots$, denote the discrete eigenvalues of the Hydrogen Hamiltonian $-\frac{1}{2}\Delta_x - \frac{1}{|x|}$. The eigenvalues $e_n, n = 1, 2, \ldots$, are known explicitly:

$$e_n = -\frac{1}{2n^2},\tag{3.3}$$

with the multiplicities of n^2 and the corresponding eigenfunctions are given by Eq (A.1) below.

Then the ground state energy of H_0 is $\lambda_0 = 2e_1 + 1 + \beta = \beta$, as claimed, and the gap, $\gamma_0 = e_1 + e_2 - 2e_1 = e_2 - e_1 = 3/8$.

Next, we show that the condition (1.3) is satisfied for $z \ge 31.25$. We begin with the really rough estimate:

$$\frac{1}{|x_1 - x_2|} \le h_{x_1} + h_{x_2} + 10, \tag{3.4}$$

where $h_x := -\frac{1}{2}\Delta_x - \frac{1}{|x|}$. First, we use Hardy's inequality, $-\Delta \ge \frac{1}{4|x|^2}$, and the estimate $\frac{1}{4m|x|^2} - \frac{1}{|x|} \ge -m$ to obtain

$$-\frac{1}{m}\Delta - \frac{1}{|x|} \ge -m. \tag{3.5}$$

Next, passing to the relative and centre-of-mass coordinates, x - y and $\frac{1}{2}(x + y)$, we find

$$-\Delta_x - \Delta_y = -2\Delta_{x-y} - \frac{1}{2}\Delta_{\frac{1}{2}(x+y)} \ge -2\Delta_{x-y}.$$

which, together with (3.5), yields

$$\frac{1}{|x_1 - x_2|} \le -\frac{1}{2}\Delta_{x_1 - x_2} + 2 \le -\frac{1}{4}(\Delta_{x_1} + \Delta_{x_2}) + 2$$

Now, we use $-\frac{1}{2}\Delta_x = h_x + \frac{1}{|x|} \le h_x - \frac{1}{4}\Delta_x + 4$ to obtain

$$-\frac{1}{4}\Delta_x \le h_x + 4.$$

The last two inequalities yield (3.4). Eq. (3.4), together with the relation

$$H_0 = h_{x_1} + h_{x_2} + 1 + \beta_2$$

implies the estimate:

$$\frac{1}{|x_1 - x_2|} \le H_0 + 9 - \beta. \tag{3.6}$$

Now, we check the condition (1.3):

$$\|P^{\perp}WP^{\perp}\|_{H_0} \leq \frac{b\gamma_0}{\lambda_*}.$$

Using the last relation, we estimate

$$z(H_0^{\perp})^{-\frac{1}{2}}W(H_0^{\perp})^{-\frac{1}{2}} \le (H_0^{\perp})^{-1}(H_0^{\perp} + 9 - \beta)$$

= 1 + (9 - \beta)(H_0^{\perp})^{-1}.

Recalling that $\lambda_0 = \beta$, we see that $H_0^{\perp} \ge \beta + \gamma_0$, so that the last inequality gives

$$0 \le (H_0^{\perp})^{-\frac{1}{2}} W(H_0^{\perp})^{-\frac{1}{2}} \le \frac{1}{z} \frac{9 + \gamma_0}{\beta + \gamma_0},$$

provided $\beta < 9$. This implies

$$\|P^{\perp}WP^{\perp}\|_{H_0} \le \frac{1}{z} \frac{9 + \gamma_0}{\beta + \gamma_0}.$$
(3.7)

Since $\lambda_* = \beta + \gamma_0$, condition (1.3) is satisfied, if $\frac{9+\gamma_0}{z} \le b\gamma_0$, which gives $z \ge \frac{9+\gamma_0}{b\gamma_0}$. Since $\gamma_0 = 3/8$ and b = 0.8, this implies $z \ge 31.25$. We will need the following lemma, whose proof is given after the proof of the proposition.

Lemma 3.3. Recall that *P* is the orthogonal projection onto the eigenspace of H_0 corresponding to the lowest eigenvalue β . We have

$$\langle W \rangle = \|PWP\| = \frac{w_1}{z} \quad and \quad \Phi(W) \le \frac{w_2}{z^2 \gamma_0},$$
(3.8)

with, recall, $\langle W \rangle := \langle \varphi_0, W \varphi_0 \rangle$, where φ_0 is the eigenfunction of H_0 corresponding to λ_0 .

We check now the second condition of Theorem 1.1, (1.4). Recall the definition

$$r := \frac{\|PWP\| + k\Phi(W)}{\gamma_0}.$$

Then condition (1.4) can be written as r < a. By Lemma 3.3,

$$r \leq \frac{1}{\gamma_0} \left(\frac{w_1}{z} + \frac{kw_2}{z^2 \gamma_0} \right).$$

Recall the condition $z \ge 31.25$ and k = 10, $w_1 \approx 0.6$ and $w_2 \approx 0.3$. Thus

$$\frac{kw_2}{z^2\gamma_0} \le \frac{w_1}{z} \frac{kw_2}{31.25\,\gamma_0\,w_1} \le 0.5\,\frac{w_1}{z}.$$

Then we find $r \le 1.5 \frac{w_1}{z\gamma_0}$ and therefore condition (1.4) is satisfied if $a > 1.5 \frac{w_1}{z\gamma_0}$, or (for a = 0.1)

$$z > \frac{3}{2} \frac{8}{3} \frac{0.6}{a} = 24.$$

This is less restrictive than $z \ge 31.25$.

For the third condition (1.5), recalling that $\lambda_0 = \beta$, so that $\lambda_* = \gamma_0 + \beta$ (= λ_1 , the second eigenvalue of H_0) and using both relations in (3.8), we obtain that condition (1.5) is satisfied if $kw_2/(z^2\gamma_0) < \frac{1}{2}(a\gamma_0 - w_1/z)$, which is equivalent to

$$z>\frac{1}{2a\gamma_0}\left(w_1+\sqrt{w_1^2+8akw_2}\right).$$

Using the values $\gamma_0 = \frac{3}{8}$, $w_1 \approx 0.6$ and $w_2 \approx 0.3$, and b = 0.8 and a = 0.1, giving k = 10, this shows that the latter inequality, and therefore (1.5), holds if z > 30, which is less restrictive than $z \ge 31.25$. Thus, all three conditions are satisfied for $z \ge 31.25$.

Next, we use (1.8) to estimate the ground state energy, $E_{\text{sym}}^{(z)}$ of $H^{(z)}$. The first and second relations in (3.8), together with (1.8) and the fact that $U(\lambda) \leq 0$, gives the following bounds

$$-\frac{kw_2}{\gamma_0 z^2} \le E_{\text{sym}}^{(z)} + 1 - \frac{w_1}{z} \le 0.$$

which after rescaling gives (3.2).

Now, we consider the ground state of $H^{(z)}$ on *anti-symmetric* functions. In this case, the ground state energy of $\sum_{j=1}^{2} \left(-\frac{1}{2}\Delta_{x_j} - \frac{1}{|x_i|}\right)$ is $e_1 + e_2 = -\frac{5}{8}$ of multiplicity 4, with the ground states

$$\phi_{2\ell k}(x_1, x_2) := \frac{1}{\sqrt{2}} (\psi_{100}(x_1) \psi_{2\ell k}(x_2) - \psi_{2\ell k}(x_1) \psi_{100}(x_2)), \tag{3.9}$$

for $(\ell, k) = (0, 0), (1, -1), (1, 0), (1, 1)$, where $\psi_{n\ell k}(x)$ for $\ell = 0, 1, 2, ..., n - 1, k = -\ell, -\ell + 1, ..., \ell, n = 1, 2, ...,$ are the eigenfunctions of the Hydrogen-like Hamiltonian

 $-\frac{1}{2}\Delta_x - \frac{1}{|x|}$ corresponding to eigenvalues e_n , so that $\psi_{100}(x) = \psi_1(x)$, see Appendix A. Now, we define the unperturbed operator as

$$H_0 := \sum_{j=1}^2 \left(-\frac{1}{2} \Delta_{x_j} - \frac{1}{|x_j|} \right) + \frac{5}{8} + \beta,$$

to have β as the lowest eigenvalue of H_0 .

For the gap, since the first two eigenvalues are

$$e_1 + e_2 + \frac{5}{8} + \beta = \beta$$
 and $e_1 + e_3 + \frac{5}{8} + \beta(\langle e_2 + e_2 + \frac{5}{8} + \beta),$

we have $\gamma_0^{as} = e_1 + e_3 - (e_1 + e_2) = e_3 - e_2$ giving $\gamma_0^{as} = \frac{5}{72}$.

For condition (1.3), note first that since now $H_0 = h_{x_1} + h_{x_2} + \frac{5}{8} + \beta$, Eq. (3.4) implies

$$\frac{1}{|x_1 - x_2|} \le H_0 + 9 + \frac{3}{8} - \beta,$$

instead of (3.6), which shows that (3.7) should be modified as

$$\|P^{\perp}WP^{\perp}\|_{H_0} \le \frac{1}{z} \frac{9 + \frac{3}{8} + \gamma_0^{\mathrm{as}}}{\beta + \gamma_0^{\mathrm{as}}},$$

in the anti-symmetric case. Since $\lambda_*^{as} = \beta + \gamma_0^{as}$, condition (1.3) is satisfied, if $\frac{1}{z}(9 + \frac{3}{8} + \frac{1}{2})$ $\gamma_0^{\rm as}) \le b \gamma_0^{\rm as}$, which gives

$$z \ge \frac{9 + \frac{3}{8} + \gamma_0^{\mathrm{as}}}{b\gamma_0^{\mathrm{as}}}.$$

Since $\gamma_0^{as} = \frac{5}{72}$ and b = 0.8, this implies $z \ge 170$ for the anti-symmetric case. We skip the verification of conditions (1.4) and (1.5), which are simpler and similar to that of the symmetric case.

To estimate the ground state energy, $E_{as}^{(z)}$, of $H^{(z)}$ on anti-symmetric functions, we use bound (1.9). First, we claim that $\Phi(W)$ defined in (1.2) satisfies (cf. Remark 2)

$$\Phi(W) \le \frac{\mu_{\max}}{\gamma_0^{\rm as}},\tag{3.10}$$

where μ_{max} is the largest eigenvalue of the positive, 4×4 -matrix $PWP^{\perp}WP$. Indeed, recall that

$$\Phi(W) := \frac{\lambda_0 \lambda_* \|P^\perp W P\|_{H_0}^2}{\gamma_0^{\mathrm{as}}}$$

with $\lambda_0 = \beta$ and observe that $\|PWP^{\perp}\|_{H_0} = \|A\|$, with $A := H_0^{-\frac{1}{2}}PWP^{\perp}H_0^{-\frac{1}{2}}$. Using now the relations

$$AA^* = H_0^{-\frac{1}{2}} PWP^{\perp} H_0^{-1} WPH_0^{-\frac{1}{2}},$$

$$H_0^{-\frac{1}{2}}P = \lambda_0^{-\frac{1}{2}}P$$
 (since $H_0P = \lambda_0P$), and $H_0^{-1}P^{\perp} \le \lambda_*^{-1}P^{\perp}$, we find
 $AA^* \le (\lambda_0\lambda_*)^{-1}PWP^{\perp}WP$,

which, together with $||A|| = ||A^*|| = ||AA^*||^{\frac{1}{2}}$, gives

$$\|PWP^{\perp}\|_{H_0}^2 \le (\lambda_0 \lambda_*)^{-1} \|PWP^{\perp}WP\|.$$
(3.11)

Since $PWP^{\perp}WP \ge 0$, we have $||PWP^{\perp}WP|| = \mu_{max}$, which gives (3.10).

Hence, we have to compute the smallest eigenvalue μ_{\min} of the 4 × 4 matrix PWP and the largest eigenvalue, μ_{max} , of the positive, 4×4 -matrix $PWP^{\perp}WP$, see (1.9).

By scaling, it is easy to see that the matrices PWP and $PWP^{\perp}WP$ are of the form $PWP = z^{-1}A$ and $PWP^{\perp}WP = z^{-2}B$, where A and B are z-independent 4×4 matrices. Hence

$$\mu_{\min} = \frac{w_1^{as}}{z} \quad \text{and} \quad \mu_{\max} = \frac{w_2^{as}}{z^2},$$
(3.12)

for some positive z-independent constants w_1^{as} and w_2^{as} . These constants are computed in Appendix B. Now, we see that (1.9) and (3.10) give

$$\frac{w_1^{\rm as}}{z} - \frac{kw_2^{\rm as}}{\gamma_0^{\rm as} z^2} \le E_{\rm as}^{(z)} + \frac{5}{8} \le \frac{w_1^{\rm as}}{z},$$

which after rescaling and setting k = 10 gives (3.2) in the antisymmetric case.

Proof of Lemma 3.3. The ground state energy, e_1 , of $-\frac{1}{2}\Delta_x - \frac{1}{|x|}$ is non-degenerate, with the normalized ground state (known as the 1s wavefunction) given by (see e.g. [7], or Wiki, with a_0 replaced by 1 due to the rescaling above)

$$\psi_1(x) = \frac{1}{\sqrt{\pi}} e^{-|x|}.$$

Hence, the ground state energy, 0, of H_0 is also non-degenerate, with the normalized ground state $\psi_1(x_1)\psi_1(x_2)$ (in the symmetric subspace).

First, we compute $\langle W \rangle$ and ||PWP||. Let $(\psi \otimes \phi)(x, y) := \psi(x) \phi(y)$ and, for an operator A on $L^2(\mathbb{R}^6)$, we denote $\langle A \rangle := \langle \psi_1 \otimes \psi_1, A \psi_1 \otimes \psi_1 \rangle$. In the symmetric case, $PWP = \langle W \rangle P$, where

$$\langle W \rangle := \langle \psi_1 \otimes \psi_1, W \psi_1 \otimes \psi_1 \rangle = \frac{1}{z} \int_{\mathbb{R}^6} \frac{|\psi_1(x)\psi_1(y)|^2}{|x-y|} \, dx \, dy =: \frac{1}{z} w_1. \tag{3.13}$$

Hence $||PWP|| = \frac{w_1}{z}$. This gives the first relation in (3.8). Now, using that $P^{\perp} = \mathbf{1} - P$, we compute

$$PWP^{\perp}WP = PW^2P - PWPWP = \frac{w_2}{z^2}P,$$
(3.14)

and

$$w_{2} := z^{2} \left(\langle W^{2} \rangle - \langle W \rangle^{2} \right)$$

= $\int_{\mathbb{R}^{6}} \frac{|\psi_{1}(x)\psi_{1}(y)|^{2}}{|x-y|^{2}} dx dy - \left(\int_{\mathbb{R}^{6}} \frac{|\psi_{1}(x)\psi_{1}(y)|^{2}}{|x-y|} dx dy \right)^{2}.$ (3.15)

By the Schwarz inequality and the normalization of ψ_1 , we have $w_2 \ge 0$, which, together with (3.14), gives

$$\|PWP^{\perp}WP\| = \frac{w_2}{z^2}.$$
 (3.16)

Eqs. (3.11) and (3.16) imply the second relation in (3.8).

A The eigenfunctions of the Hydrogen-like Hamiltonian

The eigenfunctions $\psi_{n\ell k}(x)$ are given by (see Wiki, "Hydrogen atom" with a_0 replaced by 1)

$$\psi_{n\ell k}(x) = \sqrt{\left(\frac{2z}{n}\right)^3 \frac{(n-\ell-1)!}{2n(n+\ell)!}} e^{-\rho/2} \rho^\ell L_{n-\ell-1}^{2\ell+1}(\rho) Y_\ell^k(\theta,\phi), \tag{A.1}$$

for $\ell = 0, 1, 2, ..., n-1, k = -\ell, -\ell+1, ..., \ell, n = 1, 2, ...$ Here (r, θ, ϕ) are the polar coordinates of $x, \rho = \frac{2zr}{n}, L_{n-\ell-1}^{2\ell+1}(\rho)$ is a generalized Laguerre polynomial of degree $n - \ell - 1$, and $Y_{\ell}^{k}(\theta, \phi)$ is a spherical harmonic function of the degree ℓ and order k.³

B The numerical approximation of the constants w_1 , w_2 , w_1^{as} and w_2^{as}

Let us first focus on w_1 and w_2 . From the definition

$$w_1 := \int_{\mathbb{R}^6} \frac{|\psi_1(x)\psi_1(y)|^2}{|x-y|} \, dy \, dx,$$

$$w_2 := \int_{\mathbb{R}^6} \frac{|\psi_1(x)\psi_1(y)|^2}{|x-y|^2} \, dy \, dx - w_1^2,$$

it becomes clear that we need to compute terms of the form

$$C_{\alpha} = \int_{\mathbb{R}^{6}} \frac{|\psi_{1}(x)\psi_{1}(y)|^{2}}{|x-y|^{\alpha}} dy dx$$
$$= \int_{\mathbb{R}^{3}} |\psi_{1}(x)|^{2} \int_{\mathbb{R}^{3}} \frac{|\psi_{1}(x-z)|^{2}}{|z|^{\alpha}} dz dx,$$

with $\alpha = 1, 2$. We thus introduce a numerical quadrature in order to approximate the values of these integrals. We do not aim within this work to obtain the most efficient implementation. We define a numerical quadrature grid in terms of spherical coordinates with integration points $x_{i,n}$ and weights $\omega_{i,n}$ given by

$$x_{i,n} = r_i s_n, \qquad \omega_{i,n} = h r_i^3 \omega_n^{\text{let}}$$

with

$$r_i = \exp(-\ln(R_{\max}) + (i-1)h), \qquad i = 1, \dots, N_r, \qquad h = \frac{2\ln(R_{\max})}{N_r - 1}$$

and where $\{s_n, \omega_n^{\text{leb}}\}\$ denote Lebedev integration points on the unit sphere with N_{leb} points. Thus, N_r denotes the number of points along the *r*-coordinate, R_{max} the radius of the furthest points away from the origin.

We thus approximate C_{α} by

$$C_{\alpha} \approx \sum_{i=1}^{N_r} \sum_{n=1}^{N_{\text{leb}}} \omega_{i,n} |\psi_1(x_{i,n})|^2 \Phi_{\alpha}(x_{i,n})$$

with

$$\Phi_{\alpha}(x_{i,n}) = \sum_{j=1}^{N_r} \sum_{m=1}^{N_{\text{leb}}} \omega_{j,m} \frac{|\psi_1(x_{i,n} - x_{j,m})|^2}{|x_{j,m}|^{\alpha}}.$$

Then, we approximate $w_1 \approx C_1$ and $W_2 \approx C_2 - C_1^2$.

We now shed our attention to the constants w_1^{as} and w_2^{as} and we first introduce the bi-electronic integrals, for $(\ell, k), (\ell', k') = (0, 0), (1, -1), (1, 0), (1, 1)$, by

$$\begin{aligned} \mathsf{A}_{\ell,k}^{\ell',k'} &= \int_{\mathbb{R}^3} \psi_{2\ell k}(x) \psi_{2\ell'k'}(x) \int_{\mathbb{R}^3} \frac{|\psi_1(y)|^2}{|x-y|} \, dy \, dx, \\ \mathsf{B}_{\ell,k}^{\ell',k'} &= \int_{\mathbb{R}^3} \psi_1(x) \psi_{2\ell'k'}(x) \int_{\mathbb{R}^3} \frac{\psi_1(y) \psi_{2\ell k}(y)}{|x-y|} \, dy \, dx. \end{aligned}$$

Then, using the definition (3.9) and symmetry properties, we derive the following expressions for the matrix elements

$$\mathsf{M}_{\ell,k}^{\ell',k'} = z \left\langle \psi_{2\ell k} | W | \psi_{2\ell' k'} \right\rangle = \mathsf{A}_{\ell,k}^{\ell',k'} - \mathsf{B}_{\ell,k}^{\ell',k'}.$$




Figure 1: Value of the approximate coefficients w_1, w_2, w_1^{as} and w_2^{as} depending on the quadrature rule reported in Table 2.

We then employ the same quadrature rule as above to approximate the matrix elements $A_{\ell,k}^{\ell',k'}, B_{\ell,k}^{\ell',k'}$ and compute the smallest eigenvalue of M as an approximation of w_1^{as} . Finally, the approximation of w_2^{as} involves the matrix

$$PWP^{\perp}WP = PW^2P - PWPWP,$$

whose elements are given by $Q = N - M^2$ with

$$\mathsf{N}_{\ell,k}^{\ell',k'} = z^2 \left\langle \psi_{2\ell k} | W^2 | \psi_{2\ell'k'} \right\rangle = \mathsf{C}_{\ell,k}^{\ell',k'} - \mathsf{D}_{\ell,k}^{\ell',k'}$$

and

$$\begin{aligned} \mathsf{C}_{\ell,k}^{\ell',k'} &= \int_{\mathbb{R}^3} \psi_{2\ell k}(x) \psi_{2\ell'k'}(x) \int_{\mathbb{R}^3} \frac{|\psi_1(y)|^2}{|x-y|^2} \, dy \, dx, \\ \mathsf{D}_{\ell,k}^{\ell',k'} &= \int_{\mathbb{R}^3} \psi_1(x) \psi_{2\ell'k'}(x) \int_{\mathbb{R}^3} \frac{\psi_1(y) \psi_{2\ell k}(y)}{|x-y|^2} \, dy \, dx. \end{aligned}$$

We then again, approximate the different integrals with the above introduced quadrature rule and find the maximal eigenvalue of Q in order to approximate w_2^{as} .

In Figure 1, we plot the the approximate value of w_1, w_2, w_1^{as} and w_2^{as} for different values of the parameters R_{max} , N_r and N_{leb} given in Table 2.

We obtain approximate values

$$w_1 \approx 0.625, \quad w_2 \approx 0.2628, \quad w_1^{as} \approx 0.3, \quad w_2^{as} \approx 0.01$$

where the last reported digit is stable over the last three quadrature rules.
