preliminary issues of finite element relaxation schemes for elastodynamics from physical modeling through analytical studies for numerical purposes

• relaxation approximations support *entropy inequalities* – dissipative mechanism and damping effects on oscillations

- stability/convergence of finite elements schemes
- computational performance *adaptive meshing* yields an extra stabilization against the nonlinear response over shock regions

physical modeling : relaxation mechanisms in continuum mechanics and kinetic theory (models for elastodynamics, traffic flows, time decaying of chemical elements, biological systems with reaction time)

analytical studies : diffusive relaxation limits for hyperbolic systems by means of compensated compactness techniques, singular perturbations of first order hyperbolic (pseudo-differential) equations, BGK-type approximations towards degenerate parabolic equations

Chapman-Enskog expansions and parabolic scaling of hyperbolic systems to evidence diffusive behaviors, under a sub-characteristic condition

diffusive stress relaxation for elastodynamics in one space dimension

- deformation gradient  $u^{\varepsilon}(t,x) \in \mathbb{R}$  and velocity  $v^{\varepsilon}(t,x) \in \mathbb{R}$
- kinematic viscosity  $\mu = \mu(\varepsilon) > 0$ , relaxation parameter  $\varepsilon > 0$

non-homogeneous (strictly) hyperbolic  $3 \times 3$  semilinear system

$$\begin{array}{l} u_t^{\varepsilon} - v_x^{\varepsilon} = 0 \\ v_t^{\varepsilon} - Z_x^{\varepsilon} = 0 \\ \varepsilon Z_t^{\varepsilon} - \mu \, v_x^{\varepsilon} = -Z^{\varepsilon} + S(u^{\varepsilon}) \end{array}$$

with the corresponding system for the original fields (one-field equation)

$$\begin{cases} u_t^{\varepsilon} - v_x^{\varepsilon} = 0\\ v_t^{\varepsilon} - S(u^{\varepsilon})_x - \mu v_{xx}^{\varepsilon} + \varepsilon v_{tt}^{\varepsilon} = 0 \end{cases}$$

from the  $2 \times 2$  incompletely parabolic system of visco-elastodynamics

- supplementary relaxation variable  $Z^{\varepsilon}(t,x) \in \mathbb{R}$  for the *Piola-Kirchoff* stress-strain tensor  $S : \mathbb{R} \to \mathbb{R}$  (gradient of a convex internal/stored energy for hyper-elastic materials with nonlinear response).

viscoelastic materials exhibit <u>time dependent stress-strain response</u> when undergoing deformations : viscosity/relaxation approximations describe the (isothermal) motion in Lagrangian coordinates (with diffusive stress)

$$\left(Z^{\varepsilon}-\frac{\mu}{\varepsilon}u^{\varepsilon}\right)_{t}=-\frac{1}{\varepsilon}\left(Z^{\varepsilon}-S(u^{\varepsilon})\right)$$

which can be recast as

$$Z^{\varepsilon} = \frac{\mu}{\varepsilon} u^{\varepsilon} - \int_{-\infty}^{t} \frac{1}{\varepsilon} \exp(-\frac{t-s}{\varepsilon}) \left(\frac{\mu}{\varepsilon} u^{\varepsilon} - S(u^{\varepsilon})\right)(s) \, ds$$

and the relaxation effects come from an (integral) memory-type term

putting  $\varepsilon = 0$  into the system, the equilibrium relation  $Z = S(u) + \mu v_x$  is formally recovered, that is interpreted as the passage from viscosity of the memory-type to viscosity of the rate-type

 for visco-elastodynamics, the well-posedness in Sobolev spaces for large data is guaranteed by the results on weakly parabolic systems

– in one space dimension, the assumption that the nonlinear flux (stress-strain function) is globally Lipschitz,  $\sup_{u \in \mathbb{R}} |S'(u)| < +\infty$ , stands for the <u>sub-characteristic condition</u> (the relaxation finite element scheme yields weak solutions that dissipate all convex entropies, for the *method of symmetrizers*, and the *compensated compactness* theory holds)

- in multi-dimensional systems, a sufficient condition to compensate for the lack of parabolicity is a poly-convexity (or growth) assumption on the internal/stored energy

- these are structural properties, whereas it should be proven for Navier-Stokes and Euler equations

• Y. Brenier, R. Natalini, M. Puel, On a relaxation approximation of the incompressible Navier-Stokes equations, *Proc. Amer. Math. Soc.* (2004) features that make finite element methods computationally attractive :

- formal high-order accuracy for smooth solutions, nonlinear stability
- in curved (spatial) domains, to easily incorporate complex geometries, and support domain decomposition techniques for parallelization
- inherent implicit-explicit discretization of nonlinear terms

difficulties to solve hyperbolic and convection-dominated problems :

- to choose the correct regularization mechanism, to capture discontinuities or strong gradients without producing spurious oscillations

- for relaxation approximations, the number of unknowns is increased

## RELAXATION + ADAPTIVE MESHING

provides a *dissipative mechanism against the destabilizing effect of nonlinear response*, combined with appropriate *mesh refinement* (by means of an error indicator) *to detect the location of the singularities*

## standard semi-discrete finite element schemes

• let  $\mathbb{T}_h$  be (uniformly regular) partitions, with characteristic lenght h > 0• (conforming) finite element spaces  $W_{h,k} \subset H_0^1$ ,  $k \ge 1$ , of piecewise polynomials (globally continuous) on  $\mathbb{T}_h$  with consistency properties

$$\inf_{w_h \in W_{h,k}} \left( \|w_h - w\|_{L^2} + h \|w_h - w\|_{H^1} \right) \le C h^k \|w\|_{H^k}$$

- homogeneous/periodic boundary conditions
- finite element space  $W_{h,k-1} \subset L^2$  of piecewise discontinuous polynomials variational formulation : to find  $u_h^{\varepsilon}, v_h^{\varepsilon}, Z_h^{\varepsilon} \in W_{h,k}$  solution to

$$\begin{split} &\langle \partial_t u_h^{\varepsilon}, \phi^1 \rangle + \langle v_h^{\varepsilon}, \partial_x \phi^1 \rangle = 0 \\ &\langle \partial_t v_h^{\varepsilon}, \phi^2 \rangle + \langle Z_h^{\varepsilon}, \partial_x \phi^2 \rangle = 0 \\ &\varepsilon \langle \partial_t Z_h^{\varepsilon}, \phi^3 \rangle + \mu \langle v_h^{\varepsilon}, \partial_x \phi^3 \rangle = - \langle Z_h^{\varepsilon}, \phi^3 \rangle + \langle S(u_h^{\varepsilon}), \phi^3 \rangle \end{split}$$

for all  $\phi^1, \phi^2, \phi^3 \in W_{h,k}$  (for the computational issues, *semi-implicit discretizations in time* are eventually considered, for which analogous estimates could also be proven)

for  $\mu > \varepsilon$ , the system admits a positive definite symmetrizer

$$\mathsf{H}^{\varepsilon} = \left( \begin{array}{cc} \mu/\varepsilon & 0 & -1 \\ 0 & \mu/\varepsilon - 1 & 0 \\ -1 & 0 & 1 \end{array} \right)$$

which defines the hessian of a *convex entropy-entropy flux pair* (with dissipative behavior for the stiff/lower order source term)

$$egin{aligned} &\eta(\mathsf{w}^arepsilon) = rac{1}{2}ig(rac{\mu}{arepsilon}-1ig)ig(|u^arepsilon|^2+|v^arepsilon|^2ig) + rac{1}{2}\,|u^arepsilon-Z^arepsilon|^2\ &q(\mathsf{w}^arepsilon) = -ig(rac{\mu}{arepsilon}-1ig)v^arepsilon Z^arepsilon \end{aligned}$$

with  $w^{\varepsilon} = (u^{\varepsilon}, v^{\varepsilon}, Z^{\varepsilon})^{T}$ , in the sense that  $H^{\varepsilon}w^{\varepsilon} = \nabla_{w^{\varepsilon}}\eta(w^{\varepsilon})$  because of the symmetry, the *mechanical energy* is given by

$$E^{\varepsilon}(\mathsf{w}^{\varepsilon}) = \int_{\mathbb{R}} \eta(\mathsf{w}^{\varepsilon}) \, d\mathsf{x} = \frac{1}{2} \langle \mathsf{H}^{\varepsilon} \mathsf{w}^{\varepsilon}, \mathsf{w}^{\varepsilon} \rangle = \frac{1}{2} \langle \mathsf{w}^{\varepsilon}, \mathsf{H}^{\varepsilon} \mathsf{w}^{\varepsilon} \rangle$$

and it satisfies

$$\frac{d}{dt}E^{\varepsilon}(\mathsf{w}^{\varepsilon}(t)) = \langle \mathsf{w}^{\varepsilon}_{t}, \nabla_{\mathsf{w}^{\varepsilon}}\eta(\mathsf{w}^{\varepsilon}) \rangle$$

moreover, it bounds from above (it is equivalent to) the Euclidean norm

$$\mathsf{E}^arepsilon(\mathsf{w}^arepsilon) \geq rac{1}{4}\int_{\mathbb{R}} \Big(rac{\mu}{arepsilon}\,|u^arepsilon|^2 + rac{\mu}{arepsilon}\,|v^arepsilon|^2 + |Z^arepsilon|^2\Big) dx$$

under the (admissible) hypothesis that  $\frac{\mu}{\epsilon} \geq 4$ 

- the system is equipped with a positive definite energy functional, namely  $\varepsilon E^{\varepsilon}(\mathbf{w}^{\varepsilon})$ , which is in fact equivalent to the (square of the)  $L^2$ -norm of the triple  $(u^{\varepsilon}, v^{\varepsilon}, \sqrt{\varepsilon} Z^{\varepsilon})$  for at least  $\varepsilon \ll 1$ 

- thanks to the semi-linearity and the constant symmetrizer,

$$E^{\varepsilon}_{\gamma}(\mathsf{w}^{\varepsilon}) = \int_{\mathbb{R}} \eta(\partial_{\gamma}\mathsf{w}^{\varepsilon}) \, d\mathsf{x} = \frac{1}{2} \langle \partial_{\gamma}\mathsf{w}^{\varepsilon}, \mathsf{H}^{\varepsilon}\partial_{\gamma}\mathsf{w}^{\varepsilon} \rangle$$

defines a high-order energy, which is equivalent to higher order Sobolev norms  $H^\gamma(\mathbb{R})\,,\gamma\geq 1$ 

- it holds also for multi-dimensional systems, and for the equations of elastodynamics with a (strictly) polyconvex internal/stored energy

we use  $\phi^1 = \frac{\mu}{\varepsilon} u_h^{\varepsilon} - Z_h^{\varepsilon}$ ,  $\phi^2 = (\frac{\mu}{\varepsilon} - 1) v_h^{\varepsilon}$ ,  $\phi^3 = Z_h^{\varepsilon} - u_h^{\varepsilon} \in W_{h,k}$  to obtain  $\frac{d}{dt} E^{\varepsilon} (\mathbf{w}_h^{\varepsilon}) = \frac{1}{\varepsilon} \langle S(u_h^{\varepsilon}) - Z_h^{\varepsilon}, Z_h^{\varepsilon} - u_h^{\varepsilon} \rangle$ 

revealing that the symmetrized form of the system is actually introduced to keep the conservation property for the finite element framework

$$\begin{split} &\frac{1}{\varepsilon}\int_{\mathbb{R}}\left(S(u_{h}^{\varepsilon})Z_{h}^{\varepsilon}-|Z_{h}^{\varepsilon}|^{2}-S(u_{h}^{\varepsilon})u_{h}^{\varepsilon}+Z_{h}^{\varepsilon}u_{h}^{\varepsilon}\right)dx\\ &\leq\frac{1}{\varepsilon}\left(-\frac{1}{2}\int_{\mathbb{R}}|Z_{h}^{\varepsilon}|^{2}dx+\frac{3}{2}\int_{\mathbb{R}}\left|S(u_{h}^{\varepsilon})\right|^{2}dx+\frac{3}{2}\int_{\mathbb{R}}\left|u_{h}^{\varepsilon}\right|^{2}dx\right)\\ &\leq-\frac{1}{2\varepsilon}\|Z_{h}^{\varepsilon}\|_{L^{2}}^{2}+\frac{3}{2\varepsilon}\left(1+\sup_{\xi(u_{h}^{\varepsilon})\in W_{h}}\left|S'(\xi(u_{h}^{\varepsilon}))\right|^{2}\right)\|u_{h}^{\varepsilon}(t)\|_{L^{2}}^{2}\end{split}$$

under the generic assumption S(0)=0, and finally

$$E^{\varepsilon}_{T}(\mathsf{w}^{\varepsilon}_{h})+\frac{1}{2\varepsilon}\int_{0}^{T}\|Z^{\varepsilon}_{h}(t)\|^{2}_{L^{2}}dt \leq E^{\varepsilon}_{0}(\mathsf{w}^{\varepsilon}_{h})+\frac{C_{0}}{\varepsilon}\int_{0}^{T}\|u^{\varepsilon}_{h}(t)\|^{2}_{L^{2}}dt$$

 by testing weak derivatives of the finite element solution, we also get H<sup>1</sup>-stability estimates = strong dissipative estimates
 uniformly with respect to the relaxation and numerical parameters

• corresponding  $L^2$ -error estimates hold for the numerical errors indeed, for some projection operator  $\mathbb{P}_h$  into the finite element space, and the auxiliary relaxation variable given by  $Z = S(u) + \mu \partial_x v$ , we have

 $\mathsf{W} = \mathsf{w}_h^\varepsilon - \mathsf{w} = (\mathsf{w}_h^\varepsilon - \mathbb{P}_h \mathsf{w}) + (\mathbb{P}_h \mathsf{w} - \mathsf{w}) = \mathcal{S}(\mathsf{w}_h^\varepsilon, \mathbb{P}_h \mathsf{w}) + \mathcal{C}(\mathbb{P}_h \mathsf{w}, \mathsf{w})$ 

which satisfies an analogous semilinear system : in particular, the last equation can be rewritten as follows, for any  $\phi^3 \in W_{h,k}$ 

$$\langle \partial_t Z, \phi^3 \rangle + \frac{\mu}{\varepsilon} \langle V, \partial_x \phi^3 \rangle = -\frac{1}{\varepsilon} \langle Z, \phi^3 \rangle + \frac{1}{\varepsilon} \langle S(u_h^\varepsilon) - S(u), \phi^3 \rangle - \langle \partial_t Z, \phi^3 \rangle$$

• for *well-prepared initial data*, this implies convergence with the optimal (polynomial) rate, without specific relationship between the parameters

for the method of modulated energy, the approximation of the relaxation variables is sought in lower-order finite element spaces

we select  $\phi^3 = \partial_x \phi^2 \in W_{h,k-1}$  to obtain

 $\varepsilon \left\langle \partial_t Z_h^{\varepsilon}, \partial_x \phi^2 \right\rangle - \mu \left\langle \partial_x v_h^{\varepsilon}, \partial_x \phi^2 \right\rangle = - \left\langle Z_h^{\varepsilon}, \partial_x \phi^2 \right\rangle + \left\langle S(u_h^{\varepsilon}), \partial_x \phi^2 \right\rangle$ 

by differentiating the second equation with respect to time, we get

 $\langle \partial_{tt} v_h^{\varepsilon}, \phi^2 \rangle + \langle \partial_t Z_h^{\varepsilon}, \partial_x \phi^2 \rangle = 0$ 

and finally the following one-field equation, for any  $\phi^2 \in W_{h,k}$ 

 $\langle \partial_t \mathbf{v}_h^{\varepsilon}, \phi^2 \rangle + \langle \mathbf{S}(u_h^{\varepsilon}), \partial_x \phi^2 \rangle + \mu \langle \partial_x \mathbf{v}_h^{\varepsilon}, \partial_x \phi^2 \rangle + \varepsilon \langle \partial_{tt} \mathbf{v}_h^{\varepsilon}, \phi^2 \rangle = \mathbf{0}$ 

together with, for any  $\phi^1 \in W_{h,k}$ 

 $\langle \partial_t u_h^{\varepsilon}, \phi^1 \rangle + \langle v_h^{\varepsilon}, \partial_x \phi^1 \rangle = 0$ 

so that the numerical system admits an equivalent (mixed) formulation, that is a <u>standard finite element scheme</u> perturbed by a wave operator (similar computation for fully-conforming finite element spaces) we choose  $\phi^1 = u_h^{\varepsilon}$ ,  $\phi^2 = v_h^{\varepsilon} \in W_{h,k}$  to obtain

$$\frac{1}{2}\frac{d}{dt}\|u_{h}^{\varepsilon}\|_{L^{2}}^{2}+\langle v_{h}^{\varepsilon},\partial_{x}u_{h}^{\varepsilon}\rangle=0,$$

$$\frac{1}{2}\frac{d}{dt}\|v_{h}^{\varepsilon}\|_{L^{2}}^{2}+\langle S(u_{h}^{\varepsilon}),\partial_{x}v_{h}^{\varepsilon}\rangle+\mu\|\partial_{x}v_{h}^{\varepsilon}\|_{L^{2}}^{2}+\varepsilon\frac{d}{dt}\langle\partial_{t}v_{h}^{\varepsilon},v_{h}^{\varepsilon}\rangle_{L^{2}}-\varepsilon\|\partial_{t}v_{h}^{\varepsilon}\|_{L^{2}}^{2}=0,$$

• taking advantage from the relaxation term, we deduce an estimate for the time derivative, and <u>we modulate with a lower-order energy</u> coming from the wave equation

we fix  $\lambda > 1$  and we choose  $\phi^2 = \varepsilon \lambda \partial_t v_h^{\varepsilon} \in W_{h,k}$  to obtain

$$\varepsilon\lambda\|\partial_t \mathbf{v}_h^\varepsilon\|_{L^2}^2 + \varepsilon\lambda\langle S(\mathbf{u}_h^\varepsilon), \partial_x\partial_t \mathbf{v}_h^\varepsilon\rangle + \mu\,\varepsilon\lambda\frac{1}{2}\frac{d}{dt}\|\partial_x \mathbf{v}_h^\varepsilon\|_{L^2}^2 + \varepsilon^2\lambda\frac{1}{2}\frac{d}{dt}\|\partial_t \mathbf{v}_h^\varepsilon\|_{L^2}^2 = 0$$

we sum together, rearranging the equalities as

$$\frac{1}{2} \frac{d}{dt} \left( \|u_{h}^{\varepsilon}\|_{L^{2}}^{2} + \|v_{h}^{\varepsilon} + \varepsilon \partial_{t} v_{h}^{\varepsilon}\|_{L^{2}}^{2} + \varepsilon^{2} (\lambda - 1) \|\partial_{t} v_{h}^{\varepsilon}\|_{L^{2}}^{2} + \mu \varepsilon \lambda \|\partial_{x} v_{h}^{\varepsilon}\|_{L^{2}}^{2} \right) 
+ \varepsilon (\lambda - 1) \|\partial_{t} v_{h}^{\varepsilon}\|_{L^{2}}^{2} + \mu \|\partial_{x} v_{h}^{\varepsilon}\|_{L^{2}}^{2} + \langle S(u_{h}^{\varepsilon}) - u_{h}^{\varepsilon}, \partial_{x} v_{h}^{\varepsilon} \rangle 
+ \varepsilon \lambda \frac{d}{dt} \langle S(u_{h}^{\varepsilon}), \partial_{x} v_{h}^{\varepsilon} \rangle - \varepsilon \lambda \langle \partial_{t} S(u_{h}^{\varepsilon}), \partial_{x} v_{h}^{\varepsilon} \rangle = 0$$

- for the generic assumption S(0)=0, it holds

$$\left| \langle S(u_h^\varepsilon) - u_h^\varepsilon, \partial_x v_h^\varepsilon \rangle \right| \leq \frac{(1+L_S)^2}{\mu} \|u_h^\varepsilon\|_{L^2}^2 + \frac{1}{4} \mu \, \|\partial_x v_h^\varepsilon\|_{L^2}^2$$

with  $L_S > 0$  the *Lipschitz constant* of the stress-strain function - using  $\phi^1 = S'(u_h^{\varepsilon}) \partial_x v_h^{\varepsilon} \in W_{h,k-1}$  (with abuse of notation), we get  $\langle \partial_t u_h^{\varepsilon}, S'(u_h^{\varepsilon}) \partial_x v_h^{\varepsilon} \rangle = \langle \partial_x v_h^{\varepsilon}, S'(u_h^{\varepsilon}) \partial_x v_h^{\varepsilon} \rangle$ 

that implies

 $\mu \|\partial_x v_h^{\varepsilon}\|_{L^2}^2 - \varepsilon \lambda \langle S'(u_h^{\varepsilon}) \partial_t u_h^{\varepsilon}, \partial_x v_h^{\varepsilon} \rangle \ge (\mu - \varepsilon \lambda L_S) \|\partial_x v_h^{\varepsilon}\|_{L^2}^2 \ge 0$ 

under the sub-characteristic condition given by  $\mu \geq \varepsilon \lambda L_S$ , which is satisfied for  $\varepsilon$  small enough in diffusive relaxation limits, but also essentially for a <u>hyperbolic scaling</u>

thus, we conclude strong dissipative estimates for the *modulated energy* functional suggested by the relaxation terms (uniformly with respect to the relaxation and numerical parameters)

1) implementation for multi-dimensional problems (including boundary conditions) and inverse inequalities for weak finite element spaces 2) to employ discontinuous finite elements to effectively handle shock waves arising in nonlinear elastic materials, for real applications 3) generalization to physical models with viscosity of memory-type leading to integro-differential operators (non-local with general kernels) 4) kinetic formulation of elastodynamics and related topics, as the relaxation method corresponds to some discrete kinetic approximation (equations of gas dynamics and magneto-hydrodynamics, shallow water equations, compressible Navier-Stokes equations with high Reynolds numbers, hydrodynamic models for semiconductor devices, ...) 5) for the Euler equations, to devise an (incomplete) artificial/numerical viscosity with a (mesh dependent) higher order parameter, in view of an alternative approach to the resolution of contact discontinuities
