² A single-step purification method for the precise determination of antimony isotopic composition of environmental, geological and 4 biological samples by HG-MC-ICP-MS

6 Antimony isotopes have been recently used as geochemical tracers for archeological or environmental purposes. The 7 purification of antimony in samples with a low Sb concentration and a complex matrix is a critical step to measure ¹²³Sb/¹²¹Sb 8 ratio by hydride generation coupled to a multi-collector inductively coupled plasma mass spectrometer (HG-MC-ICP-MS). A 9 single-step purification method based on the use of Thiol-functionalized mesoporous Silica Powder (TSP) was developed to 10 separate antimony from other elements. Low amount of Sb (40-100 ng) is required thanks to low procedural blanks (< 1 ng 11 Sb) and an efficient removal (98.7% on average) of potential interfering elements (including As, Cd, Co, Cr, Cu, Fe, Ni, Pb, Se, 12 Sn). The method was validated on fourteen Certified Reference Materials (CRM) including environmental materials 13 (sediments, road dust, soils), biological materials (plants, human blood and urine), rocks and manufactured materials (fly 14 ash, polyethylene). Antimony was recovered at 100 ± 7% and no isotopic fractionation occurred during the procedure. The 15 isotopic composition of Sb (δ^{123} Sb) in the CRM ranged between -0.52 ± 0.06‰ (2 sd) and 0.40 ± 0.03‰ (2 sd) relative to an 16 in-house isotopic standard solution (SPEX). The external reproducibility was evaluated at 0.05% (2 sd) for δ^{123} Sb, based on 17 replicated measurements of independently digested and purified CRM. CRM GSD-3, SDO-1 and BCR-176R exhibited δ^{123} Sb 18 value similar to previous measurements by Rouxel et al. (2003)¹. In addition, three pure standard solutions of Sb were 19 measured against the in-house isotopic standard solution. Two of them were isotopically similar (δ^{123} Sb = 0.00 ± 0.05‰, Sb ²⁰ Fisher Scientific[®] and PlasmaCAL-1, SCP Science[®]) while a δ^{123} Sb value of 0.62 ± 0.02‰ was measured for the third one 21 (PlasmaCAL-2, SCP Science®). This raises the importance of chosing a common isotopic standard solution to compare already 22 published and future Sb isotope data.

1. Introduction 23

2. Material and methods 2
