# INVESTIGATION OF THE HYDRAULICS IN FLOODED HOUSING ESTATE

#### Abstract

Climate change is currently taking place at the scale of our planet, leading to aviolent response from the environment, particularly with regard to the water cycle. One of the risk is already floods. As an example, in France, the average annual costof damages caused by floods (and insured under the Natural Disaster plan) amountsto 520 million euros. In metropolitan France, nearly 17 million people, about aquarter of the national population, are exposed to the risk of flooding by overflowaccording to the preliminary flood risk assessment carried out by the State in 2011.And with climate evolution, floods will become more frequent and more intense. Onechallenge during floods is to be able to access to people refugee over buildings.In order to investigate the hydraulic context generated by the grouped obstaclesrepresentative of a submerged housing estate, both an experimental and numericalstudy is being conducted. We experimentally study the flow in the presence of rows of macro-roughnessesrepresentative of a slightly emerged and of a submerged housing estate, and this forsituations representing both current and more intense floods. Measurements of the velocity field will provide information on currents distribution that might affect an evacuation process. In parallel a numerical study is also conducted with the opensource code Saturne. The nuemerical results are compared to experimental results and this preliminary stupy opens the way to a systematic investigation.


## 1. INTRODUCTION

Water flows are interacting with the bottom of the water course, either natural or artificial, so the influence of the bottom and walls roughness have been investigated for long time. To give just some examples, [1] proposes formula to determine the flow resistance, [2] used laboratory experiments to investigate the influence of composite roughness on flow resistance, [3] investigate the wide range of context made of the Bristh rivers. More recent works exist on such a topic with emergeant applications ranging from fish passes [4] to urban floods [5-8]. The present paper deals with this context. Indeed,

[^0]according to the Ministry of Ecological Transition (2019 data), 17.1 million permanent residents are exposed to flooding by river overflow, including 16.8 million in metropolitan France. In addition, 1.4 million residents are exposed to the risk of marine submersion. Thus knowing how the flow behaves withing the housing settlement in relation to the submergence rate can be or practical consequence for safety services [8] have focused on high submergences, [9] on smaller ones. However experimental studies remain scarce. In this preliminary study we focus on the transition between emerged and slightly submerged situations. This experimental study will also provide benchmark data. The paper will first describe the experimental set-up and methodology. The numetrical modeling is pesented before the results are compared.

## 2. EXPERIMENTAL SET-UP

The experiments aim at reproducing the context of human settlement in recently urbanized areas on plain areas (figure 1) such as main French rivers catchments. We also consider oceanic climate floods rising quite slowly and producing pseudo static situations such as the famous Paris 1910 flood that is a centenal one. In such context, the private houses are flooded but their roof remains out of water. With the climate evolution, thoses building could be submerged, modifying the way the inhabitants can be rescued soi $t$ is of great interest to investigate how the flow behaves in this intermediate context.

The experiments have been carried out at the Laboratoire d'Hydraulique Saint Venant in an open channel which is 16 m long, 2 m wide and 0.5 m high (figure 2a). A honeycomb has been placed at the pump outlet to calm the flow. Velocity measurements were performed with a Ubertone UBLab ultrasonic profiler (Figure 2b) fixed at the free surface.


The planners propose of course a very wide range of subdivision layouts. In the littérature the experiments are mainly made with aligned buildings [10-12] or stagered ones [13]. In this study, we take 2 configurations, one with aligned houses (figure 3a) and the other with staggered buildings (Figure 3b). The distance between the buildings is taken equal to the building size in both lx and ly steamwise and transverse direction. This may be assimilated to a settlement with one level houses for a family with a road or a peace of garden between two houses. The pattern is made of wooden cubes carefully glued on the channel bottom. Each cube has a square section with a side length $\mathrm{Lx}=\mathrm{Ly}=0.1$ m.

In order to investigate the effect of the emergence or submergence, the flow depth $h$ varies from 95 to $150 \%$ of the building height D . The inflow velocity is taken equal to $0.23 \mathrm{~m} / \mathrm{s}$. The Froude number Fr ranges between 0.16 and 0.24 and the Reynolds number between 21850 and 34500, meaning a turbulent flow, with $\mathrm{Fr}=\mathrm{Ud} /(\mathrm{gD})^{1 / 2}$ and $\mathrm{Re}=\mathrm{Ud} * \mathrm{~h} / v$, where g is the gravitationnal acceleration. The block coefficient Cb ranges betwwen 0.08 and 0.16 with Cb being the ratio of the surface of the first line of blocks on the wet area of the experimental flume. Table 1 presents all the experimental conditions.

## 3. NUMERICAL STUDY

The numerical study was made using Code_Saturne. that is a free software for numerical simulation in fluid mechanics developed by EDF's Research and Development division. Based on a co-located finite volume approach that accepts meshes of any size and any type, Code_Saturne allows to model incompressible or dilatable flows, with or without turbulence or heat transfer.

The Navier-Stokes equations form a mathematical model derived from the laws of conservation of mass and conservation of the quantity of movement applied to a volume. These describe three-
dimensional flows and within the framework of our study, we will take the case of a fluid incompressible real subject to the only gravity field. The equations of Navier-Stokes are reduce to :

with $\rho$, the density of the fluid, ui components of the velocity vector, P the pressure and Dij is the shear stress tensor. By definition, $\mathrm{Dij}_{\mathrm{j}}$ is expressed as :

Where $\mu$ is the dynamic viscosity considered constant in this study
For this preliminary study, several hypotheses were chosen to simplify the numerical modeling of this complex flow without influencing the preponderant physical phenomena. The first hypothesis considers the free surface as a fixed surface modelled as a symmetry boundary condition. So the height of water D is constant throughout the field. Indeed, this hypothesis is justified by the fact that the experiments were performed on a uniform flow at a macroscopic level. The second hypothesis is that the slope of the canal is not taken into account.

In order to carry out a fine modeling of the turbulence with the available calculation means and optimize the computing and memory time, it is interesting to reduce the geometry of the hydraulic channel in a two-row pattern of two houses, with periodicity conditions in the longitudinal direction Ox and transverse Oy . The condition of periodicity consists in reinjecting all variables values from the output limit face into the input face of the domain. It thus allows to obtain an infinite configuration in length and width. Indeed, the established regime of experience justifies the condition of periodicity in the Ox direction.

Large Eddy Simulation (LES) solves the filtered Navier-Stokes equations: only the large-scale vortex structures, where most of the turbulent energy is produced, are computed explicitly, and the small scales, where most of the turbulent energy is dissipated, are modeled. This method has been chosen because it allows to directly access to the instantaneous fields and turbulent fluxes. It offers a very good compromise betwwen computational times and accuracy of the turbulent flows.

As shown on figure 4, the numerical profile in the middle of the fast vein is consistant relatively to the experimental profile of Oukacine et al (2020).

## 4 RESULTS

The velocity profiles have been measured for both aligned and staggered configurations and various flow rates corresponding to an emerged and 3 submerged

### 4.1 Aligned configurations

Far upstream of the blocks the flow is symetrical and it is not affected by the array (Figure 5a). Once is the array area, if the symetry remains, the flow is highly disturbed and the velocity profiles are rather complex.

It is interesting to notice that each lateral block has a bow wave that contribute to a global one located at about $1.2 * 1 \mathrm{~lx}$ upstream of the central block and making a pattern (Figue 6a) similar to a bow wave with a stepped vertical variation (Figure 6b) similar to the free surface shock waves discused by [14].


Figures 7 to 10 present the velocity profiles for emerged and slightly submerged situations. The velocity profiles are affected by the block even between blocks and upstream of the first one but this influence decreases with the water level. Within the array, the velocity between blocks line (points at y $=10 \mathrm{~cm}$ ) is accelerated, making a fast vein. The profiles present a dip phenomenon for the lower submersion rate and become more complex when the water level increases. This influence decreases immediatly outside of the array $(y=-30 \mathrm{~cm})$ and the profiles are less regular. In front of one of the
block, the profiles are highly distorted and become more regular when the water goes over the blocks as for the submersion rates of 130 and $150 \%$.

Figures 11 present the evolution of the velocity profiles in the fast vein with increasing water levels. It is interesting to notice that at a given location the profiles are almost the same with a maximum velocity $50 \%$ higer than the mean velocity Ud and located at $60 \%$ of the water level. Farther dowstream, the profiles remain very similar with a maximum velocity about $40 \%$ higer than the mean velocity Ud and located at $55 \%$ of the water level.

The profiler used for this preliminary study gives access to the streamwise componant of the velocity along a profile that is not strictly vertical. In the same time, visual observations dureing the experiments have shown that the flow is rather complex. The numerical similations have shown that strong secondary currents exist in the fast vein for the emerged case (Figure 12a) but also for the submerged case with the existence of another set of vortices above the blocks (figure 12 b ).


### 4.2 Staggered configurations

The staggered configuration is made on two lines of 3 blocks and a line of 4 blocks between them. Figures 13 and 14 present the velocity profiles for emerged and slightly submerged situations. The flow is canalized between the upstream blocks, forming a fast vein as for the aligned configuration (Figures 13b and 14b). But the blocks of the second line make as a barrier to the flow and then, dowstream, the flow is highly complex as presented in Figures 13b and 14b.

## 5. CONCLUSIONS

The present communication deals with the settlements exposed to flooding situations from emerged to slightly submerged situations. First the experimental configurations corresponding to an array of aligned blocs and an array with staggered blocks have been described. The main elements of the nymerical study are summarized and the results are positively compared with experimental results from the littérature.

The experiments have shown the influence of the blocks on the flow at the vicinity of the arrays and in particular the existence of a fast vein between the lines of alignes block.. Visual observations during the experiments have shown that the flow is rather complex but the profiler used is not convenient for measuring the flow in a vertical plane perpendicular to the main streamwise velocity.

This preliminary study will be continued to improve the experimental set-up for measuring the 3 components of the velocity and their turbulent fluctuations. The influence of the distance between blocks but also their square or rectangular geometries will be investigated.
