# Asymptotic analysis of a Bingham fluid in a thin T-like shaped structure.

#### Abstract

We study the steady incompressible flow of a Bingham fluid in a thin T-like shaped domain, under the action of given external forces and with no-slip boundary condition on the whole boundary of the domain. This phenomenon is described by non linear variational inequalities. By letting the parameter describing the thickness of the thin domain tend to zero, we derive two uncoupled problems corresponding to the two branches of the T-like shaped structure. We then analyze and give a physical justification of the limit problem.

## 1 Introduction

In this paper we study the asymptotic behavior of a Bingham fluid in a T-like shaped domain. More precisely, for every $n \in \mathbb{N}$ let $\left.h_{n} \in\right] 0,1\left[\right.$ be a small parameter and let $\Omega_{n}$ be a thin two-dimensional T-like shaped domain defined by (see Fig. 1)

In $\Omega_{n}$ we consider the steady incompressible flow of a Bingham fluid (see [1]) having viscosity $\mu h_{n}^{2}$ and yield stress $g h_{n}$, with $\mu$ and $g$ two strictly positive constants. The fluid moves under the action of given external forces $\mathrm{f}_{n}$ and obeys no-slip condition on the whole boundary of the domain (see [22]). The goal of our paper is to study the asymptotic behavior of this fluid when

The Bingham fluid is a fluid which has a non linear rheological behavior (see Section 2). It

is a non-Newtonian fluid which moves like a rigid body when a certain function of the stress tensor is below a given threshold. Beyond this threshold, it obeys a non linear constitutive law (see (2.2)). As examples of such a fluid we can mention some paints, the mud which can be used for the oil extraction, the volcanic lava, etc. Also the blood can be assumed in first approximation as a Bingham fluid; more precisely, it has a yield stress as the Bingham fluid, but at high shear stress it behaves as a pseudo-plastic fluid.

As proposed in [12], from a mathematical point of view, the velocity $u_{n}$ and the pressure $\mathrm{r}_{n}$ of a Bingham fluid in $\Omega_{n}$ solve the following non linear variational inequality

It is not an easy task to solve this variational inequality numerically due to the presence of the small parameter $h_{n}$ which impedes the construction of suitable meshes. For this reason an asymptotic analysis is required when $h_{n}$ vanishes.

First we reformulate problem (1.3) on a fixed domain through two appropriate rescalings according to [8] (see (3.1)-(3.9)), and in (3.10) we impose appropriate convergence assumptions on the rescaled external forces. A distinctive feature of the result proved in this paper

is that the limit problem obtained letting $h_{n}$ tend to zero decouples into two independent problems associated to the two different branches of the T-domain, as stated in Theorem 4.1. This behaviour can be explained with the separation of the flow in a $90^{\circ}$ bend. In fact (for instance, see [22]) in a $90^{\circ}$ bend the streamlines have a gradual change of direction, and a recirculation zone appears near the junction (see Fig. 2) This recirculation zone contracts the flow, i.e. it reduces the passage area between the two branches of the T-shaped domain. In the limit problem considered in the present paper such a recirculation near the junction is emphasized and its effect produces the decoupling of the flow in the two branches. Now we limit ourself to describe what happens in the horizontal branch, since a similar situation occurs in the vertical branch, up to a permutation of the axes. In the horizontal branch, the second component of the limit velocity vanishes. Indeed, following the separation of the two branches, now the flow in each branch reduces in a recirculation (see Fig. 3), then, the mass transfer through a transversal section is zero. Clearly when the thickness of the branch tends to zero this implies the limit zero velocity in the transversal direction to the branch. As the first component of the velocity is concerned, it solves variational inequality (4.4), stated in an anisotropic functional space. This inequality involves the first component of the limit force. If this component is independent of the transversal direction, also the first component of the velocity is zero (see Remark 8.2). This behavior can be explained because in this case the velocity is constant along transversal directions. Consequently, due to the presence of the wall, the conservation of the mass implies the zero velocity. On the other hand, if the first component of the force depends also on the transversal direction and the first component of the velocity is non-identically zero, then the variational inequality (4.4) modelizes a flow

obeying to a lower-dimensional "Bingham-like" law (see Remark 8.4). This law is used in engineering literature for describing Bingham flow in thin domains (for instance, see [25]).

If in the original problem one assumes $g=0$ in the yield stress, the corresponding fluid is Newtonian, the flow is governed by the Stokes equations and a similar analysis can be performed (see Section 8).

The paper is organized as follows. In Section 2 we introduce the physical properties of the fluid and the variational inequality modelizing the flow. In Section 3 we rescale the problem on a fixed domain. The main converge result, Theorem 4.1, is stated in Section 4. In order to prove this theorem, in Section 5 and in Section 6 we obtain sharp a priori estimates on the velocity and on the pressure, respectively. Section 7 is devoted to the identification of the variational inequality satisfied by the limit velocity and pressure. An analysis of the limit problem is performed in Section 8.

Thin domains with T-junctions are of wide interest in fluid dynamics. For instance, in [9] the effect of a T-junction in a micro-fluidic device for the controlled formation of water-in-oil dispersion is analyzed. For other numerical and experimental studies of flows in thin junctions we refer to [18], [30], and review [11]. For the asymptotic analysis of Navier-Stokes flow in thin multi-domain we refer to [27] and [28]. About the study of this type of junction in other contexts, we refer to [13], [14], [15], [16], [17], [20], [19], [21], [23], [26].

The physical description of the Bingham fluid was introduced in [1] and its mathematical model for a bounded domain was given in [12] as a non linear variational inequality. The existence of the velocity and of the pressure for such a flow was there proved in the case of a two-dimensional domain. For further mathematical considerations on the Bingham fluid and other non-Newtonian fluids we refer to [10]. The first asymptotic mathematical analysis of the Bingham flow in a thin domain was performed in [6] and [7] in the two-dimensional and the three-dimensional case, respectively. For other studies of the Bingham flow in domains depending on a small parameter, in particular in the frame of the homogenization theory,
we refer the reader to [24], [3], [4], and [5].

## 2 The setting of the problem

In the domain $\Omega_{n}$ defined by (1.1) we consider the non linear flow of a Bingham fluid. If we denote by $u_{n}$ and $r_{n}$ the velocity and the pressure of this fluid, respectively, the corresponding stress tensor is defined by

where $\delta_{i j}$ is the Kronecker symbol, $g$ is a strictly positive constant related to the yield stress of the fluid, $\mu$ is a strictly positive constant related to the viscosity of the fluid, $e\left(\mathrm{u}_{n}\right)$ is the strain tensor with entries given by

We remark that relation (2.1), which represents the constitutive law of the Bingham fluid, is valid only if $e_{I I}\left(\mathrm{u}_{n}\right) \neq 0$. In [12] it is shown that this constitutive law is equivalent with the following one:

We point out that this is a threshold law: as long as the shear stress $\sqrt{\sigma_{I I}\left(\mathrm{u}_{n}\right)}$ is below $g h_{n}$, the fluid behaves as a rigid solid. When the value of the shear stress $\sqrt{\sigma_{I I}\left(\mathrm{u}_{n}\right)}$ exceeds $g h_{n}$, then the fluid flows obeying a non linear law.

We also suppose that the fluid is incompressible, which means that its velocity is divergence free

Moreover, we apply to the fluid a given external force $\mathrm{f}_{n}$ belonging to $\left(L^{2}\left(\Omega_{n}\right)\right)^{2}$, and we then have the following relations

Furthermore, we assume the no-slip condition to the boundary of the domain, which reads

In [12] it is shown that the velocity $\mathrm{u}_{n}$ satisfying (2.1), (2.3), (2.4) and (2.5) solves the following variational inequality

where $D \mathrm{v}$ is the matrix denoting the gradient of v , for a function v in $\left(H_{0}^{1}\left(\Omega_{n}\right)\right)^{2}$. For each $n$, this inequality admits a unique solution $\mathrm{u}_{n}$.

According to [12], problem (2.6) is equivalent to the following one

which admits a solution $\left(\mathrm{u}_{n}, \mathrm{r}_{n}\right)$, such that $\mathrm{u}_{n}$ is unique, but $\mathrm{r}_{n}$ is not unique.
The aim of this paper is to study the asymptotic behavior, as $n$ diverges, of problem (2.7), under assumption (1.2) and suitable assumption on the given data $\left\{f_{n}\right\}_{n \in \mathbb{N}}$.

For $n \in \mathbb{N}$, let $\mathrm{u}_{n} \in\left(H_{0}^{1}\left(\Omega_{n}\right)\right)^{2}$ be the solution of problem (2.7) and let $\mathrm{r}_{n} \in L^{2}\left(\Omega_{n}\right) / \mathbb{R}$ be a solution of problem (2.7). Obviously we have

So, if $\mathrm{r}_{n}$ is a solution for problem (2.7), then $\mathrm{p}_{n}$ too is a solution for problem (2.7). Consequently, problem (2.6) is equivalent with the following one

Moreover, the couple $\left(u_{n}, \mathrm{q}_{n}\right) \in\left(H_{0}^{1}\left(\Omega_{n}\right)\right)^{2} \times\left(L^{2}\left(\Omega_{n}\right) / \mathbb{R}\right)$ is a solution of problem (2.9) with $\mathrm{q}_{n}$ instead of $\mathrm{p}_{n}$.

## 3 The rescaled problem

Set now

In order to pass to the limit, the first step consists in the reformulation of problems (2.6) and (2.9) in the domain $\Omega^{a} \cup \Omega^{b}$, independent of $n$. This is done as usual, by a domain dilatation technique (see [8]), through the maps

where $\operatorname{Int}\left(\Omega_{n}^{a}\right)$ denotes the interior of $\Omega_{n}^{a}$ (and the analogous for $\Omega_{n}^{b}$ ). More precisely, for every $n \in \mathbb{N}$ we set

## 5 A priori estimates and a convergence result for the velocity

In order to use compactness results for passing to the limit in the terms involving the velocity, we first derive a priori estimates for this function.

\int_{\Omega^{a}}\left(\mu \partial_{x_{1}} u_{2}^{a} \partial_{x_{1}} w^{a}+g\left|\partial_{x_{1}} w^{a}\right|\right) d x_{1} d x_{2} \geq \int_{\Omega^{a}}\left(f_{2}^{a} w^{a}+p^{a} \partial_{x_{2}} w^{a}\right) d x_{1} d x_{2}, \forall w^{a} \in H_{0}^{1}\left(\Omega^{a}\right) \tag{7.3}
\end{equation*}
$$

By a density argument (7.3) holds true also with $w^{a}$ belonging to space $W^{a}$ defined in Section 4. In particular, choosing $w^{a}=u_{2}^{a} \in W_{0}^{a} \subset W^{a}$ in (7.3) gives

$$
\begin{equation*}
\int_{\Omega^{a}}\left(\mu\left|\partial_{x_{1}} u_{2}^{a}\right|^{2}+g\left|\partial_{x_{1}} u_{2}^{a}\right|\right) d x_{1} d x_{2} \geq \int_{\Omega^{a}} f_{2}^{a} u_{2}^{a} d x_{1} d x_{2} \tag{7.4}
\end{equation*}
$$

since $p^{a}$ is independent of $x_{1}$ and $T^{a}\left(u_{2}^{a}\right)=0$ in $] 0,1[$.
Now replacing $q_{n}^{a}$ with $q_{n}^{b}$ in (3.9) gives formula (7.2) with $q_{n}^{a}$ replaced by $q_{n}^{b}$. Then, passing to the limit in a suitable subsequence of this new formula, as $n \rightarrow+\infty$, with test functions $\left(v^{a}, v^{b}\right)=\left((0,0),\left(w^{b}, 0\right)\right)$ such that $w^{b} \in H_{0}^{1}\left(\Omega^{b}\right)$, and arguing as above provide

$$
\begin{equation*}
\int_{\Omega^{b}}\left(\mu \partial_{x_{2}} u_{1}^{b} \partial_{x_{2}} w^{b}+g\left|\partial_{x_{2}} w^{b}\right|\right) d x_{1} d x_{2} \geq \int_{\Omega^{b}}\left(f_{1}^{b} w^{b}+q^{b} \partial_{x_{2}} w^{b}\right) d x_{1} d x_{2}, \forall w^{b} \in H_{0}^{1}\left(\Omega^{b}\right) \tag{7.5}
\end{equation*}
$$

and consequently

$$
\begin{equation*}
\int_{\Omega^{b}}\left(\mu\left|\partial_{x_{2}} u_{1}^{b}\right|^{2}+g\left|\partial_{x_{2}} u_{1}^{b}\right|\right) d x_{1} d x_{2} \geq \int_{\Omega^{b}} f_{1}^{b} u_{1}^{b} d x_{1} d x_{2} . \tag{7.6}
\end{equation*}
$$

Adding (7.6) to (7.4) gives

$$
\begin{align*}
& \int_{\Omega^{a}}\left(\mu\left|\partial_{x_{1}} u_{2}^{a}\right|^{2}+g\left|\partial_{x_{1}} u_{2}^{a}\right|\right) d x_{1} d x_{2}+\int_{\Omega^{b}}\left(\mu\left|\partial_{x_{2}} u_{1}^{b}\right|^{2}+g\left|\partial_{x_{2}} u_{1}^{b}\right|\right) d x_{1} d x_{2} \\
& \geq \int_{\Omega^{a}} f_{2}^{a} u_{2}^{a} d x_{1} d x_{2}+\int_{\Omega^{b}} f_{1}^{b} u_{1}^{b} d x_{1} d x_{2} \tag{7.7}
\end{align*}
$$

Now passing to the limit in (7.1) and using a l.s.c. argument, (5.8), and (3.10) provide

$$
\begin{align*}
& \int_{\Omega^{a}} f_{2}^{a} u_{2}^{a} d x_{1} d x_{2}+\int_{\Omega^{b}} f_{1}^{b} u_{1}^{b} d x_{1} d x_{2}  \tag{7.8}\\
& \geq \int_{\Omega^{a}}\left(\mu\left|\partial_{x_{1}} u_{2}^{a}\right|^{2}+g\left|\partial_{x_{1}} u_{2}^{a}\right|\right) d x_{1} d x_{2}+\int_{\Omega^{b}}\left(\mu\left|\partial_{x_{2}} u_{1}^{b}\right|^{2}+g\left|\partial_{x_{2}} u_{1}^{b}\right|\right) d x_{1} d x_{2}
\end{align*}
$$

Comparing (7.7) and (7.8) implies

$$
\begin{align*}
& \int_{\Omega^{a}}\left(\mu\left|\partial_{x_{1}} u_{2}^{a}\right|^{2}+g\left|\partial_{x_{1}} u_{2}^{a}\right|\right) d x_{1} d x_{2}+\int_{\Omega^{b}}\left(\mu\left|\partial_{x_{2}} u_{1}^{b}\right|^{2}+g\left|\partial_{x_{2}} u_{1}^{b}\right|\right) d x_{1} d x_{2}  \tag{7.9}\\
& =\int_{\Omega^{a}} f_{2}^{a} u_{2}^{a} d x_{1} d x_{2}+\int_{\Omega^{b}} f_{1}^{b} u_{1}^{b} d x_{1} d x_{2} .
\end{align*}
$$

Now comparing (7.4), (7.6), and (7.9) implies

$$
\left\{\begin{array}{l}
\int_{\Omega^{a}}\left(\mu\left|\partial_{x_{1}} u_{2}^{a}\right|^{2}+g\left|\partial_{x_{1}} u_{2}^{a}\right|\right) d x_{1} d x_{2}=\int_{\Omega^{a}} f_{2}^{a} u_{2}^{a} d x_{1} d x_{2}  \tag{7.10}\\
\int_{\Omega^{b}}\left(\mu\left|\partial_{x_{2}} u_{1}^{b}\right|^{2}+g\left|\partial_{x_{2}} u_{1}^{b}\right|\right) d x_{1} d x_{2}=\int_{\Omega^{b}} f_{1}^{b} u_{1}^{b} d x_{1} d x_{2}
\end{array}\right.
$$

Eventually, (7.3), (7.5), (7.10), and a density argument (see [7]) ensure that ( $u_{2}^{a}, p^{a}$ ) solves the variational inequality in (4.3) and $\left(u_{1}^{b}, q^{b}\right)$ solves the variational inequality in (4.4).

## 8 Analysis of the limit problem

This section is devoted to the analysis of limit problems (4.3) and (4.4) obtained in Theorem 4.1.

Remark 8.1. We first notice that these two problems are not coupled and consequently they can be treated independently. From a physical point of view, this behavior can be explained with the presence of a recirculation zone close to the junction that reduces the passage area through the two branches. The formation of this zone is due to the separation of the flow in a $90^{\circ}$ bend (see [22]). In our limit problem the effect of such a recirculation produces the decoupling of the two branches.

We next remark that, up to a permutation of the axes, both limit problems (4.3) and (4.4) are of the same type and for this reason we focus our attention on problem (4.4), that we recall below.

Let $f_{1}^{b} \in L^{2}\left(\Omega^{b}\right)$ be given in (3.10). Find $\left(u_{1}^{b}, q^{b}\right)$ such that

$$
\left\{\begin{array}{l}
u_{1}^{b} \in W_{0}^{b}\left(\Omega^{b}\right), \quad q^{b} \in L^{2}\left(\Omega^{b}\right), \quad \int_{-\frac{1}{2}}^{\frac{1}{2}} q^{b} d x_{1}=0  \tag{8.1}\\
\int_{\Omega^{b}}\left(\mu \partial_{x_{2}} u_{1}^{b} \partial_{x_{2}}\left(w^{b}-u_{1}^{b}\right)+g\left(\left|\partial_{x_{2}} w^{b}\right|-\left|\partial_{x_{2}} u_{1}^{b}\right|\right)\right) d x_{1} d x_{2} \\
\geq \int_{\Omega^{b}}\left(f_{1}^{b}\left(w^{b}-u_{1}^{b}\right)+q^{b} \partial_{x_{1}}\left(w^{b}-u_{1}^{b}\right)\right) d x_{1} d x_{2} \quad \forall w^{b} \in W^{b}\left(\Omega^{b}\right)
\end{array}\right.
$$

where $\left.\Omega^{b}=\right]-\frac{1}{2}, \frac{1}{2}[\times]-1,0[$. According to $[6]$, this problem is equivalent to the following problem

$$
\left\{\begin{array}{l}
u_{1}^{b} \in W_{0}^{b}\left(\Omega^{b}\right)  \tag{8.2}\\
\int_{\Omega^{b}}\left(\mu \partial_{x_{2}} u_{1}^{b} \partial_{x_{2}}\left(w^{b}-u_{1}^{b}\right)+g\left(\left|\partial_{x_{2}} w^{b}\right|-\left|\partial_{x_{2}} u_{1}^{b}\right|\right)\right) d x_{1} d x_{2} \\
\geq \int_{\Omega^{b}} f_{1}^{b}\left(w^{b}-u_{1}^{b}\right) d x_{1} d x_{2} \quad \forall w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)
\end{array}\right.
$$

Remark 8.2. If $f_{1}^{b}$ is independent of $x_{2}$, then $u_{1}^{b}=0$ is the solution of limit problem (8.2). Indeed, suppose that $f_{1}^{b}$ is independent of $x_{2}$. By choosing in the variational formulation (8.2) a test function $w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)$, the right hand side vanishes, as follows:

$$
\begin{equation*}
\int_{\Omega^{b}} f_{1}^{b}\left(w^{b}-u_{1}^{b}\right) d x_{1} d x_{2}=\int_{-\frac{1}{2}}^{\frac{1}{2}}\left(f_{1}^{b}\left(x_{1}\right) \int_{-1}^{0}\left(w^{b}-u_{1}^{b}\right) d x_{2}\right) d x_{1}=0 \tag{8.3}
\end{equation*}
$$

Then the problem becomes to find $u_{1}^{b} \in W_{0}^{b}\left(\Omega^{b}\right)$ such that

$$
\int_{\Omega^{b}}\left(\mu \partial_{x_{2}} u_{1}^{b} \partial_{x_{2}}\left(w^{b}-u_{1}^{b}\right)+g\left(\left|\partial_{x_{2}} w^{b}\right|-\left|\partial_{x_{2}} u_{1}^{b}\right|\right)\right) d x_{1} d x_{2} \geq 0 \quad \forall w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)
$$

We remark that $u_{1}^{b}=0$ satisfies this last inequality for any $w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)$. Indeed, $u_{1}^{b}=0$ implies

$$
g \int_{\Omega^{b}}\left|\partial_{x_{2}} w^{b}\right| d x_{1} d x_{2} \geq 0 \quad \forall w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)
$$

This last inequality being always satisfied and the solution $u_{1}^{b}$ of problem (8.2) being unique, we obtain the result.

Remark 8.3. Let $f_{1}^{b}$ be dependent on $x_{2}$. Then, if $u_{1}^{b}=0$ is solution of the limit problem (8.2), one has

$$
\begin{equation*}
g \int_{\Omega^{b}}\left|\partial_{x_{2}} w^{b}\right| d x_{1} d x_{2} \geq \int_{\Omega^{b}} f_{1}^{b} w^{b} d x_{1} d x_{2} \quad \forall w^{b} \in W_{0}^{b}\left(\Omega^{b}\right) \tag{8.4}
\end{equation*}
$$

Indeed, by taking $w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)$ and $u_{1}^{b}=0$ in the variational inequality (8.2), relation (8.4) directly follows.

Remark 8.4. In the sequel we are interested on the solution of problem (8.1) in the case when the function $f_{1}^{b}$ depends on $x_{2}$ and is such that

$$
g \int_{\Omega^{b}}\left|\partial_{x_{2}} w^{b}\right| d x_{1} d x_{2}<\int_{\Omega^{b}} f_{1}^{b} w^{b} d x_{1} d x_{2} \quad \forall w^{b} \in W_{0}^{b}\left(\Omega^{b}\right)
$$

According to [7], one can derive from problem (8.1) the following differential equation stated in the domain $\Omega^{b}$

$$
-\partial_{x_{2}}\left[\mu \partial_{x_{2}} u_{1}^{b}+g \operatorname{sgn}\left(\partial_{x_{2}} u_{1}^{b}\right)\right]=f_{1}^{b}-q^{b},
$$

which is valid if $\partial_{x_{2}} u_{b}^{1} \neq 0$ and where sgn states for the signum function.
As in [7] and [6], we define, up to an additive function of $x_{1}$, the limiting stress tensor $\sigma_{12}$ by

$$
\begin{equation*}
\sigma_{12}=-\partial_{x_{1}} q^{b}+\sigma_{12}^{*} \tag{8.5}
\end{equation*}
$$

with $\sigma_{12}^{*}=\mu \partial_{x_{2}} u_{1}^{b}+g \operatorname{sgn}\left(\partial_{x_{2}} u_{1}^{b}\right)$. This is to be compared with the following lower-dimensional "Bingham-like" law, used in the engineering literature for describing Bigham flow in thin domains, as for instance in [25]:

$$
\left\{\begin{align*}
\mu \partial_{x_{2}} u_{1}^{b}=0 & \Leftrightarrow|\tau| \leq 0  \tag{8.6}\\
\mu \partial_{x_{2}} u_{1}^{b}=\tau-g \operatorname{sgn}\left(\partial_{x_{2}} u_{1}^{b}\right) & \Leftrightarrow|\tau|>0
\end{align*}\right.
$$

where $\tau$ represents the constraint. We notice that, if $\partial_{x_{2}} u_{1}^{b} \neq 0$, then relation (8.5) implies $\left|\sigma_{12}^{*}\right|>g$. Consequently, if $\left|\sigma_{12}^{*}\right| \leq g$, we have $\partial_{x_{2}} u_{1}^{b}=0$, which is exactly the lowerdimensional "Bingham-like" law above.

We end our analysis by recalling that the newtonian fluid can be seen as a particular case of the Bingham fluid, corresponding to $g=0$. Indeed, taking $g=0$ in (2.1), the stress
tensor becomes $\sigma_{i j}\left(u_{n}, r_{n}\right)=-r_{n} \delta_{i j}+2 \mu h_{n}^{2} e_{i j}\left(u_{n}\right)$, which corresponds to a newtonian fluid. The initial problem corresponds in this case to the following Stokes system

$$
\left\{\begin{array}{l}
\left(\mathrm{u}_{n}, \mathrm{r}_{n}\right) \in\left(H_{0}^{1}\left(\Omega_{n}\right)\right)^{2} \times\left(L^{2}\left(\Omega_{n}\right) / \mathbb{R}\right), \quad \operatorname{div}\left(\mathrm{u}_{n}\right)=0 \text { in } \Omega_{n}, \\
\mu \int_{\Omega_{n}} h_{n}^{2} D \mathrm{u}_{n} D \mathrm{v} d x_{1} d x_{2}=\int_{\Omega_{n}} \mathrm{f}_{n} \mathrm{v} d x_{1} d x_{2}-\left\langle\nabla \mathrm{r}_{n}, \mathrm{v}\right\rangle_{\left(H^{-1}\left(\Omega_{n}\right)\right)^{2},\left(H_{0}^{1}\left(\Omega_{n}\right)\right)^{2}} \quad \forall \mathrm{v} \in\left(H_{0}^{1}\left(\Omega_{n}\right)\right)^{2}
\end{array}\right.
$$

which admits a unique solution $\left(\mathrm{u}_{n}, \mathrm{r}_{n}\right)$.
By performing a similar analysis, we obtain to the limit the following partial differential equation stated in the domain $\Omega^{b}$

$$
-\mu \frac{\partial^{2} u_{b}^{1}\left(x_{1}, x_{2}\right)}{\partial x_{2}^{2}}=f_{1}^{b}-q^{b}
$$

and the corresponding limiting stress tensor

$$
\sigma_{12}=-\partial_{x_{1}} q^{b}+\mu \partial_{x_{2}} u_{1}^{b} .
$$

For an asymptotic analysis of the Stokes system with the method of "partial asymptotic decomposition of domain" we refer to [2].
