# LINEARIZED ELECTRODYNAMICS AND STABILIZATION OF A COLD MAGNETIZED PLASMA*

#### Abstract

We consider a linearized Euler-Maxwell model for the propagation and absorption of electromagnetic waves in a magnetized plasma. We present the derivation of the model, and we show its well-posedeness, its strong and polynomial stability under suitable and fairly general assumptions, its exponential stability in the same conditions as the Maxwell system, and finally its convergence to the time-harmonic regime. No homogeneity assumption is made, and the topological and geometrical assumptions on the domain are minimal. These results appear strongly linked to the spectral properties of various matrices describing the anisotropy and other plasma properties.

## 1. Introduction

Electromagnetic wave propagation in plasmas, especially magnetized ones, is a vast subject [24]. Even in a linear framework, the equations that describe it are generally highly anisotropic and, in many practical settings, highly inhomogeneous as well. The bewildering array of phenomena and parameters involved in this modelling requires to derive simplified models tailored to the phenomenon under study, and to the theoretical or computational purpose of this study.

Wave-plasma interaction is of paramount importance, for instance, in tokamak technology. According to their frequency, electromagnetic waves can be used in a wide range of processes: to stabilize or heat the plasma and thus bring it closer to the conditions needed for nuclear fusion, for instance, or to probe various properties such as density and temperature. These interactions involve many phenomena, such as propagation, absorption, refraction, scattering, etc.. The basic physics is well understood [24]; nevertheless, efficient and robust mathematical models have to be derived in order to do reliable numerical simulations in realistic settings, or to properly interpret experimental results.

A first, time-harmonic model focused on propagation and absorption has been derived in [4, 13]. This article constitutes the time-dependent counterpart of those works. We consider a general linearized Euler-Maxwell

[^0]model describing the interaction between a strongly magnetized, pressureless, totally ionized gas and an electromagnetic wave; it can be particularized to various physical settings. The waves accelerate the charged particles that make up the plasma, and transfer some of their energy to them through collisions, which act as friction. We study the well-posedness of the model, investigate various stability properties (strong, polynomial, and exponential), and finally check that no inconsistency stems from the time-harmonic modelling. The latter appears, as expected, as a particular solution and a limit of the general solution (under reasonable physical assumptions) in presence of a time-harmonic forcing. Not only the time-dependent model is more general, but it also appears more robust. The well-posedness of the time-harmonic model rests upon absorption; more exactly, the proof fails in the absence of absorption, and serious qualitative arguments suggest that the limiting model is actually ill-posed [4].

On the other hand, we shall see that the time-dependent model is well-posed even without absorption. Nevertheless, and unsurprisingly, the convergence (exponential or polynomial) of the time-dependent model toward the time-harmonic one does depend on absorption. The mathematical tools used in this analysis are well-known theorems on semigroups and operator spectra [2, 14, 17, 23]. The main difficulties are: first, the resolvent of the evolution operator is not compact; then, absorption only acts on some variables, namely, the hydrodynamic ones; finally, one has to handle with various technicalities linked to inhomogeneity, anisotropy, and topology. More or less similar models have been studied by various authors [18, 19, 25]; but they did not include anisotropy or inhomogeneity, and they generally considered simpler topologies or boundary conditions than we do. On the contrary, we have tried to keep our model as general as possible, by assuming neither any homogeneity in the plasma properties, nor in the external magnetic field, nor any strong topological or geometrical condition on the domain.

Generally speaking, stabilization and controllability of Maxwell's equations and coupled models involving them may be rooted in two main physical mechanisms: boundary stabilization of the sourceless Maxwell system through an absorbing boundary condition on all or part of the boundary $[5,11,15,20,22]$; or internal stabilization by some resistive source term on all or part of the domain, typically that given by Ohm's law ([22], among others). Boundary absorption is usually sufficient to have energy decay and convergence toward an equilibrium state (strong stability [5]), but the precise decay rate (polynomial or exponential stability) strongly depends on the global shape of the domain (various star-shapedness conditions such as $[15,20]$ ) and/or the absorbing part of the boundary (geometric control condition [22]). Internal absorption, when it only holds on part of the domain, also requires a geometric control condition [22]. Mathematically, the issue has been tackled by several approaches: the multiplier method ([11, 15], etc.), microlocal analysis ([22], etc.), or frequency-domain analysis [19]. In this paper we use the later method, and we focus on internal stabilisation; the internal absorption mechanism, however, is different from Ohm's law. This allows us to consider fairly arbitrary geometries and topologies, provided some physically reasonable (in the framework of tokamak plasmas) assumption holds (Hypothesis 2; cf. [4], Rem. 4.1). The complementary approach, where the physical hypotheses are weakened at the price of stricter conditions on the geometry, is reserved for future work.

The outline of the article is as follows. In Section 2, we present the derivation of the model, and recall some classical results on the functional analysis of Maxwell's equations in Section 3. Section 4 is devoted to the proof of the well-posedness of the model, in three variants: with a perfectly conducting condition on the whole boundary, and with a Silver-Müller one (homogeneous or not) on part of it. Section 5 recalls or introduces some more advanced results of functional analysis, which are needed in the sequel. In Section 6, we study the spectral properties of various matrices describing the anisotropy and other plasma properties, which will be essential in the stability proofs of Sections 7 and 8. The former is dedicated to strong stability, the latter to unconditional polynomial and conditional exponential stability. Though it happens that polynomial stability does not entail stronger hypotheses than strong one, we have chosen to present them sequentially: the results which allow us to prove strong stability are also the starting point for the finer properties needed to prove polynomial and exponential stability. The stability part is also divided into perfectly conducting and Silver-Müller boundary conditions. As an application, we conclude with a result of convergence to the time-harmonic regime when the Silver-Müller boundary data is time-harmonic.

## 2. The model

The physical system we are interested in is a plasma or totally ionized gas, pervaded by a strong, external, static magnetic field $\boldsymbol{B}_{\text {ext }}(\boldsymbol{x})$, which makes the medium anisotropic. The sources of this field are assumed to be outside the plasma. Such a medium can be described as a collection of charged particles (electrons and various species of ions) which move in vacuum and create electromagnetic fields which, in turn, affect their motion. Electromagnetic fields are, thus, governed by the usual Maxwell's equations in vacuum:

Here $\mathcal{E}$ and $\mathcal{B}$ denote the electric and magnetic fields; $\varrho$ and $\mathcal{J}$ the electric charge and current densities; $\varepsilon_{0}$ is the electric permittivity, and $c$ the speed of light, in vacuum.

The electromagnetic field is the sum of a static part and a small perturbation caused by the penetration of an electromagnetic wave. To simplify the discussion, we assume the plasma to be in mechanical and electrostatic equilibrium in the absence of the wave. Thus, the electric and magnetic fields can be written as:

where $\epsilon \ll 1$ is the perturbation parameter. The total charge and current densities associated with the fields are those due to the perturbation

The static parts of $\mathcal{E}, \varrho$ and $\mathcal{J}$ are zero by the equilibrium assumption.
Furthermore, we assume the plasma to be cold, i.e., the thermal agitation of particles, and thus their pressure, is negligible. We shall designate the particles species (electrons and various species of ions) with the index $s$. We denote as $q_{s}$ the charge of one particle and $m_{s}$ its mass. The momentum conservation equation of particles of the species $s$ writes:

where $\mathcal{U}_{s}$ denotes the fluid velocity and $\nu_{s} \geq 0$ is the collision frequency which only depends on the variable $\boldsymbol{x}$. The charge and current densities can be expressed as a function of the particle densities $n_{s}(t, \boldsymbol{x})$ and the fluid velocities:

Now, multiplying equation (2.4) by $\frac{n_{s} q_{s}}{m_{s}}$, we get

We now linearize equation (2.5). From the above discussion, we can assume, for each species $s$,

where $n_{s}^{0}$ is the equilibrium particle density, assumed to depend on $\boldsymbol{x}$ only. On the left-hand side of (2.5), the terms of order 0 in $\epsilon$ vanish. To express the terms of order 1 , we introduce the plasma and cyclotron frequencies for the species $s$, respectively:

they only depend on the space variable $\boldsymbol{x}$. Observe that the cyclotron frequency is signed: it has the same sign as the charge $q_{s}$. Finally, denoting $\boldsymbol{b}=\frac{\boldsymbol{B}_{\text {ext }}}{\left|\boldsymbol{B}_{\text {ext }}\right|}$ the unit vector aligned with the external magnetic field, we obtain the linearized equation:

The perturbative electromagnetic field $(\boldsymbol{E}, \boldsymbol{B})$ satisfies, at order 1 in $\epsilon$, the usual Maxwell equations derived form (2.1) and (2.2), namely the evolution equations:

Indeed, as its sources are outside the plasma, $\boldsymbol{B}_{\text {ext }}(\boldsymbol{x})$ is curl- and divergence-free.
For the sake of simplicity, we assume that there only are two species of particles in the plasma: the electrons $(s=1)$ and one kind of ions $(s=2)$. Obviously, the whole discussion can be extended to an arbitrary number of species, provided they all carry an electric charge (no neutral atoms).

All in all, the model which will be the object of this article is the following. Let $\Omega$ be a domain in $\mathbb{R}^{3}$, i.e., a bounded, open and connected subset of $\mathbb{R}^{3}$ with a Lipschitz boundary $\Gamma:=\partial \Omega$. The evolution equation for the hydrodynamic and electromagnetic variables are:

with the initial conditions at $t=0$ :

The boundary $\Gamma$ is split into two parts $\Gamma=\overline{\Gamma_{A}} \cup \overline{\Gamma_{P}}$, with $\Gamma_{A} \cap \Gamma_{P}=\varnothing$; both $\Gamma_{P}$ and $\Gamma_{A}$ may be empty. On $\Gamma_{P}$, there holds a usual perfectly conducting boundary (metallic) condition. On $\Gamma_{A}$, there holds a Silver-Müller boundary condition:

where $\boldsymbol{n}$ denotes the outward unit normal vector to $\Gamma, \boldsymbol{B}_{\top}$ is the component of $\boldsymbol{B}$ tangent to the boundary $\Gamma$, and $\boldsymbol{g}$ is a data defined on $\Gamma_{A} \times \mathbb{R}_{>0}$. If $\boldsymbol{g}=0$, this is an absorbing or outgoing wave condition, meaning that the electromagnetic energy can freely leave the domain through $\Gamma_{A}$. If $\boldsymbol{g} \neq 0$, this is an incoming wave condition, modelling the injection of an electromagnetic wave into the plasma, and $\Gamma_{A}$ is interpreted as an antenna (see Fig. 1 for a possible configuration).

The subsets $\overline{\Gamma_{A}}$ and $\overline{\Gamma_{P}}$ are compact Lipschitz submanifolds of $\Gamma$. When both $\Gamma_{P} \neq \varnothing$ and $\Gamma_{A} \neq \varnothing$, we do not necessarily suppose that $\partial \Gamma_{A} \cap \partial \Gamma_{P}=\varnothing$ (i.e., we consider both truncated exterior and interior problems), but we do assume that $\Gamma_{A}$ is not too irregular. A sufficient condition is to assume it either smooth, or polyhedral without so-called pathological vertices ([3], p. 204). This requirement is not very stringent; it can always be satisfied in the outgoing wave case, where $\Gamma_{A}$ appears as an artificial boundary, whose exact location and shape are to some extent arbitrary.

Otherwise, our assumptions on the domain are minimal. We do not assume $\Omega$ to be topologically trivial (but we do assume that it does not have an infinitely multiple topology), nor $\Gamma, \Gamma_{A}, \Gamma_{P}$ to be connected (though we do assume that they have a finite number of connected components). The perfectly conducting boundary $\Gamma_{P}$, if not empty, is just assumed to be Lipschitz.

The solution to the system (2.10)-(2.13) with boundary conditions (2.15)-(2.16) can be shown to satisfy equation (2.9) in $\Omega$ for all $t \geq 0$, as well the boundary condition

provided they hold at $t=0$. These properties will appear crucial for the derivation of the most suitable functional framework for stabilization. Similarly, equation (2.8) can be recovered if it holds at $t=0$ and the charge conservation equation $\partial_{t} \rho+\operatorname{div} \boldsymbol{J}=0$ is verified; yet, the latter is an immediate consequence of the continuity equations for the various species, viz., $\partial_{t} \rho_{s}+\operatorname{div} \boldsymbol{J}_{s}=0$.

In this article we are interested in to cases: first when $\Gamma_{A}=\varnothing$, i.e., we have a perfect conductor condition on the whole boundary; the second case when $\Gamma_{A}$ is non-empty and so equation (2.16) holds. In the second case, conditions on and statements about $\Gamma_{P}$ are of course void if $\Gamma_{P}=\varnothing$.

As alluded to in Section 1, the model (2.10)-(2.13) has been studied by many authors [18, 19, 25] when the medium is homogeneous and isotropic, i.e., $\Omega_{c s} \equiv 0$, and $\nu_{s}$ and $\omega_{p s}$ are constants. The dispersive medium model with perfectly conducting boundary condition on the whole boundary has been studied in [18, 25], and
it was proven in [18] that it is polynomially stable. In [19], the differential equation (2.7) is set in a subset of the full domain, and the Silver-Müller boundary condition is imposed on the entire exterior boundary; it was shown that the model is strongly stable. Similarly, some works on the boundary stabilization of the sourceless Maxwell system (e.g., $[11,20]$ ) allow for some inhomogeneity or anisotropy of the permittivity and permeability coefficients, and some works on the internal stabilization by Ohm's law (e.g., [22]) allow for an inhomogeneous conductivity. But these inhomogeneous or anisotropic terms occur in Maxwell's equations themselves, not in a coupled ODE as in our model. Furthermore, most of the works which consider mixed boundary conditions actually assume $\partial \Gamma_{A} \cap \partial \Gamma_{P}=\varnothing$ (physically, a truncated exterior problem).

Therefore, our goal in the present work is to investigate the stabilization of the model in an inhomogeneous and anisotropic medium with space variable coefficients $\nu_{s}, \omega_{p s}$ and $\Omega_{c s}$, for both types of boundary conditions and both types of truncated problems. We will give sufficient conditions on these coefficients that guarantee first the strong stability, and then the polynomial or exponential stability of the energy.

## 3. Preliminaries

In this section, we introduce the Hilbert spaces needed in the study of Maxwell's equations, and the relevant Green's formulas used in the sequel.

The Sobolev spaces of vector fields $\mathbf{L}^{2}(\Omega):=\left(\mathrm{L}^{2}(\Omega)\right)^{3}, \mathbf{H}^{1}(\Omega):=\left(\mathrm{H}^{1}(\Omega)\right)^{3}$ and $\mathbf{H}^{\ell}(\Gamma):=\left(\mathrm{H}^{\ell}(\Gamma)\right)^{3}$ for $\ell \in$ $\left\{\frac{1}{2},-\frac{1}{2}\right\}$ are defined as usual. We denote $(\cdot \mid \cdot)$ the inner products of both $\mathrm{L}^{2}(\Omega)$ and $\mathbf{L}^{2}(\Omega)$, and $\|\cdot\|$ the associated norm. As usual, $\mathrm{H}_{0}^{1}(\Omega)$ is the subspace of $\mathrm{H}^{1}(\Omega)$ whose elements vanish on the boundary $\Gamma$. The space $\widetilde{\mathbf{H}}^{\frac{1}{2}}\left(\Gamma_{A}\right)$ is the subspace of $\mathbf{H}^{\frac{1}{2}}\left(\Gamma_{A}\right)$ (the trace space of $\mathbf{H}^{1}(\Omega)$ on $\left.\Gamma_{A}\right)$ made of fields defined on $\Gamma_{A}$ such that their extension by zero to $\Gamma_{P}$ belongs to $\mathbf{H}^{\frac{1}{2}}(\Gamma)$. The space $\widetilde{\mathbf{H}}^{-\frac{1}{2}}\left(\Gamma_{A}\right)$ is the dual space of $\widetilde{\mathbf{H}}^{\frac{1}{2}}\left(\Gamma_{A}\right)$.

On the other hand, for any Hilbert space $\mathcal{W}$ other than $L^{2}(\Omega)$ or $\mathbf{L}^{2}(\Omega)$, its inner product will be denoted by $(\cdot, \cdot)_{\mathcal{W}}$ and its norm by $\|\cdot\|_{\mathcal{W}}$. The duality pairing between $\mathcal{W}$ and its dual space is written as $\langle\cdot, \cdot\rangle_{\mathcal{W}}$; the subscript designates the space to which the second variable belongs.

The spaces $\mathbf{H}(\operatorname{div} ; \Omega)$ and $\mathbf{H}(\operatorname{curl} ; \Omega)$ are the usual ones in electromagnetics; they are endowed with their canonical norm. The respective subspaces of fields with vanishing normal (resp. tangential) trace are denoted $\mathbf{H}_{0}(\operatorname{div} ; \Omega)\left(\right.$ resp. $\left.\mathbf{H}_{0}(\mathbf{c u r l} ; \Omega)\right)$. The ranges of the tangential trace mapping $\gamma_{T}: \boldsymbol{v} \mapsto \boldsymbol{v} \times \boldsymbol{n}$ and the tangential component mapping $\pi: \boldsymbol{v} \mapsto \boldsymbol{v}_{\top}:=\boldsymbol{n} \times(\boldsymbol{v} \times \boldsymbol{n})$ from $\mathbf{H}(\mathbf{c u r l} ; \Omega)$ are denoted by

& \mathbf{T C}(\Gamma):=\left\{\boldsymbol{\lambda} \in \mathbf{H}^{-\frac{1}{2}}(\Gamma): \exists \boldsymbol{v} \in \mathbf{H}(\operatorname{curl} ; \Omega), \boldsymbol{\lambda}=\boldsymbol{v}_{\top \mid \Gamma}\right\}
\end{aligned}

These two spaces have been described in [7], where they are respectively denote $\mathbf{H}_{\|}^{-\frac{1}{2}}\left(\operatorname{div}_{\Gamma}, \Gamma\right)=\mathbf{T T}(\Gamma)$ and $\mathbf{H}_{\perp}^{-\frac{1}{2}}\left(\boldsymbol{c u r l}_{\Gamma}, \Gamma\right)=\mathbf{T C}(\Gamma)$. Furthermore [8], they are in duality with respect to the pivot space

The spaces $\mathbf{T T}\left(\Gamma_{A}\right)$ and $\mathbf{T} \mathbf{C}\left(\Gamma_{A}\right)$ denote respectively the ranges of $\gamma_{\top}$ and $\pi_{\top}$, restricted on the part $\Gamma_{A}$ of the boundary. In $[7]$, they are called $\mathbf{H}_{\|, 00}^{-\frac{1}{2}}\left(\operatorname{div}_{\Gamma_{A}}, \Gamma_{A}\right)$ and $\mathbf{H}_{\perp, 00}^{-\frac{1}{2}}\left(\operatorname{curl}_{\Gamma_{A}}, \Gamma_{A}\right)$. The subspace of elements of $\mathbf{H}$ (curl; $\Omega$ ) such that the tangential trace vanishes on the part $\Gamma_{P}$ of the boundary is denoted by

& =\left\{\boldsymbol{\varphi} \in \mathbf{T T}\left(\Gamma_{A}\right): \text { the extension of } \boldsymbol{\varphi} \text { by } 0 \text { to } \Gamma \text { belongs to } \mathbf{T T}(\Gamma)\right\} ; \\
\widetilde{\mathbf{T C}}\left(\Gamma_{A}\right) & :=\left\{\boldsymbol{\lambda} \in \mathbf{H}^{-\frac{1}{2}}\left(\Gamma_{A}\right): \exists \boldsymbol{v} \in \mathbf{H}_{0, \Gamma_{P}}(\mathbf{c u r l} ; \Omega), \boldsymbol{\lambda}=\boldsymbol{v}_{\left.\right|_{\Gamma_{A}}}\right\} \\
& =\left\{\boldsymbol{\lambda} \in \mathbf{T C}\left(\Gamma_{A}\right): \text { the extension of } \boldsymbol{\lambda} \text { by } 0 \text { to } \Gamma \text { belongs to } \mathbf{T C}(\Gamma)\right\} ;
\end{aligned}
$$

they are respectively called $\mathbf{H}_{\|}^{-\frac{1}{2}}\left(\operatorname{div}_{\Gamma_{A}}^{0}, \Gamma_{A}\right)$ and $\mathbf{H}_{\perp}^{-\frac{1}{2}}\left(\operatorname{curl}_{\Gamma_{A}}^{0}, \Gamma_{A}\right)$ in $[7]$. The spaces $\widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)$ and $\mathbf{T C}\left(\Gamma_{A}\right)$ are in duality with respect to the pivot space $\mathbf{L}_{t}^{2}\left(\Gamma_{A}\right)$, and similarly for $\mathbf{T T}\left(\Gamma_{A}\right)$ and $\widetilde{\mathbf{T C}}\left(\Gamma_{A}\right)$. We denote the duality product between those spaces as $\gamma_{A}^{0}\langle\cdot, \cdot\rangle_{\pi_{A}}$ or $\gamma_{A}\langle\cdot, \cdot\rangle_{\pi_{A}^{0}}$. This allows one to derive the following integration by parts formula:

If $\Gamma_{P}=\varnothing$, i.e., $\Gamma_{A}=\Gamma$, then $\mathbf{H}_{0, \Gamma_{P}}(\operatorname{curl} ; \Omega)=\mathbf{H}(\operatorname{curl} ; \Omega)$, while $\widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)=\mathbf{T T}(\Gamma)$ and $\widetilde{\mathbf{T C}}\left(\Gamma_{A}\right)=\mathbf{T C}(\Gamma)$. In the case of a truncated exterior problem, i.e., $\partial \Gamma_{A} \cap \partial \Gamma_{P}=\varnothing$, it holds again that $\widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)=\mathbf{T} \mathbf{T}\left(\Gamma_{A}\right)$ and $\widetilde{\mathbf{T C}}\left(\Gamma_{A}\right)=\mathbf{T C}\left(\Gamma_{A}\right)$.

A profound and useful property of these spaces is: in the absence of pathological vertices, $\widetilde{\mathbf{T T}}\left(\Gamma_{A}\right) \cap \mathbf{T C}\left(\Gamma_{A}\right)$ is included in $\mathbf{L}_{t}^{2}\left(\Gamma_{A}\right)$, see [5] for the truncated exterior problem in a smooth domain and Remarks 5.1.5 and 5.1.8 of [3] in the general case. This is the framework of this article.

We shall also use the basic integration by parts formula between $\mathbf{H}(\operatorname{curl} ; \Omega)$ and $\mathbf{H}^{1}(\Omega)$ :

## 4. Well-posedness of the model

In the whole article, we shall make the following. . .
Hypothesis 1. We suppose that there exists strictly positive real numbers $\nu^{*}, \Omega^{*}$ and $\omega^{*}$ such that, for almost all $\boldsymbol{x} \in \Omega$ and for each species $s$ (ions and electrons), one has:

\end{array}
$$

For $s \in\{1,2\}$ and $\boldsymbol{x} \in \Omega$ fixed, the mapping $\boldsymbol{v} \mapsto \Omega_{c s}(\boldsymbol{x}) \boldsymbol{b}(\boldsymbol{x}) \times \boldsymbol{v}+\nu_{s}(\boldsymbol{x}) \boldsymbol{v}$ defined from $\mathbb{R}^{3}$ (or $\mathbb{C}^{3}$ ) to itself is linear. So, there exists a matrix $\mathbb{M}_{s}(\boldsymbol{x}) \in \mathcal{M}_{3}(\mathbb{R})$ such that:

We denote by $\|\cdot\|_{\mathcal{M}}$ the operator norm on the space $\mathcal{M}_{3}(\mathbb{C})$ induced by the Hermitian norm of $\mathbb{C}^{3}$.
Proposition 4.1. There exists $\lambda>0$ such that $\left\|\lambda \mathbb{M}_{s}(\boldsymbol{x})\right\|_{\mathcal{M}}<1$, for all $s \in\{1,2\}$ and $\boldsymbol{x} \in \Omega$. Therefore, the matrix $\mathbb{I}+\lambda \mathbb{M}_{s}$ is invertible for all $s \in\{1,2\}$ and $\boldsymbol{x} \in \Omega$, where $\mathbb{I}$ is the identity matrix, and its inverse is uniformly bounded on $\Omega$.

Proof. This is an easy consequence of Hypothesis 1, by a simple perturbation argument. See Propositions 3.1 and 3.2 of [16].

Definition 4.2. Let $\lambda$ be given by Proposition 4.1. Let $\mathbb{D}_{\lambda}: \Omega \longrightarrow \mathcal{M}_{3}(\mathbb{R})$ be the matrix

By convention, sums on the variable $s$ run on all particle species, i.e., from $s=1$ to 2 in our model.
Proposition 4.3. The matrix $\mathbb{D}_{\lambda}(\boldsymbol{x})$ is positive for all $\boldsymbol{x}$ in $\Omega$. Moreover, there exists $\xi>0$ such that

\sup _{\boldsymbol{x} \in \Omega}\left\|\mathbb{D}_{\lambda}(\boldsymbol{x})\right\|_{\mathcal{M}} \leq \xi
$$

Proof. Let $\boldsymbol{x} \in \Omega$. To show the positivity of $\mathbb{D}_{\lambda}$, it is enough to prove that the matrix $\left(\mathbb{I}+\lambda \mathbb{M}_{s}(\boldsymbol{x})\right)^{-1}$ is positive for $s \in\{1,2\}$. Given $\boldsymbol{v} \in \mathbb{R}^{3}$, we have

$$

Then, $\mathbb{I}+\lambda \mathbb{M}_{s}(\boldsymbol{x})$ is positive. Next, given $\boldsymbol{w} \in \mathbb{R}^{3}$, there exists $\boldsymbol{\eta} \in \mathbb{R}^{3}$ such that $\boldsymbol{w}=\left(\mathbb{I}+\lambda \mathbb{M}_{s}(\boldsymbol{x})\right) \boldsymbol{\eta}$. Hence, it follows that

So, the matrix $\left(\mathbb{I}+\lambda \mathbb{M}_{s}(\boldsymbol{x})\right)^{-1}$ is positive. The uniform boundedness of $\mathbb{D}_{\lambda}$ is an easy consequence of Hypothesis 1 and Proposition 4.1.

To prove the well-posedness, we rewrite the system (2.10)-(2.14) with boundary condition (2.15)-(2.16) as the first order evolution equation

where the vector $\boldsymbol{U}$ is

and $\mathbb{A}$ is a linear operator formally given by the expression

0 & 0 & \text { curl } & 0

The existence and uniqueness of the solution to Problem (4.6) follows from the classical Lumer-Phillips theorem $[9,21]$, as we shall se later.

We introduce the weighted $L^{2}$ spaces associated to each species index $s$ :

In view of the bound (4.3), one immediately deduces a basic useful result:
Lemma 4.4. For each $s$ :
(i) The space $\mathbf{L}_{(s)}^{2}(\Omega)$ is continuously embedded into $\mathbf{L}^{2}(\Omega)$.
(ii) For any $\boldsymbol{w} \in \mathbf{L}^{2}(\Omega)$, it holds that $\omega_{p s}^{2} \boldsymbol{w} \in \mathbf{L}_{(s)}^{2}(\Omega)$.

Next, we introduce the energy space

and we endow it with the inner product defined for all $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top}$ and $\boldsymbol{V}=\left(\boldsymbol{V}_{1}, \boldsymbol{V}_{2}, \boldsymbol{V}_{3}, \boldsymbol{V}_{4}\right)^{\top}$ by

(\boldsymbol{U}, \boldsymbol{V})_{\mathbf{X}}:=\frac{1}{\varepsilon_{0}} \sum_{s}\left(\left.\frac{\boldsymbol{U}_{s}}{\omega_{p s}} \right\rvert\, \frac{\boldsymbol{V}_{s}}{\omega_{p s}}\right)+\varepsilon_{0}\left(\boldsymbol{U}_{3} \mid \boldsymbol{V}_{3}\right)+c^{2} \varepsilon_{0}\left(\boldsymbol{U}_{4} \mid \boldsymbol{V}_{4}\right) \tag{4.10}
\end{equation*}
$$

and the associated norm $\|\cdot\|_{\mathbf{x}}$.

### 4.1. Perfectly conducting case

Here, we suppose that $\Gamma_{A}$ is empty. The domain $\Omega$ is encased in a perfect conductor, which means:

Now, we define the linear unbounded operator $\mathbb{A}_{1}: D\left(\mathbb{A}_{1}\right) \subset \mathbf{X} \rightarrow \mathbf{X}$ as

& \mathbb{A}_{1} \boldsymbol{U}:=\mathbb{A} \boldsymbol{U}, \quad \forall \boldsymbol{U} \in D\left(\mathbb{A}_{1}\right) \tag{4.11}

The fact that $\operatorname{im}\left(\mathbb{A}_{1}\right) \subset \mathbf{X}$ follows from Proposition 4.1 and Lemma 4.4. The abstract evolution equation (4.6) writes:

Proposition 4.5. The operator $\mathbb{A}_{1}$ is maximal monotone.
Proof. First, we check that $\mathbb{A}_{1}$ is monotone. Given $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top} \in D\left(\mathbb{A}_{1}\right)$, one finds, by the definition of $\mathbb{A}$,
$(\mathbb{A} \boldsymbol{U}, \boldsymbol{U})_{\mathbf{x}}=\frac{1}{\varepsilon_{0}} \sum_{s}\left(\left.\frac{\mathbb{M}_{s} \boldsymbol{U}_{s}}{\omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}}{\omega_{p s}}\right)-\sum_{s}\left(\boldsymbol{U}_{3} \mid \boldsymbol{U}_{s}\right)+\sum_{s}\left(\boldsymbol{U}_{s} \mid \boldsymbol{U}_{3}\right)-\varepsilon_{0}\left(c^{2} \operatorname{curl} \boldsymbol{U}_{4} \mid \boldsymbol{U}_{3}\right)+\varepsilon_{0} c^{2}\left(\operatorname{curl} \boldsymbol{U}_{3} \mid \boldsymbol{U}_{4}\right)$.
By Lemma 4.4, $\boldsymbol{U}_{s} \in \mathbf{L}^{2}(\Omega)$ for $s=1,2$ too. Taking the real part of this inner product, one gets:

But, for all $s=1,2$, on has, according to the definition of $\mathbb{M}_{s}$,

\Re\left(\left.\frac{\mathbb{M}_{s} \boldsymbol{U}_{s}}{\omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}}{\omega_{p s}}\right)=\Re\left(\left.\frac{\nu_{s} \boldsymbol{U}_{s}}{\omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}}{\omega_{p s}}\right)+\Re\left(\left.\Omega_{c s} \boldsymbol{b} \times \frac{\boldsymbol{U}_{s}}{\omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}}{\omega_{p s}}\right)=\left(\left.\frac{\nu_{s} \boldsymbol{U}_{s}}{\omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}}{\omega_{p s}}\right) \tag{4.14}
\end{equation*}

Thus, plugging (4.14) into (4.13) and using Green's formula (3.1), the boundary condition $\boldsymbol{U}_{3} \times \boldsymbol{n}=0$ on $\Gamma$ and the condition (4.1), one obtains

Let us proceed to the maximal character. Let $\lambda>0$ given by Proposition 4.1. Given any $\boldsymbol{F}=$ $\left(\boldsymbol{F}_{1}, \boldsymbol{F}_{2}, \boldsymbol{F}_{3}, \boldsymbol{F}_{4}\right)^{\top} \in \mathbf{X}$, we look for $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top} \in D\left(\mathbb{A}_{1}\right)$ such that $\left(\mathbb{I}+\lambda \mathbb{A}_{1}\right) \boldsymbol{U}=\boldsymbol{F}$. More explicitly, this equation writes:

\boldsymbol{U}_{4}+\lambda \operatorname{curl} \boldsymbol{U}_{3} & =\boldsymbol{F}_{4} \tag{4.19}
\end{align*}

Assuming that a solution $\boldsymbol{U}$ of (4.16)-(4.19) exists, we can eliminate the equations (4.16), (4.17) and (4.19) respectively:

& \boldsymbol{U}_{4}=\boldsymbol{F}_{4}-\lambda \operatorname{curl} \boldsymbol{U}_{3} \tag{4.22}
\end{align*}

Inserting these three expressions into (4.18), one obtains, in function of $\boldsymbol{U}_{3}$,

Multiplying this identity by a test-function $\boldsymbol{v} \in \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega)$ and applying the Green formula (3.1), one finds the following variational formulation:

L(\boldsymbol{v}) & :=\left(\boldsymbol{F}_{3} \mid \boldsymbol{v}\right)+\lambda c^{2}\left(\boldsymbol{F}_{4} \mid \operatorname{curl} \boldsymbol{v}\right)-\frac{\lambda}{\varepsilon_{0}} \sum_{s}\left(\left(\mathbb{I}+\lambda \mathbb{M}_{s}\right)^{-1} \boldsymbol{F}_{s} \mid \boldsymbol{v}\right) . \tag{4.26}
\end{align*}
$$

The problem (4.24) is well-posed. Indeed, thanks to Proposition 4.3, the sesquilinear form $a$ is continous and coercive on $\mathbf{H}_{0}(\operatorname{curl} ; \Omega)$. The form $L$ is anti-linear, and by Proposition 4.1 and Lemma 4.4, it obviously continuous on $\mathbf{H}_{0}(\operatorname{curl} ; \Omega)$. Then, we conclude by the Lax-Milgram theorem the existence of a unique solution $\boldsymbol{U}_{3} \in \mathbf{H}_{0}(\operatorname{curl} ; \Omega)$ to the formulation (4.24).

Returning to the problem (4.16)-(4.19), we define $\boldsymbol{U}_{1}$ and $\boldsymbol{U}_{2}$ by (4.20) and (4.21). Again, by Proposition 4.1 and Lemma 4.4, they respectively belong to $\mathbf{L}_{(1)}^{2}(\Omega)$ and $\mathbf{L}_{(2)}^{2}(\Omega)$. Also, we define $\boldsymbol{U}_{4}$ by (4.22); it belongs to $\mathbf{L}^{2}(\Omega)$. Next, if we take $\boldsymbol{v} \in \mathcal{D}(\Omega)$ as a test function in the formulation (4.24) and use the Green formula (3.1), we obtain equation (4.23). So, by the definition of $\boldsymbol{U}_{4}$, we can write this equation as

This equation, on the one hand, implies that $\operatorname{curl} \boldsymbol{U}_{4} \in \mathbf{L}^{2}(\Omega)$, and on the other hand is equivalent to (4.18) (just replace $\mathbb{D}_{\lambda}$ with its expression). Hence, the quadruple $\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)$ belongs to $D\left(\mathbb{A}_{1}\right)$ and it solves the equations (4.16)-(4.19). The proof is completed.

Theorem 4.6. The operator $-\mathbb{A}_{1}$ generates a $\mathrm{C}^{0}$-semigroup of contractions $\left(T_{1}(t)\right)_{t \geq 0}$ on the energy space $\mathbf{X}$. Thus, for all $\boldsymbol{U}_{0} \in \mathbf{X}$, there exists a unique solution $\boldsymbol{U} \in \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}\right)$, given by $\boldsymbol{U}(t)=T_{1}(t) \boldsymbol{U}_{0}$, which solves the problem (4.12).

Moreover, if $\boldsymbol{U}_{0} \in D\left(\mathbb{A}_{1}\right)$, then

Furthermore, we have $\|\boldsymbol{U}(t)\|_{\mathbf{x}} \leq\left\|\boldsymbol{U}_{0}\right\|_{\mathbf{X}}$ and $\left\|\partial_{t} \boldsymbol{U}(t)\right\|_{\mathbf{x}} \leq\left\|\mathbb{A}_{1} \boldsymbol{U}_{0}\right\|_{\mathbf{x}}$.
Proof. From the previous proposition, the operator $-\mathbb{A}_{1}$ is maximal dissipative. The domain $D\left(\mathbb{A}_{1}\right)$ of $-\mathbb{A}_{1}$ is dense in $\mathbf{X}$ according to Theorem 1.4.6 of [21]. Then, we can apply the Lumer-Phillips theorem (see [21], Thm. 1.4.3) to obtain the result.

### 4.2. Silver-Müller case

Now, we assume that $\Gamma_{A}$ is non-empty. A Silver-Müller boundary condition holds on the antenna $\Gamma_{A}$, and a perfect conductor boundary condition on the rest of the boundary $\Gamma_{P}$ :

Our goal is to solve Problem (4.6) with the boundary condition (4.28). First, we will start with the homogeneous (or absorbing, outgoing wave) case, $\boldsymbol{g}=0$, and next we proceed to the general (incoming wave) case, i.e., $\boldsymbol{g} \neq 0$.

### 4.2.1. Homogeneous (absorbing) boundary condition

Let us define the linear unbounded operator $\mathbb{A}_{2}: D\left(\mathbb{A}_{2}\right) \subset \mathbf{X} \rightarrow \mathbf{X}$ as

\mathbb{A}_{2} \boldsymbol{U}:=\mathbb{A} \boldsymbol{U}, \quad \forall \boldsymbol{U} \in D\left(\mathbb{A}_{2}\right) \tag{4.29}
\end{equation*}
$$

Therefore, the abstract evolution equation (4.6) writes:

(\boldsymbol{w}, \boldsymbol{v})_{\mathcal{V}}:=(\boldsymbol{w} \mid \boldsymbol{v})+(\operatorname{curl} \boldsymbol{w} \mid \operatorname{curl} \boldsymbol{v})+\left(\boldsymbol{w}_{\top} \mid \boldsymbol{v}_{\top}\right)_{\Gamma_{A}} . \tag{4.32}
\end{equation*}

Above, $(\cdot \mid \cdot)_{\Gamma_{A}}$ denotes the inner product in $\mathbf{L}^{2}\left(\Gamma_{A}\right)$.
Proposition 4.7. The operator $\mathbb{A}_{2}$ is maximal monotone.
Proof. Let us start by proving the monotonicity of $\mathbb{A}_{2}$. Pick any $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top}$ in $D\left(\mathbb{A}_{2}\right)$. The equality (4.13) still holds; it only relies on the expression of $\mathbb{A}$ in $\Omega$, not on the boundary conditions. As $U_{3} \in \mathbf{H}_{0, \Gamma_{P}}(\operatorname{curl} ; \Omega)$, we get by the integration-by-parts formula (3.2):

Now, we use the Silver-Müller boundary condition $\boldsymbol{U}_{3} \times \boldsymbol{n}+c \boldsymbol{U}_{4 \mathrm{~T}}=0$ on $\Gamma_{A}$. We remark that both $\boldsymbol{U}_{3} \times \boldsymbol{n}$ and $\boldsymbol{U}_{4 \boldsymbol{T}}$ belong to $\widetilde{\mathbf{T T}}\left(\Gamma_{A}\right) \cap \mathbf{T C}\left(\Gamma_{A}\right) \subset \mathbf{L}_{t}^{2}\left(\Gamma_{A}\right)$ as said in Section 3. Then, it holds that

\end{equation*}
$$

which yields the monotonicity of the operator $\mathbb{A}_{2}$.
Now we show the maximality of $\mathbb{A}_{2}$. Again, we use the same $\lambda>0$ given by Proposition 4.1. Given any $\boldsymbol{F}=\left(\boldsymbol{F}_{1}, \boldsymbol{F}_{2}, \boldsymbol{F}_{3}, \boldsymbol{F}_{4}\right)^{\top} \in \mathbf{X}$, we look for $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top} \in D\left(\mathbb{A}_{2}\right)$ such that $\left(\mathbb{I}+\lambda \mathbb{A}_{2}\right) \boldsymbol{U}=\boldsymbol{F}$, which is equivalent to the system (4.16)-(4.19) (plus boundary conditions). Following the same argument as in Proposition 4.5 , we can eliminate $\boldsymbol{U}_{1}, \boldsymbol{U}_{2}$ and $\boldsymbol{U}_{4}$, and they are given respectively by (4.20), (4.21) and (4.22), while $\boldsymbol{U}_{3}$ verifies the equation:

Thus, multiplying (4.34) by a test-function $\boldsymbol{v} \in \mathcal{V}$, applying Green's formula (3.2), and using the Silver-Müller boundary condition and the expression (4.22), we arrive at the variational formulation:
Find $\boldsymbol{U}_{3} \in \mathcal{V}$ such that

and the forms $a$ and $L$ given respectively by (4.25) and (4.26).
As the form $a$ is coercive on $\mathbf{H}(\operatorname{curl} ; \Omega)$ (Prop. 4.5), the form $\widetilde{a}$ is coercive on $\mathcal{V}$. So, by Lax-Milgram theorem, Problem (4.35) admits a unique solution $\boldsymbol{U}_{3} \in \mathcal{V}$. Defining $\boldsymbol{U}_{1}, \boldsymbol{U}_{2}$ and $\boldsymbol{U}_{4}$ respectively by (4.20), (4.21) and (4.22), they respectively belong to $\mathbf{L}_{(1)}^{2}(\Omega), \mathbf{L}_{(2)}^{2}(\Omega)$ and $\mathbf{L}^{2}(\Omega)$; taking a test-function $\boldsymbol{v} \in \mathcal{D}(\Omega)$ in (4.35), we find the equation (4.34) which is equivalent to (4.18). Thus $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)$ formally satisfies $(\mathbb{I}+\lambda \mathbb{A}) \boldsymbol{U}=\boldsymbol{F}$, and in order to prove that $D\left(\mathbb{A}_{2}\right)$ it remains only to check the homogeneous Silver-Müller boundary condition on $\Gamma_{A}$. To this end, using the integration-by-parts formula (3.2) in (4.35) and the definition of $\boldsymbol{U}_{4}$, it follows from the identity (4.34) that:

Let $\boldsymbol{\omega} \in \widetilde{\mathbf{H}}^{\frac{1}{2}}\left(\Gamma_{A}\right)$ and $\widetilde{\boldsymbol{\omega}} \in \mathbf{H}^{\frac{1}{2}}(\Gamma)$ be its extension by 0 to the whole boundary. By the surjectivity of the trace mapping, there exists $\boldsymbol{v} \in \mathbf{H}^{1}(\Omega)$ such that $\widetilde{\boldsymbol{\omega}}=\boldsymbol{v}_{\left.\right|_{\Gamma}}$; clearly, $\boldsymbol{v} \in \mathcal{V}$. From the integration by parts formulas (3.2), (3.3) applied to $\boldsymbol{U}_{4}$ and $\boldsymbol{v}$, we get that

Recalling that $\boldsymbol{v}_{\left.\right|_{\Gamma}}=\boldsymbol{v}_{\top}+(\boldsymbol{n} \cdot \boldsymbol{v}) \boldsymbol{n}$, it follows that $\left(\boldsymbol{U}_{3 \top} \mid \boldsymbol{v}_{\top}\right)_{\Gamma_{A}}=\left(\boldsymbol{U}_{3 \top} \mid \boldsymbol{v}\right)_{\Gamma_{A}}$. Using (4.38) and the previous identity, equation (4.37) becomes:

As $\boldsymbol{v}_{\Gamma_{A}}=\boldsymbol{\omega}$ and $\boldsymbol{\omega}$ is arbitrary in $\widetilde{\mathbf{H}}^{\frac{1}{2}}\left(\Gamma_{A}\right)$, one concludes from (4.39) that $\boldsymbol{U}_{3 \top}-c \boldsymbol{U}_{4} \times \boldsymbol{n}=0$ in $\widetilde{\mathbf{H}}^{-\frac{1}{2}}\left(\Gamma_{A}\right)$ which is equivalent to $\boldsymbol{U}_{3} \times \boldsymbol{n}+c \boldsymbol{U}_{4 \top}=0$ in $\widetilde{\mathbf{H}}^{-\frac{1}{2}}\left(\Gamma_{A}\right)$, and therefore also in $\mathbf{L}^{2}\left(\Gamma_{A}\right)$ because $\boldsymbol{U}_{3 \top}$ is in $\mathbf{L}^{2}\left(\Gamma_{A}\right)$ (plus a density argument). This proves the Silver-Müller boundary condition, and the proof of the Proposition is complete.

Theorem 4.8. The operator $-\mathbb{A}_{2}$ generates a $\mathrm{C}^{0}$-semigroup of contractions $\left(T_{2}(t)\right)_{t \geq 0}$ on the energy space $\mathbf{X}$. Thus, for all $\boldsymbol{U}_{0} \in \mathbf{X}$, there exists a unique solution $\boldsymbol{U} \in \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}\right)$, given by $\boldsymbol{U}(t)=T_{2}(t) \boldsymbol{U}_{0}$, which solves the problem (4.30).

Moreover, if $\boldsymbol{U}_{0} \in D\left(\mathbb{A}_{2}\right)$, then

\boldsymbol{U} \in \mathrm{C}^{1}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}\right) \cap \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; D\left(\mathbb{A}_{2}\right)\right)

Furthermore, we have $\|\boldsymbol{U}(t)\| \mathbf{x} \leq\left\|\boldsymbol{U}_{0}\right\|_{\mathbf{x}}$ and $\left\|\partial_{t} \boldsymbol{U}(t)\right\| \mathbf{x} \leq\left\|\mathbb{A}_{2} \boldsymbol{U}_{0}\right\| \mathbf{x}$.
Proof. Entirely similar to Theorem 4.6.

### 4.2.2. General (non-homogeneous) boundary condition

Here, we suppose that $\boldsymbol{g} \neq 0$ in (4.28). We shall solve the evolution problem by using a lifting of the boundary data $\boldsymbol{g}$. To this end, we introduce the mapping:

(\boldsymbol{v}, \boldsymbol{w}) & \mapsto \gamma_{\top}(\boldsymbol{v})+c \pi_{\top}(\boldsymbol{w}) .

It is clear that $Z_{A}$ is linear and continuous, and due to the surjectivity of $\gamma_{\top}$ and $\pi_{\top}$ (see the definition of $\widetilde{\mathbf{T T}}$ and $\mathbf{T C}$ ), $Z_{A}$ is also surjective. Then, we deduce that $Z_{A}$ is bijective from $\left(\operatorname{ker} Z_{A}\right)^{\perp}$ to $\widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)+\mathbf{T C}\left(\Gamma_{A}\right)$ and we denote its inverse by $R_{A}$. By the Banach-Schauder theorem, $R_{A}$ is continuous.

We assume the following regularity on the boundary data $\boldsymbol{g}$ :

According to the previous paragraph, for any $t \geq 0$ there exists $\left(\boldsymbol{g}_{3}(t), \boldsymbol{g}_{4}(t)\right) \in \mathbf{H}_{0, \Gamma_{P}}(\mathbf{c u r l} ; \Omega) \times \mathbf{H}(\mathbf{c u r l} ; \Omega)$ such that

and the functions $\left(\boldsymbol{g}_{3}, \boldsymbol{g}_{4}\right)$ have the following regularity:

\left(\boldsymbol{g}_{3}, \boldsymbol{g}_{4}\right) \in \mathrm{W}^{2,1}\left(\mathbb{R}_{>0} ; \mathbf{H}_{0, \Gamma_{P}}(\operatorname{curl} ; \Omega) \times \mathbf{H}(\operatorname{curl} ; \Omega)\right) . \tag{4.42}
\end{equation*}
$$

Theorem 4.9. Suppose that the initial data satisfy:

\boldsymbol{E}_{0} \in \mathbf{H}_{0, \Gamma_{P}}(\operatorname{curl} ; \Omega), \quad \boldsymbol{B}_{0} \in \mathbf{H}(\operatorname{curl} ; \Omega), \\
\boldsymbol{E}_{0} \times \boldsymbol{n}+c \boldsymbol{B}_{0 \top}=\boldsymbol{g}(0) \quad \text { on } \Gamma_{A},
\end{array}\right.
$$

and $\boldsymbol{g}$ is of regularity (4.40), which gives a meaning to the initial value $\boldsymbol{g}(0)$. Then, there exists one, and only one, solution $\boldsymbol{U}=\left(\boldsymbol{J}_{1}, \boldsymbol{J}_{2}, \boldsymbol{E}, \boldsymbol{B}\right)^{\top}$ to the evolution problem (4.6), supplemented with the boundary conditions (4.28),
such that its components have the following regularity:

\boldsymbol{E} & \in \mathrm{C}^{1}\left(\mathbb{R}_{\geq 0} ; \mathbf{L}^{2}(\Omega)\right) \cap \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; \mathbf{H}_{0, \Gamma_{P}}(\operatorname{curl} ; \Omega)\right) \\
\boldsymbol{B} & \in \mathrm{C}^{1}\left(\mathbb{R}_{\geq 0} ; \mathbf{L}^{2}(\Omega)\right) \cap \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; \mathbf{H}(\operatorname{curl} ; \Omega)\right)
\end{aligned}

Proof. Define $\left(\boldsymbol{g}_{3}, \boldsymbol{g}_{4}\right)$ by (4.41), and introduce the auxiliary unknown $\boldsymbol{U}^{\star}=\left(\boldsymbol{J}_{1}^{\star}, \boldsymbol{J}_{2}^{\star}, \boldsymbol{E}^{\star}, \boldsymbol{B}^{\star}\right)^{\top}$ :

If a solution $\left(\boldsymbol{J}_{1}, \boldsymbol{J}_{2}, \boldsymbol{E}, \boldsymbol{B}\right)^{\top}$ as above exists then, by construction, the field $\boldsymbol{U}^{\star}(t)$ belongs to $D\left(\mathbb{A}_{2}\right)$ for any $t \geq 0$. Moreover it is governed by the evolution equations

with data

\varepsilon_{0} \omega_{p 1}^{2} \boldsymbol{g}_{3} \\
\varepsilon_{0} \omega_{p 2}^{2} \boldsymbol{g}_{3} \\
-\partial_{t} \boldsymbol{g}_{3}+c^{2} \operatorname{curl} \boldsymbol{g}_{4} \\
-\partial_{t} \boldsymbol{g}_{4}-\operatorname{curl} \boldsymbol{g}_{3}
\end{array}\right), \quad \boldsymbol{U}_{0}^{\star}=\left(\begin{array}{c}
\boldsymbol{J}_{1,0} \\
\boldsymbol{J}_{2,0} \\
\boldsymbol{E}_{0}-\boldsymbol{g}_{3}(0) \\
\boldsymbol{B}_{0}-\boldsymbol{g}_{4}(0)
\end{array}\right)
$$

Thanks to (4.42) and Lemma 4.4, one sees that $\boldsymbol{F} \in \mathrm{W}^{1,1}\left(\mathbb{R}_{>0} ; \mathbf{X}\right)$; and, obviously, $\boldsymbol{U}_{0}^{\star} \in D\left(\mathbb{A}_{2}\right)$. Thus, Problem (4.44)-(4.45) admits a unique strong solution ([9], Prop. 4.1.6), with regularity $\boldsymbol{U}^{\star} \in \mathrm{C}^{1}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}\right) \cap$ $\mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; D\left(\mathbb{A}_{2}\right)\right)$, which depends continuously on the data $\boldsymbol{F}$ and $\boldsymbol{U}_{0}^{\star}$. Hence, we conclude the existence of

$$
\boldsymbol{U}=\left(\boldsymbol{J}_{1}, \boldsymbol{J}_{2}, \boldsymbol{E}, \boldsymbol{B}\right)^{\top}=\left(\boldsymbol{J}_{1}^{\star}, \boldsymbol{J}_{2}^{\star}, \boldsymbol{E}^{\star}+\boldsymbol{g}_{3}, \boldsymbol{B}^{\star}+\boldsymbol{g}_{4}\right)^{\top}
$$

solution to (4.6) with boundary condition (4.28), and depending continuously on the data $\boldsymbol{g}$ and $\boldsymbol{U}_{0}$. To get uniqueness, we notice that the difference of two solutions solves the homogeneous problem (4.30) with zero initial data, so it vanishes.

### 4.3. On the constraint equations

Following the usual pattern in electromagnetics, the constraints on the fields: divergence equations (2.8), (2.9), magnetic boundary condition (2.17), are preserved by the evolution semigroup, provided the sources $(\rho, \boldsymbol{J}):=$ $\sum_{s}\left(\rho_{s}, \boldsymbol{J}_{s}\right)$ satisfy the charge conservation equation. We omit the proofs, as they are extremely classical ([3], Rem. 5.1.2, Thms. 5.2.3 and 5.2.12). The details can be found in $\S 4$ of [16]. As a matter of fact, once the existence and uniqueness of the solution to the coupled model is obtained, the electromagnetic variables $(\boldsymbol{E}, \boldsymbol{B})$ naturally appear as the solution to the Maxwell equations with data $(\rho, \boldsymbol{J})$.

Theorem 4.10. Assume that

$$

and that the charge conservation equation

\frac{\partial \rho(t)}{\partial t}+\operatorname{div} \boldsymbol{J}(t)=0 \quad \text { holds in } \Omega \text { for a.e. } t>0
$$

Then, for all $t>0$, the electric field $\boldsymbol{E}$ satisfies (2.8) and the magnetic field $\boldsymbol{B}$ satisfies (2.9) and (2.17).
Remark 4.11. For $\ell=1,2$, we define $\mathbf{X}_{\ell}:=\mathbf{L}_{(1)}^{2}(\Omega) \times \mathbf{L}_{(2)}^{2}(\Omega) \times \mathbf{L}^{2}(\Omega) \times \mathbf{H}_{0, \Gamma_{P}}(\operatorname{div} 0 ; \Omega)$ where the case $\ell=1$ corresponds to $\Gamma_{A}=\varnothing$, i.e., $\Gamma_{P}=\Gamma$ and $\ell=2$ is for the case $\Gamma_{A} \neq \varnothing$. Then, im $\left(\mathbb{A}_{\ell}\right) \subset \mathbf{X}_{\ell}$ and, according to Theorem 4.10, we conclude that the space $\mathbf{X}_{\ell}$ is stable by the semigroup $T_{\ell}$ generated by the operator $-\mathbb{A}_{\ell}$, i.e.,

- For all $\boldsymbol{U}_{0} \in D\left(\mathbb{A}_{1}\right) \cap \mathbf{X}_{1}$, there exists a unique $\boldsymbol{U} \in \mathrm{C}^{1}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}_{1}\right) \cap \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; D\left(\mathbb{A}_{1}\right) \cap \mathbf{X}_{1}\right)$ solution to the system of equations (2.10)-(2.14) and (2.9) with boundary conditions (2.15) and (2.17).
- For all $\boldsymbol{U}_{0} \in D\left(\mathbb{A}_{2}\right) \cap \mathbf{X}_{2}$, there exists a unique $\boldsymbol{U} \in \mathrm{C}^{1}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}_{2}\right) \cap \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; D\left(\mathbb{A}_{2}\right) \cap \mathbf{X}_{2}\right)$ solution to the system of equations (2.10)-(2.14) and (2.9) with boundary conditions (2.15)-(2.17).

Also, for all $\ell$, if we take $\boldsymbol{U}_{0} \in \mathbf{X}_{\ell}$, the two problems above have a weak solution $\boldsymbol{U} \in \mathrm{C}^{0}\left(\mathbb{R}_{\geq 0} ; \mathbf{X}_{\ell}\right)$.

## 5. SOME RESULTS OF FUNCTIONAL ANALYSIS

### 5.1. The geometry

As said in Section 2, the domain $\Omega$ can be topologically non-trivial, and the boundary $\Gamma$ can be connected, or not; see Figure 2 for an example. We now introduce some notations associated with this geometry; we use the notations from $[1,3,12]$.

We denote by $\Gamma_{k}, 0 \leq k \leq K$ the connected components of $\Gamma, \Gamma_{0}$ being the boundary of the unbounded component of $\mathbb{R}^{3} \backslash \bar{\Omega}$. When the boundary is connected, $\Gamma_{0}=\Gamma$. Let us introduce a subspace of $H^{1}(\Omega)$ :

$$
\mathrm{H}_{\partial \Omega}^{1}(\Omega):=\left\{q \in \mathrm{H}^{1}(\Omega): q_{\mid \Gamma_{0}}=0, q_{\mid \Gamma_{k}}=C_{k}, 1 \leq k \leq K\right\}
$$

Above, $C_{k}$ means a constant, and for $\ell \neq k, C_{\ell}$ and $C_{k}$ may be different. This space can be endowed with the norm $\|\cdot\|_{\mathrm{H}_{\partial \Omega}^{1}(\Omega)}=\|\operatorname{grad} \cdot\|$ (see [3], Prop. 2.1.66).

We assume that there exist $J$ connected open surfaces $\Sigma_{j}, j=1, \ldots, J$, called "cuts", contained in $\Omega$, such that:
i) each surface $\Sigma_{j}$ is a smooth, orientable two-dimensional manifold;
ii) the boundary of $\Sigma_{j}$ is contained in $\partial \Omega$;
iii) the intersection $\overline{\Sigma_{j}} \cap \overline{\Sigma_{i}}$ is empty for $i \neq j$;
iv) (if $\Gamma_{A} \neq \emptyset:$ ) $\Gamma_{A} \backslash \partial \Sigma$, where $\Sigma=\bigcup_{j=1}^{J} \Sigma_{j}$, has a finite number of connected components, denoted $\Gamma_{A, i}$, $i=1, \ldots, N$, whose closures are compact Lipschitz submanifolds of $\Gamma$;
v) the open set $\dot{\Omega}:=\Omega \backslash \Sigma$ is pseudo-Lipschitz ([1], Def. 3.1) and topologically trivial (i.e., any vector field with vanishing curl is the gradient of a scalar field on $\dot{\Omega}$ ).

If $\Omega$ is topologically trivial, $J=0$ and $\dot{\Omega}=\Omega$. The extension operator from $\mathbf{L}^{2}(\dot{\Omega})$ to $\mathbf{L}^{2}(\Omega)$ is denoted $\sim$, whereas $[\cdot]_{\Sigma_{j}}$ denotes the jump across the surface $\Sigma_{j}, j=1, \ldots, J$. Being orientable, each cut is assumed to have a "plus" and a "minus" side, so $[w]_{\Sigma_{j}}=w_{\left.\right|_{\Sigma_{j}^{+}}}-w_{\left.\right|_{\Sigma_{j}^{-}}}$. For all $j$, we denote $\langle\cdot, \cdot\rangle_{\Sigma_{j}}$ the duality pairing between $\mathrm{H}^{\frac{1}{2}}\left(\Sigma_{j}\right)$ and its dual $\mathrm{H}^{-\frac{1}{2}}\left(\Sigma_{j}\right)$.


Figure 2. Exemple of non-topologically trivial domain with a non-connected boundary. The domain $\Omega$ is made of the interior of the torus minus the green cylinders. The boundary $\partial \Omega$ is the union of the boundary of the torus and the cylinders which are all disjoint. The purple surface is a cut $\Sigma_{1}$, and the set $\dot{\Omega}=\Omega \backslash \Sigma_{1}$ is simply connected.

### 5.2. Hodge decompositions and topology-related spaces

Let $\mathbb{B}: \Omega \longrightarrow \mathcal{M}_{3}(\mathbb{C})$ be a matrix-valued function. We make the following assumption:

Define the Hilbert space

\mathbf{H}(\operatorname{div} \mathbb{B} ; \Omega):=\left\{\boldsymbol{v} \in \mathbf{L}^{2}(\Omega): \operatorname{div} \mathbb{B} \boldsymbol{v} \in \mathrm{L}^{2}(\Omega)\right\} .
$$

This space is equipped with the canonical norm $\boldsymbol{v} \mapsto\left(\|\boldsymbol{v}\|^{2}+\|\operatorname{div} \mathbb{B} \boldsymbol{v}\|^{2}\right)^{\frac{1}{2}}$. The subspace $\mathbf{H}(\operatorname{div} \mathbb{B} 0 ; \Omega):=\{\boldsymbol{v} \in$ $\left.\mathbf{L}^{2}(\Omega): \operatorname{div} \mathbb{B} \boldsymbol{v}=0\right\}$ is obviously a closed subspace of both $\mathbf{H}(\operatorname{div} \mathbb{B} ; \Omega)$ and $\mathbf{L}^{2}(\Omega)$. If $\boldsymbol{v} \in \mathbf{H}(\operatorname{div} \mathbb{B} ; \Omega)$, the normal trace of $\boldsymbol{v}$ is a well-defined element of $\mathrm{H}^{\frac{1}{2}}(\Gamma)$ and the integration by parts formula holds

\begin{equation*}
\forall \boldsymbol{v} \in \mathbf{H}(\operatorname{div} \mathbb{B} ; \Omega), \forall q \in \mathrm{H}^{1}(\Omega), \quad(\mathbb{B} \boldsymbol{v} \mid \operatorname{grad} q)+(\operatorname{div} \mathbb{B} \boldsymbol{v} \mid q)=\langle\mathbb{B} \boldsymbol{v} \cdot \boldsymbol{n}, q\rangle_{\mathrm{H}^{\frac{1}{2}}(\Gamma)} \tag{5.2}
\end{equation*}
$$

If $q \in \mathrm{H}_{0}^{1}(\Omega)$, the above formula can be extended to $\boldsymbol{v} \in \mathbf{L}^{2}(\Omega)$. Then, $\operatorname{div} \mathbb{B} \boldsymbol{v} \in \mathrm{H}^{-1}(\Omega)$ and one gets

$$
\begin{equation*}
(\mathbb{B} \boldsymbol{v} \mid \operatorname{grad} q)+\langle\operatorname{div} \mathbb{B} \boldsymbol{v}, q\rangle_{\mathrm{H}_{0}^{1}(\Omega)}=0 \tag{5.3}
\end{equation*}
$$

In this paragraph, we introduce some other spaces and notations associated to a matrix $\mathbb{B}$ satisfying (5.1), and we prove some useful results. We start with a result on elliptic problems, whose proof is straightforward and left to the reader.

Lemma 5.1. For any $f \in \mathrm{H}^{-1}(\Omega)$, the elliptic problem:

$$
\left\{\begin{array}{l}
\text { Find } q \in \mathrm{H}_{0}^{1}(\Omega) \text { such that }  \tag{5.4}\\
-\Delta_{\mathbb{B}} q:=-\operatorname{div}(\mathbb{B} \operatorname{grad} q)=f
\end{array}\right.
$$

admits a unique solution. Furthermore, there exists a constant $C>0$ such that

$$
\begin{equation*}
\|q\|_{\mathrm{H}^{1}(\Omega)} \leq C\|f\|_{\mathrm{H}^{-1}(\Omega)} \tag{5.5}
\end{equation*}
$$

Lemma 5.2. For any $\boldsymbol{v} \in \mathbf{L}^{2}(\Omega)$, there exists a unique pair $\left(q, \boldsymbol{v}^{T}\right) \in \mathrm{H}_{0}^{1}(\Omega) \times \mathbf{L}^{2}(\Omega)$ satisfying the conditions

$$
\begin{equation*}
\boldsymbol{v}=\operatorname{grad} q+\boldsymbol{v}^{T}, \quad \operatorname{div}\left(\mathbb{B} \boldsymbol{v}^{T}\right)=0 \tag{5.6}
\end{equation*}
$$

Moreover, there exists $C>0$ independent constant of $\boldsymbol{v}$ such that

$$
\begin{equation*}
\|\operatorname{grad} q\| \leq C\|\boldsymbol{v}\|, \quad\left\|\boldsymbol{v}^{T}\right\| \leq C\|\boldsymbol{v}\| \tag{5.7}
\end{equation*}
$$

Proof. Let $\boldsymbol{v} \in \mathbf{L}^{2}(\Omega)$. As $\mathbb{B}$ is bounded and the application div is continuous from $\mathbf{L}^{2}(\Omega)$ to $\mathrm{H}^{-1}(\Omega)$, we have $\operatorname{div} \mathbb{B} \boldsymbol{v} \in \mathrm{H}^{-1}(\Omega)$ and $\|\operatorname{div} \mathbb{B} \boldsymbol{v}\|_{\mathrm{H}^{-1}(\Omega)} \leq C_{1}\|\boldsymbol{v}\|$. According to Lemma 5.1, there exists one, and only one, $q \in \mathrm{H}_{0}^{1}(\Omega)$ that solves the problem (5.4) with data $f=-\operatorname{div} \mathbb{B} \boldsymbol{v}$ and satisfies $\|\operatorname{grad} q\| \leq C\|\operatorname{div} \mathbb{B} \boldsymbol{v}\|_{\mathrm{H}^{-1}(\Omega)}$. Finally, let $\boldsymbol{v}^{T}=\boldsymbol{v}-\operatorname{grad} q$. By construction, we have $\boldsymbol{v}^{T} \in \mathbf{L}^{2}(\Omega)$ and $\operatorname{div} \mathbb{B} \boldsymbol{v}^{T}=0$. The estimates of (5.7) are also established.

We now characterize the following space:

$$
\mathbf{Z}_{N}(\Omega ; \mathbb{B}):=\mathbf{H}_{0}(\operatorname{curl} 0 ; \Omega) \cap \mathbf{H}(\operatorname{div} \mathbb{B} 0 ; \Omega)
$$

Proposition 5.3. The dimension of the vector space $\mathbf{Z}_{N}(\Omega ; \mathbb{B})$ is equal to $K$, the number of connected components of the boundary, minus one. Furthermore, a basis of $\mathbf{Z}_{N}(\Omega ; \mathbb{B})$ is the set of the functions $\left(\mathbf{g r a d} q_{k}\right)_{1 \leq k \leq K}$, where each $q_{k}$ is the unique solution in $\mathrm{H}^{1}(\Omega)$ to the problem

$$
\left\{\begin{array}{l}
\Delta_{\mathbb{B}} q_{k}=\operatorname{div} \mathbb{B} \operatorname{grad} q_{k}=0, \quad \text { in } \Omega  \tag{5.8}\\
q_{k \mid \Gamma_{0}}=0 \quad \text { and } \quad q_{k \mid \Gamma_{i}}=\text { cst }_{i}, \quad 1 \leq i \leq K, \\
\left\langle\mathbb{B} \operatorname{grad} q_{k} \cdot \boldsymbol{n}, 1\right\rangle_{\mathrm{H}^{\frac{1}{2}}\left(\Gamma_{0}\right)}=-1 \quad \text { and }\left\langle\mathbb{B} \operatorname{grad} q_{k} \cdot \boldsymbol{n}, 1\right\rangle_{\mathrm{H}^{\frac{1}{2}}\left(\Gamma_{i}\right)}=\delta_{k i}, 1 \leq i \leq K
\end{array}\right.
$$

Proof. Entirely similar to Proposition 3.18 of [1], using the integration-by-parts formulas (5.3) and (5.2), and the well-posedness of elliptic problems involving the operator $\Delta_{\mathbb{B}}$, as in Lemma 5.1.

Remark 5.4. All norms being equivalent on the finite-dimensional space $\mathbf{Z}_{N}(\Omega ; \mathbb{B})$, we may use any norm to measure elements of this space; for example

$$
\boldsymbol{v} \mapsto\|\boldsymbol{v}\|, \quad \text { or } \quad \boldsymbol{v} \mapsto\left|\left(\langle\mathbb{B} \boldsymbol{v} \cdot \boldsymbol{n}, 1\rangle_{\mathrm{H}^{\frac{1}{2}}\left(\Gamma_{k}\right)}\right)_{1 \leq 1 \leq K}\right|_{p}
$$

with $1 \leq p \leq \infty$. Also, we easily check that $\mathbf{Z}_{N}(\Omega ; \mathbb{B})=\operatorname{grad}\left[Q_{N}(\Omega ; \mathbb{B})\right]$, where

$$
Q_{N}(\Omega ; \mathbb{B}):=\left\{q \in \mathrm{H}_{\partial \Omega}^{1}(\Omega): \operatorname{div} \mathbb{B} \operatorname{grad} q=0 \text { in } \Omega\right\}
$$

so, $\boldsymbol{v}=\operatorname{grad} q \mapsto\left|\left(q_{\mid \Gamma_{k}}\right)_{1 \leq k \leq K}\right|_{p}$, with $1 \leq p \leq \infty$, is another norm. Hereafter, we denote $|\cdot| \mathbf{z}_{N}(\Omega ; \mathbb{B})$ the chosen norm.

### 5.3. A compactness result

We introduce the function space

$$
\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B}):=\left\{\boldsymbol{w} \in \mathbf{H}(\operatorname{curl} ; \Omega): \operatorname{div} \mathbb{B} \boldsymbol{w} \in \mathrm{L}^{2}(\Omega) \text { and } \boldsymbol{w} \times \boldsymbol{n}_{\left.\right|_{\Gamma}} \in \mathbf{L}^{2}(\Gamma)\right\}
$$

obviously, $\boldsymbol{w} \times \boldsymbol{n}_{\left.\right|_{\Gamma}}$ can be replaced with $\boldsymbol{w}_{\top \mid \Gamma}$ in the above definition. It is endowed with its canonical norm

$$
\begin{equation*}
\|\boldsymbol{w}\|_{\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})}^{2}=\|\boldsymbol{w}\|^{2}+\|\operatorname{curl} \boldsymbol{w}\|^{2}+\|\operatorname{div} \mathbb{B} \boldsymbol{w}\|^{2}+\left\|\boldsymbol{w}_{\top}\right\|_{\mathbf{L}^{2}(\Gamma)}^{2} \tag{5.9}
\end{equation*}
$$

Below, we derive some useful properties of the space $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$ : it is compactly embedded into $\mathbf{L}^{2}(\Omega)$, which yields an a inequality in $\mathbf{L}^{2}$ norm for elements of $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$, and finally a new norm equivalent to (5.9). These results parallel and generalize those of Theorem 3.22 of [13] (for the boundary condition $\boldsymbol{w} \times \boldsymbol{n}=0$ and $\Gamma$ connected) and Theorem 8.1.3 of [3] (where $\mathbb{B}$ is assumed to be real and symmetric, and $\boldsymbol{w} \times \boldsymbol{n}=0$ on $\Gamma_{P}$ ), both of which grounded in the pioneering work ([26], Thm. 2.2). However, we choose to present the proof, as the two simultaneous negative features (non-Hermitianness of $\mathbb{B}$ and non-connectedness of $\Gamma$ ) call for a careful demonstration.

### 5.3.1. Compact embedding of $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$ into $\mathbf{L}^{2}(\Omega)$

We denote

$$
\mathbf{Z}_{N}(\Omega):=\mathbf{H}_{0}(\operatorname{curl} 0 ; \Omega) \cap \mathbf{H}(\operatorname{div} 0 ; \Omega)=\mathbf{Z}_{N}(\Omega ; \mathbb{I})
$$

As the identity matrix $\mathbb{I}$ obviously satisfies the condition $(5.1), \mathbf{Z}_{N}(\Omega)$ is of dimension $K$ and a basis is given by (5.8). Next, we introduce the (closed) subspace of $\mathbf{H}(\operatorname{div} 0 ; \Omega)$ :

$$
\mathbf{H}^{\Gamma}(\operatorname{div} 0 ; \Omega):=\left\{\boldsymbol{v} \in \mathbf{H}(\operatorname{div} 0 ; \Omega):\langle\boldsymbol{v} \cdot \boldsymbol{n}, 1\rangle_{\mathrm{H}^{\frac{1}{2}}\left(\Gamma_{k}\right)}=0,1 \leq k \leq K\right\}
$$

As an immediate consequence of Proposition 5.3, we have...
Proposition 5.5. Let $\Omega$ a domain. The following orthogonal decomposition of the space $\mathbf{H}(\operatorname{div} 0 ; \Omega)$ holds:

$$
\mathbf{H}(\operatorname{div} 0 ; \Omega)=\mathbf{Z}_{N}(\Omega) \stackrel{\perp}{\oplus} \mathbf{H}^{\Gamma}(\operatorname{div} 0 ; \Omega)
$$

Now, we can prove the following compactness result.
Theorem 5.6. Let $\Omega$ be a domain. The embedding of the space $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$ into $\mathbf{L}^{2}(\Omega)$ is compact.
Proof. Let $\left(\boldsymbol{v}_{n}\right)_{n \in \mathbb{N}}$ be a bounded sequence of $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$. According to Lemma 5.2, there exists two sequences $\left(q_{n}\right)_{n \in \mathbb{N}}$ and $\left(\boldsymbol{v}_{n}^{T}\right)_{n \in \mathbb{N}}$ of elements, respectively, of $\mathrm{H}_{0}^{1}(\Omega)$ and $\mathbf{L}^{2}(\Omega)$, such that $\boldsymbol{v}_{n}=\operatorname{grad} q_{n}+\boldsymbol{v}_{n}^{T}$ for all $n$. Our aim, using this decomposition, is to prove that a subsequence of $\left(\boldsymbol{v}_{n}\right)_{n}$ converges strongly in $\mathbf{L}^{2}(\Omega)$. This is done in two steps.
Step 1. According to (5.7), the sequence $\left(q_{n}\right)_{n}$ satisfies, for all $n$ : $\left\|\boldsymbol{\operatorname { g r a d }} q_{n}\right\| \leq C\left\|\boldsymbol{v}_{n}\right\|$, with $C$ independent of $\boldsymbol{v}_{n}$. So, $\left(q_{n}\right)_{n}$ is bounded in $\mathrm{H}_{0}^{1}(\Omega)$, and since $\mathrm{H}_{0}^{1}(\Omega)$ is compactly embedded into $\mathrm{L}^{2}(\Omega)$, there exists a subsequence, still denoted by $\left(q_{n}\right)_{n}$, that converges strongly in $\mathrm{L}^{2}(\Omega)$. Now, let us show that the subsequence $\left(\operatorname{grad} q_{n}\right)_{n}$ converges in $\mathbf{L}^{2}(\Omega)$. Denote $\boldsymbol{v}_{n m}:=\boldsymbol{v}_{n}-\boldsymbol{v}_{m}$ and $q_{n m}:=q_{n}-q_{m}$. By construction, the sequence $\left(q_{n}\right)_{n}$ verifies $\operatorname{div} \mathbb{B} \boldsymbol{v}_{n}=\operatorname{div} \mathbb{B} \operatorname{grad} q_{n}$, for all $n \in \mathbb{N}$. This leads to the inequality

$$
\begin{aligned}
\left|\left(\operatorname{div}\left(\mathbb{B} \operatorname{grad} q_{n m}\right) \mid q_{n m}\right)\right| & =\left|\left(\operatorname{div}\left(\mathbb{B} \boldsymbol{v}_{n m}\right) \mid q_{n m}\right)\right| \\
& \leq\left\|\operatorname{div}\left(\mathbb{B} \boldsymbol{v}_{n m}\right)\right\| \cdot\left\|q_{n m}\right\| \\
& \leq 2 \sup _{n}\left\|\boldsymbol{v}_{n}\right\|_{\mathbf{x}_{N, \Gamma}(\Omega ; \mathbb{B})}\left\|q_{n m}\right\| \leq C^{\prime}\left\|q_{n m}\right\|
\end{aligned}
$$

On the other hand, from (5.1) and the integration-by-parts formula (5.2), we deduce:

$$
\left|\left(\operatorname{div}\left(\mathbb{B} \operatorname{grad} q_{n m}\right) \mid q_{n m}\right)\right|=\left|\left(\mathbb{B} \operatorname{grad} q_{n m} \mid \operatorname{grad} q_{n m}\right)\right| \geq \zeta\left\|\operatorname{grad} q_{n m}\right\|^{2} .
$$

Combining the above, we conclude:

$$
\left\|\operatorname{grad} q_{n}-\operatorname{grad} q_{m}\right\|^{2} \leq \frac{C^{\prime}}{\zeta}\left\|q_{n m}\right\| .
$$

So, $\left(\operatorname{grad} q_{n}\right)_{n}$ is a Cauchy sequence in $\mathbf{L}^{2}(\Omega)$, and therefore it converges in this space.
Step 2. Recall that the sequence $\left(\boldsymbol{v}_{n}^{T}\right)_{n}$ verifies div $\mathbb{B} \boldsymbol{v}_{n}^{T}=0, \operatorname{curl} \boldsymbol{v}_{n}^{T}=\boldsymbol{\operatorname { c u r l }} \boldsymbol{v}_{n}$ and $\boldsymbol{v}_{n}^{T} \times \boldsymbol{n}_{\mid \Gamma}=\boldsymbol{v}_{n} \times \boldsymbol{n}_{\mid \Gamma}$. By Proposition 5.5, there exists a sequence $\left(\boldsymbol{y}_{n}\right)_{n}$ of elements of $\mathbf{H}^{\Gamma}(\operatorname{div} 0 ; \Omega)$ and a sequence $\left(\boldsymbol{z}_{n}\right)_{n}$ on $\mathbf{Z}_{N}(\Omega)$ such that $\mathbb{B} \boldsymbol{v}_{n}^{T}=\boldsymbol{z}_{n}+\boldsymbol{y}_{n}$ for all $n$. The sequence $\left(\boldsymbol{z}_{n}\right)_{n}$ is bounded in the finite-dimensional space $\mathbf{Z}_{N}(\Omega)$, so there exists a subsequence, still denoted by $\left(\boldsymbol{z}_{n}\right)_{n}$, which converges in any norm, e.g., that of $\mathbf{L}^{2}(\Omega)$. Then, according to Theorem 3.4.1 of [3], there exists a sequence $\left(\boldsymbol{w}_{n}\right)_{n}$ of elements of $\mathbf{H}^{1}(\Omega)$ such that $\boldsymbol{y}_{n}=\boldsymbol{\operatorname { c u r l }} \boldsymbol{w}_{n}$ for all $n$, and it satisfies:

$$
\left\|\boldsymbol{w}_{n}\right\|_{\mathbf{H}^{1}(\Omega)} \leq \xi\left\|\boldsymbol{y}_{n}\right\|
$$

for some $\xi>0$. As $\left(\boldsymbol{y}_{n}\right)_{n}$ is bounded in $\mathbf{L}^{2}(\Omega)$, it follows that $\left(\boldsymbol{w}_{n}\right)_{n}$ is bounded in $\mathbf{H}^{1}(\Omega)$. As the trace mapping is continuous from $\mathbf{H}^{1}(\Omega)$ to $\mathbf{H}^{\frac{1}{2}}(\Gamma)$, it follows that $\left(\boldsymbol{w}_{n \mid \Gamma}\right)_{n}$ is bounded in $\mathbf{H}^{\frac{1}{2}}(\Gamma)$. Therefore, by Sobolev's compact embedding theorem, we can extract a subsequence, still denoted by $\left(\boldsymbol{w}_{n}\right)_{n}$, that converges in $\mathbf{L}^{2}(\Omega)$ and such that $\left(\boldsymbol{w}_{n \mid \Gamma}\right)_{n}$ converges in $\mathbf{L}^{2}(\Gamma)$. Denote $\boldsymbol{v}_{n m}^{T}:=\boldsymbol{v}_{n}^{T}-\boldsymbol{v}_{m}^{T}, \boldsymbol{w}_{n m}:=\boldsymbol{w}_{n}-\boldsymbol{w}_{m}$ and $\boldsymbol{z}_{n m}:=\boldsymbol{z}_{n}-\boldsymbol{z}_{m}$. According to the condition (5.1), $\mathbb{B}$ is invertible, and we find

$$
\begin{aligned}
\left|\left(\mathbb{B}^{-1}\left(\boldsymbol{z}_{n m}+\operatorname{curl} \boldsymbol{w}_{n m}\right) \mid \boldsymbol{z}_{n m}+\operatorname{curl} \boldsymbol{w}_{n m}\right)\right| & =\left|\left(\boldsymbol{v}_{n m}^{T} \mid \mathbb{B} \boldsymbol{v}_{n m}^{T}\right)\right| \\
& \geq \zeta\left\|\boldsymbol{v}_{n m}^{T}\right\|^{2} .
\end{aligned}
$$

Next, by integration by parts (3.1), we obtain

$$
\begin{aligned}
& \left|\left(\mathbb{B}^{-1}\left(\boldsymbol{z}_{n m}+\operatorname{curl} \boldsymbol{w}_{n m}\right) \mid \boldsymbol{z}_{n m}+\operatorname{curl} \boldsymbol{w}_{n m}\right)\right| \\
= & \left|\left(\boldsymbol{v}_{n m}^{T} \mid \boldsymbol{z}_{n m}+\operatorname{curl} \boldsymbol{w}_{n m}\right)\right| \\
= & \left|\left(\boldsymbol{v}_{n m}^{T} \mid \boldsymbol{z}_{n m}\right)+\left(\operatorname{curl} \boldsymbol{v}_{n m}^{T} \mid \boldsymbol{w}_{n m}\right)+\left(\boldsymbol{v}_{n m}^{T} \times \boldsymbol{n} \mid\left(\boldsymbol{w}_{n m}\right)_{T}\right)_{\mathbf{L}^{2}(\Gamma)}\right| \\
= & \left|\left(\boldsymbol{v}_{n m}^{T} \mid \boldsymbol{z}_{n m}\right)+\left(\operatorname{curl} \boldsymbol{v}_{n m} \mid \boldsymbol{w}_{n m}\right)+\left(\boldsymbol{v}_{n m} \times \boldsymbol{n} \mid\left(\boldsymbol{w}_{n m}\right)_{T}\right)_{\mathbf{L}^{2}(\Gamma)}\right| \\
\leq & 2 \sup _{n}\left\|\boldsymbol{v}_{n m}\right\|_{\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})}\left(\left\|\boldsymbol{z}_{n m}\right\|+\left\|\boldsymbol{w}_{n m}\right\|+\left\|\boldsymbol{w}_{n m}\right\|_{\mathbf{L}^{2}(\Gamma)}\right) . \\
\leq & C^{\prime}\left(\left\|\boldsymbol{z}_{n m}\right\|+\left\|\boldsymbol{w}_{n m}\right\|+\left\|\boldsymbol{w}_{n m}\right\|_{\mathbf{L}^{2}(\Gamma)}\right) .
\end{aligned}
$$

Combining the above, we find

$$
\left\|\boldsymbol{v}_{n}^{T}-\boldsymbol{v}_{m}^{T}\right\|_{\mathbf{L}^{2}(\Omega)}^{2} \leq \frac{C^{\prime}}{\zeta}\left(\left\|\boldsymbol{z}_{n m}\right\|+\left\|\boldsymbol{w}_{n m}\right\|+\left\|\boldsymbol{w}_{n m}\right\|_{\mathbf{L}^{2}(\Gamma)}\right) .
$$

So, $\left(\boldsymbol{v}_{n}^{T}\right)_{n}$ is a Cauchy sequence in $\mathbf{L}^{2}(\Omega)$, and it converges in this space. Finally, the subsequence $\left(\boldsymbol{v}_{n}\right)_{n}$, defined by $\boldsymbol{v}_{n}:=\boldsymbol{\operatorname { g r a d }} q_{n}+\boldsymbol{v}_{n}^{T}$, converges in $\mathbf{L}^{2}(\Omega)$.

### 5.3.2. Equivalent norms on $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$

As a consequence of Theorem 5.6, there holds a basic inequality. The proof follows the lines of ([3], Thm 3.4.3) and ([12], Prop. 7.4).

Proposition 5.7. There exists a constant $C>0$ such that

$$
\begin{equation*}
\forall \boldsymbol{v} \in \mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B}), \quad\|\boldsymbol{v}\| \leq C\left\{\|\mathbf{c u r l} \boldsymbol{v}\|+\|\operatorname{div} \mathbb{B} \boldsymbol{v}\|+\left\|\boldsymbol{v}_{\mathrm{T}}\right\|_{\mathbf{L}^{2}(\Gamma)}+\left|P_{\mathbf{Z}_{N}(\Omega ; \mathbb{B})} \boldsymbol{v}\right|_{\mathbf{z}_{N}(\Omega ; \mathbb{B})}\right\} \tag{5.10}
\end{equation*}
$$

Corollary 5.8. The semi-norm

$$
|v|_{\mathbf{x}_{N, \Gamma}(\Omega ; \mathbb{B})}=\left(\|\operatorname{curl} \boldsymbol{v}\|^{2}+\|\operatorname{div} \mathbb{B} \boldsymbol{v}\|^{2}+\left\|\boldsymbol{v}_{\top}\right\|_{\mathbf{L}^{2}(\Gamma)}^{2}+\left|P_{\mathbf{Z}_{N}(\Omega ; \mathbb{B})} \boldsymbol{v}\right|_{\mathbf{z}_{N}(\Omega ; \mathbb{B})}\right)^{\frac{1}{2}}
$$

is a norm in $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$, equivalent to the natural norm.

## 6. Spectral properties of some useful matrices

We still denote $\|\cdot\|_{\mathcal{M}}$ the operator norm of $\mathcal{M}_{3}(\mathbb{C})$ induced by the Hermitian norm of $\mathbb{C}^{3}$. In the rest of the paper, in addition to Hypothesis 1, we shall make the following. . .

Hypothesis 2. For each species $s$, the real functions $\nu_{s}$ and $\omega_{p s}$ are bounded below by a strictly positive constant on $\Omega$, i.e., there exist $\nu_{*}>0$ and $\omega_{*}>0$ such that:

Proposition 6.1. Let $s \in\{1,2\}$ and $\alpha \in \mathbb{R}$. Then, the matrix $\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}$ is invertible for all $\boldsymbol{x} \in \Omega$. Moreover, its inverse is uniformly bounded on $\Omega$.

Proof. First, we determine the matrix $\mathbb{M}_{s}$. At each point $\boldsymbol{x} \in \Omega$, we consider an orthonormal Stix frame [24] $\left(\boldsymbol{e}_{1}(\boldsymbol{x}), \boldsymbol{e}_{2}(\boldsymbol{x}), \boldsymbol{e}_{3}(\boldsymbol{x})=\boldsymbol{b}(\boldsymbol{x})\right)$. In this frame, the expression of $\mathbb{M}_{s}$ writes:

The determinant of this matrix is:

\operatorname{det}\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}\right)=\left(\mathrm{i} \alpha+\nu_{s}\right)\left[\left(\mathrm{i} \alpha+\nu_{s}\right)^{2}+\Omega_{c s}^{2}\right]=\left(\mathrm{i} \alpha+\nu_{s}\right)\left[\left(\Omega_{c s}^{2}+\nu_{s}^{2}-\alpha^{2}\right)+2 \mathrm{i} \alpha \nu_{s}\right]:=d_{s}
$$

By Hypothesis 2 , for $\alpha \in \mathbb{R}$ fixed it holds that $\left|d_{s}(\boldsymbol{x})\right| \geq d_{\alpha}>0$ a.e. on $\Omega$. Thus, the matrix $\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}$ is invertible, and the usual inversion formula gives:

We can check that the above matrix is normal (i.e., it commutes with its conjugate transpose). By Theorem 1.42 of [10], we deduce that the $\|\cdot\|_{\mathcal{M}}$ norm of $\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}\right)^{-1}$ is equal to its spectral radius. Therefore, to prove that $\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}\right)^{-1}$ is uniformly bounded it suffices to bound its spectral radius on $\Omega$. Its eigenvalues are:

According to Hypothesis 1 and the above, these eigenvalues are bounded on $\Omega$.
From Hypotheses 1 and 2 there follows:
Proposition 6.2. Let $\alpha \in \mathbb{R}$. Let $\mathbb{D}_{\alpha}: \Omega \longrightarrow \mathcal{M}_{3}(\mathbb{C})$ be the matrix

Then, $\mathbb{D}_{\alpha}$ is uniformly bounded on $\Omega$.
Let $\alpha \in \mathbb{R}$. We now introduce another matrix which will play an important role in the proofs of stability.

\mathbb{B}_{\alpha}:=\mathrm{i} \alpha \mathbb{I}+\mathbb{D}_{\alpha}:=\left(\begin{array}{ccc}
P & Q & 0  \tag{6.3}\\
-Q & P & 0 \\

where the functions $P, Q$ and $R$ are given by

& P(\boldsymbol{x}):=\mathrm{i} \alpha+\sum_{s} \frac{\omega_{p s}^{2}(\boldsymbol{x})\left(\mathrm{i} \alpha+\nu_{s}(\boldsymbol{x})\right)}{\left(\mathrm{i} \alpha+\nu_{s}(\boldsymbol{x})\right)^{2}+\Omega_{c s}^{2}(\boldsymbol{x})}  \tag{6.4}\\
& Q(\boldsymbol{x}):=\sum_{s} \frac{\omega_{p s}^{2}(\boldsymbol{x}) \Omega_{c s}(\boldsymbol{x})}{\left(\mathrm{i} \alpha+\nu_{s}(\boldsymbol{x})\right)^{2}+\Omega_{c s}^{2}(\boldsymbol{x})}  \tag{6.5}\\
& R(\boldsymbol{x}):=\mathrm{i} \alpha+\sum_{s} \frac{\omega_{p s}^{2}(\boldsymbol{x})}{\mathrm{i} \alpha+\nu_{s}(\boldsymbol{x})} \tag{6.6}
\end{align*}
$$

The matrix $\mathbb{B}_{\alpha}$ is normal $\left(\mathbb{B}_{\alpha} \mathbb{B}_{\alpha}^{*}=\mathbb{B}_{\alpha}^{*} \mathbb{B}_{\alpha}\right)$, and its eigenvalues are

According to Proposition 6.2 , we deduce that $\mathbb{B}_{\alpha}$ is uniformly bounded on $\Omega$, i.e there exists a constant $\eta_{\alpha}>0$ depending on $\alpha$ such that

Proposition 6.3. Let $\alpha \in \mathbb{R}$. Then, the real parts of $\left(\lambda_{\alpha, j}\right)_{j=1,2,3}$ are uniformly bounded below on $\Omega$. We then define $\zeta_{\alpha}$ to be

& \Re\left(\lambda_{\alpha, 2}(\boldsymbol{x})\right)=\sum_{s} \frac{\omega_{p s}^{2}(\boldsymbol{x}) \nu_{s}(\boldsymbol{x})}{\left(\Omega_{c s}^{2}(\boldsymbol{x})+\nu_{s}^{2}(\boldsymbol{x})-\alpha^{2}\right)^{2}+4 \alpha^{2} \nu_{s}^{2}(\boldsymbol{x})}\left[\left(\Omega_{c s}(\boldsymbol{x})-\alpha\right)^{2}+\nu_{s}(\boldsymbol{x})^{2}\right], \\
& \Re\left(\lambda_{\alpha, 3}(\boldsymbol{x})\right)=\sum_{s} \frac{\omega_{p s}^{2}(\boldsymbol{x}) \nu_{s}(\boldsymbol{x})}{\nu_{s}^{2}(\boldsymbol{x})+\alpha^{2}} .
\end{aligned}
$$

Due to Hypothesis 2 and assumption (4.3), one deduces that these real parts are strictly positive. The rest of the proof follows by Hypotheses 1 and 2 .

Lemma 6.4. Given $\alpha \in \mathbb{R}$, it holds that

\end{equation*}
$$

Remark 6.5. According to Lemma 6.4, we can apply all the results of Subsection 5.2 to the matrix $\mathbb{B}_{\alpha}$, for $\alpha \in \mathbb{R}$.

## 7. Strong stability

We define the energy of our model as $\mathcal{E}(t):=\frac{1}{2}\|\boldsymbol{U}(t)\|_{\mathbf{X}}^{2}$. With the definition (2.6) of the plasma pulsation, the term given by the $\boldsymbol{J}_{s}$ variables is interpreted as the kinetic energy of the particles: $\left|\frac{\boldsymbol{J}_{s}}{\omega_{p s}}\right|^{2} \propto n_{s}\left|\mathcal{U}_{s}\right|^{2}$ at dominant order; while the $(\boldsymbol{E}, \boldsymbol{B})$ part is the electromagnetic energy of the wave. If $\boldsymbol{U}_{0}$ satisfies the condition (4.43), then, using the Green formula (3.1), one easily finds that:

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} t} \mathcal{E}(t)=-\frac{1}{\varepsilon_{0}} \sum_{s}\left\|\frac{\sqrt{\nu_{s}} \boldsymbol{J}_{s}}{\omega_{p s}}\right\|^{2}-\varepsilon_{0} c^{2} \int_{\Gamma_{A}}\left(c\left|\boldsymbol{B}_{\top}\right|^{2}-\boldsymbol{g} \cdot \boldsymbol{B}_{\top}\right) \mathrm{d} \Gamma . \tag{7.1}
\end{equation*}
$$

Here, $\Gamma_{A}$ is arbitrary. The above equation shows that the energy is non-increasing if $\Gamma_{A}=\varnothing$ or $\boldsymbol{g}=0$. (On the other hand, if $\Gamma_{A}=\varnothing$ and $\nu_{s}=0$, the derivative vanishes and $\mathcal{E}(t)=\mathcal{E}(0)$ for all $t>0$; this justifies Hypothesis 2.)

Therefore, we will study the decay of the energy in both cases: perfectly conducting $\left(\Gamma_{A}=\varnothing\right)$ and homogeneous Silver-Müller $\left(\Gamma_{A} \neq \varnothing\right.$ and $\left.\boldsymbol{g}=0\right)$. Notice that, as a consequence of Hypotheses 1 and 2, the spaces $\mathbf{L}_{(s)}^{2}(\Omega)$ are equal to $\mathbf{L}^{2}(\Omega)$, and the norms $\|\cdot\|_{(s)}$ and $\|\cdot\|$ are equivalent. Similarly, the norm $\|\cdot\|_{\mathbf{X}}$ is equivalent to the canonical norm of $\mathbf{L}^{2}(\Omega)^{4}$.

For $\ell=1,2$, the domain $D\left(\mathbb{A}_{\ell}\right)$ is not compactly embedded into $\mathbf{X}$; thus, the resolvent of $\mathbb{A}_{\ell}$ is not compact, as said in the Introduction. This fact precludes the use of many operator-theoretical results. To show the strong stability we shall use the general criterion of Arendt-Batty and Lyubich-Vu [2, 17].

Theorem 7.1 (Arendt-Batty / Lyubich-Vu). Let $X$ be a reflexive Banach space and $(T(t))_{t \geq 0}$ be a $C_{0}$ semigroup on $X$ generated by $\mathcal{L}$. Assume that $(T(t))_{t \geq 0}$ is bounded and no eigenvalue of $\mathcal{L}$ lies on the imaginary axis. If $\sigma(\mathcal{L}) \cap \mathrm{i} \mathbb{R}$ is countable, then $(T(t))_{t \geq 0}$ is strongly stable.

### 7.1. Perfectly conducting case

Proposition 7.2. For all $\alpha \in \mathbb{R} \backslash\{0\}$, the operator $\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{1}$ is injective, i.e.,

Furthermore, 0 is an eigenvalue of $\mathbb{A}_{1}$ and the corresponding set of eigenvectors is:

Proof. Let $\alpha \in \mathbb{R}$ and $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top} \in D\left(\mathbb{A}_{1}\right)$ such that

This is equivalent to the system

\mathrm{i} \alpha \boldsymbol{U}_{3}+\frac{1}{\varepsilon_{0}} \boldsymbol{U}_{1}+\frac{1}{\varepsilon_{0}} \boldsymbol{U}_{2}-c^{2} \operatorname{curl} \boldsymbol{U}_{4} & =0  \tag{7.5}\\
\mathrm{i} \alpha \boldsymbol{U}_{4}+\operatorname{curl} \boldsymbol{U}_{3} & =0 \tag{7.6}
\end{align*}
$$

Taking the real part of the inner product of (7.2) with $\boldsymbol{U}$ in $\mathbf{X}$, one gets:

\end{equation*}
$$

From Equations (7.7) and (7.8), we deduce that

\boldsymbol{U}_{1}=0 \quad \text { and } \quad \boldsymbol{U}_{2}=0 \quad \text { in } \Omega \tag{7.9}
\end{equation*}
$$

This, together with equation (7.3), implies that

If $\alpha \neq 0, \boldsymbol{U}_{4}=0$ follows from (7.10) and (7.6). And if $\alpha=0$, we deduce from (7.5), (7.9) and (7.10) that $\operatorname{curl} \boldsymbol{U}_{4}=0$. The proof of the proposition is complete.

Therefore, $\operatorname{ker} \mathbb{A}_{1}$ consists of the space of stationary solutions to Problem (2.10)-(2.14) with boundary condition (2.15), and it is of infinite dimension. From Remark 4.11, we can define the operator $\mathbb{A}_{1 \mid \mathbf{X}_{1}}: D\left(\mathbb{A}_{1}\right) \cap \mathbf{X}_{1} \rightarrow$ $\mathbf{X}_{1}$ the restriction of $\mathbb{A}_{1}$ on the space $\mathbf{X}_{1}$. In this case, the set of stationary solutions of the problem formed by Equations (2.10)-(2.14) and (2.9), with the boundary conditions (2.15) and (2.17), is equal to

\operatorname{ker}\left(\mathbb{A}_{1 \mid \mathbf{X}_{1}}\right)=\{0\}^{3} \times \mathbf{Z}_{T}(\Omega)
$$

where the kernel

\mathbf{Z}_{T}(\Omega):=\mathbf{H}(\operatorname{curl} 0 ; \Omega) \cap \mathbf{H}_{0}(\operatorname{div} 0 ; \Omega)
$$

We recall that the space $\mathbf{Z}_{T}(\Omega)$ is of dimension $J$, the number of cuts [1, 3] (if $\Omega$ is topologically trivial then $\left.\mathbf{Z}_{T}(\Omega)=\{0\}\right)$. Consider $\left(\widetilde{\operatorname{grad} \dot{q}_{j}}\right)_{1 \leq j \leq J}$ a basis of $\mathbf{Z}_{T}(\Omega)$ given by Proposition 3.14 of [1] where $\dot{q}_{j} \in \mathrm{H}^{1}(\dot{\Omega})$ is a function such that (among other conditions) $\left\langle\boldsymbol{\operatorname { g r a d } \dot { q } _ { j }} \cdot \boldsymbol{n}, 1\right\rangle_{\Sigma_{i}}=\delta_{j i}$ for $i=1, \ldots, J$. From this basis we deduce the following orthogonal decomposition in $\mathbf{H}_{0}(\operatorname{div} 0 ; \Omega)$ :

\mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega):=\left\{\boldsymbol{v} \in \mathbf{H}_{0}(\operatorname{div} 0 ; \Omega):\langle\boldsymbol{v} \cdot \boldsymbol{n}, 1\rangle_{\Sigma_{j}}=0,1 \leq j \leq J\right\}
$$

Then, according to (7.11) and by Propositions 3.7.3 and 3.7.4 of [3], we have the following decomposition

Proposition 7.3. For all $\alpha \in \mathbb{R} \backslash\{0\}$, the operator $\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{1}$ is surjective, i.e.,

Proof. We take any $\alpha \in \mathbb{R} \backslash\{0\}$ and any $\boldsymbol{F}=\left(\boldsymbol{F}_{1}, \boldsymbol{F}_{2}, \boldsymbol{F}_{3}, \boldsymbol{F}_{4}\right)^{\top} \in \mathbf{X}$, and we look for $\boldsymbol{U}=$ $\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4},\right)^{\top} \in D\left(\mathbb{A}_{1}\right)$, which solves

\mathrm{i} \alpha \boldsymbol{U}_{4}+\operatorname{curl} \boldsymbol{U}_{3} & =\boldsymbol{F}_{4} \tag{7.17}

Using (7.14), (7.15) and (7.17), we keep $\boldsymbol{U}_{3}$ as the main unknown and eliminate the others:

\boldsymbol{U}_{1} & =\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{1}\right)^{-1}\left(\boldsymbol{F}_{1}+\varepsilon_{0} \omega_{p 1}^{2} \boldsymbol{U}_{3}\right)  \tag{7.18}\\
\boldsymbol{U}_{2} & =\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{2}\right)^{-1}\left(\boldsymbol{F}_{2}+\varepsilon_{0} \omega_{p 2}^{2} \boldsymbol{U}_{3}\right)  \tag{7.19}\\
\boldsymbol{U}_{4} & =(\mathrm{i} \alpha)^{-1}\left(\boldsymbol{F}_{4}-\operatorname{curl} \boldsymbol{U}_{3}\right) \tag{7.20}
\end{align*}
$$

Inserting these expressions into (7.16), we obtain an equation in $\boldsymbol{U}_{3}$ :

Here, we cannot apply the Lax-Milgram theorem as in Proposition 4.5: the operator on the left-hand side (even suitably rescaled) is not positive. So, we shall solve this problem with a suitable version of the Fredholm alternative for constrained problems, as in $\S 4.5 .1$ of [3]. Taking account of the constraints is necessary in order to give some compactness properties (by Thm. 5.6), which are not furnished by the definition of our evolution operator.

Thus, we introduce the following mixed formulation for (7.21):
Find $\left(\boldsymbol{U}_{3}, p\right) \in \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega) \times \mathrm{H}_{\partial \Omega}^{1}(\Omega)$ such that

b_{\alpha}\left(\boldsymbol{U}_{3}, q\right) & =(\boldsymbol{G} \mid \operatorname{grad} q), \tag{7.23}
\end{align*}

where the sesquilinear forms $a_{\alpha}, c_{\alpha}$ and $b_{\alpha}$ are respectively defined on $\mathbf{H}_{0}(\mathbf{c u r l} ; \Omega) \times \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega), \mathbf{L}^{2}(\Omega) \times$ $\mathbf{H}_{0}(\operatorname{curl} ; \Omega)$ and $\mathbf{H}_{0}(\operatorname{curl} ; \Omega) \times \mathrm{H}_{\partial \Omega}^{1}(\Omega)$ as:

c_{\alpha}(\boldsymbol{w}, \boldsymbol{v}) & :=\left(\mathbb{B}_{\alpha} \boldsymbol{w} \mid \boldsymbol{v}\right), \quad \text { where } \quad \mathbb{B}_{\alpha}=\mathrm{i} \alpha \mathbb{I}+\mathbb{D}_{\alpha},  \tag{7.25}\\
b_{\alpha}(\boldsymbol{v}, q) & :=\left(\mathbb{B}_{\alpha} \boldsymbol{v} \mid \operatorname{grad} q\right) \tag{7.26}
\end{align*}

The anti-linear form $L_{\alpha}$ on $\mathbf{H}_{0}(\operatorname{curl} ; \Omega)$ is given by:

\end{equation*}

and $\boldsymbol{G}$ is an element of $\mathbf{L}^{2}(\Omega)$ which will be chosen later.
To show the well-posedness of the variational formulation (7.22)-(7.23), we first verify that the assumptions of Theorem 4.5.9 in [3] on Helmholtz-like problems with constraints are fulfilled, and we conclude by the Fredholm alternative.
i) Continuity: it is clear that the sesquilinear forms $a_{\alpha}, b_{\alpha}$ and $c_{\alpha}$, and the anti-linear from $L_{\alpha}$, are continuous on their respective spaces.
ii) Coercivity on the kernel: the kernel of $b_{\alpha}$ is defined by

which, by Green's formulas (5.3) and (5.2), can be written as

$$
=\left\{\boldsymbol{v} \in \mathbf{H}_{0}(\operatorname{curl} ; \Omega) \cap \mathbf{H}\left(\operatorname{div} \mathbb{B}_{\alpha} 0 ; \Omega\right): P_{\mathbf{Z}_{N}\left(\Omega ; \mathbb{B}_{\alpha}\right)} \boldsymbol{v}=0\right\}
$$

According to Corollary 5.8 applied to the closed subspace K of $\mathbf{X}_{N, \Gamma}(\Omega ; \mathbb{B})$, the sesquilinear form $a_{\alpha}$ is coercive on $\mathrm{K} \times \mathrm{K}$. Furthermore, the embedding $\mathrm{K} \subset \mathbf{L}^{2}(\Omega)$ is compact by Theorem 5.6.
iii) Inf-sup condition: let $q \in \mathrm{H}_{\partial \Omega}^{1}(\Omega)$ and set $\boldsymbol{v}=\operatorname{grad} q \in \mathbf{H}_{0}(\operatorname{curl} 0 ; \Omega)$, thus $\boldsymbol{v}$ checks $\|\boldsymbol{v}\|_{\mathbf{H}(\operatorname{curl} ; \Omega)}=$ $\left(\|\boldsymbol{v}\|^{2}+\|\operatorname{curl} \boldsymbol{v}\|^{2}\right)^{\frac{1}{2}}=\|\boldsymbol{v}\|$. On the other hand, according to Lemma 6.4, one has

Consequently, there exists $C_{b}=\zeta_{\alpha}>0$ such that

Hence, the assumptions of Theorem 4.5.9 in [3] are satisfied: we can apply the usual Fredholm alternative ([3], Thm. 4.5.7). So, we show that the variational formulation (7.22) is injective on the kernel, i.e., its solution is unique. Let $\boldsymbol{Z}_{3}$ be a solution to

Since $\boldsymbol{Z}_{3}$ belongs to $K$, one has $\boldsymbol{Z}_{3} \in \mathbf{H}(\operatorname{curl} ; \Omega)$ with $\operatorname{div} \mathbb{B}_{\alpha} \boldsymbol{Z}_{3}=0$ in $\Omega$ and $\boldsymbol{Z}_{3} \times \boldsymbol{n}_{\mid \Gamma}=0$. Next, consider $\boldsymbol{y} \in \mathcal{D}(\Omega)$. Introduce the scalar field $\varphi \in \mathrm{H}_{\partial \Omega}^{1}(\Omega)$ that solves the variational formulation: for all $\psi \in \mathrm{H}_{\partial \Omega}^{1}(\Omega)$, $\left(\mathbb{B}_{\alpha} \operatorname{grad} \varphi \mid \operatorname{grad} \psi\right)=\left(\mathbb{B}_{\alpha} \boldsymbol{y} \mid \operatorname{grad} \psi\right)$. By construction, $\boldsymbol{v}:=\boldsymbol{y}-\operatorname{grad} \varphi$ belongs to K with $\operatorname{curl} \boldsymbol{v}=\operatorname{curl} \boldsymbol{y}$. Using it as a test function in (7.30) yields

& =(\mathrm{i} \alpha)^{-1} c^{2}\left(\operatorname{curl} \boldsymbol{Z}_{3} \mid \operatorname{curl} \boldsymbol{v}\right)+\left(\mathbb{B}_{\alpha} \boldsymbol{Z}_{3} \mid \boldsymbol{v}+\operatorname{grad} \varphi\right) \\
& =(\mathrm{i} \alpha)^{-1} c^{2}\left(\operatorname{curl} \boldsymbol{Z}_{3} \mid \operatorname{curl} \boldsymbol{v}\right)+\left(\mathbb{B}_{\alpha} \boldsymbol{Z}_{3} \mid \boldsymbol{v}\right)=0 .
\end{aligned}
$$

The last line is obtained by integration by parts, using the facts that $\operatorname{div}\left(\mathbb{B}_{\alpha} \boldsymbol{Z}_{3}\right)=0$ in $\Omega$ and $\left\langle\mathbb{B}_{\alpha} \boldsymbol{Z}_{3}\right.$. $\boldsymbol{n}, 1\rangle_{\mathbf{H}^{\frac{1}{2}}\left(\Gamma_{k}\right)}=0$, for all $1 \leq k \leq K$. Recall that $\mathbb{B}_{\alpha}=\mathrm{i} \alpha \mathbb{I}+\mathbb{D}_{\alpha}$; as $\boldsymbol{y}$ is arbitrary, it follows that:

Let now $\boldsymbol{Z}_{1}, \boldsymbol{Z}_{2}$ and $\boldsymbol{Z}_{4}$ defined as

\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}\right) \boldsymbol{Z}_{s}=\varepsilon_{0} \omega_{p s}^{2} \boldsymbol{Z}_{3}, s=1,2 ; \quad \boldsymbol{Z}_{4}=-(\mathrm{i} \alpha)^{-1} \operatorname{curl} \boldsymbol{Z}_{3} \tag{7.32}
\end{equation*}
$$

Clearly, these fields belong to $\mathbf{L}_{(s)}^{2}(\Omega)=\mathbf{L}^{2}(\Omega)$. Replacing the matrix $\mathbb{D}_{\alpha}$ with its expression in (7.31) and using the definitions above, we get

which implies that $\operatorname{curl} \boldsymbol{Z}_{4} \in \mathbf{L}^{2}(\Omega)$. The equations (7.32)-(7.33) are equivalent to (i $\left.\alpha \mathbb{I}+\mathbb{A}_{1}\right) \boldsymbol{Z}=0$, with $\boldsymbol{Z}=\left(\boldsymbol{Z}_{1}, \boldsymbol{Z}_{2}, \boldsymbol{Z}_{3}, \boldsymbol{Z}_{4}\right)^{\top} \in D\left(\mathbb{A}_{1}\right)$. Therefore, according to Proposition 7.2 , one finds $\boldsymbol{Z}=0$, and so $\boldsymbol{Z}_{3}=0$ in $\Omega$. Thus, the formulation (7.30) is injective. Finally, according to Theorem 4.5.9 and Proposition 4.5.8 of [3], the problem (7.22)-(7.23) has a unique solution $\left(\boldsymbol{U}_{3}, p\right) \in \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega) \times \mathrm{H}_{\partial \Omega}^{1}(\Omega)$.

To show the equivalence between (7.22) and the strong formulation (7.21), we have to check that the Lagrange multiplier $p$ vanishes. Taking $\boldsymbol{v}=\operatorname{grad} p \in \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega)$ as a test function in (7.22), we obtain

\end{equation*}
$$

The first term above is the left-hand side of the constraint equation (7.23). Thus, choosing

\end{equation*}
$$

we get, according to (7.34) and (7.23),

Thanks to Lemma 6.4 , we deduce that $\operatorname{grad} p=0$ in $\Omega$. As $p$ belongs to $\mathrm{H}_{\partial \Omega}^{1}(\Omega)$, we find $p=0$.
Returning to Problem (7.13), we define $\boldsymbol{U}_{1} \in \mathbf{L}_{(1)}^{2}(\Omega), \boldsymbol{U}_{2} \in \mathbf{L}_{(2)}^{2}(\Omega)$ respectively by (7.18) and (7.19). Also, we define $\boldsymbol{U}_{4} \in \mathbf{L}^{2}(\Omega)$ by (7.20). Taking $\boldsymbol{v} \in \mathcal{D}(\Omega)$ as a test function in (7.22), replacing $\mathbb{B}_{\alpha}$ with its expression and using Green's formula (3.1), we obtain equation (7.21), and by the definition (7.20) of $\boldsymbol{U}_{4}$ we find

\mathrm{i} \alpha \boldsymbol{U}_{3}-c^{2} \operatorname{curl} \boldsymbol{U}_{4}+\mathbb{D}_{\alpha} \boldsymbol{U}_{3}=\boldsymbol{F}_{3}-\frac{1}{\varepsilon_{0}} \sum_{s}\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}\right)^{-1} \boldsymbol{F}_{s} \quad \text { in } \mathcal{D}^{\prime}(\Omega) . \tag{7.36}
\end{equation*}
$$

This implies that $\operatorname{curl} \boldsymbol{U}_{4} \in \mathbf{L}^{2}(\Omega)$. To finish the proof, it remains to check that equation (7.16) is satisfied: to this end, it is enough to replace in (7.36) the matrix $\mathbb{D}_{\alpha}$ with its definition and to use (7.18) and (7.19).

Let us introduce a closed subspace of $\mathbf{X}$ :

Of course, $\widetilde{\mathbf{X}}_{1}$ is a Hilbert space when endowed with the inherited inner product.
Proposition 7.4. The range $\operatorname{im}\left(\mathbb{A}_{1}\right)$ of $\mathbb{A}_{1}$ is included in $\widetilde{\mathbf{X}}_{1}$.
Proof. Consider $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top}$ an element of $D\left(\mathbb{A}_{1}\right)$. Then, by the definition (4.11) of $\mathbb{A}_{1}, \mathbb{A}_{1} \boldsymbol{U}$ belongs to $\widetilde{\mathbf{X}}_{1}$ if, and only if, $\boldsymbol{\operatorname { c u r l }} \boldsymbol{U}_{3}$ belongs to $\mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega)$. But $\boldsymbol{U}_{3} \in \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega)$, and it is well-known (see, e.g., [3], Rem. 3.5.2) that $\boldsymbol{v} \in \mathbf{H}_{0}(\mathbf{c u r l} ; \Omega)$ implies $\operatorname{curl} \boldsymbol{v} \in \mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega)$.

The spectral analysis of the operator $\mathbb{A}_{1}$ shows that no stabilization can take place in the whole space $\mathbf{X}$ : an initial data $\boldsymbol{U}_{0} \in \operatorname{ker} \mathbb{A}_{1}$ generates a constant-in-time solution. The above results lead us to introduce the unbounded operator $\widetilde{\mathbb{A}}_{1}: D\left(\widetilde{\mathbb{A}}_{1}\right) \rightarrow \widetilde{\mathbf{X}}_{1}$ defined by

D\left(\widetilde{\mathbb{A}}_{1}\right)=D\left(\mathbb{A}_{1}\right) \cap \widetilde{\mathbf{X}}_{1} \quad \text { and } \quad \widetilde{\mathbb{A}}_{1} \boldsymbol{U}=\mathbb{A}_{1} \boldsymbol{U}, \forall \boldsymbol{U} \in D\left(\widetilde{\mathbb{A}}_{1}\right) . \tag{7.38}
\end{equation*}
$$

The spectral properties of $\widetilde{\mathbb{A}}_{1}$ are easily deduced from Propositions 7.2 and 7.3.
Proposition 7.5. For all $\alpha \in \mathbb{R}$, the operator $\mathrm{i} \alpha \mathbb{I}+\widetilde{\mathbb{A}}_{1}$ is injective. For $\alpha \in \mathbb{R} \backslash\{0\}$, it is surjective.

Proof. The injectivity for $\alpha \neq 0$ directly follows from Proposition 7.2. For $\alpha=0, \widetilde{\mathbb{A}}_{1} \boldsymbol{U}=0$ means $\boldsymbol{U} \in \widetilde{\mathbf{X}}_{1}$ and $\mathbb{A}_{1} \boldsymbol{U}=0$, hence $\boldsymbol{U}_{1}=\boldsymbol{U}_{2}=\boldsymbol{U}_{3}=0, \boldsymbol{U}_{4} \in \mathbf{H}(\operatorname{curl} 0 ; \Omega)$ and $\boldsymbol{U}_{4} \in \mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega)$. According to (7.12), this implies $\boldsymbol{U}_{4}=0$.

Taking account of Proposition 7.3 , the surjectivity property means that, if $\boldsymbol{F} \in \widetilde{\mathbf{X}}_{1}$, the unique solution $\boldsymbol{U}$ to $\mathrm{i} \alpha \boldsymbol{U}+\mathbb{A}_{1} \boldsymbol{U}=\boldsymbol{F}$ belongs to $\widetilde{\mathbf{X}}_{1}$. This, in turn, is an obvious consequence of Proposition 7.4.

We notice that $\widetilde{\mathbf{X}}_{1}$ is an invariant space for the problem (4.12), see Lemma 7.8. We then define $\check{T}_{1}:=$ $T_{1_{\mid D\left(\mathbb{A}_{1}\right) \cap} \widetilde{\mathbf{x}}_{1}}$.
Theorem 7.6. The semigroup of contractions $\left(\check{T}_{1}(t)\right)_{t \geq 0}$ with generator $-\widetilde{\mathbb{A}}_{1}$ is strongly stable on the energy space $\widetilde{\mathbf{X}}_{1}$, i.e.,

$$
\begin{equation*}
\lim _{t \rightarrow+\infty}\left\|\check{T}_{1}(t) \widetilde{\boldsymbol{U}}_{0}\right\|_{\widetilde{\mathbf{X}}_{1}}=0, \quad \forall \widetilde{\boldsymbol{U}}_{0} \in \widetilde{\mathbf{X}}_{1} \tag{7.39}
\end{equation*}
$$

Proof. According to Proposition 7.5, we conclude that

$$
\sigma\left(-\widetilde{\mathbb{A}}_{1}\right) \cap i \mathbb{R}=\varnothing \quad \text { or } \quad\{0\}
$$

which is countable in both cases, and that 0 is not an eigenvalue. On the other hand, $\widetilde{\mathbb{A}}_{1}$ is monotone in $\widetilde{\mathbf{X}}_{1}$, so $-\widetilde{\mathbb{A}}_{1}$ is dissipative in $\widetilde{\mathbf{X}}_{1}$. The rest of the proof follows from Theorem 7.1.
Remark 7.7. As we shall see in Section 8,0 actually does not belong to $\sigma\left(-\widetilde{\mathbb{A}}_{1}\right)$.
We denote by $P_{1}$ the orthogonal projection in $\mathbf{L}^{2}(\Omega)$ onto $\mathbf{Z}_{T}(\Omega)$.
Lemma 7.8. Let $\boldsymbol{U}_{0} \in \mathbf{X}_{1}$ and $\boldsymbol{U}$ be the solution of problem (4.12). It holds that

P_{1}(\boldsymbol{B}(t))=P_{1}\left(\boldsymbol{B}_{0}\right), \quad \forall t>0 . \tag{7.40}
\end{equation*}
$$

Proof. Just multiply equation (2.13) by a element of $\mathbf{Z}_{T}(\Omega)$ and integrate by parts on $\Omega$.
Lemma 7.8 shows that the projection of the solution $\boldsymbol{U}$ onto $\operatorname{ker}\left(\mathbb{A}_{1 \mid \mathbf{X}_{1}}\right)$ does not depend on the time. Then we conclude...

Corollary 7.9. It holds that

$$
\lim _{t \rightarrow+\infty}\left\|T_{1}(t) \boldsymbol{U}_{0}-\sum_{1 \leq j \leq J} \xi_{j}\left(0,0,0, \widetilde{\operatorname{grad} \dot{q}_{j}}\right)^{\top}\right\|_{\mathbf{X}_{1}}=0, \quad \forall \boldsymbol{U}_{0} \in \mathbf{X}_{1}
$$

where $\xi_{j}=\left\langle\boldsymbol{B}_{0} \cdot \boldsymbol{n}, 1\right\rangle_{\Sigma_{j}}, \quad$ for $j=1, \ldots, J$.
Proof. Let $\boldsymbol{U}_{0} \in \mathbf{X}_{1}$. From the orthogonal decomposition (7.11) and Lemma 7.8, we deduce that the solution $\boldsymbol{U}$ to the system (2.10)-(2.14) and (2.9), with boundary conditions (2.15) and (2.17), can be written as:

\boldsymbol{U}(t)=\widetilde{\boldsymbol{U}}(t)+\left(0,0,0, P_{1} \boldsymbol{B}_{0}\right)
$$

and $\tilde{\boldsymbol{U}}(t) \in \widetilde{\mathbf{X}}_{1}$ is the solution of problem

$$
\partial_{t} \tilde{\boldsymbol{U}}(t)+\widetilde{\mathbb{A}}_{1} \tilde{\boldsymbol{U}}(t)=0, \text { for } t>0, \quad \tilde{\boldsymbol{U}}(0)=\widetilde{\boldsymbol{U}}_{0}
$$

where the initial condition $\widetilde{\boldsymbol{U}}_{0}=\boldsymbol{U}_{0}-\left(0,0,0, P_{1} \boldsymbol{B}_{0}\right)$ belongs to $\widetilde{\mathbf{X}}_{1}$. Next, let $\xi_{j}, j=1, \ldots, J$ be a constants such that $P_{1} \boldsymbol{B}_{0}=\sum_{1 \leq j \leq J} \xi_{j} \widehat{\operatorname{grad} \dot{q}_{j}}$. Therefore, $\boldsymbol{B}_{0}-P_{1} \boldsymbol{B}_{0}$ belongs to $\mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega)$, which yields:

$$
\left\langle\boldsymbol{B}_{0} \cdot \boldsymbol{n}, 1\right\rangle_{\Sigma_{i}}=\sum_{j} \xi_{j}\left\langle\widetilde{\operatorname{grad} \dot{q}_{j}} \cdot \boldsymbol{n}, 1\right\rangle_{\Sigma_{i}}=\xi_{i}
$$

Finally, from Theorem 7.6, $\widetilde{\boldsymbol{U}}$ satisfies $\lim _{t \rightarrow+\infty}\|\widetilde{\boldsymbol{U}}(t)\|_{\tilde{\mathbf{x}}_{1}}=0$, hence the result.

### 7.2. Homogeneous Silver-Müller case

Proposition 7.10. For all $\alpha \in \mathbb{R} \backslash\{0\}$, the operator $\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{2}$ is injective, i.e.,

\operatorname{ker}\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{2}\right)=\{0\}
$$

Furthermore, 0 is an eigenvalue of $\mathbb{A}_{2}$ and the set of its eigenvectors is

$$
\operatorname{ker}\left(\mathbb{A}_{2}\right)=\left\{(0,0,0, \boldsymbol{V}): \boldsymbol{V} \in \mathbf{H}_{0, \Gamma_{A}}(\operatorname{curl} 0 ; \Omega)\right\}
$$

Proof. Let $\alpha \in \mathbb{R}$ and $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top} \in D\left(\mathbb{A}_{2}\right)$ be such that

$$
\begin{equation*}
\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{2}\right) \boldsymbol{U}=0 \tag{7.41}
\end{equation*}
$$

which is equivalent, in $\Omega$, to the system (7.3)-(7.6). Taking the inner product of (7.41) with $\boldsymbol{U}$, one gets:

\Re\left(\mathrm{i} \alpha\|\boldsymbol{U}\|_{\mathbf{X}}^{2}\right)=\Re\left(\mathbb{A}_{2} \boldsymbol{U} \mid \boldsymbol{U}\right)_{\mathbf{X}}=0

By the monotonicity of $\mathbb{A}_{2}$, see (4.33), one obtains

\left(\left.\frac{\nu_{s} \boldsymbol{U}_{s}}{\varepsilon_{0} \omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}}{\omega_{p s}}\right)=0, \quad s=1,2, \quad \text { and } \quad\left\|\boldsymbol{U}_{4 \top}\right\|_{\mathbf{L}^{2}\left(\Gamma_{A}\right)}^{2}=0
$$

The rest of the proof follows the same arguments as Proposition 7.2.
The above Proposition states that ker $\mathbb{A}_{2}$ coincides with the set of stationary solutions to the problem (2.10)(2.14) with boundary condition (2.15) and (2.16) (with $\boldsymbol{g}=0$ ). Similarly to the operator $\mathbb{A}_{1}$, if we define the operator $\mathbb{A}_{2 \mid \mathbf{X}_{2}}: D\left(\mathbb{A}_{2}\right) \cap \mathbf{X}_{2} \rightarrow \mathbf{X}_{2}$ as the restriction of $\mathbb{A}_{2}$ to the space $\mathbf{X}_{2}$, then we obtain

$$
\operatorname{ker}\left(\mathbb{A}_{2 \mid \mathbf{X}_{2}}\right)=\{0\}^{3} \times \mathbf{Z}\left(\Omega ; \Gamma_{A}\right)
$$

where the kernel

$$
\mathbf{Z}\left(\Omega ; \Gamma_{A}\right):=\mathbf{H}_{0, \Gamma_{A}}(\operatorname{curl} 0 ; \Omega) \cap \mathbf{H}_{0, \Gamma_{P}}(\operatorname{div} 0 ; \Omega)
$$

Note that the set of stationary solution to equations (2.10)-(2.14) and (2.9), with boundary conditions (2.15)(2.17) and $\boldsymbol{g}=0$, is equal to $\operatorname{ker}\left(\mathbb{A}_{2 \mid \mathbf{X}_{2}}\right)$.

The space $\mathbf{Z}\left(\Omega ; \Gamma_{A}\right)$ has been studied by Fernandes and Gilardi in [12]. It is of finite dimension and from Corollarly 5.2 of [12] one has $\operatorname{dim} \mathbf{Z}\left(\Omega ; \Gamma_{A}\right) \leq N+J-1$. (We recall that $N$ is the number of connected components of $\Gamma_{A} \backslash \partial \Sigma$.)

We now recall some orthogonal decompositions from [12]; we mostly keep the same notations. Picking a vector $\mathbf{a} \in \mathbb{R}^{N}$ such that $\sum_{i=1}^{N} a_{i} \neq 0$, we define the space

\begin{aligned}
& \mathrm{H}_{\text {const } \Gamma_{A}, \Sigma}^{\frac{1}{2}}(\partial \dot{\Omega} ; \mathbf{a}):=\left\{p \in \mathrm{H}^{\frac{1}{2}}(\partial \dot{\Omega}): \exists \mathbf{c} \in \mathbb{R}^{N}, \exists \mathbf{c}^{\prime} \in \mathbb{R}^{J}: \mathbf{c} \cdot \mathbf{a}=0\right. \\
& \left.\quad p_{\mid \Gamma_{A, i}}=c_{i} \text { for } i=1, \ldots, N ; \quad[p]_{\Sigma_{j}}=c_{j}^{\prime} \text { for } j=1, \ldots, J\right\}
\end{aligned}
$$

Moreover we introduce

$$
\begin{aligned}
& \mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega):=\left\{\boldsymbol{v} \in \mathbf{H}_{0, \Gamma_{P}}(\operatorname{div} 0 ; \Omega):\right. \\
& \left.\quad\langle\boldsymbol{v} \cdot \boldsymbol{n}, p\rangle_{\mathrm{H}^{\frac{1}{2}}\left(\Gamma_{A} \cup \Sigma\right)}=0 \quad \forall p \in \mathrm{H}_{\text {const } \Gamma_{A}, \Sigma}^{\frac{1}{2}}(\partial \dot{\Omega} ; \mathbf{a})\right\} .
\end{aligned}
$$

For the proof, we refer the reader to Proposition 3.3 and Remark 2.1 of [12]. Then, we have the orthogonal decompositions in $\mathbf{L}^{2}(\Omega)$ which are proven in Propositions 6.3 and 6.4 of [12]:

\begin{align*}
\mathbf{H}_{0, \Gamma_{P}}(\operatorname{div} 0 ; \Omega) & =\quad \mathbf{Z}\left(\Omega ; \Gamma_{A}\right) \tag{7.42}
\end{align*} \stackrel{\perp}{\oplus} \mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega), ~ . ~(\operatorname{curl} 0 ; \Omega) \stackrel{\perp}{\oplus} \mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega) .
$$

Proposition 7.11. For all $\alpha \in \mathbb{R} \backslash\{0\}$, the operator $\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{2}$ is surjective, i.e

$$
\operatorname{im}\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{2}\right)=\mathbf{X}
$$

Proof. We follow the lines of the proof of Proposition 7.3. Let $\alpha \in \mathbb{R} \backslash\{0\}$ and $\boldsymbol{F}=\left(\boldsymbol{F}_{1}, \boldsymbol{F}_{2}, \boldsymbol{F}_{3}, \boldsymbol{F}_{4}\right)^{\top} \in \mathbf{X}$; we look for $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top} \in D\left(\mathbb{A}_{2}\right)$ which solves:

$$
\begin{equation*}
\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{A}_{2}\right) \boldsymbol{U}=\boldsymbol{F} \tag{7.44}
\end{equation*}
$$

which is equivalent to the system (7.14)-(7.17), with different boundary conditions. Again, we eliminate $\boldsymbol{U}_{1}$, $\boldsymbol{U}_{2}$ and $\boldsymbol{U}_{4}$ by (7.18), (7.19) and (7.20) respectively, while $\boldsymbol{U}_{3}$ verifies the equation (7.21) in $\Omega$. Given the Silver-Müller boundary condition, the mixed formulation of (7.21) writes - recall the space $\mathcal{V}$ from (4.31):
Find $\left(\boldsymbol{U}_{3}, p\right) \in \mathcal{V} \times \mathrm{H}_{\partial \Omega}^{1}(\Omega)$ such that

\begin{align*}
\widetilde{a}_{\alpha}\left(\boldsymbol{U}_{3}, \boldsymbol{v}\right)+c_{\alpha}\left(\boldsymbol{U}_{3}, \boldsymbol{v}\right)+b_{\alpha}(\boldsymbol{v}, p) & =L_{\alpha}(\boldsymbol{v}), \quad \forall \boldsymbol{v} \in \mathcal{V},  \tag{7.45}\\
b_{\alpha}\left(\boldsymbol{U}_{3}, q\right) & =(\boldsymbol{G} \mid \operatorname{grad} q), \quad \forall q \in \mathrm{H}_{\partial \Omega}^{1}(\Omega) \tag{7.46}
\end{align*}
$$

where the sesquilinear form $\widetilde{a}_{\alpha}$ is defined on $\mathcal{V} \times \mathcal{V}$ as:

\begin{equation*}
\widetilde{a}_{\alpha}(\boldsymbol{w}, \boldsymbol{v}):=a_{\alpha}(\boldsymbol{w}, \boldsymbol{v})+c\left(\boldsymbol{w}_{\top} \mid \boldsymbol{v}_{\top}\right)_{\Gamma_{A}} \tag{7.47}
\end{equation*}
$$

the form $a_{\alpha}$ being defined in (7.24); on the other hand, $b_{\alpha}, c_{\alpha}, L_{\alpha}$ are as in (7.25)-(7.27), except that the variable $\boldsymbol{v}$ now belongs to $\mathcal{V}$. Again, $\boldsymbol{G}$ is an element of $\mathbf{L}^{2}(\Omega)$ which will be chosen later.

Checking the hypotheses of Theorem 4.5.9 in [3] proceeds as in Proposition 7.3.
i) Continuity: obvious.
ii) Coercivity on the kernel: the kernel of $b_{\alpha}(.,$.$) is defined by$

\mathrm{K}=\left\{\boldsymbol{v} \in \mathcal{V}: b_{\alpha}(\boldsymbol{v}, q)=0, \quad \forall q \in \mathrm{H}_{\partial \Omega}^{1}(\Omega)\right\}
$$

which, by the Green formulas (5.3) and (5.2), can be written as:

& \mathrm{K}=\left\{\boldsymbol{v} \in \mathcal{V} \cap \mathbf{H}\left(\operatorname{div} \mathbb{B}_{\alpha} 0 ; \Omega\right):\left\langle\mathbb{B}_{\alpha} \boldsymbol{v} \cdot \boldsymbol{n}, 1\right\rangle_{\mathrm{H}^{\frac{1}{2}}\left(\Gamma_{k}\right)}=0, \forall 1 \leq k \leq K\right\} \\
& \quad=\left\{\boldsymbol{v} \in \mathcal{V} \cap \mathbf{H}\left(\operatorname{div} \mathbb{B}_{\alpha} 0 ; \Omega\right): P_{\mathbf{Z}_{N}\left(\Omega ; \mathbb{B}_{\alpha}\right)} \boldsymbol{v}=0\right\}
\end{aligned}
$$

This kernel is compactly embedded into $\mathbf{L}^{2}(\Omega)$ by Theorem 5.6. Furthermore, according to Corollary 5.8, the sesquiliear form $\widetilde{a}_{\alpha}$ is coercive on $\mathrm{K} \times \mathrm{K}$. Indeed, taking $\boldsymbol{v} \in \mathrm{K}$, we find

\left|\widetilde{a}_{\alpha}(\boldsymbol{v}, \boldsymbol{v})\right|=\left|(\mathrm{i} \alpha)^{-1} c^{2}\|\operatorname{curl} \boldsymbol{v}\|^{2}+c\left\|\boldsymbol{v}_{\top}\right\|_{\mathbf{L}^{2}\left(\Gamma_{A}\right)}^{2}\right|=\left(\left(|\alpha|^{-1} c^{2}\|\operatorname{curl} \boldsymbol{v}\|^{2}\right)^{2}+\left(c\left\|\boldsymbol{v}_{\top}\right\|_{\mathbf{L}^{2}\left(\Gamma_{A}\right)}^{2}\right)^{2}\right)^{\frac{1}{2}}
$$

But, we have the inequality

\left(z^{2}+y^{2}\right)^{\frac{1}{2}} \geq \frac{1}{\sqrt{2}}|z+y|, \quad \forall(z, y) \in \mathbb{R}^{2}
$$

Consequently,

\left|\widetilde{a}_{\alpha}(\boldsymbol{v}, \boldsymbol{v})\right| & \geq \frac{1}{\sqrt{2}}\left(|\alpha|^{-1} c^{2}\|\operatorname{curl} \boldsymbol{v}\|^{2}+c\left\|\boldsymbol{v}_{\top}\right\|_{\mathbf{L}^{2}\left(\Gamma_{A}\right)}^{2}\right) \\
& \geq \frac{1}{\sqrt{2}} \min \left\{|\alpha|^{-1} c^{2}, c\right\}\left(\|\operatorname{curl} \boldsymbol{v}\|^{2}+\left\|\boldsymbol{v}_{\top}\right\|_{\mathbf{L}^{2}\left(\Gamma_{A}\right)}^{2}\right)=C|\boldsymbol{v}|_{\mathbf{X}_{N, \Gamma}\left(\Omega ; \mathbb{B}_{\alpha}\right)}^{2}
\end{aligned}
$$

iii) Inf-sup condition: take any $q \in \mathrm{H}_{\partial \Omega}^{1}(\Omega)$ and set $\boldsymbol{v}=\operatorname{grad} q$. Then, we have curl $\boldsymbol{v}=0 \in \mathbf{L}^{2}(\Omega)$ and $\boldsymbol{v}_{\top}=0 \in \mathbf{L}^{2}(\Gamma)$, thus $\boldsymbol{v} \in \mathcal{V}$ and verifies $\|\boldsymbol{v}\| \mathcal{V}=\|\boldsymbol{v}\|$. The conclusion follows from the inequalities (7.28) and (7.29).

As in the perfect conductor case, we can apply the Fredholm alternative. So, we show that the variational formulation (7.45) is injective on the kernel. Let $\boldsymbol{Z}_{3}$ be a solution to the variational formulation

\end{equation*}
$$

Since $\boldsymbol{Z}_{3}$ belongs to K , one has $\boldsymbol{Z}_{3} \in \mathbf{H}(\operatorname{curl} ; \Omega)$ with $\operatorname{div} \mathbb{B}_{\alpha} \boldsymbol{Z}_{3}=0$ in $\Omega$ and $\boldsymbol{Z}_{3} \times \boldsymbol{n}_{\mid \Gamma_{P}}=0$. As in Proposition 7.3 , we obtain the existence of $\boldsymbol{Z}_{1}, \boldsymbol{Z}_{2} \in \mathbf{L}^{2}(\Omega)$ and $\boldsymbol{Z}_{4} \in \mathbf{H}(\operatorname{curl} ; \Omega)$ such that $(\mathrm{i} \alpha \mathbb{I}+\mathbb{A}) \boldsymbol{Z}=0$, with $\boldsymbol{Z}=\left(\boldsymbol{Z}_{1}, \boldsymbol{Z}_{2}, \boldsymbol{Z}_{3}, \boldsymbol{Z}_{4}\right)^{\top}$. To apply Proposition 7.10 , we must check that $\boldsymbol{Z} \in D\left(\mathbb{A}_{2}\right)$, i.e., the Silver-Müller condition is satisfied. For $\boldsymbol{v} \in \mathrm{K}$, using the integration-by-parts formula (3.2) in (7.48) and equation (7.31), we get

\left(\boldsymbol{Z}_{3 \top} \mid \boldsymbol{v}_{\top}\right)_{\Gamma_{A}}-c_{\gamma_{A}}\left\langle\boldsymbol{Z}_{4} \times \boldsymbol{n}, \boldsymbol{v}_{\top}\right\rangle_{\pi_{A}^{0}}=0, \quad \forall \boldsymbol{v} \in \mathrm{~K} \tag{7.49}
\end{equation*}
$$

Now, consider any $\boldsymbol{y} \in \mathcal{V}$. Let $\varphi$ be the unique element of $\mathrm{H}_{\partial \Omega}^{1}(\Omega)$ such that

$$
\left(\mathbb{B}_{\alpha} \operatorname{grad} \varphi \mid \operatorname{grad} \psi\right)=\left(\mathbb{B}_{\alpha} \boldsymbol{y} \mid \operatorname{grad} \psi\right), \quad \forall \psi \in \mathrm{H}_{\partial \Omega}^{1}(\Omega)
$$

So, $\boldsymbol{v}:=\boldsymbol{y}-\operatorname{grad} \varphi$ belongs to K with $\boldsymbol{v}_{\top}=\boldsymbol{y}_{\top}$ on $\Gamma_{A}$. Using it as a test function in (7.49), we find

$$

The above equation is the same as (4.37), thus we obtain the Silver-Müller boundary condition as in the proof of Proposition 4.7. Consequently, $\boldsymbol{Z}$ belongs to $D\left(\mathbb{A}_{2}\right)$, and from Proposition 7.10 we infer that $\boldsymbol{Z}=0$, so $\boldsymbol{Z}_{3}=0$ : the formulation (7.48) is injective.

We deduce by Theorem 4.5.9 and Proposition 4.5 .8 of [3] that the problem (7.45)-(7.46) admits a unique solution $\left(\boldsymbol{U}_{3}, p\right) \in \mathcal{V} \times \mathrm{H}_{\partial \Omega}^{1}(\Omega)$. Choosing $\boldsymbol{G}$ as in (7.35), we get once again $p=0$. Thus, $\boldsymbol{U}_{3}$ satisfies (7.21), or equivalently

\frac{c^{2}}{\mathrm{i} \alpha} \operatorname{curl}\left(\operatorname{curl} \boldsymbol{U}_{3}-\boldsymbol{F}_{4}\right)+\mathbb{B}_{\alpha} \boldsymbol{U}_{3}=\boldsymbol{F}_{3}-\frac{1}{\varepsilon_{0}} \sum_{s}\left(\mathrm{i} \alpha \mathbb{I}+\mathbb{M}_{s}\right)^{-1} \boldsymbol{F}_{s} \tag{7.50}
\end{equation*}
$$

in the sense of distributions. Defining $\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{4}$ respectively by (7.18), (7.19), and (7.20), these fields clearly belong to $\mathbf{L}^{2}(\Omega)$. Combining (7.50) and (7.20) with the definition of $\mathbb{B}_{\alpha}$, one sees that $\boldsymbol{U}_{4} \in \mathbf{H}(\mathbf{c u r l} ; \Omega)$. Thus, the quadruple $\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)$ verifies the system (7.14)-(7.17). For this quadruple to belong to $D\left(\mathbb{A}_{2}\right)$, we have to check that the Silver-Müller condition holds. To this end, we use the Green formula (3.2) in (7.45), and find that

\end{equation*}
$$

Following the same argument as in the proof of Proposition 4.7, we deduce that equation (7.51) implies that $\boldsymbol{U}_{3 \top}-c \boldsymbol{U}_{4} \times \boldsymbol{n}=0$ in $\widetilde{\mathbf{H}}^{-\frac{1}{2}}\left(\Gamma_{A}\right)$ which is equivalent to $\boldsymbol{U}_{3} \times \boldsymbol{n}+c \boldsymbol{U}_{4 \top}=0$ in $\widetilde{\mathbf{H}}^{-\frac{1}{2}}\left(\Gamma_{A}\right)$ and thus in $\mathbf{L}^{2}\left(\Gamma_{A}\right)$ because $\boldsymbol{U}_{3}$ T belongs to $\mathbf{L}^{2}\left(\Gamma_{A}\right)$. The proof is complete.

Let us introduce yet another closed subspace of $\mathbf{X}$ :

\end{equation*}
$$

It is a Hilbert space when endowed with the inner product of $\mathbf{X}$.
Proposition 7.12 . The range $\operatorname{im}\left(\mathbb{A}_{2}\right)$ of $\mathbb{A}_{2}$ is included in $\widetilde{\mathbf{X}}_{2}$.
Proof. Let $\boldsymbol{U}=\left(\boldsymbol{U}_{1}, \boldsymbol{U}_{2}, \boldsymbol{U}_{3}, \boldsymbol{U}_{4}\right)^{\top}$ be an element of $D\left(\mathbb{A}_{2}\right)$. Then, by the definition (4.29) of $\mathbb{A}_{2}, \mathbb{A}_{2} \boldsymbol{U}$ belongs to $\widetilde{\mathbf{X}}_{2}$ if, and only if, $\boldsymbol{\operatorname { c u r l }} \boldsymbol{U}_{3}$ belongs to $\mathbf{H}_{0, \Gamma_{P} ; f l u x, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$. Recall that $\boldsymbol{U}_{3}$ belongs to $\mathbf{H}_{0, \Gamma_{P}}(\mathbf{c u r l} ; \Omega)$, therefore one can conclude by Lemma 7.7 of [12].

The results of the spectral analysis of the operator $\mathbb{A}_{2}$ lead us to introduce the unbounded operator $\left(D\left(\widetilde{\mathbb{A}}_{2}\right), \widetilde{\mathbb{A}}_{2}\right)$ on $\widetilde{\mathbf{X}}_{2}$ defined by

D\left(\widetilde{\mathbb{A}}_{2}\right)=D\left(\mathbb{A}_{2}\right) \cap \widetilde{\mathbf{X}}_{2} \quad \text { and } \quad \widetilde{\mathbb{A}}_{2} \boldsymbol{U}=\mathbb{A}_{2} \boldsymbol{U}, \quad \forall \boldsymbol{U} \in D\left(\widetilde{\mathbb{A}}_{2}\right) \tag{7.53}
\end{equation*}
$$

Proposition 7.13. For all $\alpha \in \mathbb{R}$, the operator $\mathrm{i} \alpha \mathbb{I}+\widetilde{\mathbb{A}}_{2}$ is injective. For $\alpha \in \mathbb{R} \backslash\{0\}$, it is surjective.
Proof. Similar to Proposition 7.5, using Propositions 7.10, 7.11, 7.12, and the orthogonal decomposition (7.43).

Observe that $\widetilde{\mathbf{X}}_{2}$ is an invariant space for Problem (4.30), see Lemma 7.15. We define $\check{T}_{2}:=T_{2 \mid D\left(\mathbb{A}_{2}\right) \cap \widetilde{\mathbf{x}}_{2}}$.
Theorem 7.14. The semigroup of contractions $\left(\check{T}_{2}(t)\right)_{t \geq 0}$ with generator $-\widetilde{\mathbb{A}}_{2}$ is strongly stable on the energy space $\widetilde{\mathbf{X}}_{2}$ in the sense that

$$
\lim _{t \rightarrow+\infty}\left\|\check{T}_{2}(t) \widetilde{\boldsymbol{U}}_{0}\right\|_{\mathbf{x}}=0, \quad \forall \widetilde{\boldsymbol{U}}_{0} \in \widetilde{\mathbf{X}}_{2}
$$

Proof. It is sufficient to repeat the proof of Theorem 7.6.
We denote by $P_{2}$ the orthogonal projection in $\mathbf{L}^{2}(\Omega)$ onto $\mathbf{Z}\left(\Omega ; \Gamma_{A}\right)$.

Lemma 7.15. Let $\boldsymbol{U}_{0} \in \mathbf{X}_{2}$ and $\boldsymbol{U}$ is the solution of problem (4.30). It holds that

P_{2}(\boldsymbol{B}(t))=P_{2}\left(\boldsymbol{B}_{0}\right), \quad \forall t>0
$$

Combining this result with Theorem 7.14, we conclude
Corollary 7.16. It holds that

\lim _{t \rightarrow+\infty}\left\|T_{2}(t) \boldsymbol{U}_{0}-\left(0,0,0, P_{2} \boldsymbol{B}_{0}\right)^{\top}\right\|_{\mathbf{X}_{2}}=0, \quad \forall \boldsymbol{U}_{0} \in \mathbf{X}_{2}
$$

## 8. Stronger stability

We now establish explicit decay rates (polynomial or exponential) for the energy. Our results are based on theorems relating decay of the resolvent of an operator with respect to frequency and decay of the generated semigroup with respect to time.

Namely, exponential decay will be derived from the following Theorem [14, 21]:
Theorem 8.1 (Prüss / Huang). A $\mathrm{C}^{0}$-semigroup $(T(t))_{t \geq 0}$ of contractions on a Hilbert space $X$ generated by $\mathcal{L}$ is exponentially stable, i.e., it satisfies

$$
\forall t \geq 0, \quad \forall u_{0} \in X, \quad\left\|T(t) u_{0}\right\| \leq C \mathrm{e}^{-\gamma t}\left\|u_{0}\right\|_{X}
$$

for some positive constants $C$ and $\gamma$ if, and only if,

$$
\begin{equation*}
\mathrm{i} \mathbb{R}=\{\mathrm{i} \beta: \beta \in \mathbb{R}\} \subset \rho(\mathcal{L}) \tag{8.1}
\end{equation*}
$$

the resolvent set of the operator $\mathcal{L}$, and

$$
\begin{equation*}
\sup _{\beta \in \mathbb{R}}\left\|(\mathrm{i} \beta \mathbb{I}-\mathcal{L})^{-1}\right\|<+\infty \tag{8.2}
\end{equation*}
$$

On the other hand, polynomial decay will follow from this other one ([6], Thm. 2.4):
Theorem 8.2. $A \mathrm{C}^{0}$-semigroup $(T(t))_{t \geq 0}$ of contractions on a Hilbert space $X$ generated by $\mathcal{L}$ satisfies

$$
\forall t>1, \quad \forall u_{0} \in D(\mathcal{L}), \quad\left\|T(t) u_{0}\right\| \leq C t^{-\frac{1}{\ell}}\left\|u_{0}\right\|_{D(\mathcal{L})}
$$

as well as

$$
\forall t>1, \quad \forall u_{0} \in D\left(\mathcal{L}^{\ell}\right), \quad\left\|T(t) u_{0}\right\| \leq C t^{-1}\left\|u_{0}\right\|_{D\left(\mathcal{L}^{\ell}\right)}
$$

for some constant $C>0$ and for some positive integer $\ell$ if (8.1) holds and if

$$
\begin{equation*}
\limsup _{|\beta| \rightarrow \infty} \frac{1}{\beta^{\ell}}\left\|(\mathrm{i} \beta \mathbb{I}-\mathcal{L})^{-1}\right\|<+\infty \tag{8.3}
\end{equation*}
$$

### 8.1. Polynomial stability, perfectly conducting case

Proposition 8.3. Let $\rho\left(-\widetilde{\mathbb{A}}_{1}\right)$ denote the resolvent set of $-\widetilde{\mathbb{A}}_{1}$. Then, $0 \in \rho\left(-\widetilde{\mathbb{A}}_{1}\right)$.

Proof. By Proposition 7.5 , we know that $0 \in \mathbb{i} \mathbb{R}$ is not an eigenvalue, so in order to prove that $0 \in \rho\left(-\widetilde{\mathbb{A}}_{1}\right)$, we need to check that $\widetilde{\mathbb{A}}_{1}$ is surjective and has a bounded inverse. Both properties follow from the fact that the resolvent of $-\widetilde{\mathbb{A}}_{1}$ is uniformly bounded in the neighborhood of 0 , which we shall now prove by a contradiction argument.

Suppose the above condition is false, then there exists a sequence $\left(\beta_{n}\right)_{n \in \mathbb{N}}$ on $\mathbb{R} \backslash\{0\}$ with $\beta_{n} \rightarrow 0$ as $n \rightarrow+\infty$, and a sequence of vector fields $\left(\boldsymbol{U}^{n}\right)_{n \in \mathbb{N}}=\left(\left(\boldsymbol{U}_{1}^{n}, \boldsymbol{U}_{2}^{n}, \boldsymbol{U}_{3}^{n}, \boldsymbol{U}_{4}^{n}\right)^{\top}\right)_{n}$ on $D\left(\widetilde{\mathbb{A}}_{1}\right)$, with

$$
\begin{equation*}
\left\|\boldsymbol{U}^{n}\right\|_{\mathbf{x}}=1, \quad \forall n \tag{8.4}
\end{equation*}
$$

such that

$$
\begin{equation*}
\left\|\left(\mathrm{i} \beta_{n} \mathbb{I}+\mathbb{A}_{1}\right) \boldsymbol{U}^{n}\right\|_{\mathrm{X}} \rightarrow 0 \text { as } n \rightarrow+\infty, \tag{8.5}
\end{equation*}
$$

which is equivalent to

$$
\begin{align*}
& \mathrm{i} \beta_{n} \boldsymbol{U}_{1}^{n}+\mathbb{M}_{1} \boldsymbol{U}_{1}^{n}-\varepsilon_{0} \omega_{p 1}^{2} \boldsymbol{U}_{3}^{n} \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega),  \tag{8.6}\\
& \mathrm{i} \beta_{n} \boldsymbol{U}_{2}^{n}+\mathbb{M}_{2} \boldsymbol{U}_{2}^{n}-\varepsilon_{0} \omega_{p 2}^{2} \boldsymbol{U}_{3}^{n} \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega),  \tag{8.7}\\
& \mathrm{i} \beta_{n} \varepsilon_{0} \boldsymbol{U}_{3}^{n}+\boldsymbol{U}_{1}^{n}+\boldsymbol{U}_{2}^{n}-\varepsilon_{0} c^{2} \operatorname{curl} \boldsymbol{U}_{4}^{n} \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega),  \tag{8.8}\\
& \mathrm{i} \varepsilon_{0} c^{2} \beta_{n} \boldsymbol{U}_{4}^{n}+\varepsilon_{0} c^{2} \operatorname{curl} \boldsymbol{U}_{3}^{n} \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega) . \tag{8.9}
\end{align*}
$$

Since, by (4.15) and (8.4),

$$
\begin{equation*}
\sum_{s}\left(\left.\frac{\nu_{s} \boldsymbol{U}_{s}^{n}}{\varepsilon_{0} \omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}^{n}}{\omega_{p s}}\right)=\Re\left(\left(\mathrm{i} \beta_{n} \mathbb{I}+\mathbb{A}_{1}\right) \boldsymbol{U}^{n}, \boldsymbol{U}^{n}\right) \mathbf{x} \leq\left\|\left(\mathrm{i} \beta_{n} \mathbb{I}+\mathbb{A}_{1}\right) \boldsymbol{U}^{n}\right\|_{\mathbf{X}} \tag{8.10}
\end{equation*}
$$

we obtain from (8.5) that

$$
\begin{equation*}
\left(\left.\frac{\nu_{s} \boldsymbol{U}_{s}^{n}}{\varepsilon_{0} \omega_{p s}} \right\rvert\, \frac{\boldsymbol{U}_{s}^{n}}{\omega_{p s}}\right) \rightarrow 0, \text { as } n \rightarrow+\infty, \quad s=1,2 \tag{8.11}
\end{equation*}
$$

which leads by (7.8) to

$$
\begin{equation*}
\left\|\boldsymbol{U}_{s}^{n}\right\|_{(s)} \rightarrow 0, \text { as } n \rightarrow+\infty, \quad s=1,2 . \tag{8.12}
\end{equation*}
$$

The matrix $\mathbb{M}_{s}$ is bounded on $\Omega$, so it follows from to (8.12) and (8.6) that

$$

\boldsymbol{U}_{3}^{n} \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega) \text {, as } n \rightarrow+\infty \tag{8.13}
\end{equation*}
$$

and then we deduce from (8.8) that

\operatorname{curl} \boldsymbol{U}_{4}^{n} \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega), \text { as } n \rightarrow+\infty . \tag{8.14}
\end{equation*}
$$

This shows that $\left(\operatorname{curl} \boldsymbol{U}_{4}^{n}\right)_{n}$ is bounded in $\mathbf{L}^{2}(\Omega)$. Taking account of (8.4), the sequence $\left(\boldsymbol{U}_{4}^{n}\right)_{n}$ is bounded in $\mathbf{H}(\operatorname{curl} ; \Omega)$, and more specifically in the closed subspace $\mathcal{J}_{1}(\Omega):=\mathbf{H}(\operatorname{curl} ; \Omega) \cap \mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega)$ to which all its terms belong given the definition of $D\left(\widetilde{\mathbb{A}}_{1}\right)$, see (7.38) and (7.37). But $\mathcal{J}_{1}(\Omega)$ is also a closed subspace of $\mathbf{H}(\operatorname{curl} ; \Omega) \cap \mathbf{H}_{0}(\operatorname{div} ; \Omega)$, which is compactly embedded into $\mathbf{L}^{2}(\Omega)$ ([3], Thm. 3.5.4); thus, we can extract a
subsequence still denoted by $\left(\boldsymbol{U}_{4}^{n}\right)_{n}$ which converges strongly in $\mathbf{L}^{2}(\Omega)$ to some $\boldsymbol{U}_{4} \in \mathcal{J}_{1}(\Omega)$. As a consequence, $\left(\operatorname{curl} \boldsymbol{U}_{4}^{n}\right)_{n}$ converges in the sense of distributions to $\operatorname{curl} \boldsymbol{U}_{4}$; this combined with (8.14) implies that

$$
\operatorname{curl} \boldsymbol{U}_{4}^{n} \rightarrow \operatorname{curl} \boldsymbol{U}_{4}=0 \text { in } \mathbf{L}^{2}(\Omega), \text { as } n \rightarrow+\infty
$$

So, $\boldsymbol{U}_{4} \in \mathbf{H}(\mathbf{c u r l} 0 ; \Omega)$. Together with $\boldsymbol{U}_{4} \in \mathcal{J}_{1}(\Omega)$, this means that $\boldsymbol{U}_{4}$ belongs to $\mathbf{Z}_{T}(\Omega)=\mathbf{H}(\mathbf{c u r l} 0 ; \Omega) \cap$ $\mathbf{H}_{0}(\operatorname{div} 0 ; \Omega)$ and its orthogonal $\mathbf{H}_{0}^{\Sigma}(\operatorname{div} 0 ; \Omega)(c f .(7.11))$, whence $\boldsymbol{U}_{4}=0$.

On the other hand, (8.4), (8.12) and (8.13) imply that

$$
1=\lim _{n \rightarrow+\infty}\left\|\boldsymbol{U}^{n}\right\|_{\mathbf{X}}^{2}=\lim _{n \rightarrow+\infty} \varepsilon_{0} c^{2}\left\|\boldsymbol{U}_{4}^{n}\right\|^{2}=\varepsilon_{0} c^{2}\left\|\boldsymbol{U}_{4}\right\|^{2}
$$

in particular, $\boldsymbol{U}_{4} \neq 0$, and the above conclusion is contradicted. Hence the resolvent is uniformly bounded in the neighborhood of 0 :

\exists C>0, \quad \forall \beta \in[-1,1] \backslash\{0\}, \quad\left\|\left(\mathrm{i} \beta \mathbb{I}+\widetilde{\mathbb{A}}_{1}\right)^{-1}\right\| \leq C \tag{8.15}
\end{equation*}
$$

The surjectivity of $-\widetilde{\mathbb{A}}_{1}$ and the boundedness of its inverse then follow from a standard argument. Pick any $\boldsymbol{F} \in \widetilde{\mathbf{X}}_{1}$. By Proposition 7.5 , for any $k \in \mathbb{N} \backslash\{0\}$ there exists a unique $\boldsymbol{U}^{k} \in D\left(\widetilde{\mathbb{A}}_{1}\right)$ such that $\left(\mathrm{i} k^{-1}+\mathbb{A}\right) \boldsymbol{U}^{k}=$ $-\boldsymbol{F}$, and $\left\|\boldsymbol{U}^{k}\right\|_{\mathbf{x}} \leq C\|\boldsymbol{F}\|_{\mathbf{x}}$.

Being bounded, the sequence $\left(\boldsymbol{U}^{k}\right)_{k}$ admits a subsequence (still denoted $\left.\left(\boldsymbol{U}^{k}\right)_{k}\right)$ that converges weakly toward $\boldsymbol{U} \in \widetilde{\mathbf{X}}_{1}$, as the latter is a closed subspace of $\mathbf{X}$, which still satisfies $\|\boldsymbol{U}\|_{\mathbf{X}} \leq C\|\boldsymbol{F}\|_{\mathbf{x}}$. Moreover, $-\mathbb{A} \boldsymbol{U}^{k} \rightharpoonup-\mathbb{A} \boldsymbol{U}$ in the sense of distributions. But, on the other hand

$$
-\mathbb{A} \boldsymbol{U}^{k}=\boldsymbol{F}+\mathrm{i} k^{-1} \boldsymbol{U}^{k} \rightarrow \boldsymbol{F} \quad \text { in } \mathbf{X}
$$

Hence, $-\mathbb{A} \boldsymbol{U}=\boldsymbol{F}$, i.e., $\boldsymbol{U} \in D\left(\widetilde{\mathbb{A}}_{1}\right)$. As $\boldsymbol{F}$ is arbitrary, this proves that $-\widetilde{\mathbb{A}}_{1}$ is surjective, hence bijective, between $D\left(\widetilde{\mathbb{A}}_{1}\right)$ and $\widetilde{\mathbf{X}}_{1}$, and its inverse is bounded: $\left\|\left(-\widetilde{\mathbb{A}}_{1}\right)^{-1}\right\| \leq C$ and $\left\|\left(-\widetilde{\mathbb{A}}_{1}\right)^{-1}\right\| \tilde{\mathbf{X}}_{1} \rightarrow D\left(\widetilde{\mathbb{A}}_{1}\right) \leq C+1$.

Remark 8.4. The surjectivity of $-\widetilde{\mathbb{A}}_{1}$ could have been easily obtained by a direct argument. We gave this proof because it provides a pattern for subsequent ones.
Proposition 8.5. The resolvent of the operator $-\widetilde{\mathbb{A}}_{1}$ satisfies the condition (8.3) with $\ell=2$.
Proof. We again use a contradiction argument, i.e., we assume that (8.3) is false for some $\ell \in \mathbb{N}$, which will be specified later. Then, there exists a sequence $\left(\beta_{n}\right)_{n \in \mathbb{N}}$ on $\mathbb{R}$ with $\left|\beta_{n}\right| \rightarrow+\infty$ as $n \rightarrow+\infty$, and a sequence $\left(\boldsymbol{U}^{n}\right)_{n \in \mathbb{N}}=\left(\left(\boldsymbol{U}_{1}^{n}, \boldsymbol{U}_{2}^{n}, \boldsymbol{U}_{3}^{n}, \boldsymbol{U}_{4}^{n}\right)^{\top}\right)_{n}$ of elements of $D\left(\widetilde{\mathbb{A}}_{1}\right)$, such that

$$
\begin{equation*}
\left\|\boldsymbol{U}^{n}\right\|_{\mathbf{x}}=1, \quad \forall n \tag{8.16}
\end{equation*}
$$

and

$$
\begin{equation*}
\beta_{n}^{\ell}\left\|\left(\mathrm{i} \beta_{n} \mathbb{I}+\mathbb{A}_{1}\right) \boldsymbol{U}^{n}\right\|_{\mathbf{X}} \rightarrow 0 \text { as } n \rightarrow+\infty \tag{8.17}
\end{equation*}
$$

which is equivalent to

$$
\begin{align*}
\beta_{n}^{\ell}\left(\mathrm{i} \beta_{n} \boldsymbol{U}_{1}^{n}+\mathbb{M}_{1} \boldsymbol{U}_{1}^{n}-\varepsilon_{0} \omega_{p 1}^{2} \boldsymbol{U}_{3}^{n}\right) & \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega),  \tag{8.18}\\
\beta_{n}^{\ell}\left(\mathrm{i} \beta_{n} \boldsymbol{U}_{2}^{n}+\mathbb{M}_{2} \boldsymbol{U}_{2}^{n}-\varepsilon_{0} \omega_{p 2}^{2} \boldsymbol{U}_{3}^{n}\right) & \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega),  \tag{8.19}\\
\beta_{n}^{\ell}\left(\mathrm{i} \beta_{n} \varepsilon_{0} \boldsymbol{U}_{3}^{n}+\boldsymbol{U}_{1}^{n}+\boldsymbol{U}_{2}^{n}-\varepsilon_{0} c^{2} \operatorname{curl} \boldsymbol{U}_{4}^{n}\right) & \rightarrow 0 \text { in } \mathbf{L}^{2}(\Omega),  \tag{8.20}\\

### 8.2. Polynomial stability, homogeneous Silver-Müller case

Proposition 8.7. Let $\rho\left(-\widetilde{\mathbb{A}}_{2}\right)$ denote the resolvent set of $-\widetilde{\mathbb{A}}_{2}$. Then, $0 \in \rho\left(-\widetilde{\mathbb{A}}_{2}\right)$.
Proof. We follow the same argument in the proof of Proposition 8.3, and we prove that the resolvent of $-\widetilde{\mathbb{A}}_{2}$ is uniformly bounded in the neighborhood of 0 by using a contradiction argument. Suppose it is not the case, then there exists a sequence $\left(\beta_{n}\right)_{n \in \mathbb{N}}$ on $\mathbb{R} \backslash\{0\}$ with $\beta_{n} \rightarrow 0$ as $n \rightarrow+\infty$, and a sequence of vectors fields $\left(\boldsymbol{U}^{n}\right)_{n \in \mathbb{N}}=\left(\left(\boldsymbol{U}_{1}^{n}, \boldsymbol{U}_{2}^{n}, \boldsymbol{U}_{3}^{n}, \boldsymbol{U}_{4}^{n}\right)^{\top}\right)_{n}$ on $D\left(\widetilde{\mathbb{A}}_{2}\right)$, with

& \leq\left\|\left(\mathrm{i} \beta_{n} \mathbb{I}+\mathbb{A}_{2}\right) \boldsymbol{U}^{n}\right\|_{\mathbf{X}}
\end{aligned}

As already said, the condition $\boldsymbol{U}_{4 \top}^{n} \in \mathbf{L}^{2}\left(\Gamma_{A}\right)$ follows from the Silver-Müller boundary condition, in the absence of pathological vertices.

Taking account of (8.35) and (8.38), the sequence $\left(\boldsymbol{U}_{4}^{n}\right)_{n}$ is bounded in $\mathcal{W}=\left\{\boldsymbol{w} \in \mathbf{H}(\mathbf{c u r l} ; \Omega): \boldsymbol{w} \times \boldsymbol{n}_{\left.\right|_{\Gamma_{A}}} \in \mathbf{L}_{t}^{2}\left(\Gamma_{A}\right)\right\}$, and more specifically in the closed subspace $\mathcal{J}_{2}(\Omega):=\mathcal{W} \cap$ $\mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$ to which all its terms belong given the definition of $D\left(\widetilde{\mathbb{A}}_{2}\right)$, see (7.53) and (7.52). Yet, $\mathcal{J}_{2}(\Omega)$ also appears as a closed subspace of

Therefore, we can extract a subsequence, still denoted $\left(\boldsymbol{U}_{4}^{n}\right)_{n}$, which converges strongly in $\mathbf{L}^{2}(\Omega)$, and weakly in $\mathcal{J}_{2}(\Omega)$, to some $\boldsymbol{U}_{4} \in \mathcal{J}_{2}(\Omega)$. Combining the weak convergence in $\mathcal{J}_{2}(\Omega)$ with (8.40) and (8.38), we find

for all $\ell>0$. Moreover, equation (8.45) implies that the first term on the right-hand side of (8.47) converges to 0 if $\ell \geq 2$. As a consequence,

\begin{equation*}
\beta_{n}^{\frac{\ell}{2}-2}\left(\operatorname{curl} \boldsymbol{U}_{3}^{n} \mid \boldsymbol{U}_{4}^{n}\right) \rightarrow 0, \quad \text { as } n \rightarrow+\infty \tag{8.48}
\end{equation*}
$$

for $\ell \geq 2$, which together with (8.26) implies (8.31). Again, this implies $\left\|\boldsymbol{U}^{n}\right\|_{\mathbf{x}} \rightarrow 0$, contradicting the assumption (8.41).

The above results allow us to conclude...
Theorem 8.9. The semigroup of contractions $\left(\check{T}_{2}(t)\right)_{t \geq 0}$, with generator $-\widetilde{\mathbb{A}}_{2}$, is polynomially stable on $\widetilde{\mathbf{X}}_{2}$, i.e., there exist a constant $C>0$ such that

\forall t>1, \quad\left\|\check{T}_{2}(t) \widetilde{\boldsymbol{U}}_{0}\right\|_{\tilde{\mathbf{x}}_{2}} \leq C t^{-\frac{1}{2}}\left\|\widetilde{\boldsymbol{U}}_{0}\right\|_{D\left(\tilde{\mathbb{A}}_{2}\right)}, \quad \forall \widetilde{\boldsymbol{U}}_{0} \in D\left(\widetilde{\mathbb{A}}_{2}\right) \tag{8.49}

Furthermore, under the assumptions of Theorem 4.10 on $\boldsymbol{B}_{0}$, there exists a constant $M>0$ such that the solution to Problem (4.30) satisfies

\forall t>1, \quad\left\|T_{2}(t) \boldsymbol{U}_{0}-\left(0,0,0, P_{2} \boldsymbol{B}_{0}\right)^{\top}\right\|_{\mathbf{x}_{2}} \leq M t^{-\frac{1}{2}}\left\|\boldsymbol{U}_{0}\right\|_{D\left(\mathbb{A}_{2}\right) \cap \mathbf{X}_{2}}, \quad \forall \boldsymbol{U}_{0} \in D\left(\mathbb{A}_{2}\right) \cap \mathbf{X}_{2} \tag{8.50}
\end{equation*}
$$

### 8.3. Conditional exponential stability in the Silver-Müller case

Proposition 8.10. Suppose that the divergence-free, source-free Maxwell system with Silver-Müller, or mixed, boundary condition:

\operatorname{div} \boldsymbol{E}=0, \quad \operatorname{div} \boldsymbol{B}=0, \quad \text { in } \Omega \times \mathbb{R}_{>0} \\
\boldsymbol{E} \times \boldsymbol{n}=0, \quad \boldsymbol{B} \cdot \boldsymbol{n}=0, \quad \text { on } \Gamma_{P} \times \mathbb{R}_{>0} \\
\boldsymbol{E} \times \boldsymbol{n}+c \boldsymbol{B}_{\top}=0, \quad \text { on } \Gamma_{A} \times \mathbb{R}_{>0}
\end{array}\right.
$$

is exponentially stable. Then, the resolvent of the operator $-\widetilde{\mathbb{A}}_{2}$ satisfies:

\sup _{\beta \in \mathbb{R}}\left\|\left(\mathrm{i} \beta+\widetilde{\mathbb{A}}_{2}\right)^{-1}\right\|<\infty \tag{8.52}
\end{equation*}

Proof. Again, we use a contradiction argument. Assume there exists a sequence $\left(\beta_{n}\right)_{n}$ on $\mathbb{R}$, with $\left|\beta_{n}\right| \rightarrow+\infty$ as $n \rightarrow+\infty$, and a sequence of fields $\left(\boldsymbol{U}^{n}\right)_{n}=\left(\left(\boldsymbol{U}_{1}^{n}, \boldsymbol{U}_{2}^{n}, \boldsymbol{U}_{3}^{n}, \boldsymbol{U}_{4}^{n}\right)^{\top}\right)_{n}$ on $D\left(\widetilde{\mathbb{A}}_{2}\right)$ satisfying (8.35) and (8.36), the latter being equivalent to the system (8.6)-(8.9). Following the same reasoning as in Proposition 8.7, we get

In order to use the exponential stability of (8.51), we need to correct $\boldsymbol{U}_{3}^{n}$ since it does not satisfy $\operatorname{div} \boldsymbol{U}_{3}^{n}=0$ in $\Omega$. Let $\varphi \in \mathrm{H}_{0}^{1}(\Omega)$ be the unique solution to

\end{equation*}
$$

Now, define

\hat{\boldsymbol{U}}_{3}^{n}=\boldsymbol{U}_{3}^{n}-\operatorname{grad} \varphi_{n}, \quad \text { in } \Omega
$$

Then, $\hat{\boldsymbol{U}}_{3}^{n}$ belongs to $\mathbf{H}_{0, \Gamma_{P}}(\mathbf{c u r l} ; \Omega)$ and it satisfies

\operatorname{div} \hat{\boldsymbol{U}}_{3}^{n}=0 \quad \text { in } \Omega \tag{8.56}
\end{equation*}
$$

Introduce

$$
\boldsymbol{L}_{n}:=\mathrm{i} \beta_{n} \varepsilon_{0} \boldsymbol{U}_{3}^{n}+\sum_{s} \boldsymbol{U}_{s}^{n}-\varepsilon_{0} c^{2} \operatorname{curl} \boldsymbol{U}_{4}^{n},
$$

the l.h.s. of (8.8); by assumption $\left\|\boldsymbol{L}_{n}\right\| \rightarrow 0$. By choosing $\psi=\varphi_{n}$ in (8.55) and using the Green formula (3.1), we find

\left\|\operatorname{grad} \varphi_{n}\right\|^{2} & =\frac{1}{\mathrm{i} \beta_{n} \varepsilon_{0}} \int_{\Omega}\left(\boldsymbol{L}_{n}-\sum_{s} \boldsymbol{U}_{s}^{n}+\varepsilon_{0} c^{2} \boldsymbol{\operatorname { c u r l }} \boldsymbol{U}_{4}^{n}\right) \cdot \boldsymbol{\operatorname { g r a d }} \overline{\varphi_{n}} \mathrm{~d} \Omega \\
& =\frac{1}{\mathrm{i} \beta_{n} \varepsilon_{0}} \int_{\Omega}\left(\boldsymbol{L}_{n}-\sum_{s} \boldsymbol{U}_{s}^{n}\right) \cdot \operatorname{grad} \overline{\varphi_{n}} \mathrm{~d} \Omega \\
& \leq \frac{C}{\left|\beta_{n}\right|}\left(\left\|\boldsymbol{L}_{n}\right\|+\sum_{s}\left\|\boldsymbol{U}_{s}^{n}\right\|\right)\left\|\boldsymbol{\operatorname { g r a d }} \varphi_{n}\right\| .
\end{aligned}
$$

Then, by (8.8) and (8.53) we deduce that

We now introduce

& \hat{\boldsymbol{L}}_{n}=\boldsymbol{L}_{n}-\sum_{s} \boldsymbol{U}_{s}^{n}-\mathrm{i} \beta_{n} \varepsilon_{0} \operatorname{grad} \varphi_{n}, \\
& \boldsymbol{Q}_{n}=\mathrm{i} \varepsilon_{0} c^{2} \beta_{n} \boldsymbol{U}_{4}^{n}+\varepsilon_{0} c^{2} \operatorname{curl} \boldsymbol{U}_{3}^{n} .
\end{aligned}
$$

By (8.9), (8.53) and (8.57), it holds that:

\hat{\boldsymbol{L}}_{n}, \boldsymbol{Q}_{n} \rightarrow 0 \quad \in \mathbf{L}^{2}(\Omega), \text { as } n \rightarrow+\infty . \tag{8.58}
\end{equation*}

To summarize, the pair $\left(\hat{\boldsymbol{U}}_{3}^{n}, \boldsymbol{U}_{4}^{n}\right)$ satisfies the perfectly conducting boundary condition on $\Gamma_{P}$, the Silver-Müller boundary condition on $\Gamma_{A}$, and the divergence-free harmonic Maxwell problem in $\Omega$ :

\mathrm{i} \varepsilon_{0} c^{2} \beta_{n} \boldsymbol{U}_{4}^{n}+\varepsilon_{0} c^{2} \operatorname{curl} \hat{\boldsymbol{U}}_{3}^{n}=\boldsymbol{Q}_{n} .
\end{array}\right.
$$

By assumption, the system (8.51) is exponentially stable; thus, according to Theorem 8.1, its resolvent is uniformly bounded on the imaginary axis. In other words, there exists a positive constant $C$, independent of $n$, such that the solution $\left(\hat{\boldsymbol{U}}_{3}^{n}, \boldsymbol{U}_{4}^{n}\right)$ to (8.59) satisfies

which together with (8.53) gives the desired contradiction of (8.4).
Using again Theorem 8.1, we obtain a conditional improved version of the decay Theorem 8.9.
Theorem 8.11. Assume that the divergence-free Maxwell system (8.51) is exponentially stable. Then, the semigroup of contractions $\left(\check{T}_{2}(t)\right)_{t \geq 0}$, with generator $-\widetilde{\mathbb{A}}_{2}$, is exponentially stable on $\widetilde{\mathbf{X}}_{2}$, i.e., there exist two constants $C, \gamma>0$ such that

$$
\begin{equation*}
\forall t \geq 0, \quad\left\|\check{T}_{2}(t) \widetilde{\boldsymbol{U}}_{0}\right\|_{\widetilde{\mathbf{x}}_{2}} \leq C \mathrm{e}^{-\gamma t}\left\|\widetilde{\boldsymbol{U}}_{0}\right\|_{\tilde{\mathbf{x}}_{2}}, \quad \forall \widetilde{\boldsymbol{U}}_{0} \in \widetilde{\mathbf{X}}_{2} \tag{8.60}
\end{equation*}
$$

Furthermore, under the assumptions of Theorem 4.10 on $\boldsymbol{B}_{0}$, there exists a constant $M>0$ such that the solution to Problem (4.30) satisfies

$$
\forall t \geq 0, \quad\left\|T_{2}(t) \boldsymbol{U}_{0}-\left(0,0,0, P_{2} \boldsymbol{B}_{0}\right)^{\top}\right\| \mathbf{x}_{2} \leq M \mathrm{e}^{-\gamma t}\left\|\boldsymbol{U}_{0}\right\|_{\mathbf{x}_{2}}, \quad \forall \boldsymbol{U}_{0} \in \mathbf{X}_{2}
$$

Remark 8.12. Examples of sufficient conditions for the exponential stability of the Maxwell system with pure Silver-Müller or mixed boundary conditions are given in the seminal papers [15, 22].

Remark 8.13. On the other hand, our model with perfectly conduction boundary condition everywhere $\left(\Gamma_{A}=\right.$ $\varnothing$ ) is never exponentially stable: there exists no improved version of Theorem 8.6. In this case, the Maxwell operator has an infinite number of eigenvalues on the imaginary axis: the associated evolution operator cannot be exponentially stable.

Consider the eigenvalue problem with perfectly conducting boundary condition:

\end{equation*}

It is well-known (see, e.g., [3], §8.2.1) that it admits a nondecreasing sequence of eigenvalues tending to infinity. Assume that the corresponding eigenvectors are normalized by $\left\|\boldsymbol{E}_{k}\right\|=1$, and introduce the sequence $\left(\boldsymbol{U}^{k}\right)_{k \in \mathbb{N}}$ on $D\left(\widetilde{\mathbb{A}}_{1}\right)$ as:

\boldsymbol{U}_{s}^{k}=\left(\mathrm{i} \lambda_{k} \mathbb{I}+\mathbb{M}_{s}\right)^{-1} \varepsilon_{0} \omega_{p s}^{2} \boldsymbol{E}_{k}, s=1,2, \quad \boldsymbol{U}_{3}^{k}=\boldsymbol{E}_{k}, \quad \boldsymbol{U}_{4}^{k}=-\frac{1}{\mathrm{i} \lambda_{k}} \operatorname{curl} \boldsymbol{E}_{k}
$$

Thanks to Section 6 , it is easily shown that $\lambda_{k} \rightarrow+\infty$ implies $\left\|\left(\mathrm{i} \lambda_{k} \mathbb{I}+\mathbb{M}_{s}\right)^{-1}\right\|_{\mathcal{M}} \rightarrow 0$. Therefore, $\left\|\boldsymbol{U}_{s}^{k}\right\| \rightarrow 0$ as $k \rightarrow+\infty$, and:

$$
\left(\mathrm{i} \lambda_{k} \mathbb{I}+\widetilde{\mathbb{A}}_{1}\right) \boldsymbol{U}^{k}=\left(0,0, \frac{1}{\varepsilon_{0}}\left(\boldsymbol{U}_{1}^{k}+\boldsymbol{U}_{2}^{k}\right), 0\right)^{\top} \rightarrow 0 \quad \text { in } \mathbf{L}^{2}(\Omega), \text { as } k \rightarrow+\infty
$$

On the other hand, taking $\boldsymbol{E}_{k}$ as a test function in (8.61), one finds $\left\|\boldsymbol{U}_{4}^{k}\right\|=1 / c$. All in all, $0<U_{*} \leq\left\|\boldsymbol{U}^{k}\right\| \leq$ $U^{*}<+\infty$, for some $U_{*}, U^{*}$ independent of $k$. This shows that the counterpart of (8.2) or (8.52) cannot hold for $-\widetilde{\mathbb{A}}_{1}$.

### 8.4. Convergence to the harmonic regime

A time-harmonic solution to the model (2.10)-(2.16) is a particular solution such that $\boldsymbol{U}(t, \boldsymbol{x})=$ $\Re\left[\mathbf{U}(\boldsymbol{x}) \mathrm{e}^{-\mathrm{i} \omega t}\right]$. Such a solution may only exist if two conditions are satisfied: (i) the forcing or Silver-Müller data is time-harmonic $\left(\boldsymbol{g}(t, \boldsymbol{x})=\Re\left[\boldsymbol{g}(\boldsymbol{x}) \mathrm{e}^{-\mathrm{i} \omega t}\right]\right)$ and (ii) the initial data match $\left(\boldsymbol{U}_{0}(\boldsymbol{x})=\Re[\mathbf{U}(\boldsymbol{x})]\right)$. Of course, the general condition (4.43) must also hold.

The time-harmonic version of (2.10)-(2.13), i.e., with $\partial_{t} \mapsto-\mathrm{i} \omega$, has been studied in [4]. Under Hypotheses 1 and 2 , its well-posedness has been established with slightly different boundary conditions, but the adaptation
to the Silver-Müller case is not difficult. Indeed, the solution to time-harmonic problem, supplemented with boundary conditions formally similar to (2.15)-(2.16), can be expressed with the tools introduced in this paper.

The harmonic variables will be denoted with upright bold letters: $\mathbf{J}_{s}, \mathbf{E}, \mathbf{B}$, etc..
Let $\mathbf{g} \in \widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)+\mathbf{T C}\left(\Gamma_{A}\right)$. As in Section 4.2.2, set:

\left(\mathbf{g}_{3}, \mathbf{g}_{4}\right) \in \mathbf{H}_{0, \Gamma_{P}}(\operatorname{curl} ; \Omega) \times \mathbf{H}(\operatorname{curl} ; \Omega) \quad \text { s.t. } \quad \mathbf{g}_{3} \times \boldsymbol{n}+c \mathbf{g}_{4 \top}=\mathbf{g} \text { on } \Gamma_{A}, \\
\mathbf{J}_{1}^{\star}=\mathbf{J}_{1}, \quad \mathbf{J}_{2}^{\star}=\mathbf{J}_{2}, \quad \mathbf{E}^{\star}=\mathbf{E}-\mathbf{g}_{3}, \quad \mathbf{B}^{\star}=\mathbf{B}-\mathbf{g}_{4} .
\end{array}
$$

The variable $\mathbf{U}^{\star} \in D\left(\mathbb{A}_{2}\right)$ is solution to

$$
\begin{equation*}
-\mathrm{i} \omega \mathbf{U}^{\star}+\mathbb{A}_{2} \mathbf{U}^{\star}=\left(\varepsilon_{0} \omega_{p 1}^{2} \mathbf{g}_{3}, \varepsilon_{0} \omega_{p 2}^{2} \mathbf{g}_{3}, \mathrm{i} \omega \mathbf{g}_{3}+c^{2} \mathbf{c u r l} \mathbf{g}_{4}, \mathrm{i} \omega \mathbf{g}_{4}-\mathbf{c u r l} \mathbf{g}_{3}\right)^{\top} \tag{8.62}
\end{equation*}
$$

a well-posed equation according to Proposition 7.11. Then $\mathbf{U}:=\mathbf{U}^{\star}+\left(0,0, \mathbf{g}_{3}, \mathbf{g}_{4}\right)^{\top}$ is solution to the timeharmonic problem. Obviously, the difference of two solutions belongs to $D\left(\mathbb{A}_{2}\right)$ and satisfies $-\mathrm{i} \omega \mathbf{U}+\mathbb{A} \mathbf{U}=0$, hence it vanishes by Proposition 7.10.

Definition 8.14. For any $\mathbf{g} \in \widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)+\mathbf{T C}\left(\Gamma_{A}\right)$, we denote $H[\mathbf{g}]:=\mathbf{U}$, the unique solution to the timeharmonic problem constructed by the above procedure.

By uniqueness, any lifting $\left(\mathbf{g}_{3}, \mathbf{g}_{4}\right)$ of the boundary data $\mathbf{g}$ can actually be used. For instance, it is possible to take $\mathbf{g}_{4} \in \mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$. Starting with $\left(\mathbf{g}_{3}^{0}, \mathbf{g}_{4}^{0}\right)=R_{A}[\mathbf{g}]$, one defines $\varphi \in H_{0, \Gamma_{A}}^{1}(\Omega):=\left\{w \in H^{1}(\Omega)\right.$ : $\left.w_{\Gamma_{\Gamma_{A}}}=0\right\}$ as the solution to

and $\mathbf{g}_{4}^{1}:=\mathbf{g}_{4}^{0}-\operatorname{grad} \varphi$. By (5.2), $\mathbf{g}_{4}^{1} \in \mathbf{H}_{0, \Gamma_{P}}(\operatorname{div} 0 ; \Omega)$ and $\mathbf{g}_{4 \top}^{1}=\mathbf{g}_{4 \top}^{0}$ on $\Gamma_{A}$. Then one sets:

\mathbf{g}_{3}=\mathbf{g}_{3}^{0}, \quad \mathbf{g}_{4}=\mathbf{g}_{4}^{1}-P_{2} \mathbf{g}_{4}^{1}
$$

recall that $P_{2}$ is the orthogonal projection onto $\mathbf{Z}\left(\Omega ; \Gamma_{A}\right)$. By (7.42), $\mathbf{g}_{4} \in \mathbf{H}_{0, \Gamma_{P} ; f l u x, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$, and $\mathbf{g}_{4 \top}=$ $\mathbf{g}_{4 \top}^{1}=\mathbf{g}_{4 \top}^{0}$ on $\Gamma_{A}$, i.e., $\mathbf{g}_{3} \times \boldsymbol{n}+c \mathbf{g}_{4 \top}=\mathbf{g}$.

Proposition 8.15. The range of the mapping $H$ is included in $\widetilde{\mathbf{X}}_{2}$.
Proof. Let $\mathbf{g} \in \widetilde{\mathbf{T T}}\left(\Gamma_{A}\right)+\mathbf{T C}\left(\Gamma_{A}\right)$. Take $\mathbf{g}_{4} \in \mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$ as above. As $\mathbf{g}_{3} \in \mathbf{H}_{0, \Gamma_{P}}(\mathbf{c u r l} ; \Omega)$ by definition, its curl also belongs to $\mathbf{H}_{0, \Gamma_{P} ; \text { flux }, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$. Hence, the right-hand side of (8.62) actually belongs to $\widetilde{\mathbf{X}}_{2}$. By Proposition 7.13 the solution also belongs to this space, and so does finally $\mathbf{U}=\mathbf{U}^{\star}+\left(0,0, \mathbf{g}_{3}, \mathbf{g}_{4}\right)^{\top}$.

By uniqueness of the solution to the time-dependent model $(2.10)-(2.16), \boldsymbol{U}^{\omega}(t, \boldsymbol{x})=\Re\left[H[\mathbf{g}](\boldsymbol{x}) \mathrm{e}^{-\mathrm{i} \omega t}\right]$ is the solution to the said system, with the Silver-Müller data $\boldsymbol{g}(t, \boldsymbol{x})=\Re\left[\mathbf{g}(\boldsymbol{x}) \mathrm{e}^{-\mathrm{i} \omega t}\right]$ and the "well-prepared" initial condition $\boldsymbol{U}_{0}^{\omega}(\boldsymbol{x})=\Re[H[\mathbf{g}](\boldsymbol{x})]$. Thus, the necessary conditions stated at the beginning of this Subsection are actually sufficient.

On the other hand, if the forcing is still time-harmonic, but the initial condition is arbitrary, the solution to (2.10)-(2.16) does not have a time-harmonic form. However, if the initial condition satisfies both the compatibility condition and the physical requirements for a magnetic field, then the solution converges to the time-harmonic one as fast as the solution to the homogeneous system converges to 0 .

Theorem 8.16. Let $\boldsymbol{U}=\left(\boldsymbol{J}_{1}, \boldsymbol{J}_{2}, \boldsymbol{E}, \boldsymbol{B}\right)^{\top}$ be the solution to (2.10)-(2.16) with the time-harmonic Silver-Müller data $\boldsymbol{g}(t, \boldsymbol{x})=\Re\left[\mathbf{g}(\boldsymbol{x}) \mathrm{e}^{-\mathrm{i} \omega t}\right]$, where $\mathbf{g} \in \widetilde{\mathbf{T} \mathbf{T}}\left(\Gamma_{A}\right)+\mathbf{T C}\left(\Gamma_{A}\right)$, and the initial data $\boldsymbol{U}_{0}=\left(\boldsymbol{J}_{1,0}, \boldsymbol{J}_{2,0}, \boldsymbol{E}_{0}, \boldsymbol{B}_{0}\right)^{\top}$
satisfying (4.43) and $\boldsymbol{B}_{0} \in \mathbf{H}_{0, \Gamma_{P} ; f l u x, \Gamma_{A}, \Sigma}(\operatorname{div} 0 ; \Omega)$. There exists $K\left(\mathbf{g}, \boldsymbol{U}_{0}\right)$ such that:

$$
\begin{equation*}
\left\|\boldsymbol{U}(t)-\boldsymbol{U}^{\omega}(t)\right\|_{\mathbf{x}} \leq K\left(\mathbf{g}, \boldsymbol{U}_{0}\right) \phi(t) \tag{8.63}
\end{equation*}
$$

where $\boldsymbol{U}^{\omega}(t, \boldsymbol{x})=\Re\left[H[\mathbf{g}](\boldsymbol{x}) \mathrm{e}^{-\mathrm{i} \omega t}\right]$, and the decay function $\phi(\cdot)$ can be taken in all cases as $\phi(t)=t^{-\frac{1}{2}}$ for $t>1$, and as $\phi(t)=\mathrm{e}^{-\gamma t}$ if the divergence-free Maxwell system (8.51) is stable.

Proof. The difference $\boldsymbol{U}-\boldsymbol{U}^{\omega}$ is solution to (2.10)-(2.16) with homogeneous Silver-Müller boundary condition. Furthermore, the initial data $\boldsymbol{U}_{0}-\Re H[\mathbf{g}]$ satisfies the same boundary condition; by construction, it belongs to $\widetilde{\mathbf{X}}_{2}$ by Proposition 8.15 ; while its third and fourth components belong to $\mathbf{H}_{0, \Gamma_{P}}(\mathbf{c u r l} ; \Omega) \times \mathbf{H}(\mathbf{c u r l} ; \Omega)$. All in all, $\boldsymbol{U}_{0}-\Re H[\mathbf{g}] \in D\left(\widetilde{\mathbb{A}}_{2}\right)$ : one can apply the estimate (8.49), and even (8.60) under the assumptions of Theorem 8.11.
