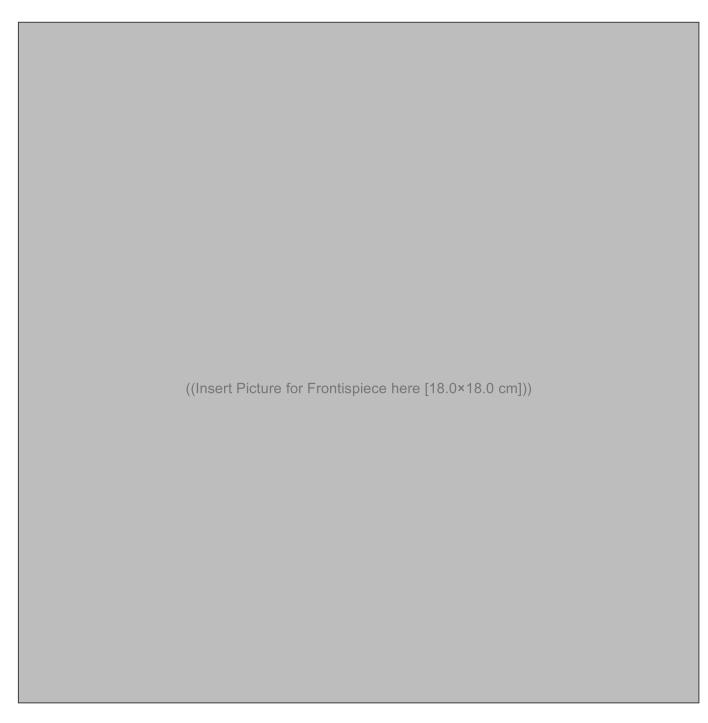

# Steering Site-Selectivity in Transition Metal-Catalyzed C-H Bond Functionalization: the Challenge of Benzanilides

Abstract: Selective C-H bond functionalizations catalyzed by metal complexes have completely revolutionized the way in which chemical synthesis is conceived nowadays. Typically, the reactivity of a transition metal catalyst is the key to control the site-, regioand/or stereo-selectivity of a C-H bond functionalization. Of particular interests are molecules that contain multiple C-H bonds prone to undergo C-H bond activations with very similar bond dissociation energies at different positions. This is the case of benzanilides, relevant chemical motifs that are found in many useful fine chemicals, in which two C-H sites are present in chemically different aromatic fragments. In the last years, it has been found that depending on the metal catalyst and the reaction conditions, the amide motif might behave as a directing group towards the metalcatalyzed C-H bond activation in the benzamide site or in the anilide site. The impact and the consequences of such subtle control of siteselectivity are herein reviewed with important applications in carboncarbon and carbon-heteroatom bond forming processes. The mechanisms unraveling these unique transformations are discussed in order to provide a better understanding for future developments in the field of site-selective C-H bond functionalization with transition metal catalysts.

In 2015 he was appointed CNRS senior researcher (Charge de Recherche) in



the group of Christian Bruneau at the University of Rennes, where he obtained the Habilitation diploma (2019). His research activities include transition metal catalysis for fine chemicals, C-H bond functionalization, supramolecular and coordination chemistry, and supramolecular catalysis.

#### 1. Introduction

Controlling chemical reactivity at specific positions is of fundamental relevance for the advancement of our knowledge in chemical synthesis. In this respect, C-H bond functionalizations contribute significantly in this direction as it represents one of the most sustainable entries enabling sophisticated molecular structures to be obtained from straightforward building blocks. During the last decades, a wide array of transition metal complexes have been recognized as fascinating catalysts to activate and functionalize a broad

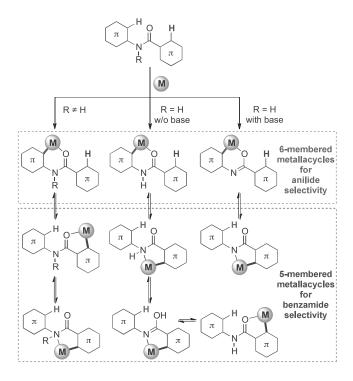
variety of aromatic C-H bonds into more useful  $C(sp^2)$ -C and  $C(sp^2)$ -heteroatom bonds. [3] Usually, transition metal-catalyzed aromatic C-H bond functionalizations are sought in such a way that one C-H bond is preferentially activated with respect to the other ones by means of chelation-assisted directing groups and/or the stereo-electronic properties of the substrate of interest. [3] A classic approach is the use of molecular substrates containing a single aromatic fragment in which the C-H bond functionalization can occur. Traditionally, the installation of a rationally-designed directing group at close proximity of the desired aromatic C-H bond to be functionalized enables the metal catalyst to tackle regio-selectivity issues (i.e.  $ortho\ vs\ meta\ vs\ para$ ). An increasing level of complexity appears when the molecule of interest contains two aromatic C-H sites in which the functionalization can occur. Besides regio-selectivity, site-selectivity is herein an appealing case for exploiting transition metal-catalyzed C-H bond functionalizations. [5] In this context, benzanilides (or phenylbenzamides) are one of the best examples. They contain a single amide motif linking two aromatic entities that in turn, result to be chemically different. Importantly, benzanilide-containing derivatives are present in a myriad of useful chemicals with applications ranging from biology to materials sciences, despite being key intermediates in the synthesis of very sophisticated molecules (Figure 1). Consequently, targeting site-selective C-H bond functionalizations with benzanilide derivatives is highly interesting because it facilitates the access to molecules that otherwise will require long and tedious synthetic sequences generating significant amounts of chemical waste. In the last years, the amide group from benzanilides has been identified as a promising directing group for controlling the *ortho*-selectivity in transition metal-catalyzed C-H bond functionalizations. The action mode of this amide group is manifold (Scheme 1).<sup>[7]</sup> For instance, the oxygen lone pair of the carbonyl group can interact with the metal catalyst leading to five-membered metallacycles for benzamide site-selectivity or six-membered ones for anilide

site-selectivity. Such behavior is upgraded in terms of efficiency when considering secondary amides. In this case, due to amide tautomerization, the nitrogen can bind to the metal catalyst preferentially leading to benzamide site-selectivity via the formation of five-membered metallacycles. Additionally, under specific reaction conditions the amide group can undergo deprotonation leading to a negative charge in the nitrogen atom or in the oxygen atom that will translate in a different type of coordination to the metal catalyst, thus leading to different siteselectivity. Finally, it is important to note that in the case of benzanilides in which the amide group is part of a cyclic structure, different geometries and torsion angles might be relevant for accessing different site-selective C-H bond activation steps. Clearly, the directing ability of the amide group from benzanilides is rich and versatile for providing a plethora of possibilities in terms of C-H bond activations using transition metal catalysts and appropriate coupling partners.

In this review, the advances leading to site-selective C-H bond functionalizations by means of transition metal catalysts at the benzanilide platform (up to 2019 included) are discussed (Scheme 2). Particular attention is paid to the role of the amide group for enabling the transition metal catalyst to reach a given site-selectivity. Those cases in which the amide group is part of a more elaborated, strong directing group (i.e. pyridine, quinoline, triazole, oxazoline, etc.) or the benzanilide derivatives are highly functionalized with chemical substituents at specific positions (i.e. halides, alcohols, amines, etc.) dictating the selectivity of the reactions are not herein considered as it is meaningless to consider the site-selectivity in these scenarios.<sup>[7]</sup>

#### 2. C-C Bond-Forming Reactions

#### 2.1. C-H Bond Arylation Reactions

As it is the case for many type of directing groups, transition metal-catalyzed C-H bond arylations represent the most active area of research for benzanilide derivatives as well.[8] In 2000, the first examples of successful C-H bond arylations of benzanilides in an intermolecular manner were reported by Miura and co-workers. [9] Benzanilide derivatives reacted with a variety of aryl bromides and aryl triflates, respectively, leading to ortho-arylated products under palladium catalysis (Scheme 3). Exclusive benzamide site-selectivity was observed for the resulting products, which was rationalized by the formation of 5membered palladacycle intermediates. The active catalyst was formed in-situ upon mixing Pd(OAc)2 complex with triphenylphosphine as the ligand. The reaction was performed in the presence of a base (Cs2CO3) and bis-arylation was mainly observed in apolar solvents (toluene or o-xylene), whereas the products resulting from mono-arylation were better formed in polar solvents such as N,N-dimethylformamide (DMF). Interestingly, the reaction was compatible with ether and chloride functional groups.

Recently, a very similar palladium-catalyzed strategy was reported by Banerji and co-workers for the synthesis of appealing phenanthridones from 1-bromo-2-iodobenzene through a tandem N–H/C–H bond arylation sequence (Scheme 4).<sup>[10]</sup> The mechanism of such reaction likely undergoes *via* a Buchwald-Hartwig palladium-catalyzed amination followed by an intramolecular palladium-catalyzed C-H bond arylation. The reaction was compatible with chloride and nitro groups.

In 2015, Ackermann and co-workers showed that cobalt catalysts enabled the C-H bond arylation of benzanilides with benzamide site-selectivity (Scheme 5). [11] Interestingly, the catalysis employed readily available aryl chlorides as coupling partners and the active catalyst required the use of a specific *N*-heterocyclic carbene pre-ligand (ICyHCI). Compared to the previous two examples (Schemes 3-4), [9,10] the reaction temperature in this case was milder (60 °C). However, three equivalents of an organomagnesium (CyMgCI) had to be used.

Inspired from the seminal work from Itahara, [12] in 2007 DeBoef and co-workers reported a palladium-catalyzed intramolecular aerobic oxidative coupling of N-benzoylindoles (Scheme 6).[13] The reaction proceeded with benzamide siteselectivity leading to a type of bioactive tetracycle type of lactams<sup>[14]</sup> that can also undergo cleavage of the N-C(O) bond with primary amines accessing biologically-privileged scaffolds (Scheme 6). [15] Fagnou and co-workers described the same reactivity but with a more affordable catalytic system as it did not require the use of any copper salt and catalytic amounts of K<sub>2</sub>CO<sub>3</sub> were enough in the presence of an air atmosphere (Scheme 6).[16] The mechanism of this C-H bond arylation is proposed to follow a Pd(0)/Pd(II) catalytic cycle with initial regioselective palladation at the C-2 position of the indole fragment followed by a concerted metalation-deprotonation (CMD) palladation in the ortho-C-H bond of the benzamide ring prior to reductive elimination to provide the final product (Scheme 6). Later, Oestreich and co-workers reported similar findings using 40 mol% of a pyridine-containing ligand. [17] The same type of reaction was found to occur under basic conditions, that is 1 equivalent of KOAc in toluene<sup>[18]</sup> or using K<sub>2</sub>CO<sub>3</sub> as an additional additive in 10 mol% loading.[19]

Considering C-H bond arylations with anilide siteselectivity, Fagnou and co-workers reported the first examples by means of palladium catalysis in 2005 (Scheme 7).[20] It consisted in an intramolecular C-H bond arylation using Pd(OH)<sub>2</sub>/C (Pearlman's) as catalyst in the presence of two equivalents of KOAc. With this affordable reaction conditions, excellent yields of the corresponding products were obtained (Scheme 7). Although the initial palladium pre-catalyst is heterogeneous in nature, mechanistic studies indicate that the true active catalyst is an homogeneous one that is in-situ formed under these reaction conditions. A year later, they showed that the same type of transformation was possible using less reactive aryl chlorides with Pd(OAc)<sub>2</sub>/PCy<sub>3</sub> as the catalytic system in the presence of K2CO3 instead of KOAc (Scheme 7).[21] In both cases depicted in Scheme 7, the reaction likely starts with an oxidative addition to the aryl-halide bond, followed by halide/base exchange and a CMD step assisted by the presence of a palladium-ligated base, either acetate or carbonate (Scheme 7).[21-22] For the above described examples,[12-22] it is relevant to note that the formation of thermodynamically accessible five-membered rings (Scheme 6) or six-membered rings (Scheme 7) may trigger the site-selectivity of the reaction to some extent.

The intermolecular version with anilide site-selectivity was tackled in 2007 by Shi and co-workers employing also a palladium catalyst, but with trimethoxyphenylsilane as the aryl source (Scheme 8).[23] Although exclusive anilide site-selectivity was observed, the yield was rather low (38%). In addition, the catalysis required over-stoichiometric amounts of Cu(OTf)2 and AgF. Cu<sup>2+</sup> and/or Ag<sup>+</sup> were claimed to behave as chemical oxidants in the last step of the catalytic cycle in order to regenerate the active palladium(II) catalyst whereas fluoride anions might assist in the transmetallation step for activating the arylsilane partner. Wang and co-workers achieved the same site-selectivity but using benzoylperoxide as the aryl source under palladium catalysis and CO<sub>2</sub> extrusion (Scheme 8). [24] The catalysis was more efficient, leading to the arylated product in 65% yield with HOTf as the only additive. The same siteselectivity but with higher reactivity (up to 79% yield) was reported later with other aryl sources such as benzoic acids, [25] arylsulfonyl chlorides, [26] and aryldiazonium salts under organic photoredox catalysis at room temperature. [27] In all these cases, a six-membered cyclopalladate intermediate with the carbonyl motif behaving as directing group is likely operating for the control of the site-selectivity of this type of C-H bond arylations (Scheme 8). A copper-catalyzed C-H bond arylation of benzanilides with diaryliodonium salts was developed too, the mechanism of which, however, proceeds via a Friedel-Crafts pathway.[28]

Under oxidative conditions, homo- and cross-coupling reactions between benzanilide derivatives with palladium catalysts at room temperature were reported by Lu and coworkers (Scheme 9). These types of (pseudo)dimerization occurs at the  $\it ortho$ -C-H bonds from both anilide rings selectively. The homo-coupling reaction was also found to proceed with an heterogeneous catalyst (Pd/Al<sub>2</sub>O<sub>3</sub>) under O<sub>2</sub> atmosphere. [30]

Similar to the above-described work from Shi (Scheme 8),  $^{[23]}$  N-benzoylindoline, which contains a benzanilide core, was found to react with trimethoxyphenylsilane under palladium catalysis leading to a C-H bond arylation with anilide site-selectivity (Scheme 10).  $^{[31]}$  This time, the catalysis was performed with THF as the solvent and a milder temperature of 40  $^{\circ}\mathrm{C}$ , although the loading of palladium pre-catalyst was doubled.

Boronic acids were found to be suitable aryl sources to afford C-H bond *ortho*-arylated benzanilides with anilide site-selectivity. This was demonstrated with ruthenium catalysts using *N*-arylisoindolinones (Scheme 11). [32] Mono-arylated products exclusive formed with a broad functional group tolerance in both coupling partners. Preliminary mechanistic experiments indicate that the site-selectivity of the catalysis for this type of substrates arises from their preference to likely access six-membered ruthenacycle intermediates in the C-H activation step over five-membered ones. The same reactivity was observed with potassium phenyltrifluoroborate as coupling partner instead of boronic acids.

#### 2.2. C-H Bond Alkenylation Reactions

After C-H bond arylations, C-H bond alkenylations undoubtedly constitute an appealing entry towards the formation of new carbon-carbon bonds. In 2002, de Vries, van Leeuwen and coworkers reported the first example of C-H bond *ortho*-alkenylation of benzanilide (Scheme 12).<sup>[33]</sup> Butylacrylate was employed as the alkene source under palladium catalysis. This oxidative coupling led to exclusive C-H bond alkenylation at the anilide ring in the presence of benzoquinone (BQ) as chemical oxidant and *para*-toluenesulfonic acid (TsOH). Interestingly, the

reaction was carried out at room temperature and the presence of acetic acid was required to get highly active palladium species. The reaction is likely assisted by coordination of the carbonyl group to palladium leading to six-membered palladacycle species. Alkene insertion and β-hydride elimination leads to the C-H bond alkenylated product with Heck regio-selectivity (Scheme 12). Then, a number of related reaction conditions were reported. For instance, using catalytic amounts of copper salts under an oxygen atmosphere, [34] employing selectfluor and trifluoroacetic acid, [35] and even under non-acidic conditions. [36] heterogeneous palladium-containing polyoxometalate catalyst led to the same reactivity without the use of any extra reagents.[37] Such type of reactivity enabled the access to 4alkenyl benzoxazoles from readily available 2-amidophenols[38] and implementation in fullerene functionalization has been demonstrated too. [39] Similarly, switching the alkene source for an alkyne derivative such as diphenylacetylene leads to the formation of original indoles, although in a modest yield (Scheme 13).[40] Structurally-related indoles can also form via an iridium-catalyzed C-H bond functionalization employing a diazo compound (i.e. ethyl 2-diazo-3-oxobutanoate) as a coupling partner (Scheme 13).[41] The site-selectivity of the reaction appears to be determined by the formation of six-membered iridacycles similar to the palladium ones described in Scheme 12.

Alternatively, Huang and co-workers reported a reverse site-selectivity for the reaction of benzanilides with alkynes. <sup>[42]</sup> In the presence of a base and a copper co-catalyst, the palladium catalyst enables the C-H bond functionalization at the benzanilide ring with an intramolecular cyclization step leading to *N*-arylisoquinolones in good yields (Scheme 14).

Experimental mechanistic studies suggest the formation of five-membered palladacycle intermediates in the site-determining C-H bond activation step. In the presence of air, copper salts likely serve to re-oxydize Pd(0) species into the catalytically active Pd(II) species after the formal reductive elimination step (cyclization/annulation). An heterogeneous Pd/C-based catalytic system has been reported using similar reagents with the same site-selectivity.<sup>[43]</sup>

Besides palladium catalysts, rhodium catalysts are rather efficient for C-H bond alkenylations with benzanilides. In 2010, the groups of Rovis and Miura, independently, reported a pioneering rhodium-catalyzed oxidative cycloaddition with alkynes via C-H/N-H functionalization (Scheme 15).[44,45] The catalysis was found to be site-selective as only the ortho-C-H bond in the benzamide ring underwent functionalization forming N-arylisoguinolones. Unsymmetrical alkynes led to mixtures of regio-isomers with the smaller substituent (i.e. alkyl vs aryl) preferentially near to the C-H bond being functionalized. Mechanistic investigations indicate that (1) a Rh(I)/Rh(III) catalytic cycle is operating and (2) the turnover-limiting step is the C-H bond activation with the alkyne insertion step being irreversible. The rhodium-mediated C-H bond activation step likely occurs via a CMD mechanism with a rhodium-coordinated acetate ligand enabling the deprotonation in the substrate. An alternative protocol using Ag<sub>2</sub>CO<sub>3</sub> as chemical oxidant instead of Cu(OAc)<sub>2</sub> has been reported. [46] A greener approach was developed using  $[Cp*Rh(MeCN)_3][BF_4]_2$  as the pre-catalyst in the presence of K<sub>2</sub>CO<sub>3</sub>, air and water. [47] Additionally, Ackermann and co-workers showed that the same site-selectivity was reached using [RuCl<sub>2</sub>(p-cymene)]<sub>2</sub> as the pre-catalyst with identical reaction conditions as the ones developed by Rovis group [i.e. Cu(OAc)<sub>2</sub> H<sub>2</sub>O in <sup>t</sup>AmOH] at the expenses of a higher catalyst loading (5 mol%).[48] The nickel-catalyzed version was accomplished by Chatani and co-workers who found a catalytic system based on Ni(OTf)2, PPh3 and \*BuOK.[49]

In 2014, Tanaka and co-workers reported a reversal in the site-selectivity of the above-described reaction by switching the electronic properties of the Cp ligand attached to the rhodium catalyst (Scheme 16).[50] The key rhodium catalyst contained an electron-deficient η<sup>5</sup>-cyclopentadienyl ligand (Cp<sup>E</sup>). In tηe presence of catalytic amounts of silver(I) and copper(II) salts in acetone solvent under air at room temperature, benzanilide reacted with diphenylacethylene with anilide site-selectivity leading to indoles. This catalytic system preferentially performs annulation across the electron-rich ring (anilide) over the electron-deficient one (benzamide). These results clearly indicate that tuning the electron-properties of the ligand on rhodium impact the site-selectivity of the reaction. A sixmembered rhodacycle similar to the palladium one reported in Scheme 12 may account for the site-selectivity observed in this C-H bond functionalization. Importantly, this strategy was extended to perform the very challenging oxidative olefination with unactivated alkenes (Scheme 16). [51] In addition, the same site-selectivity was observed using activated alkenes (i.e. acrylates) with a catalytic system based on [RhCp\*Cl2]2 and AgSbF<sub>6</sub> (or AgOTf) in the presence of NaOAc (or Ag<sub>2</sub>CO<sub>3</sub>).<sup>[52,53]</sup>

In 2017, You and co-workers described a rhodium-catalyzed annulation of pyridinones and alkynes with anilide site-selectivity enabling the synthesis of aromatically-fused quinolizinones (Scheme 17).<sup>[54]</sup> Structurally-related products were obtained *via* an iron-catalyzed reaction with 1,1,3-triphenylpropargyl alcohol as coupling partner using benzanilide derivatives (Scheme 17).<sup>[55]</sup> The reaction, however, does not proceed *via* a formal metal-catalyzed C-H bond activation but rather *via* a Friedel-Crafts mechanism which shows the higher inner reactivity of the anilide ring *versus* the benzamide ring.

In this context, ruthenium catalysts have shown its ability to perform C-H bond alkenylations as well (vide supra).[48] Different reports have shown the preference of ruthenium catalysts to enable C-H bond alkenylations using benzanilide derivatives with excellent site-selectivity for the benzamide ring. In 2010, Yi and co-workers reported a ruthenium(II)-catalyzed oxidative coupling involving unactivated alkenes such as cyclopentene (Scheme 18). [56] Several kinetic and spectroscopic evidences indicate that the C-H bond functionalization is fast and that the C(sp<sup>2</sup>)-C(sp<sup>2</sup>) bond forming step is the rate-limiting one. The carbonyl group from the amide fragment is essential for enabling catalytically-productive five-membered ruthenacycle species. A similar type of ruthenacycle intermediates were exploited by Miura, and co-workers for the site-selective hydroarylation of alkynes (Scheme 18).[57] This time, the reaction was performed with [RuCl<sub>2</sub>(p-cymene)]<sub>2</sub> as the pre-catalyst and catalytic amounts of AgSBF6 in dioxane. They showed that the catalysis was more efficient in the presence of 4 equivalents of AcOH as protons participate in the last elementary step of protonolysis in the catalytic cycle. The same pre-catalyst was used by Ackermann and co-workers in water media to promote C-H bond alkenylations with benzamide site-selectivity using acrylates as coupling partners (Scheme 19).[58] The same siteselectivity was accomplished with a rhodium catalyst using a less reactive styrene derivative as shown by Li and co-workers under non-optimized reaction conditions (Scheme 19).[59]

Ruthenium catalysts enabling anilide site-selectivity for C-H bond alkenylations remain rare (vide supra)<sup>[48]</sup> and it has been observed as a side-product for C2-alkenylations with Nbenzoylindoles (Scheme 20). [60] A more general design has been reported recently, in which N-aryl-isoindolinones appeared to be excellent substrates enabling C-H bond alkenylations with anilide site-selectivity (Scheme 21).[61] Exclusive mono- and ortho-selectivity was obtained for acrylate and styrene derivatives as coupling partners, respectively. Phthalimides led to the same site-selectivity but with lower reactivity, as it was the case when using alkynes as coupling partners. In this case, the geometry of the directing group is critical to locate the ruthenium center at close proximity of the C-H bond from the anilide ring as stated before for related C-H bond functionalizations (Scheme 11).[32] Importantly, the potential of the catalysis was exemplified in the late-stage functionalization of indoprofen. Double C-H bond alkenylations were feasible albeit with low yield (20%).

Organometallic cobalt species have merged as a promising type of catalysts for C-H bond functionalizations. For instance, [Cp\*Co(CO)l<sub>2</sub>] complex displayed modest activity as a pre-catalyst with benzamide site-selectivity for the vinylation of secondary benzanilides (Scheme 22). The same cobalt complex led to the same site-selectivity for the intramolecular cyclization of alkynes (Scheme 22). In both cases, it was reasoned that five-membered cobaltacycles are formed during the C-H bond activation step.

#### 2.3. C-H Bond Alkylation Reactions

In 2010, Li and co-workers reported the first examples of siteselective C-H bond alkylations of benzanilides (Scheme 23). [59] Electron-withdrawing olefins (i.e. acrylates, acrylonitriles,  $\alpha,\beta$ unsaturated ketones) underwent oxidative coupling at the aromatic C-H bond belonging to the benzamide ring followed by an intramolecular Michael reaction (nucleophilic cyclization) forming a series of γ-lactams. This tandem reaction was tolerant to a wide variety of functional chemical groups as shown also by Wang in 2016.[53] The same type of reaction occurred under ruthenium catalysis as shown by Miura and co-workers with similar levels of efficiency (Scheme 23). [64] Similar to C-H bond alkenylations (vide supra), the C-H bond activation step likely involved formation of five-membered metallacycle. [58,59] This intramolecular cascade approach was later extended to different coupling partners (benzaldehydes, allylic alcohols, alkynes, diphenylcyclopropenone) leading to complex structures such as 3-hydroxyisoindolin-1-ones, [65] isoindolinones,[66] dihydroisoquinolinones, [67] and spiroisoindolinones (Scheme 23). [68] Importantly, these examples show that the site-selectivity of the catalysis is favored also because they lead to thermodynamically affordable five-membered rings. The other site-selectivity will hypothetically lead to much less stable fourmembered rings that do not form so far.

Intermolecular C-H bond alkylations with benzamide site-selectivity were pioneered by Nakamura and co-workers with a series of cobalt- and manganese-catalyzed methodologies for methylation, ethylation and *n*-butylation (Scheme 24).<sup>[69-71]</sup> The formation of five-membered metallacyles is postulated to be at the origin of such site-selectivity. A palladium-catalyzed version for *n*-butylation gave rise to very poor results (12% yield)<sup>[72]</sup> and a rhodium-catalyzed methylation employing MeBF<sub>3</sub>K as a more benign alkylating agent was reported too (43% yield).<sup>[73]</sup> The same site-selectivity was observed with allylbromides under

rhodium catalysis.<sup>[74]</sup> Moreover, *N*-substituted maleimides were found to be appropriate partners leading to alkylated products upon a formal hydroarylation *via* ruthenium catalysis as it was shown by Prabhu and co-workers (Scheme 25).<sup>[75]</sup> In 2018, Hamilton and Whiteoak studied the difference between the reactivity of benzamides and anilides, respectively, by DFT calculations under cobalt catalysis, before being applied experimentally to the benzamilde (Scheme 26).<sup>[76]</sup> This work demonstrated full benzamide site-selectivity upon reaction with 3-buten-2-one.

A reversal in the site-selectivity of cyclization reactions leading to formal C-H bond alkylations in the anilide ring are not trivial, [77] besides some radical-based reactions with iron [78] and copper catalysts. [79-82] Regarding C-H bond functionalizations, Shibata and co-workers disclosed a highly enantioselective intramolecular C-H conjugate addition between benzanilides and  $\beta$ -substituted acrylates under iridium catalysis (Scheme 27). [83] For that, they employed [Ir(cod)\_2]OTf (cod = 1,5-cyclooctadiene) complex as catalyst precursor and (S)-BINAP as the chiral ligand. The intermolecular version was accomplished using (S)-SEGPHOS as the chiral ligand but leading exclusively to benzamide site-selectivity.

Intermolecular C-H bond alkylations of benzanilides with anilide site-selectivity have been achieved in a limited number of cases. For instance, in 2013, Yu and co-workers described a palladium-catalyzed oxidative cross-coupling using β-keto esters as the alkyl source (Scheme 28).<sup>[84]</sup> The key mechanistic findings are that dinuclear palladium(II) species might be involved in the C-H bond activation step and that mononuclear palladium(IV) species precede the reductive elimination step. The overall mechanism involved a Pd(II)/Pd(IV) catalytic cycle similar to seminal observations reported by Sanford and Dong, independently, for other substrates.<sup>[85-86]</sup> Recently, Novak and co-workers reported a palladium-catalyzed C-H bond methylation using an original sulfonium salt as reagent (Scheme 28).<sup>[87]</sup>

The same site-selectivity was observed by Kim and coworkers with rhodium catalysis. 4-vinyl-1,3-dioxolan-2-one was used as a coupling partner leading to the corresponding allylic alcohol in moderate yield<sup>[88]</sup> and a higher reactivity was obtained using enones (Scheme 29).<sup>[89]</sup> Similar observations were found with allylic alcohols, however, C-H bond functionalization at the benzamide ring took place to some extent as well (Scheme 29).<sup>[90]</sup>

Ruthenium catalysts enabling C-H bond alkylations in the anilide ring of benzanilides are also scarce. For instance, *N*-substituted maleimides were found to react with *N*-arylisoindolinones giving rise to the product resulting from C-H bond *ortho*-alkylation in the anilide ring (Scheme 30).<sup>[91]</sup> In a complementary strategy, it was shown that products resulting from C-H bond *ortho*-alkylation in the anilide ring can be prepared upon a sequence involving ruthenium-catalyzed C-H bond alkenylation and palladium-catalyzed hydrogenation (Scheme 30).<sup>[61]</sup>

#### 2.4 C-H Bond Acylation Reactions.

In 2010, Yu and co-workers reported a seminal work on C-H bond acylations of benzanilides with anilide site-selectivity (Scheme 31). [92] They found that Pd(OAc)<sub>2</sub> was an excellent precatalyst to perform C-H bond carboxylations in the presence of CO leading to *ortho*-carboxylated chemicals. Additionally, these products can easily underwent post-functionalizations affording complex structures such as benzoxazinones and quinazolinones. In the catalysis, BQ served as a chemical oxidant and TsOH as the ligand. From the mechanistic viewpoint, they managed to isolate a catalytically productive intermediate consisting of a six-membered palladacycle in which coordination of the oxygen lone pair from the amide unit took place, although a dimeric palladium intermediate is more likely to operate. Further studies supported a Pd(0)/Pd(II) catalytic cycle. [92] In alternative protocols, CO was

replaced by a more benign N,N-dimethyloxamic acid giving lower yields<sup>[93]</sup> and using diethyl azodicarboxylate (DEAD) instead of CO led to the product resulting from *ortho*-C-H ethoxycarboxylation (R-CO<sub>2</sub>Et) with the same anilide site-selectivity.<sup>[94]</sup> A reversed site-selectivity with a palladium catalyst was reported using CO<sub>2</sub> in a poor yield.<sup>[95]</sup> In this case, an intramolecular reaction cascade occurred leading to N-phenylphthalimide (Scheme 32).

Inspired by the pioneering contribution from Yu ( $vide\ supra$ ), [92] a number of new methodologies based on palladium catalysts under oxidizing conditions appeared employing different coupling partners as the source of acyl groups. The formation of these acyl groups is manifold. They can be obtained in the presence of tert-butyl hydroperoxide (TBHP) from benzaldehyde derivatives, [96-97] benzylic acohols, [98] toluene derivatives, [99-101] (Scheme 33) or from decarboxylation of  $\alpha$ -oxocarboxylic acids (Scheme 34). [102-103] All these reactions share the formation of a common catalytic intermediate prior to the reductive elimination step, namely a six-membered palladacycle bearing an acyl group (Scheme 32).

Besides palladium catalysts, there is a noteworthy case of a catalytic system based on rhodium leading to acylated benzanilides. Wang and co-workers reported the *ortho*-C-H bond functionalization of benzanilides with anilide site-selectivity using isocyanates as coupling partners. The catalysis was compatible with a variety of functional groups and the key catalytic intermediates were postulated to involve six-membered rhodacycles (Scheme 35). This methodology is appealing because unsymmetric diamides are not trivial to synthesize with current protocols.

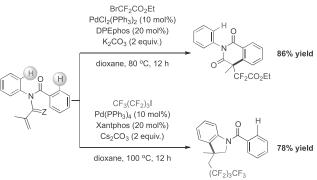
#### 2.5 C-H Bond Fluoroalkylation Reactions.

Fluoride-containing building blocks are particularly relevant for biomedical applications. [105] As such, C-H bond functionalizations of benzanilides employing fluorinated coupling partners have been tackled, leading mostly to products resulting from anilide site-selectivity. A first contribution was made by Shi and co-workers in 2013, who developed a palladium-catalyzed *ortho-*C-H bond trifluoromethylation of benzanilide utilizing Umemoto's reagent as the trifluoromethyl source (Scheme 36). [106] Recently, a more efficient methodology was introduced by Wang using a rather safe and stable reagent, namely CF<sub>3</sub>SO<sub>2</sub>Na, under visible-light-induced palladium catalysis (Scheme 36). [107] In both cases, a six-membered palladacycle species with oxidation state +4 on palladium was postulated to precede the reductive elimination step with an overall catalytic cycle involving Pd(II)/Pd(IV) species.

A palladium-catalyzed *ortho*-C-H bond trifluoroethylation with anilide site-selectivity was reported by Novak and coworkers using the very original mesityl(trifluoroethyl)iodonium triflate reagent as the "CF $_3$ CH $_2$ " source (Scheme 37). The reaction was fast and took place under very mild conditions. Two complementary palladium-catalyzed protocols have been described involving an intramolecular cyclization with different site-selectivity (Scheme 38).  $^{[109-110]}$

#### 2.6 C-H Bond Alkynylation Reactions.

Alkynylated compounds are key synthons in the synthesis of more elaborated molecular structures since the alkenyl fragment can readily be engaged in further derivatizations *via* well-known protocols (i.e. the Sonogashira cross-coupling). [111] Unfortunately, the site-selectivity of the C-H bond alkynylation of bezanilide derivatives have been rarely studied. The group of Glorius reported the first observations dealing with rhodium catalysis. [112] Benzanilide reacted with 1-[(triisopropylsilyl)ethynyl]-1,2-benziodoxol-3(1H)-one (TIPS-EBX) affording the *ortho*-C-H bond alkynylated product with exclusive benzamide site-selectivity (Scheme 39). A two-fold *ortho*-C-H bond alkynylation was achieved using an iridium catalyst and

(triisopropylsilyl)acetylene as reagent (Scheme 39). [113] In both cases, a five-membered metallacycle is sought to be responsible for the observed site-selectivity. The reversed site-selectivity was achieved only for structurally pre-disposed indolines under rhodium catalysis using TIPS-EBX reagent (Scheme 40). [114] In this case, the site-selective determining intermediate was evoked to be a six-membered rhodacycle due to the molecular geometry adopted by the substrate.

#### 2.7 C-H Bond Cyanation Reactions.

In 2014, Ackermann and co-workers noted that the ruthenium-catalyzed cyanation using *N*-cyano-*N*-phenyl-*p*-toluenesulfonamide (NCTS) as coupling partner proceeded with benzamide site-selectivity leading to the cyanated product in a moderate yield (Scheme 41).<sup>[115]</sup> Similar reactions conditions but swapping ruthenium for rhodium led to anilide site-selectivity for indolines, as it was shown by Kim and co-workers (Scheme 42).<sup>[116]</sup> The carbonyl group coordinates to the metal catalyst enabling different site-selective determining C-H bond activations in each case (five-membered ruthenacycle *vs* six-membered rhodacycle, *vide supra*). NCTS is an efficient partner for these transformations, although stoichiometric amounts of PhNHTs are formed as side-products at the end of the reaction.

#### 3. C-O Bond Forming Reactions.

In 2008, Nagasawa and co-workers reported the first examples of a site-selectivite C-H bond functionalization of benzanilides leading to products resulting from a C-O bond forming process. [117] Indeed, they showed that a variety of benzanilide derivatives reacted in an intramolecular fashion giving rise to 2-arylbenzoxazoles under copper catalysis and an atmosphere of oxygen, the latter being an oxidant to re-generate the catalytically active copper(II) species (Scheme 43). In a subsequent study they showed that oxygen could be switched by air at the expenses of replacing o-xylene by odichlorobenzene as the solvent.[118] The mechanism of the reaction was postulated to involve six-membered copper species via electrophilic aromatic substitution followed by a C-O coupling event. This represents the single example for intramolecular site-selective C-O bond formation via C-H bond functionalization using benzanilide derivatives.

On the other hand, intermolecular reactions have been more explored. In fact, a palladium-catalyzed C-H bond *ortho*-alkoxylation with anilide site-selectivity was reported in 2012 (Scheme 44). Interestingly, the C-O bond formation involved the use of readily affordable alcohols as coupling partners. Modest yields of the alkoxylated derivatives were obtained and the reaction was presumed to proceed involving a Pd(II)/Pd(IV) catalytic cycle.

Nakamura and co-workers described an original [1,3]-alkoxy rearrangement of *N*-alkoxybenzanilide derivatives. <sup>[120]</sup> The reaction, which was catalyzed by a carbene-copper(I) complex, led to a formal C-H bond *ortho*-alkoxylation with exclusive anilide site-selectivity (Scheme 45). The same group reported the [1,3]-alkoxycarbonyloxy rearrangement catalyzed by a cobalt salt (Scheme 45). <sup>[121]</sup> The metal catalyst (either copper or cobalt) serves likely as a Lewis acid.

Recently, Hii and co-workers reported a palladiumcatalyzed C-H bond ortho-acetoxylation using peracetic acid (AcOOH) as coupling partner, which was conceived as an atomeconomical reagent (Scheme 46). [122] For benzanilide derivatives, exclusive anilide site-selectivity was reached under very mild reaction conditions. Interestingly, only one equivalent of water was formed as side-product which is important from a sustainable point of view. Considering acetoxylation reactions, Movassaghi and co-workers reported one example of a using biologically-relevant N-acylindoline (diacetoxyiodo)benzene as the acetate source (Scheme 47).[123] They observed the exclusive formation of the acetoxylated product resulting from the ortho-C-H functionalization in the anilide ring.

Regarding C-H bond ortho-benzoxylations of benzanilide derivatives, Jeganmohan and co-workers showed that the reaction was not site-selectivity as the two possible products formed in a 1:1 ratio under a ruthenium-based catalytic system (Scheme 48).[124] This finding highlights the challenges associated to site-selective C-O bond forming reactions involving benzanilides. This issue is somehow circumvented using N-arylisoindolinones, which contain a benzanilide motif.[125] Similar reactions conditions as the ones developed by Jeganmohan led to exclusive C-H bond ortho-benzoxylations with anilide site-selectivity (Scheme 49). Although a good functional group tolerance was demonstrated, the conditions were not compatible for acetoxylation or benzyloxylation and no reactivity was observed with N-arylphthalimides. Six-membered ruthenacycles similar to those from Scheme 11 were claimed to occur for the C-H bond activation step.

A last type of C-O bond forming reaction tackled with benzanilide derivatives is the very relevant C-H bond hydroxylation. Particularly, Rao and co-workers reported a catalyst-controlled regio-divergent strategy to obtain exclusively the product resulting from a given site-selectivity for N-protected benzanilides. [126] Typically, para-cymene-coordinated ruthenium catalysts enabled the C-H bond ortho-hydroxylation in the benzamide ring, whereas palladium catalysts enabled the C-H bond hydroxylation in the anilide ring (Scheme 50). Such findings were rationalized by the different coordination geometries adopted by each metal catalyst in the C-H bond activation step according to DFT calculations. The ruthenium catalyst seems to prefer a piano stool geometry involving a fivemembered ring while the palladium catalyst displays a square planar geometry involving a six-membered ring (Scheme 50). The opposite site-selective determining intermediates are not favorable due to the steric shielding between the substrate the metal catalyst. The same group also reported the C-H bond

*ortho*-hydroxylation of *N*-H benzanilides.<sup>[127]</sup> The catalysis enabled anilide site-selectivity with ruthenium catalysts and a mixtures of mono- and di-hydroxylated products formed depending on the substituents from the benzamide fragment (Scheme 51).

Alternatively, *N*-arylphthalimide derivatives were found to be suitable partners to provide exclusively mono-hydroxylated products with anilide site-selectivity regardless of the equivalents of oxidant being used (Scheme 52).<sup>[128]</sup> The reactions, which were catalyzed by ruthenium or palladium catalysts, were tolerant to a broad scope of functional groups. Interestingly, no di-hydroxylated products were formed. On the other hand, *N*-arylisoindolinones, which are less sterically-demanding substrates, did give rise to di-hydroxylated products when using up to 3 equivalents of oxidant (Scheme 53). In these examples, the site-selectivity of the reaction is controlled by the predisposed carbonyl group that enforces formation of sixmembered metallacycle intermediates at the anilide ring rather than five-membered ones at the benzamide ring. (*vide supra*, Scheme 11).

#### 4. C-N Bond Forming Reactions.

C-N bond formation have also been accomplished with benzanilide derivatives. In all cases to date, only anilide site-selectivity has been reached with different transition metal catalysts via C-H bond functionalization strategies. In 2010, Yu and co-workers described the first successful example of a C-N bond forming reaction. They showed that a palladium(II) precatalyst enabled the C-H bond ortho-amidation using ethyl N-nosyloxycarbamate (NsONHCO $_2$ Et) as a source of "NHCO $_2$ Et" moieties (Scheme 54). The C-H bond activated species are postulated to be similar to those reported in Scheme 31, namely, dimeric six-membered palladacycles via coordination of the carbonyl lone pair to the metal center.

An alternative type of reagents suitable for C-H bond amidation are 3-substituted 1,4,2-dioxazol-5-ones. Chang and co-workers demonstrated that C-H bond ortho-amidation with anilide site-selectivity were feasible employing cobalt catalysts, although with a low yield(Scheme 55).[130] Only traces of product were observed by replacing the cobalt complex [CoCp\*Cl2]2 for [RuCl<sub>2</sub>(p-cymene)]<sub>2</sub> as the pre-catalyst. Analogously, Whiteoak and co-workers showed that the presence of catalytic amounts of NaOAc as a base have little impact in the site-selectivity of this transformation (Scheme 56).[131] Indeed, they showed that both possible products form in comparable yields and sideproducts displaying C-H bond over-amidation at both aromatic sites were also detected in some cases. DFT calculations suggested that the catalytically active species involved halfsandwich cobaltocene-coordinated intermediates. Overall, these observations indicate the difficulty to access this type of transformation in a site-selective and efficient manner.

The same type of amidating reagents were used by Prabhu and co-workers under ruthenium catalysis to functionalize indolines. Due to the restricted flexibility of the substrate, site-selective C-H bond *ortho*-amidation in the anilide ring was achieved in a good yield (Scheme 57). The key ruthenacycle species participating in the C-H bond activatin step is equivalent to the rhodacycle shown in Scheme 40.

In 2010, Zhang and co-workers reported a unique example of a C-H bond *ortho*-sulfonimidation of benzanilides under palladium catalysis using *N*-fluorobenzenesulfonimide (NFSI) as the nitrogen source (Scheme 58).<sup>[133]</sup> Interestingly, C-H bond *para*-sulfonimidation was observed for a methoxy-substituted benzanilide derivative. The catalysis exclusively provided the products resulting from anilide site-selectivity. The authors suggested a common palladium species for the C-H bond activation step. Then, depending on the substituents on the anilide ring two pathways were postulated to access each regioisomer: (1) reductive elimination *via* a Pd(II)/Pd(0) cycle for *ortho*-selectivity or (2) dearomatization of a spiro-palladacycle that undergoes sulfonimidation and hydrogen elimination for *para*-selectivity.

Ruthenium(II)-based catalysts appeared to be suitable for C-H bond *ortho*-sulfonamidation with anilide site-selectivity (Scheme 59). Two complementary methodologies were provided for indolines. In one case  $[RuCl_2(\textit{p}\text{-cymene})]_2$  is used as the precatalyst in the presence of silver salts,  $^{[134]}$  and in the other case,  $RuHCl(CO)(PPh_3)_3$  is enough to reach comparable efficiencies.  $^{[135]}$  These methodologies were not appropriate for indole derivatives. Alternatively, iridium catalysts enabled C-H bond *ortho*-sulfonamidation with anilide site-selectivity although in modest yields (Scheme 60).  $^{[136-137]}$

Several examples of nitration reactions with benzanilides have been disclosed. In particular, copper salts operating under a radical mechanism are convenient. Carretero and co-workers showed that Cu(NO<sub>3</sub>)<sub>2</sub> behaves as an excellent pre-catalyst for the C-H bond ortho-nitration of benzanilides with anilide site-(Scheme 61).[138] Different mono-substituted derivatives were obtained in good yields and di-nitration was demonstrated as well. For benzanilides substituted in ortho position at the anilide ring, mixtures of ortho- and para-nitration were observed. Interestingly, it was possible to replace the hazardous nitric acid reagent for a more benign tert-butyl nitrite (TBN) obtaining similar yields of ortho-nitrated products with the same site-selectivity (Scheme 61).[139] Alternatively, a copper(I)based catalytic system enabling in-situ azidation-oxydation with azidotrimethylsilane and tert-butyl hydroperoxide enabled similar reactivity as the copper(II) catalysts from Scheme 61.[140] One example under silver catalysis has been reported too. [141]

#### 5. C-H Bond Halogenation Reactions

Few examples have been reported for the site-selective C-H bond halogenation of benzanilide derivatives and all of them relying on palladium catalysis. In 2006, Shi and co-workers reported a seminal contribution showing that palladium(II) precatalysts afforded the product resulting from the C-H bond orthohalogenation in the anilide ring although in a low yield (Scheme 62).[142] The reaction was carried out in the presence of overstoichiometric amounts of Cu(OAc)2 and CuCl2, the former being the oxidant and the latter being the source of chlorides. The key C-H bond activated species seems to involve dimeric cyclopalladated complexes structurally similar to the ones in Scheme 28. In 2013, Rao and co-workers reported a copperfree protocol for the C-H bond ortho-chlorination with anilide siteselectivity under palladium catalysis (Scheme 62).[143] This time, the reaction required the use of stoichiometric amounts of Nchlorosuccinimide (NCS) with TfOH and Na<sub>2</sub>S<sub>2</sub>O<sub>8</sub> as the cooxidant.

Palladium catalysts were efficient for the C-H bond *ortho*-bromination with anilide site-selectivity as it was shown by Kapur and co-workers. [144] *N*-bromosuccinimide (NBS) was employed as the source of bromide in the presence of Cu(OTf)<sub>2</sub> and they noted that the reactions were fast, being accomplished in only 15 minutes (Scheme 63).

**Scheme 63.** Palladium-catalyzed C-H bond *ortho*-bromination with anilide site-selectivity. R = H or Me.

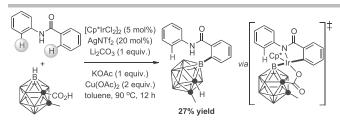
In 2018, Ritter and co-workers developed a rationally-designed palladium(II)-based catalytic system that enabled electrophilic aromatic C-H bond *ortho*-fluorinations (Scheme 64). They reported one example for a biologically-relevant benzanilide derivative, namely, tolvaptan. This compound is particularly challenging as it contains two benzanilide fragments. The catalysis was highly site-selective as only the *ortho*-C-H bonds from the anilide ring in the central core reacted leading to a statistical mixture of regioisomers. The reaction was performed with *N*-fluorobenzenesulfonimide (NFSI) as the source of fluorides under very mild conditions.

#### 6. C-H Bond Borylation Reactions

Borylation reactions via transition metal catalyzed C-H bond functionalization strategies is rather appealing as the boron-containing motifs are easily transformable into more elaborated carbon-carbon or carbon-heteroatoms bonds. [146] Regarding benzanilide derivatives only a couple of examples have been reported. The first one deals with an iridiumcatalyzed C-H bond borylation using the biologically relevant indomethacin. [147] By means of an original analytical approach employing LC-HR-MS/MS coupled with reaction-driven data processing, it was reported a low yield for the C-H bond orthoborylation with benzamide site-selectivity (Scheme 65). In a second example, a carboxylic acid-containing carborane (1-COOH-2-CH<sub>3</sub>-o-C<sub>2</sub>B<sub>10</sub>H<sub>10</sub>) was found to react with benzanilide affording a B-C cross-coupled product with benzamide siteselectivity (Scheme 66).[148] In-depth mechanistic studies highlight the role of the carboxylate fragment to assist the B-H activation step and further C-H bond activation via a fivemembered iridacycle with an overall mechanism involving Ir(III)/Ir(V) species with decarboxylation taking place.

# 7. An attempt of "site-selectivity rules" for *ortho-*C-H bond functionalization of benzanilide derivatives.

As it is clearly seen above in detail, the mechanisms governing each site-selectivity are not always trivial and may vary depending on (1) the presence of additives/ligands, (2) pH conditions and/or (3) coupling partners. In view to provide a sort of general overview, Tables 1 and 2 summarizes the main findings that have been accomplished for site-selective *ortho*-C-H bond functionalizations of benzanilides derivatives, which are the most studied so far. It is expected that these guidelines will serve to select reaction conditions to those that are entering in the field of C-H bond functionalization using metal catalysts or to those who are searching for a specific site-selectivity for synthetic purposes. In addition, the remaining challenges are also highlighted, indirectly suggesting future research directions.

#### 8. Beyond ortho-selectivity

The examples below undoubtedly testify the preference for *ortho*-selective transformations due to the coordinating ability of the amide bond as manifold directing group in C-H bond functionalizations of benzanilides. Interestingly, some studies have investigated C-H bond *meta*-functionalizations with additional control of the site-selectivity for benzanilides. van Gemmeren and co-workers described a palladium-catalyzed olefination protocol enabling high levels of *meta*-selectivity in aromatic C-H bonds.<sup>[149]</sup> When applied to *N*-arylphthalimide, a modest yield was obtained but with a high preference for *meta*-selectivity in the anilide ring (Scheme 67). Recently, a palladium-

catalyzed methodology inspired by contributions from Yu<sup>[150]</sup> and Catellani,<sup>[151]</sup> respectively, showed the incorporation of a norbornene unit to the anilide ring from benzanilide with a simultaneous *meta*- and *para*-regioselectivity (Scheme 68).<sup>[152]</sup>

Recently, Gaunt and co-workers reported a C-H bond *meta*-arylation using first-row transition metal catalysis. <sup>[153]</sup> It was disclosed that a copper catalyst enabled such transformation using  $Ph_2IOTf$  as the arylating reagent. For benzanilide, the reaction delivered the compound resulting from functionalization in the anilide ring (Scheme 69). The key mechanistic feature was to reach such site- and regio-selectivity by means of an unprecedented dearomatization oxycupration step.

In 2014, a gold-catalyzed C-H bond *para*-functionalization with  $\alpha$ -aryl- $\alpha$ -diazoacetates was reported. [154] When applied to a benzanilide derivative, this *para*-functionalization occurred with exclusive anilide site-selectivity (Scheme 70). The role of the ligand was essential for the success of the reaction and a phosphite ligand was preferred. Two years later, Nakao and coworkers developed an appealing strategy to furnish C-H bond *para*-alkylated derivatives with benzamide site-selectivity. [155] More precisely, an aluminum complex (i.e. MAD) was engaged in transient coordination to the ketone, while a nickel-carbene catalyst participated in the C-H bond *para*-functionalization (Scheme 71).

#### 9. Conclusion

In the last two decades a broad knowledge of the reactivity of benzanilide derivatives in C-H bond ortho-functionalization with transition metal catalysts have been accumulated. The usefulness and versatility of these type of amides as powerful directing groups has enabled challenging site-seletive ortho-C-H bond functionalizations. At this stage, the control of the siteselectivity for carbon-carbon bond formation is rather well established with different methodologies. The creativity to introduce original reagents as new carbon-sources appeared to be useful to circumvent some reactivity issues. This is true also for carbon-heteroatom bond forming reactions, although they remain under-studied with respect to the carbon-carbon ones. A key observation is that the reactivity of benzanilides is not only controlled by the stereoelectronic effects at each aryl group, but most importantly, by the transition metal catalyst generated under different reaction conditions which translates into a different mechanistic pathways. Most of the successful catalytic systems herein reviewed are based on expensive and scarce metal complexes (Pd, Rh, Ru, Ir, Au, etc.), although more benign ones such as Co, Cu or Fe have started to be considered for this type of site-selective transformations. [156] In the future it would be desirable, to apply green chemistry rules to these processes in view to reduce the waste of chemicals and the energy input of the reactions regarding the temperature and the time. [157] Besides, some fundamental niches still do exist. For example, the reversal of the site-selectivity observed for some type of benzanilides. In particular, the ones involving cyclic amides and imides such as N-benzoyl-indoles and -indolines, and N-aryl-isoindolinones and -phthalimides, in which no examples for benzamide site-selectivity are known to date. Additionally, the site-selectivity for meta- and para-C-H bond functionalization of benzanilides is in its infancy compared to substrates based on strong directing groups such as the nitrogen-containing ones (i.e. pyridine, imine, etc.).[158] New methodologies based on catalytic systems displaying original action modes and rationally-designed reagents will probably constitute two complementary strategies to overcome the

remaining challenges in this field. It will be interesting as well to see real applications of the current protocols in the late-stage functionalization of fine chemicals as well as in material sciences.<sup>[159]</sup>

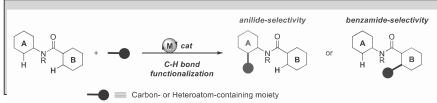
