# Relative importance of tree species richness, tree functional type, and microenvironment for soil macrofauna communities in European

# <sup>10</sup> Abstract

- 11 Soil fauna communities are major drivers of many forest ecosystem processes. Tree species diversity and composition shape 12 soil fauna communities, but their relationships are poorly understood, notably whether or not soil fauna diversity depends on AQ1 13 tree species diversity. Here, we characterized soil macrofauna communities from forests composed of either one or three tree 14 species, located in four different climate zones and growing on different soil types. Using multivariate analysis and model 15 averaging we investigated the relative importance of tree species richness, tree functional type (deciduous vs. evergreen), litter 16 quality, microhabitat and microclimatic characteristics as drivers of soil macrofauna community composition and structure. 17 We found that macrofauna communities in mixed forest stands were represented by a higher number of broad taxonomic AQ2 18 groups that were more diverse and more evenly represented. We also observed a switch from earthworm-dominated to 19 predator-dominated communities with increasing evergreen proportion in forest stands, which we interpreted as a result of a 20 lower litter quality and a higher forest floor mass. Finally, canopy openness was positively related to detritivore abundance 21 and biomass, leading to higher predator species richness and diversity probably through trophic cascade effects. Interestingly, 22 considering different levels of taxonomic resolution in the analyses highlighted different facets of macrofauna response to AQ3 23 tree species richness, likely a result of both different ecological niche range and methodological constraints. Overall, our 24 study supports the positive effects of tree species richness on macrofauna diversity and abundance through multiple changes

Forests are a major type of ecosystem in Europe, covering 29 30 42% of land surface (Paivinen et al. 2001) and providing a multitude of key ecosystem services, such as timber 31 production, watershed protection and carbon sequestra-32 tion (Scherer-Lorenzen et al. 2005). These services depend 33 34 strongly on tree taxonomic richness and on the proportion of different functional type (e.g., evergreen vs. decidu-35 AQ4ous) in forest stands (Gamfeldt et al. 2013). In addition, 37 tree species richness may determine the abundance and diversity of other groups of organisms (Ampoorter, et al. 38 2019) that could affect ecosystem processes. Especially, 39 trees shape communities of soil invertebrates, which are 40 key regulators of soil functioning and primary productiv-41 ity (Wardle 2004; Wall et al. 2012). However, the direct 42 and indirect mechanisms underlying soil invertebrate 43 responses to tree species diversity and composition remain 44 45 poorly understood, even in temperate forest ecosystems (Korboulewsky et al. 2016). 46

Trees can influence soil fauna through the provision 47 of energy and matter via living and dead plant products 48 such as leaf and root litter, dead wood, and rhizodepo-49 sition. Many soil organisms such as macrodetritivores 50 (earthworms, millipedes, woodlice) feed directly on plant 51 52 debris (Lavelle and Spain 2001), imposing stoichiometric constraints with lower and narrower carbon to nutrient 53 ratios in animal biomass than that of their feeding resource 54 (Sterner and Elser 2002). Resource nutrient concentrations 55 are therefore particularly important as they determine lit-56 ter palatability for macrodetritivores, and have important 57 consequences on the structure of their communities, nota-58 bly on their biomasses (Ott et al. 2014). In mixed forest 59 stands, litter may be of overall higher quality relative to 60 monospecific stands when tree species with high quality 61 62 litter may compensate for those with low nutrient concentrations or high contents in recalcitrant compounds 63 (e.g., polyphenols or lignin; Korboulewsky et al. 2016). 64 65 Another pattern often highlighted in the literature is the strong effect of evergreen trees on soil fauna communities 66 (Reich et al. 2005), which can be related to the low lit-67 ter quality of most evergreen species. Additionally, other 68 evergreen traits such as leaf life span and the phenology of 69 leaf senescence together determine tree canopy properties 70 71 which affect microhabitats and microclimate conditions at soil surface (Monk 1966). 72

Beyond litter quality and its consequences for the heterotrophic soil food web, different tree species also vary
in a number of physical characteristics that may influence soil fauna communities. For instance, differences in
leaf size, leaf shape, and amount of litterfall (including
deadwood), determine the total volume of habitats, and

their spatial organization for both detritivore and predator 79 species (Aubert et al. 2006, Kaspari and Yanoviak 2009). 80 The structural complexity of litter layers, and the resulting 81 diversity of microhabitats for the soil fauna, also vary from 82 one tree species to another and are likely higher in mixed 83 than pure stands (Hättenschwiler et al. 2005). This may 84 contribute to an increase in abundance, biomass, diversity, 85 and evenness of soil invertebrates in mixed when com-86 pared to monospecific forest stands (Hansen and Coleman 87 1998; Perry and Herms 2016), especially when the mixed 88 stands include deciduous broadleaved trees among ever-89 green conifers (Kaneko and Salamanca 1999). 90

The influence of the previously mentioned litter prop-91 erties (nutrient content, shape, litter layer depth) on soil 92 and forest floor properties and on invertebrate communi-93 ties also varies with tree canopy richness and composition 94 (Augusto et al. 2002; Ponge 2003). Tree canopy openness 95 is an important but overlooked forest stand characteristic 96 that has important effects on forest floor conditions. By 97 modulating light availability at the soil surface, canopy 98 openness may influence soil communities by altering forest 99 floor microclimate and understory vegetation (Prescott and 100 Vesterdal 2013; Henneron et al. 2015; Mueller et al. 2016). 101 This again can differ depending on tree species richness that 102 can affect canopy openness and litter production through 103 increased canopy packing, as was reported for different 104 European forests (Jucker et al. 2015). In addition, evergreen 105 tree species distinctively affect microclimatic conditions, in 106 particular through a permanent canopy cover, and high leaf 107 area index (LAI) all year round which leads to higher rainfall 108 interception and evaporation and thus drier soils (Augusto 109 et al. 2015). 110

Characterizing soil fauna responses to the diversity and 111 composition of the standing vegetation is thus complex 112 and often made even more difficult by taxonomic impedi-113 ments and our lack of knowledge of certain taxa. Indeed, 114 it is difficult if not impossible to obtain rapid and reliable 115 taxonomic assignations at a species level for most of the 116 soil biota (Decaëns 2010). A classic strategy to avoid this 117 problem in soil macrofauna studies is to target assignations 118 to higher taxonomic ranks, which allows the whole com-119 munity to be considered without prior selection of target 120 taxa (Williams and Gaston 1994; Andersen 1995). Another 121 option is to make species-level identifications possible by 122 restricting the study to a small number of taxa, for which 123 taxonomic expertise is available, that are further assumed to 124 be representative of the whole community or of a particu-125 lar trophic group thereof. The implication of each of these 126 approaches for our ability to describe community patterns 127 reliably, and the importance of the level of taxonomic reso-128 lution they imply, has never been formally addressed with 129 regard to soil fauna. However, it is probable that some of 130 these patterns (e.g., diversity—area, or diversity—available 131

energy relationships) may vary in their shape depending on
the fundamental taxonomic units of the study, which could
consequently affect observed community responses to environmental gradients (Williams and Gaston 1994; Kaspari
2001; Storch and Šizling 2008).

In this study, we described soil macrofauna communities 137 in forest plots composed of either a single dominant tree 138 species or three co-dominant tree species in four different 139 pedoclimatic zones ranging from boreal to Mediterranean. 140 These plot were part of an existing network of natural forest 141 plots with different tree species richness and composition 142 across Europe (Baeten et al. 2013). We tested three com-143 plementary hypotheses. First (H1) higher tree richness in 144 forest stand will promote soil macrofauna richness, diversity, 145 evenness, abundance, and biomass, likely by increasing the 146 probability of including at least one tree species that sig-147 nificantly improve life conditions for invertebrates (e.g., by 148 producing a high quality litter, having a denser canopy that 149 limits microclimatic variations, or promoting more diver-150 sified microhabitats in the litter layer). Alternatively, (H2) 151 increasing the proportion of evergreen species will nega-152 tively affect detritivore assemblages due to their low-quality 153 litter and soil-acidification effect, but may favor predator 154 organisms by the production of a thicker litter layer and the 155 consecutive provision of more microhabitats. Combined, 156 these expected effects will result in changes in the whole 157 macrofauna community composition. Finally, because of the 158 tighter trophic link between litter characteristics and detri-159 tivores species (Scherber et al. 2010; Beugnon et al. 2019), 160 we expect that (H3) tree species richness and composition 161 will induce a stronger response in detritivore than in predator 162 communities. These three hypotheses were tested at different 163 levels of taxonomic resolution to assess the response of the 164 whole macrofauna community and of specific groups with 165 narrower ecological niche. 166

### 167 Material and methods

### 168 Study sites and tree stand composition

The study was carried out within the framework of the Soil-169 ForEUROPE project in four forest sites selected to represent 170 four major European forest types along a broad climatic gra-171 dient in Europe: thermophilous deciduous forests (Colline 172 Metallifere, Italy), mountainous deciduous forests (Râsça, 173 Romania), temperate mixed coniferous and broadleaf for-174 ests (Bialowieza, Poland), and boreal forests (North Karelia, 175 Finland). The sampled plots are part of the FunDivEUROPE 176 exploratory platform (Baeten et al. 2013) excluding within 177 site variation in climate, soil and land use history between 178 plots and specifically designed to disentangle the species 179 diversity and identity effect in the biodiversity-ecosystem 180

functioning relationship (Nadrowski et al. 2010). In each 181 site, replicated forest plots of  $30 \times 30$  m were selected to 182 represent either monospecific stands (34 plots) or 3 species 183 mixtures (30 plots), further referred to as pure and mixed 184 stands, respectively. Selected tree species (i.e., target spe-185 cies) are 13 locally dominant and representative tree species, 186 including evergreen conifers and evergreen or deciduous 187 broadleaved trees (Table 1). These plots were selected in 188 2012 during the FunDivEUROPE project and relative basal 189 area of tree species was re-estimated in 2018 for this study. 190 The relative proportion of tree species was based on their 191 relative basal area, and non-targeted species basal area in 192 the plot was kept below 5%. In each plot we selected three 193 subplots based on tree triplets forming a triangle of three 194 individual trees with a minimal diameter at breast height of 195 5 cm, composed of either the same target species in the pure 196 stands or the three target tree species in the mixed stands 197 (Fig. S1). 198

### Invertebrates sampling and community descriptors 199

Sampling was conducted in 2017 during the phenological 200 spring at each of the four sites. In each plot, soil macrofauna 201 was sampled by excavating one soil block of  $25 \times 25 \times 10$  cm 202 within each tree triplet (i.e., three soil blocks per plot). Inverte-203 brates were hand sorted in the field, and immediately fixed and 204 preserved in 70% ethanol. They were further assigned to broad 205 taxonomic groups (usually orders), with additional considera-206 tion of trophic position or ecological categories when relevant. 207 This resulted in 16 groups: Araneae, predatory Coleoptera 208 (Carabidae adults and larvae, Staphylinidae), Opilionidae, 209 Dermaptera, Chilopoda, Blattodea, rhizophagous Coleop-210 tera (larvae of Melolonthinae, Curculionidae, Elateridae), 211 coprophagous Coleoptera (Geotrupinae), endogeic, epigeic, 212 and anecic Lumbricidae, Diplopoda, Isopoda, Diptera larvae, 213 Gastropoda, and Lepidoptera larvae. Species level identifi-214 cations were done for all Lumbricidae, Isopoda, Diplopoda, 215 Chilopoda, and Araneae specimens. For the few individuals 216 for which this was not possible, genus or family levels were 217 kept for the analysis; as this only concerned a small fraction of 218 specimens, these higher rank taxonomic identifications were 219 treated without distinguishing them from species-level iden-220 tifications. All invertebrates were counted per broad group or 221 species and weighed individually to the nearest 0.01 mg after 222 gently drying them with a paper towel. The abundance and 223 biomass of the 16 different groups is given in Table S1. We 224 then organized the data into three different matrices: one with 225 the numbers of individuals per plot for each broad group, fur-226 ther referred to as "all macrofauna", and two with the numbers 227 of individuals per plot and per species (or finest level achieved) 228 for the detritivore and predator groups previously mentioned, 229

further referred to as "detritivore assemblage" and "predator 230 assemblage", respectively (taxa list in Table S2). 231

From these three matrices, we calculated several commu-232 nity descriptors: taxonomic richness (S) Pielou's evenness (J; 233 Pielou 1966), and  $\operatorname{Hill}_{q=1}'$  diversity  $(D_1)$ .  $D_1$  was obtained with 234 the formula: 235

where S is the total number of taxa (i.e., fundamental taxo-238 nomic units: broad groups or species depending on the 239 matrix), p the proportion of taxa i and q the "order" of the 240 diversity. The order q determines the diversity index sen-241 sitivity to common and rare taxa with values of q below 242 or above one giving diversities highly sensitive to rare or 243 common taxa, respectively (Jost 2006). We choose q = 1 and 244 even though Eq. (1) is not defined when the diversity order 245 is one its limit exists and equals: 246

This is the exponential of Shannon entropy which has the 249 250 advantage of being relatively insensitive to rare or common taxa. All analyses were done using R software v.3.5.2 (R 251 Core Team 2019) with the individual forest plots as replica-252 tion units (i.e., the three samples per plot were pooled for 253 calculations). Community descriptors were calculated with 254 the diversity function of the vegan package (Oksanen et al. 255 2019). 256

### 257 Selection of predictor variables

The predictor variables used in this study are summarized in 258 Table S3, and protocols of variable acquisition are detailed 259 in Online Appendix 1. Tree richness was included in the 260 analyses as a factor (one or three tree species), and we 261 assessed the effect of tree functional type using the relative 262 basal area of evergreen species across the three tree triplets. 263 Other predictor variables (i.e., leaf litter traits, microenvi-264 ronmental characteristics, and soil properties) were summa-265 rized by computing three Principal Components Analysis 266 (PCA) ordinations (Fig. S2) with the prcomp function from 267 the package factoextra (Kassambara 2019). The scores of 268 the forest plots on the retained axes of each PCA were then 269 used as synthetic environmental variables to further explain 270 the structure and composition of macrofauna communities. 271 Pearson correlation between all predictor variable is given 272 in Figure S3. 273

Litter traits included the concentrations of cellulose, 274 lignin, polyphenols, nitrogen, and calcium measured in 275 freshly fallen leaf litter of all tree species for each coun-276 try independently (i.e., we used country mean trait value 277 for each tree species). PCA was computed with community 278 weighted means of these traits (Garnier et al. 2004), using 279 tree basal area over the three triplets as a measure of the rela-280 tive proportion of each species. We kept the first PCA axis 281 which accounted for 49.5% of overall variance and repre-282 sented a "litter quality" gradient from low-quality associated 283 with high concentrations of lignin and cellulose (negative 284 scores) to high-quality associated with high nitrogen and 285 polyphenol concentrations (positive scores) (Fig. S2A). 286

The microenvironmental variables included forest floor 287 mass, biomass of understory vegetation and volume of 288 coarse deadwood debris per unit ground area, and the leaf 289 area index of canopy trees as a proxy of canopy closure. 290 Here, to include enough variance in microhabitat and micro-291 climate properties, we kept the first two PCA axes, explain-292 ing 38.2% and 26% of the overall variance, respectively. The 293 first axis corresponded to a switch from plots with a high 294 understory vegetation biomass (negative scores), to plots 295

with most of the soil covered by a thick forest floor (positive scores), and is for simplicity further referred to as "forest floor mass". The second axis reflected "canopy openness", with closed canopy plots having negative scores on this axis (Fig. S2B).

Soil characteristics in the top 10 cm of mineral horizon included bulk density, pH (determined in a  $CaCl_2$  solution), clay content, carbon content, and C/N ratio. We kept the first axis which explained 52.5% of the overall variance and represented a gradient of "soil quality", with sites having negative scores being characterized by more compact, acidic and C-poor soils (Fig. S2C).

### **Statistical analysis**

To test the effect of tree stand properties and environmental 309 variables on the whole macrofauna, detritivore, and preda-310 tor community composition, we calculated the Bray-Curtis 311 dissimilarity matrix of the three matrices and performed a 312 partial distance-based Redundancy Analysis (dbRDA; Leg-313 endre and Anderson 1999) with capscale function of the 314 vegan package, and including the country as a random fac-315 tor with the argument condition (Borcard et al. 2018). The 316 significance of the predictor variable and of the ordination 317 along each axis was assessed using permutation tests (anova 318 function of the stats package, R Core Team 2019), constrain-319 ing the permutation within countries (4999 permutations, 320 how function in permute package; Besag and Clifford 1989). 321

Since macrofauna communities are concomitantly influ-322 enced by many environmental factors, themselves driven by 323 tree species richness and functional type, we modeled the 324 response of each community descriptor first with a model 325 (M1) including only tree species richness and functional 326 type as co-variable, and then with a complete model (M2) 327 including also microenvironment variable. Thus, H1 and H2 328 are validated if a significant effect of tree species richness 329 and evergreen proportion are detected in M1, respectively. If 330 these effects are no longer supported in M2 and are replaced 331 by significant effects of the other co-variables, this gives 332 further insights into the mechanisms through which tree spe-333 cies richness and evergreen proportion affect macrofauna 334 communities. On the other hand, similar results in M1 and 335 M2 would suggest that tree species richness or evergreen 336 proportion effects are mediated by mechanisms others than 337 those covered by our co-variables. Finally, the fact of finding 338 significant effects only for microenvironmental variables in 339 M2, would imply that macrofauna communities are influ-340 enced by microenvironment independently of tree species 341 richness and evergreen proportion. H3 was tested by com-342 paring the results of both models obtained for detritivore and 343 predator assemblages separately. 344

We applied a MultiModel Inference (MMI) approach (Burnham et al. 2002) allowing to quantify for the relative 346

where Y is one of the 15 response variables (i.e., taxonomic 352 richness, Hill<sub>g=1</sub> diversity, evenness, abundance, and bio-353 mass calculated separately for the whole macrofauna and 354 detritivore and predator assemblages). The list of terms 355 preceded by the "~" are the explanatory variables (with 356 Tree SR = tree species richness; Evergreen % = percentage 357 of evergreen basal area; litter quality = PC1 of litter traits; 358 FF mass = PC1 of microenvironmental variables; canopy 359 openness = PC2 of microenvironmental variables; soil qual-360 ity = PC1 of soil properties; PC refereeing to the plot score 361 on the axes of PCA of environmental variables as defined in 362 the previous section), and "1lCountry" refers to the belong-363 ing to countries included as random factor. We used Gener-364 alized Linear Mixed Models with the glmmTMB function of 365 the glmmTMB package (Magnusson et al. 2019) and checked 366 for residual normality and homoscedasticity. Abundance 367 data were log(1 + x) transformed since including an argu-368 ment to model residuals distributions in the function (Pois-369 son or negative binomial family) was not sufficient to meet 370 model assumptions (Ives 2015). In both model steps (M1 371 and M2), best models were selected based on the Akaike 372 Information Criterion for small sample size (AICc, dredge 373 function in the MuMIN package), keeping all models within 374  $\Delta$ AICc < 6 (Harrison et al. 2018). Predictor estimates were 375 obtained by averaging their value across the models in which 376 the predictor appeared to avoid estimate value shrinkage 377 towards zero (Harrison et al. 2018). Estimates were stand-378 ardized ( $\beta_{st}$  scale-standardization) to allow cross model 379 comparisons of predictor effects. To quantify to what extent 380 including microenvironmental variables improve community 381 descriptors modeling, we compared the best model obtained 382 from the reduced (M1) and complete (M2) model. These 383 two best models were compared on the basis of the addi-384 tional variance explained by fixed effects ( $R^2m$ ) and by fixed 385 and random effects ( $R^2$ c; Nakagawa and Schielzeth 2013), 386 and AICc. Additionally to this first analysis across the four 387 sites (continental scale), we performed the same analytical 388 procedure with the complete model (M2) in each country 389 individually (regional scale) to investigate to what extent the 390 observed effects could depend on the geographic context (as 391 in de Wandeler et al. 2018). Abundance data were log(1+x)392 transformed as well as detritivore and predator biomass data 393 to reach model assumptions. The analysis was not feasible 394 for detritivore assemblage in Finland because of the large 395 proportion of empty sites (eight out of nine plots). 396

Results

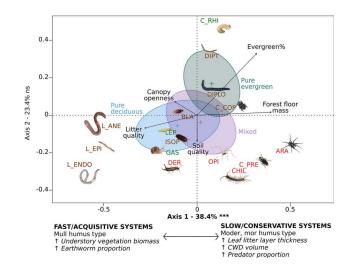
We collected a total of 2951 soil invertebrates belonging to 16 broad groups, with an average of  $237.6 \pm 98.9$  indi-

viduals per square meter in Finland,  $246.1 \pm 106$  in Poland, 400  $300 \pm 111.8$  in Romania, and  $204.1 \pm 76.4$  in Italy. Among 401 the identified specimens, roughly one sixth of all individu-402 als collected (504 individuals) were detritivores assigned 403 to 14 species of Lumbricidae, 10 of Isopoda, and 20 of 404 Diplopoda, and a bit more than one fourth (803 individuals) 405 were predators assigned to 90 species of Araneae and 49 of 406 Chilopoda. Nine detritivore species were singletons (1 indi-407 vidual sampled), and 3 doubletons (2 individuals sampled), 408 while 55 singletons and 25 doubletons predator species were 409 recorded. Macrofauna individuals were sampled in every 410 plots, but detritivore species (Lumbricidae, Isopoda, Diplop-411 oda) were absent in nine plots, mainly in Finland (absent in 412 eight over nine plots). 413

### **Community composition**

At a coarse level of taxonomic resolution, whole macro-415 fauna communities were organized along the first axis of 416 the dbRDA (Fig. 1), which explained 38.4% of overall vari-417 ance (p < 0.001), Table S4) and was mainly driven by litter 418 quality, evergreen proportion, and forest floor mass. Plots 419 with negative scores on the first axis were characterized 420 by high understory biomass, thin forest floor layer, high 421 litter chemical quality, and low evergreen proportion, and 422 they supported high abundance of earthworms of all three 423 ecological types (i.e., endogeic, epigeic, and anecic). Plots 424 with positive scores were dominated by evergreen tree spe-425 cies, presented a thick forest floor layer, a high amount of 426 coarse deadwood debris, and harbored a relatively high 427 abundance of predators (Araneae, Chilopoda, predatory 428 Coleoptera, Opiliones). The second axis explained 23.4% 429 of overall variance (p=0.075) and highlighted the effect of 430 soil quality on macrofauna communities. Plots with positive 431 scores were characterized by low clay and carbon content, 432 lower pH associated with evergreen tree dominance, and 433 harbored comparatively higher densities of rhizophagous 434 Coleoptera, Diptera larvae, and Diplopoda. The same anal-435 ysis on detritivore and predator assemblages did not reveal 436 any significant ordination (dbRDA<sub>Detritivore</sub> axis 1 p = 0.13, 437 dbRDA<sub>Predator</sub> Axis 1 p = 0.06, Fig. S4, Table S4), meaning 438 that the predictors considered in our study did not signifi-439 cantly explain community composition at the finer level of 440 taxonomic resolution. 441

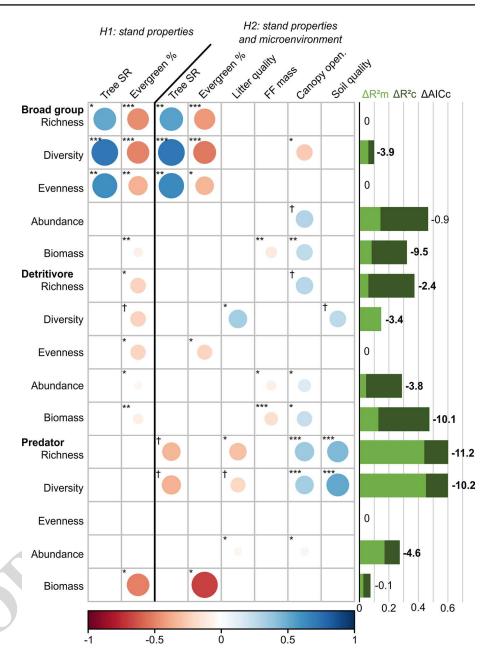
443 When all macrofauna was considered, the proportion of explained variance by fixed effects  $(R^2m)$  in the full model 444 (M2) varied from 14% (abundance) to 44% (Hill<sub>a=1</sub> ' diver-445 sity  $D_1$ ). Accounting for random effects ( $R^2c$ ) increased the 446 proportion of explained variance to 24% (evenness J) and 447 to 76% (biomass), indicating a strong variability between 448 countries. Broad group richness,  $Hill_{a=1}$  diversity and even-449 ness were well predicted in the reduced model (M1), while 450 biomass, and to a lesser extent abundance, were better pre-451 dicted in the complete model (M2). Broad group richness, 452  $\operatorname{Hill}_{a=1}$  diversity and evenness were higher in mixed than in 453 monospecific stands (M1, S: std.est. = 0.51, p = 0.013;  $D_1$ : 454 std.est. = 0.72, p < 0.001; J: std.est. = 0.62, p < 0.01, Fig. 2, 455 Fig. S5–S6), and at the same time decreased with the propor-456 tion of evergreen trees (M1, S: std.est. = -0.46, p < 0.001; 457 458  $D_1$ : std.est. = -0.50, p < 0.001; J: std.est. = -0.36, p < 0.01, Fig. 2, Fig. S5-S6). There were no consequent changes 459 between M1 and M2 in the proportion of explained vari-460 ance or AICc, except for broad groups D<sub>1</sub> that also decreased 461 with canopy openness ( $\Delta AICc = -9.5$ ,  $\Delta R^2m = +0.06\%$ , 462  $\Delta R^2 c = +0.04\%$ ; Fig. 2, Table S5). Broad group abundance 463 was poorly predicted regardless of the model, while bio-464 mass decreased with evergreen proportion in M1. However, 465

this effect disappeared in M2, where total biomass instead 466 decreased with forest floor mass and increased with canopy 467 openness (Fig. 2). In this case, the best complete model 468 showed a lower AICc ( $\Delta AICc = -9.5$ ) and higher proportion 469 of explained variance ( $\Delta R^2 m = +0.08\%$ ,  $\Delta R^2 c = +0.24\%$ ; 470 Fig. 2, Table S5). Most significant effects detected at the 471 continental scale were also detected in at least 1 country 472 (14 effects out of 23; Table S6). Only the negative effect 473 of canopy openness on broad group  $Hill_{a=1}$  diversity and 474 the negative effect of evergreen proportion and broad group 475 evenness only appeared at the continental scale. On the other 476 hand, some factors that were not significant at the continen-477 tal scale showed significant effects at the regional scale in 478 one or two countries. Regarding detritivore species assem-479 blages, the proportion of variance explained by fixed effects 480 was low, ranging from 4% (J) to 23% (biomass). Including 481 the country as a random factor substantially increased the 482 explained variance to 68% (J) and 79% (abundance), except 483 for taxa  $\operatorname{Hill}_{a=1}$  diversity which only reached 24% of total 484 explained variance in both models. In M1, none of the com-485 munity metrics were affected by tree species richness, while 486 evergreen proportion negatively affected all of them (Fig. 2, 487 Table S5). However, most of these effects were replaced in 488 M2 by the effect of microenvironmental variables, which 489 produced a better model with substantially lower AICc 490 and higher explained variance. Detritivore richness mar-491 ginally increased with canopy openness, while detritivore 492 Hill<sub>*a*=1</sub>' diversity increased with litter quality (std.est. = 0.33, 493 p = 0.029). Evergreen proportion was retained as the best 494 predictor of detritivore evenness in both models (M1: std. 495 est. = -0.22, p = 0.012; M2: std.est. = -0.21, p = 0.033; 496 Fig. 2, Table S5). Forest floor mass was negatively corre-497 lated with abundance and biomass (ab: std.est. = -0.08, 498 p = 0.013; m: std.est. = -0.17, p < 0.001; Fig. 2, Table S5), 499 while the opposite pattern was found with canopy openness 500 (ab: std.est. = 0.15, p = 0.023; m: std.est. = 0.22, p = 0.02; 501 Fig. 2, Table S5). Five out of the eight significant relation-502 ships found at the continental scale were also observed at 503 the regional scale, but the effect of forest floor mass and 504 canopy openness on detritivore abundance and biomass 505 mainly occurred at the continental scale. In Poland, tree SR 506 increased detritivore  $\operatorname{Hill}_{a=1}$  diversity, and evergreen propor-507 tion reduced detritivore biomass and marginally abundance. 508

Most descriptors of predator assemblages were well 509 explained by fixed factor, except for evenness, with  $R^2$ m 510 ranging from 9% (biomass) to 45% ( $D_1$ ). The random factor 511 accounted for a very small part of predator richness, diver-512 sity, or evenness, but consistently increased explained vari-513 ance for abundance and biomass. Most of community met-514 rics were better predicted in the complete model. Predator 515 species richness and (marginally) Hill's diversity decreased 516 with litter quality (S: std.est. = -0.29, p = 0.012;  $D_1$ : std. 517 est. = -0.21, p = 0.059) and strongly increased with canopy 518

openness (S: std.est. = 0.36, p < 0.001;  $D_1$ : std.est. = 0.33, 519 p < 0.001) and soil quality (S: std.est. = 0.45, p < 0.001; 520  $D_1$ : std.est. = 0.51, p < 0.001). Here, changes in the propor-521 tion of explained variance and AICc were very high (S: 522  $\Delta R^2 m = +0.44\%$ ,  $\Delta R^2 c = +0.16\%$ ,  $\Delta AICc = -11.2$ ; S: 523  $\Delta R^2 m = +0.45\%$ ,  $\Delta R^2 c = +0.15\%$ ,  $\Delta AICc = -10.2$ ; Fig. 2, 524 Table S5). Predator abundance weakly decreased with litter 525 526 quality and weakly increased with canopy openness, while biomass strongly decreased with evergreen proportion in 527 both the reduced and complete models. Nine of the 11 sig-528 nificant effects detected at the continental scale were also 529 present at the regional scale. Tree SR decreased predator 530 abundance in Finland but increased their biomass in Poland. 531 Canopy openness negatively affected predator assemblage 532

evenness in both Poland and Italy, while litter quality533decreased predator biomass in Finland and Poland. Finally,534soil quality had a negative effect on predator abundance and535biomass in Finland, while FF mass increased predator abundance536dance in Poland.537

# Discussion

The results of our study show the effect of tree richness and functional type (i.e., stand evergreen proportion) on soil macrofauna communities and highlight the underlying mechanisms. Interestingly, we found that forest stands with a low evergreen tree proportion supported macrofauna 543

communities with a higher number of broad groups that 544 were also more diverse and evenly represented. In contrast, 545 at a species-level taxonomic resolution, the effects of tree 546 species richness and functional type were less pronounced. 547 Instead, litter quality, microhabitat and microclimate became 548 important drivers of both detritivore and predator assem-549 blage structure, with trophic cascade effects potentially 550 occurring between these two trophic groups. The majority 551 of the effects observed at the continental scale were also 552 present in at least one country, giving further support to 553 our results (Table S6). Some effects idiosyncratically dis-554 appeared or appeared at the regional scale due to changes 555 in sample size, or narrower environmental and community 556 variable gradients as reported for earthworms in European 557 forests (de Wandeler et al. 2018). In our study, considering 558 this regional scale provided no additional insights into the 559 links between macrofauna communities and their environ-560 ment, and this will therefore not be discussed further. 561

# 562 Main axes of variability in soil macrofauna 563 communities

The results of our redundancy analysis show that as much 564 as 38.4% of the total variability in macrofauna communi-565 ties, when described at a coarse taxonomic resolution, was 566 explained by an opposition between two extremes of a gra-567 dient from pure deciduous to pure evergreen stands. This 568 gradient is consistent with the classification of ecosystems 569 along a productivity gradient (Wardle 2004), soil process 570 domains (Desie et al. 2019), or the distinction between dif-571 ferent humus types ranging from mull, i.e., "fast turnover" 572 and "acquisitive strategy", to moder and mor, i.e., "slow 573 turnover" and "conservative strategy" (Ponge 2003; Zanella 574 et al. 2011). 575

In fast cycling systems, deciduous trees provide high-576 quality litter and canopy openness over the year, allow-577 ing the establishment of an important understory vegeta-578 tion, which produces litter rich in important nutrients such 579 as calcium and nitrogen (Reich et al. 2005; Gilliam 2007; 580 Augusto et al. 2015). This results in both a higher earthworm 581 proportion in macrofauna communities and more diverse 582 detritivore assemblages in general (Reich et al. 2005). Being 583 more abundant and diverse, macrodetritivores are expected 584 to further accelerate litter burial and decomposition, thus 585 reducing the litter layer thickness at the soil surface (Hedde 586 et al. 2010; Coulis et al. 2016). Conversely, the decrease in 587 earthworm relative abundance and detritivore diversity in 588 evergreen dominated forests is a long known pattern that 589 can be explained by the poor quality of litter inputs as well 590 as the more acidic conditions of the forest floor (Reich et al. 591 2005; Ammer et al. 2006; Schelfhout et al. 2017). Such a 592 decrease in macrodetritivore abundance is expected to be 593 associated to lower bacterial activity, thicker forest floor 594

layer, and the promotion of other groups of smaller detriti-595 vores such as Collembola (Scheu et al. 2003). This probably 596 also explains the observed increase in predator relative abun-597 dance in stands with higher evergreen proportion, as this 598 group could benefit simultaneously from the higher diversity 599 and amount of microhabitats, and from the increased avail-600 ability of mesofauna prey (Arpin et al. 1986; Kaspari and 601 Yanoviak 2009). 602

# Tree diversity and functional type direct versus indirect effects

603 604

In line with our first hypothesis, both our reduced and com-605 plete model showed a strong positive effect of tree species 606 richness and a negative effect of evergreen proportion on 607 the richness, diversity, and evenness of macrofauna broad  $AQ5_{B8}$ groups. This is globally congruent with the results of other 609 studies that described a higher diversity of soil organisms 610 at a broad taxonomic level in mixed compared to pure ever-611 green forests (Scheu et al. 2003; Salamon et al. 2008). As 612 mentioned previously, many environmental factors can dif-613 fer between mixed and pure forests, including litter quality 614 and trait diversity, microhabitat heterogeneity and quantity, 615 canopy openness and soil quality (Scherer-Lorenzen et al. 616 2005), and most of them could indirectly explain tree effects 617 on soil macrofauna communities. However, when included 618 in a more detailed statistical model, none of the microenvi-619 ronmental variables considered in our study were found to 620 explain macrofauna community metrics at a broad level of 621 taxonomic resolution, apart from canopy openness which 622 had a weak negative effect on  $\operatorname{Hill}_{a=1}$  diversity. This suggests 623 that tree species richness and evergreen proportion effects on 624 macrofauna broad groups could be related to other micro-625 environmental variables not included in our analysis, such 626 as litter trait diversity or microhabitat heterogeneity. This 627 would be in line with other studies that have emphasized 628 the importance of litter chemical and physical trait variation, 629 which may both determine resource diversity for detritivores 630 and microhabitat quantity and diversity for invertebrates in 631 general (Hansen and Coleman 1998). 632

At a finer level of taxonomic resolution, tree species 633 richness no longer had a detectable effect on detritivore nor predator community descriptors, as indicated by our reduced 635 model. Concomitantly, the negative effect of evergreen pro-636 portion on detritivore and predator assemblages produced 637 by the reduced model was not retained in the complete 638 model, except for detritivore evenness and predator biomass. 639 Instead, our results revealed rather an indirect effect via 640 resource quality, habitat volume, and microclimate. The lack 641 of tree species richness effect on macrofauna assemblages at 642 this level of taxonomic resolution, is congruent with simi-643 lar studies focusing on earthworms or on detritivorous and 644 predatory beetles (Schwarz et al. 2015; Chamagne et al. 645

2016; De Wandeler et al. 2018). Other studies did report a 646 positive effect of tree species richness on spiders, saprox-647 ylic beetles, or earthworm richness, but differences in sam-648 pling protocols and study design can probably explain these 649 apparently contradictory results (Chamagne et al. 2016; 650 Ampoorter et al. 2019). Here, we also have to consider that 651 our design only included two levels of tree species richness 652 (monocultures and three-species mixtures), which is differ-653 ent from a true species richness gradient. This might have 654 impeded the detection of a tree richness effect, if it occurs at 655 another level of the diversity gradient. The negative effect of 656 evergreen proportion on detritivore evenness was consistent 657 regardless of the model, suggesting a significant importance 658 of diversity of litter traits or microhabitat, as already dis-659 cussed for broad group diversity. The negative response of 660 predator biomass to evergreen proportion, which was also 661 highlighted by both modeling approaches, and the simulta-662 neous lack of effect on their abundance, indicates that ever-663 green trees drive the predator assemblages towards smaller 664 body-sized taxa in less productive stands (Sklodowski 2002). 665 This supports the previously discussed idea that soil fauna 666 communities in evergreen-dominated stands are dominated 667 by small detritivores (Collembola and Acari), representing 668 a preferred prey for small body-sized predators (Arpin et al. 669 1986; Scheu et al. 2003). 670

Detritivore and predator communities also showed a 671 strong response to canopy openness, with increased detri-672 tivore abundance and biomass and predator richness and 673 diversity in more open forests. This can first be explained 674 by the direct controls exerted by canopy openness on for-675 est ground insolation, water availability, and temperature 676 conditions (Prescott 2002), as well as their expected effects 677 on ectotherm activity and on animals' ability to access 678 resources (Turner et al. 1987; Kaspari et al. 2000; Salmon 679 et al. 2008). Secondly, canopy openness increase light and 680 water availability for understory plants, which can result in 681 higher plant cover and diversity (Thomas et al. 1999). Detri-682 tivores will thus benefit from the nutrient-rich herbaceous 683 plant leaf litter and roots, which may constitute an important 684 and high-quality source of organic matter (Lavelle and Spain 685 2001; Gilliam 2007; Henneron et al. 2015). Finally, preda-686 tors may also rely on understory vegetation which deter-687 mines to a large extent the characteristics and heterogeneity 688 of their microhabitat (Pakeman and Stockan 2014). 689

### 690 Detritivore versus predator responses

A surprising result of our study is the fact that predator assemblages seem to be more sensitive to soil quality than detritivores. This predator response to soil quality may first be attributed to the fact that roughly half of them belonged to Chilopoda in our samples (Table S2), a group which is known to have at least partly endogeic behavior and is

therefore sensitive to soil properties, notably soil pH and 697 organic matter content (Blackburn et al. 2002). Conversely, 698 the absence of detritivore response may be explained by 699 three mechanisms. First, it is possible that other soil and 700 forest floor properties not included here, such as forest 701 floor pH or litter phosphorus content, may be more impor-702 tant for detritivore communities (De Wandeler et al. 2016). 703 Secondly, detritivore assemblages were composed of both 704 endogeic groups (endogeic Lumbricidae) and epigeic groups 705 (epigeic Lumbricidae, Diplopoda, and Isopoda). Epigeic 706 taxa may show weaker response to soil characteristics than 707 endogeic taxa which may have resulted in the absence of 708 response (Scheu and Falca 2000; Henneron et al. 2015; De 709 Wandeler et al. 2016). Finally, soil characteristics and plot 710 scores on the first PCA axis were strongly country specific 711 (Table 1), and it is possible that by including country as a 712 random factor in the models, captured part of soil charac-713 teristics variations was obscured. This is supported by the 714 smaller proportion of variance explained by fixed compared 715 to random effects (14 vs 50% on average) for detritivore 716 assemblage descriptors, which is notably due to the very low 717 abundance of these organisms in Finland. 718

In addition to the direct and indirect effects of tree rich-719 ness and functional type on macrofauna communities, 720 trophic cascades may also have occurred between detriti-721 vore and predator assemblages, particularly because Lum-722 bricidae, and to a lesser extent Diplopoda and Isopoda, 723 represent potentially important preys for Chilopoda and 724 Araneae (Scheu and Falca 2000). First, higher detritivore 725 abundance and biomass in response to increased canopy 726 openness may have enhanced predator diversity and rich-727 ness through higher resource availability (Abrams 1995). 728 Secondly, increased detritivore diversity in response to litter 729 quality may have resulted in a more heterogeneous resource 730 for predators, potentially decreasing prey-finding probability 731 for the more specialized species (Root 1973), and result-732 ing in the observed less rich, diverse and abundant predator 733 assemblages. These mechanisms stress the importance of 734 including trophic interactions when modeling soil macro-735 fauna distribution in forests (Scheu et al. 2003; Salamon 736 et al. 2008). To this end, it would also be interesting to 737 include in future studies other sampling methods, such as 738 pitfall traps, that could be more effective at sampling large, 739 mobile predators such as Carabidae that may feed on large 740 Lumbricidae. 741

#### Importance of taxonomic resolution

742

Given that the effect of tree species richness and evergreen proportion was detectable on whole macrofauna communities described at a low taxonomic resolution but no longer on detritivore or predator assemblages identified at the species level deserves particular attention.

Mixed deciduous-evergreen stands, with their intermedi-748 ate position between two forest type extremes ("fast" pure 749 deciduous, versus "slow" pure evergreen systems) may 750 provide the necessary conditions for the co-existence of 751 a high number of broad groups with contrasting ecologi-752 cal requirements (Fig. 1). This can also be explained by 753 the fact, as mentioned previously, that mixed deciduous-754 evergreen forests produce a litter layer with larger chemi-755 cal and physical trait variation, thus increasing resource 756 diversity for detritivores and microhabitat features for 757 invertebrates in general (Schuldt et al. 2008). The same 758 does not apply when considering individual detritivore 759 or predator species, because their narrower environmen-760 tal preferences limit them to a more restricted part of 761 the environmental gradient. This can explain why, at the 762 species level, detritivores and predators were more sen-763 sitive to resources, habitat, and microclimate conditions 764 than to tree species diversity and functional type (Fig. 765 S4; Kaspari 2001). 766

The differences in response patterns highlighted by 767 the use of different levels of taxonomic resolution also 768 illustrate some important methodological issues. Indeed, 769 approaches at low taxonomic resolution are often favored 770 in studies of soil macrofauna, especially because they 771 allow to bypass the taxonomic impediment that exists for 772 many groups of soil invertebrates (Decaëns et al. 2010). 773 The use of broad taxonomic levels makes it possible 774 to consider the whole macrofauna community without 775 reducing datasets to the best-known groups for which 776 species-level identifications are possible. Taxa of higher 777 rank also have wider geographic distributions, making 778 comparisons easier between geographically distant sites. 779 In our case, where sites harbor contrasting macrofauna 780 species pools, the multiple pedoclimatic changes along 781 latitude may be the major drivers of soil communities (De 782 Wandeler et al. 2018). This is supported by the fact that 783 the proportion of variance explained by random effects is 784 larger when using species than when using broad group 785 as fundamental taxonomic units (Table S5), as well as the 786 small effect of the included predictor variables on detriti-787 vore and predator assemblage composition in the dbRDA 788 analysis (Table S4, Fig. S4). Finally, datasets constructed 789 at coarse levels of taxonomic resolution also by definition 790 have fewer zeros than those constructed at species level, 791 thus increasing the robustness and statistical power of 792 analyses (Harrison et al. 2018). However, a corollary of 793 this is that they are also potentially less efficient at detect-794 ing subtle community responses to ecological gradients 795 since the distributions of higher rank taxa along these 796 gradients are wider than those of the species that consti-797 tute them (Kaspari 2001). This stresses the importance of 798 investigating community responses at different levels of 799 taxonomic resolution. 800

# Conclusion

Our study highlights the complexity of the direct and indi-802 rect mechanisms underlying the relationships between 803 tree species richness and composition and macrofauna 804 communities. Mixed forest stands supported richer, more 805 diverse and even macrofauna communities, at a broad 806 level of taxonomic resolution. Compared to mixed stands, 807 pure deciduous stands favored Lumbricidae and other 808 macrodetritivore groups, while evergreen forests were 809 dominated by predator taxa. Combined, these two results 810 suggest that mixed forest stands offer resource, microhabi-811 tat, microclimate, and soil conditions suitable for a wide 812 range of organisms of contrasting lifestyles. Future stud-813 ies should incorporate if possible quantitative description 814 of changes in litter or fine root trait diversity and habi-815 tat heterogeneity, as they can be of importance for soil 816 macrofauna. Macrofauna response to tree species richness 817 and functional type was detectable almost only at a coarse 818 level of taxonomic resolution, while macrofauna species 819 rather responded to microenvironmental variables. This 820 highlights the importance of combining different levels 821 of taxonomic resolution to elucidate in a comprehensive 822 way the complex tree-macrofauna relationships in forest 823 ecosystems. 824

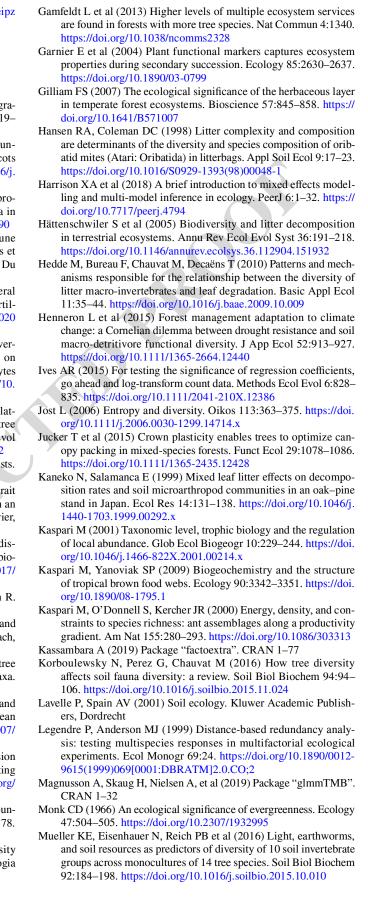
