# Numerical simulation of rigid particles in Stokes flow: lubrication correction for any (regular) shape of particles*

#### Abstract

We address the problem of numerical simulation of suspensions of rigid particles in a Stokes flow. We focus on the inclusion of the singular short range interaction effects (lubrication effects) in the simulations when the particles come close one to another. The problem is solved without introducing new hypothesis nor model. As in [11, the key idea is to decompose the velocity and pressure flows in a sum of a singular and a regular part. In this article, the singular part is computed using an explicit asymptotic expansion of the solution when the distance goes to zero. This expansion is similar to the asymptotic expansion proposed in [6] but is more appropriate for numerical simulations of suspensions. It can be computed for any shape of particles. Using [6] as an intermediate result, we prove that the remaining part is regular in the sense that it is bounded independently of the distance. As a consequence, only a small number of degrees of freedom are necessary to obtain accurate results. The method is tested in dimension 2 for clusters of two or three aligned particles with general rigid velocities. We show that, as expected, the convergence is independent on the distance.

## 1 Introduction

We consider in this article suspensions of rigid particles in a Stokes flow. Various domains of application can be modeled and studied using such systems: concretes or reinforced plastics in industry, silting up in natural environment, micro-swimmers or blood tests in biology, wastewater treatment in ecology...

The applications we have in mind are for example migration in couette flows, dynamics of aggregates, or the study of the interphase stress contribution to the total stress. Unfortunately, the behavior of such systems is still partially misunderstood and precise numerical simulations are needed to understand the mechanisms behind their rheological behavior as well as their origin. A large amount of research has been developed to design numerical tools in order to study the motion of rigid bodies embedded in a Stokes flow. One can see for example [13] for a finite-element method, [1, 16] for multipole decomposition methods, [4] for finite-difference methods or [7, 8] for lattice Boltzmann simulations in case of a Navier-Stokes fluid.

In view of the previously cited applications, we have to consider dense systems for which the particles are close to the maximal packing and therefore close to contact. It consists in a challenging domain in which very few results are available. From a computational point of view, we have to consider suspensions with densities from $30 \%$ to $50 \%$, involving several thousands of particles. It is well known, that, for such physical studies, one need to compute precisely the velocity and pressure fields in the fluid domain. In particular, one need to take into account carefully close interactions between particles (such as lubrication or contact) and their feedback on the flow. The objective of this paper is to propose a method allowing to compute a precise approximation of the velocity and pressure fields using coarse meshes, even for small distances between the particles. Moreover, we design a method allowing to deal with non-spherical particles.

Equations of the problem.
We consider $\Omega=\mathbb{R}^{3}$ and denote by $\left(B_{i}\right)_{i=1, \ldots, N} N$ rigid particles in $\Omega$. We assume that the fluid domain $\mathcal{F}=\Omega \backslash \cup B_{i}$ is filled with a Newtonian fluid governed by the Stokes equations.

[^0]We consider in the following the corresponding Dirichlet problem. We suppose that the velocity on the boundary of each particle is given: the velocity of particle $i$ is denoted by $\mathbf{u}_{i}^{\star} \in H^{1 / 2}\left(\partial B_{i}\right)$ and is supposed to satisfy the incompressibility condition

Note that this condition is fulfilled if particle $i$ undergoes a rigid motion: $\mathbf{u}_{i}^{\star}=\mathbf{V}_{i}+\boldsymbol{w}_{i} \wedge\left(\mathbf{x}-\mathbf{x}_{i}\right)$.
The problem is written as follows,

where $L_{0}^{2}(\mathcal{F})=\left\{\mathrm{q} \in L^{2}(\mathcal{F}): \int_{\mathcal{F}} \mathrm{q}=0\right\}$.
Since we suppose that $\Omega=\mathbb{R}^{3}$, we add the following vanishing condition at infinity

This, together with assumption (1) on $\mathbf{u}_{i}^{\star}$, ensures that system (2) admits a unique solution. We denote by $\operatorname{St}\left(\mathbf{u}_{1}^{\star}, \ldots, \mathbf{u}_{N}^{\star}\right)$ this solution.
A singular problem due to the lubrication effect.
The main difficulty to solve problem (2) in case of dense suspensions is to be able to deal with the so called lubrication effect: when two particles get close one to another, their relative velocities, together with the incompressibility constraint, induce large variations in the velocity fields and high values for the pressure field, located in the thin gap between the two particles. For example, the density of the pressure is concentrated in a gap with radius of order the square root of the distance and its maximum increases with the distance. We provide on Figure 1 an example of velocity and pressure fields for two particles moving towards each other (the detail of the corresponding configuration will be given in Subsection 3.2.1.


Figure 1: Reference flow for two particles with opposite velocities along the horizontal direction.
This behavior is said to be singular in the sense that the norm of the solutions are not bounded when the distance goes to zero. As a consequence, for a given number of degrees of freedom, the error when computing a numerical solution to the problem is increasing when the distance between the particles goes to zero. It is clear that, to properly capture the relevant phenomenon in numerical simulations, one will need to use a high number of degrees of freedom (for example, very fine meshes in the gap if using volume discretization methods). This is very expensive for 3 -dimensional dense suspensions (both for CPU time and memory reasons). However, in such situation, most of the particles are close and the effect of lubrication dominates the global behavior of the system. The challenge is then to find a suitable numerical strategy that takes into account the lubrication effects, without increasing the size of the mesh.

A singular/regular decomposition of the forces.
Suppose you want to compute the forces $\left(F_{i}\right)_{i=1 \ldots N}$ exerted on the particles:

for example to compute the resistance matrix (linking the velocities to the forces) associated to the problem.
A widely used strategy has been proposed in [3] in the context of Stokesian Dynamics simulations. The Stokesian Dynamics method is based on the computation of the resistance matrix at each time step. The authors propose a method to compute accurately the forces exerted on the particles, in order to be able to compute a precise resistance matrix, taking lubrication into account.

The founding remark is the following: if two particles are embedded in an infinite fluid, have the same radius and have opposite velocities with unit norm, the forces exerted on these particles only depend on the distance: $d \mapsto F_{i}^{2 s p h}(d)$. Since they only depend on a unique parameter, they can be easily estimated using both an asymptotic development when the distance goes to zero (see e.g. [2]) and a mean square approach for larger distances (very precise computations are achieved off-line for a discrete set of distances to construct an approximation for any value of the distance).

Now, consider a general configuration of $N$ particles. The singular part of the force $F_{i}^{\text {sing }}$ acting particle $i$ is estimated as the sum of the contributions of each pair of close particles including particle $i$, each of these contributions being estimated using the previous off-line computations. The singular part of the forces being estimated, one then has to compute the remainder of the force $F_{i}^{\text {reg }}$, due to multi-particle interactions, to the physical boundaries of the domain, etc... This regular part can be approximated using coarse meshes. We refer to [3] for more details. Finally, the method can be rewritten as computing

F_{i}=F_{i}^{\text {sing }}+F_{i}^{\mathrm{reg}}
$$

where $F_{i}^{\text {sing }}$ is computed precisely from off-line tabulations and $F_{i}^{\text {reg }}$ is computed on-line, using a small number of degrees of freedom. This method has been used more recently to include lubrication in the computation of the resistance matrix using direct solvers 4 .

This method allows to take lubrication into account when computing the forces exerted on the particles. It converges when the number of degrees of freedom used to compute the regular part of the force increases. However, due to the off-line tabulation, it is restricted to spherical mono-disperse particles. Indeed, for polydisperse spherical particles, computing the singular solution would necessitate an interpolation depending on 2 parameters: the distance and the ratio of the two radii. Concerning non-spherical particles, the singular part depends on the distance, the geometry of the particles in the gap and the orientation of the particles... Such tabulations have never been achieved because too costly...

Another kind of correction of the forces has been proposed more recently in 9], where an explicit asymptotic development of the local distribution of the force on the boundary of the particles has been used. This allows to free the authors from the tabulation step so that they can deal with non-spherical particles. However, the lubrication correction is added to the force computed by the direct numerical solver and therefore, when the mesh step goes to zero, numerical parameter tuning is necessary to avoid computing twice the force.

Note also that, although these methods compute precisely the total force exerted on the particles, they do not correct the velocity and pressure flows.

A new singular/regular decomposition of the flow.
The key point to take lubrication into account on the whole flow is to decompose the velocity and pressure fields into a regular and a singular part: $\mathbf{u}=\mathbf{u}^{\text {reg }}+\mathbf{u}^{\text {sing }}$ and $p=p^{\text {reg }}+p^{\text {sing }}$. Using the linearity of Stokes problem and assuming that the singular field is known, it remains to approximate the solution to the following regular problem:

The aim is to construct a suitable singular field $\mathbf{u}^{\text {sing }}$ such that:

- $\mathbf{u}^{\text {sing }}$ is known analytically ;
- the corresponding $\mathbf{u}^{\text {reg }}$ is bounded regardless of the distance, that is there exists $C>0$ independent of $d$ such that

$$
\left\|\mathbf{u}^{\mathrm{reg}}\right\|:=\left(\int_{\mathcal{F}}\left|\nabla \mathbf{u}^{\mathrm{reg}}\right|^{2}\right)^{\frac{1}{2}} \leq C
$$

Doing so, the right-hand side of (4) can be computed precisely and its solution can be approximated using a small number of degrees of freedom. A first method to compute such a singular field was proposed in [11]. The authors followed the idea proposed for the Stokesian Dynamics: they considered the singular solution $\left(\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right)$ to the Stokes problem for two spherical particles with the same radius and having opposite velocities with unit norm. This solution only depends on the distance between the particles $d \mapsto\left(\mathbf{u}^{\text {sing }}(d), \mathrm{p}^{\text {sing }}(d)\right)$. They interpolate off-line the coefficients of the solution on a suitable basis. The remaining regular part of the solution is then approximated using a small number of degrees of freedom. Doing so, the global flow $\mathbf{u}=\mathbf{u}^{\text {sing }}+\mathbf{u}^{\text {reg }}$ is computed precisely, including lubrication effects, even for low numbers of degrees of freedom. However, the method is strongly dependent on the tabulation of the singular field which can be achieved only if it depends on a single parameter. This reduces the use of the method to mono-disperse spherical suspensions.

A way to avoid off-line interpolation would be to derive an explicit analytical expression for the singular field. One could think to use the exact expressions of the field solution to the problem with the two particles approaching one to another. Such expressions do not exist for any kind of particles but are available for pairs of spheres (see e.g. [12] for two equal spheres or more recently the preprint [5] for two unequal spheres). They are expressed as infinite series which have to be truncated to be used in a numerical code. Unfortunately, for a given precision, the order of truncation increases when the distance between the particles goes to zero. This implies parameter tuning to choose the order of truncation and makes such a method potentially costly for suspensions involving many pairs of close particles.

To obtain a method numerically tractable, one can recall that, since ( $\mathbf{u}^{\text {reg }}, \mathrm{p}^{\mathrm{reg}}$ ) is solution to the Stokes problem (4) with ( $\left.\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right)$ in the right-hand side, it is sufficient to find $\left(\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right)$ for which the following quantities are bounded in $H^{-1}$ when the distance goes to zero:

As a consequence, there is no need to derive the expression of an exact singular flow in the whole domain for any distance: it is sufficient to use an asymptotic expression when the distance goes to zero.

A first step towards such a choice for the singular field was proposed in [10]. In that article, the singular field is based on an explicit asymptotic expansion of the flow $\left(\mathbf{u}_{\mathrm{in}}, \mathrm{q}_{\mathrm{in}}\right)$ in the gap between the particles. The expansion is simply truncated to be used as the singular field. Doing so, the author shows that, using a finiteelement discretization for the regular problem, she obtain a good approximation of the whole flow in case of two spherical particles. However, the numerical results still depend on the distance.

In the present article, we propose a new explicit expression for the singular field which is based on the same asymptotic flow $\left(\mathbf{u}_{\mathrm{in}}, \mathrm{q}_{\mathrm{in}}\right)$. Our asymptotic field is similar to the one proposed in [6]. The field proposed in that article is not tractable from a numerical point of view. Here, we use estimations proved in [6 as an intermediate result to show that our remaining regular field is bounded independently on the distance. Doing so, we obtain numerical results for which the error is independent of the distance which allows to use coarse meshes, independently on the size of the gap. Moreover, tests for non-spherical particles are achieved, showing that the method can be extended to general suspensions.

Note that a decomposition of the solution has also been proposed in [14] in the context of boundary integral equations: the force density is decomposed in a singular and a regular part. The method proposed needs parameter tuning to make it converge when the number of degrees of freedom increases. Here, we propose a decomposition of the velocity and pressure fields so that the method is adapted to volumic numerical solvers (finite element, finite differences...). Moreover, no parameter tuning is necessary to make the method converge.
Outline of the paper.
The outline of the article is the following: after this introduction, the second section is dedicated to the case of two single particles. We explain how we construct the singular field ( $\left.\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right)$ and how the results of [6] are used to bound the remaining regular field. Numerical simulations are presented in Section 3 to validate the method. In Section 4, we investigate the case of three aligned particles, to show how the method can be extended to more than one singularity. To finish, we discuss in Section 5 the extension to more general suspensions.

## 2 The two particles case

We consider here the two particles case. Using the linearity of Stokes problem, one can decompose the boundary condition and write

As a consequence, it is sufficient to solve accurately the problem involving an obstacle and a moving particle, which is the case treated in [6]. Following this reference, let us rewrite this elementary problem and precise the notations.

We denote by $B$ the obstacle and $B^{\star}$ the moving particle with velocity $\mathbf{u}^{\star}$.


Figure 2: The two particles case
The problem is the following

Without loss of generality we define the origin of coordinates as the unique point of $\partial B^{\star}$ that achieves the distance $d$ between $\partial B$ and $\partial B^{\star}$ (see Figure 2). Let $\mathbf{e}_{\perp}$ be the unit normal outward to $\partial B^{\star}$ at the origin and we assume that $\mathbf{e}_{\perp}=\mathbf{e}_{z}$. All along the paper we will use the notation $/ /$ and $\perp$ to distinguish the normal and the tangent components:

- for any vector field $\mathbf{v} \in \mathbb{R}^{3}$ we define its normal and tangent components as follows,

\mathbf{v}=\mathbf{v}_{/ /}+v_{\perp} \mathbf{e}_{\perp}, \text { where } v_{\perp}=\mathbf{v} \cdot \mathbf{e}_{\perp} \in \mathbb{R}
$$

- we note $\nabla_{/ /}$(respectively div//) the parallel component (that is the component corresponding to $\mathbf{e}_{x}$ and $\mathbf{e}_{y}$ ) of operator $\nabla$ (respectively div) and $\nabla_{\perp}$ its normal component.

We also suppose there exists a parametrization of the boundaries $\partial B$ and $\partial B^{\star}$ close to the origin: there exist $L>0$ and smooth functions $\gamma_{b}$ and $\gamma_{t}$ on $B(\mathbf{0}, L)$ such that for any $(x, y) \in B(\mathbf{0}, L)$,

- if $z=\gamma_{b}(x, y)$ then $(x, y, z) \in \partial B^{\star}$;
- if $z=d+\gamma_{t}(x, y)$ then $(x, y, z) \in \partial B$.

Classically, we suppose that there is a "single non-degenerate contact" in $B(\mathbf{0}, L)$, that is there exists a unique contact point in $B(\mathbf{0}, L) \times \mathbb{R}$ when the distance $d$ goes to 0 (we refer the reader to [6] for the corresponding assumptions on the functions $\gamma_{t}$ and $\gamma_{b}$ ).

Finally, the gap between the particles is denoted by $\mathcal{G}_{L}$ :

### 2.1 Explicit expression for the singular field

The expressions of the singular field we use are based on an asymptotic expansion of the flow when the distance goes to zero. Formal computations can be found in [2] where the author estimates the forces exerted on two particles almost in contact and undergoing a rigid motion. One can extend the corresponding computations to obtain a formal development of the flow in the narrow gap between the particles. These computations have been rigorously derived and generalized to any boundary condition on the particles in [6]. In this section, we explain how we use these results to obtain an expression for the singular field that is tractable for numerical simulations of multi-particle suspensions.

### 2.1.1 A local asymptotic development of the flow

Following [2, 6], we provide here an explicit expression for the singular field in the gap $\mathcal{G}_{L}$ between the particles.

- Step 1. Singular part of the boundary condition. Using the linearity of Stokes equations, the first step is to decompose the boundary condition $\mathbf{u}^{\star}$ (rigid or not) into a sum of two boundary conditions. The first part, denoted by $\mathbf{u}_{\mathrm{as}}^{\star}$, is supposed to be the singular one, leading to singular behaviors of the flow when the distance goes to zero. It has to include the whole singularities of the boundary condition in the sense that the remaining part has to generate flows with a bounded norm when the distance goes to zero. By [2, 6] the singular part can be chosen as

- Step 2. Local singular pressure field. Denoting the distance between the boundaries of the particles by

the asymptotic pressure field $\mathrm{q}_{\mathrm{in}}$ does not depend on $z$ and is defined in $B(\mathbf{0}, L)$ as the solution to the following 2-dimensional problem:

- Step 3. Local singular velocity field. From the 2-dimensional scalar field $\mathrm{q}_{\mathrm{in}}$ defined in $B(\mathbf{0}, L)$, the corresponding asymptotic velocity field is

where, for any 2-dimensional scalar field q defined in $B(\mathbf{0}, L)$ the 3 -dimensional vector field $\mathbf{w}[\mathrm{q}]$ is given in $\mathcal{G}_{L}$ by

w[\mathrm{q}]_{\perp}(\cdot, z)= & \frac{1}{2} \operatorname{div}_{/ /}\left[\int_{z}^{d+\gamma_{t}}\left(\left(s-\left(d+\gamma_{t}\right)\right)\left(s-\gamma_{b}\right) \nabla \mathrm{q} d s\right]\right.  \tag{10b}\\
& +\int_{z}^{d+\gamma_{t}} \operatorname{div}_{z}\left[\frac{d+\gamma_{t}-s}{\gamma} \mathbf{u}_{\mathrm{as}, / /}^{\star}(\cdot, z) \chi_{L}\right] d s .
\end{align*}
$$

Note that these formula provide a divergence free velocity field.

### 2.1.2 Truncation and singular field choice

From this local asymptotic field $\left(\mathbf{u}_{\text {in }}, \mathrm{q}_{\text {in }}\right)$ in $\mathcal{G}_{L}$, we now want to define the singular field ( $\left.\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right) \in$ $H^{1}(\mathcal{F}) \times L_{0}^{2}(\mathcal{F})$ in the whole fluid domain $\mathcal{F}$. To make it tractable for numerical simulations of multi-particle suspensions, we need that the velocity field vanishes far from the gap $\mathcal{G}_{L}$. Indeed, the boundary condition for $\mathbf{u}^{\text {reg }}$ in (4) depends on $\mathbf{u}^{\text {sing }}$ and computing the value of the singularity generated by a pair of particles on the boundary of all the other particles in the suspension would be too costly. Also, if we manage to design a
singular field vanishing outside the gaps, the computation of the right-hand side of (4) in $\mathcal{F}$ would be quicker and could even be parallelized.

To construct a singular field meeting these requirements, we define a regular truncation function $\chi_{L}$ which does not depend on $z$, is equal to 1 in $B(\mathbf{0}, L / 2)$ and vanishes outside $B(\mathbf{0}, L)$.

- The singular pressure field in $\mathcal{G}_{L}$. The singular pressure field is simply chosen as the truncation of the local singular field $\mathrm{q}_{\mathrm{in}}$ :

$$
\begin{equation*}
\mathrm{p}^{\operatorname{sing}}(x, y, z)=\mathrm{p}^{\operatorname{sing}}(x, y)=\mathrm{q}_{\mathrm{in}}(x, y) \chi_{L}(x, y), \quad \forall(x, y, z) \in \mathcal{G}_{L} \tag{11}
\end{equation*}
$$

Note that since the pressure field $\mathrm{p}^{\text {sing }}$ does not depend on $z$, one has $\nabla_{\perp} \mathrm{p}^{\text {sing }}=0$.

- The singular velocity field in $\mathcal{G}_{L}$. In order to choose the singular velocity field, one has to recall that, to bound ( $\mathbf{u}^{\text {reg }}, \mathrm{p}^{\mathrm{reg}}$ ) independently of the distance, we need to bound $\Delta \mathbf{u}^{\text {sing }}-\nabla \mathrm{p}^{\text {sing }}$ in $H^{-1}$ (see (5)). Following expression (9) for the local singular velocity field from the local pressure field, we try to compute a singular velocity field with the following form: $\mathbf{u}^{\text {sing }}=\mathbf{w}[q]$ for a given $q$ to be chosen. In that case, the orthogonal component of the first term to be bounded in (5) rewrites:

$$
\begin{equation*}
\Delta w[\mathrm{q}]_{\perp}-\nabla_{\perp} \mathrm{p}^{\text {sing }}=\Delta w[\mathrm{q}]_{\perp} \tag{12}
\end{equation*}
$$

and its parallel component, using equation 10a):

$$
\begin{align*}
\Delta \mathbf{w}[\mathrm{q}] / /-\nabla_{/ /} \mathrm{p}^{\text {sing }} & =\Delta_{/ / \mathbf{w}[\mathrm{q}] / / /}+\partial_{z z}^{2} \mathbf{w}[\mathrm{q}]_{/ /}-\nabla_{/ / \mathrm{p}^{\text {sing }}} \\
& =\Delta_{/ / \mathbf{w}[\mathrm{q}] / / /}+\nabla_{/ /} \mathrm{q}-\nabla_{/ /} \mathrm{p}^{\text {sing }} . \tag{13}
\end{align*}
$$

From these computations, we see that, to cancel the gradient of the singular pressure field in the right-hand side (which is the most singular remaining term), one should choose the tangential part of the singular velocity field consistently with $\mathrm{p}^{\text {sing }}: \mathbf{u}_{/ /}^{\text {sing }}=\mathbf{w}\left[\mathrm{p}^{\text {sing }}\right]_{/ /}$. Concerning $u_{\perp}^{\text {sing }}$, to avoid the computation of to many derivatives of $\chi_{L}$, we simply consider the truncation of $\mathbf{w}\left[q_{i n}\right] / /$. To sum up, our choice for the singular field in $\mathcal{G}_{L}$ is:

$$
\begin{array}{ll}
\mathbf{u}_{/ /}^{\operatorname{sing}}(x, y, z)=\mathbf{w}\left[\mathrm{p}^{\operatorname{sing}}\right]_{/ /}(x, y, z), & \forall(x, y, z) \in \mathcal{G}_{L} \\
u_{\perp}^{\operatorname{sing}}(x, y, z)=w\left[\mathrm{q}_{i n}\right]_{\perp}(x, y, z) \chi_{L}(x, y), & \forall(x, y, z) \in \mathcal{G}_{L} \tag{14b}
\end{array}
$$

- Extension to $\mathcal{F}$. The velocity and pressure fields are naturally extended to $\mathcal{F}$ by zero.

We plot on Figure 3 the singular field corresponding to the reference situation with two particles moving with opposite velocities, for which the solution is plotted on Figure 1.


Figure 3: Singular flow for two particles with opposite velocities along the horizontal direction.
From this, we can plot on Figure 4 the corresponding regular field $\left(\mathbf{u}^{\text {reg }}, \mathrm{p}^{\text {reg }}\right)=(\mathbf{u}, \mathrm{p})-\left(\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right)$.
We observe that, within the gap, the velocity flow is almost constant and the maximum of pressure flow is much smaller than for the reference solution. This suggests that it will be much more easy to compute

numerically this regular field, with not too many degrees of freedom. Using asymptotic results from 6] (recalled in Subsection 2.2, we will prove in Subsection 2.3 that this regular flow is indeed bounded independently of the size of the gap. This will allow to obtain convergence results independent on the distance in the numerical tests presented Section 2.3 .

Remark 2.1 Note that contrary to the field $\mathbf{u}_{\mathrm{in}}=\mathbf{w}\left[q_{\mathrm{in}}\right]$ defined in 10 , the velocity field $\mathbf{u}^{\text {sing }}$ is no longer divergence free.

REmARK 2.2 The resulting velocity field $\mathbf{u}^{\text {sing }} \in \mathcal{C}^{\infty}(\overline{\mathcal{F}})$ has support in $\mathcal{G}_{L}$. It vanishes on the boundary of the obstacle and $\mathbf{u}^{\text {sing }}=\mathbf{u}^{\star}$ on $\partial B^{\star} \cap \mathcal{G}_{L / 2}$. Note that $\mathbf{u}^{\text {sing }}$ does not satisfy the boundary condition on the whole boundary $\partial B^{\star}$ of the moving particle.

REMARK 2.3 A straightforward choice for the singular velocity field could have been, as for the pressure, to truncate $\mathbf{u}_{\mathrm{in}}$ and use $\mathbf{u}_{\mathrm{in}}=\mathbf{w}\left[q_{\mathrm{in}}\right] \chi_{L}$ in $\mathcal{G}_{L}$, extended by zero in $\mathcal{F}$. This choice is of course different from the actual one since $\mathbf{w}\left[p^{\text {sing }}\right]_{/ /}=\mathbf{w}\left[q_{\mathrm{in}} \chi_{L}\right]_{/ /} \neq \mathbf{w}\left[q_{\mathrm{in}}\right]_{/ /} \chi_{L}$ and unfortunately, it does not make the gradient of the singular pressure cancel in (5). As a consequence, the corresponding regular field ( $\mathbf{u}^{\mathrm{reg}}, p^{\mathrm{reg}}$ ) is not bounded independently on the distance. The corresponding numerical error based on the computation of the remaining field ( $\left.\mathbf{u}^{\mathrm{reg}}, p^{\mathrm{reg}}\right)$ provides better results than when computing directly $(\mathbf{u}, p)$. The error is less dependent on the distance but still, it is increasing when the distance decreases (see [10]).

### 2.2 Asymptotic results from [6]

We recall here the expression of the asymptotic field proposed in [6] and the estimations provided in the article. Indeed, this asymptotic field will be used in the next section as an intermediate field in the computations in order to estimate $\mathbf{u}^{\text {reg }}$. In [6], the asymptotic field is also based on $q_{i n}$ defined in (8) and the choice for the singular pressure field is the same as the one proposed in the previous section and given by (11). The difference relies in the choice for the singular velocity field.

- The singular velocity field in $\mathcal{G}_{L}$. The authors choose to use the singular pressure field $\mathrm{p}^{\text {sing }}$ both for the tangential and normal part of the velocity field in $\mathcal{G}_{L}$ :

$$
\begin{equation*}
\mathbf{v}_{\mathrm{in}}=\mathbf{w}\left[\mathrm{p}^{\operatorname{sing} \mathrm{g}}\right], \quad \text { in } \mathcal{G}_{L} . \tag{15}
\end{equation*}
$$

Note that here, since the same pressure field is used for the parallel and orthogonal terms, the resulting velocity field is divergence free.

- Extension to $\mathcal{F}$. Then, as in the previous section the velocity field $\mathbf{v}_{\text {in }}$ is extended by zero on the whole domain $\mathcal{F}$. Note that, as for $\mathbf{u}^{\text {sing }}$ (see remark 2.2 , $\mathbf{v}_{\text {in }}$ does not match the boundary condition $\mathbf{u}^{\star}$ on the moving particle: we have

$$
\begin{equation*}
\mathbf{v}_{\text {in }}=0 \text { on } \partial B \quad \text { and } \quad \mathbf{v}_{\text {in }}=\mathbf{u}^{\star} \text { on } \partial B^{\star} \cap \partial \mathcal{G}_{L / 2} . \tag{16}
\end{equation*}
$$

- Modification of the velocity field oustide $\mathcal{G}_{L / 4}$ to match the boundary condition. This velocity field is then modified outside $\mathcal{G}_{L / 4}$ : it is written as

$$
\mathbf{v}_{\mathrm{as}}=\mathbf{v}_{\mathrm{in}}+\mathbf{v}_{\mathrm{ext}}
$$

where $\mathbf{v}_{\text {ext }}$ vanishes in $\mathcal{G}_{L / 4}$ and is designed to obtain a velocity field $\mathbf{v}_{\text {as }}$ on $\mathcal{F}$ which is divergence free and satisfies the same boundary conditions as $\mathbf{u}$. This correction $\mathbf{v}_{\text {ext }}$ has to be bounded independently of the distance. Here is how it is constructed:

- The authors first define an outer domain $\Omega^{\star}$ independent on $d$ (see Figure 5) such that:
* $\Omega^{\star}$ is a smooth subdomain of $\mathcal{F} \backslash \mathcal{G}_{L / 4}$ independent of $d$;
* $\Omega^{\star} \subset \mathcal{F}$ for any $d \in(0,1]$;
* $\partial \Omega^{\star}$ contains the part of the boundary of $\partial B^{\star}$ on which $\mathbf{v}_{\text {in }} \neq \mathbf{u}^{\star}$, that is $\partial B^{\star} \backslash \partial \mathcal{G}_{L / 2} \subset \partial \Omega^{\star}$.


Figure 5: Definition of $\Omega^{\star}$

- In order to match the boundary condition on $\partial B^{\star}$, the authors define $\mathbf{v}_{\text {ext }}$ as the solution to the following Stokes problem in $\Omega^{\star}$,

$$
\left\{\begin{align*}
& \text { Find }\left(\mathbf{v}_{\mathrm{ext}}, \mathrm{q}_{\mathrm{ext}}\right) \in H^{1}\left(\Omega^{\star}\right) \times L_{0}^{2}\left(\Omega^{\star}\right) \text { such that }  \tag{17}\\
&-\Delta \mathbf{v}_{\mathrm{ext}}+\nabla \mathrm{q}_{\mathrm{ext}}=0, \text { in } \Omega^{\star} ; \\
& \operatorname{div} \mathbf{v}_{\mathrm{ext}}=0, \text { in } \Omega^{\star} ; \\
& \mathbf{v}_{\mathrm{ext}}=\mathbf{v}_{\mathrm{ext}}^{\star}, \text { on } \partial \Omega^{\star} ;
\end{align*}\right.
$$

with the correcting boundary condition

$$
\mathbf{v}_{\text {ext }}^{\star}=\mathbf{u}^{\star}-\left.\mathbf{v}_{\text {in }}\right|_{\partial B^{\star}} \in \mathcal{C}^{\infty}\left(\partial B^{\star}\right),
$$

which is extended by zero to $\partial \Omega^{\star}$. The solution $\mathbf{v}_{\text {ext }}$ is then also extended by zero to the whole domain $\mathcal{F}$.

Let us now recall three estimations proved in [6] that will be useful to estimate $\mathbf{u}^{\text {reg }}$.
First, the authors provide the following estimation for the inner field [6, proof of lemma 20]: there exists $C>0$ independent of $d$ such that,

$$
\begin{equation*}
\int_{\mathcal{G}_{L}}\left(\mid \nabla_{\left./ /\left.\mathbf{v}_{\mathrm{in}, / / /}\right|^{2}+\left|\nabla v_{\mathrm{in}, \perp}\right|^{2}\right) \leq C\left(\left|u_{\perp}^{\star}(\mathbf{0})\right|^{2}|\ln (d)|+\left\|\mathbf{u}^{\star}\right\|_{H^{3}(B(\mathbf{0}, L))}^{2}\right) . . . . . . .}\right. \tag{18}
\end{equation*}
$$

Note that, this estimation is useful to bound in $\mathcal{G}_{L}$ the right-hand side of the Stokes problem solved by their regular field (see (15) together with 12 ) and $\sqrt{13}$ ).

The authors also provide the following estimation for the external field [6, Lemma 18]: there exists $C>0$ independent of $d$ such that,

$$
\begin{equation*}
\left\|\mathbf{v}_{\mathrm{ext}}\right\| \leq C\left(\left\|\mathbf{u}^{\star}\right\|_{H^{2}(B(\mathbf{0}, L))}+\left\|\mathbf{u}^{\star}\right\|_{H^{\frac{1}{2}\left(\partial B^{\star}\right)}}\right) . \tag{19}
\end{equation*}
$$

Finally, it is proved in [6, Lemma 4] that the field $\mathbf{v}_{\text {as }}$ is a good approximation of $\mathbf{u}$ when the distance goes to zero: there exists $C>0$ independent of $d$, but depending on $\gamma_{b}, \gamma_{t}, \partial B^{\star}$ and $\mathbf{u}^{\star}$, such that

$$
\begin{equation*}
\left\|\mathbf{u}-\mathbf{v}_{\mathrm{as}}\right\| \leq C\left(1+\left|u_{\perp}^{\star}(\mathbf{0}) \| \ln (d)\right|^{\frac{1}{2}}\right) . \tag{20}
\end{equation*}
$$

Moreover, if the function $\gamma$ is radial one has,

$$
\left\|\mathbf{u}-\mathbf{v}_{\mathrm{as}}\right\| \leq C
$$

Remark 2.4 Let us again emphasize the differences between the singular field $\mathbf{u}^{\text {sing }}$ used in this paper and the asymptotic expansion $\mathbf{v}_{\mathrm{as}}=\mathbf{v}_{\mathrm{in}}+\mathbf{v}_{\mathrm{ext}}$ defined in [6].

- The field $\mathbf{u}^{\text {sing }}$, as well as $\mathbf{v}_{\mathrm{in}}$, are designed to represent the singularity in the gap between the particles. They both vanish outside $\mathcal{G}_{L}$, their tangential components are equal while their normal components are different:

$$
\mathbf{u}_{/ /}^{\text {sing }}=\mathbf{w}\left[p^{\text {sing }}\right]_{/ /}=\mathbf{v}_{\text {in }, / /} \quad \text { while } \quad u_{\perp}^{\text {sing }}=w\left[q_{\mathrm{in}}\right]_{\perp} \neq w\left[p^{\text {sing }}\right]_{\perp}=v_{\mathrm{in}, \perp} .
$$

- In [6] the inner velocity is corrected and the authors finally consider the asymptotic field $\mathbf{v}_{\mathrm{as}}=\mathbf{v}_{\mathrm{in}}+\mathbf{v}_{\mathrm{ext}}$ which fits the boundary condition on the moving particle but does not vanish anymore outside $\mathcal{G}_{L}$. In this paper we use $\mathbf{u}^{\text {sing }}$ as singular velocity field, without any modification: it does not fit the boundary condition on the moving particle but vanishes outside $\mathcal{G}_{L}$ (see again the singular field plot on Figure 3 for example).

REMARK 2.5 The field $\mathbf{v}_{\mathrm{as}}$ does not vanish outside the gap. As a consequence, to use it in numerical simulations of suspensions, one would have to numerically compute $\mathbf{v}_{\mathrm{ext}}$ and then to compute the right-hand side of the regular problem (4) everywhere in $\mathcal{F}$ and on the boundaries of each particles. This prevents using this asymptotic field for general suspensions involving many couples of close particles. One could think of using $\mathbf{v}_{\mathrm{in}}$ as the singular field since it vanishes outside $\mathcal{G}_{L}$. However, its normal component $v_{\mathrm{in}, \perp}$ involves many derivatives of the truncation function, which increases the number of computations and induces (controlled) oscillations in the singular flow.

### 2.3 Estimation for $\mathbf{u}^{\text {reg }}$

The regular field $\mathbf{u}^{\text {reg }}$ is defined as $\mathbf{u}^{\text {reg }}=\mathbf{u}-\mathbf{u}^{\text {sing }}$. Since $\mathbf{v}_{\text {as }}=\mathbf{v}_{\text {in }}+\mathbf{v}_{\text {ext }}$ and $\mathbf{u}_{/ /}^{\text {sing }}=\mathbf{v}_{\text {in }, / /}$, we obtain

$$
\begin{align*}
\left\|\mathbf{u}^{\mathrm{reg}}\right\|=\left\|\mathbf{u}-\mathbf{u}^{\mathrm{sing}}\right\| & \leq\left\|\mathbf{u}-\mathbf{v}_{\mathrm{as}}\right\|+\left\|\mathbf{v}_{\mathrm{ext}}\right\|+\left\|\mathbf{v}_{\mathrm{in}}-\mathbf{u}^{\text {sing }}\right\|  \tag{21}\\
& \leq\left\|\mathbf{u}-\mathbf{v}_{\mathrm{as}}\right\|+\left\|\mathbf{v}_{\mathrm{ext}}\right\|+\left\|v_{\mathrm{in}, \perp}\right\|+\left\|u_{\perp}^{\operatorname{sing}}\right\| .
\end{align*}
$$

The first three terms on the right-hand side are bounded from [6] (see equations (18), (19) and (20)). It remains to bound the last term. To do so, $\chi_{L}$ being regular, we know that there exists $C_{L}>0$ such that,

$$
\left\|u_{\perp}^{\text {sing }}\right\|=\left\|w\left[\mathrm{q}_{\mathrm{in}}\right]_{\perp} \chi_{L}\right\| \leq C_{L}\left(\left\|w\left[\mathrm{q}_{\mathrm{in}}\right]_{\perp}\right\|_{L^{2}(\mathcal{F})}+\left\|\nabla w\left[\mathrm{q}_{\mathrm{in}}\right]_{\perp}\right\|_{L^{2}(\mathcal{F})}\right) .
$$

To bound these two terms, we first remark that these fields vanish outside $\mathcal{G}_{L}$ and that, concerning the first term of the sum, we have

$$
w\left[\mathrm{q}_{\mathrm{in}}\right]_{\perp}=\int_{z}^{d+\gamma_{t}} \operatorname{div}_{/ /} \mathbf{w}\left[\mathrm{q}_{\mathrm{in}}\right]_{/ /}
$$

As a consequence, in order to bound $\left\|u_{\perp}^{\text {sing }}\right\|$, it is sufficient to bound $\nabla w\left[\mathrm{q}_{\mathrm{in}}\right]_{\perp}$ together with $\nabla_{/ /} \mathbf{w}\left[\mathrm{q}_{\mathrm{in}}\right] / /$ in $L^{2}\left(\mathcal{G}_{L}\right)$. To do so, we recall that $\mathbf{v}_{\mathrm{in}}=\mathbf{w}\left[\mathrm{p}^{\text {sing }}\right]$ so that $\mathbf{w}\left[\mathrm{q}_{\mathrm{in}}\right]$ is constructed from $\mathrm{q}_{\mathrm{in}}$ as $\mathbf{v}_{\mathrm{in}}$ is constructed from $p^{\text {sing }}$ in [6]. As a consequence, the computations of [6] to obtain (18) can be carried out the same way to obtain a similar upper bound, which provides a constant $C$ independent on $d$ such that

$$
\left\|\mathbf{u}^{\mathrm{reg}}\right\| \leq C\left(1+\left|u_{\perp}^{\star}(\mathbf{0}) \| \ln (d)\right|^{\frac{1}{2}}\right) .
$$

Moreover, if the function $\gamma$ is radial one has,

$$
\left\|\mathbf{u}^{\mathrm{reg}}\right\| \leq C
$$

## 3 Numerical validation for pairs of particles

Due to the computational cost of three dimensional direct simulations, we propose here to validate the method using numerical simulations in dimension two. The results of the previous section can straightforwardly be extended to this situation. Note that, concerning short-range interaction and lubrication, dimension two is more challenging than dimension three. Indeed, the situation is more constrained since the fluid has one dimension less to escape the gap between the particles: the singularity induced by lubrication effects is more important.

After detailing the numerical scheme we use, we test the method for different configurations for the case of two (spherical or not) particles with general rigid velocities. Note that, since a finite-element discretization is used, the fluid domain is bounded, which is not the case in the theoretical results of the previous section. In fact, if the particles are apart from the boundaries, the previous results still hold. In case the particles are close to the boundaries, one should add the corresponding singularity to the computations.

### 3.1 Numerical scheme

We propose to solve (4) using a finite-element method. We consider an inf-sup stable pair of finite-element spaces for the Stokes problem $V_{h} \subset H^{1}(\mathcal{F})$ and $M_{h} \subset L^{2}(\mathcal{F})$. The singular field is detailed in Section 2.1 using a truncated asymptotic expansion (see equations 11 ) and $\sqrt{14})$. Thus, since ( $\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}$ ) are known, we are looking to compute an approximation ( $\mathbf{u}_{h}^{\text {reg }}, \mathrm{p}_{h}^{\text {reg }}$ ) of the regular field solution to the following Stokes problem

$$
\left\{\begin{array}{rlrl}
\text { Find }\left(\mathbf{u}_{h}^{\text {reg }}, \mathrm{p}_{h}^{\text {reg }}\right) \in V_{h} \times M_{h} \text { such that } &  \tag{22}\\
-\Delta \mathbf{u}_{h}^{\text {reg }}+\nabla \mathrm{p}_{h}^{\text {reg }} & =\Delta \mathbf{u}^{\text {sing }}-\nabla \mathrm{p}^{\text {sing }}, & \text { in } \mathcal{F} ; \\
\operatorname{div} \mathbf{u}_{h}^{\text {reg }} & =-\operatorname{div} \mathbf{u}^{\text {sing }}, & & \text { in } \mathcal{F} ; \\
\mathbf{u}_{h}^{\text {reg }} & =\mathbf{u}_{i}^{\star}-\mathbf{u}^{\text {sing }}, & & \text { on } \partial B_{i}, i=1,2
\end{array}\right.
$$

where the right-hand side is computed as precisely as possible.
Then, the discrete approximation of the field $(\mathbf{u}, \mathrm{p})$ solution to problem $\sqrt{2}$ ) is given by,

$$
\begin{aligned}
& \mathbf{u}_{h}=\mathbf{u}^{\text {sing }}+\mathbf{u}_{h}^{\text {reg }} \in \mathbf{u}^{\text {sing }}+V_{h}, \\
& \mathrm{p}_{h}=\mathrm{p}^{\text {sing }}+\mathrm{p}_{h}^{\text {reg }} \in \mathrm{p}^{\text {sing }}+M_{h} .
\end{aligned}
$$

It is well-known that non-homogeneous Stokes problems as (4) or (22) have a unique solution if and only if a compatibility condition is satisfied by the right-hand side of the problem. In our case the compatibility condition is written,

$$
\int_{\mathcal{F}} \operatorname{div} \mathbf{u}^{\mathrm{reg}}=\int_{\partial F} \mathbf{u}^{\mathrm{reg}} \cdot \mathbf{n} \quad \text { and } \quad \int_{\mathcal{F}} \operatorname{div} \mathbf{u}_{h}^{\mathrm{reg}}=\int_{\partial F} \mathbf{u}_{h}^{\mathrm{reg}} \cdot \mathbf{n} .
$$

Thanks to divergence theorem and assumption (1) on $\mathbf{u}_{i}^{\star}$ the compatibility condition is satisfied for the continuous problem (4). However, for the discrete problem (22) the boundary condition actually realized is

$$
\left.\mathbf{u}_{h}^{\mathrm{reg}}\right|_{\partial F}=\mathbf{u}_{i}^{\star}-\operatorname{Proj}\left(\mathbf{u}^{\text {sing }}\right) \text { on } \partial B_{i},
$$

where Proj is the projection onto the space made of the traces on $\partial F$ of the functions of $V_{h}$.
Then, thanks to (1), one has

$$
\int_{\partial F} \mathbf{u}_{h}^{\mathrm{reg}} \cdot \mathbf{n}=-\int_{\partial F} \operatorname{Proj}\left(\mathbf{u}^{\operatorname{sing}}\right) \cdot \mathbf{n} \neq-\int_{\mathcal{F}} \operatorname{div} \mathbf{u}^{\operatorname{sing}}=\int_{\mathcal{F}} \operatorname{div} \mathbf{u}_{h}^{\mathrm{reg}}
$$

and so problem (22) may not have a solution.
Thus, to remedy this problem, for a given $\varepsilon>0$ we solve the following penalized Stokes problem,

$$
\left\{\begin{array}{rlrl}
\text { Find }\left(\mathbf{u}_{h, \varepsilon}^{\mathrm{reg}},,_{h, \varepsilon}^{\mathrm{reg}}\right) \in V_{h} \times M_{h} \text { such that } & &  \tag{23}\\
-\Delta \mathbf{u}_{h, \varepsilon}^{\text {reg }}+\nabla \mathrm{p}_{h, \varepsilon}^{\mathrm{reg}} & =\Delta \mathbf{u}^{\text {sing }}-\nabla \mathrm{p}^{\text {sing }}, & & \text { in } \mathcal{F} ; \\
\operatorname{div} \mathbf{u}_{h, \varepsilon}^{\text {reg }}+\varepsilon \mathrm{p}_{h, \varepsilon}^{\text {reg }} & =-\operatorname{div} \mathbf{u}^{\text {sing }}, & & \text { in } \mathcal{F} ; \\
\mathbf{u}_{h, \varepsilon}^{\text {reg }} & =\mathbf{u}_{i}^{\star}-\operatorname{Proj}\left(\mathbf{u}^{\text {sing }}\right), & & \text { on } \partial B_{i}, i=1,2 .
\end{array}\right.
$$

Integrating the divergence equation we obtain,

$$
\varepsilon\left(\int_{\mathcal{F}} \mathrm{p}_{h, \varepsilon}^{\mathrm{reg}}\right)=-\int_{\mathcal{F}} \operatorname{div} \mathbf{u}^{\text {sing }}+\int_{\partial F} \operatorname{Proj}\left(\mathbf{u}^{\text {sing }}\right) \cdot \mathbf{n} \neq 0 .
$$

In the classical Stokes equation, the pressure field is defined up to an additive constant. The penalized Stokes problem allows us to fix the constant so that the mean value of the pressure satisfies the previous equation to compensate the fact that, from a numerical point of view, the compatibility condition is not satisfied. Thus, the problem admits a unique solution.

Remark 3.1 Parameter $\varepsilon$ has to be chosen sufficiently small so that the error induced in the divergence equation is smaller than the one due to the finite-element discretization. On the other hand, the finite-element discretization being fixed, letting $\varepsilon$ go to zero in the numerical tests shall induce numerical errors since the discrete problem for $\varepsilon=0$ has no solution.

### 3.2 Numerical simulations

We run in this section two tests involving a pair of particles. In the first one, we consider two spherical particles moving along the line of their centers (see Figure 6a) and we check that the error for the approximation of (u,p) in that case does not depend on the distance. Then, we show how the explicit expansion computed for a normal relative displacement of two spherical particles can be used to solve more general cases such as non-spherical particles undergoing general rigid motions, that is $\mathbf{u}_{i}^{\star}=\mathbf{V}_{i}+\boldsymbol{w}_{i}\left(\mathbf{x}-\mathbf{x}_{i}\right)^{\perp}$ for $i=1,2$ (see Figure 6b).


Figure 6: The studied configurations
The numerical tests have been implemented with freefem++ 15 and we choose $V_{h}=\mathbb{P}^{1}$ iso $\mathbb{P}^{2}$ and $M_{h}=\mathbb{P}^{1}$. In each case we choose the penalization parameter $\varepsilon=10^{-8}$, we compute the right-hand side with a quadrature formula exact to order 10 and we use a direct solver to solve the linear system associated to problem (23). Since we do not know the exact solution for this type of problem, we compare our results with a reference solution $\left(\mathbf{u}^{\text {ref }}, p^{\text {ref }}\right)$ computed with a direct solver on a very fine mesh.

For each configuration, we plot the absolute error between the approximate solution and the reference solution (in $H_{0}^{1}$-norm for each component of the velocity and in $L^{2}$-norm for the pressure). The tests are run for three different distances between the particles: $d=r_{2} / 8, d=r_{2} / 12$ and $d=r_{2} / 16$.

### 3.2.1 Two spherical particles moving along the line of their centers

The configuration is the one given in Figure 6a with $r_{1}=0.07, r_{2}=0.1, \mathbf{u}_{1}^{\star}=\mathbf{e}_{x}, \mathbf{u}_{2}^{\star}=-\mathbf{e}_{x}$. In that case one has $\mathbf{u}_{\mathrm{as}}^{\star}=\mathbf{u}^{\star}$.

We study the convergence of the method when the size of the mesh $h$ goes to zero. We compare the results with the ones obtained without any correction. We display on Figure 7 the fine mesh used to compute the reference solution (which is displayed on Figure 1), together with three of the meshes used for the computations.


Figure 7: Different meshes used for the computation

First, we plot in Figure 8 the error between the approximate solution $\left(\mathbf{u}_{h, \varepsilon}^{\mathrm{reg}}, \mathrm{p}_{h, \varepsilon}^{\mathrm{reg}}\right)$ and the reference solution $\left(\mathbf{u}^{\text {ref }}, \mathrm{p}^{\text {ref }}\right)$ versus the size of the mesh $h$.


Figure 8: Absolute error in function of $h$ for 3 different distances for two spherical particles
We observe in Figure 8 that without correction (dashed line) the error increases as the distance between the two particles decreases while, as expected, the error no longer depends on the distance when using the new method with correction (solid line). Moreover, the error between the approximate solution and the reference solution is better with correction than without correction.

Now we consider the forces (see equation (3)) exerted on the particles in the longitudinal direction, that is $F_{i}^{x}=F_{i}\left(\mathbf{u}_{h, \varepsilon}^{\text {reg }}\right) \cdot \mathbf{e}_{x}$ for $i=1,2$. We compare in Figure 9 their numerical approximation with the corresponding reference value (in black). Note that, we only consider the components according to $\mathbf{e}_{x}$ since the component according to $\mathbf{e}_{y}$ and the torque are null, due to the symmetry of the configuration.

As expected, a symmetrical behaviour between the two particles is observed. In addition, we observe that the forces obtained with correction (solid lines) converge faster towards the reference forces than those obtained without correction (dashed lines).

### 3.2.2 Two non-spherical particles with general velocities: approximation of the singular field and the geometry

We consider now the case of non-spherical particles with a general rigid motion $\mathbf{u}_{i}^{\star}=\mathbf{V}_{i}+\boldsymbol{w}_{i}\left(\mathbf{x}-\mathbf{x}_{i}\right)^{\perp}$ as described in Figure 6 b . We choose $\mathbf{V}_{1}=(1,1), \mathbf{V}_{2}=(-1,-2), \boldsymbol{w}_{1}=3, \boldsymbol{w}_{2}=5, r_{2}=1 / 20$ and the radius of the osculating circle to particle 1 at the contact point is $r_{1}=4 / 60$.

To apply the theoretical results given in Section 2.1, we must be able to explicitly compute the singular field ( $\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}$ ) defined by (11) and (14). In Section 3.2.1 since we considered two spheres moving along the line of their centers, the singular field could easily be explicitly computed. In more general configurations, this computation could be trickier. Here, in order to go back to the previous computations, we choose to make approximations both on the geometry of the particles and on the singular boundary condition $\mathbf{u}_{\mathrm{as}}^{\star}$.


Figure 9: Comparison of the forces in function of $h$ for two spherical particles

The first approximation is a geometrical approximation: we approximate the non-spherical boundaries ( $\partial B_{1}$ in our case) by the osculating circle at the contact point (dashed lines in Figure6b). This amounts to approaching the parametrization of the boundaries $\gamma_{t}$ and $\gamma_{b}$ in (11) and (14).

Then, we approximate the boundary conditions: we consider the velocity of the boundary at the contact point and use its projection along the normal direction instead of $\mathbf{u}_{\mathrm{as}}^{\star}$ :

$$
\mathbf{u}_{\mathrm{as}}^{\star} \hookrightarrow \tilde{\mathbf{u}}_{\mathrm{as}}^{\star}=\mathbf{u}_{\mathrm{as}}^{\star}(\mathbf{0}) \cdot \mathbf{e}_{\perp}=u_{\perp}^{\star}(\mathbf{0}) \mathbf{e}_{x} .
$$

Doing so, we take into account the part of $\mathbf{u}_{\mathrm{as}}^{\star}$ leading to the most singular behavior of the flow.
To sum up, the singular field is the one that would be computed for two spheres approximating the particles (osculating circle at the contact point) and moving along the line of their centers with velocities equal to the projection along this direction of their initial velocities at the contact point. Then, explicit computations can be achieved as for the previous case.

Due to these approximations, the norm of ( $\left.\mathbf{u}^{\text {reg }}, \mathrm{p}^{\text {reg }}\right)$ now depend on the distance but in a less singular way that the original field $(\mathbf{u}, \mathrm{p})$. We check here that these simplifications are sufficient to catch the lubrication effects. As for the previous case we begin by plotting in Figure 10 the error between the approximate solution and the reference solution.


Figure 10: Absolute error in function of $h$ for 3 different distances in the general case

We observe that even if the whole singularity is not taken into account in the singular field, the behavior is very similar to what was observed in the previous section (see Figure 81. Indeed, here again, the error does not depend on the distance for the case with correction and the error with correction is smaller than the error without correction.

As for the spherical case, we compare in Figure 11 the forces numerically computed with the reference forces (in black). Since here we consider general rigid motions we also plot the component according to $\mathbf{e}_{y}$ and the torque, that is for $i=1,2$

$$
F_{i}^{y}=F_{i}\left(\mathbf{u}_{h, \varepsilon}^{\mathrm{reg}}\right) \cdot \mathbf{e}_{y}, \quad \text { and } \quad T_{i}=\int_{\partial B_{i}}\left(\mathbf{x}-\mathbf{x}_{i}\right) \wedge \sigma\left(\mathbf{u}_{h, \varepsilon}^{\mathrm{reg}}\right) \mathbf{n} .
$$



Figure 11: Comparison of the forces and the torque in function of $h$ in the general case
We observe that for the component according to $\mathbf{e}_{x}$ the force with correction approaches the reference force much better than the force without correction (see Figures 11a and 11d). As expected, these normal forces along $\mathbf{e}_{x}$ are well corrected since the new boundary condition $\tilde{\mathbf{u}}_{\mathrm{a}}^{\star}$ takes into account the normal motion of the contact points. For the component according to $\mathbf{e}_{y}$ as well as for the computation of the torque, this is no longer the case but the behaviours with and without correction are similar. Moreover, we can observe that the results oscillate more (and are therefore less reliable) when we do not correct the field.

## 4 Extension to 3 aligned particles and 2 singularities

We come back to the 3-dimensional problem of multi-particle systems (2) for which the solution is written $\operatorname{St}\left(\mathbf{u}_{1}^{\star}, \ldots, \mathbf{u}_{i}^{\star}, \ldots, \mathbf{u}_{N}^{\star}\right)$. Once again, the linearity of Stokes equation allows us to write this problem as a sum of elementary problems

$$
\operatorname{St}\left(\mathbf{u}_{1}^{\star}, \ldots, \mathbf{u}_{i}^{\star}, \ldots, \mathbf{u}_{N}^{\star}\right)=\sum_{i=1}^{N} \operatorname{St}\left(0, \ldots, 0, \mathbf{u}_{i}^{\star}, 0, \ldots, 0\right) .
$$

We explain below how the previous decomposition in a sum of a regular and a singular field can be extended in that case. For the sake of simplicity, the method is described and analyzed for three aligned particles. The extension to more general cases is then discussed in Section 5

### 4.1 Case of 3 aligned particles: construction of the singular field

Let us then consider in this section the case of three aligned particles. The previous decomposition gives

$$
\operatorname{St}\left(\mathbf{u}_{1}^{\star}, \mathbf{u}_{2}^{\star}, \mathbf{u}_{3}^{\star}\right)=\operatorname{St}\left(\mathbf{u}_{1}^{\star}, 0,0\right)+\operatorname{St}\left(0, \mathbf{u}_{2}^{\star}, 0\right)+\operatorname{St}\left(0,0, \mathbf{u}_{3}^{\star}\right) .
$$

Since the first and last terms can be treated in the same way, we only have to deal with the following two cases:

1. the problem $\operatorname{St}\left(\mathbf{u}^{\star}, 0,0\right)$ where the moving particle $B^{\star}=B_{1}$ is at one end and the other two particles $B_{2}$ and $B_{3}$ are seen as obstacles (see Figure 12a);
2. the problem $\operatorname{St}\left(0, \mathbf{u}^{\star}, 0\right)$ where the moving particle $B^{\star}=B_{2}$ is in the middle and the two particles $B_{1}$ and $B_{3}$ at the ends are seen as obstacles (see Figure 12b).

In the following of the section, we first construct the singular field ( $\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}$ ) used in numerical simulations to compute the regular field ( $\left.\mathbf{u}^{\text {reg }}, \mathrm{p}^{\text {reg }}\right)$. Then, to prove that the remaining field $\mathbf{u}^{\text {reg }}$ is bounded independently of the distance (see equation (21), we use as for two particles, an intermediate asymptotic field $\mathbf{v}_{\mathrm{as}}=\mathbf{v}_{\text {in }}+\mathbf{v}_{\text {ext }}$, which is an extension to the one constructed for two particles. We detailed below the main steps of the reasoning for the two cases presented in Figure 12.

### 4.1.1 Singular field choice

The choice for the singular field in case of multiple singularities is quite obvious: it is constructed as the sum of the corresponding singular fields as defined in Section 2. Let us illustrate this construction for the two considered cases:

- Case 1 (see Figure 12a): in that case, since $B_{2}$ and $B_{3}$ have the same (null) velocity, the unique singularity in the problem is due to the relative velocity between $B^{\star}=B_{1}$ and $B_{2}$. Let us define, as in the previous section, $\mathcal{G}_{L}=\mathcal{G}_{L}^{1,2}$ as the gap between particles $B_{1}$ and $B_{2}$. The singular field is then defined as

$$
\left(\mathbf{u}^{\operatorname{sing}}, p^{\operatorname{sing}}\right)=\left(\mathbf{u}^{\text {sing }, 1,2}, p^{\text {sing }, 1,2}\right)
$$

where $\left(\mathbf{u}^{\text {sing,1,2 }}, \mathrm{p}^{\text {sing,1,2 }}\right.$ ) is the singular field computed from (11) and (14) in $\mathcal{G}_{L}$ (with $B^{\star}=B_{1}, B=B_{2}$ and $\mathbf{u}^{\star}=\mathbf{u}_{1}^{\star}$ ) and extended to zero on $\mathcal{F}$. Note that this singular field vanishes outside $\mathcal{G}_{L}$.

- Case 2 (see Figure 12b): In that case, two singularities have to be taken into account, due to the relative velocities between $B_{2}$ and $B_{1}$ and between $B_{2}$ and $B_{3}$. With evident notations, we define $\mathcal{G}_{L}=\mathcal{G}_{L}^{2,1} \cup \mathcal{G}_{L}^{2,3}$ as the union of the gaps between the two pairs of particles. The singular field is defined as

$$
\left(\mathbf{u}^{\text {sing }}, p^{\text {sing }}\right)=\left(\mathbf{u}^{\text {sing }, 2,1}, p^{\text {sing }, 2,1}\right)+\left(\mathbf{u}^{\text {sing }, 2,3}, p^{\text {sing }, 2,3}\right) .
$$

Again, ( $\left.\mathbf{u}^{\operatorname{sing}, 2, i}, \mathrm{p}^{\text {sing }, 2, i}\right)$ is the singular field computed in $\mathcal{G}_{L}^{2, i}$ from (11) and (14) and extended to zero on $\mathcal{F}$ (of course, one has to use an appropriate change of coordinate before using formula (11) and (14): for
each singularity, the origin of the coordinates is the point on $\partial B_{2}$ which achieves the minimum between $B_{i}$ and $B^{\star}=B_{2}$ and $\mathbf{e}_{\perp}$ is the unit vector from the origin to particle $i$ ). Again, the singular field vanishes outside $\mathcal{G}_{L}$.

### 4.1.2 Construction of the intermediate field $v_{\text {as }}$

In order to prove that, using this singular field, the corresponding regular field $\mathbf{u}^{\text {reg }}=\mathbf{u}-\mathbf{u}^{\text {sing }}$ is bounded, we proceed as in Section 2. We construct an intermediate asymptotic field $\mathbf{v}_{\mathrm{as}}=\mathbf{v}_{\mathrm{in}}+\mathbf{v}_{\mathrm{ext}}$, which is an extension to the one constructed in [6] for two particles.

The inner field $\mathbf{v}_{\mathrm{in}}$ is defined from the inner field for two particles as $\mathbf{u}^{\text {sing }}$ has been defined from the singular field for two particles: with evident notations,

$$
\begin{array}{ll}
\text { Case } 1 \text { (see Figure } 12 \mathrm{a} \text { : } & \mathbf{v}_{\text {in }}=\mathbf{v}_{\mathrm{in}}^{1,2} . \\
\text { Case } 2 \text { (see Figure } 12 \mathrm{~b} \text { : } & \mathbf{v}_{\mathrm{in}}=\mathbf{v}_{\mathrm{in}}^{2,1}+\mathbf{v}_{\mathrm{in}}^{2,3} .
\end{array}
$$

Note that, in both cases,

$$
\mathbf{v}_{\mathrm{in}}=\mathbf{u}^{\star} \text { on } \mathcal{G}_{L / 2} \cap \partial B^{\star}
$$

where $\mathcal{G}_{L / 2}=\mathcal{G}_{L / 2}^{1,2}$ in case 1 and $\mathcal{G}_{L / 2}=\mathcal{G}_{L / 2}^{2,1} \cup \mathcal{G}_{L / 2}^{2,3}$ in case 2 .
It now remains to define $\mathbf{v}_{\text {ext }}$ so that the couple ( $\mathbf{v}_{\mathrm{in}}, \mathbf{v}_{\mathrm{ext}}$ ) shares the same properties as in Section 2 . To do so, we recall that we need to construct $\mathbf{v}_{\text {ext }}$, bounded independently of the distance and such that $\mathbf{v}_{\text {as }}=\mathbf{v}_{\text {in }}+\mathbf{v}_{\text {ext }}$ satisfies the boundary conditions of the initial problem. Following Section 2 and [6], $\mathbf{v}_{\text {ext }}$ is defined as the solution to a Stokes problem in a suitable outer domain $\Omega^{\star}$. The main difficulty is to be able to choose $\Omega^{\star}$ such that the boundary condition is corrected and $\mathbf{v}_{\text {ext }}$ is bounded independently on the distance. To this end, as in Section 2, the domain $\Omega^{\star}$ has to satisfy:

- $\Omega^{\star}$ is a smooth subdomain of $\mathcal{F} \backslash \mathcal{G}_{L / 4}$ (with evident notation);
- $\Omega^{\star}$ is independent of $d$;
- $\Omega^{\star} \subset \mathcal{F}$ for any $d \in(0,1] ;$
- $\partial \Omega^{\star}$ contains the part of the boundary of $\partial B^{\star}$ on which $\mathbf{v}_{\text {in }} \neq \mathbf{u}^{\star}$.

Supposing, as in Section 2, that for each singularity, the contact is "single, non-degenerate", such a domain exists for the two configurations studied. One of the choices for $\Omega^{\star}$ is represented on Figure 12 ,

From this construction, the computations and estimations in Section 2 can be extended to obtain the asymptotic result 20 and one gets the required estimate 21 on $\mathbf{u}^{\text {reg }}$.

### 4.2 Case of 3 non-spherical aligned particles with general velocities: numerical results

In this section, we consider three non-spherical particles with general rigid motions $\mathbf{u}_{i}^{\star}=\mathbf{V}_{i}+\boldsymbol{w}_{i}\left(\mathbf{x}-\mathbf{x}_{i}\right)^{\perp}$. As in Section 3.2.2, we approximate the geometry of the particles at the contact point using the osculating circles and the singular velocity is computed using the more singular part of the boundary condition:

$$
\tilde{\mathbf{u}}_{\mathrm{as}, i}^{\star}=\mathbf{u}_{a s, i}^{\star}(\mathbf{0}) \cdot \mathbf{e}_{\perp}=u_{\perp, i}^{\star}(0) \mathbf{e}_{x} .
$$

We choose $\mathbf{V}_{1}=(1,1), \mathbf{V}_{2}=(-1,-2), \mathbf{V}_{3}=(1.5,-2), \boldsymbol{w}_{1}=3, \boldsymbol{w}_{2}=5, \boldsymbol{w}_{3}=5, r_{2}=1 / 20$ and the radius of the osculating circles at the contact points are $r_{1}=4 / 60$ and $r_{3}=(1.3)^{2} / 20$. The corresponding configuration is plotted on Figure 13.


Figure 13: Configuration for the 3 non-spherical particles. Particles, together with their osculating circles at the contact point.

The convergence of the method is illustrated on Figures 14 and 15 where we plot respectively the error versus $h$ on the flow and the convergence versus $h$ of the forces and torques on the three particles. The results are similar to the ones obtained in Section 3.2 .2 for two particles: the error on the flow is better when using the singular/regular decomposition and do not depend on the distance. The forces along the horizontal direction are better approximated using the new method and the other components behave similarly with ou without correction, with generally less oscillations in the case of the corrected method.

## 5 Conclusion and prospects: towards more general configurations

To sum up, from a theoretical point of view, we propose in this article a new explicit expression to compute a singular field ( $\left.\mathbf{u}^{\text {sing }}, \mathrm{p}^{\text {sing }}\right)$ in three dimensions. We prove that the remaining field $\left(\mathbf{u}^{\text {reg }}, \mathrm{p}^{\text {reg }}\right)=(\mathbf{u}, \mathrm{p})-$ $\left(\mathbf{u}^{\text {sing }}, p^{\text {sing }}\right)$ is regular in the sense that it is bounded independently on the distance. We achieve this study for two particles or three aligned particles. The particles are not necessarily spherical and undergo general rigid velocities.

The method is easily transposed to the 2-dimensional case and the numerical behavior of the method for two or three aligned particles is investigated in 2 dimensions. We show that, with the new method, the error made on the computed fields does not depend on the distance anymore and that the forces are better approximated.

The extension of the method to more general configurations involving any number of non aligned particles is straightforward: mimicking the case of three aligned particles, one would like to sum up the different contributions of the singularities induced by the pairs of close particles. To illustrate this, let us consider three particles in a L-shape configuration (see Figure 16). Suppose that the radius of the particles are $r_{1}=2, r_{2}=1$, and $r_{3}=1.5$. Particles 1 and 2 are aligned on the horizontal axis and the third particle is above the second one. Suppose that particle 2 is at rest and that both particles 1 and 3 move towards it. In that case, one has two singularities to sum: between particles 1 and 2 and between particles 2 and 3. As in Section 4.1 (dealing with three aligned particles), to prove that the remaining field is regular, it is sufficient to construct an adapted $\Omega^{\star}$ for the two following cases: $B^{\star}=B_{2}$ and $B^{\star}=B_{1}$. We show in Figure 16 the corresponding constructions, together with the reference solution computed on a very fine mesh for distances between particles 1 and 2 and particles 2 and 3 equal to $r_{1} / 10$. The demonstration of the regularity of the remaining field can then be extended which is confirmed by the fact that the reference solution in Figure 16 c behaves as the sum of two singularities concentrated in the gaps between the pairs of particles 1 and 2 and particles 2 and 3 . As a consequence, the method can be extended in that case and convergence results should be similar to the ones obtained in the case of aligned particles.

As long as it is possible to construct a domain $\Omega^{\star}$ verifying the assumptions recalled in Section 2.2 , one can choose the singular field as the sum of the pairwise singular fields and prove that the remaining part of the field is regular. We provide on Figure 17 an example in dimension 2 for which this construction is not possible. This example exhibits a closed subdomain in which the fluid is confined when the distance between the particles goes to zero. It is made of three particles located at the apexes of an equilateral triangle. All the particles have the same radius $r$ and the distance between the particles is equal to $r / 10$. In Figure 17a we observe that it is not possible to construct a domain $\Omega^{\star}$ (independent of the distance and included in $\mathcal{F}$ for any distance) whose

boundary takes into account the blue part of $\partial B_{2}$ when the distance goes to zero whereas we should correct the boundary condition on this part of $\partial B_{2}$. We plot in Figure 17b the pressure field when one of the particles (bottom right) is at rest and the two other ones move towards it. We can observe that the solution does not behave as the sum of the singularities in the gaps: a new kind of singularity appears in the confining zone.

Note that such a situation exhibiting a confined zone of fluid does not exist in dimension 3. As a consequence, one can always construct an adapted $\Omega^{\star}$ and the method should work for any configuration of particles. The numerical behavior of the method for more general configurations in dimension 3 will be investigated in a forthcoming work.
