Gene Expression in Nitrogen-Fixing Symbiotic Nodule Cells in *Medicago truncatula* and Other Nodulating Plants

One-sentence summary: Gene expression analyses of nodules of the nitrogen-fixing clade of plants have advanced our understanding of nodule organogenesis and functioning and the evolution of symbiosis.

ABSTRACT

Root nodules formed by plants of the nitrogen-fixing clade (NFC) are symbiotic organs that function in the maintenance and metabolic integration of large populations of nitrogen-fixing bacteria. These organs feature unique characteristics and processes, including their tissue organization, the presence of specific infection structures called infection threads, endocytotic uptake of bacteria, symbiotic cells carrying thousands of intracellular bacteria without signs of immune responses, and the integration of symbiont and host metabolism. The early stages of nodulation are governed by a few well-defined functions, which together constitute the common symbiosis-signaling pathway (CSSP). The CSSP activates a set of transcription factors (TFs) that orchestrate nodule organogenesis and infection. The later stages of nodule development require the activation of hundreds to thousands of genes, mostly expressed in symbiotic cells. Many of these genes are only active in symbiotic cells, reflecting the unique nature of nodules as plant structures. Although how the nodulespecific transcriptome is activated and connected to early CSSP-signaling is poorly understood, candidate TFs have been identified using transcriptomic approaches, and the importance of epigenetic and chromatin-based regulation has been demonstrated. We discuss how gene regulation analyses have advanced our understanding of nodule organogenesis, the functioning of symbiotic cells, and the evolution of symbiosis in the NFC.

1 INTRODUCTION

- 2 In response to nitrogen starvation and the presence of specific compatible nitrogen-
- 3 fixing bacteria in the rhizosphere, plants of the nitrogen-fixing clade (NFC) in the

- 4 Rosid clade form symbiotic organs on their roots known as nodules. Nodules are
- 5 infected by a large population of these bacteria, which convert atmospheric nitrogen
- gas to ammonia. The ammonia is taken up by the plant to satisfy its nitrogen needs
- 7 for growth. The NFC, which originated over 100 million years ago (MYA), is
- 8 composed of four orders, the Fabales, Cucurbitales, Fagales, and Rosales (Soltis et
- 9 al., 1995). Nodulation is widespread in the Leguminosae family of the Fabales
- 10 (although not present in all legume species), while it is scattered among species of
- the three other orders. Leguminosae and species of the *Parasponia* genus of the
- 12 Rosales are infected with phylogenetically diverse bacteria, collectively named
- rhizobia, belonging to the Rhizobiales of the alphaproteobacteria (alpha-rhizobia) or
- the Burkholderiales of the betaproteobacteria (beta-rhizobia). The other nodulating
- genera, collectively known as actinorhizal plants, interact with nitrogen-fixing
- 16 actinobacteria of the genus Frankia.
- Although they are diverse, all rhizobia, as typical Gram-negative bacteria, have
- (broadly speaking) a similar type of cell envelope structure, which is a crucial attribute
- for effective nodule colonization (Haag et al., 2013). At least one other shared feature
- of rhizobia with one reported exception (Giraud et al., 2007) is the capacity to
- 21 produce so-called Nod factors, the bacterial signals that trigger the nodulation
- 22 program of the host plant via the activation of the common symbiosis signaling
- pathway (CSSP). Nod factors are lipochitooligosaccharides with a characteristic
- 24 molecular structure and are similar only to the Myc factors produced by mycorrhizal
- fungi (Oldroyd, 2013; Cope et al., 2019). The capacity to produce Nod factors is
- encoded by the nodulation or *nod* genes located on symbiotic islands or on mobile
- 27 plasmids in the rhizobial genomes (Poole et al., 2018).
- 28 By contrast, *Frankia* are Gram-positive bacteria with a fundamentally different cell
- 29 envelope from rhizobia. Although very little is known about the requirements of cell
- 30 envelopes for symbiosis in *Frankia*, these envelope differences likely have profound
- effects on the colonization of nodules. The nodule-inducing factors produced by
- 32 Frankia strains are currently unknown (Cissoko et al., 2018), although some
- particular *Frankia* strains possess genes homologous to the *nod* genes of rhizobia
- (Persson et al., 2015). It is thus conceivable that *Frankia* strains produce nodule-
- inducing signals that are structurally homologous to Nod factors.

The nodule can be viewed as a plant organ that relies on the integration or recruitment of existing processes (meristem formation, endoreduplication, polar growth, endocytosis and exocytosis, nitrogen and sugar metabolism) in a new context, in conjunction with the deployment of seemingly completely new features (infection threads and uptake of bacteria, meristem organization, formation of new organellar structures, maintenance of bacteria inside plant cells and immune suppression and metabolic integration of a bacterial endosymbiont). Thus, depending on whether one considers the glass half-empty or half-full, nodules can be viewed as "novel" or "not-so-novel" plant organs. The latter point of view — particularly motivated by the finding that nodule formation is controlled by the CSSP, which is widely conserved in land plants that form symbiotic relationships with arbuscular mycorrhizal fungi — has led to the suggestion that engineering nodulation and symbiotic nitrogen-fixation to currently non-nodulating plants would require a minimal set of genes and is therefore an attainable objective (Markmann and Parniske, 2009; Oldroyd and Dixon, 2014; Stokstad, 2016). However, nodule formation is accompanied by massive transcriptional reprogramming involving the activation and repression of hundreds of genes. Remarkably, this nodule transcriptional program is entirely different from the mycorrhizal transcriptional program controlled by the same CSSP. This highlights the uniqueness of nodules as plant organs and emphasizes the challenges faced when trying to transfer nodulation to non-legume crops. Here we review what we have learned from transcriptome approaches aimed at characterizing the specific features of nodules, focusing mostly but not exclusively on the transcriptional reprogramming taking place during the formation of symbiotic nodule cells in the model legume, Medicago truncatula.

NODULE DEVELOPMENT AND MORPHOLOGY: NODULES ARE UNIQUE STRUCTURES

Nodules in different lineages of the NFC can differ from one another in terms of development, infection mechanisms, final structure, and metabolism. However, nodule organogenesis and functioning commonly calls upon several processes, which do not have equivalents in other plant developmental programs. Nodule formation in *M. truncatula* is among the best described (Figure 1). This process is governed by a number of unique signaling cascades that utilize inter-specific

(bacterium to plant and vice versa) and intra-specific (plant to plant) signaling 69 molecules including flavonoids (plant to bacterium) and Nod factors (bacterium to 70 plant) (Oldroyd, 2013) (Figure 1A), Type III, IV, and VI secretion system effectors 71 (bacterium to plant) (Nelson and Sadowski, 2015; Teulet et al., 2019), bacterial 72 surface polysaccharides (exopolysaccharides, lipopolysaccharides) (bacterium to 73 plant) (Haag et al., 2013), NCR (nodule-specific cysteine-rich) peptides (plant to 74 bacterium) (Kondorosi et al., 2013), phytohormones (intra-plant) (Gamas et al., 2017; 75 Schiessl et al., 2019), CLE and CEP peptides (intra-plant) (Taleski et al., 2018), and 76 77 small RNAs (intra-plant and bacterium to plant) (Tsikou et al., 2018; Ren et al., 2019). Each of these signaling systems seems to be variations on a theme of widely used 78 79 regulatory mechanisms in plants. For example, similar to Myc factors, Nod factors activate the CSSP (Figure 1A), which thus controls not only nodulation but also 80 81 mycorrhization (Oldroyd, 2013). However, the output of the signaling in response to Nod factors and Myc factors is completely different (see below). It is a long-lasting 82 83 conundrum how this differential output is achieved. Other key signals of nodulation are used in plant development (e.g. phytohormones) or in biotic interactions (e.g. 84 immunity) but with a unique output in nodulation. Thus, nodulation relies upon a 85 unique rewiring of signaling pathways. 86 The nodule primordium and the persistent meristem of indeterminate *M. truncatula* 87 nodules have features reminiscent of the formation of lateral roots and the root apical 88 meristem (Franssen et al., 2015; Couzigou et al., 2012; Xiao et al., 2014), including 89 overlapping genetic and hormonal control mechanisms (Schiessl et al., 2019). 90 However, the root apical meristem is organized in a different manner and leads to the 91 92 formation of one central vascular bundle, while in legumes, the nodule meristem generates several peripheral vascular bundles (Figure 1B). Nevertheless, actinorhizal 93 94 and Parasponia nodules have a central vasculature (Downie, 2014; Behm et al., 2014). The other cell types derived from the nodule meristem are also fundamentally 95 96 different from root cells. Endoreduplication drives the differentiation of postmeristematic cells into symbiotic nodule cells, which become infected by rhizobium 97 98 bacteria (Kondorosi et al., 2013). Endoreduplication is common in plants and can be observed in differentiating root cells and other plant tissues in a species-specific 99 100 manner, as well as in many other biotrophic interactions in plants (Wildermuth et al., 2017; Edgar et al., 2014). In nodules, endoreduplication is tightly coupled to infection 101

and the passage of so-called infection threads (van Brussel et al., 1992; Yang et al., 102 1994; Suzaki et al., 2014). Determinate nodules, which form in some legume clades, 103 differ fundamentally from the indeterminate nodules of *M. truncatula*, because they 104 do not develop a meristem. Nevertheless, cells of determinate nodules also undergo 105 endoreduplication after infection with rhizobia (Gonzáles-Sama et al., 2006). 106 Consequently, and contrary to meristem-containing indeterminate nodules, these 107 nodules have a determinate growth, which is limited by early cell divisions during the 108 primordium stage and the subsequent cell enlargement of rhizobium-infected cells 109 110 driven by their endoreduplication. Well-studied examples of determinate nodules are formed by Lotus japonicus and soybean (Glycine max). 111 112 Infection threads are tubular structures containing infecting rhizobia that conduct these bacteria inside the nodule tissues (Figure 1C). Infection thread formation 113 initiates in growing root hairs due to the activation of the CSSP by rhizobial Nod 114 factors. These structures share some similarities with pollen tubes and root hairs, 115 116 which both display polar growth, as do infection threads. The polar growth of infection threads, pollen tubes, and root hairs indeed relies on common molecular 117 mechanisms (Yang, 2008; Ke et al., 2012; Kiirika et al., 2012; Montiel et al., 2012; 118 Morieri et al., 2013). However, contrary to pollen tubes and root hairs, which are 119 autonomous cells, infection threads are trans-cellular structures that grow from cell to 120 cell, hijacking the cellular machinery of their temporal host cells. Infection thread 121 growth is a process also derived from the eukaryotic cell cycle (van Brussel et al., 122 1992; Yang et al., 1994; Timmers et al., 1999). Before penetration by an infection 123 thread, the targeted vacuolated cortical root cell undergoes cytological 124 125 reorganization, forming a so-called pre-infection thread or PIT (Figure 1C) (van Brussel et al., 1992; Timmers et al., 1999). The PIT is structurally related to the 126 127 phragmosome, a cytoplasmic bridge through the vacuole formed by cells in preparation for mitosis. An analysis of the expression of cell cycle marker genes 128 129 revealed that PIT-forming cells indeed enter into the cell cycle and duplicate their genomes but are arrested in the G2 phase, before the initiation of mitosis (Yang et 130 131 al., 1994). More recently, it was shown that root hairs also prepare for infection thread formation by activating cell cycle genes (Breakspear et al., 2014). PITs are 132 133 reminiscent of the pre-penetration apparatus in root cells prior to infection with the hyphae of arbuscular mycorrhizal fungi (Genre et al., 2008). 134

Infection threads grow towards young, differentiating symbiotic cells where they 135 release rhizobia through an endocytotic process (Figure 1D). Endocytosis, a well-136 known process in plants (Paez Valencia et al., 2016), is essential for controlling the 137 turnover of plasma membrane proteins such as receptors and transporters. However, 138 the uptake of whole bacteria by plant cells as during rhizobium (or *Frankia*) infection 139 of nodule cells is unknown, except for the case of the nitrogen-fixing symbiosis of the 140 plant genus Gunnera with cyanobacteria. Nevertheless, the infection of nodule cells 141 shares some similarities with the infection of plant cells by fungal pathogens and 142 mycorrhizal symbionts (Harrison and Ivanov, 2017; Parniske, 2018). Endocytotic 143 uptake does not release rhizobia freely in the cytosol of nodule cells, instead 144 145 releasing them inside organelle-like vesicles known as symbiosomes, which have a plasmalemma-like membrane (Figure 1D). Within symbiosomes, the rhizobia grow 146 147 and differentiate into nitrogen-fixing structures called bacteroids. The latter process is enabled by the exocytosis pathway, which traffics specific proteins to the 148 149 symbiosomes (Figure 1D). The exocytosis pathway is strongly conserved in eukaryotes, but some components are nodule-specific and are encoded by 150 151 duplicated genes or by nodule-specific splice variants (Stonoha-Arther and Wang, 2018). 152 Among the unique features of nodules, the nitrogen-fixation process by symbiotic 153 nodule cells is certainly the most prominent. This process requires the maintenance 154 of thousands of bacterial endosymbiont-containing symbiosomes within individual 155 plant cells (Figure 1E). During this process, symbiosomes acquire a specific vesicular 156 identity and avoid a vacuolar identity, which would lead to the elimination of the 157 158 symbiont (Limpens et al., 2009; Sinharoy et al., 2013). In addition, symbiotic cells contain specific machinery that suppresses innate immunity responses against their 159 160 many endosymbionts (Figure 1D) (Gourion et al., 2015; Wang et al., 2016; Domonkos et al., 2017; Yu et al., 2018). In certain legumes, such as Medicago spp. 161 162 in the IRLC clade and Aeschynomene spp. in the Dalbergoid branch, symbiosome formation also involves the production of symbiosis-specific peptides called NCRs, 163 164 which target the bacteroids and control their extreme, terminal differentiation (Mergaert, 2018). Finally, the functioning of symbiotic cells requires bacterial 165 166 metabolism to be integrated with the metabolism of the host cells (Figure 1F). Bacteroids generate ammonia in large excess to their own needs and release this 167

ammonia to the plant. Major features of the metabolism of symbiotic cells include i) the supply of carbon sources derived from photosynthesis in the shoots to the energy-devouring bacteroids, ii) the maintenance of a low oxygen concentration to avoid the irreversible oxidation and inactivation of the nitrogenase enzyme, and iii) the assimilation of ammonium provided by nitrogen-fixing bacteroids. This specific metabolism requires the activation of a suite of enzymes and transporters and the massive production of leghemoglobin to bind oxygen (Figure 1D,F) (Udvardi and Poole 2013; Poole et al., 2018; Roy et al., 2019).

NODULE TRANSCRIPTOME DATABASES

Transcriptional reprogramming associated with nodule formation has been studied in 178 many legume species, including M. truncatula (see below), Medicago sativa 179 (O'Rourke et al., 2015), pea (*Pisum sativum*) (Alves-Carvalho et al., 2015), chickpea 180 (Cicer arietinum) (Kant et al., 2016; Kudapa et al., 2018), Trifolium pratense (Trujillo 181 et al., 2019), L. japonicus (Verdier et al., 2013; Høgslund et al., 2009; Takanashi et 182 183 al., 2012; Colebatch et al., 2004; Kelly et al., 2018), G. max (Brechenmacher et al., 2008; Severin et al., 2010), common bean (*Phaseolus vulgaris*) (O'Rourke et al., 184 2014), Sesbania rostrata (Capoen et al., 2007), Lupinus spp. (Keller et al., 2017), 185 Aeschynomene evenia (Gully et al., 2018), and peanut (Arachis hypogaea), Arachis 186 duranensis, Arachis ipaensis (Clevenger et al., 2016; Peng et al., 2017; Karmakar et 187 al., 2019), in the non-legume Parasponia andersonii (van Velzen et al., 2018), as well 188 as in the actinorhizal plant species Casuarina glauca (Hocher et al., 2011), Alnus 189 glutinosa (Hocher et al., 2011), Datisca glomerata (Demina et al., 2013; Battenberg 190 et al., 2018; Salgado et al., 2018) and Ceanothus thyrsiflorus (Battenberg et al., 191 2018; Salgado et al., 2018). 192 Transcriptomic approaches to study nodule formation have been extensively applied 193 194 in *M. truncatula*, in large part due to the development of whole genome Affymetrix Medicago GeneChips. These GeneChips have been used in 274 different 195 experimental conditions, which can be found in the Medicago truncatula Gene 196 Expression Atlas (MtGEA) repository (https://mtgea.noble.org/v3/index.php; Benedito 197 et al., 2008). MtGEA compiles a broad range of developmental and environmental 198 conditions, including different plant organs and tissue types, biotic-, abiotic stress 199

200	conditions, and hormone treatments and is therefore currently the richest M.
201	truncatula resource for the analysis of expression patterns and specificity of genes of
202	interest and the discovery of genes expressed under certain conditions or in organs
203	of interest. Ordering the MtGEA dataset with a clustering algorithm results in the
204	identification of tissue-specific gene sets (Figure 2A). The heat map discloses large
205	clusters of genes that are expressed in different plant organs, leaves, stems, flowers,
206	seeds, hypocotyls, roots, mycorrhiza, and nodules. This analysis also revealed that
207	nodules and mycorrhiza are primarily typified by the expression of different sets of
208	genes (Figure 2B), despite the shared CSSP module of regulators that controls both
209	nodule and mycorrhiza formation and a number of common target genes that are
210	activated immediately downstream of the CSSP during both types of interactions
211	(Hogekamp et al., 2011). For research on rhizobium-legume symbiosis, the MtGEA
212	dataset can be complemented by expression data derived from laser-capture
213	microdissection (LCM)-transcriptome analysis (see below) available in the
214	SYMBIMICS database (https://iant.toulouse.inra.fr/symbimics/ ; Roux et al., 2014).
215	Together, the MtGEA and SYMBIMICS databases are priceless resources for
216	studying <i>M. truncatula</i> biology, particularly nodulation.
217	Datasets similar to MtGEA are available for two alfalfa subspecies, <i>M. sativa</i> ssp.
218	sativa (B47) and M. sativa ssp. falcata (F56) (Alfalfa Gene Index and Expression
219	Atlas Database or AGED; http://plantgrn.noble.org/AGED/; O'Rourke et al., 2015), <i>L.</i>
220	japonicus (LjGEA; https://ljgea.noble.org/v2/; https://lotus.au.dk/expat/; Verdier et al.,
221	2013), P. vulgaris (Common Bean Gene Expression Atlas or PvGEA;
222	http://plantgrn.noble.org/PvGEA/; O'Rourke et al., 2014), soybean (SoyBase;
223	https://soybase.org/soyseq/; Severin et al., 2010) and Arachis spp. (PeanutBase;
224	https://www.peanutbase.org/; Clevenger et al., 2016). Except for LjGEA, which
225	reports approximately 80 experimental conditions, including organs and physiological
226	conditions, the other databases are less well furnished and focus on the principal
227	plant organs. LjGEA was generated with Affymetrix gene chips while the AGED,
228	PvGEA, SoyBase, and PeanutBase datasets were generated by RNA-seq.

NOVEL INSIGHTS FROM NODULE TRANSCRIPTOME ANALYSES

Because nodules form de novo on roots starting from fully differentiated cortical, endodermal, pericycle, and epidermal cells, the nodule transcriptome is usually defined by the genes showing differential expression in nodules versus roots. A recurring theme in each transcriptome study on legumes, Parasponia, and actinorhizal plants is that nodule formation is accompanied by the differential expression of hundreds to thousands of genes. These sets of nodule-enhanced genes are composed in part of genes that are more strongly expressed in nodules than in other organs but importantly, these gene sets also contain large numbers of absolutely nodule-specific genes (see below). Conversely, a transcriptome analysis in M. truncatula revealed that the larger part of the gene expression changes during lateral root initiation also occur during nodule organogenesis (Schiessl et al., 2019). These common differentially expressed genes are related to auxin biosynthesis and signaling and transcriptional regulation. This observation suggests that lateral root organogenesis has been recruited into the symbiotic program to which a large panel of nodule-specific features was added. The nodule-specific gene sets are composed of genes with homologs in other plants or paralogs expressed in other plant tissues as well as orphan genes. These findings further underscore the unique nature of nodules and the very complex genetic program governing the formation of this symbiotic organ. Thus, from this perspective, the glass might be half-empty.

The Specificity of the Nodule Transcriptome

The analysis presented in Figure 2 suggests that some organs, particularly nodules, are associated with the expression of genes that are extraordinarily specifically expressed. This is obvious when zooming in on the expression of NCR genes (Figure 3A) (Guefrachi et al., 2014). This extremely large gene family encodes nodule-specific cysteine-rich peptides, which target endosymbionts and induce them into a terminally differentiated state, are required for maintaining bacteroids, or are involved in the selection of well-adapted rhizobia in nodules (Mergaert, 2018). All but five of the over 300 analyzed NCR genes are exclusively expressed in nodules and in no other plant organ or in response to any other biotic interaction or abiotic stress. To express the apparent tissue specificity of genes expressed in nodules and of the NCRs in a quantitative manner, a metric called Shannon entropy was used (Guefrachi et al., 2014). Shannon entropy is a parameter derived from information theory that is applied to gene expression analysis to characterize the uniformity (high

Shannon entropy) or specificity (low Shannon entropy) of the expression pattern of a 264 gene of interest over a number of tested conditions. Taking into account ten different 265 tissues or organs of *M. truncatula*, the Shannon entropy was calculated for all genes 266 in MtGEA. Ordering the MtGEA genes according to expression profile (Figure 3B) or 267 ranking them according to their Shannon entropy value (Figure 3C) makes it clear 268 that flowers, seeds, pods, and mycorrhiza and most particularly nodules are 269 characterized by large gene sets with very low Shannon entropy that are thus 270 (almost) uniquely expressed in these organs. Thus, nodulation in *M. truncatula* 271 272 strongly depends on dedicated gene sets that do not function elsewhere in the plant (Guefrachi et al., 2014). As discussed below, the large majority of these genes are 273 274 expressed in differentiating or mature symbiotic cells (Figure 3C). Shannon entropy analysis of the AGED, PvGEA, LiGEA, and SoyBase datasets 275 (Figure 3D) confirmed the notion that nodule formation in M. sativa, P. vulgaris, L. 276 japonicus, and soybean is also associated with the expression of large numbers of 277 278 low Shannon entropy genes that are (nearly) uniquely expressed in that organ. Soybean/P. vulgaris, L. japonicus and M. truncatula/M. sativa belong to different 279 clades of legumes: the Milletioids, Robinioids, and IRLC (inverted repeat-lacking 280 clade), respectively. Thus, the reliance on large gene sets that are uniquely 281 expressed in the nodule is not restricted to Medicago spp. and is not a specific 282 feature of the particular nodule types formed by these species, which are of the 283 284 indeterminate type and induce terminal bacteroid differentiation. Both of these features are not present in bean, soybean, or *L. japonicus* nodules. However, the 285 nodule-specific gene sets in *Medicago* spp. appear to be significantly larger than 286 287 those in the other legumes (Figure 3). This difference is largely due to the extremely high number of *Medicago* genes encoding NCR peptides (Mergaert et al., 2003). In 288 289 M. truncatula, the NCR gene family is composed of approximately 600 genes and in tetraploid M. sativa, the number of NCR genes increases to 1300 (O'Rourke et al., 290 291 2015), whereas these genes are absent in the three other legumes. Besides the NCR gene family, there are many other nodule-specific, low entropy 292 genes. Among these are well-studied genes, some with essential functions in 293 294 symbiosis (e.g. genes encoding leghemoglobin, SNARPs [small nodulin acidic RNAbinding protein, also known as LEED..PEEDs], the phospholipase C-like DNF2 295 (defective in nitrogen fixation), the cysteine-rich receptor-like kinase SymCRK, 296

metabolite transporters, and so on) and many genes with only predicted or 297 uncharacterized functions (e.g. putative transporter encoding genes, GRPs (glycine-298 rich proteins), early nodulins ENOD8 and ENOD16, calmodulin-like proteins, and so 299 on) or genes of unknown function. Importantly, the nodule-specific transcriptome 300 contains several families of orphan genes or taxonomically restricted genes (genes 301 without homologs in other lineages), including the NCRs, SNARPs, and GRPs, which 302 are restricted to the IRLC legumes (Mergaert et al., 2003; Kevei et al., 2002; Laporte 303 et al., 2010; Trujillo et al., 2014), the NCR genes of Aeschynomene spp. (Czernic et 304 305 al., 2015), the NAD1 (nodules with activated defense 1) genes conserved only in plants from the NFC (Wang et al., 2016), and the nodulin 20 family, first identified in 306 307 soybean (Richter et al., 1991), which is specific for the Phaseoleae (Trujillo et al., 2019). Such genes could have arisen from the duplication and rearrangement of 308 ancestral genes followed by rapid diversification. Alternatively, orphan genes could 309 have evolved de novo from non-coding genomic regions believed to be used as raw 310 311 materials for the evolution of new genes (Tautz and Domazet-lošo 2011). A number of low-entropy nodule-specific genes encode proteins with unique 312 combinations of existing domains, likely resulting from gene recombination. For 313 example, the symbiosis-specific thioredoxin Trx s, Calmodulin-like protein, and 314 ENOD8 families evolved from fusions of known protein domains with an N-terminal 315 signal peptide, resulting in unique secretory proteins targeted to symbiosomes and 316 bacteroids. There are a remarkably high number of low-entropy genes with signal 317 peptides, suggesting that symbiotic cells target many proteins and peptides to the 318 symbiosomes (Figure 1D) (e.g. NCRs, GRPs, SNARPs, calmodulin-like proteins, 319 320 ENOD8, ENOD16, ENOD20, DNF2, SymCRK, Trx s, nodulin 25, MtN22, MtN11, lipase/lipoxygenases (also known as nodule-specific PLAT domain proteins or 321 322 NPDs), basic blue-like protein, NCR-like peptides, MBP-1, and CAP antimicrobial peptides in the Dalbergioid lineage, nodulin 20 family proteins of the Phaseoleae, 323 324 APN1 of L. japonicus, and so on) (Maunoury et al., 2010; Alunni et al., 2007; Liu et al., 2006; Dickstein et al., 2002; Laporte et al., 2010; Trujillo et al., 2014; Pecrix et al., 325 326 2018; Trujillo et al., 2019; Pislariu et al., 2019; Yamaya-Ito et al., 2017). The high level of protein secretion to symbiosomes and bacteroids in symbiotic cells of M. 327 328 truncatula, particularly in developing and young mature cells, is further supported by the strongly developed endoplasmic reticulum in these cells (Maunoury et al., 2010) 329

for normal bacteroid differentiation and nodule development (reviewed in Stonoha-331 Arther and Wang, 2018). 332 Other genes resulted from duplications and modifications with neofunctionalization, 333 334 such as leghemoglobin genes. Oxygen-binding leghemoglobins are essential for protecting the oxygen-sensitive enzyme nitrogenase. Their recruitment for symbiosis 335 required mutations (replacement of a few amino acids) of non-oxygen-transporting 336 hemoglobins present in all plants to create an oxygen-transporting hemoglobin, as 337 well as nodule-specific expression of the corresponding genes. Other genes also 338 resulted from duplication, whereby one paralog obtained a new, nodule-specific 339 340 expression profile but without a new function. Genes encoding subunits of a nodulespecific signal peptidase complex, including *Dnf1*, fall in this category (Wang et al., 341 2010). This endoplasmic reticulum-localized enzyme complex of the secretory 342 pathway is required for removing the signal peptide during trafficking of secretory 343 proteins. The NPDs in the IRLCs and the MBP-1 and CAP peptides in the 344 Dalbergioids are encoded by multigene families including nodule-specific subsets as 345 well as subsets with constitutive expression (Trujilo et al., 2019). Other examples are 346 the many small metabolite transporter genes that are essential for the formation of 347 functional nodules (Figure 1F) (e.g. Sugiyama et al., 2017; Frare et al., 2018; 348 Senovilla et al., 2018; Chen et al., 2019). These genes belong to small multigene 349 350 families, with one copy having nodule-specific or nodule-enhanced expression. The encoded transporters assure the transport of metabolites to and from the symbiotic 351 cells and bacteroids and are essential for the metabolic integration of bacteroids with 352 353 symbiotic nodule cells. A similar situation holds true for the many genes encoding the enzymes involved in the specific carbon and nitrogen metabolism of symbiotic cells 354 355 (Figure 1F). Carbon metabolism provides the carbon source to bacteroids in the form of dicarboxylic acids and synthesizes the carbon backbone for assimilation of the 356 357 ammonium derived from nitrogen fixation in bacteroids. Nitrogen metabolism assures that this nitrogen is assimilated into amino acids or in some legumes into ureides. A 358 359 large body of evidence indicates that the key enzymes of carbon and nitrogen metabolism in symbiotic cells are encoded by nodule-specific genes. Like small-360 361 metabolite transporters, metabolic genes are also members of small gene families,

and by the requirement of symbiotic cell-specific regulators of the secretory pathway

- with one copy having a nodule-specific or -enhanced expression (e.g. Miller et al.,
- 363 1998; Hakoyama et al., 2009; Nouwen et al., 2017).
- The large number of rhizobia in symbiotic cells implies the massive presence of
- PAMPs (pathogen-associated molecular patterns) and the potential to induce strong
- PAMP triggered immunity (PTI). Several symbiotic cell-specific proteins are required
- to suppress the PTI response and to enable the long-term maintenance of rhizobia
- 368 (Figure 1D). In the absence of the receptor-like kinase SymCRK, the phospholipase
- 369 C-like DNF2, the PLAT Domain protein NPD1, the transcription factor RSD, or the
- endoplasmic reticulum located small protein NAD1, a strong immune response is
- induced, as evidenced by the induction of immunity marker genes, nodule necrosis,
- and a complete halting of symbiosis (Bourcy et al., 2013; Sinharoy et al., 2013;
- Berrabah et al., 2014; Wang et al., 2016; Domonkos et al., 2017; Pislariu et al.,
- 2019). The genes encoding these immune repressors are low entropy genes that are
- only expressed in symbiotic nodule cells. SymCRK, DNF2, NPD1, and RSD are
- nodule-specific paralogs, whereas *NAD1* is unique and appears to be specific to the
- NFC (Wang et al., 2016), suggesting that it was present in the ancestor of the NFC.

Examples of Functional Insights from Nodule Transcriptomics

- As mentioned above, nodule formation has been studied by transcriptomics in many
- legumes and non-legume species, and several studies have focused on specific
- aspects of the symbiotic process in these NFC plants (e.g. Høgslund et al., 2009;
- Libault et al., 2009a; Libault et al., 2010; Yuan et al., 2017; van Velzen et al., 2018).
- Undoubly, transcriptomics have been used most extensively in *M. truncatula* to study
- nodule development, from very early responses induced by Nod factors and gene
- activation in root hairs (Combier et al., 2008; Breakspear et al., 2014; Czaja et al.,
- 386 2012; Jardinaud et al., 2016; Van Zeijl et al., 2015; Larrainzar et al., 2015) to the
- development of mature nodules (El Yahyaoui et al., 2004; Maunoury et al., 2010;
- Moreau et al., 2011). Analyses focusing on the early responses to Nod factors and
- 389 rhizobia have used clever tricks to overcome the limited sensitivity in detecting
- transcriptional responses in the small number of Nod factor- or rhizobium-responsive
- cells in roots. These solutions included preparing RNA from the roots of
- 392 supernodulating plant mutants, which have a strongly enhanced nodulation response
- (Combier et al., 2008; Larrainzar et al., 2015). Alternatively, analysis has been
- performed using as a starting material purified root hairs, the first target cells of Nod

factors and rhizobia, obtained by breaking them off from roots frozen in liquid 395 nitrogen (Breakspear et al., 2014; Damiani et al., 2016; Liu et al., 2019a) or root 396 epidermal cells obtained by LCM (Jardinaud et al., 2016). Analysis of the early 397 symbiotic signaling responses highlighted the importance of cytokinin, auxin, 398 ethylene, strigolactone, abscisic acid, gibberellic acid, and brassinosteroid 399 phytohormone signaling pathways. This observation suggests that an important 400 rewiring of the interconnected phytohormone pathways is a key step in the initiation 401 of nodule organogenesis (Breakspear et al., 2014; Czaja et al., 2012; Jardinaud et 402 403 al., 2016; Van Zeijl et al., 2015; Larrainzar et al., 2015; Liu et al., 2019a; reviewed in Gamas et al., 2017; Liu et al., 2018; Buhian and Bensmihen, 2018). These studies 404 405 confirmed the activation of cell cycle-related processes early in the nodulation signaling pathway (Breakspear et al., 2014; Jardinaud et al., 2016; Larrainzar et al., 406 407 2015), which is in agreement with the known role of the cell cycle in the establishment of a nodule primordium (Foucher and Kondorosi, 2000), cell 408 409 differentiation (Vinardell et al., 2003; Suzaki et al., 2014), and infection (Van Brussel et al., 1992; Yang et al., 1994; Suzaki et al., 2014). Another striking finding is the 410 411 identification of the gene encoding the rapid alkanization factor MtRALF1 peptide as a Nod factor-induced gene controlling infection thread development (Combier et al., 412 2008). Peptides of this family control cell expansion in plants, notably during root hair 413 and pollen tube growth (Murphy and De Smet, 2014; Haruta et al., 2014; Mecchia et 414 al., 2017; Ge et al., 2017), the two plant cell types that show the highest similarity to 415 the infection thread structure. Notably, these RALF peptides interact with receptor-416 like kinases containing a so-called malectin-like domain within their ectodomain 417 (Franck et al., 2018). Such a domain is also present and plays a key role in the 418 ectodomain of the receptor-like kinase SYMRK/DMI2/NORK (Antolin-Llovera et al., 419 2014; Pan and Wang, 2018), a component of the CSSP, suggesting that MtRALF1 420 targets the Nod factor receptor complex, a hypothesis that might be worth pursuing. 421 422 Using time series of wild-type nodule growth combined with collections of both rhizobial and plant mutants arrested at different stages of nodule development, 423 424 transcriptome dynamics during nodule organogenesis was dissected into distinct transcriptional waves composed of the induction and repression of genes that are 425 426 consecutively initiated during organogenesis (Starker et al., 2006; Maunoury et al., 2010; Moreau et al., 2011; Lang and Long, 2015). Four major waves of gene 427

activation were uncovered using these approaches. The first wave is associated with 428 early signaling and bacterial infections, the second with symbiotic cell differentiation, 429 the third with the differentiation of bacteroids, and the fourth with the activation of 430 nitrogen fixation. 431 432 In addition to studies that focused on the overall transcriptome dynamics associated with nodule development, other studies have used transcriptomics to address more 433 specific questions. The transcriptomes in non-functional nodules formed by M. 434 truncatula mutants in transcriptional regulators were used to characterize the stages 435 of nodule development affected by the mutations at the molecular level and to 436 delineate the sets of potential target genes of these transcriptional regulators (see 437 below; Vernié et al., 2008; Satgé et al., 2016; Sinharoy et al., 2013; Deng et al., 438 2019). Another type of study used transcriptomics to investigate particular 439 physiological conditions in nodules. During nodule senescence, nodule cells break 440 down and their macromolecular components are degraded and remobilized to other 441 plant organs (Van de Velde et al., 2006). The process can be developmentally 442 induced by the aging of nodules or when the host plants need to shift their nutrient 443 resources for seed production. Nodule senescence can also be induced by particular 444 physiological conditions, including reduced photosynthesis, nutrient starvation, or a 445 shift in the nitrogen status of the plant. Nodule senescence under these different 446 conditions has been studied intensively by transcriptomics (Van de Velde et al., 2006; 447 Seabra et al., 2012; Cabeza et al., 2013; Cabeza et al., 2014; Liese et al., 2017; 448 Deng et al., 2019), which has led to the identification of marker genes and actors in 449 the process. Cysteine proteinases appear to be key players in nodule senescence: 450 451 manipulating their expression causes delayed or premature senescence, thus affecting nitrogen fixation (Pierre et al., 2014; Deng et al., 2019). 452 Other studies have used transcriptomics and dedicated Affymetrix gene chips to 453 focus on the expression of NCR and other defensin-like peptide genes in M. 454 truncatula (Nallu et al., 2013; Tesfaye et al., 2013). The results confirmed the notion 455 that NCRs are nodule-specific peptides and revealed a distinct subset of defensin-456 like genes unrelated to the NCRs that are specifically expressed in seeds. Like M. 457 truncatula, many defensin-like peptides are also expressed in both the inflorescences 458 459 and seeds of *Arabidopsis*. The peptides in these organs may play roles in defense. Indeed, the abundant expression of defensin-like peptides may reflect a specific, 460

strongly protected immune status of reproductive organs. In an RNA-seq study 461 focusing on small, secreted peptides that act via receptor-mediated signaling, 365 462 peptides belonging to 29 different putative functional peptide families were identified 463 whose expression changed during nodule formation, suggesting that peptide 464 signaling plays a prominent role in the coordination of nodulation (de Bang et al., 465 2017). This data set produced in this study represents a rich resource for future work 466 aiming to decipher the functions of these peptides. 467 The genotypes of both the *Rhizobium* and legume influence the outcome of the 468 interaction and the efficiency of the nitrogen-fixation process (Sugawara et al., 2013; 469 Kazmierczak et al., 2017). Transcriptomics were used to gain insights in the 470 471 molecular basis of these genotype-by-genotype variations in *M. truncatula*-Sinorhizobium symbiosis (Heath et al., 2012; Nallu et al., 2014; Burghardt et al., 472 473 2017). These studies revealed a high degree of genotype-by-genotype variability in the transcriptomes that was more dependent on the host genotype than the bacterial 474 475 symbiont genotype. In particularly, NCR expression is highly variable, suggesting that the NCRs and the differentiation of the bacteroids induced by NCRs are important 476 determinants of the efficiency of symbiosis (Kazmierczak et al., 2017). In agreement 477 with this finding, the orthologous NCR genes within a collection of *M. truncatula* 478 accessions showed a high degree of nucleotide variation with signatures of 479 diversifying selection pressure, suggesting that NCR genes are rapidly and recently 480 evolving, possibly to help plants adapt to diversifying rhizobium symbionts (Branca et 481 al., 2011; Nallu et al., 2014; Zhou et al., 2017). 482 Many transcriptome studies have been performed using whole nodules and did not 483 provide information on the cell type-specific expression of nodule-enhanced or 484 nodule-specific genes. Indeterminate *M. truncatula* nodules are complex organs 485 composed of many cell types. Differentially expressed genes could be specifically 486 expressed in one or several of these cell types. However, some studies have 487 provided spatial resolution at the level of cell type or nodule tissue (Maunoury et al., 488 2010, Roux et al., 2014, Limpens et al., 2013). These studies demonstrated that the 489 large majority of nodule-enhanced or nodule-specific genes are expressed in 490 491 differentiating or mature symbiotic cells. By analyzing different stages of nodule 492 development in conjunction with a large panel of symbiotic mutants arrested in 493 nodule development, two major transcriptome switches (regulating a large proportion

of nodule-enhanced or -specific genes) were revealed, one that correlated with 494 symbiotic cell maturation and another one with bacteroid differentiation (Maunoury et 495 al., 2010). An impressive improvement in transcriptome analysis was achieved by 496 combining LCM of nodule tissues with Affymetrix gene chips (Limpens et al., 2013) or 497 RNA-seg analysis (Roux et al., 2014; Jardinaud et al., 2016), providing spatial 498 resolution to global gene expression analysis in nodules (Figure 4). The dissection of 499 nodules by LCM-RNA-seq confirmed the conclusion that a large majority (over 90%) 500 of the 1200 nodule-enhanced or -specific genes are expressed in differentiating or 501 502 mature symbiotic cells (Roux et al., 2014) (Figure 3C). This observation reinforces the notion that symbiotic nodule cells are unique cell types that have complex needs 503 504 for their formation and maintenance and for the metabolic integration of endosymbionts. 505 New technologies could in the (near) future further improve the spatial resolution to 506 the level of nodule tissue subdomains or even single cells, which would resolve non-507 508 uniform responses that are averaged over the population of cells in multi-cell samples or unmask unique biological properties of single cells that are too diluted in 509 populations to be discovered in multi-cell samples. These new methods include 510 single cell-type or single cell transcriptome analysis. Single cell types or single cells 511 or the corresponding nuclei could be obtained through LCM, through isolating nuclei 512 tagged in specific cell types (INTACT), or through flow cytometry and sorting of nuclei 513 based on genome size (Figure 4; Libault, 2018). The latter technique could also be 514 combined with fluorescent labeling of nuclei in specific cells in transgenic plant lines 515 with cell type-specific promoters driving the expression of a fluorescent marker. Other 516 517 new technologies, including spatial transcriptomics and Slide-seq, that could be applied to nodule gene expression analysis, are based on the transfer of RNA from 518 519 tissue sections onto a surface coated with spatially structured molecular barcodes that are sequenced together with the transferred RNA, generating spatially resolved 520 521 RNA-seg transcriptome data (Figure 4) (Ståhl et al., 2016; Rodrigues et al., 2019). **Genome Organization of Nodule-Specific Genes** 522 Nodule-specific genes often form small, intermediate, or even very large gene 523 families, as observed for the NCR genes in many IRLC legumes (Montiel et al., 524 2017). After their birth, the NCR genes in these plants must have spread massively 525

through the genome by repetitive gene duplications. NCR genes appear in small

- clusters, which are spread across the genome in *M. truncatula* (Graham et al., 2004;
- Alunni et al., 2007; Zhou et al., 2017), indicating that long-distance duplications
- followed by local duplications must have played a role in the spreading of NCR
- genes. A well-documented mechanism for generating gene duplications is based on
- transposon-mediated non-homologous recombination and retrotranscription (Galindo-
- González et al., 2017). Many NCR genes in M. truncatula are in the vicinity of
- transposable elements, indicating transposons were (and possibly still are) involved
- in the explosion of the NCR gene family in the *M. truncatula* genome (Graham et al.,
- 535 2004; Satgé et al., 2016).
- Besides NCR genes, other nodule-specific genes in *M. truncatula*, particularly those
- expressed in differentiating and mature symbiotic cells, also display local
- duplications, including genes encoding GRPs, SNARPs, NPDs, calmodulin-like
- proteins, ENOD8, leghemoglobins, the ammonium channel NOD26, and others
- (Alunni et al., 2007; Liu et al., 2006; Dickstein et al., 2002; Trujillo et al., 2014; Frare
- et al., 2018; Pecrix et al., 2018; Trujillo et al., 2019). These clusters are distributed all
- over the *M. truncatula* genome and strikingly, in addition to locally duplicated genes,
- they often contain different types of nodule-specific genes (Liu et al., 2006; Pecrix et
- al., 2018). These genome clusters of nodule-specific genes are called symbiosis-
- related islands (SRIs). Almost 300 SRIs were identified in the *M. truncatula* genome,
- which on average contain more than seven nodule-enhanced genes and more than
- 547 five distinct gene families. Besides the above-mentioned genes, several other well-
- known, important symbiotic genes are located within SRIs (for example, *RPG*
- 549 [RHIZOBIUM-DIRECTED POLAR GROWTH], ENOD40, ENOD11, ENOD12, IRE
- 550 [INCOMPLETE ROOT HAIR ELONGATION], SymCRK, RSD, and SYMREM1
- 551 [SYMBIOTIC REMORIN1]). This clustered gene organization is thought to contribute
- to the nodule-specific regulation of SRI-localized genes (Pecrix et al., 2018).

The Evolution of Nodulation

- To date, no systematic meta-analysis has been performed that compares the details
- of the transcriptomes of all analyzed NFC plants to identify (for example) the common
- 556 nodule-enhanced genes. The upstream regulatory hierarchy that orchestrates the
- genetic program underlying nodulation in the host, the CSSP, is functionally
- conserved between legumes, *Parasponia*, and actinorhizal plants (Gherbi et al.,
- 2008; Markmann et al., 2008; Svistoonoff et al., 2013; Clavijo et al. 2015; Granqvist

et al., 2015; van Zeijl et al., 2018; Battenberg et al 2018; van Velzen et al., 2018). 560 However, the extent of conservation of the other actors in nodulation downstream of 561 these master regulators is currently unknown. Nevertheless, analyses have recently 562 started to address this question by defining orthologous groups between NFC plant 563 species and identifying common nodule-enhanced genes. One study compared root 564 and nodule transcriptomes in the actinorhizal plants C. thyrsiflorus and D. glomerata 565 and the legume *M. truncatula* and identified a set of only 51 genes commonly 566 induced in the nodules of these three NFC plants (Battenberg et al 2018). A 567 568 comparison focusing on the low-entropy nodule-specific gene sets in soybean, L. japonicus, P. vulgaris and M. truncatula found only 12 common orthologous genes 569 570 between the four species and 34 to 70 common genes in pairwise comparisons (Wu 571 et al., 2019). These results suggest that these nodule-specific gene sets appeared 572 late in evolution and independently in the legume clades. However, another study comparing the P. andersonii-nodule transcriptome obtained by RNA-seq with 573 574 comparable M. truncatula data found a more substantial overlap (van Velzen et al., 2018). Among the 1719 and 2753 nodule-enhanced genes in P. andersonii and M. 575 576 truncatula, respectively (Roux et al., 2014) (genes that are upregulated at least twofold in young mature nodules vs. uninfected roots), 290 putative orthologs were 577 found. This common set of genes activated in P. andersonii and M. truncatula 578 nodules includes genes encoding several known symbiosis regulators, signaling 579 proteins, and TFs, as well as metabolic proteins such as enzymes and metabolite 580 transporters. The common genes were further classified into two functional 581 categories based on their expression profiles in nitrogen-fixing *P. andersonii* nodules 582 and in uninfected non-functional nodules. Of the 290 common genes, 126 were 583 upregulated in both functional and non-functional nodules, suggesting they play roles 584 related to nodule organogenesis. The 164 remaining genes were only induced in 585 infected and functional nodules and are therefore associated with infection or 586 587 nitrogen fixation (van Velzen et al., 2018). At first glance, the list of 290 common genes between these two nodule 588 589 transcriptomes appears to be relatively small in light of the 1719 and 2753 noduleenhanced genes in these species, suggesting that the functions of these nodules 590 591 primarily involve different gene sets. However, the two plants diverged approximately 100 MYA, which may have brought about this functional divergence. Moreover, this 592

comparison has to be placed in the context of the evolution of nodulation and 593 symbiotic nitrogen fixation. Two opposing evolutionary models for nodulation have 594 been proposed (Figure 5A,B). Until recently, the prevailing hypothesis (based on 595 phylogenetic ancestral state reconstruction and the strong differences in nodules of 596 different lineages) considered the evolution of nodulation to be a two-step process. 597 The initial step was the acquisition of an uncharacterized predisposition for 598 nodulation by the ancestor of the NFC over 100 MYA, which was followed (at least 30 599 MY later) by the independent acquisition or convergent evolution of nodulation in six 600 to ten different lineages of the NFC (Figure 5A) (Soltis et al., 1995; Werner et al., 601 602 2014; Doyle, 2016). This hypothesis implies multiple independent recruitments for 603 nodulation of the CSSP, that pre-existed and functioned in mycrorrhization in these 604 lineages, an evolutionary scenario known as deep homology that has repeatedly 605 been identified for animal structures (e.g. eyes and limbs) (Shubin et al., 2009). Under this scenario, nodulation evolved independently in *Medicago* and *Parasponia*, 606 607 implying that the 290 common genes in *P. andersonii* and *M. truncatula* nodules arose through complex convergent evolution. 608 Therefore, van Velzen et al. proposed the challenging hypothesis that nodulation 609 arose already in the common ancestor of the NFC (van Velzen et al., 2018; van 610 Velzen et al., 2019). Besides the substantial overlap in the nodule transcriptomes of 611 P. andersonii and M. truncatula, including 126 putative organogenesis genes, this 612 new hypothesis is also based on the independent and recent losses or 613 pseudogenizations of the essential symbiosis genes NFP, NIN, and RPG in non-614 nodulating plants of multiple lineages of the NFC (van Velzen et al., 2018; Griesmann 615 616 et al., 2018). Together, these observations can be interpreted as a single gain of nodulation at the origin of the NFC and subsequent multiple losses in the current 617 618 non-nodulating lineages (Figure 5B). Since the divergence of the four orders of the NFC occurred very rapidly (~104 MYA) after the divergence of the NFC itself from its 619 sister clades (~110 MYA), a period of only a few MYs (Wang et al., 2009; Li et al., 620 621 2015), this hypothesis implies that nodule organogenesis evolved in a very short 622 time, within these few MYs. Alternatively, perhaps nodulation and nitrogen-fixing symbiosis are much more ancient than previously thought and have been lost 623 624 altogether in the NFC sister clades.

A possible evolutionary scenario leading to nodule formation is that the existing interaction with mycorrhiza in the ancestor for nodulation was extended to a bacterial nitrogen-fixing symbiont, resulting in the infection of root cortical cells with bacteria rather than fungi. This interaction used the already present CSSP and recruited additional genes. One of the new key functions could have been the suppression of immunity against bacteria in infected root cells. NAD1, a conserved protein specific to the NFC, might represent an early recruited immunity suppressor (Wang et al., 2016). Perhaps the ammonium channel NOD26, which is involved in the uptake of ammonium produced by bacteroids from the symbiosomes into the symbiotic cells, represents another early innovation (Frare et al., 2018). This transporter, along with ammonium assimilation enzymes, is required for the metabolic integration of the nitrogen fixing symbiont. At the regulatory level, the TF NIN, which is required for nodule organogenesis and infection in present-day plants, might have been recruited early on by the CSSP from a pre-existing TF family of NIN-like proteins (NLPs) implicated in the regulation of nitrogen homeostasis in plants (Soyano et al., 2014; Clavijo et al., 2015). Another innovation must have been the activation of the cell cycle in differentiated root cells to increase the number of infected cells by cell proliferation and to direct organogenesis. This step could have been accomplished through the recruitment of cytokinin signaling by NIN, a crucial step in the initiation of root cortical cell division in legumes (Schauser et al., 1999; Vernié et al., 2015; Gamas et al., 2017), although the role of cytokinin signaling in nodulation has not been confirmed in the other clades of the NFC (Van Zeijl et al., 2018; Gauthier-Coles et al., 2019). Subsequently, the evolution of nodulation may have occurred via a gradual process that created an ever increasing mass of infected symbiotic cells, providing more and more nitrogen to the host until the full nitrogen needs of the plant were met (Figure 5B). The new model of van Velzen et al. (2019) further proposes that symbiosis with Frankia occurred at the NFC origin and subsequent independent switches to rhizobia occurred in the ancestor of legumes and *Parasponia*. This proposition is based on the finding that legumes and *Parasponia* use paralogous and not homologous hemoglobin genes in nodules to protect the oxygen-sensitive nitrogenase enzyme of the rhizobium symbionts (Sturms et al., 2010). Nitrogen fixation by *Frankia* does not require an external oxygen scavenger because these bacteria are able to create their

own oxygen barrier by forming a shell of hopanoid lipids. Legumes recruited class 2 658 hemoglobins and *Parasponia* independently recruited a class 1 hemoglobin to 659 function as oxygen transporters in nitrogen-fixing symbiotic nodule cells. Thus, in this 660 second evolutionary scenario, nodulation with Frankia in proto-legumes and 661 Parasponia shares a relatively short common evolutionary history from the origin of 662 nodulation to the diversification of the two lineages, followed by 100 MY of separation 663 during which both lineages independently switched from hosting Frankia to rhizobia. 664 The symbiont exchange could have been achieved through a temporary phase of co-665 666 infection of nodules by the primary *Frankia* symbiont and a secondary rhizobium symbiont, followed by the full overtaking of Frankia by the rhizobia. Indeed, co-667 668 infection of nodules by a nodule-inducing bacterium and a non-nodulating bacterium is often observed in legumes and actinorhizal plants (Martínez-Hidalgo and Hirsch, 669 670 2017).. Furthermore, the replacement of the symbiont likely required new host functions for recognizing the new symbionts (which have a distinct cell envelope) and 671 672 for suppressing immune responses against the rhizobia. From the bacterial side, the rhizobia acquired the nodulation genes required for Nod factor synthesis (Figure 1A), 673 674 although the origin of these genes is still an enigma. Nod factors were required to replace the *Frankia* factors that triggered the nodulation program, and they also 675 helped suppress immune responses by the host (Liang et al., 2013). 676 One could also envision a third, in-between scenario in which the ancestor of the 677 NFC established an interaction with *Frankia* spp. without nodule formation and 678 organogenesis, instead forming nitrogen-fixing structures similar to arbuscular 679 mycorrhiza (structures formed without organogenesis) with little or no cell division, 680 681 facilitating bacterial uptake and forming infection foci (Figure 5C) (see Parniske 2018 for an inspiring discussion on this scenario). In other words, in this third scenario, the 682 hypothetical "predisposition of nodulation" of scenario 1 would correspond to the 683 replacement (or extension) of a mycorrhizal fungus with a filamentous bacterial 684 685 symbiont of the *Frankia* genus. During the second stage, *Frankia* were replaced by rhizobia independently in legumes and *Parasponia*, as described in scenario 2. 686 687 Finally, during the third stage, nodule organogenesis evolved independently in multiple lineages. The timing of stage two and three could also be inverted. The 688 689 present day absence of nodulation in many lineages of the NFC could correspond to the loss of nodulation or the loss of the more ancient nitrogen-fixing Frankia 690

presence of putative organogenesis-related genes in the common gene set of the Medicago and Parasponia transcriptomes. However, this overlap could represent the combined result of the early shared evolution towards a simple infection focus in the root cortex and the later convergent recruitment of orthologous gene functions after the separation of the two lineages. Moreover, the three symbiosis genes (NFP, NIN and RPG) that were lost in non-nodulating plants of the NFC are involved in infection and are thus not necessarily (exclusive) markers of nodule organogenesis. On the other hand, the third scenario fits well with the existing differences in infection, ontogeny, and physiology of nodules formed by plants in the different lineages of the NFC. For example, the nodules of *Parasponia* and actinorhizal plants have a central vascular bundle, whereas the nodules of legumes contain multiple peripheral vascular bundles (Downie, 2014; Behm et al., 2014). In addition, legumes and nonlegumes of the NFC differ in their reliance on cytokinin signaling (Van Zeijl et al., 2018; Gauthier-Coles et al., 2019). Finally, the nodule-specific transcriptomes of different plants are largely dissimilar (Battenberg et al 2018; Wu et al., 2019) (despite the overlap of a subset of nodule-enhanced genes in *Medicago* and *Parasponia*; van Velzen et al., 2018), suggesting that organogenesis in these plants followed distinct evolutionary paths. Investigating whether the large overlap between nodule transcriptomes observed between *P. andersonii* and *M. truncatula* could be extended to all nodulating plants could be informative. The available nodule transcriptomes from legumes cover all the major clades of the Papilionoideae subfamily, the hologalegina (Medicago, Pisum, Lotus, Sesbania), the millettioids (*Phaseolus*, *Glycine*), and the genistoids (*Lupinus*), but no data are available for species of the other large clade of the Leguminosae, the Mimosoideae-Caesalpineae-Cassieae (MCC) clade. In the non-legume NFC plants, the Cucurbitales are represented by the Datsica transcriptome, the Fagales by the Alnus and Casuarina transcriptomes, and the Rosales by C. thyrsiflorus and the rhizobium-infected *Parasponia* transcriptomes. A systematic comparative analysis identifying orthologous genes in the available transcriptome data, complemented with new data from the unexplored branches of the legume family, would certainly provide insights into the evolutionary scenario of nodulation. Such analysis would further

symbiosis without organogenesis. It is harder to reconcile this third scenario with the

highlight the mechanisms in nodulation that are ancestral and those that are more recent innovations specific to particular lineages of the NFC.

REGULATION OF THE NODULE TRANSCRIPTOME

Transcription Factors

The stimulation of the CSSP by Nod factors results in the activation of a TF network 728 composed of IPD3 (CYCLOPS), IPD3L, NIN, NSP1, NSP2, DELLA proteins, ERN1, 729 ERN2, NF-YA1, and potentially other yet-to-be identified TFs (Schauser et al., 1999; 730 Kalo et al., 2005; Smit et al., 2005; Asamizu et al., 2008; Jin et al., 2018; Marsh et al., 731 732 2007; Combier et al., 2006; Andriankaja et al., 2007; Middleton et al., 2007; Cerri et al., 2012; Fonouni-Farde et al., 2016; Jin et al., 2016; Singh et al., 2014; for reviews 733 734 on the topic, see Oldroyd, 2013; Soyano and Hayashi, 2014; Roy et al., 2019). This TF network activates the infection process, nodule organogenesis, and 735 736 autoregulation of nodulation (AON, a long-distance negative-feedback pathway that controls nodule number based on the number of already formed or initiated nodules 737 738 and the nitrogen needs of the plant) (Figure 1A). The NIN TF emerged from these studies as a master regulator of nodulation that coordinates these processes 739 (Soyano et al., 2013; Vernié et al., 2015; Liu et al., 2019a; Liu et al., 2019b), which is 740 in agreement with the proposed early recruitment of NIN during the evolution of 741 nodulation in the NFC. Several direct target genes of this network have been 742 identified (e.g. ENOD11, CRE1, NPL1 [NODULATION PECTATE LYASE 1], CLE), 743 but how this TF network further connects to the downstream nodule transcriptome 744 and the massive reprogramming in the symbiotic cells (Figure 2B) remains to be 745 clarified. This regulation most likely involves the generation of secondary signals 746 (such as phytohormones and others) as well as a downstream TF network. 747 Nevertheless, some TFs involved in late stages of nodule formation have been 748 749 identified, but they have no direct link to transcription in symbiotic cells or their roles remain to be pinpointed. A few early studies have identified potential regulators in 750 751 symbiotic nodule cells, which were not further characterized (Heard and Dunn, 1995; Heard et al., 1997; Jørgensen et al., 1999). Other transcriptional regulators, such as 752 753 the Medicago Krüppel TF MtZPT2, the Medicago basic helix-loop-helix TF MtbHLH1, NOOT in *Medicago* and *Lotus* (belonging to the NPR1-like BTB/POZ-Ankyrin domain 754

protein family), and soybean GmbHLHm1 (formerly GmSAT1) are important for 755 nodule formation but are not directly involved in symbiotic cell-specific gene 756 regulation. Their genes are not expressed in symbiotic cells but are instead 757 expressed in roots and nodule vascular bundles or nodule parenchyma, where they 758 affect nodule vasculature patterning and nutrient transport between nodules and 759 roots (Frugier et al., 2000; Godiard et al., 2011; Couzigou et al., 2012; Chiasson et 760 al., 2014; Magne et al., 2018). 761 Other characterized TFs have demonstrated roles in symbiotic cell formation. The TF 762 763 EFD, belonging to the ethylene response factor family, controls symbiotic cell formation, bacteroid differentiation and the expression of a subset of nodule-specific 764 genes, including some NCR genes (Vernié et al., 2008). However, this regulation of 765 nodule-specific genes could be indirect, as MtRR4 is the only gene found to be 766 767 directly regulated by EFD (Vernié et al., 2008). MtRR4 is a type A cytokinin response regulator induced by cytokinins that is part of a negative feedback loop involved in 768 769 repressing the cytokinin pathway. Cytokinins are key signals that activate cell divisions in the root cortex to establish a nodule primordium (Gamas et al., 2017). 770 The repression of cytokinin signaling mediated by EFD through MtRR4 might be 771 essential for promoting symbiotic cell differentiation. Furthermore, a group of three 772 class 2 KNOX homeodomain TFs directly or indirectly regulate EFD and MtRR4 773 expression (Di Giacomo et al., 2017; Azarakhsh et al., 2015). One of these KNOX 774 TFs, MtKNOX3, is strongly induced in nodules and is active in differentiating 775 symbiotic cells. This TF could be involved in regulating other genes, including 776 symbiotic cell-specific genes. 777 778 The C₂H₂ TF RSD is expressed in differentiating symbiotic cells and is required for symbiosome formation. However, data suggest that RSD act as a repressor of a 779 780 small set of genes to influence vesicle transport in symbiotic cells and avoid mistargeting of specific vesicles and their cargo to symbiosomes (Sinharoy et al., 2013). 781 782 Thus, the present data on RSD are not in agreement with a role of this TF in positively activating symbiotic cell-specific gene expression. Similarly, the Medicago 783 TF MtbHLH2 might be expressed in infected nodule cells but is thought to act as a 784 785 negative regulator of genes that stimulate nodule senescence (Deng et al., 2019). A small set of APETALA2 TFs in soybean, L. japonicus, and P. vulgaris might have a 786 negative effect on nodulation, including symbiotic cell functioning. These TF were 787

identified because they are targeted by a nodule-enhanced miRNA (see below), and 788 their upregulation in symbiotic cells may be correlated with the activation of 789 senescence-associated genes (Wang et al., 2014; Holt et al., 2015; Nova-Franco et 790 al., 2015). 791 792 In a large-scale effort in soybean, the expression profiles of approximately 1000 genes encoding putative transcriptional regulators were analyzed during nodule 793 formation via RT-qPCR (Libault et al., 2009a). This systematic screening identified 39 794 genes that are upregulated during nodule formation. A gene encoding a MYB TF was 795 found to be expressed in vascular tissues and not in symbiotic nodule cells. Although 796 the remaining genes were not further characterized, they constitute a collection of 797 putative regulators in symbiotic nodule cells. 798 799 Overall, very little is thus known about how the massive transcriptome switch in symbiotic nodule cells is directly regulated. Libault et al. (2009b) and Young et al. 800 (2011) cataloged all TFs in the M. truncatula genome. Analyzing the MtGEA and 801 Symbimics databases using nodule-specific or nodule-enhanced expression and 802 803 expression in symbiotic cells (IZ and zone III) as criteria resulted in the identification of a set of interesting TFs that might be involved in gene-specific regulation in 804 symbiotic cells (Supplemental Figure 1). These TFs include NIN (the above-805 mentioned master regulator of nodulation) and IPD3. IPD3 directly interacts with the 806 CSSP component calcium- and calmodulin-dependent protein kinase (CCaMK) and 807 functions in Nod factor activation of the CSSP, infection thread formation and the 808 809 release of rhizobia from infection threads, organogenesis, and symbiotic cell formation (Yano et al., 2008; Maunoury et al., 2010; Horváth et al., 2011; 810 Ovchinnikova et al., 2011; Singh et al., 2014). The transcriptome data show that *IPD3* 811 is most strongly expressed in differentiating and mature symbiotic cells of the 812 interzone and zone III. This finding corresponds with the results of IPD3 promoter-813 GUS fusion analysis (Messinese et al., 2007). CCaMK is also expressed in these 814 nodule zones but has a uniform expression pattern across all nodule tissues. These 815 expression patterns suggest that IPD3 and NIN also play important roles in 816 controlling gene expression in differentiating and mature symbiotic cells. Therefore, 817 818 NIN and IPD3 might regulate symbiotic cell- specific genes directly or indirectly (through downstream TFs). In agreement with this hypothesis, the nodule 819 820 transcriptome is not activated in the nodule-like structures formed in the *M. truncatula*

ipd3 mutant TR3 (Maunoury et al., 2010). Interestingly, genetic analyses also 821 uncovered a role for other components of the CSSP in multiple stages of nodulation 822 (Capoen et al., 2005; Limpens et al., 2005; Moling et al., 2014). These observations 823 suggest that the CSSP is a regulatory module that is used and re-used to control all 824 stages of nodulation, from the first response to Nod factors to infection thread 825 formation to the endocytotic uptake of rhizobia and to symbiotic cell differentiation 826 and functioning. During each step, this pathway appears to activate different gene 827 sets depending on the cellular context. 828 Cis-Regulatory Elements in the Promoters of Nodule-Specific Genes 829 Leghemoglobin genes, the prototypical symbiotic cell-specific genes, were the first 830 legume genes cloned (Sullivan et al., 1981). Their identification was rapidly followed 831 by the identification of other nodule-specific genes encoding nodulins (Legocki and 832 Verma, 1980; Sandal et al., 1987). The promoters of these genes were 833 experimentally screened for cis-acting elements required for high level, nodule-834 specific expression (Stougaard et al., 1987; Jensen et al., 1988; Metz et al., 1988; 835 Szabados et al., 1990; Szczyglowski et al., 1994; Frühling et al., 2000; Nallu et al., 836 2013). These elements were used to demonstrate the existence of nodule-specific 837 trans-acting factors. Unfortunately, these efforts were not further pursued, and the 838 putative TFs were not characterized (Jensen et al., 1988; Metz et al., 1988). 839 The precise identification of *cis*-acting elements should in principle facilitate the 840 straightforward screening of TFs using methods such as yeast-one-hybrid analysis. 841 Thus far, this strategy has not led to the identification symbiotic cell-specific genes. 842 Such an approach has only been performed on cis-acting elements of the Nod factor-843 responsive promoter of the very early activated gene ENOD11, resulting in the 844 identification of the TF ERN1 (Andriankaja et al., 2007). Certainly, this approach 845 holds promise for elucidating the transcriptional network in symbiotic nodule cells. 846 847 **Chromatin-Based Regulation of Nodule-Specific Gene Expression** The tight regulation of nodule-specific genes clearly requires specific TFs but in 848 addition, regulation at the chromatin level might also be important for keeping these 849 genes silent during all stages of plant development. Genes with high tissue-specific 850

expression are often actively silenced throughout much of the plant lifecycle via

epigenetic mechanisms. Chromatin-based silencing of nodule-specific genes could 852 be released during symbiotic cell differentiation, making them accessible to TFs. 853 The soybean protein CPP1 (cysteine-rich polycomb-like protein 1) is a DNA binding 854 protein that interacts with the promoter of the leghemoglobin gene *Gmlbc3* (Cvitanich 855 856 et al., 2000). CCP1 contains conserved CXC domains homologous to a domain in some polycomb proteins. CCP proteins are widely distributed in plants and animals 857 where they form small families. CCP proteins Tso1 in Arabidopsis, TESMIN in 858 mammals, Mip120 and Tombola in Drosophila, and LIN-54 in Caenorhabditis elegans 859 function in chromatin complexes and are involved in cell cycle regulation, cell 860 differentiation, and reproduction (Sijacic et al., 2011; Jiang et al., 2007; Beall et al., 861 862 2007). Despite some initial characterization in various organisms, much remains to be learned about the mechanisms of these transcriptional regulators and their 863 biological roles. Soybean CCP1 binds the *Gmlbc3* promoter and represses its 864 expression, which is in agreement with the notion that CCP1 is part of a chromatin-865 866 related repression complex. Further evidence for the key role of chromatin-based regulation in the massive gene 867 activation during symbiotic cell differentiation in M. truncatula was obtained by 868 analyzing the chromatin features of nodule-specific genes during symbiotic cell 869 870 differentiation. This differentiation is driven by endoreduplication whereby postmeristematic nodule cells switch their cell cycle to an endocycle and multiply their 871 genome from a 2C/4C DNA content in meristem cells, over 8C and 16C in 872 differentiating cells, to 32C and 64C in maturing and mature symbiotic cells (Vinardell 873 et al., 2003). Gene expression analysis of purified nodule nuclei of increasing ploidy 874 875 levels revealed a correlation between the ploidy level and the sequential activation of nodule-specific genes in these nuclei, suggesting that endoreduplication is involved 876 in this process (Nagymihály et al., 2017). The expression levels of nodule-specific 877 genes in nodule nuclei with different ploidy levels correlated with the opening of 878 879 chromatin as well as with reduced H3K27me3 (trimethylation of lysine 27 in histone H3) levels in a subset of tested genes (Nagymihály et al., 2017). Similarly, the above-880 mentioned SRIs showed reduced H3K27me3 levels in nodules vs., roots (Pecrix et 881 882 al., 2018). H3K27me3 is a repressive chromatin mark introduced by the Polycomb complex, a regulatory complex involved in the epigenetic silencing of chromatin. 883 Thus, the activation of nodule-specific genes could rely on the opening of the 884

885	chromatin and the release of H3K37me3-mediated repression during symbiotic cell
886	differentiation.
887	DNA methylation represents another level of epigenetic control of the expression of
888	symbiotic nodule cell-specific genes. DNA methylation of promoters usually leads to
889	gene silencing. A comparison of DNA methylation levels in whole roots vs. nodules or
890	in nodule nuclei of different ploidy levels showed that many symbiotic nodule cell-
891	specific genes, including genes encoding NCRs, calmodulin-like proteins,
892	leghemoglobin, GRPs, and many others, as well as many transposons, become
893	demethylated, which correlates with the activation of their expression (Satgé et al.,
894	2016; Nagymihály et al., 2017). Remarkably, SRIs show differential methylation
895	patterns in roots vs. nodules, and the borders of the SRIs sharply define the limits of
896	differentially methylated regions, with the flanking regions showing very low and non-
897	differential methylation (Pecrix et al., 2018). The DNA demethylation of nodule-
898	specific genes is largely regulated by the activation of the DNA demethylase gene
899	DEMETER (DME) during symbiotic nodule cell differentiation (Satgé et al., 2016).
900	Remarkably, DME activity also results in the loss of DNA methylation and the
901	expression of NCR-flanking transposons during symbiotic cell differentiation
902	(Guefrachi et al., 2014; Satgé et al., 2016). Since transposons are epigenetically
903	silenced, the activation of these transposons in symbiotic cells confirms the notion
904	that the re-structuring of chromatin occurs in these loci during symbiotic cell
905	differentiation.
906	Thus, epigenetic control via DNA methylation and histone modifications appears to
907	maintain the nodule-specific genes and SRIs silenced. During the endoreduplication-
908	driven differentiation of symbiotic cells, epigenetic reprogramming of these loci
909	renders them accessible and competent for transcription. However, the current data
910	only establish correlations between gene expression, chromatin modifications, and
911	endoreduplication. A future challenge will be to establish causal relationships
912	between these processes.
913	The Regulation of Gene Expression by Alternative Splicing, Small RNAs, and
914	Small Peptides
915	Additional mechanisms that control symbiotic cell-specific expression have been
916	reported. One of these mechanisms is the alternative splicing of the Syntaxin 132

(SYP132 or SYP13II) gene (Pan et al., 2016; Huisman et al., 2016). SYP132 917 encodes a t-SNARE protein that functions in the secretory pathway controlling the 918 fusion of secretory vesicles with the membrane of the target organelle. In M. 919 truncatula, SYP132 is transcribed into two different transcripts due to alternative 920 splicing. The SYP132B (or SYP132C) transcript is ubiquitously expressed, while the 921 SYP132α (or SYP132A) transcript is preferentially expressed in symbiotic nodule 922 cells and in arbuscular mycorrhiza cells. The two transcripts differ in their 13th 923 terminal exon, which in the $SYP132\beta$ transcript is located immediately downstream of 924 the previous exon. By contrast, in the SYP132α transcript, this canonical 13th exon is 925 skipped and replaced by an exon located approximately 2000 base pairs 926 927 downstream. The two encoded proteins are therefore almost identical, differing only in 60 C-terminal amino acids. RNAi experiments specifically targeting one of these 928 929 transcripts revealed that SYP132\$\beta\$ is essential for plant growth, whereas nodule- and mycorrhiza-specific SYP132α is essential for arbuscule formation and bacteroid 930 931 differentiation. The SYP132 proteins are transported to the symbiosomes in symbiotic nodule cells. Downregulating the SYP132α transcript arrests bacteroid differentiation, 932 933 presumably due to a blockage in the transport of nodule-specific secretory proteins, including NCRs, to the symbiosomes. It is not yet understood how this alternative 934 splicing is regulated and if this is a common mechanism for nodule-specific gene 935 expression or unique to SYP132. However, the finding that alternative splicing of 936 SYP132 is conserved in most dicots including plants not in the NFC and is absent in 937 dicot species that have lost mycorrhizal symbiosis suggests that this mechanism is 938 related to mycorrhiza formation and has been co-opted for nodule symbiosis. 939 940 MicroRNAs (miRNAs) are small regulatory RNA molecules that control the expression of specific target genes by binding to their mRNAs and affecting mRNA 941 942 translation or stability.. miRNAs control early stages of nodulation before the establishment of symbiotic cells (reviewed in Couzigou and Combier, 2016). For 943 944 example, the TF NF-YA1 in *M. truncatula*, which controls nodule meristem function, is negatively regulated by the miRNA miR169 (Combier et al., 2006). In addition, the 945 946 class-III homeodomain-leucine zipper TFs MtHB8, MtCNA1, and MtCNA2, which are involved in root and nodule meristem formation as well as vascular bundle 947 948 differentiation, are negatively regulated by miR166 (Boualem et al., 2008). In L. japonicus miR2111 undergoes shoot-to-root translocation and controls the AON 949

response in roots by negatively regulating the expression of *TML*, encoding an F-box 950 protein that suppresses symbiosis (Tsikou et al., 2018). In soybean, a whole array of 951 miRNAs affect the early stages of nodule induction and therefore nodule number 952 (Yan et al., 2015; Wang et al., 2014; Wang et al., 2015; Hossain et al., 2019). In 953 agreement with this role of miRNAs, Argonaute5, a small RNA-guided silencing 954 955 protein involved in mediating miRNA activity is required for nodule induction (del Rocio Reyero-Saavedra et al., 2017). 956 miRNAs are processed from primary transcripts resulting from the transcription of 957 miRNA genes by RNA polymerase II. These primary miRNA transcripts often encode 958 small peptides called miPEPs. miPEPs enhance the transcription of their cognate 959 960 primary transcript and thereby the accumulation of the corresponding miRNA (Lauressergues et al., 2015). In soybean, miR172c targets the APETALA 2 TF 961 NNC1, which negatively regulates nodule number (Wang et al., 2014; Wang et al., 962 2019). The miPEP172c peptide is encoded by the primary transcript of miR172c. This 963 964 peptide stimulates the expression of this primary transcript, thereby positively regulating nodulation (Couzigou et al., 2016). Regulatory small peptides can also be 965 encoded by protein encoding mRNAs. An alternatively spliced mRNA of the TF NF-966 YA1 encodes such a peptide, called uORF1p (Combier et al., 2008). The alternatively 967 spliced mRNA and uORF1p are expressed in nodule tissues adjacent to the 968 meristem. uORF1p negatively regulates the expression of NF-YA1 and thus, in 969 combination with the above-mentioned miR169, restricts the expression of this gene 970 to the nodule meristem. 971 Thus, the initial stages of nodule formation are regulated by miRNAs and small 972 973 peptides that control the transcript levels of their target TFs. Later stages of the nodule development are also regulated by miRNAs in L. japonicus, soybean, and P. 974 vulgaris. In L. japonicus, miR397 is systemically induced only by the presence of 975 functional, nitrogen-fixing nodules and it downregulates a member of the laccase 976 977 protein family (De Luis et al., 2012). miR397 is conserved in many plants and is involved in regulating copper homeostasis. However, whether this regulation takes 978 979 place in symbiotic cells or in other nodule cells remains to be confirmed. The P. 980 vulgaris miRNA homolog of the above-mentioned miR172c plays a regulatory role in a late stage of nodulation. miR172c represses the expression of the APETALA2 TF 981 gene AP2-1 (Nova-Franco et al., 2015). An analysis of the roles of AP2-1 and 982

miR172c suggested that AP2-1 activates senescence-related genes in symbiotic 983 cells and that miR172c is required to downregulate AP2-1 in active nodules. By 984 contrast, in non-active nodules infected with a non-functional rhizobium strain or 985 induced by nitrate application, miR172c expression is reduced, leading to the 986 induction of *AP2-1* and senescence. Corresponding miRNAs in soybean and *L.* 987 japonicus are expressed in symbiotic cells of mature nodules; these miRNA172s and 988 their AP2 targets could play similar roles to those in P. vulgaris (Wang et al., 2014; 989 Holt et al., 2015). Finally, miR393j-3p targets and represses the expression of 990 991 ENOD93 in soybean; this gene is specifically expressed in nodules and symbiotic cells (Yan et al., 2015). 992 993 Small RNAs derived from endonuclease-mediated tRNA cleavage (tRNA fragments or tRFs) are a recently described class of small RNAs that associate with Argonaute 994 proteins and regulate gene expression (Kumar et al., 2016). A recent analysis of 995 small RNA transcriptomes from soybean nodules and cultures of its symbiotic partner 996 997 Bradyrhizobium revealed numerous Bradyrhizobium-derived tRFs, most with higher abundance in nodules than in culture (Ren et al., 2019). Twenty-five of these tRFs 998 were predicted to target 52 different soybean genes, suggesting that they contribute 999 to the post-transcriptional regulation of these genes. Three selected rhizobial tRFs 1000 were indeed shown to be loaded on soybean Argonaute protein 1 and to 1001 downregulate their predicted target genes GmRHD3a/GmRHD3b, 1002 GmHAM4a/GmHAM4b, and GmLRX5. The silencing of these target genes by the 1003 rhizobial tRFs occurred during the early stages of infection and enhanced nodulation. 1004 1005 These finding point to a new level of interspecies communication between the 1006 rhizobia and their legume hosts. The finding that additional *Bradyrhizobium* tRFs are predicted to target other soybean genes and that a different set of rhizobial tRFs 1007 1008 potentially targeting a different set of host genes was identified in a small RNA transcriptome from the legume *P. vulgaris* suggests that this type of signaling is not 1009 1010 restricted to these three reported examples. Although it is too early to fully 1011 understand the implications of this new signaling mechanism, it is tempting to 1012 speculate that it introduces yet another level of control to host-specificity to match the right symbiont with the right plant. Another intriguing question is how these rhizobial 1013 1014 small RNAs reach their target genes in the plant cell. An exciting possibility is that they might be delivered via outer membrane vesicles (OMVs) produced by the 1015

rhizobia, a mechanism similar to that used by the human pathogen *Pseudomonas* 1016 aeruginosa, which delivers a tRF via OMVs to epithelial cells in the human airway 1017 (Koeppen et al., 2016). 1018 Taken together, these pioneering studies have made it clear that miRNAs and other 1019 1020 small RNAs play a role in coordinating and fine-tuning gene expression in symbiotic nodule cells. Accordingly, downregulating Argonaute5 expression in P. vulgaris and 1021 1022 soybean not only reduces nodule initiation but also affects the formation of symbiotic cells (del Rocio Reyero-Saavedra et al., 2017). Dedicated transcriptome analyses 1023 focusing on small RNAs expressed in nodules and infected root hairs have been 1024 performed for several legumes, including *M. truncatula* (Lelandais-Brière et al., 2009: 1025 1026 Formey et al., 2014; Pecrix et al., 2018), soybean (Subramanian et al., 2008; Joshi et al., 2010; Yan et al., 2015; Yan et al., 2016), P. vulgaris (Peláez et al., 2012; 1027 1028 Fourmey et al., 2016), and L. japonicus (Holt et al., 2015). The corresponding databases represent promising sources for the future discovery of novel RNAs that 1029 1030 control gene expression in nodules. Finally, long non-coding and antisense RNAs (IncRNAs) might also be involved 1031 regulating nodule-specific gene expression. LCM RNA-seg analysis of *M. truncatula* 1032 1033 nodules (SYMBIMICS dataset) has revealed a surprisingly large number (over 1000) 1034 of IncRNAs expressed in nodules. Most of these are active in differentiating or mature symbiotic cells. Many are located in SRIs, and the expression profiles of many of 1035 these IncRNAs were correlated with the expression of the closest mRNA-encoding 1036 1037 genes in the genome, suggesting these IncRNAs play regulatory roles (Pecrix et al 2018). For example,-the TF EFD is expressed in young symbiotic cells in the distal 1038 1039 and proximal infection zones of the nodule. Strikingly, an antisense transcript of EFD showed a complementary expression profile, i.e., in older symbiotic cells in the 1040 1041 interzone and fixation zones. This finding suggests that EFD is downregulated by antisense transcripts in order to promote the final stages of symbiotic cell 1042 differentiation. Indeed, a large set of the above-mentioned nodule-specific genes in 1043 M. truncatula (e.g. genes encoding NCRs, GRPs, ENOD8, ENOD16, ENOD20, 1044 1045 calmodulin-like proteins, leghemoglobin, nodulin 25 IPD3, NIN, SymCRK, DME, 1046 DNF1, RSD, and ERN2) as well as many others have associated lncRNAs or 1047 antisense transcripts. The biological meaning of this will certainly be worth deciphering. 1048

CONCLUDING REMARKS

Transcriptomic analysis of nodule formation has been instrumental in the discovery of new genes that were subsequently shown by reverse genetics to be important for nodule formation. Thus, transcriptomics have played a complementary role (and will probably continue to do so) to the many forward genetic screens that have been successfully conducted by several laboratories to identify key regulators of nodulation (reviewed by Roy et al., 2019). However, transcriptomics analysis also provides broader insights into the nodulation process. Here, we argue that nodule formation is a unique developmental process that is supported by drastic transcriptional reprogramming. This reprogramming involves the activation of many hundreds of genes, many of which are exclusively expressed in these organs and are novel genes that have been shaped by evolution since the origins of nodulation. A remarkable number of nodule-specific genes have signal peptides and are therefore transported to bacteroid-containing symbiosomes, suggesting that a major adaptation of nodule-forming plants is the massive production of a large variety of proteins that interact with endosymbionts. We have some knowledge about the functions of some of these proteins (e.g. the NCRs), but at the moment, we have no clue about most of their roles. Even though the CSSP is the upstream regulatory apparatus that activates both nodule formation and mycorrhiza formation, the nodule-specific and mycorrhizaspecific transcriptomes are dramatically different. How the different read-outs of this conserved module are achieved is likely one of the most import questions to be solved in the field. Perhaps the components of the CSSP are arranged in multiprotein signaling modules anchored in the cell membrane through receptor complexes located in nanoclusters organized by microdomain-associated proteins, including remorins, flotillins, and FW2.2-like proteins (Haney and Long, 2010; Haney et al., 2011; Levebvre et al., 2010; Ott, 2017; Qiao et al., 2017; Liang et al., 2018). Distinct nodulation signaling modules and mycorrhization signaling modules could activate the appropriate responses. The regulatory mechanisms that underlie symbiotic cell formation and control the transcriptome switch are also poorly understood. With the recent identification of

candidate TFs, the discovery of SRIs, the description of epigenetic modifications, and the documentation of transcriptional fine-tuning mechanisms by alternative splicing, miRNAs, miPEPs, tRFs, and antisense RNAs, we are only starting to decipher this process, and we can hope that the key regulators will soon be discovered. An intriguing observation from nodule transcriptomes is that the TF gene *IPD3* is most strongly expressed in symbiotic cells. It would be interesting to determine its specific role in these cells and how this role relates to its transcriptional activity during the very early stages of the nodulation process.

An important implication of the current analysis is that nodules are unique organs, not only from the perspective of organogenesis and histological organization but also from a genetic perspective. All attempts to transfer nodule formation to non-legume crops that are currently underway in different laboratories should take into account the finding that "naturally" evolved nodule formation relies on the concerted action of hundreds of genes, many of which appear to function specifically in nodules. It will be important in future efforts to understand in great detail not only the regulatory mechanisms of nodule-specific genes, but also their function as well as their evolution. A key issue for the future will be to understand how adaptive the nodule transcriptome response is. Gene regulation is usually considered to be an adaptive response of the organism, organ, or cell to a specific environmental or developmental condition so that genes are expressed when and where they are required. The validity of this presumption has not been tested thoroughly in plants. In bacteria, however, the picture has emerged that transcriptional responses are in large part suboptimal or even maladaptive (Price et al., 2013). Striking examples come from the rhizobium bacteroids in nodules themselves. Similar to their host cells, bacteroids undergo a major transcriptomic switch during their formation, with the induction of many hundred of genes and the downregulation of the rest of the genome. Some of these upregulated genes are essential for symbiosis, such as genes encoding nitrogenase and accessory functions. However, disappointingly from a researcher's perspective, in various studies, the mutation of many selected genes that were strongly upregulated in mature bacteroids resulted in no symbiotic phenotype for any of the tested genes (Karunakaran et al., 2009; Lamouche et al., 2019). Similarly, in the yeast Saccharomyces cerevisiae, only a small portion of genes upregulated under a particular growth condition contributed to the fitness of the yeast under that

114	condition (Giaever et al., 2002). Thus, genes may be upregulated in a specific
1115	context only as a side-effect without having a clear functional contribution. Whether
1116	this is the case in nodules remains to be analyzed, as it is possible that part of the
117	nodule transcriptome contributes little to symbiotic nitrogen fixation.
118	Clearly, it is not possible, at least with currently available technology, to engineer
1119	something as complex as nodules of the NFC. Thus, it will be important to
120	understand to what extent the complexity present in current day nodules is required
121	for nitrogen fixation, even at levels below the optimal level reached in legume
122	nodules. Much attention has been paid to the early stages of nodule formation, but
123	we would like to advocate for more intense efforts towards understanding symbiotic
124	nodule cell formation. These unique cell types are at the heart of symbiosis and
125	determine the high efficiency of the nitrogen-fixation process.

Figure legends

Figure 1. Unique features of nodules. A. Nod factor activation of the common symbiosis signaling pathway (CSSP). Brown, signaling in the rhizobium symbiont resulting in Nod factor production. Grey, CSSP in the host cells activates nodule organogenesis, infection and autoregulation of nodulation. B. Organization of nodule tissues. Tissues are color-coded. The dividing meristem cells (yellow) give rise at the edge to several vascular bundles (blue) concentrically organized around the central nodule tissue. The meristem cells (2C to 4C DNA content) give also rise to the central nodule tissue, which is mainly composed of infected symbiotic cells formed from post-meristematic cells by successive rounds of endoreduplication (shades of grey from light to dark indicate cells with increasing ploidy from 8C to 64C). Infection threads (green) deliver rhizobia to early differentiating symbiotic cells. C. Infection threads, filled with rhizobium bacteria, are initiated in a root hair and have polar growth (red). The underlying cortical cells are activated and initiate a cell cycle. Outer cortical cells, adjacent to an infection thread-carrying cell, do not complete the cell cycle but form a cytoplasmic bridge (related to a phragmosome) that will be penetrated by the growing infection thread, which is referred to as a preinfection thread. Inner cortical cells complete the cell cycle and the newly generated cells constitute the nodule primordium. Drawings are based on Van Brussel et al., 1992. D. An infection thread reaching a target cell in a nodule primordium or growing nodule releases rhizobia by endocytosis. The exocytosis pathway of the host cell targets proteins and peptides to bacteria located in vesicles called symbiosomes, resulting in the differentiation of these bacteria into nitrogen-fixing bacteroids. PAMP Triggered Immunity (PTI) is actively repressed in symbiotic cells. Specific expression in symbiotic cells is required for the production of symbiosome-targeted secretory proteins (green and orange), for immune suppression functions (yellow), and for metabolism (purple, see panel F.). E. A fully mature symbiotic cell is entirely filled

with bacteroid-containing symbiosomes and has a central vacuole and a polyploid 2005 2006 nucleus (blue). F. Integration of the bacteroid metabolism (brown) with symbiotic cell metabolism (grey) relies on complementarity of the metabolic functions in both 2007 symbiotic partners and a complex exchange of small molecules mediated by a 2008 multitude of transporters. Some metabolic steps require a third partner, the plastid 2009 (green). The drawing is based on Temple et al., 1998, Udvardi and Poole, 2013 and 2010 Poole et al., 2018. 2011 Figure 2. Gene expression in M. truncatula. A. Hierarchical clustering of the 2012 2013 MtGEA dataset (Benedito et al., 2008). Genes are shown in rows and experiments in columns. On the top, the experiment types are indicated. To the left, gene clusters 2014 2015 are labeled based on organ-specific expression. In the expression heatmap, yellow indicates high expression and black indicates low expression. In the "NCR" column, 2016 2017 the NCR genes are indicated by a yellow line. In the "Shannon" columns, yellow indicates high specificity (i.e. low Shannon entropy) and black indicates low 2018 specificity, with more uniform expression (i.e. high Shannon entropy). **B.** An 2019 enlargement of the red squared area of the heatmap in panel A showing nodule-2020 specific (nod) and mycorrhizal-specific (myc) genes (lines) and experiments 2021 (columns). C. The SYMBIMICS dataset (Roux et al., 2014) for nodule-specific genes 2022 from MtGEA (gene cluster labeled in red in panel A). The columns correspond to the 2023 nodule tissues: I, meristem; Ild, distal infection zone or nodule zone II; Ilp, proximal 2024 2025 infection zone; IZ, interzone between nodule zones II and III; III, fixation zone or nodule zone III. Color-codes as in panel A. The data sets used to generate the 2026 heatmaps are available upon request. 2027 2028 Figure 3. Nodule-specific gene expression. Extreme specificity of nodule-specific genes in M. truncatula (A-C). Expression of NCR genes (A). Clusters of tissue-2029 specific genes (B). Expression patterns of genes ordered according to specificity 2030 (Shannon entropy) (C). Panels A-C are adapted from Guefrachi et al. (2014), 2031 2032 licensed under the Creative Commons Attribution 4.0 International License. Nodulespecific gene expression in different legumes (D). The heatmaps show hierarchical 2033 2034 cluster analysis of gene expression in the indicated legumes using data from the 2035 SoyBase (Severin et al., 2010), LiGEA (Verdier et al., 2013), AGED (O'Rourke et al., 2015), and PvGEA (O'Rourke et al., 2014) databases. Genes are shown in rows and 2036 2037 tissue types in columns. The Shannon entropy of the genes (calculated based on the

expression profile) is displayed to the right of each gene expression heatmap. The 2038 2039 nodule-specific gene clusters mostly comprising low Shannon entropy genes are 2040 highlighted by a red rectangle. Color codes: in the expression heatmaps, yellow 2041 indicates high expression and black indicates low expression; in the "NCR" columns, the NCR genes are indicated by a yellow line; in the "Shannon" columns, yellow 2042 indicates high specific expression (i.e. low Shannon entropy) and black indicates low 2043 specificity, more uniform expression (i.e. high Shannon entropy). The data sets used 2044 to generate the heatmaps are available upon request. 2045 Figure 4. Spatial resolution of gene expression analysis in nodules. A. Purified 2046 nodule cell types can be obtained by laser-capture microdissection (LCM). This 2047 2048 technology uses a laser guided by a microscope to cut cells in a precise, contamination-free manner out of their surrounding tissues from an organ section. B. 2049 2050 A second methodology exploits the varying DNA content in the nuclei of differentiating symbiotic nodule cells and separates these nuclei using flow cytometry 2051 2052 and a cell sorter. Flow-cytometry is a laser-assisted technology that analyzes the biophysical features of small particles, such as cells or nuclei, in a capillary stream. 2053 The graph on the right shows a typical flow cytometry measurement of the DNA 2054 content in nodule nuclei. A cell sorter coupled to the flow cytometer separates these 2055 nuclei. Both methods, LCM and flow cytometry, yield purified materials that are 2056 compatible with downstream molecular biology methods such as gene expression 2057 analysis (RNA-seq, microarray hybridization, RT-qPCR) and chromatin analysis 2058 (DNA methylation analysis, ChIP-seq). Both methods can be used to isolate single 2059 cells or single cell types from nodules and can also be combined with the use of 2060 2061 fluorescent markers expressed in cells of interest. C. In spatial transcriptomics or Slide-seq, a nodule section is placed on a support that carries a defined array of 2062 2063 barcodes. After the RNA is transferred from the tissue to the array, the barcode sequence is introduced during cDNA synthesis, and RNA-seq sequencing libraries 2064 2065 are produced from the whole sample, preserving the spatial information through 2066 barcodes. 2067 Figure 5. Models for the evolution or nodulation in the nitrogen-fixing clade. A. 2068 The convergent evolution hypothesis proposes the evolution of a cryptic innovation or predisposition for nodulation (red asterisk) followed by independent acquisitions of 2069 2070 nodule formation (indicated by colored dots on tree branches). Green and blue dots

signify the acquisition of nodulation with *Frankia* and *Rhizobium*, respectively. **B.** The model of a single acquisition of nodulation with Frankia at the origin of the nitrogenfixing clade (NFC) and multiple losses in the non-nodulating lineages (red crosses). This acquisition required the suppression of PAMP-triggered immunity against the infecting bacteria, a process involving the NAD1 protein. The evolution of nodulation might have involved a rapid succession of stepwise innovations including the replacement of mycorrhizal fungal infection by Frankia infection, followed by cortical cell divisions resulting in the production of small foci of infected cells before the development of nodules. Two independent switches of symbionts occurred (indicated by green to blue dot), once in the *Parasponia* lineage of the Rosales and once in the ancestor of the legumes in the Fabales. These switches to a *Rhizobium* symbiont were possible due to the recruitment and mutation of a non-symbiotic, non-oxygen transporting class 1 or class 2 hemoglobin (nsHb1 or nsHb2), forming the oxygentransporting *Parasponia* hemoglobin (Parab) or leghemoglobin (Lb), respectively. **C.** An alternative model proposes that the ancestor of the NFC acquired the possibility to extend mycorrhizal infection with Frankia infection of root cortical cells. The subsequent stages imply multiple independent acquisitions of nodule organogenesis as in panel A and two independent symbiont switches as in panel B. The trees are schematic representations based on published chronograms (Doyle, 2016). The present status of clades is indicated by a blue or green nodule for Rhizobium-infected or Frankia-infected nodulating clades and by a black cross for non-nodulating clades.

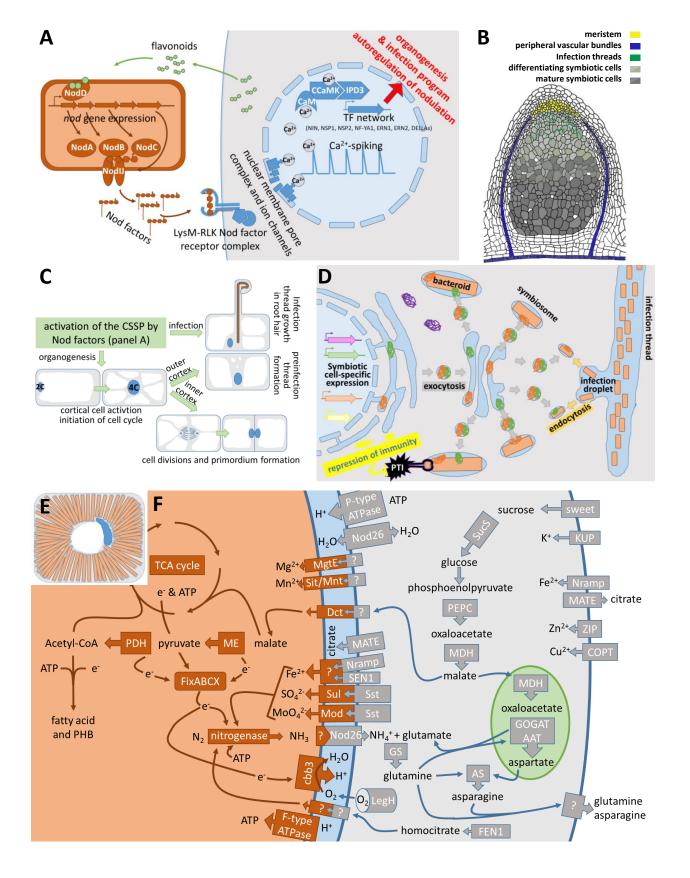


Figure 1. Unique features of nodules, A. Nod factor activation of the common symbiosis signaling pathway (CSSP). Brown, signaling in the rhizobium symbiont resulting in Nod factor production. Grey, CSSP in the host cells activates nodule organogenesis, infection and autoregulation of nodulation. B. Organization of nodule tissues. Tissues are color-coded. The dividing meristem cells (yellow) give rise at the edge to several vascular bundles (blue) concentrically organized around the central nodule tissue. The meristem cells (2C to 4C DNA content) give also rise to the central nodule tissue, which is mainly composed of infected symbiotic cells formed from post-meristematic cells by successive rounds of endoreduplication (shades of grey from light to dark indicate cells with increasing ploidy from 8C to 64C). Infection threads (green) deliver rhizobia to early differentiating symbiotic cells, C. Infection threads, filled with rhizobium bacteria, are initiated in a root hair and have polar growth (red). The underlying cortical cells are activated and initiate a cell cycle. Outer cortical cells, adjacent to an infection thread-carrying cell, do not complete the cell cycle but form a cytoplasmic bridge (related to a phragmosome) that will be penetrated by the growing infection thread, which is referred to as a preinfection thread. Inner cortical cells complete the cell cycle and the newly generated cells constitute the nodule primordium. Drawings are based on Van Brussel et al., 1992 . D. An infection thread reaching a target cell in a nodule primordium or growing nodule releases rhizobia by endocytosis. The exocytosis pathway of the host cell targets proteins and peptides to bacteria located in vesicles called symbiosomes, resulting in the differentiation of these bacteria into nitrogen-fixing bacteroids. PAMP Triggered Immunity (PTI) is actively repressed in symbiotic cells. Specific expression in symbiotic cells is required for the production of symbiosome-targeted secretory proteins (green and orange), for immune suppression functions (yellow), and for metabolism (purple, see panel F.). E. A fully mature symbiotic cell is entirely filled with bacteroid-containing symbiosomes and has a central vacuole and a polyploid nucleus (blue). F. Integration of the bacteroid metabolism (brown) with symbiotic cell metabolism (grey) relies on complementarity of the metabolic functions in both symbiotic partners and a complex exchange of small molecules mediated by a multitude of transporters. Some metabolic steps require a third partner, the plastid (green). The drawing is based on Temple et al., 1998, Udvardi and Poole, 2013 and Poole et al., 2018.

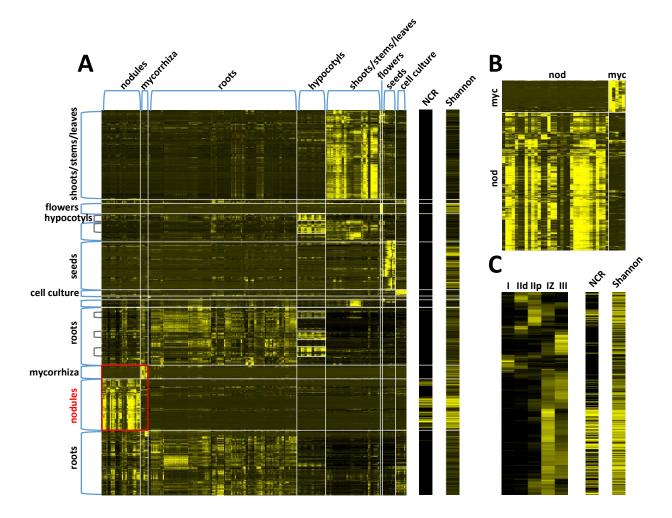


Figure 2. Gene expression in *M. truncatula.* **A.** Hierarchical clustering of the MtGEA dataset (Benedito et al., 2008). Genes are shown in rows and experiments in columns. On the top, the experiment types are indicated. To the left, gene clusters are labeled based on organ-specific expression. In the expression heatmap, yellow indicates high expression and black indicates low expression. In the "NCR" column, the NCR genes are indicated by a yellow line. In the "Shannon" columns, yellow indicates high specificity (*i.e.* low Shannon entropy) and black indicates low specificity, with more uniform expression (*i.e.* high Shannon entropy). **B.** An enlargement of the red squared area of the heatmap in panel A showing nodule-specific (nod) and mycorrhizal-specific (myc) genes (lines) and experiments (columns). **C.** The SYMBIMICS dataset (Roux et al., 2014) for nodule-specific genes from MtGEA (gene cluster labeled in red in panel A). The columns correspond to the nodule tissues: I, meristem; IId, distal infection zone or nodule zone II; IIp, proximal infection zone; IZ, interzone between nodule zones II and III; III, fixation zone or nodule zone III. Color-codes as in panel A. The data sets used to generate the heatmaps are available upon request.

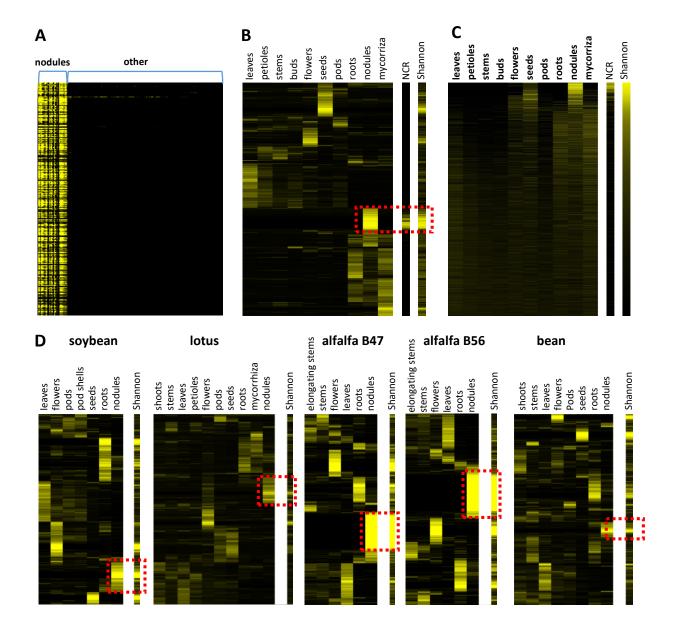


Figure 3. Nodule-specific gene expression. Extreme specificity of nodule-specific genes in *M. truncatula* (A-C). Expression of NCR genes (A). Clusters of tissue-specific genes (B). Expression patterns of genes ordered according to specificity (Shannon entropy) (C). Panels A-C are adapted from Guefrachi et al. (2014), licensed under the Creative Commons Attribution 4.0 International License. Nodule-specific gene expression in different legumes (D). The heatmaps show hierarchical cluster analysis of gene expression in the indicated legumes using data from the SoyBase (Severin et al., 2010), LjGEA (Verdier et al., 2013), AGED (O'Rourke et al., 2015), and PvGEA (O'Rourke et al., 2014) databases. Genes are shown in rows and tissue types in columns. The Shannon entropy of the genes (calculated based on the expression profile) is displayed to the right of each gene expression heatmap. The nodule-specific gene clusters mostly comprising low Shannon entropy genes are highlighted by a red rectangle. Color codes: in the expression heatmaps, yellow indicates high expression and black indicates low expression; in the "NCR" columns, the NCR genes are indicated by a yellow line; in the "Shannon" columns, yellow indicates high specific expression (*i.e.* low Shannon entropy) and black indicates low specificity, more uniform expression (*i.e.* high Shannon entropy). The data sets used to generate the heatmaps are available upon request.

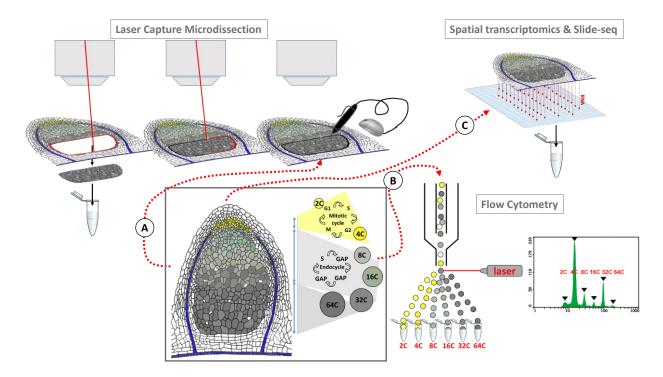


Figure 4. Spatial resolution of gene expression analysis in nodules. A. Purified nodule cell types can be obtained by laser-capture microdissection (LCM). This technology uses a laser guided by a microscope to cut cells in a precise, contamination-free manner out of their surrounding tissues from an organ section. B. A second methodology exploits the varying DNA content in the nuclei of differentiating symbiotic nodule cells and separates these nuclei using flow cytometry and a cell sorter. Flow-cytometry is a laser-assisted technology that analyzes the biophysical features of small particles, such as cells or nuclei, in a capillary stream. The graph at the right shows a typical flow cytometry measurement of the DNA content in nodule nuclei. A cell sorter coupled to the flow cytometer separates these nuclei. Both methods, LCM and flow cytometry, yield purified materials that are compatible with downstream molecular biology methods such as gene expression analysis (RNA-seq, microarray hybridization, RT-qPCR) and chromatin analysis (DNA methylation analysis, ChIP-seq). Both methods can be used to isolate single cells or single cell types from nodules and can also be combined with the use of fluorescent markers expressed in cells of interest. C. In spatial transcriptomics or Slide-seq, a nodule section is placed on a support that carries a defined array of barcodes. After the RNA is transferred from the tissue to the array, the barcode sequence is introduced during cDNA synthesis, and RNA-seq sequencing libraries are produced from the whole sample, preserving the spatial information through barcodes.

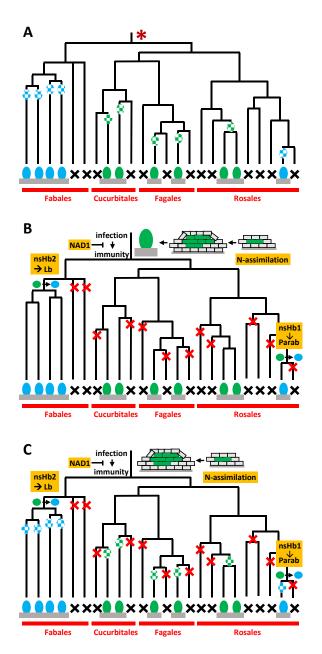


Figure 5. Models for the evolution or nodulation in the nitrogen-fixing clade. A. The convergent evolution hypothesis proposes the evolution of a cryptic innovation or predisposition for nodulation (red asterisk) followed by independent acquisitions of nodule formation (indicated by colored dots on tree branches). Green and blue dots signify the acquisition of nodulation with Frankia and Rhizobium, respectively. B. The model of a single acquisition of nodulation with Frankia at the origin of the nitrogenfixing clade (NFC) and multiple losses in the non-nodulating lineages (red crosses). This acquisition required the suppression of PAMP-triggered immunity against the infecting bacteria, a process involving the NAD1 protein. The evolution of nodulation might have involved a rapid succession of stepwise innovations including the replacement of mycorrhizal fungal infection by Frankia infection, followed by cortical cell divisions resulting in the production of small foci of infected cells before the development of nodules. Two independent switches of symbionts occurred (indicated by green to blue dot), once in the Parasponia lineage of the Rosales and once in the ancestor of the legumes in the Fabales. These switches to a Rhizobium symbiont were possible due to the recruitment and mutation of a nonsymbiotic, non-oxygen transporting class 1 or class 2 hemoglobin (nsHb1 or nsHb2), forming the oxygen-transporting Parasponia hemoglobin (Parab) or leghemoglobin (Lb), respectively. C. An alternative model proposes that the ancestor of the NFC acquired the possibility to extend mycorrhizal infection with Frankia infection of root cortical cells. The subsequent stages imply multiple independent acquisitions of nodule organogenesis as in panel A and two independent symbiont switches as in panel B. The trees are schematic representations based on published chronograms (Doyle, 2016). The present status of clades is indicated by a blue or green nodule for Rhizobium-infected or Frankiainfected nodulating clades and by a black cross for non-nodulating clades.
