#### **Research questions**

- 1. What is poverty for the urban poor in their everyday lives?
- 2. How does this understanding about poverty influence the urban poor's action and practice towards poverty?
- 3. To what extent do everyday actions and practices of the urban poor towards poverty influence participation in urban poverty alleviation programmes and their sustainability?

#### Research hypothesis

- L. Other than material needs, poor people experience powerlessness, exclusions from basic services and have unmet emotional and psychological needs (Narayan, et al, 2000).
- 2. Solutions to poverty are not always constructed upon the lives of the people hence their everyday experiences do not always form the core of poverty alleviation policy.
- 3. The disconnect between poverty alleviation programmes and poor people's everyday lives leads to poor sustainability of poverty alleviation policies
