# Synthesis and Structure of the Stable Paramagnetic Cyclopentadienyl Polyhydride Complexes $\left[\mathbf{C p} * \mathbf{M H}_{3} \text { (dppe) }\right]^{+}(\mathbf{M}=\mathbf{M o}, \mathbf{W})$ : Stronger $\mathbf{M}-\mathbf{H}$ Bonds upon Oxidation

Transition-metal polyhydride derivatives have been at the focus of much experimental ${ }^{2}$ and theoretical ${ }^{3}$ work, especially dealing with their high fluxionality ${ }^{4}$ and their structure type (i.e. classical vs nonclassical). ${ }^{5}$ There is scarce information on how these properties change upon oxidation to the 17-electron configuration because of the paucity of stable complexes. Only a few monohydride complexes have have been isolated, ${ }^{6}$ as facile decomposition via deprotonation or disproportionation pathways usually occurs. ${ }^{7}$ Isolable paramagnetic polyhydrides are even less common. We are only aware of $\mathrm{TaCl}_{2} \mathrm{H}_{2} \mathrm{~L}_{4}\left(\mathrm{~L}=\mathrm{PMe}_{3}\right.$ or $\mathrm{L}_{2}=$ dmpe $)^{6 \mathrm{~g}}$ and $\left[\mathrm{WCl}_{2} \mathrm{H}_{2}\left(\mathrm{PMe}_{3}\right)_{4}\right]^{+} \mathrm{BF}_{4}{ }^{-}$, ${ }^{6 \mathrm{~h}}$ as well characterized, unambiguous examples. ${ }^{8}$ Chemical reactivity studies of such species are also rare. ${ }^{9}$ When these compounds are obtained by one-electron oxidation of neutral precursors, $\mathrm{H}_{2}$ reductive elimination is facilitated by the decreased metal p basicity ${ }^{10}$ and adds to the array of decomposition pathways available. ${ }^{11}$

We wish to report here the new complexes $\left[\mathrm{Cp} * \mathrm{MH}_{3}(\right.$ dppe $\left.)\right]$ $\left[\mathrm{PF}_{6}\right]\left(\mathrm{M}=\mathrm{Mo},\left([\mathbf{1}] \mathrm{PF}_{6}\right), \mathrm{W}\left([2] \mathrm{PF}_{6}\right)\right)$, which are accessible by 1-electron oxidation of the parent complexes $\mathbf{1}$ and $\mathbf{2}$ with $\mathrm{FcPF}_{6} .{ }^{12}$ Cyclovoltammetric studies show a reversible oxidation for both 1 and 2 in THF ( -0.75 and -0.88 V vs $\mathrm{Fc} / \mathrm{Fc}^{+}$, respectively). Complex [1] ${ }^{+}$exhibits a triplet of quartets in the EPR spectrum ( $g=1.989, a_{\mathrm{P}}=28.9 \mathrm{G}, a_{\mathrm{H}}=11.8 \mathrm{G}$; see Figure 1) consistent with coupling to three equivalent H and two equivalent P ligands. Chemical oxidation of $\mathrm{Cp} * \mathrm{MoD}_{3}$ (dppe) leads to the formation of $[\mathbf{1}]^{+}-d^{3}$, which is characterized by an EPR broad triplet ( $g=$ $1.991, a_{\mathrm{P}}=28.9 \mathrm{G}$; see Figure 1). IR investigations ${ }^{13}$ show the expected isotope shift upon deuteration, and a $10-20 \mathrm{~cm}^{-1}$ blue shift upon oxidation. From simple theory, the vibrational frequency correlates directly with the bond energy. ${ }^{14}$ Thus, the IR data indicate that the $\mathrm{M}-\mathrm{H} / \mathrm{D}$ bonds are stronger in the oxidized materials, consistent with expectations on the basis of a $\mathrm{M}^{\delta+}-\mathrm{H}^{\delta-}$ bond polarity. Previous IR studies on $\mathrm{Cp} * \mathrm{FeH}$ (dppe)

[^1]and $\mathrm{WH}_{2} \mathrm{Cl}\left(\mathrm{PMe}_{3}\right)_{4}$ indicated either no change or a slight red shift upon oxidation, ${ }^{\text {bhi, }, 15}$ and a lowering of $\mathrm{M}-\mathrm{H}$ BDE's was indicated for lower-valent carbonyl complexes by thermodynamic cycles involving acidity and electrochemical measurements. ${ }^{16}$

Despite the supposedly greater $\mathrm{Mo}-\mathrm{H}$ bond energy relative to the neutral precursor, complex $[\mathbf{1}]^{+}$decomposes rapidly ( $t_{1 / 2}$ $=2 \mathrm{~min}$ at $25^{\circ} \mathrm{C}$ in either THF or $\mathrm{CH}_{2} \mathrm{Cl}_{2}$ ) with gas evolution, to afford a new signal consisting of a doublet of triplets ( $g=$ $1.950, a_{\mathrm{P}}=16.5 \mathrm{G}, a_{\mathrm{H}}=24.0 \mathrm{G}$; solvent independent), consistent with the formation of $\mathrm{Cp}{ }^{*} \mathrm{MoH}(\mathrm{dppe})\left(\mathrm{PF}_{6}\right)$, 3. $[\mathbf{1}]^{+}-d^{3}$ correspondingly decomposes to yield a triplet of 1:1:1 triplets ( $a_{\mathrm{D}}$ $=4.0 \mathrm{G}$ ). This indicates that $[\mathbf{1}]^{+}$decomposes by reductive elimination of $\mathrm{H}_{2}$. The similar decomposition rate in THF and $\mathrm{CH}_{2} \mathrm{Cl}_{2}$ suggests that $\mathrm{H}_{2}$ elimination may occur without solvent precoordination. Solvent-independent $\mathrm{R}-\mathrm{R}$ reductive eliminations from dialkyl complexes have previously been reported. ${ }^{17}$ No solvent is coordinated to solid $\mathbf{3},{ }^{18}$ which is therefore formulated as either the salt of a rather uncommon ${ }^{19} 15$-electron cation or a 17 -electron complex with a coordinated $\mathrm{FPF}_{5}$ ligand. Solvent coordination cannot be excluded in solution. Additional studies on this compound are in progress and will be reported later.

Compound [2] ${ }^{+}$exhibits a broad triplet resonance in the EPR spectrum ( $g=2.017$; see Figure 1), which decays slowly at room temperature in THF ( $t_{1 / 2}=3 \mathrm{~h}$ ). The nature of the decomposition products is under current investigation. Cooling to $-80^{\circ} \mathrm{C}$ does not affect the line shape of the signal. Oxidation of $\mathrm{Cp} * \mathrm{WD}_{3}{ }^{-}$ (dppe) leads to $[2]^{+}-d^{3}$, which better reveals the phosphorus coupling ( $g=2.022, a_{\mathrm{P}}=27.6 \mathrm{G}$; see Figure 1). A single crystal of [2] $\mathrm{PF}_{6}$ could be investigated by X-ray diffraction, ${ }^{20}$ which permitted the location and refinement of the three hydride ligands (see Figure 2).

The cation and anion are well separated, the closest contacts being between F atoms and $\mathrm{Cp} *$ and dppe C atoms ( $>3.0 \AA$ ). Neglecting the hydrogen positions, the geometry of [2] ${ }^{+}$is very close to that of $\left[\mathrm{Cp} * \mathrm{WH}_{4}(\mathrm{dppe})\right]^{+}$, previously determined as the $\mathrm{BF}_{4}{ }^{-}$salt. ${ }^{21}$ The major difference consists of a small displacement ( $0.025(8) \AA$, as opposed to $0.002(9) \AA$ in the tetrahydrido complex) of the W atom from the plane defined by CNT, $\mathrm{P}(1)$,

and $\mathrm{P}(2)$ toward the side of the molecule occupied by H 2 and H3 (see Figure 2). The $\mathrm{W}-\mathrm{P}$ and $\mathrm{W}-\mathrm{Cp}^{*}$ bond distances are also very similar for $[2]^{+}$and $\left[\mathrm{Cp} * \mathrm{WH}_{4}(\mathrm{dppe})\right]^{+},{ }^{21 a}$ suggesting that the replacement of a $\mathrm{W}-\mathrm{H}$ bond with a singly occupied W orbital does not greatly affect the effective metal charge (i.e. the $\mathrm{W}-\mathrm{H}$ bond is highly covalent). Although the H positions are not determined with high precision, the relatively long $\mathrm{H} \cdots \mathrm{H}$ separations (H1-H2 $2.81 \AA$ A $\mathrm{H} 2-\mathrm{H} 32.11 \AA$ ) suggest a classical formulation for $[2]^{+}$. The geometry of $[2]^{+}$is intermediate between I (a pseudotrigonal prism) and II (a pseudooctahedron), i.e., the ideal geometries adopted by the isoelectronic $\mathrm{d}^{2}$ complexes 1 and $\left[\mathrm{Cp} * \mathrm{MoH}(\text { dppe })(\mathrm{MeCN})_{2}\right]^{2+}$, respectively. ${ }^{21 a, 22}$

The equivalence of the P and H hyperfine couplings in the EPR spectrum of $[\mathbf{1}]^{+}$clearly indicates fluxionality. A scrambling mechanism involving a pseudo-Bailar twist between I and II, as previously proposed for the precursor complexes $\mathbf{1}$ and $\mathbf{2}$, could also be adopted by $[\mathbf{1}]^{+}$and $[\mathbf{2}]^{+} .{ }^{21 a}$ Our future work will attempt to define the chemical reactivity of this new class of 17-electron polyhydride complexes and their decomposition products.

    (12) To a solution of $\mathbf{2}(115 \mathrm{mg}, 0.160 \mathrm{mmol})$ in 4 mL of $\mathrm{CH}_{2} \mathrm{Cl}_{2}$ was added $\mathrm{FcPF}_{6}(53 \mathrm{mg}, 0.160 \mathrm{mmol})$ at room temperature. The yellow-orange solution immediately turned red-orange. The solution was filtered and concentrated under reduced pressure to ca. 0.5 mL . Orange single crystals of $[2]^{+} \mathrm{PF}_{6}{ }^{-}$were obtained by diffusion of a layer of diethyl ether into this solution. Yield: $97 \mathrm{mg}(70 \%)$. [1] ${ }^{+}$can be obtained from $\mathbf{1}$ in an analogous manner in either THF or $\mathrm{CH}_{2} \mathrm{Cl}_{2}$. The oxidized complexes do not give rise to any observable NMR resonances.
    (13) IR bands (THF, $\mathrm{cm}^{-1}$, all broad): 1, 1815 (m, sh), $1775(\mathrm{~m}) ;[1]^{+}$, 1896 (w, sh), 1824 (m); 1- $d^{3}, 1307$ (m); [1] ${ }^{+}-d^{3}, 1318$ (m); 2, 1885 (w), 1815 (m); [2] ${ }^{+}$, 1897 (m), 1830 (w). W-D bands could not be located for compounds $2-d^{3}$ and $[2]^{+}-d^{3}$ (no significant changes were observed upon oxidation). The spectra of $[\mathbf{1}]^{+}$and $[\mathbf{1}]^{+}-d^{3}$ were recorded immediately after charging the cell with the cold solution. The follow-up decompositions (see text) generated a new weaker band at $1818 \mathrm{~cm}^{-1}$ from $[\mathbf{1}]^{+}$, assigned to $\mathbf{3}$. A corresponding band for $3-d$ could not be observed.

Structure solution by direct methods located the W and P atoms and several F atoms. All hydrogen atoms except the three hydrides were placed in calculated positions (AFIX). The three hydride atoms were located from the highest peaks near the W atom with W -peak distances ranging from 1.4 to 1.7 A . Their refinement was assisted by restraining the $\mathrm{W}-\mathrm{H}$ distances to be near $1.70 \AA$ (ADFIX with esd of $0.03 \AA$ ). Thermal parameters were allowed to refine freely.
