# Fredholm transformation on Laplacian and rapid stabilization for the heat equation

#### Abstract

We study the rapid stabilization of the heat equation on the 1-dimensional torus using the backstepping method with a Fredholm transformation. We prove that, under some assumption on the control operator, two scalar controls are necessary and sufficient to get controllability and rapid stabilization. This classical framework allows us to present the backstepping method with Fredholm transformations on Laplace operators in a sharp functional setting, which is the main objective of this work. Finally, we prove that the same Fredholm transformation also leads to the local rapid stability of the viscous Burgers equation.

## 1 Introduction

We consider the following heat equation with two internal controls,

$$
\begin{cases}\partial_{t} u-\Delta u=v_{1}(t) \phi_{1}+v_{2}(t) \phi_{2}, & (t, x) \in(0,+\infty) \times \mathbb{T},  \tag{1.1}\\ \left.u\right|_{t=0}=u_{0}(x), & x \in \mathbb{T},\end{cases}
$$

with $\mathbb{T}=\mathbb{R} / 2 \pi \mathbb{Z}$ the one-dimensional torus, $\left(v_{1}, v_{2}\right) \in L^{2}((0,+\infty) ; \mathbb{R})$ real-valued scalar controls to be defined and $\left(\phi_{1}, \phi_{2}\right) \in H^{\sigma}(\mathbb{T} ; \mathbb{R})$ with $\sigma \in \mathbb{R}$ real-valued potentials. Our goal is to design a suitable feedback law to stabilize the system (1.1) exponentially with an arbitrarily large decay rate.

It would be more natural to first consider the simpler system with only one scalar control

$$
\begin{cases}\partial_{t} u-\Delta u=v(t) \phi, & (t, x) \in(0,+\infty) \times \mathbb{T}  \tag{1.2}\\ \left.u\right|_{t=0}=u_{0}(x), & x \in \mathbb{T}\end{cases}
$$

with $v \in L^{2}((0,+\infty) ; \mathbb{R})$ a real-valued control to be defined and $\phi \in H^{\sigma}(\mathbb{T} ; \mathbb{R})$. As it turns out, as simple as it is, this system is not controllable, due to the degeneracy of the eigenvalues of the Laplacian operator defined on $H^{s}(\mathbb{T} ; \mathbb{R})$ (see Section 2 ). In this paper we show that at least two internal controls are required and that, in fact, two controls are enough provided that $\phi_{1}$ and $\phi_{2}$ satisfy some good conditions. In order to obtain the rapid stabilization result we then propose a double backstepping method, detailed in Section 3.3.

### 1.1 Main result

Let $H^{s}(\mathbb{T}), s \in \mathbb{R}$ denotes the classical Sobolev spac $\xi^{\mathbb{1}}$ on $\mathbb{T}$ and define $H^{s-}(\mathbb{T})\left(\operatorname{resp} .\left(H^{s+}(\mathbb{T})\right)^{\prime}\right)$ as $H^{s-\epsilon}(\mathbb{T})\left(\right.$ resp. $\left.\left(H^{s+\epsilon}(\mathbb{T})\right)^{\prime}\right)$ for any $\epsilon>0$ small (see 2.8)-2.9) for detailed definitions). Our main result is the following:

THEOREM 1.1. Let $m \in \mathbb{R}_{+}$and $\phi_{1}, \phi_{2} \in H^{m-1 / 2-}$, such that

\phi_{1}=\sum_{n \in \mathbb{N}^{*}} a_{n}^{1} \sin (n x), \quad \phi_{2}=\sum_{n \in \mathbb{N}} a_{n}^{2} \cos (n x) \tag{1.3}
\end{equation*}

with,

$$
a_{0}^{2} \neq 0 \text { and } c n^{-m}<\left|a_{n}^{k}\right|<C n^{-m} \text {, for } k \in\{1,2\} \text { and } n \in \mathbb{N}^{*} \text {. }
$$

For any $\lambda>0$, there exist $K_{1}$ and $K_{2}$ bounded feedback functionals on $H^{m+1 / 2+}$ such that for any $y_{0} \in H^{m+r}$ with $r \in(-1 / 2,1 / 2)$, the equation

$$
\begin{cases}\partial_{t} y-\Delta y=K_{1}(y) \phi_{1}+K_{2}(y) \phi_{2}, & (t, x) \in(0,+\infty) \times \mathbb{T},  \tag{1.4}\\ y(0, \cdot)=y_{0}, & x \in \mathbb{T},\end{cases}
$$

has a unique solution satisfying

$$
\begin{equation*}
y \in C^{0}\left([0,+\infty) ; H^{m+r}(\mathbb{T})\right) \cap L_{l o c}^{2}\left((0,+\infty) ; H^{m+r+1}(\mathbb{T})\right) \cap H_{l o c}^{1}\left((0,+\infty) ; H^{m+r-1}(\mathbb{T})\right) . \tag{1.5}
\end{equation*}
$$

Moreover, we have the following exponential stability estimate,

$$
\begin{equation*}
\|y(t, \cdot)\|_{H^{m+r}} \leq C e^{-\lambda t}\left\|y_{0}\right\|_{H^{m+r}}, \quad \forall t \in[0,+\infty) \tag{1.6}
\end{equation*}
$$

where $C=C_{r}(\lambda, m)$ is a constant independent of $y_{0}$.
REMARK 1.2. Note that the feedback laws $K_{1}$ and $K_{2}$, as well as the backstepping transformations that we construct to obtain them, do not depend on $r \in(-1 / 2,1 / 2)$. Nonetheless, they stabilize the system in the $H^{m+r}$ spaces with $r \in(-1 / 2,1 / 2)$ (for an $H^{m+r}$ initial condition).

REMARK 1.3. The assumption $a_{0}^{2} \neq 0$ is necessary, as it is related to the eigenfunction 1 of 0 eigenvalue. Otherwise, one can easily check that the "mass", $\int_{\mathbb{T}} y(t, x) d x$, is conserved. In this case, instead of converging to 0 , the solution of the closed-loop system converges exponentially to the final equilibrium state $\tilde{y}(x):=\int_{\mathbb{T}} y_{0}(x) d x$.

The same feedback also stabilizes several related nonlinear systems such as the viscous Burgers equation and the nonlinear heat equations. More precisely, simply as an example, we have the following theorem which corresponds to the case $m=r=0$.

THEOREM 1.4. Let $\phi_{1}, \phi_{2} \in H^{-1 / 2-}$, such that

\phi_{1}=\sum_{n \in \mathbb{N}^{*}} a_{n}^{1} \sin (n x), \quad \phi_{2}=\sum_{n \in \mathbb{N}} a_{n}^{2} \cos (n x), \tag{1.7}
\end{equation*}
$$

with

$$
a_{0}^{2} \neq 0 \text { and } c<\left|a_{n}^{k}\right|<C, \text { for } k \in\{1,2\} \text { and } n \in \mathbb{N}^{*} .
$$

[^1]For any $\lambda>0$, there exists $K_{1}$ and $K_{2}$ bounded feedback functionals on $H^{1 / 2+}$ such that, for any $y_{0} \in L^{2}$, the equation

\partial_{t} y-\Delta y+\partial_{x}\left(y^{2} / 2\right)=K_{1}(y) \phi_{1}+K_{2}(y) \phi_{2}  \tag{1.8}\\

has a unique solution

\begin{equation*}
y \in C^{0}\left([0,+\infty) ; L^{2}(\mathbb{T})\right) \cap L_{l o c}^{2}\left((0,+\infty) ; H^{1}(\mathbb{T})\right) \cap H_{l o c}^{1}\left((0,+\infty) ; H^{-1}(\mathbb{T})\right) . \tag{1.9}
\end{equation*}
$$

Moreover, there exists $\delta>0$ such that for any $\left\|y_{0}\right\|_{L^{2}}<\delta$, we have the following exponential stability estimate

$$
\begin{equation*}
\|y(t, \cdot)\|_{L^{2}} \leq C e^{-\lambda t}\left\|y_{0}\right\|_{L^{2}}, \quad \forall t \in[0,+\infty) \tag{1.10}
\end{equation*}
$$

where $C=C(\lambda)$ is a constant independent of $y_{0}$.

### 1.2 Related results: the heat equation and the backstepping method

There exists various way to design feedback laws for infinite dimensional systems: Riccati equations (see for instance [36, 45] and the references therein), Gramian methods [31, 46], Lyapunov functionals (see for instance [5, 23, 28, 29, 48]) or pole-shifting techniques [40, 41, and among others. The backstepping method is also among these methods, and its use for infinite dimensional systems can be traced back to Russell [42] and to Balogh and Krstic [3] (we refer to [15, 32, 43] for an introduction to the finite dimensional backstepping method). Obtained as the continuum limit of a stabilization method applied to space discretizations of PDEs, the backstepping method relied at first on a Volterra transformation of the second kind mapping the system to another stable target system. The Volterra transformation having the advantage of always being invertible, only the existence remains to prove, which is equivalent to solving a PDE of the kernel on a triangular domain. These PDEs usually do not enter in the classical Cauchy problem framework, but different techniques are now known to solve the kernel equation: successive approximations [33, explicit representations 33] or method of characteristics [19]. There exists now a vast literature on the backstepping method with Volterra transformations: let us cite for the heat/parabolic equation [3, 9, 22], for hyperbolic systems [6] and for the viscous Burgers equation [24]. We refer to [33] to a general overview of the backstepping method with Volterra transformations.

As of late, the Fredholm transformation was introduced for the backstepping method as an alternative for certain limitations of the Volterra transformation. In particular, it seems better suited for internal stabilization problems [16, 51]. The idea of using transformations remains the same, but proving the existence and invertibility of the transformation is generally more involved. There are mainly two ways to prove the existence of the transformation, either by direct methods [18, 19] or, more commonly, by proving the existence of a Riesz basis. For the latter, we again distinguish two cases: either the Riesz basis is deduced directly by an isomorphism applied on an eigenbasis [17, 50, 51] or the existence of a Riesz basis follows by controllability assumptions and sufficient growth of the eigenvalues of the spatial operator allowing in particular to prove that the family is quadratically close to the eigenfunctions [16, 20, 21, 27] (see Section 2.2 and Section 4 for a definition).

Finally, a large number of papers in the literature have addressed the exponential stability of the heat equations via feedback laws by different means (see for instance [2, 3, 4, 10, 30, [34, 35, 38] and references therein). We highlight two recent papers on the subject, one on the
exponential stability through impulsive feedback for the heat equation [39], and the second [48] linked with the quantitative estimate on the stabilization cost $C_{r}(\lambda, m)$ (we refer to Section 1.3.3 and Section 7.1 on this subject).

### 1.3 Contributions

One of the major contributions of this paper is the thorough study of the optimal functional setting for backstepping transformations for the Laplace operator. To illustrate this into perspective, we first present the backstepping problem in a finite-dimensional setting.

### 1.3.1 Backstepping in finite dimension

In a very general setting, finding backstepping transformations for exponential stabilization consists in solving a specific set of equations. Consider the control system,

$$
\begin{equation*}
\dot{x}=A x+B u, \tag{1.11}
\end{equation*}
$$

the aim is to find suitable a invertible operator $T$ and a feedback law $K$ such that, if $x_{1}$ is a solution of

$$
\begin{equation*}
\dot{x}_{1}=A x_{1}+B K x_{1}, \tag{1.12}
\end{equation*}
$$

then $x_{2}:=T x_{1}$ is a solution of

$$
\begin{equation*}
\dot{x}_{2}=\tilde{A} x_{2}, \tag{1.13}
\end{equation*}
$$

where $\tilde{A}$ is an exponentially stable operator. In many cases, one makes the classical choice $\tilde{A}=A-\lambda I$.

Formally, we have

$$
\begin{equation*}
\tilde{A} T x_{1}=\tilde{A} x_{2}=\dot{x}_{2}=T \dot{x}_{1}=T(A+B K) x_{1} . \tag{1.14}
\end{equation*}
$$

Thus, $(T, K)$ should solve the following operator equation

$$
\begin{equation*}
T(A+B K)=\tilde{A} T \tag{1.15}
\end{equation*}
$$

This equation is nonlinear in $(T, K)$, which makes it difficult to solve. However, adding the natural condition $T B=B$ to this equation,

$$
\left\{\begin{array}{l}
T A+B K=\tilde{A} T,  \tag{1.16}\\
T B=B
\end{array}\right.
$$

makes it linear in $(T, K)$ and ensures the existence and uniqueness of a solution, as two controllable systems are always $F$-equivalent (feedback equivalent), which in our case corresponds exactly to equation (1.16).

THEOREM 1.5 ([1]). Let $A, \tilde{A} \in \mathbb{R}^{n \times n}, B \in \mathbb{R}^{n \times l}$. If both $(A, B)$ and $(\tilde{A}, B)$ are controllable, then there exists a unique pair $(T, K) \in G L_{n}(\mathbb{R}) \times \mathbb{R}^{l \times n}$ satisfying equations 1.16.

The proof of this result relies on the fact that in finite dimension, controllable systems can always be written in control canonical form. Hence, writing (1.15) using the canonical form for the pairs $(A, B)$ and $(\tilde{A}, B)$ (assuming both are controllable) yields naturally the first equation of (1.16) and $T B=B$ (see [17] for more details).

We call the system (1.16) the backstepping equations, and its first equality the operator equality. Exponential stabilization is a direct consequence of this equality. Indeed, $x_{2}$ decays exponentially with rate $\lambda$ and, since $T$ is an invertible operator, so does $x_{1}$ :

$$
\begin{align*}
\left\|x_{1}(t)\right\| & =\left\|T^{-1} x_{2}(t)\right\| \\
& \leq\left\|T^{-1}\right\|\left\|x_{2}(t)\right\| \\
& \leq e^{-\lambda t}\left\|T^{-1}\right\|\left\|x_{2}(0)\right\|  \tag{1.17}\\
& \leq e^{-\lambda t}\left\|T^{-1}\right\|\| \| T\| \| x_{1}(0) \| .
\end{align*}
$$

Rapid stabilization via backstepping therefore reduces to the existence of solutions ( $T, K$ ) to the backstepping equations (1.16).

In infinite dimension, the situation is more complex, but the same philosophy applies. The role of controllability in finding such backstepping transformations has been established for several important PDE models such as the transport equation [51], the KdV equation [20], Kuramoto-Sivashinsky equation [21, the linearized Schrödinger equation [16], the linearized Saint-Venant equation [17]. We highlight that the uniqueness equation $T B=B$ was decisive in [16, 17, 51] to transform non-local terms emanating from distributed control functions into local terms for the operator equality, but was fundamentally used in an implicit way in [20, 21] for boundary controls.

The general case remains wide open, and is considerably more involved. Indeed, it is not reasonable for instance to expect that two PDEs with wildly differing physical properties should be related to one another by a backstepping transformation.

Open Problem 1. Let $A, \tilde{A}$ and $B$ be (unbounded) operators. Is there a necessary and sufficient condition on $A, \tilde{A}, B$ to guarantee the existence and the uniqueness of the solution $(T, K)$ to the operator equality 1.16)?

An important common feature of the infinite-dimensional results mentioned above is that the eigenvalues of the operator $A$ are simple and isolated. This plays a role in the controllability property (through the moments method), which is crucial to implement the backstepping method in the references above. In our case, as we have pointed out above, all non-zero eigenvalues have multiplicity greater than 1 (this will be specified rigorously in the next section), a feature which occurs in several PDE models, such as the water waves system. As a consequence, the system is not controllable with a single internal control. This phenomenon appears quite often when working on compact Riemannian manifolds, for example Schrödinger equations on torus. To tackle this difficulty, we consider backstepping with two internal scalar controls.

Backstepping with two scalar controls has already been implemented in [13] for a coupled KdV-KdV system with two boundary controls, for which, because of the coupling nature, it is natural to introduce two control terms. More recently, it has been improved in [12], where the authors showed that only one control is sufficient to stabilize the system.

### 1.3.2 Sharp functional setting for the Laplacian

Another important contribution of our paper is to present a sharp functional setting, with respect to the state space and control space, for the application of the backstepping method with a Fredholm transform in the case of the Laplacian with periodic boundary conditions. In particular, we deduce the sharp spaces $H^{s}(\mathbb{T})$ for which the Riesz basis exists, which is crucial for the application of the backstepping method with a Fredholm transformation. We hope this precise framework could extend the knowledge on backstepping method using Fredholm type
transformation, for example on the use of nonlinear systems, and on other important models. For instance, Proposition 3.4, Corollary 3.5 and Lemma 4.14 .3 can be similarly proved for Schrödinger equations on $\mathbb{T}$, which somehow extends the analysis of [16]. It is interesting to further investigate whether these new observation could be applied to the bi-linear Schrödinger equations. This analysis could also be applied to evolution equations with fractional Laplacian $(-\Delta)^{\alpha}$, at least for $\alpha$ strictly larger than $3 / 4$, where similar results (at least partially, depending on the value of $\alpha$ ) to Lemma 4.1 can be proved.
Indeed, it seems that the critical growth of the eigenvalues for the existence of a quadratically close Riesz basis is $\left|\lambda_{n}\right| \sim n^{3 / 2+\epsilon}$ (i.e. $\alpha>3 / 4$ is the case of the fractional Laplacian), meaning that for a growth of order $\left|\lambda_{n}\right| \sim n^{s}, 1 \leq s \leq 3 / 2$ does not seem enough to prove that the family is quadratically close to the eigenbasis. An interesting open problem is therefore to apply the backstepping method with a Fredholm type transformation for spatial operator with eigenvalues with growth $\left|\lambda_{n}\right| \sim n^{s}, 1<s \leq 3 / 2$, the first-order equation being excluded due to the positive answer [17, 51] and its link to other transformation such as the Hilbert transform. However the case $1<s \leq 3 / 2$ remains and this analysis may give some inspiration on the study of fractional Laplacian with the value of $\alpha$ lower than this threshold.

Moreover, we also highlight that the framework investigated here is closely related to the one found for the linear Schrödinger equation in [16]. A major distinction between [16] and the present article is that the well-posedness for the closed-loop system here relies on the dissipation properties of the heat equation. Hence, there is no need to satisfy the operator equality $T(A+B K)=(A-\lambda I) T$ for functions in $D(A+B K)$ (see Remark 3.6).

### 1.3.3 Cost of stabilization

Finally, as we can see from Theorem 1.1 (more precisely, from Section 6), it is totally a new observation that the same feedback law stabilizes the system in $H^{m+r}$ with some cost $C_{r}(\lambda, m)$ depending on $r \in(-1 / 2,1 / 2)$ and $\lambda \notin \mathcal{N}$. It is an important but challenging problem to get any quantitative description of this constant $C_{r}(\lambda, m)$ in view of possible applications. Such a description would also be interesting for finite time stabilization problems, namely $C e^{C \lambda^{\beta}}$ type estimates. So far such estimates have been achieved via different methods, relying on direct energy estimates [22], Bessel functions [25], iterative methods [47], and spectral inequalities [48, 49]. However, so far such important property has not yet been discovered for Fredholm type backstepping methods. Armed with the precise description introduced in this paper, we believe that we are closer to an answer.

### 1.4 Structure of the paper

This paper is organized as follows: in Section 2 we define the functional setting, in Section 3 we show that the system (1.2) with a single control is neither controllable nor stabilizable, in Section 3.3 we present the double backstepping approach. In Sections 4 and 5 we prove the main propositions and lemma on which the backstepping method relies. Finally in Section 6 we prove Theorem 1.1 .1 .4.

## 2 Functional setting

### 2.1 Function spaces

We start by recalling some results on the eigenvectors and eigenvalues of the Laplacian on the torus. Observe that the classical Fourier series $\left\{e^{i n x}\right\}_{n \in \mathbb{Z}}$ in $\mathbb{T}$ are eigenfunctions of the Laplacian operator $\Delta$ associated to the eigenvalues $\lambda_{n}:=-n^{2}$, and form an orthonormal basis of $L^{2}(\mathbb{T})$. Note that thanks to the fact that we are working on $\mathbb{T}$ without boundary, the Sobolev space $H^{s}$ coincides with the span of $\left\{n^{s} e^{i n x}\right\}$. Note also that

$$
\lambda_{n}=\lambda_{-n}=-n^{2},
$$

and therefore the nonzero eigenvalues have multiplicity 2 . We therefore easily deduce the existence of an orthonormal basis of real-valued eigenfunctions for the Laplacian:

$$
\begin{gather*}
f_{n}^{1}:=\frac{1}{\sqrt{\pi}} \sin n x, f_{n}^{2}:=\frac{1}{\sqrt{\pi}} \cos n x, \text { associated to } \lambda_{n}:=-n^{2}, \forall n \in \mathbb{N}^{*}, \\
f_{0}^{2}:=\frac{1}{\sqrt{2 \pi}}, \text { associated to } \lambda_{0}:=0 . \tag{2.1}
\end{gather*}
$$

Except in Section 3 where using the Fourier series $\left\{e^{i n x}\right\}_{k \in \mathbb{Z}}$ is convenient, we will use this basis, and work with real-valued functions, i.e. $L^{2}(0,2 \pi ; \mathbb{R})$. We further define

$$
\begin{gather*}
L_{1}^{2}:=\operatorname{span}_{\mathbb{R}}\{\sin n x\}_{n \in \mathbb{N}^{*}}, \text { describing the odd functions, }  \tag{2.2}\\

(1) Minimal in $X$, if for every $k \in \mathcal{I}, \xi_{k} \notin \overline{\operatorname{span}\left\{\xi_{i} ; i \in \mathcal{I}-\{k\}\right\}}$.
(2) Dense in $X$, if $\overline{\operatorname{span}\left\{\xi_{i} ; i \in \mathcal{I}\right\}}=X$.
(3) $\omega$-independent in $X$, if

These definitions allow us to give the following criteria for a Riesz basis which will be used later on in Section 4.2.

Suppose that $\left\{\xi_{n}\right\}_{n \in \mathcal{I}}$ is either dense in $X$ or $\omega$-independent in $X$, then $\left\{\xi_{n}\right\}_{n \in \mathcal{I}}$ is a Riesz basis of $X$.

It is noteworthy that under the assumption that $\left\{\xi_{n}\right\}_{n \in \mathcal{I}}$ is quadratically close to some orthonormal basis $\left\{e_{n}\right\}_{n \in \mathcal{I}}$, if for some coefficients $\left\{c_{n}\right\}_{n \in \mathcal{I}} \in \mathbb{R}^{\mathcal{I}}$ (or $\mathbb{C}^{\mathcal{I}}$ ) the following series converges in the Cauchy sense

& \geq\left(\sum_{k>|N|, k \in \mathcal{I}}\left(c_{k}\right)^{2}\right)^{1 / 2}-\left(\frac{1}{4} \sum_{k>|N|, k \in \mathcal{I}}\left(c_{k}\right)^{2}\right)^{1 / 2} \\
& =\frac{1}{2}\left(\sum_{k>|N|, k \in \mathcal{I}}\left(c_{k}\right)^{2}\right)^{1 / 2} .
\end{aligned}

Therefore, $\left\{c_{n}\right\}_{n \in \mathcal{I}} \in \ell^{2}(\mathcal{I})$.
We also have the following Lemma that will be useful in the Section 4.2.
LEMMA 2.3. Let $X, Y$ be Hilbert spaces. Let $T: X \rightarrow Y$ be an isomorphism. Suppose that $\left\{\xi_{n}\right\}_{n \in \mathcal{I}}$ is a Riesz basis of $X$, then with $\zeta_{n}:=T \xi_{n}$, the family $\left\{\zeta_{n}\right\}_{n \in \mathcal{I}}$ is a Riesz basis of $Y$.

Proof. If $X=Y$ we can directly use Definition 2.1 (5) to show that it is a Riesz basis as the image of an orthonormal basis by an isomorphism on $X$. Otherwise, a quite straightforward proof is given according to Definition 2.1 (5)'.

We first show the inequality 2.24 . Thanks to the fact that $T$ is an isomorphism and that $\left\{\xi_{n}\right\}_{\mathbb{Z}}$ is a Riesz basis of $X$, there exist constants $C, C_{1}$ and $C_{2}$ such that

Next, we show that $\left\{\zeta_{n}\right\}_{\mathcal{I}}$ is dense in $Y$. For any $\zeta \in Y$, since $T^{-1} \zeta=: \xi \in X$, for any $\varepsilon>0$ there exist a finite combination such that

LEMMA 2.4 (Proposition 19 of [8]). Let $X$ be a Hilbert space. Suppose that $\left\{\xi_{n}\right\}_{n \in \mathcal{I}}$ is a Riesz basis of $X$, then its bi-orthogonal sequence $\left\{\xi_{n}^{\prime}\right\}_{n \in \mathcal{I}}$ is also a Riesz basis of $X$, where bi-orthogonal means,

## 3 From one to two controls

As we have mentioned in the introduction, due to the multiplicity of its nonzero eigenvalues, our system is not controllable with a single internal scalar control. We prove this assertion, and prove that controllability can however be achieved with two internal scalar controls. We then lay out how we adapt the backstepping method to obtain a stabilization result with two controls.

### 3.1 Non-controllability with one scalar control

In this section we show that, for any $T>0$, the system $(1.2$ is not controllable. Recall that $\left\{e^{i n x}\right\}_{n \in \mathbb{Z}}$ is a basis of eigenfunctions of $A$ associated to the eigenvalue $\lambda_{n}=-n^{2}$. For ease of the presentation and for symmetry considerations, in this section we choose to work with the orthonormal basis $\left\{e^{i n x}\right\}_{n \in \mathbb{Z}}$ instead of $\{\sin n x, \cos n x\}$. Therefore, either

or the system is non-controllable as there exists $n_{0}$ such that $\left\langle\phi, e^{i n_{0} x}\right\rangle=0$ and therefore the control has no effect on the associated one dimensional vector space: $e^{-n_{0}^{2} t+i n_{0} x}$ is a solution of (1.2) with initial condition $e^{i n_{0} x}$, whatever the control is. Assume now that (3.1) holds. Motivated by the moment method (see for instance [26]) and the fact that $\lambda_{n}=\lambda_{-n}$ we have for a solution $u$ to 1.2 with $u(0)=0$,

thus let us denote

one has

Hence the states $u(T, \cdot)$ that are reachable at time $T$ satisfy the following

which means that the projection of the reachable space on the two dimensional space $\operatorname{Span}\left\{e^{i n x}, e^{-i n x}\right\}$ is always of one dimension, hence the system is not controllable.

This non-controllability prevents any stabilization result. For instance, we can simply consider the space $\operatorname{Span}\{\sin n x, \cos n x\}$, as we are only allowed to change the direction of $\left(a_{n} e^{i n x}+e^{-i n x}\right)$, the projection of the solution on its co-direction $\left(e^{i n x}-a_{n} e^{-i n x}\right)$ does not change, thus the solution is not asymptotically stable whatever the feedback control.

The setting is different from the one found in [37] for controllability and [48] for finite time stabilization (the special case for $\mathbb{T}$, as these papers deal with general compact Riemannian manifolds), where the controllability and the stabilizability is obtained under the assumption that the controlled domain is $\omega \subset \mathbb{T}$, for which the control has infinite degrees of freedom. and not a one dimensional scalar control.

### 3.2 Controllability with two scalar controls

According to the preceding section, two controls are required for the controllability of the heat equation on $\mathbb{T}$ : $\phi_{1} v_{1}(t)+\phi_{2} v_{2}(t)$, which corresponds to the system 1.1. In fact, two controls are eventually sufficient. In the following we prove the controllability in $L^{2}(\mathbb{T})$ space, while the other spaces can be treated similarly.

Due to the smoothing effect of the heat equation we only consider the so-called null controllability, i.e. for any $u_{0} \in L^{2}(\mathbb{T})$ there exist $v_{1}, v_{2} \in L^{2}(0, T)$ (this space is the natural space according to Lions' Hilbert Uniqueness Method, though this is not the optimal candidate) such that the final state becomes 0 . In order to simplify the presentation, we always assume the projections of $\phi_{1}, \phi_{2}, u_{0}$ on the direction corresponding to the eigenfunction $e^{i 0 x}$ to be 0 . Assuming that

u_{0}=\sum_{n \in \mathbb{N}^{*}} b_{n}^{1} e^{i n x}+b_{n}^{2} e^{-i n x} \in L^{2}(\mathbb{T})
$$

Direct calculation yields,

$$
\begin{aligned}
u(T)= & \int_{0}^{T} e^{A(T-s)}\left(\phi_{1} v_{1}(t)+\phi_{2} v_{2}(t)\right) d s+\int_{0}^{T} e^{A(T-s)} u_{0} d s \\
= & \sum_{n \in \mathbb{N}^{*}}\left(\int_{0}^{T} e^{\lambda_{n}(T-s)}\left(\left\langle\phi_{1}, e^{i n x}\right\rangle v_{1}(s)+\left\langle\phi_{2}, e^{i n x}\right\rangle v_{2}(s)\right) d s\right) e^{i n x} \\
+ & \sum_{n \in \mathbb{N}^{*}}\left(\int_{0}^{T} e^{\lambda_{n}(T-s)}\left(\left\langle\phi_{1}, e^{-i n x}\right\rangle v_{1}(s)+\left\langle\phi_{2}, e^{-i n x}\right\rangle v_{2}(s)\right) d s\right) e^{-i n x} \\
& +\sum_{n \in \mathbb{N}^{*}}\left(\frac{b_{n}^{1}}{e^{n^{2} T}} e^{i n x}+\frac{b_{n}^{2}}{e^{n^{2} T}} e^{-i n x}\right)
\end{aligned}
$$

The preceding formula indicates that the null controllability requires that

\left\langle\phi_{1}, e^{i n x}\right\rangle & \left\langle\phi_{1}, e^{-i n x}\right\rangle \\
\left\langle\phi_{2}, e^{i n x}\right\rangle & \left\langle\phi_{2}, e^{-i n x}\right\rangle
\end{array}\right)=-\left(\begin{array}{l}
b_{n}^{1} \\
e^{n^{2} T}
\end{array}, \frac{b_{n}^{2}}{e^{n^{2} T}}\right) .
$$

Consequencely, for any $n \in \mathbb{N}^{*}$ provided that the following matrix is invertible, we can control the two dimensional space $\operatorname{Span}\left\{e^{i n x}, e^{-i n x}\right\}=\operatorname{Span}\{\cos n x, \sin n x\}$,

\end{array}\right), \quad \forall n \in \mathbb{N}^{*} .
$$

It is a quite general assumption to achieve, a simple example can be

\phi_{1}(x)=\sum_{n \in \mathbb{N}^{*}} c_{n}^{1} e^{i n x}, \phi_{2}(x)=\sum_{n \in \mathbb{N}} c_{n}^{2} e^{-i n x},
$$

with $c_{n}^{1} c_{n}^{2} \neq 0$ for any $n \in \mathbb{N}^{*}$. Note that, as mentioned earlier, we excluded the direction $1=e^{i 0 x}$ corresponding to the case $n=0$ to simplify the presentation but it could be included as well. Heuristically, this case already provides the exact controllability in projections on finite dimensional subspaces, for example, $\operatorname{span}\left\{e^{i n x}:-N<n<N\right\}$. Moreover, if further $c_{n}^{1}, c_{n}^{2}$ satisfy some suitable growth assumption, the system is even exact null controllable in $L^{2}(\mathbb{T})$.

PROPOSITION 3.1. If there exist $-\infty<\alpha \leq \beta<1 / 2$ and $c, C>0$ such that

c n^{\alpha} \leq\left|c_{n}^{1}\right|,\left|c_{n}^{2}\right| \leq C n^{\beta}, \forall n \in \mathbb{N}^{*} \tag{3.6}
\end{equation*}
$$

then the system (1.1) is $L^{2}(\mathbb{T})$ exact null controllable.
REMARK 3.2. The assumption on $\beta<1 / 2$ is here to guarantee that the functions $\phi_{i} \in H^{-1}$. Thus for any given $v(t) \in L^{2}(0, T)$ the inhomogeneous term $v(t) \phi_{i}(x)$ belongs to $L^{2}\left((0, T) ; H^{-1}\right)$, which indicates that the open-loop system is well-posed in $C^{0}\left([0, T) ; L^{2}\right) \cap L^{2}\left((0, T) ; H^{1}\right)$. On the other hand, the assumption $-\infty<\alpha$ is used for the null controllability property that will be proved in the following. The lower bound on $c_{n}^{i}$ proposed here is not the sharp condition. As we can see from the following proof, to get the null controllability in $L^{2}(\mathbb{T})$ space, it suffices to find some $0<T_{0}<T$ and $C>0$ such that

which is of course weaker than the condition proposed in Proposition 3.1.
Proof of Proposition 3.1. In order to solve the controllability problem, it suffices to treat the following moment problem: show that for any $\left\{b_{n}^{1}\right\}_{\mathbb{N}^{*}},\left\{b_{n}^{2}\right\}_{\mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right)$, there exist $v_{1}(t), v_{2}(t) \in$ $L^{2}(0, T)$ such that

& \int_{0}^{T} e^{-n^{2}(T-s)} v_{2}(s) d s=\frac{b_{n}^{2}}{e^{n^{2} T} c_{n}^{2}}, \quad \forall n \in \mathbb{N}^{*} . \tag{3.9}
\end{align*}
$$

Solving this problem is, in fact, a direct consequence of the following moment theory.
LEMMA 3.3 ([26], Section 3, Equation (3.25)). For any $T>0$. The sequence $\left\{e^{-\left.n^{2}(T-s)\right|_{s \in(0, T)}}\right\}_{n \in \mathbb{N}^{*}}$ is minimal in $L^{2}(0, T)$, thus admits a bi-orthogonal sequence $\left\{\Psi_{n}\right\}_{n \in \mathbb{N}^{*}}$ satisfying

Moreover, there exists $C>0$ such that

By adapting Lemma 3.3, and assuming (3.6), we know that the moment problem (3.8) can be solved by setting

\left\|v_{1}\right\|_{L^{2}(0, T)} \leq \sum_{n \in N^{*}} C b_{n}^{1} n^{-\alpha} e^{C n-T n^{2}} \leq C_{2} \sum_{n \in N^{*}} b_{n}^{1} e^{-T n^{2} / 2}<+\infty, \tag{3.13}
\end{equation*}
$$

where $C_{2}>0$ is a constant independent of $n$. Then a similar procedure leads to $v_{2}(t)$ as the solution of the moment problem (3.9).

### 3.3 Double backstepping: strategy and outline

Inspired by the fact that $(\sin (n x), \cos (n x))$ form an orthonormal basis of the two-dimensional eigenspaces corresponding to the eigenvalue $\lambda_{n}$, we directly consider the special form of $\phi_{k}$ :

\phi_{2} & :=\sum_{n \in \mathbb{N}} a_{n}^{2} \cos n x \in L_{2}^{2} . \tag{3.15}
\end{align*}
$$

We can similarly separate the function $y(t)$ in

y(t)=: y_{1}(t)+y_{2}(t) \text { with } y_{k} \in L_{k}^{2} . \tag{3.16}
\end{equation*}

Therefore,

\partial_{t} y_{1}-\partial_{x}^{2} y_{1}=u_{1}(t) \phi_{1}  \tag{3.17}\\
\partial_{t} y_{2}-\partial_{x}^{2} y_{2}=u_{2}(t) \phi_{2}
\end{array}\right.
$$

The logic behind is to deal with the odd functions using the first control and with the even functions using the other one. What we are going to show is that each of the systems (3.17) can be rapidly stabilized for $k \in\{1,2\}$.

To do so, we would like to show that for any $k \in\{1,2\}$ and for any $\lambda>0$, under some conditions on $\phi_{k}$, there exists an isomorphism $T_{k}(\lambda): L_{k}^{2} \rightarrow L_{k}^{2}$ as well as a feedback $u_{k}(t):=$ $K_{k}(\lambda) y_{k}(t, x)$ such that the solution of

\partial_{t} y_{k}-\partial_{x}^{2} y_{k}=\phi_{k} K_{k} y_{k} \\
y_{k}(0) \in L_{k}^{2}
\end{array}\right.
$$

is such that $z_{k}:=T_{k}(\lambda) y_{k}$ satisfies the following equation

\partial_{t} z_{k}-\partial_{x}^{2} z_{k}-\lambda z_{k}=0, z_{k} \in L_{k}^{2} \tag{3.18}
\end{equation*}
$$

With this property, the stabilization result would follow simply by a decomposition of $y$ in odd and even parts provided that the system is well-posed.

This existence of an isomorphism $T_{k}$ and a feedback law $K_{k}$ is given by the following key proposition.

PROPOSITION 3.4. Let the countable set

Then for any $\lambda \notin \mathcal{N}$, there exists a sequence $\left\{K_{n}^{k}\right\}_{n}$ satisfying

c n^{m}<\left|K_{n}^{k}\right|<C n^{m}, \text { for } k \in\{1,2\}, \text { for } n \in \mathbb{N}^{*}, \\
\left\{\left(\lambda+a_{n}^{k} K_{n}^{k}\right) n^{r}\right\}_{n} \in \ell^{2}, \quad \forall r \in[0,1 / 2),
\end{gathered}
$$

$K_{k}$ is a bounded functional on $H_{k}^{m+1 / 2+}$,
such that the linear operator $T_{k}$ defined as follows

& \rightarrow \mathcal{S}_{k}^{\prime},  \tag{3.23}\\
& f_{n}^{k} \mapsto-K_{n}^{k} \sum_{p} \frac{a_{p} f_{p}^{k}}{p^{2}+\lambda-n^{2}},  \tag{3.24}\\
& f_{n}^{3-k} \mapsto 0,
\end{align*}
$$

can be linearly extended to $\mathrm{H}^{m-3 / 2+}$, and

T_{k} \text { is an isomorphism on } H_{k}^{m+s} \text { for any } s \in(-3 / 2,3 / 2),  \tag{3.25}\\
T_{k} \phi_{k}=\phi_{k} \text { in } H_{k}^{m-1 / 2-} \tag{3.26}
\end{gather*}
$$

and moreover, for any $r \in(-1 / 2,1 / 2)$, for any $\varphi \in H_{k}^{m+r+1}$ we have that

This proposition gives exactly what we want. Indeed, if we denote by

COROLLARY 3.5. Under the assumption of Proposition 3.4, the transformation $T_{12}$ can be linearly extended on $H^{m-3 / 2+}$. Moreover,
$T_{12}$ is an isomorphism on $H^{m+s}$ for any $s \in(-3 / 2,3 / 2)$,
and, for any $r \in(-1 / 2,1 / 2)$, for any $\varphi \in H^{m+r+1}$,

Proposition 3.4 will be proved in Section 4 .
REMARK 3.6. The functional setting of $\sqrt[3.29]{ }$ is optimal without assuming additional compatibility conditions. Indeed, as shown in [16], the operator equality (3.29) is satisfied for $r=1$ if $\phi \in H^{m+r+1}$ satisfies additional compatibility conditions, for $\varphi$ satisfying some regularity requirement, namely $D(A+B K)$. In [16], this can be seen from the fact that $r \geq 1 / 2$ is the precise space for which the trace of $\phi$ makes sense and for which the compatibility conditions can be ensured.

## 4 Building the backstepping transformation

In this section we only work on the odd functions which correspond to the $H_{1}^{m}$ spaces. We assume $k=1$ in the following. Similar results hold for even functions which correspond to the $H_{2}^{m}$ spaces. To simplify the notations, in this section we ignore the index $k$ and we also denote $T:=T_{k}, K:=K_{k}$ and $\phi:=\phi_{k}$. This Section will be divided in several parts:

1. In Section 4.1 we reformulate the problem by projecting the equation on the eigenfunctions of $A$ and we build a candidate $T$ to satifies the operator equality 3.27 ).
2. In Section 4.2 we prove some Riesz basis properties which will be used to study the invertibility of $T$.
3. In 4.3 we prove the existence of a feedback $K$ such that the corresponding candidate $T$ satisfies the condition $T \phi=\phi$ weakly.
4. In Section 4.5 we show that this candidate $T$ is an isomorphism that satisfies the operator equality (3.27).

### 4.1 Setting up for the backstepping transformation

We want to map the solution of

via transformation $T$, to the solution of

\end{equation*}
$$

To achieve this aim we would like $T$ to satisfies formally the backstepping conditions

& T \phi=\phi \tag{4.4}
\end{align*}

for a suitable feedback law $K$ :

Projected on the eigenvectors $f_{n}:=\sin n x$ with eigenvalues $\lambda_{n}=-n^{2}$, the formal relation 4.3) becomes

the first condition becomes

Projecting the preceding equation now on $f_{p}$, defining

Therefore

q_{n}:=-\frac{h_{n}}{K_{n}}=\sum_{p \in \mathbb{N}^{*}} \frac{a_{p} f_{p}}{\lambda_{n}-\lambda_{p}+\lambda}, \quad \forall n \in \mathbb{N}^{*} \tag{4.12}
\end{equation*}
$$

Inspired by the preceding formula, the number $\lambda$ should be selected in such a way that

\lambda_{n}-\lambda_{p}+\lambda \neq 0, \quad \forall p, n \in \mathbb{N}^{*} \tag{4.13}
\end{equation*}

which is rather easy to achieve, for example to choose from $\mathbb{N}^{*}+1 / 2$. More precisely, it suffices to choose

### 4.2 Riesz basis properties

Recall that for any $n \in \mathbb{N}^{*}$,

h_{n}:=T f_{n}, \quad-K_{n} q_{n}:=h_{n},  \tag{4.17}\\
q_{n}=\sum_{p \in \mathbb{N}^{*}} \frac{a_{p} f_{p}}{\lambda_{n}-\lambda_{p}+\lambda},  \tag{4.18}\\
g_{n}:=\sum_{p \in \mathbb{N}^{*}} \frac{f_{p}}{\lambda_{n}-\lambda_{p}+\lambda} \in H^{3 / 2-} . \tag{4.19}
\end{gather*}
$$

This last claim on the regularity of the $g_{n}$ comes from the growth of the eigenvalues $\lambda_{p}$, i.e., for any $n \in \mathbb{N}^{*}$ we have

\end{equation*}
$$

$$
\begin{equation*}
\left\|g_{n}\right\|_{H^{s}}^{2}=\sum_{p \in \mathbb{N}^{*}} \frac{p^{2 s}}{\left(p^{2}-n^{2}+\lambda\right)^{2}}=+\infty, \text { for } s=3 / 2 . \tag{4.21}
\end{equation*}
$$

Notice that $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$ is uniquely determined by the value of the function $\phi$, while the sequences $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ and $\left\{q_{n}\right\}_{n \in \mathbb{N}^{*}}$ are independent of the choice of $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$. Hence any sequence $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ determines the value of $\left\{h_{n}\right\}_{n \in \mathbb{N}^{*}}$, thus the operator $T$, and such operator $T$ (at least formally) satisfies the equation (4.3).

### 4.2.1 Existence

The following lemma is devoted to the properties of $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$, to the properties of $\left\{q_{n}\right\}_{n \in \mathbb{N}^{*}}$ provided some suitable assumption on $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$, and to the properties of the transformation $T$ provided some assumption on both $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$ and $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$.
LEMMA 4.1. Let $m \geq 0$. Let $a_{n} \neq 0$ such that $c n^{-m}<\left|a_{n}\right|<C n^{-m}$. Let $\lambda \notin \mathcal{N}$. The following properties hold:
(1) $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $L_{1}^{2}$.
(2) Let $s \in(-3 / 2,3 / 2)$. Then $\left\{n^{-s} g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{s}$.
(3) Let $s \in(-3 / 2,3 / 2)$. Then $\left\{n^{-s} q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{m+s}$.
(4) Let $m \geq 0$. Let $s \in(-3 / 2,3 / 2)$. If $K_{n}:=\left\langle f_{n}, K\right\rangle$ is chosen in such a way that $\left|K_{n}\right|<C n^{m}$, then the transformation $T: H_{1}^{m+s} \rightarrow H_{1}^{m+s}$ is bounded.
Moreover, if $\mathrm{cn}^{m}<\left|K_{n}\right|<C n^{m}$, then the transformation $T: H_{1}^{m+s} \rightarrow H_{1}^{m+s}$ is an isomorphism.

Let us remark here that all the choices of $s$ and $r$ in the above are sharp.
We give here the key ideas of the proof. The rigorous proof itself is detailed below.

- In order to show that $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $L_{1}^{2}$ we show first that it is quadratically close to $\left\{f_{n} / \lambda\right\}_{n \in \mathbb{N}^{*}}-$ which is obviously an orthonormal basis of $L_{1}^{2}-$ and then we show that $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is either $\omega$-independent or dense in $L_{1}^{2}$ and we conclude using Lemma 2.2 . Showing that $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is quadratically close to $\left\{f_{n} / \lambda\right\}_{n \in \mathbb{N}^{*}}$ amounts to show that

$$
\begin{equation*}
\left(\sum_{p \in \mathbb{N}^{*}} \frac{f_{p}}{\lambda_{n}-\lambda_{p}+\lambda}\right)_{n \in \mathbb{N}^{*}} \text { is quadratically close to }\left(\frac{f_{n}}{\lambda}\right)_{n \in \mathbb{N}^{*}} \text { in } L_{1}^{2} . \tag{4.22}
\end{equation*}
$$

For this, it suffices to show that

\begin{equation*}
\sum_{n \in \mathbb{N}^{*}} \sum_{p \neq n}\left(\frac{1}{p^{2}+\lambda-n^{2}}\right)^{2}<+\infty \tag{4.23}
\end{equation*}
$$

which can be done by cases (see 4.36 4.45 below) by using that for $\lambda \in \mathbb{N}^{*}$ and any $n>\lambda$ and $p<n$ there exists $j \in\{1, \ldots, n-1\}$ such that $p=(n-j)$ and

n^{2}-(n-j)^{2}-\lambda \geq\left(n^{2}-(n-j)^{2}\right) / 2 . \tag{4.24}
\end{equation*}

One can look at 4.39-(4.41) for more details, and Remark 4.2 for general value of $\lambda$.

- Showing that $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is either $\omega$-independent or dense in $L_{1}^{2}$ can be done by noticing first that

and assuming that $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is not $\omega$-independent (otherwise the proof is done). Then, we deduce the existence of

\end{equation*}

The preceding formula is well-defined, in fact, thanks to 4.22,

\sum_{n \in \mathbb{N}^{*}} c_{n} g_{n}=\sum_{n \in \mathbb{N}^{*}} c_{n} \frac{f_{n}}{\lambda}+\sum_{n \in \mathbb{N}^{*}} c_{n}\left(g_{n}-\frac{f_{n}}{\lambda}\right) \tag{4.27}
\end{equation*}
$$

converges in $L_{1}^{2}$. Next, by applying $\mathcal{A}^{-1}$ to this equality we conclude

\sum_{n \in \mathbb{N}^{*}} c_{n} k_{n} g_{n}=\sum_{n \in \mathbb{N}^{*}} c_{n} k_{n} \mathcal{A}^{-1} h, \text { in } L_{1}^{2}, \tag{4.28}
\end{equation*}
$$

where we have used the fact $\sum_{n} c_{n} k_{n}$ converges. We then iterate and show (see (4.48)(4.54) for more details) that

C_{l}:=\sum_{n \in \mathbb{N}^{*}} c_{n} k_{n}^{l}<+\infty . \tag{4.30}
\end{equation*}

From this point, there are only two possibilities: either there exists $m \geq 1$ such that $C_{m} \neq 0$ and we can show that $\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is dense (see 4.55)-4.59) below concerning what is referred as "First case" and "Second case"), or $C_{m}=0$ for any $m \in \mathbb{N}^{*}$ and we get contradiction using that the complex function

- Showing that $\left\{n^{-s} g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{s}$ is done in a similar fashion as the $s=0$ case. Then, showing that $\left\{n^{-s} q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{m+s}$ is done by using that

- Finally, assuming that $c n^{m}<K_{n}<C n^{m}$, we know that $\left\{\frac{n^{-s} f_{n}}{n^{m}}\right\}_{n \in \mathbb{N}^{*}}$ is an orthonormal basis of $H_{1}^{m+s}$ and because $\left\{n^{-s} q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{m+s}$, we deduce from the assumptions on $K_{n}$ and the previous point that $\left\{\frac{-K_{n}}{n^{m}}\left(n^{-s} q_{n}\right)\right\}_{n \in \mathbb{N}^{*}}$ is also a Riesz basis of $H_{1}^{m+s}$. From Lemma 2.3 this means that $T$ is an isomorphism from $H_{1}^{m+s}$ to itself.

Proof of Lemma 4.1. For ease of notations, in the proof of this lemma we fix

Then we show that it is $\omega$-independent or dense in $L_{1}^{2}$, which, together with the quadratically close behavior, ensures that it is a Riesz basis of $L_{1}^{2}$.

The following proof to show that $g_{n}$ is either $\omega$-independent or dense in $L_{1}^{2}$ is inspired by [20], though even the transformation type that is adapted here is slightly different from the one given in [20].

Recalling that $\mathcal{A}:=-A=-\Delta$ and defining $k_{n}:=\left(n^{2}-\lambda\right)^{-1}$, from 4.46 we notice that

Then we conclude from the proceding equation that for all $m \in \mathbb{N}^{*}$ we have that $A^{-m} h \in \operatorname{span}\left\{g_{n}\right\}_{n \in \mathbb{N}^{*}}$. & \leq C+\sum_{n} \sum_{p<n} \frac{n^{2}}{p^{2}\left(p^{2}+\lambda-n^{2}\right)^{2}}, \\
& \leq C+\sum_{n \geq N} \sum_{p<n} \frac{n^{2}}{p^{2}\left(n^{2}-p^{2}-\lambda\right)^{2}}, \\
& \leq C+4 \sum_{n \geq N} \sum_{p<n} \frac{n^{2}}{p^{2}\left(n^{2}-p^{2}\right)^{2}}, \\
& \leq C+C \sum_{n \geq N} \sum_{p<n} \frac{n^{2}}{p^{2} n^{2}(n-p)^{2}}, \\
& \leq C+C \sum_{n \geq N} \sum_{p<n} \frac{1}{n^{2}}\left(\frac{1}{p}+\frac{1}{n-p}\right)^{2}, \\
& \leq C+C \sum_{n \geq N} \sum_{p<n} \frac{1}{n^{2}}\left(\frac{1}{p^{2}}+\frac{1}{(n-p)^{2}}\right), \\
& \leq C+C \sum_{n \geq N} \sum_{p<n} \frac{1}{p^{2} n^{2}}<+\infty,
\end{aligned}

where $C$ is a constant that can change between lines and where used (4.34), 4.39), the fact that $\lambda=N$, and

& =\sum_{n}\left(\sum_{p<n}+\sum_{n<p<2 n}+\sum_{p \geq 2 n}\right) \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \frac{p^{2 s}}{n^{2 s}} \\
& \leq C+\sum_{n} \sum_{p \geq 2 n} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \frac{p^{2 s}}{n^{2 s}} \\

$\star$ Let $s \in(-3 / 2,3 / 2) .\left\{n^{-s} g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is $\omega$-independent in $H_{1}^{s}$ or dense in $H_{1}^{s}$.
Similar to the case that $s=0$. Suppose that there exists $\left\{c_{n}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right)$ such that

$$
\begin{equation*}
\sum_{n \in \mathbb{N}^{*}} \frac{c_{n}}{n^{s}} g_{n}=0, \text { in } H_{1}^{s} \tag{4.64}
\end{equation*}
$$

which is well defined as

$$
\begin{equation*}
\sum_{n \in \mathbb{N}^{*}} c_{n} n^{-s} g_{n}=\sum_{n \in \mathbb{N}^{*}} c_{n} n^{-s} \frac{f_{n}}{\lambda}+\sum_{n \in \mathbb{N}^{*}} c_{n} n^{-s}\left(g_{n}-\frac{f_{n}}{\lambda}\right) \tag{4.65}
\end{equation*}
$$

converges in $H_{1}^{s}$ space thanks to the fact that $s \in(-3 / 2,3 / 2)$, and the quadratically close result in $H_{1}^{s}$ that we just proved. By the same reasoning as the case $s=1$, we get

$$
\begin{equation*}
\sum_{n \in \mathbb{N}^{*}} \frac{c_{n}}{n^{s}} k_{n} g_{n}=\sum_{n \in \mathbb{N}^{*}} \frac{c_{n}}{n^{s}} k_{n} \mathcal{A}^{-1} h, \text { in } H_{1}^{s}, \tag{4.66}
\end{equation*}
$$

where we have used the fact $\sum_{n} \frac{c_{n}}{n^{s}} k_{n}$ converges for $s>-3 / 2$.
Then, we can further consider

$$
\begin{equation*}
C_{m}:=\sum_{n \in \mathbb{N}^{*}} \frac{c_{n}}{n^{s}} k_{n}^{m}<+\infty . \tag{4.67}
\end{equation*}
$$

Exactly the same as in the case $s=0$, it suffices to consider two cases, $C_{1} \neq 0$, or $C_{m}=0$ for all $m \in \mathbb{N}^{*}$.

In the first case, we find that $\mathcal{A}^{-m} h \in \operatorname{span}\left\{n^{-s} g_{n}\right\}_{n \in \mathbb{N}^{*}}$ in $H_{1}^{s}$. Suppose that span $\left\{n^{-s} g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is not dense in $H_{1}^{s}$, then we can find $d=\sum_{n} \frac{d_{n}}{n^{s}} f_{n} \in H_{1}^{s}$ (thus $\left\{d_{n}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right)$ ) such that

\left\langle\mathcal{A}^{-m} h, d\right\rangle_{H_{1}^{s}}=0, \forall m \in \mathbb{N}^{*}, \tag{4.68}
\end{equation*}
$$

which is well-defined as $h \in H_{1}^{-1 / 2-}$ and $\mathcal{A}^{-1} h \in H_{1}^{3 / 2-} \subset H_{1}^{s}$. Recalling the exact definition of $h=\sum_{n} f_{n} \in H_{1}^{-1 / 2-}$, we get that

\sum_{n} d_{n} \frac{n^{s}}{n^{2 m}}=0, \forall m \in \mathbb{N}^{*} \tag{4.69}
\end{equation*}

which further implies that $d_{n}=0$ using the holomorphic function technique.
In the second case where $C_{m}=0$ for all $m \in \mathbb{N}^{*}$, we can also prove that $c_{n}=0$, similarly as in the case $s=0$, which is in contradiction with the choice of $\left\{c_{n}\right\}_{n \in \mathbb{N}^{*}}$.
(3) $\left\{n^{-s} q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{m+s}$.

Let $s \in(-3 / 2,3 / 2)$. We introduce $\tau: H_{1}^{s} \rightarrow H_{1}^{m+s}$ defined by,

\tau: n^{-s} f_{n} \mapsto n^{-s} a_{n} f_{n}, \tag{4.70}
\end{equation*}
$$

which is an isomorphism thanks to the fact that $c n^{-m}<\left|a_{n}\right|<C n^{-m}$. We immediately notice that

\begin{equation*}
\tau: n^{-s} g_{n}=n^{-s} \sum_{p \in \mathbb{N}^{*}} \frac{f_{p}}{\lambda_{n}-\lambda_{p}+\lambda} \mapsto n^{-s} \sum_{p \in \mathbb{N}^{*}} \frac{a_{p} f_{p}}{\lambda_{n}-\lambda_{p}+\lambda}=n^{-s} q_{n} \tag{4.71}
\end{equation*}
$$

Consequently, thanks to the fact that $\left\{n^{-s} g_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{s}$, from Lemma 2.3 we know that $\left\{n^{-s} q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{m+s}$.

## (4) Boundedness of the transformation $T$ and isomorphism

If $K_{n} \neq 0$ is chosen in such a way that $c n^{m}<\left|K_{n}\right|<n^{m}$, then from the definition of $T$ we know that

\begin{equation*}
T: \frac{n^{-s} f_{n}}{n^{m}} \mapsto \frac{-K_{n}}{n^{m}}\left(n^{-s} q_{n}\right) . \tag{4.72}
\end{equation*}
$$

Since $\left\{n^{-s} f_{n}\right\}_{n \in \mathbb{N}^{*}}$ is an orthonormal basis of $H^{s}$, we know that $\left\{\frac{n^{-s} f_{n}}{n^{m}}\right\}_{n \in \mathbb{N}^{*}}$ is an orthonormal basis of $H_{1}^{m+s}$. Moreover, because $\left\{n^{-s} q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{m+s}$, from Lemma 2.3 we know that $\left\{\frac{-K_{n}}{n^{m}}\left(n^{-s} q_{n}\right)\right\}_{n \in \mathbb{N}^{*}}$ is also a Riesz basis of $H_{1}^{m+s}$.

Therefore, the transformation $T$ is an isomorphism from $H_{1}^{m+s}$ to $H_{1}^{m+s}$. When $m=2$, we remark, however, that $T$ is not a isomorphism from $L_{1}^{2}$ to itself (indeed $2+s>0$ for any $s \in(-3 / 2,3 / 2))$.

Moreover, if we only assume that $\left|K_{n}\right| \leq C n^{m}$, then $T$ is a bounded operator from $H_{1}^{m+s}$ to $H_{1}^{m+s}$. However, in this case $T$ might not be an isomorphism.

### 4.2.2 Smoothing properties

In this section, we prove some smoothing properties which are not deduced trivially from the Riesz basis properties shown in Lemma 4.1.

LEMMA 4.3. (1) Let $r \in[0,1 / 2)$. Then, $q_{n}$ has the following smoothing property,

(2) Let $r \in[0,1 / 2)$. Similar smoothing effect also holds in the space $H^{-1+m}$,

\sum_{n \in \mathbb{N}^{*}}\left\|n\left(q_{n}-a_{n} f_{n} / \lambda\right)\right\|_{H_{1}^{-1+m+r}}^{2}<+\infty \tag{4.74}
\end{equation*}

(3) Let $m=0$ and $r \in[0,1 / 2)$. Then,

\sum_{n \in \mathbb{N}^{*}}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right) \in H_{1}^{r} \tag{4.75}
\end{equation*}
$$

Again, all the choices of $s$ and $r$ in the above are sharp.
Proof. (1) Smoothing effect in $H_{1}^{m+r}$, for $r \in[0,1 / 2)$

$$
\begin{aligned}
\sum_{n}\left\|q_{n}-a_{n} f_{n} / \lambda\right\|_{H_{1}^{m+r}}^{2} & =\sum_{n}\left\|\sum_{p \neq n} \frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}}\right\|_{H_{1}^{m+r}}^{2} \\
& \leq C \sum_{n} \sum_{p \neq n} \frac{p^{2 r}}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \\
& =C \sum_{p} p^{2 r} \sum_{n \neq p} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \\
& \leq C+C \sum_{p \geq N} p^{2 r} \sum_{n \neq p} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}}
\end{aligned}
$$

where C is a constant that can change between lines. Moreover,

$$
\sum_{p \geq N} p^{2 r} \sum_{n<p} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \leq \sum_{p \geq N} p^{2 r-2} \sum_{n<p} \frac{1}{(p-n)^{2}}<+\infty
$$

and, using 4.39),

\begin{aligned}
\sum_{p \geq N} p^{2 r} \sum_{p<n} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}} & \leq \sum_{p \geq N} p^{2 r} \sum_{p<n} \frac{4}{\left(n^{2}-p^{2}\right)^{2}} \\
& \leq \sum_{p \geq N} p^{2 r-2} \sum_{p<n} \frac{4}{(p-n)^{2}}<+\infty
\end{aligned}
$$

From the above proof we find that the condition $r<1 / 2$ is sharp.

## (2) Smoothing effect in $H_{1}^{-1+m+r}$ for $r \in[0,1 / 2)$

$$
\begin{aligned}
\sum_{n}\left\|n\left(q_{n}-a_{n} f_{n} / \lambda\right)\right\|_{H_{1}^{-1+m+r}}^{2} & =\sum_{n}\left\|\sum_{p \neq n} \frac{n a_{p} f_{p}}{p^{2}+\lambda-n^{2}}\right\|_{H_{1}^{-1+m+r}}^{2} \\
& \leq C \sum_{n} \sum_{p \neq n} \frac{p^{2 r-2} n^{2}}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \\
& =C \sum_{p} p^{2 r-2} \sum_{n \neq p} \frac{n^{2}}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \\
& \leq C+C \sum_{p \geq N} p^{2 r-2} \sum_{n \neq p} \frac{n^{2}}{\left(p^{2}+\lambda-n^{2}\right)^{2}}
\end{aligned}
$$

Moreover,

$$
\sum_{p \geq N} p^{2 r-2} \sum_{n<p} \frac{n^{2}}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \leq \sum_{p \geq N} p^{2 r-2} \sum_{n<p} \frac{1}{(p-n)^{2}}<+\infty
$$

and, still using 4.39),

$$
\sum_{p \geq N} p^{2 r-2} \sum_{p<n} \frac{n^{2}}{\left(p^{2}+\lambda-n^{2}\right)^{2}} \leq \sum_{p \geq N} p^{2 r-2} \sum_{p<n} \frac{16}{(p-n)^{2}}<+\infty
$$

(3) The quantity $\sum_{n \in \mathbb{N}^{*}}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right)$ belongs to $H_{1}^{r}$ for $r \in[0,1 / 2)$.

At first we point out that since $\left\{n q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{-1}$, and $\left\{n f_{n}\right\}_{n \in \mathbb{N}^{*}}$ is an orthonormal basis of $H_{1}^{-1}$, the candidate $\sum_{n \in \mathbb{N}^{*}}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right)$ belongs to $H_{1}^{-1}$. We need to show that it actually belongs to more regular spaces $H_{1}^{r}$ for $r \in[0,1 / 2)$. Moreover, both $\sum_{n \in \mathbb{N}^{*}} q_{n}$ and $\sum_{n \in \mathbb{N}^{*}} \frac{a_{n} f_{n}}{\lambda}$ belong to $H^{-1 / 2-}$ but not to $H^{-1 / 2}$.

In the following, we mainly focus on the case $r=0$. Since $m=0$ we notice that the lemma is equivalent to

\left\|\sum_{n} \sum_{p \neq n} \frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}}\right\|_{L^{2}}^{2}<+\infty \tag{4.76}
\end{equation*}

Note that this cannot be directly deduced from the quadratically close inequality that we proved in Lemma 4.1 (3) (case $m=s=0$ ),

\end{equation*}

Indeed, we need more delicate estimates. We know from the fact that $\sum_{n \in \mathbb{N}^{*}}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right)$ belongs to $H_{1}^{-1}$ that

\sum_{n \in \mathbb{N}^{*}}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right)=\sum_{n} \sum_{p \neq n} \frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}}=\sum_{p} \sum_{n \neq p} \frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}} \text { in } H_{1}^{-1} \tag{4.78}
\end{equation*}
$$

the last equality can be obtained from the "distribution sense": we observe that the inner product of both quantities with $f_{k}$ are equivalent, which implies that those two quantities are equivalent. Or, alternatively, since

& \sum_{n} \sum_{p \neq n}\left\|\frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}}\right\|_{H_{1}^{-1}} \\
\leq & C \sum_{n} \sum_{p \neq n} \frac{1}{p\left|p^{2}-n^{2}\right|} \\
\leq & C \sum_{n}\left(\sum_{p<n}+\sum_{n<p<2 n}+\sum_{p>2 n}\right) \frac{1}{p\left|p^{2}-n^{2}\right|} \\
\leq & C \sum_{n}\left(\sum_{p<n} \frac{1}{n^{2}}\left(\frac{1}{p}+\frac{1}{n-p}\right)+\sum_{n<p<2 n} \frac{1}{n^{2}} \frac{1}{p-n}+\sum_{p>2 n} \frac{1}{p^{3}}\right) \\
\leq & C \sum_{n} \frac{1+\log n}{n^{2}}<+\infty,
\end{aligned}
$$

then thanks to Fubini we have that

\sum_{n} \sum_{p \neq n} \frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}}=\sum_{p} \sum_{n \neq p} \frac{a_{p} f_{p}}{p^{2}+\lambda-n^{2}} \quad \text { in } H_{1}^{-1}
$$

Hence, it suffices to show the last quantity in equation 4.78 belongs to $L_{1}^{2}$, which is equivalent to

\begin{equation*}
\left\|\sum_{p} a_{p} f_{p} \sum_{n \neq p} \frac{1}{p^{2}+\lambda-n^{2}}\right\|_{L_{1}^{2}}^{2}=\sum_{p} a_{p}^{2}\left(\sum_{n \neq p} \frac{1}{p^{2}+\lambda-n^{2}}\right)^{2}<+\infty \tag{4.79}
\end{equation*}
$$

which, to be combined with the growth condition $a_{n} \sim 1$, is equivalent to

$$
\begin{equation*}
\sum_{p}\left(\sum_{n \neq p} \frac{1}{p^{2}+\lambda-n^{2}}\right)^{2}<+\infty \tag{4.80}
\end{equation*}
$$

It further suffices to prove that

$$
\begin{equation*}
\sum_{p}\left(\sum_{n \neq p}\left|\frac{1}{p^{2}+\lambda-n^{2}}\right|\right)^{2}<+\infty \tag{4.81}
\end{equation*}
$$

which further reduces to showing that

$$
\begin{equation*}
\sum_{p \geq N}\left(\left(\sum_{n<p}+\sum_{p+1<n<2 p}+\sum_{n \geq 2 p}\right)\left|\frac{1}{p^{2}+\lambda-n^{2}}\right|\right)^{2}=: \sum_{p \geq N}\left(S_{p}^{1}+S_{p}^{2}+S_{p}^{3}\right)^{2}<+\infty \tag{4.82}
\end{equation*}
$$

Next we estimate the $S_{p}^{i}$ one by one.
i) Estimation of $S_{p}^{1}$ :

$$
\begin{aligned}
S_{p}^{1} & =\sum_{n \leq p-1} \frac{1}{p^{2}+\lambda-n^{2}}, \\
& \leq \sum_{n \leq p-1} \frac{1}{p^{2}-n^{2}}, \\
& \leq \frac{1}{p} \sum_{n \leq p-1} \frac{1}{p-n}, \\
& \leq C \frac{1+\log p}{p},
\end{aligned}
$$

where $C$ is a constant independent of $p$.
ii) Estimation of $S_{p}^{2}$ : by the choice of $p \geq N$ and the fact that $\lambda=N$, we know that

\begin{aligned}
S_{p}^{2} & =\sum_{p<n<2 p} \frac{1}{n^{2}-p^{2}-\lambda}, \\
& \leq \sum_{p<n<2 p} \frac{2}{n^{2}-p^{2}}, \\
& \leq \frac{1}{p} \sum_{p<n<2 p} \frac{1}{n-p}, \\
& \leq C \frac{1+\log p}{p} .
\end{aligned}
$$

iii) Estimation of $S_{p}^{3}$ : the last part can be estimated by

\begin{aligned}
S_{p}^{3} & =\sum_{2 p \leq n} \frac{1}{n^{2}-p^{2}-\lambda} \\
& \leq \sum_{2 p \leq n} \frac{2}{n^{2}-p^{2}}, \\
& \leq \sum_{2 p \leq n} \frac{4}{n^{2}}, \\
& \leq \frac{3}{p} .
\end{aligned}
$$

Consequently,

\sum_{p \geq N}\left(S_{p}^{1}+S_{p}^{2}+S_{p}^{3}\right)^{2} \leq \sum_{p \geq N} C\left(\frac{1+\log p}{p}\right)^{2}<+\infty \tag{4.83}
\end{equation*}
$$

Finally, for the case $r \in[0,1 / 2)$, by slightly modifying 4.79] it suffices to show that

\sum_{p \geq N} p^{2 r}\left(S_{p}^{1}+S_{p}^{2}+S_{p}^{3}\right)^{2} \leq C \sum_{p \geq N} p^{2 r}\left(\frac{1+\log p}{p}\right)^{2}<+\infty \tag{4.84}
\end{equation*}
$$

where $r<1 / 2$ is sharp. This ends the proof of Lemma 4.3.

### 4.3 On the choice of the backstepping candidate

In the following, in order to simplify the calculation, we only consider the special case $m=0$, thus

## the other cases can be treated exactly similarly.

According to Section 4.1 we know that every sequence $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ determines a unique transformation $T$, and at least formally, it satisfies

\end{equation*}
$$

Thanks to Section 4.2 we know that when $\left\{K_{n}\right\}_{\mathbb{N}^{*}}$ satisfies

\left|K_{n}\right| \leq C, \forall n \in \mathbb{N}^{*}, \tag{4.86}
\end{equation*}
$$

this unique transformation $T$ is bounded on $H^{s}$ with $s \in(-3 / 2,3 / 2)$.
Moreover, if $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ further satisfies

$$
\begin{equation*}
c \leq\left|K_{n}\right| \leq C, \forall n \in \mathbb{N}^{*}, \tag{4.87}
\end{equation*}
$$

then $T$ is an isomorphism on $H^{s}$ with $s \in(-3 / 2,3 / 2)$.
However, until now we have not yet treated the second condition:

$$
\begin{equation*}
T \phi=\phi \tag{4.88}
\end{equation*}
$$

This condition is called in the literature the " $T B=B$ condition" (here the function $\phi$ represent what is usually formally denoted $B$ ), which is now becoming a standard requirement for Fredholm type backstepping transformations, [16, 17, 20, 21, 27, 51. The aim of this section is to determine a precise candidate of $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ such that
(i) The "TB $=B$ condition" (4.88) holds, in a suitable space to be found.
(ii) The boundedness condition (4.86) holds.
(iii) The operator equality 4.85 holds, in a suitable space to be found.

The proofs of (i) and (ii) are provided by Sections 4.3.1 4.3.2, and Section 4.3.3 is devoted to the proof of (iii).

We also remark here that, in this section, we only prove the condition (4.86) instead of the stronger (4.87), as it is sufficient to obtain conditions (4.88) and 4.85). The proof of 4.87), which implies that $T$ is an isomorphism and not only a bounded operator, is left to Sections 4.44 .5

### 4.3.1 The $T B=B$ condition in weaker spaces

For any given $\phi$ satisfying

we want to find $K$ such that

\end{equation*}

\begin{equation*}
T \phi=\phi, \text { in a suitable sense. } \tag{4.91}
\end{equation*}
$$

Since the solutions of the closed-loop system are expected to live in $C^{0}\left([0, \tau] ; L_{1}^{2}\right)$, it is natural to start by considering that $T \phi=\phi$ holds in $L_{1}^{2}$.

For any given $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$ satisfying (4.89), Lemma 4.1 (2) holds. Meanwhile the strong $T \phi=\phi$ condition for (4.91) reads

\sum_{p} a_{p} f_{p}=\phi=T \phi=\sum_{n} a_{n} h_{n}=\sum_{n}-a_{n} K_{n} q_{n} \tag{4.92}
\end{equation*}

which is equivalent to

\end{equation*}
$$

However, we can not use Lemma 4.1 (3) with $m=s=0$ directly, because $\phi \in H_{1}^{-\frac{1}{2}-}$ instead of $L_{1}^{2}$. Otherwise, formally the preceding equation admits a solution.

We now prove that the condition 4.88 can hold in $H_{1}^{-1 / 2-}$. We notice that, formally,

As $\left\{n q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{-1}$, and as $\phi \in H_{1}^{-1}$, 4.93) can be solved in $H_{1}^{-1}$. Indeed, since the span of $\left\{n q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is dense in $H_{1}^{-1}$, and since $\phi$ also belongs to $H_{1}^{-1}$, it has the unique decomposition:

$$
\begin{equation*}
\phi=\sum_{n \in \mathbb{N}^{*}} \tilde{a}_{n}\left(n q_{n}\right), \quad\left(\tilde{a}_{n}\right) \in \ell^{2}\left(\mathbb{N}^{*}\right) \tag{4.95}
\end{equation*}
$$

We then define

$$
\begin{equation*}
K_{n}:=-n \frac{\tilde{a}_{n}}{a_{n}}, \quad n \in \mathbb{N}^{*} \tag{4.96}
\end{equation*}
$$

Note that $\left(K_{n}\right)$ is thus uniquely determined, solves (4.93), and

$$
\begin{equation*}
\left(\frac{a_{n} K_{n}}{n}\right)_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right) \tag{4.97}
\end{equation*}
$$

Now, as $\phi \in H_{1}^{-1 / 2-}$, by Lemma 4.1 (3), and uniqueness of $\tilde{a}_{n}$, we have

$$
\begin{equation*}
\phi=\sum_{n \in \mathbb{N}^{*}} \tilde{a}_{n} n^{s+1}\left(n^{-s} q_{n}\right), \quad s \in(-3 / 2,-1 / 2) \tag{4.98}
\end{equation*}
$$

with

$$
\left(\tilde{a}_{n} n^{s+1}\right)_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right), \quad s \in(-3 / 2,-1 / 2)
$$

Together with (4.96), this implies

$$
\begin{equation*}
\left(a_{n} K_{n} n^{s}\right)_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right), \quad s \in(-3 / 2,-1 / 2) \tag{4.99}
\end{equation*}
$$

which generalizes (4.97). We can now write, analogously to 4.94):

$$
\begin{equation*}
T \phi=\sum_{n} a_{n} K_{n} q_{n}=\sum_{n} a_{n} K_{n} n^{s}\left(n^{-s} q_{n}\right), \quad s \in(-3 / 2,-1 / 2) \tag{4.100}
\end{equation*}
$$

Together with 4.98), this solves (4.93), i.e. (4.88), in $H_{1}^{s}$ for $s \in(-3 / 2,-1 / 2)$
Note however that, although condition (4.99) holds for any bounded sequence $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$, conversely (4.99) is not enough to conclude that $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ is bounded. Indeed, let $b_{n}:=\log n$, we can easily observe that

$$
\begin{equation*}
\left\{\frac{b_{n}}{n^{1 / 2+\varepsilon}}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right), \forall \varepsilon>0 \tag{4.101}
\end{equation*}
$$

REMARK 4.4. More generally, even if a sequence $\left\{b_{n}\right\}_{n \in \mathbb{N}^{*}}$ satisfies

$$
\begin{equation*}
\left\{\frac{b_{n}}{n^{\varepsilon}}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right), \forall \varepsilon>0, \tag{4.102}
\end{equation*}
$$

we are not able to conclude that the sequence $\left\{b_{n}\right\}_{n \in \mathbb{N}^{*}}$ is bounded. For example, by defining

$$
\begin{gather*}
M(n)=\left[e^{n}\right]+1, \forall n \in \mathbb{N}^{*},  \tag{4.103}\\
b_{m}:=n, \text { if } m=M(n),  \tag{4.104}\\
b_{m}:=0, \text { if } m \notin\left\{M(n): n \in \mathbb{N}^{*}\right\}, \tag{4.105}
\end{gather*}
$$

we know that for any $\varepsilon>0$,

$$
\begin{equation*}
\sum_{m \in \mathbb{N}^{*}}\left(\frac{b_{m}}{m^{\varepsilon}}\right)^{2}=\sum_{m \in\left\{M(n): n \in \mathbb{N}^{*}\right\}}\left(\frac{b_{m}}{m^{\varepsilon}}\right)^{2} \leq \sum_{n \in \mathbb{N}^{*}}\left(\frac{n}{e^{\varepsilon n}}\right)^{2}<+\infty . \tag{4.106}
\end{equation*}
$$

Clearly, such $\left\{b_{n}\right\}_{n \in \mathbb{N}^{*}}$ is not bounded.
In the next section, we will prove that the sequence $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ that we have found in this section is indeed bounded from above.

### 4.3.2 Regularity of $K$ and $T$

In order to prove the condition (4.86), namely the boundedness of the candidate $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$, we come back to the $T \phi=\phi$ equation

$$
\begin{equation*}
\sum_{n}-a_{n} K_{n} q_{n}=\sum_{n} a_{n} f_{n} . \tag{4.107}
\end{equation*}
$$

Thanks to the preceding Section, we have found a unique $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ satisfying 4.99) such that equation (4.107) holds in $H_{1}^{-1 / 2-}$ (in particular, in $H_{1}^{-1}$ ).

Motivated by Lemma 4.3 part (3), we define $c_{n}$ as

$$
\begin{equation*}
c_{n}=:-a_{n} K_{n}-\lambda . \tag{4.108}
\end{equation*}
$$

As $\left\{n q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{-1}$, we know that

$$
\begin{equation*}
\sum_{n} \lambda q_{n}=\lambda \sum_{n} \frac{1}{n}\left(n q_{n}\right) \in H_{1}^{-1} . \tag{4.109}
\end{equation*}
$$

Then, the $T \phi=\phi$ condition in $H_{1}^{-1}$ is equivalent to

$$
\begin{equation*}
\sum_{n}\left(\lambda+c_{n}\right) q_{n}=\sum_{n} a_{n} f_{n} \text { in } H_{1}^{-1}, \tag{4.110}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{n} c_{n} q_{n}=\sum_{n}\left(a_{n} f_{n}-\lambda q_{n}\right) \text { in } H_{1}^{-1} . \tag{4.111}
\end{equation*}
$$

Thanks to Lemma 4.3 part (3) with $r=0$, we actually have

$$
\begin{equation*}
\sum_{n} c_{n} q_{n}=\sum_{n}\left(a_{n} f_{n}-\lambda q_{n}\right) \in L_{1}^{2} . \tag{4.112}
\end{equation*}
$$

Considering the fact that $\left\{q_{n}\right\}$ is a Riesz basis of $L_{1}^{2}$ (Lemma 4.1 (3) with $m=s=0$ ), by uniqueness we get

$$
\begin{equation*}
\left\{c_{n}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right) \tag{4.113}
\end{equation*}
$$

Now, we have by definition of $c_{n}$ :

$$
\begin{equation*}
K_{n}=-\frac{\lambda+c_{n}}{a_{n}} . \tag{4.114}
\end{equation*}
$$

By (4.89) and 4.113), $\left(K_{n}\right)$ is clearly bounded.
Now, from Lemma 4.1 (4) in the case $m=0$, we deduce that $T$ is bounded on $H_{1}^{s}$ for $s \in(-3 / 2,3 / 2)$.

REMARK 4.5. We notice that the equation 4.107) is equivalent to

$$
\begin{equation*}
\sum_{n \in \mathbb{N}^{*}}\left(a_{n} K_{n}\right) \frac{1}{p^{2}+\lambda-n^{2}}=-1, \forall p \in \mathbb{N}^{*} \tag{4.115}
\end{equation*}
$$

Hence the value of $\left\{-a_{n} K_{n}\right\}_{n \in \mathbb{N}^{*}}=\left\{\lambda+c_{n}\right\}_{n \in \mathbb{N}^{*}}$ is independent of the choice of $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$ satisfying

$$
c \leq\left|a_{n}\right| \leq C .
$$

### 4.3.3 On the operator equality

In the previous subsection we proved the following lemma
LEMMA 4.6. By the choice of $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$ and $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ from Section 4.3.2, we have

$$
\begin{equation*}
T \phi=\phi \text { in } H_{1}^{s}, \quad s \in(-3 / 2,1 / 2), \tag{4.116}
\end{equation*}
$$

in particular it holds in $H_{1}^{-1}$. However, it does not hold in $L_{1}^{2}$.
Now, we show the operator equality and the spaces in which this equality holds.
LEMMA 4.7. Let $r \in(-1 / 2,1 / 2)$. By the choice of $\left\{a_{n}\right\}_{n \in \mathbb{N}^{*}}$ and $\left\{K_{n}\right\}_{n \in \mathbb{N}^{*}}$ from Section 4.3.2. for any $\varphi \in H_{1}^{r+1}$ we have

$$
\begin{equation*}
(T A+T \phi K) \varphi=(A T-\lambda T) \varphi \text { in } H_{1}^{r-1} . \tag{4.117}
\end{equation*}
$$

In particular we can consider $r=0$ then the equality holds in $H_{1}^{-1}$. Moreover, the range $r \in(-1 / 2,1 / 2)$ is sharp.

Proof. Recalling that, thanks to Section 4.3.2, $T: H_{1}^{s} \rightarrow H_{1}^{s}$ is a bounded operator for $s \in$ $(-3 / 2,3 / 2)$. Though so far we do not know whether $T$ is an isomorphism -this will be proved in the next section- this is now sufficient to study the operator equality.

Let us first check that each term of the operator equality (4.117) is well defined.
i) $T A \varphi$ : we know that $A \varphi \in H_{1}^{r-1}$. Notice that $r-1 \in(-3 / 2,-1 / 2)$, which, combined with Lemma 4.1 (4) in the case $m=0$ and $s:=r-1$, implies that $T A \varphi \in H_{1}^{r-1}$. Moreover, as $A: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ and $T: H_{1}^{r-1} \rightarrow H_{1}^{r-1}$ are bounded, the linear operator $T A: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ is bounded.
Concerning the sharpness of $r \in(-1 / 2,1 / 2)$, as we can see above, if $r$ is chosen such that $r \leq-1 / 2$ then the operator $T$ is no longer bounded on $H_{1}^{r-1}$, thus the linear operator $T A: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ is not bounded.
ii) $T \phi K \varphi$ : given that $\varphi \in H_{1}^{r+1}$ with $r>-1 / 2$, and that $K: H_{1}^{r+1} \rightarrow \mathbb{R}$ is a bounded operator, we know that $|K \varphi|<+\infty$ is well-defined. Then, thanks to $\operatorname{Lemma} 4.6, T \phi K \varphi \in$ $H_{1}^{-1 / 2-} \subset H_{1}^{r-1}$. Moreover, as and $T \phi: \mathbb{R} \rightarrow H_{1}^{r-1}$ and $K$ are bounded, the linear operator $T \phi K: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ is bounded.
iii) $T \varphi$ : thanks to Lemma 4.1 (4) in the case $m=0$ and $s=r+1 \in(1 / 2,3 / 2)$, and the fact that $\varphi \in H_{1}^{r+1}$, we know that $T \varphi \in H_{1}^{r+1} \subset H_{1}^{r-1}$. Clearly, $T: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ is bounded (in fact $T$ is even bounded from $H_{1}^{r+1}$ in itself).
iv) $A T \varphi$ : because $T \varphi \in H_{1}^{r+1}$, we have that $A T \varphi \in H_{1}^{r-1}$. As $T: H_{1}^{r+1} \rightarrow H_{1}^{r+1}$ and $A: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ are bounded, the linear operator $A T: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ is bounded.
Concerning the sharpness of $r \in(-1 / 2,1 / 2)$, as we can see above, if $r$ is chosen such that $r \geq 1 / 2$ then the operator $T$ is no longer bounded on $H_{1}^{r+1}$, thus the linear operator $A T: H_{1}^{r+1} \rightarrow H_{1}^{r-1}$ is not bounded.

From the above we have:

$$
T A, T \phi K, A T, \lambda T: H_{1}^{r+1} \rightarrow H_{1}^{r-1}
$$

are bounded linear operators. Now, using the definition of $q_{n}$ given in Section 4.1, we have in the $H^{r-1}$ space:

$$
\begin{aligned}
(T A+T \phi K-A T+\lambda T) f_{n} & =\left(-A-n^{2}+\lambda\right) T f_{n}+\phi K_{n} \\
& =K_{n}\left(\phi-\left(-A-n^{2}+\lambda\right) q_{n}\right), \\
& =0 \\
i . e . T A f_{n}+T \phi K f_{n} & =A T f_{n}-\lambda T f_{n} .
\end{aligned}
$$

Since the finite linear combinations of $\left\{f_{n}\right\}_{n \in \mathbb{N}^{*}}$ are dense in $H_{1}^{r+1}$, by boundedness of $T A, A T, T \phi K$ and $T$, this yields 4.117.

### 4.4 Invertibility of the transformation $T$ on the space $H_{1}^{-1}$.

So far we know, thanks to Lemma 4.1, that $T$ is a bounded operator on $H_{1}^{s}$. But we do not know yet that it is an isomorphism. To prove this, we will first prove in this section that $T$ is invertible on $H_{1}^{-1}$. Then, we will show in Section 4.5 that this implies that it is invertible also on $H_{1}^{s}$ for $s \in(-3 / 2,3 / 2)$.

The key lemma is the following:
LEMMA 4.8. Let $r \in[0,1 / 2)$. The operator

$$
\tilde{T}:=T-I d: L_{1}^{2} \rightarrow H_{1}^{r}
$$

$$
\left(\text { resp. } \tilde{T}:=T-I d: H_{1}^{-1} \rightarrow H_{1}^{-1+r}\right),
$$

is a continuous operator. Hence $\tilde{T}: L_{1}^{2} \rightarrow L_{1}^{2}$ (resp. $T: H_{1}^{-1} \rightarrow H_{1}^{-1}$ ), and $T$ is a Fredholm operator on $L_{1}^{2}$ (resp. on $H_{1}^{-1}$ ).

To prove this Lemma, we need the following result:
LEMMA 4.9. Let $r \in[0,1 / 2)$. There exists a constant $C>0$ such that

$$
\begin{equation*}
\left\|\sum_{n} b_{n}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right)\right\|_{H_{1}^{r}}^{2} \leq C \sum_{n} b_{n}^{2}, \quad \forall\left(b_{n}\right) \in \ell^{2}(\mathbb{N}) \tag{4.118}
\end{equation*}
$$

Proof of Lemma 4.9. In fact, we have from the definition of $\left\{q_{n}\right\}_{n \in \mathbb{N}^{*}}$, the Riesz basis property of $\left\{f_{p}\right\}_{p \in \mathbb{N}^{*}}$ and the growth condition 4.89) for $\left\{a_{p}\right\}_{p \in \mathbb{N}^{*}}$ :

$$
\begin{aligned}
\left\|\sum_{n} b_{n}\left(q_{n}-\frac{a_{n} f_{n}}{\lambda}\right)\right\|_{H_{1}^{r}}^{2} & =\left\|\sum_{p} a_{p} f_{p} \sum_{n \neq p} \frac{b_{n}}{p^{2}+\lambda-n^{2}}\right\|_{H^{r}}^{2} \\
& \leq C \sum_{p} p^{2 r}\left(\sum_{n \neq p} \frac{b_{n}}{p^{2}+\lambda-n^{2}}\right)^{2} \\
& \leq C \sum_{p} p^{2 r}\left(\sum_{n \neq p} b_{n}^{2}\right)\left(\sum_{n \neq p} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}}\right) \\
& \leq C\left(\sum_{n} b_{n}^{2}\right) \sum_{p} p^{2 r}\left(\sum_{n \neq p} \frac{1}{\left(p^{2}+\lambda-n^{2}\right)^{2}}\right) \\
& \leq C \sum_{n} b_{n}^{2}
\end{aligned}
$$

where in the last step we have used Lemma 4.3 (1) (with $m=0$ and $a_{n}=1$ ).
Proof of Lemma 4.8. i) We first consider the $L_{1}^{2}$ case. We notice that

$$
\tilde{T} f_{n}=-K_{n} q_{n}-f_{n}=\frac{\lambda+c_{n}}{a_{n}} q_{n}-f_{n}=\left(\frac{\lambda}{a_{n}} q_{n}-f_{n}\right)+\frac{c_{n}}{a_{n}} q_{n} .
$$

Therefore, for any $f=\sum_{n} b_{n} f_{n} \in L_{1}^{2}$ satisfying $\left\{b_{n}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right)$, we have that

$$
\left\|\tilde{T} \sum_{n} b_{n} f_{n}\right\|_{H_{1}^{r}}^{2}=\left\|\sum_{n} \frac{b_{n}}{a_{n}}\left(\lambda q_{n}-a_{n} f_{n}\right)+\frac{b_{n}}{a_{n}} c_{n} q_{n}\right\|_{H_{1}^{r}}^{2} .
$$

On the one hand, according to Lemma 4.1 (5) the case that $m=0$, we know that

$$
\left\|\sum_{n} \frac{b_{n}}{a_{n}}\left(\lambda q_{n}-a_{n} f_{n}\right)\right\|_{H_{1}^{r}}^{2} \leq C\left(\sum_{n} b_{n}^{2}\right)\left(\sum_{n}\left\|\lambda q_{n}-f_{n}\right\|_{H_{1}^{r}}^{2}\right) \leq C \sum_{n} b_{n}^{2}=C\|f\|_{L_{1}^{2}}^{2}
$$

On the other hand, according to Lemma 4.1 (3) with $m=0$ and $s=r$, we know that $\left\{n^{-r} q_{n}\right\}$ is a Riesz basis of $H_{1}^{r}$. Thus

$$
\begin{aligned}
\left\|\sum_{n} \frac{b_{n}}{a_{n}} c_{n} q_{n}\right\|_{H_{1}^{r}}^{2} & =\left\|\sum_{n}\left(b_{n} a_{n}^{-1} c_{n} n^{r}\right)\left(n^{-r} q_{n}\right)\right\|_{H_{1}^{r}}^{2} \\
& \leq C \sum_{n}\left(b_{n} a_{n}^{-1} c_{n} n^{r}\right)^{2} \\
& \leq C \sum_{n}\left(b_{n}\right)^{2}\left(c_{n} n^{r}\right)^{2} \\
& \leq C \sum_{n} b_{n}^{2} \\
& =C\|f\|_{L_{1}^{2}}^{2},
\end{aligned}
$$

where we have used the fact that $\left\{c_{n} n^{r}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right) \subset l^{\infty}\left(\mathbb{N}^{*}\right)$ which is proved in Section 4.3.2, equation 4.113). Hence, the operator $\tilde{T}: L_{1}^{2} \rightarrow H_{1}^{r}$ is continuous. By compactness of the injection $H_{1}^{r} \rightarrow L_{1}^{2}, \tilde{T}: L_{1}^{2} \rightarrow L_{1}^{2}$ is compact.
ii) Next we prove the $H_{1}^{-1}$ case. For any

$$
f=\sum_{n} b_{n} f_{n}=\sum_{n}\left(b_{n} / n\right)\left(n f_{n}\right) \in H_{1}^{-1},
$$

we know that $\left\{b_{n} / n\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right)$, thus

$$
\left\|\tilde{T} \sum_{n} b_{n} f_{n}\right\|_{H_{1}^{-1+r}}^{2}=\left\|\sum_{n} \frac{b_{n}}{a_{n}}\left(\lambda q_{n}-a_{n} f_{n}\right)+\frac{b_{n}}{a_{n}} c_{n} q_{n}\right\|_{H_{1}^{-1+r}}^{2} .
$$

On the one hand, according to Lemma 4.3 (2) the case that $m=0$, we know that

$$
\begin{aligned}
& \| \sum_{n} \frac{b_{n}}{n a_{n}}\left(n\left(\lambda q_{n}-a_{n} f_{n}\right) \|_{H_{1}^{-1+r}}^{2}\right. \\
& \leq C\left(\sum_{n}\left(\frac{b_{n}}{n}\right)^{2}\right)\left(\sum_{n}\left\|n\left(\lambda q_{n}-a_{n} f_{n}\right)\right\|_{H_{1}^{-1+r}}^{2}\right) \\
& \leq C \sum_{n}\left(\frac{b_{n}}{n}\right)^{2} \\
& \leq C\|f\|_{H_{1}^{-1}}^{2} .
\end{aligned}
$$

On the other hand, according to Lemma 4.1 (3) the case that $m=0$ and $s=-1+r$, we know that $\left\{n^{1-r} q_{n}\right\}$ is a Riesz basis of $H_{1}^{-1+r}$. Thus

$$
\begin{aligned}
\left\|\sum_{n} b_{n} a_{n}^{-1} c_{n} q_{n}\right\|_{H_{1}^{-1+r}}^{2} & =\left\|\sum_{n}\left(b_{n} a_{n}^{-1} c_{n} n^{r-1}\right)\left(n^{1-r} q_{n}\right)\right\|_{H_{1}^{-1+r}}^{2} \\
& \leq C \sum_{n}\left(\frac{b_{n}}{n} a_{n}^{-1} c_{n} n^{r}\right)^{2}
\end{aligned}
$$

$$
\begin{aligned}
& \leq C \sum_{n}\left(\frac{b_{n}}{n}\right)^{2} \\
& \leq C\|f\|_{H_{1}^{-1}}^{2},
\end{aligned}
$$

where, again, we have used the fact that $\left\{c_{n} n^{r}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right) \subset l^{\infty}\left(\mathbb{N}^{*}\right)$.
Therefore, for $r \in(0,1 / 2), T: H_{1}^{-1} \rightarrow H_{1}^{-1+r}$ is continuous. Since the inclusion $H_{1}^{-1+r} \rightarrow$ $H_{1}^{-1}$ is compact, this concludes the proof of Lemma 4.8

We now prove the following invertibility result on $H_{1}^{-1}$.
LEMMA 4.10. $T: H_{1}^{-1} \rightarrow H_{1}^{-1}$ is an isomorphism.
Proof of Lemma 4.10. Since $T: H_{1}^{-1} \rightarrow H_{1}^{-1}$ is a Fredholm operator of index 0 (i.e. can be written as the sum of the identity and a compact operator), thanks to Lemma 4.8, it suffices to show that $\operatorname{ker} T^{*}=\{0\}$ to conclude. By definition of Fredholm operators, we know that both ker $T$ and coKer $T$ have finite dimension. Moreover, since the adjoint of a Fredholm operator is still a Fredholm operator (by Schauder's theorem, the adjoint of a compact operator is still compact), $\operatorname{ker} T^{*}$ is of finite dimension. More precisely, we have

$$
\operatorname{dim} \operatorname{ker} T=\operatorname{dim} \operatorname{coKer} T=\operatorname{dim} \operatorname{ker} T^{*}=\operatorname{dim} \operatorname{coKer} T^{*}<+\infty .
$$

In the following we mimic the method of [16] to show that for the operator $T: H_{1}^{-1} \rightarrow H_{1}^{-1}$ we have that $\operatorname{ker} T^{*}=\{0\}$. The proof is divided in three steps

1) There exists $\rho \in \mathbb{C}$ such that

$$
\begin{gathered}
A+\phi_{1} K+\lambda I d+\rho I d: H_{1}^{1} \rightarrow H_{1}^{-1} \text { is invertible, } \\
A+\rho I d: H_{1}^{1} \rightarrow H_{1}^{-1} \text { is invertible. }
\end{gathered}
$$

2) For such a complex number $\rho, \operatorname{ker} T^{*}$ is stable under $(A+\rho I d)^{-1}$. As it is finitedimensional, $(A+\rho I d)^{-1}$ has an eigenvector in $\operatorname{ker} T^{*}$, i.e. there exists $h \in \operatorname{ker} T^{*}$ and $\mu \neq 0$ such that $(A+\rho I d)^{-1} h=\mu h$. Hence $h=f_{k}$ for some $k \in \mathbb{N}^{*}$.
3) By adapting the $T \phi_{1}=\phi_{1}$ condition, we show that $h=f_{k}$ is not in $\operatorname{ker} T^{*}$.
4) As the spectrum of $A+\rho I d$ is explicit and discrete, in the following we mainly focus on the study of the spectrum of $A+\phi K+\lambda I d+\rho I d$. By denoting $z:=\lambda+\rho$, we try to investigate the invertibility of $I d+A^{-1} \phi K+z A^{-1}$ in the $H_{1}^{1}$ space, with some $z \in \mathbb{C}$, which further gives some $\rho=z-\lambda$ such that the investigated two operators are invertible. Let us remark here that as working with $H_{1}^{k}$ spaces, $A$ is automatically invertible in this space, while when dealing with $H_{2}^{k}$ spaces, $A$ has a trivial kernel 1 , in this case we will replace $A$ by $\tilde{A}:=A+\delta$ with $\delta \neq 0$ sufficiently close to 0 . For such a purpose we consider two cases.
i) If $K\left(A^{-1} \phi\right) \neq-1$, then we know that the bounded operator $I d+A^{-1} \phi K$ is invertible. In fact, for any $f \in H_{1}^{1}$, we can check that

$$
\begin{equation*}
\varphi:=f-\frac{A^{-1} \phi(K f)}{1+K\left(A^{-1} \phi\right)} \in H_{1}^{1}, \tag{4.119}
\end{equation*}
$$

solves

$$
\begin{equation*}
\left(I d+A^{-1} \phi K\right) \varphi=f \tag{4.120}
\end{equation*}
$$

Since $I d+A^{-1} \phi K$ is invertible, and since $A^{-1}$ is also a bounded operator (indeed even compact) on $H_{1}^{1}$, according to the openness of invertible operator, there exists a small ball $B_{\varepsilon}(0)$ around 0 , such that

$$
\begin{equation*}
\left(I d+A^{-1} \phi K\right)+z A^{-1} \text { is invertible in } H_{1}^{1}, \forall z \in B_{\varepsilon}(0) . \tag{4.121}
\end{equation*}
$$

ii) If $K\left(A^{-1} \phi\right)=-1$, then we can easily check that 0 is en eigenvalue of $I d+A^{-1} \phi K$ with multiplicity 1 and the eigenspace is generated by $A^{-1} \phi$.

According to the perturbation theory, see for example [44], there exist small open neighborhoods $\Omega$ and $\widetilde{\Omega}$ of $0 \in \mathbb{C}$ satisfying

$$
\begin{gathered}
\left(I d+A^{-1} \phi K+z A^{-1}\right) y(z)=\lambda(z) y(z), \\
y(z): z \in \Omega \mapsto y(z) \in H_{1}^{1} \text { is holomorphic, } \\
\lambda(z): z \in \Omega \mapsto \lambda(z) \in \widetilde{\Omega} \subset \mathbb{C} \text { is holomorphic, } \\
\lambda(0)=0, \quad y_{0}:=y(0)=A^{-1} \phi,
\end{gathered}
$$

in such a way that for any $z \in \Omega, \lambda(z)$ is the unique eigenvalue inside $\widetilde{\Omega}$. Recall that $\lambda(0)=0$ and that the zero points of any non-trivial (not identically zero) holomorphic fucntion are isolated.

If further there exists a small neighborhood $\omega$ of $0 \in \mathbb{C}$ such that $\lambda(z)=0$ for any $z \in \omega$, then we are able to decompose $y(z) \in H_{1}^{1}$ is power series as

$$
\begin{equation*}
y(z)=y_{0}+\sum_{k=1}^{+\infty} z^{k} y_{k}, \quad y_{k} \in H_{1}^{1} . \tag{4.122}
\end{equation*}
$$

By matching the coefficients of the power series, we get

$$
\begin{equation*}
\left(I d+y_{0} K\right) y_{k}+A^{-1} y_{k-1}=0, \quad \forall k \geq 1 . \tag{4.123}
\end{equation*}
$$

By adapting $A^{-1}$ and $K$ to the preceding equation we conclude that

$$
\begin{equation*}
K\left(A^{-1} y_{k}\right)=0, \forall k \geq 0 . \tag{4.124}
\end{equation*}
$$

Then by successively adapting $A^{-1}$ and $K$ to the same equation we arrive at

$$
\begin{equation*}
K\left(A^{-n} y_{k}\right)=0, \forall k \geq 0, \forall n \geq 1, \tag{4.125}
\end{equation*}
$$

which in particular yields

$$
\begin{equation*}
K\left(A^{-n} y_{0}\right)=0, \forall n \geq 1 . \tag{4.126}
\end{equation*}
$$

The preceding equality implies

$$
\begin{equation*}
\sum_{n} \frac{a_{n} K_{n}}{n^{2 l}}=0, \forall l \geq 2 . \tag{4.127}
\end{equation*}
$$

Again using the holomorphic function technique, we conclude that $a_{n} K_{n}=0$, which is a contradiction.

Therefore, there exists a sequence of $\left\{z_{k}\right\}$ converging to 0 such that $\lambda\left(z_{k}\right) \neq 0$. Indeed, thanks to the fact that $\lambda$ is holomorphic with 0 being a zero point, in this case we even have that
$\lambda(z) \neq 0$ in $\omega_{1} \backslash\{0\}$ with $\omega_{1}$ being a small neighborhood of 0 . Then, since $\lambda\left(z_{k}\right) \neq 0$ and $\lambda\left(z_{k}\right)$ is the unique eigenvalue inside $\widetilde{\Omega}$, for $z_{k}$ sufficiently close to 0 we know that $I d+A^{-1} \phi K+z_{k} A^{-1}$ is invertible. Thus $I d+A^{-1} \phi K+\lambda A^{-1}+\left(z_{k}-\lambda\right) A^{-1}$ is invertible. As the spectrum of $A+\rho I d$ is discrete, we can find a $\rho$ (more precisely, some $z_{k}-\lambda$ ), such that both $A+\rho I d$ and $A+\phi K+\lambda I d+\rho I d$ are invertible.
2) Because

$$
\begin{equation*}
T(A+\phi K+\lambda I d+\rho I d)=A T+\rho T: H_{1}^{1} \rightarrow H_{1}^{-1} \tag{4.128}
\end{equation*}
$$

we have

$$
\begin{equation*}
(A+\rho I d)^{-1} T=T(A+\phi K+\lambda I d+\rho I d)^{-1}: H_{1}^{-1} \rightarrow H_{1}^{1} \tag{4.129}
\end{equation*}
$$

Suppose that $h \in \operatorname{ker} T^{*}$, then we deduce from the above operator equality that

$$
\begin{aligned}
0 & =\left\langle(A+\rho I d)^{-1} T \varphi-T(A+\phi K+\lambda I d+\rho I d)^{-1} \varphi, h\right\rangle_{H_{1}^{-1}} \\
& =\left\langle\varphi, T^{*}(A+\rho I d)^{-1} h\right\rangle_{H_{1}^{-1}}-\left\langle(A+\phi K+\lambda I d+\rho I d)^{-1} \varphi, T^{*} h\right\rangle_{H_{1}^{-1}} \\
& =\left\langle\varphi, T^{*}(A+\rho I d)^{-1} h\right\rangle_{H_{1}^{-1}}, \quad \forall \varphi \in H_{1}^{-1}
\end{aligned}
$$

where we have used the fact that $A$ is self-adjoint.
The above implies $(A+\rho I d)^{-1} h \in \operatorname{ker} T^{*}$, thus

$$
\begin{equation*}
(A+\rho I d)^{-1}: \operatorname{ker} T^{*} \rightarrow \operatorname{ker} T^{*} \tag{4.130}
\end{equation*}
$$

Suppose that ker $T^{*}$ is not reduced to $\{0\}$. Therefore, because the space ker $T^{*}$ is of finite dimension and not reduced to $\{0\}$ we can find an eigenfunction $(h, \mu), h \neq 0$ and $\mu \neq 0$, such that

$$
\begin{equation*}
(A+\rho I d)^{-1} h=\mu h \text { and } h \in \operatorname{ker} T^{*} \tag{4.131}
\end{equation*}
$$

We immediately deduce that $h$ is an eigenfunction of $A=\Delta$ in $H_{1}^{-1}$. Moreover, we know from the definition of $h$ that

$$
h=\mu(A+\rho I d) h, \quad \text { i.e. } \quad A h=\frac{1-\rho}{\mu} h
$$

and $h$ is a eigenfunction of $A$. We notice that the subspaces of $H_{1}^{1}$ that are also eigenspaces of $\Delta$ have dimension 1 (the eigenvalues are not degenerate in $H_{1}^{1}$ ). In particular the dimension of the eigenspace of $(1-\rho) / \mu$ is one, and therefore $h=C f_{k}$ for some $k \in \mathbb{N}^{*}$.
3) From the above, we get

$$
\begin{equation*}
\left\langle T \varphi, f_{k}\right\rangle_{H_{1}^{-1}}=0, \forall \varphi \in H_{1}^{-1} \tag{4.132}
\end{equation*}
$$

Thanks to the fact that $T \phi=\phi$ in $H_{1}^{-1}$, we can take $\varphi:=\phi$ to achieve

$$
\begin{equation*}
0=\left\langle T \phi, f_{k}\right\rangle_{H_{1}^{-1}}=\left\langle\phi, f_{k}\right\rangle_{H_{1}^{-1}}=\frac{a_{k}}{k^{2}} \tag{4.133}
\end{equation*}
$$

which is in contradiction with the fact that $a_{n} \neq 0$.

### 4.5 Invertibility of the transformation $T$ on $H_{1}^{s}$ for any $s \in(-3 / 2,3 / 2)$

In the previous part we have proved the invertibility of the transformation $T$ on $H^{-1}$. We will now show that this implies

$$
K_{n} \neq 0, \forall n \in \mathbb{N}^{*},
$$

which will in turn imply the isomorphism property in $H_{1}^{s}$ for any $s \in(-3 / 2,3 / 2)$ thanks to Lemma 4.1 .

Recall that

$$
\begin{equation*}
T: n f_{n} \mapsto-K_{n}\left(n q_{n}\right), \tag{4.134}
\end{equation*}
$$

is a bounded operator form $H_{1}^{-1}$ to itself. By contradiction, suppose that for some $n_{0}$ we have $K_{n_{0}}=0$. As $T: H_{1}^{-1} \rightarrow H_{1}^{-1}$ is an isomorphism there exists $h \in H_{1}^{-1}$ such that

$$
T h=n_{0} q_{n_{0}}
$$

By property of Riesz bases, there exists a unique $\left\{d_{n}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right)$ such that

$$
\begin{equation*}
h=\sum_{n} d_{n}\left(n f_{n}\right) \in H_{1}^{-1} . \tag{4.135}
\end{equation*}
$$

Then

$$
\begin{equation*}
T h=\sum_{n}-d_{n} K_{n}\left(n q_{n}\right) \tag{4.136}
\end{equation*}
$$

which converges absolutely as $\left\{n q_{n}\right\}_{n \in \mathbb{N}^{*}}$ is a Riesz basis of $H_{1}^{-1}$. By definition of $h$, and by uniqueness of the decomposition,

$$
d_{n_{0}} K_{n_{0}}=1
$$

which contradicts the assumption on $K_{n_{0}}$. Consequently, for every $n \in \mathbb{N}^{*}$ we know that $K_{n} \neq 0$, thus $-a_{n} K_{n} \neq 0$.

We also know that

$$
\begin{equation*}
-a_{n} K_{n}=\lambda+c_{n} \text { with }\left\{c_{n}\right\}_{n \in \mathbb{N}^{*}} \in \ell^{2}\left(\mathbb{N}^{*}\right), \tag{4.137}
\end{equation*}
$$

which implies that at high frequency $\left\{\left|a_{n} K_{n}\right|\right\}_{n \geq M}$ is bounded away from 0 and also bounded from above. Therefore, $\left\{\left|a_{n} K_{n}\right|\right\}_{n \in \mathbb{N}^{*}}$ is bounded away from 0 and also bounded from above. Hence

$$
\begin{equation*}
c<\left|K_{n}\right|<C, \quad \forall n \in \mathbb{N}^{*} \tag{4.138}
\end{equation*}
$$

By applying Lemma 4.1 (4) with $m=0$ and $s \in(-3 / 2,3 / 2)$, we get that $T: H_{1}^{s} \rightarrow H_{1}^{s}$ is an isomorphism for any $s \in(-3 / 2,3 / 2)$. The special case $s=0$ corresponds to the invertibility on the space $L_{1}^{2}$.

### 4.6 Conclusion

We are now in a position to prove Proposition 3.4 .
Proof. The proof of Proposition 3.4 is a consequence of the above subsections: we choose $K_{n}$ as in Sections 4.3.1 4.3.2. We know from Section 4.3.2 that $K$ is a bounded functional on $H_{1}^{1 / 2+}$ and from Section 4.5 we know that there exists $c>0$ and $C>0$ such that

$$
c<\left|K_{n}\right|<C, \quad \forall n \in \mathbb{N}^{*}
$$

Consequently, from Lemma 4.1 that $T$ is an isomorphism on $H_{1}^{s}$ for any $s \in(-3 / 2,3 / 2)$. Moreover from Lemma 4.7 we know that for any $r \in(-1 / 2,1 / 2)$, and $\varphi \in H_{1}^{r+1}$ we have

$$
(T A+T B K) \varphi=(A T-\lambda T) \varphi \text { in } H_{1}^{r-1},
$$

and from Lemma 4.6

$$
\begin{equation*}
T \phi_{1}=\phi_{1} \text { in } H_{1}^{-1 / 2-} . \tag{4.139}
\end{equation*}
$$

Finally from 4.113) and the definition of $\left\{c_{n}\right\}_{n \in \mathbb{N}^{*}}$ given in 4.108], for any $r \in[0,1 / 2)$ we have

$$
\left\{\left(\lambda+a_{n} K_{n}\right) n^{r}\right\}_{n \in \mathbb{N}^{*}} \in l^{2}\left(\mathbb{N}^{*}\right) .
$$

Hence the operators $K$ and $T$ satisfy the properties announced in Proposition 3.4 for $m=0$. Thanks to Lemma 4.1 the same can be done identically in the case $m \neq 0$. This ends the proof of Proposition 3.4 .

## 5 Well-posedness results

### 5.1 Well-posedness of the closed-loop systems of heat equations

In this section we show that the closed-loop systems provided in Theorem 1.1 and Theorem 1.4 are actually well-posed.

We mainly focus on the well-posedness of the heat equation. In the next subsection a similar proof will yield the well-posedness of the viscous Burgers equation.

It suffices to consider the case of $m=0$, while the other cases can be proved similarly. Furthermore, for the ease of notations, here we only prove the following special case corresponding to $r=0$, while the other cases where $r \in(-1 / 2,1 / 2)$ can be proved similarly. Inspired by the decomposition (3.17) and the fact that $H^{m}=H_{1}^{m} \oplus H_{2}^{m}$ it suffices to consider the well-posedness in $H_{1}^{m}$ and $H_{2}^{m}$ separately, which is given by the following lemma:

LEMMA 5.1 (Well-posedness of the odd and even part: $m=0, r=0$ ). Let $k \in\{1,2\}$. Let $y_{0} \in L_{k}^{2}$. Let $\phi \in H_{k}^{-1}$. Let $K_{k}: H_{k}^{3 / 4} \rightarrow \mathbb{R}$ be bounded. The equation

$$
\left\{\begin{array}{l}
\partial_{t} y-\Delta y=\phi_{k} K_{k}(y)  \tag{5.1}\\
y(0)=y_{0}
\end{array}\right.
$$

has a unique solution that is satisfied in $L_{\text {loc }}^{2}\left((0,+\infty) ; H_{k}^{-1}\right)$, and

$$
\begin{equation*}
y(t) \in C^{0}\left([0,+\infty) ; L_{k}^{2}\right) \cap L_{l o c}^{2}\left((0,+\infty) ; H_{k}^{1}\right) \cap H_{l o c}^{1}\left((0,+\infty) ; H_{k}^{-1}\right) . \tag{5.2}
\end{equation*}
$$

COROLLARY 5.2 (Case $m=0, r \in(-1 / 2,1 / 2))$. Let $k \in\{1,2\}$. Let $r \in(-1 / 2,1 / 2)$. Let $y_{0} \in H_{k}^{r}$. Let $\phi \in H_{k}^{-1 / 2-}$. Let $K_{k}: H_{k}^{1 / 2+} \rightarrow \mathbb{R}$ be bounded. The equation (5.1) has a unique solution such that the equation is satisfied in $L_{\text {loc }}^{2}\left((0,+\infty) ; H_{k}^{r-1}\right)$, and

$$
\begin{equation*}
y(t) \in C^{0}\left([0,+\infty) ; H_{k}^{r}\right) \cap L_{l o c}^{2}\left((0,+\infty) ; H_{k}^{r+1}\right) \cap H_{l o c}^{1}\left((0,+\infty) ; H_{k}^{r-1}\right) \tag{5.3}
\end{equation*}
$$

REMARK 5.3 (Cases $m \neq 0, r \in(-1 / 2,1 / 2))$. Let $k \in\{1,2\}$. For the other cases where $m \neq 0$, we are dealing with $y_{0} \in H_{k}^{m+r}, \phi_{k} \in H_{k}^{m-1 / 2-}, K_{k}: H_{k}^{m+1 / 2+} \rightarrow \mathbb{R}$. Either we can perform the same proof with respect to the pivot space $H_{k}^{m}$ but, this time, or we can consider the isomorphism $D^{m}: H_{k}^{m} \rightarrow L_{k}^{2}$ :

$$
\begin{equation*}
D^{m}: n^{-m} f_{n}^{k} \mapsto f_{n}^{k} \tag{5.4}
\end{equation*}
$$

with convention that $D^{m}\left(f_{0}^{2}\right)=f_{0}^{2}$, where we recall that $f_{n}^{k}$ is an eigenfunction of $A$ given by (2.1). Observe that $D^{m}$ commute with Laplacian, thus the equation (5.1) is equivalent to

$$
\left\{\begin{array}{l}
\partial_{t} w-\Delta w=\left(D^{m} \phi_{k}\right) K_{k} D^{-m}(w),  \tag{5.5}\\
w(0)=D^{-m} y_{0} \in H_{k}^{r}
\end{array}\right.
$$

with $y=D^{m} w$, which goes back to the case of Corollary 5.2.
By combining Lemma 5.1, Corollary 5.2, Remark 5.3 and the fact that $H^{m}=H_{1}^{m} \oplus H_{2}^{m}$, we immediately get the well-posedness of the equation (1.4).

COROLLARY 5.4 (Well-posedness of the heat equation (1.4)). Let $m \in \mathbb{R}$. Let $r \in$ $(-1 / 2,1 / 2)$. Let $y_{0} \in H^{m+r}$. Let $\phi_{k} \in H_{k}^{m-1 / 2-}$ for every $k \in\{1,2\}$. Let $K_{k}: H^{m+1 / 2+} \rightarrow \mathbb{R}$ be bounded satisfying $K_{k}: H_{3-k}^{m+1 / 2+} \rightarrow 0$ for every $k \in\{1,2\}$. The equation (1.4) has a unique solution such that the equation holds in the space $L_{\text {loc }}^{2}\left((0,+\infty) ; H^{m+r-1}\right)$, and

$$
\begin{equation*}
y(t) \in C^{0}\left([0,+\infty) ; H^{m+r}\right) \cap L_{l o c}^{2}\left((0,+\infty) ; H^{m+r+1}\right) \cap H_{l o c}^{1}\left((0,+\infty) ; H^{m+r-1}\right) \tag{5.6}
\end{equation*}
$$

### 5.2 Well-posedness of the viscous Burgers equation

We now turn to the well-posedness of the closed-loop viscous Burgers system 1.8).
LEMMA 5.5 (Well-posedness of the viscous Burgers equation (1.8)). Let $y_{0} \in L^{2}$. Let $\phi_{1}, \phi_{2} \in$ $H^{-1}$. Let $K_{1}, K_{2}: H^{3 / 4} \rightarrow \mathbb{R}$ be bounded. The equation

$$
\left\{\begin{array}{l}
\partial_{t} y-\Delta y+\partial_{x}\left(y^{2} / 2\right)=\phi_{1} K_{1}(y)+\phi_{2} K_{2}(y)  \tag{5.7}\\
y(0)=y_{0}
\end{array}\right.
$$

has a unique solution that is satisfied in $L_{\text {loc }}^{2}\left((0,+\infty) ; H^{-1}\right)$ sense, and

$$
\begin{equation*}
y(t) \in C^{0}\left([0,+\infty) ; L^{2}\right) \cap L_{l o c}^{2}\left((0,+\infty) ; H^{1}\right) \cap H_{l o c}^{1}\left((0,+\infty) ; H^{-1}\right) \tag{5.8}
\end{equation*}
$$

Moreover,

$$
\begin{equation*}
\|y(t, \cdot)\|_{L^{2}} \leq e^{C t}\left\|y_{0}\right\|_{L^{2}}, \forall t \in[0,+\infty) \tag{5.9}
\end{equation*}
$$

Proof of Lemma 5.1. By denoting $S(t)$ the free heat flow evolution: $y:=S(t) y_{0}$ as the solution of

$$
\left\{\begin{array}{l}
\partial_{t} y-\Delta y=0 \text { in } \mathbb{T},  \tag{5.10}\\
y(0)=y_{0},
\end{array}\right.
$$

we know from integration by parts that

$$
\begin{align*}
\left\|S(t) y_{0}\right\|_{C^{0}\left([0, T] ; L_{1}^{2}\right)} & \leq\left\|y_{0}\right\|_{L_{1}^{2}},  \tag{5.11}\\
\left\|S(t) y_{0}\right\|_{L^{2}\left([0, T] ; H_{1}^{1}\right)} & \leq\left\|y_{0}\right\|_{L_{1}^{2}} . \tag{5.12}
\end{align*}
$$

We also know from integration by parts that the solution $g$ of the inhomogeneous heat equation,

$$
\left\{\begin{array}{l}
\partial_{t} g-\Delta g=f \text { in } \mathbb{T},  \tag{5.13}\\
g(0)=0,
\end{array}\right.
$$

satisfies, for any given $T>0$,

$$
\begin{align*}
& \|g(t)\|_{C^{0}\left([0, T] ; L_{1}^{2}\right)} \leq\|f\|_{L^{2}\left(0, T ; H_{1}^{-1}\right)},  \tag{5.14}\\
& \|g(t)\|_{L^{2}\left([0, T] ; H_{1}^{1}\right)} \leq\|f\|_{L^{2}\left(0, T ; H_{1}^{-1}\right)} . \tag{5.15}
\end{align*}
$$

Let us define

$$
\begin{equation*}
\mathcal{B}_{T}:=\left\{y \in C^{0}\left([0, T] ; L_{1}^{2}\right) \cap L^{2}\left([0, T] ; H_{1}^{1}\right)\right\}, \tag{5.16}
\end{equation*}
$$

with its norm given by

$$
\begin{equation*}
\|y\|_{\mathcal{B}_{T}}:=\|y\|_{C^{0}\left([0, T] ; L_{1}^{2}\right)}+\|y\|_{L^{2}\left([0, T] ; H_{1}^{1}\right)} . \tag{5.17}
\end{equation*}

For $M>0$, we also define $\mathcal{B}_{T}(M)$ as

y(0)=y_{0}
\end{array}\right.
$$

We immediately know that $y \in \mathcal{B}_{T}$. However, in order to show that $\mathcal{L}$ is a contraction on $\mathcal{B}_{T}(3 R)$ we need more delicate estimates. Indeed, we benefit from the fact that $K$ is a functional on $H_{1}^{3 / 4}$ instead of on $H_{1}^{1}$.

We know that the solution $y=\mathcal{L} z$ satisfies

& \leq 2 R+C\|z\|_{L^{2}\left(0, T ; H_{1}^{\frac{3}{4}}\right)}, \\
& \leq 2 R+C T^{\frac{1}{8}}\|z\|_{L^{\frac{8}{3}}\left(0, T ; H_{1}^{\frac{3}{4}}\right)}, \\
& \leq 2 R+C T^{\frac{1}{8}}\|z\|_{\mathcal{B}_{T}}, \\
& \leq 2 R+3 C R T^{\frac{1}{8}}, \tag{5.21}
\end{align*}
$$

where we have used the following technical lemma.

& \leq\| \| z\left\|_{L_{1}^{2}}^{\frac{1}{4}}\right\|_{L^{\infty}(0, T)}\| \| z\left\|_{H_{1}^{1}}^{\frac{3}{4}}\right\|_{L^{\frac{8}{3}}(0, T)}, \\
& \leq\|z\|_{L^{\infty}\left(0, T ; L_{1}^{2}\right)}^{\frac{1}{4}}\|z\|_{L^{2}\left(0, T ; H_{1}^{1}\right)}^{\frac{3}{4}}, \\
& \leq\|z\|_{\mathcal{B}_{T}} .
\end{aligned}

Therefore, for $T>0$ sufficiently small we know that

Next, we show that, by choosing $T$ even small if necessary, the map $\mathcal{L}$ is actually a contraction map. For any $z_{1}, z_{2} \in \mathcal{B}_{T}(3 R)$, suppose that $y_{1}:=\mathcal{L} z_{1}, y_{2}:=\mathcal{L} z_{2}$, thus

y_{2}(0)=y_{0} .
\end{array}\right.
$$

This implies that $w:=y_{1}-y_{2}=\mathcal{L}\left(z_{1}-z_{2}\right)$ satisfies

\partial_{t} w-\Delta w=\phi K\left(z_{1}-z_{2}\right) \text { in } \mathbb{T}  \tag{5.27}\\
w(0)=0
\end{array}\right.
$$

which further yields

\left\|\mathcal{L}\left(z_{1}-z_{2}\right)\right\|_{\mathcal{B}_{T}}=\|w\|_{\mathcal{B}_{T}} \leq 2\left\|\phi K\left(z_{1}-z_{2}\right)\right\|_{L^{2}\left(0, T ; H_{1}^{-1}\right)} \leq C T^{\frac{1}{8}}\left\|z_{1}-z_{2}\right\|_{\mathcal{B}_{T}} . \tag{5.28}
\end{equation*}
$$

Therefore, $\mathcal{L}$ is actually a contraction on $\mathcal{B}_{T}(3 R)$ for $T$ sufficiently small. Banach fixed point theorem gives the existence and uniqueness of the solution in a small time interval.

Finally, it is standard to extend the solution to a large time domain. It actually suffices to show the existence on $[0,1]$, thus it does not blow up in this domain. Concerning the solution
$y(t)$ of the system (5.1), integration by parts, which together with Sobolev interpolation and Young's inequality, yield,

& \leq-2\|y(t)\|_{H_{1}^{1}}^{2}+C\left(\frac{7 \varepsilon}{8}\|y(t)\|_{H_{1}^{1}}^{2}+\frac{1}{8 \varepsilon^{7}}\|y(t)\|_{L_{1}^{2}}^{2}\right), \\
& \leq-\|y(t)\|_{H_{1}^{1}}^{2}+C\|y(t)\|_{L_{1}^{2}}^{2} .
\end{aligned}
$$

The preceding a priori estimate, to be combined with standard arguments, indicate the existence of solution on $[0,1]$ and further on $[0,+\infty)$.

Proof of Corollary 5.2. Concerning Corollary 5.2, again, we only prove the case that $k=1$ as the other case that $k=2$ is similar. Observe that $r-1<-1 / 2$, meaning $\phi_{1} \in H_{1}^{r-1}$. Meanwhile, the choice of $r$ also tells us that $K$ is bounded on $H_{1}^{r+1}$.

At first we investigate the related open-loop system, i.e. we replace $K_{1}(y)$ by $u(t) \in$ $L_{l o c}^{2}(0,+\infty)$. The equation

\|y(t)\|_{L^{2}\left(0, T ; H_{1}^{r+1}\right)}^{2} & \leq\left\|y_{0}\right\|_{H_{1}^{r}}^{2}+\left\|\phi_{1} u(t)\right\|_{L^{2}\left(0, T ; H_{1}^{r-1}\right)}^{2} \tag{5.31}
\end{align*}
$$

Indeed,

\frac{1}{2} \frac{d}{d t}\|y(t)\|_{H_{1}^{r}}^{2} & =\langle y(t), \dot{y}(t)\rangle_{H_{1}^{r}} \\
& =-\|y(t)\|_{H_{1}^{r+1}}^{2}+\left\langle y(t), u(t) \phi_{1}\right\rangle_{H_{1}^{r}} \\
& \leq-\|y(t)\|_{H_{1}^{r+1}}^{2}+\|y(t)\|_{H_{1}^{r+1}}\left\|u(t) \phi_{1}\right\|_{H_{1}^{r-1}} \\
& \leq-\|y(t)\|_{H_{1}^{r+1}}^{2}+\frac{1}{2}\|y(t)\|_{H_{1}^{r+1}}^{1}+\frac{1}{2}\left\|u(t) \phi_{1}\right\|_{H_{1}^{r-1}}^{2} \\
& \leq-\frac{1}{2}\|y(t)\|_{H_{1}^{r+1}}^{2}+\frac{1}{2}|u(t)|^{2}\left\|\phi_{1}\right\|_{H_{1}^{r-1}}^{2} \\
& \leq-\frac{1}{2}\|y(t)\|_{H_{1}^{r+1}}^{2}+C|u(t)|^{2}
\end{aligned}
$$

where we have used the fact that for $h, g \in \mathcal{S}_{1}$ (thus extends to related Sobolev spaces)

\langle h, g\rangle_{H_{1}^{r}}=\sum_{n \in \mathbb{N}^{*}}\left(n^{r} h_{n}\right)\left(n^{r} g_{n}\right)=\sum_{n \in \mathbb{N}^{*}}\left(n^{r+1} h_{n}\right)\left(n^{r-1} g_{n}\right) \leq\|h\|_{H_{1}^{r+1}}\|g\|_{H_{1}^{r-1}},
\end{gathered}
$$

as well as that

\langle h, \Delta h\rangle_{H_{1}^{r}}=-\sum_{n \in \mathbb{N}^{*}}\left(n^{r} h_{n}\right)\left(n^{r+2} h_{n}\right)=-\sum_{n \in \mathbb{N}^{*}}\left(n^{r+1} h_{n}\right)\left(n^{r+1} h_{n}\right)=-\|h\|_{H_{1}^{r+1}}^{2} .
$$

Next, for the closed-loop system (5.1), by the choice of $r$ there exists some $s_{0}, s_{1}$ satisfying $r<1 / 2<s_{0}<r+1$ such that $H_{1}^{r+1} \subset H_{1}^{s_{0}} \subset H_{1}^{r}$, and that $K$ is bounded on $H_{1}^{s_{0}}$. Consequently, the same proof of Lemma 5.1 adapts here. For instance, in Lemma 5.1 the value of $s_{0}$ is chosen as $3 / 4$ (see Lemma 5.6 in Section 5). Indeed,

& =\|z\|_{L^{\infty}\left(0, T ; H_{1}\right.}^{\left.r+1-s_{0}^{r}\right)}\|z\|_{L^{p\left(s_{0}-r\right)}\left(0, T ; H_{1}^{r+1}\right)}^{s_{0}-r} .
\end{aligned}

For any given $T>0$. Let us define

\mathcal{B}_{T}^{r}(M):=\left\{y \in \mathcal{B}_{T}^{r} \mid\|y\|_{\mathcal{B}_{T}^{r}} \leq M\right\} \tag{5.36}
\end{equation*}

Let $\left\|y_{0}\right\|_{H_{1}^{r}}=R$. For any $T>0$, we further consider the map $\mathcal{L}^{r}: z \in \mathcal{B}_{T}^{r}(3 R) \mapsto y \in \mathcal{B}_{T}^{r}$ defined as

\partial_{t} y-\Delta y=\phi K(z) \text { in } \mathbb{T},  \tag{5.37}\\
y(0)=y_{0}
\end{array}\right.
$$

When $T$ is sufficiently small, by adapting

\|\phi(K z)\|_{L^{2}\left(0, T ; H_{1}^{r-1}\right)} \leq C\|K z\|_{L^{2}(0, T)} \leq C\|z\|_{L^{2}\left(0, T ; H_{1}^{s_{0}}\right)} \leq C T^{\frac{1}{2}-\frac{1}{p}}\|z\|_{L^{p}\left(0, T ; H_{1}^{s_{0}}\right)}
$$

and the fixed point argument, there is a unique solution in the space 5.3) in a small interval of time $[0, T]$, more precisely as the unique fixed point of $\mathcal{L}^{r}$ in $\mathcal{B}_{T}^{r}(3 R)$.

Next, the a priori estimate further implies the existence of a unique solution in large interval of time.

REMARK 5.8. For the case that $k=2$ instead of 1, similar approach leads to the same well-posedness result. The only place that needs to be (slightly) modified is that the inequalites (5.30) -(5.31) should be replaced by,

\end{aligned}

That is because

\frac{1}{2} \frac{d}{d t}\|y(t)\|_{H_{2}^{r}}^{2} & \leq-\|y(t)\|_{H_{2}^{r+1}}^{2}+\|y(t)\|_{H_{2}^{r}}^{2}+\left\langle y(t), u(t) \phi_{1}\right\rangle_{H_{2}^{r}} \\
& \leq\|y(t)\|_{H_{2}^{r}}^{2}-\frac{1}{2}\|y(t)\|_{H_{2}^{r+1}}^{2}+\frac{1}{2}\left\|u(t) \phi_{1}\right\|_{H_{2}^{r-1}}^{2} .
\end{aligned}
$$

Thus

Proof of Lemma 5.5. Finally, we simply comment on the proof of Lemma 5.2 whose proof is essentially the same as the proof of Lemma 5.1.

Indeed, concerning the existence of the solution in a small interval of time, it suffices to treat the nonlinear term as a perturbation using Gagliardo-Nirenberg interpolation inequality, which is standard.

& \leq C \int_{0}^{T}\|y(t, \cdot)\|_{L^{2}}^{3}\|y(t, \cdot)\|_{H^{1}} d t \\
& \leq C T^{\frac{1}{2}}\|y\|_{C^{0}\left([0, T] ; L^{2}\right)}^{3}\|y\|_{L^{2}\left(0, T ; H^{1}\right)} .

& \leq-\frac{1}{2}\|y(t)\|_{H^{1}}^{2}+C\|y(t)\|_{L^{2}}^{2}
\end{aligned}

where, slightly different from the calculation on $L_{1}^{2}$ and $H_{1}^{1}$, for $H^{1}$ norm (just as for $H_{2}^{1}$ norm) we have

## 6 Exponential stabilization of the heat and Burgers equations

### 6.1 Heat equation: well-posedness and stability of the transformed system

In order to show Theorem 1.1, we need to show the well-posedness of the closed-loop system and its exponential stability. Also, to simplify the notation we assume that $m=0$ even though the exact same can be done with $m \neq 0$. Let $y_{0} \in L_{1}^{2}$. Under the assumption of Theorem 1.1 we can define

$$
B=\left(\phi_{1}, \phi_{2}\right), K=\left(K_{1}, K_{2}\right)^{T}, T=T_{1}+T_{2}
$$

given by Proposition 3.4 and Corollary 3.5.
Let $\tau>0$. Considering the fact that for $k \in\{1,2\} \phi_{k} \in H_{k}^{-1}$ and that $K_{1}: H_{k}^{1} \rightarrow \mathbb{R}$, for any $\varphi(t) \in L^{2}\left((0, \tau) ; H^{1}\right)$ we have that $B K \varphi(t) \in L^{2}\left((0, \tau) ; H^{-1}\right)$. Then, concerning the closed-loop system

y_{t}-\Delta y=B K(y), \quad y(0)=y_{0} \tag{6.1}
\end{equation*}
$$

from Corollary 5.4, we get a unique solution of the closed-loop system

$$
\begin{equation*}
y(t) \in C^{0}\left([0, \tau] ; L^{2}\left(\mathbb{T}^{1}\right)\right) \cap L^{2}\left((0, \tau) ; H^{1}\left(\mathbb{T}^{1}\right)\right) \cap H^{1}\left((0, \tau) ; H^{-1}\left(\mathbb{T}^{1}\right)\right) \tag{6.2}
\end{equation*}
$$

which indicates that the equation (6.1) (thus each item of it) is satisfied in $L^{2}\left((0, \tau) ; H^{-1}\left(\mathbb{T}^{1}\right)\right)$.
Since the operator $T$ is bounded in $H^{l}\left(\mathbb{T}^{1}\right)$ space with $l=-1,0,1$ (from Proposition 3.4 and Corollary 3.5), we know that

z(t):=T y(t) \in C^{0}\left([0, \tau] ; L^{2}(\mathbb{T})\right) \cap L^{2}\left((0, \tau) ; H^{1}(\mathbb{T})\right) \cap H^{1}\left((0, \tau) ; H^{-1}(\mathbb{T})\right) \tag{6.3}
\end{equation*}
$$

Moreover, by applying $T$ to (6.1) we know that

\end{equation*}

By applying Proposition 3.4 and Corollary 3.5 with $s=0$, together with the fact that $y(t) \in$ $L^{2}\left((0, \tau) ; H_{1}^{1}\left(\mathbb{T}^{1}\right)\right)$, we arrive at

\end{equation*}

Hence,

z_{t}-\Delta z+\lambda z=0 \text { in } L^{2}\left((0, \tau) ; H^{-1}(\mathbb{T})\right) \tag{6.6}
\end{equation*}
$$

Consequently,

$$
\begin{equation*}
\frac{1}{2} \frac{d}{d t}\|z(t)\|_{L^{2}(\mathbb{T})}^{2}=\langle z(t), \dot{z}(t)\rangle_{H^{1}, H^{-1}} \leq-\lambda\|z(t)\|_{L^{2}(\mathbb{T})}^{2} \tag{6.7}
\end{equation*}
$$

holds in $L^{1}(0, T)$, which further implies the required decay property of the solution

$$
\begin{equation*}
\|z(t)\|_{L^{2}} \leq e^{-\lambda t}\|z(0)\|_{L^{2}}, \forall t \in[0, \tau] . \tag{6.8}
\end{equation*}
$$

Finally, as $T$ is an isomorphism on $L^{2}$ from Proposition 3.4 and Corollary 3.5, we conclude that

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-\lambda t}\left\|y^{0}\right\|_{L^{2}}, \forall t \in[0, \tau] \tag{6.9}
\end{equation*}
$$

Given that this is true for any $\tau>0$ and that $C(\lambda)$ does not depend on $\tau$, it implies that $y \in C^{0}\left([0,+\infty) ; L^{2}(\mathbb{T})\right)$ and

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-\lambda t}\left\|y^{0}\right\|_{L^{2}}, \forall t \in[0,+\infty) \tag{6.10}
\end{equation*}
$$

This nearly ends the proof of Theorem 1.1, the only thing left is to check that we have also a stabilization in $H^{r}$ for any $r \in(-1 / 2,1 / 2)$.

REMARK 6.1. Let $r \in(-1 / 2,1 / 2)$. The same feedback law $K(y)$ also stabilizes the system (6.1) in $H^{r}$-space.

Indeed, let $r \in(-1 / 2,1 / 2)$ and let $y_{0} \in H^{r}$. As $\phi_{k} \in H_{k}^{r-1}$ and $K_{k}: H_{k}^{r+1} \rightarrow \mathbb{R}$, for any $\varphi(t) \in L^{2}\left((0, \tau) ; H^{r+1}\right)$ we have that $B K \varphi(t) \in L^{2}\left((0, \tau) ; H^{r-1}\right)$. Then equation (6.1) has a solution

$$
\begin{equation*}
y(t) \in C^{0}\left([0, \tau] ; H^{r}(\mathbb{T})\right) \cap L^{2}\left((0, \tau) ; H^{r+1}(\mathbb{T})\right) \cap H^{1}\left((0, \tau) ; H^{r-1}(\mathbb{T})\right) \tag{6.11}
\end{equation*}
$$

and holds in $L^{2}\left((0, \tau) ; H^{r-1}(\mathbb{T})\right)$.
Because $T$ is bounded in $H^{l}$ with $l=r-1, r, r+1$ (Lemma 4.1 part (4) and Section 4.3.2, we know that $z(t):=T y(t)$ lives in the same space of $y(t)$ in 6.11.

By adapting $T$ to the equation (6.1) we know that (6.4) holds in $L^{2}\left((0, \tau) ; H^{r-1}(\mathbb{T})\right)$. Then by adapting Lemma 4.7 to the case that $s=r$, we get

$$
\begin{equation*}
T y_{t}=A T y-\lambda T y, \text { in } L^{2}\left((0, \tau) ; H^{r-1}(\mathbb{T})\right) . \tag{6.12}
\end{equation*}
$$

Hence,

$$
\begin{equation*}
z_{t}-\Delta z+\lambda z=0 \text { in } L^{2}\left((0, \tau) ; H^{r-1}(\mathbb{T})\right) \tag{6.13}
\end{equation*}
$$

which leads to the required exponential decay of $z$ in $H^{r}$,

$$
\begin{equation*}
\frac{1}{2} \frac{d}{d t}\|z(t)\|_{H^{r}}^{2}=\langle z(t), \dot{z}(t)\rangle_{H^{r}} \leq-\lambda\|z(t)\|_{H^{r}}^{2} . \tag{6.14}
\end{equation*}
$$

Consequently, using again that $T$ is an isomorphism in $H^{r}$,

$$
\begin{equation*}
\|y(t)\|_{H^{r}} \leq C_{r}(\lambda) e^{-\lambda t}\|y(0)\|_{H^{r}}, \tag{6.15}
\end{equation*}
$$

with $C$ and $C_{r}(\lambda)$ depending on $r \in(-1 / 2,1 / 2)$ and $\lambda \notin \mathcal{N}$. This ends the proof of Theorem 1.1.

### 6.2 Viscous Burgers equation: well-posedness of the target system and stability of the closed-loop system

The proof of Theorem 1.4 dealing with the viscous Burgers equation is very similar to the proof of Theorem 1.1 dealing with the heat equation with $m=0, r=0$. Let $\tau>0$ and $y_{0} \in L_{1}^{2}$ such that $\left\|y_{0}\right\|_{L^{2}}<\delta$, where $\delta$ is a constant to be chosen. Lemma 5.5 implies that the closed-loop system (1.8) has a unique solution $y(t)$, provided that $\delta$ is sufficiently small (depending on $\tau$ ), and

$$
\begin{equation*}
y(t) \in C^{0}\left([0, \tau] ; L^{2}(\mathbb{T})\right) \cap L^{2}\left((0, \tau) ; H^{1}(\mathbb{T})\right) \cap H^{1}\left((0, \tau) ; H^{-1}(\mathbb{T})\right), \tag{6.16}
\end{equation*}
$$

which holds in $L^{2}\left(0, \tau ; H^{-1}(\mathbb{T})\right)$. Next, again, thanks to the fact that the operator $T$ is bounded in $H_{1}^{l}(\mathbb{T})$ space with $l=-1,0,1$,

$$
\begin{equation*}
z(t):=T y(t) \in C^{0}\left([0, \tau] ; L^{2}(\mathbb{T})\right) \cap L^{2}\left((0, \tau) ; H^{1}(\mathbb{T})\right) \cap H^{1}\left((0, \tau) ; H^{-1}(\mathbb{T})\right) \tag{6.17}
\end{equation*}
$$

Next, by applying $T$ to (1.8) we know that in $L^{2}\left((0, \tau) ; H^{-1}(\mathbb{T})\right)$,

$$
\begin{equation*}
T y_{t}-T A y+T \partial_{x}\left(y^{2} / 2\right)=T B K(y) \tag{6.18}
\end{equation*}
$$

where we used the fact that $T \partial_{x}\left(y^{2} / 2\right) \in L^{2}\left((0, \tau) ; H^{-1}\right)$.
By applying Lemma 4.7 for the case $s=0$, combined with the fact that $y(t) \in L^{2}\left((0, \tau) ; H^{1}\left(\mathbb{T}^{1}\right)\right)$, we get that

$$
\begin{equation*}
T y_{t}=A T y-\lambda T y-T \partial_{x}\left(y^{2}\right) / 2, \text { in } L^{2}\left((0, \tau) ; H^{-1}(\mathbb{T})\right) . \tag{6.19}
\end{equation*}
$$

Hence,

$$
\begin{equation*}
z_{t}-\Delta z+\lambda z+T \partial_{x}\left(T^{-1} z\right)^{2} / 2=0 \text { in } L^{2}\left((0, \tau) ; H_{1}^{-1}(\mathbb{T})\right) \tag{6.20}
\end{equation*}
$$

Therefore, the system is locally stable in $L^{2}(\mathbb{T})$ space, provided that $\|z\|_{L^{2}}$ is small enough, indeed

$$
\begin{aligned}
\frac{1}{2} \frac{d}{d t}\|z(t)\|_{L^{2}(\mathbb{T})}^{2} & =\langle z(t), \dot{z}(t)\rangle_{H^{1}, H^{-1}} \\
& =\left\langle z(t), \Delta z-\lambda z-T \partial_{x}\left(T^{-1} z\right)^{2} / 2\right\rangle_{H^{1}, H^{-1}} \\
& \leq-\|z\|_{H^{1}}^{2}+\|z\|_{L^{2}}^{2}-\lambda\|z\|_{L^{2}}^{2}+C\|z\|_{H^{1}}\left\|T \partial_{x}\left(T^{-1} z\right)^{2}\right\|_{H^{-1}} \\
& \leq-\|z\|_{H^{1}}^{2}-(\lambda-1)\|z\|_{L^{2}}^{2}+C\|z\|_{H^{1}}\left\|\left(T^{-1} z\right)^{2}\right\|_{L^{2}} \\
& \leq-\|z\|_{H^{1}}^{2}-(\lambda-1)\|z\|_{L^{2}}+C\|z\|_{H^{1}}\left\|T^{-1} z\right\|_{L^{2}}\left\|T^{-1} z\right\|_{H^{1}} \\
& \leq-\|z\|_{H^{1}}^{2}-(\lambda-1)\|z\|_{L^{2}}^{2}+C\|z\|_{H^{1}}^{2}\|z\|_{L^{2}} .
\end{aligned}
$$

Hence, provided that $\sup _{[0, \tau]}\left(\|z\|_{L^{2}}\right)$ is small enough (depending on $\left.\lambda \in(1,+\infty)\right)$ one has

$$
\begin{equation*}
\|z(t)\|_{L^{2}} \leq e^{-(\lambda-1) t}\|z(0)\|_{L^{2}}, \forall t \in[0, \tau] \tag{6.21}
\end{equation*}
$$

which also implies, using $T^{-1}$, that

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-(\lambda-1) t}\|y(0)\|_{L^{2}}, \forall t \in[0, \tau] \tag{6.22}
\end{equation*}
$$

provided that $\sup _{[0, \tau]}\left(\|z\|_{L^{2}}\right)$ small, or equivalently that $\sup _{[0, \tau]}\left(\|y\|_{L^{2}}\right)$ small, from the isomorphism property of $T$. Finally, from Lemma 5.5 and 5.9 it suffices to have $\left\|y_{0}\right\|_{L^{2}}$ small. This means that there exists $\delta_{1}(\tau, \lambda)$ such that for any $\delta \in\left(0, \delta_{1}(\tau, \lambda)\right)$ the solution $y$ satisfies (6.16) and the exponential stability estimate $\sqrt{6.22}$ holds.

So far the constant $\delta$ depends on $\tau$ but, leveraging the exponential stability estimate $\sqrt{6.22)}$, it can be made independent of $\tau$ using a very classical argument: let $\tau_{1}>0$ such that $e^{-(\lambda-1) \tau_{1} / 2}<$ $(C(\lambda))^{-1}$, and select $\delta=\delta_{1}\left(\tau_{1}, \lambda\right)$, then $y$ exists and (6.22) holds on $\left[0, \tau_{1}\right]$, therefore

$$
\begin{equation*}
\left\|y\left(\tau_{1}, \cdot\right)\right\|_{L^{2}} \leq e^{-(\lambda-1) \tau_{1} / 2}\left\|y_{0}\right\|_{L^{2}} \tag{6.23}
\end{equation*}
$$

As the system $(1.8)$ is autonomous, studying it on $\left[\tau_{1}, 2 \tau_{1}\right]$ is the same as studying it on $\left[0, \tau_{1}\right]$ with initial condition $y\left(\tau_{1}, \cdot\right)$. And from (6.23), $\left\|y\left(\tau_{1}, \cdot\right)\right\|_{L^{2}} \leq\left\|y_{0}\right\|_{L^{2}} \leq \delta_{1}\left(\tau_{1}, \lambda\right)$, hence the solution exists on $\left[\tau_{1}, 2 \tau_{1}\right]$ and

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-(\lambda-1)\left(t-\tau_{1}\right)}\left\|y\left(\tau_{1}\right)\right\|_{L^{2}}, \forall t \in\left[\tau_{1}, 2 \tau_{1}\right] \tag{6.24}
\end{equation*}
$$

which together with (6.22) gives

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-\frac{(\lambda-1)}{2} t}\|y(0)\|_{L^{2}}, \forall t \in\left[0,2 \tau_{1}\right], \tag{6.25}
\end{equation*}
$$

Hence, iterating this procedure, for any $n \in \mathbb{N}^{*} y$ exists on $\left[0, n \tau_{1}\right]$

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-\frac{(\lambda-1)}{2} t}\|y(0)\|_{L^{2}}, \forall t \in\left[0, n \tau_{1}\right] \tag{6.26}
\end{equation*}
$$

hence $y$ exists on $[0,+\infty)$ and

$$
\begin{equation*}
\|y(t)\|_{L^{2}} \leq C(\lambda) e^{-\frac{(\lambda-1)}{2} t}\|y(0)\|_{L^{2}}, \forall t \in[0,+\infty) \tag{6.27}
\end{equation*}
$$

This ends the proof of Theorem 1.4 .

## 7 Conclusion

### 7.1 Quantitative studies on $C_{r}(\lambda, m)$

Thanks to the precise analysis introduced in this paper. The next step could also be on the quantitative study of the stabilization cost, namely on the value of the constant $C_{r}(\lambda, m)$ in Theorem 1.1. For example, let $m=0$. For any fixed $\lambda \notin \mathcal{N}$, even if we do not have enough information on the exact value of $C_{r}(\lambda)$, it can be conjectured that the optimal value of $C_{r}(\lambda)$ (at least obeying our feedback law) tends to $+\infty$ as $|r|$ tends to $1 / 2^{-}$.

The appearance of the critical set $\mathcal{N}$ also indicates that, for any $r \in(-1 / 2,1 / 2)$ fixed, as $\lambda$ tends to $\mathcal{N}$ the value of $C_{r}(\lambda)$ tends to $+\infty$. Therefore, it seems that by adapting this feedback we are not able to achieve $e^{C \sqrt{\lambda}}$ type estimates, at least not uniformly on $\lambda \in \mathbb{R}^{+}$. However, we believe that with the precise functional settings treated in this paper, we are much more closed to such quantitative results. Indeed, it is still possible and reasonable to expect $e^{C \sqrt{\lambda}}$ estimate on $\left\{\lambda=4 N+2 ; N \in \mathbb{N}^{*}\right\}$.

### 7.2 General parabolic equations

It is natural to ask whether our framework also adapts general parabolic equations, namely

$$
\left\{\begin{array}{l}
\partial_{t} y-\Delta y+a_{1}(x) \partial_{x} y+a_{2}(x) y=\phi_{1} K_{1}(y)+\phi_{2} K_{2}(y)  \tag{7.1}\\
y(0)=y_{0}
\end{array}\right.
$$

with $a_{i}(x)$ satisfying suitable regularity assumption.
By regarding the lower order operators $a_{1}(x) \partial_{x}+a_{2}(x)$ as source, the same feedback law and transformation yields the operator equality. However, on the next step, when applying $T$ to the evolution equation, the source $a_{1}(x) \partial_{x} y+a_{2}(x) y$ turned out to be $T\left(a_{1}(x) \partial_{x}\left(T^{-1} z\right)+a_{2}(x)\left(T^{-1} z\right)\right)$ which may become even stronger than the $-\lambda z$ damping produced by backstepping.

Therefore, it seems that we need to perform backstepping directly on the elliptic operator $-\Delta+a_{1}(x) \partial_{x}+a_{2}(x)$. In the case that $a_{1}(x)=0$, the analysis is probably simpler as the operator is remained to be self-adjoint. However, losing those explicit formulation of eigenvalues and eigenfunctions make it more challenging to conclude Lemma 4.1. While the other case that $a_{1}(x) \neq 0$ is of course more delicate, maybe the perturbation theory of resolvent estimates should be applied, a good news is that due to the spectral gaps between different eigenvalues are increasing, it is possible that no smallness of $a_{1}(x) \partial_{x}+a_{2}(x)$ should be assumed. Technically speaking, due to the appearance of eigenvalues admitting double multiplicity the bifurcation phenomenon when splitting those eigenvalues should appear, the resolvent analysis involved would be more interesting and more delicate to some related works such as [7, 17].

### 7.3 Stabilization with one scalar control

It is proved in this work that two scalar controls are necessary and sufficient for the rapid stabilization of the heat equation provided some decay information, because of those double eigenvalues. But if we work on more general parabolic equations, for which it is possible that every eigenvalues are simple and isolated, then probably one scalar control, of course always admitting suitable decay properties, is sufficient to conclude controllability and rapid stabilization.

According to the "return philosophy" introduced by Coron [15], it is still possible to stabilize nonlinear system even if the linearized system is not stabilizable. Therefore, it is also of interest to consider the rapid stabilization of the viscous Burgers equation with one scalar control.
