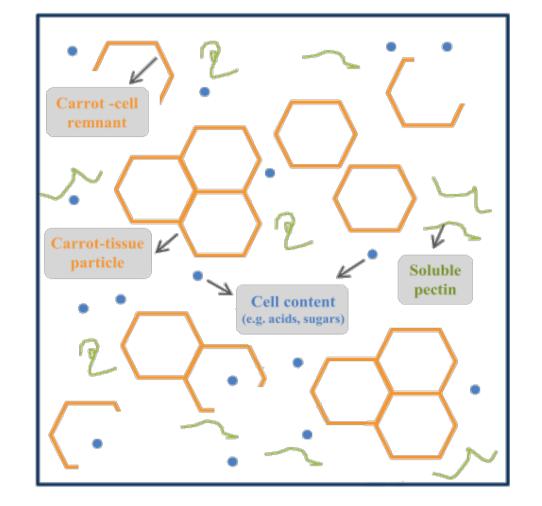
Research question:

How does continuous medium impact rheological behaviour of fruit suspensions ?

Strategy & Context

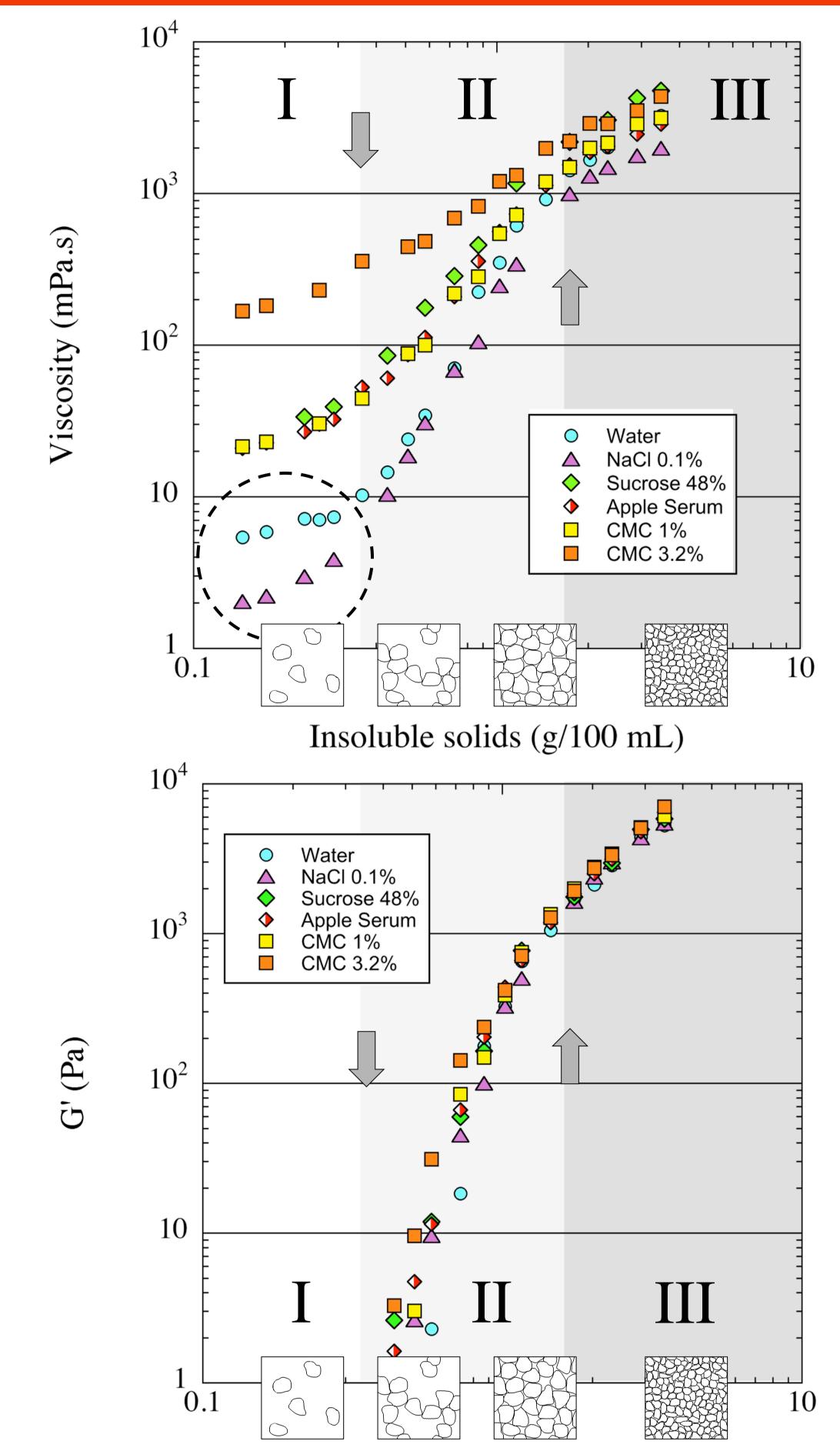
In food industry, controlling texture allows to generate innovative products and to deal with consumer expectations.

Fruit purees = suspensions of deformable cells or cell clusters

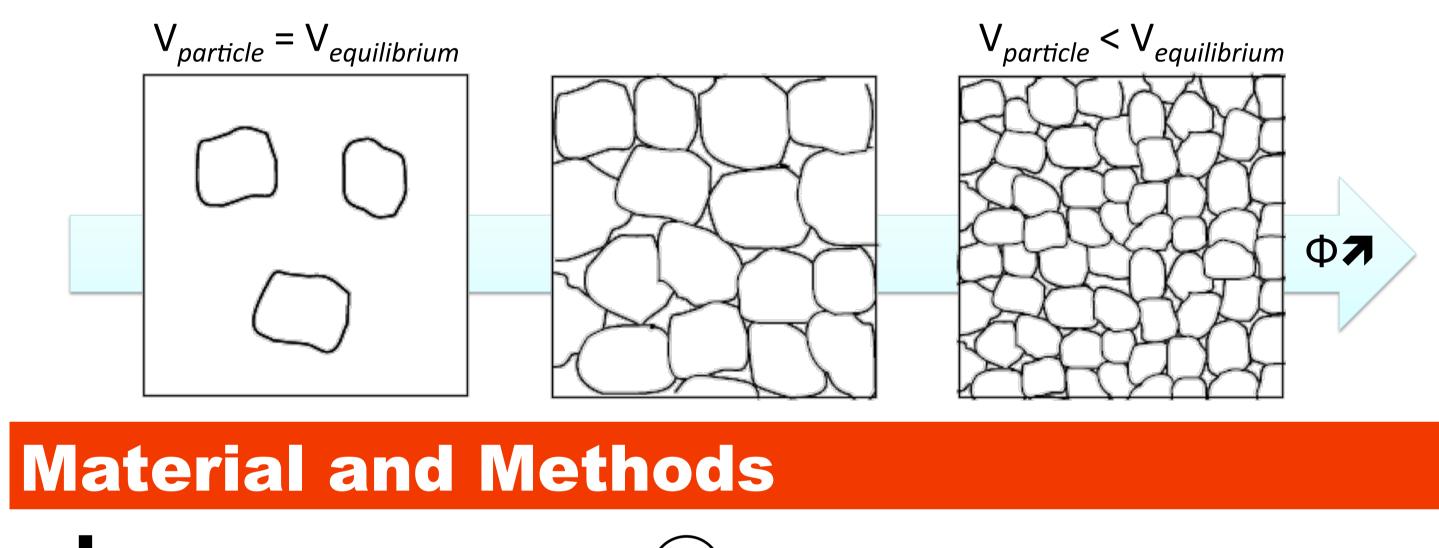

Apple puree = 1.16 g of cell walls for 100 mL of puree

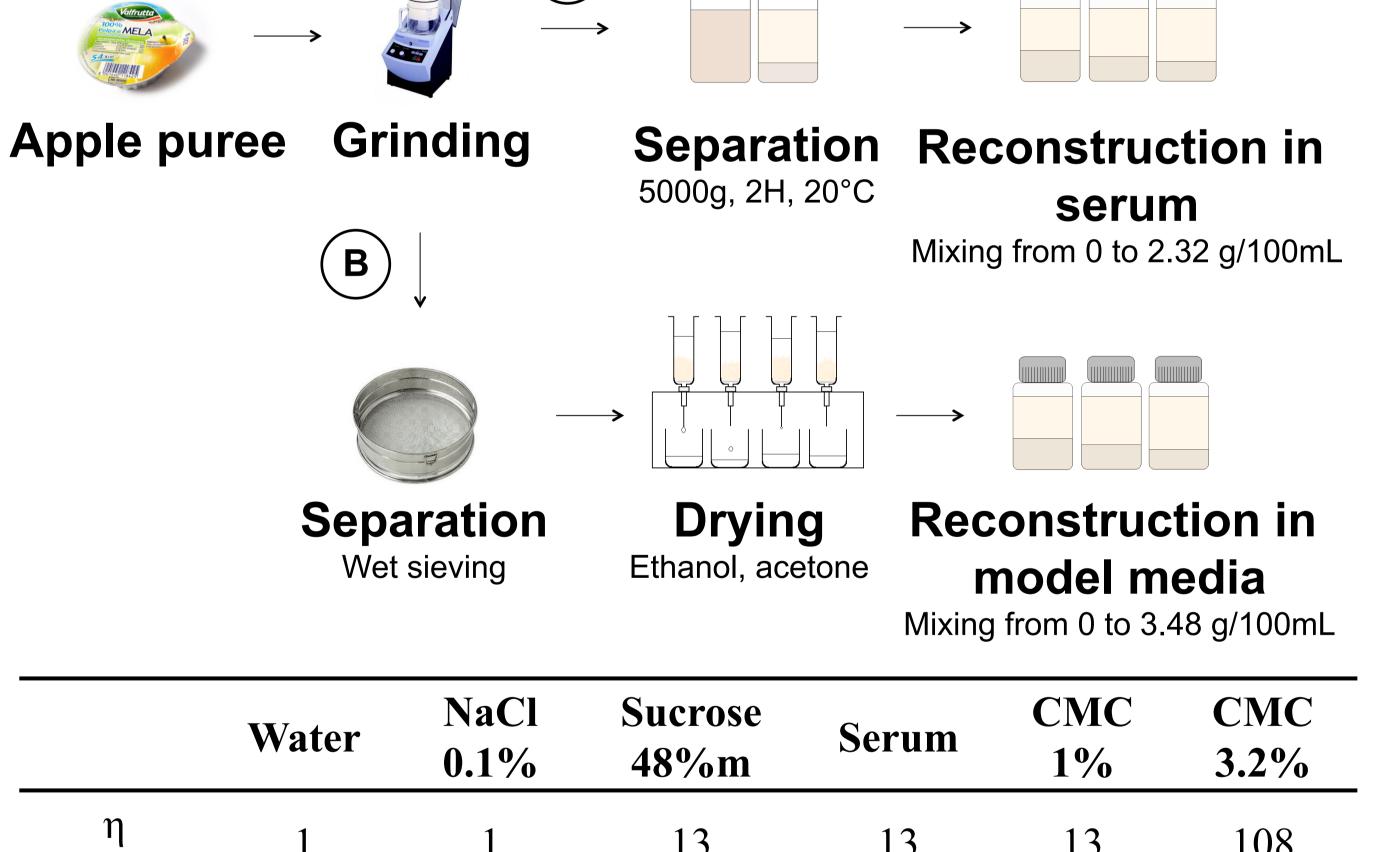
Construction of apple cells suspensions varying in :

Conclusions

Rheological parameters increase with the particle content. This study confirms that **particle content** has **a major impact** on rheological behaviour of apple cells dispersions, and highlights **three concentration domains**, both in flow and dynamics measurements.

- The **diluted domain** exhibits Newtonian flow. Ionic strength appears to impact only in distilled water inducing electrostatic repulsion between particles which increases viscosity values.
- The intermediate domain is characterised by the building of a weak network between particles. Continuous phase have a little effect in this domain, but its viscosity and ionic strength seem to impact the elastic modulus in this domain.
- In the **concentrated domain**, the dependency between viscosity and concentration decreases. Particles begin to pack and their volume becomes lower than their equilibrium volume. Continuous phase has no longer any impact on G', the interactions between particles are the only paameters affecting elastic properties in this domain.

The continuous phase seems to have no impact on transition domains.

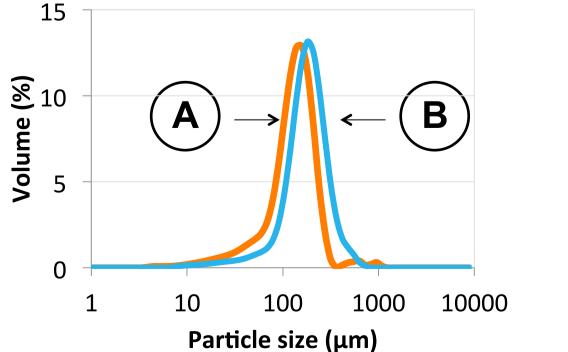
MATERIAL

MCR 301, Anton Paar, using large gap coaxial cylinders (δr=5mm)

Steady-state measurements Apparent viscosity after 1min at 50s⁻¹

Oscillatory measurements Strain sweep from 0.015% to 150% was performed at 10rad.s^{-1.}

Particle size distribution Mastersizer 2000, Malvern
