# STABILITY ESTIMATES IN INVERSE PROBLEMS FOR THE SCHRÖDINGER AND WAVE EQUATIONS WITH TRAPPING 

VÍCTOR ARNAIZ AND COLIN GUILLARMOU<br>Dedicated to the memory of Slava Kurylev


#### Abstract

For a class of Riemannian manifolds with boundary that includes all negatively curved manifolds with strictly convex boundary, we establish Hölder type stability estimates in the geometric inverse problem of determining the electric potential or the conformal factor from the Dirichlet-to-Neumann map associated with the Schrödinger equation and the wave equation. The novelty in this result lies in the fact that we allow some geodesics to be trapped inside the manifold and have infinite length.


## 1. Introduction

In this article we study a geometric inverse problem associated with the anisotropic Schrödinger equation and the wave equation on a compact Riemannian manifold ( $M, g$ ) with boundary $\partial M$.

Let $\Delta_{g}$ be the non-negative Laplace-Beltrami operator associated with the metric $g$, we consider two initial-value-problems. First, we consider the Schrödinger equation for finite time of propagation and with Dirichlet conditions:

\begin{cases}\left(i \partial_{t}-\Delta_{g}+q(x)\right) u(t, x)=0, & \text { in }(t, x) \in I \times M  \tag{1.1}\\ u(0, \cdot)=0, & \text { in } x \in M \\ u(t, x)=f(t, x), & \text { on }(t, x) \in I \times \partial M\end{cases}
$$

where $I=(0, T)$ for $T>0$ fixed. Secondly, we consider the wave equation for infinite time of propagation and with Dirichlet conditions:

\begin{cases}\left(\partial_{t}^{2}+\Delta_{g}+q(x)\right) u(t, x)=0, & \text { in }(t, x) \in I \times M  \tag{1.2}\\ u(0, \cdot)=0, \partial_{t} u(0, \cdot)=0, & \text { in } x \in M \\ u(t, x)=f(t, x), & \text { on }(t, x) \in I \times \partial M\end{cases}
$$

where $I=(0, T)$ and $T$ can be equal to $+\infty$.
We aim at studying the problem of the stable recovery of the potential $q$, or alternatively conformal factor in a conformal class of a metric $g$, from the Dirichlet-to-Neumann map associated with (1.1) and (1.2). The Dirichlet-to-Neumann map (DN map in short) is the operator defined for each $T<\infty$

where $u^{S}$ solves (1.1) and $u^{W}$ solves (1.2), and $\partial_{\mathrm{n}}$ is the unit inward normal derivative at $\partial M$. Here $H_{0}^{1}([0, T) \times \partial M)$ denotes the closed subspace of functions in $H^{1}([0, T) \times \partial M)$ vanishing at $t=0$. For the wave equation, we shall need to consider the case $T=\infty$, and we will show that there is $\nu_{0} \geq 0$ depending only on $\|q\|_{L^{\infty}}$ so that for all $\nu \geq \nu_{0}$

is bounded.
By a stability estimate, we mean that there is a constant $C>0$, possibly depending on some a priori bound on $\left\|q_{j}\right\|_{H^{s}(M)}$ for some $s \geq 0$ such that an estimate of the following form holds

where the used norm for the Schrödinger/wave DN map are respectively

\|\cdot\|_{*}=\|\cdot\|_{H^{1}(I \times \partial M) \rightarrow L^{2}(I \times \partial M)}, \quad\|\cdot\|_{*, \nu}=\|\cdot\|_{e^{\nu t} H_{0}^{1}(I \times \partial M) \rightarrow e^{\nu t} L^{2}(I \times \partial M)}
$$

and $F$ is a continuous function satisfying $F(0)=0$; we shall write simply $\|\cdot\|_{*}$ for the wave case when $I=[0, T]$ with $T<\infty$, and $\nu=0$. We say that the stability is of Hölder type if $F(x)=x^{\beta}$ for some $\beta>0$, it is said of log-type if $F(x)=\log (1 / x)^{-\beta}$ for some $\beta>0$. More generally, one can ask if there is a stability for the problem of recovering the metric, i.e.

for some diffeomorphism $\psi$ (depending on $g_{1}, g_{2}$ ). Here we have used the $L^{2}$ norm on $M$ to measure $q_{1}-q_{2}$, but one could also ask the same question for Sobolev or Hölder norms. Assuming a priori bounds on $q$ in some large enough Sobolev spaces $H^{s_{0}}(M)$ allows to deduce (by interpolation) bounds on $\left\|q_{1}-q_{2}\right\|_{H^{s}}$ for $s<s_{0}$ if one has bounds on $\left\|q_{1}-q_{2}\right\|_{L^{2}}$ (and similalry for $g_{1}-g_{2}$ ).

The problem of determination of the metric $g$ or the potential $q$ from $\Lambda_{g, q}^{W}$ was solved in general by Belishev-Kurylev [BK92] (see also [KKL01]) but the stability estimates in the general setting appeared only recently in the work of Burago-Ivanov-Lassas-Lu [BILL20] and are of $\log \log$ type (i.e. $F(x)=|\log | \log x| |^{-\beta}$ ) for the case with no potential. When $g=g_{\text {eucl }}$ is the Euclidean metric on a domain $M \subset \mathbb{R}^{n}$, a Hölder type stability was proved by Sun [Sun90] and Alessandrini-Sun-Sylvester [AZS90] for the determination of the potential $q$ from $\Lambda_{g_{\text {euc }}, q}^{W}$. In the case of non-Euclidean metrics, but close to the Euclidean metric on a ball in $\mathbb{R}^{n}$, Stefanov-Uhlmann [SU98] obtained Hölder estimates for the metric recovery (with no potential involved), and they extended this result in [SU05] to Riemannian metrics close to a simple metric $g_{0}$ with injective X-ray transform on symmetric 2-tensors. Such simple metrics are dense among simple metrics. We recall that simple metrics are Riemannian metrics with no conjugate points on a ball $B$ in $\mathbb{R}^{n}$ with strictly convex boundary, in particular all geodesics in $B$ for such a metric have finite length with endpoints on the boundary $\partial B$. If $g_{0}$ is a fixed simple metric, Bellassoued and Dos Santos Ferreira [BDSF10, BDSF11] proved Hölder stability of the inverse problem for both $\left\|\Lambda_{g_{0}, q_{1}}^{W}-\Lambda_{g_{0}, q_{2}}^{W}\right\|_{*}$ and $\left\|\Lambda_{g_{0}, q_{1}}^{W}-\Lambda_{g_{0}, q_{2}}^{W}\right\|_{*}$. When $g$ is close to a fixed simple metric $g_{0}$ with
injective X-ray transform on 2-tensors, Montalto [Mon14] extended the previous result to the recovery of the pair $(g, q)$ (and a magnetic potential term in addition) in a Hölder stable way. For non-simple metrics, we are aware of only two results showing strong stability: the first by Bao-Zhang [BZ14] who prove for a non-trapping metric $g=c(x)^{2} g_{\text {eucl }}$, conformal to the Euclidean metric, and satisfying certain assumptions on their conjugate points, that if $\left\|\Lambda_{c^{2} g_{\text {eucl }}}^{W}-\Lambda_{\tilde{c}^{2}}^{W} g_{\text {eucl }}\right\|_{*}$ is small enough then the conformal factors agree $c=\tilde{c}$; the second by Stefanov-Uhlmann-Vasy [SUV16] is of the same kind but under the assumption that $g_{\text {eucl }}$ is replaced by a metric $g_{0}$ so that the manifold $\left(M, g_{0}\right)$ can be foliated by strictly convex hypersurfaces. In all these results, the time interval $I=(0, T)$ can be taken with $T>0$ finite but large enough for the wave case (depending on the diameter of the domain), while for the Schrödinger case it can be taken finite and small using infinite speed of propagation.

All these mentionned results where Hölder stability results hold assume no trapped geodesic rays for the Riemannian manifold $(M, g)$, i.e. geodesics staying inside the interior $M^{\circ}$ of $M$ for infinite time. This means that some regions of the phase space are not accessible from the boundary by geodesic rays, and some waves can possibly stay (microlocally) trapped for a long time near these trapped rays, so that a part of the information can not be read off microlocally from the DN map at the boundary. It is thus an open question to understand how stable is the recovery of the coefficients of the wave equation or the Schrödinger equation when the metric is not simple. The difficulty to obtain such Hölder estimates lies in the fact that one usually reduces the inverse problem for the DN map to some X-ray tomography problem using wave packets or WKB solutions of the wave/Schrödinger equations that concentrate near single geodesics going from a point of the boundary to another point. It is likely that under general assumptions, no Hölder stability estimates hold but log stability estimates do; we mention the recent work of Koch-Rüland-Salo [KRS] about this question. Our purpose in this work is to address this stability question in a family of cases where the trapped set is sufficiently filamentary, the typical example being that of a non-simply connected Riemannian metric with negative curvature and strictly convex boundary.

Our main geometric assumptions are the hyperbolicity of the trapped set for the geodesic flow and the absence of conjugate points. We notice that these two assumptions are satisfied if $(M, g)$ is negatively curved. Let us recall the precise definition of hyperbolic trapped set. Let $\varphi_{t}: S M \rightarrow S M$ be the geodesic flow for $t \in \mathbb{R}$, where $S M=\left\{(x, v) \in T M:|v|_{g(x)}=\right.$ $1\}$ is the unit tangent bundle. We call, for every $z=(x, v) \in S M$, the escape time of $S M$ in positive $(+)$ and negative $(-)$ times,

The incoming ( - ) and outgoing $(+)$ tails in $S M$ are defined by

and the trapped set for the flow on $S M$ is the set $K:=\Gamma_{+} \cap \Gamma_{-}$. If $\partial M$ is strictly convex for $(M, g)$ (i.e. the second fundamental form of $\partial M$ is positive), the trapped set $K$ is a
compact flow-invariant subset of the interior $S M^{\circ}$ of $S M$. We say that the trapped set $K \subset S M$ is a hyperbolic set if there exists $C>0$ and $\nu>0$ so that, there is a continuous flow-invariant splitting over $K$

where $E_{s}$ and $E_{u}$ are vector subspaces satisfying for all $z \in K$

& \left\|d \varphi_{t}(z) w\right\| \leq C e^{-\nu|t|}\|w\|, \quad \forall t<0, \quad \forall w \in E_{u}(z), \tag{1.5}

with respect to any fixed metric on $S M$. The notion of conjugate points can be defined as follows. If $\pi_{0}: S M \rightarrow M$ is the projection and $\mathcal{V}:=\operatorname{ker} d \pi_{0} \subset T(S M)$ is the vertical bundle of the fibration, we say that there is no conjugate point if $d \varphi_{t}(\mathcal{V}) \cap \mathcal{V}=\{0\}$ for all $t \neq 0$, where $\{0\}$ denotes the 0 -section of $T(S M)$.
1.1. The case of the Schrödinger equation. The DN map associated with (1.1) is continuous [BDSF10, Thm. 1] as an operator from $H^{1}((0, T) \times \partial M)$ to $L^{2}((0, T) \times \partial M)$. Our first goal is to a obtain a Hölder stability estimate of the form

\left\|q_{1}-q_{2}\right\|_{L^{2}(M)} \leq C\left\|\Lambda_{g, q_{1}}-\Lambda_{g, q_{2}}\right\|_{*}^{\beta}, \tag{1.6}
\end{equation*}
$$

for some $\beta>0$ for the Schrödinger equation on a bounded time interval $(0, T)$. Here we assume that $q_{1}$ and $q_{2}$ belong to the family of admissible electrical potentials

\mathcal{Q}\left(N_{0}\right):=\left\{q \in W^{1, \infty}(M) \mid\|q\|_{W^{1, \infty}(M)} \leq N_{0}\right\} \tag{1.7}
\end{equation*}

with $N_{0}>0$ fixed, and that $q_{1}$ and $q_{2}$ coincide on the boundary $\partial M$. It is known that the estimate (1.6) holds on simple manifolds [BDSF10] with $\beta=1 / 8$. Our aim is to extend this result to the case of hyperbolic trapped set of the geodesic flow and no conjugate points.

Our first result gives the stable determination of the potential $q$ from the DN map.
Theorem 1. Let $(M, g)$ be a compact Riemannian manifold of dimension $d \geq 2$ with strictly convex boundary. Let $T, N_{0}>0$ fixed. Assume that the trapped set $K$ is hyperbolic and there are no conjugate points. Then, there exists a constant $C=C\left(M, g, T, N_{0}\right)>0$ such that, for any $q_{1}, q_{2} \in \mathcal{Q}\left(N_{0}\right)$ with $q_{1}=q_{2}$ on $\partial M$,

\begin{equation*}
\left\|q_{1}-q_{2}\right\|_{L^{2}(M)} \leq C\left\|\Lambda_{g, q_{1}}^{S}-\Lambda_{g, q_{2}}^{S}\right\|_{*}^{\beta}, \tag{1.8}
\end{equation*}
$$

for some $\beta>0$ depending only on $(M, g)$.
We notice from our proof that the constant $\beta$ can be expressed in terms of the volume entropy and dynamical quantities on the geodesic flow of $(M, g)$, more precisely the pressure of the unstable jacobian of the geodesic flow on the trapped set and the maximal expansion rate of the flow.

In order to obtain a stability estimate for the conformal factor of the metric, we consider the family of admissible conformal factors given by

\mathscr{C}\left(N_{0}, k, \epsilon\right):=\left\{c \in \mathcal{C}^{\infty}(M) \mid c>0 \text { in } \bar{M}, \quad\|1-c\|_{\mathcal{C}^{0}(M)} \leq \epsilon, \quad\|c\|_{\mathcal{C}^{k}(M)} \leq N_{0}\right\} . \tag{1.9}
\end{equation*}

Our second result gives the stable determination of the conformal factor.

Theorem 2. Let $(M, g)$ be a compact Riemannian manifold of dimension $d \geq 2$ with strictly convex boundary, hyperbolic trapped set $K$ and no conjugate points. Let $T, N_{0}>0$ be fixed. Then, there exist $k \geq 1$ depending only on $\operatorname{dim}(M), \epsilon>0$ depending on $\left(M, g, N_{0}\right)$ and a constant $C=C\left(M, g, T, N_{0}\right)>0$ such that, for any $c \in \mathscr{C}\left(N_{0}, k, \epsilon\right)$ with $c=1$ near $\partial M$,

\|1-c\|_{L^{2}(M)} \leq C\left\|\Lambda_{g, 0}^{S}-\Lambda_{c g, 0}^{S}\right\|_{*}^{\beta}, \tag{1.10}
\end{equation*}
$$

for some $\beta>0$ depending only on $(M, g)$.
As far as we know, these two results are the first Hölder stability results for the Schrödinger equation when the principal symbol of the operator has trapped bicharacteristic rays.
1.2. The case of the wave equation. The DN map associated with (1.2) with $I=(0, T)$ is bounded as an operator from $H_{0}^{1}((0, T) \times \partial M)$ to $L^{2}((0, T) \times \partial M)$ (see [LM72a, LM72b]). In the case $I=(0, \infty)$, it is necessary to introduce a exponential weight in the time as $T \rightarrow+\infty$ to obtain boundedness of the DN map. For our result, due to the fact that some geodesics have infinite length (those that are trapped), we need to consider the wave equation for all positive time.

For $k, \ell \in \mathbb{N}_{0}$, let $\nu>0$. We define the weighted Sobolev space $e^{\nu t} H^{k}\left(I ; H^{\ell}(M)\right)$ as the space of functions $f \in H^{k}\left(I ; H^{\ell}(M)\right)$, with finite norm

\|f\|_{e^{\nu t} H^{k}\left(I ; H^{\ell}(M)\right)}:=\sum_{j=0}^{k}\left(\int_{0}^{\infty} e^{-2 \nu t}\left\|\partial_{t}^{j} f(t, \cdot)\right\|_{H^{\ell}(M)}^{2} d t\right)^{\frac{1}{2}}
$$

In particular, we denote $e^{\nu t} H^{k}(I \times M):=e^{\nu t} H^{k}\left(I ; H^{k}(M)\right)$. Similarly we define the weighted Sobolev spaces $e^{\nu t} H^{k}\left(I ; H^{\ell}(\partial M)\right)$ on the boundary $\partial M$, and denote $e^{\nu t} H^{k}(I \times$ $\partial M):=e^{\nu t} H^{k}\left(I ; H^{k}(\partial M)\right)$.

The DN map associated with (1.2) is continuous from $e^{\nu t} H_{0}^{1}(I \times \partial M)$ to $e^{\nu t} L^{2}(I \times \partial M)$ for every $\nu \geq \nu_{0}$ : this follows from [CP82, Thm 6.10 and Thm. 7.1] and can be checked that $\nu_{0} \geq 0$ depends only on $\|q\|_{L^{\infty}}$, as we show in Lemma 4.3 and the comment that follows. We denote:

\left\|\Lambda_{g, q}^{W}\right\|_{*, \nu}:=\left\|\Lambda_{g, q}^{W}\right\|_{\mathcal{L}\left(e^{\nu t} H_{0}^{1}(I \times \partial M) ; e^{\nu t} L^{2}(I \times \partial M)\right)} . \tag{1.11}
\end{equation*}
$$

We next state our main result on the stable determination of the electric potential from the DN map.

Theorem 3. Let $(M, g)$ be a compact Riemannian manifold of dimension $n \geq 2$ with strictly convex boundary, hyperbolic trapped set and no conjugate points. Let $N_{0}>0$ be fixed. There is $\nu_{0}$ depending only on $N_{0}$ such that for every $\nu>\nu_{0}$, there exists $C>0$ such that, for any $q_{1}, q_{2} \in \mathcal{Q}\left(N_{0}\right)$ with $q_{1}=q_{2}$ on $\partial M$,

\begin{equation*}
\left\|q_{1}-q_{2}\right\|_{L^{2}(M)} \leq C\left\|\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}\right\|_{*, \nu}^{\beta} \tag{1.12}
\end{equation*}
$$

for some $\beta>0$ depending only on $(M, g)$ and $\nu$.
We finally state our main result on the stable recovery of the conformal factor.

Theorem 4. Let $(M, g)$ be a compact Riemannian manifold of dimension $d \geq 2$ with strictly convex boundary, hyperbolic trapped set and no conjugate points. Let $N_{0}>0$ be fixed. Then, there exist $\nu_{0}>0, k \geq 1$ depending only on $d$, and $\epsilon>0$ depending on $\left(M, g, N_{0}\right)$, such that for all $\nu>\nu_{0}$, there is $C$ depending on $\left(M, g, N_{0}, \nu\right)$ so that, for any $c \in \mathscr{C}\left(N_{0}, k, \epsilon\right)$ with $c=1$ near $\partial M$,

\|1-c\|_{L^{2}(M)} \leq C\left\|\Lambda_{g, 0}^{W}-\Lambda_{c g, 0}^{W}\right\|_{*, \nu}^{\beta}, \tag{1.13}
\end{equation*}
$$

for some $\beta>0$ depending only on $(M, g)$ and $\nu$.
1.3. Method of proof. To obtain the stability results, we use the general method of [SU05, BDSF10, BDSF11] of reducing the problem to some estimate on X-ray transform of $q_{1}-q_{2}$. We however need to perform several important modifications due to trapping. Ultimately we rely on some results of the second author [Gui17] on the injectivity and stability estimates of the X-ray transform for the class of manifold under study, but it is not a simple reduction to that problem, as we now explain. We first follow the well known route of constructing WKB solutions $u$ of the Schrödinger/wave equation concentrating on each geodesic $\gamma$ of length less or equal to $T_{0}>0$ with endpoints on the boundary. We use the universal covering of $M$ to construct $u$ since $M$ is not assumed simply connected. We can then bound the integral of $q_{1}-q_{2}$ along these geodesics by a constant times $\left\|\Lambda_{g, q_{1}}^{S / W}-\Lambda_{g, q_{2}}^{S / W}\right\|_{*, \nu}$. The non-simple metric assumption complicates that step compared to the simple metric case, due to the fact that geodesics self intersect. In the Schrödinger equation, using the infinite speed of propagation, we can take $T_{0}$ as large as we want by taking WKB solutions with frequencies $\lambda \gg T_{0} / T$, while for the wave we need to know the DN map on time $[0, \infty)$ to be able to let $T_{0}$ be arbitrarily large. We then use some estimate on the volume of the set of geodesics staying in $M^{\circ}$ for time $\leq T_{0}$ : this volume decays exponentially in $T_{0}$. We deduce that the transform $I_{0}^{*} I_{0}\left(q_{1}-q_{2}\right)$ of $q:=q_{1}-q_{2}$ can be controled in $L^{2}$ by

for some $C_{0}>0, C>0, \epsilon>0$ independent of $T_{0}$. Here $I_{0}: L^{\infty}(M) \rightarrow L_{\mathrm{loc}}^{2}\left(\partial S M \backslash \Gamma_{-}\right)$is the X-ray transform defined by

$$
I_{0} q(z):=\int_{0}^{\tau_{+}(z)} q\left(\pi_{0}\left(\varphi_{t}(z)\right)\right) d t
$$

that extends continuously to $L^{\infty}(M) \rightarrow L^{2}(\partial S M)$ by [Gui17]; here $\pi_{0}: S M \rightarrow M$ is the projection on the base. For simple metrics, it is well-known (see [PU05]) that the normal operator $\Pi_{0}:=I_{0}^{*} I_{0}$ is an elliptic pseudo-differential operator of order -1 thus satisfying $\left\|\Pi_{0} f\right\|_{H^{s}} \geq C_{s}\|f\|_{H^{s-1}}$ for all $s \geq 0$ and $C_{s}>0$ depending on $s$. In [Gui17], using anisotropic Sobolev spaces an Fredholm theory for vector fields generating Axiom A flows [DG16], it is shown that the same properties hold on $\Pi_{0}$ for metrics with no conjugate points and hyperbolic trapping. We can then bound the norm of $\left\|q_{1}-q_{2}\right\|$ by a constant times some norm $\left\|\Pi_{0}\left(q_{1}-q_{2}\right)\right\|$, which in turn is bounded by (1.14). Taking $T_{0}$ large enough (depending on $\left\|\Lambda_{g, q_{1}}^{S / W}-\Lambda_{g, q_{2}}^{S / W}\right\|_{*, \nu}$ ) and using interpolation estimates, we can then show that
the second term of (1.14) can be absorbed into the first term, and we obtain the desired stability bound. The case of the recovery of the conformal factor is using a similar type of arguments.

Notations: In what follows, we shall use the notational convention of writing $C>0$ for constants appearing in upper/lower bounds, where this constant may change from line to line, and we shall indicate its dependence on the parameters of our problem when this is important.

## 2. GEOMETRIC SETTING AND DYNAMICAL PROPERTIES OF THE GEODESIC FLOW

In this section we recall, for $(M, g)$ a Riemannan manifold with strictly convex boundary, some notions about the geometry of the unit tangent bundle $S M:=\{(x, v) \in$ $\left.T M \mid g_{x}(v, v)=1\right\}$ and the dynamics of the geodesic flow on $S M$. Let

$$
\pi_{0}: S M \rightarrow M, \quad \pi_{0}(x, v)=x
$$

be the natural projection on the base. We will denote by $X$ the geodesic vector field on $S M$ defined by $X f(x, v)=\left.\partial_{t} f\left(\gamma_{(x, v)}(t), \dot{\gamma}_{(x, v)}(t)\right)\right|_{t=0}$ where $\gamma_{(x, v)}(t)$ is the unit speed geodesic with initial condition $\left(\gamma_{(x, v)}(0), \dot{\gamma}_{(x, v)}(0)\right)=(x, v)$. We will denote by $\varphi_{t}(x, v)=$ $\left(\gamma_{(x, v)}(t), \dot{\gamma}_{(x, v)}(t)\right)$ the geodesic flow, which in turn is the flow of the vector field $X$.

The incoming ( - ) and outgoing ( + ) boundaries of the unit tangent bundle of $M$ are defined by

$$
\partial_{ \pm} S M:=\left\{(x, v) \in S M \mid x \in \partial M, \mp g_{x}(v, \mathrm{n})>0\right\}
$$

where n is the inward pointing unit normal vector field to $\partial M$. For any $(x, v) \in S M$, define the forward and backward escaping time

$$
\begin{aligned}
& \tau_{+}(x, v)=\sup \left\{t \geq 0 \mid \varphi_{t}(x, v) \in \partial S M \text { or } \forall s \in(0, t), \varphi_{s}(x, v) \in S M^{\circ}\right\} \in[0,+\infty], \\
& \tau_{-}(x, v):=-\tau_{+}(x,-v) \in[-\infty, 0]
\end{aligned}
$$

which satisfies $X \tau_{+}=-1$ in $S M$ with $\left.\tau_{+}\right|_{\partial_{+} S M}=0$. For $(x, v) \in \partial_{-} S M$, the geodesic $\gamma_{(x, v)}$ with initial point $x$ and tangent vector $v$ either has infinite length (i.e. $\tau_{+}(x, v)=+\infty$ ) or it intersects $\partial M$ at a boundary point $x^{\prime} \in \partial M$ with tangent vector $v^{\prime}$ with $\left(x^{\prime}, v^{\prime}\right) \in \partial_{+} S M$. The incoming $(-)$ and outgoing $(+)$ tails in $S M$ are defined by

$$
\Gamma_{\mp}=\left\{z \in S M \mid \tau_{ \pm}(z)= \pm \infty\right\}
$$

and the trapped set for the flow on $S M$ is the set

$$
K:=\Gamma_{+} \cap \Gamma_{-}
$$

It is a compact subset of $S M^{\circ}$ that is flow invariant ([Gui17]). We define the subset $\mathcal{T}_{+}(t) \subset S M$ given by the points $(x, v) \in S M$ for which the orbit of the geodesic flow issued from $(x, v)$ remains in $S M$ after time $t$ :

$$
\mathcal{T}_{+}(t):=\left\{(x, v) \in S M \mid \tau_{+}(x, v) \geq t\right\}
$$

We define the non-escaping mass function $V(t)$ as

$$
V(t):=\operatorname{Vol}\left(\mathcal{T}_{+}(t)\right)
$$

where Vol is the volume with respect to the Liouville measure $\mu$ on $S M$. Let us also denote

$$
\begin{equation*}
\partial \mathcal{T}_{+}(t):=\mathcal{T}_{+}(t) \cap \partial_{-} S M \tag{2.1}
\end{equation*}
$$

The escape rate $Q \leq 0$ measures the exponential rate of decay of $V(t)$. It is given by:

$$
\begin{equation*}
Q:=\limsup _{t \rightarrow+\infty} \frac{1}{t} \log V(t) \tag{2.2}
\end{equation*}
$$

By [Gui17, Prop. 2.4], if the trapped set $K$ is hyperbolic, then $Q=\operatorname{Pr}\left(-J_{u}\right)$ is the topological pressure of (minus) the unstable Jacobian $\left.\partial_{t} \operatorname{det}\left(\left.d \varphi_{t}\right|_{E_{u}}\right)\right|_{t=0}$ of the geodesic flow on the trapped set $K$, and it satisfies

$$
Q=\operatorname{Pr}\left(J_{u}\right)<0
$$

Let $d \mu_{\mathrm{n}}$ be the measure on $\partial S M$ defined by

$$
d \mu_{\mathrm{n}}(x, v):=\left|g_{x}(v, \mathrm{n})\right| \iota^{*}|d \mu(x, v)|
$$

where $|d \mu|$ is the Liouville density, and $\iota: \partial S M \rightarrow S M$ is the inclusion map. When $\operatorname{Vol}\left(\Gamma_{-} \cup \Gamma_{+}\right)=0$, then $\operatorname{Vol}_{\partial S M}\left(\Gamma_{ \pm} \cap \partial_{ \pm} S M\right)=0$ and one can use Santalo's formula ([Gui17, Section 2.5]) to integrate functions in $S M$ : for all $f \in L^{1}(S M)$ :

$$
\begin{equation*}
\int_{S M} f d \mu=\int_{\partial_{-} S M \backslash \Gamma_{-}} \int_{0}^{\tau_{+}(x, v)} f \circ \varphi_{t}(x, v) d t d \mu_{\mathrm{n}}(x, v) . \tag{2.3}
\end{equation*}
$$

It is convenient to view $(M, g)$ as a strictly convex region of a larger smooth manifold $\left(M_{e}, g_{e}\right)$ with strictly convex boundary so that each geodesic in $M_{e} \backslash M$ has finite length with endpoints on $\partial M_{e} \cup \partial M$. The existence of such extension is proved in [Guil7, Sect. 2.1 and Lemma 2.3]. Moreover, if $(M, g)$ has hyperbolic trapped set and no conjugate points, one can choose $\left(M_{e}, g_{e}\right)$ with the same properties as $(M, g)$, as is shown in [Guil7, Lemma 2.3]. The vector field $X$ and the flow $\varphi_{t}$ are extended in $S M_{e}$ and we define the function $\tau_{ \pm}^{e}$ on $S M_{e}$ just as we did for $\tau_{+}$on $S M$. The trapped set of the flow in $S M_{e}$ is still $K \subset S M^{\circ}$, the incoming tail $\Gamma_{ \pm}^{e}$ on $S M_{e}$ is $\Gamma_{ \pm}^{e}=\cup_{t \geq 0} \varphi_{ \pm t}\left(\Gamma_{ \pm}\right) \cap S M_{e}$ and $\Gamma_{ \pm}^{e} \cap S M=\Gamma_{ \pm}$.

## 3. The $X$-ray transform

In this section we recall from [Gui17] the main properties of the $X$-ray transform acting on functions in our geometric setting. Let $(M, g)$ be a smooth compact Riemannian manifold with strictly convex boundary and $M_{e}$ a small extension with the same property.

The $X$-ray transform $I$ is defined as the map:

$$
I: \mathcal{C}_{c}^{\infty}\left(S M \backslash\left(\Gamma_{-} \cup \Gamma_{+}\right)\right) \rightarrow \mathcal{C}_{c}^{\infty}\left(\partial_{-} S M \backslash \Gamma_{-}\right), \quad I f(x, v):=\int_{0}^{\tau_{+}(x, v)} f \circ \varphi_{t}(x, v) d t
$$

The $X$-ray transform can be extended to more general spaces. If $\operatorname{Vol}(K)=0$, then Santalo's formula implies that the operator $I$ extends as a bounded operator

$$
I: L^{1}(S M) \rightarrow L^{1}\left(\partial_{-} S M ; d \mu_{\mathrm{n}}\right)
$$

When moreover the escape rate $Q$ of (2.2) satisfies $Q<0$ then, by [Gui17, Lemma 5.1], one has that

$$
\begin{equation*}
\forall p>2, \quad I: L^{p}(S M) \rightarrow L^{2}\left(\partial_{-} S M, d \mu_{\mathrm{n}}\right) \tag{3.1}
\end{equation*}
$$

For our purposes to extend the results of [BDSF10], it is more convenient to deal with the $X$-ray transform acting on functions in $\mathcal{C}^{\infty}(M)$. The projection $\pi_{0}: S M_{e} \rightarrow M_{e}$ on the base induces a pullback map

$$
\pi_{0}^{*}: \mathcal{C}_{c}^{\infty}\left(M_{e}^{\circ}\right) \rightarrow \mathcal{C}^{\infty}\left(S M_{e}^{\circ}\right), \quad \pi_{0}^{*} f:=f \circ \pi_{0}
$$

and a pushforward map $\pi_{0 *}$ defined by duality:

$$
\pi_{0 *}: \mathcal{D}^{\prime}\left(S M_{e}^{\circ}\right) \rightarrow \mathcal{D}^{\prime}\left(M_{e}^{\circ}\right), \quad\left\langle\pi_{0 *} u, f\right\rangle:=\left\langle u, \pi_{0}^{*} f\right\rangle
$$

When acting on $L^{1}$ functions, the pushforward $\pi_{0 *}$ acts as

$$
\pi_{0 *} f(x):=\int_{S_{x} M} f(x, v) d \omega_{x}(v)
$$

where $d \omega_{x}$ is the measure on $S_{x} M$ induced by $g$. The pullback by $\pi_{0}$ gives a bounded operator $\pi_{0}^{*}: L^{p}(M) \rightarrow L^{p}(S M)$ for all $p \in(1, \infty)$. We define the $X$-ray transform on functions by

$$
I_{0}=I \pi_{0}^{*}
$$

If $Q<0$ then $I_{0}$ extends as a bounded operator

$$
\begin{equation*}
I_{0}:=I \pi_{0}^{*}: L^{p}(M) \rightarrow L^{2}\left(\partial_{-} S M, d \mu_{\mathrm{n}}\right) \tag{3.2}
\end{equation*}
$$

for any $p>2$. The adjoint $I_{0}^{*}: L^{2}\left(\partial_{-} S M, d \mu_{\mathrm{n}}\right) \rightarrow L^{p^{\prime}}(M)$ is bounded for $1 / p^{\prime}+1 / p=1$, and it is given precisely by $I_{0}^{*}=\pi_{0 *} I^{*}$. The operator $\Pi_{0}$ is defined as the bounded selfadjoint operator

$$
\Pi_{0}: I_{0}^{*} I_{0}=\pi_{0 *} I^{*} I \pi_{0}^{*}: L^{p}(M) \rightarrow L^{p^{\prime}}(M), \quad \frac{1}{p}+\frac{1}{p^{\prime}}=1, \quad p>2 .
$$

Similarly, we define the extended $X$-ray transform $I_{0}^{e}$ associated with $M_{e}$, and

$$
\begin{equation*}
\Pi_{0}^{e}=I_{0}^{e *} I_{0}^{e}: L^{p}(M) \rightarrow L^{p^{\prime}}(M), \quad \frac{1}{p}+\frac{1}{p^{\prime}}=1, \quad p>2 \tag{3.3}
\end{equation*}
$$

Lemma 3.1. [Gui17, Prop. 5.7] Assume that ( $M, g$ ) has strictly convex boundary, no conjugate points and hyperbolic trapped set and let $\left(M_{e}, g_{e}\right)$ be an extension with the same properties. The operator $\Pi_{0}$, resp. $\Pi_{0}^{e}$, is an injective elliptic pseudo-differential operator of order -1 in $M^{\circ}$, resp. $M_{e}^{\circ}$, with principal symbol $\sigma\left(\Pi_{0}^{e}\right)(x, \xi)=C_{d}|\xi|_{g}^{-1}$ for some constant
$C_{d}>0$ depending only on $d=\operatorname{dim} M$. For each $k \in \mathbb{Z}$ and each compact subset $\Omega \subset M_{e}^{\circ}$ with smooth boundary, there exists $C_{1}, C_{2}>0$ such that for all $f \in C_{c}^{\infty}(\Omega)$

$$
\begin{equation*}
C_{1}\|f\|_{H^{k}\left(M_{e}\right)} \leq\left\|\Pi_{0}^{e} f\right\|_{H^{k+1}\left(M_{e}\right)} \leq C_{2}\|f\|_{H^{k}\left(M_{e}\right)} \tag{3.4}
\end{equation*}
$$

Moreover, a direct calculation yields for $z \notin \Gamma_{+}^{e} \cup \Gamma_{-}^{e}$

$$
I^{e *}\left(I_{0}^{e} f\right)(z)=\int_{\tau_{-}^{e}(z)}^{\tau_{+}^{e}(z)} \pi_{0}^{*} f\left(\varphi_{t}(z)\right) d t, \quad I^{*}\left(I_{0} f\right)(z)=\int_{\tau_{-}(z)}^{\tau_{+}(z)} \pi_{0}^{*} f\left(\varphi_{t}(z)\right) d t
$$

and thus if $f \in L^{p}\left(M_{e}\right)$ satisfies supp $f \subset M$, we have $I^{e^{*}}\left(I_{0}^{e} f\right)=I^{*}\left(I_{0} f\right)$ on $S M \backslash\left(\Gamma_{+} \cup \Gamma_{-}\right)$. In particular this implies that

$$
\begin{equation*}
\left.\left(\Pi_{0}^{e} f\right)\right|_{M}=\Pi_{0} f \tag{3.5}
\end{equation*}
$$

Since pseudo-differential operators of order - $1 \operatorname{map} W_{\text {comp }}^{s, p}\left(M_{e}^{\circ}\right)$ continuously to $W_{\text {loc }}^{s+1, p}\left(M_{e}^{\circ}\right)$ for all $(s, p) \in \mathbb{R} \times(1, \infty)$ (see [Tay91, Thm. 0.11.A]), (3.5) implies that

$$
\begin{equation*}
f \in W_{0}^{s, p}(M) \Longrightarrow \Pi_{0} f \in W^{s+1, p}(M), \quad f \in W_{0}^{s, p}\left(M_{e}\right) \Longrightarrow \Pi_{0}^{e} f \in W^{s+1, p}\left(M_{e}\right) \tag{3.6}
\end{equation*}
$$

where $W^{s, p}(M)$ denotes the Sobolev space (with $s$ derivatives in $L^{p}$ ) on the manifold with boundary $M, W_{0}^{s, p}(M)$ is the closure of $C_{c}^{\infty}\left(M^{\circ}\right)$ for the $W^{s, p}(M)$ topology, and similarly on $M_{e}$.

## 4. Geometrical optics solutions

We will assume along this section that $(M, g)$ is a smooth compact Riemannian manifold with boundary such that

- The boundary $\partial M$ is strictly convex,
- The metric $g$ has no pairs of conjugate points,
- The trapped set $K$ is hyperbolic.

We shall take $\left(M_{e}, g_{e}\right)$ an extension of $(M, g)$ with the same properties and for notational simplicity we will write $g$ instead of $g_{e}$ for the extended metric on $M_{e}$.
4.1. Geometrical optics for the Schrödinger equation. In this section we generalize the geometrical optics solutions given in [BDSF10, Sect. 4] for simple manifolds to our geometric setting. Since the map $\exp _{x}^{-1}(M) \rightarrow M$, with $x \in M$, is no longer a diffeomorphism, but the exponential map behaves well on the universal cover of $M$, we then make the construction in the universal cover of $M$, periodize it with respect to the fundamental group $\pi_{1}(M)$, and then project it down to $M$.

We first recall the following:
Lemma 4.1. [BDSF10, Lemma 3.2 and eq (3.5)] Let $T>0$ and $q \in L^{\infty}(M)$. If $F \in$ $W^{1,1}\left([0, T] ; L^{2}(M)\right)$ such that $F(0, \cdot) \equiv 0$, then the unique solution $v$ to

$$
\begin{cases}\left(i \partial_{t}-\Delta_{g}+q(x)\right) v(t, x)=F(t, x) & \text { in }(0, T) \times M \\ v(0, x)=0 & \text { in } M \\ v(t, x)=0 & \text { on }(0, T) \times \partial M\end{cases}
$$

satisfies

$$
v \in \mathcal{C}^{1}\left([0, T] ; L^{2}(M)\right) \cap \mathcal{C}\left([0, T] ; H^{2}(M) \cap H_{0}^{1}(M)\right)
$$

In addition, there is a $C>0$ depending on $(M, g), T$ and $\|q\|_{L^{\infty}}$ such that for any $\eta>0$ small and $t \in[0, T]$

$$
\begin{gather*}
\|v(t, \cdot)\|_{L^{2}(M)} \leq C \int_{0}^{T}\|F(s, \cdot)\|_{L^{2}(M)} d s  \tag{4.1}\\
\|v(t, \cdot)\|_{H_{0}^{1}(M)} \leq C\left(\eta\left\|\partial_{t} F\right\|_{L^{1}\left([0, T] ; L^{2}(M)\right)}+\eta^{-1}\|F\|_{L^{1}\left([0, T] ; L^{2}(M)\right)}\right) \tag{4.2}
\end{gather*}
$$

Let us consider extensions $M \Subset M_{e} \Subset M_{e e}$ of the manifold $M$ and extend the metric $g$ smoothly in a way that $\left(M_{e}, g_{e}\right)$ has the same properties as $(M, g)$. The potentials $q_{1}, q_{2}$ may also be extended to $M_{e e}$ and their $W^{1, \infty}(M)$ norms may be bounded by $N_{0}$. Since $q_{1}$ and $q_{2}$ concide on the boundary, their extension outside $M$ can be taken so that $q_{1}=q_{2}$ in $M_{e e} \backslash M$.

We first recall the construction, following [BDSF10, Sect. 4], of a geometric optics solution for simple manifolds and we will explain how to extend it to our setting. If $(M, g)$ is a simple manifold, a geometric optics solution $u \in \mathcal{C}^{1}\left([0, T] ; L^{2}(M)\right) \cap \mathcal{C}\left([0, T] ; H^{2}(M)\right)$ for the Schrödinger equation

$$
\begin{align*}
\left(i \partial_{t}-\Delta_{g}+q(x)\right) u & =0, \quad \text { in } \quad(0, T) \times M,  \tag{4.3}\\
u(0, x) & =0,
\end{align*}
$$

can be constructed in terms of a function $\psi \in \mathcal{C}^{2}(M)$ satisfying the eikonal equation

$$
\left|\nabla^{g} \psi(x)\right|_{g}=1, \quad \forall x \in M,
$$

and a function $a \in H^{1}\left(\mathbb{R} ; H^{2}(M)\right)$ solving the transport equation

$$
\begin{align*}
& \frac{\partial a}{\partial t}+d a\left(\nabla^{g} \psi\right)-\frac{1}{2}\left(\Delta_{g} \psi_{y}\right) a=0, \quad \forall t \in \mathbb{R}, \quad x \in M  \tag{4.4}\\
& \text { with } a(t, x)=0, \quad \forall x \in M, \quad \text { and } t \leq 0, \quad \text { or } t \geq T_{0}
\end{align*}
$$

for some $T_{0}$ sufficiently large (which in the simple case is taken to satisfy $T_{0}>1+\operatorname{Diam}\left(M_{e}\right)$ where $\operatorname{Diam}\left(M_{e}\right)$ is the $g$-diameter of $M_{e}$ ). More precisely if $\partial M_{e}$ is chosen close enough to $\partial M$ so that $\left(M_{e}, g\right)$ is a simple manifold, one can define, for any fixed $y \in \partial M_{e}$,

$$
\psi(x)=\psi_{y}(x):=d_{g}(y, x), \quad x \in M_{e}
$$

Using geodesic polar coordinates we can write each $x \in M_{e}$ as

$$
x=\exp _{y}(r(x) v(x)), \quad r(x)=d_{g}(y, x), \quad v(x) \in S_{y} M_{e}
$$

where $\exp _{y}: T M_{e} \rightarrow M_{e}$ denotes the exponential map at $y$ for the metric $g$. One defines a solution to the transport equation $a \in H^{1}\left(\mathbb{R} ; H^{2}(M)\right)$ in polar coordinates as

$$
a(t, x):=\alpha^{-1 / 4}(r(x), v(x)) \phi(t-r(x)) b(y, v(x))
$$

where $\alpha=\alpha(r, v)=\left|\operatorname{det}\left(g_{i j}(r, v)\right)\right|$ denotes the square of the volume element in geodesic polar coordinates, $\phi \in \mathcal{C}_{c}^{\infty}(\mathbb{R})$ satisfies $\operatorname{supp} \phi \subset\left(0, \varepsilon_{0}\right)$ for $\varepsilon_{0}>0$ small, and $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ is a fixed initial data.

A geometrical optics solution $u \in \mathcal{C}^{1}\left([0, T] ; L^{2}(M)\right) \cap \mathcal{C}\left([0, T] ; H^{2}(M)\right)$ for (4.3) is then defined by $u(t, x)=G_{\lambda}(t, x)+v_{\lambda}(t, x)$, where

$$
G_{\lambda}(t, x):=a(2 \lambda t, x) e^{i \lambda\left(\psi_{y}(x)-\lambda t\right)}
$$

and the remainder $v_{\lambda}$ satisfies ([BDSF10, Lemma 4.1]):

$$
\begin{aligned}
& v_{\lambda}(t, x)=0, \quad \forall(t, x) \in(0, T) \times \partial M \\
& v_{\lambda}(0, x)=0 .
\end{aligned}
$$

Moreover, there exists $C>0$ such that, for all $\lambda \geq T_{0} / 2 T$,

$$
\left\|v_{\lambda}(t, \cdot)\right\|_{H^{k}(M)} \leq C \lambda^{k-1}\|a\|_{H^{1}\left(\left[0, T_{0}\right] ; H^{2}(M)\right)}, \quad k=0,1 .
$$

The constant $C$ depends only on $T$ and $(M, g)$. One can also construct a geometrical optics solution $u(t, x)$ if the initial condition $u(0, x)=0$ is replaced by the final condition $u(T, x)=0$ provided $\lambda \geq T_{0} / 2 T$; in this case $v_{\lambda}$ satisfies $v_{\lambda}(T, x)=0$.

In our setting, that is, assuming that the trapped set $K$ is hyperbolic and that $g$ has no conjugate points, the construction is a bit more subtle, since the exponential map $\exp _{y}: \exp _{y}^{-1}(M) \rightarrow M$ is no longer a diffeomorphism. We work on the universal cover $\widetilde{M}$ of $M$, which is a non-compact manifold with boundary (the boundary has infinitely many connected components), whose interior is diffeomorphic to a ball. One has

$$
M=\widetilde{M} / \pi_{1}(M)
$$

where the fundamental group $\pi_{1}(M)$ is identified with the group of deck transformations on $\widetilde{M}$, that is, the set of homeomorphisms $f: \widetilde{M} \rightarrow \widetilde{M}$ such that $\pi \circ f=\pi$, with the composition, where $\pi: \widetilde{M} \rightarrow M$ is the covering map. The metric $g$ lifts to a smooth metric $\tilde{g}$ on $\widetilde{M}$ satisfying $\gamma^{*} \tilde{g}=\tilde{g}$ for all $\gamma \in \pi_{1}(M)$. More generally, we denote by $\widetilde{\sim}$ the lifted objects to the universal cover. If $(M, g)$ is assumed to have no pair of conjugate points, $\widetilde{g}$ does not have pairs of conjugate points. Thus, for each $y \in \widetilde{M}$ the exponential map

$$
\widetilde{\exp }_{y}: U_{y} \subset T \widetilde{M} \rightarrow \widetilde{M}
$$

is a diffeomorphism for some simply connected set $U_{y}$. Similarly, we define the universal cover $\widetilde{M}_{e}$ of $M_{e}$, and note that $\pi_{1}(M)=\pi_{1}\left(M_{e}\right)$ so that each deck transformation $\gamma$ of $\widetilde{M}$ extends naturally as a deck transformation on $\widetilde{M}_{e}$. Let us fix $y \in \partial M_{e}$ and we lift this point to $\tilde{y} \in \partial \widetilde{M}_{e}$. We can choose a fundamental domain $\mathcal{F} \subset \widetilde{M}$, so that $M=\mathcal{F} / \pi_{1}(M)$ via identification of the points of the boundary of $\mathcal{F}$ by the action of the elements of $\pi_{1}(M)$. Note that $\mathcal{F}$ has two types of boundary components, the boundary components $\partial_{i} \mathcal{F}$ in the interior $\widetilde{M}{ }^{\circ}$ of $\widetilde{M}$ which are identified by elements of $\pi_{1}(M)$, and the boundary components $\mathcal{F} \cap \pi^{-1}(\partial M)$. Similarly, we choose a fundamental domain $\mathcal{F}_{e}$ for $\pi_{1}\left(M_{e}\right) \simeq \pi_{1}(M)$ in $\widetilde{M}_{e}$ extending $\mathcal{F}$ and denote by $\partial_{i} \mathcal{F}_{e}$ the interior boundary of $\mathcal{F}_{e}$. We can freely assume that $\tilde{y} \in \mathcal{F}_{e}$ does not belong to the closure of $\partial_{i} \mathcal{F}_{e}$. Recall the definition of the volume entropy of $M$

$$
\begin{equation*}
h(M, g):=\limsup _{R \rightarrow \infty} \frac{1}{R} \log \operatorname{Vol}_{g}\left(B_{g}(\tilde{y} ; R)\right) \tag{4.5}
\end{equation*}
$$

where $B_{g}(\tilde{y} ; R) \subset \widetilde{M}_{g}$ is the $\tilde{g}$-geodesic ball centered at $\tilde{y}$ of radius $R$. Since $M$ is compact, one has $h(M, g)<\infty$ (for instance by Bishop-Gromov comparison theorem) and $h(M, g)$ is not depending on the choice of $\tilde{y}$.

We define on $\widetilde{M}$ the solution to the "lifted" eikonal equation $\left|\nabla_{\tilde{g}} \psi_{\tilde{y}}\right|=1$ given by

$$
\psi_{\tilde{y}}(\tilde{x}):=d_{\tilde{g}}(\tilde{y}, \tilde{x}), \quad \tilde{x} \in \widetilde{M}
$$

where $d_{\tilde{g}}$ denotes the distance associated to the lifted metric $\tilde{g}$ on $\widetilde{M}$. Notice that $\psi_{\tilde{y}}$ is well defined and smooth outside $\tilde{x}=\tilde{y}$ since $\tilde{g}$ has no conjugate points (for any $\tilde{x} \in \widetilde{M}$ there is a unique geodesic joining $\tilde{y}$ with $\tilde{x}$ and realizing $\left.d_{\tilde{g}}(\tilde{y}, \tilde{x})\right)$. Let

$$
\partial_{-} S_{\widetilde{y}} \widetilde{M}_{e}:=\left\{v \in S_{\widetilde{y}} \widetilde{M}_{e} \mid\langle v, \nu(\widetilde{y})\rangle>0\right\} .
$$

Using geodesic polar coordinates on $\widetilde{M}$ we can write each $x \in \widetilde{M}_{e}$

$$
x=\widetilde{\exp }_{\tilde{y}}(r(x) v(x)), \quad r(x)=\psi_{\tilde{y}}(x), v(x) \in S_{\tilde{y}} \widetilde{M}_{e} .
$$

Fix $T_{0}>1+\operatorname{Diam}\left(M_{e}\right)$. For any given $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ with $\left.b\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$ (recall definition (2.1)), we denote by $\tilde{b}$ its lift to $\partial_{-} S F_{e}$. Let $\phi \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ with $\operatorname{supp} \phi \subset\left(0, \varepsilon_{0}\right), \varepsilon_{0}>0$ small, we define

$$
\begin{equation*}
a(t, x):=\alpha^{-1 / 4}(r(x), v(x)) \phi(t-r(x)) \tilde{b}(\tilde{y}, v(x)) \tag{4.6}
\end{equation*}
$$

where $\alpha(r, v)=\left|\operatorname{det}\left(g_{i j}(r, v)\right)\right|$ denotes the square of the volume element of $\widetilde{M}_{e}$ in geodesic polar coordinates. We introduce the norm $\|a\|_{*}$ on functions on $\left[0, T_{0}\right] \times \widetilde{M}$ given by

\|a\|_{*}:=\|a\|_{H^{1}\left(\left[0, T_{0}\right] ; H^{2}(\widetilde{M})\right)} .
$$

For any $\lambda>0$, we set

\end{equation*}
$$

where $\gamma(x)$ denotes the lift of the point $\pi(x) \in M_{e}$ to the fundamental domain $\gamma\left(F_{e}\right)$. Notice that, since $\operatorname{supp}(a(2 \lambda t, \cdot))$ is contained in a fixed compact set of $\widetilde{M}_{e}$ for $t \in[0, T]$, the sum in $\gamma \in \pi_{1}(M)$ is locally finite. Moreover, as $G_{\lambda}(t, \gamma x)=G_{\lambda}(t, x)$, the function $G_{\lambda}$ descends to $M_{e}$ (and will also be denoted $G_{\lambda}$ downstair), and satisfies $G_{\lambda} \in H^{1}\left([0, T] ; H^{2}\left(M_{e}\right)\right)$.

Lemma 4.2. Let $q \in L^{\infty}(M)$. For $T_{0}>0$ and $T>0$, the Schrödinger equation

has a solution of the form

with $G_{\lambda}$ given by (4.7), such that

$$

where $v_{\lambda}(t, x)$ satisfies, for $\lambda \geq \frac{T_{0}}{2 T}$,

& v_{\lambda}(t, x)=0, \quad \forall(t, x) \in(0, T) \times \partial M \\
& v_{\lambda}(0, x)=0, \quad x \in M
\end{aligned}
$$

Furthermore, for each $\epsilon>0$ there exists $C>0$ depending only on $\left(\epsilon, M, g,\|q\|_{L^{\infty}}, T\right)$ but not on $T_{0}, y$, such that, for any $\lambda \geq \frac{T_{0}}{2 T}$ the following estimate holds true:

where $h=h(M, g)$ denotes the volume entropy of $(M, g)$. The result remains valid after replacing the initial condition $u(0, \cdot)=0$ by the final condition $u(T, \cdot)=0$.

Proof. We prove the Lemma with initial condition $u(0, \cdot)=0$, the proof for $u(T, \cdot)=0$ being analogous. As in [BDSF10, Proof of Lemma 4.1], we consider for $x \in M_{e}$

where $\tilde{x} \in \widetilde{M}_{e}$ is a lift of $x$. Let $v_{\lambda}$ be the solution, given by Lemma 4.1, to the homogeneous boundary value problem

We shall show that $v_{\lambda}$ satisfies the estimate (4.8). A computation gives

-k(t, x)= & \sum_{\gamma \in \pi_{1}(M)} e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(\tilde{x}))-\lambda t\right)}\left(-\Delta_{\tilde{g}}+\tilde{q}(\gamma(\tilde{x}))\right) a(2 \lambda t, \gamma(\tilde{x})) \\
& +2 i \lambda \sum_{\gamma \in \pi_{1}(M)} e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(\tilde{x}))-\lambda t\right)}\left(\partial_{t} \tilde{a}+d a\left(\nabla^{\tilde{g}} \psi_{\tilde{y}}\right)-\frac{a}{2} \Delta_{\tilde{g}} \psi_{\tilde{y}}\right)(2 \lambda t, \gamma(\tilde{x})) \\
& +\lambda^{2} \sum_{\gamma \in \pi_{1}(M)} a(2 \lambda t, \gamma(\tilde{x})) e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(\tilde{x}))-\lambda t\right)}\left(1-\left|\nabla^{\tilde{g}} \psi_{\tilde{y}}\right|_{\tilde{g}}^{2}\right)
\end{aligned}
$$

Using that $a$ solves the transport equation, that $\psi_{\tilde{y}}$ solves the eikonal equation and that $\Delta_{\tilde{g}}$ commute with $\gamma^{*}$ (since $\gamma$ are isometries of $\tilde{g}$ ), we obtain

$$
\begin{aligned}
-k(t, x) & =\sum_{\gamma \in \pi_{1}(M)} e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(\tilde{x}))-\lambda t\right)}\left(-\Delta_{\tilde{g}} a+\tilde{q} a\right)(2 \lambda t, \gamma(\tilde{x})) \\
& =: \sum_{\gamma \in \pi_{1}(M)} e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(\tilde{x}))-\lambda t\right)} k_{0}(2 \lambda t, \gamma(\tilde{x})) .
\end{aligned}
$$

Notice that $k_{0} \in H_{0}^{1}\left([0, T] ; L^{2}(M)\right)$ for $\lambda \geq T_{0} / 2 T$ and $\left.k_{0}(s, \cdot)\right|_{\widetilde{M}}=0$ for $s>T_{0}$. Then, using Lemma 4.1 we get

v_{\lambda} \in \mathcal{C}^{1}\left([0, T] ; L^{2}(M)\right) \cap \mathcal{C}\left([0, T] ; H^{2}(M) \cap H_{0}^{1}(M)\right)
$$

Moreover, using (4.1), there exists $C>0$ depending on $(M, g), T>0$, and $\|q\|_{L^{\infty}}$ such that

$$
\begin{aligned}
\left\|v_{\lambda}(t, \cdot)\right\|_{L^{2}(M)} & \leq C \sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T}\left\|k_{0}(2 \lambda t, \cdot)\right\|_{L^{2}(\gamma(F))} d t \leq \frac{C}{\lambda} \sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T_{0}}\left\|k_{0}(s, \cdot)\right\|_{L^{2}(\gamma(\mathcal{F}))} d s \\
& \leq \frac{C\left(1+\|q\|_{L^{\infty}}\right) T_{0}^{1 / 2} N\left(T_{0}\right)}{\lambda}\|a\|_{*}
\end{aligned}
$$

where $N\left(T_{0}\right)$ denotes the number of fundamental domains which intersects the geodesic ball $B\left(\tilde{y}, T_{0}\right)$ of center $\tilde{y}$ and radius $T_{0}$ in $\tilde{M}$, that is:

$$
\begin{aligned}
N\left(T_{0}\right) & =\#\left\{\gamma \in \pi_{1}(M) \mid \exists x \in \mathcal{F}, d_{\tilde{g}}(\gamma(x), \tilde{y}) \leq T_{0}\right\} \\
& \leq \#\left\{\gamma \in \pi_{1}(M) \mid \max _{x \in \mathcal{F}} d_{\tilde{g}}(\gamma(x), \tilde{y}) \leq T_{0}+\operatorname{Diam}(M)\right\}
\end{aligned}
$$

Clearly, $N\left(T_{0}\right) \operatorname{Vol}(M) \leq \operatorname{Vol}\left(B\left(\widetilde{y}, T_{0}+\operatorname{Diam}(M)\right)\right)$, and therefore for each $\epsilon>0$, there is $C>0$ (depending on $\operatorname{Diam}(M)$ and $\operatorname{Vol}(M))$ such that for all $T_{0}>0$ large enough

$$
N\left(T_{0}\right) \leq C e^{(h+\epsilon) T_{0}}
$$

where $h=h(M, g)$ is the volume entropy of $(M, g)$ defined in (4.5). We notice that the constants $C>0$ above can be chosen independently of $y$ and that $h$ is in fact not depending on $y$.

Finally, by Lemma 4.1, there is $C>0$ (depending on $\left(M, g, T,\|q\|_{L^{\infty}}\right)$ ) such that for each $\eta>0$

& +C \eta^{-1} \sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T}\left\|k_{0}(2 \lambda t, \cdot)\right\|_{L^{2}(\gamma(\mathcal{F}))} d t .
\end{aligned}
$$

Choosing $\eta=\lambda^{-1}$, for each $\epsilon>0$ there is $C>0$ such that for all $\lambda \geq T_{0} / 2 T$

\begin{aligned}
\left\|\nabla^{g} v_{\lambda}(t, \cdot)\right\|_{L^{2}(M)} & \leq C \sum_{\gamma \in \pi_{1}(M)}\left(\int_{0}^{T_{0}}\left\|k_{0}(s, \cdot)\right\|_{L^{2}(\gamma(\mathcal{F}))} d s+\int_{0}^{T_{0}}\left\|\partial_{t} k_{0}(s, \cdot)\right\|_{L^{2}(\gamma(\mathcal{F}))} d s\right) \\
& \leq C e^{(h+\epsilon) T_{0}}\|a\|_{*} .
\end{aligned}
$$

4.2. Geometrical optics for the wave equation. In this section we give the construction of geometric optics solutions for the wave equation with hyperbolic trapped set. First we use the following

Lemma 4.3. Let $q \in L^{\infty}(M)$. There are constants $C>0$ depending only on $\left(M, g,\|q\|_{L^{\infty}}\right)$ and $\nu_{0} \geq 0$ depending only on $\|q\|_{L^{\infty}}$, such that for all $0<t \leq T$, and all $F \in L^{2}((0, T) \times$
$M)$, there is a unique solution $v$ to

\begin{cases}\left(\partial_{t}^{2}+\Delta_{g}+q(x)\right) v(t, x)=F(t, x) & \text { in }[0, T] \times M  \tag{4.9}\\ v(0, x)=0, \quad \partial_{t} v(0, x)=0 & \text { in } M \\ v(t, x)=0 & \text { on }[0, T] \times \partial M\end{cases}
$$

in $\mathcal{C}^{1}\left([0, T] ; L^{2}(M)\right) \cap \mathcal{C}^{0}\left([0, T] ; H_{0}^{1}(M)\right)$ satisfying for each $\nu \geq \nu_{0}$

$$
\begin{gather*}
\|v(t, \cdot)\|_{L^{2}(M)}^{2}+\left\|\partial_{t} v(t, \cdot)\right\|_{L^{2}(M)}^{2}+\left\|\nabla^{g} v(t, \cdot)\right\|_{L^{2}(M)}^{2} \leq C \int_{0}^{t} e^{\nu(t-s)}\|F(s, \cdot)\|_{L^{2}(M)}^{2} d s,  \tag{4.10}\\
\left\|e^{-\frac{\nu}{2} t} \partial_{\mathrm{n}} v\right\|_{L^{2}((0, T) \times \partial M)} \leq C\left\|e^{-\frac{\nu}{2} t} F\right\|_{L^{2}((0, T) \times M)}
\end{gather*}
$$

where $C$ depends only on $\|q\|_{L^{\infty}}$ and $\nu$.
There is $C>0$ as above such that for each $f \in H^{1}([0, T] \times \partial M)$ with $f(0, \cdot)=\partial_{t} f(0, \cdot)=$ 0 , there is a unique solution $u \in \mathcal{C}^{1}\left([0, T] ; L^{2}(M)\right) \cap \mathcal{C}^{0}\left([0, T] ; H_{0}^{1}(M)\right)$ such that

$$
\begin{cases}\left(\partial_{t}^{2}+\Delta_{g}+q(x)\right) u(t, x)=0 & \text { in }[0, T] \times M  \tag{4.11}\\ u(0, x)=0, \quad \partial_{t} u(0, x)=0 & \text { in } M \\ u(t, x)=f(t, x) & \text { on }[0, T] \times \partial M\end{cases}
$$

and u satisfies,

$$
\left\|e^{-\nu t / 2} \partial_{\mathrm{n}} u\right\|_{L^{2}([0, T] \times \partial M)} \leq C\left\|e^{-\nu t / 2} f\right\|_{H^{1}([0, T] \times \partial M)}
$$

As a consequence, the operator $\Lambda_{q}^{W}: e^{\nu t / 2} H_{0}^{1}\left(\mathbb{R}_{+} \times \partial M\right) \rightarrow e^{\nu t / 2} L^{2}\left(\mathbb{R}_{+} \times \partial M\right)$ is bounded with norm depending only on $(M, g),\|q\|_{L^{\infty}}$ and $\nu$.
Proof. The uniqueness and existence is done in [LM72a, Chapter 3, Section 8 and 9] and based on energy estimates. Here we want a uniform estimate in time involving the exponent $\nu_{0}$, in particular for what concerns its dependence in $q$. Let $v$ be a solution to (4.9), then, for any $\nu \geq 0, v_{\nu}(t, x)=e^{-\nu t / 2} v(t, x)$ satisfies the damped-wave equation

\begin{cases}\left(\partial_{t}^{2}+\Delta_{g}+\frac{\nu^{2}}{4}+q(x)+\nu \partial_{t}\right) v_{\nu}(t, x)=F_{\nu}(t, x) & \text { in }[0, T] \times M  \tag{4.12}\\ v_{\nu}(0, x)=0, \quad \partial_{t} v_{\nu}(0, x)=0 & \text { in } M \\ v_{\nu}(t, x)=0 & \text { on }[0, T] \times \partial M\end{cases}
$$

where $F_{\nu}(t, x)=e^{-\nu t / 2} F(t, x)$. Similarly, let $u$ be the solution to (4.11), then $u_{\nu}(t, x)=$ $e^{-\nu t / 2} u(t, x)$ solves the boundary-value problem:

where $f_{\nu}(t, x)=e^{-\nu / 2 t} f(t, x)$. First, multiply equation (4.12) by $\bar{v}_{\nu}$ and integrate in $[0, t] \times$ $M$ to get

& =-\int_{M} \partial_{t} v_{\nu} \bar{v}_{\nu} \mathrm{dv}_{g}-\nu \int_{0}^{t} \int_{M} \partial_{s} v_{\nu} \bar{v}_{\nu} \mathrm{dv}_{g} d s+\int_{0}^{t} \int_{M} F_{\nu} \bar{v}_{\nu} \mathrm{dv}_{g} d s
\end{aligned}
$$

Then:

& \int_{0}^{t} \int_{M}\left|\nabla^{g} v_{\nu}\right|^{2} \mathrm{dv}_{g} d s+\frac{\nu^{2}}{4} \int_{0}^{t} \int_{M}\left|v_{\nu}\right|^{2} \mathrm{dv}_{g} d s \\
& \leq \frac{1}{2} \int_{M}\left|\partial_{t} v_{\nu}(t)\right|^{2} \mathrm{dv}_{g}+\frac{1}{2} \int_{M}\left|v_{\nu}(t)\right|^{2} \mathrm{dv}_{g}+\frac{\nu}{2} \int_{0}^{t} \int_{M}\left(\left|\partial_{s} v_{\nu}\right|^{2}+\left|v_{\nu}\right|^{2}\right) \mathrm{dv}_{g} d s \\
& \quad+\left(\|q\|_{L^{\infty}}+\frac{1}{2}\right) \int_{0}^{t} \int_{M}\left|v_{\nu}\right|^{2} \mathrm{dv}_{g} d s+\frac{1}{2} \int_{0}^{t} \int_{M}\left|F_{\nu}\right|^{2} \mathrm{dv}_{g} d s
\end{aligned}
$$

and we get, for $C_{\nu}=\frac{\nu^{2}}{4}-\frac{\nu}{2}-\|q\|_{L^{\infty}}-\frac{1}{2}$,

$$
\begin{align*}
\int_{0}^{t}\left\|\nabla^{g} v_{\nu}(s)\right\|_{L^{2}(M)}^{2} d s+C_{\nu} \int_{0}^{t}\left\|v_{\nu}(s)\right\|^{2} d s \leq & \frac{1}{2}\left\|\partial_{t} v_{\nu}(t)\right\|_{L^{2}(M)}^{2}+\frac{1}{2}\left\|v_{\nu}(t)\right\|_{L^{2}(M)}^{2} \\
& +\frac{\nu}{2} \int_{0}^{t}\left\|\partial_{s} v_{\nu}\right\|_{L^{2}(M)}^{2}+\frac{1}{2} \int_{0}^{t}\left\|F_{\nu}(s)\right\|_{L^{2}(M)}^{2} d s \tag{4.14}

& \quad+\left(\|q\|_{L^{\infty}}-\nu\right) \int_{0}^{t}\left\|\partial_{s} v_{\nu}(s)\right\|_{L^{2}(M)}^{2} d s \\
& \leq \int_{0}^{t}\left\|F_{\nu}(s)\right\|_{L^{2}(M)}^{2} d s+\|q\|_{L^{\infty}} \int_{0}^{t}\left\|v_{\nu}(s)\right\|_{L^{2}(M)}^{2} d s+\left(1+\|q\|_{L^{\infty}}-\nu\right) \int_{0}^{t}\left\|\partial_{s} v_{\nu}(s)\right\|_{L^{2}(M)}^{2} d s .

Defining $\Phi_{v_{\nu}}(t):=\left\|\partial_{t} v_{\nu}(t)\right\|_{L^{2}}^{2}+\left\|v_{\nu}(t)\right\|_{L^{2}}^{2}+\left\|\nabla^{g} v_{\nu}(t)\right\|_{L^{2}}^{2}$, using (4.14) and taking $\nu>2$ large enough depending only on $\|q\|_{L^{\infty}}$, we obtain:

& \quad+\nu \int_{0}^{t} \int_{M} \partial_{s} v_{\nu} d \bar{v}_{\nu}(N) \mathrm{dv}_{g} d s \\
& =I_{1}+I_{2}+I_{3}+I_{4}
\end{aligned}
$$

Using integration by parts in $s$

\begin{aligned}
2 \operatorname{Re}\left(I_{1}+I_{4}\right)= & 2 \operatorname{Re}\left(\left\langle\partial_{t} v_{\nu}, d \bar{v}_{\nu}(N)\right\rangle_{L^{2}(M)}\right)-\int_{0}^{t}\left\langle N,\left(\nabla^{g}\left|\partial_{s} v_{\nu}\right|_{g}^{2}\right)\right\rangle_{L^{2}(M)} d s \\
& +\nu \operatorname{Re}\left(\int_{0}^{t}\left\langle\partial_{s} v_{\nu}, d v_{\nu}(N)\right\rangle_{L^{2}(M)} d s\right)
\end{aligned}
$$

which gives, after integrating by parts in $x \in M$ the second term, using $\partial_{s} v=0$ on $(0, t) \times$ $\partial M$ and the estimates (4.15) (for some $C_{\nu,\|q\|_{L^{\infty}}}>0$ depending only on $\left.(M, g), \nu,\|q\|_{L^{\infty}}\right)$

& =\int_{M}\left(\nabla^{g} N\left(\nabla^{g} v_{\nu}, \nabla^{g} \bar{v}_{\nu}\right)-\left|\nabla^{g} v\right|^{2} \operatorname{div}(N)\right) \operatorname{dv}_{g}-\int_{\partial M}\left|\nabla^{g} v_{\nu}\right|^{2} \mathrm{dv}_{\partial M}

Note that $\partial_{t} w_{\nu}=\partial_{t}^{2} u_{\nu}=-\left(\Delta_{g}+\frac{\nu^{2}}{4}+q+\nu \partial_{t}\right) u_{\nu} \in L^{2}\left((0, T) ; H^{-2}(M)\right)$ and

for some constant as above, thus by interpolation with $w_{\nu} \in L^{2}\left((0, T) ; L^{2}(M)\right)$, we also have $\partial_{t} w_{\nu} \in L^{2}\left((0, T) ; H^{-1}(M)\right)$ ([LM72a, Proposition 2.2]) with bound

Then, by elliptic regularity and since $\partial_{t}^{2} u_{\nu}, \partial_{t} u_{\nu} \in L^{2}\left((0, T) ; H^{-1}(M)\right)$, there is $C>0$ depending only on $(M, g)$ so that

& -2 i \lambda \sum_{\gamma \in \pi_{1}(M)} e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(x))-t\right)}\left(\partial_{t} a+d a\left(\nabla^{\tilde{g}} \psi_{\tilde{y}}\right)-\frac{a}{2} \Delta_{\tilde{g}} \psi_{\tilde{y}}\right)(t, \gamma(x)) \\
& -\lambda^{2} \sum_{\gamma \in \pi_{1}(M)} a(t, \gamma(x)) e^{i \lambda\left(\psi_{\tilde{y}}(\gamma(x))-t\right)}\left(1-\left|\nabla^{\tilde{g}} \psi_{\tilde{y}}\right|^{2}\right)

solves the mixed hyperbolic problem (4.22) with right-hand side $k_{1}(t, x)=\int_{0}^{t} k(s, x) d s$. For $t \geq T$, this is equal to

& \leq \frac{C e^{(h+\epsilon) T}}{\lambda} \int_{0}^{\infty} \int_{r}^{\infty} e^{-\nu(s-r)} e^{-\nu r}\left\|\partial_{r} k_{0}(r, \cdot)\right\|_{L^{2}(\widetilde{M})} d s d r \\
& \leq \frac{C e^{(h+\epsilon) T}}{\lambda} \int_{0}^{\infty} e^{-\nu r}\left\|\partial_{r} k_{0}(r, \cdot)\right\|_{L^{2}(\widetilde{M})} d r \\
& \leq \frac{C e^{(h+\epsilon) T}}{\lambda}\|a\|_{*}

for some constants $C$ independent of $(T, \lambda)$ (but depending on $\nu-\nu_{0}$ ). On the other hand, using again Lemma 4.3 for $v_{\lambda}$, we obtain

## 5. Stable determination of the eletrical potential for the Schrödinger EQUATION

In this section we prove Theorem 1 about the stability estimate for the Schrödinger equation. The main idea relies in taking geometric optics solutions with initial data $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ with $\left.b\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$ where $T_{0}>0$ is taken large. These solutions are concentrating on geodesics with endpoints on the boundary and with length at most $T_{0}$; when $T_{0} \rightarrow \infty$, these geodesics will cover a set of full measure in $M$. Using these solutions, one can control the $L^{2}$ to norm of $\Pi_{0}^{e} q$ by the difference of the DN maps for $q_{1}$ and $q_{2}$, with a remainder term coming from $L^{2}$ estimates of the $X$-ray transform of $q$ and $\Pi_{0}^{e} q$ on $\partial \mathcal{T}_{+}\left(T_{0}\right)$; here $\Pi_{0}^{e}=I_{0}^{e *} I_{0}^{e}$ is the normal operator associated to the X-ray transform on $M_{e}$ introduced in (3.3). As we shall see, using the estimate (3.4), this is enough to obtain our stability estimate since, due to hyperbolicity of the trapped set, the volume of $\mathcal{T}_{+}\left(T_{0}\right)$ decays exponentially as $T_{0} \rightarrow \infty$ and this remainder term can be absorbed in the stability estimate for $T_{0}$ sufficiently large.
5.1. Preliminary estimates. We first reformulate Lemmas 5.1 and 5.2 from [BDSF10] in our setting. Let $q=q_{1}-q_{2}$ extended to $M_{e}$ by $q=0$ in $M_{e} \backslash M$. Recall that $\Lambda_{g, q}^{S}$ is the Dirichlet-to-Neumann map associated with the Schrödinger equation (1.1).
Lemma 5.1. Let $q_{1}, q_{2} \in W^{1, \infty}(M)$ with $\left.q_{1}\right|_{\partial M}=\left.q_{2}\right|_{\partial M}$ and set $q:=q_{1}-q_{2}$. There exists $C>0$ depending only on $\left(M, g,\|q\|_{W^{1, \infty}}\right)$ and $C_{0}>0$ depending only on $(M, g)$ such that for any $T_{0}>0$, any $a_{1}, a_{2} \in H^{1}\left(\mathbb{R} ; H^{2}(\widetilde{M})\right)$ satisfying the transport equation (4.4) on $\widetilde{M}_{e}$ with condition $\left.a_{j}\right|_{\partial_{-} S \widetilde{M}}=\pi^{*} b_{j}$ for $b_{1}, b_{2} \in H^{2}\left(\partial_{-} S M\right)$ satisfying $\left.b_{1}\right|_{\left.\partial \mathcal{T}_{+}\left(T_{0}\right)\right)}=\left.b_{2}\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$, the following estimate holds true:

This correspond to bounding below the distance between two vectors $v_{1}=d \pi \nabla^{\tilde{g}} \psi_{\tilde{y}}(x)$ and $v_{2}=d \pi(d \gamma)^{-1}\left(\nabla^{\tilde{g}} \psi_{\tilde{y}}\right)(\gamma(x)) \in T_{x} M_{e}$ tangent to two geodesics $\alpha_{1}$ and $\alpha_{2}$ of length $\leq T_{0}$ in $M_{e}$, starting at $y \in \partial M_{e}$ and with endpoints $x \in M_{e}$, and $\alpha_{1}, \alpha_{2}$ being in two different homotopy classes. On the other hand, if injrad $\left(M_{e e}, g\right)$ is the injectivity radius of $\left(M_{e e}, g\right)$, then for $0<\delta<\operatorname{injrad}\left(M_{e e}, g\right)$ and any $C^{1}$ curves $\alpha_{1}:[0,1] \rightarrow M_{e}$ and $\alpha_{2}:[0,1] \rightarrow M_{e}$ so that

Notice that $C_{0}>0$ above depends only the maximal expansion rate of the flow defined as the smallest constant $\theta>0$ such that for each $\epsilon>0$ there is $C>0$ such that for all $t$ large enough

There is $C_{0}>0$ depending only on $(M, g)$ and $C>0$ depending on $\left(M, g,\left\|q_{1}\right\|_{W^{1, \infty}},\left\|q_{2}\right\|_{W^{1, \infty}}\right)$ such that for any $T_{0}>0$ and any $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ such that $\left.b\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$, the following estimate

holds uniformly for any $y \in \partial M_{e}$, where $\mu(y, v)=g\left(\mathrm{n}_{y}, v\right)$, with $\mathrm{n}_{y}$ the inward unit normal of $\partial M_{e}$ at $y$.

Proof. We take two solutions $a_{1}, a_{2}$ to the transport equation on the universal cover $\widetilde{M}_{e}$ defined as before by

Here we have used the natural identification $S_{\tilde{y}} \widetilde{M}_{e} \simeq S_{y} M_{e}$ to define $\tau_{+}^{e}(y, v(x))$. We write using geodesic polar coordinates $x=\widetilde{\exp }_{\tilde{y}}(r v)$ with $v \in \partial_{-} S_{\tilde{y}} \widetilde{M}_{e}$

& =\int_{0}^{T} \int_{\partial_{-} S_{y} M_{e}} \int_{0}^{\tau_{+}^{e}(y, v)} q\left(\exp _{y}(r v)\right) \phi^{2}(2 \lambda t-r) b(y, v) \mu(y, v) d r d \omega_{y}(v) d t \\
& =\frac{1}{2 \lambda} \int_{0}^{2 \lambda T} \int_{\partial_{-} S_{y} M_{e}} \int_{0}^{\tau_{+}^{e}(y, v)} q\left(\exp _{y}(r v)\right) \phi^{2}(t-r) b(y, v) \mu(y, \theta) d r d \omega_{y}(v) d t
\end{aligned}
$$

By Lemma 5.1, we obtain the bound (using that $r \leq T_{0} \leq 2 \lambda T$ by our assumption)

\end{aligned}
$$

Moreover, using the properties of the function $\phi$, we also have

& \quad=\left(\int_{-\infty}^{\infty} \phi^{2}(t) d t\right) \int_{\partial_{-} S_{y} M_{e}} \int_{0}^{\tau_{+}^{e}(y, v)} q\left(\exp _{y}(r v)\right) b(y, v) \mu(y, v) d r d \omega_{y}(v)
\end{aligned}

Finally, to prove the Lemma it suffices to take

5.2. Proof of the stability estimate. Using Lemma 5.2 we have, for any $y \in \partial M_{e}$ and $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ such that $\left.b\right|_{\partial \tau_{+}\left(T_{0}\right)}=0$,

where $C, C_{0}$ are uniform in $y, T_{0}$. Now we take bump function $\chi_{T} \in \mathcal{C}_{c}^{\infty}(\mathbb{R})$ supported in the interval $\left[0, T_{0}+1\right)$ and equal to 1 on $\left[0, T_{0}\right]$, and set

\end{align*}
$$

Moreover, we can write

& \leq\left(\int_{\partial \mathcal{T}_{+}\left(T_{0}\right)}\left|I_{0}^{e} q(y, \theta)\right|^{2} d \mu_{\mathrm{n}}(y, \theta)\right)^{1 / 2}\left(\int_{\partial \mathcal{T}_{+}\left(T_{0}\right)}\left|I_{0}^{e}\left(\Pi_{0}^{e} q\right)(y, \theta)\right|^{2} d \mu_{\mathrm{n}}(y, \theta)\right)^{1 / 2}
\end{aligned}
$$

Since $q \in W^{1, \infty}(M) \subset H^{1}(M)$, then by [Gui17, Prop. 5.7], $\Pi_{0}^{e} q \in H^{2}(M)$. By Sobolev embedding theorem, we also have that

Proof. We follow the argument in [Gui17, Lemma 5.1]. Using Hölder inequality, with $\frac{1}{p}+\frac{1}{p^{\prime}}=1$ and $\frac{r}{p^{\prime}}=\frac{p-1}{p-2}>1$ and Santalo's formula we have:

& \leq \int_{\partial \mathcal{T}_{+}\left(T_{0}\right)}\left(\int_{0}^{\tau_{+}^{e}(y, v)}\left|\pi_{0}^{*} f\left(\varphi_{t}(y, v)\right)\right|^{p} d t\right)^{2 / p} \tau_{+}(y, v)^{2 / p^{\prime}} d \mu_{\mathrm{n}} \\
& \leq\left(\int_{\partial \mathcal{T}_{+}\left(T_{0}\right)} \int_{0}^{\tau_{+}^{e}(y, v)}\left|\pi_{0}^{*} f\left(\varphi_{t}(y, v)\right)\right|^{p} d t d \mu_{\mathrm{n}}\right)^{2 / p}\left\|\tau_{+}^{e}\right\|_{L^{2 r / p^{\prime}}\left(\partial-S M \backslash \partial \mathcal{T}_{+}\left(T_{0}\right)\right)}^{2 / p^{\prime}} \\
& \leq C\|f\|_{L^{p}(M)}^{2}\left(\int_{T_{0}}^{\infty} t^{\frac{2 r}{p^{\prime}}-1} V(t) d t\right)^{\frac{1}{r}} \\
& \leq C\|f\|_{L^{p}(M)}^{2} e^{Q T_{0} / 2}
\end{aligned}
$$

and $C$ only depends on $(Q, p, \operatorname{dim} M)$.
Notice that as $p \rightarrow+\infty$ we have $r \rightarrow 1$ and $C(Q, p, \operatorname{dim} M)$ can be taken uniform in $p$.
Lemma 5.4. There is $C>0$ and $\theta>0$ such that for all $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ given by (5.5),

Let $\rho$ be a boundary defining function of $M_{e}$ so that $|d \rho|_{g}=1$ near $\partial M_{e}$ and $d\left(\pi_{0}^{*} \rho\right)(X)=-g(v, \mathrm{n})$ at $\partial_{+} S M_{e}$. The function $\tau_{+}^{e}$ is defined by the implicit equation

From standard estimates on flows of autonomous $C^{2}$-vector fields, there is $C, \theta>0$ depending on $\|X\|_{C^{2}}$ such that for all $t \in \mathbb{R}$ for which the flow is defined,

Using this, the fact that $g(S(x, v), \mathrm{n})>c_{0}>0$ for some $c_{0}$ if $\tau_{+}(x, v)>1$, we see from the expression (5.8) and its derivative that there is $C>0, \theta>0$ independent of $T_{0}$ such that

Finally, we compute another derivative of $b$, and write

& +2 \chi_{T_{0}}^{\prime}\left(\tau_{+}^{e}(z)\right) d \tau_{+}^{e}(z) \otimes\left(d \tau_{+}^{e}(z) \pi_{0}^{*} f(S(z))+\int_{0}^{\tau_{+}^{e}(z)} d\left(\pi_{0}^{*} f\right) \cdot d \varphi_{t}(z) d t\right) \\
& +\chi_{T_{0}}\left(\tau_{+}^{e}(z)\right)\left(\nabla^{2} \tau_{+}^{e}(z) \pi_{0}^{*} f(S(z))+2 d \tau_{+}^{e}(z) \otimes\left(d\left(\pi_{0}^{*} f\right) \cdot d S(z)\right)\right) \\
& +\chi_{T_{0}}\left(\tau_{+}^{e}(z)\right) \int_{0}^{\tau_{+}^{e}(z)} \nabla\left(\varphi_{t}^{*} d\left(\pi_{0}^{*} f\right)\right) d t
\end{aligned}
$$

Since $\pi_{0}^{*} f$ is smooth near $\partial_{-} S M_{e}$ and since the bounds (5.9) hold and $I_{0}^{e} f \in L^{2}$, we obtain that there is $C>0, \theta>0$ independent of $T_{0}, q$ such that

Proof of Theorem 1. By (5.6), Lemma 5.3, Lemma 5.4, and using that $\left\|\Pi_{0}^{e} q\right\|_{L^{p}\left(M_{e}\right)} \leq$ $C\|q\|_{L^{\infty}(M)}$ for each $p \in(2, \infty)$, we have that there is $C_{0}>0$ depending only on $(M, g)$ and $C$ depending on $\left(M, g,\|q\|_{W^{1, \infty}}\right)$ such that

Then, defining $\alpha:=e^{-\frac{Q}{2} T_{0}}$ and $m:=-\frac{2 C_{0}}{Q}>0$, we deduce from (5.13) that

Finally, by (3.4), there is $C>0$ depending only on $(M, g)$ such that

Using this, an interpolation estimate, (5.14), we obtain

Finally, by the first bound of (5.15), we conclude that for $q_{1}, q_{2} \in \mathcal{Q}\left(N_{0}\right)$

This concludes the proof.

## 6. Stable determination of the electrical potential for the wave EQUATION

In this section we shall prove Theorem 3.
6.1. Preliminary estimates. We start with a Lemma very similar to Lemma 5.1 but now in the context of the wave equation. Its proof follows the lines of that of Lemma 5.1.
Lemma 6.1. Let $q_{1}, q_{2} \in W^{1, \infty}(M)$ with $\left.q_{1}\right|_{\partial M}=\left.q_{2}\right|_{\partial M}$ and set $q:=q_{1}-q_{2}$ There exist $C>0$ depending only on $\left(M, g,\left\|q_{i}\right\|_{W^{1, \infty}(M)}\right), \nu>0$ depending only on $\left\|q_{i}\right\|_{L^{\infty}}$ and $C_{0} \geq 0$ depending only on $(M, g, \nu)$ such that for any $T>0, \lambda>1$, and for $a_{1}, a_{2} \in$ $H_{0}^{1}\left([0, T], H^{2}(\widetilde{M})\right)$ the functions constructed in (4.6) with function $b$ given respectively by $b_{1}, b_{2} \in H^{2}\left(\partial_{-} S M\right)$ satisfying $\left.b_{1}\right|_{\partial \mathcal{T}_{+}(T)}=\left.b_{2}\right|_{\partial \mathcal{T}_{+}(T)}=0$, the following estimate holds true:

We next denote by $f_{\lambda}$ the restriction of $G_{2, \lambda}$ to $[0, T] \times \partial M$

which corresponds to the electric potential $q_{1}$, where $v_{1, \lambda}$ satisfies $v_{1, \lambda}(T, \cdot)=\partial_{t} v_{1, \lambda}(T, \cdot)=$ 0 , and for each $\epsilon>0$ there is $C$ independent of $T, \lambda$ such that

where the boundary data $g_{\lambda}$ is given by

&-\sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T} \int_{\mathcal{F}} q e^{i \lambda\left(\left(\psi_{\tilde{y}}(\gamma(\cdot))-t\right)\right.} a_{2}(t, \gamma(\cdot)) \bar{v}_{1, \lambda} \mathrm{dv}_{\tilde{g}} d t \\
&-\sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T} \int_{\mathcal{F}} q v_{2, \lambda} e^{-i \lambda\left(\psi_{\tilde{y}}(\gamma(\cdot))-t\right)} \overline{a_{1}(t, \gamma(\cdot))} \mathrm{dv}_{\tilde{g}} d t
\end{aligned}
$$

By (6.1) and (6.2), for each $\epsilon>0$ small, there is $C>0$ depending on $g,\|q\|_{L^{\infty}}, \epsilon$ such that for all $T, \lambda$

& \leq C \sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T}\left\|a_{2}(t, \cdot)\right\|_{L^{2}(\gamma(\mathcal{F}))}\left\|v_{1, \lambda}(t, \cdot)\right\|_{L^{2}(M)} d t \\
& \leq C e^{2(h+\nu+\epsilon) T} \lambda^{-1}\left\|a_{2}\right\|_{*}\left\|a_{1}\right\|_{*} .
\end{aligned}
$$

and $\left|\int_{0}^{T} \int_{M} q v_{2, \lambda} \bar{v}_{1, \lambda} \mathrm{dv}_{g} d t\right| \leq C e^{2(h+\nu+\epsilon) T} \lambda^{-2}\left\|a_{1}\right\|_{*}\left\|a_{2}\right\|_{*}$. We also have, using that $\forall \epsilon>0$, $\left\|f_{\lambda}\right\|_{H^{1}([0, T] \times \partial M} \leq C \lambda e^{(h+\epsilon) T}\left\|a_{2}\right\|_{*}$ and $\left\|g_{\lambda}\right\|_{L^{2}([0, T] \times \partial M} \leq C e^{(h+\epsilon) T}\left\|a_{1}\right\|_{*}$ for some $C>0$ depending only on the metric $g$ and $\epsilon$,

\left|\int_{0}^{T} \int_{\partial M}\left(\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}\right)\left(f_{\lambda}\right) \bar{g}_{\lambda} \mathrm{dv}_{\left.g\right|_{\partial M}} d t\right| \leq C e^{2(h+\nu+\epsilon) T} \lambda\left\|a_{1}\right\|_{*}\left\|a_{2}\right\|_{*}\left\|\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}\right\|_{*, \nu} .
$$

Finally, using that

and bounding the off-diagonal terms as in (5.3), the Lemma holds.
We then obtain the following Lemma comparable to Lemma 5.2:

There exist $C>0$ depending only on $\left(M, g,\left\|q_{1}\right\|_{W^{1, \infty}},\left\|q_{2}\right\|_{W^{1, \infty}}\right)$, $\nu$ depending on $\left(\left\|q_{1}\right\|_{L^{\infty}},\left\|q_{2}\right\|_{L^{\infty}}\right)$ and $C_{0}>0$ depending on $(M, g, \nu)$ such that, for any $T>1, b \in$ $H^{2}\left(\partial_{-} S M_{e}\right)$ such that $\left.b\right|_{\partial \mathcal{T}_{+}(T)}=0$, one has

&\left|\int_{\partial_{-} S_{y} M_{e}} \int_{0}^{\tau_{+}^{e}(y, v)} q\left(\exp _{y}(s v)\right) b(y, v) \mu(y, v) d s d \omega_{y}(v)\right| \\
& \leq C e^{C_{0} T_{0}}\left\|\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}\right\|_{*, \nu}^{1 / 2}\|b(y, \cdot)\|_{H^{2}\left(\partial_{-} S_{y} M_{e}\right)}
\end{aligned}
$$

holds uniformly for any $y \in \partial M_{e}$, where $\mu(y, v)=g\left(\mathrm{n}_{y}, v\right)$.
Proof. Take $a_{1}, a_{2}$ solutions to the transport equation on the universal cover $\widetilde{M}$ as before. Then as in the proof of Lemma 5.2, we obtain

\end{aligned}
$$

Combining this with Lemma 6.1 and choosing $\lambda=\left\|\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}\right\|_{*, \nu}^{-\frac{1}{2}}$ yields the desired result.
6.2. Proof of the stability estimate. Using Lemma 6.2 there is $C>0$ such that for any $y \in \partial M$ and $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ such that $\left.b\right|_{\left.\partial \mathcal{T}_{+}(T)\right)}=0$,

Now we take a bump function $\chi_{T} \in \mathcal{C}_{c}^{\infty}(\mathbb{R})$ as in Section 5.2 and choose $b$ by (5.5) with $T$ instead of $T_{0}$

Proof of Theorem 3. The proof is then almost the same as the proof of Theorem 1, we then just briefly describe it. From (6.3), the same as (5.6) holds with $\Lambda_{g, q_{1}}^{S}-\Lambda_{g, q_{2}}^{S}$ replaced by $\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}$, then using Lemmas 5.3 and 5.4 with $\left\|\Pi_{0}^{e} q\right\|_{L^{p}\left(M_{e}\right)} \leq\|q\|_{L^{\infty}(M)}$, we obtain

The last part of the proof is exacly the same as for Theorem 1 by choosing $T$ so that $e^{-Q T / 2}=\left\|\Lambda_{g, q_{1}}^{W}-\Lambda_{g, q_{2}}^{W}\right\|_{*, \nu}^{-\frac{1}{2(m+1)}}$ with $m=-2 C_{0} / Q$.

## 7. Stable determination of the conformal factor for the Schrödinger EQUATION

In this section we prove Theorem 2. The proof follows the argument of [BDSF10, Thm. 3], and we indicate the main modifications. Let $c \in \mathscr{C}\left(N_{0}, k, \epsilon\right)$, be such that $c=1$ near the boundary $\partial M$, we denote

\rho_{0}(x):=1-c(x), \quad \rho_{1}(x):=c^{d / 2}(x)-1, \quad \rho_{2}(x):=c^{d / 2-1}(x)-1, \\
\rho(x):=\rho_{2}(x)-\rho_{1}(x)=c^{d / 2-1}(x)(1-c(x)) \tag{7.1}
\end{gather*}
$$

where recall that $d=\operatorname{dim}(M)$. We modify the construction of geometric optics solutions [BDSF10, Sect. 6.1] in our geometrical setting similarly to what was discussed in previous sections, using the universal cover $\widetilde{M}$. We consider two solutions $\widetilde{\psi}_{1}, \widetilde{\psi}_{2}$, respectively to the lifted eikonal equations $\left|\nabla_{\tilde{g}} \widetilde{\psi}_{1}\right|=1$ and $\left|\nabla_{\widetilde{c} g} \widetilde{\psi}_{2}\right|=1$, a solution $a_{2}$ to the lifted transport equation

\begin{equation*}
\partial_{t} a_{2}+d a_{2}\left(\nabla^{\tilde{g}} \widetilde{\psi}_{1}\right)-\frac{a_{2}}{2} \Delta_{\tilde{g}} \tilde{\psi}_{1}=0 \tag{7.2}
\end{equation*}
$$

given in geodesical polar coordinates with respect to $g$, as in (4.6), by

$$
a_{2}(t, x)=\alpha^{-1 / 4} \phi(t-r(x)) \tilde{b}(\tilde{y}, v(x)), \quad \tilde{y} \in \partial S M_{e}
$$

for some $b \in H^{2}\left(\partial_{-} S M\right)$ satisfying that $\left.b\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$, and $\phi \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ with $\operatorname{supp} \phi \subset\left(0, \varepsilon_{0}\right)$, $\varepsilon_{0}>0$ small, and a solution $a_{3}$ to the lifted transport equation

\partial_{t} a_{3}+d a_{3}\left(\nabla^{\widetilde{c} g} \widetilde{\psi}_{2}\right)-\frac{a_{3}}{2} \Delta_{\widetilde{c g}} \widetilde{\psi}_{2}=-\frac{1}{2 i} a_{2}(t, x)\left(1-\frac{1}{\widetilde{c}}\right) e^{i \lambda\left(\widetilde{\psi}_{1}-\widetilde{\psi}_{2}\right)}

which satisfies (analogously to [BDSF10, (6.10)]) the bound

for some $C>0$ depending on $(M, g)$ (it does not depend on $T_{0}$, notice that the derivatives of the difference between $\widetilde{\psi}_{1}$ and $\widetilde{\psi}_{2}$ can be bounded in terms of derivatives of $c$ ), where $\|\cdot\|_{*}=\|\cdot\|_{H^{1}\left(\left[0, T_{0}\right] ; H^{2}(\widetilde{M})\right)}$. Then, [BDSF10, Lemma 6.2] becomes in our setting:

which satisfies, for $\lambda \geq T_{0} / 2 T$,

\lambda\left\|v_{2, \lambda}(t, \cdot)\right\|_{L^{2}(M)}+\left\|\nabla^{g} v_{2, \lambda}(t, \cdot)\right\|_{L^{2}(M)}+\lambda^{-1}\left\|\partial_{t} v_{2, \lambda}(t, \cdot)\right\|_{L^{2}(M)} \\
\leq C e^{C_{0} T_{0}}\left(\lambda^{2}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}+\lambda^{-1}\right)\left\|a_{2}\right\|_{*} .
\end{gathered}
$$

for $C>0$ depending on $\left(M, g, N_{0}\right)$ and $C_{0}>0$ depending on $(M, g)$.
The constant $C_{0}$ above can be written in terms of the max of the volume entropies of the metrics $c g$ for $|c-1|_{\mathcal{C}^{1}(M)} \leq 1 / 2$ (this can be bounded by a uniform constant times the volume entropy of $(M, g))$.

Moreover, reasoning as in previous Sections, [BDSF10, Lemma 6.3] becomes in our setting:

Lemma 7.2. There exist constants $C>0$ depending on $\left(M, g, N_{0}\right)$ and $C_{0}>0$ depending on $(M, g)$ such that, for any $a_{1}, a_{2} \in H^{1}\left(\left[0, T_{0}\right] ; H^{2}(\widetilde{M})\right)$ solving (7.2) associated to $b_{1}, b_{2} \in$ $H^{2}\left(\partial_{-} S M_{e}\right)$ with $\left.b_{1}\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=\left.b_{2}\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$, the following estimate holds:

&\left|\sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T} \int_{M} \rho(x) a_{1}(2 \lambda t, \gamma(x)) a_{2}(2 \lambda t, \gamma(x)) \mathrm{dv}_{g}(x) d t\right| \\
& \leq C \lambda^{-1} e^{C_{0} T_{0}}\left(\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)+\lambda\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}\right)\left\|a_{1}\right\|_{*}\left\|a_{2}\right\|_{*}
\end{aligned}
$$

for any $\lambda \geq T_{0} / 2 T$.
Finally, [BDSF10, Lemma 6.4] becomes in our setting
Lemma 7.3. There exists $C>0$ and $C_{0}>0$ as in previous Lemma such that, for any $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ with $\left.b\right|_{\partial \mathcal{T}_{+}\left(T_{0}\right)}=0$ the following estimate

$$
\begin{aligned}
& \left|\int_{\partial_{-} S M_{e}} I_{0}^{e}(\rho)(y, v) b(y, v) d \mu_{\mathrm{n}}(y, v)\right| \\
& \quad \leq C e^{C_{0} T_{0}}\left(\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}+\lambda\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}\right)\|b\|_{H^{2}\left(\partial_{-} S M\right)}
\end{aligned}
$$

holds for any $\lambda \geq T_{0} / 2 T$. Here $I_{0}^{e}$ is the $X$-ray transform for $g$ on functions on $M_{e}$.
Proof of Theorem 2. We take $b$ as in (5.5) with $q$ replaced by $\rho$. By Lemma 7.3, Lemma 5.3, and Lemma 5.4, there is $C>0, C_{0}>0$ depending on $\left(M, g, N_{0}, \epsilon\right)$ such that

$$
\begin{aligned}
& \left\|\Pi_{0}^{e} \rho\right\|_{L^{2}\left(M_{e}\right)}^{2} \\
& \quad \leq C e^{C_{0} T_{0}}\left(\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}+\lambda\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}\right)\|\rho\|_{W^{1, p}(M)}+C e^{\frac{Q}{2} T_{0}}\|\rho\|_{L^{p}(M)}^{2}
\end{aligned}
$$

for some $p>2$. By interpolation,

$$
\begin{aligned}
\left\|\Pi_{0}^{e} \rho\right\|_{H^{1}\left(M_{e}\right)}^{2} \leq & C\left\|\Pi_{0}^{e} \rho\right\|_{L^{2}\left(M_{e}\right)}\left\|\Pi_{0}^{e} \rho\right\|_{H^{2}\left(M_{e}\right)} \\
\leq & C e^{\frac{C_{0}}{2} T_{0}}\left(\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}+\lambda\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}\right)^{\frac{1}{2}}\|\rho\|_{W^{1, p}(M)}^{\frac{1}{2}}\|\rho\|_{H^{1}(M)} \\
& +C e^{\frac{Q}{4} T_{0}}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)}
\end{aligned}
$$

We use (3.4) to deduce the bound

$$
\begin{aligned}
\|\rho\|_{L^{2}(M)}^{2} \leq & C e^{C_{0} T_{0} / 2}\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)^{\frac{1}{2}}\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}^{\frac{1}{2}}\|\rho\|_{W^{1, p}(M)}^{\frac{1}{2}}\|\rho\|_{H^{1}(M)} \\
& +C e^{\frac{C_{0}}{2} T_{0}} \lambda^{\frac{1}{2}}\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}^{\frac{3}{2}}\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}^{\frac{1}{2}}+C e^{\frac{Q}{4} T_{0}}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)}
\end{aligned}
$$

Taking

$$
\lambda=\frac{T_{0}}{2 T} \cdot\left(\frac{\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}}{2 N_{0}}\right)^{-\frac{1}{4}}
$$

we obtain for $T_{0}>0$ large

$$
\begin{aligned}
\|\rho\|_{L^{2}(M)}^{2} & \leq C e^{C_{0} T_{0}}\left(\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{\frac{17}{8}}+\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{\frac{11}{8}}\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}^{\frac{1}{2}}\right)+C e^{\frac{Q}{4} T_{0}}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)} \\
& \leq C e^{C_{0} T_{0}}\left(\epsilon^{\ell}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{\frac{33}{16}}+\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}^{\frac{1}{2}}\right)+C e^{\frac{Q}{4} T_{0}}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)},
\end{aligned}
$$

where $C$ depends on $N_{0}, \ell=\frac{1}{16}\left(1-\frac{2}{k}\right)$, and we have used the interpolation estimate

$$
\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)} \leq C\left\|\rho_{0}\right\|_{\mathcal{C}(M)}^{1-\frac{2}{k}} \leq C \epsilon^{1-\frac{2}{k}}
$$

By interpolation, choosing $k>\max \left(s, s^{\prime}\right)$ large enough, we have for some $\delta, \delta^{\prime}>0$ small

$$
\begin{align*}
\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)} & \leq C\left\|\rho_{0}\right\|_{H^{\frac{d}{2}+2+\delta}(M)} \leq C\left\|\rho_{0}\right\|_{L^{2}(M)}^{32 / 33+\delta}\left\|\rho_{0}\right\|_{H^{s}(M)}^{1 / 33-\delta} \leq C\left\|\rho_{0}\right\|_{L^{2}(M)}^{32 / 33+\delta}  \tag{7.4}\\
\|\rho\|_{H^{1}(M)} & \leq\|\rho\|_{L^{2}(M)}^{1-\delta^{\prime}}\|\rho\|_{H^{s^{\prime}(M)}}^{\delta^{\prime}} \leq C\|\rho\|_{L^{2}(M)}^{1-\delta^{\prime}}  \tag{7.5}\\
\|\rho\|_{L^{p}(M)} & \leq\|\rho\|_{L^{2}(M)}^{1-\delta^{\prime}}\|\rho\|_{L^{p^{\prime}(M)}}^{\delta^{\prime}} \leq C\|\rho\|_{L^{\prime}(M)}^{1-\delta^{\prime}} \tag{7.6}
\end{align*}
$$

where $C>0$ depends on $N_{0}$. Thus, using that $C^{-1}\left\|\rho_{0}\right\|_{L^{2}} \leq\|\rho\|_{L^{2}} \leq C\left\|\rho_{0}\right\|_{L^{2}}$, we see that there is $C>0$ depending on $\left(M, g, N_{0}, k\right)$ and $C_{0}>0$ depending on $(M, g)$ such that

$$
\left\|\rho_{0}\right\|_{L^{2}(M)}^{2} \leq C e^{C_{0} T_{0}} \epsilon^{\ell}\left\|\rho_{0}\right\|_{L^{2}(M)}^{2+\delta}+C e^{C_{0} T_{0}}\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}^{\frac{1}{2}}+C e^{\frac{Q}{4} T_{0}}\left\|\rho_{0}\right\|_{L^{2}(M)}^{2-2 \delta^{\prime}} .
$$

We finally take $T_{0}$ sufficiently large so that

$$
C e^{\frac{Q}{4} T_{0}}<\frac{1}{2}\left\|\rho_{0}\right\|_{L^{2}}^{2 \delta^{\prime}}
$$

This allows us to absorb the third term of the right-hand-side in the left-hand side:

$$
\left\|\rho_{0}\right\|_{L^{2}(M)}^{2} \leq C \epsilon^{\ell}\left\|\rho_{0}\right\|_{L^{2}(M)}^{-2 m \delta^{\prime}}\left\|\rho_{0}\right\|_{L^{2}(M)}^{2+\delta}+C\left\|\rho_{0}\right\|_{L^{2}(M)}^{-2 m \delta^{\prime}}\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}^{\frac{1}{2}}
$$

for $m=C_{0} / 4|Q|>0$. Choosing $\delta>2 m \delta^{\prime}$ and taking $\epsilon$ sufficiently small, we can absorb the first term of the right-hand-side into the left-hand-side. Therefore, there exists $\beta>0$ depending on $(M, g)$ and $C>0$ depending on $\left(M, g, N_{0}, k, \epsilon\right)$ such that

$$
\left\|\rho_{0}\right\|_{L^{2}(M)} \leq C\left\|\Lambda_{g}^{S}-\Lambda_{c g}^{S}\right\|_{*}^{\beta}
$$

and the proof is complete.

## 8. Stable determination of the conformal factor for the wave equation

In this section we sketch the proof of Theorem 4. We just indicate the modifications with respect to the proof of [BDSF11, Thm. 2]. We will assume that the conformal factor satisfies $c \in \mathscr{C}\left(N_{0}, k, \epsilon\right)$ be such that $c=1$ near the boundary $\partial M$, and we use the notation (7.1). First, [BDSF11, Lemma 6.2] becomes in our setting:

Lemma 8.1. The equation

$$
\begin{cases}\left(\partial_{t}^{2}+\Delta_{c g}\right) u & =0, \\ u(0, x) & =0, \\ \text { in }(0, T) \times M\end{cases}
$$

has a solution of the form

$$
u_{2}(t, x)=\sum_{\gamma \in \pi_{1}(M)}\left(\frac{1}{\lambda} a_{2}(t, \gamma(x)) e^{i \lambda\left(\psi_{1}(\gamma(x))-t\right)}+a_{3}(t, \gamma(x) ; \lambda) e^{i \lambda\left(\psi_{2}(\gamma(x))-t\right)}\right)+v_{2, \lambda}(t, x)
$$

such that there is $\nu_{0}>0$ (given by Lemma 4.3) so that for all $\nu>\nu_{0}$, there is $C>0$ depending only on $\left(M, g, N_{0}, \nu\right)$, and $C_{0}>0$ depending only on $(M, g, \nu)$ so that $\forall \lambda>1$

$$
\begin{gathered}
\lambda\left\|v_{2, \lambda}\right\|_{e^{\nu t} L^{2}\left(\mathbb{R}_{+} \times M\right)}+\left\|\nabla^{g} v_{2, \lambda}\right\|_{e^{\nu t} L^{2}\left(\mathbb{R}_{+} \times M\right)}+\lambda^{-1}\left\|\partial_{t} v_{2, \lambda}\right\|_{e^{\nu t} L^{2}\left(\mathbb{R}_{+} \times M\right)} \\
\leq C e^{C_{0} T}\left(\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)} \lambda^{2}+\lambda^{-1}\right)\left\|a_{2}\right\|_{*}
\end{gathered}
$$

Moreover, $[B D S F 11$, Lemma 6.3] is replaced by:
Lemma 8.2. There exist constants $C_{0}>0$ depending on $(M, g, \nu)$ and $C>0$ depending on $\left(M, g, N_{0}, \nu\right)$ such that, for any $a_{1}, a_{2} \in H^{1}\left([0, T] ; H^{2}(\widetilde{M})\right)$ solving (7.2) associated to $b_{1}, b_{2} \in H^{2}\left(\partial_{-} S M_{e}\right)$ with $\left.b_{1}\right|_{\partial \mathcal{T}_{+}(T)}=\left.b_{2}\right|_{\partial \mathcal{T}_{+}(T)}=0$, the following estimate holds:

$$
\begin{aligned}
& \mid \sum_{\gamma \in \pi_{1}(M)} \int_{0}^{T} \int_{M} \rho(x) a_{1}(t, \gamma(x)) \overline{a_{2}(t, \gamma(x))} \mathrm{dv} \\
& \quad \leq C e^{C_{0} T}\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\| \|_{\mathcal{C}^{2}(M)}\right)\left\|a_{1}\right\|_{*}\left\|a_{2}\right\|_{*}+C e^{C_{0} T} \lambda\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}\left\|a_{1}\right\|_{*}\left\|a_{2}\right\|_{*},
\end{aligned}
$$ for all $\lambda>1$.

Finally, [BDSF11, Lemma 6.4] is replaced by:
Lemma 8.3. There exists $C>0$ depending on $\left(M, g, N_{0}, \nu\right)$ and $C_{0}>0$ depending on $(M, g, \nu)$ such that, for any $b \in H^{2}\left(\partial_{-} S M_{e}\right)$ with $\left.b\right|_{\partial \mathcal{T}_{+}(T)}=0$ the following estimate

$$
\begin{aligned}
& \left|\int_{\partial_{-} S M_{e}} I_{0}^{e}(\rho)(y, v) b(y, v) d \mu_{\nu}(y, v)\right| \\
& \quad \leq C e^{C_{0} T}\left(\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}+\lambda\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}\right)\|b\|_{H^{2}\left(\partial_{-} S M\right)}
\end{aligned}
$$

holds for all $\lambda>1$.

Proof of Theorem 4. We take $b$ as in (5.5) with $q$ replaced by $\rho$. By Lemma 7.3, Lemma 5.3, and Lemma 5.4, there is $C>0$ depending on $\left(M, g, N_{0}, \nu\right)$ and $C_{0}>0$ depending on $(M, g)$ such that

$$
\begin{aligned}
& \left\|\Pi_{0}^{e} \rho\right\|_{L^{2}\left(M_{e}\right)}^{2} \\
& \leq C e^{C_{0} T}\left(\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}+\lambda\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}\right)\|\rho\|_{W^{1}, p}(M) \\
& \quad C e^{\frac{Q}{2} T}\|\rho\|_{L^{p}(M)}^{2}
\end{aligned}
$$

for some $p>2$. By interpolation,

$$
\begin{aligned}
\left\|\Pi_{0}^{e} \rho\right\|_{H^{1}\left(M_{e}\right)}^{2} \leq & C\left\|\Pi_{0}^{e} \rho\right\|_{L^{2}\left(M_{e}\right)}\left\|\Pi_{0}^{e} \rho\right\|_{H^{2}\left(M_{e}\right)} \\
\leq & C e^{\frac{C_{0}}{2} T}\left(\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}+\lambda\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}\right)^{\frac{1}{2}}\|\rho\|_{\mathcal{C}^{1}(M)}^{\frac{3}{2}} \\
& +C e^{\frac{Q}{4} T}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)}
\end{aligned}
$$

We use (3.4) to deduce the bound

$$
\begin{aligned}
\|\rho\|_{L^{2}(M)}^{2} \leq & C e^{\frac{C_{0} T}{2}}\left(\lambda^{-1}+\lambda^{3}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}\right)^{\frac{1}{2}}\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}^{\frac{1}{2}}\|\rho\|_{\mathcal{C}^{1}(M)}^{\frac{3}{2}} \\
& +C e^{\frac{C_{0}}{2} T} \lambda^{\frac{1}{2}}\left\|\rho_{0}\right\|_{\mathcal{C}^{1}(M)}^{\frac{3}{2}}\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}^{\frac{1}{2}}+C e^{\frac{Q}{4} T}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)}
\end{aligned}
$$

Taking $\lambda=\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{-\frac{1}{4}}$, we obtain for $T>0$ large:

$$
\begin{aligned}
\|\rho\|_{L^{2}(M)}^{2} & \leq C e^{C_{0} T}\left(\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{\frac{17}{8}}+\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{\frac{11}{8}}\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}^{\frac{1}{2}}\right)+C e^{\frac{Q}{4} T}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)} \\
& \leq C e^{C_{0} T}\left(\epsilon^{\ell}\left\|\rho_{0}\right\|_{\mathcal{C}^{2}(M)}^{\frac{33}{16}}+\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}^{\frac{1}{2}}\right)+C e^{\frac{Q}{4} T}\|\rho\|_{L^{p}(M)}\|\rho\|_{H^{1}(M)},
\end{aligned}
$$

where $\ell=\frac{1}{16}\left(1-\frac{2}{k}\right)$. Choosing $k>\max \left(s, s^{\prime}\right)$ large enough as in the previous section, we have for some $\delta, \delta^{\prime}>0$ small the interpolation estimates (7.4), (7.5), and (7.6). Thus we get that there is $C>0$ depending on $\left(M, g, N_{0}, k\right)$ and $C_{0}>0$ depending on $(M, g)$ such that

$$
\left\|\rho_{0}\right\|_{L^{2}(M)}^{2} \leq C e^{C_{0} T} \epsilon^{\ell}\left\|\rho_{0}\right\|_{L^{2}(M)}^{2+\delta}+C e^{C_{0} T}\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}^{\frac{1}{2}}+C e^{\frac{Q}{4} T}\left\|\rho_{0}\right\|_{L^{2}(M)}^{2-2 \delta^{\prime}}
$$

We finally take $T$ sufficiently large so that

$$
C e^{\frac{Q}{4} T}<\frac{1}{2}\|\rho\|_{L^{2}}^{2 \delta^{\prime}}
$$

This allows us to absorb the third term of the right-hand-side in the left-hand side:

$$
\left\|\rho_{0}\right\|_{L^{2}(M)}^{2} \leq C \epsilon^{\ell}\left\|\rho_{0}\right\|_{L^{2}}^{-2 m \delta^{\prime}}\left\|\rho_{0}\right\|_{L^{2}}^{2+\delta}+C\left\|\rho_{0}\right\|_{L^{2}}^{-2 m \delta^{\prime}}\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}^{\frac{1}{2}},
$$

for $m=C_{0} / 4|Q|>0$. Choosing $\delta>2 m \delta^{\prime}$ and taking $\epsilon$ sufficiently small (depending only on $\|1-c\|_{L^{2}}$, we can absorb the first term of the right-hand-side into the left-handside. Therefore, there exists $\beta>0$ depending on $(M, g, \nu)$ and $C>0$ depending on ( $M, g, N_{0}, k, \epsilon$ ) such that

$$
\left\|\rho_{0}\right\|_{L^{2}(M)} \leq C\left\|\Lambda_{g}^{W}-\Lambda_{c g}^{W}\right\|_{*, \nu}^{\beta}
$$

and the proof is complete.
