#### 8 Abstract

9 **Purpose** To identify the changes of ventilation ( $\dot{V}_{F}$ ), tidal volume ( $V_{T}$ ) and respiratory frequency (fr) at different incremental 10 step test intensities during maturation of children and adolescents.

11 Methods A semi-longitudinal study was conducted on 68 healthy untrained boys and girls aged 11–17 years. The subjects

were separated into three distinct age groups.  $\dot{V}_{F}$ ,  $V_{T}$  and fr parameters were evaluated annually during 3 years by modify-12

13 ing incremental step test intensities according to ventilatory threshold ( $V_{Th}$ ) level (30, 60 and 90% of  $\dot{VO}_{2max}$ ). Absolute and 14

relative values of ventilatory responses were analyzed and compared according to age and developmental phase. 15

Results (1) Height, weight, lean body mass and vital capacity increased significantly from 11 to 17 years of age. (2) VO<sub>2max</sub>, 16  $\dot{V}_{F}$ , and  $V_{T}$  increased during maturation even when exercise intensity changed, especially from 11 to 15 years of age. On the

17 other hand, fr showed a decreasing trend.

18 **Conclusion** Increases of  $V_T$  are the main reason for  $\dot{V}_E$  increases during maturation of children. fr decreased independently

of total body mass during maturation.  $\dot{V}_{F}$ , kg<sup>-1</sup> was stable despite intensity variations.  $V_{T}$ , kg<sup>-1</sup> increased significantly from 19

20 11 to 15 years then stabilized at 17 years. Lean body mass seems to explain the evolution of  $V_T$ .kg<sup>-1</sup> during maturation.

## 46 Introduction

The increased supply of oxygen  $(O_2)$  to the muscles is essen-A:()2 tial during physical exercise (Zhang et al. 1993). During 48 the first phase of this process, is the transport of  $O_2$  to the 49 alveoli through ventilation ( $\dot{V}_{F}$ ) (Calbet and Lundby 2009). $\dot{V}$ 50 <sub>E</sub>, expressed in liters per minute  $(1.min^{-1})$ , corresponds to the 51 volume of air mobilized per minute, resulting from the prod-52 uct of the tidal volume  $(V_T)$  by the respiratory frequency (fr)53 (Holley et al. 2016). $\dot{V}_{F}$  must adapt at each level of exercise 54 intensity to the needs of  $O_2$  in muscles.  $\dot{V}_E$  is also regulated 55 to remove carbon dioxide  $(CO_2)$  from the blood to maintain 56 normocapnia (Whipp and Pardy 1986). Any failure of this 57 adaptation will result in physical performance limitations 58 AQ3 and discomfort during exercise (O'Donnell et al. 2009).

Numerous studies have shown that metabolic and anthro-60 pometric changes during puberty will have an influence on 61 ventilatory response at maximal exercise  $(\dot{V}_{Emax})$  in boys 62 (Rutenfranz et al. 1981; Prioux et al. 1997; Burstein et al. 63 2020; Armstrong and Welsman 2020) and girls (Rutenfranz 64 et al. 1981; Rowland and Cunningham 1997; Burstein et al. 65 2020; Armstrong and Welsman 2020). Several studies (Rob-66 inson 1938; Andersen et al. 1974; Rutenfranz et al. 1981; 67 68 Boule et al. 1989; Armstrong et al. 1997; Rowland and Cunningham 1997; Ondrak and McMurray 2006; Marinov et al. 69 2007) have also analyzed the changes in ventilatory response 70 71 at submaximal intensities during puberty. Nevertheless, only two of these studies are of longitudinal aspect (Rowland and 72 Cunningham 1997; Rutenfranz et al. 1981) whereas the oth-73 ers are cross-sectional studies. However, the cross-sectional 74 studies did not consider differences in physical maturation 75 among subjects of the same chronological age (Matecki et al. 76 2003). Consequently, cross-sectional values give only the 77 range of variability at a certain age and do not provide a 78 true reference for the dynamic process of growth (Ruten-79 franz et al. 1981). Therefore, longitudinal studies can be 80 expected to provide a clearer picture in changes of ventila-81 tory response at submaximal exercise intensities compared 82 83 to cross-sectional studies (Rowland and Cunningham 1997). Furthermore, among the two remaining longitudinal stud-84 ies, Rowland and Cunningham, (1997) compared ventila-85 86 tory responses according to age at absolute exercise intensities (walking speed: 3.25 mph) rather than relative exercise 87 intensities. However, the absolute values did not consider the 88 children's evolution of physical fitness with the age param-89 eter. Indeed, the same intensity, expressed in absolute value, 90 may result in greater ventilatory responses in younger and 91 smaller subjects when compared to the older and larger par-92 ticipants (Ondrak and McMurray 2006). Finally, Rutenfranz 93

et al. (1981) have studied the ventilatory response during a 94 maximal incremental step test performed on a cycle ergom-95 eter using relative intensities which varied between 50 and 96 70% of  $\dot{VO}_{2max}$ . However, the choice of these exercise inten-97 sities is never justified by the authors. To date, no longitu-98 dinal studies have analyzed the ventilatory response during 99 exercise in children and adolescents at exercise intensities 100 determined by ventilatory threshold  $(V_{Th})$ . Nevertheless, it 101 is well known that ventilatory responses differ according to 102 relative exercise intensity and particularly as a function of 103  $V_{Th}$  (Prado et al. 2010). Indeed, during the first minutes of a 104 maximal incremental test, during which the power increases 105 every minute,  $\dot{V}_E$  increases proportionally to the metabolic 106 rate determined by the oxygen uptake  $(\dot{V}O_2)$  and/or carbon 107 dioxide output ( $\dot{V}CO_2$ ) measurements. When exercise inten-108 sity exceeds an average of 50–60% of  $\dot{VO}_{2max}$ , which cor-109 responds to the  $V_{Th}$ , the increase in  $\dot{V}_{F}$  accelerates while 110 VO<sub>2</sub> continues to increase linearly with exercise intensity 111 (Wasserman et al. 1967). A second non-linear increase in 112  $\dot{V}_{F}$  is observed when the metabolic rate reaches approxi-113 mately 80–90% of the subject's  $\dot{V}O_{2max}$ . At this point,  $\dot{V}_E$ 114 increases disproportionately to VO2 and VCO2 (Wasserman 115 et al. 1986). Our semi-longitudinal study, covering a total 116 age range of 11-17 years in boys and 11-15 years in girls, 117 is, therefore, in line with that of Rutenfranz et al (1981). Its 118 objective was thus to further specify the changes with matu-119 ration of submaximal ventilatory response during a maximal 120 incremental step test. To do so, we compared the ventilatory 121 responses according to age at three exercise intensities cho-122 sen according to V<sub>Th</sub> measured during a maximal incremen-123 tal step test, i.e., under  $V_{Th}$  corresponding to 30% of  $\dot{VO}_{2max}$ , 124 around  $V_{Th}$  corresponding to 60% of  $\dot{V}O_{2max}$  and above  $V_{Th}$ 125 corresponding to 90% of  $\dot{VO}_{2max}$ . 126

**Materials and methods** 

## Subjects

Fifty-eight healthy untrained boys (n = 54) and girls (n = 14)129 started in this study. None of them had ever taken part in AQ4 to training or athletic competition. Time spent in extracur-131 ricular physical activities was between  $2h49 \min \pm 0.32$  and 132  $4h28 \min \pm 0.67$  per week for the boys (Table 1) and between 133  $2h34 \min \pm 0.44$  and  $4h18 \min \pm 1.18$  for the girls (Table 2). 134 Annually, at the same period and for 3 years, the children 135 performed a maximal incremental step test on a bicycle 136 ergometer in their school. Five different age groups were 137 established with an initial age for boys of  $11.2 \pm 0.50$  years 138 (group I—n=22), 12.9 ± 0.71 years (group II—n=18), and 139  $14.9 \pm 0.75$  years (group III—n = 14). Concerning girls, 140 the initial age was of  $11.2 \pm 0.61$  years (group IV—n=7), 141 and  $12.9 \pm 1.11$  years (group V—n=7). Concerning boys, 142

the children in group I were tested from  $11.2 \pm 0.50$  to 143  $13.2 \pm 0.83$  years, children in group II from  $12.9 \pm 0.71$  to 144  $14.8 \pm 0.89$  years and children in group III from  $14.9 \pm 0.75$ 145 to  $16.9 \pm 0.77$  years. Concerning girls, the children in group 146 IV were tested from  $11.2 \pm 0.61$  to  $13.0 \pm 0.57$  and children 147 in group V from  $12.9 \pm 1.11$  to  $14.9 \pm 1.72$ . Subjects and 148 their parents provided informed consent following an expla-149 nation of the study's procedures and objectives. The study 150 protocol was approved by the hospital's ethics committee. 151

## Measurements

Anthropometric measurements: the following measurements 153 were performed: total body mass (BM), height and skinfold 154 thickness (bicipital, tricipital, subscapular and supra-iliac). 155 All measurements were taken by the same observer accord-156 ing to technique and positions established by the Interna-157 tional Biological Program (Weiner and Lourie 1981). Body 158 fat mass was assessed from four skinfold thickness meas-159 urements according to Durnin and Rahaman (1967). Lean 160 body mass (LBM) was calculated by subtracting body fat 161 mass from BM. 162

Stage of development: the same pediatrician assessed the 163 level of pubertal maturation by analyzing pubic hair growth 164 according to Tanner's five stages (Tanner 1962). The three 165 age groups corresponded to three maturational groups: pre-166 pubertal, stage I (groups I and IV), pubertal, stages II and III 167 (groups II and V) and post-pubertal, stages IV and V (group 168 III). In this classification, stage 1 represents the immature, 169 prepubertal state, while stage 5 represents fully matured 170 adolescence. 171

Gas exchange measurements: a nose clip and a buccal 172 piece were attached to subjects. During exercise, the sub-173 jects breathed through a low-resistance valve (Warren E. 174 Collins, Inc., Mass., USA) attached to a large tubing (i.d. 175 3.5 cm) into a 5 L mixing chamber. Inspiratory airflow was 176 measured with a Fleisch no. 3 pneumotachometer (Godard, 177 Statham, Hollande) and a pressure transducer (MP 45, Vali-AQ5 18 dyne, Engineering Corp., Calif., USA) with a measuring 179 range of  $\pm 2$  cmH<sub>2</sub>O. The pneumotachograph was placed on 180 the inspiratory line to avoid problems linked to water vapor. 181 Calibration of the flow module was accomplished by intro-182 ducing a measured volume of air for several flows. Expired 183 gases were sampled in the mixing box and analyzed for oxy-184 gen (O<sub>2</sub>) with a polarographic analyzer (OM 11, Sensormed-185 ics Corp., Calif., USA). Carbon dioxide (CO<sub>2</sub>) was analyzed 186 with an infrared analyzer (Diamant 6000, Cosma, France). 187 Gas analyzers were calibrated before and after each test with 188 standard gases. Inspiratory flow and fractions of expired O<sub>2</sub> 189 and CO<sub>2</sub> were treated by a computer that calculated the fol-190 lowing parameters from 10 breathing cycles:  $\dot{V}_E$ ,  $V_T$ , fr,  $\dot{V}$ 191  $O_2$  and  $\dot{V}CO_2$ . 192

flow (MEF) forced expiratory volume in 1 s (FEV<sub>1</sub>), and vital capacity (VC) were measured on this occasion.

## **Statistical analysis**

All examinations, as well as tests, were carried out in the 201 schools. Clinical examination and an electrocardiogram 202 203 were carried out at the beginning of the testing procedure. During the clinical examination, the anthropometric meas-204 urements were taken. Each subject was then asked to per-205 206 form a maximal incremental step test in a sitting position on a cycle ergometer (EPS 990, Bodyguard Jonas Ogland AS, A.06 Norway). The electrocardiogram was continuously moni-208 tored with a cardio scope (Diascope Simonsen and Weel, 209 Denmark). A continuous progressive protocol was used: 210 after 3 min of warm-up, exercise intensity was increased 211 until exhaustion. For children from age 10.8 to 12 years, 212 the exercise intensity was increased by steps of 20 W.min<sup>-1</sup> 213 and for the other children, by steps of 30 W.min<sup>-1</sup>. The chil-214 dren were instructed to maintain a constant pedaling rate of 215 50 rpm and were actively encouraged throughout the test. 216 The ventilatory measurement was taken during the last 30 s 217 of each exercise period.  $\dot{VO}_{2max}$  was achieved when three 218 of the following criteria were obtained: a steady heart rate 219 (HR) at a value close to the theoretical maximal HR, a res-220 221 piratory exchange ratio (R) greater than 1.1, a constant VO<sub>2</sub> despite the increased exercise intensity and the impossibility 222 for the subject to maintain a pedaling rate of 50 rpm.  $\dot{V}_{Emax}$ 223 was defined when VO2max was achieved. HR was measured 224 from five recorded ventricular complexes after each effort. 225 All subjects performed the same testing protocol 12 and 226 227 24 months later.

Lung function: the measurements of the flow-volume 228 loops and volume-time curve were performed on a digital 229 spirometer (Datalink pulmochart). The maximum expiratory 230

All values are given as means  $\pm$  SEM. One-way analysis 234 of variance was used to measure the annual effects, in all 235 groups, of age on anthropometric characteristics and ventila-236 tory parameters. Concerning boys, the measurements were 237 performed from  $11.2 \pm 0.50$  to  $13.2 \pm 0.83$  years in group I, 238 from  $12.9 \pm 0.71$  to  $14.8 \pm 0.89$  years in group II and from 239  $14.9 \pm 0.75$  to  $16.9 \pm 0.77$  years in group III. Concerning 240 girls, the measurements were performed from  $11.2 \pm 0.61$ 241 to  $13.0 \pm 0.57$  years in group IV and from  $12.9 \pm 1.11$  to 242  $14.9 \pm 1.72$  years in group V. Student's t test was used to 243 compare the values of parameters between groups I and II 244 (in boys) and IV and V (in girls) at 13 years and between 245 groups II and III (in boys) at 15 years. To study the changes 246 of ventilatory response with age at different percentages of 247  $\dot{VO}_{2max}$  (30%, 60% and 90%), we determined the best regres-248 sion equation that related each subject's ventilatory response 249 to the percentage of  $\dot{VO}_{2max}$ . The relationships were expo-250 nential for  $\dot{V}_{E}$  and fr and logarithmic for  $V_{T}$ . For each of 251 these relationships, the correlation coefficients were high. 252 We then calculated the values of the different ventilatory 253 parameters for each percentage of  $\dot{VO}_{2max}$ . The changes of 254 ventilatory response with age at different percentages of 255 VO<sub>2max</sub> were tested by one-way analysis of variance for 256 repeated measurements completed by a Newman-Keuls 257 test when the ANOVA F ratio was significant (p < 0.05). 258 The analyses were carried out on all ventilatory parameters, 259 whether expressed as absolute or relative values, and for all 260 age groups. Values of p < 0.05 were considered significant 261 throughout the study. 262

To compare the kinetics of the ventilatory variables as a 263 function of age, sex and at the three different intensities, we 264 used a two-way analysis of variance for repeated measurements 265 completed by a Newman-Keuls test when the ANOVA F ratio 266 was significant (p < 0.05). This analysis of variance was used 267 only for groups I (from  $11.2 \pm 0.50$  years to  $13.2 \pm 0.83$  years) 268

Height, BM and LBM increased (p < 0.05) in groups I, and III for boys (Table 1) and in groups IV and V for given by the second secon (Table 2). Concerning boys, no significant differences we observed between groups I and II at 13 years and betwe groups II and III at 15 years. Differences (p < 0.05) we observed in girls between groups IV and V at 13 year regarding BM and LBM. The time spent in extracurricu physical activities does not change significantly regardle of the sex and age of the subjects (Tables 1 and 2). Maximal oxygen uptake and ventilatory threshold

Concerning boys,  $\dot{VO}_{2max}$  in  $1.min^{-1}$  increased (p < 0.0284 in groups I and II and  $\dot{VO}_{2max}$  in ml.min<sup>-1</sup>.kg<sup>-1</sup> increas 285 (p < 0.05) only in group I (Table 3). Concerning give 286 (Table 4),  $\dot{V}O_{2max}$  in  $1.min^{-1}$  increased (p < 0.05) only 287 group IV and no significant difference was observed in a 288 group regarding VO<sub>2max</sub> in ml.min<sup>-1</sup>.kg<sup>-1</sup>. V<sub>Th</sub> in l.min 289 increased (p < 0.05) in groups II and III for boys and 290 groups IV and V for girls. Concerning boys, difference 291 (p < 0.05) were observed at 13 years between groups I and 292 regarding  $\dot{V}O_{2max}$  in ml.min<sup>-1</sup>.kg<sup>-1</sup> and at 15 years betwee 293 groups II and III regarding V<sub>Th</sub> in % VO<sub>2max</sub>. Concer 294 ing girls, a difference (p < 0.05) was observed at 13 years 295

between groups IV and V regarding  $V_{Th}$  in 1.min<sup>-1</sup>.

Concerning boys (Table 5),  $\dot{V}_{Emax}$ , FEV<sub>1</sub> and VC increas 299 (p < 0.05) in groups I, II and III, and MEF increased or 300 in group II. Concerning girls (Table 6), V<sub>Emax</sub> increas 301 (p < 0.05) in group IV, FEV<sub>1</sub>, and VC increased (p < 0.05)302 in groups IV and V and no significant change was observ 303 regarding MEF. No significant difference was observed f 304 any parameters at 13 years between groups I and II (in boy 305 and IV and V (in girls) and at 15 years between groups 306 and III (in boys). 307

#### Changes in ventilatory response according to age 308 and exercise intensity 309

Expressed in absolute value. Concerning boys (Fig. 1), 310 increased (p < 0.05) in groups I and II at all three intensities. 311 In group III,  $\dot{V}_E$  also increased (p < 0.05) but only at 60% and 312

90% $\dot{V}O_{2max}$ . For V<sub>T</sub>, increases (p < 0.05) were observed in all 313 three groups and at all three intensities. Finally, no signifi-314 cant change was observed for fr in all three groups and at all 315 three intensities and no significant differences were observed 316 between groups I and II at 13 years and between groups II 317 and III at 15 years for any of the ventilatory parameters. Con-318 cerning girls (Fig. 2),  $\dot{V}_{\rm F}$  increased (p < 0.05) in group IV at 319 all three intensities and no significant increase was observed 320 in group V. For  $V_T$ , increases (p < 0.05) were observed in 321 group IV at all three intensities. In group V, V<sub>T</sub> also increases 322 (p < 0.05) but only at 60% and 90%  $\dot{VO}_{2max}$ . Finally, fr tended 323 to stabilize in both groups at all three intensities, with no sig-324 nificant change observed. For  $V_T$ , differences (p < 0.05) were 325 observed between groups IV and V at 13 years. 326

Expressed in relative value. Concerning boys, no significant 327 changes were observed for  $\dot{V}_E kg^{-1}$ , which tends to stabilize 328 in all three groups and at all three intensities (Fig. 3).  $V_T$ .kg<sup>-1</sup> 329 increased (p < 0.05) in group I at 60% and 90%  $\dot{VO}_{2max}$  and in 330 group II but only at 90%VO<sub>2max</sub>. No other significant changes 331 in V<sub>T</sub>.kg<sup>-1</sup> were observed in group III and no significant differ-332 ences between groups I and II at 13 years and between groups 333 II and III at 15 years were observed for any of the ventila-334 tory parameters. Concerning girls, except for a significant dif-335 ference of  $\dot{V}_{E}$ .kg<sup>-1</sup> and  $V_{T}$ .kg<sup>-1</sup> in group IV at 30% $\dot{V}O_{2max}$ 336 between 12 and 13 years, these parameters tend to stabilize in 337 groups IV and V (Fig. 4). A difference (p < 0.05) was observed 338 between groups IV and V at 13 years for  $\dot{V}_E kg^{-1}$  at 30%  $\dot{V}$ 339 O2max. No other significant difference was observed at 13 years 340 between groups IV and V. 341

# Changes in ventilatory response according to age, exercise intensity and sex

Expressed in absolute values. Figure 5 shows that  $\dot{V}_E$  in boys was significantly higher than that of girls from 11 to 13 years and from 13 to 15 years at either 30% (p < 0.01), 346 60% (p < 0.01) or 90%  $\dot{VO}_{2max}$  (p < 0.05). No other significant differences were observed for V<sub>T</sub> and fr. 348

Expressed in relative values. No significant difference 349 was observed for  $V_T \cdot kg^{-1}$  (Fig. 6). In contrast,  $\dot{V}_E \cdot kg^{-1}$  was 350 significantly higher (p < 0.05) between 11 and 13 years in 351 boys compared to girls at 30%, 60% and 90%  $\dot{V}O_{2max}$ . No significant difference between boys and girls was observed 353 between 13 and 15 years. 354

Important note: for the sake of clarity, some results of the355study were included in the "supplementary material" section356placed at the end of the manuscript. This supplementary357data comprise the changes in ventilation according to carbon358dioxide output and the changes in respiratory carbon dioxide359equivalent according to oxygen uptake.360

## Discussion

The aim of this semi-longitudinal study was to specify in boys and girls the changes, during growth, of submaximal ventilatory response during a maximal incremental test. Our results show significant changes in ventilatory response with age and sex, whether expressed in absolute or relative values. 366

## The effects of age and sex on ventilatory response 367

Robinson (1938) showed that  $\dot{V}_E$  increased from 6 to 368 17 years during a standardized treadmill walk test at con-369 stant intensity. The results of Rutenfranz et al. (1981) cor-370 roborated those of Robinson (1938). They found that  $\dot{V}$ 371  $_{\rm F}$  increased from 12 to 15 years and then stabilized until 372 17 years. While our results, up to 15 years, agree with those 373 of Rutenfranz et al. (1981), they showed that  $\dot{V}_E$  increased 374 significantly up to age 17 at the highest exercise intensities 375 (Fig. 1). These results agree with the results of our previous 376

study (Prioux et al. 1997) and those of this study (Table 5), 377 which showed that  $\dot{V}_{\text{Emax}}$  increased significantly between 378 15 and 17 years (Table 5). However, the  $\dot{V}_E$  values observed 379 by Rutenfranz et al. (1981) at 12, 15 and 17 years seem 380 higher than those of our study at 60% of  $\dot{VO}_{2max}$ . These 381 differences can probably be explained by the methodolo-382 gies used. Indeed, Rutenfranz et al. (1981) measured V 383  $_{\rm F}$  at the same exercise intensity (between 50 and 70% of 384  $\dot{V}O_{2max}$ ) whereas we evaluated  $\dot{V}_E$ ,  $V_T$  and fr at three dif-385 ferent intensities (below 30% of  $\dot{V}O_{2max}$ , around 60% of  $\dot{V}$ 386  $O_{2max}$  and above 90% of  $\dot{V}O_{2max}$ ). Regardless of the meth-387 odological differences discussed previously, the slightly 388 higher exercise intensity in the study by Rutenfranz et al. 389 (1981) compared to ours could also explain the differences 390 of  $\dot{V}_E$  between our studies. Indeed, at these exercise inten-391 sities, the increase in  $\dot{V}_E$  is exponential: a small increase 392 in intensity leads to a proportionally larger increase in  $\dot{V}_E$ 393 (Wasserman et al. 1973). Rutenfranz et al. (1981), in their 394 study, were also interested in changes in  $V_{\rm F}$ , as a function of 395 age, in girls. These changes appear to be different than for 396 boys. Indeed, their results showed that  $\dot{V}_E$  did not increase 397 for exercise intensities between 65 and 70% of  $VO_{2max}$ , and 398 that it remained stable between 12 and 17 years. Similar 399 results were observed by these authors for lower exercise 400 intensities, i.e., between 50 and 65% of VO<sub>2max</sub>. Our results 401 were not fully in agreement with those of Rutenfranz et al. 402 (1981). They showed no significant increase in  $\dot{V}_E$  between 403 13 and 15 years, regardless of exercise intensity, with a sig-404 nificant increase in  $\dot{V}_E$  between 11 and 13 years (Fig. 2). 405 However, these results agree with those observed in  $\dot{V}_{Emax}$ 406 (Table 6). Indeed, they showed that  $\dot{V}_{Emax}$  increased signifi-407 cantly between 11 and 13 years without any change between 408 13 and 15 years. Given the relationship between BM, LBM 409 and  $\dot{V}_{Emax}$  (Mercier et al. 1991; Armstrong and Welsman 410 2020) it is likely that  $\dot{V}_{Emax}$  did not increase significantly 411 between 13 and 15 years because BM and LBM also did not 412 increase during this period. Finally, regarding the differences 413 in ventilatory response between boys and girls, our results 414 agree with those of Rutenfranz et al. (1981) which showed, 415 from the age of 12 years, a significantly higher  $V_E$  in boys 416 than girls for the same percentage of  $\dot{VO}_{2max}$ . Our results 417 also seem to agree with those of Armstrong et al. (1997). 418 The results of this study showed that  $\dot{V}_E$  was significantly 419 higher in boys than in girls, either between 70 and 75% of  $\dot{V}$ 420  $O_{2max}$  or between 80 and 85% of  $\dot{V}O_{2max}.$ 421

Similar to  $\dot{V}_E$ , few studies have analyzed the changes 422 in V<sub>T</sub> and fr during submaximal intensity exercise. First, 423 while no significant differences were observed between 424 groups I and II at 13 years and between groups II and 425 III at 15 years in boys, significant differences in  $V_T$  were 426 observed at 13 years between groups IV and V in girls 427 (Fig. 2). Indeed, regardless of exercise intensity,  $V_T$  at 428 13 years in group IV was always higher than  $V_T$  in group 429

V. These differences seem to be directly related to anthro-430 pometric characteristics. Indeed, BM and LBM are the 431 anthropometric characteristics that best explain the 432 changes in  $\dot{V}_{Emax}$  and  $V_{Tmax}$  during growth (Mercier et al. 433 1991; Armstrong and Welsman 2020) and BM and LBM 434 were significantly higher among 13-year-old girls in group 435 IV (Table 2). However, when  $V_T$  was expressed relatively 436 to BM (Fig. 4) the significant differences disappeared. 437 438 The significant differences in BM and LBM at 13 years between groups IV and V can probably be explained by 439 the small number of subjects (n = 7) in each group of girls 440 441 and by heterogeneity in pubertal maturation levels between girls in groups IV and V. 442

Second, the significant increase in  $\dot{V}_{F}$ , up to 17 years in 443 boys, was due to a significant increase in VC, and there-444 fore,  $V_T$  (Prioux et al. 1997), while fr tended to decrease 445 (Fig. 1) but without significant change. Robinson's (1938) 446 results showed that V<sub>T</sub> was 430 ml in the youngest chil-447 dren (6 years) and 1.73 l in the oldest (17 years). The study 448 by Andersen et al. (1974) corroborated these results. They 449 showed, for a relative intensity between 50 and 60% of  $\dot{V}$ 450  $O_{2max}$ , an increase in  $V_T$  from  $530 \pm 100$  to  $1760 \pm 740$  ml 451 in boys and from  $460 \pm 120$  to  $810 \pm 100$  ml in girls. Our 452 study's results appear to be consistent with those outlined 453 above. Indeed, a significant increase was observed in  $V_T$ 454 from 11 to 13 years, 13-15 years, and 15-17 years, regard-455 less of exercise intensity. In girls, V<sub>T</sub> also increased sig-456 nificantly from 11 to 13 years and 13-15 years in group 457 V except for V<sub>T</sub> between 13 and 15 years at  $30\% \dot{VO}_{2max}$ 458 (Fig. 2). The fact that the increase in  $V_T$  can be explained 459 by the increase in VC, as indicated above, agrees with (i) the 460 significant increase in FEV<sub>1</sub> and VC in boys (Table 5) and 461 girls (Table 6), (ii) the linear relationships between  $FEV_1$ , 462 VC and V<sub>Tmax</sub> during growth (Rutenfranz et al. 1981), (iii) 463 the fact that only half of the lung volume capacity is consid-464 465 ered during maximal exercise (Rutenfranz et al. 1981) and most importantly (iv) the significant increase in  $\boldsymbol{V}_{\text{Tmax}}$  and 466 VC up to 17 years, which justifies the stability of the  $V_{Tmax}$ / 467 468 VC ratio between 11 and 17 years (Prioux et al. 1997).

Third, the few studies focusing on fr during growth have 469 shown a decrease in fr when age increased. Robinson (1938) 470 observed that fr decreased in boys aged 6-17 years. Data 471 from Andersen et al (1974) were similar to those of Ruten-472 franz et al. (1981) and confirmed those of Robinson (1938). 473 Rutenfranz et al. (1981) have shown that an exercise car-474 ried out at an intensity between 65 and 70% of  $\dot{VO}_{2max}$  in 475 children aged 12-17 years induced a decrease in fr from 476 39 to 28 breaths.min<sup>-1</sup> in boys and from 38 to 26 breaths. 477 min<sup>-1</sup> in girls. These fr values were very close to those 478 we observed at 60% of  $\dot{VO}_{2max}$  especially in boys (Fig. 1). 479 Andersen et al. (1974) showed a decrease in fr, relatively to 480 age, when children aged 8-16 years exercised on a bicycle 481 ergometer at 50–60% of  $\dot{V}O_{2max}$  intensity or 70–80% of  $\dot{V}$ 482 O<sub>2max</sub> intensity. Rowland and Cunningham (1997) showed 483 that fr decreased from 45 to 36 breaths.min<sup>-1</sup> in children 484 aged 9-13 years. Finally, Ondrak and McMurray (2006) 485 found that fr decreased with age regardless of exercise inten-486 sity. The results we observed in boys (Fig. 1) were consistent 487 with those in the literature. Indeed, although not significant, 488 fr tended to decrease in all age groups and for each intensity. 489 A full longitudinal study conducted from 11 to 17 years of 490 age could have shown a significant decrease for this param-491 eter. The results observed in girls are more difficult to inter-492 pret. Indeed, Fig. 2 seems to indicate a tendency of fr to sta-493 bilize during growth. However, the comparison of fr kinetics 494 as a function of sex (Fig. 5) showed no significant difference 495 between girls and boys, which was consistent with the litera-496 ture (Robinson 1938; Andersen et al. 1974; Rutenfranz et al. 497 1981). The trend of fr, with advancing age, would, therefore, 498 be to decrease for both girls and boys. 499

# The effects of age, sex, and body weight500on ventilatory response501

Height is the simplest parameter to measure when evaluating growth. It was, therefore, naturally proposed as a determining factor in the ventilatory response (Mercier et al. 1991; Rutenfranz et al. 1981; Rowland 1996). However, 505

the systematic use of height as a determinant of  $V_{\rm Emax}$ , 506 recommended by Rowland, (1996), is relativized by the 507 study of Mercier et al., (1991). Indeed, for these authors, 508 BM and LBM are the anthropometric characteristics 509 that best explain the variations in  $V_{\rm Emax}$  and  $V_{\rm Tmax}$  with 510

511 growth. Thus, studies such as ours, which propose V<sub>Emax</sub> and V<sub>Tmax</sub> values only corrected by BM are not far from 512 reality (Armstrong and Welsman 2020). Likewise, the use 513 of BM also makes it possible to compare our values with 514 those in the literature. Robinson (1938) found a decrease 515 in  $\dot{V}_{\rm F}$ .kg<sup>-1</sup> for boys aged 6–17 years. Similar results have 516 been observed by Rowland and Cunningham (1997) who 517 indicated that  $\dot{V}_E$ .kg<sup>-1</sup> decreased with age without any dif-518 ference between boys and girls. More recently, Ondrak and 519 McMurray (2006) found that  $\dot{V}_{E}$ .kg<sup>-1</sup> decreased with age, 520 regardless of exercise intensity, in children 8-18 years. 521 Our results do not coincide with those of the two previous 522 studies. Indeed,  $\dot{V}_E$ .kg<sup>-1</sup> remained stable during growth 523

in boys (Fig. 3) and girls (Fig. 4) with significantly higher 524 values in boys between 11 and 13 years, regardless of 525 exercise intensity (Fig. 6). However, the comparison of 526 our results with previous studies is questionable. Firstly, 527 in the studies of Robinson et al. (1938) and Ondrak and 528 McMurray, (2006) the exercise intensities are expressed in 529 absolute values. Hence, each workload may have elicited 530 greater ventilatory responses in the younger and smaller 531 participants, compared to the older and larger participants. 532 Secondly, Rowland and Cunningham (1997) focused on 533 a small number of children (11 boys and 9 girls) and a 534 relatively small age range (9-13 years). Thus, the variabil-535 ity in exercise protocols, the use of different submaximal 536 intensities, the lack of evaluation of the subjects' body 537 composition and level of physical activity may contribute 538 to the variability of the results between the different stud-539 ies. in children. More complete analyses should be carried
out on the changes of ventilatory response at submaximal
intensities according to, for example, mechanical power
developed relative to the child's total mass.

Concerning  $V_T.kg^{-1}$ , Robinson (1938) found a small 546 increase when comparing to age:  $V_T.kg^{-1}$  increased from 547 0.021  $1.min^{-1}.kg^{-1}$  at 6 years to 0.025  $1.min^{-1}.kg^{-1}$  at 548 17 years. More recently, Ondrak and McMurray (2006) 549

showed that V<sub>T</sub>.kg<sup>-1</sup> decreased with age, regardless of exer-550 cise intensity, in children aged 8-18 years. These results are 551 not in agreement with those of Rowland and Cunningham 552 (1997). Indeed, these authors found no significant changes 553 for  $V_T$ .kg<sup>-1</sup> in boys aged 9–13 years. Our results in boys 554 showed a significant increase in V<sub>T</sub>.kg<sup>-1</sup> from 11 to 13 years 555 at 60% and 90% of  $\dot{V}O_{2max}$  and from 13 to 15 years at 90% 556 of  $\dot{VO}_{2max}$  (Fig. 3). From 15 years of age in group III and up 557 to the age of 17 years, V<sub>T</sub>.kg<sup>-1</sup> no longer increased. These 558 results suggest that, up to 15 years, the increase in  $V_T$  is 559 greater than the increase in BM at high intensities (60% and 560 90% of  $\dot{VO}_{2max}$ ). BM may, therefore, not be the best anthro-561 pometric parameter to consider when studying the changes 562 of V<sub>T</sub> during growth. The use of LBM appears to be more 563 appropriate (Mercier et al. 1991; Amstrong and Welsman 564 2020). However, these results also assume that parameters, 565 other than anthropometric characteristics, can influence the 566 changes of V<sub>T</sub>.kg<sup>-1</sup> during growth. This does not seem to be 567 the case for girls. Indeed, except for a significant increase 568 in  $V_{T}$ .kg<sup>-1</sup> between 12 and 13 years at 30% of  $\dot{VO}_{2max}$ , our 569 results showed a remarkable stability of this parameter dur-570 ing growth (Fig. 4). Finally, the evolution of  $V_T$ .kg<sup>-1</sup> during 571 growth appears to be independent of sex, since no difference 572 in  $V_T$ .kg<sup>-1</sup> was observed between boys and girls (Fig. 6). 573

## 574 Strengths and limitations

Although breathing pattern data are presented in our study 575 and helps to explain the changes in ventilation during 576 growth, we have not fully considered how ventilatory control 577 may change with age. It would be interesting (i) to add an 578 index of operating lung volume (i.e., expiratory and inspira-579 tory reserve volume) and (ii) to report P<sub>a</sub>CO2 or more practi-580 cally P<sub>FT</sub>CO2 data. Indeed, these data would provide further 581 detail regarding exercise ventilatory mechanics (i.e., pres-582 ence of dynamic hyperinflation) and ventilatory control (i.e., 583 estimates of dead space and alveolar ventilation). In addi-584 tion, we should have used a more appropriate experimental 585 model, such as a real longitudinal study from 11 to 15 years 586 in girls and from 11 to 17 years in boys, to analyze changes 587 in ventilatory responses at submaximal exercise intensities 588 during the growth spurt period (Amstrong and Welsman 589 2020). Finally, the sample size differs substantially between 590 boys and girls. Indeed, we have 54 healthy untrained boys 591 against only 14 healthy untrained girls. Moreover, we have 592 collected data from 11 to 17 years in boys and only from 593 11 to 15 years in girls. Despite the validity of our statistical 594 analyses, it would be interesting to conduct other studies 595 with more subjects of both sexes and over a longer period, 596 especially for girls, so that (i) the data can reflect the general 597 pediatric population in France and (ii) to use these data as 598 age-specific normative values for exercise performance. 599

## Conclusion

At submaximal intensities,  $\dot{V}_{E}$ , expressed in absolute val-601 ues, increases between 11 and 17 years in boys and only 602 between 11 and 13 years in girls. Increases in VC, and 603 therefore, in  $V_T$ , is the main reason for  $\dot{V}_E$  increases dur-604 ing growth.  $\dot{V}_{E}$  in boys is higher than  $\dot{V}_{E}$  in girls regardless 605 of age and exercise intensity.  $\dot{V}_{\rm F}$ .kg<sup>-1</sup> is stable in boys 606 and girls whatever the intensity of exercise with signifi-607 cantly lower values in girls compared to boys between 11 608 and 13 years, regardless of exercise intensity. In boys,  $V_T$ . AQ7 9 kg<sup>-1</sup> increases significantly from 11 to 15 years and then 610 stabilizes until the age of 17 years while  $V_T$ .kg<sup>-1</sup> tends to 611 stabilize during growth in girls with no significant differ-612 ence of V<sub>T</sub>.kg<sup>-1</sup> between boys and girls regardless of age 613 and exercise intensity. 614
