### **Notes S1: Criteria for retaining local communities, sample sizes of communities and species, calculus of phylogenetic signal, and baseline data per habitat type.**

#### Criteria for retaining local communities

From the Dutch vegetation database, we first excluded communities without information on plot size, as plot size was needed to calculate abundance, resulting in about 250,000 communities. A second filter excluded all communities containing at least one species not present in our Angiosperm phylogeny, hybrids or individuals not identified at the species level. This filter left 48,339 communities. We decided to reduce this number arbitrarily to around 10,000 to reduce computation time (4 days for 10 traits and the about 6,700 communities finally studied, see below) and tried to obtain similar numbers of communities per habitat type (i.e. about 232 communities per habitat type). We chose those communities randomly from the 48, 339 communities. However, some habitat types were represented by less than 232 communities; and we chose to exclude habitat types that had less than 25 communities to ensure representative information for each habitat type considered. Note that not all traits were available for all species and a few of the remaining habitat types had less

than 25 communities for some traits, and were hence also excluded. Overall, we retained 38 out of the 43 habitat types and 6,851 communities containing 984 angiosperm species.

Finally, we removed communities without variation in traits among species (as it can occur for ordinal traits in species-poor communities), because phylogenetic signal (PS) cannot be calculated without trait variation. This left 6,704 communities in total, and between 6,424 to 6,693 communities per trait. See Table A for the number of communities per trait and per habitat type.

### Measuring phylogenetic signal (PS)

We used a modified version of the tips/root skewness test by Pavoine et al. (2010). The advantage of this approach compared to other metrics such as Blomberg' K is that it can handle multiple traits, including quantitative, qualitative, and ordered traits (See Pavoine et al. 2010). This parameter has proven to be consistent with but more powerful than other measures to detect PS (e.g. Bennett et al. 2013). According to Pavoine et al. (2016), we calculated the functional dissimilarity among the lineages that descend from a node as:

where  $n_i$  is the  $i$ th interior node of a phylogenetic tree,  $\text{dd}_{n_i}$  is the set of direct descending nodes, which may be interior nodes or tips, that arise from the node  $n_i$ ,  $\text{dd}_{n_i}[g]$  is the  $g$ th direct descending node from  $n_i$ ,  $\text{card}(\text{dd}_{n_i})$  is the number of nodes that directly descend from

the node  $n_i$ ,  $H_\Delta(P)$  is trait diversity measured by Rao's  $Q$  (Botta-Dukat 2005) applied to  $P_{dd_{ni}}$

[g] the vector of abundance of species descending from  $dd_{ni}$  [g] and  $\Delta$  the matrix of functional distances between species. This statistic,  $w_i^*$ , corresponds to de Bello et al. (2010, Eq. 14) scaled beta diversity where the focal species assemblages here are the lineages that descend from node  $n_i$ . It varies between 0 and 1.

Then, as a modification of the S3 statistics by Pavoine et al. (2010), we calculated PS as:

$$PS = 1 - \frac{1}{N} \sum_{i=1}^N i \frac{w_i^*}{\sum_{i=1}^N w_i^*}$$

where the sum of  $w_i^*$  is over interior nodes ordered from low to high values of the sum of branch lengths between the node and the root,  $N$  is the total number of interior nodes in the phylogenetic tree (including the root node) and  $w_i^*$  is the phylogenetic dissimilarity among the lineages descending from node  $i$  as defined above. The advantage of this modification is that varies from 0 to 1, signifying low to a strong PS, respectively.

Measures were performed in R (R Core Team 2020) with function *decdiv* (with argument *option = 2* in package *adiv v2.0*, Pavoine 2020).

### **Notes S3: Definitions of species traits**

For each species, we extracted the values of 10 functional traits relevant to community assembly and ecosystem functioning (e.g. Kunstler et al. 2016) from two complementary databases: BIOLFLOR (Klotz et al. 2002) and LEDA (Kleyer et al. 2008). To match the species names between the phylogeny and the trait dataset, we checked the synonymy using the Taxonomic Name Resolution Service (TNRS: <http://tnrs.iplantcollaborative.org>, Boyle et al. 2013). From BIOLFLOR, we collated the following traits, taking the most common trait state if several states were indicated for the same species: 1) “flowering duration” in months. 2) “flowering date”, treated as a multivariate trait integrating months of flowering start and end (as in Pavoine et al. 2009). 3) “reproduction type” (coded from 1 completely vegetative, to 3 completely sexual); 4) “breeding system” (coded from 1 always allogamous, to 5 always autogamous); 5) “seed mass” (i.e. diaspore mass) in mg; 6) “seed shape” (using the scores on the second axis of a principal component analysis based on heights, lengths and widths of seeds, in cm); and 7) “life form”, ranked from entirely ephemeral, to ephemeral above ground but persistent below ground, to persistent also above ground but close to the soil surface, to persistent far above soil surface (0-Therophyte, 1-Geophyte, 2-Hemicryptophyte, 3-Chamaephyte, dwarf shrub, 4-Hemiphanoerophyte, 5-Nanophanoerophyte, and 6-Macrophanerophyte). From LEDA, we obtained: 8) “specific leaf area” (SLA) in mm<sup>2</sup>/mg; 9) “leaf dry-matter content” (LDMC) in mg/g; and 10) “maximum height” in meters. In LEDA, we also collected seed-mass data (i.e. trait 5) that were not available in BIOLFLOR. When for a trait information differed between LEDA and BIOLFLOR we calculated the mean values for quantitative traits, and we used LEDA values for qualitative traits. The number of species with trait data varied between 820 and 982 (984 species in total), depending on the trait. For details about the number of species available per trait, see Notes S1 Table A.

#### **Notes S4: Sufficient resolution of our phylogenetic tree**

We characterized the evolutionary relationships between all native species through a recent, dated phylogeny of all 1,283 species of Dutch angiosperm flora (excluding hybrids, subspecies, and exotics; Tree Base ID S13572). The data on sequences of genes, fossil calibrations, and specific analyses used to reconstruct this phylogeny have been more thoroughly described in Hermant et al. (2012) and Bartish et al. (2016). This phylogeny is consistent with, but regionally more representative than, the phylogeny of Zanne et al. (2014). Among others, our phylogeny is resolved within the older genera (>35 Myrs). As a result, the overall resolution of our phylogeny is 58%. Such a resolution permits reliable conclusions: Bartish et al. (2016) calculated from this phylogeny diversity of lineages dating back to a given geological epoch (Bartish et al. 2016) and found that they are correlated at  $r^2=0.999$  to those calculated after randomly resolving the remaining polytomies, resulting in the same conclusions in further analyses in Bartish et al. (2016, 2020). Even in less resolved phylogenies, phylogenetic signals calculated from unresolved phylogenies are very highly correlated to those calculated from randomly resolved phylogenies (Li et al. 2019; data in Seger et al. 2013 appendix 7). Finally, with a 58% resolved phylogeny even absolute values of phylogenetic signal are almost identical to those after 100% resolution (Davies et al. 2011, Molina-Venegas & Rodríguez 2017).




**Notes S5: Relationship between the standard deviation of phylogenetic signal (PS) and species richness.**



### **Notes S6: Effect of species richness on local PS in randomly sampled communities.**

Testing how species richness affects PS in randomly sampled communities. We again use reproduction type as an example. In our dataset, 977 species had a known value for the reproduction type. We randomly drew X species from the pool of 977 species and calculated phylogenetic signal in the set of X species. We considered 30 simulations per species number (X) and X varying from 4 to 976 (with a step of 1), which led to  $30 \times 973 = 29190$  simulations. Marks correspond to maxima of observed mean local species richness (blue) and of observed species pool richness (red); Note that at the smallest species richnesses, variation of PS is massive, but there is practically no tendency of PS being larger at smaller species richnesses ( $r = -0.038$ ). This is contrary to our observation for real communities (Tab. 3). Also, the PS of the random communities converges on the PS of the species pool (dotted line).

(Exclusion of one to three residual outliers, rendering stress (marginally) significant twice, and disturbance significant twice.) ## **Notes S10: Distributions of habitat types across the Netherlands**

We note that spatial position is little informative in our study system of habitats within a region of the Netherlands, in our approach of characterising each habitat type by the mean across spatially distinct patches: Across the Netherlands, none of the habitat types is geographically entirely distinct from the remaining ones, they are almost all widely scattered across the Netherlands (Figure Notes S10 1a, b). Mean spatial positions of habitat types would hence be similar to identical and would not represent the strong local mosaic of habitats types imposed by the local environmental mosaic (Schaminée et al 1995-1999), in some habitat types, the mean spatial position would even be in a zone little occupied by this very habitat type (Figure Notes S10 2 - 39). Also, within habitat types, no spatial, non-environmental patterning of species composition has been reported, neither across the Netherlands nor between the Netherlands and the adjacent countries (Schaminée et al (1995-1999) and European vegetation map (accessed at




## **Notes S12: Relationship between disturbance or stress regime of habitat types and the phylogenetic signal (PS) of traits**

Relationship between disturbance regime (UD, undisturbed vs D, disturbed) or stress regime (US, unstressed vs S, stressed) of habitat types and the phylogenetic signal (PS) of all traits except of reproduction type (which is given in Fig. 3). PS is quantified either within local communities and the mean is calculated within each habitat type (left) or across the entire species pool of each habitat type within the study region (right). N=18 habitat types. Per category of habitat types, means and 95% confidence limits are given. Mean local phylogenetic signal of reproduction type in a habitat type (left) tends to decrease with disturbance (“D” vs “UD”) and to increase with stress (“S” to “US”) (corresponding to significant effects in Table 3). At the level of habitat species pools (right) these relationships to disturbance and stress tend to disappear (corresponding to significant interaction terms of either disturbance or stress with “mean local” in Table 4). Disturbance and stress regime were ranked based on observations, i.e. names of habitat types, representing three of the possible combinations of stress and disturbance. 





**Notes S13: Effect of trait means on trait phylogenetic signal (PS) in randomly sampled communities.**

In our dataset, 977 species had a known value for the reproduction type. We randomly drew X species from the pool of 977 species with X drawn randomly between 4 and 977. We calculated the mean trait value and the phylogenetic signal in the set of X species. We repeated this process 1000 times. Random sampling of 1000 communities of five or more species with known value of reproduction type gives only a very weak relationship between means and PSs of these communities:  $r = -0.038$  (opposite to the very minor relationship to trait mean observed in Table 3). We note that this is less than for two alternative measures of PS in the literature such as Blomberg's K or K\* (Blomberg et al. 2003) which score  $r = 0.094$  and 0.086, respectively. The below figure shows the relationship between mean of reproduction type and PS across 1000 communities.
