# Wood identification of Chinese Buddhist statues in the Philadelphia Museum of Art

#### Abstract

Wood identification based on anatomical features was performed on thirty Chinese Buddhist and deity statues, preserved in the Philadelphia Museum of Art (PMA). While research on Buddhist statues' wood species in Japan has an over 70-year-old history, Buddhist statues in East Asian countries such as China and Korea have not yet been fully investigated scientifically. This research is part of a large project in which the wood species of Chinese Buddhist and deity statues from various Western museums underwent microscopic wood identification and our goal is to construct the database of wood selection for statues.

In order to know the reason for what kind of species of trees were used for sculptures in different countries, the best way would be to examine the species of wood statues made in ancient countries starting with China. However, it is believed that few wooden statues from before the 10th century have survived in China. Therefore, this survey of the tree species of Chinese wooden statues preserved in the United States was very important to compare that of wooden statues made in Japan.

In this study, aside from conventional optical microscopy, synchrotron X-ray micro tomography for very small samples was performed. The following wood species were identified for the Chinese statues: *Tilia* sp. (11 statues), *Paulownia* sp. (7 statues), *Salix* sp. (6 statues), Lauraceae (2 statues), *Pinus* subgenus Haploxylon (1 statue), *Cladrastis* sp. (1 statue), *Populus* sp. (1 statue), and *Juniperus* sp. (1 statue).

We hope this research will contribute to discussing the historical context of the statues and to elucidating the criteria of wood selection for Chinese, Korean and Japanese statues.

#### 1. Introduction

Microscopic wood species identification of important wooden cultural heritages provides meaningful information on the criteria of wood selection, a new understanding of the meaning that these wood species held in ancient times.

The choice of wood for Buddhist sculptures seems to have been important to the Buddhist devotee.

The historical Buddha lived in India, 5th to 4th century BC. According to an Indian legend, the first image of the Buddha was made from sandalwood, a material being even or superior to gold. Therefore, sandalwood was considered to be the best wood for carving Buddhist images. Buddhism was introduced to China via the Silk Road devotees and traders from the west, probably in the first century AD.

In the 630s AD the Chinese pilgrim Xuanzang (AD 602-664) brought a sandalwood copy of the supposedly original sculpture back to China, and thereby initiated the East Asian iconography of this type.

Recently, several wood identifications of Buddhist statues have been conducted little by little in East Asia. In Japan, scientific wood identification from the 8th century statues have been conducted jointly by art historians and wood anatomists (Kaneko *et al.*: 1998, 2003, 2010). The selection of *Torreya nucifera* for the 8th century AD statues is referring to an ancient sacred text that mentions the use of the so-called *haku* (Cupressaceous wood in China) as a substitute for *Santalum album* for statues and that this selection might have brought to Japan with the arrival of the monk Jianzhen (Ganjin in Japanese, 688-763) in Japan.

In South Korea, in the Joseon Dynasty (AD 1392-1897) wood identification showed that *Gingko biloba, Alnus* sp., *Pinus densiflora, Pinus koraiensis, Salix* sp., and *Tilia* sp. were frequently used (Jeong: 2013). The major species used for Buddhist statues is *Gingko bi-*

*loba* in South Korea, a tree known to have been introduced to Korea from China with Buddhism (Jeong: 2013).

As for Chinese Buddhist sculptures, *Paulownia* sp., *Salix* sp., *Tilia* sp., and *Populus* sp. (Mertz and Itoh: 2010, Tazuru: 2020 accepted) have been revealed to be used. For instance, the identification of the wood species in the Metropolitan Museum of Art's collection in New York was conducted in 2010 (Mertz and Itoh: 2010), and of the twenty-eight wood sculptures selected for species identification, nine were found to be made of *Salix* sp., eight of *Paulownia* sp., five of *Tilia* sp., three of *Santalum album*, two of *Juniperus* sp. and one of *Populus* sp.

Compared to the large number of wood identification for Japanese Buddhist statuary, that for Chinese and Korean Buddhist statues are much less. Therefore, our approach is to focus on wood species identification of mainly Chinese Buddhist wooden statues in Western Museums, where a great number of religious sculptures are preserved. By comparing the wood species used for Buddhist sculptures in various East Asian countries, we aim to elucidate the relationship and historical background of the spread of Buddhist sculptures, and to gain new insights for art historical research.

This study investigates the wood species of Chinese Buddhist and deity statues preserved in the Philadelphia Museum of Art (PMA, https://www.philamuseum.org/collections/search.html). The museum has a large collection of Chinese wood sculptures that are rarely found in Japanese museums and galleries.

In this research, we applied the conventional preparation method and the synchrotron X-ray micro tomography (SRX-ray  $\mu$ CT) method (Tazuru-Mizuno and Sugiyama : 2019, Hwang *et al.* : 2020, Mizuno *et al.* : 2020) for the wood identification of the wooden statues.

#### 2. Materials and methods

In this study, wood identification was performed on 42 samples from thirty Chinese sculptures, preserved in the Philadelphia Museum of Art (PMA). Especially for some statues, which present joined wood block construction, two or three samples from different parts were taken. The statues were all assumed to be made from the 7th to the 17th centuries AD (Table 1).

The methods used are conventional microscopy, and SRX-ray  $\mu$ CT. In cooperation with the curator and conservators, wood samples were collected in the Philadelphia Museum of Art. Small samples were taken by a scalpel from the underside of the sculpture, from cracks and from a hollowing without harming the integrity of the sculptures.

The samples were prepared for wood identification at the Research Institute for Sustainable Humanosphere, Kyoto University, Japan.

First, the samples were soaked in water for softening. For the following preparation of the microscopic slides, thin slices were taken from the samples by using single razor blades in cross, radial and tangential directions (15µm to 30µm thick). The slices were heated on a hotplate in glycerin: ethanol (= 1:1) to remove the internal air bubbles, and enclosed with Gum-chloral. The slides were studied under the optical microscope (Olympus BX51, Japan), and photos were taken by a digital camera (Olympus DP70, Japan).

Five samples, marked by two stars\*\* in Table 1, namely (1929-8-6\*\*), (1990-75-3-B\*\*), (1929-8-7-A\*\*), (1929-8-10-B\*\*) and (1929-8-2\*\*) were too small and fragile for optical microscopic preparation, therefore, SRx-ray  $\mu$ CT was undertaken at BeamLine20XU (BL20XU) in SPring-8, a large synchrotron radiation facility in Hyogo Prefecture, Japan. As reported in the past (Tazuru-Mizuno and Sugiyama: 2019, Hwang

et al.: 2020, Mizuno et al.: 2020), we have made it possible to identify wood species using SRX-ray μCT. Tiny and fragile samples with a size of 1 mm  $\times$  1 mm  $\times$  2 mm was fixed on a designed stage of the SRX-ray µCT equipment. Transmitted images obtained thorough the beamline 20XU were recorded by a Hamamatsu High Resolution camera (resolution is 0.472 µm/pixel). Reconstituted images were further analyzed with the "VGStudio" and "ImageJ" software. The thickness of wood sections should be around 10-20 µm for wood identification, based on microscopy. Each original reconstituted slice made by the SRX-ray µCT was under 0.5 µm thick, therefore it was necessary to increase the depth information, in order not to lose the anatomical information. For this purpose, about 24 slices were integrated, and approximately 12 µm thick pseudomicrographs prepared. The anatomical characteristics were referenced from previous publications (Wheeler et al.: 1989, Richter et al.: 2004). For identification, we also referred to the Wood Diversity HSDB network (http://database.rish. kyoto-u.ac.jp/cgi-bin/bmi/en/namazu.cgi) in Japan.

#### 3. Results

Wood identification was performed on the thirty Chinese wood sculptures. As a result, the following wood species were identified: *Tilia* sp. (11 statues), *Paulownia* sp. (7 statues), *Salix* sp. (6 statues), Lauraceae (2 statues), *Pinus* subgenus Haploxylon (1 statue), *Cladrastis* sp. (1 statue), *Populus* sp. (1 statue), and *Juniperus* sp. (1 statue). Four important Buddhist statues from China are shown in Fig. 1. Details are described below.






Fig. 2(continued)

The optical micrographs and pseudo-sections constructed from the SRX-ray µCT dataset of these images are shown in Fig 2. One sculpture and its pedestal (2013-74-1) are made of two different species: Tilia sp. and Magnolia sp., respectively. In statue 1929-8-11, two samples were identified: Paulownia sp. was used for the proper left, upper thigh, and *Pinus* sp. Haploxylon was used in a detached sample from the proper right thigh. As Paulownia sp. was used for upper left thigh, the sample made of *Pinus* sp. Haploxylon could have been from an alternative material for repair, maybe. Although it is difficult to determine whether the detached sample made of Pinus sp. Haploxylon is original wood or a wood used for repair by naked eyes, the fact that different species were used is an important finding for future research. In all the other seven cases (acc. Nos. 1929-20-1, 1929-20-2, 1925-53-12, 1990-75-3, 1929-8-7, 1929-8-10, and 1929-8-9), two or three samples were collected from different parts with the same species identified for all parts (Table. 1).

Fig. 2.1 shows the pseudo-optical micrographs of wood sample 1929-8-6\*\*, reconstructed from the synchrotron μCT dataset. From the pseudo-optical micrographs, the following features can be observed.

Growth ring boundary distinct (Fig. 2.1.a). The wood is diffuse-porous to semi-ring-porous (Fig. 2.1.a). Solitary vessel outline is angular (Fig. 2.1.a). Axial parenchyma is in marginal or in seemingly marginal bands. Helical thickenings are observed on inner vessel walls (Fig. 2.1.b). Intervessel pitting is alternate, and all ray cells are procumbent (Fig. 2.1.c). From the above-described features, the wood is identified as *Tilia* sp.

Fig. 2.2 shows the micrographs of wood sample 1929-20-1. The growth ring boundary is distinct and it shows ring-porous wood (Fig. 2.2.a). Tyloses is observed (Fig. 2.2.a). Vessel pores are arranged in multiples of 2 and round in outline (Fig. 2.2.a). The perforation plate is simple, and rays are homogeneous (Fig. 2.2.b, c). From the above-described features, the wood is identified as *Paulownia* sp.

Fig. 2.3 shows the micrographs of wood sample 1925-53-10. Growth ring boundaries are not observed; diffuse-porous wood is observed (Fig. 2.3.a). Intervessel pitting is alternate, and rays are exclusively uniseriate and heterogeneous (Fig. 2.3.b). Body ray cells are procumbent with one row of upright and / or square marginal cells. Perforation plate is simple (Fig. 2.3.c). From the above-described features, the wood is identified as *Salix* sp.

Fig. 2.4 shows the micrographs of wood sample 1925-53-11. The growth ring boundary is distinct and it shows ring-porous wood (Fig. 2.4.a). Axial parenchyma is confluent. Intervessel pitting is alternate and the shape of the alternate pits is polygonal. The perforation plate is simple and helical thickenings are observed in vessel elements (Fig. 2.4.b.c). Vessel-ray pits are with distinct borders. From the above-described features, the wood is identified as *Cladrastis* sp.

#### 4. Discussion

In our research at the Philadelphia Museum of Art, the main wood species identified in the wood sculptures were Tilia sp., Paulownia sp., and Salix sp. The wood identification data at the PMA were compared with the analysis of Chinese sculptures in the Metropolitan Museum of Art's collections (Mertz and Itoh: 2010). Table 2 summarizes the wood species and their period in the PMA. Although the total number of sculptures was limited, Tilia sp. was used constantly from the 7th to 17th century AD. Interestingly, the usage of *Paulownia* sp. was concentrated in the 10th to 13th century AD. Our recent research in the Museum of Fine Arts, Boston, one sculpture (made from the 10th to 13th century AD) was also made of *Paulownia* sp. (unpublished). The use of Paulownia sp. might be a key factor to estimate the date of sculptures in China. In our research, no sculpture made of the sacred sandalwood was identified in the PMA so far. Nevertheless, wood identification results on thirty Buddhist statues gave very useful information to expand our database on wood species used for Chinese statues, and to consider Chinese historical wood selection for statues. In order to know whether the reason for the use of *T. nucifera* in Japanese wood carvings originated from the choice of wood in ancient China, wood identification of Chinese and Korean wood

statues would bring the important hint. However, it is believed that few wooden statues from before the 10th century have survived in China and Korea. Therefore, this survey of tree species of Chinese wooden statues in the United States is very important to understand the history of Japanese wood statues and an aspect of wood selection in Japan.

We hope that this research will contribute to discussing the historical origins of statues and to elucidating the historical background of wood selection for Chinese, Korean and Japanese statues. We also hope that our research will contribute to a better understanding of the interaction of different cultural heritages.

#### 5. Conclusion

Microscopic wood identification was performed on thirty Chinese Buddhist and deity statues, preserved in the Philadelphia Museum of Art (PMA). By using both, conventional optical microscopy and synchrotron X-ray micro tomography, the following wood species were identified for the Chinese statues: *Tilia* sp. (11 statues), *Paulownia* sp. (7 statues), *Salix* sp. (6 statues), Lauraceae (2 statues), *Pinus* subgenus Haploxylon (1 statue), *Cladrastis* sp. (1 statue), *Populus* sp. (1 statue), and *Juniperus* sp. (1 statue). Our study

was conducted by wood anatomists in collaboration with art historians, curators and conservators. We believe that it is indispensable to cooperate, publish and share the results of all fields to deepen the interdisciplinary research. Our results showed a possibility of revealing differences in the wood selection between Chinese and Japanese Buddhist

statues in ancient period. This is only an initial step that opens the way for further investigations of East Asian statues. Further investigation, identification and dating of many East Asian statues preserved in Western Museums would have potential to deepen the study of Buddhist images in East Asia.

4 Cladastris sp. - Bodhisattva of Compassion/Watermoon Guanyin (Acc.No.: 1925-53-11)




Fig. 2 Micrographs (2 - 4), and pseudo-sections constructed from the SRX-ray  $\mu$ CT dataset (1): 1 Bodhisattva (Acc.No.: 1929-8-6\*\*), *Tilia* sp.; 2 Attendant Bodhisattva (Acc.No.: 1929-20-1), *Paulownia* sp.; 3 Bodhisattva (Acc.No.: 1925-53-10), *Salix* sp.; 4 Bodhisattva of Compassion/Watermoon Guanyin (Acc.No.: 1925-53-11), *Cladastris* sp.

### フィラデルフィア美術館における中国の仏像の樹種調査

米国フィラデルフィア美術館 (PMA) に保存されている中国の仏像・神像 30 躰を対象に、解剖学的特徴に基づいた木材の樹種識別を行った。日本における仏像の樹種研究は 70 年以上の歴史があるが、中国や韓国などの東アジア諸国の木彫像の樹種については未だ十分に科学的に調査されていない。本研究では、欧米の様々な博物館に所蔵されている中国の木彫像における樹種を解明する大規模なプロジェクトの一環であり、用材選択にまつわるデータベースを構築することを目的としている。

東アジア各国の木彫像にどのような樹種が使われていたのか、その理由を知るためには、中国をはじめとして古代に作られた木彫像の樹種を調べることが唯一にして最良の方法であろう。しかし、中国では10世紀以前の木彫像はほとんど残っていないと考えられている。したがって、米国で保存されている中国の木彫像の樹種を調査することは、日本の木彫像の源流を理解する上でも非常に重要である。

今回の調査では、従来の光学顕微鏡の他に、極小サンプルを対象としてシンクロトロン X 線マイクロトモグラフィーを行った。その結果、中国の木彫像では、*Tilia* sp. (11 体)、*Paulownia* sp. (7 体)、*Salix* sp. (6 体)、Lauraceae (2 体)、*Pinus* subgenus Haploxylon (1 体)、*Cladrastis* sp. (1 体)、*Populus* sp. (1 体)、*Juniperus* sp. (1 体)の樹種が確認された。本研究が、木彫像の歴史的起源の議論や、中国、韓国、日本の造像における木材選択の歴史的背景の解明に貢献することを期待したい。
