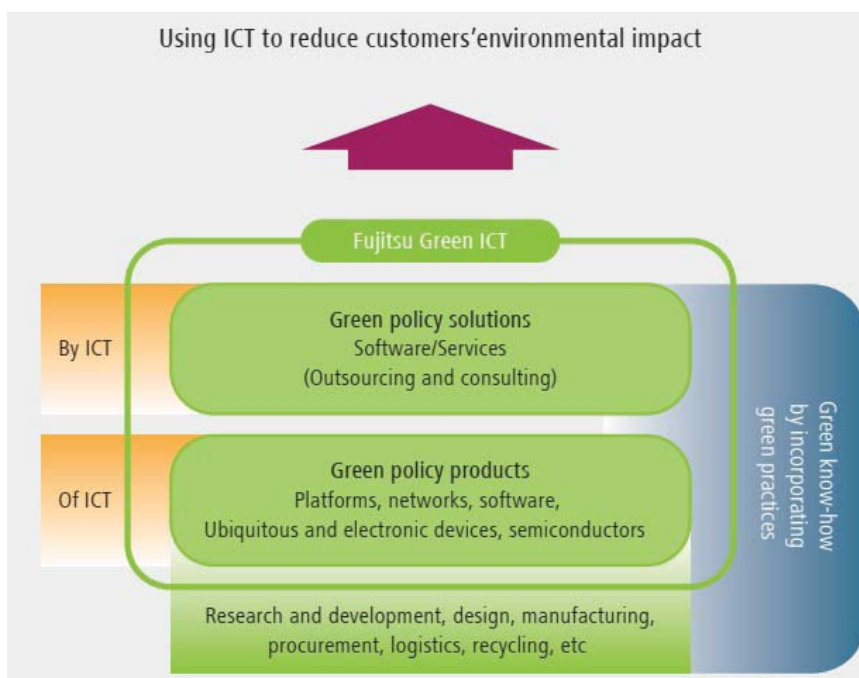

## **2. THE EFFECTS OF ICT TO CLIMATE CHANGE AND REDUCTION OF CO2 EMISSIONS**

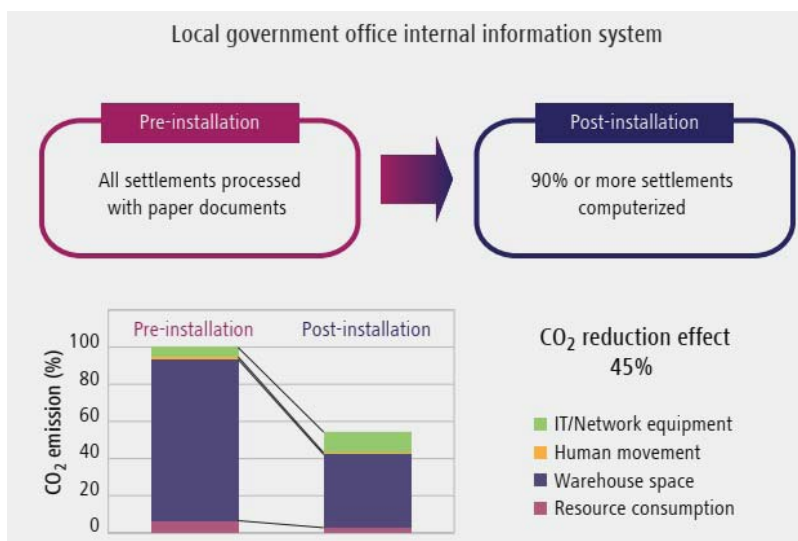

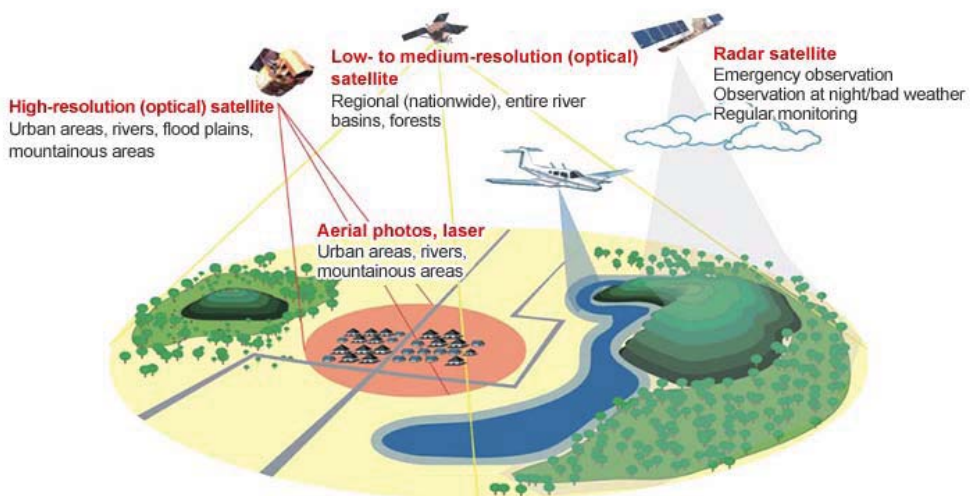

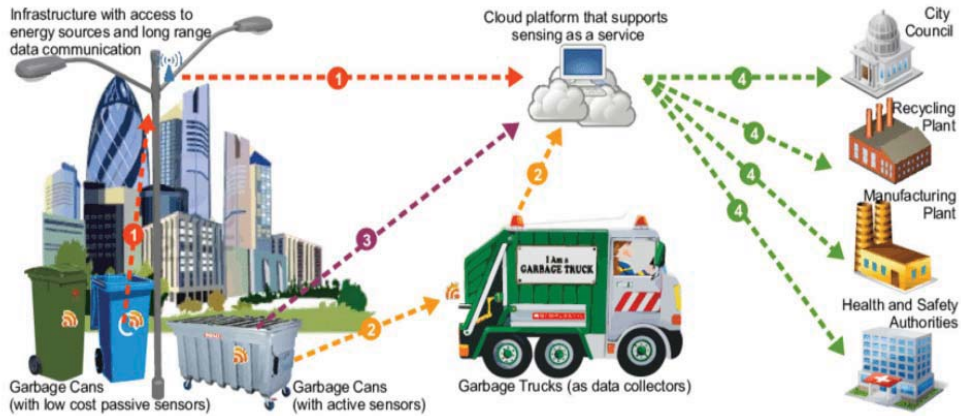


**Fig. 5.** Application of the Radar satellite data in monitoring of density of forest cover ("FOREST MONITORING").

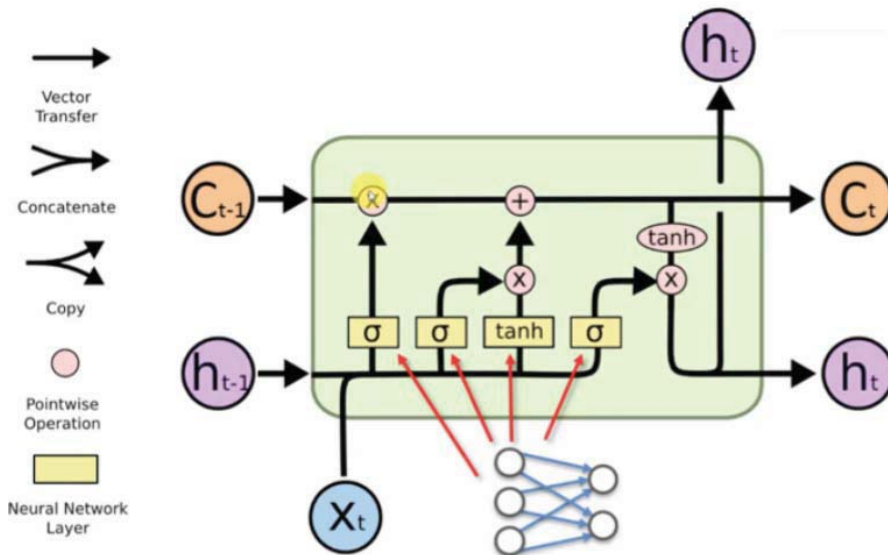
## **7. WASTE MATERIALS MANAGEMENT WITH SMART ICT**
