# On complex algebraic singularities of some genuinely nonlinear PDEs 

Denys Dutykh* and Éric Leichtnam


#### Abstract

. In this manuscript we highlight a new phenomenon of complex algebraic singularities formation for solutions of a large class of genuinely nonlinear Partial Differential Equations (PDEs). We start from a unique Cauchy datum which is holomorphic ramified like $x_{1}^{\frac{1}{k+1}}$ (and its powers) around the smooth locus $x_{1}=0$ and is sufficiently singular. Then, we expect the existence of a solution which should be holomorphic ramified around the singular locus $\mathfrak{S}$ defined by the vanishing of the discriminant of an algebraic equation of degree $k+1$. Notice, moreover, that the monodromy of the Cauchy datum is Abelian whereas the one of the solution is non-Abelian and that $\mathfrak{S}$ depends on the Cauchy datum in contrast to the Leray principle (stated for linear problems only). This phenomenon is due to the facts that the PDE is genuinely nonlinear and that the Cauchy datum is sufficiently singular. First, we investigate the case of the inviscid Burgers Equation (iBE). Later, we state a general Conjecture 9.1 which describes the expected phenomenon. We view this Conjecture 9.1 as a working programme allowing to develop interesting new Mathematics. We state also Conjecture 7.1 which is a particular case of the general Conjecture 9.1 but keeps all the flavour and difficulty of the subject. Then, we propose a new algorithm with a map $\boldsymbol{F}$ such that a fixed point of $\boldsymbol{F}$ would give a solution to the problem associate to Conjecture 7.1. Then, we perform convincing elaborate numerical tests which suggest that there should exist a Banach norm for which the mapping $\boldsymbol{F}$ should be a contraction, so that the solution (with the above specific algebraic structure) should be unique.

## Preface

In this manuscript we investigate the process of singularity formation in two examples of fully (or genuinely) nonlinear Partial Differential Equation (PDE)s starting from a single algebraic singular CaUChY datum. Namely, we consider specific ramified initial value (or CAUCHY-type) problems. In order to understand better the real singularities, our approach consists in looking at what happens in the complex domain. Thus, we formally assume that space and time variables take complex values. The analysis of the PDEs in the complex domain sheds new light on the origin of familiar real singularities. In the case of the inviscid Burgers Equation (iBE) (with an algebraic singular Cauchy datum) we are able to carry out all computations analytically using two completely different methods: Cauchy-Kovalevskaya theory and contact geometry on the space of 1 -jets. We propose a generalisation to the case of genuinely nonlinear PDEs of orders two or higher, and we state several conjectures. Moreover, for a second order PDE we propose an iterative scheme, which allows to construct efficiently approximate complex solutions. The convergence of this scheme is empirically demonstrated on a sufficient number of numerical examples, which is a good indication in favour of our conjectures. We stress out that the proposed algorithm is completely new. This scheme might be also used to show the existence and uniqueness of solutions to the ramified Initial Value Problem (IVP) corresponding to our conjectures.

In more precise mathematical terms, in this manuscript we highlight a new phenomenon of complex algebraic singularities formation for solutions of genuinely nonlinear Partial Differential Equation (PDE)

$$
P(u)(t, \boldsymbol{x})=0, \quad(t, \boldsymbol{x}) \in \mathbb{C} \times \mathbb{C}^{n}
$$

starting from a unique CaUChy datum which is sufficiently singular. More precisely, we start from a unique CAUCHY datum $u(0, \boldsymbol{x})$ which is ramified near the origin like $x_{1}^{\frac{1}{k+1}}$ around the smooth hyper surface $x_{1}=0$ and assume that $P$ is simply characteristic with respect to the co-normal of $x_{1}=0$. Then, we expect the existence of a solution to $P(u)=\underline{0}$ of a specific form (ansatz) $u(t, \boldsymbol{x})=\mathcal{A}(t, \boldsymbol{x}, z(t, \boldsymbol{x}))$, where $\mathcal{A}$ is a holomorphic function near the origin and $z(t, \boldsymbol{x})$ is a solution of an algebraic equation

$$
\begin{equation*}
z^{k+1}(t, \boldsymbol{x})-a_{k-1}(t, \boldsymbol{x}) z^{k-1}(t, \boldsymbol{x})-\ldots-a_{0}(t, \boldsymbol{x})=0 \tag{*}
\end{equation*}
$$

Thus, the solution is holomorphic ramified around the singular locus defined by the discriminant (swallow-tail) of Equation $(*)$. Since we search a solution under a special form which is ramified along a single (singular) hyper-surface we need only single CaUCHY datum. Actually, "morally" the solution is unique once we have fixed the choice of a root to the polynomial equation defined by the simply characteristic hypothesis. The fact that the solution is ramified around a singular locus and has a non-AbeLiAn monodromy whereas the Cauchy datum is ramified around a smooth locus and has Abelian monodromy is a (new) phenomenon which is due to the facts that the CaUCHY datum is sufficiently singular and that the $\operatorname{PDE} P(u)=\underline{0}$ is genuinely nonlinear. Let us provide two examples to illustrate the concept of genuine nonlinearity, while the more general definition will be
given in the formulation of Conjecture 9.1. Let $u$ be a holomorphic function

u: \mathbb{C}^{n+1} & \longrightarrow \mathbb{C} \\
\left(t, x_{1}, x_{2}, \ldots, x_{n}\right) & \longmapsto u\left(t, x_{1}, x_{2}, \ldots, x_{n}\right)

Then, the following 'initial' value problem is genuinely nonlinear
$u_{t t}-u_{x_{1}}\left(u_{x_{1} x_{1}}+u_{x_{2} x_{2}}+\ldots u_{x_{n} x_{n}}\right)=\underline{0}, \quad u(0, \boldsymbol{x})=c_{1} x_{1}+c_{2} x_{1}^{1+\frac{1}{3}}$, and the next one is not
$u_{t t}-u_{x_{2}}\left(u_{x_{1} x_{1}}+u_{x_{2} x_{2}}+\ldots u_{x_{n} x_{n}}\right)=\underline{0}, \quad u(0, \boldsymbol{x})=c_{1} x_{1}+c_{2} x_{1}^{1+\frac{1}{3}}$, where $c_{1,2} \in \mathbb{C}^{\times}$.

The full generalization of this phenomenon is stated in Conjecture 9.1 for genuinely nonlinear PDE of order greater or equal than two. Simpler versions of this Conjecture are stated in Conjecture 7.1 and Conjecture 7.2. But Conjecture 7.1 keeps all the flavour and the conceptual difficulty of Conjecture 9.1. Conjecture 7.1 considers the following PDE

$$
u_{t t}-u_{x} u_{x x}=\underline{0}
$$

along with the Cauchy datum

$$
u(0, x)=\sum_{j=1}^{N_{0}} c_{j} x^{1+\frac{j-1}{3}}
$$

where $N_{0} \in \mathbb{N}_{>2}, c_{1,2} \in \mathbb{C}^{\times}$and $\left\{c_{j}\right\}_{j=3}^{N_{0}} \subseteq \mathbb{C}$ are constants. Moreover, a root of the polynomial equation associated to the simple characteristic hypothesis is chosen. Then, Conjecture 7.1 states the existence of an algebraic solution $u(t, x)$ ramified along a cusp

$$
4 p^{3}(t, x)-27 q^{2}(t, x)=0
$$

depending on the CaUCHY datum and on the previous choice. This conjecture is a working programme allowing to develop interesting new Mathematics. The algebraic and geometric studies carried out in Sections 5 and 6 allow to construct, in Section 7, a new algorithm with a map $\boldsymbol{F}$ such that a fixed point of $\boldsymbol{F}$ provides a solution to Conjecture 7.1. In Section 8 we carry out various elaborate numerical experiments which show quite convincingly that the iterations $\boldsymbol{F}^{\circ m}\left(w_{0}\right)$ seem to converge (as $m \rightarrow+\infty$ ) to a unique fixed point. This suggests that there should exist a family of semi norms allowing to construct a Banach norm for which $\boldsymbol{F}$ would be contracting. However, this is a very difficult problem, much harder than the one treated successfully in [32] corresponding to the case of algebraic equations of degree two (see also Section 2 for a short reminder).
In the case of the inviscid Burgers Equation (iBE), we are able to carry out all the computations analytically using two completely different methods: the CauchyKovalevskaya theorem and the contact geometry approach on the space of 1 -jets. This new phenomenon is exhibited very clearly in the case of the iBE. For the most general case of genuinely nonlinear PDEs of the order higher or equal to two, we state the general Conjecture 9.1 which describes very precisely the new phenomenon previously mentioned. Conjecture 9.1 is a very difficult problem. We view it as a motivation to develop new Mathematics and, indeed, in this paper we try to lay the foundations of a proof. We also state Conjectures 7.1 and 7.2 , which are particular cases of the general

Conjecture 9.1. The Conjecture 7.1 deals with the case $k=2$ and

$$
\begin{align*}
P(u):=u_{t t}-u_{x} u_{x x} & =\underline{0}  \tag{1}\\
u(0, x) & =\sum_{j=1}^{N_{0}} c_{j} x^{1+\frac{j-1}{3}}, \tag{2}
\end{align*}
$$

where $N_{0} \geqslant 3, c_{1,2} \in \mathbb{C}^{\times}$and $c_{j} \in \mathbb{C},\left(3 \leqslant j \leqslant N_{0}\right)$ are constants, and $(t, x) \in \mathbb{C}^{2}$. Morally, Conjecture 7.1 is not much easier than Conjecture 9.1 but its simpler formulation allows for direct numerical verifications.

We revisit and improve the geometric study of the algebra $\mathcal{O}[z]$, where $z^{3}=p z+q$ and $\mathcal{O}$ denotes the algebra of germs of holomorphic functions $\{a(p, q)\}$ near the origin $\mathbf{0} \in \mathbb{C}^{2}$. This study allows us to construct a new algorithm (and the corresponding ansatz) along with a mapping $\boldsymbol{F}$ such that a fixed point of $\boldsymbol{F}$ gives a solution to the Problem $\left(* *_{1}\right),\left(* *_{2}\right)$. We provide various numerical experiments which show that that the iterations $\boldsymbol{F}^{\circ m}\left(w_{0}\right)$ seem to converge numerically (when $m \rightarrow+\infty$ ) to a fixed point which does not depend on $w_{0}$. This provides a strong empirical evidence that this algorithm will provide a unique solution to the Problem $\left(* *_{1}\right),\left(* *_{2}\right)$ of the form $\mathcal{A}(t, \boldsymbol{x}, z(t, \boldsymbol{x}))$ once a choice of a root to the simply characteristic equation (of degree two here) has been chosen. It remains a very difficult open problem to find appropriate a BANACH (normed) algebra for which

$$
\|\boldsymbol{F}(w)-\boldsymbol{F}(v)\| \leqslant c\|w-v\|,
$$

with $0<c<1$, which would give a proof of Conjecture 7.1.

## 1. Introduction

The process of formation of singularities to solutions of nonlinear Partial Differential Equations is a huge and important topic which has stimulated a lot of interesting works (see e.g. $[44,51]$ ). We begin with recalling some known results in this topic in order to describe briefly the landscape in which our results and goals will be realized.

Even an infinitely smooth initial data under the dynamics of a nonlinear PDE will not remain in general smooth for all times. Henceforth, the topic of the singularity formation in solutions to nonlinear PDEs has been central in the study of these equations. Perhaps, the wave breaking phenomenon is the most familiar, and far from being completely studied, natural singularity formation processes [4]. Moreover, the wave breaking process can be easily seen by everyone.

An attempt to classify various finite time singularities in PDEs has been made in [12]. This classification has been clearly motivated by physical (and several other) applications. The question of eventual blow-up in 3D incompressible Euler and Navier-Stokes equations is open and central to many current theoretical and numerical investigations [23]. We also refer to [8] as an excellent review of available numerical approaches to detect complex singularities of PDEs. Complex singularities of the LORENZ dynamical system (with complex time) have been studied in [49].

The present manuscript is devoted in the first place to the study of complex algebraic singularities in the inviscid Burgers Equation (iBE). Namely, we study the algebraic singularity blow-up under the dynamics of some first and second order genuinely nonlinear PDEs. Among the second order PDEs, we focus on a particular second order PDE belonging to the celebrated family of $p$-systems described in some detail below.

The iBE can be written as [7]:

$$
\begin{equation*}
u_{t}-u u_{x}=\underline{0}, \tag{1.1}
\end{equation*}
$$

where in the (classical) real case

$$
\begin{aligned}
u: \mathbb{R}_{\geqslant t_{0}} \times \mathbb{R} & \longrightarrow \mathbb{R}, \\
(t, x) & \longmapsto u(t, x)
\end{aligned}
$$

The subscripts $(-)_{t}$ and $(-)_{x}$ denote the usual partial derivatives $\frac{\partial}{\partial t}$ and $\frac{\partial}{\partial x}$ respectively. In order to obtain an Initial Value Problem (IVP), Equation (1.1) has to be completed by an appropriate initial condition:

$$
u\left(t_{0}, x\right)=u_{0}(x), \quad x \in \mathbb{R}
$$

It is well-known that the iBE will develop the gradient catastrophe in finite time from a generic initial condition. More precisely, the existence time $t_{0} \leqslant t<t_{s}$ depends on the initial condition:

$$
t_{s}=\frac{1}{\sup _{x \in \mathbb{R}} u_{0, x}(x)}
$$

Please, note that the real singularity never occurs (in forward time) if $u_{0, x}$ takes strictly negative values for all finite $x \in \mathbb{R}$. Below, for the sake of simplicity, we shall take $t_{0}=0$.

The real singularity is point-like in the sense that it occurs locally in a single point at a fixed time $t_{s}$. In contrast to real singularities, we shall demonstrate below that complex algebraic singularities take place on sets of positive dimension (i.e. analytical hyper-surfaces in $\mathbb{C}^{2}$ in our case). For the sake of completeness, we would like to mention that some singularities may even happen on sets of fractional Hausdorff dimensions [13]. This mechanism is conjectured for the Navier-Stokes equations in 3D. We can remind also an old idea of J. Leray that singularities in the Navier-Stokes equations could be related to the phenomenon of turbulence [5]. However, this idea was not followed, up to now and to the best of our knowledge, by any significant results.
In a similar line of thinking, we shall consider also in the present manuscript the following second order nonlinear hyperbolic equation:

$$
\begin{equation*}
u_{t t}-u_{x} u_{x x}=\underline{0}, \tag{1.2}
\end{equation*}
$$

whose IVP requires traditionally two data to be specified:

$$
\begin{align*}
u(0, x) & =u_{0}(x), & & x \in \mathbb{R},  \tag{1.3}\\
u_{t}(0, x) & =u_{1}(x), & & x \in \mathbb{R} . \tag{1.4}
\end{align*}
$$

However, we shall consider a ramified CAUCHY problem with only one (algebraic) CAUCHY datum (1.3) and we shall seek a solution $(t, x) \longmapsto u(t, x)$ of a very special (algebraic) form so that only the first CaUchy datum is needed. Both considered Equations (1.1) and (1.2) come from the same family of PDEs discussed in Section 3. Mathematically speaking, we discuss in the present study the hyperbolic sub-family of genuinely nonlinear PDEs. The general notion of genuinely nonlinear PDE that we use is stated as Assumption (2) in Conjecture 9.1. For example, the following PDE

$$
u_{t t}-u_{x} u_{x x}=\underline{0}
$$

is genuinely nonlinear whereas

$$
u_{t t}-u u_{x x}=\underline{0}
$$

is not genuinely nonlinear but only quasilinear. Other examples will be given in Section 3.
Example 1.1. Let us consider the following Cauchy 'toy' problem in $\mathbb{C}^{2}$ :

$$
\begin{aligned}
\frac{\partial u}{\partial t} & =u^{2} \\
u(0, x) & =\frac{1}{x}
\end{aligned}
$$

It is not difficult to see that the exact solution to this problem is

$$
u(t, x)=\frac{1}{x-t}
$$

This simple example shows that it is absolutely crucial to assume that CaUChY data (1.3) is bounded if we want to establish the existence of a holomorphic solution ramified along a characteristic hyper-surface. However, we mention that this toy example is not representative for our study for the following reasons:
(1) The singular locus $\mathfrak{S}:=\{t \in \mathbb{C} \mid(t, t)\}$ is a regular hyper-surface.
(2) The hyper-surface $\mathfrak{S}$ is not characteristic for the differential operator $\frac{\partial}{\partial t}$.

Henceforth, our example has some serious limitations.

## On complex algebraic singularities of nonlinear PDEs

It is well-known that the behaviour of the real-valued and complex-valued solutions is quite different. We shall mention the example of the 2D viscid Burgers system. For real-valued solutions O. Ladyzhenskaya proved* in 1963 global existence and uniqueness result in Sobolev spaces [29]. Later, it turned out that complex-valued solutions differ drastically from real ones. In particular, Li and Sinai proved in [36] using the renormalization group method that complex-valued solutions (in $n \mathrm{D}$ ) can develop finite time singularities. For gradient-like solutions this was proven earlier in [43]. The 2D complex Burgers equation was studied in [38], where an open set of six-parameter family of initial conditions is constructed such that the corresponding solutions exhibit blowups in finite time. Finally, complex-valued initial conditions have been showed numerically to develop singularity in finite time in complete agreement with theory. These results have also been extended to 3D complex-valued Navier-Stokes equations [37]. The complex singularities in 2D Euler equations have been studied in [19].

Our study differs at least in two important respects from previously described line of thinking:
(1) We consider hyperbolic and inviscid equations starting with the iBE.
(2) We complexify not only the dependent variables, but also the independent ones.

The viscous Burgers equation with real time and complex spatial variables have been considered in [17] in the context of semi-groups. Similarly, the linear wave (or D'Alembert) and telegraph equations were treated in [16]. Perhaps, the complex view on PDEs can be traced back to the work of S. Kovalevskaya who considered the Cauchy problem (CP) for the usual (linear) heat equation with complex temporal and spatial variables [28]. In particular, she showed that there are examples of holomorphic non-entire initial conditions such that the power series solution does not converge in any neighbourhood of $t_{0} \in \mathbb{C}$. The Borel summability of these divergent solutions has been studied much later [39]. However, the goal of our study consists in shedding new light from the complex geometry angle on the formation of real singularities in fully nonlinear PDEs. The complex iBE appeared surprisingly also in random matrix theory [41] and random surface models [27].

In the present work we focus first on the classical iBE and the following ramified IVP:

$$
\begin{aligned}
u_{t}-u u_{x} & =\underline{0}, \\
u(0, x) & =x^{\frac{1}{3}} .
\end{aligned}
$$

We show that the last IVP possesses solutions of the form $u=a+z$, where $a$ is a regular holomorphic function and $z$ verifies the cubic equation $z^{3}=p z+q$. The obtained solution can be analytically continued along any path in a small neighbourhood of the origin $\mathbf{0} \in \mathbb{C}^{2}$ and originating from $\left(0, x_{0}\right) \in \mathbb{C}^{2}$ and avoiding the cusp singularity $4 p^{3}-27 q^{2}=\underline{0}$. This is explained in details in Section 4. Thus, the solution $u$ is ramified along the singular locus $4 p^{3}-27 q^{2}=\underline{0}$ and its monodromy group** (cf.

[^1]Remarks 4.1 and 4.2) is the (non-commutative) permutation group $S_{3}$ (cf. Remark 4.1) whereas the CAUCHY datum $x^{\frac{1}{3}}$ is ramified around a smooth locus with a commutative monodromy group, namely $\mathbb{Z} / 3 \mathbb{Z}$. This phenomenon (including the changing of the monodromy group) is due both to the genuine nonlinearity of the iBE and the fact the algebraic CaUchy datum is sufficiently singular (see Section 4.1 and Theorem 6.2). However, the main goal of our study is to formulate a convincing numerical convergence evidence along with the generalisation of this phenomenon for genuinely nonlinear PDEs of the order two and higher (see Conjectures 7.1, 7.2 and 9.1). A first generalization is stated in Conjecture 7.1 which considers the Partial Differential Equation (PDE) (1.2) with the initial condition

u(0, x)=\sum_{j=1}^{N_{0}} c_{j} x^{1+\frac{j-1}{3}}
$$

where $N_{0} \in \mathbb{N}_{>2}, c_{1,2} \in \mathbb{C}^{\times}$and $\left\{c_{j}\right\}_{j=3}^{N_{0}} \subseteq \mathbb{C}$ are constants. It states the existence of an algebraic solution $u(t, x)$ ramified along a cusp $4 p^{3}(t, x)-27 q^{2}(t, x)=0$ depending on the Cauchy datum. We strongly believe that Conjectures 7.1, 7.2 and the most general Conjecture 9.1 are important problems requiring to develop interesting new Mathematics.

This manuscript is a first step in which we shall provide solid mathematical foundations along with numerical evidences to believe that they are indeed true. Especially, regarding the Conjecture 7.1 we shall construct in Section 7 a new (and highly non-trivial) algorithm allowing to obtain quite convincing numerical convergence results in Section 8. Moreover, we sketch a tentative strategy to address the general Conjecture 9.1 theoretically. In Sections 5 and 6 we revisit the general results of [35] in the specific case of the cubic equation $z^{3}=p z+q$ and make them more precise. The big advantage here is that most of computations can be done almost explicitly which allow us to highlight the underlying structures, which will allow us to construct a new practical algorithm from Section 7. More precisely, in Section 5 we revisit the ring* $\mathcal{O} \llbracket z \rrbracket$ (with $z^{3}=p z+q$ ) and we introduce the primitive operator $\partial_{q}^{-1}$. The reason why the derivation $\partial_{q}$ operator governs the structure of the ring $\mathcal{O} \llbracket z \rrbracket$ is elucidated in Section 6. In the same Section we establish the fact that $\left(z, z^{2}\right)$ is a solution of a holonomic $\mathscr{D}$-module with the characteristic variety $\mathbf{V}$ which is included in the union of the zero section and the co-normal** to the cusp $4 p^{3}-27 q^{2}=\underline{0}$ :

\mathbf{V} \bigcap \mathbf{T}_{\mathbf{0}}^{*} \mathbb{C}^{2}=(0,0 ; 0, \mathbb{C})

 determination. The homotopy equivalence classes $[\gamma]$ form the fundamental group $\pi_{1}(\mathbf{V})$. Finally, the monodromy is defined as the following map:

$$
\begin{aligned}
\pi_{1}(\mathbf{V}) & \longrightarrow \mathbf{G L}(\mathbb{E}), \\
\gamma & \longmapsto(u \longmapsto \gamma \cdot u) .
\end{aligned}
$$

Of course, it has to be shown that all these maps are well-defined and the result does not depend on the representative $\gamma$ of the homotopy class [ $\gamma$ ]. Fortunately, it can be done without any difficulties.
*Throughout this article, the word "ring" means "ring with identity".
${ }^{* *}$ Let us remind that the co-normal is constituted of all co-tangent vectors which annihilate on the tangent space to a given manifold (here, an analytic curve or surface).

## On complex algebraic singularities of nonlinear PDEs

In fact, using a deep result of KASHIWARA, we are able to prove an even stronger result stating that the characteristic variety $\mathbf{V}$ is the the union of the zero section and the co-normal to the cusp. The characteristic variety is an important geometric invariant of a $\mathscr{D}$-module. The integrability of the characteristic variety is a central result in the theory of $\mathscr{D}$-modules. Loosely speaking, this result says that the singular support of a $\mathscr{D}-$ module is an involutive sub-variety in the co-tangent bundle. The involutivity property may be seen under the sheaf angle: the ideal sheaf defining the singular support is closed with respect to the natural Poisson bracket on the co-tangent bundle [47].

Let us remind some additional relevant background material which will help to understand the sequel of this Section. We denote by $\mathscr{D}$ the sheaf of holomorphic differential operators on $\mathbb{C}^{2} \cong\{(p, q)\}$. The vector space of sections of $\mathfrak{D}$ over an open subset $\mathcal{U}$ is denoted by $\mathscr{D}(\mathcal{U})$.

Definition 1.1. Let $M$ be a sheaf of $\mathscr{D}$-modules ( $\mathscr{D}$-module for short) over an open subset $\mathcal{U}$ of $\mathbb{C}^{2}$. The $\mathscr{D}$-module $\mathcal{M}$ is said to be coherent if for any sheaf homomorphism of $\mathfrak{D}$-modules

\phi: \mathscr{D}^{m} \longrightarrow \mathcal{M}
$$

and for any point $z$ of $\mathcal{U}$, one can find an open neighbourhood $\mathcal{U}_{z}$ of $z$ and a finite number of sections $s_{1}, s_{2}, \ldots, s_{r}$ (over $\mathcal{U}_{z}$ ) of the sheaf (ker $\phi$ ) such that for any open subset $\mathcal{W} \subseteq \mathcal{U}_{z}$, the restrictions $s_{1}\left|w, s_{2}\right| w, \ldots, s_{r} \mid w$ generate $(\operatorname{ker} \phi)(\mathcal{W})$ as a module over $\mathscr{D}(\mathcal{W})$.

The fact that above the origin there is only one line (the co-normal to $\partial_{q}$ ) in $\mathbf{V}$ is absolutely crucial for our constructions. In particular, it explains why the primitive $\partial_{q}^{-1}$ exists and why the "micro-local singularities"* of the product $z^{2}$ remain under the control above the origin $\mathbf{0} \in \mathbb{C}^{2}$. This observation will constitute one of the key ingredients in the future proof of Conjecture 7.1. However, before engaging into this huge endeavor, we thought that it was indispensable to obtain convincing numerical tests for the convergence of our new iterative algorithm. Indeed, its convergence was not obvious a priori and its proof will constitute a big challenge. We end with a short heuristic explanation why we believe that if we impose a second Cauchy datum to Conjecture 7.1, then there will be no solution in general. Indeed, from the linear result [35], two cusps will show up. The products of $u$ and its derivatives will provide a spreading of singularities (associate to the co-normal of each of the cusps) over the origin which will not be possible to control. We shall return to this question in the forthcoming works.

The present manuscript is organized as follows. In Section 2 we briefly review some results of [32] which proves Conjecture 9.1 in the case of the algebraic equation of degree two and which provides some foundational material for an approach of Conjectures 7.1 and 7.2. In Section 3, we review an interesting family of genuinely nonlinear PDE to which our Conjectures should apply. First, we understand the formation of complex singularities in the iBE using the Cauchy-Kovalevskaya theory in Section 4.2, then, for the sake of completeness, we obtain the same results using completely different methods of contact geometry in Section 4.3. The reason to tackle the same problem from two completely different angles allows us to explore different ideas underlying the general conjecture

[^2]formulated below. Some brief reminder on the ring of formal series with holomorphic germs* coefficients is made in Section 5 and some remarks on holonomic $\mathfrak{D}$-modules are presented in Section 6. The second order nonlinear PDE (1.2) is analyzed in Section 7 and a completely new algorithm to approximate ramified solutions is presented in Section 7.1. The convergence of this algorithm would prove a particular case of the general Conjecture 9.1. We demonstrate it numerically in Section 8 that the proposed algorithm converges in practice, which constitutes one of the main achievements of the present work. Some possible further generalizations are discussed in Section 9. The main conclusions and perspectives of this study are outlined in Section 10. Finally, in Appendix C we show on an elementary example how our theory relates to the classical theory of shock waves.

## 2. Review of existing results

In this Section we remind the general theory of singular solutions to genuinely nonlinear PDEs which was initiated by the second author some thirty years ago and the construction of holomorphic ramified solutions have been considered even earlier, see e.g. [22, 24, 50]. Certain linear ramified CAUCHY problems were considered in [33] and second-order semilinear problems in [34]. The linear ramified differential operators were considered in [10] in the setting of sheaves theory. They demonstrated independently a weaker version of the results presented in [35]. Hamada considered the homogeneous linear case even earlier in [21]. The micro-local existence result was established in [6] for certain classes of linear differential operators. The same homogeneous case was investigated later using the contact transformation approach in [26]. The linear homogeneous case was considered also using the tools of the micro-local theory of sheaves in [11].

The reminders will allow to understand better the context and set up of Conjectures 7.1, 7.2 and 9.1. Actually, Theorem 2.2 (to be recalled below) is the particular case of Conjectures 7.1 and 9.1 obtained by restricting oneself to algebraic equations of the second order. This is an additional good reason in favour of Conjecture 7.1.

Let us consider an operator $\mathcal{P}$ of the order $m$ :

u \longmapsto \mathcal{P}(u): \stackrel{\text { def }}{=} \sum_{|\sigma|=m} P_{\sigma}\left(\boldsymbol{x}, u, \partial_{\boldsymbol{x}}^{\beta} u\right) \partial_{\boldsymbol{x}}^{\sigma} u+\mathcal{R}\left(\boldsymbol{x}, \partial_{\boldsymbol{x}}^{\beta} u\right)

[^3]where we use the multi-indices* $\sigma$ and $\beta$ with $|\beta| \leqslant m-1$. The use of multi-index notation is often attributed in the literature to Laurent Schwartz. All functions $P_{\sigma}$ and $\mathcal{R}$ are supposed to be holomorphic in their arguments $\forall \boldsymbol{x}$ in some vicinity $\boldsymbol{U}_{\mathbf{0}}$ of $\mathbf{0} \in \mathbb{C}^{n+1}, \forall \partial_{\boldsymbol{x}}^{\beta} u$ in some vicinity of $u_{0}^{\beta} \stackrel{\text { def }}{=} \partial_{\boldsymbol{x}}^{\beta} u(\mathbf{0}), \beta \in \mathbb{N}^{n+1}$. The question of local solutions to equation $\mathcal{P} u=\underline{0}$ can be naturally asked. The solution $u(\boldsymbol{x})$ is holomorphic and ramified around a hyper-surface $\mathfrak{S}$ defined by equation $s(\boldsymbol{x})=0$ and passing by $\mathbf{0} \in \mathbb{C}^{n+1}$. This solution has the following analytical form [32]:

u(\boldsymbol{x})=a(\boldsymbol{x})+\sum_{k=0}^{+\infty} b_{k}(\boldsymbol{x}) s^{\gamma_{k}}(\boldsymbol{x}) \tag{2.1}
\end{equation*}

where the sequence $\left\{\gamma_{k}\right\}_{k=0}^{+\infty}$ takes its values in $\mathbb{R}_{>0}$ and is strictly increasing and tending to $+\infty$. The functions $a$ and $b_{k}, \forall k \in \mathbb{N}$ are holomorphic in $\mathcal{U}_{\mathbf{0}} \ni \mathbf{0}$. The series (2.1) is convergent on the covering space of $\boldsymbol{U}_{\mathbf{0}} \backslash \mathfrak{S}$. The following assumption is also adopted: the hyper-surface $\mathfrak{S}$ is simply characteristic for the linearized equation $\mathcal{P}_{\text {lin }}$ of the genuinely nonlinear operator $\mathcal{P}$ in every point $a(\boldsymbol{x})$. In other words, the principal symbol $p_{m}$ of $\mathscr{P}$

p_{m}(\boldsymbol{x}, \bar{\xi}): \stackrel{\text { def }}{=} \sum_{|\sigma|=m} P_{\sigma}\left(\boldsymbol{x}, a(\boldsymbol{x}), \partial_{\boldsymbol{x}}^{\beta} a(\boldsymbol{x})\right) \bar{\xi}^{\sigma}, \quad|\beta| \leqslant m-1
$$

verifies two conditions:

- $\left.p_{m}(\boldsymbol{x}, \mathrm{~d} s(\boldsymbol{x}))\right|_{\mathfrak{S}} \equiv 0$,
- $\left.\partial_{\bar{\xi}} p_{m}(\mathbf{0}, \mathrm{~d} s(\mathbf{0}))\right|_{\mathfrak{G}} \neq 0$.

The hypothesis of simple characteristics is a holomorphic analogue of the strictly hyperbolic operator relative to $\mathfrak{S}$ in the real case.

We suppose also that we know the 'initial' data $\left.\partial_{t}^{\beta} a\right|_{t=0}(\forall|\beta| \leqslant m-1),\left.b_{k}\right|_{t=0}$ $(\forall k \geqslant 0)$ and $\left.s\right|_{t=0}$, where $t=0$ is the equation a complex smooth hyper-surface $\mathcal{T}$ transversal to the vector field $\partial_{\bar{\xi}} p_{m}(\boldsymbol{x}, \mathrm{~d} s(\boldsymbol{x}))$. Below we consider two separate cases.

### 2.1. Weakly singular solutions

In this case, we take a holomorphic function $a$ and a hyper-surface $\mathfrak{S}$ (given by equation $s(\boldsymbol{x})=0$ ) verifying preceding conditions, we assume $\mathcal{P}(a) \equiv \underline{0}$ and we seek for weakly singular solutions of type (2.1) with

\left.\gamma_{k}:=m+(k+1) \mu, \quad \mu \in\right] 0,1[

[^4]so that the constructed solution $u$ admits $m$ bounded derivatives. A change of variables allows to assume that $\mathfrak{S}$ is defined by the equation

s(\boldsymbol{x})=y_{1}=0,
$$
where we decompose $\boldsymbol{x} \equiv(t, \boldsymbol{y})$ and we introduce the following notation:
$$
1-\frac{y}{R}: \stackrel{\text { def }}{=} \prod_{j=1}^{n}\left(1-\frac{y_{j}}{R}\right), \quad R>0
$$

By analogy,

$$
\frac{1}{1-\frac{y}{R}}: \stackrel{\text { def }}{=} \prod_{j=1}^{n} \frac{1}{1-\frac{y_{j}}{R}}, \quad R>0

Definition 2.1. Let $u=\sum_{j=1}^{+\infty} u_{j} y^{j}$ and $v=\sum_{j=1}^{+\infty} v_{j} y^{j}$ be two formal power series with complex coefficients. We shall say that $u \preccurlyeq v$ if and only if

The last definition can be easily extended to the multi-variable case:
Definition 2.2. Let $p \in \mathbb{N}^{\times}$and $u=\sum_{\beta \in \mathbb{N}^{p}} u_{\beta} y^{\beta}$ and $v=\sum_{\beta \in \mathbb{N}^{p}} v_{\beta} y^{\beta}$ be two formal power series with complex coefficients. We shall say that $u \preccurlyeq v$ if and only if

Definition 2.3. Let $\Upsilon$ be a formal variable. Given $R>0, \varepsilon>0, p \in \mathbb{N}$ and $d \in \mathbb{N}$, we denote by $\mathbb{A}^{d}(R, \varepsilon, p)$ the set of formal power series of the type:

where functions $u_{k, j}$ are holomorphic in some neighbourhood of $\mathbf{0} \in \mathbb{C}^{n+1}$ and verify

u_{k, j} \preccurlyeq \sum_{l=0}^{+\infty} \frac{t^{l}}{\left(1-\frac{y}{R}\right)^{k+j+l}} \cdot \frac{(k+j+l)!}{l!(k+j+p)!} \cdot C_{k j l}^{p} \tag{2.2}
\end{equation*}

such that

\|u\|_{p, d} \stackrel{\text { def }}{=} \sum_{k, j, l \in \mathbb{N}} C_{k j l}^{p} \varepsilon^{k+2 j+l}<+\infty \tag{2.3}
\end{equation*}

where $C_{k j l}^{p}(u)$ are the smallest non-negative real constants allowing to bound functions $u_{k, j}$ in (2.2). We introduce also the following related definitions:

To each element $u \in \mathbb{A}^{d}(R, \varepsilon, p)$ we put non-injectively in correspondence a function

u(\boldsymbol{x})=\sum_{j=0}^{+\infty} \sum_{k=1}^{+\infty} u_{k, j} y^{k \mu+j+d}
$$

It is not difficult to see that if $u_{1} \in \mathbb{A}^{d_{1}}$ and $u_{2} \in \mathbb{A}^{d_{2}}$, then $u_{1} \cdot u_{2} \in \mathbb{A}^{d_{1}+d_{2}}$. If $\beta$ is a multi-index in $\mathbb{N}^{n+1}$ of the height $\leqslant d$ then the operator $\partial^{\beta}$ takes the elements
from $\mathbb{A}^{d}$ and sends them to $\mathbb{A}^{d-|\beta|}$. Since $\mathfrak{S}$ is characteristic, then $\mathcal{P}_{\text {lin }}$ sends $\mathbb{A}^{d}$ to $\mathrm{A}^{d-m+1}$. The following property specifies the geometric domain of the convergence associated to the norm $\|\cdot\|_{p, d}$ defined in (2.3):
Lemma 2.1 ([32]). Let $u \in \mathbb{A}^{d}(R, \varepsilon, p)$. Then, every $u_{k, j}$ is a holomorphic function in the domain

\Omega: \stackrel{\text { def }}{=}\left\{(t, \boldsymbol{y}) \in \mathbb{C}^{n+1}| | y_{j}|<R, \quad| t \left\lvert\,<\varepsilon \prod_{j=1}^{n}\left(1-\frac{\left|y_{j}\right|}{R}\right)\right.\right\},

and, for every compact $K \subset \Omega$ there exists a constant $C_{K}>0$ such that

\sup _{K}\left|u_{k, j}\right| \leqslant C_{K}^{k+j+1}

Conversely, let $\left\{u_{k, j}\right\}$ be a sequence of holomorphic functions defined on an open neighbourhood $\mathcal{U}_{\mathbf{0}}$ of the point $\mathbf{0} \in \mathbb{C}^{n+1}$ such that

\sup _{u_{0}}\left|u_{k, j}\right| \leqslant C^{k+j+1}
$$

Then,

$$
\sum_{j=0}^{+\infty} \sum_{k=1}^{+\infty} u_{k, j} \Upsilon^{k \mu+j+d} \in \mathbb{A}^{d}
$$

Then, finally, we may state the first result:
Theorem 2.1 ([32]). Take $u_{0} \in \mathbb{A}^{m}\left(\mathbb{C}^{n}\right)$ and let $\mathcal{T}$ be an analytic hyper-surface passing by $\mathbf{0} \in \mathbb{C}^{n+1}$ being defined by the analytical equation $t=0$. This hypersurface is transversal to the field $\partial_{\bar{\xi}} p_{m}\left(\boldsymbol{x}, \mathrm{~d} y_{1}\right)$ (and, thus, to $\left.\mathfrak{S}\right)$. Then, there exists $r \in \mathbb{A}^{m}\left(\mathbb{C}^{n+1}\right)$ such that

$$
\mathcal{P}(a(\boldsymbol{x})+r(\boldsymbol{x})) \equiv \underline{0} \quad \text { and }\left.\quad r\right|_{t=0}=u_{0}
$$

The proof consists, roughly speaking, in applying the fixed point iterations.
Remark 2.1. The obtained solution $a(\boldsymbol{x})+r(\boldsymbol{x})$ in the previous Theorem is ramified around a smooth locus (independent of the value of $\mu$ ) because the Cauchy datum is not sufficiently singular.

### 2.2. Strongly singular solutions

In this Section we are looking for solutions of type (2.1) with

$$
\gamma_{k} \stackrel{\text { def }}{=} m-\frac{1}{2}+\frac{k}{2}
$$

We stress out that the function $a$ is not necessarily a solution of equation $\mathcal{P}(a)=\underline{0}$ anymore if $b_{0} \neq \underline{0}$. In this Section $a$ and $\mathfrak{S}$ will be considered as problem unknowns on the same footing with $\left\{b_{k}\right\}_{k=0}^{+\infty}$.

Definition 2.4. Let $S$ be a formal variable. By $\mathrm{B}^{m-1}\left(\mathbb{C}^{n+1}\right)$ we designate the algebra of formal series of the form:

$$
r(\boldsymbol{x}, S)=\sum_{j=0}^{+\infty} b_{k}(\boldsymbol{x}) S^{\frac{k+2 m-1}{2}}
$$

We assume also that all $\left\{b_{j}\right\}_{j \in \mathbb{N}}$ are holomorphic functions defined on the same neighbourhood $\mathcal{U}_{\mathbf{0}}$ of the point $\mathbf{0} \in \mathbb{C}^{n+1}$ and there exists a constant $C>0$ such that

$$
\left|b_{j}(\boldsymbol{x})\right| \leqslant C^{k+1}, \quad \forall j \in \mathbb{N}, \quad \forall \boldsymbol{x} \in \mathcal{U}_{\mathbf{0}}
$$

Below, we shall substitute the formal variable $S$ by the holomorphic function $s$ vanishing at the origin $\mathbf{0} \in \mathbb{C}^{n+1}$ and defining the characteristic hyper-surface for the operator $\mathcal{P}_{\text {lin }}$.

For any $|\beta|=1$, we define the action of $\partial^{\beta}$ on $\mathbb{B}^{m-1}$ by conveying that

$$
\partial^{\beta}\left(S^{\frac{k+2 m-1}{2}}\right)=\frac{k+2 m-1}{2} S^{\frac{k+2 m-3}{2}} \partial^{\beta} S(\boldsymbol{x}) .

The action of $\partial^{\beta}$ on $\mathbb{B}^{m-1}$ is defined recursively for any $|\beta| \leqslant m$. To each element $r(\boldsymbol{x}, S) \in \mathbb{B}^{m-1}\left(\mathbb{C}^{n+1}\right)$ we associate non-injectively a function $\boldsymbol{x} \longmapsto r(\boldsymbol{x}, s(\boldsymbol{x}))$ defined near the origin.

Let $\boldsymbol{x} \equiv(t, \boldsymbol{y}) \in \mathbb{C} \times \mathbb{C}^{n}$ and we assume that the operator $\mathcal{P}$ has the form $\mathcal{P}=\partial_{t}^{m}+\mathcal{Q}\left(t, \boldsymbol{y}, \partial^{\beta}\right)$ with $|\beta| \leqslant m$ and $\beta \neq(m, 0, \ldots, 0)$. The principal symbol of the linearized operator $\mathcal{P}_{\operatorname{lin}}(a)$ of $\mathcal{P}$ at $a$ has the form $p_{m}\left(t, \boldsymbol{y}, \partial^{\beta} \tau, \bar{\xi}\right)$ with $|\beta| \leqslant m-1$. Finally, we consider a point $\left(\tau_{0}, \bar{\xi}^{0}\right) \in\left(\mathbb{C} \times \mathbb{C}^{n}\right) \backslash \mathbf{0}$ together with CaUCHY data $\left\{a_{j}(\boldsymbol{y})\right\}_{j=0}^{m-1}$ holomorphic in some neighbourhood of $\mathbf{0} \in \mathbb{C}^{n}$. We assume that

$$
p_{m}\left(0, \partial^{\sigma} a_{j}(\mathbf{0}), \tau^{0}, \bar{\xi}^{0}\right)=\underline{0}, \quad \partial_{\tau} p_{m}\left(0, \partial^{\sigma} a_{j}(\mathbf{0}), \tau^{0}, \bar{\xi}^{0}\right) \neq \underline{0},
$$

where $j+|\sigma| \leqslant m-1$. We choose also a root $\tau_{1}\left(\boldsymbol{x}, u_{\beta}, \bar{\xi}\right)$ of the equation $\tau \longmapsto p_{m}(\boldsymbol{x}, u, \tau, \bar{\xi})=0$ holomorphic near the point $\left(0, \partial^{\sigma} a_{j}(\mathbf{0}), \bar{\xi}^{0}\right)$. Finally, let $s_{1}$ be a holomorphic function near $\mathbf{0} \in \mathbb{C}^{n}$ such that

$$
s_{1}(\mathbf{0})=0, \quad \mathrm{~d} s_{1}(\mathbf{0})=\bar{\xi}^{0}
$$

We can state the main result:
Theorem 2.2 ([32]). Let $\sum_{k=0}^{+\infty} b_{k}^{0}(\boldsymbol{y}) S^{\frac{k+2 m-1}{2}} \in \mathbb{B}^{m-1}\left(\mathbb{C}^{n}\right)$. Then, there exists a neighbourhood of the point $\mathbf{0} \in \mathbb{C}^{n+1}$ along with holomorphic functions $s, a,\left\{b_{k}\right\}_{k=0}^{+\infty}$ defined on it such that $s$ is characteristic for $\mathcal{P}_{\text {lin }}$ and

$$
\begin{aligned}
b_{k}(0, \boldsymbol{y}) & \equiv b_{k}^{0}, \quad \forall k \in \mathbb{N}, \\
\partial_{t}^{j} a(0, \boldsymbol{y}) & \equiv a_{j}, \quad j \in(m+1)^{\sqsubset}, \\
s(0, \boldsymbol{y}) & \equiv s_{1}, \\
\partial_{t} s(0) & \equiv \tau^{0} .
\end{aligned}
$$

The series

$$
r(\boldsymbol{x}, S): \stackrel{\text { def }}{=} \sum_{k=0}^{+\infty} b_{k}(\boldsymbol{x}) S^{\frac{k+2 m-1}{2}} \in \mathbb{B}^{m-1}
$$

and $\boldsymbol{x} \longmapsto u(\boldsymbol{x}) \equiv a(\boldsymbol{x})+r(\boldsymbol{x}, s(\boldsymbol{x}))$ is a solution of the equation $\mathcal{P}(u)=\underline{0}$.

The space $\mathbb{B}^{m-1}\left(\mathbb{C}^{n+1}\right)$ is endowed with appropriate norm to define a BANACH algebra. This Theorem is proved by applying the fixed point Picard iteration, which gives also a practical algorithm converging to the required solution [34].
Remark 2.2. Since the CAUCHY datum $u_{0} \equiv u(0, \boldsymbol{y})$ is sufficiently singular, the hypersurface $s=\underline{0}$ around which the solution is ramified depends on $u_{0}$ and cannot be prescribed in advance. Moreover, since $u_{0}$ is ramified like $s_{1}^{\frac{1}{2}}$, the algebraic equation $z^{2}+b z+c=\underline{0}$ will inevitably show up in the construction of the solution. The discriminant of this equation is equal to $\Delta:=b^{2}-4 c$. Observe that $\Delta=\underline{0}$ defines a smooth locus with respect to the variables $(b, c)$. That is why Theorem 2.2 is easier to prove than its generalizations to the algebraic equations of order $k \geqslant 3$, cf. Conjectures 7.1, 7.2 and 9.1.

## 3. An interesting family of genuinely nonlinear PDEs

We consider a family of PDEs with the unknown function $u: \mathbb{R} \times \mathbb{R}_{\geqslant 0} \longrightarrow \mathbb{R}$ :

$$
\begin{equation*}
\mathscr{L}_{m}(u): \stackrel{\text { def }}{=} \partial_{t}^{m} u-\partial_{x}^{m-1} u \partial_{x}^{m} u=\underline{0}, \tag{3.1}
\end{equation*}
$$

where $m \geqslant 1$ is an integer parameter and $\partial_{(-)}^{m}$ denotes the $m^{\text {th }}$ order partial derivatives with respect to independent variables $t$ or $x$. Let us introduce the auxiliary variables:

$$
v_{1}(t, x): \stackrel{\text { def }}{=} \partial_{x}^{m-1} u(t, x), \quad v_{m}(t, x) \stackrel{\text { def }}{=} \partial_{t}^{m-1} u(t, x)
$$

Then, we have

$$
\begin{aligned}
\partial_{t}^{m-1} v_{1}-\partial_{x}^{m-1} v_{m} & =\underline{0} \\
\partial_{t} v_{m}-\partial_{x}\left(\frac{1}{2} v_{1}^{2}\right) & =\underline{0} .
\end{aligned}
$$

We shall also introduce the functions $\left\{v_{j}\right\}_{j=2}^{m-1}$ satisfying the following system:

$$
\begin{aligned}
\partial_{t} v_{1}-\partial_{x} v_{2} & =\underline{0} \\
\partial_{t} v_{2}-\partial_{x} v_{3} & =\underline{0} \\
\vdots & \vdots \\
\partial_{t} v_{m}-\partial_{x}\left(\frac{1}{2} v_{1}^{2}\right) & =\underline{0}
\end{aligned}
$$

For regular solutions (i.e. of the class $C^{1}$ ), the last system can be rewritten under the following matrix form:

$$
\partial_{t}\left(\begin{array}{c}
v_{1}  \tag{3.2}\\
v_{2} \\
\vdots \\
v_{m}
\end{array}\right)-\left(\begin{array}{ccccc}
0 & 1 & 0 & \cdots & 0 \\
0 & 0 & 1 & \cdots & 0 \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
v_{1} & 0 & 0 & \cdots & 0
\end{array}\right) \cdot \partial_{x}\left(\begin{array}{c}
v_{1} \\
v_{2} \\
\vdots \\
v_{m}
\end{array}\right)=\mathbf{0}
$$

where $\mathbf{0}$ is a function taking a constant (zero) vector value, i.e.

$$
\begin{aligned}
\mathbf{0}: \mathbb{R}_{\geqslant 0} \times \mathbb{R} & \longrightarrow \mathbb{R}^{m} \\
(t, x) & \longmapsto(0,0, \ldots, 0)^{\top}
\end{aligned}
$$

Formulations (3.1) and (3.2) are equivalent to each other on the set of sufficiently regular solutions.
It is not difficult to see that this system matrix is nothing else but the transposed companion matrix of the polynomial

$$
\lambda^{m}-v_{1} \in \mathbb{R}[\lambda]
$$

If we assume that $v_{1}>0$ (just for definiteness), the eigenvalues of this matrix are all simple and given by:

$$
\lambda_{k} \stackrel{\text { def }}{=} v_{1}^{\frac{1}{m}} \mathrm{e}^{\mathrm{i} \frac{2 \pi k}{m}}, \quad k \in m^{\sqsupset}
$$

The eigenvector associated to the eigenvalue $\lambda_{k}$ is a direction in the kernel of the following linear operator:

$$
\left(\begin{array}{ccccc}
-\lambda_{k} & 1 & 0 & \cdots & 0 \\
0 & -\lambda_{k} & 1 & \cdots & 0 \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
v_{1} & 0 & 0 & \cdots & -\lambda_{k}
\end{array}\right)
$$

or simply the following vector:

$$
\omega_{k}: \stackrel{\text { def }}{=}\left(1, \lambda_{k}, \ldots, \lambda_{k}^{m-1}\right)^{\top}
$$

We can easily verify that

$$
\left\langle\mathrm{d} \lambda_{k}, \omega_{k}\right\rangle=\frac{\lambda_{k}}{m v_{1}} \neq \underline{0},
$$

which means that the $k^{\text {th }}$ characteristic field is genuinely nonlinear according to the definition from [30, Section §5]. It is also obvious that System (3.2) is not hyperbolic since it admits complex characteristic speeds if $m>2$. Below we shall consider in some detail the two hyperbolic cases $m \in 1$ and $m=2$. The former corresponds to the familiar $i B E$. The latter deserves more attention. It can be written as the following system of two equations:

$$
\begin{align*}
\partial_{t} v_{1}-\partial_{x} v_{2} & =\underline{0},  \tag{3.3}\\
\partial_{t} v_{2}-\partial_{x}\left(\sigma\left(v_{1}\right)\right) & =\underline{0} . \tag{3.4}
\end{align*}
$$

In the last system (also known as the $p$-system) we can recognize a particular case of nonlinear elasticity written in Lagrangian variables, where $v_{1}$ is the deformations field and $v_{2}$ corresponds to the velocity field. Finally, the mechanical constraint $\sigma(w): \stackrel{\text { def }}{=} \frac{1}{2} w^{2}$ is induced by the deformation $v_{1}$. See [9, Chapter 7] and, in particular, Equation (7.1.11) therein for more details. It is known that System (7.13) is hyperbolic when $\frac{\mathrm{d} \sigma}{\mathrm{d} w} \equiv w>$ 0 , which becomes the condition $v_{1}>0$ in our case. The two characteristic fields corresponding to speeds

$$
\lambda_{ \pm}= \pm \sqrt{v_{1}}
$$

and to eigenvectors

$$
\omega_{ \pm}=\left(1, \pm \sqrt{v_{1}}\right)^{\top}
$$

are genuinely nonlinear as in the general case (i.e. $m>2$ ).

## 4. Inviscid Burgers equation

In this Section we consider a particular IVP for the iBE (1.1):

$$
\begin{align*}
u_{t}-u u_{x} & =\underline{0}  \tag{4.1a}\\
u(0, x) & =x^{\frac{1}{3}} . \tag{4.1b}
\end{align*}
$$

The main particularity of our study is that we consider the space and time variables to be complex including the unknown function $u$ :

$$
u: \mathbb{C} \times \mathbb{C} \longrightarrow \mathbb{C} .
$$

The derivatives with respect to $x$ and $t$ are understood from now on in the sense of complex analysis. The initial condition containing an algebraic branching point in the complex domain was taken on purpose. Consequently, the IVP (4.1) is called the ramified Cauchy problem. Solving the ramified Cauchy problem (4.1) means by definition to find an open neighbourhood $\mathcal{U}_{\mathbf{0}}$ of $\mathbf{0} \in \mathbb{C}^{2}$ along with a germ of holomorphic function $u(t, x)$ at a point of $\mathcal{U}_{\mathbf{0}} \cap\{t=0\}$ (different from the origin) satisfying (4.1a) and (4.2) such that $u(t, x)$ can be continued holomorphically along any path in $\mathcal{U}_{\mathbf{0}}$ which does not meet a certain characteristic hyper-surface which restricts to $x=0$ when $t=0$. Below we describe two different approaches to study the IVP (4.1) because both of them contain the foundational ideas to approach the Conjecture 7.1.

### 4.1. A linear digression

It is often helpful to consider first the linear problem before tackling the fully nonlinear formulation. It often brings some useful insight. The linear counterpart to IVP (4.1) reads

$$
\begin{aligned}
u_{t}-u_{x} & =\underline{0} \\
u(0, x) & =x^{\frac{1}{3}}
\end{aligned}
$$

It is clear to see that the last IVP has the following exact solution:

$$
u(t, x)=(t+x)^{\frac{1}{3}}
$$

Moreover, the singular locus of this solution is the following affine algebraic variety:

$$
\mathfrak{S}_{\mathrm{s}}: \stackrel{\text { def }}{=}\left\{(t, x) \in \mathbb{C}^{2} \mid t+x=0\right\}
$$

It is clear to see that this locus is completely regular as a geometric object. This is a characteristic property of linear equations. Below in Section 4.2 we shall demonstrate that in the genuinely nonlinear case (4.1) the corresponding singular locus is singular itself and we shall describe explicitly its algebraic singularity. We emphasize that Example 1.1 was (simply) nonlinear and also had a completely regular locus. Also the Galois group of the field extension of the Cauchy data and of the solution is the same Abelian group:

$$
\operatorname{Gal}\left(\mathbb{C}\left(x^{\frac{1}{3}}\right): \mathbb{C}(x)\right)=U_{3}
$$

This observation is to be compared with the genuinely nonlinear case described below. Moreover, the solution $u(t, x)$ and the Cauchy datum $u(0, x)$ share the same monodromy group.
Let us underline one more aspect in which linear and genuinely nonlinear problems differ. If we remove from $\mathbb{C}^{2}$ the singular locus and we compute the fundamental group of the obtained domain, we shall obtain*:

$$
\pi_{1}\left(\mathbb{C}^{2} \backslash \mathfrak{S}_{\mathrm{s}}\right)=\mathbb{Z}
$$

which is an Abelian group. In the genuinely nonlinear case the fundamental group will be non-commutative.

### 4.2. The Cauchy-Kovalevskaya approach

In the present Section we employ the Cauchy-Kovalevskaya theory in order to study the Initial Value Problem (IVP) (4.1). We shall even obtain a slightly more general result by considering the following IVP:

$$
\begin{align*}
u_{t}-u u_{x} & =\underline{0}  \tag{4.2a}\\
u(0, x) & =a_{0}(x)+x^{\frac{1}{3}} \tag{4.2b}
\end{align*}
$$

Theorem 4.1. Consider the IVP (4.1) for the iBE. Then, there exist three holomorphic functions $(t, x) \longmapsto a(t, x),(t, x) \longmapsto p(t, x)$ and $(t, x) \longmapsto q(t, x)$ defined in some neighbourhood of the point $(0,0) \in \mathbb{C}^{2}$ such that

$$
\begin{equation*}
a(0, x)=a_{0}(x), \quad p(0, x)=0, \quad q(0, x)=x \tag{4.3}
\end{equation*}
$$

and

$$
\begin{equation*}
u(t, x): \stackrel{\text { def }}{=} a(t, x)+z(t, x) \tag{4.4}
\end{equation*}
$$

being a unique solution to Equation (4.1) with the complex auxiliary function $(t, x) \longmapsto$ $z(t, x)$ verifying the following algebraic relation**

$$
\begin{equation*}
z^{3}=p z+q . \tag{4.5}
\end{equation*}
$$

Proof. First of all, we check that the ansatz (4.4) verifies the initial condition (4.2). Indeed, by taking the limit $t \rightarrow 0$ in Equation (4.5), we obtain

$$
z^{3}(0, x)=p(0, x) \cdot z(0, x)+q(0, x) \stackrel{(4.3)}{=} x
$$

Thus, $z(0, x)=x^{\frac{1}{3}}$. Substituting this result into the solution ansatz (4.4) we obtain:

$$
u(0, x): \Rightarrow a(0, x)+z(0, x) \stackrel{(4.3)}{\equiv} a_{0}(x)+x^{\frac{1}{3}}
$$

[^5][^6]By differentiating the algebraic relation (4.5) with respect to $t$ and $x$, we may compute the partial derivatives of the function $z$ :

$$
\begin{equation*}
z_{t}=\frac{p_{t} z+q_{t}}{3 z^{2}-p}, \quad z_{x}=\frac{p_{x} z+q_{x}}{3 z^{2}-p} \tag{4.6}
\end{equation*}
$$

Let us substitute the solution ansatz (4.4) into the iBE (4.1a):

$$
a_{t}+z_{t}-(a+z)\left(a_{x}+z_{x}\right)=\underline{0} .
$$

By substituting partial derivatives (4.6) and multiplying both sides by the denominator $3 z^{2}-p$, we obtain:

$$
\left(3 z^{2}-p\right) a_{t}+z p_{t}+q_{t}-(a+z)\left(a_{x}\left(3 z^{2}-p\right)+z p_{x}+q_{x}\right)=\underline{0} .
$$

Now, by equating the coefficients in front of equal powers of $z$, we have the following sequence of equalities:

$$
\begin{array}{ll}
z^{0}: & -p a_{t}+q_{t}+\underline{a} p a_{x}-a q_{x}=\underline{0}, \\
z^{1}: & p_{t}+p a_{x}-a p_{x}-q_{x}=\underline{0}, \\
z^{2}: & a_{t}-\underline{a a_{x}}-\frac{1}{3} p_{x}=\underline{0}, \\
z^{3}: & 3 a_{x}=\underline{0} .
\end{array}
$$

The last equation can be substituted into three previous ones to obtain:

$$
\begin{align*}
q_{t} & =a q_{x}+p a_{t} \equiv a q_{x}+\frac{1}{3} p p_{x} \\
p_{t} & =a p_{x}+q_{x}  \tag{4.7}\\
a_{t} & =\frac{1}{3} p_{x}
\end{align*}
$$

The first two equations are not incompatible because co-tangent vectors $\mathrm{d} p$ and $\mathrm{d} q$ are linearly independent by continuity in the vicinity of the point $(0,0) \in \mathbb{C}^{2}$. Indeed,

$$
\left(p_{t}, p_{x}\right)(0,0) \equiv(1,0), \quad\left(q_{t}, q_{x}\right)(0,0) \equiv\left(a_{0}(0), 1\right)
$$

It is not difficult to see that the last two co-vectors are linearly independent* for any value of $a_{0}(0) \in \mathbb{C}$. Thus, after applying the classical CaUchy-Kovalevskaya theorem to System (4.7), we obtain the required local existence and uniqueness result.
Corollary 4.1. The local existence and uniqueness for the IVP (4.1) is obtained by simply choosing $a_{0}:=\underline{0}$.

Remark 4.1. It is instructive to have a look at the obtained solution from the point of view of Galois theory. We already established above that the Galois group associated to the initial data is the Abelian group $U_{3}$. The dynamics of the iBE transforms this initial data into the local analytic solution (4.4). The Galois group associated to the solution $u$ can be easily computed:

$$
\text { Gal }(\mathbb{C}(p, q)[z]: \mathbb{C}(p, q))=S_{3} .
$$

We stress out that the last group is obviously different from $U_{3}$ and, additionally, it is non-commutative.
*Indeed,

$$
\left|\begin{array}{cc}
1 & 0 \\
a_{0}(0) & 1
\end{array}\right| \equiv 1 \neq 0, \quad \forall a_{0}(0) \in \mathbb{C} .
$$

It is also very interesting to investigate the situations where the solution established in the last Theorem 4.1 becomes singular. Let us fix some values of $\left(p_{0}, q_{0}\right)$ of $(p, q) \in \mathbb{C}^{2}$ for which $z_{0}$ is a simple root of Equation (4.5). Then, by the classical implicit function theorem, there exists a holomorphic function $(p, q) \longmapsto z(p, q)$ defined in the vicinity of the point ( $p_{0}, q_{0}$ ) of the complex plane. Henceforth, the singular locus for Equation (4.5) will consist of the following points:

$$
\Delta: \stackrel{\text { def }}{=}\left\{(p, q) \in \mathbb{C}^{2} \mid \text { Equation (4.5) has a double root }\right\}
$$

It is not difficult to describe this set analytically. For this, we eliminate $z$ from the following system of equations:

$$
\left\{\begin{array}{l}
z^{3}-p z-q=0 \\
3 z^{2}-p=0
\end{array}\right.
$$

The last two equations can be seen as a system of linear equations with respect to parameters $(p, q)$. It admits the following parametric solution:

$$
\left\{\begin{array}{l}
q=-2 z^{3} \\
p=3 z^{2}
\end{array}\right.
$$

Henceforth, the singular locus is

$$
\Delta: \Rightarrow\left\{(p, q) \in \mathbb{C}^{2} \mid 4 p^{3}-27 q^{2}=0\right\}
$$

It is not difficult to recognize here the swallow tail (cusp) singularity [52], which coincides with the cusp in this particular case ( $n=2$, see below).
Remark 4.2. The Theorem 4.1 establishes the local existence of the solution in some polydisc $D$ around the origin $(0,0) \in \mathbb{C}^{2}$. Let us take the solution germ $u(t, x)$ at $\left(t_{0}, x_{0}\right) \in D \backslash \Delta^{<}(\{\boldsymbol{0}\})$. If $\gamma$ denotes a closed loop around the point $\left(t_{0}, x_{0}\right)$ which does not intersect the singular locus $\Delta^{<}(\{\boldsymbol{0}\})$, then one can obtain the analytical continuation of the germ $u(t, x)$ along the loop $\gamma$ [14]. In other terms, this defines the action of the first homotopy (or fundamental) group $\pi_{1}\left(\boldsymbol{U}_{\mathbf{0}} \backslash \Delta^{<}(\{\mathbf{0}\})\right)$ on the solution (4.4):

$$
\gamma \cdot u:=a+\gamma \cdot z
$$

since the regular part $a$ is not ramified. We note that this group action turns out to be transitive (see below Theorem 4.3). We say that $\gamma \cdot z$ is the monodromy action of $\gamma$ on $z$. Depending on the chosen loop $\gamma \in D \backslash \Delta^{<}(\{\mathbf{0}\})$, this action may bring us to a different root of the algebraic Equation (4.5). This situation is schematically depicted in Figure 1. We mention also that this action can be lifted to the universal covering as well.

It is well-known (see e.g. [1]) that the fundamental group* of the complex plain without the cusp is

$$
\pi_{1}\left(\mathbb{C}^{2} \backslash \Delta^{<}(\{0\})\right)=\operatorname{Br}_{3}
$$

the braid group with three strands, which is an infinite non-commutative group (in contrast to the linear case discussed above).

Let us clarify our terminology. Consider the following polynomial equation*:

$$
\begin{equation*}
F(\boldsymbol{x}, z):=z^{n+1}-x_{n} z^{n-1}-x_{k-1} z^{n-2}-\ldots-x_{2} z-x_{1}=\underline{0} \tag{4.8}
\end{equation*}
$$

where $\boldsymbol{x}: \stackrel{\text { def }}{=}\left(x_{1}, x_{2}, \ldots, x_{n}\right) \in \mathbb{C}^{n}$. By $\Delta(\boldsymbol{x})$ we denote the discriminant of the polynomial Equation (4.8) [18]. By swallow tail we shall designate the analytical hypersurface $\Delta^{<}(\{0\})$. We provide below the most general definition of the swallow tail which suits our purposes:

Definition 4.1 ([35]). An analytical hyper-surface $\mathfrak{S}$ in $\mathbb{C}^{n+1}$ defined in some open neighbourhood $\mathcal{U}_{\mathbf{0}}$ is called the swallow tail with the edge $\mathbf{0} \in \mathbb{C}^{n+1}$ if there exists $k \in \mathbb{N}_{\geqslant 1}$ and $k$ holomorphic functions

$$
g_{j}: U_{\mathbf{0}} \longrightarrow \mathbb{C}, \quad g_{j}(\mathbf{0})=0, \quad j \in k^{\sqsupset}
$$

such that the differentials $\left\{\mathrm{d} g_{j}(\mathbf{0})\right\}_{j=1}^{k}$ are linearly independent and $\mathfrak{S}$ is defined as the locus of the equation

$$
\Delta\left(g_{1}(\boldsymbol{x}), g_{2}(\boldsymbol{x}), \ldots, g_{k}(\boldsymbol{x})\right)=\underline{0},
$$

where, as above, $\Delta\left(g_{1}, g_{2}, \ldots, g_{k}\right)$ denotes the discriminant of the following polynomial equation in $z$ [18]:

$$
z^{k+1}-g_{k} z^{k-1}-\ldots-g_{2} z-g_{1}=\underline{0}
$$

[^8]We define the co-normal $\mathcal{N}(\mathfrak{S})$ of $\mathfrak{S}$ to be the closure in $\mathbf{T}^{*} \boldsymbol{U}_{\mathbf{0}} \backslash \mathbf{0}$ of the co-normal $\mathcal{N}\left(\mathfrak{S}_{\text {reg }}\right)$, where $\mathfrak{S}_{\text {reg }}$ is the smooth (regular) part of $\mathfrak{S}$, i.e.

\mathfrak{S}_{\mathrm{reg}}: \stackrel{\text { def }}{=}\left\{\boldsymbol{y} \in \mathbb{C}^{k} \mid \Delta(\boldsymbol{y})=0, \quad \mathrm{~d} \Delta(\boldsymbol{y}) \neq 0\right\}
$$

It can be also shown that for any polydisc $D$ centered around $\mathbf{0} \in \mathbb{C}^{k}, D \cap \mathfrak{S}_{\text {reg }}$ is a connected domain. This property is important from the topological point of view.

Remark 4.3. Let $\boldsymbol{x}_{0} \in \boldsymbol{U}_{\mathbf{0}} \backslash \mathfrak{S}$. Consider a holomorphic germ* ${ }^{*}$ at the point $\left(g_{1}^{(0)}, g_{2}^{(0)}, \ldots, g_{n}^{(0)}\right):=\left(g_{1}\left(\boldsymbol{x}_{0}\right), g_{2}\left(\boldsymbol{x}_{0}\right), \ldots, g_{n}\left(\boldsymbol{x}_{0}\right)\right):$

$$
\left(g_{1}, g_{2}, \ldots, g_{n}\right) \longmapsto z\left(g_{1}, g_{2}, \ldots, g_{n}\right),
$$

where $z$ is the solution to the polynomial Equation (4.8). The existence of this germ is ensured by the classical implicit function theorem. The germ $z\left(g_{1}, g_{2}, \ldots, g_{n}\right)$ is a holomorphic function ramified around $\Delta^{<}(\{0\})$ and it can be prolonged holomorphically along any path starting from the point $\left(g_{1}\left(\boldsymbol{x}_{0}\right), g_{2}\left(\boldsymbol{x}_{0}\right), \ldots, g_{n}\left(\boldsymbol{x}_{0}\right)\right)$ and avoiding the swallow tail $\Delta^{<}(\{0\})$. Then, the germ in $\boldsymbol{x}_{0}$ :

$$
\boldsymbol{x} \longmapsto z\left(g_{1}(\boldsymbol{x}), g_{2}(\boldsymbol{x}), \ldots, g_{n}(\boldsymbol{x})\right)
$$

can be prolongated holomorphically along any path starting from $\boldsymbol{x}_{0}$ and belonging to $\mathcal{U}_{\mathbf{0}} \backslash \mathfrak{S}$. These facts are rigorously established in [35, Theorem 3.2]:
Theorem 4.2. Let $\left\{z_{j}\right\}_{j=1}^{n+1}$ denote the set of solutions to polynomial Equation (4.8). Then, for $\forall j \in(n+1)^{\beth}$, the germ $z_{j}$ defined at $\boldsymbol{x}_{0}$ can be holomorphically prolongated along any path starting from $\boldsymbol{x}_{0}$ and belonging to $\mathbb{C}^{n} \backslash \Delta^{<}(\{0\})$.

Proof. See [35, p. 40].
Basically, we came to the point where we may define a group epimorphism from the fundamental group on the permutation group of simple roots to the algebraic Equation (4.8):
Theorem 4.3 ([35]). Let $D$ be a polydisc of some positive radius centered around $\mathbf{0} \in \mathbb{C}^{n}$ and $\gamma$ is a closed path drawn in $D \backslash \Delta^{<}(\{\mathbf{0}\})$ starting and ending at $\boldsymbol{x}_{0}$ :

$$
\begin{aligned}
{[0,1] } & \longrightarrow D \backslash \Delta^{<}(\{\mathbf{0}\}) \\
t & \longmapsto \gamma(t)
\end{aligned}
$$

such that $\gamma(0)=\gamma(1) \equiv \boldsymbol{x}_{0} \cdot B y \gamma \cdot z\left(\boldsymbol{x}_{0}\right)$ we denote the holomorphic germ obtained from $z\left(\boldsymbol{x}_{0}\right)$ after the analytical continuation along the loop $\gamma$. Thanks to the implicit

[^9]function theorem and the fact that the roots of (4.8) are simple in $D \backslash \Delta^{<}(\{\mathbf{0}\})$ allows us to define the mapping:
\[

$$
\begin{aligned}
S_{n+1} & \longrightarrow S_{n+1} \\
z\left(x_{0}\right) & \longmapsto \gamma \cdot z\left(x_{0}\right),
\end{aligned}
$$
\]

where $S_{n+1}$ is the permutation group on $n+1$ symbols $\left\{z_{1}, z_{2}, \ldots, z_{n+1}\right\}$. Then, the following mapping

$$
\begin{aligned}
\pi_{1}\left(D \backslash \Delta^{<}(\{\boldsymbol{0}\})\right) & \longrightarrow S_{n+1}, \\
\gamma & \longmapsto\left(z_{j}\left(\boldsymbol{x}_{0}\right) \longmapsto \gamma z_{j}\left(\boldsymbol{x}_{0}\right)\right)
\end{aligned}
$$

defines the desired group epimorphism.

### 4.2.1. Uniformization of the local solution

It is known that the Cauchy-Kovalevskaya theory provides only the local analytic solutions. However, we work in the complex analytic setting where a germ can be continued along any path avoiding singularities. Henceforth, the local solution obtained in the previous Section can be continued analytically along any path starting in some neighbourhood in the origin and avoiding the swallow tail singularity $\Delta^{<}(\{0\})$. The analytical continuation theorem ensures that two solution germs at a point $x$ obtained from two homotopic paths starting at $x_{0}$ are identical. This fundamental theorem of the analytical continuation guarantees that the uniform solution is well-defined in each homotopy class of paths [14].

We shall use this analytical continuation technique in order to lift the obtained local solution to the global one on the universal covering. Let us denote the universal covering* of $\mathcal{X}: \stackrel{\text { def }}{=} \mathbb{C}^{2} \backslash \Delta^{<}(\{0\})$ by $\mathscr{y}$. In the previous Section we already mentioned that the fundamental group of $\mathcal{X}$ is $\mathbf{B r}_{3}$ and the Galois group associated to Equation (4.5) is $S_{3}$. It is known from the theory of groups that there exists a group epimorphism**

$$
\chi: \mathrm{Br}_{3} \rightarrow S_{3} .
$$

It is also a well-known fact that ker $\chi \unlhd \mathrm{Br}_{3}$ is a normal sub-group and $\mathrm{Br}_{3} /$ ker $\chi \cong$ $S_{3}$. Moreover, for every $\gamma \in \operatorname{ker} \chi$, the monodromy action of $\chi(\gamma)$ fixes each solution $z$ of (4.5). We introduce also an intermediate covering $\mathcal{R}: \stackrel{\text { def }}{=} y /$ ker $\chi$. It is composed of $y$ elements orbits by the (sub-)group action ker $\chi$. It is also the Riemann surface which defines the Galois covering of the structural automorphisms group (i.e. ker $\chi$ ).

[^10]This situation is represented on the following commutative diagram:


Hence, the solution germ $u$ on $\mathcal{X}$ induces a uniform holomorphic function $u \circ \pi_{\chi}$ on the intermediate covering $\mathcal{R}$. In a similar way, the solution germ $u$ can be lifted to the universal covering $y$ by taking the composition $u \circ \pi$. We added a little illustration of the uniformization process in Figure 2. This completes our short description of the solution uniformization.


Figure 2. Illustration of the solution uniformization on the universal covering $y$.

### 4.3. The contact geometry approach

In this Section we recover the same swallow tail singularity using the contact geometry approach. It can be also seen as a holomorphic method of characteristics.

Consider a complex space*

$$
\mathbb{C}^{5} \equiv \mathbb{C}^{2+2+1} \stackrel{\text { def }}{=}\left\{(t, x, u, \tau, \xi) \in \mathbb{C}^{5}\right\}
$$

together with a holomorphic contact form

$$
\omega: \stackrel{\text { def }}{=} \mathrm{d} u-\tau \mathrm{d} t-\xi \mathrm{d} x,
$$

which defines the contact structure on $\mathbb{C}^{5}$. Let us consider also a first order holomorphic PDE:

$$
\mathcal{F}\left(t, x, u, u_{t}, u_{x}\right) \equiv \mathcal{F}(t, x, u, \tau, \xi)=\underline{0} .
$$

[^11]Typically, the practical application we are interested in is given by the inviscid Burgers Equation (iBE):

$$
\begin{equation*}
\mathcal{F}(t, x, u, \tau, \xi):=\tau-u \xi=\underline{0} . \tag{4.9}
\end{equation*}
$$

It is assumed that the family $\{\mathrm{d} \mathcal{F}, \omega\}$ is free* and $\mathcal{F}$ is a real smooth function of its arguments.

The contact field $\mathscr{H}_{\mathcal{F}}$ is defined by the following condition [2]:

$$
\mathrm{d} \omega\left(\mathscr{H}_{\mathcal{F}}, h\right) \equiv \mathrm{d} \mathscr{F} \cdot h, \quad \forall h \in \operatorname{ker} \omega .
$$

In our case, the contact field can be easily computed explicitly**:

$$
\begin{equation*}
\mathscr{H}_{\mathcal{F}}: \Rightarrow\left(\mathscr{F}_{\tau}, \mathscr{F}_{\xi}, \tau \mathscr{F}_{\tau}+\xi \mathscr{F}_{\xi},-\left(\mathcal{F}_{\tau}+\tau \mathcal{F}_{u}\right),-\left(\mathscr{F}_{x}+\xi \mathcal{F}_{u}\right)\right) . \tag{4.10}
\end{equation*}
$$

By $\phi^{t}$ we denote the flow map along the vector field $\mathscr{H}_{\mathcal{F}}$ :

$$
\left\{\begin{array}{l}
\left.\frac{\mathrm{d}}{\mathrm{~d} t} \phi^{t}(z)\right|_{t=0}=\mathscr{H}_{\mathcal{F}}(z) \\
\phi^{0}(z)=z
\end{array}\right.
$$

The integral curves of this flow are called the characteristics. By construction, the function $\mathscr{F}$ is constant along this flow. We can easily check it by direct computation:

$$
\begin{aligned}
\frac{\mathrm{d}}{\mathrm{~d} t}\left(\mathscr{F}\left(\phi^{t}(z)\right)\right) \stackrel{(4.10)}{=} \mathcal{F}_{t} \mathcal{F}_{\tau}+\mathcal{F}_{x} \mathcal{F}_{\xi}+\mathcal{F}_{u}\left(\tau \mathcal{F}_{\tau}+\xi \mathcal{F}_{\xi}\right)+ \\
\mathscr{F}_{\tau}\left(-\mathcal{F}_{t}-\tau \mathcal{F}_{u}\right)+\mathscr{F}_{\xi}\left(-\mathcal{F}_{x}-\xi \mathcal{F}_{u}\right) \equiv \underline{0} .
\end{aligned}
$$

Obviously, the last identity is the consequence of the fact that

$$
\mathrm{d} \mathscr{F} \cdot \mathscr{H}_{\mathcal{F}}: \Rightarrow \mathrm{d} \omega\left(\mathscr{H}_{\mathcal{F}}, \mathscr{H}_{\mathcal{F}}\right)=\underline{0} .
$$

It is not difficult to check that $\mathscr{H}_{\mathcal{F}} \in \operatorname{ker} \omega$.
We recall that the Legendrian sub-variety $\mathbb{V}$ in our case is a holomorphic, possibly singular, integral sub-variety of ker $\omega$ of dimension $\operatorname{dim} \mathbb{V}=2$ such that

$$
\begin{align*}
\mathbf{T V} & \subseteq \operatorname{ker} \omega \\
\mathbb{V} & \subseteq \mathcal{F}^{-1}(0) \tag{4.11}
\end{align*}
$$

We shall say that $\mathbb{V}$ is the generalized solution in the sense of Lie. We know that a contact transformation allows to obtain a classical solution locally given by the graph of a function. If the canonical projection

$$
\begin{aligned}
\pi: \mathbb{V} & \longrightarrow \mathbb{C}^{2} \\
(t, x, u, \tau, \xi) & \longmapsto(t, x)
\end{aligned}
$$

is of (maximal) rank 2 , then $\mathbb{V}$ is a 1 -jet $j^{1}(u)$ of a complex holomorphic function $u$, i.e.

$$
\mathbb{V} \equiv\left\{(t, x) \in \mathbb{C}^{2} \mid\left(t, x, u(t, x), u_{t}(t, x), u_{x}(t, x)\right)\right\}
$$

We remind that all considerations in this article are local in the vicinity of $(0,0) \in \mathbb{C}^{2}$. The Legendrian $V$ should be understood in the same sense.
${ }^{*}$ In the contrary case, the contact field $\mathscr{H}_{\mathcal{F}}$ will be identically equal to zero.
${ }^{* *}$ The contact field can be easily computed explicitly for a general $\mathscr{F}$ as well [31, Chapter V, Section §1]:

$$
\mathscr{H}_{\mathcal{F}}:=\left(\frac{\partial \mathcal{F}}{\partial \tau}, \frac{\partial \mathcal{F}}{\partial \xi}, \tau \frac{\partial \mathcal{F}}{\partial \tau}+\xi \frac{\partial \mathcal{F}}{\partial \xi},-\left(\frac{\partial \mathcal{F}}{\partial t}+\tau \frac{\partial \mathcal{F}}{\partial u}\right),-\left(\frac{\partial \mathcal{F}}{\partial x}+\xi \frac{\partial \mathcal{F}}{\partial u}\right)\right) .
$$

The Legendrian $V$ can be also defined by a generating function [2], i.e. $(\tau, x) \longmapsto$ $\delta(\tau, x)$ :

$$
\mathbb{V}=\left\{(\tau, x) \in \mathbb{C}^{2} \mid\left(-f_{\tau}, \tau, \delta-\tau f_{\tau}, x, f_{x}\right)\right\}
$$

It is not difficult to check that conditions (4.11) hold. For example,

$$
\mathrm{d}\left(\boldsymbol{f}-\tau f_{\tau}\right)-\tau \mathrm{d}\left(-\boldsymbol{f}_{\tau}\right)-\boldsymbol{f}_{x} \mathrm{~d} x=\mathrm{d} \boldsymbol{f}-\boldsymbol{f}_{\tau} \mathrm{d} \tau-\boldsymbol{f}_{x} \mathrm{~d} x \equiv \underline{0} .
$$

### 4.3.1. Application to the iBE

In this case, the first order holomorphic PDE was defined above in Equation (4.9). In this case, the contact field becomes:

$$
\begin{equation*}
\mathscr{H}_{\mathcal{F}}: \Rightarrow(1,-u, \underbrace{\tau-u \xi}_{\equiv \underline{0} \text { by }(4.9)}, \tau \xi, \xi^{2}) . \tag{4.12}
\end{equation*}
$$

Using the iBE (4.9) and Cauchy data (4.2), we may reconstruct the 1 -jet of the function $u$ at $t=0$ :

$$
j^{1}(u) \bigcap\{t=0\} \equiv\left(0, x, x^{\frac{1}{3}}, \frac{1}{3} x^{-\frac{1}{3}}, \frac{1}{3} x^{-\frac{2}{3}}\right) \stackrel{\text { def }}{=} z_{0} .
$$

The last point $z_{0}$ will be used as an initial condition in finding the flow $\phi^{s}\left(z_{0}\right)$ (we change the flow parameter $t$ to $s$, because $t$ is already employed in the iBE). To simplify computations, we notice also that the third component in $\mathscr{H}_{\mathcal{F}}$ vanishes (cf. Equation (4.12)) since $\mathcal{F}$ conserves its value along the flow trajectories:

$$
\left\{\begin{array}{l}
\left.\frac{\mathrm{d}}{\mathrm{~d} t} \phi^{s}\left(z_{0}\right)\right|_{s=0}=\mathscr{H}_{\mathscr{F}}\left(z_{0}\right) \equiv\left(1,-u, 0, \tau \xi, \xi^{2}\right) \\
\phi^{0}\left(z_{0}\right)=z_{0}
\end{array}\right.
$$

The flow can be explicitly written in this case:

$$
\begin{aligned}
& \phi^{s}\left(z_{0}\right) \equiv(t(s), x(s), u(s), \tau(s), \xi(s)):= \\
&\left(s, x-x^{\frac{1}{3}} s, x^{\frac{1}{3}}, \frac{x^{\frac{1}{3}}}{3 x^{\frac{2}{3}}-s}, \frac{1}{3 x^{\frac{2}{3}}-s}\right) .
\end{aligned}
$$

Hence, $u \equiv x^{\frac{1}{3}}$. We introduce a new variable

$$
y: \stackrel{\text { def }}{=} x-x^{\frac{1}{3}} t \equiv u^{3}-u t
$$

In these new variables, the flow becomes:

$$
\phi^{s}\left(z_{0}\right) \equiv\left(t, y, u, \frac{u}{3 u^{2}-t}, \frac{1}{3 u^{2}-t}\right)
$$

with an additional algebraic relation:

$$
\begin{equation*}
u^{3}-u t-y=0 . \tag{4.13}
\end{equation*}
$$

The singularity occurs when $t \rightarrow 3 u^{2}$. It is not difficult to see that by definition of variably $y$ we have in the limit $y \rightarrow-2 u^{3}$. After eliminating $u$, we obtain an important algebraic relation between $t$ and $y$ on the singularity:

$$
4 t^{3}-27 y^{2}=0
$$

It corresponds to the swallow tail (cusp) singularity seen above in Section 4.2.
Remark 4.4. If in Cauchy problem (4.1) we take another ramified initial data

$$
u(0, x)=x^{\frac{1}{5}}
$$

then direct computations show that the algebraic relation between $u, t$ and $y$ would be

$$
u^{5}-u t-y=0 .
$$

### 4.4. Generalizations

A natural multidimensional generalization of the IVP (4.2) for an unknown function

$$
\begin{aligned}
u: \mathbb{C} \times \mathbb{C}^{n} & \longrightarrow \mathbb{C} \\
\left(t, x_{1}, x_{2}, \ldots, x_{n}\right) & \longmapsto u\left(t, x_{1}, x_{2}, \ldots, x_{n}\right)
\end{aligned}
$$

is the following one:

$$
\begin{align*}
u_{t}-u\left(u_{x_{1}}+u_{x_{2}}+\ldots+u_{x_{n}}\right) & =\underline{0}  \tag{4.14a}\\
u\left(0, x_{1}, x_{2}, \ldots, x_{n}\right) & =u_{0}\left(x_{1}, x_{2}, \ldots, x_{n}\right)+x_{1}^{\frac{1}{p}} \tag{4.14b}
\end{align*}
$$

for some holomorphic function $u_{0}$ in the vicinity of $(0,0, \ldots, 0) \in \mathbb{C}^{n}$. The right hand side in the multi-dimensional PDE could be a polynomial in variables $t, x$ and $u$. In the homogeneous case, it is not difficult to show the following

Theorem 4.4. Consider the IVP (4.14). Then, there exist $p$ germs of holomorphic functions $a_{0}, a_{1}, \ldots, a_{p-1}$ in the vicinity of $\left(t, x_{1}, x_{2}, \ldots, x_{n}\right) \equiv(t, \boldsymbol{x}):=$ $(0,0, \ldots, 0) \in \mathbb{C}^{n+1}$ along with a holomorphic function $(t, \boldsymbol{x}) \longmapsto v(t, \boldsymbol{x})$ defined in the vicinity of the origin such that $u(t, \boldsymbol{x}) \stackrel{\text { def }}{=} v(t, \boldsymbol{x})+z(t, \boldsymbol{x})$ is the unique solution to (4.14). The function $(t, \boldsymbol{x}) \longmapsto z(t, \boldsymbol{x})$ is defined as a solution to the following algebraic equation (with $t$ and $\boldsymbol{x}$ being seen as parameters):

$$
z^{p}=a_{p-1}(t, \boldsymbol{x}) z^{p-1}+\ldots a_{1}(t, \boldsymbol{x}) z+a_{0}(t, \boldsymbol{x})
$$

together with 'initial' conditions:

$$
\begin{aligned}
& a_{0}\left(0, x_{1}, x_{2}, \ldots, x_{n}\right)=x_{1}, \\
& a_{j}\left(0, x_{1}, x_{2}, \ldots, x_{n}\right)=\underline{0}, \quad j \in(p-1)^{\sqsupset} .
\end{aligned}
$$

Proof. Can be done by analogy with the proof of Theorem 4.1.

## 5. A ring of algebraic convergent power series

In the present Section we give a glimpse on the very rich and complex geometry of the ring* of formal power series. The goal of this Section is to provide a differential study of the algebra $\mathcal{O} \llbracket z \rrbracket$ (with $\left.z^{3}=p z+q\right)$. This study will exhibit some of the

[^12]tools allowing to construct the Algorithm of Section 7.1 which will provide a test of our Conjecture 7.1.

To fix the ideas, let us consider the following ring [48]:
Definition 5.1. We define

$$
\mathcal{O} \llbracket z \rrbracket: \stackrel{\text { def }}{=}\left\{\sum_{j=0}^{+\infty} a_{j}(p, q) z^{j}\right\}
$$

where the coefficients $\left\{a_{j}(p, q)\right\}_{j \in \mathbb{N}}$ are the germs of analytic functions at the origin* $(0,0) \in \mathbb{C}^{2}$ and the complex variable $z$ satisfies the algebraic equation (4.5). The algebra of these germs is denoted by $\mathcal{O}$. We require also that there exists $\exists \varepsilon>0$ (depending on the $\left.\left\{a_{j}(p, q)\right\}_{j \in \mathbb{N}}\right)$ such that

$$
\sum_{j=0}^{+\infty} \sup _{\substack{p|<\varepsilon\\| q \mid<\varepsilon}}\left|a_{j}(p, q)\right| \varepsilon^{j}<+\infty
$$

By applying the Weierstra $ß$ division theorem [42], we may show that this ring is isomorphic to the following reduced form:

$$
\mathcal{O}[z] \stackrel{\text { def }}{=}\left\{a(p, q)+b(p, q) z+c(p, q) z^{2} \mid z^{3}=p z+q\right\}
$$

for some germs of analytic functions $a, b$ and $c$. Our goal consists in building some form of the differential and integral calculus on $\mathcal{O} \llbracket z \rrbracket$ (or, in our case, equivalently on $\mathcal{O}[z]$ ).
Remark 5.1. Notice that we may remove the explicit dependence on variable $q$ in coefficients $a, b$ and $c$ since according to Equation (4.5), $q=z^{3}-p z$ and the coefficients $(a, b, c)$ may be re-expanded in the second variable $q \longmapsto\{a, b, c\}(p, q)$ after the substitution of the new expression for $q$. Finally, after collecting all the terms, we obtain the equivalent representation of the ring using formal power series:

$$
\mathcal{O}[z]: \stackrel{\text { def }}{=}\left\{\sum_{j=0}^{+\infty} b_{j}(p) z^{j} \mid z^{3}=p z+q\right\}
$$

It is not difficult to see that the same remark applies also to the ring $\mathcal{O} \llbracket z \rrbracket$ that we considered from the beginning:

$$
\sum_{j=0}^{+\infty} a_{j}(p, q) z^{j} \equiv \sum_{j=0}^{+\infty} b_{j}(p) z^{j}
$$

Namely, we have demonstrated the following
Proposition 5.1. Every element $\sum_{j=0}^{+\infty} a_{j}(p, q) z^{j} \in \mathcal{O} \llbracket z \rrbracket$ may be written under the form $\sum_{j=0}^{+\infty} b_{j}(p) z^{j}$ for some appropriately chosen holomorphic coefficients $\left\{b_{j}(p)\right\}_{j=0}^{+\infty}$.

Now, we start to construct the differential calculus over the rings $\mathcal{O} \llbracket z \rrbracket$ and $\mathcal{O}[z]$ :

Figure 3. Division of the real domain $M \backslash \Delta^{<}(\{0\}) \subseteq \mathbb{R}^{2}$ in three regions $\varphi_{1,2,3}$.

Lemma 5.1. The partial derivatives of the solution $z$ with respect to coefficients $p$ and $q$ are given by:

$$
\frac{\partial z}{\partial p}=\frac{z}{3 z^{2}-p}, \quad \frac{\partial z}{\partial q}=\frac{1}{3 z^{2}-p}
$$

Proof. By taking the differential of Equation (4.5), we obtain:

$$
\left(3 z^{2}-p\right) \mathrm{d} z=z \mathrm{~d} p+\mathrm{d} q
$$

or

$$
\mathrm{d} z=\frac{z}{3 z^{2}-p} \mathrm{~d} p+\frac{1}{3 z^{2}-p} \mathrm{~d} q
$$

After identifying the left and right hand sides we obtain the required result.
Remark 5.2. Lemma 5.1 (and Section 4.2) shows that the derivatives of a branch of $z(p, q)$ blow up when the point $(p, q)$ tends to a point of the discriminant locus $\Delta^{<}(\{0\})$.

### 5.1. A lyrical digression

Let us return to the real space $\mathbb{R}^{2} \subseteq \mathbb{C}^{2}$ for the moment. At the current stage we conjecture the following intuitive, but precise statement about micro-local singularities of $z$ and $z^{2}$ (real) distributions:

## Proposition 5.2.

$$
\begin{equation*}
W F(\breve{z})=W F\left(\breve{z}^{2}\right)=\overline{\mathcal{N}\left(\Delta^{<}(\{0\}) \backslash\left\{\mathbf{0} \in \mathbb{R}^{2}\right\}\right)}, \tag{5.1}
\end{equation*}
$$

where by the bar we denote the closure operation and $\mathcal{N}(\cdot)$ is the co-normal set and the distributions $\breve{z}$ and $\breve{z}^{2}$ are defined below.

Proof. This proposition is left for our future works on the subject. Namely, in a future work, we wish to apply the results of this manuscript to the construction, in the real domain, of weak solutions to some genuinely nonlinear PDEs. A first step would be the following investigation. Divide the domain $\left\{(p, q) \in \mathbb{R}_{\geqslant 0} \times \mathbb{R}\right\} \backslash \Delta^{<}(\{0\})$ in three connected components $\boldsymbol{C}_{1,2,3}$ as depicted in Figure 3. Choose in each branch $\boldsymbol{C}_{j}$ a branch $z_{j}$ of solution to the Equation (4.5). Let us denote by $\breve{z}$ the distribution on $M \stackrel{\text { def }}{=}\left\{(p, q) \in \mathbb{R}_{\geqslant 0} \times \mathbb{R}\right\}$ obtained by gluing together all the local pieces $\left\{z_{j}\right\}_{j=1}^{3}$. Then, in a separate work we plan to address the following question: would it be possible to choose the $z_{j}$ in each $\breve{C}_{j}$ so that the wave front sets WF $(\breve{z})$ and WF $\left(\breve{z}^{2}\right)$ is included in the intersection of the co-tangent bundle $T^{*} M$ with the co-normal to $\Delta^{<}(\{0\})$ ? It is in this sense that the proposition above has to be understood.

In the last Equation (5.1) there is an obvious part of the statement:

$$
\begin{aligned}
\operatorname{sing} \operatorname{supp}(z) & \subseteq \Delta^{<}(\{0\}), \\
\operatorname{sing} \operatorname{supp}\left(z^{2}\right) & \subseteq \Delta^{<}(\{0\})
\end{aligned}
$$

The deeper sens of Proposition 5.2 consists in making the connection between our theory and the more classical theory of shock waves with first steps in this direction given in Appendix C.

### 5.2. Primitivization

For the reasons which will become clearer below, the goal of this Section is to introduce and study the primitive of the ring $\mathcal{O}[z]$ with respect to the variable $q$ :

$$
\partial_{q}^{-1} \mathcal{O}[z] \stackrel{\text { def }}{=}\left\{a+b z+c z^{2} \in \mathcal{O}[z] \mid \partial_{q}\left(a+b z+c z^{2}\right) \in \mathcal{O}[z]\right\}
$$

The following Lemma shows that the derivative $\partial_{q}$ of an element of $\mathcal{O}[z]$ belongs to $\mathcal{O}[z]$ only under certain conditions:
Lemma 5.2. Let $z$ be a solution to Equation (4.5) and $\Delta: \Rightarrow 4 p^{3}-27 q^{2}$ be its discriminant. Take an element $a+b z+c z^{2} \in \mathcal{O}[z]$. Then, $\partial_{q}\left(a+b z+c z^{2}\right) \in$ $\mathcal{O}[z]$ if and only if the discriminant $\Delta$ divides $6 c q-2 b p$ and $9 b q-4 c p^{2}$.

Proof. Let us show the main steps of computations which yield the required result. First of all, we differentiate the element $a+b z+c z^{2} \in \mathcal{O}[z]$ with respect to $q$ and we use the result from Lemma 5.1:

$$
\partial_{q}\left(a+b z+c z^{2}\right)=a_{q}+b_{q} z+c_{q} z^{2}+\frac{b+2 c z}{3 z^{2}-p}
$$

It is clear that the derivative $\partial_{q}\left(a+b z+c z^{2}\right) \in \mathcal{O}[z]$ if and only if the last fraction can be presented as

$$
\frac{b+2 c z}{3 z^{2}-p} \equiv \alpha+\beta z+\gamma z^{2}
$$

for some holomorphic germs $\alpha, \beta$ and $\gamma$. The system of algebraic equations to determine these germs is obtained from the following obvious relation:

$$
b+2 c z=\left(\alpha+\beta z+\gamma z^{2}\right)\left(3 z^{2}-p\right)
$$

After expanding the powers of $z$ higher than two using Equation (4.5) and identifying the coefficients in front of $z^{0}, z^{1}$ and $z^{2}$, we obtain the following system of equations:

$$
\begin{aligned}
3 \beta q-\alpha p & =b, \\
3 \gamma q+2 \beta p & =2 c, \\
3 \alpha+2 \gamma p & =\underline{0} .
\end{aligned}
$$

Simple algebraic manipulations yield:

$$
\begin{aligned}
\alpha & :=-\frac{2 p(6 c q-2 b p)}{\Delta}, \\
\beta & :=\frac{9 b q-4 c p^{2}}{\Delta} \\
\gamma & :=\frac{3(6 c q-2 b p)}{\Delta} .
\end{aligned}
$$

This yields the conclusion of this Lemma.
Similar conditions can be formulated for the derivation with respect to $p$, however, it is out of scope of our study.

The next question we have to discuss is the integral calculus on $\mathcal{O}[z]$ in the sense of the operation inverse to the differentiation. Let us focus on the independent variable* $q$ and introduce the following

Definition 5.2. An element $w(z) \in \mathcal{O}[z]$ is called a primitive of $v(z) \in \mathcal{O}[z]$ if two conditions** are satisfied:

- $\partial_{q} w=v$,
- $w(0)=0$.

This fact will be denoted as $w=\partial_{q}^{-1} v$ and, by definition, we have $\partial_{q} \circ \partial_{q}^{-1}=\mathbb{1}_{\mathcal{O}}[z]$.
To illustrate this definition, we provide one concrete example:

$$
\partial_{q}^{-1} z=\frac{3 q z+p z^{2}}{4}
$$

The last formula can be obtained by specifying Equation (5.2) to $z$. Otherwise, it can be checked by a direct verification ${ }^{\dagger}$.

In the following two Lemmas 5.3 and 5.4 we show that this definition is meaningful and effective. However, first of all, we make use of the Remark 5.1 and switch back to

& \partial_{q} \circ \partial_{q}^{-1} z=\partial_{q}\left(\frac{3 q z+p z^{2}}{4}\right)=\frac{1}{4}\left(\frac{2 p z}{3 z^{2}-p}+3 z+\frac{3 q}{3 z^{2}-p}\right)= \\
& \frac{9 z^{3}-p z+3 q}{4\left(3 z^{2}-p\right)}=\frac{9 z^{3}-p z+3\left(z^{3}-p z\right)}{4\left(3 z^{2}-p\right)}= \\

the isomorphic ring object $\mathcal{O} \llbracket z \rrbracket$ since it is directly used in our construction presented in Section 7.1:

Lemma 5.3. The primitive $\partial_{q}^{-1} v, \forall v \in \mathcal{O} \llbracket z \rrbracket$ is unique.
Proof. In order to show this statement, it is enough to demonstrate that if $\partial_{q} w=0$ and $w(0)=0$ imply that $w=\underline{0} \in \mathcal{O} \llbracket z \rrbracket$. Indeed, from the second condition we conclude that

$$
w=\sum_{j=1}^{\infty} c_{j}(p) z^{j}
$$

for some germs $\left\{c_{j}(p)\right\}_{j=1}^{\infty}$. Let us compute its derivative (which exists because $w$ is a primitive):

$$
\partial_{q} w=\sum_{j=1}^{\infty} j c_{j}(p) \frac{z^{j-1}}{3 z^{2}-p}=\underline{0} .
$$

We multiply both sides of the last equality by $3 z^{2}-p$ :

$$
\sum_{j=1}^{\infty} j c_{j}(p) z^{j-1}=\underline{0}
$$

By using the unicity theorem for power series, we conclude that

$$
c_{j}(p) \equiv \underline{0}, \quad \forall j \geqslant 1
$$

Lemma 5.4. Let $\sum_{j=0}^{\infty} a_{j}(p) z^{j} \in \mathcal{O} \llbracket z \rrbracket$. Then, the primitive $\partial_{q}^{-1}$ of this element with respect to $q$ belongs also to $\mathcal{O} \llbracket z \rrbracket$ and can be explicitly computed (see Equation (5.2)).

Proof. The proof is constructive. Let us assume that there exists another element $\sum_{j=0}^{\infty} b_{j}(p) z^{j} \in \mathcal{O} \llbracket z \rrbracket$ such that

$$
\partial_{q}\left(\sum_{j=0}^{\infty} b_{j}(p) z^{j}\right)=\sum_{j=0}^{\infty} a_{j}(p) z^{j}
$$

and we shall construct it. By interchanging the summation and derivation operators, and using Lemma 5.1 we obtain:

$$
\sum_{j=1}^{\infty} b_{j}(p) \frac{j z^{j-1}}{3 z^{2}-p}=\sum_{j=0}^{\infty} a_{j}(p) z^{j}
$$

By multiplying both sides by $3 z^{2}-p$ and rearranging the terms, we obtain:

$$
\sum_{j=0}^{\infty}(j+1) b_{j+1}(p) z^{j}=\sum_{j=0}^{\infty}\left(3 a_{j-2}-p a_{j}(p)\right) z^{j}
$$

where we assume the following convention $a_{-1} \equiv a_{-2} \stackrel{\text { def }}{=} \underline{0}$. It can be readily deduced that

$$
b_{j+1}(p):=\frac{1}{j+1}\left(-p a_{j}(p)+3 a_{j-2}(p)\right), \quad \forall j \in \mathbb{N}
$$

Henceforth, we obtain the required result:

$$
\partial_{q}^{-1}\left(\sum_{j=0}^{\infty} a_{j}(p) z^{j}\right)=\underbrace{\sum_{j=\mathcal{O} \llbracket z \rrbracket}^{\infty} \frac{1}{j}\left(-p a_{j-1}(p)+3 a_{j-3}(p)\right) z^{j}}_{\substack{\text { def } \\=: \\ j=1}}
$$

Once we constructed the primitive given in the right hand side of the above equation, it is not difficult to check by the direct calculation that we have found the desired element in $\mathcal{O} \llbracket z \rrbracket$ :

$$
\partial_{q} w: \Rightarrow \partial_{q}\left(\sum_{j=1}^{\infty} \frac{1}{j}\left(-p a_{j-1}(p)+3 a_{j-3}(p)\right) z^{j}\right)=\sum_{j=0}^{\infty} a_{j}(p) z^{j}
$$

This is left to the reader as a simple exercise*. The found primitive $w$ in Equation (5.2) satisfies also obviously the second condition $w(0)=0$.

It is worthwhile to observe that one cannot define the primitive with respect to the other independent variable $p$. It is due, in particular, to the non-uniqueness as it follows from this simple example (employing again Lemma 5.1):

$$
\partial_{p} q \equiv \partial_{p}\left(z^{3}-p z\right)=3 z^{2} \frac{z}{3 z^{2}-p}-z-p \frac{z}{3 z^{2}-p} \equiv \underline{0}=\partial_{p} \underline{0}
$$

Hence, we just showed the following
Proposition 5.3. Let $w \in \mathcal{O} \llbracket z \rrbracket$. Then, two conditions

- $\partial_{p} w \equiv \underline{0}$,
- $w(0)=0$
do not necessarily imply that $w \equiv \underline{0}$.
Proof. See above.
A conceptual explanation of the non-existence of the primitive $\partial_{p}^{-1}$ will be given at the very end of Section 6.

$$
\begin{aligned}
& \text { *For the sake of completeness of our manuscript, we provide here this simple computation: } \\
& \partial_{q} w=\sum_{j=1}^{\infty} \frac{1}{j}\left(3 a_{j-3}-p a_{j-1}\right) \frac{j z^{j-1}}{3 z^{2}-p}=\sum_{j=1}^{\infty}\left(3 a_{j-3}-p a_{j-1}\right) \frac{z^{j-1}}{3 z^{2}-p}= \\
& \frac{1}{3 z^{2}-p}\left(3 \sum_{j=1}^{\infty} a_{j-3} z^{j-1}-p \sum_{j=1}^{\infty} a_{j-1} z^{j-1}\right)= \\
& \frac{1}{3 z^{2}-p}\left(3 z^{2} \sum_{j=0}^{\infty} a_{j} z^{j}-p \sum_{j=0}^{\infty} a_{j} z^{j}\right) \equiv \sum_{j=0}^{\infty} a_{j} z^{j} .
\end{aligned}
$$

The primitive with respect to $q$ has another good property which deserves to be mentioned here: it is $p$-differentiable in the ring $\mathcal{O} \llbracket z \rrbracket$. The following computation demonstrates this property and gives explicitly the formula for the $p$-derivative:

$$
\begin{aligned}
& \partial_{p} \circ \partial_{q}^{-1}\left(\sum_{j=0}^{\infty} a_{j} z^{j}\right)=\partial_{p}\left(\sum_{j=1}^{\infty} \frac{1}{j}\left(3 a_{j-3}-p a_{j-1}\right) z^{j}\right)= \\
& \underbrace{\sum_{j=1}^{\infty} \frac{1}{j}\left(3 a_{j-3}^{\prime}+p a_{j-1}^{\prime}-a_{j-1}\right) z^{j}}_{(*)}+\underbrace{\sum_{j=1}^{\infty} \frac{z^{j}}{3 z^{2}-p}\left(3 a_{j-3}-p a_{j-1}\right)}_{(* *)},
\end{aligned}
$$

where by prime $(\cdot)^{\prime}$ we denote the derivative with respect to $p$. The first term $(*)$ is regular and belongs to $\mathcal{O} \llbracket z \rrbracket$. The second term $(* *)$ can be further transformed to the regular form:

$$
\begin{aligned}
&(* *): \Rightarrow \sum_{j=1}^{\infty} \frac{z^{j}}{3 z^{2}-p}\left(3 a_{j-3}-p a_{j-1}\right)= \\
& \frac{1}{3 z^{2}-p}\left(3 \sum_{j=0}^{\infty} a_{j} z^{j+3}-p \sum_{j=0}^{\infty} b_{j} z^{j+1}\right)= \\
& \frac{z}{3 z^{2}-p}\left(3 z^{2} \sum_{j=0}^{\infty} a_{j} z^{j}-p \sum_{j=0}^{\infty} b_{j} z^{j}\right) \equiv z \sum_{j=0}^{\infty} b_{j} z^{j} .
\end{aligned}
$$

Hence, to summarize, we just demonstrated the following result:

$$
\partial_{p} \circ \partial_{q}^{-1}\left(\sum_{j=0}^{\infty} a_{j} z^{j}\right)=\sum_{j=1}^{\infty} \frac{1}{j}\left(3 a_{j-3}^{\prime}+p a_{j-1}^{\prime}-a_{j-1}\right) z^{j}+z \sum_{j=0}^{\infty} b_{j} z^{j}
$$

More generally, one can similarly show that
Proposition 5.4. Let $u=\partial_{q}^{-k} v$ for some element $v \in \mathcal{O} \llbracket z \rrbracket$ and $k \in \mathbb{N}$. Then, $\partial_{p}^{\alpha} \circ \partial_{q}^{\beta} u \in \mathcal{O} \llbracket z \rrbracket$ provided that $\alpha+\beta \leqslant k$.

## 6. Holonomic coherent $\mathfrak{D}$-modules

In this Section we perform the explicit construction of a coherent* holonomic** $\mathscr{D}$-module whose geometry is underlying our solution strategy of Conjecture 7.1. The

[^15]goal is to study the singularities of the obtained solution. More precisely, we show that the vector* $\left(z, z^{2}\right)^{\top}$ is a solution of a holonomic $\mathscr{D}$-module whose characteristic variety $\mathbf{V}$ is included into the union of the zero section and of the co-normal to the swallow tail. In the case of a smooth hyper-surface defined by $x=\underline{0}$, the multivalued function $x^{\frac{1}{3}}$ is a solution of the equation
$$
x u_{x}-\frac{u}{3}=\underline{0} .
$$

So, morally, the "micro-local" singularities of $x^{\frac{1}{3}}$ live in the co-normal of $x=\underline{0}$ and this property is one of the ingredients of the proof of Theorem 2.2. Therefore, in order to understand the Conjecture 7.1, it is important to work out the analogue of this property in the case of $z$ satisfying $z^{3}=p z+q$. This is the goal of this Section.

So, we consider the algebraic Equation (4.5) whose discriminant $\Delta$ is given by

$$
\Delta: \Rightarrow 4 p^{3}-27 q^{2}
$$

The co-normal ${ }^{* *} \mathcal{N}$ to $\mathfrak{S}: \stackrel{\text { def }}{=} \Delta^{<}(\{0\})$ can be easily computed:

$$
\begin{equation*}
\mathcal{N}(\mathfrak{S}): \Rightarrow \overline{\mathcal{N}\left(\mathfrak{S}_{\mathrm{reg}}\right)}=\left\{\left(3 z^{2},-2 z^{3}, z \lambda, \lambda\right) \mid(z, \lambda) \in \mathbb{C}^{2}\right\} \subseteq \mathbf{T}^{*} \mathbb{C}^{2} \tag{6.1}
\end{equation*}
$$

where we use the following coördinates to parametrize the co-tangent bundle:

$$
\mathbf{T}^{*} \mathbb{C}^{2} \equiv\left\{\left(p, q, \xi_{1}, \xi_{2}\right)\right\} \cong \mathbb{C}^{4}
$$

In the sequel, the co-normal $\mathcal{N}(\mathfrak{S})$ will be always understood as the closure $\overline{\mathcal{N}\left(\mathfrak{S}_{\text {reg }}\right)}$ according to its definition.
Remark 6.1. The fact that the co-normal $\mathcal{N}(\mathfrak{S})$ to the swallow tail contains only one complex direction ${ }^{\dagger}$ above the origin is absolutely crucial in our study).
Lemma 6.1. Let us define the following polynomials on the co-tangent bundle $\mathbf{T}^{*} \mathbb{C}^{2}$ :

$$
\begin{align*}
& P_{1}\left(p, q ; \xi_{1}, \xi_{2}\right): \stackrel{\text { def }}{=} \frac{p}{3} \xi_{2}^{2}-\xi_{1}^{2}, \quad m_{1} \stackrel{\text { def }}{=} \operatorname{deg}\left(P_{1}\right)=2  \tag{6.2a}\\
& P_{2}\left(p, q ; \xi_{1}, \xi_{2}\right): \stackrel{\text { def }}{=} \frac{q}{2} \xi_{2}^{3}+\xi_{1}^{3}, \quad m_{2}: \stackrel{\text { def }}{=} \operatorname{deg}\left(P_{2}\right)=3  \tag{6.2~b}\\
& P_{3}\left(p, q ; \xi_{1}, \xi_{2}\right): \stackrel{\text { def }}{=}\left(4 p^{3}-27 q^{2}\right) \xi_{1}^{2}, \quad m_{3}: \stackrel{\text { def }}{=} \operatorname{deg}\left(P_{3}\right)=2 \tag{6.2c}
\end{align*}
$$

whose respective degrees in variables $\left(\xi_{1}, \xi_{2}\right)$ are denoted by $m_{k}, j \in 3^{\sqsupset}$. Then,

$$
\bigcap_{j=1}^{3} P_{j}^{<}(\{0\})=\mathcal{N}(\mathfrak{S}) \bigcup\{(p, q, 0,0)\} \subseteq \mathbf{T}^{*} \mathbb{C}^{2}
$$

where the orthogonal complement (.) ${ }^{\top}$ is taken in the sense of the natural symplectic structure on the cotangent bundle $\mathbf{T}^{*} \mathbf{V}$. We remind that in general one has only the involution property of the characteristic variety [15]:

$$
\left(\mathbf{T}_{x} \mathbf{V}\right)^{\top} \subseteq \mathbf{T}_{x} \mathbf{V}
$$

This is a symplectic geometry view on the involutivity. More algebraic points of view are also possible, see e.g. [15, 47].
*After some simplification, the solution ansatz we consider looks like $a+b z+c z^{2}$. So, one could be inclined to consider instead the vector $\left(1, z, z^{2}\right)^{\top}$. However, the first component is completely regular and, since we are interested in singularities, we retain only the two last components.
${ }^{* *}$ Informally speaking, the co-normal $\mathcal{N}(\mathfrak{S})$ plays the rôle of the characteristic variety for the quasilinear operator (7.1a) defined below.
${ }^{\dagger}$ It would be more accurate to speak about a line, of course. In the real case the singular directions are $(0, \pm 1)$, which lie along the same line.

Proof. Due to the continuity of polynomial functions, it is enough to check the statement on the regular part of the co-normal $\mathcal{N}(\mathfrak{S})$. First, let us prove the inclusion $\subseteq$. So, consider a point

$$
\left(p, q ; \xi_{1}, \xi_{2}\right) \in \bigcap_{j=1}^{3} P_{j}^{<}(\{0\}) .
$$

Observe that if $\xi_{2}=0$, then $P_{1}\left(p, q ; \xi_{1}, \xi_{2}\right)=0$ implies that $\xi_{1}=0$. Consequently, the point $\left(p, q ; \xi_{1}, \xi_{2}\right)$ belongs to the zero section. If we assume now that $4 p^{3}-$ $27 q^{2} \neq 0$, then $P_{3}\left(p, q ; \xi_{1}, \xi_{2}\right)=0$ implies $\xi_{2}=0$. We draw similarly the conclusion that the point $\left(p, q ; \xi_{1}, \xi_{2}\right)$ belongs to the zero section again. Now assume that $\xi_{2} \neq 0$ and $4 p^{3}-27 q^{2}=0$. Then, there exists $z \in \mathbb{C}$ such that $(p, q) \equiv$ $\left(3 z^{2},-2 z^{3}\right)$. If $z=0$, then from $P_{1}\left(p, q ; \xi_{1}, \xi_{2}\right)=0$ we deduce that $\xi_{1}=0$ and $\left(0,0 ; 0, \xi_{2}\right)$ belongs to $\mathcal{N}(\mathfrak{S})$ as desired. If $z \neq 0$, then we can deduce from the equalities $P_{1,2}\left(p, q ; \xi_{1}, \xi_{2}\right)=0$ :

$$
\xi_{1}=\frac{\xi_{1}^{3}}{\xi_{1}^{2}}=\frac{-\frac{q}{2} \xi_{2}^{3}}{\frac{p}{3} \xi_{2}^{2}}=z \xi_{2}
$$

This proves the inclusion. Now let us prove the reverse inclusion $\supseteq$. The zero section is clearly included in $\cap_{j=1}^{3} P_{j}^{<}(\{0\})$. So, let us consider instead $\left(3 z^{2},-2 z^{3}, z \lambda, \lambda\right) \in$ $\mathcal{N}(\mathfrak{S})$. Then, an easy computation shows that

$$
P_{j}\left(3 z^{2},-2 z^{3}, z \lambda, \lambda\right) \equiv \underline{0}, \quad \forall j \in 3^{\sqsupset}
$$

This proves the Lemma.
Theorem 6.1. There exists an open polydisc $D$ centered around $\mathbf{0} \in \mathbb{C}^{2}$ such that $\forall k \in 3^{\sqsupset}$ and $\forall(i, j) \in 2^{\sqsupset} \times 2^{\sqsupset}$ we can find a differential operator $R_{i j}^{k}$ with holomorphic coefficients on $D$ such that:
(1) The operator $R_{i j}^{k}, \forall(i \neq j)$ is of the order $m_{k}-1$ at most.
(2) The differential operator $R_{i i}^{k}$ is of the order $m_{k}$ and admits the polynomial $P_{k}\left(p, q ; \xi_{1}, \xi_{2}\right)$ as its principal symbol.
(3) The following identity holds:

$$
\left(\begin{array}{ll}
R_{11}^{k} & R_{12}^{k} \\
R_{21}^{k} & R_{22}^{k}
\end{array}\right) \cdot\binom{z}{z^{2}} \equiv\binom{\underline{0}}{\underline{0}} .
$$

Proof. This theorem can be proved along the same lines as [35, Theorem 4.37].

### 6.1. The holonomic $\mathfrak{D}$-module construction

The holonomic $\mathfrak{D}$-module $\mathcal{M}$ will be constructed in the proof of the following
Theorem 6.2. The characteristic variety ${ }^{*} \mathbf{V}$ of $\mathcal{M}$ is included in $\bigcap_{j=1}^{3} P_{j}^{<}(\{0\}) \equiv$ $\mathcal{N}(\mathfrak{S}) \bigcup\{(p, q, 0,0)\}$ and

(1) The $\mathfrak{D}$ - module $\mathcal{M}$ is holonomic.
(2) The vector $\left(z, z^{2}\right)$ defines a holomorphic solution to $\mathcal{M}$ on every simply connected open subset of $\mathbb{C}^{2} \backslash \Delta^{<}(\{0\})$.

Proof. We denote by $\mathfrak{D}$ (respectively by $\mathscr{D}^{(j)}$ ) the sheaf of holomorphic differential operators (of the order not greater than $j$, respectively) on the polydisc $D$. The grading of $\mathfrak{D}$ is defined as

$$
\operatorname{gr} \mathscr{D}: \stackrel{\text { def }}{=} \bigoplus_{j=-1}^{+\infty} \frac{\mathscr{D}^{(j+1)}}{\mathscr{D}^{(j)}}, \quad \mathscr{D}^{(-1)} \equiv\{0\}
$$

Algebraically speaking, this object is isomorphic to the polynomial algebra $\mathcal{O}\left[\xi_{1}, \xi_{2}\right]$.
We consider a $\mathscr{D}$-module morphism $\phi$ defined as:

$$
\begin{aligned}
& \phi: D^{6} \longrightarrow \mathscr{D}^{2} \\
&\left(Q_{\ell}^{k}\right)_{\substack{k \in 3 \\
\ell \in 2 \sqsupset}} \longmapsto \sum_{\substack{k \in 3 \sqsupset \\
\ell \in 2 \sqsupset}}\left(Q_{\ell}^{k} R_{\ell, 1}^{k}, Q_{\ell}^{k} R_{\ell, 2}^{k}\right) .
\end{aligned}
$$

We are particularly interested in the co-kernel of this morphism:

$$
\mathcal{M}: \text { def }=\operatorname{coker} \phi: \Rightarrow \operatorname{cod} \phi / \phi_{>}(\{\operatorname{dom} \phi\}) \equiv \mathscr{D}^{2} / \phi_{>}\left(\left\{\mathscr{D}^{6}\right\}\right)
$$

along with the canonical projection

$$
\pi: \mathscr{D}^{2} \longrightarrow \mathcal{M}
$$

We stress out that $\mathcal{M}$ is a $\mathscr{D}$-module by construction. Theorem 6.1 allows us to define a $\mathscr{D}$-module sheaf homomorphism by the formula:

$$
\begin{aligned}
\mathcal{M} & \longrightarrow \mathcal{O}[z] \\
(\mathcal{A}, \mathcal{B}) & \longmapsto \mathcal{A} z+\mathscr{B} z^{2}
\end{aligned}
$$

where the right hand side is a ramified solution existing on $D \backslash \Delta^{<}(\{0\})$ defined by the pair ( $z, z^{2}$ ). Then part (2) of the Theorem follows from Theorem 4.2. We introduce

It is an ideal in gr $\mathcal{D}$. However, this ideal generally depends on the choice of a good filtration. So, one has to consider instead its radical:

$$
\sqrt{\text { Ann } \mathcal{M}}: \stackrel{\text { def }}{=}\left\{P \in \mathbf{g r} \mathscr{D} \mid P^{k} \in \mathbf{A n n} \mathcal{M} \text { for some } \exists k \in \mathbb{N}\right\} .
$$

It can be shown that the object $\sqrt{\mathbf{A n n} \mathcal{M}}$ does not depend on the filtration. The set of common zeros of
$\sqrt{\mathbf{A n n} \mathcal{M}}$ is referred to as the characteristic variety $\mathbf{V}$ of $\mathcal{M}$ :

$$
\mathbf{V}(\sqrt{\mathbf{A n n} \mathcal{M}}) \stackrel{\text { def }}{=}\left\{\left(x_{0}, \bar{\xi}_{0}\right) \mid P\left(x_{0}, \bar{\xi}_{0}\right) \equiv 0, \forall P \in \sqrt{\mathbf{A n n M}}\right\} .
$$

also a good $^{*}$ filtration** $\left\{\mathcal{M}_{j}\right\}_{j \in \mathbb{Z} \geqslant-1}$ on $\mathcal{M}$ in the following way [40]:

$$
\mathcal{M}_{-1}: \stackrel{\text { def }}{=}\{0\}, \quad \mathcal{M}_{j}: \stackrel{\text { def }}{=} \pi\left(\mathscr{D}^{(j)}, \mathscr{D}^{(j)}\right) \quad \forall j \geqslant 0, \quad \mathcal{M} \equiv \bigcup_{j=-1}^{+\infty} \mathcal{M}_{j}
$$

Consider $k \in 3^{\sqsupset}$ and $(\mathcal{A}, \mathscr{B}) \in \mathcal{M}_{j+1}$ with $j \geqslant-1$. The grading of $\mathcal{M}$ is

$$
\mathbf{g r} \mathcal{M}: \stackrel{\text { def }}{=} \bigoplus_{j=-1}^{+\infty} \frac{\mathcal{M}^{(j+1)}}{\mathcal{M}^{(j)}}
$$

The action of $\mathscr{D}$ on $\mathcal{M}$ induces the action of $\mathbf{g r} \mathscr{D}$ on $\mathbf{g r} \mathcal{M}$ in the obvious way. In $\mathcal{M}_{k+1+m_{k}} / \mathcal{M}_{k+m_{k}}$ we have:

$$
P_{k} \cdot(\mathcal{A}, \mathscr{B})=\mathscr{A} \cdot\left(R_{1,1}^{k}, R_{1,2}^{k}\right)+\mathscr{B} \cdot\left(R_{2,1}^{k}, R_{2,2}^{k}\right)=\underline{0} .
$$

Hence, the multiplication of $\mathcal{M}_{k+1} / \mathcal{M}_{k}$ by $P_{k}$ induces a zero mapping into $\mathcal{M}_{k+1+m_{k}} / \mathcal{M}_{k+m_{k}}$.

The characteristic variety of $\mathcal{M}$ minus the zero section $\{(p, q, 0,0)\}$ is included into a Lagrangian sub-variety of $\mathbf{T}^{*} \mathbb{C}^{2} \backslash\{(p, q, 0,0)\}$, so $\mathcal{M}$ is holonomic. This completes the proof of the Theorem.

Of course, the couple of holomorphic ramified functions $\left(z, z^{2}\right)$ does not define a (uniform) distribution, but morally, Theorem 6.2 means that the "micro-local singularities" of $\left(z, z^{2}\right)$ live in the co-normal to the swallow tail $\mathcal{N}(\mathfrak{S})$.

We reiterate the important fact there exists only one direction ${ }^{\dagger}$ in $\mathcal{N}(\mathfrak{S})$ above $(0,0) \in \mathbb{C}^{2}$, namely $(0, \lambda), \lambda \in \mathbb{C}$. The principal symbol of $\partial_{q}$ (respectively, $\partial_{p}$ ) does not vanish (respectively, vanishes) on $\left\{(0,0 ; 0, \lambda) \mid \lambda \in \mathbb{C}^{\times}\right\}$. This explains why the primitive $\partial_{q}^{-1}$ exists on $\mathcal{O} \llbracket z \rrbracket$ whereas $\partial_{p}^{-1}$ does not exist as we saw above in Section 5 . Lastly, Theorem 6.2 shows morally that the singularities of the product $z \cdot z$ do not spread over the origin and remain confined in $\mathcal{N}(\mathfrak{S})$.

${ }^{* *}$ A filtration of $\mathcal{M}$ is an increasing sequence of sub-modules $\left\{\mathcal{M}_{j}\right\}_{j \in \mathbb{Z} \geqslant-1}$ of $\mathcal{M}$ verifying two properties:

- $\mathcal{M} \equiv \bigcup_{j=-1}^{+\infty} \mathcal{M}_{j}$.
- $\mathscr{D}^{(k)} \cdot \mathcal{M}_{j} \subseteq \mathcal{M}_{j+k}, \forall(k, j) \in \mathbb{N}^{2}$.

### 6.2. A computational digression

Let $P_{i}$ and $P_{j}\left(i, j \in 3^{\sqsupset}\right)$ be any two polynomials from Lemma 6.1. Theorem 6.2 shows that the characteristic variety $\mathbf{V}$ is contained in

$$
\mathbf{V} \subseteq P_{i}^{<}(\{0\}), \quad \mathbf{V} \subseteq P_{j}^{<}(\{0\})
$$

Hence, $\mathbf{T}_{\boldsymbol{x}} \mathbf{V} \subseteq \operatorname{kerd} P_{i, j}(\boldsymbol{x})$, where $\boldsymbol{x} \in \mathbf{V}$ is a smooth point of the characteristic variety $\mathbf{V}$. Then, if $\omega \stackrel{\text { def }}{=} \sum_{k=1}^{2} \mathrm{~d} x_{k} \wedge \mathrm{~d} \xi_{k}$ denotes the standard symplectic 2 -form on $\mathbf{T}_{\boldsymbol{x}} \mathbf{V}$, then $\forall h \in \mathbf{T}_{\boldsymbol{x}} \mathbf{V}$ :

$$
\begin{equation*}
\mathrm{d} P_{i, j}(\boldsymbol{x}) \cdot h \equiv \omega\left(\mathscr{H}_{P_{i, j}}(\boldsymbol{x}), h\right)=0 \tag{6.3}
\end{equation*}
$$

where $\mathscr{H}_{P_{i, j}}$ is the following vector field:

$$
\mathscr{H}_{P_{i, j}}: \stackrel{\text { def }}{=} \sum_{k=1}^{2}\left(\frac{\partial P_{i, j}}{\partial \xi_{k}} \frac{\partial}{\partial x_{k}}-\frac{\partial P_{i, j}}{\partial x_{k}} \frac{\partial}{\partial \xi_{k}}\right) .
$$

The second eqality in (6.3) shows that $\mathscr{H}_{P_{i, j}}(\boldsymbol{x}) \in\left(\mathbf{T}_{\boldsymbol{x}} \mathbf{V}\right)^{\perp}$, where the orthogonal complement is taken in the sense of the natural symplectic structure on the (co-)tangent bundle $\mathbf{T}^{*} \mathbf{V}$. Due to the involutivity* property of the characteristic variety $\mathbf{V}$ [15], we have that

$$
\left(\mathbf{T}_{\boldsymbol{x}} \mathbf{V}\right)^{\perp} \subseteq \mathbf{T}_{\boldsymbol{x}} \mathbf{V}
$$

Henceforth, $\mathscr{H}_{P_{i, j}}(\boldsymbol{x}) \in \mathbf{T}_{\boldsymbol{x}} \mathbf{V}$. Consequently, we obtain the following result:

$$
\omega\left(\mathscr{H}_{P_{i}}(\boldsymbol{x}), \mathscr{H}_{P_{j}}(\boldsymbol{x})\right) \equiv\left\{P_{i}, P_{j}\right\}(\boldsymbol{x})=0
$$

where the Poisson bracket operator definition is implied by the symplectic structure:

$$
\{P, Q\}: \stackrel{\text { def }}{=} \sum_{k=1}^{2}\left(\frac{\partial P}{\partial \xi_{k}} \frac{\partial Q}{\partial x_{k}}-\frac{\partial P}{\partial x_{k}} \frac{\partial Q}{\partial \xi_{k}}\right)
$$

Since $\boldsymbol{x}$ is a smooth point of $\mathbf{V}$, Theorem 6.2 allows to show that $\mathbf{V}$ and $\bigcap_{j=1}^{3} P_{j}^{<}(\{0\})$ coincide in a small neighbourhood of $\boldsymbol{x}$. Then, by Hilbert Nullstellensatz and Theorem 6.2, one deduces that the Poisson brackets $\left\{P_{i}, P_{j}\right\}\left(i, j \in 3^{\sqsupset}\right)$ must belong at least to the radical ideal $\sqrt{\ell}$, where $\ell: \stackrel{\text { def }}{=}\left\langle P_{1}, P_{2}, P_{3}\right\rangle$. We are going to check this property using modern computer algebra methods which are deeply based on the Gröbner bases methods [45].

First of all, let us initialize and load the library to work with polynomial ideals:

Then, we define the polynomials from Lemma 6.1:

Then, we define the polynomial ideal $\mathfrak{d}$ :

The last function returns the logical value false. Henceforth, we construct its radical:

We have to compute also the corresponding pairwise Poisson brackets of polynomials $P_{1,2,3}$ :

P12 := (p, q, r, s) -> PBracket(P[1], P[2]);
P13 := (p, q, r, s) -> PBracket(P[1], P[3]);
P23 := (p, q, r, s) -> PBracket(P[2], P[3]);
Finally, we can check whether the Poisson brackets belong to the radical ideal $\sqrt{\lambda}$ :
IdealMembership(P12(p, q, r, s), RI);
IdealMembership(P13(p, q, r, s), RI);
IdealMembership(P23(p, q, r, s), RI);
All these functions return the value true. This motivates us to establish an even stronger result comparing to Theorem 6.2.

It is also interesting to note that $\left\{P_{1}, P_{2}\right\}$ and $\left\{P_{2}, P_{3}\right\}$ belong even to the ideal $\ell$. However, it is not the case for $\left\{P_{1}, P_{3}\right\}$. These facts can be simply checked as follows:

The first two calls return true while the last one returns the value false. However, it is not difficult to check that $\left\{P_{1}, P_{3}\right\}^{2}$ already belongs to $\ell$ :

which returns the value true.

### 6.3. A stronger result

In fact, we were able to prove a stronger result comparing to Theorem 6.2. One actually has the equality in Theorem 6.2:

Theorem 6.3. Under conditions of Theorem 6.2, one has

$$
\mathbf{V} \backslash\{(p, q, 0,0)\}=\mathcal{N}(\mathfrak{S}) \backslash\{(p, q, 0,0)\}
$$

where $\{(p, q, 0,0)\}$ refers to the zero section.
Proof. In Theorem 6.2 we already established the inclusion $\mathbf{V} \backslash\{(p, q, 0,0)\} \subseteq$ $\mathcal{N}(\mathfrak{S}) \backslash\{(p, q, 0,0)\}$ and from it we deduce that $\mathcal{M}$ is holonomic. Let

$$
\begin{aligned}
\pi: \mathbf{T}^{*} \mathbb{C}^{2} & \longrightarrow \mathbb{C}^{2} \\
(\boldsymbol{x}, \bar{\xi}) & \longmapsto x
\end{aligned}
$$

denote the standard projection. We shall prove our statement be contradiction. So, let us assume that $\mathcal{N}(\mathfrak{S}) \backslash\{(p, q, 0,0)\}$ is not included in $\mathbf{V} \backslash\{(p, q, 0,0)\}$ and let us deduce a contradiction. Consider a point

$$
\left(p_{0}, q_{0} ; \xi_{1}^{0}, \xi_{2}^{0}\right) \in \mathcal{N}(\mathfrak{S}) \backslash(\mathbf{V} \cup\{(p, q, 0,0)\})
$$

By homogeneity, for any $\mu \in \mathbb{C}^{\times}$, the point $\left(p_{0}, q_{0} ; \mu \xi_{1}^{0}, \mu \xi_{2}^{0}\right)$ does not belong to $\mathbf{V}$. Since $\pi^{-1}\left\{\left(p_{0}, q_{0}\right)\right\} \cap \mathcal{N}(\mathfrak{S})$ is a complex line and since $\mathbf{V} \backslash$ $\{(p, q, 0,0)\} \subseteq \mathcal{N}(\mathfrak{S}) \backslash\{(p, q, 0,0)\}$, we immediately deduce that $\left(p_{0}, q_{0}\right) \notin$ $\pi(\mathbf{V} \backslash\{(p, q, 0,0)\})$. Now recall that the characteristic variety minus the zero section is (always) a homogeneous closed subset of $\mathbf{T}^{*} \mathbb{C}^{2} \backslash\{(p, q, 0,0)\}$. Therefore, there exists an open neighbourhood $\mathcal{U}^{(0)}$ of $\left(p_{0}, q_{0}\right) \in \mathbb{C}^{2}$ such that

$$
\pi(\mathbf{V} \backslash\{(p, q, 0,0)\}) \bigcap u^{(0)}=\varnothing .
$$

Consider now a Whitney stratification of $\mathbb{C}^{2}$ :

$$
\mathbb{C}^{2}=\bigcup_{\lambda \in \Lambda} \mathbf{X}_{\lambda}
$$

such that $\mathbf{V} \subseteq \bigcup_{\lambda \in \Lambda} \mathbf{N}^{*} \mathbf{X}_{\lambda}$, where $\mathbf{X}_{\lambda}$ are smooth (open) sub-manifolds and $\mathbf{N}^{*} \mathbf{X}_{\lambda}$ denotes the co-normal bundle to $\mathbf{X}_{\lambda}$. Recall also that $\left\{\mathbf{X}_{\lambda}\right\}_{\lambda \in \Lambda}$ form a partition of $\mathbb{C}^{2}$. Since $\pi(\mathbf{V} \backslash\{(p, q, 0,0)\}) \cap \mathcal{U}^{(0)}=\varnothing$, we can assume that $(p, q, 0,0) \in \mathbf{X}_{\lambda_{0}}$, where $\mathbf{X}_{\lambda_{0}}$ is an open subset of $\mathbb{C}^{2}$ so that its co-normal is the zero section. Then, consider an open simply connected neighbourhood $\mathcal{U}^{\left(\lambda_{0}\right)}$ of $\left(p_{0}, q_{0}\right)$ which is included in $\mathbf{X}_{\lambda_{0}}$. Consider also an open simply connected subset $\mathcal{W}^{\left(\lambda_{0}\right)}$ included in $\mathcal{U}^{\left(\lambda_{0}\right)} \backslash \Delta^{<}(\{0\})$. Now we can apply to $\mathcal{M}$ the first theorem of Kashiwara [25, Theorem 3.1] (see also a brief reminder below). It states, in particular, that the restriction of

$$
\operatorname{Ext}_{\mathscr{D}}^{0}(\mathcal{M}, \mathcal{O}) \equiv \operatorname{Hom}_{\mathfrak{D}}(\mathcal{M}, \mathcal{O})
$$

to $\mathbf{X}_{\lambda_{0}}$ is a local system. Since by Theorem 6.2, the vector $\left(z, z^{2}\right)$ is a holomorphic solution of $\mathcal{M}$ on $\mathcal{W}^{\left(\lambda_{0}\right)}$, Kashiwara's theorem implies that one can analytically continue $\left(z, z^{2}\right)$ to $\mathcal{W}^{\left(\lambda_{0}\right)}$. But this is impossible because if we make the analytic continuation of $\partial_{q} z=\frac{1}{3 z^{2}-p}$ along a path which ends up at $\left(p_{0}, q_{0}\right)$, it will blow up. This
contradiction therefore shows that the reverse inclusion is satisfied and this Theorem is proved.

For the sake of the exposition completeness, we formulate the following fundamental result of M. Kashiwara on which our Theorem 6.3 is based:

Theorem 6.4 ([25]). Let $\mathfrak{M}$ by a maximally overdetermined system on a complex manifold $\mathbf{X}$ and $\mathbf{X}=\bigcup \mathbf{X}_{\alpha}$ be a stratification of $\mathbf{X}$ satisfying the regularity conditions of $H$. Whitney such that the singular support of $\mathfrak{M}$ is contained in the union of co-normal projective bundles of the strata. Then, the restriction of $\operatorname{Ext}^{{ }_{\mathcal{D}}} \mathbf{i}\left(\mathfrak{M}, \mathcal{O}_{\mathbf{x}}\right)$ to each stratum is a locally constant sheaf of finite rank.

In the Theorem above the following notations were used:
$D_{\mathrm{x}}$ : The sheaf of differential operators of finite order on the complex manifold $\mathbf{X}$.
$\mathcal{O}_{\mathrm{x}}$ : The sheaf of holomorphic functions on $\mathbf{X}$, which is a left coherent $\mathscr{D}_{\mathrm{x}}$-module.
$\mathfrak{M}$ : The coherent $\mathscr{D}_{\mathbf{x}}-$ module.
Ext : The right derived functor of the hom-functor.

## 7. Second order PDE

In this Section we study the next representative of the PDE family (3.1) with $m=2$. Typically, we would like to develop the methods which would allow us to study the following ramified CP* for a genuinely nonlinear second order PDE:

$$
\begin{align*}
u_{t t}-u_{x} u_{x x} & =\underline{0},  \tag{7.1a}\\
u(0, x) & =\sum_{j=1}^{N_{0}} c_{j} x^{1+\frac{j-1}{3}}, \tag{7.1b}
\end{align*}
$$

with $N_{0} \in \mathbb{N}_{>2}, c_{1,2} \in \mathbb{C}^{\times}$and $\left\{c_{j}\right\}_{j=3}^{N_{0}} \subseteq \mathbb{C}$ some constants. Namely, we would like to provide a sufficient evidence that the following conjecture holds. This is the main goal of this Section:

Conjecture 7.1. Consider the ramified IVP (7.1). Then, for each choice of a root to the algebraic equation** $\tau^{2}-u_{x}(0,0) \cdot 1^{2}=\underline{0}$ (where we put $\xi \leftarrow 1 \neq 0$ by homogeneity of the principal symbol), there exist holomorphic functions $p(t, x), q(t, x)$ and $\left\{a_{j}(t, x)\right\}_{j=0}^{2}$ defined in a neighbourhood of $(0,0) \in \mathbb{C}^{2}$ with

$$
p(0, x)=\underline{0}, \quad q(0, x)=x
$$

[^20]such that the following assertion holds: the problem (7.1) admits a local solution of the form:
\[

$$
\begin{equation*}
u(t, x)=\partial_{q}^{-1}\left(\sum_{j=0}^{2} a_{j}(t, x) z^{j}\right) \tag{7.2}
\end{equation*}
$$

\]

where $z(t, x)$ satisfies the following algebraic equation:

$$
z^{3}=p(t, x) z+q(t, x)
$$

Proof. Open problem.
Remark 7.1. Please, notice that the second order ramified IVP (7.1) contains only one Cauchy data. To compensate this fact, we impose a special form (i.e. ansatz) for the solution that we are seeking. The condition $c_{1} \neq 0$ is necessary in order to ensure that the equation $\tau^{2}-u_{x}(0,0) \cdot 1^{2}=\underline{0}$ has two distinct roots. The condition $c_{2} \neq 0$ means that the CaUchy datum is sufficiently singular, it is crucial to ensure that the matrix $\mathbb{M}$ defined in Equation (7.10) in the eikonal Equation (7.9) is invertible. Actually, the Theorem 2.1 from Section 2.1 shows that if the constant $c_{2}$ is equal to zero, then the solution will be ramified around a smooth hyper-surface.

The choice of a root in the algebraic equation will allow to fix the value of $q_{t}(0,0)$, then it is very likely that the solution under the form (7.2) will be unique. Notice that the functions $p(t, x)$ and $q(t, x)$ will depend on the Cauchy datum.

Despite the fact that we do not have a proof for this conjecture, we shall present in this Section a strong evidence that it is true. Our symbolic-numeric computations will be performed in the case of $c_{1}=1$ and $c_{2}=\frac{3}{4}$ for the sake of convenience.

In the sequel we shall rather write the solution ansatz without applying the WeIERSTRAB division theorem [42], i.e.

$$
\sum_{j=0}^{2} a_{j}(t, x) z^{j} \equiv \sum_{k=0}^{\infty} b_{k}(t, x) z^{k}
$$

Despite the apparent complication, in this way it will be easier to express the iterative process.

### 7.1. Construction of iterations

Motivated by Lemma 5.3 and Theorem 6.3, we extract from the PDE (7.1a) the following characteristic equation:

$$
q_{t}(0,0)^{2}-u_{x}(0,0) q_{x}(0,0)=0
$$

Observe that $q_{x}(0,0)=1$ and that the choice $c_{1}=1$ necessarily implies $u_{x}(0,0)=$ 1. Then, in the previous equation we shall choose the root $q_{t}(0,0)=1$ for the rest of this Section.

The approach we adopt in this Section is greatly inspired by Sections 5 and 6. We would like to construct a solution to Equation (7.1a) in the following form, motivated by

Lemma 5.4:

$$
\begin{equation*}
u(t, x)=\sum_{k=1}^{\infty} \frac{1}{k}\left(-p(t, x) b_{k-1}(t, x)+3 b_{k-3}(t, x)\right) z^{k} \in \mathcal{O} \llbracket z \rrbracket, \tag{7.3}
\end{equation*}
$$

where $p(t, x), q(t, x)$ and $\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}$ are holomorphic functions of its two variables $(t, x) \in \mathbb{C}^{2}$ defined in the vicinity $\mathcal{U}_{(0,0)}$ of $(0,0) \in \mathbb{C}^{2}$ that verify the following 'initial' conditions:

$$
\begin{gather*}
p(0, x) \equiv \underline{0}, \quad q(0, x) \equiv x, \quad q_{t}(0,0)=1  \tag{7.4a}\\
b_{0}(0, x) \equiv \underline{1}, \quad b_{1}(0, x) \equiv \underline{1}, \quad b_{k}(0, x) \equiv \underline{0}, \quad \forall k \geqslant 2 \tag{7.4b}
\end{gather*}
$$

and

$$
z^{3}=p z+q, \quad \forall(t, x) \in \mathcal{U}_{(0,0)} \subseteq \mathbb{C}^{2}
$$

The 'initial' conditions (7.4) correspond to the CAUCHY datum (7.1b) with $c_{1}=1$ and $c_{2}=\frac{3}{4}$ :

$$
\begin{equation*}
u(0, x)=x+\frac{3}{4} x^{\frac{4}{3}} \tag{7.5}
\end{equation*}
$$

Several other initial conditions will be considered below in Section 8.
It seems impossible to construct directly such a solution $u(t, x)$ having a property that the series (7.3) is convergent $\forall(t, x) \in \mathcal{U}_{(0,0)}$. Instead, we propose to construct this solution $u(t, x)$ using the fixed point iterative scheme.

Using the ansatz (7.3) and this scheme, we shall see that the solution is completely determined if we have the following collection of holomorphic functions:

$$
\begin{equation*}
\mathfrak{C}: \stackrel{\text { def }}{=}\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right) \bigcap(7.4) . \tag{7.6}
\end{equation*}
$$

By construction, the functions from this collection $\mathfrak{C}$ verify the 'initial conditions' (7.4). Thus, if we know these functions, we can easily recover the solution $u(t, x)$ thanks to (7.3). Hence, the collection (7.6) will be called the solution data.

The first naive tentative to solve Conjecture 7.1 consists in replacing $u(t, x)$ by (7.3) in the nonlinear differential operator $u \longmapsto u_{t t}-u_{x} u_{x x}$. One obtains a certain expression ( $\mathbf{w}^{\mathbf{w}}$ ). Unfortunately, it seems to be unrealistic to construct the solutions directly in this way. Henceforth, we introduce an iterative procedure where we replace in one specific place of the expression ( $\mathbf{(})$ the function $p(t, x)$ by $\hat{p}(t, x)$, respectively, $q(t, x)$ by $\hat{q}(t, x)$ and $\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}$ by $\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{\infty}$. This procedure is better explained in Appendix B. As a result, we obtain the new expression:

$$
(\widehat{\mathbf{X}})=\sum_{k=0}^{\infty} \alpha_{k} z^{k}+\frac{\sum_{k=0}^{\infty} \beta_{k} z^{k}}{3 z^{2}-p} .
$$

Then, by requiring that $3 z^{2}-p$ divides $\sum_{k=0}^{\infty} \beta_{k} z^{k}$ we obtain the eikonal Equation (7.9) which gives us the new components ( $\hat{p}, \hat{q}$ ). Roughly speaking, (7.9) means that the cusp is characteristic for the PDE. By requiring that ( $\widehat{\mathbf{2}}$ ) vanishes, we obtain the following discrete 'time' (but infinite dimensional) dynamical system:

$$
\left(\hat{p}(t, x), \hat{q}(t, x),\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{\infty}\right):=\boldsymbol{F}\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right) .
$$

Henceforth, we may say that the construction of iterations is inspired by the ideas of the geometric optics. A similar procedure was employed by Wagschal in [50].

Then, by construction of the mapping $\boldsymbol{F}$, its fixed point gives us the desired solution to Conjecture 7.1. In this Section we shall construct the mapping $\boldsymbol{F}$ and implement it in a computer algebra system Maple ${ }^{\mathrm{TM}}$ :

$$
\begin{align*}
\boldsymbol{F}: \mathfrak{C} & \longrightarrow \mathfrak{C},  \tag{7.7}\\
\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right) & \longmapsto\left(\hat{p}(t, x), \hat{q}(t, x),\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{\infty}\right)
\end{align*}
$$

As we already mentioned, the mapping $\boldsymbol{F}$ is constructed such that if we have a fixed point

$$
\boldsymbol{F}\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right) \equiv\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right),
$$

then the solution (7.3) reconstructed from this data verifies (7.1a) (cf. Lemma 7.1). Additionally, since we impose Conditions (7.4b), this mapping will yield that $\left(q_{t}(0,0)\right)^{2}=1$. The fact that we have chosen $q_{t}(0,0)=1$ corresponds to the choice of a root to equation $\tau^{2}-\partial_{x} u(0,0) \cdot 1^{2}=\underline{0}$ in Conjecture 7.1 (where we replaced $\xi \leftarrow 1 \neq 0$ by homogeneity of the principal symbol).
We define the following family of functions:

$$
\begin{array}{r}
\mathscr{B}_{k} \stackrel{\text { def }}{=} \sum_{j=0}^{k}\left[\left(1-\frac{1}{j}\right) p_{x} b_{j-1}+q_{x} b_{j}+\frac{1}{j}\left(-p b_{j-1, x}+3 b_{j-3, x}\right)\right] \times \\
{\left[(k-j-1) p_{x}^{2} b_{k-j-1}+2(k-j) p_{x} q_{x} b_{k-j}+(k-j+1) q_{x}^{2} b_{k-j+1}\right]} \\
-(k-1) \cdot p_{t}^{2} b_{k-1}, \quad \forall k \in \mathbb{N},
\end{array}
$$

where we additionally use the convention:

$$
\begin{equation*}
b_{-j} \equiv \underline{0}, \forall j \geqslant 1 . \tag{7.8}
\end{equation*}
$$

The eikonal equation* is defined as

$$
\begin{equation*}
\binom{\hat{p}_{t}}{\hat{q}_{t}}=\mathbb{M}^{-1} \cdot\binom{\sum_{k=0}^{+\infty}\left(\frac{p}{3}\right)^{k} \mathscr{B}_{2 k}}{\sum_{k=0}^{+\infty}\left(\frac{p}{3}\right)^{k} \mathscr{B}_{2 k+1}} \tag{7.9}
\end{equation*}
$$

Since functions $\hat{p}$ and $\hat{q}$ belong to the class $\mathfrak{C}$, they verify the following initial conditions:

$$
\hat{p}(0, x)=\underline{0}, \quad \hat{q}(0, x)=x .
$$

The functional $2 \times 2$ matrix M is defined as

$$
\mathrm{M} \stackrel{\text { def }}{=}\left(\begin{array}{cc}
4 \sum_{k=0}^{+\infty}\left(\frac{p}{3}\right)^{k} k q_{t} b_{2 k} & \sum_{k=0}^{+\infty}\left(\frac{p}{3}\right)^{k}(2 k+1) q_{t} b_{2 k+1}  \tag{7.10}\\
2 \sum_{k=0}^{+\infty}\left(\frac{p}{3}\right)^{k}(2 k+1) q_{t} b_{2 k+1} & 2 \sum_{k=0}^{+\infty}\left(\frac{p}{3}\right)^{k}(k+1) q_{t} b_{2 k+2}
\end{array}\right) .
$$

[^21]We underline that the inversion of the last matrix is necessary to obtain an explicit form of the eikonal System (7.9) solved with respect to the time derivatives. It is not difficult to see (by substituting the necessary initial data and conventions) that the first Equation in (7.9) yields $\hat{p}_{t}(0,0)=\frac{1}{2}$.

Let us define also the following family of functions:

$$
\begin{aligned}
& \mathcal{A}_{k} \stackrel{\text { def }}{=}(k-1) b_{k-1} p_{t}^{2}+2 k b_{k} \hat{p}_{t} q_{t}+(k+1) \hat{q}_{t} q_{t} b_{k+1}- \\
& \quad \sum_{j=0}^{k}\left[\left(1-\frac{1}{j}\right) b_{j-1} p_{x}+b_{j} q_{x}+\frac{1}{j}\left(-p b_{j-1, x}+3 b_{j-3, x}\right)\right] \times \\
& {\left[(k-j-1) b_{k-j-1} p_{x}^{2}+2(k-j) b_{k-j} p_{x} q_{x}+(k-j+1) b_{k-j+1} q_{x}^{2}\right], \quad \forall k \in \mathbb{N} .}
\end{aligned}
$$

Also, for any $k \in \mathbb{N}$ we define:

$$
\varphi_{k}: \stackrel{\text { def }}{=} \sum_{j=0}^{\infty} \mathcal{A}_{k+2+2 j}\left(\frac{p}{3}\right)^{j}
$$

Now, we are ready to write down equations which define the family of functions $\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{\infty}:$

$$
\begin{gathered}
\frac{\partial \hat{b}_{k}}{\partial t}=\frac{1}{2 q_{t}}\left\{-\left(2-\frac{2}{k}\right) b_{k-1, t} p_{t}-\left(1-\frac{1}{k}\right) b_{k-1} p_{t t}-b_{k} q_{t t}\right. \\
\quad-\frac{1}{k}\left(-p b_{k-1, t t}+3 b_{k-3, t t}\right)-\bigodot_{k}+ \\
\quad \sum_{j=0}^{k}\left[\left(1-\frac{1}{j}\right) b_{j-1} p_{x}+b_{j} q_{x}+\frac{1}{j}\left(-p b_{j-1, x}+3 b_{j-3, x}\right)\right] \times \\
{\left[\left(2-\frac{2}{k-j}\right) b_{k-j-1, x} p_{x}+\left(1-\frac{1}{k-j}\right) b_{k-j-1} p_{t t}+b_{k-j} q_{x x}+\right.}
\end{gathered}
$$

$$
\begin{equation*}
\left.\left.2 b_{k-j, x} q_{x}+\frac{1}{k-j}\left(-p b_{k-j-1, x x}+3 b_{k-j-3, x x}\right)\right]\right\}, \quad \forall k \in \mathbb{N} \tag{7.11}
\end{equation*}
$$

We underline that functions $\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{\infty}$ satisfy the initial conditions (7.4b). The convention (7.8) must be employed to interpret correctly the last equation.

The solution of differential Equations (7.9) and (7.11) completes the construction of the fixed point mapping $\boldsymbol{F}$ (7.7). Then, the connection between the mapping $\boldsymbol{F}$ and the ramified CaUCHY problem (7.1) is elucidated in the following
Lemma 7.1. Let us assume that we have a fixed point data:

$$
\boldsymbol{F}\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right)=\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right)
$$

satisfying the 'initial' conditions (7.4). Then, the function

$$
\begin{equation*}
u(t, x)=\partial_{q}^{-1}\left(\sum_{k=0}^{+\infty} b_{k}(t, x) z^{k}\right) \tag{7.12}
\end{equation*}
$$

with $z^{3}=p z+q$ satisfies PDE (7.1a) together with the initial condition (7.1b).
Proof. By direct computations we have the following expressions for ansatz (7.12) derivatives:

$$
\begin{aligned}
& u_{\alpha}= \sum_{k=0}^{+\infty}\left[\left(1-\frac{1}{k}\right) b_{k-1} p_{\alpha}+b_{k} q_{\alpha}+\frac{1}{k}\left(-p b_{k-1, \alpha}+3 b_{k-3, \alpha}\right)\right] z^{k} \\
& u_{\alpha \alpha}= \sum_{k=0}^{+\infty}\left[\left(2-\frac{2}{k}\right) b_{k-1, \alpha} p_{\alpha}+\left(1-\frac{1}{k}\right) b_{k-1} p_{\alpha \alpha}+b_{k} q_{\alpha \alpha}+2 b_{k, \alpha} q_{\alpha}+\right. \\
&\left.\frac{1}{k}\left(p b_{k-1, \alpha \alpha}+3 b_{k-3, \alpha \alpha}\right)\right] z^{k}+ \\
& \frac{1}{3 z^{2}-p} \sum_{k=0}^{+\infty}\left[(k-1) b_{k-1} p_{\alpha}^{2}+2 k b_{k} p_{\alpha} q_{\alpha}+(k+1) b_{k+1} q_{\alpha}^{2}\right] z^{k}
\end{aligned}
$$

where the symbol $\alpha \in\{t, x\}$.
Then, using the definition of the mapping $\boldsymbol{F}$ along with the fact that

$$
\left(\hat{p}(t, x), \hat{q}(t, x),\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{\infty}\right)=\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right),
$$

one obtains the result stated in this Lemma. For more details, we refer also to Appendix B.

To the best of our knowledge, the presented algorithm is completely new.

### 7.2. Generalizations

We may attempt to generalize the result stated in Theorem 4.1 to the case of the PDEs family (3.1) with $m \geqslant 2$. However, we stress out that at the current stage it remains at the level of a conjecture:

Conjecture 7.2. Consider the following ramified IVP for Equation (3.1):

$$
\begin{align*}
\mathscr{L}_{m}(u): \Rightarrow \partial_{t}^{m} u-\partial_{x}^{m-1} u \partial_{x}^{m} u= & \underline{0},  \tag{7.13a}\\
u(0, x)= & c_{1} x^{m-1}+c_{2} x^{m-1+\frac{1}{3}} \\
& +c_{3} x^{m-1+\frac{2}{3}}+x^{m} \cdot u_{0}(x), \tag{7.13b}
\end{align*}
$$

where $c_{1,2} \in \mathbb{C}^{\times}, c_{3} \in \mathbb{C}$ and $u_{0}$ is a holomorphic function in some neighbourhood of $0 \in \mathbb{C}$. Then, for each choice of a root to the algebraic equation* $\tau^{m}-\partial_{x}^{m-1} u(0,0)$. $1^{m}=\underline{0}$ (where we replaced $\xi \leftarrow 1 \neq 0$ by homogeneity of the principal symbol), there exist holomorphic functions $p(t, x), q(t, x)$ and $\left\{a_{j}(t, x)\right\}_{j=0}^{2}$ defined in the vicinity

[^22]of $(0,0) \in \mathbb{C}^{2}$ such that there exists a local solution $u$ to (7.13) which can be written in the following form:
$$
u(t, x):=\partial_{q}^{-(m-1)} \circ\left(\sum_{j=0}^{2} a_{j}(t, x) z^{j}\right)
$$
where the function $z$ satisfies the following algebraic relation (4.5):
$$
z^{3}=p(t, x) z+q(t, x)
$$

The coefficients $p, q$ verify the 'initial' conditions:

$$
p(0, x)=\underline{0}, \quad q(0, x)=x
$$

Proof. Open problem.
Remark 7.2. The holomorphic functions $p(t, x), q(t, x)$ and $\left\{a_{j}(t, x)\right\}_{j=0}^{2}$ whose existence is conjectured above depend also on $c_{1,2,3}$ and on the function $u_{0}(x)$ appearing in the formulation of the CAUCHY problem (7.13b).

## 8. Numerical illustrations

In the absence of the rigorous theoretical proof, in this Section we would like to illustrate the practical convergence of the fixed point algorithm described in Section 7.1. Thus, it will provide a rational computational support towards various conjectures formulated in this study (in particular, the Conjecture 7.1 and indirectly Conjecture 7.2).

### 8.1. Test 1

In order to come up with a practical algorithm, we have to truncate the expansion (7.3):

$$
u(t, x) \approx \sum_{k=1}^{N} \frac{1}{k}\left(-p(t, x) b_{k-1}(t, x)+3 b_{k-3}(t, x)\right) z^{k}
$$

Since we work with holomorphic functions, we shall expand all the functions in double truncated series in the vicinity of the origin $(0,0) \in \mathbb{C}^{2}$ as follows:

$$
\psi(t, x)=\sum_{\substack{l, m=1 \\ l+m \leqslant M-1}}^{M-1} \psi_{l m} t^{l} x^{m}+\mathcal{O}\left(t^{M}+t^{M-1} x+\ldots t x^{M-1}+x^{M}\right)
$$

with $\psi \in\left\{p, q, b_{0}, \ldots, b_{N-1}\right\}$. So, in practice we perform all our computations with such double truncated power series in independent variables $(t, x) \in \mathbb{C}^{2}$. There is another technical issue towards the practical implementation of our algorithm that we have to describe here. Since we work with truncated data, our finitary mapping $\tilde{\boldsymbol{F}}$ by construction returns a slightly reduced set of data:

$$
\left(p(t, x), q(t, x),\left\{b_{k}(t, x)\right\}_{k=0}^{N}\right) \stackrel{\tilde{\boldsymbol{F}}}{\longmapsto}\left(\hat{p}(t, x), \hat{q}(t, x),\left\{\hat{b}_{k}(t, x)\right\}_{k=0}^{N-3}\right)
$$

Table 1. Various numerical parameters used in our computations.

| Parameter | Value |
| :--- | :---: |
| Floating point arithmetics, significant digits | 30 |
| Truncation degree in $t, M$ | 25 |
| Truncation degree in $x, M$ | 25 |
| Total number of iterations, $I$ | 25 |

Thus, at every iteration we are practically loosing three components of the data. Consequently, if we are willing to obtain $N$ components of data vector $\left\{b_{k}(t, x)\right\}_{k=0}^{N}$ after $I$ iterations, we have to initiate the iterative process with $\left\{b_{k}(t, x)\right\}_{k=0}^{N+3 I}$ initial components. We took into account this observation in our computations. We are going to illustrate the work of the algorithm starting from the following initial guess:

$$
\begin{align*}
p(t, x) & :=\frac{t}{2}, \quad q(t, x):=t+x,  \tag{8.1a}\\
b_{0} & :=\underline{1}, \quad b_{1}:=\underline{1}, \quad b_{j}:=\underline{0}, \quad \forall j \geqslant 2 . \tag{8.1b}
\end{align*}
$$

It corresponds to the Cauchy datum (7.5) as it is explained in the beginning of Section 7.1. Throughout all this Section 8 we shall assume $c_{1}=1$ and $c_{2}=\frac{3}{4}$. However, three different possibilities are taken for the rest of coefficients* $\left\{c_{j}\right\}_{j \geqslant 3} \subseteq \mathbb{C}$. For example, in this Section 8.1 we take all $\left\{c_{j}\right\}_{j \geqslant 3}$ to be zero.
Remark 8.1. The choice of the initial data (8.1a) implies that $q_{t}(0,0)=1$. This specifies one of two roots in $q_{t}(0,0)$ in the eikonal equation. Consequently, in all iterations we shall also have that $\hat{q}_{t}(0,0)=1$. Similarly, we shall also have $\hat{p}_{t}(0,0)=\frac{1}{2}$.

In order to speed-up the computations, we turn also to the floating-point arithmetics with, possibly, extended precision. The values of all other parameters are reported in Table 1. The proposed algorithm was implemented in the computer algebra system Maple ${ }^{\mathrm{TM}}$. The essential part of the employed code is reported in Appendix D. The complete program can be shared upon a simple request by email.

To summarize, we can say that we perform numeric-symbolic computations in order to observe the convergence towards a fixed point in practice. If we denote by $\psi^{(j)}$ the value of the variable $\psi \in\left\{p, q, b_{0}, \ldots, b_{N-3 j}\right\}$ after $j$ iterations, the closeness to the fixed point may be appreciated by looking at the norm of the difference between two successive iterations:

$$
\left\|\psi^{(j)}-\psi^{(j-1)}\right\| .
$$

We illustrate the behaviour of the proposed algorithm on the initial data (8.1). We perform $I$ iterations of our mapping. It turns out that even very moderate values of the parameter

Figure 4. The absolute value of the difference between two successive iterations $(I)^{\text {th }}$ and $(I-1)^{\text {th }}$ of solution data for $I=10$. The values of several numerical parameters are reported in Table 1.
$I$ (cf. Table 1) are enough to appreciate the convergence of the iterative fixed point process. The whole symbolic/numeric computation lasted about five minutes of the CPU time (on our computers). The precise information is not very important because it may vary from one system to another. In four panels of Figure 4 we show the differences between two last iterations of functions $\left\{p, q, b_{0}, b_{1}\right\}$, constituting the problem data. It can be clearly seen that the absolute value of the difference is quite small already after $I=10$ iterations. We checked that subsequent iterations reduce further this difference. The reduction of the $L_{\infty}$ norm of the difference between two successive iterations is shown in Figure 5. This Figure presents a strong empirical evidence for the convergence towards a fixed point, which solves the underlying IVP according to Lemma 7.1, even if the convergence seems to be far from being linear.


Figure 5. The maximum norm $L_{\infty}([a, b])$ of the difference between two successive iterations $(I)^{\text {th }}$ and $(I-1)^{\text {th }}$ as a function of the iteration number in semi-logarithmic coördinates. The initial data is given in Equation (8.1). The values of several numerical parameters are reported in Table 1.

In order to present even more convincing numerical evidence, we include in our study another test case with the following initial guess:

$$
\begin{align*}
p(t, x) & :=\frac{t}{2}, \quad q(t, x)  \tag{8.2a}\\
b_{0} & :=\underline{1}+t, \quad \quad b_{1}:=\underline{1}-t, \quad b_{j}:=\underline{0}, \quad \forall j \geqslant 2 . \tag{8.2b}
\end{align*}
$$

It is not difficult to see that these initial data (8.2) (which correspond to a different initialization with respect to (8.1)) verify the same initial conditions (7.4), i.e. the CAUCHY
datum (7.5). Thus, if the solution we seek is unique*, we may expect the iterations to converge to the same fixed point. This explains the motivation behind this second numerical study. We are using precisely the same numerical parameters as reported above in Table 1 (and, thus, the same parameters as in the previous computations). The convergence of the fixed point iterations is reported in Figure 6. We can observe the same ( $c f$. Figure 5) roughly linear, but non-monotonic convergence to a fixed point. Now one may ask a legitimate question whether iterations starting at (8.1) and (8.2) converge to the same point in $\mathcal{O} \llbracket z \rrbracket$ ? We may answer this question by looking at the difference between obtained solutions data at the final iteration $I$. We can have a look at these differences $t \longmapsto\left|\psi_{1}^{(I)}\left(t, x_{0}\right)-\psi_{2}^{(I)}\left(t, x_{0}\right)\right|$ in Figure 7 where they are represented as functions of time ${ }^{* *}$ for $t \in[a, b] \equiv\left[0, \frac{1}{10}\right]$. In particular, we would like to underline the fact that the magnitude of these differences is consistent with the results presented in Figures 5 and 6. All these observations provide a strong empirical evidence for the convergence of the iterative process described above. The experimental findings of this Section are schematically depicted and summarized in Figure 8.

### 8.2. Test 2

We shall consider a completely different initial condition from (7.1b):

u(0, x)=x+\frac{3}{4} x^{\frac{4}{3}}+\frac{3}{50} x^{\frac{8}{3}}+\frac{1}{20} x^{3} \tag{8.3}
\end{equation*}

In terms of the solution data, the last initial datum translates in the following coefficients:

b_{0} & :=\underline{1}, \quad b_{1}:=\underline{1},  \tag{8.4b}\\
b_{2}(t, x) & :=\frac{x}{10}, \quad b_{3}(t, x):=\frac{x}{10},  \tag{8.4c}\\
b_{j} & :=\underline{0}, \quad \forall j \geqslant 4 . \tag{8.4d}
\end{align*}
$$

The complexity of this test-case is much higher than what we do before. In order to make the computational times reasonable, we had to reduce the parameter $M:=10$. All other numerical parameters were kept as in Table 1. We studied the convergence of fixed point iterations under the map $\tilde{\boldsymbol{F}}$ for this IVP. Namely, we monitored the differences between successive iterations for variables $p, q, b_{0}, \ldots, b_{3}$. The results are reported in Figure 9. As we can see, the practical linear non-monotonic convergence can be clearly witnessed even in this test-case.

As we do it systematically, we consider also another initialization of the fixed point algorithm, which corresponds to the same CAUCHY datum (8.3) as before:

The algorithm was run with this initialization and all other parameters as above. The convergence of the iterations initialized with the initial date (8.5) is reported in Figure 10. We can observe a very similar behaviour to Figure 9 attesting one more time of the convergence of the proposed algorithm. One may ask the legitimate question whether two different initializations (8.4) and (8.5) do converge to the same point? This theoretical question is very complicated. However, what we can do in practice is to measure how close are the corresponding iterates from each other in the spirit of mental representation from Figure 8. This is done in Figure 11 where the difference $(t, x) \longmapsto \mid \psi_{1}^{(I)}(t, x)-$ $\psi_{2}^{(I)}(t, x) \mid$ with $\psi \in\left\{p, q, b_{0}, \ldots, b_{3}\right\}$. In order to make the error plot possible, we considered the real values of independent variables varying in some finite neighbourhood

of the origin $\mathbf{0} \in \mathbb{R}^{2}$ :

$$
\left\{(t, x) \in \mathbb{R}^{2} \left\lvert\, t^{2}+x^{2} \leqslant \frac{1}{100}\right.\right\} .
$$

In particular, Figure 11 shows that the convergence is the slowest for the component $b_{3}$ of the solution data but even for $b_{3}$ the results are perfectly acceptable.

The Section below contains another couple of computational investigations of the proposed fixed point algorithm.

### 8.3. Test 3

As a final numerical test-case, we consider another IVP (7.1), represented by two different initial guesses, which contains explicitly the fractional power $x^{\frac{4}{3}}$ along with $x^{\frac{5}{3}}$ in perfect agreement with the generalized Conjecture 7.2. Namely, in the Cauchy datum (7.13b) there is a term $c_{3} x^{m-1+\frac{2}{3}}$ (with $c_{3} \in \mathbb{C}$ ), which for $m=2$ gives $c_{3} x^{\frac{5}{3}}$ and it was absent in previous numerical Tests 1 (Section 8.1) and 2 (Section 8.2). As a result, we decided to include an additional numerical test which contains explicitly this term. Namely, we consider the following Cauchy datum:

u(0, x)=x+\frac{3}{4} x^{\frac{4}{3}}+\frac{3}{50} x^{\frac{5}{3}} \tag{8.6}
\end{equation*}
$$

This Cauchy datum can be represented by two slightly different initial data. The first initial guess reads:

p(t, x) & :=\frac{t}{2}, \quad q(t, x):=t+x,  \tag{8.7a}\\
b_{0} & :=\underline{1}, \quad b_{1}:=\underline{1},  \tag{8.7b}\\
b_{2}(t, x) & :=\frac{1}{10}, \quad b_{j}:=\underline{0}, \quad \forall j \geqslant 3 . \tag{8.7c}
\end{align*}
$$

The second one is

b_{0} & :=\frac{1}{2}, \quad b_{1}:=\underline{1}-\frac{t}{10},  \tag{8.8b}\\
b_{2}(t, x) & :=\frac{1}{10}+\frac{t^{2}}{5}, \quad b_{j}:=\underline{0}, \quad \forall j \geqslant 3 \tag{8.8c}
\end{align*}
$$

The convergence of both initializations has been studied symbolically and numerically using the code provided in Appendix D. The norms of differences between two successive iterations are reported in Figures 12 and 13. Moreover, Figure 14 indicates that both iterations converge to the same element of $\mathcal{O} \llbracket z \rrbracket$.

To make an intermediate conclusion, we would like to mention that the Authors tested several other (and even gradually more complicated) configurations, and the practical convergence of the proposed algorithm was invariably observed. This constatation gives us a good hope that Conjectures 7.1, 7.2 are true. More precisely, these numerical tests make quite plausible the following (informal) Conjecture, which, thanks to PiCARD theorem, would imply the Conjecture 7.1:

Conjecture 8.1. There exists a BANACH space $E$ with current point $(p(t, x), q(t, x)$, $\left.\left\{b_{k}(t, x)\right\}_{k=0}^{\infty}\right)$ and a closed subset $B \subseteq E$ satisfying the three following properties:
(1) The elements of $B$ satisfy for $t=0$ the initial condition corresponding to the value $u(0, x)$.
(2) $\boldsymbol{F}_{>}(\{B\}) \subseteq B$.
(3) The restriction $\left.\boldsymbol{F}\right|_{B}$ is a contraction.

### 8.4. The singular locus $4 p^{3}-27 q^{2}=0$ 's dependence on the Cauchy datum

Recall that the LERAY principle states that singularities of a ramified linear CaUCHY problem are determined by the singularity locus of the CAUCHY data. In our genuinely nonlinear case, this principle seems not to be valid anymore.

Above, we solved (approximately) three different ramified CaUCHY problems (7.5), (8.3) and (8.6). The singularities of the solution are determined by functions $p$ and $q$. Let us compare them at the end of respective iterative processes:

$$

p_{2}^{(I)} \approx & \frac{1}{2} t+\left(0.0250+0.0004 x+0.0025 x^{2}\right) t^{2}+ \\
& \left(0.0175+0.0070 x-0.0009 x^{2}+0.0003 x^{3}\right) t^{3}+\ldots \\
p_{3}^{(I)} \approx & \frac{1}{2} t+0.0113 t^{2}+0.0019 t^{3}+\ldots
\end{aligned}
$$

Let us have a look at the corresponding $q$ component approximations:

$$
\begin{aligned}
& q_{1}^{(I)} \approx t+x-0.0333 t^{2}-0.0050 t^{3}+\ldots \\
& q_{2}^{(I)} \approx t+x+(-0.0333+0.0133 x) t^{2}+ \\
&\left(0.0082-0.0010 x+0.0006 x^{2}\right) t^{3}+\ldots \\
& q_{3}^{(I)} \approx t+x-0.0200 t^{2}-0.0017 t^{3}+\ldots
\end{aligned}
$$

The lower indices show the test case number ( 1,2 or 3 corresponding to Sections 8.1, 8.2 and 8.3 respectively) and we show only four significant digits for the sake of notation compactness. Just from the visual inspection of expressions provided above, we can see that solution data $p$ and $q$ depend on the Cauchy datum. Thus, the Leray principle seems to hold in our problem and it is another sign of the genuinely nonlinear problem.

## 9. Further generalizations

In this Section we would like to announce the general conjecture that we would like to formulate as a result of our investigations on this topic. Let us denote by ( $t, \boldsymbol{x}$ ) a generic point of $\mathbb{C}^{n+1}$, where $\boldsymbol{x}=\left(x_{1}, x_{2}, \ldots, x_{n}\right) \in \mathbb{C}^{n}$. We fix also a polydisc $D \subset \mathbb{C}^{n+1}$ centered around the origin $\mathbf{0} \in \mathbb{C}^{n+1}$ and we denote by $\mathcal{O}_{D}$ the ring of holomorphic functions $A(t, \boldsymbol{x})$ on $D$.

Definition 9.1. Denote by $\ell_{m-1}$ the vector space of polynomial functions in several variables on $\mathcal{O}_{D}$ of the following form:

$$
F\left(t, \boldsymbol{x}, v_{1, \alpha_{1}}, v_{2, \alpha_{2}}, \ldots, v_{n, \alpha_{n}}\right): \stackrel{\text { def }}{=} \sum_{a \in \hat{a}} A_{a}(t, \boldsymbol{x}) \prod_{\ell=1}^{n} \prod_{k=1}^{m-1} v_{\ell, k}^{a(\ell, k)},
$$

where $A_{a} \in \mathcal{O}_{D}, \forall a \in \hat{a}$ and the collection of maps $\hat{a}$ is a finite set with elements of the type

$$
a: n^{\sqsupset} \times(m-1)^{\sqsupset} \longrightarrow \mathbb{N},
$$

which do not vanish identically, so that we always have

$$
F(t, \boldsymbol{x}, 0, \ldots, 0) \equiv \underline{0} .
$$

In the Definition above, $v_{\ell, k}$ (respectively, $v_{\ell, k}^{a(\ell, k)}$ ) should correspond morally to $\partial_{x_{\ell}}^{k}$ (respectively, to the nonlinear operator $u \longmapsto\left(\partial_{x_{\ell}}^{k} u\right)^{a(\ell, k)}$ ).

Let $u(t, \boldsymbol{x})$ be a germ of a holomorphic function at a point of the polydisc $D$. For any $F \in \delta_{m-1}$ we shall write:

$$
F\left(t, \boldsymbol{x}, \partial_{x_{1}}^{\alpha_{1}} u, \partial_{x_{2}}^{\alpha_{2}} u, \ldots, \partial_{x_{n}}^{\alpha_{n}} u\right): \stackrel{\text { def }}{=} \sum_{a \in \hat{a}} A_{a}(t, \boldsymbol{x}) \prod_{\ell=1}^{n} \prod_{k=1}^{m-1}\left(\partial_{x_{\ell}}^{k} u\right)^{a(\ell, k)}
$$

Notice, that in the previous expression the involved partial derivatives of the germ $u$ are of order at most $m-1$. Also, as above, we shall use extensively the multi-index notation. If $\beta:=\left(\beta_{1}, \beta_{2}, \ldots, \beta_{n}\right) \in \mathbb{N}^{n}$, we shall denote $|\beta|: \Rightarrow \beta_{1}+\beta_{2}+\ldots \beta_{n}$ and $\partial_{\boldsymbol{x}}^{\beta}: \Rightarrow \partial_{x_{1}}^{\beta_{1}} \circ \partial_{x_{2}}^{\beta_{2}} \circ \ldots \circ \partial_{x_{n}}^{\beta_{n}}$.

We consider also the following scalar quasi-linear differential operator of order $m$ :

P(u): \stackrel{\text { def }}{=} \partial_{t}^{m} u+\sum_{j=0}^{m-1} \sum_{\substack{\beta \in \mathbb{N}^{n} \\
|\beta|=m-j}} F_{j, \beta}\left(t, \boldsymbol{x}, \partial_{x_{1}}^{\alpha_{1}} u, \partial_{x_{2}}^{\alpha_{2}} u, \ldots, \partial_{x_{n}}^{\alpha_{n}} u\right) \partial_{t}^{j} \circ \partial_{x}^{\beta} u+ \\
G\left(t, \boldsymbol{x}, \partial_{x_{1}}^{\alpha_{1}} u, \partial_{x_{2}}^{\alpha_{2}} u, \ldots, \partial_{x_{n}}^{\alpha_{n}} u\right),
\end{array}
$$

where $F_{j, \beta}$ and $G$ both belong to the vector space $\boldsymbol{\rho}_{m-1}$. We are finally led to formulate the following
Conjecture 9.1. Consider $p \in \mathbb{N}^{\times}$and $p+1$ holomorphic functions $\left\{v_{j}(\boldsymbol{x})\right\}_{j=0}^{p}$ on $D \cap\left(\{0\} \times \mathbb{C}^{n}\right)$ such that both $v_{0}(\mathbf{0})$ and $v_{1}(\mathbf{0})$ are not zero. Let

$$
\begin{equation*}
u_{0}(\boldsymbol{x})=\sum_{j=0}^{p} v_{j}(\boldsymbol{x}) x_{1}^{m-1+\frac{j}{p+1}} \tag{9.1}
\end{equation*}
$$

be a germ of a holomorphic function ramified around $x_{1}=0$. We make the following two assumptions:
(1) The following polynomial equation in variable $\xi$ admits $m$ distinct roots*:

$$
\begin{align*}
& \xi^{m}+ \\
& \quad \sum_{j=0}^{m-1} \xi^{j} F_{j,(m-j, 0, \ldots, 0)}\left(0, \mathbf{0}, \partial_{x_{1}}^{\alpha_{1}} u_{0}(\mathbf{0}), \partial_{x_{2}}^{\alpha_{2}} u_{0}(\mathbf{0}), \ldots, \partial_{x_{n}}^{\alpha_{n}} u_{0}(\mathbf{0})\right)=0 . \tag{9.2}
\end{align*}
$$

(2) $\partial_{v_{1, m-1}} F_{0,(m, 0, \ldots, 0)}\left(0, \mathbf{0}, \partial_{x_{1}}^{\alpha_{1}} u_{0}(\mathbf{0}), \partial_{x_{2}}^{\alpha_{2}} u_{0}(\mathbf{0}), \ldots, \partial_{x_{n}}^{\alpha_{n}} u_{0}(\mathbf{0})\right) \neq 0$.

Then, the following statements are true. For each choice of a root to the algebraic Equation (9.2), there exist holomorphic functions $\left\{q_{\ell}(t, \boldsymbol{x})\right\}_{\ell=0}^{p-1}$ defined in a neighbourhood of the origin $\mathbf{0} \in \mathbb{C}^{n+1}$ such that

q_{0}(0, \boldsymbol{x})=x_{1}, \quad q_{\ell}(0, \boldsymbol{x})=\underline{0}, \quad \ell \in(p-1)^{\sqsupset} .
$$

We denote by $z(t, \boldsymbol{x})$ a holomorphic germ satisfying the following algebraic equation outside the swallow tail singularity:

z^{p+1}(t, \boldsymbol{x})-q_{p-1}(t, \boldsymbol{x}) z^{p-1}(t, \boldsymbol{x})-\ldots q_{0}(t, \boldsymbol{x})=\underline{0} .
$$

There exist also the holomorphic functions $\left\{a_{\ell}(t, \boldsymbol{x})\right\}_{\ell=0}^{p}$ defined on a neighbourhood of the origin $\mathbf{0} \in \mathbb{C}^{n+1}$ such that the function

u(t, \boldsymbol{x})=\partial_{q_{0}}^{-m+1}\left(a_{p}(t, \boldsymbol{x}) z^{p}(t, \boldsymbol{x})+\ldots+a_{1}(t, \boldsymbol{x}) z(t, \boldsymbol{x})+a_{0}(t, \boldsymbol{x})\right)
$$

satisfies:

$$
\begin{aligned}
P(u)(t, \boldsymbol{x}) & \equiv 0, \\
u(0, \boldsymbol{x}) & \equiv u_{0}(\boldsymbol{x}),
\end{aligned}
$$

where $u_{0}(\boldsymbol{x})$ was defined in (9.1).
Now, let us discuss the motivation behind this general Conjecture 9.1. The $p$-tuple $\left(z, z^{2}, \ldots, z^{p}\right)$ is solution of a holonomic $\mathscr{D}$-module whose characteristic variety $\mathbf{V}$ is

[^25]included in the union of the zero section of $\mathbf{T}^{*} \mathbb{C}^{p}$ and of the co-normal to the swallow tail singularity associated to the algebraic equation:
$$
z^{p+1}-q_{p-1} z^{p-1}-\ldots q_{1} z-q_{0}=\underline{0}
$$

The fact that this singularity is stable plays the crucial rôle in our constructions. Moreover, $\mathbf{T}_{0}^{*} \mathbb{C}^{p} \bigcap \mathbf{V}$ coincides with the line co-normal to $q_{0}=0$ and $q_{0}(0, \boldsymbol{x})=x_{1}$. These important facts explain why we consider only the contributions of the monomials $\partial_{t}^{j} \circ \partial_{x_{1}}^{m-j}$ in Equation (9.2).

The assumption (1) means that all the characteristics associated with this geometry are simple. The proof of Conjecture 9.1 should allow to construct $m$ solutions of this type, each corresponding to a choice of a root in Equation (9.2). It is quite clear that holomorphic functions $\left\{q_{\ell}(t, \boldsymbol{x})\right\}_{\substack{p=0}}^{p-1}$ highly depend on the initial datum $u_{0}(\boldsymbol{x})$ and, even more precisely, on $\left\{v_{j}(\boldsymbol{x})\right\}_{j=0}^{p}$. The assumption (2) means that the $\operatorname{PDE} P(u)=\underline{0}$ is genuinely nonlinear with respect to this geometry. The simplest example of such an operator $P(\cdot)$ from the Conjecture 9.1 statement is given by the following expression:

$$
P(u):=\partial_{t}^{m} u+\left(\partial_{x_{1}}^{m-1} u\right)^{n} \partial_{x_{1}}^{m} u, \quad n \in \mathbb{N}_{\geqslant 1}
$$

To make things clearer, let us emphasize that, for instance, the two following quasi-linear operators do not satisfy the assumption (2) of Conjecture 9.1:

& \bullet P_{1}(u)=\partial_{t}^{m} u+\left(\partial_{x_{1}}^{m-2} u\right)^{n} \partial_{x_{1}}^{m} u \\
& \bullet P_{2}(u)=\partial_{t}^{m} u+\left(\partial_{x_{1}}^{m} u\right)^{n} \partial_{x_{2}}^{m} u
\end{aligned}
$$

We summarize below the proposed strategy to attack this problem:
(1) We seek a solution of $P(u)=\underline{0}$ under the form

$$
u(t, \boldsymbol{x})=\partial_{q_{0}}^{-m+1}\left(\sum_{j=0}^{+\infty} b_{j}(t, \boldsymbol{x}) z^{j}\right)
$$

Since it does not seem to be possible to construct a solution directly, we proceed as in Section 7, i.e. we try to find an algorithm with an underlying map $\boldsymbol{F}$ such that a fixed point of $\boldsymbol{F}$ gives a solution. The fact that the swallow tail singularity should be characteristic for the PDE will lead to the eikonal equation. So, in some sense, we use an ansatz and the method of the geometric optics*. An heuristic (but crucial) underlying idea is that the Hamiltonian flow of the principal symbol of the linearized operator should propagate the singularities along the co-normal of the swallow tail.
(2) Find suitable semi-norms allowing to construct a BANACH space so that one might apply the fixed point theorem to the mapping $\boldsymbol{F}$.
We hope to motivate and stimulate the research in this direction. Of course, this programme is extremely difficult. The best rational reasons to believe that it should work are the validity of Theorem 2.2 (the case of algebraic equations of the second degree) and the numerical convergence results for the algorithm of Section 7.

## 10. Conclusions and perspectives

Above we presented the main results of the present manuscript. The main conclusions and perspectives of this study are outlined below.

### 10.1. Conclusions

In this article we considered several ramified CAUChy problem (CP)s for the first and second order genuinely nonlinear PDEs in the full complex setting. The term CP should be understood in the context because we specify only one initial condition even for PDEs (3.1) with $m>1$. We succeeded to understand completely the case of the iBE (1.1) using the methods of Cauchy-Kovalevskaya and those of the contact geometry. Both theories give the same singularities for the iBE solutions to the IVP (4.2). Then, we switched to the second-order IVP (7.1) for the genuinely nonlinear PDE (1.2). However, this problem cannot be addressed with the same methods. This observation lead us to consider some holonomic $\mathscr{D}$-modules, their geometry, which gave us the solution ansatz. The closed form expression is not possible even within the proposed ansatz. Consequently, we devised an iterative method whose fixed point gives the desired solution. Unfortunately, we were not able to prove rigorously its convergence. Nevertheless, we performed the practical computations with the celebrated computer algebra software Maple ${ }^{\mathrm{TM}}$ in order to check in practice the behaviour of the proposed algorithm. Indeed, our symbolic computations clearly indicate the convergence of the proposed method. The main part of the employed code is provided in Appendix D. On the basis of this empirical evidence, we were able to formulate several new conjectures which remain open for the moment, the main one being the Conjecture 9.1.

### 10.2. Perspectives

We already mentioned in Remark 5.2 the need to study the micro-local singularity of distributions $z$ and $z^{2}$. The Authors are currently working to establish a rigorous convergence proof for the iterative scheme proposed in Section 7. The underlying theoretical setting was briefly mentioned in Section 2. This result will allow us to establish the existence and uniqueness result for the considered IVP to Equation (1.2). For the moment, the appropriate BANACH spaces seem to have been identified (see Section 2). Of course, the application of these methods to other fully nonlinear and even higher order PDEs (such as the family of PDEs (3.1) with $m>2$ ) is to be expected. Finally, we would like to see the connections between our theory with the more classical theory of shock waves for $p$-systems as presented in [46, Chapter 12]. We shall investigate the interplay and connections between both theories. As the first glance on possible connections, we invite the reader to consult Appendix C. As a separate research direction, we would like to explore other types of singularities. According to the classification of catastrophes [3], the cusp and swallowtail belong to the class $A_{n}$ for some $n \in \mathbb{N}$. We believe that it would be interesting to explore other types of singularities $D_{n}$ and $E_{n}$ and the solutions they generate in the current genuinely nonlinear PDE framework.

## B. Details of computations

In this Appendix we explain more precisely how we construct the iterations from Section 7.1. Namely, we specify how the expression ( $\widehat{\mathbf{2}}$ ) is constructed from ( $\mathbf{w}$ )

Recall, that the solution ansatz is given by

Now, we construct ( $\widehat{\mathbf{W}}$ ) from ( $\mathbf{W}$ ) $\equiv u_{t t}-u_{x} u_{x x}$ in the following way. First, we replace in (B.1) the term $2 b_{k, t} q_{t}$ by $2 \hat{b}_{k, t} q_{t}$. Then, we replace in (B.2) the term $2 k b_{k} p_{t} q_{t}$ by $2 k b_{k} \hat{p}_{t} q_{t}$ and $(k+1) b_{k+1} q_{t}^{2}$ by $(k+1) b_{k+1} q_{t} \hat{q}_{t}$. Then, the eikonal Equation (7.9) is obtained by writing that $(\widehat{\mathbf{v}}) \in \mathcal{O} \llbracket z \rrbracket$, namely, the coefficient (B.2) of $\frac{1}{3 z^{2}-p}$
in ( $\widehat{\mathbf{W}}$ ) is divisible by $3 z^{2}-p$. Finally, Equation (7.11) is obtained by fulfilling the requirement that ( $\widehat{\mathbf{N}}$ ) $\equiv \underline{0}$.
Remark B.1. In Equation (B.2) we could have replaced the term $2 k b_{k} p_{t} q_{t}$ (respectively, $\left.(k+1) b_{k+1} q_{t}^{2}\right)$ by $2 k b_{k} \hat{p}_{t} \hat{q}_{t}$ (respectively $\left.(k+1) b_{k+1} \hat{q}_{t}^{2}\right)$ and thus get a nonlinear eikonal equation. What we did is roughly a simple linearisation of this, which is more convenient for implementing in practice. In other words, no matter what is the form of the eikonal equation, one has to perform the infinity of fixed point iterations. We took a special care to make each such iterative step as easy as possible.

## C. A simple explicit example of shock wave formation in the iBE

In this Appendix we would like to provide one simple explicit example and discuss some relations between our theory of ramified solutions and the classical theory of shock waves. This Appendix should be perceived only as an appetizer. The deeper connections will be revealed in the subsequent works.

Let us consider the following IVP for the iBE:

u(0, x) & =x^{\frac{1}{2}}, \tag{C.2}

where we took the square root singularity to simplify algebraic computations which follow. In the real case we would consider the IVP on a half-line $(t, x) \in \mathbb{R}_{\geqslant 0} \times \mathbb{R}_{\geqslant 0}$, but there are no such restrictions in the complex case. So, in agreement with our line of thinking, we assume that $(t, x) \in \mathbb{C}^{2}$. Using the methods of contact geometry described in Section 4.3, we introduce the auxiliary variable

The solution $u$ verifies the following second order algebraic equation:

The last algebraic Equation (C.4) can be also rewritten in an equivalent form:

Now it is obvious that the discriminant of Equation (C.4) is

$$
\delta: \stackrel{\text { def }}{=} y+\frac{t^{2}}{4}
$$

Our theory states that the complex solution $u$ will be ramified around the locus $\delta=\underline{0}$. Taking into account (C.3), two solutions to Equation (C.4) read

$$
r_{ \pm} \stackrel{\text { def }}{=} \frac{t}{2} \pm \sqrt{\left(\frac{t}{2}-\sqrt{x}\right)^{2}}
$$

We take two points $x_{0} \neq x_{1}$ and we consider two characteristics (C.3) passing through these points at $t=0$. If $x_{0,1}$ are real, we may assume that $0<x_{0}<x_{1}$ to fix the
ideas. Along the characteristic $y_{j} \stackrel{\text { def }}{=} x_{j}-x_{j}^{\frac{1}{2}} t$ the solution $u$ takes the value $x_{j}^{\frac{1}{2}}$, $j \in 2^{\sqsubset}$. A shock wave forms when two characteristics cross each other since in the crossing point the solution value is obviously contradictory:

$$
x_{0} \neq x_{1} \quad \Longrightarrow \quad x_{0}^{\frac{1}{2}} \neq x_{1}^{\frac{1}{2}}
$$

The crossing will take place when

$$
x_{0}-x_{0}^{\frac{1}{2}} t=x_{1}-x_{1}^{\frac{1}{2}} t
$$

It can be easily checked that the characteristic $y=x_{0}-x_{0}^{\frac{1}{2}} t$ meets the singular locus $\delta=\underline{0}$ in the real plane at time instance $t_{0} \stackrel{\text { def }}{=} 2 x_{0}^{\frac{1}{2}}$. Indeed,

$$
y_{0}=x_{0}-x_{0}^{\frac{1}{2}} t_{0} \equiv x_{0}-2 x_{0}=-x_{0}
$$

Henceforth,

$$
\delta\left(t_{0}, x_{0}\right): \Rightarrow y_{0}+\frac{t_{0}^{2}}{4}=-x_{0}+\frac{\left(2 x_{0}^{\frac{1}{2}}\right)^{2}}{4} \equiv 0
$$

and we deduce that $\left(t_{0}, x_{0}\right) \in \delta^{<}(\{0\})$. Moreover, it is not difficult to compute exactly the crossing time $t_{\star}$ :

$$
t_{\star}=x_{0}^{\frac{1}{2}}+x_{1}^{\frac{1}{2}}>2 x_{0}^{\frac{1}{2}}: \Rightarrow t_{0}
$$

We would like to explain what happens precisely at time $t=t_{0}$. Until the crossing time $t=t_{\star}$, the solution value along the characteristic $y_{0}$ is $x_{0}^{\frac{1}{2}}$. The point is that at time $t=t_{0}$ we change the solution branch. Indeed, for $0<t<t_{0}$ :

$$
r_{+}: \Rightarrow \frac{t}{2}+x_{0}^{\frac{1}{2}}-\frac{t}{2} \equiv x_{0}^{\frac{1}{2}}
$$

while for $t_{0}<t<t^{\star}$ we have

$$
r_{-}: \Rightarrow \frac{t}{2}-\left(\frac{t}{2}-x_{0}^{\frac{1}{2}}\right) \equiv x_{0}^{\frac{1}{2}}
$$

In other words, at the discriminant contact point $t=t_{0}$, we have no other choice except jumping from one solution branch to another in order to keep the constant solution value along the given characteristic. The changing of solution branch precedes and explains the apparition of the shock. This situation is illustrated in Figure 15.


Figure 15. A schematic graphical illustration of the shock wave formation in the iBE for an IVP (C.1), (C.2) with the square root algebraic singularity.

The code provided above was used to study the convergence of initial data (8.1), (8.2) and all the others from Section 8. A few modifications are needed to run the IVP (8.4). The complete programs can be obtained under a simple request by email.

## E. An example of a genuinely nonlinear problem

Sometimes, an example is worth one thousand words. In our terminology, the following Cauchy problem is nonlinear (quasi-linear) but not genuinely nonlinear:

$$
u_{t t}-u u_{x x}=\underline{0}, \quad u(0, x)=c_{1} x+c_{2} x^{1+\frac{1}{3}}
$$

for some real non-zero constants $c_{1,2} \in \mathbb{R}^{\times}$. In contrast, the following PDE is genuinely nonlinear:

$$
u_{t t}-u_{x} u_{x x}=\underline{0}, \quad u(0, x)=c_{1} x+c_{2} x^{1+\frac{1}{3}} .
$$

In reality, this notion depends on the operator and on the initial condition as well. That is why we speak above about the CAUCHY problem instead of just a PDE. The notion of a genuinely nonlinear problem was made more precise in Section 9.
