



Psycho-organizational and medical factors in burnout in French medical and surgery residents

ABSTRACT

Hospital residency is stressful, with a risk of burnout. To assess the prevalence of burnout in medical and surgical residents and identify psycho-organizational and medical risk factors with a view to prevention. A transverse study was conducted in France between September 2018 and November 2018, targeting 633 hospital residents. A self-administered questionnaire was delivered by e-mail. Burnout was assessed on the Maslach Burnout Inventory, anxiety/ depression on the Hospital Anxiety and Depression Scale (HAD) and stress on a visual analogue scale (VAS). Two-hundred and sixteen of the targeted residents (34%) responded. Twenty-three (12%) showed severe burnout in all three dimensions, severe loss of empathy being the most frequent. Almost one-third showed symptoms of anxiety. Residents exposed to psycho-organizational constraints (stress, time pressure, intense work rhythm) and/or with symptoms of anxiety/depression more frequently showed burnout. Prevention of burnout requires reinforced medical monitoring and reduced psycho-organizational constraints.

Introduction

Burnout was described by Maslach, Jackson and Leiter as a syndrome associating emotional exhaustion, depersonalization and diminished personal accomplishment (Maslach et al., 1996). The most recent versions of the International Classification of Diseases (ICD-10) and Diagnostic and Statistical Manual of Mental Disorders (DSM-5) did not recognize burnout as an entity. Both non-work-related and work-related factors influence burnout among physicians (Manit et al., 2013). Individual characteristics, such as personality and interpersonal skills, and personal experiences may influence how physicians cope with stress(West et al., 2018). Besides, work intensity and organization, high emotional demand with experience of suffering, death and emotional dissonance have been identified as psychosocial risk factors for caregivers (Gollac & Bodier, 2011). Medical and surgical residents, facing new responsibilities for patient care, exposed to emotional demands and time pressures, are the population at-risk of burnout (Goldhagen et al., 2015; Romani & Ashkar, 2014). Burnout among resident physicians has implications for patient care(Kang et al., 2013).

The present study aimed to assess burnout prevalence in medical and surgical residents and to identify psycho-organizational and medical risk factors, with a view to prevention.

Material and methods

A transverse study was conducted in 633 hospital residents in France: 376 medical/surgical, 257 in general medicine.

Data were collected via a self-administered questionnaire e-mailed to eligible residents.

The main endpoint (burnout) was assessed on the French version of the Maslach Burnout Inventory (MBI) (Maslach et al., 1996).

The three score dimensions are assessed independently:

Emotional exhaustion: nine questions, burnout is mild for atotal score \leq 17, moderate for 18–29 and severe for \geq 30.

Loss of empathy or depersonalization: five questions, burnout is mildfor a total score ≤ 5 , moderate for 6-11 and severe for ≥ 12 .

Personal accomplishment: eight questions, burnout is mild for atotal score \geq 40, moderate for 34–39 and severe for \leq 33.

The self-administered questionnaire covered three areas:;

Sociodemographic: gender, family situation and children.

Occupational: years of residency, specialty plus psycho-organizational: weekly workload, intensity of work rhythm, autonomy at work, task interruption, recognition, mutual assistance and access to training. Perceived stresswas assessed on a visual analogue scale (VAS) (Lesage & Chamoux, 2008).

Medical: perceived health status, frequency of physical activity, skipping meals, sleep time, drug consumption for sleep or anxiety, alcohol consumptions, smoking, cannabis consumption. Anxiety/depressionwas assessed on the validated French version of the Hospital Anxiety and Depression Scale (HAD) (Bjelland et al., 2002). The "anxiety" and "depression" dimensions are rated on three levels: no symptoms (score \leq 7), low (8–10) and high (\geq 11).

As emotional exhaustion is predictive of burnout, assessment focused on the association between emotional exhaustion and psycho-organizational and medical factors.

Analysis

A descriptive analysis was made of the sample's sociodemographic, occupational and medical characteristics.

Univariate analysis then assessed the association between emotional exhaustion and sociodemographic, occupational and medical factors. Chi-square and Fisher's tests were applied as appropriate. The significance threshold was set at 5%. Analyses used SAS 9.3 software.

Ethical statements

The study protocol had approval from the Terre d'Ethique committee, 14 June 2018 (n° IRBN412018/CHUSTE). Data collection and processing were declared to the CNIL data protection commission on 2 October 2018 (n°2 207 966 v 0). Eligible subjects received clear and comprehensible information on study objectives and procedures and were free to decline participation.

Results

Description of sociodemographic, occupational and medical characteristics (Table 1)

Two-hundred and sixteen of the 633 eligible residents (130 females, 86 males) responded: response rate of 34%.

Prevalence of burnout (Table 2)

Twenty-three respondents (12%) presented associated severe emotional exhaustion, severe loss of empathy and severe loss of personal accomplishment. Almost a third presented severe emotional exhaustion, almost half severe loss of empathy and fewer than 30% severe loss of personal accomplishment.

Relation between emotional exhaustion and sociodemographic factors (Table 3)

Severe emotional exhaustion was significantly associated with being single, but not with the number of children, gender or age-group.

Relation between emotional exhaustion and occupational factors (Table 4)

Severe emotional exhaustion was significantly associated with several psychoorganizational factors: high perceived stress, heavy workload, time pressure, task interruption, lack of autonomy, lack of means for good-quality work, non-recognition, lack of mutual assistance, and impact of workload on occupational performance and social and family life. Emotional exhaustion was not associated with the type of work structure or seniority in medical studies.

Relation between emotional exhaustion and medical factors (Table 5)

Severe emotional exhaustion was significantly associated with anxiety, depression, mediocre perceived health, and regular drug use for sleep or anxiety. Smoking and use of cannabis or alcohol did not show association with emotional exhaustion.

Discussion

In this study, 23 respondents (12%) showed severe burnout on all three dimensions. This was comparable to the findings of Costal et al. (Costa et al., 2012).

Severe loss of empathy was the most frequent dimension. This is in agreement with Doolittle et al. and Dyrbye et al., although at a higher level in the present study (Doolittle et al., 2013; Dyrbye et al., 2014).

Among sociodemographic factors, being single was more frequently associated with burnout than living in a couple, in agreement with previous reports (McManus et al., 2004; Willcock et al., 2004). Emotional exhaustion showed no association with gender, in agreement with Soler et al. (Soler et al., 2008)

Certain psychosocial factors showed association with severe emotional exhaustion: high stress, intense workload, time pressure, task interruption, lack of autonomy, lack of means for good-quality work, non-recognition, lack of mutual assistance. Previous studies reported that lack of social and supervisory support, lack of reciprocity in relationships at work, high workloads, and long and irregular working hours are residency characteristics linked to stress and burnout (Prins et al., 2010; Prins et al. 2007; Prins et al. 2007, 2008). Time demands, lack of control, work planning, work organization, inherently difficult job situations and interpersonal relationships are considered factors contributing to residents' burnout (Ishak et al., 2009).

Higher levels of stress coupled with poor coping strategies may be the major factors responsible for the development of burnout among medical students, due to the cyclic relation between stress and emotional exhaustion(Kajjimu et al., 2021; Lebares et al., 2018).

The number of working hours and caseload was shown to increase the likelihood of burnout indirectly, via their effects on either perceived workload or autonomy (Shirom et al., 2009; Soler et al., 2008). Work overload made the greatest contribution to overall stress (Ramirez et al., 1996).

A cross-sectional study of medical residents showed that working hours and major stress were significant independent determinants of emotional exhaustion (Ashkar et al., 2010). Another study reported a reduction in the prevalence of burnout after implementation of a work-week hour limit (Martini et al., 2004).

Raminez et al. showed that perceived job demands and lack of support from colleagues emerged as important stressors for medical specialists (Ramirez et al., 1996).

In the present study, severe emotional exhaustion was associated with mediocre perceived health, anxiety symptoms and depressive symptoms. This is in agreement with the literature (Clark et al. 1984; Willcock et al., 2004).

In the present study, smoking and use of cannabis or alcohol did not show association with severe emotional exhaustion, in disagreement with Soler et al.'s findings (Soler et al., 2008), but in agreement with (Lebares et al., 2018).

This study showed that residents exposed to psycho-organizational constraints (stress, time pressure, intense work rhythm) and/or with symptoms of anxiety/depression are more likely to experience burnout. Qualitative future research should assess the training in dealing with the emotional demands to reduce the emotional exhaustion. The internal validity of the study was limited by the cross-sectional design. The present 34% response rate may limit extrapolation to all medical and surgical residents in the Saint Etienne area. Data entry error, however, was limited by the use of an on-line questionnaire, and assessment of burnout and anxiety/depression used validated questionnaires.

Conclusion

In the light of the present findings, it seems necessary to reinforce medical monitoring of French medical and surgical residents for early screening of clinical signs of burnout, anxiety and depression. Combining individual and organizational interventions could have a good impact in reducing burnout in medical residents.

Multidisciplinary actions that include changes in work environment factors along with stress management programs that teach people how to cope better with stressful events showed promising solutions to manage burnout (Romani & Ashkar, 2014).

Physical exercise has been shown to ameliorate depression, anxiety and mood, making it an ideal intervention for burnout (Ishak et al., 2009). Greater dispositional mindfulness and greater trait resilience were both significantly associated with decreased risk of burnout (Lebares et al., 2018). Meditation has been also shown to alleviate burnout (Shapiro et al., 2005).
