10 A novel strain of the genus *Promicromonospora*, designated PT9<sup>T</sup>, was recovered from irradiated roots of the xerophyte 11 Panicum turgidum collected from the Ksar Ghilane oasis in southern Tunisia. Strain PT9<sup>T</sup> is aerobic, non-spore-forming, 12 Gram- positive actinomycete that produces branched hyphae and forms white to yellowish-white colonies. Chemotaxonomic Aqu 13 features, including fatty acids, whole cell sugars and polar lipid profiles, support the assignment of PT9<sup>T</sup> to the genus *Promi*-A02 cromonospora. The genomic relatedness indexes based on DNA-DNA hybridization and average nucleotide identity values revealed a significant genomic divergence between strain  $PT9^{T}$  and all sequenced type strains of the taxon. Phylogenomic AQ3 analysis showed that isolate PT9<sup>T</sup> was most closely related to *Promicromonospora soli* CGMCC 4.7398<sup>T</sup>. Phenotypic and phylogenomic analyses suggest that isolate PT9<sup>T</sup> represents a novel species of the genus Promicromonospora, for which the name *Promicromonospora panici* sp. nov. is proposed. The type strain is  $PT9^{T}$  (LMG 31103<sup>T</sup> = DSM 108613<sup>T</sup>). The 18 isolate PT9<sup>T</sup> is an ionizing-radiation-resistant actinobacterium ( $D_{10}$  value = 2.6 kGy), with resistance to desiccation and AQ5 20 hydrogen peroxide. The complete genome sequence of PT9<sup>T</sup> consists of 6,582,650 bps with 71.2% G+C content and 6291 21 protein-coding sequences. This genome will help to decipher the microbial genetic bases for ionizing-radiation resistance

#### Introduction

The genus *Promicromonospora*, belonging to the family *Promicromonosporaceae*, was first proposed by Krasil'nikov et al. (1961). This genus is phylogenetically closely related to the genera *Cellulosimicrobium* and *Oerskovia* (Schumann et al. 2001; Busse et al. 2003). Members of the genus are aerobic and Gram-positive actinomycetes. Their major characteristics are a branched substrate mycelium that fragments into rod-shaped or coccoid elements, iso- and anteiso-branched as the predominant cellular fatty acids, MK-9(H<sub>4</sub>) as the major menaquinone and a DNA G+C content of 70–75% (Schumann and Stackebrandt 2012).

*Promicromonospora* genus contains 18 species that have been isolated from various biotopes, such as air in the medieval Vienna (Busse et al. 2003), medicinal plant *Maytenus austroyunnanensis* in Yunnan Province (Qin et al. 2012), the surface-sterilized root of a pine tree in Australia (Kaewkla et al. 2017), soil in Mount Song (Zheng et al.

2017), etc. However, it is important to note that the num-52 ber of validly named species is 14 as of August 08, 2020, 53 available at https://lpsn.dsmz.de/genus/promicromonospo 54 ra, including Promicromonospora soli (Zheng et al. 2017), 55 Promicromonospora kermanensis (Mohammadipanah et al. 56 2017), Promicromonospora callitridis (Kaewkla and Franco 57 2017), Promicromonospora alba (Guo et al. 2016) and Pro-58 micromonospora iranensis (Mohammadipanah et al. 2014), 59 among the most recently described species. 60

Promicromonospora strains have industrially and environmentally valuable applications owing to the production of various bioactive molecules (Gabani and Singh 2013; Thomas et al. 2016), such as antibiotics (Izumikawa et al. 2011), xylanase (Kumar et al. (2011), cellulase (Thomas et al. 2016), xylanilyticolides (Jin et al. 2018), etc. Fur-66 thermore, Promicromonospora genus showed interesting biological properties, such as antimicrobial activity against 68 bacteria and yeast pathogens (Zothanpuia et al. 2018), bioremediation by the removal of cadmium from polluted waste 70 (Hamedi et al. 2015), plant growth-promoting rhizobacterium through the production of gibberellins (Kang et al. 2012, 2014), etc.

Despite the potential applications of *Promicromonospora* 74 species, there have been a limited number of reports that 75 investigated genomic and phenotypic aspects such as multi-76 resistance to extreme conditions (radiation, desiccation, 77 oxidative stress, etc.) of this genus members. The number 78 of related genomes available at the National Center for Bio-79 technology Information (NCBI) and the Genomes OnLine 80 Database is limited to 25 as of August 08, 2020. 81

In this study, we report the phenotypic, phylogenetic and 82 genomic characterization of a novel actinomycete species, 83 Promicromonospora panici sp. nov., with insights into its 84 tolerance to ionizing radiation (IR), desiccation and oxida-85 tive stress. 86

#### Materials and methods 87

#### Strain isolation and cultivation 88

PT9<sup>T</sup> was isolated from irradiated roots of *P. turgidum*, A:O6 which were collected in May 2015 from the oasis Ksar 90 Ghilane (Tunisia, coordinates N 32°59.557', E 9°36.941', 91 221.9 m above sea level) at the gates of the Sahara Desert. 92 One-gram root sample aliquots were exposed to levels of 93 IR at a dose of 10 kilogray (kGy) with a mean rate dose of 94 25.6 kGy/h at room temperature using a cobalt-60 gamma 95 irradiator at the National Center for Nuclear Sciences and 96 Technology (CNSTN), Tunisia. After gamma irradiation, 97 the 1 g root samples were mixed with 9 mL of 0.9% NaCl 98 solution (w/v) and shaken on a rotary shaker at 250 rpm, 99 30 °C for 1 h (h). Then, 100 µL sample of the suspension 100

was serially diluted  $(10^{-5}-10^{-9})$  and spread onto tryptic soy 101 agar (TSA) medium (contains 15 g/L of tryptone, 5 g/L of 102 soy peptone, 5 g/L of sodium chloride and 15 g/L of bacte-103 riological agar, at pH 7). After 7 days of aerobic incubation 104 at 30 °C, colonies were transferred and purified on liquid 105 medium using tryptic soy broth (TSB) and maintained as 106 20% (v/v) glycerol suspensions at -20 and -80 °C (Rainey 107 et al. 2005). 108

For routine work, PT9<sup>T</sup> was cultured aerobically on solid 109 TSA medium and liquid TSB medium for 3 days at 30 °C. 110 Isolate PT9<sup>T</sup> was deposited in the BCCM collection (Bel-111 gian Coordinated Collections of Microorganisms) and the 112 DSMZ collection (Deutsche Sammlung von Mikroorganis-113 men und Zellkulturen GmbH) under the deposit numbers 114 LMG 31,103 and DSM 108,613, respectively. 115

#### Morphological and phenotypic characteristics

Colony morphology of isolate PT9<sup>T</sup> was observed by using 117 cells grown on TSA at 30 °C for 2 days. Gram staining was 118 assessed using the standard Gram stain method and spore 119 motility was carried out by optical light and epifluorescence 120 microscopy (Leica Microsystems, Germany) observation 121 of cells suspended in phosphate buffer (at pH 7). For the 122 observation of morphological characteristics, bacterial cells 123 growing on TSA medium at 30 °C for 72 h, were harvested 124 with 2% glutaraldehyde in saline solution (0.9% of NaCl) 125 and then fixed cells were dried in a graded ethanol series (50, 126 70, 90 and 100% of ethanol) (Kaewkla and Franco 2019). 127 Observations were done via a scanning electron microscope 128 (JSM 5400.JEOL, Japan). 129

Growth of isolate was checked on Luria-Bertani 130 (LB) (sodium chloride 10 g/L, tryptone 10 g/L, yeast 131 extract 5 g/L), nutrient agar (meat extract 10 g/L, pep-132 tone 10 g/L, sodium chloride 5 g/L, agar 15 g/L at pH 133 7.3), R2YE medium (is a variation of R2 containing yeast 134 extract) (sucrose 10.3 g/L, K2SO4 0.25 g/L, MgCl2·6H2O 135 10.12 g/L, glucose 10 g/L, casamino acid 0.1 g/L, yeast 136 extract 5 g/L, agar 15 g/L), soya flour mannitol agar (soya 137 flour 2 g/l, mannitol 20 g/L, agar 20 g/L), starch casein agar 138 (starch 10 g/L, casein powder 10 g/L, agar 15 g/L at pH 139 7.2) and in TSA medium at 30 °C for 72 h. The optimal 140 temperature for growth was tested by checking growth on 141 TSA over a range of 10-60 °C with 5 °C intervals. The pH 142 range for growth was examined over a range pH 4-10 with 1 143 pH unit intervals in TSB over 3 days of incubation at 30 °C. 144 Tolerance of NaCl was evaluated in TSB supplemented with 145 0-15.0% (w/v) NaCl (at 2.0% intervals) after incubation at 146 30 °C for 72 h. 147

Catalase activity was determined by monitoring genera-148 tion of bubbles upon the addition of a drop of 3% hydro-149 gen peroxide  $(H_2O_2)$  solution (Smibert and Krieg 1994). 150 Oxidase activity was assessed by the oxidation of 0.2% (w/v) oxidase reactive by monitoring the colour change.

For chemotaxonomic characterization, cells of PT9<sup>T</sup> 153 were maintained on yeast extract-malt extract agar (Inter-154 national Streptomyces Project medium 2; ISP2) medium 155 which had been shaken at 180 rpm and incubated for 156 7 days at 28 °C. After incubation, the biomass of isolate 157 PT9<sup>T</sup> was harvested from ISP2 broth cultures. Then, cells 158 were washed three times with sterile distilled water and 159 freeze-dried. Whole-cell sugars were extracted according 160 to the procedures of Lechevalier and Lechevalier (1970) 161 and identified using thin layer chromatography (TLC) as 162 described by Staneck and Roberts (1974). Whole-organism 163 diaminopimelic acids were identified using the protocols 164 of Schleifer and Kandler (1972). Polar lipids pattern was 165 determined following the modified protocol of Minnikin 166 et al. (1984) by Kroppenstedt and Goodfellow (2006). Cel-167 lular fatty acids were extracted according to the protocol 168 of Miller (1982) with minor modification from Kuykendall 169 et al. (1988). Fatty acid patterns were determined from 170 the biomass of isolate PT9<sup>T</sup> using the Standard Microbial 171 Identification (MIDI) system Version 4.5 and the ACTIN6 172 database (Sasser 1990). 173

# Genome sequencing, molecular and phylogeneticanalyses

#### 176 Genomic DNA extraction

Genomic DNA extraction from isolate PT9<sup>T</sup> was per-177 formed as described previously by Marmur (1961) with a 178 phenol/chloroform extraction step (Li et al. 2007). Cells 179 from 50 mL cultures grown on TSB were collected by 180 centrifugation (Eppendorf France) and the pellets were 181 solubilized in 8 mL of 10 mM Tris-HCl at pH 8, 10 mg/ 182 mL of lysozyme and 1 mM of ethylenediaminetetraacetic 183 acid (EDTA). Cells lysis was done on the ice during one 184 hour, then 8 mL of 2% w/vol sodium dodecyl sulfate (SDS) 185 and 2.8 mg/mL of proteinase K were added to the mix and 186 incubated at 55 °C for 5 h. Proteins and cell debris were 187 removed by extraction with 16 mL of phenol, chloroform 188 and isoamyl alcohol 25:24:1 (v/v/v) at pH 8.2. After cen-189 trifugation, the aqueous phase was transferred into a new 190 tube and genomic DNA was precipitated by adding 1.5 mL 191 of 3 M sodium acetate and two volume of absolute ethanol. 192 The DNA pellet was washed in 70% ethanol, air-dried and 193 solubilized in TE buffer (Tris-EDTA buffer from Invit-194 rogen<sup>TM</sup>, 10 mM Tris and 0.1 mM EDTA) at pH 8. The 195 quality of extracted DNA was assessed by measuring the 196 A<sub>260</sub>/A<sub>280</sub> ratio using a Nanodrop (Implen NP80, Thermo 197 Fisher Scientific, USA) spectrophotometer. 198

#### Genome sequencing, assembly and annotation

The genome sequencing of PT9<sup>T</sup> was performed on the Illu-200 mina MiSeq<sup>TM</sup> platform (Illumina, USA) by Biofidal society, 201 Vaulx-en-Velin, France (https://www.biofidal-lab.com) using 202 NextGen High Throughput Sequencing. Thus, a standard 203 Illumina shotgun library "Nextera XT DNA Library Prep" 204 was constructed and sequenced using the Illumina MiSeq 205 technology by synthesis. A paired-end sequencing strategy 206 was used with an average size of  $2 \times 300$  bp in length gener-207 ated and a total number of reads of 25,425,220 bp obtained. 208 Quality control of raw data was assessed using the FastQC 209 tool (https://www.bioinformatics.babraham.ac.uk/projects/ 210 fastqc). The Unicycler software was used for de novo assem-211 bly. Genome annotation was performed with the Micro-212 Scope platform version 3.10.0 using the integrated micro-213 bial genomes non-redundant database, KEGG and COG 214 databases (Vallenet et al. 2017). Reads were processed and 215 assembled as described by Castro-Wallace et al. (2017). The 216 final draft assembly had an average depth coverage of 6.9 217 Mbp and 59 contigs. In addition, the percentage of G + C in 218 the complete genome sequence was calculated. 219

#### Phylogenetic analysis and genomic comparisons

Analysis of the 16S rDNA gene used the complete sequence 221 retrieved from the genome using MAGE platform (Vallenet 222 et al. 2009). This gene was identical to the 16S rDNA gene 223 sequence originally deposited in GenBank (MG712873) 224 after the initial single colony isolation and amplification 225 by polymerase chain reaction using the universal 27F and 226 1492R primers (Sun et al. 2010). The resulting 16S rDNA 227 gene sequence was compared with those of all validly named 228 species using the EzTaxon database EzBioCloud (https:// 229 www.ezbiocloud.net/identify/) (Yoon et al. 2017) and the 230 web tool leBIBI(QBPP) available at https://umr5558-bibis 231 erv.univ-lyon1.fr/lebibi/lebibi.cgi (Flandrois et al. 2015). 232 The phylogenetic tree highlighting the position of PT9<sup>T</sup> rela-233 tive to the type strains of the other species within the genus 234 Promicromonospora was constructed using W-IQ-TREE 235 software accessed at https://iqtree.cibiv.univie.ac.at/, (Tri-236 finopoulos et al. 2016) based on the Shimodaira-Hasegawa 237 approximate likelihood ratio (SH-aLRT) (%) (Guindon et al. 238 2010) and the ultrafast bootstrap (UFboot) (%) (Minh et al. 239 2013). 240

These 16S rDNA sequence data have been submitted to<br/>the DDBJ/EMBL/GenBank databases through https://submi<br/>t.ncbi.nlm.nih.gov/ under accession number MG712873.241<br/>243Genome based phylogenetic tree was constructed using a<br/>high throughput wed server, Type Strain Genome server<br/>(TYG) available in the Genome to Genome Distance Cal-<br/>culator webserver (Meier-Kolthoff and Göker 2019).241<br/>242

Average nucleotide identity (ANI) values between the 248 genome of isolate PT9<sup>T</sup> and those of the type strains of 249 Promicromonospora species were calculated using best hits 250 and reciprocal best hits between two genomic datasets as 251 described by Yoon et al. (2017) available at (https://www. 252 ezbiocloud.net/tools/ani). The top hits of the 16S rDNA-253 related strains of PT9<sup>T</sup> were identified via the in silico 254 calculation of digital DNA-DNA hybridization (dDDH) 255 values between strains determination, using the Genome-256 to-Genome Distance Calculator (GGDC) web server (https 257 ://ggdc.dsmz.de/distcalc2.php) (Goris et al. 2007; Meier-258 Kolthoff et al. 2013). 259

#### 260 Growth under extreme conditions

The resistance of isolate PT9<sup>T</sup> to extreme conditions was 261 assessed under IR, desiccation and hydrogen peroxide stress. 262 The tolerance to gamma irradiation was assayed using cul-263 tures of PT9<sup>T</sup> and *Escherichia coli* grown in TSB medium 264 and LB agar, respectively at 30 °C for 3 days. Thus, E. 265 coli DH5a was used as an IR-sensitive bacterium (Beblo-266 Vranesevic et al. 2018) for comparative analyses. Briefly, 267 bacterial cells were collected, washed twice with a 0.9% 268 NaCl solution, homogenized and subsequently resuspended 269 in the same solution of NaCl. Survival rates after exposure 270 to a range of gamma radiation doses (1-5 kGy) were deter-271 mined using the 3-(4, 5-dimethyl imidazole-2-yl)-2, 5-diphe-272 nyltetrazolium bromide (MTT) assay (Mosmann 1983). Bac-273 terial cells were exposed to levels of gamma irradiation at 274 a dose ranging from 1 to 5 kGy using a cobalt-60 gamma 275 irradiator at the National Center for Nuclear Sciences and 276 Technology (CNSTN), Tunisia. A volume of 10 µL of MTT 277 solution (5 mg/mL) was added to 100 µL of irradiated cells 278 and kept in the dark for 3 h at 37 °C. Results are represented 279 with the corresponding controls not exposed to gamma irra-280 diation, normalized to 100% (Morini et al. 2017). After incu-281 bation, the absorbance in each well was measured, including 282 blanks, at 570 nm using a microtiter plate reader (Shimadzu, 283 UV-1800). The value of  $D_{10}$  (kGy), which is the dose nec-284 essary for a 90% reduction in Colony Forming Units, was 285 also calculated via RadioP1 (www.radiop.org.tn) (Benhamda 286 et al. 2015) based on our experimental survival data. 287

The desiccation tolerance assay was performed in TSB 288 medium according to Mattimore and Battista (1996). 289 Briefly, 200 µL of cell suspensions were pipetted into ster-290 ile Petri dishes and dried 28 days in a desiccator at 30 °C. 291 *E.* coli DH5 $\alpha$  was used as a desiccation-sensitive bacterium 292 (Beblo-Vranesevic et al. 2018) for comparative analyses. 293 After 28 days, samples were revived by washing the cells 294 off the plate with 200 µL of saline solution (0.9% NaCl) 295 to rehydrate the cells. Cell viability was examined using 296 MTT assay, then 100 µL of cell suspensions was transferred 297 to a 96-well microplate and a volume of 10 µL of MTT 298

solution (5 mg/mL) was added. The microplate was incu-299 bated at room temperature in the dark for 3 h at 37 °C. After 300 incubation, the absorbance of each well, including blank 301 (without cells) which was normalized to 100%, was meas-302 ured at 570 nm using a microtiter plate reader (Shimadzu, 303 UV-1800). The measured absorbance at OD 570 nm is pro-304 portional to the number of viable cells. The survival rate 305 represents the absorbance at 570 nm after drying with a 306 reference before drying. The package lethal (https://githu 307 b.com/hofnerb/lethal) was used also to estimate the survival 308 of PT9<sup>T</sup> following exposure to desiccation. 309

Growth of isolate PT9<sup>T</sup> with various concentrations of 310  $H_2O_2$  (v/v) was also performed as described by Gholami 311 et al. (2015). E. coli DH5α was used as a proteome-oxida-312 tion-sensitive bacterium (Krisko et al. 2010) for comparative 313 analyses. Fifty µL of bacterial suspensions were added to 314 100  $\mu$ L of TSB supplemented with 0–5% (v/v) of H<sub>2</sub>O<sub>2</sub> using 315 96-well microplates. Plates were kept in the dark at 30 °C 316 for 48 h with agitation at 120 rpm. The optical density was 317 determined at 630 nm using a microplate reader TECAN 318 (Infinite<sup>®</sup> 200 PRO, Germany). 319

#### Prediction of secondary metabolite clusters and genes related to oxidative stress response

Clusters for secondary metabolites of isolate PT9<sup>T</sup> were predicted using the antiSMASH (https://antismash.secondarym etabolites.org/#!/start) version 4.0.2 software (Weber et al. 2015). Besides, in silico analyses of the genome PT9<sup>T</sup> were done and genes implicated in scavenging of reactive oxygen species (ROS) were determined.

#### Nucleotide sequence accession number

The whole-genome shotgun sequence of isolate PT9T329was submitted to GenBank/ENA under BioProject accession number PRJEB29453 (ERP111755), BioSample331number SAMEA5056529 and SRA accession number332ERS2867704. Contig sequences of the de novo assembly334uWYY01000000–UWYY01000056.335

#### Results and discussion

#### Cultural and phenotypic characteristics

PT9<sup>T</sup> was isolated from the irradiated roots of *Panicum turgidum*, which were collected from the oasis of Ksar Ghilane in the south of Tunisia. The isolate is an aerobic, Grampositive, non-motile and non-spore-forming actinomycete. Colonies are white-pigmented on TSA medium (Fig. S1), like *P. xylanilytica*, which was isolated from the medicinal

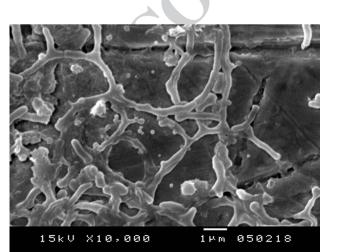
plant Mavtenus austroyunnanensis (Oin et al. 2012). Cells 344 of PT9<sup>T</sup> developed a branched substrate mycelium with a 345 wrinkled and shining surface, the septate hyphae of which 346 broke, at a later stage, into fragments of various sizes and 347 rod-shaped elements (Fig. 1). This feature is shared by all 348 members of the genus Promicromonospora (Krasil'nikov 349 et al. 1961; Schumann and Stackebrandt 2012). 350

This actinobacterial isolate had an optimal growth on nutrient agar, R2YE (medium specific for Streptomyces 352 genus), soya flour mannitol agar and TSA media after incubation at 30 °C for 72 h. It grew moderately well on LB agar and starch casein agar media. Growth of isolate PT9<sup>T</sup> was observed at 28–37 °C (optimum at 30 °C) and pH 6.0–9.0, like *P. xylanilytica* YIM 61515<sup>T</sup> (Qin et al. 2012). No growth was observed in the presence of 2% NaCl. Catalase 358 and oxidase activities of  $PT9^T$  were positive, similar to P. 359 xylanilytica YIM 61515<sup>T</sup> (Qin et al. 2012). Promicromonos-360 pora sukumoe was shown to have a very high endo-cellulase activity (Ventorino et al. 2015). 362

#### **Chemotaxonomic characteristics** 363

Chemotaxonomic features of isolate PT9<sup>T</sup> matched those 364 described for members of the genus Promicromonospora. Whole-organism hydrolysates of isolate PT9<sup>T</sup> contained DL-2,6-Diaminopimelic acid (DL-DAP) and galactose, glucose and ribose as whole cell sugars. These traits are the same as 368 the close phylogenetic neighbor, P. soli CGMCC 4.7398<sup>T</sup> 369 (Zheng et al. 2017). 370

Polar lipid profiles of PT9<sup>T</sup> consisted of diphosphatidyl-371 glycerol (DPG), phosphatidylglycerol (PG), phosphatidylin-372 ositol (PI) and unidentified lipid (L), phospholipid (PL), 373 phosphoglycolipid (PGL) and glycolipids  $(GL_{1,3})$ . These 374 features are coherent with those P. soli CGMCC 4.7398<sup>T</sup> 375 (Zheng et al. 2017) (Fig. S2). The major fatty acids (>25%)376



of PT9<sup>T</sup> are *anteiso*- $C_{15:0}$  (56.4%) and *iso*- $C_{15:0}$  (26.9%) 377 (Table S1), which are similar to those of P. soli CGMCC 378 4.7398<sup>T</sup> (Zheng et al. 2017). 379

The chemotaxonomic features of isolate PT9<sup>T</sup> are in line 380 with the genus Promicromonospora but are not enough to 381 distinguish isolate PT9<sup>T</sup> from its close neighbor. For this AQ8 reason, phylogenetic analyses based on genomic compari-383 sons were necessary to determine the taxonomic affiliation 384 of isolate PT9<sup>T</sup>. 385

#### Phylogeny and genomic comparisons

Blast of the complete 16S rDNA gene sequence (1508 bp) of 387 isolate PT9<sup>T</sup> showed similarity values of 99.3% and 99.0% 388 with P. xylanilytica YIM 61515<sup>T</sup>, Promicromonospora aero-389 lata DSM 15943<sup>T</sup> and *P. iranensis* DSM 45554<sup>T</sup>, respec-390 tively. However, it decreased to 98.9%, 98.8%, and 98.7% 391 with Promicromonospora vindobonensis DSM 24547<sup>T</sup>, 392 Promicromonospora thailandica DSM 26652<sup>T</sup> and P. alba 393 DSM 100490<sup>T</sup> and *P. callitridis* DSM 103339<sup>T</sup> (Table 1), 394 respectively. 395

Comparison of the sequences of isolate PT9<sup>T</sup> and type strains belonging to genus Promicromonospora revealed identity differences that are marginally within the cut-off value of > 1.3% (Stackebrandt and Ebers 2006).

The results of the 16S rDNA gene sequence similarity 400 are not in line with the phylogenetic position of strain PT9<sup>T</sup> 401 in the 16S rDNA gene based tree (Fig. S3). Strain PT9<sup>T</sup> 402 occupied a poorly supported distinct branch loosely associ-403 ated to a subclade housing several Promicromonospora spp. 404 including the ones cited above and next to the type strain of 405 *P. soli*. Thus, further information is required to determine the 406 reliable phylogenetic position of isolate PT9<sup>T</sup>. 407

In the genome based phylogenetic tree (Fig. 2), strain 408 PT9<sup>T</sup> was found to form a well-supported subclade closely 409 related to the type strain of P. soli which was associated to the branch of Promicromonospora umidemergens DSM 22081<sup>T</sup>.

16S rDNA gene sequence similarities between PT9<sup>T</sup> and 413 closely related type strains indicated the need to confirm 414 the genomic distinctness of the type strain as representing a 415 novel species by genomic relatedness indices. These analy-416 ses are necessary to further differentiate PT9<sup>T</sup> from other 417 species affiliated to the Promicromonospora genus. 418

Therefore, pairwise comparisons between isolate 419 PT9<sup>T</sup> and the available reference genomes were deter-420 mined based on the proposed thresholds for recognition 421 of genomic species, ANI and isDDH values. ANI values 422 between *P. panici* PT9<sup>T</sup> and closely related species ranged 423 from 84.6 with P. sukumoe DSM 44121<sup>T</sup> to 86.95% with 424 *P. soli* CGMCC 4.7398<sup>T</sup>, which were below the cut-off 425 level (95–96%) for species delineation (Goris et al. 2007; 426 Richter and Rossello-Mora 2009). Indeed, strain PT9<sup>T</sup> 427

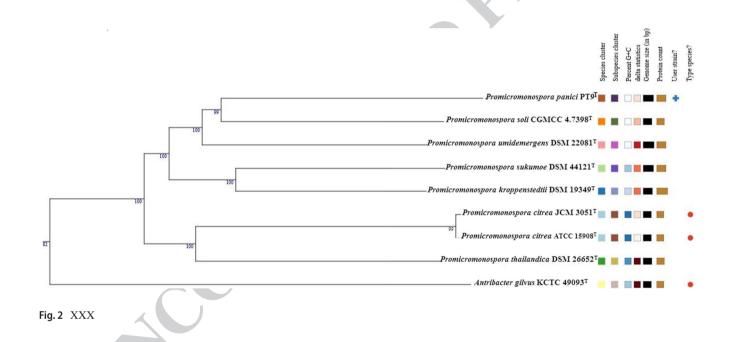

displayed isDDH value of 32.8% with its closest neighbor 428 P. soli CGMCC 4.7398<sup>T</sup> and 31.3% with Promicromono-429 spora kroppenstedtii DSM 19349<sup>T</sup>. DNA-DNA related-430 ness of 28.8% for isolate PT9<sup>T</sup> against P. sukumoe DSM 431 44121<sup>T</sup>. These values are well below the 70% cut-off value 432 recommended for the circumscription of bacterial genomic 433 species (Wayne et al. 1987; Chun et al. 2018). Thus, isDDH 434 and ANI values indicated that PT9<sup>T</sup> represents a novel spe-435 cies within the genus Promicromonospora. 436

Based on the morphological, phenotypic and
 genetic characteristics, it is evident that isolate PT9<sup>T</sup>
 should be assigned to a novel species in the genus

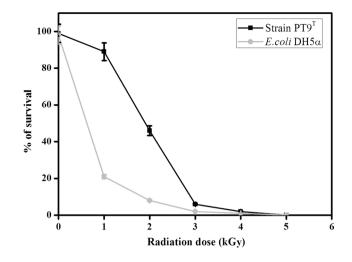
*Promicromonospora*, for which the name *Promicromono-* 440 *spora panici* sp. nov. is proposed. 441

442

#### **Growth under extreme conditions**

The survival rate of  $PT9^{T}$  after exposure to IR was assessed. 443 PT9<sup>T</sup> showed a marked survival profile following treatment 444 with increasing doses of gamma radiation (1–5 kGy), when 445 compared to *E. coli* DH5 $\alpha$  (Fig. 3). 446

As shown in Fig. 3, there is a significant difference 447 between survival profiles of  $PT9^{T}$  and the IR-sensitive strain 448 DH5 $\alpha$ . Indeed, the D<sub>10</sub> value of  $PT9^{T}$  was around 2.6 kGy 449

(Fig. S4). To be considered an IR-resistant prokaryote, a 450 bacterium should have a D<sub>10</sub> value greater than 1 kGy 451 (Sghaier et al. 2008). Accordingly,  $PT9^T$  ( $D_{10}=2.6$  kGy) was 452 described as an IR-resistant actinobacterium. Furthermore, 453 the desiccation of isolate PT9<sup>T</sup> for 28 days resulted in an 454 overall loss of culturable cells (CFU/mL) of approximately 455 32% (Fig. S5). Also, the survival rate for this Saharan act-456 inobacterium after 28 days of desiccation was 68% (Fig. S6). 457 Thus, it is legitimate to conclude that PT9<sup>T</sup> is also tolerant 458 to desiccation. 459

The evaluation of resistance to  $H_2O_2$  of PT10 was also assessed at various concentrations from 1 to 5% (v/v) (Fig. 4).

463 As shown in Fig. 4,  $PT9^{T}$  is tolerant to  $H_2O_2$  at concentra-464 tions ranging from 1 to 3% (v/v), when compared to *E. coli* 465 DH5α. However, the growth of  $PT9^{T}$  was almost completely 466 inhibited at a concentration of 5% (v/v) of  $H_2O_2$ .

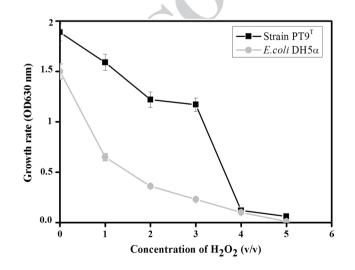

This is the first report that examined the growth under 467 extreme conditions of a strain belonging to genus Promi-468 cromonospora. Isolate PT9<sup>T</sup> is resistant to gamma radiation, 469 desiccation and oxidative stress  $(H_2O_2)$ . The convergence 470 and the similarity among desiccation and gamma radia-471 tion stress response pathways in Deinococcus radiodurans 472 were explained by the common production of ROS, which 473 induces oxidative damage to cells (Slade et al. 2011; Lim 474 et al. 2019). Thus, IR-resistant prokaryotes can also be desic-475 cation tolerant (Slade et al. 2011). However, it is necessary 476 to note that some desiccation-sensitive prokaryotes can pos-477 sess resistance to IR (Beblo-Vranesevic et al. 2018). 478

In this context, the 'radiation adaptation hypothesis' 479 stipulates that desiccation tolerance could be a consequence 480 to IR, as gene products contributing to IR may have been 481 recruited in some microbes to serve an additional function 482 that is desiccation tolerance (Sghaier et al. 2007). The multi-483 resistance of isolate PT9<sup>T</sup> may be originating from its oxida-484 tive response mechanisms. Thus, the genome sequencing of 485 PT9<sup>T</sup> was performed to identify these mechanisms and the 486 strategies used to thrive under extreme conditions, such as 487 gamma radiation, desiccation, salt concentration, H<sub>2</sub>O<sub>2</sub>, etc. 488

# Genome sequence analysis and oxidative stress response

#### **Genomic features**

The complete genome of *P. panici* PT9<sup>T</sup> consists of 492 6,582,650 bps in size and has an average G+C content of 493 71.2%. The size of the  $PT9^{T}$  chromosome is not similar 494 to this of the most closely related strain P. soli CGMCC 495 4.7398<sup>T</sup> (5,378,526 bps). De novo assembly of the genome 496 sequencing data of PT9<sup>T</sup> resulted in 59 contigs and an aver-497 age CDS length of 984.18 bp. The genome was predicted 498 to contain 6368 protein-coding genes, with a 91.9% pro-499 tein-coding density, 51 tRNA and 3 rRNA genes. General 500 features for the complete genome of  $PT9^{T}$  are shown in Table 2.

For 6291 protein-coding genes, 75.08% (4723 CDSs) 503 are classified in at least one Clusters of Orthologous Genes 504 (COG) group. The most abundant categories are general 505 function prediction (910); carbohydrate transport and 506 metabolism (808); transcription (744); amino acid trans-507 port and metabolism (610); and inorganic ion transport and 508 metabolism (405). The identification also of several catego-A09 ries involved in the defense of microorganisms, which are 510 cell wall/membrane/envelope biogenesis (270); replication, 511 recombination and repair (200); secondary metabolites bio-512 synthesis, transport and catabolism (175); chaperones (151); 513 defense mechanisms (116); and more others (Supporting 514 information presented in Table S2). 515

#### 516 Prediction of genes related to oxidative stress response

<sup>517</sup> The genome sequence of PT9<sup>T</sup> contains several genes impli-<sup>518</sup> cated in response to oxidative stress (Table 3).

Several proteins detected in isolate PT9<sup>T</sup> were reported 519 to have a role in IR and desiccation resistance-associated 520 mechanisms such as GyrAB, NucS, PolA, RadA, RecA, 521 RecD, RecO, SodA, SoxR, SSB and UvrD (Lim et al. 2019). 522 PT9<sup>T</sup> contains also various proteins implicated in defense 523 mechanisms related to oxidative stress response, such as uni-524 versal stress protein UspA, class III stress response-related 525 ATPase ClpC, Fe-S center for redox-sensing, putative ATP-526 dependent helicase DinG, putative ABC transporter YclH, 527 ferric enterobactin transport ATP-binding protein FepC, 528 daunorubicin/doxorubicin resistance ATP-binding protein 529 DrrA. The proteins observed in response to oxidative stress 530 of D. radiodurans were DNA repair proteins (PolA, RadA, 531 RecA, RecF, RecO), DNA protein binding (ArgF, DnaE, 532 HisS, RecN), ribosomal proteins (RplB, Rpsl, RpsR) and 533 oxidation-reduction process proteins (GltA, NuoC) (Slade 534 et al. 2009; Ujaoney et al. 2017; Gao et al. 2020). 535

Isolate PT9<sup>T</sup> seems to possess genes involved in the 536 protection of its cytosolic proteins from oxidation (such as 537 mntA, mntB, sodA) and the repair of DNA double-strand 538 breaks (DSBs) after exposure to IR (dinG, hup, recA, recQ, 539 ssbA) (Lim et al. 2019). Several DNA repair genes, which 540 were reported to contribute to radiation and oxidative stress 541 resistance in D. radiodurans, such as gyrAB, ligD, ligA, recC 542 (Bellenberg et al. 2019; Lim et al. 2019), were also detected 543 in the genome of isolate PT9<sup>T</sup>. Some genes of *D. radio*-544 durans, such as recF and recO, are extremely sensitive to 545 gamma rays, which are required for recombination repair 546 by an incomplete genome reconstitution, a reduced level of 547 DNA breakdown and an absence of DNA synthesis (Bent-548 chikou et al. 2010). RecF and RecO genes play an essential 549 role in DNA double-strand-break repair pathways through 550 an extended synthesis-dependent strand annealing process 551

(ESDSA) (Bentchikou et al. 2010), which might be involved552in the repair of DSBs and the DNA synthesis step of ESDSA553for isolate PT9<sup>T</sup>.554

Furthermore, the treatment of *D. radiodurans* R1 with IR555(and also desiccation) induced the over-expression of several556genes in responses to oxidative stress damages, such as *recA*557and *uvrD*, which encode proteins that have been previously558associated with DNA repair (Tanaka et al. 2004).559

PT9<sup>T</sup> contains also many DNA ligase paralogs (such as 560 ligA, ligC, ligD) and putative DNA ligases. For instance, 561 ligD gene is involved in the bacterial non-homologous DNA 562 end joining (NHEJ) pathway according to the study of Ishino 563 and Narumi (2015). D. radiodurans possesses efficient oxi-564 dative damage protection mechanisms, such as NHEJ and 565 CNDEJ (condensed nucleoid-dependent end joining) repair 566 pathways, involving radiation-inducible proteins (Ishino and 567 Narumi 2015). These DNA repair proteins, such as ATP-568 dependent DNA ligase that was detected in the genome of 569 PT9<sup>T</sup>, play a principal role in the CNDEJ pathway, which 570 represents a DSBs repair system specific to radioresistant 571 bacteria with a high degree of genome condensation. 572

PT9<sup>T</sup> contains also desiccation tolerance-associated proteins, such as ferritin BfrB, pleiotropic regulatory protein DegT, HTH-type transcriptional regulator RcdA, manganese-containing peroxidase XpdC (Mn\_catalase) (Lim et al. 4016 2019). 577

Various enzymes involved in oxidative stress responses, such as catalase, superoxide dismutase, NADH-dependent oxidases, manganese-containing antioxidants, which provide an important role to protect radioresistant microorganisms (Cárdenas et al. 2012; Bellenberg et al. 2019). Catalase KatA, superoxide dismutase [Mn] SodA and manganese MntA were detected in the genome of PT9<sup>T</sup>.

Radioresistant microorganisms have various mecha-585 nisms of defense against ionizing radiation, desiccation, 586 oxidative stress-generating agents and environmental 587 stresses that can damage cell components, including the 588 production of scavenging ROS, detoxification and repair 589 systems (Lim et al. 2019). Deinococcus radiodurans, has 590 developed efficient enzymatic and non-enzymatic anti-591 oxidant systems, involving different physiological deter-592 minants and well-regulated molecular mechanisms for 593 tolerance to radiation, desiccation and oxidative stress 594 (Timmins and Moe 2016; Bellenberg et al. 2019). D. radi-595 odurans employs various strategies to prevent oxidative 596 stress, including an efficient DNA repair system, ROS-597 scavenging enzymes (catalase and superoxide dismutase), 598 non-enzymatic antioxidants and transcriptional regulators 599 (OxyR) (Munteanu et al. 2015; Chen et al. 2019). The 600 genome sequence of D. radiodurans revealed the pres-601 ence of homologues of most well-known prokaryotic DNA 602 repair proteins involved in base excision repair, nucleotide 603 excision repair, mismatch repair and recombination repair. 604

Thus, the DNA repair machinery of D. radiodurans seems 605 similar to that of other bacteria, such as isolate PT9<sup>T</sup>, with 606 specificities contributing to radiation resistance and pro-607 608 tection of proteins against oxidative damages (Makarova et al. 2001; Daly 2012; Lim et al. 2019). 609

To conclude, oxidative stress resistance of PT9<sup>T</sup> against 610 damages caused by gamma radiation, desiccation and 611 oxidative stress generated by H<sub>2</sub>O<sub>2</sub> was explained by the 612 presence of a combination of enzymatic anti-oxidants 613 (ROS-scavenging enzymes, such as catalase, superox-614 ide dismutase) and non-enzymatic (like carotenoids and 615 manganese Mn<sup>2+</sup>) defense mechanisms (Shashidhar et al. 616 2010; Slade and Radman 2011). These proteins are mainly 617 associated with DNA repair and response to oxidative 618 stress. Further functional analyses of these new oxidative 619 stress-induced proteins will enhance our understanding of 620 the regulatory mechanism underlying extreme resistance 621 to oxidative stress in isolate PT9<sup>T</sup>. However, sufficient pro-622 teome protection is crucial for survival after irradiation 623 because protein activity is required for essential processes 624

including transcription, translation and DNA repair (Bel-625 lenberg et al. 2019). 626

#### Secondary metabolites prediction

The genome analysis of isolate PT9<sup>T</sup> harbors multiple 628 secondary metabolites related to defense mechanisms and 629 strategies developed to survive under extreme conditions 630 (Table 4). 631

As shown in Table 4, five biosynthesis gene clusters for secondary metabolites were identified in the genome of isolate PT9<sup>T</sup>—oligosaccharides, t3pks, lassopeptides, siderophores and ectoine.

Various microbial metabolites, such as oligosaccha-636 rides, carotenoids and compatible solutes (ectoine) were 637 demonstrated to protect cells against IR (Beblo-Vranesevic 638 et al. 2017). Cupriabactin is a carboxylate-type siderophore 639 extracted from Cupriavidus necator JMP134, which demon-640 strated important roles in iron scavenging, bacterial motility, 641 biofilm formation and oxidative stress resistance. Physiolog-642 ical analyses revealed that this system induced an increase 643

of the resistance of C. necator JMP134 to stress caused by 644 aromatic compounds (Li et al. 2019). In general, oxidative 645 stress responses of bacteria have been observed to be part 646 of complex phenomena such as biofilm formation, antibiotic 647 resistance and pathogenicity (Cárdenas et al. 2012). Also, a 648 secondary defense barrier consists of the induced expression 649 of specific ROS degrading enzymes and repair systems for 650 damaged macromolecules (Cabiscol et al. 2000). 651

Altogether, our findings allow us to develop an integrated 652 understanding of the molecular basis of recovery from desic-AO1 cation and other protein and DNA-damaging agents in PT9<sup>T</sup> 654 and roots-associated bacteria, particularly in the extreme 655 environment of the Tunisian desert. 656

#### Description of Promicromonospora panici sp. nov.

Promicromonospora panici [pa'ni.ci. N.L. gen. n. pan*ici* referring to the isolation source, the xerophytic plant 659 Panicum]. 660

Aerobic, Gram-staining positive, non-spore-forming 661 and non-motile actinobacterium. Forms well-developed 662 branching septate hyphae that breaks up into fragments of 663 various sizes and rod-shaped elements on the media tested 664 after incubation at 30 °C for 72 h. Colonies are white to 665 vellowish-white with characteristic wrinkly surfaces. Cells 666 grow well on soya flour mannitol, nutrient agar and tryptic 667 soy agar media, but no growth was observed on LB agar 668 medium. Optimal growth occurs at 28-37 °C (optimum at 669 30 °C) and pH 6.0–9.0. No growth in the presence of 2% 670 NaCl. Positive for catalase and oxidase. 671

The major fatty acids are anteiso-C15:0 and iso-C15:0. 672 The polar lipid pattern is diphosphatidylglycerol (DPG), 673 phosphatidylglycerol (PG), phosphatidylinositol (PI), phos-674 phoglycolipid (PGL), unidentified glycolipids (GL<sub>1,2</sub>), lipid 675 (L) and phospholipid (PL). Whole-organism hydrolysates 676 contain DL-2,6-diaminopimelic acid (DL-DAP), galactose, 677 glucose and ribose as whole cell sugars. 678

The genome of the type strain is 6.5 Mb with a GC con-679 tent of 71.2 mol%. The GenBank/ENA accession number for 680 the draft genome sequence of isolate PT9<sup>T</sup> is PRJEB29453. 681

The type strain  $PT9^{T}$  (LMG 31103<sup>T</sup> = DSM 108613<sup>T</sup>) was 682 isolated from irradiated roots of P. turgidum collected from 683 the Ksar Ghilane oasis, southern Tunisia. 684
