### Strained and Reactive Donor/Acceptor-Supported Metalla-Silanone

**Abstract:** A novel stable donor/acceptor-supported Mn(I)metallasilanone **3** was synthesized. The intramolecular silanone-Mn(I) interaction induces a highly strained three-membered cyclic structure, leading to an exceptionally high reactivity of **3** as a donor/acceptor complex of silanone. Indeed, metallasilanone **3** readily reacts with various small molecules such as  $H_2$  or ethylene gas in mild conditions.

In contrast to the ubiquitous carbonyl function, the heavier silicon analogue, silanones **I**, are generally highly reactive transient species<sup>[1]</sup> which were observed either in low-temperature argon matrices<sup>[2]</sup> or in the gas phase<sup>[3]</sup> and were evidenced by trapping reactions.<sup>[4]</sup> Silanones present a strongly polarized Si=O double bond (Si<sup> $\delta$ +</sup>O<sup> $\delta$ -</sup>) with a considerably large bond energy difference between SiO- $\pi$ - and - $\sigma$ -bonds,<sup>[5]</sup> and therefore, they easily oligomerize to give polysiloxanes.<sup>[6]</sup> Even though some recent studies have demonstrated that bulky or/and strongly  $\sigma$ - or/and  $\pi$ -donating substituents efficiently stabilize silanones, the synthesis of stable silanones **I** remains a great challenge and, to date, only a limited number of isolable silanones are available.<sup>[7-12]</sup>

A drastic improvement in the stability was achieved by Driess's group, using donor (II)<sup>[13]</sup> or donor/acceptor (III)<sup>[14]</sup> systems.<sup>[15-19]</sup> Thanks to that, several stable and easy-to-manipulate silanone derivatives have been prepared.<sup>[15-19]</sup> Particularly, the formation of donor/acceptor complexes III, which blocks both nucleophilic O and electrophilic Si centers, is very efficient. This was clearly demonstrated by the formation of chloro-substituted silanone as an air-stable molecule<sup>[20]</sup> as well as the isolation of SiO<sub>2</sub> as a stable monomeric species.<sup>[21]</sup> Nevertheless, not surprisingly, such a stabilization considerably reduces the reactivity thus limiting their synthetic potential.<sup>[22]</sup> A solution of this issue would be the introduction of the Lewis acidic component (A) as a Si-substituent, that would allow the formation of an intramolecular  $Si=O \rightarrow A$ interaction. Because of the high strain of the resulting three membered ring, complexes IV should present an enhanced reactivity. To date, only two stable transition-metal substituted silanones V have been described by Filippou's group<sup>[7]</sup> and by us.<sup>[8]</sup> Particularly, the cyclic Rh<sup>I</sup>-substituted silanone shows a unique reactivity associated with the two reactive centers (Si=O and Rh). However, in both cases, the desired intramolecular interaction to form a strained silanone-metal complex (type IV) was not observed.



Here, we would like to report the synthesis of  $Mn^1$ -substituted silanone **3** showing an original intramolecular silanone-Mn interaction. Contrary to poorly reactive donor/acceptor-stablized silanones (**III**), this highly strained cyclic silanone complex **3** is particularly reactive and is able to achieve the H<sub>2</sub>-splitting at room temperature.

As a precursor of cyclic silanone complexes, the  $Mn^{1}$ -silylidene complex **2** was readily synthesized by the stoichiometric reaction of phosphine-stabilized chloro-silylene **1** with NaMn(CO)<sub>5</sub> in toluene at 80 °C (Scheme 1). Complex **2** was isolated as a highly airsensitive dark purple powder in 86 % yield. In the <sup>29</sup>Si-NMR spectrum, a broad doublet signal appears at significantly down field

 $(\delta = 182 \text{ ppm}, {}^{1}J_{\text{SiP}} = 52.6 \text{ Hz})$ , but with an upfield shift compared to previously reported NHC-stabilized transition metal silylidene complexes **VI**<sup>[23]</sup> (M = Cr, Mo, W) (230 to 279 ppm) and the recently reported stable silylene-Mn complexes **VII** (285 to 364 ppm).<sup>[24]</sup> The <sup>31</sup>P-NMR spectrum displays a singlet signal at 31.9 ppm, which is significantly upfield shifted compared with that of the phosphine-stabilized silylene **1** (75.0 ppm). In the <sup>13</sup>C-NMR spectrum, the four carbonyl ligands appear as a broad signal at 226 ppm, probably due to the rapid isomerization through the pseudo rotation of Mn(CO)<sub>4</sub> moiety at RT. The structure of **2** reveals a planar Si1 center ( $\Sigma^{\circ}_{\text{Si}} = 360^{\circ}$ ) and a Si-Mn bond (2.163 Å) considerably shorter than Si-Mn single bonds (ca 2.35 Å), but similar to that observed for silylene-Mn complexes **VII** (2.188 Å), and in agreement with the Si=M double character of transition-metal substituted silylidene complexes.

In contrast to other double-bonded silicon species or silvlene-Mn complexes VII, which are generally highly reactive, silvlidene complex 2 is moderately reactive, and no reaction was observed with H<sub>2</sub>, ethylene, CO<sub>2</sub>, and 2,3-dimethylbutadiene. However, complex 2 readily reacts with N2O at -40 °C to afford the corresponding three-membered cyclic donor/acceptor-supported silanone 3 (Scheme 1), which was isolated as extremely air-sensitive yellow crystals from a concentrated THF solution at -50 °C (yield 42 %). Silanone 3 was obtained as a 70 : 30 mixture of two diastereomers as indicated by two sets of signals systematically observed in all NMR spectra. In the <sup>31</sup>P-NMR spectrum, two singlet signals (major: 40.6 ppm, minor: 40.7 ppm) appeared in the same region to those of silvlidene complex 2 (40.4 ppm). In contrast, <sup>29</sup>Si-NMR signals for the Mn-substituted Si atom are significantly upfield shifted (major: -6.0 ppm,  ${}^{1}J_{SiP} = 29.9$  Hz, minor: -3.4 ppm,  ${}^{1}J_{SiP} = 30.0$  Hz), which is in good agreement with a three-membered ring containing a silicon atom. In contrast to the case of silylidene complex 2, <sup>13</sup>C-NMR displays well-defined four singlet signals corresponding to the carbonyl ligands in the typical region (214.9 -223.3 ppm) for each diastereomer of 3.

The X-ray diffraction analysis of  $3^{[25]}$  reveals a three-membered cyclic donor/acceptor-silanone structure with two intramolecular coordination interactions  $P \rightarrow Si=O \rightarrow Mn$ . The Si1-O1 bond length (1.592 (2) Å), considerably elongated compared to Si=O double bonds (1.535 - 1.549 Å), is at the upper limit of those observed for donor/acceptor-supported silanones III (1.538 - 1.587 Å), but is still shorter than Si-O single bonds (1.65 Å), suggesting a weak and strongly polarized Si=O multiple-bond character. Indeed, the second order perturbation theory analysis indicates that one of the three lone pairs on O atom of silanone function is delocalized to the Si atom resulting in a relatively strong donor-acceptor interaction (99.6 kcal/mol). The Wiberg bond index and the Meyer bond order for the Si=O fragment are calculated to be 0.752 and 1.520 respectively.<sup>[26]</sup> Probably due to the ring strain, O1-Mn bond distance (2.147 (2) Å) is elongated from those of five-membered cyclic one  $8~(2.077~{\rm \AA})$ (vide-infra) and other related  $R_2C=O \rightarrow MnR(CO)_4$  complexes (2.55-2.069 Å). <sup>[27]</sup> The Si1-Mn bond (2.268 Å) is shorter than single bonds observed for  $R_3Si-Mn(L)(CO)_4$  complexes (2.35 - 2.50 Å)<sup>[28]</sup> but is similar to those observed for the previously reported basestabilized silylene-Mn<sup>I</sup> complexes (2.279 - 2.281 Å).<sup>[29]</sup>

To gain more insight into the electronic structure of metalla silanone 3, DFT calculations have been performed at the M06/6-31G(d) level of theory. The optimized structure of 3 agrees quite well with the experimental one (Si-Mn: 2.248 Å, Si-O: 1.606 Å, O-Mn: 2.135 Å, O-Si-Mn: 64.80°). The highest occupied molecular orbital (HOMO, -5.58 eV) corresponds to the Si-Mn  $\sigma$ -bond and the lowest unoccupied bond orbital (LUMO, -1.22 eV) mainly consists of a combination of two anti-bonding  $\sigma^*\mbox{-}orbitals$  at Si and P atoms ( $\sigma^*_{Si-O}$  and  $\sigma^*_{P-N}$ ). A labile character of Si=O $\rightarrow$ Mn interaction in 3 is suggested by the considerably low-lying  $\sigma *_{\text{O-Mn}}$  orbital (LUMO+1, -1.05 eV, Figure 3a) as well as the relatively high-lying O-Mn  $\sigma$ bond orbital (or  $n_0$  orbital directing to Mn center: HOMO-10, -8.50 eV, Figure 3c) which is close in energy to the  $\pi_{Si-O}$  orbital (HOMO-9, -7.97 eV, Figure 3b). This is particularly different from the donor/acceptor-supported silanones of type III, with a stronger silanone-Lewis acid interaction.

Thanks to an original donor/acceptor system, silanone complex **3** is perfectly stable at room temperature. However, the addition of

other ligands such as  $Ph_3P$  or CO (5 bars), probably inducing a dissociation of silanone from the Mn centre, immediately destabilizes **3**, affording a complex mixture of compounds.

Based on the MO analysis, the silanone-Mn interaction would be expected labile, and indeed, complex 3, behaving as a metal based Lewis pair (O: Lewis base and Mn: Lewis acid), quickly reacts under 3 bar of CO<sub>2</sub> at room temperature yielding the CO<sub>3</sub>bridged silvlene-manganese complex 4, via an insertion of  $CO_2$  into the O-Mn bond (Scheme 2). The concept of frustrated Lewis pair has been extended to systems containing transition metals which include not only molecular FLP complexes<sup>[30, 31]</sup> but also solid metals with FLP sites on their surface.<sup>[32]</sup> Furthermore, complex 3 cleaves, at RT, the Si-H bond of Ph3Si-H to afford the corresponding silyloxy silylene-manganese hydride complex 5. A typical high-field signal ( $\delta = -9.82$  ppm,  ${}^{3}J_{HP} = 19.6$  Hz) in the  ${}^{1}H$ NMR spectrum is in good agreement with the formation of a manganese hydride.<sup>[33]</sup> Of particular interest, the highly strained silanone complex 3 is capable to achieve the H<sub>2</sub>-splitting at room temperature. However, unlike previous reactions, there is no H<sub>2</sub>adduct formed, but a phosphine oxide-supported hydrosilylene complex 6 was obtained in 56 % yield. This silvlene-(tetracarbonyl)Mn(I) hydride complex 6 has been fully characterized by spectroscopic methods and X-ray diffraction analysis (Figure 3left).<sup>[25]</sup>

To understand better the reaction of 3 with  $H_2$ , we performed DFT calculations with a simplified model 3' with methyl groups instead of tBu and iPr groups (Figure 4). These calculations indicate that, similarly to the reaction with Ph<sub>3</sub>SiH, the reaction starts with the Lewis pair type H-H bond cleavage to form a H<sub>2</sub>-adduct 7' as an intermediate. This process proceeds through the replacement of Si=O on the Mn center by H<sub>2</sub> to form a dihydrogen-Mn complex intermediate (Int-1). Although the formation of Int-1 is thermodynamically unfavorable ( $\Delta G_{3' \rightarrow Int-1} = +$  6.8 kcal/mol), the following H<sub>2</sub>-bond cleavage process costs little energy ( $\Delta G^{\dagger}_{int-1\rightarrow7'}$  = 0.4 kcal/mol) and is exergonic ( $\Delta G_{3'-7'} = -25.6$  kcal/mol). Then, the isomerization of 7' proceeds by a dissociation of phosphine ligand from the Si center and its insertion into the OH bond (7'→Int-4) followed by a  $P \rightarrow Si$  hydride migration (Int-4 $\rightarrow$ 6') afford the experimentally obtained complex 6'. In the overall process, the ratelimiting step is the replacement of silanone on the Mn center by H<sub>2</sub> to generate Int-1 ( $\Delta G_{3' \rightarrow Int-1}^{\dagger} = +19.6$  kcal/mol), which is consistent with the fact that no intermediate has been experimentally observed.

In order to confirm this hypothesis, we considered the synthesis of the hydroxysilylene-Mn(I) complex  $7^{[7, 34]}$  *via* the 1,2-addition of H<sub>2</sub>O on the Si=Mn bond of Mn<sup>I</sup>-silylidene complex **2** (Scheme 3). The reaction proceeds immediately at room temperature leading to the formation of the 1,2-adduct **7**, which, as predicted, slowly isomerizes to give **6**. Nevertheless, complex **7** was found to be stable at -30 °C, and was characterized by NMR spectroscopy. Furthermore, single crystals of complex **7** were grown from a concentrated THF solution at -50 °C and its molecular structure was confirmed by X-ray diffraction study (Figure 3-right).<sup>[25]</sup>

Of particular interest, the reaction of **3** with ethylene proceeds differently leading to the ethylene-insertion into Si-Mn bond, instead of O-Mn bond, to afford a five-membered cyclic donoracceptor silanone complex **8** (Scheme 4). The reaction probably starts with the displacement of silanone ligand by ethylene on the Mn center to generate the olefin-Mn(I) complex **9** (Scheme 4), which evolves further by the migratory insertion of ethylene into Si-Mn bond to give the experimentally obtained complex **8**.

In conclusion, we have successfully synthesized the donor/acceptor-supported Mn(I)-metalla-silanone **3**, which presents a highly strained small cyclic structure formed by the intramolecular silanone-Mn(I) interaction. Thanks to the high ring strain, the interaction Si=O->Mn is labile, leading to an exceptionally high reactivity of Mn<sup>I</sup>-substituted silanone **3**, which readily reacts, as a metal-based Lewis Pair, with various small molecules in mild conditions. Further study on the reactivity of this new type of silanone complex and its applications are under active investigation.

Strained and Reactive Donor/Acceptor-Supported Metalla-Silanone



A new stable donor/acceptor-supported Mn(I)-metallasilanone was synthesized. This silanone complex is highly strained because of its incorporation in a small cyclic structure formed by the intramolecular silanone-Mn(I) interaction. Thanks to the high ring strain, the interaction Si=O->Mn is labile, leading to an exceptionally high reactivity with various small molecules such as  $H_2$  or ethylene gas in mild conditions.
