Is polymerase chain reaction fully reliable? A critical review in the light of published evidence from the golden decades of molecular genetics

Simple Summary: Soon after its introduction in 1987, Polymerase Chain Reaction (PCR) has11become a cycle-based technique widely employed in diagnostic medical devices and in foren-12sic science with the intention of amplifying genetic information. The achievement of a sufficient degree of fidelity is mandatory for reliability in applications; however, PCR prescribes14that each of its cycles must include a heating subprocess at 95°C or more, denominated DNA15denaturation, which may entail a risk of disruption of the DNA molecule.16

Understanding that the conditio sine qua non for the fidelity of PCR is to prevent such a disrup-17 tion, a review is presented of the historical literature of the years 1950-1960 elucidating the 18 effects of heating on possible DNA fragmentation. The main conclusion of this review is that 19 the body of examined evidence consistently and redundantly confirms such disruption when 20 DNA is heated at temperatures above 90°C, even for one minute. This appears to contradict 21 the paradigm of PCR fidelity and leads the authors to raise the concern that PCR may amplify 22 information, but, at least for long sequences, in an unreliable way. This should open a discus-23 sion on what the PCR paradigm could signify in various fields in which PCR is used. 24

Abstract: The purpose of this review is to verify the reliability of the PCR test in amplifying 25 the genetic information contained in the samples to be tested. The fundamentals of PCR in-26 clude, in each of its amplification cycles, a phase of denaturation of DNA by heating, which -27 according to the proponents – allows the two chains of the molecule to be separated, followed 28 by a cooling phase intended to allow-the formation of two equal molecular sequences of DNA. 29 The repetition of the procedure for several times would allow to obtain huge quantities of the 30 same sequence, thus allowing easier detection and analysis of a desired sequence. The possi-31 bility of fragmentation could however compromise the final result. While this is excluded by 32 the inventor, scientific literature on the matter is far from being unanimous. 33

Tracing back to the seminal studies on DNA heating, proof of longitudinal sequence-breaking34random thermal fragmentation of DNA molecules is found. To ascertain this phenomenon,35three main measurement methodologies have been applied on native and heated DNA by in-36dependent group of researchers: sedimentation rate, viscometry, and light scattering. The ex-37amined experimental studies agree – all but a few exceptions – in finding important alterations38of DNA even after one heating-cooling cycle: it would seem amplified DNA molecules could39not maintain their original structure.40

The real significance of PCR is questioned, and a thorough revaluation suggested on this mat-
ter and its consequences.4142

Sommario in italiano: Poco dopo la sua introduzione nel 1987, la Polymerase Chain Reaction 45 (PCR), una tecnica basata sulla reiterazione di procedimenti ciclici di manipolazione del mate-46 riale genetico, ha trovato largo impiego, in ambito medico diagnostico e nelle scienze forensi, 47 in dispositivi impiegati dagli utenti con l'intento di amplificare l'informazione genetica conte-48 nuta in campioni di materiale. Il raggiungimento di un grado di fedeltà di amplificazione suf-49 ficiente è fondamentale per garantire affidabilità nelle applicazioni; tuttavia, la PCR prescrive 50 che in ciascuno dei suoi cicli sia incluso un processo di riscaldamento a temperature uguali o 51 superiori a 95°C, denominato denaturazione del DNA, che può comportare il rischio di di-52 struggere le molecole di DNA. 53

Procedendo dalla considerazione che la conditio sine qua non affinché il requisito di fedeltà della 54 PCR sia garantito è che sia scongiurata una distruzione caotica della molecola oggetto di am-55 plificazione, viene qui presentata una revisione della letteratura storica a cavallo degli anni 56 1950-1960 allo scopo di chiarire gli effetti del riscaldamento sulla possibile frammentazione del 57 DNA. La conclusione principale di questa revisione è che il corpo complessivo di evidenze 58 esaminate conferma consistentemente e ridondantemente una siffatta distruzione quando il 59 DNA è riscaldato a temperature superiori ai 90°C anche per un solo minuto. Questa conclu-60 sione appare contraddire il paradigma della fedeltà della PCR e induce gli autori a sollevare la 61 preoccupazione che la PCR possa amplificare l'informazione ma, almeno per sequenze di lun-62 ghezza maggiore, in un modo non affidabile e non controllabile. Questa conclusione dovrebbe 63 sollecitare una discussione sul reale significato del paradigma della PCR nei vari campi in cui 64 questa tecnica è impiegata. 65

1. Introduction

As narrated by himself in an autobiographic note [1], in 1983 Kary Mullis 72 was struck by the idea of a procedure for synthesizing repeatedly Deoxyribo-73 Nucleic Acid (DNA) in vitro, which he named Polymerase Chain Reaction 74 (PCR). Beginning with a single target molecule of DNA, he envisaged he 75 could find DNA fragments and "generate 100 billion similar molecules in an af-76 ternoon". In 1985 he applied for a patent for PCR [2], then finished and substi-77 tuted it by a subsequent 1987 application [3]. He described such procedure 78 also in a scientific record [4] in the format of an experimental method. The 79 Authors report [3,4] that PCR is based upon the reiteration of a reaction cycle 80 which includes, in each cycle, a heating subprocess referred to as *denaturing* 81 or denaturation. In the "Claims" section of the patent application [3], denatur-82 ation was so mentioned: "wherein said nucleic acid is double stranded and its 83 strands are separated by denaturing". Hereafter, we will refer to such heating 84 subprocess intended for DNA strands separation as the 'denaturation claim' 85 or, more briefly, as DNA denaturation. 86

The presence of a DNA heating step, in a conceivable theoretical scheme 87 for nucleic acid amplification and sequencing, turns out to be a critical point 88 for the sake of the fidelity of such an amplification procedure against the risk 89 of thermal depolymerization, or disaggregation, of the DNA molecule. This 90 could lead to a consequential loss of information in the sequence of nucleotides, due to the random breakage mechanisms similar to those explaining 92 the molecular weight decay observed under the effect of gamma-rays on 93 fication purposes, and the results in the original early studies devoted to the analysis of the disruptive effects of heat on DNA. Such discrepancies are briefly sketched hereafter. 100 Innis et al. in 1988 [6], cited by Kary Mullis in 1990 [1], reported a remarkable fidelity of PCR by heating. It is stated indeed [6] that with PCR "segments of single-copy genomic DNA can be amplified >10 million-fold with very high specificity and fidelity" and (referring to a modified version of PCR therein pro-104

posed) that "the fidelity of PCR [...] is quite respectable (approximately one mistake 105 in 4000-5000 base pairs sequenced after 35 cycles of PCR and cloning of the prod-106 ucts)". They write "The mixture was heated to 90°C for 3 min, incubated at 42°C 107 for 20 min, cooled to room temperature", but no specific considerations or refer-108 ences are reported concerning the problem of a thermal depolymerization-109 Similarly, in [3,4] it is reported the possibility to customarily perform heating 110 steps from a temperature of about 80° up to temperatures as high as 100°C 111 and even 105°C [3]. 112

Conversely, the very early pioneering studies of historical relevance 113 which were entirely dedicated to the physical, chemical and biological effects 114 on DNA by several physical agents [7,8], provided compelling evidence that 115 heating above 81°, even for few minutes, determines a sharp thermal DNA 116 degradation. The observed degradation also consists in strands fragmenta-117 tion into shorter molecular segments involving deterministically unpredicta-118 ble sequence-breaking fractures of linkages along a single polynucleotide 119 chain. This phenomenon was early shown by several authors. Among others, 120 Shooter et al. carefully experimentally examined it [9], while Applequist in 121 1961 well described its bond scission kinetics by a random degradation model 122 [10] achieving significant predictivity of several degradation processes. Also, 123 the biological implications concomitant to DNA fragmentation with loss of 124 biological activity were early shown as a first macroscopic effect by Zamen-125 hof et al. (1953) [8]. 126

It is worth anticipating that, in this respect, a watershed publication deal-127 ing with the denaturation claim is a 3 pages short communication by Doty and 128 Rice published in 1955 [11]. With some emphasis, this paper can be said to 129 represent a sort of "parting of the Red Sea" as it marked the birth of a new 130 post-1955 paradigm on the preserved integrity of molecular information (after 131 DNA is brought to temperatures capable to irreversibly reduce its viscosity, 132 generally above 81°C, and consecutively cooled). Within a pre-1955 paradigm, 133 the DNA molecule appears to be divided into many smaller fragments upon 134 heating above 81°C while, within a post-1955 paradigm retrievable in part of 135 the literature, it undergoes only a marginal alteration which, at least according 136 to what has been stated by Doty in his 1955 paper, may also leave its molecular 137 weight unchanged or even determine strand disassociation. Quite remarka-138 bly, heating above 81°C, under some fast cooling conditions requirements spec-139 ified in a subsequent 1960 paper by Doty and coauthors [12], is deemed to be 140 even capable of bringing neat strands separation with halving of molecular 141

weight. Given the discriminant role of the 1955 short communication, this paper is carefully scrutinized in a subsequent section of the present study.

The aim of the present review is to analyze such apparent conflict between what has been reported in the more recent papers dealing with the denaturation claim and what has been found in previous seminal scientific publications of the decade 1950-1960, which have first investigated the matter of thermal denaturation/degradation.

The overall focus of the present study is on answering the following main 150 research question: 151

based on the available scientific literature concerning the investigation of 152 thermal degradation of DNA, is it plausible to admit that an amplification of 153 genetic information, stored in the sequence of DNA, can be achieved by consecutive heating/cooling cycles with temperatures above 90°C?

To answer the question above a detailed scientific review is reported of 156 publications which have provided qualitative and quantitative evidence elu-157 cidating if, how, and under which conditions, an onset of longitudinal se-158 quence-breaking random fragmentation of DNA molecules is possible at the 159 PCR heating temperatures above 90°C. Based on the critical scientific review 160 and discussion of diriment issues relevant to the plausibility of achieving am-161 plification of DNA information by consecutive heating/cooling cycles at tem-162 peratures above 90°C, this study is brought to a precise answer to the main 163 research question above and implications on PCR fidelity are drawn in a con-164 clusive section. 165

Given the ever-increasing diffusion of PCR in forensic science and in kits 166 for diagnostic applications asseverated by the World Health Organization 167 (some of which commonly known as "*PCR swabs*"), the purpose and significance of the questions posed in the current study are promptly understood to 169 be of high relevance for public health policies as well as in forensic science. 170

1.1. Guide to reading subsections of this review

The present study is organized as follows. In Section 2 a scientific background is reported and discussed in three parts separately. 175

- Subsection 2.1 presents a retrospective bibliographic survey 177 which starts from the account of the denaturation claim in Mullis' 178 1987 patent and parses all evidence about the denaturation claim 179 retrievable from the bibliographical references contained in the 180 main papers which have presented PCR.
- Subsection 2.2 presents a first introductory review of three papers 182 of Doty et al. of the years 1955–1960 which have introduced 183 some controversial elements of interpretation of the effect of 184 DNA heating at high temperatures.
- A third subsection, 2.3, reviews the pioneering studies from 1950 186 to 1960 on the effects of heating and of other physical and chemi cal agents, which mainly describe evidence against the 188

denaturation claim and consequently raise questions on the fidel-189 ity of PCR. 190

Focus of Section 2 is specifically kept over experiments capable to show 191 whether or not DNA complementary strands neatly separate as a consequence 192 of heating, and – even more – over the associated degree of preserved integrity 193 of molecular information upon repeated heating-cooling cycles with heating 194 above 80°C. 195

The organization of this review prosecutes as follows. Section 3 contains 196 a closer scrutinization and critical review of the papers by Doty and coworkers 197 in the years 1955-1960 and pinpoints key issues related to the denaturation 198 claim which are identified to be pivotal elements of controversy when com-199 pared with contemporary results on DNA heating. In Section 4, such key is-200 sues are discussed in the light of experimental evidence collected in this study 201 from the literature herein reviewed. Conclusions are finally drawn in Section 202 5. 203

2. Scientific background

2.1. The denaturation claim from PCR back to Doty and Rice (1955)

In Mullis and Faloona's paper [4] few information is reported on the 210 DNA denaturation step. Among five methods therein presented, for methods 211 I and II the Authors state: "The solution is brought to 100°C for 1 min, and is 212 cooled to 25 ° for 30 sec in a waterbath + 2 min" and the same heating time and 213 temperature are used for method II. For methods III, IV, V and VI, heating is 214 reported at a temperature of 95° with time varying from 2 to 5 minutes. The 215 paper does not contain references which deal with the function of the DNA 216 denaturation associated with the specific methodology employed, except for 217 three footnote references [13–15]. No differences of results are mentioned con-218 cerning the use of the two different temperatures and times. 219

Since Mullis and coworkers in their first descriptions [3,4] do offer scarce 220 bibliographical support to the denaturation claim, a dedicated background is 221 reported in this section. Hereafter, excerpts from three references [13-15] 222 mentioned in [3] and from those retrieved in Mullis' patent [16-17] are re-223 ported, selected as far as they contain significant information concerning the 224 issue under scrutiny, i.e. relevant or relatable to the denaturation claim as 225 presented by K. Mullis. Following a philological rationale, these excerpts are 226 presented by publication date in reverse order: 227

- In (Innis, 1988) [6], mentioned by Kary Mullis in 1990 [1] an "an-228 *nealing reaction*" is described comprising a step in which "the mix-229 ture was heated to 90°C for 3 min". Also, brief accounts of "PCR 230 thermal cycling" and of "denaturation at 93°C for 30 sec" are re-231 ported as well as brief accounts of denaturing steps "at 80°C for 3 232 min" and "at 75°C for 5 min". 233
- In (Kwok et al., 1987) [15], where the authors deal with the appli-234 cation of procedures related to PCR in search for identification of 235

- In (Scharf et al., 1986) [14] it is reported: "2 minutes of denaturation 240 at 95°C, 2 minutes of cooling at 37°C".
- In Saiki et al. (1985) [13] the information relevant to heating that 242 can be retrieved is the temperature of 95°C, and heating times of 243 2 minutes, 5 minutes or more, up to 10 minutes.
- In (Gaubatz and Paddock, 1982) [16] a "Heating and quick cool" 245 step is reported in Fig. 5 therein which depicts an "Hypothetical 246 approach for sequencing recombinant plasmid containing a cDNA". In 247 Section 4 therein it can be also read about "heat denaturation and 248 quenching in ice". 249
- The 1979 paper by Caton and Robertson [17] reports: "a novel technique is described for the production of pure, full-length influenza virus 251 ds DNA's corresponding to each segment of the influenza virus genome, 252 and suitable for molecular cloning and restriction endonuclease" and, 253 concerning heating, it is reported that "Corresponding cDNA's 254 were [...] boiled for 30 seconds and cooled on ice". 255

The excerpts collected above constitute the almost entire body of textual 256 information on the heating/cooling step that is readily retrievable after a *first* 257 level bibliographic scan from [1–4]. For the sake of scientific reproducibility of 258 materials and methods related to the PCR denaturation step, this information 259 is not sufficient to allow prompt repetition of the same experimental methods 260 by other researchers; even more, this information is not even adequate to per-261 mit a basic understanding of the elementary significance and purpose of tem-262 perature change in a 20°C-wide range of critical values, -i.e., from 80°C to 263 100°C — in this step of the PCR scheme. Times of heating also frequently dif-264 fer without explanation (from 1 minute to 1 hour or even more). 265

This substantial lack of information may let the reader presume that the 266 denaturation claim might have been considered established enough in the 267 specialized scientific community, at the time of these publication (i.e., in the 268 time frame 1979-1990), so as to not require additional descriptions or elucida-269 tions. 270

A second level bibliographic investigation of references cited in the papers just mentioned [6, 13-17], proceeding from 1979 backwards, offers a few additional elements about the denaturation claim. 273

Innis et al. [6] place PCR in the wake of refinements of DNA sequencing 274 techniques, which followed the methodology reported in a 1977 paper by 275 Sanger et al. [18]. Therein, concerning the denaturation claim, the only state-276 ment retrievable is that a solution of DNA is "heated to 100°C for 3 min". This 277 procedure refers to the DNA sequencing method described in a paper by Air 278 et al. (1976) [19], which is actually based on heating at 100°C for 3 min and 279 which, in turn, is reported to correspond, with slight modifications, to a pre-280 vious DNA sequencing method described by Sanger and Coulson (1975) [20]. 281

In [20] the denaturation step is reported "to separate the newly-synthesized 282 strands from the template". The importance of denaturing is remarked and, con-283 cerning heating, temperatures and time are indicated at 95°C as well as "at 95 284

to 100°C for 3 min". In presenting the principle of their synthesis method, 285 Sanger and Coulson cite Wu and Kaiser (1968) [21] who also refer in their 286 materials and methods section, when dealing with hydrolysis of DNA, of a 287 heating process of DNA mixtures "to 100°C for 3 min". Therein reference is 288 made to the enzymatic synthesis method of DNA proposed by Josse et al. 289 (1961) [22]. In this last paper, denaturation by heating is described with a 290 longer heating time: They specifically report "Heating of calf thymus DNA for 291 30 minutes at 100° in a medium of low ionic strength results in <u>collapse of the rigid</u> 292 helical structure to a randomly coiled configuration." 293

It can be concluded from this first literature parsing that the practice of 294 heating steps along times from 1 to 5 minutes, reported by Mullis and Faloona 295 (1987) and by Innis et al (1988), can be indirectly traced back to heating practices already accepted in 1961 as documented by the paper of Josse et al. who 297 apply 100°C for the larger time of 30 minutes. 298

Josse et al. report that "The pattern of sequence frequencies was the same in 299 DNA synthesized with calf thymus DNA primer or with enzymatically prepared primer in which only traces of the native calf thymus DNA primer were present. The 301 pattern was also unaltered when the primer used was denatured by heating." 302

A fundamental point to be remarked concerning the paper by Josse et al. 303 (1961) is the notion of unaltered pattern of frequencies. In the first page of this 304 paper it is clearly explained, however, that pattern of frequencies refers to 305 the frequency of occurrence of nucleotides. Understanding that the notion of 306 unaltered pattern of frequencies of nucleotides is completely different from the 307 notion of unaltered pattern of nucleotides, a fundamental question to be formu-308 lated for the sake of integrity of genetic information becomes the following: 309 "To what extent the 'collapse' entailed by such heating denaturation practices is re-310 versible for the sake of the integrity of the pattern of the sequences of nucleotides?" 311

Geiduschek and Holtzer in their 1962 review on light-scattering studies 313 for the characterization of DNA [24] also review the stability of DNA in aque-314 ous solutions to acids and heat and summarize the findings achieved at their 315 time into the following sentences (see pages 489-490 therein): "No distinction 316 between heat and acid denaturation is to be made. By suitable adjustment of these 317 variables, it is possible to deform DNA without change of molecular weight although 318 denaturation may under the proper circumstances be followed by degradation or even 319 aggregation". Also, they write: "The native helical structure of DNA can be dis-320 rupted in a variety of ways not involving changes of its chemical constitution" and 321 specify that among other causes "addition of acid [..], heating [...] are all capable 322 of producing denaturation". A list of 13 references supports this last assertion 323 on heating denaturation. These references are examined according to their 324 ability to provide diriment elements of evidence for answering to the key re-325 search question of the present study: if, and how, at the PCR heating temper-326 atures, above 90°C, an onset of longitudinal sequence-breaking random frag-327 mentation of DNA molecules is possible, and under which conditions. The 328 works of this list of 13 references containing diriment elements for answering 329 are reviewed in closer detail in Subsection 2.3 together with other fundamen-330 tal publications. Four of these 13 works are, instead, more briefly reviewed 331 hereafter (explaining the reason for such a briefer review). 332

The scientific content of the one-page conference proceeding by But-333 ler, Shooter, and Pain containing their report at the 1955 Third Inter-334 national Congress of Biochemistry in Bruxelles [25] is more broadly 335 presented and discussed in the six-pages publication by Shooter Pain 336 and Butler [9] on the journal *Biochimica et Biophysica Acta* submitted 337 just one month after the conference, on September 1955. This last sci-338 entific publication is reviewed in detail in Subsections 2.3.6 and 3.1. 339 From the 1955 book "The nucleic acids" edited by Davidson and 340 Chargaff, and contained among the 13 references by Geidusheck, no 341 specific conclusive information can be retrieved on the effect of heat-342 ing, in terms of proof or disproof of the occurrence of sequence-break-343 ing longitudinal fragmentation. In particular concerning heating at 344 100°C, in the fifth chapter on hydrolysis of nucleic acids by Loring 345 [26] on page 196 it can be read: "The purine bases of DNA are easily 346 removed by mild acid treatment (heating the free nucleic acid in 2 % solution 347 at boiling water bath temperature for 10 minutes) apparently without com-348 plete degradation of the original polynucleotide structure. The material re-349 maining was early recognized as a complex substance". In Chargaff's tenth 350 chapter of the same book [27], the distinction between denaturation 351 and degradation is discussed. Concerning the meaning of denatura-352 tion, it can be read: "A mild, but persistent, mistreatment of a protein leads 353 to a state of malaise known, vaguely, as denaturation." The Author writes: 354 "The line separating a denaturation product from a degradation product is 355 not clearly drawn; but one could define as denaturation products those sub-356 stances whose preparation caused interference with the physical properties, 357 but not with the chemical composition, of the parent nucleic acid, while the 358 latter change will form part of the description of a degradation product.". 359 This definition is understood to leave completely open the question 360 on whether the word *denaturation* contemplates or not a disruption or 361 a randomization of the genetic sequence by sequence-breaking fragmen-362 tations and sequence-recombining aggregations. However, no specific re-363 view or discussion of heating effects is reported in Chargaff's chapter 364 and in the remainder of this book. Concerning molecular weight de-365 cay as a primary indicator of possible longitudinal sequence-break-366 ing fragmentation, the reassuring conclusion achieved by Reich-367 mann, Bunce and Doty (1953) [28] is reported by Chargaff that the 368 adjustment of calf thymus DNA solutions (in 0.2 M NaCl), to pH 2.6 369 by dialysis "did not affect the molecular weight (7,700,000), as determined 370 by light scattering.". This conclusion by Reichmann et al. quoted in ref-371 erence [28] is closely reviewed in Subsection 3.2.2 together with the 372 underlying experimental evidence. Concerning stability to heat, even 373 in Jordan's chapter [29], devoted to the physical properties of nucleic 374 acids, no decisive information is retrieved about the thermal stability 375 to longitudinal fragmentation of the DNA molecule, apart from a 376 mention of the protective effect of salt against heat denaturation, as 377 found in Thomas' work [30-31]. It can be read in this chapter: "A 378 further protective effect of salts against heat denaturation of DNA solutions 379 has been observed by Thomas. For calf thymus DNA in sodium chloride so-380 lutions of various concentrations, some denaturation occurs at room 381

temperature at <10⁻⁴ M and below 70° in 10⁻² M. Denaturation is strongly 382 inhibited even at 100° C. in 10⁻¹ M and M solutions. It is claimed that heat 383 denaturation occurs stepwise and that the critical temperature for each step 384 varies for DNA from different sources. Thus DNA from starfish testis in 10⁻ 385 ² M sodium chloride undergoes the first step in denaturation at 55° C. com-386 pared with 70° C. for that from calf thymus.". In particular, the statement 387 that "Denaturation is strongly inhibited even at 100° C. in 10⁻¹ M and M 388 solutions" is a quotation of Thomas (1954) [29,31]. Concerning this last 389 statement by Thomas, it should be remarked that Thomas detects de-390 naturation by changes in optical density at 260 mµ and that this meas-391 ure in not conclusive neither in proof nor in disproof of occurrence of 392 sequence-breaking longitudinal fragmentation of the DNA molecule 393 at 100°C in presence of these salt concentrations. 394

- Finally, the two papers by Zamenhof and coauthors [32,33], among 395 the 13 cited by Geiduschek and Holtzer concerning heating degrada-396 tion and denaturation, are also not reviewed in detail since these two 397 works just extend measures of viscosity drop and bacterial transfor-398 mation inactivation reported by Zamenhof et al. (1953) [8] and do not 399 provide conclusive evidence in proof or disproof of the possibility of 400 the onset of disruptive longitudinal sequence-breaking random frag-401 mentation of DNA molecules in addition to the fundamental ele-402 ments of evidence already reported by Zamenhof in [8]. For this rea-403 son, in Subsection 2.3.3 only the scientific publication by Zamenhof 404 et al. (1953) is reviewed. 405
- The remaining 9 references quoted by Geiduschek and Holtzer are all 406 reviewed in closer detail in the next subsections.

2.2. The pivotal papers of Doty et al. of the years 1955–1960

Continuing the literature review by keeping a reverse chronological or-410 der and a focus on possible evidences of molecular integrity of the sequences 411 of nucleotides in a same strand at high temperature and/or of possible 412 strands separation, the bibliographic scan runs across three papers by Doty 413 and coworkers published between 1955 and 1960 [11,10,23], and already men-414 tioned in the introduction. These papers report results of physical and chem-415 ical analyses specifically devised to follow the molecular weight changes of 416 DNA during and after a heating/cooling cycle in order to attempt to under-417 stand how depolymerization and possible strand separation progress as a 418 consequence of heating. The conclusions of these three papers by Doty re-419 garding the consequences of DNA heating at 100°C deserve to be remarked 420 since they entail significant elements of mutual disagreement (i.e., conflict 421 among conclusions stated in these same three papers) and of conflict with the 422 conclusions of studies on DNA heating published before 1955. Some of these 423 elements of disagreement are reported hereafter. 424

In particular, Doty et al. (1960) [12] conclude their study reporting, in a 425 final summary, a very general statement: "When solutions of bacterial DNA are 426 denatured by heating and then cooled, two different molecular states can be obtained 427 in essentially pure form depending on the choice of conditions, that is, rate of cooling, 428 DNA concentration, and ionic strength". They continue: "One state corresponding 429 to fast cooling consists of single stranded DNA having about half the molecular 430 weight of the original DNA. The other state corresponding to slow cooling consists 431 of recombined strands united by complementary base pairing over most of their 432 length. This form has as much as 50 per cent of its original transforming activity and 433 is called renatured." The statement above is remarkably very general since, 434 without specifying the heating temperature and the heating time, it depicts a 435 single stranded product resulting from complete disassociation of all hydro-436 gen bonds between complementary strands into molecular weight halving. 437 We will refer to this picture as the *high temperature heating* + *fast cooling disso*-438 *ciation claim*. A second point of remark for the 1960 statement above is that it 439 turns out to be in open conflict with the conclusions by Doty and Rice in two 440 papers, one published in 1957 [23] and the other one published as a prelimi-441 nary note in 1955 [11]. Their preliminary 1955 conclusion is that, upon heating 442 a neutral saline DNA solution to 100°C for 15 minutes, the product is "found 443 to have the same molecular weight as the native DNA" [11]. Such conclusion is 444 further specified in 1957 to be inferred from light scattering studies, as the 445 Authors write that, upon observing the effects of heating of four calf thymus 446 DNA preparations along exposure times of one hour and more at tempera-447 tures from 89°C up to 100°C, "the molecular weight remains unchanged according 448 to light scattering studies" [11]. We will refer to the paradigm introduced in 449 these last 1955 and 1957 papers by Doty and Rice as the 100°C stable molecular 450 weight claim. Although the Authors include in [11] bibliographical references 451 to previous studies, such as the study by Goldstein and Stern [7] and Zamen-452 hof et al. [8], which bring instead to the opposite conclusion of DNA mole-453 cules thermally fragmenting in aqueous solutions already at temperatures not 454 higher than 81°C, the 100°C stable molecular weight claim is remarkable since 455 they make no mention of the existence of such a macroscopic conflict with the 456 previous literature. Even more remarkably, except for the 1955 preliminary 457 note, no subsequent mention is made by Doty et al. in [10] and [23] of Gold-458 stein and Stern's study among the referenced works, so that the trace of their 459 fundamental contribution is lost. 460

Additional elements of perplexity rise from reading in Doty et al. (1960) 461 [12] statements that appear to be in open conflict with both the *high tempera*-462 ture heating + fast cooling dissociation claim and the 100°C stable molecular weight 463 claim. For instance, the Authors report in [12] that heating pneumococcal 464 DNA of molecular weight 8.2 million at 100° for 10 minutes in standard saline 465 citrate and subsequently quickly cooling this material, they find a molecular 466 weight of 2.0 million (see page 471 therein). Even excluding, simplistically, 467 any considerations of polydispersity, this evidence is neither compatible with 468the first claim (which would require a decrease of molecular weight by a fac-469 tor of one half) nor with the second claim. 470

The literature showing evidence of thermally induced DNA fragmentation and the characteristic temperatures above which this phenomenon is observed is examined in the next subsection 2.3. The discrepancies determined by the 1955 and 1957 papers by Doty and Rice with previous findings are specifically examined and critically reviewed in the subsequent Section 3 of the present study. 477

478

2.3. Pioneering pre-1961 studies on DNA heating not authored by Doty

Prosecuting the literature scan before 1955, results are found implying 480 significant elements of divergence related to the *high temperature heating + fast* 481 *cooling dissociation claim* and to the 100°C stable molecular weight claim. This 482 group of references are presented hereafter in progressive chronological 483 order. 484

2.3.1. Evidence of viscosity drop and of heat turning fibrous material into flocculent precipitate

Strong and consistent evidence of DNA thermal degradation resulting in 489 the fragmentation into much smaller molecular products (thus incompatible 490 with a hypothesis of orderly disassociation or with one of unchanged molec-491 ular weight) had clearly emerged in several papers between 1950 and 1960. 492 Milestone results of experiments on thermal depolymerization showing this 493 fragmentation evidence are described by Goldstein and Stern in 1950 [7]. The 494 Authors report the following diriment experimental observation "Preliminary 495 tests showed that a highly viscous aqueous solution of sodium desoxyribosenucleinate 496 loses its viscosity when it is heated almost to the boiling point and then permitted to 497 cool to room temperature. Upon adding the solution to 1.5 volumes of ethyl alcohol a 498 flocculent precipitate is formed instead of the fibrous material yielded by "native" nu-499 cleic acid preparations." Concerning viscosity, Fig. 12 therein (reproduced in 500 Fig. 11 of Section 4.1) shows that a 0.1% solution of purified calf thymus DNA 501 in a barbital buffer at pH 7.2, heated just one minute at 100°C, experiments an 502 irreversible drop of relative viscosity, from a value of 3.4 to a value below 1.4 503 (see Fig.7TEMP in Section 4.1). Besides, the same figure shows a similar drop 504 to a value, close to 1.4, is obtained by a 2 minutes heating at 90°C. 505

Notably, Goldstein and Stern warn that an experiment that fails in detect-506 ing evidences of depolymerization (produced either sonically or thermally) is 507 ultraviolet absorption spectrophotometry. Specifically, concerning changes 508 upon heating in ultraviolet spectrum absorption of solutions of tetrasodium 509 salt of DNA (therein indicated by the acronym STN), they report: "The exami-510 nation in the Beckman spectrophotometer of a 0.048% STN solution in distilled water 511 (after dilution to 0.008%) which had been heated for 15 minutes at 100° showed no 512 change in the position of the maximum at 259 m μ or of the minimum at 231 m μ , 513 although the relative viscosity had fallen from 3.11 to 1.35 as a result of this treatment. 514 The rise in optical density from 1.28 to 1.46 at 259 $m\mu$ which was observed in this 515 experiment may possibly be due to the fact that it was performed in the absence of a 516 buffer system." 517

Goldstein and Stern also warn (see section therein "Effect on Absorption 518 Spectrum") that when the optical density absorption spectrum is observed in 519 the wave lengths range from 225 to 300 mµ, changes are detected only if the 520 solvent is distilled water ("unbuffered" solution) while in the buffered solu-521 tions no changes are observed. Such findings find confirmation in a study by 522 Blout and Asadourian (1954) [35] showing that the intensity of ultraviolet ab-523 sorption of the sodium salt of DNA is dependent on the ionic strength. The 524 intensity of absorption is highly pH dependent, in the absence of salt, in the 525 pH range 3 to 12. These and other results therein reported concerning various 526

heating tests between 60 and 100°C lead the Authors to the conclusive obser-527 vation: "The depolymerization of desoxyribosenucleic acid by thermal treatment is of 528 special interest in view of the high temperature coefficient and, hence, large energy of 529 activation, observed in the range between 60 and 100°C (see Fig. 12). While this phe-530 nomenon is similar to the heat inactivation and denaturation of proteins (cf. ref. 22), 531 there exist important differences. Thus, the nucleic acid molecules appear to be split 532 into many small fragments on heating while the thermal denaturation of proteins, as 533 a rule, does not lead to a significant alteration of their molecular weight, although in 534 some instances aggregation will occur under these conditions (cf. ref. 22). This would 535 seem to indicate that the bond strength of the sugar-phosphate links in the polynucle-536 otide chain is smaller than that of the peptide bonds in proteins." 537

In the same year 1950, Miyaji and Price [34] find confirmation of the vis-539 cosity drop induced by heating. They also study the effect of NaCl addition 540 coming to the following conclusion: "The viscosity of aqueous solutions of sodium 541 thymonucleate is reduced both by heating and by addition of sodium chloride and other 542 salts. If, however, the nucleate solution is heated in the presence of a sufficiently high 543 concentration of salt, there is no further decrease in viscosity beyond that induced by 544 the salt. The protective effect of the salt is reversible, for if the salt is removed by dial-545 ysis from the heated nucleate-salt mixture, the residual aqueous solution of nucleate 546 again suffers a marked reduction in viscosity on heating". They also find the singu-547 lar phenomenon above 85°C that "At temperatures over 85°C, mixtures of nucle-548 ate and salt sometimes yielded a small amount of white precipitate.". 549

Miyaji and Price highlight the importance of discriminating whether the drop in viscosity is due to 1) either fragmentation of the DNA molecule or 2) to coiling of the DNA molecule with reduction of molecular radius yet in absence of fragmentation, or even to a combination of the two phenomena.

2.3.2. Evidence of thixotropy induced by heating

Also in 1950, Zamenhof and Chargaff [36] find that heating a 0.3 per cent 558 solution of DNA at 86°C for 90 minutes makes the specific viscosity, η_{sp} , drop 559 from 30.3 to 3.9. They find that the solution degraded by heating can repoly-560 merize but show that a DNA preparation degraded by heat (similar to the 561 degradation produced by other agents such as acid and alkali) acquires a 562 marked thixotropy (i.e., reduction of viscosity determined by forced flow and 563 viscosity regain as the forced flow is arrested). They also show, conversely, 564 that an intact DNA preparation exhibits no thixotropy since its viscosity re-565 mains unaltered upon subjecting it to forced flow. They observe that this effect 566 of induced thixotropy is irreversible since it cannot be removed by repolymer-567 ization. They conclude that their experiments show that "original preparations" 568 of desoxypentose nucleic acids possess unique physical properties (non-thixotropic 569 viscosity, regular temperature-viscosity relationship) which, once lost, cannot be re-570 gained by repolymerization". They specify that such phenomena of irreversible 571 acquisition of thixotropy "were observed with desoxypentose nucleic acid prepara-572 tions from calf thymus and from yeast, depolymerized not only by acid or alkali but 573 also by heat". Also, with Goldstein and Stern they are among the first who "ex-574 tend the concept of irreversible denaturation from the field of proteins to that of 575

another group of macromolecules, the nucleic acids" and likewise remark the irreversible character of the transformations produced in DNA by heating.

2.3.3. Evidence of vanishing of transforming activity paired by viscosity drop

A biological confirmation of the simultaneous onset, at heating tempera-585 tures higher than T_{td} = 81°C, of irreversible viscosity drop phenomena paired 586 by biological inactivation phenomena is reported by Zamenhof, Alexander 587 and Leidy in 1953 [8]. The Authors extract and purify DNA from a culture of 588 Hemophilus influenzae that has resistance to streptomycin. They add dilu-589 tions of these aqueous solutions of purified DNA from streptomycin-resistant 590 colonies to bacterial suspensions obtained from cultures derived from strains 591 characterized by initial *absence* of resistance to streptomycin, under controlled 592 37°C temperature and time. Subsequently, they add streptomycin (SM) and 593 detect, by observing the quantity of surviving bacteria, the degree of re-594 sistance to streptomycin induced in the non SM-resistant colonies by DNA 595 addition. Thanks to dilutions they can also measure the degree of biological 596 active the extracted DNA solutions. 597

As well known, biology interprets this phenomenon of induced resistance 598 as a parasexual phenomenon, known as Griffith bacterial transformation ac-599 tivity, thanks to which the bacterium that initially does *not* have resistance to 600 streptomycin, upon entering in contact with the purified DNA solution «ac-601 quires» the genetic code contained in the DNA molecules thus receiving the 602 necessary instructions to build the polysaccharide bacterial capsule that gives 603 the increase in resistance to streptomycin, and transmits it to its own lineage. 604 They perform part of their experiments with H. Influenzae after subjecting the 605 DNA extract to heating at a variable T temperature in a pH 7.4 buffer with 606 0.14 M NaC1 and 0.015 M sodium citrate (upon reporting the temperature to 607 23°C before each activity assay). They find that viscosity and the activity are 608 practically unaffected by 1 hour heating to temperatures (T) as high as 76-81°C 609 while, in a temperature range (T) between 81 and 90°C heating, induces a 610 more than significant reduction and, by further increasing (T), they see a drop 611 to practically zero of the phenomenon of bacterial transformation activity. 612

Points on the graph of Fig. 1 by the Authors on page 379 [8], concerning 613 measures of relative bacterial transformative activity (in percentage), have 614 been digitized; the resulting numerical values, converted from logarithmic 615 scale, are reported in Table 1 herein. The values of Table 1 are plotted in Fig. 616 1 reporting, on the x horizontal axis, the heating temperature of DNA in $^{\circ}$ C 617 and, on the ordinates, the percentage of residual bacterial transformation ac-618 tivity employing a linear scale in place of the logarithmic scale of the original 619 figure. 620

The evidence found in [8], clearly represented by Fig. 2 herein, is that, 635 upon subjecting a purified DNA aqueous solution to a preliminary heat-636 ing/cooling cycle bringing it to a variable temperature (*T*) and back again to 637 23°C, the residual bacterial transformation activity is stable when T ranges be-638 tween 25 and 80.9°C. When the heating temperature T reaches 81.4° C, the 639 transforming activity is reduced to 15%, and, by increasing the heating tem-640 perature, the activity continues to decay rapidly to zero, so that 90°C it is ba-641 sically absent. 642

A further fundamental result in [8] concerns stability of DNA viscosity after heating. Upon measuring viscosity in the same pH 7.4 buffer at 23°C, they find that "the viscosity and the activity are practically unaffected by 1 hour heating to temperatures as high as 76-81°C.".

Concerning the possibility that heating or acidity may just induce molec-647 ular contraction and not depolymerization Zamenhof et al. also write: "It has 648 recently been suggested (22, 26, 27) that the decrease in viscosity of DNA solution 649 upon mild H⁺ treatment is due to the change in asymmetry caused by the contracting 650 of the molecule rather than by actual depolymerization. This may also be true for the 651 mild heating. The contraction may be made possible by the breakage of labile bonds 652 (such as hydrogen bonds) under the action of thermal oscillations (40, 41). At higher 653 temperatures, actual depolymerization may occur (32)." 654

2.3.4. Evidence of depolimerization by ultraviolet light measurements

Thomas in his 1954 publication [31] on the study of the ultraviolet absorp-659 tion spectrum of neutral saline NaCl (unbuffered) solution of desoxyribonu-660 cleic acids (DNA) isolated from calf thymus, starfish (Asterias Glacialis) testi-661 cles and red frog (Rana Temporaria) testicle devotes an entire section, titled "Ef-662 fect irreversibles de la temperature sur le spectre U.V", on the effects of heat-663 ing on changes of optical density measures. Besides finding that this measure 664 is strongly sensitive to the NaCl concentration, he plots the graphs of the func-665 tion relating the absorption at 260 m μ versus the preheating temperature and 666 he finds sudden increases of the optical density at temperatures ranging be-667 tween 55°C and 80°C with intermediate plateau regions in which the absorp-668 tion remains constant. For calf thymus DNA he finds a maximum upper limit 669 for stability against depolymerization corresponding to a temperature around 670 80°C, in agreement with Goldstein and Stern (although these authors are not 671 quoted by Thomas). 672

It is worth observing that the detection by Thomas of changes in optical density as function of heating temperature are also in agreement with the explanation by Goldstein and Stern since Thomas employs unbuffered solutions. 676

2.3.5. Detection of depolymerization by staining

Measurements indicating depolymerization of DNA available in 1954 are summarized by Kurnick [39] and recalled in the following list: 682

 reduction in viscosity;
 reduction in rate of sedimentation in the ultracentrifuge;
 increase in ultraviolet absorption (detectable in unbuffered solutions);

- lowering of PH;

formation of acid-soluble and dialyzable products.

Based on his previous study [40] where he could show that methyl green 689 selectively stains only highly polymerized desoxyribonucleic acid, and fails 690

to stain, to any significant extent, depolymerized desoxyribonucleic acid and 691 ribonucleic acid, Kurnick introduces a new methodology for studying depol-692 ymerization induced by heat [39]. From experiments on calf thymus DNA, 693 among which ultracentrifugation patterns of DNA solutions, with and with-694 out 0.02% methyl green, heated to 80° for 7 hours, and to 100° for 1 hour or 2 695 hours as well as on unheated DNA, he finds that "Heat and enzymatic depoly-696 merization of DNA produce certain effects in common: both reduce the viscosity of the 697 solution rapidly [...], increase the ultraviolet absorption [...] and reduce methyl green 698 affinity". He remarks that "These changes are maximal before any dialyzable, acid-699 soluble oligonucleotides are formed [...] and nearly maximal before reduction in sedi-700 mentation rate appears". He adds: "The products of heat and initial enzymatic di-701 gestion (and of sonic depolymerization) are large molecules which, as judged by their 702 sedimentation velocity, are probably still quite asymmetric rods. This hypothesis is in 703 better accord with the unaltered sedimentation rate (despite marked reduction in vis-704 cosity) than the alternative suggestion [citation of Creeth Gulland and Jordan (1947) 705 [41] and of Conway and Butler] that heat has produced collapsed molecules of the 706 original molecular weights. Such collapsed molecules would show a great reduction 707 in viscosity, but would also show considerable change in sedimentability." 708

He conclusively provides an explanation of the heating degradation at 709 100°C in terms of "bombardment by the solvent molecules": "Thus, at 100°C, a mol-710 ecule with very low intrinsic viscosity, but of a considerable size as characterized by 711 its non-dialyzability, sedimentability and affinity for methyl green [...] is stable. This 712 suggests that the increased bombardment by the solvent molecules at elevated temper-713 ature snaps the rigid molecule into still large units, but of such lesser size as to be 714 stable when subjected to the bombardment characteristic of this temperature." 715

From the background above on the studies on thermal depolymerization 718 published between 1950 and 1954, it consistently emerges that heating at tem-719 peratures above 81°, or just above 81°, ordinarily produces depolymerization 720 (or disaggregation) in purified DNA solutions. For completeness, it is worth 721 adding that a residual possibly conceivable alternative justification explaining 722 drop in viscosity could be the hypothesis considered by Creeth Gulland e Jor-723 dan (1947) [41] of a coiling of the DNA molecule capable of "reducing the mo-724 lecular asymmetry but not the molecular weight". It should be pointed out, how-725 ever, that such a coiling hypothesis is drawn in [38] to explain decrease in vis-726 cosity observed after addition of NaCl, occurring without production of titrat-727 able groups and that in [41] no heating experiments are carried out. 728

2.3.6. Estimates of molecular weight from viscosity-sedimentation experiments

An important contribution comprehensively accounting for most of the previously published literature on the effect of DNA heating, confirming Goldstein and Stern's conclusion on DNA fragmentation above 81°, is a physical chemical study by Dekker and Schachman (1954) [42]. This study, while essentially focused on the assessment of different investigated models for the possible macromolecular structure of DNA (among which also models differing from the Watson and Crick double helical chain [43]), is important for the sake of understanding the effect of heating, since it reports a simple quantitative estimate of the molecular weight change before and after heating due to
fragmentation, by a calculation from sedimentation and viscosity data before
and after heating.
743

Dekker and Schachman do not exclude ab initio a possible coiling of the 744 DNA molecule determined by heating and they are the first to point out that 745 paired measurements of viscosity and sedimentation rate of dilute solutions 746 of DNA and heated DNA could differentiate between a disorganization of the 747 DNA molecule without a change in molecular weight (coiling), on one side, 748 and a process in which there is a degradation into much smaller pieces, on the 749 other side. Their key reasoning is that if, upon heating, the DNA molecule is 750 divided into smaller fragments, the viscosity must decrease and the sedimen-751 tation coefficient must decrease as well, while, in case heating should produce 752 just a coiling of the molecule, unlike viscosity the sedimentation must instead 753 increase. 754

Based on their experimental measurements, the Authors make the diri-755 ment observation which compels them to exclude a hypothesis of thermal coil-756 ing as they write: "The reduced viscosity of a 0.005 per cent solution heated at pH 7 757 for 15 minutes at 100°C. decreased from 30 (gm/100 cc)⁻¹ to less than 1.0 (gm/100 cc) 758 ⁻¹. Instead of an increase in the sedimentation rate, which would be expected from the 759 amount of coiling necessary to produce such a large drop in viscosity, we found that 760 measurements at 0.005 per cent DNA showed that the heated material had a sedimen-761 tation coefficient of about 6S, whereas the unheated preparation had a value of nearly 762 20S. These experiments provide proof that the molecular weight of DNA changes from 763 about 5×10^6 to 5×10^4 as a result of this mild heating procedure." In the previous 764 quotation, uppercase S indicates the Svedberg unit which corresponds to 765 $s \times 10^{-13}$ where s stands here for seconds. It is also worth recalling that the 766 reduced viscosity, η_{red} , is related to the viscosity η through the following re-767 lations: $\eta_{red} = \eta_{sp}/c$ where c is the concentration and η_{sp} is the specific vis-768 cosity $\eta_{sp} = \eta_r - 1$, being $\eta_r = \eta/\eta_0$ the relative viscosity defined as the ratio 769 of solution viscosity η to solvent viscosity η_0 . The intrinsic viscosity $[\eta]$ is ob-770 tained by extrapolation of reduced viscosity against concentration at infinite 771 dilution, c = 0, viz.: $[\eta] = \lim_{c \to 0} \eta_{sp}/c$. [5,44]. 772

The proportion behind this simple quantitative estimate by Dekker and 774 Schachman can be presented as follows. Denoting by M the average weight of 775 the DNA molecule, or of its fragment produced upon heating (assuming here 776 introductively and simplistically that all molecules or fragments have the 777 same weight and molecular hydrodynamic radius r_s) the following direct pro-778 portionality holds 779

$$M \propto (r_s \times s \times \eta), \tag{1}$$

where *s* is now the sedimentation constant, η the viscosity and \propto is the symbol 782 of direct proportionality. References for the proportion above, which is 783 obtained combining Svedberg's equation [45] with Stokes-Einstein's equation, 784 can be found in treatises of physical chemistry of macromolecules such as 785 Barrow's treatise (see, e.g. [46], Chapter 20 and, in particular, page 659, Eq. (23)). 786 Fundamental more advanced investigations, contemporary to those years,787based on careful consideration of the hydrodynamic Stokes's law, empyrical788data for long chain polymers, dimensionless analysis and investigation of789universal constant for flexible long chain polymers such as DNA can be found790in (Mandelkern et al., 1952) [47] and related references.791

Dekker and Schachman's estimate stems from the simplistic consideration 792 that the hydrodynamic radius remains unchanged upon heating so that, denoting by subscripts *N* and *H* the quantities relevant to native DNA and to DNA 794 possibly fragmented by heating, respectively, one infers from Eq. (1) setting 795 $r_{s_N} = r_{s_H}$: 796

Shooter, Pain and Butler (1956) [9] also dedicate a study to examining the effect of thermal degradation above 80°C on DNA. Based on their experiments they propose some simple graphical models suggesting the effects of heating on DNA (see the reproduction in current Fig.3).

They conclude their study stating that after 15 minutes heating at 100°C, DNA samples always produces thermal degradation. They remark that the extent of degradation and the distribution of the size and shape of the fragments produced depends on how DNA is prepared.

2.3.7. Evidence of irreversibility of heating degradation from titration analyses

Titration analyses although do not provide direct quantification of molecular weight decrease and direct evidence of possible onset of disruptive longitudinal sequence-breaking random fragmentation of DNA molecules, can detect however some irreversible features occurring during the heating process and the quantity of broken hydrogen bonds and for these reasons part of these works on titration relevant to DNA heating are hereafter reviewed.

The study by Cavalieri and Rosenberg (1957) [48] reports of potentiom-829 etric titration analyses on DNA solutions using calomel and glass electrodes. 830 The study ascertains the conditions under which hydrogen bonds in DNA 831 can be cleaved reversibly by heat, and the conditions under which heat bonds 832 cleave spontaneously and irreversibly. Concerning the temperature at which 833 irreversible phenomena are observed the Authors report: "A temperature is 834 finally reached (about 70° in 0.017 M NaCl, for example) at which denaturation oc-835 curs without titrating any bases, and cannot be prevented by heating in buffers of 836 any pH. In such cases, the original H-bonds of DNA must all be thermally and irre-837 versibly cleaved.". 838

Cox and Peacocke (1956) [49] prior to presenting their results on electro-839 metric titration well summarize the contemporary debate on the stability of 840 the molecular weight to heating: "When sodium deoxyribonucleate is heated in 841 neutral aqueous solution, irreversible changes occur above a critical temperature 842 which varies with the source of the deoxyribonucleate and its method of extraction. 843 These irreversible changes, which often take place over a temperature range of only a 844 few degrees, include: a drop in the viscosity; an increase in the ultraviolet absorption; 845 a displacement of the spectrophotometric titration curves; the appearance of new in-846 frared absorption bands; changes in sedimentation constant; and displacement of the 847 titration curves. Some investigators deduced a decrease in molecular weight from 848 sedimentation and viscosity measurements after the nucleate had been heated in wa-849 ter [(Dekker and Schachman, 1954) [42, (Sadron, 1955) [51], and in salt [(Shooter et 850 al., 1956) [9]], whereas others reported [(Doty and Rice, 1955) [11], (Sadron, 1955) 851 [51] no change in molecular weight after heating in the presence of sufficient sodium 852 chloride." (notice that, in the quotation above, text references originally re-853 ported in superscript format have been converted into the current squared 854 brackets format adding also author and year). They summarize in Fig.2 855 therein that the percentage of ruptured hydrogen bonds in herring-sperm in 856 a (0.15%, 0.05 M -NaCl) solution heated along 1 hour at 95°C is 100%. More-857 over, on the basis these titration experiments the Authors infer evidence for 858 "the random nature of the heat-denaturation process". 859

We incidentally remark that the statement by Cox and Peacocke (1956) 860 [49] according to which (Sadron, 1955) [51] would report no change in molec-861 ular weight after heating in the presence of sufficient sodium chloride, ap-862 pears to be incorrect as the data in this publication by Sadron show in all cases 863 a decrease of the molecular weight after heating except for just one case where 864 it is reported even an increment of molecular weight. This issue is examined 865 in detail in Subsection 2.3.9 dedicated to the light scattering measurements by 866 Sadron on heated DNA. 867

In 1957 Cox and Peacocke [52] specify the limit of titration in detecting 868 changes in molecular weight: *"ionizing radiations invariably and heat, under certain conditions also cause changes in molecular weight but this degradative aspect of their action will not be considered further here, if only for the reason that the titration curves can only just detect a release of one secondary phosphoryl end group in 50 nucleotides."*

Most importantly, Cox, Overend, Peacocke and Wilson in their publication on Nature (1955) [5], reaffirm "*it is only changes in the intrinsic viscosity which are of significance in the estimation of molecular size and shape*" and propose the employment of the following expression, usual for high weight polymers, relating intrinsic viscosity [η] to the is the viscosity-average molecular weight, M_v :

$$[\eta] = K(M_{\nu})^{\alpha}, \tag{3}$$

where K and α are constants for homologous polymers. Based on their ex-881 perimental data the Authors compute $\alpha = 0.93$. Remarkably, agreement with 882 this value is found by the same Doty and coworkers who later compute in 883 1960 [12] from two DNA preparations from Diplococcus Pneumoniae DNA 884 and Escherichia Coli two determinations of α and K whose average value is 885 $\alpha = 0.923$ and K = 3.28. The exponent close to unity signifies that the relation 886 between viscosity-average molecular weight and intrinsic viscosity is almost 887 linear. 888

Use of this formula with the intrinsic viscosity data, measured before and after a heating treatment, allows to compute the drops from the molecular weight of the unheated molecule M_N to the weight of the molecule after heating, M_H , by the following formula: 892

$$\frac{M_H}{M_N} = \left(\frac{[\eta]_H}{[\eta]_N}\right)^{1/0.923} = \left(\frac{[\eta]_H}{[\eta]_N}\right)^{1.083},\tag{4*}$$

On the basis of light scattering experiments and viscosity measurements on B94 DNA degraded by gamma rays, Peacocke and Preston (1958) [50] improve B95 the precision of the determination of coefficients α and K in (3) they find a B96 round value $\alpha = 1.0$ for the exponent and find K = 3.28. They find that the B97 weight-average molecular weight M_w is related to intrinsic viscosity by: B98

$$[\eta] = 4.26 \times (M_w)^{1.00},\tag{5}$$

Most importantly, they find a remarkable consistency of the value M_w 900 obtained from (5) with countercheck values obtained by light scattering 901 measures, so that (5) can be considered a reliable choice for determining molecular weight from intrinsic viscosity, substitutive of light scattering measurements. 903

Employing the data reported by Shooter et al. (1956) [9] concerning measurements before and after 15 minutes heating at 100°C on different samples and also in absence of salt (see Table I therein), the viscosity-based average weight of the heated DNA molecules is computed from (4) to range between 909

2.3.8. Models for random degradation matching experimental data

Kinetic molecular models provide a valuable mean for computing the number of scissions (fragmentations in shorter segments) that the DNA molecule undergoes during a heating experiment and the rate of fragmentations, i.e. the number of fragmentations per unit of time, based on diagrams of molecular weight plotted vs. time.

1.45% and 5.01% of the average weight before heating, what signifies a depol-

Peacocke and Preston (1958) [50], proceeding from viscosity and light 921 scattering experiments on DNA samples degraded after exposure at different 922 doses of gamma rays, find that internucleotide phosphodiester bonds in DNA 923 are ruptured by a random fragmentation process. Fragmentation is the pro-924 cess which divides the molecule into shorter segments of lower molecular 925 weight. They experimentally find for DNA an almost quadratic relation (ex-926 ponent 1.85) between the radiation dose *R* and the intrinsic viscosity $[\eta]$ in-927 stead of the linear relation characteristic of single strand polymers. From such 928 fundamental difference they infer that in DNA (and in any other similar dou-929 ble stranded polymer) the fragmentation of the molecule in a fragmentation 930 process must be generated by a double breakage mechanism. This mechanism 931 consists of the breakage of two intra-chain longitudinal bonds each located at 932 two facing nucleotides situated at the same longitudinal position of the mole-933 cule but belonging to opposite strands. This mechanism is mathematized in 934 the context molecular weight distributions [53]. In this context distinction is 935 made between the *number*-average molecular weight M_n which is the arith-936 metic mean of the weights, and the *weight*-average molecular weight M_w 937 which is the weighted arithmetic mean in which the molecular weights them-938 selves as the averaging weights. For a uniform distribution $M_w = M_n$ while for 939 a random distribution (i.e., a distribution generated from random fracture of 940 an infinite chain) $M_w = 2M_n$. 941

The considerations of Peacocke and Preston are conveniently summarized hereafter in the format of proportionality relations. The *weight*-average molecular weight M_w and *number*-average molecular weight M_n are related to the number of fragmentations F per original number-average molecule: 945

where the 0 subscript indicates the original molecular weight of the molecule 947 before fragmentation starts. We recall that in special cases For a higher number of molecules and fractures ($F \gg 1$) relation above can be represented as 949 the proportionality relation: 950

For degradation by radiation of single strand polymer chains it is ordinarily expected that the probability of single chain break p_s and the radiation dose R are related to fragmentation by: 954

what should imply from (7) that $\frac{1}{M_n} \propto R$. Peacocke and coworkers find instead, 956 experimentally, that after a transitory range of exposition the proportionality 957 holds: $\frac{1}{M_n} \propto R^2$. They explain in terms of probability distributions such evi-958 dence, unusual for single stranded polymers, to be the consequence of a frag-959 mentation process in which a fragmentation is produced when two intra-960 chain scissions at opposite strands in two facing nucleotides occur (or in two 961 proximal nucleotides). The probability of this double-step process is shown to 962 follow the proportionality holds: $p_D \propto p_s^2$, so that, owing to the previous pro-963 portionality relations, one has: 964

Owing to the previous equation and to (7) one finally has for DNA and 966 for any double stranded polymer the theoretical prediction: 967

It is important to highlight the difference between the previous relation 970 (10) and the corresponding relation for single-stranded polymers which reads 971 instead: 972

Peacocke and Preston find that for gamma-rays degradation of DNA relation (10) is closely respected and consider this as evidence that the fragments ensuing from gamma-ray degradations are always double stranded. 977

The Authors also investigate the effect on molecular weight of heat deg-978 radation (100°C along 15 minutes in a 0.1 M NaCl solution) applied to frag-979 ments obtained by previous gamma ray degradation. Their data shows this 980 thermal treatment yields a decrease in molecular weight, but the Authors un-981 derline that quantitative appreciation of the entity of molecular weight de-982 crease and of number of fractures is made difficult by the "the known tendency 983 for the polynucleotide chains to remain entangled, in spite of the removal of hydrogen 984 bonding, and for separated chains to re-aggregate on cooling". 985

A kinetic statistical model for random degradation of a two-stranded polymer model specifically devised by Applequist [10] to analyze DNA degradation provides a more detailed description of the kinetics of double fracture proposed by Peacocke and Preston which accounts for independent probabilities of intrachain fractures (termed P-bonds by the Author and denoted in our synthetic review) and crosslinking hydrogen bonds (H-bonds). 980

Denoting by *p* the fraction of broken P-bonds, by *q* the fraction of broken 992 H-bonds, and by p' the probability that a pair of facing nucleotides is followed 993 by a double chain break, they compute that at the beginning of the degrada-994 tion process when almost all P-bonds are unbroken the relation holds: 995

This relation is a more explicit determination of the proportionality rela-997 tion highlighted by Peacocke and Preston and contained in (9). By further in-998 troducing the simplest assumption that P-bonds are broken by a first-order 999 rate process, viz. $1 - p = (1 - p_0) \cdot e^{-kt}$ corresponding in the early stages of 1000 degradation when $kt \ll 1$ to the linearized law $p = p_0 + (1 - p_0) \cdot kt$, they 1001 find that the linear relation: 1002

$$\left(\frac{M_{w0}}{M_w}\right)^{1/2} = 1 + \frac{1 - p_0}{p_0} kt \tag{13}$$

excellently fits the asymptotic trend in experimental data $M_w(t)$ obtained 1004 from enzymatic degradation [54], acidic degradation [55] and thermal degra-1005 dation (Doty, Marmur, Eigner and Schildkraut, 1960) [12]. The data for ther-1006 mal degradation is reported together with the fit provided by (13) (divided by 1007 $(M_{w0})^{1/2}$) in Figs. 4(a) and 4(b), respectively. 1008

This very close fit constitutes a strong proof that *the DNA remains actually* 1014 two-stranded during the thermal degradation process reported by Doty et al., 1015 (1960) [12]. This observation is pivotal for the focus of our study for three rea-1016 sons: 1017 1018

- 1) Fragmentation rules out also the plausibility of the 100°C stable molecular weight claim. 1019
- 2) Doty et al., (1960) [12], based on the circumstance that one of their 1021 determination of the molecular weight of the DNA heated at 84° is 1022 approximately decreased by a factor of two (from 10.5 million to 5.0 1023 million), advance the claim that "with aggregation eliminated and depol-1024 *ymerization taken into account it can be said that strand separation did occur* 1025 in the very early stages of the exposure to the elevated temperature". Con-1026 versely, the fit in Fig. 4(b) shows the two-stranded character of the 1027 heated DNA and points to the clear evidence that the continuous fall 1028 of molecular weight is the result of progressive fragmentation into 1029 pieces that substantially remain two-stranded, so that the molecular 1030 weight halving recorded by Doty et al. is only fortuitously in agree-1031 ment with the value of $\frac{1}{2}$. In this respect it is worth acknowledging 1032 that also Doty et al. [12] in the statement above mention the necessity 1033 to account for "depolymerization", thus duly excluding the possibility 1034 that halving of molecular might correspond to separation of intact sin-1035 gle strands:. 1036
- 3) The elucidation of the substantial two-stranded character of the material produced by heating, besides confuting the *100°C dissociation claim* as advanced by Doty et al. in the same paper [12], rules out any meaningfulness of heating denaturation for the purpose of strand separation.

A second important highlight in the contribution by Applequist is the role of the initial induction relatable to the presence of an initially uniform distribution of molecular weights and the determination based on the data by Shumaker et al. of the presence of initially broken P-bonds corresponding to $p_0 = 1.57 \times 10^{-2}$. This numerical determination will be recalled in the discussion of Section 4.2.

An examination of the type of intra-strand bond breakage is reported in Section 4 based on a closer review of the insightful analysis by Dekker and Schachmann (1954).

2.3.9. Evidence from light scattering of DNA fragmentation upon heating

This subsection reviews determinations of DNA degration by heating via light-scattering experiments reported in publications other than those by Doty and Rice of 1955 and 1957, which are instead more closely reviewed in the dedicated Section 3.

Peacocke and Preston (1958) [50] also perform light scattering measure-1060 ments on DNA degraded by combined exposure to gamma rays and heating 1061 at 100°C for 15 minutes. They confirm observation of a decrease in molecular 1062 weight but highlight that the observation of the effect of heating degradation 1063 in larger DNA molecules is less pronounced and emphasize that the interpre-1064 tation of the entity of this decrease is affected by "the known tendency for the 1065 polynucleotide chains to remains entangled, in spite of the removal of hydrogen bond-1066 ing, and for separated chains to re-aggregate on cooling". 1067

Sadron performed measurements of molecular weights by light scatter-1069 ing after heating alone (in absence of gamma-rays exposure) and reported his 1070 findings in several publications between 1955 and 1959 [51], [60], [61]. In the 1071 1955 biochemistry congress proceedings (see addendum on page 134) he re-1072 ports the effect of heating at 100°C along 15 minutes on two DNA prepara-1073 tions of initial molecular weight $M_0 = 6.0 \times 10^6$. The weights he determines 1074 by light scattering on heated DNA at different NaCl concentrations show that 1075 DNA weight is always reduced as a confirmation that DNA is the more de-1076 graded the less is the NaCl content. 1077

In particular, the table in his 1955 addendum on page 134 in [51] reports that 1078 just 15 minutes heating in absence of salt bring the molecular weight from 1079 6×10^6 to 0.28×10^6 and 0.35×10^6 . In just one experiment with 1M NaCl 1080 he finds, in one of the two preparations, a weight increment to an average 1081 value $M = 7.0 \times 10^6$. Later, Freund, Pouyet and Sadron (1958) [61] report 1082 tests of calf thymus DNA (CV71) in 1M NaCl solutions and obtain by light 1083 scattering for the unheated preparation molecular weight $M_0 = 7.4 \times 10^6$. 1084 They measure by light scattering the molecular weight *M* in a 0.01 M NaCl 1085 solution after thermal degradation produced by heating at temperatures of 1086 75°, 80°, 85° and 98°C during a variable time θ . They find that by heating at 1087 temperatures of 80°, 85° and 98°C the ratio $R = M/M_0$ as function of θ first 1088 increases, reaches a maximum and then drops to a residual value R =1089 0.047 corresponding to $M = M_2 = 350000$. The point data in the original fig-1090 ure have been digitized and those corresponding to temperatures of 85°C and 1091 98°C are reported in Fig.5. The only correction applied to the digitized num-1092 ber was that minutes that were rounded to closest simple fractions of the hour 1093 of multiples of 5 minutes and to ordinates reached at the horizontal asymp-1094 tote which were rounded to the value 0.047 explicitly reported by Freund et 1095 al. 1096

The Authors find that the higher is the heating temperature the higher is 1097 the maximum, as shown in Fig. 5. This figure shows that heating at 98° brings 1098 this maximum above 1.4 and then makes *R* suddenly drop at approximately 1099 10 minutes to a value below 0.35. It is also seen that at 15 minutes the interpolation reaches 10% of the native weight. This measure brings further quantitative straightforward evidence of the sudden fragmentation that the DNA 1102 molecule undergoes when heated at temperatures above 90° C. 1103

2.3.10. DNA Heating experiments in presence of different electrolytes

Hamaguchi and Geiduschek (1962) [56] perform a broad analysis of ther-1113 mal stability of DNA in aqueous solution in presence of many different elec-1114 trolytes and under many different pH conditions and temperature ranges. 1115 They confirm that thermal stability of DNA has a relatively broad maximum 1116 at pH 7-8 in 0.1 M NaCl and that in any concentration of any of the many 1117 electrolytes therein investigated the upper bounds of the temperature thresh-1118 old of thermal stability can be never above 92.6°C (see Table I and Fig. 4 1119 therein), irrespective of the electrolytes content and type. 1120

3. Review of the experiments on DNA heating by Doty and Rice (1955, 1957)

The arguments relevant to the effects of DNA heating, and their interpre-1125 tation, contained in the 1955 short communication by Doty and Rice "The de-1126 naturation of desoxypentose nucleic acid" [11] deserve the utmost attention 1127 since, to the authors' knowledge, this paper is chronologically the first record 1128 where it can be read of the 100°C stable molecular weight claim for DNA. This is 1129 in neat disagreement with the big picture consistently emerging from the 1130 studies analyzed in Sections 2.2, about DNA undergoing thermal depolymer-1131 ization when the threshold of 81°C is surpassed, or even at lower tempera-1132 tures in less stable conditions. In [11] it is reported indeed that, after heating a 1133 neutral saline solution to 100°C for 15 minutes the product is found "to have 1134 the same molecular weight as the native DNA". 1135

This third section enucleates the experimental evidence reported in [11] 1136 relevant to the effect of DNA heating and contains an analysis of the interpretation given by Doty and Rice to such experimental evidence aimed at understanding if, and how, new diriment measurements are reported by Doty and Rice in this 1955 study able to reverse the previous overall experimental-1140

Concerning quantities in Table 2 and their units it is worth recalling what 1179 follows. 1180

Quantity $[\eta]$ in Table 2 is the intrinsic viscosity: the specific increase in 1181 relative viscosity, $\Delta \eta / \eta_0$, determined by adding a quantity of DNA associated 1182 with a concentration increment $\Delta \rho$ to the solvent (of viscosity η_0), divided by 1183 $\Delta \rho$. Accordingly, $[\eta] = \frac{\Delta \eta}{\eta_0 \cdot \Delta \rho}$ and, as $\Delta \rho$ is in grams per deciliter, $[\eta]$ is in reciprocal units of deciliters/gram. The solvent of Doty and Rice is a saline-citrate 1185 solvent (0.015 M sodium citrate and 0.15 M NaCl). 1181

The sedimentation constant s_{20}^0 is a rate of sedimentation measured by 1187 the ultracentrifuge experiment methodology developed by Svedberg [57]. In-1188 dicating by r the radial coordinate in the axial symmetric setup of the ultra-1189 centrifuge, the centripetal acceleration *a* is a radial field varying as $a = r\omega^2$, 1190 where ω is the angular velocity. The rate $\frac{dr}{dt}$ is measured by an optical system. 1191 through so called schlieren photography which essentially returns diagrams of 1192 changes in refractive index that typically have a «striped» pattern ("schlie-1193 ren" = strip from German) and that inform about the change in concentration 1194 as function of time and radial coordinate r. If the centrifugal field is strong 1195 enough to cause the molecules or particles to sediment with measurable ve-1196 locity, $v = \frac{dr}{dt}$ the sedimentation constant is then $s = \frac{1}{r\omega^2} \frac{dr}{dt}$ 1197

The principle of measurement in centrifuge is that the rate of sedimenta-1198 tion increases with the mass of the particle and with the intensity of accelera-1199 tion. Tracing a parallel with a falling object of mass *M* immersed in atmos-1200 phere and in a uniform gravitational field, it is known that due to the presence 1201 of air friction, the object deviates from the Galilean prediction of uniformly 1202 accelerated motion with gravitational acceleration g and reaches after a tran-1203 sitory time a steady velocity. The frictional force F_f , directed upwards, in a 1204 simplest description, is proportional to the velocity v of the falling object so 1205 that $F_f = b \cdot v$. As theoretically predicted by the force balance (gravitational 1206 force = frictional force; $F_a = F_f$; $M \cdot a = b \cdot v$) and empirically confirmed, the fi-1207 nal velocity reached by the object increases with the object mass M and with 1208 acceleration *a* which for the gravitational field is uniform in space and equal 1209 to the terrestrial gravitational acceleration constant g: a = g. The mass is ac-1210 cordingly computed as $M = \frac{b \cdot v}{a}$ or $M \propto \frac{v}{a}$. As recalled, the main difference 1211 between the acceleration field of the centrifuge set-up and the gravitational 1212 field is that rotation implies a circular relative motion field with acceleration 1213 increasing with the radius by $a = r\omega^2$ so that acceleration is no longer uni-1214 form as in the example of the falling object. The DNA molecules, heavier than 1215 the solvent, by inertia, will *appear* in the non-inertial rotor reference frame to 1216 be subject to a radial motion component directed towards the periphery of 1217 the centrifuge. This motion component may be causally interpreted as the 1218 consequence of not being sufficiently «pushed» in centripetal direction by the 1219 pressure gradient field that is generated in the solvent in response to the cen-1220 tripetal acceleration generated by the rotor. Through a special focus lenses 1221 measurements of the concentration along the radial direction are obtained 1222 from measurements of light absorption changes and/or refraction changes. 1223 Records are taken of the «strips» produced by the different optical properties 1224 of this moving «solute clouds». From these striped diagrams it is possible to 1225

measure concentration changes along the radius and, in turn, evaluate the 1226 speed dr/dt. The higher the $\frac{dr}{dt}$ rate of sedimentation of this «dust», at the 1227 same acceleration $a = r\omega^2$ (and therefore at the same angular velocity of ro-1228 tation ω and radial distance r in the blender), the greater is the mass M of the 1229 DNA molecule or molecule fragment by the proportion $M \propto \frac{dr/dt}{a}$. The final 1230 raw quantitative measurement obtained from this experiment is the sedimen-1231 tation constant $s = \frac{1}{r\omega^2} \frac{dr}{dt}$ whereby the direct proportionality holds $M \propto s$. 1232 Experiments are performed to extrapolate the limit s^0 of s at zero concentra-1233 tion (zero superscript), so that direct interaction between molecules can be 1234 excluded. If account is also taken of temperature which can change the sol-1235 vent viscosity and a reference temperature of 20°C is employed, the symbol 1236 s_{20}^0 is used to refer to such quantity. Ultracentrifuge sedimentation analysis 1237 of DNA containing a detailed report of observed sedimentation boundaries 1238 are presented by Cecil and Ogston (1948) [57,58]. Also, to the authors' 1239 knowledge, the first reported molecular weight measurements for DNA, 1240 based on the application of combined viscosity-sedimentation methods, are 1241 by Krejci, Sweeny and Hambleton (1949) [59]. 1242

Concerning the ultracentrifuge sedimentation experiments, Rice and Doty [23] report two important information:

- When DNA solutions are exposed to 100°C for 15 minutes the hypersharp sedimentation profile is lost and *"two differently sedimenting species in solutions"* appear.
- Such a polydisperse character of the heated solution, in the same words 1249 as Rice and Doty, "posed a difficult problem" and induced the Authors to 1250 erroneously attribute a sedimentation constant of 30 S. In fact they also 1251 report, "Dr. K. V. Shooter and Professor J. A. V. Butler have examined our 1252 sample SB-11 by ultraviolet optics in the ultracentrifuge and found that the dis-1253 tribution of sedimentation coefficients broadened but remained single-peaked at 1254 21 S. when heated at 100°C for 15 min. at a concentration of 10 mg./dl." (see 1255 Shooter et al. [9]). 1256

The scientific debate between Doty and Rice and Shooter et al. deserves 1259 attention. Measurements by Shooter et al. [9] are conveniently reported in Ta-1260 ble 3 since the Authors re-execute both sedimentation and viscosity measure-1261 ments for sample SB-11 (in the acknowledgement the donation by Prof. Paul 1262 Doty is mentioned) investigating the effect of 15 mins heating at 100°C and 1263 achieve increased accuracy for sedimentation measurements. Increased accu-1264 racy is achieved since the Authors employ a preferable lower 0.01% concen-1265 tration instead of 0.035% of the samples examined in [23], and operate optical 1266 measurements in the ultra-violet range where they had shown that heteroge-1267 neity with respect to sedimentation coefficient is more easily observed [62]). 1268 By comparing Tables 2 and 3 it is seen that reduced intrinsic viscosity values 1269 are the same in [23] and [62] while a value of 20.0 S is more accurately meas-1270 ured for the sedimentation constant after heating thus identifying and 1271

correcting the experimental error recognized by Doty and Rice and recalled 1272 above. 1273

Shooter et al. [9] finalize their study on the effect of DNA heating and 1279 their countercheck of Doty and Rice measurements by concluding that "The 1280 results given suggest that in all cases the samples of DNA are degraded on heating 1281 but that the extent of the degradation and the distribution of size and shape of the 1282 fragments produced depends upon the way in which the DNA has been prepared". It 1283 is important to remark that this conclusion is achieved in [9] upon testing 1284 sedimentation constants and viscosities of four DNA preparations (TNA 7, 1285 TNA 15, TNA 23 and SB-11) under multiple concentrations, in presence and 1286 in absence of the protective effect of NaCl. The Authors emphasize that sed-1287 imentation constant decreases in all samples except for samples TNA16 and 1288 SB-11 for which it remains unchanged. They remark that *despite the unchanged* 1289 sedimentation constant the apparent molecular weight is reduced in all cases. They 1290 have the merit of highlighting the possible fallacies in deducing the molecular 1291 weight from combined sedimentation and viscosity measurements. Fallacies 1292 may arise from reaggregation of the fragments when heating is performed at 1293 higher concentrations. Indeed, in one case they find that heating the TNA23 1294 solution at 0.05% concentration at 100°C for 15 minutes makes the sedimen-1295 tation constant increase from 27 to 36 Svedberg units. This measurement 1296 shows that particles appear to have possibly even increased their mass, an 1297 effect that may be explained only by reaggregation. They also observe for all 1298 DNA preparations that the "spread of sedimentation coefficients is changed, there 1299 being an increase of material with both high and low sedimentation coefficients". 1300 Such result is readily interpreted as evidence of the production by 15 minutes 1301 heating of both fragments of lower molecular weight as well as of aggrega-1302 tions of fragments of higher molecular weight. 1303

Shooter et al. highlight that preparations TNA 23 and SB-11 are obtained, in particular, by detergent methods (it is worth recalling that SB-11, donated by 1305

Doty, has been prepared employing sodium p-xylene sulfonate) pointing to the1306risk that higher sedimentation constants may be preparation artefacts due to1307the use of detergent methods while lower sedimentation constants might be1308artefacts due to purification procedures employing enzyme methods which1309have a depolymerizing effect.1310

Next, in their 1957 publication [23] containing the reply to Shooter et al. 1311 countercheck, Rice and Doty do not make considerations on the evidence that 1312 fragments reaggregation readily explains the increase in sedimentation con-1313 stant from 21 S to 30 S of Table 2 that they had published in their 1955 pre-1314 liminary note. On the other hand, Shooter et al. had shown that heating at 1315 0.05% concentration, a value close to the 0.035% concentration employed by 1316 Rice and Doty, makes the sedimentation constant of TNA 23 increase from 27 1317 S to 36 S. 1318

Doty and Rice reference the empirically well-established relation of 1321 Krigbaum, Flory, Mandelkern and Sheraga [11] which is the following: 1322

In Equation (14) K is a universal constant which has the same value irre-1325 spective of molecular weight, temperature and solvent and depends only on 1326 the flexibility of the molecular chain. Its value ranges between $K_{flex} = 2.5$. 1327 10⁶ for a flexible coiled molecule and $K_{stiff} = 3.6 \cdot 10^6$ for ellipsoids of in-1328 creasing axial ratio, η_0 is the solvent viscosity, *N* is Avogadro's number, ρ is 1329 the density of the solution and \bar{v} is the partial specific volume. All quantities 1330 on the right hand side of Eq. (14) are constants, or can be treated as such, in 1331 the experiments under examination. 1332

Equation (14) permits a more accurate determination of molecular mass. 1334 It can be applied to examine Doty and Rice data of Table 2 and to investigate 1335 the scientific substantiation of their key argument: i.e., to investigate whether 1336 changes induced by 15 mins heating at 100° can be explained exclusively by 1337 calling into question a possible coiling or change in the molecule flexibility, 1338 excluding any molecular weight change, or if compelling evidence exists of 1339 molecular fragmentation from data of Tables 2 and 3. 1340

Subscripts N and H are used below in a way similar to Eq. (2) of Sect. 2.3.6 1341 above to indicate values relevant to native and heated DNA. Assuming, first, 1342 that *K* is not influenced by heating, so that it takes the same value *K* for the 1343 heated and unheated material, one infers from Eq. (14): 1344

Hence from Doty e Rice 1955 data we compute under this assumption of 1347 unchanged flexibility: 1348

which states that after heating the molecules are more than 2 times smaller,1351on average. It is understood, however, that Shooter et al. have elucidated that1352the sedimentation 30 S appears to be an erroneous measurement artefact.1353Moreover, by taking into account the correction of the erroneous measure-1354ment evidenced by Shooter et al., one further computes:1355

so that after heating the molecules are about 4 times smaller, on average. 1358 If one wishes to defend further the claim of Doty and Rice, appealing to the 1359 residual argument that the increase in sedimentation constant might only be 1360 due to coiling of the molecule (putting apart the already reasonably clear evidence of fragments reaggregation) one can employ $K_{stiff} = 3.6 \cdot 10^6$ for the 1362 native material and $K_{flex} = 2.5 \cdot 10^6$ for the heated material. One can thus 1363 write: 1364

It is hence seen that, even appealing to such a coiling hypothesis, 1372 fragmentation remains a compelling evidence matching with the "*two* 1373 *sedimenting species*" recorderd by Rice and Doty. 1374

3.2. DNA Molecular weight from light scattering

Section 3.1 has shown the absence of any evidence from combined sedimen-1382 tation and viscosity measurements supporting the possibility that native 1383 DNA molecules can avoid fragmentation and remain thermally stable above 1384 85° with the specific buffer solutions subject to testing and have also shown 1385 the existence of consistent and redundant evidence of such fragmentation 1386 above 85°. The present section shows that the same conclusion is arrived at 1387 even when results coming from light scattering measurements are carefully 1388 examined. 1389

Light scattering deserves attention for several reasons:

- it is the third and last measurement technique reported in [23] on the 1391 basis of which it is claimed therein that no fragmentation occurs 1392 above 85° in the DNA molecules (if not, admittedly, only after a heat-1393 ing period of 15 minutes and more) since it is claimed, from light scat-1394 tering results therein reported, that no significant change in molecu-1395 lar weight occurs on thermal denaturation; 1396
- among the methods available for the determination of the size and 1397 shape of macromolecules, light-scattering in 1954 was considered the 1398 method giving more nearly correct values for the molecular weight 1399 and the radius of gyration by several researchers [63-65] actively 1400 working on DNA molecular characterization, such as Reichmann, 1401 Doty and coworkers [63] and Alexander and Stacey [64] and by 1402 Sadron and coworkers; 1403
- it is the tool which brought to the remarkable result that DNA puri-1404 fied from different biological sources such as calf thymus, herring 1405 sperm, bacteria and bacteriophage [63-65] has always the same mo-1406 lecular weight of about 6 \times 10⁶ when the extraction and purification 1407 methods are the same. 1408

It is thus understood that if light scattering is properly employed for deter-1410 mining the molecular weights of native DNA and of molecules after poten-1411 tially fragmenting treatments, such as heating, acid treatment or depolymer-1412 izing enzymes, it can be a mean for quantitative verification of different hy-1413 potheses on possible depolymerization or coiling of the molecule. 1414 Clearly, we anticipate that as we have already remarked in the previous sec-1415 tions of this survey, in examining the effect of these treatments it is funda-1416 mental to properly discern four possible situations: 1417

- s1) the possibility that the molecules remain with unchanged weight 1419 and unchanged size;
- s2) the case of a reduction in size of the molecule due to a *real fragmen*-1421 *tation* into parts of lower molecular weight; 1422
- s3) the case of *a merely ostensible reduction in size* which is due instead 1423 to just a coiling of the molecule with unchanged molecular weight; 1424
- s4) the case specular to case 2) and elucidated by Shooter and 1425 coworkers [9] in which, a depolymerizing action (such as heating 1426 or acid treatment), yields, in presence of a not sufficiently low 1427

concentration of DNA, a reaggregation of fragments producing aggregates showing an ostensible measurable effect which may be misinterpreted as the indication of the production of a material having higher molecular weight (this is the case, we recall, of the increase of the sedimentation coefficient for preparation TNA 23 at 0.005 % concentration rising from 27 Svedberg units (before heating) to 36 Svedberg units [9]).

3.2.1. Brief notes on the fundamentals of light scattering

Before examining Rice and Doty's light scattering results, a brief introduction of the measurement principle and measurement technique of the light scattering method and of the related turbidimetry method.

Fundamental advancements to optical methods of turbidity and lightscattering have been contributed by Debye [70-72] and by Zimm [75-76]. In brief, the essential physical principle of these optical techniques applied to molecules in solution, clearly described by Debye in 1944 [70], is based on the following relation expressing the turbidity τ of diluted solutions as function of the refractive index of the solvent, μ_0 , of the refractive index μ of the solution, of the wave-length λ , and of the number n of molecules per cm^3 : 1443

If μ_0 for the solvent is known, *n* can thus be measured, in the first instance, on the basis of two experiments, a first one giving μ and a second one giving τ . Once *n* is determined, the mass of the particle *u* and its molecular weight *c* follow from the concentration *c* as u = c/n and M = cN/n, being as usual *N* Avogadro's number. For practical purposes the quantity $K = \tau/(Mc)$ 1456 is introduced by Debye. This quantity, on account of (22) and of relation nM = cN, achieves the expression: 1458

K is thus for turbidity, in a first approximation, a refraction constant which, once determined, permits to compute *M* as $M = \tau/Kc$ or, equivalently: 1462

However, Debye discusses in 1947 [72] that, for solutions of high-polymer substances, such as the case of DNA, even at high dilutions *K* cannot be treated as a constant with respect to concentration *c* but is found to be a function K(c) of the concentration *c*, and the same occurs for turbidity τ which is similarly a function $\tau(c)$ of concentration. He advises to employ the linear interpolation:

in which *B* is a constant depending on the solvent so that in the limit of zero 1473 concentration, $c \rightarrow 0$, Eq. (24) is recovered and *M* is computed. This corresponds to the following two-dimensional plot extrapolation: 1474

- the refraction term *K* and the dilution τ are determined for different concentrations $c_1, c_2, c_3, ...$ obtaining several determinations 1478 $K(c_1), K(c_2), K(c_3), ...$ and $\tau(c_1), \tau(c_2), \tau(c_3), ...;$ 1479
- from these determinations the left-hand side of (25) as function of the independent variable c, $L(c) = K(c) \cdot c/\tau(c)$, is interpolated (in [71] he employs in particular the method of least squares); 1482
- function L(c) is extrapolated to zero concentration obtaining the 1483 limit lim_{c→0} L(c) = lim_{c→0} K(c)·c/τ(c); this limit is equal to the limit of the 1484 right-hand side lim_{c→0} (1/M + 2B · c) = 1/M;
 eventually this mothed is defined.
- eventually, this method graphically provides the molecular term weight *M* as the intercept at c = 0 of curve L(c). the second s

The method described so far for determining M only involves measure-1489 ment of the turbidity τ and not of light scattered at different angles. For larger 1490 thread-like polymerized molecules, such as DNA, a more refined measure-1491 ment technique which is based on the additional information obtainable from 1492 measurement of the angular distribution of the scattered light is further de-1493 vised by Debye [72]. Debye derives a fundamental analytical relation for the 1494 intensity *I* of scattered light as function of the angle θ between the primary 1495 beam and the scattered beam. The function $I(\theta, c)$, accounting for such de-1496 pendency upon θ and upon the concentration *c* of solute in each experiment, 1497 is theoretically elaborated by Debye through an averaging procedure ac-1498 counting for all conceivable particle configurations (since the particles are sta-1499 tistically free to rotate and fluctuate in the optical model). The expression of 1500 $I(\theta, c)$ resulting from this theoretical elaboration depends on the employed 1501 model for the particle. Debye presents specific analytical expressions for par-1502 ticles modeled as having spherical or ellipsoidal shape and, additionally, con-1503 siders a third model (a so-called random coil model, essentially devised for 1504 schematizing the optical behavior of polymers) in which thread polymers are 1505 schematized as a flexible number of links, each one able to rotate freely. De-1506 bye finds that, for this set of molecular models (random coils, spherical 1507 shapes or ellipsoidal shapes) the relevant function $I(\theta, c)$ turns out to be to be 1508 conveniently expressed in a relatively simpler analytical closed form of the 1509 following type: $I(\sin^2(\theta/2), c)$, i.e., by an analytical expression in which 1510 $\sin^2(\theta/2)$ is the first independent variable. A convenient alternate series ex-1511 pansion expression of function $I(\theta, c)$, applicable to a variety of molecular 1512 shapes and typologies and under some respects analogous to (12), is contex-1513 tually elaborated by Debye one year later. A more explicit expansion of this 1514 form is also presented by Zimm [75] (see Eq. (26) therein). Zimm's series ex-1515 pansion yields a determination of the molecular weight M from light 1516

In the previous relation $I(\theta, c)$ is the intensity of the excess scattering (over that of the solvent alone) at a given concentration, $P(\theta)$ is a probability function such that P(0) = 1, A_2 is a constant independent from θ and c, and $f(\theta)$ 1523 is a term independent from c. Owing to these properties, it is seen that extrapolation of the left hand term in (19) at zero concentration and zero angle 1525 θ gives again the reciprocal of the molecular weight: 1526

Debye also shows [72] that the slope of the plots (as function of *c*) in proximity of c = 0 defined by coefficient $2A_2$ in (26) defines the square of the average size of the particle in terms of distance from its center of gravity (also termed radius of gyration by some authors [64],[69]). For clarity in the employed terminology, it is recalled that the function $\frac{K \cdot c}{I(\theta,c)}$ is also called in [64] and [69] reciprocal reduced intensity and the Zimm plots are also denominated *reciprocal reduced intensity plots*.

The accuracy of the extrapolation procedure stated by (27) is understood 1537 to be critical for the accuracy of the determination of the molecular weight. 1538 The extrapolation is operatively carried out by graphical construction of a 1539 grid-like plot (denominated Zimm plot) in the plane having the quantity 1540 $\sin^2(\theta/2)$ on the horizontal axis and the quantity $K \cdot c/I(\theta, c)$ on the vertical 1541 axis. 1542

For the problem of interest, which is the determination of the weight of 1544 the DNA molecule by light scattering, the construction of a Zimm plot has 1545 been well exemplified and explained by Alexander and Stacey (1955) [64] 1546 who, aside to Doty and coworkers, have been among the first researchers per-1547 forming such a measure. Fig.6 is a handmade copy of the plot performed by 1548 Alexander and Stacey [64] for determining the molecular weight of herring 1549 sperm DNA at PH 6.8. On the horizontal axis of the graph in Fig. 6 it can be 1550 read $\sin^2(\theta/2) + 2000 \cdot c$ since the addition of the term $2000 \cdot c$ is simply a 1551 mean for graphically shifting in the horizontal direction the curves, function 1552 of $\sin^2(\theta/2)$, obtained at each constant value for *c*. The intercept at *c* = 0 is 1553 seen to be $\frac{1}{M} = 1.7 \cdot 10^{-7}$ and from this value the result $M = 5.9 \cdot 10^{6}$ is com-1554 puted by these Authors. Observe that the slope of the horizontal segments of 1555 the plot represent the sensitivity of this method to the solute concentration 1556 and that the property of these segments of being almost horizontal in the vi-1557 cinity of the intercept with the vertical axis ensures the independence of eval-1558 uation of the molecular weight from the concentration employed in the ex-1559periments. 1560

We briefly recall now the light scattering results that Doty and coworkers 1568 publish in the years 1953-1957. With these data Doty supports two claims: 1569

- the claim of unchanged DNA molecular weight upon acidification to pH 2.6 (Reichmann, Bunce and Doty, 1953) [28];
- the claim of unchanged DNA molecular weight after 15 minutes 1572 heating at 100°C (Rice and Doty, 1957) [23].

3.2.2. A fundamental digression on the detection of DNA acidic degradation by light scattering with a confutation

Although the central object of discussion of this subsection are possible 1578 evidences from the light scattering measurements by Doty and Rice of the 1579 molecular weight stability of DNA to *heating*, a brief digression on the close 1580 examination of the light scattering data relevant to the assessment of stability 1581 upon pH 2.6 acidification of DNA, presented by Reichmann, Bunce and Doty 1582 in (1953) [27] is carried out hereafter to duly highlight possible sources of fal-1583 lacious, or diverging, interpretation of data from light scattering. Such a di-1584 gression is revealed to be important by the existence of an ongoing debate in 1585 the thread of publications [27], [64], [23] concerning the question of whether 1586 the molecular weight of DNA changes or not after acidification at pH 2.6 in 1587 aqueous solution with 0.2 M NaCl. Such debate is very instructive for dis-1588 cerning in heating degradation the situations s1), s2), s3) and s4) enumerated 1589 at the beginning of Section 3.2. 1590

The apparatus employed by Reichmann et al., (1953) [28] for light-scat-1592 tering experiments is not described in detail, as the reader is referred to (Doty 1593 and Bunce, 1952) [69] where it is specified that measurements were made by 1594 a Brice-Speiser photometer. 1595

Reichmann et al. (1953) [28] perform two sets of light scattering experi-1596 ments for determining the molecular weight of calf thymus DNA in 0.2 M 1597 NaCl, at pH 6.5 and at pH 2.6 obtaining the two Zimm plots in Fig. 7, repro-1598 ducing Fig. 1 by Reichmann et alii. These Authors interpret these plots as the 1599 evidence of unchanged molecular weight, ostensibly given by the common 1600 intercept attained by these grids in the limit of zero angle and zero concen-1601 tration. 1602

Reichmann et al. pair this possible evidence of stable molecular weight 1609 with the interpretation that the fall in viscosity would be the result of a con-1610 traction of the coiled molecule as the solution is acidified. They do not con-1611 sider any possibility of the effect of disaggregation and reaggregation evi-1612 denced by Shooter, Pain and Butler (1956) [9]. However, this conclusion of 1613 stable molecular under pH 2.6 weight has been challenged by contrary evi-1614 dence shown by Alexander and Stacey [64] who employed the same method 1615 of light scattering to analyze the behavior of this molecule in a broader set of 1616 similar experiments. The light-scattering analyses of DNA by these Authors 1617 are characterized by a specific view towards possible evidence of depolymer-1618 ization and towards the delicate discernment of antagonist effects due to frag-1619 mentation and to fragments reaggregation highlighted in Section 3.1. In this 1620 study the Authors examine DNA depolymerization due to acid treatment un-1621 der conditions similar to those of Reichmann et al. (1953) [44] while encom-1622 passing a countercheck of particle weight and particle size at different pH 1623

values and even in presence of renetraulization. Their results relevant to the analysis of possible depolymerization due to acidification down below pH 2.6 are recalled hereafter. 1626

The apparatus for the light scattering experiments by Alexander and 1627 Stacey experiments is described in [67] and is similar in design to the one used 1628 by Carr and Zimm [68]. Also, the experimental conditions examined by these 1629 Authors and by Reichmann et al. are readily comparable (solutions of 0.10 to 0.2 M NaCl). 1630

In examining and confronting the experimental results, it is convenient 1632 to introductively recall that evidence of acid depolymerization below pH 5 in 1633 terms of viscosity reduction and decreased sedimentation has been already 1634 highlighted by Cecil and Ogston [58] who had reported that at pH 3.5 "Treat-1635 ment with acid leads to the formation of two fractions, one of which is relatively ho-1636 mogeneous and resembles the original material except that it is altered by reprecipi-1637 tation. The formation of the heterogeneous component is probably the result of dis-1638 aggregation. The changes brought about at pH 3.5 proceed to a limit, and no further 1639 important change follows subsequent neutralisation. Reprecipitation of the neutral-1640 ised solution causes a further large change, the homogeneous component disappearing 1641 and a gel-forming material appearing in its place : this change is likely to be due to a 1642 *re-aggregation.*". Evidence in terms of viscosity reduction and of decreased 1643 transformation activity in bacteria similarly pointing towards depolymeriza-1644 tion has been also reported by Zamenhof et al. [8] (with a different buffer) 1645 and is synthesized in the following Fig. 8 taken from such reference. 1646

The data showing the effect of molecular weight decrease, as determined 1652 by the Zimm plot, and showing a spurious molecular weight increase due to 1653 fragments reaggregation are shown in Table 4 and Fig. 9, (data and image 1654 taken from [64]).

In the original source, only the curve corresponding to the extrapola-1671tion to $c \rightarrow 0$ are plotted and not the entire Zimm grids. pH labels and arrows1672on the right side are the only elaboration added to the figure obtained as the1673hand reproduction of the original figure.1674

We recall that, as the intercept gives 1/M, when the intercepts of the 1675 curves in Fig. 9 are lifted up after a treatment, the molecular weight of the 1676 particle (or of the aggregate of particles) decreases. The opposite is true when 1677 the intercept decreases: the weight of the particle increases (as observed by 1678 the Authors this phenomenon can result from aggregation revealed by the 1679 observed precipitation). The curves are best examined following the sequence 1680 of incremental acidification (a) \rightarrow (b) \rightarrow (c) \rightarrow (e) and next considering the 1681 re-neutralization $(e) \rightarrow (d)$ from pH 2.6 to pH 7.0. What is seen is that in step 1682 (a) \rightarrow (b) *M* remains the same. Next in step (b) \rightarrow (c), from pH 4.0 to pH 3.0, 1683 the lowering of the intercept corresponds to an increase of M from $5.9 \cdot 10^6$ to 1684 6.6. 10⁶. This increase can be interpreted as a first sign of fragmentation and 1685 reaggregation. Such a picture is confirmed in step $(c) \rightarrow (e)$ where pH is low-1686 ered from pH 3.0 to pH 2.6 and M rises from 6.6 · 10⁶ to 15.9 · 10⁶ showing a 1687 clear sign of reaggregation. The evidence that aggregation is reduced comes 1688 from step $(e) \rightarrow (d)$ from pH 2.6 to pH 7.0 when *M* is lowered back again to 1689 5.9, possibly giving the fallacious feeling of the molecule being undegraded 1690 since 5.9 is the same molecular weight of the best-preserved DNA samples. 1691 Any misinterpretation is ruled out by examining data in the last row of Table 1692 4 showing that reneutralization to pH 7.0 from pH 2.2 yields a molecular 1693 weight 2.45. 1694

Concerning the completeness of the dataset of measurements behind 1695 Fig.5, it is important to remark that the authors report to have performed the 1696 extrapolation by ordinarily testing the solution at different concentration (as 1697 required by the proper execution of the grid-plot methodology devised by 1698 Debie and Zimm) although only the curves corresponding to the extrapola-1699 tion to $c \rightarrow 0$ are plotted by Alexander and Stacey in their figures and not the 1700 entire Zimm grids (this for avoiding data superposition and for permitting 1701 clear readability to the reader). 1702

Altogether the data by in Table 4 and Fig. 9 by Alexander and Stacey [64]1704disproof the claim by Reichmann, Bunce and Doty (1953) [28] that the DNA1705molecule recovers its original size and shape upon the pH being returned to1706pH 6.5 from pH 2.6 and the fallacious explanation that the large decreases in1707viscosity observed by several researchers upon adding acid to DNA solutions1708are due primarily to the contraction of the DNA molecules, the contribution1709of degradation being only secondary.1710

Referring to media more acid than pH 3.0 the Authors explicitly report 1711 the following evidence: "In more media there was a rapid aggregation until precipitation occurred. At pH 2.6 apparently stable aggregates with molecular weights 1713 of about 15×10^6 were produced (Fig. 3). This material is polydisperse and no significance can be attached to this numerical value since the weight-average molecular weight varies somewhat with slight changes of experimental conditions in this pH range." [64].

| Once the elements of knowledge in the bullet list above are acquired, the examination of the light scattering data by Rice and Doty (1957) [23] on DNA subjected to heating at 94° and 100° can be carried out in an unbiased way able to separate the <i>"wheat from the chaff"</i> , i.e., of separating a fallacious evidence of increased or stable molecular weight in front of an incomplete set of measurements. The study by Rice and Doty proceeds from the premise referred to the1759publication by by Reichmann, Bunce and Doty (1953) [27] that: "When dis-1760solved in 0.2 M NaC1, DNA can be exposed to PH values as low as 2.6 for several1761

hours without significant chemical degradation". Such a premise has been just 1762 shown in Subsection 3.2.2 to be disproved by Alexander and Stacey [64] 1763 showing that what had been dected at pH 2.6 are joint phenomena of frag-1764 mentation and reaggregation, in confirmation of Cecil and Ogston's [58] early 1765 findings and of the multiplicity of evidences so far collected in Sect. 2.2 and 1766 2.3.1. 1767

The data that Rice and Doty claim would show that heating at 100°C during 15 minutes would leave the molecular weight unchanged are contained in Figs. 5 therein. Such figure has been digitized and reproduced in current 1771 Fig. 10(b). 1772

Concerning the completeness of the dataset of measurements behind 1779 Fig.10, it is important to remark the following key circumstance. The Authors 1780 report that "the molecular weight can be obtained from measurements at a single 1781 concentration" and employ the value of 0.06 mg/cc, so that they do report of 1782 not having performed measurements at different solute concentrations and 1783 report of not having performed an ordinary extrapolation procedure with re-1784 spect to concentration to obtain these curves. This choice appears to be non-1785

compliant with the standard Zimm-plot methodology (devised by Zimm and 1786 Debie and described in Section PIPPO) ordinarily applied, for instance, by 1787 Alexander and Stacey [64] with the graphical construction of Fig. 6 and ordi-1788 narily applied to obtain Figure 9. The non-compliant methodology deployed 1789 by Rice and Doty to obtain the plots and the molecular weight determination 1790 in Fig. 10 can be promptly criticized based on the following consideration. 1791 From Fig. 7 herein, which reproduces the complete Zimm plot extrapolation 1792 concerning a previous similar light scattering experiment by the same group 1793 of Doty over a similar DNA sample tested at pH 2.6 (Reichmann, Bunce and 1794 Doty, 1953) [27] (Fig. 1 therein), it is seen that the employment of one concen-1795 tration, in place of the ordinary construction of the complete Zimm grids, is 1796 prone to considerable error. Actually, owing to the apparent variability of the 1797 curves upon concentration (see the subvertical curves therein intercepting the 1798 filled dots) by passing, for instance, from 0.005 to 0.05 mg./cc, the use of the 1799 single arbitrarily selected value of 0.06 mg/cc, indicated by the Authors, is 1800 prone to arbitrarily affect the particular point where the curve at the selected 1801 concentration intercepts the vertical axis. This approach is clearly prone to 1802 yielding a considerably large experimental error or even room for arbitrari-1803 ness in selecting the concentration. Stated differently, if the curve reported by 1804 the Authors were to be determined at a different concentration – say of 0.005 1805 mg/cc - it cannot be excluded that the intercept on the vertical axis and the 1806 corresponding determination for the molecular weight would have been con-1807 siderably different. The criticality just highlighted deprives this measure of 1808 intersubjectivity and points to the necessity of rejecting this measure as a sci-1809 entific evidence supporting the 100°C stable molecular weight claim. 1810

It is worth to point out that, after having recalled and remarked in Section 1812 3.1 the absence of scientific probative value of the arguments by Rice and 1813 Doty from sedimentation-viscosity measures in support of their 100°C stable 1814 molecular weight claim, the light scattering data reproduced in the plots of Figs 1815 10(a) and 10(b) remained the last possible surviving evidence from those con-1816 tributed by Rice and Doty (1957) [23] in support of such claim. It is also worth 1817 recalling that, as reviewed in Section 2.3.9, all light scattering experiments on 1818 DNA heated at elevated temperatures, from all retrievable scientific publica-1819 tions of the decade 1950-1960 on such argument, show consistent and coher-1820 ent evidence disproving the 100°C stable molecular weight claim. Also, to the 1821 authors' knowledge, there exist no other element of evidence from light scat-1822 tering published in the literature of the decade 1950-1960 in possible support 1823 of the 100°C stable molecular weight claim. 1824

In the light of the considerations above and of the scientific background 1825 elucidated in Section 2.3, the confutation provided in the present subsection 1826 of a measurement of stable molecular weight from the light-scattering data of 1827 Doty and Rice brings to an end the review of the papers by Doty possibly 1828 supporting such claim and brings to zero the number of unconfuted elements 1829 of evidence in possible support of the $100^{\circ}C$ stable molecular weight claim. 1830

4. Discussion

4.1. A summary of evidence of DNA thermal disruption

Upon having disproved in Section 3 both claims by Doty and Rice of "high 1838 temperature C heating + fast cooling dissociation" and "100°C stable molecular 1839 *weight"*, we can summarize into the following statement the coherent picture 1840 emerging from the scope of the literature on thermal degradation of DNA 1841 (published between 1950 and 1960 comprehensively reviewed in Sections 2 1842 and 3). Independent research, conducted by independent researchers using 1843 independent experimental methods, consistently and redundantly confirm 1844 Goldstein and Stern's first observation, both qualitatively and quantitatively: 1845 if an aqueous solution of intact DNA molecules is heated between 81°C and 1846 100°C, even for few minutes, extensive sequence-breaking irreversible longi-1847 tudinal fragmentation is produced and may be followed by reaggregation 1848 upon cooling. This evidence will be briefly referred to as DNA thermal disrup-1849 tion evidence. 1850

As reviewed, the most compelling qualitative and directly perceivable 1851 empirical evidence of polidispersity and degradation is detected by Goldstein 1852 and Stern by direct visual observation of the native fibrous material turning 1853 into a flocculent precipitate when DNA is heated almost to the boiling point 1854 and then permitted to cool to room temperature. Similarly, Zamenhof and 1855 Chargaff describe that heating at 86° for 90 minutes yields a material which is 1856 thixotropic whereas unheated DNA solutions are not and that heated DNA 1857 upon cooling does not return to preheating condition and becomes a gel-like 1858 material. 1859

Precise indication of degradation after heating times closer to those pro-1861 vided for by PCR (ranging between 1 and 5 minutes per cycle) is reported in 1862 both works by Dekker and Schachman and by Shooter, Pain and Butler: al-1863 ready after 15 minutes heating, irreversible drop of viscosity to a value close 1864 to that of the solvent alone occur associated with other evident phenomena 1865 such as spread of the sedimentation profiles with appearance of distinguisha-1866 ble species in solution and clear evidence of degradation and reaggregation of 1867 fragments. 1868

These perceptive and qualitative evidence of thermal disruption were quantitatively shown in Section 3.1 of this review to be an undeniable fact even for the most stable preparations obtained by detergent methods, such as SB-11 tested by Doty, Rice, Shooter, Pain and Butler, and even appealing to a possible ancillary influence of coiling contributing to the decrease in viscosity. 1873

A specific quantitative determination of the number of fragmentations 1875 undergone by DNA after one or few minutes heating can be obtained from 1876 the relative viscosity vs. time data and experimental conditions (in a barbital 1877 buffer) reported by Goldstein and Stern in Fig. 11 which is a handmade reproduction of the original 1950-dated Figure 12. 1879 Readily employable tools for approximately evaluating the average molecular weight of the fragments (customarily employed by Cox, Overend, Peacocke and Wilson in 1955 as well as by Doty, Marmur, Eigner and Schildkraut in 1960) are the almost linear relation with the intrinsic viscosity [η]: $M \propto$ 1883 [η]^{1.083} or the fully linear relation obtained by Peacocke and Preston (1958) [50] and reported in Equation (5). 1885

From data on relative viscosity in Fig 11 (a,b) the intrinsic viscosity can be computed. In particular, Cox et al. [5] find, for a given DNA preparation from experiments at different concentrations, a linear relation between reduced viscosity and concentration (in g./ml.) representable in the following form: 1897

in which the experimentally determined value k' = 0.77 consistently matches 1899 with the value proper to extended chain molecules obtained by Simha [66]. 1900

Relation (28) can be employed to compute the intrinsic viscosity from the relative viscosity. Actually, from (28) and recalling the relations among 1902

The plots intrinsic viscosity vs. time resulting from elaboration of data in 1912 Fig. 11(b) via function (31) and corresponding to c = 0.001 and k' = 0.77 are 1913 reported in Figure 11(c). 1914

The intrinsic viscosity of the unheated solution is $[\eta]_N = 12.31$ and the 1916 intrinsic viscosity of the solution after 1 minute heating at 100°C is 1917 $[\eta]_{100^\circ,1min} = 2.16$. These values can be used to compute from the most accu-1918 rate viscosity-mass relation (5) of Section 2.3.7, obtained by Peacocke and Pres-1919 ton (1958) [50], the (weight-average) molecular weight drop based on viscosity 1920 measurements: 1921

The experiments by Goldstein and Stern thus permit to compute that one 1923 minute heating at 100°C determines the division of the initial molecule into 1924 segments whose average length can be closely rounded to the simple integer 1925 fraction of one-sixth and Equation (6) of Section 2.3.8 permits to compute the 1926 corresponding average number of sequence-breaking fragmentations 1927

This number of fragmentations per one minute corresponds to $5 \times 15 =$ 1930 75 fragmentations during a heating time of 15 minutes by assuming the num-1931 ber of fragmentations per minute to be a constant (in reality, this assumption 1932 yields an optimistic lower bound of fragmentations since the reviewed statis-1933 tical models by Peacocke and Preston and by Applequist show that the num-1934 ber of full fragmentations is a quadratic function of time). It can be readily 1935 controlled that such a number of 75 fragmentations well fits with the determi-1936 nations obtained for the longer time of 15 minutes heating by Shooter, Pain 1937 and Butler and by Dekker and Schachman, as well as by Sadron (all results 1938 reviewed in the previous sections). The results of these authors show the 1939

production of fragments whose average weight ranges between 5% and 1% of 1940 the molecular weight of molecule before heating (corresponding to 20 and 100 1941 average number of fragmentations). 1942

It is worth recalling that cooling after fragmentation is also a remarkable 1944 disordering factor since many works herein reviewed, describe, upon DNA 1945 cooling, evidence of fragment reaggregation and of formation of a gel-like dispersion (see in particular the works by Shooter and coworkers) or even the 1947 formation of aggregates of molecular weight even higher than the original 1948 one. 1949

4.2. What really happens during DNA thermal fragmentation?

Before attempting an answer, in the light of the bulk of the available data 1954 herein reviewed on the physical and chemical behavior of DNA subject to 1955 heating, to the opening question of this review (i.e. "To what extent the integrity 1956 of the sequential information of nucleotides is affected when the DNA solutions in the 1957 buffer conditions provided for by PCR is accordingly subjected to heating and cooling 1958 cycles of 95°C or 100°C as described by Mullis and Faloona?") it is convenient to 1959 gain few closer insights on the longitudinal sequence-breaking mechanism of 1960 DNA during thermal fragmentation. These insights will permit, based on sim-1961 ple arithmetical considerations, a computation of lower bounds of the number 1962 of fragments produced under PCR heating conditions in a sequence of nucle-1963 otides assumed initially intact. 1964

Before attempting any calculation, it is however necessary to understand 1965 if the sequence-breaking longitudinal rupture by heating alone involves either 1966 phosphodiester covalent bond breakages or the opening of labile hydrogen 1967 bonds, or even if both the circumstances have to be contemplated. By paraphrasing the title of a 1968 review by Chargaff titled "What Really Is DNA?" 1969 [78], the further question can be hence formulated "What really happens during DNA thermal fragmentation?". 1971

Perhaps the simplest and most effective explanation of thermal disruption of DNA in aqueous solution was early well depicted by the words of Kurnick as the disruptive effect of the *"bombardment by the solvent molecules"*.

A remarkable work which specifically and comprehensively examined 1976 this issue early in 1954 is the proceeding of the National Academy of Sciences 1977 of the United States of America authored by Dekker and Schachman [42]. 1978 These Authors, upon collecting a considerable body of evidence from light-1979 scattering, ultracentrifugation, diffusion, viscosity, streaming birefringence, 1980 electron microscopy, titration, and other end-group studies such as dye bind-1981 ing, show sufficient evidence to cast doubt on the adequacy of a model made 1982 up of only two contiguous uninterrupted polynucleotide strands. Proceeding 1983 from the postulate that phosphodiester bonds cannot be thermally disrupted below 1984 100°C by heating alone, Dekker and Schachman show that, if compliance with 1985 all data from experimental evidence on DNA degradation by several agents is 1986 sought, it is mandatory to consider a modification of the Watson and Crick 1987 model of the DNA macromolecular structure to explain its division in shorter 1988

segments and, specifically, it is necessary to introduce an hypothesis on the pres-1989 ence of some sparse weaker and thermally labile longitudinal bonds, perhaps of hy-1990 drogen type, so as to consider that the true length of uninterrupted phos-1991 phodiester chains contained in an individual strand does not coincide with 1992 the full length of the strand. Specifically, they investigate the presence of: "ei-1993 ther secondary forces, like hydrogen bonds, holding smaller molecular entities into 1994 some well-korganized structure, or easily hydrolyzed covalent bonds, such as deoxy-1995 ribosyl-1-phosphates, spaced at roughly periodic intervals along the main chains". 1996 They show that a model more compatible with all data therein reviewed on 1997 DNA degradation is the interrupted two-strand aggregate sketched in Fig.12 1998 (b) corresponding to the Watson & Crick's double helical structure but com-1999 posed of much smaller molecules held together in a specific configuration by 2000 hydrogen bonds between the purine and pyrimidine rings. 2001

Proceeding from the consideration that it is highly improbable that a 15 2009 minutes heating at 100°C of DNA solution is capable of breaking phos-2010 phodiester bonds, Dekker and Schachman show that all evidence therein re-2011 viewed concur to bring to the conclusions that the observed features of ther-2012 mal degradation can only be the result of the sole rupture of hydrogen bonds 2013 and that DNA is an aggregate of fragments of smaller molecular weight. They 2014 find corroboration of this model assumption from titration studies which can 2015 detect terminal phosphoryl groups giving good evidence for the existence of 2016 at least one terminal phosphate group for every 30 to 50 nucleotides [73]. On 2017 the same trend, other studies reviewed by Dekker and Schachman, based on 2018 rosaniline binding [74], lead to estimating one terminal phosphoryl group for 2019 every 300 to 100 phosphorous atoms. Further studies therein reviewed on the 2020

action of magnesium ions on DNA bring to an analogous computation of one 2021 terminal group every 20 to 30 phosphorus atoms. 2022

Interestingly enough, a further corroboration of this range of values can 2023 be now a-posteriori recognized from the statistical analysis of enzymatic deg-2024 radation performed by Applequist in 1961 [10], seven years after the publica-2025 tion by Dekker and Schachman. Applequist computes the fraction p_0 of 2026 "seemingly already broken" bonds on account of his double-strand random 2027 degradation model (reviewed in Section 2.3.8) from the analysis of the kinetics 2028 of enzymatic degradation from data later published in 1956 by Schumaker, 2029 Richards and Schachman [54] to be $p_0 = 1.57 \times 10^{-2}$. This value corresponds 2030 to approximately 1 interrupted P-bond every 64 nucleotides and hence to 1 2031 terminal group every 32 nucleotides thus fitting well the range of data re-2032 ported above. It is worth noticing, however, that in [10] Dekker and 2033 Schachman [42] are not quoted. 2034

If the macromolecular interrupted-chains model by Dekker and 2035 Schachman was correct, it would readily explain the observations early reported by Goldstein e Stern of fragmentation after just one-minute heating, 2037 albeit such rupture would be allowed not by thermal ruptures in the sugarphosphate links of the polynucleotide chain, yet by hydrogen bonds or by 2039 some other thermally labile and electrophoretically labile bonds 2040

In conclusion, to find a quantitative scientific answer (or at least a conservative estimate) on what is the effect in terms of molecular information integrity of the bombardment of the solvent molecule on the DNA molecule based on all empirical data collected in this study and proceeding from the undeniable evidence that the molecule is considerably segmented at high temperature even after just one minute, two hypotheses and two ensuing models must be comprehensive contemplated: 2042

- (USH) standard Uninterrupted Strands Hypothesis: the molecule is made of two uninterrupted strands and the longitudinal sugar-phosphate bonds (P-bonds) can be ruptured at high temperatures;
- (ISH) Interrupted Strands Hypothesis by Dekker and Schachman: 2054 the P-bond cannot be ruptured even at high temperatures so that 2055 the segmentation is produced by initially weaker, or completely 2056 absent, longitudinal links which are found one every *j* nucleotides 2057 with *j* ranging between 40 to 600 and with 64 being a qualified 2058 number compatible with all estimation and range inferences from 2059 independent titration analyses, dye binding analyses, magnesium 2060 binding analyses and enzymatic degradation analyses. 2061

To appreciate the repercussions of the previously computed probability 2063 datum of average 5 fragmentations per 1 min 100°C heating cycles (shortest 2064 heating time in PCR repeated a minimum of 10 times) on the integrity of a 2065 given sequence of nucleobases, it is convenient to identify a sample test molecule model of given molecular weight. To this end it is convenient to consider 2067 the same reference molecule of DNA considered by Dekker and Schachman 2068 of weight 5×10^6 which is the best molecular value reported in their study 2069 and obtained from applications of the "mild" method by Signer and Schwan-2070 der's for extracting calf thymus DNA. Recalling that the average molecular 2071 weight of the four nucleobases is equal to (G + A + C + T)/4 = (151 + 135 + 135)2072 $111 + 126)/4 \approx 130$ and that deoxyribose and phosphate group weights are, 2073 respectively and approximately, 134 and 95, a weight of 720 per pair of nucle-2074 otides is obtained which corresponds to approximately 7000 pairs. 2075

In the USH hypothesis a molecule of weight 5×10^6 is thus composed of 2077 two strands of 7000 nucleotides each. In the ISH hypothesis, the evidence col-2078 lected by Dekker and Schachman and the number of nucleotides above esti-2079 mated on the basis of the number of detected end-groups lead these Authors 2080 to estimate between 300 to 500 terminal groups in a molecule of weight 2081 5×10^6 , corresponding to a value ranging from 150 to 250 uninterrupted sub-2082 chains (altogether in both strands) and, approximately, to an equal number of 2083 gaps/interruptions ranging from 150 to 250.

Since in the ISH model the most experimentally qualified number of nucleotides per sub-chain on the basis on the evidences reviewed herein and by Dekker and Schachman is 64, a most qualified single strand model, taking in-2095 teger numbers, can be selected as being composed of 110 sub-chains $(110 \times 64 = 7040 \text{ nucleotides})$. We consider here, however, the example most favorable for the sake of molecular integrity corresponding to the lowest number of 75 'thermally unbreakable' sub-chains made of 93 nucleotides each. This 2099 model is denominated interrupted-strand model ISH-93.

Evidence shows that a cycle of heating followed by rapid cooling entails 2102 molecular fragmentation followed by possible reaggregation of fragments. A 2103 quantitative optimistic lower-bound estimate of the increment of the degree 2104 of disorder produced by such a *fragmentation* + *reaggregation cycle* can be ob-2105 tained by a 1-dimensional sequential model in which the only information 2106 maintained is the sequence of nucleotides in the individual strands at the be-2107 ginning and at the end of the heating/cooling cycle. Accordingly, any other 2108 degree of freedom of the molecule fragments (included rotation and transla-2109 tion) is excluded as well as the possibility of the formation, upon reaggrega-2110 tion, of a more topologically complex 3-dimensionally disordered arrange-2111 ment, typical of colloidal aggregates, not describable by a sequential scheme. 2112 In such a simplest model, the datum of a lower bound of 5 complete double 2113 scissions with molecular segmentations per one minute heating at 100°C (ex-2114 perimentally confirmed from Goldsten and Stern's data), is taken as the basis 2115 for computation. In the abstraction considered, the sequence of nucleotides in 2116 an individual strand undergoes a shuffling rearrangement process character-2117 ized by 5 sequence openings. 2118

For the USH model this shuffling process consists of the following two 2119 steps: 2120

- Step 1.A scission step represented as the random division of the initial2121ordered sequence of 7000 nucleotides into five sub-sequences each2122preserving the order of the contained nucleotide sub-sequences.2123This step can be also thought of as the cutting of a deck of 70002124cards into 5 subdecks.2125
- Step 2. A permutation step in which the sequence of 5 sub-sequences resulting from Step 1 is subjected to a permutation which reassembles a new full sequence in which the order of each nested subsequence is left unchanged. Following the card deck analogy, this
 step corresponds to a permutation of the 5 subdecks obtained from cutting in Step 1 of the initial deck, and to stacking the permuted subdecks to obtain a new deck of cards.

For the *ISH-93 model*, the shuffling model is the same above, although uninterrupted phosphodiester sub-chains now replace the role of the individual cards of the USH shuffling model. Accordingly, shuffling consequent to 5 fragmentations consists of the following steps: 2137

- Step 1. A scission step represented as the random division of the initial ordered sequence of 75 atomic (not divisible) sub-chains into five sub-sequences of sub-chains each preserving unaltered the order of the sub-chains; this step can be illustratively depicted as the or-dered division of a deck of 75 cards into 5 subdecks.
- Step 2. A permutation step in which the sequence of subsequences is re- 2143 ordered leaving the order of each nested subsequence unchanged. 2144

The two models above provide an 'optimistic' quantitative estimate of the 2146 probability, for *model USH*, that a given sequence (or subsequence) of nucleo-2147 tides of a certain length can preserve its integrity after a shuffling process or, 2148 analogously for the *ISH-93 model*, the probability that a given sequence (or 2149

subsequence) of sub-chains of nucleotides can preserve its integrity after a 2150 shuffling process representative of heating degradation. 2152

These shuffling models provide a – very simplistic, yet very optimistic – 2153 quantitative answer to the question of what 'really' happens, for the sake of 2154 the integrity of molecular information, during DNA thermal fragmentation. 2155

Considerations and computations on the basis of the specific number and 2156 duration of PCR heating cycles are carried out in Section 4.3. 2157

4.3. Implications of DNA thermal disruption evidence on PCR fidelity

Considerations on PCR buffers

Even if one resorts to appealing to a possibly salvific protective action of 2165 the electrolytes in the PCR buffer reported by Mullis and Faloona, the data 2166 reported by Hamaguchi and Geiduschek (1962) [56] indicate that conditions 2167 provided for in the PCR buffer are prone to thermal instability at the PCR 2168 temperatures (of 95°C and 100°C) and that are less stable to thermal disrup-2169 tion than those of most of the DNA solutions employed in the many works 2170 herein reviewed. Actually, data reported by Hamaguchi and Geiduschek 2171 (1962) show that at any concentration of any of the many electrolytes therein 2172 investigated, upper bounds of thermal instability onset temperatures (defined 2173 as midpoints of thermal denaturation curves) cannot be, in any case, above 2174 92.6°C so that a protective action of some electrolyte cannot be argued at 95°C 2175and 100°C. To make matters worse, these data also show that thermal stability 2176 in sodium acetate (which is the prevalent solute in the PCR buffers) is even 2177 lower than in sodium chloride (see Table I therein) as the midpoint tempera-2178 ture of irreversible thermal denaturation curves viscometrically determined 2179 by these authors (which turns out to be always an upper bound of the temper-2180 ature of thermal depolymerization onset) is lowered from 90.0°C to 83.5°C. 2181

Most remarkably, the absence of NaCl in the PCR buffers deprives these 2182 solutions of the protective effect of salt against thermal degradation which 2183 the reviewed literature has shown to be fundamental. 2184

Considerations on the known degrading effect of depurination by heating 2185 are not carried out but could be also taken into account. The addition of dithi-2186 othreitol (DTT, the threo isomer of 2,3-dihydroxy-1,4-dithiolbutane), which is 2187 a strong reducing agent, provided for in two of PCR buffers (methods I and 2188 II) can be considered anything but a stabilizing component considering the 2189 capability of thiols of generating mercaptylated derivatives of DNA, as shown 2190 for instance by Tamm & Chargaff (1953) [77] employing phenylmethanethiol 2191 (benzyl mercaptan). The effect of addition of DTT is also not contemplated in 2192 the subsequent analyses. 2193

Optimistic computations of number of DNA fragmentations consequent to PCR 2195 heating 2196

2197

PCR heating temperatures are of 95°C and 100°C. The number of heating 2198 cycles in PCR multiplied by the duration of each heating process ranges approximately from an *overall* time of exposure to heating of $10 \times 1 = 10$ 2200 minutes (in methods I and II prescribing addition of dithiothreitol) to overall 2201 heating times higher than 40 minutes minutes (in methods III, IV, V and VI 2202 and in absence of DTT) and as high as $27 \times 2 = 54$ minutes in particular in 2203 method V. 2204

The most promptly employable information for estimating the entity of 2205 fragmentation of PCR short heating cycles, among those herein reviewed, is 2206 represented by the 5 sequence-breaking fragmentations computed in Section 2207 4.1 from Goldstein and Stern's data on the viscosity drop consequent to one 2208 minute heating at 100°C followed by cooling. We recall from the reviewed 2209 literature that the *optimistical significance* of this estimate from viscosity data 2210 in representing a reliable *lower bound* to the weight-average number of frag-2211 mentations and number-average number of fragmentations experimented by 2212 the distribution of DNA molecules during 1 minute heating at 100° is sup-2213 ported, among many others, by the following elements: 2214

- *"the random nature of the heat-denaturation process"*. Cox and Peacocke (1956) [49]; 2216
- the knowledge that "it is only changes in the intrinsic viscosity which 2217 are of significance in the estimation of molecular size and shape" reaffirmed, for instance, on Nature by Cox, Overend, Peacocke and 2219 Wilson [5]; 2220
- the partial fragments reaggregation on cooling which determines 2221

 a regain in viscosity (in part of thixotropic nature) so that what is 2222
 actually determined by measuring a lower bound of the viscosity 2223
 drop upon cooling of the heated solution is just a lower bound of 2224
 the number of fragmentations really experimented by the mole-cule; 2226
- the evidence, shown by Peacocke and Preston (1958) and ny Applequist (1961), that single-strand fragmentation is a first-order 2228 rate process and that the number of single-strand sequencebreaking ruptures by heating is linear with time all through the 2230 heating degradation. 2231
- the evidence, shown by the same Authors, that the number of single strand sequence-breaking ruptures by heating is much higher
 than the number of complete fragmentations of the molecule (requiring each a double longitudinal rupture), since it is a quadratic
 function of time.

Lower bound estimate of the probability of survival of a sequence of nucleotides 2238 after repeated heating/cooling 1 minute, 100°C cycles 2239

Based on the two models described in Section 4.2, *USH* and *ISH-93*, and on the conservative assumption that one heating/cooling 1 minute, 100°C produces 5 fragmentations, a highly optimistic computation of the probability of survival (integrity preservation of molecular information) of a selected sequence of nucleotides contained in the main single-strand sequence after repeated cycles is carried out. As discussed above such a computation provides 2240

2237

a lower bound of the degree of disordering and rupture experimented by a 2247 nucleotide sequence during such a cycle. We recall that: 2248

- the USH model consists of the abstraction of uninterrupted strands 057000 nucleotides assumed having thermally labile longitudinal 2250 bonds; 2251
- the *ISH-93* model is an abstraction in which each strand is made of 75 2252 sub-chains whose internal intranucleotide bonds are not thermally labile.
 2254

2255

To perform a computation, the length of the sequence intended for PCR2256"amplification" must be introduced. Mullis and Faloona write: "The sequence2257to be synthesized can be present initially as a discrete molecule or it can be part of a2258larger molecule."2259

As far as the integrity of the full sequence is concerned, the computation 2260 is the same for the USH model and for the ISH-93 model. Five random thermal 2261 longitudinal fragmentations occurring in one minute heating correspond to 2262 randomly dividing the main sequence into 5 subsequences each preserving its 2263 internal order of nucleotides. In the optimistic abstraction herein followed of 2264 cooling always being able to restore a sequential reaggregation of fragments, 2265 cooling corresponds to randomly reassembling these five ordered subse-2266 quences into one out of (5 + 1)! = 720 new possible main sequences each ob-2267 tainable as a random permutation, so that the probability of reobtaining the 2268 original full sequence is 1/720. Already after only 3 cycles this probability be-2269 comes very low dropping to $\frac{1}{(6!)^3} = 1/(2.6874 \times 10^{11})$. After the total number 2270 of 10 cycles provided for by PCR, corresponding to $n_{Tfrag} = 10 \times 5 = 50$ 2271 overall fragmentations, the optimistic estimate of the probability of preserving 2272 the integrity of the molecule is 3.1097×10^{-32} . 2273

The integrity of smaller contained sequences after 10 heating cycles is 2274 now examined. This issue is important, for instance, when the possible em-2275 ployment of PCR is intended by its users for searching for information possi-2276 bly relatable to gene expression of a protein. The length of the subsequence is 2277 indicated by n_{sub} . A documented representative value of n_{sub} can be set to 2278 $n_{sub} = 1000$ adopting, for instance, an optimistic lower bound of the typical 2279 lengths retrievable in public databases for the so-called spike protein (US Na-2280 tional Center for Biotechnology Information, GenBank: QGV12784.1, $n_{sub} =$ 2281 1386 [80]; European Bioinformatics Institute (EMBL-EBI), Universal Protein 2282 Resource UniProtKB - P59594 (SPIKE_SARS), *n*_{sub} = 1255 [81]). 2283

For the USH model, denoting by $n_T = 7000$ the total number of nucleotides, by $n_{sub} = 1000$ the number of consecutive nucleotides of a subsequence, and by $n_{Tfrag} = 10 \times 5 = 50$ the total number of fragmentations after 10 cycles, the number of combinations by which the main sequence can be fragmented in 50 subsequences is computed as:

where n! indicates the factorial of number n. The number of combinations by 2292 which the main sequence can be fragmented in 50 subsequences preserving 2293 the integrity of the main sequence is 2294

The same computation can be carried out with the *ISH-93* model in the 2305 same way by just converting in number of sub-chains elements (we recall, 2306 each sub-chain being composed of 93 nucleotides, see Table 5) the lengths of 2307 7000 and 1000 in sub-tokens of 93 while the number of total fragmentations 2308 remains $n_{Tfrag} = 10 \times 5 = 50$. Accordingly, one computes: 2309

so that computations elucidate that the 'ISH-93 model' at hand, although composed of longer sub-chains (hypothesized thermally unbreakable), turns out to be, as a matter of fact, less thermally stable, as far as the integrity of a sequence of 1000 nucleobases is concerned. 2318 2319 2320 2321

The above computations well exemplify and illustrate the remarkable 2322 proneness of PCR to entropy-related error determined by the presence of heat-2323 ing steps in such procedure, even more so if it is considered that all simplify-2324 ing hypothesis introduced to arrive at such computations do have a lower-2325 bound optimistic character, i.e., they all contribute to the benefit of reducing 2326 the computed probability of disruption produced by the PCR heating cycles. 2327 The considerations above raise a serious concern towards longitudinal se-2328 quence-breaking degradation, even more so when the action of the random-2329 izing effect of fragments reaggregation upon cooling is contemplated in addi-2330 tion to the randomization effect produced by thermal degradation at the end 2331 of each PCR heating cycle (ranging between 1 and 5 minutes). A critical factor 2332 related to this statement is the length of the sequence to be amplified and 2333 whether this sequence is larger than the sub-chain elements with uninter-2334 rupted phosphodiester bonds identified by Dekker and Schachman. If the se-2335 quence to be amplified or to be detected is larger than the average length of 2336 the Dekker & Schachman sub-chains (93 in our simplified computations), as it 2337 is the case of a sequence of more than 100 nucleobases such as the length 2338

reported by NIH under the denomination spike protein, the probability of preserving integrity is thus computed to be very low.

In this regard, it is worth recalling that the abstraction of the physical phenomena of heating and cooling leading the computational models adopted for the calculations above have speculatively excluded the possibility of translation and rotation of the molecular fragments and the possibility of formation, upon reaggregation, of a more topologically complex-and more disordered nonsequential arrangement, like, for instance, a net.

Perhaps fewer words and fewer computations are necessary to represent 2347 to the reader the degree of disorder which can be achieved after just one heating-cooling cycle at 60°C , by showing here in Fig. 13 the electron micrograph 2349 taken by Williams (1952) [79] of a sprayed 0.01% water solution of DNA prepared by the method by Schwander and Signer subjected to a process consisting of 1) freezing at -78°C, 2) 60°C heating for drying, 3) rapid cooling. 2352

It may be argued that Figure 13 may not be representative of the degree 2363 of disorder induced by PCR cycles because the DNA freeze-drying process, 2364 with 60°C heating, leading to the micrograph of Figure 13 may have induced 2365 disordering factors that cannot be comparable with the effect in PCR of 2366

multiple 95°C and 100°C heating steps followed by quick cooling. It is undeniable that, while the milder 60°C heating must have induced a significantly lower degradation, concentration and drying have a significant role in determining the picture of densely agglomerated fibers in Figure 13. 2369

On the other hand, micrographs of the molecules in the material pro-2371 duced after DNA heating at 100°C have been taken by Doty, Marmur, Eigner 2372 and Schildkraut (1960) [12]. Figure 3 in [12] shows the electron micrograph 2373 with a magnification factor (\times 95,000) of DNA molecules from a solution 2374 heated in saline-citrate at 100°C for 10 minutes, and then diluted, slowly cooled 2375 and dialyzed. Such micrograph shows longer molecules having all, with no 2376 exceptions, a cross-linked, non-sequential, topologically complex and invo-2377 luted structure, appearing in large part quite intricately coiled and, as ob-2378 served by the Authors, with "irregular patches at the ends of cylindrical threads". 2379 Figure 4 in [12] shows a micrograph obtained with exactly the same method-2380 ology with the only difference that the cooling step was instead performed 2381 quickly. The description given by the Authors is that the figure "shows only 2382 irregularly coiled molecules with clustered regions". As this second micrograph 2383 has the same magnification factor of the first Figure 3, relevant to slowly 2384 cooled DNA, the lengths of the observable molecular threads in the two fig-2385 ures can be compared. By comparing the two figures, it is evident that the 2386 visible aggregates in Figure 4 besides being in some part clustered are also 2387 much smaller in length and few individual thread-like fragments, even up to 2388 20 times shorter than the thread-like structures of Figure 3, can be almost 2389 clearly discerned. 2390

Summarizing, as elucidated by the elements of empirical evidence and by 2392 the conservative quantitative lower-bound predictions collected in the present 2393 Section 4.3, it would not be an exaggeration to argue that achieving a faithful 2394 amplification, and even before detection, of a long nucleobase sequence after 2395 reiterated cooling and uncooling cycles of PCR, may appear to be as much 2396 plausible as pretending to faithfully reconstitute at the Angströms scale a com-2397 plete long celery stalk of the size of few thousands Angströms from a soup of 2398 randomly aggregated and very similar vegetable fragments, with each frag-2399 ment being dozens of times smaller in size. Such a duty would be burdensome 2400 enough for a nanoscale Maxwell's demon with tweezers capable of seeing and 2401 reconstructing the searched nucleobase sequence, even more so in absence of 2402 such a demon and by just reiterating the thermal bombardment by heat-2403 ing/cooling cycles. 2404

molecules. On the basis of the reviewed experimental data and by adopting 2415 conservative modelling hypotheses, prediction of lower bounds of the in-2416 duced degree of disorganization in molecular sequences is possible. The ex-2417 tent of the computed disruption of nucleobase sequences raises the concern 2418 towards a high probability that, under the heating conditions provided by 2419 PCR, this methodology may amplify chaotically randomized sequences of 2420 nucleotides in an unreliable way. Even if these unwanted fragmentations 2421 were fewer than those observed at the PCR temperatures, the chain reaction 2422 would inevitably amplify the errors in a geometric progression. The scenario 2423 that for larger genetic sequences reliability might not be far from the condi-2424 tion of unfeasibility should be considered, as well as the scenario that PCR 2425 may tout court amplify informational noise. Concerns towards molecular in-2426 tegrity of sequences of any length may also be raised from the use in PCR of 2427 buffers of reducing agents such as DTT and from possible thermal depurina-2428 tion, although these issues have not been herein investigated and are left for 2429 possible future work. 2430

In the light of the strong elements of qualitative and quantitative evi-2431 dence collected in the present study, a preliminary, but very precise, answer 2432 may be given to the opening question: "To what extent is Polymerase Chain 2433 Reaction fully reliable?" The conclusion is that reliability appears out of reach 2434 of all those methodologies, intended for DNA amplification, which are based 2435 on heating at high temperatures under conditions equal or similar to those 2436 prescribed by PCR. The authors of this study believe that a discussion should 2437 be opened on what this unreliability scenario could signify in various fields 2438 in which PCR is used, especially in medical diagnostic applications and in 2439 forensic sciences. 2440

5. Conclusioni (in Italian)

Il presente studio ha sistematicamente esaminato le ricerche scientifiche 2446 fondamentali, pubblicate a cavallo della decade 1950-1960, riguardanti gli ef-2447 fetti del riscaldamento del DNA nelle condizioni previste nei cicli della PCR. 2448 Questa revisione ha mostrato consistenti e ridondanti evidenze, provenienti 2449 dalla totalità dei risultati sperimentali reperibili nei documenti scientifici 2450 presi in esame, che tale processo di riscaldamento determina frammentazioni 2451 delle molecole di DNA interrompendo in modo non controllabile, per bom-2452 bardamento termico, la sequenza di nucleotidi. Sulla base dei risultati speri-2453 mentali oggetto della revisione e sulla base dell'adozione di ipotesi modelli-2454 stiche ottimistiche, in sottostima dell'entità del danno prodotto dalla suddetta 2455 frammentazione, è stato possibile ricavare minoranti del grado di disorganiz-2456 zazione molecolare indotto da tale frammentazione. L'entità della distruzione 2457 della sequenza di nucleotidi così computata solleva una fondata e considere-2458 vole preoccupazione rispetto alla elevata probabilità che, nelle condizioni di 2459 riscaldamento previste dalla PCR, questa metodologia possa amplificare se-2460 quenze caoticamente randomizzate di nucleotidi in maniera non affidabile e 2461 controllabile. Anche laddove l'entità di queste indesiderate non 2462

frammentazioni potesse essere, per ipotesi, minore rispetto a quanto ordina-2463 riamente osservato alle temperature di riscaldamento caratteristiche della 2464 PCR, il carattere reiterativo della 'reazione a catena' amplificherebbe l'errore 2465 secondo una progressione geometrica. Lo scenario in cui, per sequenze gene-2466 tiche di maggiore lunghezza, il requisito di affidabilità possa essere non lon-2467 tano da una vera e propria condizione di non conseguibilità dovrebbe essere 2468 preso in considerazione, al pari di uno scenario in cui l'amplificazione della 2469 PCR possa generare semplicemente del tutto rumore informativo. Ulteriori 2470 preoccupazioni rispetto all'integrità molecolare di sequenze di qualsiasi lun-2471 ghezza derivano altresì dall'uso di agenti riducenti come il DTT impiegati in 2472 alcune soluzioni tampone previste dalla PCR, e da possibili effetti di depuri-2473 nazione per azione termica, sebbene queste tematiche non siano state oggetto 2474 di ricerca specifica in questo studio e sono rimandate a un possibile lavoro 2475 futuro. 2476

Alla luce dei considerevoli elementi di evidenza, di carattere sia qualita-2477 tivo che quantitativo, raccolti nel presente studio, una risposta preliminare, 2478 ma molto precisa, può essere fornita alla domanda di apertura: "In quale mi-2479 sura la Polymerase Chain Reaction è affidabile?". La conclusione a cui perviene 2480 questo studio è che la caratteristica di affidabilità appare fuori della portata 2481 di tutte quelle metodologie, intese per l'amplificazione del DNA, che siano 2482 basate su cicli di riscaldamento a elevate temperature uguali o prossime alle 2483 temperature previste dalla PCR. Gli autori di questo studio ritengono che una 2484 seria discussione debba essere aperta nella comunità scientifica sulle implica-2485 zioni che questo scenario di inaffidabilità può comportare sulla validità, e sul 2486 significato, dei risultati forniti dalla PCR nelle sue applicazioni in ambito me-2487 dico-diagnostico e nell'ambito delle scienze forensi. 2488
