1 Concurrent systemic antibiotics at catheter insertion and intravascular

30 Abstract:

Objectives: Data on the impact of systemic antibiotics at the time of catheter insertion are scarce.
Therefore, we assessed the association between coincident antibiotic administration at insertion and
short-term catheter-related infections.

Methods: We used individual data gathered from five large, randomized, controlled ICU trials. We
analyzed adult patients who required arterial, short-term central venous or dialysis catheter insertion in
the ICU. The effect of antibiotics at insertion on major catheter-related infection (MCRI), catheterrelated bloodstream infection (CRBSI) and colonization was estimated using multivariate marginal
Cox and propensity score models.

Results: We included 10,269 patients and 18,743 catheters from 36 ICUs. Antibiotic use was ongoing
at the time of 11,361 (60.6%) catheter insertions. After adjusting for well-known risk factors for
intravascular catheter infection, we observed a similar risk for MCRI (HR 0.83, 95% CI 0.62-1.10,
p=0.19) and CRBSI (HR 0.85, 95% CI 0.60-1.22, p=0.38) between the antibiotic and no-antibiotic
groups. A confirmatory analysis using propensity score showed consistent results. No specific
antibiotic subclasses reduced the risk of MCRI. Non-fermenting Gram-negative bacilli were more
frequently observed in the antibiotic group.

46 Conclusions: Ongoing antibiotic administration at the time of catheter insertion was not associated
47 with a decrease risk of catheter-related infections and should not be administered for preventing such
48 infections. Our results bring new insights to antimicrobial stewardship in critically ill patients and may
49 direct empirical antimicrobial therapy if MCRI is suspected.

51 Introduction

52 Short-term intravascular catheters are essential in the care of critically ill patients. Central venous 53 catheter (CVC) are frequently used in European intensive care units (ICUs) and ICU-acquired 54 bloodstream infections are catheter-related in almost half of cases [1]. Additionally, intravascular 55 catheter-related infections are associated with increased morbidity and mortality [2].

The role of prophylactic systemic antibiotics at the time of catheter insertion remains the subject of 56 57 ongoing debate. In long-term catheters of oncologic patients, flushing and locking long-term CVCs 58 with a combined antibiotic and heparin solution significantly decreases risk of Gram-positive catheterrelated infection [3]. Use of prophylactic antibiotics at the time of dialysis catheter insertion 59 significantly reduces risk of catheter-related infections and bacteremia [4]. A meta-analysis including 60 three relatively small studies concluded that the routine use of prophylactic systemic antibiotics in 61 neonates during the full period of CVC maintenance reduced the rate of "proven" or "suspected" 62 63 septicemia and of clinical sepsis [5].

The role of systemic antibiotic prophylaxis in adults with short-term intravascular catheters remains unresolved and the literature shows conflicting results [6-9]. We performed a *post-hoc* analysis using high-quality, individual data gathered from five large randomized, controlled trials (RCTs) [10-14] to determine the association between coincident systemic antibiotic at insertion and short-term intravascular catheter-related infections in critically ill patients.

70 Material and Methods

71 Design and data sources

72 We performed a *post-hoc* analysis using individual patient data from five large RCTs (DRESSING1, 73 DRESSING2, ELVIS, CLEAN and 3SITES) [10-14]. The definitions and inclusion criteria were 74 similar among all these RCTs. Therefore, we merged the five study databases. The objectives of the five studies were similar: to evaluate the effect of specific prevention measures on the risk of 75 76 intravascular catheter complications. Briefly, the DRESSING1 study assessed the effect of 77 chlorhexidine-gluconate (CHG) sponge for preventing catheter-related infections [10]. The DRESSING2 study evaluated the effect of CHG gel-dressing for catheter-related infections prevention 78 [11]. The ELVIS trial evaluated the risk of infection with or without ethanol lock among short-term 79 dialysis catheters [12]. The impact of skin antisepsis with 2% CHG compared to povidone iodine-80 81 alcohol [PVI] on intravascular catheter-related infections was investigated in the CLEAN study [13]. The 3SITES study evaluated differences in infectious and mechanical complications between the 82 subclavian, jugular and femoral insertion sites [14]. CHG-sponges, CHG-gel dressing, CHG-skin 83 84 antisepsis and the subclavian vein insertion site decreased the risk of catheter infection[10, 11, 14]. 85 The study interventions were not blinded to the ICU staff nor to the investigators. They were blinded 86 to the microbiologists who processed the blood and catheter cultures and to the adjudication committee. The five RCTs were approved by the national ethic committees. 87

88 Patients

Adult patients (≥18 years) were recruited from 2006 to 2014 in ICU in France as soon as they required
an arterial catheter (AC), a CVC or a short-term dialysis catheter (DC) insertion [10-14]. Patients
underwent follow-up until 48 hours after ICU discharge [10-13], ICU discharge [14] or death [10-14].

92 <u>Catheters</u>

93 This *post hoc* analysis investigated individual data from short-term catheters included in the five 94 RCTs. All short-term catheters were managed in the same way and complied with national 95 recommendations (*i.e.*, French Haute Autorité de Santé checklist) [15], which are similar to U.S.

96 (Centers for Disease Control and Prevention) recommendations [16]: 1) maximal sterile barrier precautions were used (surgical hand antisepsis; large sterile drape; mask, cap, sterile gloves, and 97 98 gown); 2) the site of insertion was selected according to the randomization scheme [14] or at the physician's discretion [10-13]; 3) CHG or PVI was utilized for skin antisepsis at catheter insertion and 99 during dressing changes according to the randomization scheme [13] or at the physician's discretion 100 [10-12, 14]; 4) standard or impregnated-dressings were changed 24h after insertion and then every 3 or 101 102 7 days according to randomization scheme or standard practices in each ICU [10-14]. Soiled, wet or 103 leaking dressings were immediately removed and changed. Antibiotic- or antiseptic-impregnated 104 catheters were not included in the five RCTs. Most importantly, antibiotics were administered at the 105 physician's discretion and this variable was routinely collected in all studies (*i.e.*, in the 48h before the 106 insertion). Of note, the reason for antibiotic use was not known (e.g., treatment of a known infection or 107 prophylaxis). The physicians caring for each patient decided independently to remove catheter.

108 Outcomes and definitions

109 French and U.S. definitions were used [17, 18]. A catheter culture yielding ≥1000 cfu/mL was required for defining catheter tip colonization [19]. Catheter-related bloodstream infection (CRBSI) 110 111 was a combination of 1) \geq 1 positive peripheral blood culture sampled after >48h of catheter 112 maintenance or within 48h after removal; 2) the identification of the same microorganism from the 113 positive catheter tip culture, or a blood culture differential time-to positivity of $\geq 2h [11, 13]$ (*i.e.*, time 114 growth difference between catheter-drawn blood culture and peripherally-drawn blood cultures) [20]; 115 and 3) no other source of bacteremia or fungemia other than the catheter. Positive blood culture with coagulase-negative staphylococci (CoNS) were considered if the same pulsotype (i.e., the clonality 116 117 was checked) was identified from the isolates recovered from the catheter tip and blood culture [11]. 118 Alternatively, the same microorganism that colonized the catheter tip was identified in >1 separate 119 peripheral blood cultures [10, 12-14]. Catheter-related clinical sepsis without bloodstream infection (BSI) was a combination of abnormal temperature ($\leq 36.5^{\circ}$ C or $\geq 38.5^{\circ}$ C), positive catheter tip culture, 120 purulence at the insertion site, or resolution of clinical sepsis after catheter removal, and no apparent 121 infectious source other than the catheter. Major catheter-related infection (MCRI) was defined as 122

either catheter-related clinical sepsis without BSI or a CRBSI. Of note, MCRI is a moderate to good
surrogate endpoint for CRBSI [21]. We performed an exploratory analysis for the following antibiotic
groups which were routinely collected in four studies [10-13]: beta-lactam, beta-lactam with activity
against *Pseudomonas* spp, antibiotics against only Gram-positive microorganisms (*i.e.*, glycopeptide,
linezolid or lincosamide), aminoglycoside/quinolone/trimethoprim-sulfamethoxazole, and others.

128 <u>Statistics</u>

Patient and catheter characteristics are described as median (interquartile range) or number (percent),as appropriate.

The statistical plan had three steps: 1) To evaluate the association between antibiotics at insertion and MCRI, CRBSI and colonization using multivariate Cox models; 2) to perform a secondary analysis using a propensity score model; 3) and to explore if a specific antibiotic subgroup was associated with a reduction of MCRI.

135 We performed "marginal" Cox models, which considered a possible clustering effect of multiple 136 catheters per patient [22], and we stratified by ICU. Data were censored at 28 days after catheter insertion. A hazard ratio (HR, representing the daily risk for infection during the catheter maintenance) 137 138 was derived: a HR <1 indicated a decreased risk for antibiotics at insertion. This model considers the intra-cluster dependency (*i.e.*, more than one catheter per patient), using robust sandwich covariance 139 140 estimates (PROC PHREG of SAS) [23]. The proportionality of hazard risk for antibiotic at insertion 141 was tested using Martingale residuals. HR for MCRI, CRBSI and colonization were evaluated by univariate and multivariate analysis. The variable "antibiotic at insertion" was forced in the 142 143 multivariate models and the following clinically relevant variables were used as adjustment factors (i.e., well-known risk factors for intravascular catheter infections): SAPS II, experience of the 144 145 operator, insertion site, catheter type (*i.e.*, AC, CVC or short-term dialysis catheter), skin antisepsis, CHG-impregnated dressing, heparin during catheter insertion, vasopressor and mechanical ventilation 146 at insertion. Moreover, we performed additional analyses using propensity score models (see 147 148 electronic supplementary material [ESM]).

- 149 In the exploratory analysis, we used, instead of a binary variable (antibiotics vs without antibiotics),
- 150 the categorical variable "antibiotic subgroups" in order to describe the individual infectious risk for the
- 151 different antibiotic subgroups.
- 152 Tests were considered significant with a p < 0.05. We performed all analyses using R (version 3.5.3)
- and SAS (version 9.4; SAS Institute, Cary, NC).
- 154 See the ESM for further details on methods and statistical analysis.

156 **Results**

157 Patients and catheters:

Between 2006 and 2014, 10,269 patients and 18,743 (9,641 CVCs, 6,373 ACs and 2,729 DCs) catheters were included in 36 ICUs (Figure 1). Median age was 64 years (interquartile range [IQR] 52.9, 74.8) and 3,704 (36.1%) patients were female (Table 1). The SAPS II at admission was 54 (41, 69) and 1,952 (19%) patients were immunosuppressed. Senior operators (>50 procedures) placed 7,075 (37.7%) catheters and 7,186 (38.3%) catheters were inserted at the femoral site. CHG for skin disinfection was used in 8,416 (44.9%) catheters and CHG-impregnated dressings were used in 4,061 catheters (21.7%).

Antibiotics were administered at catheter insertion in 11,361 (60.6%) catheters, predominantly consisting of beta-lactam antibiotics (8,344, 54.9%, Table E1 in ESM). MCRI, CRBSI and catheter colonization were observed in 241 (1.3%), 151 (0.8%) and 1,514 (8.1%) episodes, respectively. The proportionality of hazards assumption was violated for catheter colonization (p<0.0001), but respected for MCRI (p=0.51) and CRBSI (p=0.81).

170 MCRI and antibiotic type:

171 Among catheters without MCRI, antibiotics were administered during 11,211 (60.6%) catheter 172 insertions, whereas among catheters with MCRI, 150 (62.2%) received an antibiotic at insertion. In the 173 univariate Cox model analysis, the MCRI risk was similar for the antibiotic and no-antibiotic group (HR 0.82, 95% confidence interval [CI] 0.62-1.09, p=0.18, Figure 2 and Table E2 ESM). After 174 adjusting for well-known risk factors for intravascular infection, we found similar results (HR for 175 176 antibiotics 0.83, 95% CI 0.62-1.10, p=0.19, Figure 2 and Table E2 ESM). A confirmatory analysis using IPTW also showed similar results (HR for antibiotics 0.82, 95% CI 0.61-1.09, p=0.17). No 177 specific antibiotic subgroup reduced the risk for MCRI: beta-lactam antibiotics or other groups of 178 179 antibiotics with Gram-positive antimicrobial activity exhibited a HR of 0.83 (95%CI 0.57-1.21, 180 p=0.34) and 0.86 (95%CI 0.55-1.36, p=0.52, Figure E2 ESM), respectively. However, the distribution of microorganisms associated with MCRI was significantly different between the two groups 181

182 (p<0.0001). Non-fermenting Gram-negative bacilli were more frequently observed in the antibiotic 183 group (21.1% versus without antibiotics 5.7%, 0.0053). In >85% of cases non-fermenting Gram-184 negative were Pseudomonas MCRI. *S aureus* was more frequently detected in the group without 185 antibiotics (Table 2).

186 <u>CRBSI risk:</u>

Among catheters without CRBSI, Antibiotics were administered at insertion for 11,266 (60.6%) catheters; whereas among catheters with CRBSI, 95 (62.9%) received an antibiotic at insertion. In the univariate Cox model analysis, the CRBSI risk was similar for antibiotics compared to group without antibiotics (HR 0.84, 95% CI 0.59-1.21, p=0.34, Figure 2 and Table E3 ESM). After adjusting for risk factors for intravascular catheter infection, we found similar results (HR for antibiotics 0.85, 95% CI 0.60-1.22, p=0.38, Figure 2 and Table E3 ESM). A confirmatory analysis using IPTW revealed similar results (HR for antibiotics 0.86, 95% CI 0.60-1.24, p=0.43).

194 <u>Catheter colonization risk</u>

195 Among catheters without colonization, Antibiotics were administered at insertion for 10,505 (61%) 196 catheters, whereas among colonized catheters, 856 (56.5%) received an antibiotic at insertion. In the 197 univariate Cox model analysis, catheter colonization risk was significantly decreased in the antibiotic 198 group (HR 0.67, 95% CI 0.6-0.75, p<0.0001, Figure 2 and Table E4 ESM). After adjusting for risk 199 factors for intravascular infection, we found similar results with a reduced risk for the antibiotic group 200 (HR 0.67, 95% CI 0.60-0.75, p<0.0001, Figure 2). After introducing a time-dependent variable, the 201 HR was 0.53 (95% CI 0.45-0.63, p<0.0001) in the first 7 days and 0.81 (95% CI 0.70-0.93, p=0.0039) 202 after >7 days of catheter maintenance (Table E4 ESM).

203 **Discussion**

Using high-quality, individual data from five RCTs, we demonstrated that the daily hazard ratio of MCRI and CRBSI was similar regardless of whether or not antibiotics were administered at catheter insertion. Moreover, no specific antibiotic subgroup significantly reduced the subsequent risk of catheter infection. However, antibiotics administered at insertion did decrease risk of catheter colonization.

209 Data in the literature regarding the role of antibiotic administration during short-term catheter insertion 210 are scant and, to our knowledge, no RCT on this topic is currently planned. Only a limited number of 211 studies assessed the association between antibiotics administration and infectious risk related to short-212 term catheters in critically ill patients. The post-hoc analysis of the first RCT illustrated that systemic 213 antibiotics were an independent protective factor regarding infectious complications [6]. Of note, the 214 definition "infectious complications" included either CRBSI, MCRI, or catheter colonization [6]. In a second prospective study including eight ICUs and 8,593 CVCs, the absence of antibiotics 215 216 administration within 48 hours of insertion was a risk factor for CVC-associated BSIs [7]. The third 217 study was an observational study with 179 patients which revealed that extending routine 218 perioperative antibiotic prophylaxis until all intravascular catheters had been removed did not 219 influence rates of intravascular catheter colonization [8]. The last study found that antibiotic administered at the time of catheter insertion was associated with a reduced CVC colonization in a 220 221 multivariate model [9]. Most of these studies were published prior to 2010 and may be less relevant 222 today due to the widespread adoption of recommendations for prevention of catheter infections [24]. 223 Indeed, intravascular catheter bundles have changed the landscape of risk factors associated with intravascular catheter infections in critically ill patients [25]. In an environment of consistent catheter 224 225 care representing the largest dataset ever assembled, we found that coincident systemic antibiotic 226 administration at catheter insertion was not associated with decreased risk of infection. Our data were 227 supported by different statistical models and support the fact that antibiotics at catheter insertion 228 should not be administered for preventing intravascular catheter infections when such catheters are 229 inserted. Our data also has relevance for antibiotic stewardship programs [26].

Although antibiotic administration at insertion significantly reduced catheter colonization,
colonization does not represent a reliable outcome for clinical trials [21]. However, catheter
colonization is required to meet the gold standard definition of CRBSI [18] and, therefore, in patients
with concurrent antibiotic at insertion, the diagnosis of CRBSI may be difficult.

Our study has an important clinical implication: we found that non-fermenting Gram-negative bacilli were more frequently observed in the group that received antibiotics, whereas *S. aureus* was more frequently observed in the group without antibiotic administration. This data may direct empirical antimicrobial therapy if CRBSI is suspected after catheter insertion.

We acknowledge several limitations. First, we conducted an observational study: the patients were not 238 239 randomized according to the antimicrobial therapy and unmeasured factors may persist and cause residual confounding. However, we presented data that were prospectively collected by trained 240 241 investigators in the field of catheter-related infections and we corrected for several confounders. Second, no information on reason (e.g., treatment of a known infection or prophylaxis) of 242 antimicrobial administration or antibiotic duration was available. It is conceivable that a longer 243 duration of antibiotic therapy may reduce the risk of infection. However, as mentioned above, a prior 244 245 study did not demonstrate any difference in infectious risk between a prolonged versus short 246 antimicrobial prophylactic course [8]. Third, we described a large cohort designed to investigate the 247 impact of several prevention measures, and interactions may have occurred among the various study 248 groups. However, our statistical analyses considered these potential drawbacks. Fourth, we found that 249 antibiotics significantly reduced catheter tip colonization. This result should be interpreted with caution: catheter colonization was demonstrated to be unsuitable to establish definite patient-oriented 250 251 benefit or harm for a specific treatment [21]. However, it is possible that yield of MCRI and CRBSI 252 (i.e., definitions partially using catheter tip colonization) can be reduced since antibiotics appeared to 253 decrease catheter tip colonization. Finally, the five studies were conducted in French ICUs, which may limit the generalizability of our results. 254

The analysis of five large RCTs involving over 10,000 ICU patients with more than 18,000 catheters demonstrated that ongoing antibiotic administration at the time of catheter insertion was not associated

with decreased risk of subsequent catheter-related infections. These findings may suggest that antibiotics at catheter insertion did not prevent short-term intravascular catheter infections and represents an additional point of intervention for antibiotic stewardship programs in critically ill patients.
