#### 26 Abstract

Resistance to chemical insecticides including pyrethroids, the main insecticide class used 27 against mosquitoes, led to a regain of interest for neonicotinoids. In this context, the present 28 study aims at characterizing the molecular basis of neonicotinoid resistance in the mosquito 29 Aedes aegypti. Resistance mechanisms were studied by combining transcriptomic and 30 31 genomic data obtained from a laboratory strain selected at the larval stage for 30 generations with imidacloprid (Imida-R line). After thirty generations of selection, larvae of Imida-R line 32 showed a 8-fold increased resistance to imidacloprid and a significant cross-tolerance to the 33 pyrethroids permethrin and deltamethrin. Cross-resistance to pyrethroids was only observed 34 35 in adults when larvae were previously exposed to imidacloprid suggesting a low but inducible expression of resistance alleles at the adult stage. Resistance of the Imida-R line was 36 37 associated with a slower larval development time in females. Multiple detoxification enzymes 38 were over-transcribed in larvae in association with resistance including the P450s CYP6BB2, CYP9M9 and CYP6M11 previously associated with pyrethroid resistance. Some of them 39 40 together with their redox partner NADPH P450 reductase were also affected by nonsynonymous mutations associated with resistance. Combining genomic and transcriptomic 41 42 data allowed identifying promoter variations associated with the up-regulation of CYP6BB2 in the resistant line. Overall, these data confirm the key role of P450s in neonicotinoid 43 resistance in Ae. aegypti and their potential to confer cross-resistance to pyrethroids, raising 44 concerns about the use of neonicotinoids for resistance management in this mosquito 45 species. 46

#### 55 **1. Introduction**

Arboviruses threaten public health in many tropical and subtropical countries. One of 56 the most important vector of human arboviruses is the mosquito Aedes aegypti, which can 57 transmit yellow fever, chikungunya (CHIKV), dengue (DENV), and Zika (ZIKV) viruses 58 (Crawford et al. 2017). The health and economic impact of arboviral diseases has increased 59 60 dramatically over the last 50 years (Vorou 2016). Despite decades of efforts, control strategies have failed to protect human from arboviruses due to an increase of global trade 61 and ineffective vector control strategies (Franz et al. 2015). Indeed, in absence of treatments 62 or vaccines for most arboviral diseases, arbovirus prevention mainly relies on intensive 63 vector control which itself often relies on insecticide treatments (Smith et al. 2016). However, 64 the usage of the same insecticides for decades led to the emergence and spread of 65 66 resistance to most chemical insecticides including pyrethroids, the latest insecticides used for vector control (Ranson et al. 2010). Resistance to insecticides is widespread in the dengue 67 vector Aedes aegypti (Moyes et al. 2017) with high resistance levels frequently observed in 68 69 natural populations often affecting the efficacy of vector control (Dusfour et al. 2011; Dusfour et al. 2019). 70

71 Resistance of mosquitoes to chemical insecticides has been associated to several 72 physiological adaptations among which target-site insensitivity and increased insecticide 73 metabolism are of key importance (Hemingway et al. 2004). Non-synonymous mutations 74 decreasing insecticide target sensitivity are well-characterized in mosquitoes. For example, 75 mutations affecting the voltage-gated sodium channel (knock down resistance mutations, 76 known as kdr mutations) have been well described in Ae. aegypti and are often present at 77 high frequencies in pyrethroid-resistant populations (Black and Vontas 2007; Moyes et al. 78 2017; Smith et al. 2016). Metabolic resistance is linked to an increased activity of 79 detoxification enzymes including cytochrome P450 monooxygenases (P450s or CYPs for 80 genes), carboxyl/cholinesterases (CCEs), glutathione S-transferases (GSTs) and UDPglycosyl-transferases (UDPGTs) (David et al. 2013; Li et al. 2007) which metabolize the 81

insecticide. This increased detoxifying activity is frequently caused by an over-expression of
detoxification genes through transcriptional regulation or gene duplications though the
selection of structural variants enhancing insecticide metabolism may also be involved
(Faucon et al. 2015; Faucon et al. 2017).

A classical way to manage resistance is by alternating insecticides from different 86 87 families. However, the use of the same chemical families for decades together with the limited portfolio of insecticides authorized in public health frequently impair such 88 management strategy (Dusfour et al. 2019). Enlarging the portfolio of insecticides available 89 for vector control by repurposing insecticides developed for crop protection is a possible way 90 91 to improve resistance management. In this frame, several studies pointed out the potential of neonicotinoids for mosquito control (Darriet and Chandre 2013; Paul et al. 2006; Pridgeon et 92 93 al. 2008) and vector control products containing neonicotinoids are currently being developed by the industry (Agossa et al. 2018; Fuseini et al. 2019). As other neonicotinoids, 94 95 imidacloprid is an insecticide targeting nicotinic acetylcholine receptors (nAchR) in insect 96 nervous systems (Tomizawa and Casida 2005). This insecticide has been extensively used 97 in agriculture against various crops pests (Elbert et al. 2008; Mullins 1993). Neonicotinoids such as imidacloprid alone or in combination with other insecticides have been shown to be 98 efficient against mosquitoes resistant to pyrethroids suggesting that they might represent a 99 100 new tool for managing resistance (Darriet and Chandre 2013; Paul et al. 2006). However, the 101 implementation of neonicotinoids in vector control may eventually lead to the selection of 102 novel or existing resistance alleles in mosquitoes. Several studies demonstrated the capacity 103 of various agricultural pests to become resistant to neonicotinoids. In most cases, resistance was caused by target site insensitivity (Crossthwaite et al., 2014) or an overproduction of 104 P450s (Feng et al. 2010; Karunker et al. 2008; Puinean et al. 2010). In addition, multiple 105 P450s from various insects were shown to be capable of metabolizing imidacloprid, including 106 107 Drosophila melanogaster CYP6G1, Bemisia tabaci CYP6CM1vQ, Nilaparvata lugens CYP6AY1 and CYP6ER1, and Laodelphax striatellus CYP6AY3v2 and CYP417A2v2 (Bao et 108

109 al. 2016; Jouben et al. 2008; Karunker et al. 2009; Miah et al. 2017; Wang et al. 2017). 110 Despite the strong interest for neonicotinoids in vector control, resistance mechanisms of mosquitoes to these insecticides remain poorly investigated (Corbel et al. 2004; Darriet and 111 112 Chandre 2013; Uragayala et al. 2015). A recent study pointed out the higher neonicotinoid resistance of Anopheles coluzzi populations from an intense agriculture area although 113 resistance mechanisms were not investigated (Mouhamadou et al. 2019). In Ae. aegypti, the 114 115 selection of a laboratory strain with imidacloprid at the larval stage for 8 generations lead to a 116 ~5-fold increased resistance phenotype mostly expressed at the larval stage (Riaz et al 2013). Biochemical and gene expression studies suggested the key role of P450 over-117 transcription in resistance with multiple CYP genes strongly over-transcribed in the resistant 118 strain (Riaz et al 2013, David et al 2014). Among them, substrate docking simulations 119 120 identified CYP6BB2 as a potential imidacloprid metabolizer (Riaz et al 2013). However, the low resistance level obtained after only 8 generations of selection and the lack of genomic 121 data did not allow to fully characterize the molecular bases of the resistance phenotype. 122

123 In this context, the present study aims at further characterizing the resistance 124 mechanisms having been selected in this resistant strain by combining transcriptomic and 125 genomic data obtained from individuals selected for 30 generations with imidacloprid. An additional line was also created by releasing the selection pressure from generation 11 in 126 order to improve the power of resistance allele detection and investigate fitness costs 127 associated with resistance. A combination of RNA-seq and pool DNA-seq targeting the 128 exons and promoters of 750 genes potentially involved in resistance was used in an attempt 129 130 to better characterize the genetic bases of this P450-mediated resistance phenotype.

#### 135 2. Material and methods

#### 136 2.1 Ethical statement

Adult mosquitoes were fed on mice. Mice were maintained in an animal house agreed by French Ministry of animal welfare (n° B 38 421 10 001) and used in accordance to EU laws and the relevant ethic committee recommendations (ComEth Grenoble - C2EA - 12).

#### 141 2.2. Insecticide selection

Mosquitoes were reared in standard insectary conditions (26°C, 14h/10h light/dark 142 photoperiod, 80% relative humidity). Larvae and adults were fed with hay pellets and filter 143 144 papers impregnated with honey respectively. The susceptible laboratory strain Bora-Bora. (French Polynesia), was used as a parental strain for insecticide selection. The Imida-R 145 resistant line was obtained by selecting Bora-Bora individuals with imidacloprid (Sigma-146 Aldrich, Germany) for 30 successive generations. Selection was performed following WHO 147 148 guidelines for larvicide bioassays (WHO, 2016) by exposing 3<sup>rd</sup>-4<sup>th</sup>-stage larvae for 24h to imidacloprid. The dose of imidacloprid (500 to 1500 µg/L) was adjusted at each generation to 149 150 reach a mortality rate of 70-80%. Surviving larvae were transferred in tap water until 151 emergence. At each generation, a negative control was performed with the solvent used for 152 imidacloprid solubilization (acetone) in order to control for mortality not induced by the 153 insecticide. After reproduction females were blood fed to generate eggs for the next generation. Each generation was initiated with more than 7000 individuals for limiting 154 155 bottleneck effect. In order to investigate fitness costs associated with resistance, a second line (Imida-S) was created by releasing the selection pressure from  $G_{11}$  to  $G_{30}$ . 156

#### 160 2.3. Larval bioassays with imidacloprid

Dynamics of larval resistance in each line was studied through comparative 161 bioassays with imidacloprid in the Imida-R and the Imida-S lines as compared to the 162 susceptible strain Bora-Bora at generations 6, 9, 11, 12, 14, 16, 19, 25 and 30. At each 163 generation bioassays were performed on 4th-stage larvae not previously exposed to 164 165 insecticide. For each line, three replicates of 25 larvae were maintained in 50 mL insecticide solution for 24h before recording mortality. Six different insecticide concentrations ranging 166 from 150 to 3500  $\mu$ g/L killing from 5% to 95% individuals were used for each line. LC<sub>50</sub> and 167 their 95% confident intervals (Cl<sub>95</sub>) were estimated for each line at each generation with a 168 169 log-probit model using XL-Stat (Addinsoft, Paris, France). Resistance ratios (RR<sub>50</sub>) between each line and the susceptible strain Bora-Bora were computed at each generation based on 170 their respective LC<sub>50</sub> values. 171

#### 173 2.4 Larval and adult bioassays with pyrethroids

174 Cross-resistance of the Imida-R line to the pyrethroid insecticides permethrin and deltamethrin was investigated in larvae and adult female at the end of the selection process 175 176 using single-dose bioassays. All mentioned concentrations were nominal concentrations. 177 Comparative bioassays were performed on 4<sup>th</sup>-stage larvae of the Imida-R line and the 178 susceptible Bora-Bora strain not previously exposed to insecticide. For each line, five replicates of 25 larvae were maintained in 50 mL insecticide solution for 24h before recording 179 180 mortality. A single-dose of permethrin  $(1 \mu g/l)$  and deltamethrin  $(0.125 \mu g/L)$  were used. Comparative bioassays were also conducted on four days-old non-blood fed adult females of 181 the Imida-R line and the susceptible Bora-Bora strain using WHO test tubes with 0.75% 182 permethrin and 0.05% deltamethrin papers. Bioassays were performed with 5 replicates of 183 25 females according to WHO procedure except that exposure times were reduced to 6 min 184 185 and 5 min for permethrin and deltamethrin respectively (WHO, 2016). Mortality rates were

recorded after a 24h recovery time. Two comparisons were tested. First, the susceptibility of Bora-Bora females and  $G_{30}$  Imida-R females not exposed to any insecticide were compared. Then, the susceptibility of Bora-Bora females and  $G_{30}$  Imida-R females obtained from 4<sup>th</sup> stage larvae surviving to an imidacloprid exposure of 1500 µg/L for 24h (~70% larval mortality) were compared.

#### 192 2.5 Individual development rates

193 Development rates up to imago emergence were compared between the Imida-R, 194 imida-S and Bora-Bora lines in order to investigate for fitness costs potentially associated 195 with resistance as defined from (Agossa et al. 2018; Prud'homme et al. 2017; Prud'homme et al. 2018). From 1h post-hatching to imago emergence, 100 G<sub>30</sub> individuals (3 replicates) 196 197 were reared in glass dishes (1 moquito per mL). Feeding was performed daily with 0.2 to 0.4 198 mg/individual of crushed hay pellets at days 0 to 10 as described in Prud'homme et al. (2017; 199 2018). The time-to-emergence was defined as the number of hours separating hatching and adult emergence. The distributions of time-to-emergence obtained from males and females 200 of each line were compared using a Kaplan-Meyer's test. 201

#### 203 2.6 RNA and DNA extractions

For RNA-seq, three pools of thirty 4<sup>th</sup> stage larvae from each line (Imida-R, Imida-S and Bora-Bora) not exposed to insecticide were used for RNA extractions using the RNAqueous-4PCR kit (Life technologies) according to manufacturer's instructions Genomic DNA contaminants were removed using DNAse. For targeted DNA-seq, mosquitoes (two pools of 65 individuals) were collected and used for genomic DNA extraction as described in Faucon et al. 2015

#### 211 2.7 RNA sequencing

Three RNA-seq libraries were prepared per line using the TruSeq Stranded mRNA 212 sample Prep kit (Illumina) following manufacturer's instructions. After quality check, libraries 213 were sequenced (paired reads) in multiplex on an Illumina GAIIx sequencer by Hybrigenics-214 Helixio (Clermont-Ferrand, France). After unplexing and removing adaptors FastQC 215 216 (http://www.bioinformatics.babraham.ac.uk/projects/fastqc) was used on each sample to assess reads quality. Reads were then filtered based on their length, pairing and quality 217 using Trimmomatic (Bolger et al. 2014). Trimmed reads (only paired reads) were then 218 mapped to Ae. aegypti genome (AaegL5 assembly) using Strand NGS V2.2 (Strand Life 219 220 Sciences). Reads were then filtered based on the sequence and mapping quality and read coverage was quantified for each sample and normalized as described in Faucon et al. 221 222 (2017).

223 Transcription ratios between each line were computed across all biological replicates 224 and associated P values were obtained using an ANOVA test with Benjamini-Hochberg correction for multiple comparison and a post-Hoc Tukey HSD test. Genes satisfying the four 225 following conditions in either direction were considered differentially expressed in association 226 227 with resistance (DE genes): FC[Imida-R / Bora-Bora]  $\geq$  1.5 and P value  $\leq$  0.005 (differential expression in Imida-R versus Bora-Bora) AND FC[Imida-S / Bora-Bora] ≥ 1.1 and P value ≤ 228 0.005 (moderate differential expression in Imida-S versus Bora-Bora) AND FC[Imida-R / 229 Imida-S]  $\geq$  1.0 and P value  $\leq$  0.005 (higher differential expression in Imida-R as compared to 230 231 Imida-S) AND {FC[Imida-R / Bora-Bora] / FC[imida-S / Bora-Bora]} >0 (same direction in Imida-R and imida-S). 232

Polymorphism data obtained from RNA-seq were analyzed using Strand NGS V2.2
(Strand Life Sciences). SNPs were called against the reference genome from filtered reads
using the parameters described in Faucon et al. (2017). SNPs for which allele frequency
variations satisfied the following conditions in either direction were considered associated

with resistance (Diff SNPs): f[Imida-R] - f[BoraBora] > 40% (high frequency variation between *Imida-R and Bora-Bora*), AND f[Imida-S] - f[Bora-Bora] >20% (moderate frequency variation
between Imida-S and Bora-Bora) AND f[Imida-R] / f[imida-S] >0 (frequency variations versus
Bora-Bora in the same direction for Imida-R and Imida-S). Genic effects were computed to
identify non-synonymous differential SNPs (NS Diff SNPs).

#### 243 2.8 Pool targeted DNA sequencing

244 Gene capture and sequencing were performed by Hybrigenics-Helixio (Clermont-Ferrand, France). The capture library consisted in 51,073 overlapping RNA probes of 120 bp 245 246 (baits) targeting 3458 exons belonging to 789 genes and their upstream promoter regions 247 (up to 1 kb upstream ATG) as described in Faucon et al. (2015). These genes, chosen 248 according to their potential role in insecticide resistance. Capture was performed according to the 'SureSelect Target Enrichment System for Illumina Paired-end Sequencing Library 249 250 version 1.5' protocol with 3 µg gDNA. Captured DNA fragments were amplified, purified, multiplexed and paired-end sequenced on a Genome Analyzer IIx (Illumina) producing 76 bp 251 reads. Sequencing deep was adjusted to reach an average coverage of targeted regions 252 >60X for each sample. Reads quality was checked using FastQC and reads were then 253 filtered based on their length, pairing and quality using Trimmomatic (Bolger et al. 2014) as 254 255 described in Faucon et al. (2015). Only paired reads were retained for mapping. Reads were mapped to Ae. Aegypti genome (AaegL5 assembly) using BWA (Li and Durbin 2009) with 256 default parameters implemented into a Galaxy pipeline (<u>http://galaxyproject.org</u>). Mapped 257 reads were loaded into Strand NGS V2.2 (Strand Life Sciences) and further filtered 258 259 according to their mapping quality (alignment score  $\geq$  95). Only primary hits were conserved 260 In case of multiple mapped reads.

Copy number variations affecting each targeted gene were estimated based on
 coverage data estimated from filtered reads as described in Faucon et al. (2015). Detection

of Copy Number Variations (CNV) was based on coverage fold change (FC) between samples. Genes satisfying the following conditions were considered affected by a positive CNV associated with resistance: FC[Imida-R / Bora-Bora]  $\geq$  1.5-fold] (corresponding to a duplication in  $\geq$  50% individuals) AND FC[Imida-S / Bora-Bora] > 1.05-fold (corresponding to a duplication in  $\geq$  5% individuals) AND FC[Imida-R / Imida-S]  $\geq$  1-fold (more copies in Imida-R as compared to Imida-S).

Polymorphisms (SNPs, MNPs and indels) were called against the reference genome by using Strand NGS V2.2 (Strand Life Sciences) and for each variation, allele frequencies were computed for each line based on the number of reads supporting each allele. Only substitutions showing > 5% allele frequency variation across lines were retained. SNPs for which frequency variations satisfied the same conditions as for RNA-seq polymorphisms analysis (see above) were considered associated with resistance (Diff SNPs). Genic effects were computed as described above

276 For promoter regions, the correlation between the frequency of SNPs located upstream detoxification genes over-transcribed in association with resistance and their 277 transcription levels were tested across all conditions using Pearson's tests. Then, the effect 278 of variations positively correlated with transcription levels was examined in silico by 279 280 comparing transcription factor binding sites (TFBS) at each locus between the reference and the variant alleles. TFBS were screened with Promo V3.0 (http://alggen.lsi.upc.es/cgi-281 282 bin/promo v3/promo/promoinit.cgi?dirDB=TF 8.3) using Transfac V8.3 database restricted 283 to animals and factors of at least six bp as described in Faucon et al. (2017). DNA patterns showing  $\leq$  5% matrix dissimilarity with known TFBS were retained and compared between 284 reference and variant haplotypes. Differential TFBS were then manually curated and those 285 likely having a major impact on gene regulation were identified based on i) their differential 286 287 occurrence between reference and variant alleles, ii) their known enhancer effect on 288 detoxification genes, iii) their expected effect in regards of the positive/negative correlation 289 between the frequency of the variant allele and transcription level and iv) their position

relative to core promoter elements and the putative transcription starting site. Putative
 transcription starting sites were manually identified based on the presence of core promoter
 elements previously identified in arthropods.

#### 294 3. Results

#### 3.1 Dynamics of resistance through the selection process

Monitoring larval resistance to imidacloprid along the selection process confirmed the gradual increase of resistance in the selected Imida-R line with a RR<sub>50</sub> reaching 9.5-fold at generation 19 and then stabilizing around 8-fold as compared to the susceptible parental line Bora-Bora (Fig. 1). The release of imidacloprid selection from generation 11 (Imida-S line) led to the gradual decrease of resistance with a RR<sub>50</sub> decreasing to 3.2-fold at generation 30.

301 3.2 Larval and adult cross-resistance to pyrethroids

302 Comparative bioassays revealed a significant cross-resistance of the Imida-R line to 303 the two pyrethroids permethrin and deltamethrin at the larval stage as compared to the parental Bora-Bora strain (Fig. 2A). No significant constitutive cross resistance was observed 304 305 in adult females (Fig. 2B) when obtained from unexposed larvae. However, when the adult females of the imida-R line used for bioassays were obtained from larvae surviving 306 imidacloprid exposure, a significant increased resistance to both pyrethroids was observed 307 for the Imida-R line as compared to the parental Bora-Bora strain suggesting that the 308 expression of resistance alleles can be induced by the insecticide (Fig. 2C). 309

#### 314 3.3 Fitness costs associated with resistance

Comparison of larval development rates between the three lines revealed a delay of emergence for Imida-R females as compared to females of the susceptible parental Bora-Bora strain (X-sq= 139, df=1, p-value $\approx$  0) while no significant delay was observed for Imida-S females (Fig. 3A). No significant differences were observed in males between the Imida-R or the imida-S lines and the parental Bora-Bora strain (Fig. 3B).

#### 321 3.4 Transcription level variations associated with imidacloprid resistance

The 6,145 annotated transcripts showing a transcription level > 0.5 RPKM were 322 manually associated to 13 functional categories (Fig. 4A). Twenty annotated genes were 323 324 differentially transcribed in association with resistance with a higher transcription ratio observed in the Imida-R line than in the Imida-S line (DE genes, see methods). These DE 325 genes encompassed 14 genes over-transcribed and 6 genes under-transcribed. Functional 326 categories enrichment analyses performed on the differentially transcribed genes indicated a 327 328 strong enrichment of cytochrome P450s (P450s) and glycosyl-transferases (UGT) among over-transcribed genes (Fig. 4A). Four P450s belonging to CYP6 (CYP6BB2 and CYP6M11), 329 CYP9 (CYP9M9) and CYP4 (CYP4H28) families and two UGTs (AAEL002688 and 330 AAEL001816) were found over-transcribed in association with imidacloprid resistance. 331 332 Among them the three P450 genes CYP6BB2, CYP9M9 and CYP4H28 showed the highest transcription ratios in the resistant line Imida-R (3.2-fold, 2.96-fold and 2.89-fold respectively) 333 and lower transcription ratios in the Imida-S line obtained by releasing the selection pressure. 334 335 Other differentially transcribed genes belong to various functional categories that were not 336 enriched nor commonly associated with known insecticide resistance mechanisms (Fig. 4B).

#### 339 3.5 Polymorphisms associated with imidacloprid resistance

Targeted DNA-seq identified a total of 34,858 variations called against the reference genome 340 341 with 24,252 (69%) being polymorphic between lines. Among them, 421 (1.2%) were 342 associated with resistance to imidacloprid (Diff SNPs) with 64 (0.18%) affecting the protein 343 sequence of 31 annotated genes (NS Diff SNPs). RNA-seq allowed the calling of 130,672 344 variations against the reference genome with 64,172 (49%) being polymorphic between lines. Among them, 906 (0.69%) were associated with resistance to imidacloprid (Diff SNPs) 345 with 120 (0.09%) affecting the protein sequence of 151 annotated genes (NS Diff SNPs). 346 Functional enrichment analysis (from global RNA-seq polymorphism data) identified a 2-fold 347 348 significant enrichment of Diff SNP affecting P450 genes (Fig. 5A). Such enrichment reached 5-fold when only considering Diff NS SNPs. A significant 2.5-fold enrichment of NS Diff SNP 349 350 was also observed for other enzymes families not likely involved in detoxification processes.

A focus on detoxification enzymes revealed 27 NS Diff SNPs affecting 18 distinct detoxification genes (Fig. 5B). These genes included twelve P450s mainly of the CYP4 and CYP9 families, two CCEs, one UGTs, one ABC transporters, one sulfotransferase and one oxidase/peroxidase. The NADPH P450 reductase AAEL025363 was also affected by one NS Diff SNP. Among all NS Diff SNPs affecting detoxification enzymes two were located in the putative substrate recognition sites (SRS) of the P450s CYP6AH1 and CYP9J15.

# 358 3.6 Genomic variations associated with the over-transcription of detoxification genes associated with imidacloprid resistance

360

361 Copy number variation (CNV) analysis inferred from pool targeted DNA-seq did not 362 evidence any CNV associated with the over-transcription of detoxification genes associated 363 with imidacloprid resistance (data not shown). The mapping of targeted DNA-seq reads to 364 promoter regions allowed identifying 56 Diff SNPs upstream detoxification genes but none of

them were affecting genes over-transcribed in association with resistance. Testing for 365 366 positive correlations between the transcription levels of the seven detoxification genes associated with resistance and the allele frequency of their promoter variations across all 367 368 lines identified two variations significantly correlated with the over-transcription of the P450 369 CYP6BB2 (r > 0.98 and p<0.05). In silico analysis of CYP6BB2 promoter sequence suggested that these two variations are potentially enhancing the binding of transcription 370 factors previously identified as transcriptional enhancers of detoxification genes (Fig. 6). The 371 G>T at position -69 (respective to ATG) enhances the binding of the Adf-1 factor while the 372 A>G at position -104 enhances the binding of the COE-1, Nkx2-1 and C/EBP $\alpha/\beta$  elements. 373

#### 375 4. Discussion

376 In the context of the widespread resistance of mosquitoes to most chemical insecticides used in public health, the particular mode of action of neonicotinoids have 377 suggested their use as a possible alternative to current insecticides (Paul et al. 2006; 378 Pridgeon et al. 2008; Tiawsirisup et al. 2007). Imidacloprid and other neonicotinoids alone or 379 in mixture with deltamethrin have demonstrated their efficiency against mosquitoes including 380 those resisting pyrethroids (Corbel et al. 2004; Darriet and Chandre 2013; Uragayala et al. 381 2015). However, a previous study suggested that P450-mediated resistance to imidacloprid 382 383 can be selected from standing genetic variation after only few generations of selection at the larval stage in Ae. aegypti (Riaz et al. 2013). Because no other neonicotinoid-resistant 384 mosquito strain has been described yet, the present study aims at complementing the data 385 obtained by Riaz et al. (2013) and David et al. (2014) by studying the same Ae. aegypti 386 387 selected line but with up to twenty more generations of imidacloprid selection in order to 388 strengthen the resistance phenotype. An additional line was also created by releasing the 389 selection pressure in order to investigate fitness costs associated with resistance and

improve the detection power of resistance allele through an integrated approach combiningRNA-seq and DNA-seq targeting more than 750 candidate genes.

392 Larval bioassays confirmed the further increased larval resistance of the Imida-R line to imidacloprid as compared to Riaz et (2013) although a saturation of RR<sub>50</sub> around 8-fold 393 was observed after 25 generations of selection. Considering the full susceptibility of the 394 395 parental strain Bora-Bora, the saturation of RR<sub>50</sub> may reflect the progressive enrichment of low-effect resistance alleles and their association through recombination in the Imida-R line 396 and/or the expression of fitness costs associated with resistance (McKenzie and Batterham 397 1994). Relaxing insecticide selection pressure from  $G_{11}$  led to the progressive decrease of 398 399 resistance in the Imida-S line confirming that resistance alleles where not fixed at G11 and are associated with significant fitness costs (Chown and Gaston 1999; Harak et al. 1999; 400 401 Hostetler et al. 1994). Insecticide resistance has frequently been associated with fitness costs often compensated by an increased energetic metabolism. If such compensation does 402 403 not take place, the energy reallocation for expressing the resistance phenotype may impair 404 fundamental physiological processes such as development and reproduction (Chown and 405 Gaston 1999; Harak et al. 1999; Hostetler et al. 1994). Indeed, in the Imida-R line, the time to 406 emergence increased by nearly 3 days in females as compared to the susceptible parental 407 line. This phenomenon was no longer observed in the Imida-S line supporting the association 408 of this trait with resistance. These findings agree with previous studies reporting an increased larval development time in insecticide resistant Ae. aegypti populations (Diniz et al. 2015; 409 Paris et al. 2011). The sex-dependency of this trait observed might be explained by the 410 411 higher need for females to accumulate resources for the adult stage (Tabbabi and Daaboub 412 2018). Variation in larval development time is the primary cause of variation of generation time in natural mosquito populations (Moeur and Istock 1980). The duration between 413 hatching to adult reproduction is a crucial component of fitness in expanding populations 414 415 (Charlesworth 1980). In resistant insects, resistance cost is frequently associated with an increased activity of enzymes involved in cellular catabolism (Araujo et al. 2008). Although 416

such compensation response was observed from gene expression data in the Imida-R line
after 10 generations of selection (Riaz et al. 2013), it was less apparent after 30 generations
of selection suggesting its progressive replacement by less costly mechanisms. However,
the increased development time observed might also be associated with an alteration of
hormone homeostasis as P450s such as *CYP18A1* and *CYP305A5* likely associated with
steroidogenesis in *Ae. aegypti* were both affected by non-synonymous variations in the
Imida-R resistant line (Margam et al. 2006; Prud'homme et al. 2018).

Our RNA-seq approach identified several genes encoding detoxification enzymes 424 belonging to the P450 and UGT families being over-transcribed in association with 425 426 imidacloprid resistance. Such an increase in detoxification enzyme transcription levels was previously associated with increased P450 activities in Imida-R larvae and a higher P450-427 428 dependent imidacloprid metabolism suggesting that, as in other insects, P450s play a key role in imidacloprid resistance (Riaz et al., 2013). Among the four P450s identified, CYP6BB2 429 430 and CYP9M9 were previously found over-transcribed in the Imida-R line at G<sub>11</sub> (David et al. 431 2014; Riaz et al. 2013), supporting their potential role in imidacloprid resistance. CYP9M9 432 was also shown to be induced in larvae following exposure to imidacloprid (David et al. 2010) 433 and over-transcribed in some pyrethroid-resistant populations (Smith et al. 2016). The high homology of CYP6BB2 substrate binding site with *Bemisia tabaci* CYP6CM1vQ known to 434 435 metabolize imidacloprid also supports its role in imidacloprid resistance (Karunker et al. 2009). CYP6BB2 over-transcription through up-regulation and/or gene duplication has also 436 been frequently associated with pyrethroid resistance (Cattel et al. 2020a; Faucon et al. 437 438 2015; Faucon et al. 2017; Moyes et al. 2017; Smith et al. 2016) and this P450 has been shown capable of metabolizing permethrin (Kasai et al. 2014). Although the ability of 439 CYP6M11 to metabolize insecticides remains to be demonstrated, this gene was shown to 440 be induced by several xenobiotics including the insecticide permethrin (Poupardin et al. 441 2010) and was also frequently associated with pyrethroid resistance in Ae. Aegypti (Dusfour 442 et al. 2015; Goindin et al. 2017; Marcombe et al. 2012; Marcombe et al. 2009; Moyes et al. 443

2017). Altogether, these data support the capability of these P450s to confer resistance to 444 445 various insecticides and their role in the cross-resistance of the Imida-R line to pyrethroids at the larval stage. In this regard, the absence of constitutive cross-resistance to pyrethroids 446 447 observed in adults may be explained by the lower expression of some of these genes such as CYP9M9 in adult females (Poupardin et al. 2010). Such stage-dependent resistance 448 phenotype was also observed for imidacloprid in the Imida-R line by Riaz et al. (2009). Then, 449 the significant cross-resistance phenotype observed in adult females obtained from larvae 450 451 surviving imidacloprid suggest that the lower constitutive cross-resistance of adults may be compensated by P450 induction following insecticide exposure as shown for both CYP6M11 452 and CYP9M9 (Poupardin et al 2010). 453

Over-transcription can be caused by gene Copy Number Variation (CNV) or 454 455 transcriptional regulation. In mosquitoes, copy number variations (CNV) has been highlighted as a frequent mechanism leading to the over-expression of detoxification enzymes in 456 457 response to insecticide selection (Cattel et al. 2020b; Faucon et al. 2015; Faucon et al. 2017; Lucas et al. 2019; Weetman et al. 2018). By combining controlled crosses with targeted 458 459 DNA-seq, (Cattel et al. 2020a) identified multiple P450s affected by CNV in association with 460 insecticide resistance in a multi-resistant population from French Guiana. Among them, a duplication of a CYP6 gene cluster including CYP6BB2 was associated with pyrethroids 461 resistance. In the present study, no CNV affecting CYP6BB2 or any other detoxification gene 462 was detected in association with resistance as a probable consequence of an absence of the 463 duplicated resistance alleles in the parental line. Such absence of CNV suggests that the up 464 465 regulation of detoxification genes can be rapidly selected by insecticides from standing genetic variation and that CNV may act as an additive adaptive mechanism further 466 enhancing gene expression. Indeed, though the over-expression of CYP6BB2 has been 467 associated with a gene duplication in the South American region, this gene was also found 468 over-expressed solely due to up regulation in a resistant line from Singapore (Kasai et al. 469 2014; Smith et al. 2018). Although mutations affecting promoters are frequently linked to up 470

471 regulation of P450 in insecticide-resistant populations, transcription factors involved have rarely been identified (Feyereisen et al. 2015; Ingham et al. 2017). Here, we identified two 472 473 substitutions showing an allele frequency correlated with the transcription level of CYP6BB2 474 and likely enhancing the binding of transcription factors previously associated with P450 upregulation. Among them, C/EBPs and Nkx2-1 were shown to induce the over-transcription of 475 P450s in mammals (Kolla et al. 2007; Martinez-Jimenez et al. 2005). In addition, C/EBP-like 476 transcription factors have been found upregulated in DDT-resistant anopheles populations 477 478 (Kolla et al. 2007; Martinez-Jimenez et al. 2005) suggesting their involvement in insecticide resistance in mosquitoes. Recently, Smith et al. (2018) demonstrated the role of trans-479 regulation in the overexpression of several P450s including CYP6BB2. Undoubtedly, 480 characterizing the resistance spectrum and the variety of genetic events leading to the over-481 482 expression of mosquito P450s playing a key role in insecticide resistance such as CYP6BB2 is of high interest for resistance monitoring and management. 483

484 Though genes encoding the nicotinic acetylcholine receptors (nAChR) targeted by 485 imidacloprid were included in the genes targeted by DNA-seq, no non-synonymous mutation 486 affecting these genes were found associated with imidacloprid resistance. Indeed, no targetsite mutation affecting the nAChR has been described yet in mosquitoes (Bass et al. 2015). 487 Even if such mutation exists in Ae. aegypti natural populations, its absence in the susceptible 488 parental line would have precluded its selection in the present study. In turn, multiple 489 detoxification enzymes were affected by non-synonymous mutations associated with 490 resistance including several P450s and their redox partner the NADPH P450 reductase. 491 492 Although most of these variations are probably not functionally associated with resistance and may have been enriched by genetic drift, this may also reflect the strong selection 493 pressure undertaken by genes involved in P450-mediated metabolism during selection with 494 imidacloprid. Indeed, particular detoxification enzyme variants may be associated with an 495 496 increased metabolic activity against imidacloprid. Such a variation affecting GSTE2 and conferring an increased DDT metabolism has been identified in An. funestus and is under 497

498 strong selection pressure in Africa (Riveron et al. 2014). Similarly, variants of the esterase 499 αE7 from Lucilia cuprina have been associated with increased activity toward organophosphates and deltamethrin (Coppin et al. 2012; Devonshire et al. 2007; Heidari et 500 501 al. 2005; Newcomb et al. 1997). In our study, the P450 CYP9M9 whose over-transcription 502 was associated with imidacloprid resistance was also affected by two non-synonymous variations associated with resistance. In addition, one cluster of CYP genes including 503 CYP6AH1, CYP4J14, CYP4J15 and CYP4J16 located at ~ 58 Mb on chromosome 2 504 505 appeared particularly affected by imidacloprid selection with 10 NS Diff SNP associated with resistance. Among them, two variations affecting CYP6AH1 and CYP4J15 were located 506 within the SRS of P450s and may affect the metabolism of insecticides (Feyereisen 2005). 507 Interestingly the M362I point mutation affecting CYP6AH1 previously associated with 508 509 resistance at G<sub>10</sub> (David et al., 2014) was also associated with resistance at G<sub>30</sub>. Whether these particular mutations have arisen due to drift effects, are highlighting the selection 510 511 imprint affecting these P450s, or are involved in insecticide metabolism requires additional work. Nevertheless, the strong enrichment of P450s within the genes affected by non-512 513 synonymous variations supports the selection of P450 variants involved in acute insecticide 514 degradation in the early steps of the selection process (Faucon et al. 2015; Faucon et al. 2017; Kasai et al. 2014; Smith et al. 2018). 515

516 The use of the same insecticides families for decades have led to the emergence and spread of insecticide resistance in mosquitoes, often reducing the efficacy of vector control. 517 One resistance management strategy consists in the introduction of novel active ingredients 518 519 having a different mode of action and therefore being not likely affected by existing resistance mechanisms. Among insecticides having been proposed for controlling pyrethroid 520 resistance, neonicotinoids were suggested to be of high interest (Darriet and Chandre 2013) 521 since they target nicotinic acetylcholine receptors (nAChR) which constitute a novel target for 522 vector control (Agossa et al. 2018). Though nAchR mutations conferring neonicotinoid 523 resistance have not been identified in mosquitoes, this does not mean that they are not 524

525 present at low frequency in particular mosquito populations such as those regularly exposed 526 to neonicotinoids used in agriculture. In addition, our study demonstrates that metabolic resistance alleles, likely including P450s, can be rapidly selected upon selection with 527 528 neonicotinoids and that some of them likely also confer resistance to pyrethroids. Such a P450-mediated cross-resistance between neonicotinoids and pyrethroids has frequently 529 been reported in agricultural pests (Bass et al. 2015; Le Goff et al. 2003; Ma et al. 2019; Wei 530 et al. 2017) and clearly raises concerns about the use of neonicotinoids alone for managing 531 532 pyrethroid resistance in mosquitoes. Such hypothesis is supported by recent studies pointing out the presence of neonicotinoid resistance alleles in Anopheles populations located in 533 intensive agriculture areas (Fouet et al. 2020; Mouhamadou et al. 2019). In this perspective, 534 using neonicotinoids in combination with other insecticides to target mosquitoes should be 535 536 envisaged, especially in areas where metabolic resistance alleles to pyrethroids are 537 circulating.

#### 539 **5. Conclusion**

The present study confirms that metabolic resistance alleles can be selected from 540 standing genetic variation after a few generations of selection with imidacloprid in the 541 mosquito Ae. Aegypti. As in other insects, P450-mediated insecticide metabolism appears to 542 543 play a key role in neonicotinoid resistance in mosquitoes and can led to cross-resistance with pyrethroids. Though further work is required to fully validate the functional role of the P450s 544 identified, their previous involvement in insecticide resistance and their homology with known 545 neonicotinoid-metabolizing P450s identified in other insects support their role in 546 547 neonicotinoid resistance. Whether these P450s will be selected by neonicotinoids in the field 548 cannot be fully ruled out yet, though they represent a good value for studying neonicotinoid 549 resistance in agricultural areas and monitoring resistance dynamics following the implementation of neonicotinoids for vector control. 550
