# EXISTENCE OF SOLUTIONS FOR A SYSTEM INVOLVING THE (2,Q)-LAPLACIAN OPERATOR IN A BOUNDED DOMAIN 

LAURE CARDOULIS*


#### Abstract

In this paper we study the existence of a non trivial weak solution for a system involving the Laplacian operator and the q-Laplacian operator in a bounded domain $\Omega$ of $\mathbb{R}^{N}$ with sufficiently smooth boundary.


## 1. Introduction

We consider in this paper the following system for $i=1, \cdots, m$,

-\Delta u_{i}-\Delta_{q} u_{i}+w_{i}\left|u_{i}\right|^{q-2} u_{i}+\sum_{j=1}^{m} a_{i j} u_{j}=g_{i}\left(., u_{1}, \cdots, u_{m}\right) \text { in } \Omega, \quad(S, q, g) \\
u_{i}=0 \text { on } \partial \Omega .
\end{array}\right.
$$

where $\Omega$ is a bounded domain with sufficiently smooth boudary, $\Omega \subset \mathbb{R}^{N}$.
We recall that the q -Laplacian operator is defined by $\Delta_{q} \phi=\operatorname{div}\left(|\nabla \phi|^{q-2} \nabla \phi\right)$ and we suppose $q>2$ in the whole paper. We study the existence of a weak non-trivial solution $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ for the system $(S, q, g)$ where the variational space is $W=\left(W_{0}^{1, q}(\Omega)\right)^{m}, W_{0}^{1, q}(\Omega)$ being the usual Sobolev space endowed with the norm $\|\phi\|_{0}^{1, q}(\Omega)=\left(\int_{\Omega}|\nabla \phi|^{q}\right)^{1 / q}$. We also denote $H=\left(W_{0}^{1,2}(\Omega)\right)^{m}$ and $\|\cdot\|_{W},\|\cdot\|_{H}$, the norms on $W$ and $H\left(\|u\|_{W}=\left(\sum_{i=1}^{m}\left\|u_{i}\right\|_{W_{0}^{1, q}(\Omega)}^{q}\right)^{1 / q}\right)$.

We assume throughout all the paper that the bounded functions $a_{i j}, w_{i}$ (for $i, j=1, \cdots, m)$ satisfy the following hypothesis
Assumption 1.1. i): $a_{i j}, w_{i} \in L^{\infty}(\Omega), a_{i i} \geq 0, w_{i} \geq 0$ a. e. on $\Omega$.
ii): The matrix $A=\left(a_{i j}\right)$ is symmetric and satisfies ${ }^{t} \xi A \xi \geq 0$ for all ${ }^{t} \xi=$ $\left(\xi_{1}, \cdots, \xi_{m}\right) \in \mathbb{R}^{m}$.

Note that the above Assumption 1.1ii) is satisfied when the matrix $A$ is a positive definite one. Introduce now the following functionals for $u=\left(u_{1}, \cdots, u_{m}\right) \in W$

\end{equation*}

and

\begin{equation*}
H_{2}(u)=\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{q}+w_{i}\left|u_{i}\right|^{q}\right) . \tag{1.2}
\end{equation*}
$$

Since $A$ is symmetric then $H_{1}(u)=\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{2}+a_{i i} u_{i}^{2}+2 \sum_{j=1, i<j}^{m} a_{i j} u_{j} u_{i}\right)$. Note that $\left(H_{1}(u)\right)^{1 / 2}$ and $\left(H_{2}(u)\right)^{1 / q}$ define norms on $H$ and $W$ equivalent to the norms $\|\cdot\|_{H}$ and $\|\cdot\|_{W}$ respectively.

Key words and phrases. (2,q)-Laplacian operator, system, existence of solutions.

We consider different cases for the functions $g_{i}$ : in the second section we deal with $g_{i}\left(., u_{1}, \cdots, u_{m}\right):=h_{i} \in W^{-1, q^{\prime}}(\Omega)$ the dual space of $W_{0}^{1, q}(\Omega)$ with $\frac{1}{q}+\frac{1}{q^{\prime}}=1$. In the third section, we define $g_{i}\left(., u_{1}, \cdots, u_{m}\right):=m_{i}\left|u_{i}\right|^{q-2} u_{i}$ where the functions $m_{i}$ are bounded and indefinite. In the fourth section we consider the case $g_{i}\left(., u_{1}, \cdots, u_{m}\right):=\lambda f_{i}\left|u_{i}\right|^{\gamma-2} u_{i}$ where the functions $f_{i}$ are still bounded and undefinite, $\lambda$ is a positive real parameter and the coefficient $\gamma$ satisfies some hypotheses in which $\gamma<q$.

In each of the precedent cases, the system $(S, q, g)$ will be rewritten under a variational form with $I(u)$ an adapted Euler functional defined in $W$ and the existence of weak solutions for the system $(S, q, g)$ will be equivalent to the existence of critical points for this functional $I$. In the second and third sections, we will mimimize the Euler functional $I$ using either standard arguments (cf. Theorem I.1.2 in [18]) or the Moutain-Pass Theorem. In the third section, we will use the principal eigenvalue $\lambda_{1, q, \rho}$ of the q-Laplacian operator associated with a weight $\rho$ whereas in the fourth section we will define a characteristic value $\lambda_{1}^{+}$(see (4.7)).

Equations and systems with the p-Laplacian have been widely studied for the existence of solutions or the maximum and antimaximum principles (see for examples $[3,9,10,11,12,13]$, see also [14] for the fibering procedure). These last few years, equations with the ( $\mathrm{p}, \mathrm{q}$ )-Laplacian have been studied (see for examples $[4,6,15,19,21]$ in a bounded domain and $[5]$ in $\left.\mathbb{R}^{N}\right)$. Authors study the existence of solutions (sometimes the sign of these solutions and generalized eigenvalue problems) mainly by minimization of the energy functional either by standard arguments or the mountain-pass geometry, also by using the method of sub- and super-solutions. The case of the ( $2, \mathrm{q}$ )-Laplacian arises in quantum physics (see [2]). A few systems with two equations have been studied (see for example [16] for a system with two equations, one with the p-Laplacian and the other one with the q-Laplacian ; see also [20] for a system of two equations with the (p,q)-Laplacian with critical nonlinearities) but as far as we know, there is no system with $m$ equations for the (2,q)-Laplacian studied yet.

This paper is organised as follows: in section 2, we use standard arguments for minimizing the functional $I$ when we consider the case where $g_{i}\left(., u_{1}, \cdots, u_{m}\right):=$ $h_{i} \in W^{-1, q^{\prime}}(\Omega)$. In section 3 (in the case of $g_{i}\left(., u_{1}, \cdots, u_{m}\right):=m_{i}\left|u_{i}\right|^{q-2} u_{i}$ and $q<2^{*}$ where $2^{*}=\frac{2 N}{N-2}$ if $N>2$ and $2^{*}=\infty$ if $N \leq 2$ ), first we recall some results of the existence of the principal eigenvalue for the q-Laplacian operator associated with a bounded weight (and the existence of a positive eigenfunction associated with). Then we use the Mountain-Pass Theorem in order to get the existence of a non-trivial solution for our system. Finally in section 4 (when $g_{i}\left(., u_{1}, \cdots, u_{m}\right):=$ $\lambda f_{i}\left|u_{i}\right|^{\gamma-2} u_{i}$ with $2<\gamma<q$ and $\gamma<2^{*}$ where $2^{*}=\frac{2 N}{N-2}$ if $N>2$ and $2^{*}=\infty$ if $N \leq 2$ ), first we follow a method introduced by Cherfils-Il'Yasov in [7] for one equation involving the (p-q)-Laplacian operator to define a characteristic value $\lambda_{1}^{+}$. Then we get the existence of a non-trivial solution by means of global minimization of the Euler functional.

\text { 2. FIRST CASE: } g_{i}\left(., u_{1}, \cdots, u_{m}\right):=h_{i} \in W^{-1, q^{\prime}}(\Omega)
$$

In this case the system $(S, q, g)$ is rewritten under the following form

-\Delta u_{i}-\Delta_{q} u_{i}+w_{i}\left|u_{i}\right|^{q-2} u_{i}+\sum_{j=1}^{m} a_{i j} u_{j}=h_{i} \text { in } \Omega  \tag{2.1}\\
u_{i}=0 \text { on } \partial \Omega
\end{array}\right.
$$

with $h_{i} \in W^{-1, q^{\prime}}(\Omega)$ for each $i=1, \cdots, m$. Recall that $-\Delta_{q}$ may be seen acting from $W_{0}^{1, q}(\Omega)$ into $W^{-1, q^{\prime}}(\Omega)$ with $\frac{1}{q}+\frac{1}{q^{\prime}}=1$ by

<-\Delta_{q} \phi, \psi>_{q^{\prime}, q}=\int_{\Omega}|\nabla \phi|^{q-2} \nabla \phi \cdot \nabla \psi \text { for all } \phi, \psi \in W_{0}^{1, q}(\Omega)
$$

(see $[8,17]$ ) where $<., .>_{q^{\prime}, q}$ denotes the duality mapping between $W^{-1, q^{\prime}}(\Omega)$ and $W_{0}^{1, q}(\Omega)$. Therefore the Euler functional is, for $u=\left(u_{1}, \cdots, u_{m}\right) \in W$,

I(u)=\frac{1}{2} H_{1}(u)+\frac{1}{q} H_{2}(u)-\sum_{i=1}^{m}<h_{i}, u_{i}>_{q^{\prime}, q} . \tag{2.2}
\end{equation*}
$$

The result of the existence of solution for the system (2.1) is the following.
Theorem 2.1. Assume that Assumption 1.1 is satisfied and that $h_{i} \in W^{-1, q^{\prime}}(\Omega)$ for each $i=1, \cdots, m$. Then the system (2.1) has a unique solution.

Proof. The functional $I: W \rightarrow \mathbb{R}$ defined by (2.2) is weakly lower semi-continuous by the compactness of the embedding of $W$ to $\left(L^{q}(\Omega)\right)^{m}$ and $\left(L^{2}(\Omega)\right)^{m}$ and of class $C^{1}$ on $W$. Moreover this functional $I$ is also coercive. Indeed by the Young's inequality we have

\left|<h_{i}, u_{i}>_{q^{\prime}, q}\right| \leq\left\|h_{i}\right\|_{W^{-1, q^{\prime}}(\Omega)}\left\|u_{i}\right\|_{W_{0}^{1, q}(\Omega)} \leq \frac{1}{2 q}\left\|u_{i}\right\|_{W_{0}^{1, q}(\Omega)}^{q}+C\left\|h_{i}\right\|_{W^{-1, q^{\prime}}(\Omega)}^{q^{\prime}}
$$

with $C>0, C$ independent of $u$. And since $H_{1}(u) \geq 0$ and $H_{2}(u) \geq\|u\|_{W}$ we get that

$$
I(u) \geq \frac{1}{2 q}\|u\|_{W}-C \sum_{i=1}^{m}\left\|h_{i}\right\|_{W^{-1, q^{\prime}}(\Omega)}^{q^{\prime}}
$$

Therefore the functional $I$ has a gobal minimizer (cf.[18, Theorem I.1.2]) and the system (2.1) has a solution.
Let us prove now the uniqueness of the solution. Suppose on the contrary that there exist two distinct solutions $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ and $v=\left(v_{1}, \cdots, v_{m}\right) \in W$ for (2.1), so there exists $k$ such that $u_{k} \neq v_{k}$. Since

\left(I^{\prime}(u)-I^{\prime}(v)\right) \cdot(u-v)=I^{\prime}(u) \cdot u-I^{\prime}(v) \cdot u-I^{\prime}(u) \cdot v+I^{\prime}(v) \cdot v=0
$$

we have

\sum_{i=1}^{m} \int_{\Omega}\left|\nabla u_{i}\right|^{2}+\sum_{i, j=1}^{m} \int_{\Omega} a_{i j} u_{j} u_{i}+\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{q}+w_{i}\left|u_{i}\right|^{q}\right) \\
-\sum_{i=1}^{m} \int_{\Omega} \nabla v_{i} \cdot \nabla u_{i}-\sum_{i, j=1}^{m} \int_{\Omega} a_{i j} v_{j} u_{i}-\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla v_{i}\right|^{q-2} \nabla v_{i} \cdot \nabla u_{i}+w_{i}\left|v_{i}\right|^{q-2} v_{i} u_{i}\right) \\
-\sum_{i=1}^{m} \int_{\Omega} \nabla u_{i} \cdot \nabla v_{i}-\sum_{i, j=1}^{m} \int_{\Omega} a_{i j} u_{j} v_{i}-\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{q-2} \nabla u_{i} \cdot \nabla v_{i}+w_{i}\left|u_{i}\right|^{q-2} u_{i} v_{i}\right)
\end{gathered}
$$

$$
+\sum_{i=1}^{m} \int_{\Omega}\left|\nabla v_{i}\right|^{2}+\sum_{i, j=1}^{m} \int_{\Omega} a_{i j} v_{j} v_{i}+\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla v_{i}\right|^{q}+w_{i}\left|v_{i}\right|^{q}\right)=0
$$

So we get

$$
\begin{aligned}
& \sum_{i=1}^{m} \int_{\Omega} \nabla u_{i} \cdot\left(\nabla u_{i}-\nabla v_{i}\right)+\sum_{i, j=1}^{m} \int_{\Omega} a_{i j} u_{j}\left(u_{i}-v_{i}\right)+\sum_{i=1}^{m} \int_{\Omega}\left|\nabla u_{i}\right|^{q-2} \nabla u_{i} \cdot\left(\nabla u_{i}-\nabla v_{i}\right) \\
& +\sum_{i=1}^{m} \int_{\Omega} w_{i}\left|u_{i}\right|^{q-2} u_{i}\left(u_{i}-v_{i}\right)-\sum_{i=1}^{m} \int_{\Omega} \nabla v_{i} \cdot\left(\nabla u_{i}-\nabla v_{i}\right)-\sum_{i, j=1}^{m} \int_{\Omega} a_{i j} v_{j}\left(u_{i}-v_{i}\right) \\
& \quad-\sum_{i=1}^{m} \int_{\Omega}\left|\nabla v_{i}\right|^{q-2} \nabla v_{i} \cdot\left(\nabla u_{i}-\nabla v_{i}\right)-\sum_{i=1}^{m} \int_{\Omega} w_{i}\left|v_{i}\right|^{q-2} v_{i}\left(u_{i}-v_{i}\right)=0
\end{aligned}
$$

Thus

& \sum_{i=1}^{m} \int_{\Omega}\left|\nabla u_{i}-\nabla v_{i}\right|^{2}+\sum_{i=1}^{m} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{q-2} \nabla u_{i}-\left|\nabla v_{i}\right|^{q-2} \nabla v_{i}\right) \cdot\left(\nabla u_{i}-\nabla v_{i}\right) \\
+ & \sum_{i, j=1}^{m} \int_{\Omega} a_{i j}\left(u_{j}-v_{j}\right)\left(u_{i}-v_{i}\right)+\sum_{i=1}^{m} \int_{\Omega} w_{i}\left(\left|u_{i}\right|^{q-2} u_{i}-\left|v_{i}\right|^{q-2} v_{i}\right)\left(u_{i}-v_{i}\right)=0 .
\end{aligned}
$$

The last equality can be rewritten under the following form with the duality product

\sum_{i=1}^{m}<-\Delta u_{i}+\Delta v_{i}, u_{i}-v_{i}>_{2,2}+\sum_{i=1}^{m}<-\Delta_{q} u_{i}+\Delta_{q} v_{i}, u_{i}-v_{i}>_{q^{\prime}, q} \\
+\sum_{i, j=1}^{m}<a_{i j}\left(u_{j}-v_{j}\right), u_{i}-v_{i}>_{2,2}+\sum_{i=1}^{m}<w_{i}\left(\left|u_{i}\right|^{q-2} u_{i}-\left|v_{i}\right|^{q-2} v_{i}\right), u_{i}-v_{i}>_{q^{\prime}, q}=0 .
\end{gathered}
$$

Moreover a consequence of the strict convexity of the spaces $W_{0}^{1,2}(\Omega)$ and $W_{0}^{1, q}(\Omega)$ is that the duality mappings $-\Delta$ and $-\Delta_{q}$ are strictly monotone. So from $u_{k} \neq v_{k}$ we get

<-\Delta u_{k}+\Delta v_{k}, u_{k}-v_{k}>_{2,2}>0
$$

and
$<-\Delta_{q} u_{k}+\Delta_{q} v_{k}, u_{k}-v_{k}>_{q^{\prime}, q} \geq\left(\left\|u_{k}\right\|_{W_{0}^{1, q}(\Omega)}^{q-1}-\left\|v_{k}\right\|_{W_{0}^{1, q}(\Omega)}^{q-1}\right)\left(\left\|u_{k}\right\|_{W_{0}^{1, q}(\Omega)}-\left\|v_{k}\right\|_{W_{0}^{1, q}(\Omega)}\right) \geq 0$ since $x \mapsto x^{q-1}$ is increasing on $[0, \infty)$ (and even $<-\Delta_{q} u_{k}+\Delta_{q} v_{k}, u_{k}-v_{k}>_{q^{\prime}, q}>0$ from [8, Proposition 1]).
Thus

$$
\sum_{i=1}^{m}<-\Delta u_{i}+\Delta v_{i}, u_{i}-v_{i}>_{2,2}+\sum_{i=1}^{m}<-\Delta_{q} u_{i}+\Delta_{q} v_{i}, u_{i}-v_{i}>_{q^{\prime}, q}>0
$$

Furthermore, since the function $x \mapsto|x|^{q-2} x$ is increasing and $w_{i} \geq 0$, we have

\sum_{i=1}^{m}<w_{i}\left(\left|u_{i}\right|^{q-2} u_{i}-\left|v_{i}\right|^{q-2} v_{i}\right), u_{i}-v_{i}>_{q^{\prime}, q} \geq 0
$$

Finally from Assumption 1.1,

\sum_{i, j=1}^{m}<a_{i j}\left(u_{j}-v_{j}\right), u_{i}-v_{i}>_{2,2} \geq 0
$$

Therefore we get a contradiction.

Remark: We can generalize Theorem 2.1 replacing the 2-Laplacian operator by the p-Laplacian with $2<p<q$, that for the following system

u_{i}=0 \text { on } \partial \Omega,
\end{array}\right.
$$

and even for

-\Delta_{p} u_{i}-\Delta_{q} u_{i}+b_{i}\left|u_{i}\right|^{p-2} u_{i}+w_{i}\left|u_{i}\right|^{q-2} u_{i}+\sum_{j=1}^{m} a_{i j} u_{j}=h_{i} \text { in } \Omega \\
u_{i}=0 \text { on } \partial \Omega
\end{array}\right.
$$

under the additional hypothesis that the bounded functions $b_{i}, i=1, \cdots, m$ are non-negative.

\text { 3. SECOND CASE: } g_{i}\left(., u_{1}, \cdots, u_{m}\right):=m_{i}\left|u_{i}\right|^{q-2} u_{i}
$$

In this section we assume that
Assumption 3.1. $q<2^{*}$ where $2^{*}=\frac{2 N}{N-2}$ if $N>2$ and $2^{*}=\infty$ if $N \leq 2$,
and we rewrite the system $(S, q, g)$ under the following form:
for $i=1, \cdots, m$,

$$
\left\{\begin{array}{l}
-\Delta u_{i}-\Delta_{q} u_{i}+w_{i}\left|u_{i}\right|^{q-2} u_{i}+\sum_{j=1}^{m} a_{i j} u_{j}=m_{i}\left|u_{i}\right|^{q-2} u_{i} \text { in } \Omega  \tag{3.1}\\
u_{i}=0 \text { on } \partial \Omega
\end{array}\right.
$$

Note that the decomposition with the weights $c_{i}:=m_{i}-w_{i}$ does not necessarily coincide with the decomposition $c_{i}=c_{i+}-c_{i-}$ where $c_{i+}=\max \left(c_{i}, 0\right)$ and $c_{i-}=$ $\max \left(-c_{i}, 0\right)$. Define now for $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ the functional

M(u)=\sum_{i=1}^{m} \int_{\Omega} m_{i}\left|u_{i}\right|^{q} . \tag{3.2}
\end{equation*}
$$

The Euler functional associated with (3.1) is consequently for $u=\left(u_{1}, \cdots, u_{m}\right) \in$ $W$,

I(u)=\frac{1}{2} H_{1}(u)+\frac{1}{q} H_{2}(u)-\frac{1}{q} M(u) . \tag{3.3}
\end{equation*}
$$

First let us recall the usual weighted eigenvalue problem for the q-Laplacian:

-\Delta_{q} u=\lambda \rho|u|^{q-2} u \text { in } \Omega,  \tag{3.4}\\
u=0 \text { on } \partial \Omega
\end{array}\right.
$$

with a bounded weight function $\rho$ and a real parameter $\lambda$. It is said that $\lambda$ is an eigenvalue of the q-Laplacian associated with the weight $\rho$ if (3.4) has a non-trivial solution $u$ which is called an eigenfunction associated with $\lambda$. It is well known (see [1]) that if the Lebesgue measure of $\{x \in \Omega, \rho(x)>0\}$ is positive, then the first positive eigenvalue $\lambda_{1, q, \rho}$ of $-\Delta_{q}$ with weight function $\rho$ is obtained by the Rayleight quotient

\lambda_{1, q, \rho}=\inf \left\{\frac{\int_{\Omega}|\nabla u|^{q}}{\int_{\Omega} \rho|u|^{q}} ; u \in W_{0}^{1, q}(\Omega), \int_{\Omega} \rho|u|^{q}>0\right\} . \tag{3.5}
\end{equation*}
$$

Moreover, $\lambda_{1, q, \rho}$ has a positive eigenfunction $\phi_{1, q, \rho} \in C_{0}^{1, \alpha_{q}}(\bar{\Omega})$ (for some $\alpha_{q} \in$ $(0,1))$. Assume in this section that
Assumption 3.2. i): For all $i=1, \cdots, m, m_{i} \in L^{\infty}(\Omega)$,
ii): For all $i=1, \cdots, m$, the real 1 is not an eigenvalue of the $q$-Laplacian with the weight $m_{i}-w_{i}$.

Assume also in this section that either Assumption 3.3 or Assumption 3.4 holds
Assumption 3.3. There exists $k \in\{1, \cdots, m\}$ such that:

Assumption 3.4. There exist $k, l \in\{1, \cdots, m\}, k \neq l$ such that:
$\operatorname{meas}\left\{x \in \Omega,\left(m_{k}-w_{k}\right)(x)>0\right\} \neq 0$ and $\lambda_{1, q, m_{k}-w_{k}}+\int_{\Omega}\left(w_{l}-m_{l}\right)\left|\phi_{1, q, m_{k}-w_{k}}\right|^{q}<0$ with $\phi_{1, q, m_{k}-w_{k}}$ the normalized eigenfunction associated with $\lambda_{1, q, m_{k}-w_{k}}$.

Note that Assumption 3.4 is satisfed when $\lambda_{1, q, m_{k}-w_{k}}\left(m_{k}-w_{k}\right)+w_{l}-m_{l}<0$ a. e. in $\Omega$. Our aim is to study the existence of a weak solution for the system (3.1) by minimizing the functional $I$ defined by (3.3). As in section 2 , the functional $I$ is weakly lower semi-continous on $W$ but may be no more coercive so we cannot use standard arguments for minimizing $I$. First, we prove that any Palais-Smale sequence is bounded in $W$ and has a strong convergent subsequence. Then we are able to apply the Mountain-Pass Lemma and Assumptions 3.3 or 3.4 allow us to get a non-trivial solution.

We say that $\left(u_{n}\right) \subset W, u_{n}=\left(u_{1 n}, \cdots, u_{m n}\right)$, is a Palais-Smale sequence if it satisfies the following conditions

with some constant $D>0, W^{*}$ being the dual space of $W$.
Lemma 3.1. Assume that Assumptions 1.1 and 3.2 are satisfied. If $\left(u_{n}\right) \subset W$, $u_{n}=\left(u_{1 n}, \cdots, u_{m n}\right)$, is a Palais-Smale sequence, then $\left(u_{n}\right)$ is bounded in $W$.

Proof. Let $\left(u_{n}\right) \subset W, u_{n}=\left(u_{1 n}, \cdots, u_{m n}\right)$, be a Palais-Smale sequence. We want to prove that $\left(\left\|u_{n}\right\|_{W}\right)_{n}$ is bounded or equivalently that $\left(H_{2}\left(u_{n}\right)\right)_{n}$ is bounded. But

with $C$ a positive constant, $C$ independent of $u_{n}$ (since the functions $m_{i}$ are bounded in the functional $M(u)$ defined by (3.2)). So it is sufficient to show that $\left(\left\|u_{n}\right\|_{\left.\left(L^{q}(\Omega)\right)^{m}\right)}\right.$ is bounded. We adapt ideas from [19]. Assume on the contrary that $\alpha_{n}:=\left\|u_{n}\right\|_{\left(L^{q}(\Omega)\right)^{m}} \rightarrow_{n \rightarrow \infty} \infty$ (for a subsequence) and denote $v_{n}=\frac{1}{\alpha_{n}} u_{n}=$ $\left(v_{1 n}, \cdots, v_{m n}\right)$. From (3.7), we deduce that $\left(\left\|v_{n}\right\|_{W}\right)$ is bounded and from the compact embedding of $W$ into $\left(L^{q}(\Omega)\right)^{m}$ we get the existence of $v_{0}=\left(v_{01}, \cdots, v_{0 m}\right) \in$ $W$ such that $\left(v_{n}\right)$ converges to $v_{0}$, strongly in $\left(L^{q}(\Omega)\right)^{m}$ and weakly in $W$ (for a subsequence).

- Now we prove that $\left(v_{n}\right)$ converges strongly to $v_{0}$ in $W$. Indeed by taking $\phi_{n}:=\frac{1}{\alpha_{n}^{q-1}}\left(v_{n}-v_{0}\right)$, we obtain

+\frac{1}{\alpha_{n}^{q-1}} \sum_{i, j ; i \neq j} \int_{\Omega} a_{i j} u_{j n}\left(v_{i n}-v_{0 i}\right)-\frac{1}{\alpha_{n}^{q-1}} \sum_{i=1}^{m} \int_{\Omega} m_{i}\left|u_{i n}\right|^{q-2} u_{i n}\left(v_{i n}-v_{0 i}\right) . \tag{3.8}

But $u_{n}=\alpha_{n} v_{n}$ so (3.8) becomes

+ & \frac{1}{\alpha_{n}^{q-2}} \sum_{i, j ; i \neq j} \int_{\Omega} a_{i j} v_{j n}\left(v_{i n}-v_{0 i}\right)-\sum_{i=1}^{m} \int_{\Omega} m_{i}\left|v_{i n}\right|^{q-2} v_{i n}\left(v_{i n}-v_{0 i}\right) . \tag{3.9}

Note that $\left|I^{\prime}\left(u_{n}\right) \cdot \phi_{n}\right| \leq\left\|I^{\prime}\left(u_{n}\right)\right\|_{W^{*}}\left\|\phi_{n}\right\|_{W}=\left\|I^{\prime}\left(u_{n}\right)\right\|_{W^{*}} \frac{1}{\alpha_{n}^{q-1}}\left\|v_{n}-v_{0}\right\|_{W}$ so $I^{\prime}\left(u_{n}\right) \cdot \phi_{n} \rightarrow_{n \rightarrow \infty} 0$ from (3.6), $\alpha_{n} \rightarrow_{n \rightarrow \infty} \infty$ and ( $\left\|v_{n}\right\|_{W}$ ) bounded. Moreover, since the functions $a_{i j}, w_{i}, m_{i}$ are bounded there exists a positive constant, denoting $C$ at each step, such that

\end{gathered}

\leq & \frac{1}{\alpha_{n}^{q-2}} \sum_{i=1}^{m}<-\Delta v_{i n}, v_{i n}-v_{0 i}>_{2,2}+\sum_{i=1}^{m}<-\Delta_{q} v_{i n}, v_{i n}-v_{0 i}>_{q^{\prime}, q} \\
& +\sum_{i=1}^{m}<\Delta_{q} v_{0 i}, v_{i n}-v_{0 i}>_{q^{\prime}, q}+\frac{1}{\alpha_{n}^{q-2}} \sum_{i=1}^{m}<\Delta v_{0 i}, v_{i n}-v_{0 i}>_{2,2}

Because the right-hand side of the above estimate tends to 0 as $n$ tends to infinity (from (3.12) and the weak convergence of $\left(v_{n}\right)$ to $v_{0}$ in $W$ ) we obtain that for $i=1, \cdots, m,\left\|v_{i n}\right\|_{W_{0}^{1, q}(\Omega)} \rightarrow\left\|v_{0 i}\right\|_{W_{0}^{1, q}(\Omega)}$ as $n \rightarrow \infty$ and therefore $\left(v_{n}\right)$ strongly converges to $v_{0}$ in $W$.

- Finally, we prove that $v_{0 i}$ is a non-trivial solution of the eigenvalue problem of the q-Laplacian with weight $m_{i}-w_{i}$ for at least one $i$.
Let $\phi=\left(\phi_{1}, \cdots, \phi_{m}\right) \in W$. Taking $\frac{1}{\alpha_{n}^{q-1}} \phi$ as a test function, since $u_{n}=\alpha_{n} v_{n}$, we have

Letting $n \rightarrow \infty$, we see that for each $i=1, \cdots, m, v_{0 i}$ is a weak solution to

Since $\left\|v_{n}\right\|_{\left(L^{q}(\Omega)\right)^{m}}=1$ and $\left(v_{n}\right)$ converges strongly to $v_{0}$ in $W$ we get that $\left\|v_{0}\right\|_{W} \geq$ 1. Therefore there exists $i$ such that $v_{0 i}$ is a non-trivial solution of (3.15). This contradicts Assumption 3.2.

Lemma 3.2. Assume that Assumptions 1.1 and 3.2 are satisfied. If $\left(u_{n}\right) \subset W$, $u_{n}=\left(u_{1 n}, \cdots, u_{m n}\right)$, is a Palais-Smale sequence, then $\left(u_{n}\right)$ has a strong convergent subsequence in $W$.

Proof. Let $\left(u_{n}\right)$ be a Palais-Smale sequence in $W, u_{n}=\left(u_{1 n}, \cdots, u_{m n}\right)$. By Lemma 3.1, the sequence $\left(u_{n}\right)$ is bounded in $W$. From the compact embedding of $W^{1, q}(\Omega)$ into $L^{q}(\Omega)$ we get the existence of $u_{0}=\left(u_{01}, \cdots, u_{0 m}\right) \in W$ such that $\left(u_{n}\right)$ converges to $u_{0}$ strongly in $\left(L^{q}(\Omega)\right)^{m}$ and weakly in $W$ (for a subsequence still denoted by $\left.\left(u_{n}\right)\right)$. We want to prove that $\left\|u_{n}\right\|_{W} \rightarrow\left\|u_{0}\right\|_{W}$ as $n \rightarrow \infty$ and we proceed as in the proof of Lemma 3.1.
Since $\left|I^{\prime}\left(u_{n}\right) \cdot\left(u_{n}-u_{0}\right)\right| \leq\left\|I^{\prime}\left(u_{n}\right)\right\|_{W^{*}}\left(\left\|u_{n}\right\|_{W}+\left\|u_{0}\right\|_{W}\right)$ we deduce that

As in Lemma 3.1, denoting $b_{i}$ either $w_{i}$ or $m_{i}$, we have for $i, j=1, \cdots, m$,

\leq & \sum_{i=1}^{m}<-\Delta u_{i n}, u_{i n}-u_{0 i}>_{2,2}+\sum_{i=1}^{m}<-\Delta_{q} u_{i n}, u_{i n}-u_{0 i}>_{q^{\prime}, q} \\
& +\sum_{i=1}^{m}<\Delta_{q} u_{0 i}, u_{i n}-u_{0 i}>_{q^{\prime}, q}+\sum_{i=1}^{m}<\Delta u_{i}, u_{i n}-u_{0 i}>_{2,2}

As in Lemma 3.1 we deduce that for $i=1, \cdots, m,\left\|u_{i n}\right\|_{W_{0}^{1, q}(\Omega)} \rightarrow\left\|u_{0 i}\right\|_{W_{0}^{1, q}(\Omega)}$ as $n \rightarrow \infty$ and therefore $\left(u_{n}\right)$ strongly converges to $u_{0}$ in $W$.

So we can state the main result of this section
Theorem 3.1. Assume that Assumptions 1.1, 3.1 and 3.2 are satisfied. Assume also that either Assumption 3.3 or 3.4 holds. Then the system (3.1) has a nontrivial solution in $W$.

Proof. The $C^{1}$-functional $I$ satisfies the Palais-Smale conditions and $I(0)=0$.

- First, we claim that there exist positive constants $\rho^{*}>0$ and $\delta>0$ such that $I(u) \geq \delta$ for any $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ satisfying $\|u\|_{W}=\rho^{*}$.
Let $u=\left(u_{1}, \cdots, u_{m}\right) \in W$. Put $\rho=\|u\|_{W}$ and note that $H_{1}(u) \geq\|u\|_{H}^{2}$ and $H_{2}(u) \geq \rho^{q}$.
Moreover, since $q<2^{*}$, for $i=1, \cdots, m$,

From the continous embedding of $W^{1,2}(\Omega) \subset L^{s}(\Omega)$ we deduce the existence of a positive constant $C_{1}$ such that $\left.\left|\int_{\Omega} m_{i}\right| u_{i}\right|^{q} \mid \leq C_{1}\left\|u_{i}\right\|_{W^{1,2}(\Omega)}^{q}$. Thus

Therefore if $\rho \leq \rho^{*}:=\frac{1}{C_{2}}\left(\frac{q}{2 C_{1}}\right)^{\frac{1}{q-2}}$, then $1-\frac{2 C_{1}}{q}\|u\|_{H}^{q-2} \geq 1-\frac{2 C_{1}}{q}\left(C_{2} \rho\right)^{q-2} \geq 0$ and

- Assume here that Assumption 3.3 is satisfied with $k=1$ for simplicity.

Let $\phi_{1, q, m_{1}-w_{1}}$ be the normalized eigenfunction associated with $\lambda_{1, q, m_{1}-w_{1}}$ (i. e. be such that $\int_{\Omega}\left(m_{1}-w_{1}\right)\left|\phi_{1, q, m_{1}-w_{1}}\right|^{q}=1$, we may choose such $\phi_{1, q, m_{1}-w_{1}}$ because
the equation (3.4) is homogeneous). Denote $\Phi_{q}=\left(\phi_{1, q, m_{1}-w_{1}}, 0, \cdots, 0\right)$ and take $R$ sufficiently large such that $\left\|R \Phi_{q}\right\|_{W}>\rho^{*}$. We have from (3.4) and (3.5)

& \quad=\frac{R^{2}}{2} H_{1}\left(\Phi_{q}\right)+\frac{R^{q}}{q} \int_{\Omega}\left(\lambda_{1, q, m_{1}-w_{1}}\left(m_{1}-w_{1}\right)+w_{1}-m_{1}\right)\left|\phi_{1, q, m_{1}-w_{1}}\right|^{q}
\end{aligned}
$$

So, since $\lambda_{1, q, m_{1}-w_{1}}<1$,

for $R$ sufficiently large. Therefore we can apply the mountain-pass theorem to deduce that $I$ has a non-trivial critical point which is a non-trivial weak solution of the system (3.1).

- Assume now that Assumption 3.4 is satisfied with $k=1$ and $l=2$ for simplicity. Denote again $\phi_{1, q, m_{1}-w_{1}}$ the normalized eigenfunction associated with $\lambda_{1, q, m_{1}-w_{1}}$ such that $\int_{\Omega}\left(m_{1}-w_{1}\right)\left|\phi_{1, q, m_{1}-w_{1}}\right|^{q}=1$ and denote here $\Psi_{q}=\left(0, \phi_{1, q, m_{1}-w_{1}}, 0, \cdots, 0\right)$. Take $R$ sufficiently large such that $\left\|R \Psi_{q}\right\|_{W}>\rho^{*}$. We have here

From Assumption 3.4, we get that $I\left(R \Psi_{q}\right)<0$ for $R$ sufficiently large.Therefore, as in the precedent case, we apply the mountain-pass theorem and deduce that $I$ has a non-trivial critical point.

Remark: As in section 2, we can generalize Theorem 3.1 replacing the 2Laplacian operator by the p-Laplacian with $2 \leq p<q$ for the following system

Then the hypothesis ii) in Assumption 3.2 is replaced by $\lambda$ is not an eigenvalue of $-\Delta_{q}$ associated with $m_{i}-w_{i}$ for each $i$. Moreover the hypothesis $\lambda_{1, q, m_{k}-w_{k}}<1$ in Assumption 3.3 is replaced by $\lambda_{1, q, m_{k}-w_{k}}<\lambda$.

Assumption 4.1. i): $2<\gamma<q$,
ii): $\gamma<2^{*}$ where $2^{*}=\frac{2 N}{N-2}$ if $2<N$ and $2^{*}=\infty$ if $2 \geq N$,
iii): For each $i=1, \cdots, m, f_{i} \in L^{\infty}(\Omega)$ and meas $\left\{x \in \Omega, f_{i}(x)>0\right\} \neq 0$.

We also define the functionals

where $H_{1}$ and $H_{2}$ are respectively defined by (1.1) and (1.2). We recall that we study here the existence of a weak non-trivial solution $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ for the system (4.1) with respect to the real positive parameter $\lambda$ and that the existence of weak solutions for the system (4.1) is equivalent to the existence of critical points for the Euler functional $I_{\lambda}$. The main result is the existence of a weak non-trivial solution for the system (4.1) associated with $\lambda>\lambda_{1}^{+}$where $\lambda_{1}^{+}$is defined by (4.7). For the first part of this section we follow a method developed by Cherfils-Il'Yasov in [7] for one equation with the ( $\mathrm{p}, \mathrm{q}$ )-Laplacian operator. This method is based on proving the existence of solution for $\lambda=\lambda_{1}^{+}$then on applying the mountain-pass theorem for $\lambda>\lambda_{1}^{+}$. Although we also could apply the mountain-pass theorem for our case, we will use in fact standard arguments to minimize the functional $I_{\lambda}$.

In section 4.1 we present some preliminary results: we define $\lambda_{1}^{+}$and we prove the existence of a solution for the system (4.1) for $\lambda=\lambda_{1}^{+}$. The section 4.2 is devoted to the main theorem of the existence of a solution for the system (4.1) associated with $\lambda>\lambda_{1}^{+}$.
4.1. Some preliminaries results. As in [7] we define for $\lambda>0, t>0$ and $u \in W$, $\tilde{I}_{\lambda}(t, u)=I_{\lambda}(t u)$.

Lemma 4.1. Assume that Assumptions 1.1, 4.1 i), 4.1 iii) are satisfied. For given $u$ in $W, u \neq 0$ such that $F(u) \neq 0$, the unique solution $(t(u), \lambda(u))$ of the system $\left\{\begin{array}{l}\frac{\partial}{\partial t} \tilde{I}_{\lambda}(t, u)=0 \\ \frac{\partial^{2}}{\partial t^{2}} \tilde{I}_{\lambda}(t, u)=0\end{array}\right.$ is given by

Note that the system $(S)$ is not solvable in the case where $u \in W, u \neq 0$ satisfies $F(u)=0$ (since if $u \neq 0$, then $H_{2}(u) \neq 0$ and from (4.6) we deduce $F(u) \neq 0$ ). We deduce that

First from $\gamma<2^{*}$, let $(t, l)$ be such that $\gamma<t<2^{*}$ and $\frac{1}{l}+\frac{\gamma}{t}=1$. Since $W_{0}^{1,2}(\Omega) \subset L^{t}(\Omega)$ with a continuous embedding and since the functions $f_{i}$ are bounded, there exist positive constants still denoting $C$ at each step and depending on some Sobolev constants, such that for $i=1, \cdots, m$

Moreover the function $f$ defined by $f(x)=(1+x)^{1 / x}$, is strictly decreasing on $(0, \infty)$. Then $(1+\mu)^{1 / \mu}<(1+\eta)^{1 / \eta}$. And we get that $\left(\frac{q}{2}\right)^{\gamma-2}<\left(\frac{\gamma}{2}\right)^{q-2}$. So $\Lambda_{1}^{+}<\lambda_{1}^{+}$.

We obtain now the following result that will enable us to get the existence of a non-trivial solution for the system (4.1) associated with $\lambda_{1}^{+}$.

Proposition 4.1. Assume that Assumptions 1.1 and 4.1 are satisfied. Assume that $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ satisfies $F(u) \neq 0$ and $\lambda^{\prime}(u)=0$ (i.e. $u$ is a critical point of $\lambda(u))$. Then $\tilde{u}=\left(\tilde{u_{1}}, \cdots, \tilde{u_{m}}\right) \in W$ is a non-trivial solution of the system (4.1) associated with $\tilde{\lambda}=\frac{\gamma}{2^{\alpha} q^{1-\alpha}} \lambda(u)$ where for all $i=1, \cdots, m, \tilde{u_{i}}=\frac{1}{s} u_{i}$ and $\frac{1}{s}=\left(\frac{q}{2}\right)^{\frac{1}{q-2}} t(u)>0$. Moreover $I_{\tilde{\lambda}}(\tilde{u})=0$.

Define $\tilde{u_{i}}=\frac{1}{s} u_{i}$ for $i=1, \cdots, m, s>0$ and $H(u)=\frac{H_{1}(u)}{H_{2}(u)}$. Then

But $t(u)=\left(\frac{\gamma-2}{q-\gamma}\right)^{\frac{1}{q-2}}\left(\frac{H_{1}(u)}{H_{2}(u)}\right)^{\frac{1}{q-2}}>0$ and $C_{q, \gamma}=\frac{q-2}{(q-\gamma)^{\alpha}(\gamma-2)^{1-\alpha}}$ so

$$
I_{\tilde{\lambda}}(\tilde{u})=r\left[\frac{q-\gamma}{q-2}+\frac{\gamma-2}{q-2}-1\right]=0
$$

Proposition 4.2. Assume that Assumptions 1.1 and 4.1 are satisfied and $0<\lambda<\Lambda_{1}^{+}$. Then the system (4.1) has no non-trivial solution in $W$ associated with $\lambda$.

Proof. Assume that $0<\lambda<\Lambda_{1}^{+}$. Assume also that the system (4.1) has a nontrivial solution $u=\left(u_{1}, \cdots, u_{m}\right) \in W$ associated with $\lambda$. Then we have $H_{1}(u)+H_{2}(u)=\lambda F(u)$. Note that this is impossible if $F(u) \leq 0$.

Therefore assume now that $F(u)>0$.
Recall that $\tilde{I}_{\lambda}(t, v)=I_{\lambda}(t v)=\frac{t^{2}}{2} H_{1}(v)+\frac{t^{q}}{q} H_{2}(v)-\frac{\lambda t^{\gamma}}{\gamma} F(v)$ for all $t>0$ and $v \in W$. We have $\frac{\partial}{\partial t} \tilde{I}_{\lambda}(t, v)=t H_{1}(v)+t^{q-1} H_{2}(v)-\lambda t^{\gamma-1} F(v)$ and in particular, since $u$ is a weak solution of (4.1), note that

$$
\frac{\partial}{\partial t} \tilde{I}_{\lambda}\left(\|u\|, \frac{1}{\|u\|} u\right)=I_{\lambda}^{\prime}(u) \cdot \frac{1}{\|u\|} u=0
$$

Moreover we have $\frac{\partial}{\partial t} \tilde{I}_{\lambda}(t, v)=t^{\gamma-1} R_{\lambda}(t, v)$ with

$$
R_{\lambda}(t, v)=t^{2-\gamma} H_{1}(v)+t^{q-\gamma} H_{2}(v)-\lambda F(v) .
$$

Let $v \in W$ be such that $v \neq 0$ and $F(v)>0$. Note that from Lemma 4.1 we have $R_{\lambda(v)}(t(v), v)=0$.
Moreover we can prove that $R_{\lambda}(t, v) \geq R_{\lambda}(t(v), v)$ for all $t>0$.
Indeed let $f(t)=t^{2-\gamma} H_{1}(v)+t^{q-\gamma} H_{2}(v)$. The function $f$ admits a global minimum on $t(v)$ on $(0, \infty)$ so $f(t) \geq f(t(v))=\left(\frac{H_{1}(v)}{\alpha}\right)^{\alpha}\left(\frac{H_{2}(v)}{1-\alpha}\right)^{1-\alpha}>0$. Therefore $R_{\lambda}(t, v) \geq R_{\lambda}(t(v), v)$ for all $t>0$.
Finally since $\lambda<\Lambda_{1}^{+} \leq \lambda(v)$, we get that $R_{\lambda}(t, v)>R_{\lambda(v)}(t, v)$ for all $t>0$. Thus $R_{\lambda}(t, v) \geq R_{\lambda}(t(v), v)>R_{\lambda(v)}(t(v), v)=0$ and $\frac{\partial}{\partial t} \tilde{I}_{\lambda}(t, v)=\frac{\partial}{\partial t} I_{\lambda}(t v)>0$ for all $t>0$.
So, choosing $t=\|u\|$ and $v=\frac{1}{\|u\|} u$, we get a contradiction since $\frac{\partial}{\partial t} \tilde{I}_{\lambda}\left(\|u\|, \frac{1}{\|u\|} u\right)=$ 0 .

Now we obtain a minimizer for $\Lambda_{1}^{+}$.
Proposition 4.3. Assume that Assumptions 1.1 and 4.1 are satisfied. There exists $v=\left(v_{1}, \cdots, v_{m}\right) \in W$ such that $\lambda(v)=\Lambda_{1}^{+}$.

Proof. First note that $\lambda(t u)=\lambda(u)$ for all $t>0$ and $u \in W$.
Define $\tilde{t}(u)=\frac{1}{\left(\left(H_{1}(u)\right)^{\alpha}\left(H_{2}(u)\right)^{1-\alpha}\right)^{\frac{1}{\gamma}}}$ for $u \in W \backslash\{0\}$ and note that

$$
\left(H_{1}(\tilde{t}(u) u)^{\alpha}\left(H_{2}(\tilde{t}(u))\right)^{1-\alpha}=1 .\right.
$$

Therefore we can derive that

$$
\Lambda_{1}^{+}=\inf \left\{\lambda(u), u \in W \text { such that } F(u)>0 \text { and } H_{1}(u)^{\alpha} H_{2}(u)^{1-\alpha}=1\right\}
$$

Then we consider a minimizing sequence $\left(v_{n}\right)$ of $\Lambda_{1}^{+}$.
We have $\gamma=2 \alpha+q(1-\alpha)$, so

$$
\left\|v_{n}\right\|_{H}^{\gamma}=\left\|v_{n}\right\|_{H}^{2 \alpha}\left\|v_{n}\right\|_{H}^{q(1-\alpha)}
$$

and since $W \subset H$ with a continuous embedding, there exists a positive constant $C$ such that

$$
\left\|v_{n}\right\|_{H}^{\gamma} \leq C\left\|v_{n}\right\|_{H}^{2 \alpha}\left\|v_{n}\right\|_{W}^{q(1-\alpha)}
$$

But $H_{1}$ and $H_{2}$ are equivalent norms respectively in $H$ and $W$ so we get that

$$
\left\|v_{n}\right\|_{H}^{\gamma} \leq C\left(H_{1}\left(v_{n}\right)\right)^{\alpha}\left(H_{2}\left(v_{n}\right)\right)^{1-\alpha}=C
$$

(for a positive constant $C$ ). We deduce that $\left(v_{n}\right)$ is a bounded sequence in $H$. By the compact embedding $W_{0}^{1,2}(\Omega) \subset L^{\gamma}(\Omega)$ (for $\gamma<2^{*}$ ), we get the existence of $v=\left(v_{1}, \cdots, v_{m}\right) \in H$ such that $\left(v_{n}\right)$ converges to $v$, strongly in $\left(L^{\gamma}(\Omega)\right)^{m}$ and weakly in $H$ (for a subsequence).

Afterwards we prove that $F(v)>0, v \in W$ and since $H_{1}$ and $H_{2}$ are weakly lower semi-continous in $H$ and $W$ respectively, we get that $\lambda(v)=\Lambda_{1}^{+}$.

Indeed, since $F$ is a continuous function and $F\left(v_{n}\right)>0, F\left(v_{n}\right) \rightarrow_{n \rightarrow \infty} F(v)$, we have $F(v) \geq 0$. Moreover, if $F(v)=0$, then $\lambda\left(v_{n}\right)=\frac{C_{q, \gamma}}{F\left(v_{n}\right)} \rightarrow_{n \rightarrow \infty} \infty$. This contradicts $\lambda\left(v_{n}\right) \rightarrow_{n \rightarrow \infty} \Lambda_{1}^{+}$. So $F(v)>0$ and $v \neq 0$.

Now we prove that $v \in W$. Recall that $\left(v_{n}\right)$ is a bounded sequence in $H$ and that $\left(v_{n}\right)$ converges to $v \neq 0$ strongly in $\left(L^{\gamma}(\Omega)\right)^{m}$. So there exists a positive constant $C^{\prime}$
such that $\left\|v_{n}\right\|_{\left(L^{\gamma}(\Omega)\right)^{m}} \geq C^{\prime}>0$ for $n$ large enough. Therefore, from the continuous embedding $H \subset\left(L^{\gamma}(\Omega)\right)^{m}$, we get that $\left\|v_{n}\right\|_{H} \geq C^{\prime}>0$ for $n$ large enough.
Finally from $\left\|v_{n}\right\|_{H} \geq C^{\prime}>0$ and $\left\|v_{n}\right\|_{H}^{2 \alpha}\left\|v_{n}\right\|_{W}^{(1-\alpha) q} \leq C$ we obtain that $\left(v_{n}\right)$ is a bounded sequence in $W$. Therefore $\left(v_{n}\right)$ admits a subsequence, still denoted $\left(v_{n}\right)$ such that $\left(v_{n}\right)$ converges to $v$ strongly in $\left(L^{\gamma}(\Omega)\right)^{2}$ and weakly in $W$. Thus $v \in W$.

Finally we prove that $\lambda(v)=\Lambda_{1}^{+}$.
From the weakly semi-continuousness of $H_{1}$ and $H_{2}$ respectively on $H$ and $W$ we have

$$
H_{1}(v) \leq \liminf H_{1}\left(v_{n}\right) \text { and } H_{2}(v) \leq \liminf H_{2}\left(v_{n}\right)
$$

But $\lambda\left(v_{n}\right)=\frac{C_{q, \gamma}}{F\left(v_{n}\right)}=\frac{C_{q, \gamma}\left(H_{1}\left(v_{n}\right)\right)^{\alpha}\left(H_{2}\left(v_{n}\right)\right)^{1-\alpha}}{F\left(v_{n}\right)} \rightarrow_{n \rightarrow \infty} \Lambda_{1}^{+}$. Passing to the limit inf as $n$ tends to $\infty$ we get that $\Lambda_{1}^{+} \geq \frac{C_{q, \gamma}\left(H_{1}(v)\right)^{\alpha}\left(H_{2}(v)\right)^{1-\alpha}}{F(v)}=\lambda(v)$. We deduce that

$$
\lambda(v)=\Lambda_{1}^{+}
$$

This concludes the proof.
Contrary to [7], we are not able to prove that the minimizer $v$ is non-negative because of the coupling terms $a_{i j} v_{j} v_{i}$ in $H_{1}(v)$. Finally combining Propositions 4.1 and 4.3 , since $v$ (defined by Proposition 4.3) is a critical point of $\lambda(u)$, we derive the existence of a non-trivial weak solution $u^{+}=\left(u_{1}^{+}, \cdots, u_{m}^{+}\right)$for the system (4.1) associated with $\lambda_{1}^{+}$. This is the following result
Proposition 4.4. Assume that Assumptions 1.1 and 4.1 are satisfied.
There exists $u^{+}=\left(u_{1}^{+}, \cdots, u_{m}^{+}\right) \in W$ a non-trivial solution for the system (4.1) associated with $\lambda_{1}^{+}$. Moreover $I_{\lambda_{1}^{+}}\left(u^{+}\right)=0$ and $F\left(u^{+}\right)>0$.

Proof. From Proposition 4.3 we have $\lambda(v)=\Lambda_{1}^{+}=\inf \{\lambda(u), u \in W, F(u)>0\}$. Thus $v$ is a critical point of the function $\lambda$ on $W$. From Proposition 4.1 we derive that there exists a non-trivial solution $u^{+}=\left(u_{1}^{+}, \cdots, u_{m}^{+}\right)$of system (4.1) associated with $\frac{\gamma}{2^{\alpha} q^{1-\alpha}} \lambda(v)=\lambda_{1}^{+}$where for all $i=1, \cdots, m, u_{i}^{+}=\frac{1}{s} v_{i}$ and $\frac{1}{s}=\left(\frac{q}{2}\right)^{\frac{1}{q-2}} t(v)>0$. Moreover from Proposition 4.1, $I_{\lambda_{1}^{+}}\left(u^{+}\right)=0$ and from Proposition 4.3, $F\left(u^{+}\right)=$ $\frac{1}{s^{\gamma}} F(v)>0$.

### 4.2. Main result.

Theorem 4.1. Assume that Assumptions 1.1 and 4.1 are satisfied. If $\lambda>\lambda_{1}^{+}$, then the system (4.1), associated with $\lambda$, admits a non-trivial solution in $W$.

Proof. Even if we could follow [7] for proving this result using the mountainpass theorem, we use here standard arguments by global minimization of the $C^{1}$ functional $I_{\lambda}$. Note that $I_{\lambda}$ is weakly lower semi-continuous by the compact embedding of $W$ into $\left(L^{q}(\Omega)\right)^{m}$ and $\left(L^{2}(\Omega)\right)^{m}$. Moreover $I_{\lambda}$ is coercive: indeed for any $u \in W$,

$$
I_{\lambda}(u) \geq \frac{1}{q} H_{2}(u)-\frac{\lambda}{\gamma} F(u)
$$

Since $|F(u)| \leq C\|u\|_{W}^{\gamma}$ with $C$ a positive constant, we get that

$$
I_{\lambda}(u) \geq \frac{1}{q}\|u\|_{W}^{q}\left(1-\frac{\lambda C q}{\gamma}\|u\|_{W}^{\gamma-q}\right)
$$

Thus $I_{\lambda}$ is coercive. Furthermore from Proposition 4.4, we have $I_{\lambda_{1}^{+}}\left(u^{+}\right)=0$ and $F\left(u^{+}\right)>0$. Finally from the hypothesis $\lambda>\lambda_{1}^{+}$, we get that $I_{\lambda}\left(u^{+}\right)<I_{\lambda_{1}^{+}}\left(u^{+}\right)=0$. Therefore we deduce that $I_{\lambda}$ has a non-trivial critical point which is a non-trivial weak solution of the system (4.1) associated with $\lambda$.

Remarks: We can get the same results for a larger class of coefficients, assuming that $a_{i j}, w_{i}, f_{i} \in L^{r}(\Omega)$ for some $r>1$ as in [7]. But we have not been able to adapt this method for a system with a ( $\mathrm{p}, \mathrm{q}$ )-Laplacian operator (with $p \neq 2$ ) and even for a non-symmetric system with a (2,q)-Laplacian operator. However in the particular case where the matrix $A$ is not symmetric and has the following form: $A=\left(a_{i j}\right)$ with $a_{j 1}=K a_{1 j}$ for $j=2, \cdots, m$ for some positive constant $K>0$ ( $K$ independent of $j$ ) and $a_{i j}=a_{j i}$ for $i, j \geq 2$, we can generalize all the above results. Indeed we introduce the diagonal matrix $D=\left(d_{i j}\right)$ with $d_{11}=K, d_{i i}=1$ for $i=2, \cdots, m$ and $d_{i j}=0$ if $i \neq j$. We replace the functionals $H_{1}, H_{2}$ and $F$ (defined before by (1.1),(1.2),(4.2)) by

$$
\begin{gathered}
H_{2}(u)=\sum_{i=1}^{m} d_{i i} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{q}+w_{i}\left|u_{i}\right|^{q}\right), F(u)=\sum_{i=1}^{m} d_{i i} \int_{\Omega} f_{i}\left|u_{i}\right|^{\gamma} \\
H_{1}(u)=\sum_{i=1}^{m} d_{i i} \int_{\Omega}\left(\left|\nabla u_{i}\right|^{2}+a_{i i} u_{i}^{2}+\sum_{j=1, i \neq j}^{m} a_{i j} u_{j} u_{i}\right) \\
H_{1}(u)=\sum_{i=1}^{m} d_{i i} \int_{\Omega}\left|\nabla u_{i}\right|^{2}+\int_{\Omega}{ }^{t} U D A U \operatorname{with}^{t} U=\left(u_{1}, \cdots, u_{m}\right)
\end{gathered}
$$

Therefore if we assume that the matrix $D A$ satisfies the following hypothesis ${ }^{t} \xi D A \xi \geq$ 0 for all ${ }^{t} \xi=\left(\xi_{1}, \cdots, \xi_{m}\right) \in \mathbb{R}^{m}$, we still derive that the Euler functional $I_{\lambda}$ defined by (4.3) (with the new functionals $H_{1}, H_{2}$ and $F$ ) is associated with the system (4.1) and the existence of weak solutions for the system (4.1) is equivalent to the existence of critical points for $I_{\lambda}$. Finally note that we obtain the existence of a non-trivial solution for (4.1) in Theorem 4.1 but contrary to [7], due to the coupling terms, we are not able to get the existence of a non-negative solution.
