LIMIT THEOREMS FOR THE COEFFICIENTS OF RANDOM WALKS ON THE GENERAL LINEAR GROUP

HUI XIAO, ION GRAMA, AND QUANSHENG LIU

ABSTRACT. Let $(g_n)_{n \ge 1}$ be a sequence of independent and identically distributed random elements with law μ on the general linear group GL(V), where $V = \mathbb{R}^d$. Consider the random walk $G_n := g_n \dots g_1$, $n \ge 1$, and the coefficients $\langle f, G_n v \rangle$, where $v \in V$ and $f \in V^*$. Under suitable moment assumptions on μ , we prove the strong and weak laws of large numbers and the central limit theorem for $\langle f, G_n v \rangle$, which improve the previous results established under the exponential moment condition on μ . We further demonstrate the Berry-Esseen bound, the Edgeworth expansion, the Cramér type moderate deviation expansion and the local limit theorem with moderate deviations for $\langle f, G_n v \rangle$ under the exponential moment condition. Under a subexponential moment condition on μ , we also show a Berry-Esseen type bound and the moderate deviation principle for $\langle f, G_n v \rangle$. Our approach is based on various versions of the Hölder regularity of the invariant measure of the Markov chain $G_n \cdot x = \mathbb{R}G_n v$ on the projective space of V with the starting point $x = \mathbb{R}v.$

1. INTRODUCTION

1.1. Background and main objectives. Since the pioneering work of Furstenberg and Kesten [20], the theory of random walks on linear groups (also called products of random matrices) has attracted a great deal of attention of many mathematicians for several decades, see for instance the influential work of Le Page [40], Guivarc'h and Raugi [32], Bougerol and Lacroix [7], Goldsheid and Margulis [21], Benoist and Quint [6], and the references therein. This theory has important applications in a number of research areas such as spectral theory [7, 10, 9], geometric measure theory [43, 35, 22], statistical physics [17], homogeneous dynamics [8, 4], stochastic recursions and smoothing transforms [38, 31, 42], and branching processes in random environment [41, 24]. Of particular interest is the study of asymptotic properties of the random walk

$$G_n := g_n \dots g_1, \quad n \ge 1,$$

where $(g_n)_{n \ge 1}$ is a sequence of independent and identically distributed (i.i.d.) random elements with law μ on the general linear group $\operatorname{GL}(V)$ with $V = \mathbb{R}^d$. One natural and important way to describe the random walk $(G_n)_{n \ge 1}$ is to investigate the growth rate of the coefficients $\langle f, G_n v \rangle$, where $v \in V$ and $f \in$ V^* , and $\langle \cdot, \cdot \rangle$ is the duality bracket: $\langle f, v \rangle = f(v)$. Bellman [3] conjectured that the classical central limit theorem should hold true for $\langle f, G_n v \rangle$ in the case when the matrices (g_n) are positive. This conjecture was proved by Furstenberg and Kesten [20], who established the strong law of large numbers and central limit theorem under the condition that the matrices g_n are strictly positive and that all the coefficients of g_n are comparable. This

condition was then relaxed by Kingman [39], Cohn, Nerman and Peligrad [12] and Hennion [33].

As noticed by Furstenberg [19], the analysis developed in [20] for positive matrices breaks down for invertible matrices. It turns out that the situation of invertible matrices is much more complicated and delicate. Guivarc'h and Raugi [32] established the strong law of large numbers for the coefficients of products of invertible matrices under an exponential moment condition: for any $v \in V \setminus \{0\}$ and $f \in V^* \setminus \{0\}$, a.s.

$$\lim_{n \to \infty} \frac{1}{n} \log |\langle f, G_n v \rangle| = \lambda_1, \tag{1.1}$$

where $\lambda_1 \in \mathbb{R}$ is a constant (independent of f and v) called the first Lyapunov exponent of μ . It is worth mentioning that the result (1.1) does not follow from the classical subadditive ergodic theorem of Kingman [39], nor from the recent version by Gouëzel and Karlsson [28]. The central limit theorem for the coefficients has also been established in [32] under the exponential moment condition: for any $t \in \mathbb{R}$,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\log|\langle f, G_n v \rangle| - n\lambda_1}{\sigma \sqrt{n}} \leqslant t\right) = \Phi(t), \tag{1.2}$$

where Φ is the standard normal distribution function on \mathbb{R} and $\sigma^2 > 0$ is the asymptotic variance of $\frac{1}{\sqrt{n}} \log |\langle f, G_n v \rangle|$. Recently, Benoist and Quint [6] have extended (1.1) and (1.2) to the framework of the general linear group $\operatorname{GL}(V)$ with $V = \mathbb{K}^d$, where \mathbb{K} is a local field. Moreover, they also established the law of iterated logarithm and the large deviations bounds.

The first objective of this paper is to prove the weak law of large numbers under the first moment condition: we prove that, if $\int_{\mathrm{GL}(V)} \log N(g) \mu(dg) < \infty$ with $N(g) = \max\{||g||, ||g^{-1}||\}$, then (1.1) holds in probability. Moreover, under the second moment condition that $\int_{\mathrm{GL}(V)} \log^2 N(g) \mu(dg) < \infty$, we prove the strong law of large numbers, namely that (1.1) holds a.s. Under the same second moment condition we also prove the central limit theorem: we show that the Gaussian approximation (1.2) holds.

Our second objective is to investigate the rate of convergence in the central limit theorem (1.2). To this end, we first establish a Berry-Esseen bound under the exponential moment condition: we prove that if $\int_{\mathrm{GL}(V)} N(g)^{\varepsilon} \mu(dg) < \infty$ for some $\varepsilon > 0$, then there exists a constant c > 0 such that for all $n \ge 1$, $t \in \mathbb{R}, v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1, and any γ -Hölder continuous function φ on $\mathbb{P}(V)$,

$$\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\frac{\log|\langle f, G_n v\rangle| - n\lambda_1}{\sigma\sqrt{n}} \leqslant t\right\}}\right] - \nu(\varphi)\Phi(t) \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma},$$
(1.3)

where $\|\varphi\|_{\gamma}$ is the γ -Hölder norm of the function φ . Our result (1.3) improves a very recent Berry-Esseen bound with $\varphi = 1$ in [18], where a different approach is applied. In fact we will establish a much stronger result, that is, the first-order Edgeworth expansion (cf. Theorem 2.3). Moreover, under a subexponential moment condition, we prove that a weaker version of the Berry-Esseen bound holds true. Namely, the bound (1.3) holds with the rate $\frac{c \log^{\beta} n}{\sqrt{n}}$ (for some $\beta > 0$) instead of $\frac{c}{\sqrt{n}}$.

We next establish the moderate deviation principle under the subexponential moment condition that $\int_{\mathrm{GL}(V)} e^{\log^{\alpha} N(g)} \mu(dg) < \infty$ for some constant $\alpha \in (0,1)$: for any Borel set $B \subseteq \mathbb{R}$ and any sequence $(b_n)_{n \ge 1}$ of positive real numbers satisfying $\frac{b_n}{n} \to 0$ and $b_n = o(n^{\frac{1}{2-\alpha}})$ as $n \to \infty$, we have

$$-\inf_{t\in B^{\circ}}\frac{t^{2}}{2\sigma^{2}} \leqslant \liminf_{n\to\infty}\frac{n}{b_{n}^{2}}\log\mathbb{P}\left(\frac{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}}{b_{n}}\in B\right)$$
$$\leqslant \limsup_{n\to\infty}\frac{n}{b_{n}^{2}}\log\mathbb{P}\left(\frac{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}}{b_{n}}\in B\right)\leqslant -\inf_{t\in\bar{B}}\frac{t^{2}}{2\sigma^{2}},$$
(1.4)

where B° and \overline{B} are respectively the interior and the closure of B.

We then reinforce the moderate deviation principle (1.4) to the Cramér type moderate deviation expansion under the exponential moment condition: we prove that if $\int_{\mathrm{GL}(V)} N(g)^{\varepsilon} \mu(dg) < \infty$ for some $\varepsilon > 0$, then uniformly in $t \in [0, o(\sqrt{n})], v \in V$ and $f \in V^*$ with $\|v\| = \|f\| = 1$, as $n \to \infty$,

$$\frac{\mathbb{P}\left(\frac{\log|\langle f, G_n v\rangle| - n\lambda_1}{\sigma\sqrt{n}} \ge t\right)}{1 - \Phi(t)} = e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} [1 + o(1)], \qquad (1.5)$$

where ζ is the Cramér series (cf. (2.4)). A similar expansion for the lower tail is also obtained. More generally, we prove the Cramér type moderate deviation expansion for the couple $(G_n \cdot x, \log |\langle f, G_n v \rangle|)$ with a target function φ on the Markov chain $(G_n \cdot x)$ on the projective space $\mathbb{P}(V)$; see Theorem 2.8. We mention that Bahadur-Rao type and Petrov type large deviation asymptotics for the coefficients $\langle f, G_n v \rangle$ have been recently established in [48], which give precise estimation of the rate of convergence in the weak law of large numbers (1.1).

Our third objective is to establish the local limit theorem with moderate deviations for the coefficients $\langle f, G_n v \rangle$: for any real numbers $a_1 < a_2$, we have, as $n \to \infty$, uniformly in $|t| = o(\sqrt{n})$,

$$\mathbb{P}\Big(\log|\langle f, G_n v\rangle| - n\lambda_1 \in [a_1, a_2] + \sqrt{n\sigma t}\Big) \\
= \frac{a_2 - a_1}{\sigma\sqrt{2\pi n}} e^{-\frac{t^2}{2} + \frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} [1 + o(1)].$$
(1.6)

See Theorem 2.9 for a more general statement where a local limit theorem with moderate deviations for the couple $(G_n \cdot x, \log |\langle f, G_n v \rangle|)$ with target

functions is given. We would like to mention that using the approach developed in this paper, it is possible to establish some new and interesting limit theorems for the Gromov product of random walks on hyperbolic groups; we refer to Gouëzel [26, 27] on this topic.

Finally we would like to mention that all the results of the paper remain valid when V is \mathbb{C}^d or \mathbb{K}^d , where K is any local field.

1.2. **Proof strategy.** Our starting point is the following decomposition which relates the coefficients $\langle f, G_n v \rangle$ to the cocycles $\sigma(G_n, x)$: for any $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$ with ||f|| = 1,

$$\log |\langle f, G_n v \rangle| = \sigma(G_n, x) + \log \delta(y, G_n \cdot x), \qquad (1.7)$$

where $\delta(y, x) = \frac{|\langle f, v \rangle|}{\|f\| \|v\|}$. The proof of (1.1) given in [32, 6] is based on the exponential Hölder regularity of the invariant measure ν of the Markov chain $(G_n \cdot x)$ on the projective space $\mathbb{P}(V)$, which requires the exponential moment condition. We refer to Bougerol and Lacroix [7] for a comprehensive account of the proof strategy developed in [32]. In order to relax the exponential moment condition, we will establish a weaker form of the Hölder regularity of ν : we prove that for any $\varepsilon > 0$,

$$\lim_{n \to \infty} \mathbb{P}\left(\delta(y, G_n \cdot x) \leqslant e^{-\varepsilon n}\right) = 0, \tag{1.8}$$

provided that the first moment condition holds. See Proposition 3.4. The weak law of large numbers for the coefficients follows from this and the law of large numbers of Furstenberg [19] for the norm cocycle $\sigma(G_n, x)$.

To prove the strong law of large numbers, we show the following stronger regularity of ν : if the second moment condition holds, then for any $\varepsilon > 0$ there exists a sequence of positive numbers (a_k) such that $\sum_{k=1}^{\infty} a_k < \infty$ and that for all $n \ge k \ge 1$,

$$\mathbb{P}\left(\delta(y, G_n \cdot x) \leqslant e^{-\varepsilon k}\right) \leqslant a_k.$$
(1.9)

See Lemma 3.5. This permits us to conclude the strong law of large numbers for the coefficients, using that of Furstenberg [19] for the norm cocycle.

Using again (1.9), together with the central limit theorem for the norm cocycle $\sigma(G_n, x)$ due to Benoist and Quint [5], allows us to prove the Gaussian approximation (1.2) under the optimal second moment condition.

For the proof of the Edgeworth expansion and the Berry-Esseen bound (1.3), we first use a partition $(\chi_{n,k}^y)_{k\geq 1}$ of the unity to discretise the component $\log \delta(y, G_n \cdot x)$ in (1.7). This allows to reduce the study of the coefficients to that of the norm cocycle $\sigma(G_n, x)$ jointly with the target function $\chi_{n,k}^y(G_n \cdot x)$. Then our strategy is to make use of the Edgeworth expansion for the couple $(G_n \cdot x, \sigma(G_n, x))$ with target functions on the Markov chain $(G_n \cdot x)$. Finally, the result (1.3) is obtained by patching up these expansions

by means of the exponential Hölder regularity of the invariant measure ν . For the proof of the Berry-Esseen type bound (Theorem 2.5) under a subexponential moment condition, we establish a subexponential regularity of the invariant measure ν (Theorem 2.6) and make use of the previous result in [15] on Berry-Esseen bounds for the norm cocycle $\sigma(G_n, x)$.

To prove the moderate deviation principle (1.4), we use again the subexponential regularity of the invariant measure ν together with the moderate deviation principle for the norm cocycle $\sigma(G_n, x)$ established by in [14].

To establish the Cramér type moderate deviation expansion (1.5), our approach is different from the standard one which is based on performing a change of measure and proving a Berry-Esseen bound under the changed measure; see for example Cramér [13] and Petrov [44]. However, even with a Berry-Esseen bound under the changed measure at hands, we do not know how to obtain (1.5) using this strategy. Our approach is to use again a partition of the unity and for each piece to pass to the Fourier transforms under the changed measure, and then to establish exact asymptotic expansions. We then patch up these expansions by using the exponential Hölder regularity of the invariant measure ν .

The proof of the local limit theorem with moderate deviations (1.6) follows the same lines as that of (1.5), together with the uniform version of the exponential Hölder regularity of the invariant measure of the Markov chain $(G_n \cdot x)$ under the changed measure.

2. Main results

2.1. Notation and conditions. For any integer $d \ge 1$, denote by $V = \mathbb{R}^d$ the *d*-dimensional Euclidean space. We fix a basis e_1, \ldots, e_d of V and the associated norm on V is defined by $||v||^2 = \sum_{i=1}^d |v_i|^2$ for $v = \sum_{i=1}^d v_i e_i \in V$. Let V^* be the dual vector space of V and its dual basis is denoted by e_1^*, \ldots, e_d^* so that $e_i^*(e_j) = 1$ if i = j and $e_i^*(e_j) = 0$ if $i \neq j$. For any integer $2 \le p \le d$, let $\wedge^p V$ be the *p*-th exterior product of V and we use the same symbol $|| \cdot ||$ for the norms induced on $\wedge^p V$ and V^* . We equip $\mathbb{P}(V)$ with the angular distance

$$d(x, x') = \frac{\|v \wedge v'\|}{\|v\| \|v'\|} \quad \text{for } x = \mathbb{R}v \in \mathbb{P}(V), \ x' = \mathbb{R}v' \in \mathbb{P}(V).$$
(2.1)

We use the symbol $\langle \cdot, \cdot \rangle$ to denote the dual bracket defined by $\langle f, v \rangle = f(v)$ for any $f \in V^*$ and $v \in V$. Set

$$\delta(x,y) = \frac{|\langle f, v \rangle|}{\|f\| \|v\|} \quad \text{for } x = \mathbb{R}v \in \mathbb{P}(V), \ y = \mathbb{R}f \in \mathbb{P}(V^*).$$

Denote by $\mathscr{C}(\mathbb{P}(V))$ the space of complex-valued continuous functions on $\mathbb{P}(V)$, equipped with the norm $\|\varphi\|_{\infty} := \sup_{x \in \mathbb{P}(V)} |\varphi(x)|$ for $\varphi \in \mathscr{C}(\mathbb{P}(V))$.

Let $\gamma > 0$ be a fixed small enough constant and set

$$\|\varphi\|_{\gamma} := \|\varphi\|_{\infty} + \sup_{x, x' \in \mathbb{P}(V): x \neq x'} \frac{|\varphi(x) - \varphi(x')|}{d(x, x')^{\gamma}}$$

Consider the Banach space

$$\mathscr{B}_{\gamma} := \left\{ \varphi \in \mathscr{C}(\mathbb{P}(V)) : \|\varphi\|_{\gamma} < \infty \right\},$$

which consists of complex-valued γ -Hölder continuous functions on $\mathbb{P}(V)$. Denote by $\mathscr{L}(\mathscr{B}_{\gamma}, \mathscr{B}_{\gamma})$ the set of all bounded linear operators from \mathscr{B}_{γ} to \mathscr{B}_{γ} equipped with the operator norm $\|\cdot\|_{\mathscr{B}_{\gamma}\to\mathscr{B}_{\gamma}}$. The topological dual of \mathscr{B}_{γ} endowed with the induced norm is denoted by \mathscr{B}'_{γ} . Let \mathscr{B}^*_{γ} be the Banach space of γ -Hölder continuous functions on $\mathbb{P}(V^*)$ endowed with the norm

$$\|\varphi\|_{\mathscr{B}^*_{\gamma}} = \sup_{y \in \mathbb{P}(V^*)} |\varphi(x)| + \sup_{y,y' \in \mathbb{P}(V^*): \, y \neq y'} \frac{|\varphi(y) - \varphi(y')|}{d(y,y')^{\gamma}},$$

where $d(y, y') = \frac{\|f \wedge f'\|}{\|f\|\|f'\|}$ for $y = \mathbb{R}f \in \mathbb{P}(V^*)$ and $y' = \mathbb{R}f' \in \mathbb{P}(V^*)$. Let $\mathrm{GL}(V)$ be the general linear group of the vector space V. The action of

Let $\operatorname{GL}(V)$ be the general linear group of the vector space V. The action of $g \in \operatorname{GL}(V)$ on a vector $v \in V$ is denoted by gv, and the action of $g \in \operatorname{GL}(V)$ on a projective line $x = \mathbb{R}v \in \mathbb{P}(V)$ is denoted by $g \cdot x = \mathbb{R}gv$. For any $g \in \operatorname{GL}(V)$, let $||g|| = \sup_{v \in V \setminus \{0\}} \frac{||gv||}{||v||}$ and denote $N(g) = \max\{||g||, ||g^{-1}||\}$. Let μ be a Borel probability measure on $\operatorname{GL}(V)$. We shall use the following exponential moment condition.

A1 (Exponential moment condition). There exists a constant $\varepsilon > 0$ such that $\int_{\mathrm{GL}(V)} N(g)^{\varepsilon} \mu(dg) < \infty$.

Let Γ_{μ} be the smallest closed subsemigroup generated by the support of the measure μ . An endomorphism g of V is said to be proximal if it has an eigenvalue λ with multiplicity one and all other eigenvalues of ghave modulus strictly less than $|\lambda|$. We shall need the following strong irreducibility and proximality condition.

A2. (i)(Strong irreducibility) No finite union of proper subspaces of V is Γ_{μ} -invariant.

(ii)(Proximality) Γ_{μ} contains a proximal endomorphism.

Define the norm cocycle $\sigma : \operatorname{GL}(V) \times \mathbb{P}(V) \to \mathbb{R}$ as follows:

$$\sigma(g, x) = \log \frac{\|gv\|}{\|v\|}, \text{ for any } g \in \operatorname{GL}(V) \text{ and } x = \mathbb{R}v \in \mathbb{P}(V).$$

By [45, Proposition 3.15], under A1 and A2, the following limit exists and is independent of $x \in \mathbb{P}(V)$:

$$\sigma^2 := \lim_{n \to \infty} \frac{1}{n} \mathbb{E}\left[(\sigma(G_n, x) - n\lambda_1)^2 \right] \in (0, \infty).$$
(2.2)

For any $s \in (-s_0, s_0)$ with $s_0 > 0$ small enough, we define the transfer operator P_s as follows: for any bounded measurable function φ on $\mathbb{P}(V)$,

$$P_s\varphi(x) = \int_{\mathrm{GL}(V)} e^{s\sigma(g,x)}\varphi(g \cdot x)\mu(dg), \quad x \in \mathbb{P}(V).$$
(2.3)

It will be shown in Lemma 4.1 that there exists a constant $s_0 > 0$ such that for any $s \in (-s_0, s_0)$, the operator $P_s \in \mathscr{L}(\mathscr{B}_{\gamma}, \mathscr{B}_{\gamma})$ has a unique dominant eigenvalue $\kappa(s)$ with $\kappa(0) = 1$ and the mapping $s \mapsto \kappa(s)$ being analytic.

We denote $\Lambda = \log \kappa$. Set $\gamma_m = \Lambda^{(m)}(0)$ for any $m \ge 1$. In particular, $\gamma_1 = \lambda_1$ and $\gamma_2 = \sigma^2$. Throughout the paper, we write ζ for the Cramér series [44]:

$$\zeta(t) = \frac{\gamma_3}{6\gamma_2^{3/2}} + \frac{\gamma_4\gamma_2 - 3\gamma_3^2}{24\gamma_2^3}t + \frac{\gamma_5\gamma_2^2 - 10\gamma_4\gamma_3\gamma_2 + 15\gamma_3^3}{120\gamma_2^{9/2}}t^2 + \cdots, \quad (2.4)$$

which converges for |t| small enough.

Under A1 and A2, the Markov chain $(G_n \cdot x)_{n \ge 0}$ has a unique invariant probability measure ν on $\mathbb{P}(V)$ such that for any bounded measurable function φ on $\mathbb{P}(V)$,

$$\int_{\mathbb{P}(V)} \int_{\mathrm{GL}(V)} \varphi(g \cdot x) \mu(dg) \nu(dx) = \int_{\mathbb{P}(V)} \varphi(x) \nu(dx) =: \nu(\varphi).$$
(2.5)

2.2. Law of large numbers and central limit theorem. In this subsection we present the law of large numbers and the central limit theorem for the coefficients $\langle f, G_n v \rangle$.

We first present the law of large numbers for $\langle f, G_n v \rangle$: namely we state a weak law of large numbers under the existence of the first moment and a strong law of large numbers under the second moment assumption. Denote by λ_1 and λ_2 the first and second Lyapunov exponents of μ :

$$\lambda_1 := \lim_{n \to \infty} \frac{1}{n} \mathbb{E} \log \|G_n\|, \quad \lambda_2 := \lim_{n \to \infty} \frac{1}{n} \mathbb{E} \log \frac{\|\wedge^2 G_n\|}{\|G_n\|}.$$
(2.6)

We say that Γ_{μ} is irreducible if no proper subspace of V is Γ_{μ} -invariant.

Theorem 2.1. Assume that $\int_{\mathrm{GL}(V)} \log N(g)\mu(dg) < \infty$. Assume also that $\lambda_1 > \lambda_2$ and that Γ_{μ} is irreducible. Then, we have, as $n \to \infty$, uniformly in $v \in V$ and $f \in V^*$ with $\|v\| = \|f\| = 1$,

$$\frac{1}{n}\log|\langle f, G_n v\rangle| \to \lambda_1 \quad in \text{ probability and in } L^1.$$
(2.7)

Moreover, if $\int_{\mathrm{GL}(V)} \log^2 N(g) \,\mu(dg) < \infty$ and condition **A2** holds, then the convergence in probability in (2.7) can be improved to the a.s. convergence.

Notice that, by a theorem of Guivarc'h [29], condition A2 implies that $\lambda_1 > \lambda_2$ and that Γ_{μ} is irreducible. Under the exponential moment condition A1 together with the strong irreducibility and proximality condition

A2, Guivarc'h and Raugi [32] proved the a.s. convergence in (2.7) for the special linear group $SL(d, \mathbb{R})$ (the set of $d \times d$ matrices with determinant 1); Benoist and Quint [6] extended it to the general linear group GL(V). Our Theorem 2.1 states the weak law of large numbers for GL(V) under the first moment condition, and the strong law of large numbers under the second moment condition. The question remains open whether the strong law of large numbers holds true under the first moment condition.

It is worth mentioning that Aoun and Sert [2] proved the weak law of large numbers for the spectral radius of G_n under the first moment condition, and the strong law of large numbers under the second moment condition.

In the next theorem we formulate the central limit theorem for the coefficients $\langle f, G_n v \rangle$ under the second moment condition. Recall that

$$\Phi(t) = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{t} e^{-u^2/2} du, \quad t \in \mathbb{R}$$

is the standard normal distribution function, and σ^2 is the asymptotic variation given by (2.2).

Theorem 2.2. If $\int_{\mathrm{GL}(V)} \log^2 N(g) \mu(dg) < \infty$ and condition **A2** holds, then for any $t \in \mathbb{R}$, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{\sigma \sqrt{n}} \leqslant t\right) = \Phi(t).$$
(2.8)

Theorem 2.2 improves the results of Guivarc'h and Raugi [32] on $SL(d, \mathbb{R})$ and those of Benoist and Quint [6] on GL(V) by relaxing the exponential moment condition A1 to the optimal second moment condition.

We mention that the central limit theorem for the spectral radius of G_n has been obtained by Aoun [1].

2.3. Edgeworth expansion and Berry-Esseen bound. In many applications it is of primary interest to give an estimation of the rate of convergence in the Gaussian approximation (2.8). In this direction we prove a first-order Edgeworth expansion. For any $\varphi \in \mathscr{B}_{\gamma}$, define the functions

$$b_{\varphi}(x) := \lim_{n \to \infty} \mathbb{E}[(\sigma(G_n, x) - n\Lambda'(s))\varphi(G_n \cdot x)], \quad x \in \mathbb{P}(V)$$
(2.9)

and

$$d_{\varphi}(y) := \int_{\mathbb{P}(V)} \varphi(x) \log \delta(y, x) \nu(dx), \quad y \in \mathbb{P}(V^*).$$
(2.10)

It is shown in Lemmas 4.7 and 4.8 that both functions b_{φ} and d_{φ} are well-defined and $b_{\varphi} \in \mathscr{B}_{\gamma}, d_{\varphi} \in \mathscr{B}_{\gamma}^*$.

Theorem 2.3. Assume A1 and A2. Then, for any $\varepsilon > 0$, uniformly in $t \in \mathbb{R}, x = \mathbb{R}v \in \mathbb{P}(V), y = \mathbb{R}f \in \mathbb{P}(V^*)$ with ||v|| = ||f|| = 1, and $\varphi \in \mathscr{B}_{\gamma}$, as $n \to \infty$,

$$\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\frac{\log|\langle f, G_n v\rangle| - n\lambda_1}{\sigma\sqrt{n}} \leqslant t\right\}}\right] \\
= \nu(\varphi)\left[\Phi(t) + \frac{\Lambda'''(0)}{6\sigma^3\sqrt{n}}(1 - t^2)\phi(t)\right] - \frac{b_{\varphi}(x) + d_{\varphi}(y)}{\sigma\sqrt{n}}\phi(t) \\
+ \nu(\varphi)o\left(\frac{1}{\sqrt{n}}\right) + \|\varphi\|_{\gamma}O\left(\frac{1}{n^{1-\varepsilon}}\right).$$
(2.11)

As a consequence of Theorem 2.3 we get the following Berry-Esseen bound with the optimal convergence rate, under the exponential moment condition.

Theorem 2.4. Under A1 and A2, there exist constants $\gamma > 0$ and c > 0such that for any $n \ge 1$, $t \in \mathbb{R}$, $x = \mathbb{R}v \in \mathbb{P}(V)$ and $f \in V^*$ with ||v|| =||f|| = 1, and $\varphi \in \mathscr{B}_{\gamma}$,

$$\left| \mathbb{E} \left[\varphi(G_n \cdot x) \mathbb{1}_{\left\{ \frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{\sigma \sqrt{n}} \leqslant t \right\}} \right] - \nu(\varphi) \Phi(t) \right| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}.$$
(2.12)

Under the same conditions, our result (2.12) improves on two very recent results in [18] and [16]: it is proved in [18] that (2.12) holds for the particular case when $\varphi = 1$, and in [16] the authors also consider the case where $\varphi = 1$ but the convergence rate $\frac{1}{\sqrt{n}}$ in (2.12) is replaced by $\frac{\log n}{\sqrt{n}}$. It is an open question how to relax the exponential moment condition

It is an open question how to relax the exponential moment condition **A1** in the Edgeworth expansion and in the Berry-Esseen bound. For positive matrices, the Edgeworth expansion (2.11) and the Berry-Esseen bound (2.12) have been recently obtained using a different approach in a forthcoming paper [49] under optimal moment conditions. In the following theorem we get a Berry-Esseen type bound for invertible matrices under the sub-exponential moment condition, with an extra $\log \frac{1}{\alpha} n$ factor.

Theorem 2.5. Assume A2 and that there exists a constant $\alpha \in (0, 1)$ such that $\mu(\log N(g) > u) \leq \exp\{-u^{\alpha}a(u)\}$ for any u > 0 and for some function a(u) > 0 satisfying $a(u) \to \infty$ as $u \to \infty$. Then, there exists a constant c > 0 such that for any $n \geq 2$, $t \in \mathbb{R}$, $v \in V$ and $f \in V^*$ with $\|v\| = \|f\| = 1$,

$$\left| \mathbb{P}\left(\frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{\sigma \sqrt{n}} \leqslant t \right) - \Phi(t) \right| \leqslant \frac{c \log^{\frac{1}{\alpha}} n}{\sqrt{n}}.$$
 (2.13)

Note that the condition $\mu(\log N(g) > u) \leq \exp\{-u^{\alpha}a(u)\}$ holds true if $\int_{\operatorname{GL}(V)} e^{\log^{(\alpha+\varepsilon)}N(g)} \mu(dg) < \infty$ for some $\varepsilon > 0$.

Recently in [16], under the polynomial moment condition of order $p \ge 3$, that is, $\int_{\mathrm{GL}(V)} \log^p N(g) \,\mu(dg) < \infty$, a Berry-Esseen type bound is obtained with the convergence rate $n^{-\frac{p-1}{2p}}$.

The proof of Theorem 2.5 is based on the Berry-Esseen type bound recently established in [15] and on the subexponential Hölder regularity of the invariant measure ν which is the subject of Section 2.4.

2.4. Subexponential Hölder regularity. We shall establish the following subexponential Hölder regularity of the invariant measure ν under only subexponential moments condition. This turns out to be an important step for proving the Berry-Esseen type bound (2.13) as well as the moderate deviation principle for the coefficients $\langle f, G_n v \rangle$ (see Theorem 2.7 below).

Theorem 2.6. Assume A2 and that there exists a constant $\alpha \in (0, 1)$ such that $\mu(\log N(g) > u) \leq \exp\{-u^{\alpha}a(u)\}$ for any u > 0 and for some function a(u) > 0 satisfying $a(u) \to \infty$ as $u \to \infty$. Then, there exist constants c > 0 and $k_0 \in \mathbb{N}$ such that for all $n \geq k \geq k_0$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(\delta(G_n \cdot x, y) \leqslant e^{-k}\right) \leqslant \exp\left(-ck^{\alpha}\right).$$
(2.14)

Moreover, there exists a constant $\eta > 0$ such that

$$\sup_{y \in \mathbb{P}(V^*)} \int_{\mathbb{P}(V)} \exp\left(\eta |\log \delta(x, y)|^{\alpha}\right) \nu(dx) < +\infty.$$
(2.15)

In particular, there exist constants c > 0 and $\eta > 0$ such that for any $y \in \mathbb{P}(V^*)$ and r > 0,

$$\nu(B(y,r)) \leqslant c \exp\left(\eta |\log r|^{\alpha}\right),\tag{2.16}$$

where $B(y,r) = \{x \in \mathbb{P}(V) : \delta(y,x) \leq r\}.$

Notice that if A2 holds and that subexponential moment condition in Theorem 2.6 is strengthed to the exponential moment condition A1, then by a theorem due to Guivarc'h [30], the invariant measure ν satisfies a stronger regularity property: there exists a constant $\eta > 0$ such that

$$\sup_{y \in \mathbb{P}(V^*)} \int_{\mathbb{P}(V)} \frac{1}{\delta(x, y)^{\eta}} \nu(dx) < +\infty.$$
(2.17)

In this case, we say that the invariant measure ν is exponentially Hölder regular.

Under the *p*-th moment condition that $\int_{\mathrm{GL}(V)} \log^p N(g) \mu(dg) < \infty$ for some p > 1, Benoist and Quint [5, Proposition 4.5] have recently established the log-regularity of ν : under A2,

$$\sup_{y\in\mathbb{P}(V^*)}\int_{\mathbb{P}(V)}|\log\delta(x,y)|^{p-1}\nu(dx)<+\infty.$$
(2.18)

This result is one of the crucial points for establishing the central limit theorem for the norm cocycle $\sigma(G_n, x)$ under the optimal second moment condition $\int_{\mathrm{GL}(V)} \log^2 N(g) \,\mu(dg) < \infty$, see [5].

2.5. Moderate deviation principles and expansions. In this subsection we state a moderate deviation principle and Cramér type moderate deviation expansions for the coefficients $\langle f, G_n v \rangle$.

We first present the moderate deviation principle under a subexponential moment condition, whose proof is based upon the regularity of the invariant measure ν shown in Theorem 2.6.

Theorem 2.7. Assume A2 and that $\int_{\operatorname{GL}(V)} e^{\log^{\alpha} N(g)} \mu(dg) < \infty$ for some constant $\alpha \in (0,1)$. Then, for any Borel set $B \subseteq \mathbb{R}$ and any sequence $(b_n)_{n \geq 1}$ of positive numbers satisfying $\frac{b_n}{\sqrt{n}} \to \infty$ and $b_n = o(n^{\frac{1}{2-\alpha}})$ as $n \to \infty$, we have, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\begin{split} &-\inf_{y\in B^{\circ}}\frac{y^2}{2\sigma^2}\leqslant \liminf_{n\to\infty}\frac{n}{b_n^2}\log\mathbb{P}\left(\frac{\log|\langle f,G_nv\rangle|-n\lambda_1}{b_n}\in B\right)\\ &\leqslant \limsup_{n\to\infty}\frac{n}{b_n^2}\log\mathbb{P}\left(\frac{\log|\langle f,G_nv\rangle|-n\lambda_1}{b_n}\in B\right)\leqslant -\inf_{y\in\bar{B}}\frac{y^2}{2\sigma^2}, \end{split}$$

where B° and \overline{B} are respectively the interior and the closure of B.

When the sub-exponential moment condition is strengthened to the exponential moment condition A1, we are able to establish the following Cramér type moderate deviation expansions for the coefficients $\langle f, G_n v \rangle$, and more generally, for the couple $(G_n \cdot x, \log |\langle f, G_n v \rangle|)$ with a target function φ on the Markov chain $(G_n \cdot x)_{n \geq 0}$.

Theorem 2.8. Assume A1 and A2. Then, we have, as $n \to \infty$, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1, and $t \in [0, o(\sqrt{n})]$,

$$\frac{\mathbb{P}\left(\frac{\log|\langle f,G_nv\rangle|-n\lambda_1}{\sigma\sqrt{n}} \ge t\right)}{1-\Phi(t)} = e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} [1+o(1)], \qquad (2.19)$$

$$\frac{\mathbb{P}\left(\frac{\log|\langle f,G_nv\rangle|-n\lambda_1}{\sigma\sqrt{n}}\leqslant -t\right)}{\Phi(-t)} = e^{-\frac{t^3}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})} [1+o(1)].$$
(2.20)

More generally, for any $\varphi \in \mathscr{B}_{\gamma}$ with $\gamma > 0$ sufficiently small, we have, as $n \to \infty$, uniformly in $x = \mathbb{R}v \in \mathbb{P}(V)$ and $f \in V^*$ with ||v|| = ||f|| = 1, and $t \in [0, o(\sqrt{n})]$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \ge \sqrt{n\sigma t}\right\}}\right]}{1 - \Phi(t)} = e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + o(1)\right], \quad (2.21)$$

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \leqslant -\sqrt{n\sigma t}\right\}}\right]}{\Phi(-t)} = e^{-\frac{t^3}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + o(1)\right]. \quad (2.22)$$

Note that the rate o(1) in (2.19), (2.20), (2.21) and (2.22) depends on the rate $o(\sqrt{n})$ in $t \in [0, o(\sqrt{n})]$.

Theorem 2.8 clearly implies the following moderate deviation principle for the couple $(G_n \cdot x, \log |\langle f, G_n v \rangle|)$ with a target function φ on the Markov chain $(G_n \cdot x)$: under **A1** and **A2**, for any sequence of positive numbers $(b_n)_{n \ge 1}$ satisfying $\frac{b_n}{n} \to 0$ and $\frac{b_n}{\sqrt{n}} \to \infty$, any Borel set $B \subseteq \mathbb{R}$ and realvalued function $\varphi \in \mathscr{B}_{\gamma}$ satisfying $\nu(\varphi) > 0$, we have that uniformly in $x = \mathbb{R}v \in \mathbb{P}(V), v \in V$ and $f \in V^*$ with $\|v\| = \|f\| = 1$,

$$\begin{split} &-\inf_{t\in B^{\circ}}\frac{t^{2}}{2\sigma^{2}}\leqslant \liminf_{n\to\infty}\frac{n}{b_{n}^{2}}\log\mathbb{E}\Big[\varphi(G_{n}\cdot x)\mathbb{1}_{\left\{\frac{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}}{b_{n}}\in B\right\}}\Big]\\ &\leqslant \limsup_{n\to\infty}\frac{n}{b_{n}^{2}}\log\mathbb{E}\Big[\varphi(G_{n}\cdot x)\mathbb{1}_{\left\{\frac{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}}{b_{n}}\in B\right\}}\Big]\leqslant -\inf_{t\in\bar{B}}\frac{t^{2}}{2\sigma^{2}}, \end{split}$$

where B° and \overline{B} are respectively the interior and the closure of B. This moderate deviation principle is new even for $\varphi = 1$.

2.6. Local limit theorem with moderate deviations. In this subsection we state the local limit theorem with moderate deviations and target functions for the coefficients $\langle f, G_n v \rangle$.

Theorem 2.9. Assume A1 and A2. Then, for any real numbers $-\infty < a_1 < a_2 < \infty$, we have, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1, and $|t| = o(\sqrt{n})$,

$$\mathbb{P}\Big(\log|\langle f, G_n v\rangle| - n\lambda_1 \in [a_1, a_2] + \sqrt{n}\sigma t\Big) = \frac{a_2 - a_1}{\sigma\sqrt{2\pi n}} e^{-\frac{t^2}{2} + \frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} [1 + o(1)].$$
(2.23)

More generally, for any $\varphi \in \mathscr{B}_{\gamma}$ with $\gamma > 0$ sufficiently small, and any directly Riemann integrable function ψ with compact support on \mathbb{R} , we have, as $n \to \infty$, uniformly in $x = \mathbb{R}v$, $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1, and $|t| = o(\sqrt{n})$,

$$\mathbb{E}\Big[\varphi(G_n \cdot x)\psi\Big(\log|\langle f, G_n v\rangle| - n\lambda_1 - \sqrt{n\sigma t}\Big)\Big]$$

= $\frac{e^{-\frac{t^2}{2} + \frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})}}{\sigma\sqrt{2\pi n}} \Big[\nu(\varphi)\int_{\mathbb{R}}\psi(u)du + o(1)\Big].$ (2.24)

The asymptotic (2.23) improves the recent results obtained in [25] and [18]: the result in [25] corresponds to the case when t = 0, and that in [18] to the case when t = o(1).

3. PROOFS OF THE LAWS OF LARGE NUMBERS

The following strong law of large numbers for the norm cocycle $\sigma(G_n, x)$ is due to Furstenberg [19]. Recall that Γ_{μ} is irreducible if no proper subspace of V is Γ_{μ} -invariant.

Lemma 3.1 ([19]). Assume $\int_{GL(V)} \log N(g) \mu(dg) < \infty$ and that Γ_{μ} is irreducible. Then, uniformly in $x \in \mathbb{P}(V)$,

$$\lim_{n \to \infty} \frac{\sigma(G_n, x)}{n} = \lambda_1 \quad a.s.,$$

where $\lambda_1 \in \mathbb{R}$ is the first Lyapunov exponent of μ .

In the next lemma, we state two laws of large numbers for $||G_n||$ and $|| \wedge^2 G_n||$. The first law is due to Furstenberg-Kesten [20], which can be proved by Kingman's subadditive ergodic theorem [39]; the second one is also an easy consequence of Kingman's ergodic theorem [39] using the definition of λ_2 given in (2.6).

Lemma 3.2 ([20, 39]). Assume $\int_{GL(V)} \log N(g) \mu(dg) < \infty$. Then, $\lim_{N \to \infty} \frac{1}{2} \log \|G\| = \lambda_{2}$ and $\lim_{N \to \infty} \frac{1}{2} \log \|A^{2}G\| = \lambda_{2} + \lambda_{2}$ a

$$\lim_{n \to \infty} \frac{1}{n} \log \|G_n\| = \lambda_1 \quad and \quad \lim_{n \to \infty} \frac{1}{n} \log \|\wedge^2 G_n\| = \lambda_1 + \lambda_2 \quad a.s.$$

Denote by K the group of isometries of $(V, \|\cdot\|)$ and by A^+ the semigroup $A^+ = \{ \operatorname{diag}(a_1, \ldots, a_d) : a_1 \ge \ldots \ge a_d > 0 \}$, where $\operatorname{diag}(a_1, \ldots, a_d)$ is a diagonal endomorphism under the basis e_1, \ldots, e_d of V. The well known Cartan decomposition states that $\operatorname{GL}(V) = KA^+K$. For every $g \in \operatorname{GL}(V)$, we choose a decomposition (which is not necessarily unique)

$$g = k_g a_g l_g$$

where $k_g, l_g \in K$ and $a_g \in A^+$. Recall that $(e_i^*)_{1 \leq i \leq d}$ is the dual basis in V^* . Set

$$x_g^M = \mathbb{R}k_g e_1$$
 and $y_g^m = \mathbb{R}l_g e_1^*$.

Let g^* denote the adjoint automorphism of $g \in \operatorname{GL}(V)$. Following [5, 6], $x_g^M \in \mathbb{P}(V)$ and $y_g^m \in \mathbb{P}(V^*)$ are called respectively the density point of g and g^* .

The next result is taken from [5, Lemma 4.7].

Lemma 3.3 ([5]). For any $g \in GL(V)$, $x = \mathbb{R}v$ and $y = \mathbb{R}f$ with $v \in V \setminus \{0\}$ and $f \in V^* \setminus \{0\}$, we have

$$\begin{array}{ll} (1) \ \delta(x, y_g^m) \leqslant \frac{\|gv\|}{\|g\|\|v\|} \leqslant \delta(x, y_g^m) + \frac{\|\wedge^2 g\|}{\|g\|^2}, \\ (2) \ \delta(x_g^M, y) \leqslant \frac{\|g^* f\|}{\|g\|\|f\|} \leqslant \delta(x_g^M, y) + \frac{\|\wedge^2 g\|}{\|g\|^2}, \\ (3) \ d(g \cdot x, x_g^M) \delta(x, y_g^m) \leqslant \frac{\|\wedge^2 g\|}{\|g\|^2}. \end{array}$$

Using Lemmas 3.1-3.3, we get the following:

Proposition 3.4. Assume that $\int_{GL(V)} \log N(g)\mu(dg) < \infty$. Assume also that $\lambda_1 > \lambda_2$ and that Γ_{μ} is irreducible. Then, for any $\varepsilon > 0$, we have that

uniformly in $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\lim_{n \to \infty} \mathbb{P}\left(d(G_n \cdot x, x_{G_n}^M) \ge e^{-(\lambda_1 - \lambda_2 - \varepsilon)n}\right) = 0, \tag{3.1}$$

$$\lim_{n \to \infty} \mathbb{P}\left(\delta(x_{G_n}^M, y) \leqslant e^{-\varepsilon n}\right) = 0, \tag{3.2}$$

$$\lim_{n \to \infty} \mathbb{P}\left(\delta(G_n \cdot x, y) \leqslant e^{-\varepsilon n}\right) = 0.$$
(3.3)

Proof. We first prove (3.1). For every $g \in GL(V)$, using the Cartan decomposition $g = k_g a_g l_g$ and the fact that k_g is an isometry of $(V, \|\cdot\|)$, we get that for any $x = \mathbb{R}v \in \mathbb{P}(V)$,

$$d(g \cdot x, x_g^M) = \frac{\|gv \wedge k_g e_1\|}{\|gv\| \|k_g e_1\|} = \frac{\|k_g a_g l_g v \wedge k_g e_1\|}{\|gv\|} = \frac{\|a_g l_g v \wedge e_1\|}{\|gv\|}.$$

Since $a_g = \text{diag}(a_1, \ldots, a_d)$, we have $||a_g l_g v \wedge e_1|| \leq a_2 ||v||$. This, together with the fact that $a_2 = \frac{||\wedge^2 g||}{||g||}$, implies that $d(g \cdot x, x_g^M) \leq \frac{||\wedge^2 g|| ||v||}{||g|| ||gv||}$. Hence, for any $x = \mathbb{R}v \in \mathbb{P}(V)$ and $n \geq 1$,

$$d(G_n \cdot x, x_{G_n}^M) \leqslant \frac{\|\wedge^2 G_n\| \|v\|}{\|G_n\| \|G_nv\|}.$$
(3.4)

By Lemmas 3.1 and 3.2, we get that for any $\varepsilon > 0$, uniformly in $v \in V \setminus \{0\}$,

$$\lim_{n \to \infty} \mathbb{P}\left(\left| \frac{1}{n} \log \frac{\|\wedge^2 G_n\| \|v\|}{\|G_n\| \|G_nv\|} - (\lambda_2 - \lambda_1) \right| \ge \varepsilon \right) = 0,$$

which implies that uniformly in $v \in V \setminus \{0\}$,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\|\wedge^2 G_n\| \|v\|}{\|G_nv\|} \ge e^{-(\lambda_1 - \lambda_2 - \varepsilon)n}\right) = 0.$$

Hence, using (3.4), we obtain (3.1).

We next prove (3.2). By Lemma 3.3 (2), we have that for any $\varepsilon' > 0$ and any $y = \mathbb{R}f$ with $f \in V^* \setminus \{0\}$,

$$\mathbb{P}\left(\delta(x_{G_n}^M, y) \leqslant e^{-\varepsilon' n}\right) \leqslant \mathbb{P}\left(\frac{\|G_n^*f\|}{\|G_n^*\|\|f\|} - \frac{\|\wedge^2 G_n\|}{\|G_n\|^2} \leqslant e^{-\varepsilon' n}\right).$$
(3.5)

Applying Lemma 3.2 and Lemma 3.1 to the measure μ^* (μ^* is the image of the measure μ by the map $g \mapsto g^*$, where g^* is the adjoint automorphism of $g \in GL(V)$), we get that for any $\varepsilon > 0$,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\|\wedge^2 G_n\|}{\|G_n\|^2} \ge e^{-(\lambda_1 - \lambda_2 - \varepsilon)n}\right) = 0,$$
(3.6)

and that for any $y = \mathbb{R}f$ with $f \in V^* \setminus \{0\}$,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\|G_n^*f\|}{\|G_n^*\|\|f\|} \leqslant e^{-\varepsilon n}\right) = 0.$$
(3.7)

From (3.6) we derive that as $n \to \infty$,

$$\mathbb{P}\left(\frac{\|G_{n}^{*}f\|}{\|G_{n}^{*}\|\|f\|} - \frac{\|\wedge^{2} G_{n}\|}{\|G_{n}\|^{2}} \leqslant e^{-\varepsilon' n}\right) \\
\leqslant \mathbb{P}\left(\frac{\|G_{n}^{*}f\|}{\|G_{n}^{*}\|\|f\|} - \frac{\|\wedge^{2} G_{n}\|}{\|G_{n}\|^{2}} \leqslant e^{-\varepsilon' n}, \frac{\|\wedge^{2} G_{n}\|}{\|G_{n}\|^{2}} < e^{-(\lambda_{1} - \lambda_{2} - \varepsilon)n}\right) + o(1) \\
\leqslant \mathbb{P}\left(\frac{\|G_{n}^{*}f\|}{\|G_{n}^{*}\|\|f\|} \leqslant e^{-\varepsilon' n} + e^{-(\lambda_{1} - \lambda_{2} - \varepsilon)n}\right) + o(1) \\
= o(1),$$

where in the last line we used (3.7). This, together with (3.5), gives (3.2).

We finally prove (3.3). Since, for any $a \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$ it holds that $\delta(a, y) = d(a, z)$, where $z = y^{\perp}$ is the element in $\mathbb{P}(V)$ orthogonal to y. By triangular inequality, we have, for all $a, b \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\delta(a,y) = d(a,z) \leqslant d(a,b) + d(b,z) = d(a,b) + \delta(b,y).$$

It follows that

$$\delta(G_n \cdot x, y) \ge \delta(x_{G_n}^M, y) - d(G_n \cdot x, x_{G_n}^M).$$

Therefore, using (3.1), we get that, as $n \to \infty$,

$$\mathbb{P}\left(\delta(G_{n}\cdot x, y) \leqslant e^{-\varepsilon' n}\right) \\
\leqslant \mathbb{P}\left(\delta(x_{G_{n}}^{M}, y) - d(G_{n}\cdot x, x_{G_{n}}^{M}) \leqslant e^{-\varepsilon' n}\right) \\
\leqslant \mathbb{P}\left(\delta(x_{G_{n}}^{M}, y) - d(G_{n}\cdot x, x_{G_{n}}^{M}) \leqslant e^{-\varepsilon' n}, d(G_{n}\cdot x, x_{G_{n}}^{M}) < e^{-(\lambda_{1}-\lambda_{2}-\varepsilon)n}\right) + o(1) \\
\leqslant \mathbb{P}\left(\delta(x_{G_{n}}^{M}, y) \leqslant e^{-\varepsilon' n} + e^{-(\lambda_{1}-\lambda_{2}-\varepsilon)n}\right) + o(1) \\
= o(1),$$

where in the last line we used (3.2). This ends the proof of (3.3).

The following result is a direct consequence of [5, Lemma 4.8].

Lemma 3.5. Assume that $\int_{\mathrm{GL}(V)} \log^2 N(g)\mu(dg) < \infty$ and that condition **A2** holds. Then, for any $\varepsilon > 0$, there exist constants $a_k > 0$ with $\sum_{k=1}^{\infty} a_k < \infty$, such that for all $n \ge k \ge 1$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(\delta(y, G_n \cdot x) \leqslant e^{-\varepsilon k}\right) \leqslant a_k$$

Proof. Denote $G_{n,k} = g_n \dots g_{n-k+1}$ for $n \ge k$. Notice that

$$\mathbb{P}\left(\delta(y, G_n \cdot x) \leqslant e^{-\varepsilon k}\right)$$

= $\int_{\mathrm{GL}(V)^{n-k}} \mathbb{P}\left(\delta(y, G_{n,k}g_{n-k} \dots g_1 \cdot x) \leqslant e^{-\varepsilon k}\right) \mu(dg_{n-k}) \dots \mu(dg_1).$

By [5, Lemma 4.8], for any $\varepsilon > 0$, there exist constants $a_k > 0$ with $\sum_{k=1}^{\infty} a_k < \infty$, such that for all $n \ge k \ge 1$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(\delta(y, G_n \cdot x) \leqslant e^{-\varepsilon k}\right) \leqslant a_k$$

The desired result follows.

Proof of Theorem 2.1. We first prove the assertion (2.7). Note that for any $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$ with ||v|| = ||f|| = 1,

$$\log |\langle f, G_n v \rangle| = \sigma(G_n, x) + \log \delta(y, G_n \cdot x).$$
(3.8)

Using Lemma 3.1 and (3.3), we get that, as $n \to \infty$, $\frac{1}{n} \log |\langle f, G_n v \rangle|$ converges to λ_1 in probability, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1. This, together with the fact that the sequence $\{\frac{1}{n} \log |\langle f, G_n v \rangle|\}_{n \ge 1}$ is uniformly integrable, proves (2.7).

Now we prove the almost sure convergence based on Lemmas 3.1 and 3.5. By Lemma 3.5 and Borel-Cantelli's lemma, we get that for any $\varepsilon > 0$,

$$\liminf_{n \to \infty} \frac{1}{n} \log \delta(y, G_n \cdot x) > -\varepsilon \quad \text{a.s.}$$

Together with Lemma 3.1 and the fact that $\delta(y, G_n \cdot x) \leq 1$, this yields that $\lim_{n\to\infty} \frac{1}{n} \log |\langle f, G_n v \rangle| = \lambda_1$, a.s.

In the proof of Theorem 2.2, we will use the central limit theorem for the norm cocycle $\sigma(G_n, x)$. Under the exponential moment condition A1, this result is due to Le Page [40]. Recently, using the martingale approximation approach and the log-regularity of the invariant measure ν , Benoist and Quint [5] relaxed condition A1 to the optimal second moment condition.

Lemma 3.6 ([5]). Assume that $\int_{\mathrm{GL}(V)} \log^2 N(g) \mu(dg) < \infty$ and that condition **A2** holds. Then, for any $t \in \mathbb{R}$, it holds that uniformly in $x \in \mathbb{P}(V)$,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\sigma(G_n, x) - n\lambda}{\sigma\sqrt{n}} \leqslant t\right) = \Phi(t).$$

Now we prove Theorem 2.2 using Lemmas 3.5 and 3.6.

Proof of Theorem 2.2. By Lemma 3.6 and Slutsky's theorem, it suffices to prove that $\frac{1}{\sigma\sqrt{n}}\log\delta(y,G_n\cdot x)$ converges to 0 in probability, as $n \to \infty$. Namely, we need to show that, for any $\varepsilon > 0$, uniformly in $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\lim_{n \to \infty} \mathbb{P}\left(\frac{\log \delta(y, G_n \cdot x)}{\sigma \sqrt{n}} < -\varepsilon\right) = 0.$$

To prove this, taking $k = \lfloor \sqrt{n} \rfloor$ in Lemma 3.5, we get that uniformly in $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(\frac{\log \delta(y, G_n \cdot x)}{\sigma \sqrt{n}} < -\varepsilon\right) = \mathbb{P}\left(\delta(y, G_n \cdot x) < e^{-\varepsilon \sigma \sqrt{n}}\right) \leqslant a_{\lfloor \sqrt{n} \rfloor},$$

where $a_{\lfloor \sqrt{n} \rfloor}$ converges to 0 as $n \to \infty$, since $\sum_{k=1}^{\infty} a_k < \infty$.

4. PROOF OF THE EDGEWORTH EXPANSION

4.1. Spectral gap properties and a change of measure. For any $z \in \mathbb{C}$ with $|\Re z|$ small enough, we define the complex transfer operator P_z as follows: for any bounded measurable function φ on $\mathbb{P}(V)$,

$$P_z\varphi(x) = \int_{\mathrm{GL}(V)} e^{z\sigma(g,x)}\varphi(g\cdot x)\mu(dg), \quad x \in \mathbb{P}(V).$$
(4.1)

Throughout this paper let $B_{s_0}(0) := \{z \in \mathbb{C} : |z| < s_0\}$ be the open disc with center 0 and radius $s_0 > 0$ in the complex plane \mathbb{C} . The following result shows that the operator P_z has spectral gap properties when $z \in B_\eta(0)$; we refer to [40, 34, 31, 6, 45] for the proof based on the perturbation theory of linear operators. Recall that \mathscr{B}'_{γ} is the topological dual space of the Banach space \mathscr{B}_{γ} , and that $\mathscr{L}(\mathscr{B}_{\gamma}, \mathscr{B}_{\gamma})$ is the set of all bounded linear operators from \mathscr{B}_{γ} to \mathscr{B}_{γ} equipped with the operator norm $\|\cdot\|_{\mathscr{B}_{\gamma} \to \mathscr{B}_{\gamma}}$.

Lemma 4.1 ([6, 45]). Assume A1 and A2. Then, there exists a constant $s_0 > 0$ such that for any $z \in B_{s_0}(0)$ and $n \ge 1$,

$$P_z^n = \kappa^n(z)\nu_z \otimes r_z + L_z^n, \tag{4.2}$$

where

$$z \mapsto \kappa(z) \in \mathbb{C}, \quad z \mapsto r_z \in \mathscr{B}_{\gamma}, \quad z \mapsto \nu_z \in \mathscr{B}'_{\gamma}, \quad z \mapsto L_z \in \mathscr{L}(\mathscr{B}_{\gamma}, \mathscr{B}_{\gamma})$$

are analytic mappings which satisfy, for any $z \in B_{s_0}(0)$,

- (a) the operator $M_z := \nu_z \otimes r_z$ is a rank one projection on \mathscr{B}_{γ} , i.e. $M_z \varphi = \nu_z(\varphi) r_z$ for any $\varphi \in \mathscr{B}_{\gamma}$;
- (b) $M_z L_z = L_z M_z = 0$, $P_z r_z = \kappa(z) r_z$ with $\nu(r_z) = 1$, and $\nu_z P_z = \kappa(z) \nu_z$;
- (c) $\kappa(0) = 1$, $r_0 = 1$, $\nu_0 = \nu$ with ν defined by (2.5), and $\kappa(z)$ and r_z are strictly positive for real-valued $z \in (-s_0, s_0)$.

Using Lemma 4.1, a change of measure can be performed below. Specifically, for any $s \in (-s_0, s_0)$ with $s_0 > 0$ sufficiently small, any $x \in \mathbb{P}(V)$ and $g \in \mathrm{GL}(V)$, denote

$$q_n^s(x,g) = \frac{e^{s\sigma(g,x)}}{\kappa^n(s)} \frac{r_s(g \cdot x)}{r_s(x)}, \quad n \ge 1.$$

Since the eigenvalue $\kappa(s)$ and the eigenfunction r_s are strictly positive for $s \in (-s_0, s_0)$, using $P_s r_s = \kappa(s) r_s$ we get that

$$\mathbb{Q}_{s,n}^x(dg_1,\ldots,dg_n) = q_n^s(x,G_n)\mu(dg_1)\ldots\mu(dg_n), \quad n \ge 1,$$

are probability measures and form a projective system on $\operatorname{GL}(V)^{\mathbb{N}}$. By the Kolmogorov extension theorem, there is a unique probability measure \mathbb{Q}_s^x on $\operatorname{GL}(V)^{\mathbb{N}}$ with marginals $\mathbb{Q}_{s,n}^x$. We write $\mathbb{E}_{\mathbb{Q}_s^x}$ for the corresponding expectation and the change of measure formula holds: for any $s \in (-s_0, s_0)$, $x \in \mathbb{P}(V)$, $n \ge 1$ and bounded measurable function h on $(\mathbb{P}(V) \times \mathbb{R})^n$,

$$\frac{1}{\kappa^n(s)r_s(x)}\mathbb{E}\Big[r_s(G_n\cdot x)e^{s\sigma(G_n,x)}h\Big(G_1\cdot x,\sigma(G_1,x),\dots,G_n\cdot x,\sigma(G_n,x)\Big)\Big]$$
$$=\mathbb{E}_{\mathbb{Q}_s^x}\Big[h\Big(G_1\cdot x,\sigma(G_1,x),\dots,G_n\cdot x,\sigma(G_n,x)\Big)\Big].$$
(4.3)

Under the changed measure \mathbb{Q}_s^x , the process $(G_n \cdot x)_{n \ge 0}$ is a Markov chain with the transition operator Q_s given as follows: for any $\varphi \in \mathscr{C}(\mathbb{P}(V))$,

$$Q_s\varphi(x) = \frac{1}{\kappa(s)r_s(x)}P_s(\varphi r_s)(x), \quad x \in \mathbb{P}(V).$$

Under A1 and A2, it was shown in [45] that the Markov operator Q_s has a unique invariant probability measure π_s given by

$$\pi_s(\varphi) = \frac{\nu_s(\varphi r_s)}{\nu_s(r_s)} \quad \text{for any } \varphi \in \mathscr{C}(\mathbb{P}(V)).$$
(4.4)

By [45, Proposition 3.13], the following strong law of large numbers for the norm cocycle under the changed measure \mathbb{Q}_s^x holds: under A1 and A2, for any $s \in (-s_0, s_0)$ and $x \in \mathbb{P}(V)$,

$$\lim_{n \to \infty} \frac{\sigma(G_n, x)}{n} = \Lambda'(s), \quad \mathbb{Q}_s^x \text{-a.s.}$$

where $\Lambda(s) = \log \kappa(s)$. For any $s \in (-s_0, s_0)$ and $u \in \mathbb{R}$, we define the perturbed operator $R_{s,iu}$ as follows: for $\varphi \in \mathscr{C}(\mathbb{P}(V))$,

$$R_{s,iu}\varphi(x) = \mathbb{E}_{\mathbb{Q}_s^x}\left[e^{iu(\sigma(g,x) - \Lambda'(s))}\varphi(g \cdot x)\right], \quad x \in \mathbb{P}(V).$$
(4.5)

It follows from the cocycle property of $\sigma(\cdot, \cdot)$ that for any $n \ge 1$,

$$R_{s,iu}^n\varphi(x) = \mathbb{E}_{\mathbb{Q}_s^x}\left[e^{iu(\sigma(G_n,x)-n\Lambda'(s))}\varphi(G_n\cdot x)\right], \quad x \in \mathbb{P}(V).$$

The next result gives spectral gap properties of the perturbed operator $R_{s,iu}$.

Lemma 4.2 ([45]). Assume A1 and A2. Then, there exist constants $s_0 > 0$ and $\delta > 0$ such that for any $s \in (-s_0, s_0)$ and $u \in (-\delta, \delta)$,

$$R_{s,iu}^n = \lambda_{s,iu}^n \Pi_{s,iu} + N_{s,iu}^n, \tag{4.6}$$

where

$$\lambda_{s,iu} = e^{\Lambda(s+iu) - \Lambda(s) - iu\Lambda'(s)},\tag{4.7}$$

and for fixed $s \in (-s_0, s_0)$, the mappings $u \mapsto \Pi_{s,iu} : (-\delta, \delta) \to \mathscr{L}(\mathscr{B}_{\gamma}, \mathscr{B}_{\gamma})$, $u \mapsto N_{s,iu} : (-\delta, \delta) \to \mathscr{L}(\mathscr{B}_{\gamma}, \mathscr{B}_{\gamma})$ and $u \mapsto \lambda_{s,iu} : (-\delta, \delta) \to \mathbb{R}$ are analytic. In addition, for fixed s and u, the operator $\Pi_{s,iu}$ is a rank-one projection with $\Pi_{s,0}(\varphi)(x) = \pi_s(\varphi)$ for any $\varphi \in \mathscr{B}_{\gamma}$ and $x \in \mathbb{P}(V)$, and $\Pi_{s,iu}N_{s,iu} = N_{s,iu}\Pi_{s,iu} = 0$.

Moreover, for any $k \in \mathbb{N}$, there exist constants c > 0 and 0 < a < 1 such that

$$\sup_{|s|

$$(4.8)$$$$

We end this subsection by giving the non-arithmetic property of the perturbed operator $R_{s,iu}$.

Lemma 4.3 ([45]). Assume **A1** and **A2**. Then, for any compact set $K \subseteq \mathbb{R} \setminus \{0\}$, there exist constants $s_0, c, C_K > 0$ such that for any $n \ge 1$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\sup_{s \in (-s_0, s_0)} \sup_{u \in K} \sup_{x \in \mathbb{P}(V)} |R_{s, iu}^n \varphi(x)| \leq c e^{-nC_K} \|\varphi\|_{\gamma}.$$

4.2. Exponential Hölder regularity of the invariant measure π_s . We need the following exponential regularity of the invariant measure π_s from [25].

Lemma 4.4 ([25]). Assume A1 and A2. Then there exist constants $s_0 > 0$ and $\eta > 0$ such that

$$\sup_{s \in (-s_0, s_0)} \sup_{y \in \mathbb{P}(V^*)} \int_{\mathbb{P}(V)} \frac{1}{\delta(y, x)^{\eta}} \pi_s(dx) < +\infty.$$

$$(4.9)$$

We also need the following property:

Lemma 4.5 ([25]). Assume A1 and A2. Then, for any $\varepsilon > 0$, there exist constants $s_0 > 0$ and c, C > 0 such that for all $s \in (-s_0, s_0)$, $n \ge k \ge 1$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{Q}_{s}^{x} \Big(\log \delta(y, G_{n} \cdot x) \leqslant -\varepsilon k \Big) \leqslant C e^{-ck}.$$
(4.10)

Note that (4.10) is stronger than the exponential Hölder regularity of the invariant measure π_s stated in Lemma 4.4.

4.3. **Proof of Theorem 2.3.** We shall prove a more general version of Theorem 2.3 under the changed measure \mathbb{Q}_s^x . For any $s \in (-s_0, s_0)$ and $\varphi \in \mathscr{B}_{\gamma}$, define

$$b_{s,\varphi}(x) := \lim_{n \to \infty} \mathbb{E}_{\mathbb{Q}_s^x} \big[(\sigma(G_n, x) - n\Lambda'(s))\varphi(G_n \cdot x) \big], \quad x \in \mathbb{P}(V)$$
(4.11)

and

$$d_{s,\varphi}(y) = \int_{\mathbb{P}(V)} \varphi(x) \log \delta(y, x) \pi_s(dx), \quad y \in \mathbb{P}(V^*).$$
(4.12)

These functions are well-defined as shown in Lemmas 4.7 and 4.8 below. In particular, we have $b_{0,\varphi} = b_{\varphi}$ and $d_{0,\varphi} = d_{\varphi}$, where b_{φ} and d_{φ} are defined in (2.9) and (2.10), respectively.

Our goal of this subsection is to establish the following first-order Edgeworth expansion for the coefficients $\langle f, G_n v \rangle$ under the changed measure \mathbb{Q}_s^x . Note that $\sigma_s = \sqrt{\Lambda''(s)}$, which is strictly positive under A1 and A2.

Theorem 4.6. Assume A1 and A2. Then, for any $\varepsilon > 0$, there exist constants $\gamma > 0$ and $s_0 > 0$ such that uniformly in $s \in (-s_0, s_0)$, $t \in \mathbb{R}$, $x = \mathbb{R}v \in \mathbb{P}(V)$, $y = \mathbb{R}f \in \mathbb{P}(V^*)$ with ||v|| = ||f|| = 1, and $\varphi \in \mathscr{B}_{\gamma}$, as $n \to \infty$,

$$\begin{split} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \left[\varphi(G_{n} \cdot x) \mathbb{1}_{\left\{ \frac{\log |\langle f, G_{n} v \rangle| - n\Lambda'(s)}{\sigma_{s}\sqrt{n}} \leqslant t \right\}} \right] \\ &= \pi_{s}(\varphi) \Big[\Phi(t) + \frac{\Lambda'''(s)}{6\sigma_{s}^{3}\sqrt{n}} (1 - t^{2})\phi(t) \Big] - \frac{b_{s,\varphi}(x) + d_{s,\varphi}(y)}{\sigma_{s}\sqrt{n}} \phi(t) \\ &+ \pi_{s}(\varphi) o\Big(\frac{1}{\sqrt{n}}\Big) + \|\varphi\|_{\gamma} O\Big(\frac{1}{n^{1-\varepsilon}}\Big). \end{split}$$

Theorem 2.3 follows from Theorem 4.6 by taking s = 0.

We begin with some properties of the function $b_{s,\varphi}$ (cf. (4.11)) proved recently in [45].

Lemma 4.7 ([45]). Assume A1 and A2. Then, there exists $s_0 > 0$ such that for any $s \in (-s_0, s_0)$, the function $b_{s,\varphi}$ is well-defined and

$$b_{s,\varphi}(x) = \frac{d\Pi_{s,z}}{dz}\Big|_{z=0}\varphi(x), \quad x \in \mathbb{P}(V).$$
(4.13)

Moreover, there exist constants $\gamma > 0$ and c > 0 such that $b_{s,\varphi} \in \mathscr{B}_{\gamma}$ and $\|b_{s,\varphi}\|_{\gamma} \leq c \|\varphi\|_{\gamma}$ for any $s \in (-s_0, s_0)$.

In addition to Lemma 4.7, we prove the following result on the function $d_{s,\varphi}$ defined in (4.12).

Lemma 4.8. Assume A1 and A2. Then, there exists $s_0 > 0$ such that for any $s \in (-s_0, s_0)$, the function $d_{s,\varphi}$ is well-defined. Moreover, there exist constants $\gamma > 0$ and c > 0 such that $d_{s,\varphi} \in \mathscr{B}^*_{\gamma}$ and $||d_{s,\varphi}||_{\gamma} \leq c ||\varphi||_{\infty}$ for any $s \in (-s_0, s_0)$. *Proof.* Since $a \leq e^a$ for any $a \geq 0$, for any $\eta \in (0, 1)$ we have $-\eta \log \delta(y, x) \leq \delta(y, x)^{-\eta}$, so that

$$-d_{s,\varphi}(y) \leqslant \frac{\|\varphi\|_{\infty}}{\eta} \int_{\mathbb{P}(V)} \frac{1}{\delta(y,x)^{\eta}} \pi_s(dx).$$

Choosing η small enough, by Lemma 4.4, the latter integral is bounded uniformly in $y \in \mathbb{P}(V^*)$ and $s \in (-s_0, s_0)$, which proves that $d_{s,\varphi}$ is well defined and that $||d_{s,\varphi}||_{\infty} \leq c ||\varphi||_{\infty}$.

Note that $|\log(1+a)| \leq c|a|$ for any $|a| \leq \frac{1}{2}$. Then, using this, for any $y' = \mathbb{R}f' \in \mathbb{P}(V^*)$, $y'' = \mathbb{R}f'' \in \mathbb{P}(V^*)$ and any $\gamma > 0$, we deduce that

$$\begin{split} &|\log \delta(y', x) - \log \delta(y'', x)| \\ &= \left| \log \delta(y', x) - \log \delta(y'', x) \right| \mathbb{1}_{\left\{ \left| \frac{\delta(y', x) - \delta(y'', x)}{\delta(y'', x)} \right| > \frac{1}{2} \right\}} \\ &+ \left| \log \delta(y', x) - \log \delta(y'', x) \right| \mathbb{1}_{\left\{ \left| \frac{\delta(y', x) - \delta(y'', x)}{\delta(y'', x)} \right| < \frac{1}{2} \right\}} \\ &\leqslant 2^{\gamma} \left(\left| \log \delta(y', x) \right| + \left| \log \delta(y'', x) \right| \right) \left| \frac{\delta(y', x) - \delta(y'', x)}{\delta(y'', x)} \right|^{\gamma} \\ &+ c^{\gamma} \left| \log \delta(y', x) - \log \delta(y'', x) \right|^{1-\gamma} \left| \frac{\delta(y', x) - \delta(y'', x)}{\delta(y'', x)} \right|^{\gamma} \end{split}$$

Taking into account the fact that $-\eta \log \delta(y, x) \leq \delta(y, x)^{-\eta}$, from the previous bound, we obtain

$$\begin{split} &|\log \delta(y',x) - \log \delta(y'',x)| \\ &\leqslant c_{\eta} \left(\delta(y',x)^{-\eta} \delta(y'',x)^{-\gamma} + \delta(y'',x)^{-\eta-\gamma} \right) |\delta(y',x) - \delta(y'',x)|^{\gamma} \\ &+ c_{\eta,\gamma} \left(\delta(y',x)^{-\eta(1-\gamma)} \delta(y'',x)^{-\gamma} + \delta(y'',x)^{-\eta(1-\gamma)-\gamma} \right) |\delta(y',x) - \delta(y'',x)|^{\gamma} \\ &\leqslant c_{\eta,\gamma} \left(\delta(y',x)^{-\eta} \delta(y'',x)^{-\gamma} + \delta(y'',x)^{-\eta-\gamma} \right) |\delta(y',x) - \delta(y'',x)|^{\gamma} \\ &\leqslant c_{\eta,\gamma} \left(\delta(y',x)^{-2\eta} + \delta(y'',x)^{-2\gamma} + \delta(y'',x)^{-\eta-\gamma} \right) |\delta(y',x) - \delta(y'',x)|^{\gamma} \,. \end{split}$$

Since $\|\frac{f'}{\|f'\|} - \frac{f''}{\|f\|}\| \leq d(y', y'')$ where d(y', y'') is the angular distance on $\mathbb{P}(V^*)$, it follows that

$$\left|\delta(y',x) - \delta(y'',x)\right| = \left|\frac{v(f')}{\|v\|\|f'\|} - \frac{v(f'')}{\|v\|\|f''\|}\right| \le \left\|\frac{f'}{\|f'\|} - \frac{f''}{\|f\|}\right\| \le d(y',y'').$$

By the definition of the function $d_{s,\varphi}$, using the above bounds, we obtain

$$\frac{|d_{s,\varphi}(y') - d_{s,\varphi}(y'')|}{d(y',y'')^{\gamma}} \leq c_{\eta,\gamma} \|\varphi\|_{\infty} \int_{\mathbb{P}(V)} \left(\delta(y',x)^{-2\eta} + \delta(y'',x)^{-2\gamma} + \delta(y'',x)^{-\eta-\gamma}\right) \pi_s(dx).$$

By choosing η and γ sufficiently small, the last integral is bounded uniformly in $y', y'' \in \mathbb{P}(V^*)$ and $s \in (-s_0, s_0)$ by Lemma 4.4. This proves that $d_{s,\varphi} \in \mathscr{B}^*_{\gamma}$.

In the proof of Theorem 2.4 we make use of the following Edgeworth expansion for the couple $(G_n \cdot x, \sigma(G_n, x))$ with a target function on $G_n \cdot x$, which slightly improves [45, Theorem 5.3] by giving more accurate reminder terms. This improvement will be important for establishing Theorem 2.4.

Theorem 4.9. Assume A1 and A2. Then, there exists $s_0 > 0$ such that, as $n \to \infty$, uniformly in $s \in (-s_0, s_0)$, $x \in \mathbb{P}(V)$, $t \in \mathbb{R}$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi(G_n \cdot x) \mathbb{1}_{\left\{ \frac{\sigma(G_n, x) - n\Lambda'(s)}{\sigma_s \sqrt{n}} \leqslant t \right\}} \right] \\ = \pi_s(\varphi) \left[\Phi(t) + \frac{\Lambda'''(s)}{6\sigma_s^3 \sqrt{n}} (1 - t^2) \phi(t) \right] - \frac{b_{s,\varphi}(x)}{\sigma_s \sqrt{n}} \phi(t) \\ + \pi_s(\varphi) o\left(\frac{1}{\sqrt{n}}\right) + \|\varphi\|_{\gamma} O\left(\frac{1}{n}\right).$$

Proof. For any $x \in \mathbb{P}(V)$, define

$$F(t) = \mathbb{E}_{\mathbb{Q}_s^x} \Big[\varphi(G_n \cdot x) \mathbb{1}_{\left\{ \frac{\sigma(G_n, x) - n\Lambda'(s)}{\sigma_s \sqrt{n}} \leqslant t \right\}} \Big] + \frac{b_{s,\varphi}(x)}{\sigma_s \sqrt{n}} \phi(t), \quad t \in \mathbb{R},$$
$$H(t) = \mathbb{E}_{\mathbb{Q}_s^x} [\varphi(G_n \cdot x)] \Big[\Phi(t) + \frac{\Lambda'''(s)}{6\sigma_s^3 \sqrt{n}} (1 - t^2) \phi(t) \Big], \quad t \in \mathbb{R}.$$

Since $F(-\infty) = H(-\infty) = 0$ and $F(\infty) = H(\infty)$, applying Proposition 4.1 of [45] we get that

$$\sup_{t \in \mathbb{R}} |F(t) - H(t)| \leq \frac{1}{\pi} (I_1 + I_2 + I_3 + I_4), \tag{4.14}$$

where

$$I_1 = o\left(\frac{1}{\sqrt{n}}\right) \sup_{t \in \mathbb{R}} |H'(t)|, \quad I_2 \leqslant Ce^{-cn} \|\varphi\|_{\gamma}, \quad I_3 \leqslant \frac{c}{n} \|\varphi\|_{\gamma}, \quad I_4 \leqslant \frac{c}{n} \|\varphi\|_{\gamma}.$$

Here the bounds for I_2 , I_3 and I_4 are obtained in [45]. It is easy to see that

$$I_1 = o\Big(\frac{1}{\sqrt{n}}\Big) \mathbb{E}_{\mathbb{Q}_s^x}\Big[\varphi(G_n \cdot x)\Big].$$

This, together with the fact that

$$\mathbb{E}_{\mathbb{Q}_s^x} \Big[\varphi(G_n \cdot x) \Big] \leqslant \pi_s(\varphi) + C e^{-cn} \|\varphi\|_{\gamma}$$

(cf. Lemma 4.2), proves the theorem.

In the following we shall construct a partition $(\chi_{n,k}^y)_{k\geq 0}$ of the unity on the projective space $\mathbb{P}(V)$, which is similar to the partitions in [48, 25, 18]. In contrast to [48, 25], there is no escape of mass in our partition, which simplifies the proofs. Our partition becomes finer when $n \to \infty$, which allows us to obtain precise expressions for remainder terms in the central limit theorem and thereby to establish the Edgeworth expansion for the coefficients.

Let U be the uniform distribution function on the interval [0,1]: U(t) = tfor $t \in [0,1]$, U(t) = 0 for t < 0 and U(t) = 1 for t > 1. Let $a_n = \frac{1}{\log n}$. Here and below we assume that $n \ge 18$ so that $a_n e^{a_n} \le \frac{1}{2}$. For any integer $k \ge 0$, define

$$U_{n,k}(t) = U\left(\frac{t - (k - 1)a_n}{a_n}\right), \qquad h_{n,k}(t) = U_{n,k}(t) - U_{n,k+1}(t), \quad t \in \mathbb{R}.$$

It is easy to see that $U_{n,m} = \sum_{k=m}^{\infty} h_{n,k}$ for any $m \ge 0$. Therefore, for any $t \ge 0$ and $m \ge 0$, we have

$$\sum_{k=0}^{\infty} h_{n,k}(t) = 1, \quad \sum_{k=0}^{m} h_{n,k}(t) + U_{n,m+1}(t) = 1.$$
(4.15)

Note that, for any $k \ge 0$,

$$\sup_{s,t \ge 0: s \ne t} \frac{|h_{n,k}(s) - h_{n,k}(t)|}{|s - t|} \le \frac{1}{a_n}.$$
(4.16)

For any $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$, set

$$\chi_{n,k}^{y}(x) = h_{n,k}(-\log \delta(y,x))$$
 and $\overline{\chi}_{n,k}^{y}(x) = U_{n,k}(-\log \delta(y,x)),$ (4.17)

where we recall that $-\log \delta(y, x) \ge 0$ for any $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$. From (4.15) we have the following partition of the unity on $\mathbb{P}(V)$: for any $x \in \mathbb{P}(V), y \in \mathbb{P}(V^*)$ and $m \ge 0$,

$$\sum_{k=0}^{\infty} \chi_{n,k}^{y}(x) = 1, \quad \sum_{k=0}^{m} \chi_{n,k}^{y}(x) + \overline{\chi}_{n,m+1}^{y}(x) = 1.$$
(4.18)

Denote by $\operatorname{supp}(\chi_{n,k}^y)$ the support of the function $\chi_{n,k}^y$. It is easy to see that for any $k \ge 0$ and $y \in \mathbb{P}(V^*)$,

$$-\log \delta(y, x) \in [a_n(k-1), a_n(k+1)] \quad \text{for any } x \in \text{supp}(\chi_{n,k}^y).$$
(4.19)

Lemma 4.10. There exists a constant c > 0 such that for any $\gamma \in (0, 1]$, $k \ge 0$ and $y \in \mathbb{P}(V^*)$, it holds $\chi_{n,k}^y \in \mathscr{B}_{\gamma}$ and, moreover,

$$\|\chi_{n,k}^y\|_{\gamma} \leqslant \frac{ce^{\gamma ka_n}}{a_n^{\gamma}}.$$
(4.20)

Proof. Since $\|\chi_{n,k}^y\|_{\infty} \leq 1$, it is enough to give a bound for the modulus of continuity:

$$[\chi^y_{n,k}]_{\gamma} = \sup_{x',x'' \in \mathbb{P}(V): x' \neq x''} \frac{|\chi^y_{n,k}(x') - \chi^y_{n,k}(x'')|}{d(x',x'')^{\gamma}},$$

where d is the angular distance on $\mathbb{P}(V)$ defined by (2.1). Asume that $x' = \mathbb{R}v' \in \mathbb{P}(V)$ and $x'' = \mathbb{R}v'' \in \mathbb{P}(V)$ are such that ||v'|| = ||v''|| = 1. We note that

$$||v' - v''|| \leq \sqrt{2}d(x', x'').$$
 (4.21)

For short denote $B_k = ((k-1)a_n, ka_n]$. Remark that the function $h_{n,k}$ is increasing on B_k and decreasing on B_{k+1} . Set for brevity $t' = -\log \delta(y, x')$ and $t'' = -\log \delta(y, x'')$. First we consider the case when t' and t'' are such that $t', t'' \in B_k$. Then, using (4.17) and (4.16), for any $\gamma \in (0, 1]$, we have

$$\begin{aligned} |\chi_{n,k}^{y}(x') - \chi_{n,k}^{y}(x'')| &= |h_{n,k}(t') - h_{n,k}(t'')|^{1-\gamma} |h_{n,k}(t') - h_{n,k}(t'')|^{\gamma} \\ &\leqslant |h_{n,k}(t') - h_{n,k}(t'')|^{\gamma} \leqslant \frac{|t' - t''|^{\gamma}}{a_{n}^{\gamma}} = \frac{1}{a_{n}^{\gamma}} |\log u' - \log u''|^{\gamma}, \end{aligned}$$
(4.22)

where we set for brevity $u' = \delta(y, x')$ and $u'' = \delta(y, x'')$. Since $u' = e^{-t'}$, $u'' = e^{-t''}$ and $t, t' \in B_k$, we have $u'' \ge e^{-ka_n}$ and $|u' - u''| \le e^{-(k-1)a_n} - e^{-ka_n}$. Therefore,

$$\left|\frac{u'}{u''} - 1\right| = \left|\frac{u' - u''}{u''}\right| \leqslant \frac{e^{-(k-1)a_n} - e^{-ka_n}}{e^{-ka_n}} = e^{a_n} - 1 \leqslant a_n e^{a_n} \leqslant \frac{1}{2},$$

which, together with the inequality $|\log(1+a)| \leq 2|a|$ for any $|a| \leq \frac{1}{2}$, implies

$$\left|\log u' - \log u''\right| = \left|\log\left(1 + \frac{u'}{u''} - 1\right)\right| \le 2\frac{|u' - u''|}{u''}.$$
 (4.23)

Since $u'' \ge e^{-ka_n}$, using the fact that ||v'|| = ||v''|| = 1 and (4.21), we get

$$\frac{|u' - u''|}{u''} \leqslant e^{ka_n} |\delta(y, x') - \delta(y, x'')| = e^{ka_n} \frac{|f(v') - f(v'')|}{\|f\|}$$
$$= e^{ka_n} \frac{|f(v' - v'')|}{\|f\|} \leqslant \sqrt{2} e^{ka_n} d(x', x'').$$
(4.24)

Therefore, from (4.22), (4.23) and (4.24), it follows that for $\gamma \in (0, 1]$,

$$|\chi_{n,k}^{y}(x') - \chi_{n,k}^{y}(x'')| \leq 3 \frac{e^{\gamma k a_n}}{a_n^{\gamma}} d(x', x'')^{\gamma}.$$
(4.25)

The case $t', t'' \in B_k$ is treated in the same way.

To conclude the proof we shall consider the case when $t' = -\log \delta(y, x') \in B_{k-1}$ and $t'' = -\log \delta(y, x'') \in B_k$; the other cases can be handled in the same way. We shall reduce this case to the previous ones. Let $x^* \in \mathbb{P}(V)$

be the point on the geodesic line [x', x''] on $\mathbb{P}(V)$ such that $d(x', x'') = d(x', x^*) + d(x^*, x'')$ and $t^* = -\log \delta(y, x^*) = ka_n$. Then

$$\begin{aligned} |\chi_{n,k}^{y}(x') - \chi_{n,k}^{y}(x'')| &\leq |\chi_{n,k}^{y}(x') - \chi_{n,k}^{y}(x^{*})| + |\chi_{n,k}^{y}(x'') - \chi_{n,k}^{y}(x^{*})| \\ &\leq 3 \frac{e^{\gamma k a_{n}}}{a_{n}^{\gamma}} d(x', x^{*})^{\gamma} + 3 \frac{e^{\gamma k a_{n}}}{a_{n}^{\gamma}} d(x'', x^{*})^{\gamma} \\ &\leq 6 \frac{e^{\gamma k a_{n}}}{a_{n}^{\gamma}} d(x', x'')^{\gamma}. \end{aligned}$$
(4.26)

From (4.25) and (4.26) we conclude that $[\chi_{n,k}^y]_{\gamma} \leq 6 \frac{e^{\gamma kan}}{a_n^{\gamma}}$, which shows (4.20).

We need the following bounds. Let $M_n = \lfloor A \log^2 n \rfloor$, where A > 0 is a constant and n is large enough. It is convenient to denote

$$\varphi_{n,k}^y = \varphi \chi_{n,k}^y \quad \text{for} \quad 0 \le k \le M_n - 1, \quad \varphi_{n,M_n}^y = \varphi \overline{\chi}_{n,M_n}^y.$$
 (4.27)

Lemma 4.11. Assume A1 and A2. Then there exist constants $s_0 > 0$ and c > 0 such that for any $s \in (-s_0, s_0)$, $y \in \mathbb{P}(V^*)$ and any non-negative bounded measurable function φ on $\mathbb{P}(V)$,

$$\sum_{k=0}^{M_n} (k+1)a_n \pi_s(\varphi_{n,k}^y) \leqslant -d_{s,\varphi}(y) + 2a_n \pi_s(\varphi)$$

and

$$\sum_{k=0}^{M_n} (k-1)a_n \pi_s(\varphi_{n,k}^y) \ge -d_{s,\varphi}(y) - 2a_n \pi_s(\varphi) - c \frac{\|\varphi\|_{\infty}}{n^2}.$$

Proof. Recall that $d_{\varphi}(y)$ is defined in (2.10). Using (4.18) we deduce that

$$-d_{s,\varphi}(y) = -\sum_{k=0}^{M_n} \int_{\mathbb{P}(V)} \varphi_{n,k}^y(x) \log \delta(y,x) \pi_s(dx)$$
$$\geqslant \sum_{k=0}^{M_n} (k-1) a_n \pi_s(\varphi_{n,k}^y)$$
$$= \sum_{k=0}^{M_n} (k+1) a_n \pi_s(\varphi_{n,k}^y) - 2a_n \pi_s(\varphi),$$

which proves the first assertion of the lemma.

Using the Markov inequality and the exponential Hölder regularity of the invariant measure π_s (Lemma 4.4), we get that there exists a small $\eta > 0$

such that

$$\begin{split} &-\int_{\mathbb{P}(V)} \varphi_{n,M_n}^y(x) \log \delta(y,x) \pi_s(dx) \\ &\leqslant c \|\varphi\|_{\infty} \int_{\mathbb{P}(V)} \frac{e^{-\eta A \log n}}{\delta(y,x)^{\eta}} \delta(y,x)^{-\eta} \pi_s(dx) \\ &= e^{-\eta A \log n} \|\varphi\|_{\infty} \int_{\mathbb{P}(V)} \delta(y,x)^{-2\eta} \pi_s(dx) \leqslant c \frac{\|\varphi\|_{\infty}}{n^2}, \end{split}$$

where in the last inequality we choose A>0 to be sufficiently large so that $\eta A \geqslant 2.$ Therefore,

$$\begin{aligned} -d_{s,\varphi}(y) &= -\sum_{k=0}^{M_n} \int_{\mathbb{P}(V)} \varphi_{n,k}^y(x) \log \delta(y,x) \pi_s(dx) \\ &\leqslant \sum_{k=0}^{M_n-1} (k+1) a_n \pi_s(\varphi_{n,k}^y) + c \frac{\|\varphi\|_{\infty}}{n^2} \\ &\leqslant \sum_{k=0}^{M_n-1} (k-1) a_n \pi_s(\varphi_{n,k}^y) + 2a_n \pi_s(\varphi) + c \frac{\|\varphi\|_{\infty}}{n^2} \\ &\leqslant \sum_{k=0}^{M_n} (k-1) a_n \pi_s(\varphi_{n,k}^y) + 2a_n \pi_s(\varphi) + c \frac{\|\varphi\|_{\infty}}{n^2}. \end{aligned}$$

This proves the second assertion of the lemma.

Proof of Theorem 4.6. Without loss of generality, we assume that the target function φ is non-negative. With the notation in (4.27), we have

$$I_{n}(t) := \mathbb{E}_{\mathbb{Q}_{s}^{x}} \left[\varphi(G_{n} \cdot x) \mathbb{1}_{\left\{ \frac{\log |\langle f, G_{n} v \rangle| - n\lambda_{1}}{\sigma_{s} \sqrt{n}} \leqslant t \right\}} \right]$$
$$= \sum_{k=0}^{M_{n}} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \left[\varphi_{n,k}^{y}(G_{n} \cdot x) \mathbb{1}_{\left\{ \frac{\log |\langle f, G_{n} v \rangle| - n\lambda_{1}}{\sigma_{s} \sqrt{n}} \leqslant t \right\}} \right] =: \sum_{k=0}^{M_{n}} F_{n,k}(t). \quad (4.28)$$

For $0 \leq k \leq M_n - 1$, using (1.7) and the fact that $-\log \delta(y, x) \leq (k+1)a_n$ when $x \in \operatorname{supp} \varphi_{n,k}^y$, we get

$$F_{n,k}(t) \leq \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{n,k}^y(G_n \cdot x) \mathbb{1}_{\left\{ \frac{\sigma(G_n,x) - n\lambda_1}{\sigma_s \sqrt{n}} \leq t + \frac{(k+1)a_n}{\sigma_s \sqrt{n}} \right\}} \right] =: H_{n,k}(t).$$
(4.29)

For $k = M_n$, we have

$$F_{n,M_n}(t) \leq \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{n,M_n}^y(G_n \cdot x) \mathbb{1}_{\left\{ \frac{\log \sigma(G_n,x) - n\lambda_1}{\sigma_s \sqrt{n}} \leq t + \frac{(M_n + 1)a_n}{\sigma_s \sqrt{n}} \right\}} \right] \\ + \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{n,M_n}^y(G_n \cdot x) \mathbb{1}_{\left\{ -\log \delta(y,G_n \cdot x) \geq (M_n + 1)a_n \right\}} \right] \\ =: H_{n,M_n}(t) + W_n(t),$$

$$(4.30)$$

where, by Lemma 4.5, choosing A large enough,

$$W_n(t) \leq \|\varphi\|_{\infty} \mathbb{Q}_s^x(-\log \delta(y, G_n \cdot x) \geq A \log n)$$

$$\leq \|\varphi\|_{\infty} \frac{c_0}{n^{c_1 A}} \leq \|\varphi\|_{\infty} \frac{c_0}{n^2}.$$
 (4.31)

Now we deal with $H_{n,k}(t)$ for $0 \leq k \leq M_n$. Denote for short $t_{n,k} = t + \frac{(k+1)a_n}{\sigma_s\sqrt{n}}$. Applying the Edgeworth expansion (Theorem 4.9) we obtain that, uniformly in $s \in (-s_0, s_0), x \in \mathbb{P}(V), t \in \mathbb{R}, 0 \leq k \leq M_n$ and $\varphi \in \mathscr{B}_{\gamma}$, as $n \to \infty$,

$$H_{n,k}(t) = \pi_s(\varphi_{n,k}^y) \Big[\Phi(t_{n,k}) + \frac{\Lambda'''(s)}{6\sigma_s^3 \sqrt{n}} (1 - t_{n,k}^2) \phi(t_{n,k}) \Big] \\ - \frac{b_{s,\varphi_{n,k}^y}(x)}{\sigma_s \sqrt{n}} \phi(t_{n,k}) + \pi_s(\varphi_{n,k}^y) o\Big(\frac{1}{\sqrt{n}}\Big) + \|\varphi_{n,k}^y\|_{\gamma} O\Big(\frac{1}{n}\Big).$$

By the Taylor expansion we have, uniformly in $s \in (-s_0, s_0), x \in \mathbb{P}(V), t \in \mathbb{R}$ and $0 \leq k \leq M_n$,

$$\Phi(t_{n,k}) = \Phi(t) + \phi(t) \frac{(k+1)a_n}{\sigma_s \sqrt{n}} + O\left(\frac{\log^2 n}{n}\right)$$

and

$$(1 - t_{n,k}^2)\phi(t_{n,k}) = (1 - t^2)\phi(t) + O\left(\frac{\log n}{\sqrt{n}}\right).$$

Moreover, using Lemma 4.7,

$$\frac{b_{s,\varphi_{n,k}^y}(x)}{\sigma_s\sqrt{n}}\phi(t_{n,k}) = \frac{b_{s,\varphi_{n,k}^y}(x)}{\sigma_s\sqrt{n}}\phi(t) + \|\varphi_{n,k}^y\|_{\gamma}O\Big(\frac{\log n}{n}\Big).$$

Using these expansions and (4.29), (4.30) and (4.31), we get that there exists a sequence $(\beta_n)_{n\geq 1}$ of positive numbers satisfying $\beta_n \to 0$ as $n \to \infty$, such that for any $0 \leq k \leq M_n$,

$$F_{n,k}(t) \leq \pi_s(\varphi_{n,k}^y) \Big[\Phi(t) + \frac{\Lambda'''(s)}{6\sigma_s^3 \sqrt{n}} (1 - t^2) \phi(t) \Big] - \frac{b_{s,\varphi_{n,k}^y}(x)}{\sigma_s \sqrt{n}} \phi(t) + \frac{\phi(t)}{\sigma_s \sqrt{n}} \pi_s(\varphi_{n,k}^y) (k+1) a_n + \pi_s(\varphi_{n,k}^y) \frac{\beta_n}{\sqrt{n}} + \|\varphi_{n,k}^y\|_{\gamma} \frac{c \log n}{n}.$$
(4.32)

By Lemma 4.10, it holds that for any $\gamma \in (0, 1]$ and $0 \leq k \leq M_n$,

$$\|\varphi_{n,k}^{y}\|_{\gamma} \leqslant c \|\varphi\|_{\infty} n^{\gamma A} \log^{\gamma} n + \|\varphi\|_{\gamma}.$$

$$(4.33)$$

Summing up over k in (4.32), using (4.33) and taking $\gamma > 0$ to be sufficiently small such that $\gamma A < \varepsilon/2$, we obtain

$$I_n(t) = \sum_{k=0}^{M_n} F_{n,k} \leqslant \pi_s(\varphi) \Big[\Phi(t) + \frac{\Lambda''(s)}{6\sigma_s^3 \sqrt{n}} (1 - t^2) \phi(t) \Big] - \frac{b_{s,\varphi}(x)}{\sigma_s \sqrt{n}} \phi(t) + \frac{\phi(t)}{\sigma_s \sqrt{n}} \sum_{k=0}^{M_n} \pi_s(\varphi_{n,k}^y) (k+1) a_n + \pi_s(\varphi) \frac{\beta_n}{\sqrt{n}} + \|\varphi\|_{\gamma} \frac{c}{n^{1-\varepsilon}}.$$
(4.34)

Combining (4.34) and Lemma 4.11, together with the fact that $a_n \to 0$ as $n \to \infty$, yields the desired upper bound.

The lower bound is established in the same way. Instead of (4.32) we use the following bound, which is obtained using (1.7) and the fact that $-\log \delta(y, x) \ge (k-1)a_n$ for $x \in \operatorname{supp} \varphi_{n,k}^y$ and $0 \le k \le M_n$,

$$F_{n,k}(t) \ge \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{n,k}^y(G_n \cdot x) \mathbb{1}_{\left\{ \frac{\sigma(G_n, x) - n\lambda_1}{\sigma_s \sqrt{n}} \leqslant t + \frac{(k-1)a_n}{\sigma_s \sqrt{n}} \right\}} \right].$$
(4.35)

Proceeding in the same way as in the proof of the upper bound, using (4.35) instead of (4.29) and (4.30), we get

$$\begin{split} I_n(t) &= \sum_{k=0}^{M_n} F_{n,k} \geqslant \pi_s(\varphi) \Big[\Phi(t) + \frac{\Lambda'''(s)}{6\sigma_s^3 \sqrt{n}} (1-t^2) \phi(t) \Big] \\ &- \frac{b_{s,\varphi}(x)}{\sigma_s \sqrt{n}} \phi(t) + \frac{\phi(t)}{\sigma_s \sqrt{n}} \sum_{k=0}^{M_n} \pi_s(\varphi_{n,k}^y) (k-1) a_n \\ &+ \pi_s(\varphi) o\Big(\frac{1}{\sqrt{n}}\Big) + \|\varphi\|_{\gamma} O\Big(\frac{1}{n^{1-\varepsilon}}\Big). \end{split}$$

The lower bound is obtained using again Lemma 4.11.

5. Proof of the subexponential regularity and applications

In this section we first establish Theorem 2.6 on the regularity of the invariant measure ν under a sub-exponential moment condition. Then we shall apply Theorem 2.6 to prove Theorem 2.5 on the Berry-Esseen type bound for the coefficients $\langle f, G_n v \rangle$, and Theorem 2.7 on the moderate deviation principle for $\langle f, G_n v \rangle$ also under a sub-exponential moment condition.

5.1. **Proof of Theorem 2.6.** The following moderate deviation principle is proved in [14] under a subexponential moment condition.

Lemma 5.1 ([14]). Assume A2. Assume also that $\int_{GL(V)} \log^2 N(g) \mu(dg) < \infty$ and

$$\limsup_{n \to \infty} \frac{n}{b_n^2} \log \left[n\mu \left(\log N(g) > b_n \right) \right] = -\infty, \tag{5.1}$$

where $(b_n)_{n\geq 1}$ is a sequence of positive numbers satisfying $\frac{b_n}{n} \to 0$ and $\frac{b_n}{\sqrt{n}} \to \infty$ as $n \to \infty$. Then, for any Borel set $B \subset \mathbb{R}$,

$$-\inf_{t\in B^{\circ}}\frac{t^{2}}{2\sigma^{2}} \leqslant \liminf_{n\to\infty}\frac{n}{b_{n}^{2}}\log\inf_{x\in\mathbb{P}(V)}\mathbb{P}\left(\frac{\sigma(G_{n},x)-n\lambda_{1}}{b_{n}}\in B\right)$$
$$\leqslant \limsup_{n\to\infty}\frac{n}{b_{n}^{2}}\log\sup_{x\in\mathbb{P}(V)}\mathbb{P}\left(\frac{\sigma(G_{n},x)-n\lambda_{1}}{b_{n}}\in B\right)\leqslant -\inf_{t\in\bar{B}}\frac{t^{2}}{2\sigma^{2}},$$

where B° and \overline{B} are respectively the interior and the closure of B.

The following result is an easy consequence of Lemma 5.1.

Lemma 5.2. Assume the conditions of Lemma 5.1. Then, there exist constants c, c' > 0 and $n_0 \in \mathbb{N}$ such that for any $n \ge n_0$ and $v \in V \setminus \{0\}$,

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\frac{\|G_nv\|}{\|v\|} \ge e^{\lambda_1 n + b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}},\tag{5.2}$$

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\frac{\|G_nv\|}{\|v\|} \leqslant e^{\lambda_1 n - b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}},\tag{5.3}$$

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|G_n\| \ge e^{\lambda_1 n + b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}},\tag{5.4}$$

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|G_n\| \leqslant e^{\lambda_1 n - b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}.$$
(5.5)

Proof. Inequalities (5.2) and (5.3) are direct consequences of Lemma 5.1. By (5.2) and the fact that $||G_n|| \ge \frac{||G_n v||}{||v||}$, the first inequality in (5.4) follows. To show the second inequality in (5.4), since all matrix norms on V are

equivalent, we get

$$\mathbb{P}\left(\|G_n\| \ge e^{n\lambda_1 + b_n}\right) \leqslant \mathbb{P}\left(\max_{1 \le i \le d} \|G_n e_i\| \ge e^{n\lambda_1 + b_n}\right)$$
$$\leqslant \sum_{i=1}^d \mathbb{P}\left(\|G_n e_i\| \ge e^{n\lambda_1 + b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}},$$

where the last inequality holds due to (5.2). This concludes the proof of (5.4). Using (5.3), the proof of (5.5) can be carried out in the same way as that of (5.4).

The following purely algebraic result is due to Chevalley [11]; see also Bougerol and Lacroix [7, page 125, Lemma 5.5].

Lemma 5.3 ([11, 7]). Let G be an irreducible subgroup of GL(V). Then, for any integer $1 \leq p \leq d$, there exists a direct-sum decomposition of the p-th exterior power: $\wedge^p(V) = V_1 \oplus \ldots \oplus V_k$ such that $(\wedge^p g)V_j = V_j$ for any $g \in G$ and $1 \leq j \leq k$. Moreover, $\wedge^p(G) := \{\wedge^p g : g \in G\}$ is irreducible on each subspace $V_j, j = 1, \dots, k$.

Using Lemma 5.3 and the strategies from [7, 46], we extend (5.4) and (5.5) to the exterior product $\wedge^p G_n$.

Lemma 5.4. Assume the conditions of Lemma 5.1. Let $1 \leq p \leq d$ be an integer. Then there exist constants c, c' > 0 and $n_0 \in \mathbb{N}$ such that for any $n \geq n_0$,

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|\wedge^p G_n\| \geqslant e^{n\sum_{i=1}^p \lambda_i + b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}},\tag{5.6}$$

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|\wedge^p G_n\| \leqslant e^{n\sum_{i=1}^p \lambda_i - b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}.$$
(5.7)

Proof. We first prove (5.6). Since the Lyapunov exponents $(\lambda_p)_{1 \leq p \leq d}$ of μ are given by $\lambda_1 > \lambda_2 \geq \ldots \geq \lambda_d$, the two largest Lyapunov exponents of $\wedge^p G_n$ satisfy $\sum_{i=1}^p \lambda_i > \sum_{i=2}^{p+1} \lambda_i$ (see [7]), where we use the convention that $\lambda_{d+1} = \lambda_d$. Without loss of generality, we can assume that $\sum_{i=1}^p \lambda_i = 0$; otherwise we replace $\wedge^p G_n$ by $e^{-\sum_{i=1}^p \lambda_i} \wedge^p G_n$.

Since the action of $\wedge^p G_n$ on $\wedge^p V$ is in general not irreducible, we need to consider a decomposition of $\wedge^p V$. Applying Lemma 5.3 to $G = G_{\mu}$ (the smallest closed subgroup of $\operatorname{GL}(V)$ generated by the support of μ), we get the following direct-sum decomposition of the *p*-th exterior power $\wedge^p V \colon \wedge^p V = V_1 \oplus V_2 \oplus \ldots \oplus V_k$, where V_j are subspaces of $\wedge^p V$ such that $(\wedge^p g)V_j = V_j$ for any $g \in G_{\mu}$ and $1 \leq j \leq k$. Moreover, $\wedge^p(G_{\mu}) := \{\wedge^p g :$ $g \in G_{\mu}\}$ is irreducible on each subspace V_j . Since the set of all Lyapunov exponents of $\wedge^p G_n$ on the space $\wedge^p V$ coincides with the union of all the Lyapunov exponents of $(\wedge^p G_n)$ restricted to each subspace V_j , $1 \leq j \leq k$, we can choose V_1 in such a way that the restrictions of $\wedge^p G_n$ to V_1 and $V'_1 := V_2 \oplus \ldots \oplus V_k$, denoted respectively by G'_n and G''_n , satisfy:

$$\|\wedge^{p} G_{n}\| = \max\{\|G_{n}'\|, \|G_{n}''\|\},$$
(5.8)

and a.s.,

$$\lim_{n \to \infty} \frac{1}{n} \log \|G'_n\| = \sum_{i=1}^p \lambda_i = 0 \quad \text{and} \quad \lim_{n \to \infty} \frac{1}{n} \log \|G''_n\| = \sum_{i=2}^{p+1} \lambda_i < 0.$$
(5.9)

Here, G'_n and G''_n are products of i.i.d. random variables of the form $G'_n = g'_n \cdots g'_1$ and $G''_n = g''_n \cdots g''_1$. We denote by μ_1 the law of the random variable g_1 , by d_1 the dimension of the vector space V_1 , and by Γ_{μ_1} the smallest closed subsemigroup of $\operatorname{GL}(V_1)$ generated by the support of μ_1 . Then, following the analogous argument used in the proof of the central limit theorem for $||G_n||$ (see [7, Theorem V.5.4]), one can verify that the semigroup Γ_{μ_1} is strongly irreducible and proximal on V_1 . Therefore, we can apply the moderate deviation bounds (5.4) and (5.5) (with G_n replaced by G'_n) to get

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|G_n'\| \geqslant e^{b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}, \quad e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|G_n'\| \leqslant e^{-b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}.$$
(5.10)

From (5.8) and (5.10), the lower bound of (5.6) easily follows:

$$e^{-c'\frac{b_n^2}{n}} \leqslant \mathbb{P}\left(\|\wedge^p G_n\| \ge e^{b_n}\right).$$
(5.11)

Now we prove the upper bound of (5.6). Since the first Lyapunov exponent of the sequence $(G''_n)_{n\geq 1}$ is strictly less than 0 (see (5.9)), we have

$$\frac{1}{m}\mathbb{E}(\log \|G_m''\|) < 0$$

for sufficiently large integer $m \ge 1$. If we write n = km + r with $k \ge 1$ and $0 \le r < m$, then we have the identity

$$G_n'' = [G_n''(G_{km}'')^{-1}] [G_{km}''(G_{(k-1)m}'')^{-1}] \dots [G_{2m}''(G_m'')^{-1}] G_m''$$

and hence

$$\log \|G_n''\| \le \log \|G_n''(G_{km}'')^{-1}\| + \log \|G_{km}'(G_{(k-1)m}'')^{-1}\| + \ldots + \log \|G_m''\|.$$
(5.12)

For fixed integer $m \ge 1$, we denote $u_m := -\mathbb{E}(\log \|G''_m\|) > 0$. Then,

$$\mathbb{P}(\log \|G_n''\| \ge 0) \le \mathbb{P}\left(\log \|G_n''(G_{km}'')^{-1}\| \ge k\frac{u_m}{2}\right) + \mathbb{P}\left(\log \|G_{km}''(G_{(k-1)m}'')^{-1}\| + \dots + \log \|G_m''\| + ku_m \ge k\frac{u_m}{2}\right).$$
(5.13)

For the first term, using (5.8) and the inequality $\|\wedge^p g\| \leq \|g\|^p$ for any $g \in \Gamma_{\mu}$, we get

$$\mathbb{P}\left(\log \|G_n''(G_{km}'')^{-1}\| \ge k\frac{u_m}{2}\right) = \mathbb{P}\left(\log \|G_r''\| \ge k\frac{u_m}{2}\right) \\
\leqslant \mathbb{P}\left(\log \|\wedge^p G_r\| \ge k\frac{u_m}{2}\right) = \mathbb{P}\left(\sum_{i=1}^r \log \|\wedge^p g_i\| \ge k\frac{u_m}{2}\right) \\
\leqslant \sum_{i=1}^r \mathbb{P}\left(\log \|\wedge^p g_1\| \ge k\frac{u_m}{2r}\right) \leqslant \sum_{i=1}^r \mathbb{P}\left(\log \|g_1\| \ge k\frac{u_m}{2rp}\right) \\
\leqslant \frac{c}{k}e^{-c\frac{b_k^2}{k}},$$
(5.14)

where in the last inequality we use condition (5.1). The second term on the right hand side of (5.13) is dominated by $e^{-cb_k^2/k}$, by using the moderate deviation bounds for sums of i.i.d. real-valued random variables. This, together with (5.14), (5.13) and the fact that $k \ge n/(m+1)$, yields that

$$\mathbb{P}(\log \|G_n''\| \ge 0) \le e^{-c\frac{b_n^2}{n}}.$$
(5.15)

From (5.8), (5.10) and (5.15), we derive that

$$\mathbb{P}\left(\|\wedge^{p} G_{n}\| \ge e^{b_{n}}\right) \leqslant \mathbb{P}\left(\|G_{n}'\| \ge e^{b_{n}}\right) + \mathbb{P}\left(\|G_{n}''\| \ge e^{b_{n}}\right) \leqslant 2e^{-c\frac{b_{n}^{2}}{n}}.$$

Combining this with (5.11), we get (5.6).

The proof of (5.7) can be carried out in a similar way.

Our next result is an analog of Proposition 3.4 under a subexponential moment assumption.

Proposition 5.5. Assume the conditions of Lemma 5.1. Then, there exist constants c > 0 and $n_0 \in \mathbb{N}$ such that for any $n \ge n_0$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(d(G_n \cdot x, x_{G_n}^M) \ge e^{-(\lambda_1 - \lambda_2)n + b_n}\right) \le e^{-c\frac{b_n^2}{n}},\tag{5.16}$$

$$\mathbb{P}\left(\delta(x_{G_n}^M, y) \leqslant e^{-b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}},\tag{5.17}$$

$$\mathbb{P}\left(\delta(G_n \cdot x, y) \leqslant e^{-b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}.$$
(5.18)

Proof. We first prove (5.16). By (3.4), we have

$$\mathbb{P}\left(d(G_n \cdot x, x_{G_n}^M) \ge e^{-(\lambda_1 - \lambda_2)n + b_n}\right) \le \mathbb{P}\left(\frac{\|\wedge^2 G_n\| \|v\|}{\|G_n\| \|G_nv\|} \ge e^{-(\lambda_1 - \lambda_2)n + b_n}\right) =: I_n$$

Using (5.3) gives

$$I_n \leqslant \mathbb{P}\left(\frac{\|\wedge^2 G_n\| \|v\|}{\|G_n\| \|G_nv\|} \geqslant e^{-(\lambda_1 - \lambda_2)n + b_n}, \frac{\|G_nv\|}{\|v\|} > e^{\lambda_1 n - \frac{b_n}{3}}\right) + e^{-c\frac{b_n^2}{n}} \\ \leqslant \mathbb{P}\left(\frac{\|\wedge^2 G_n\|}{\|G_n\|} \geqslant e^{\lambda_2 n + \frac{2}{3}b_n}\right) + e^{-c\frac{b_n^2}{n}}.$$

In the same way, from (5.5) and (5.6) it follows that

$$I_{n} \leq \mathbb{P}\left(\frac{\|\wedge^{2} G_{n}\|}{\|G_{n}\|} \geq e^{\lambda_{2}n + \frac{2}{3}b_{n}}, \|G_{n}\| > e^{\lambda_{1}n - \frac{1}{3}b_{n}}\right) + 2e^{-c\frac{b_{n}^{2}}{n}}$$
$$\leq \mathbb{P}\left(\|\wedge^{2} G_{n}\| \geq e^{(\lambda_{1} + \lambda_{2})n + \frac{1}{3}b_{n}}\right) + 2e^{-c\frac{b_{n}^{2}}{n}}$$
$$\leq 3e^{-c\frac{b_{n}^{2}}{n}}, \tag{5.19}$$

which concludes the proof of (5.16).

We next prove (5.17). By Lemma 3.3 (2), we have that for any $y = \mathbb{R}f$ with $f \in V^* \setminus \{0\}$,

$$\mathbb{P}\left(\delta(x_{G_n}^M, y) \leqslant e^{-b_n}\right) \leqslant \mathbb{P}\left(\frac{\|G_n^*f\|}{\|G_n^*\|\|f\|} - \frac{\|\wedge^2 G_n\|}{\|G_n\|^2} \leqslant e^{-b_n}\right) =: J_n.$$
(5.20)

Following the proof of (5.19), one has

$$\mathbb{P}\left(\frac{\|\wedge^2 G_n\|}{\|G_n\|^2} \ge e^{-(\lambda_1 - \lambda_2)n + b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}.$$

Using this together with (5.3) and (5.4) applied to the measure μ^* (μ^* is the image of the measure μ by the map $g \mapsto g^*$, where g^* is the adjoint automorphism of $g \in GL(V)$ acting on the dual space V^*), we get

$$\begin{split} J_n &\leqslant \mathbb{P}\left(\frac{\|G_n^*f\|}{\|G_n^*\|\|f\|} - \frac{\|\wedge^2 G_n\|}{\|G_n\|^2} \leqslant e^{-b_n}, \frac{\|\wedge^2 G_n\|}{\|G_n\|^2} < e^{-(\lambda_1 - \lambda_2)n + b_n}\right) + e^{-c\frac{b_n^2}{n}} \\ &\leqslant \mathbb{P}\left(\frac{\|G_n^*f\|}{\|G_n^*\|\|f\|} \leqslant 2e^{-b_n}\right) + e^{-c\frac{b_n^2}{n}} \\ &\leqslant \mathbb{P}\left(\frac{\|G_n^*f\|}{\|G_n^*\|\|f\|} \leqslant 2e^{-b_n}, \|G_n^*\| \leqslant e^{\lambda_1 n + \frac{b_n}{2}}\right) + 2e^{-c\frac{b_n^2}{n}} \\ &\leqslant \mathbb{P}\left(\frac{\|G_n^*f\|}{\|f\|} \leqslant 2e^{\lambda_1 n - \frac{b_n}{2}}\right) + 2e^{-c\frac{b_n^2}{n}} \\ &\leqslant 3e^{-c\frac{b_n^2}{n}}, \end{split}$$

which ends the proof of (5.17).

We finally prove (5.18). Since

 \mathbb{P}

 $\leqslant e^{-c\frac{b_n^2}{n}},$

$$\delta(G_n \cdot x, y) \ge \delta(x_{G_n}^M, y) - d(G_n \cdot x, x_{G_n}^M),$$

using (5.16), (5.17) and the fact that $\lambda_1 > \lambda_2$, we get
$$\mathbb{P}\left(\delta(G_n \cdot x, y) \le e^{-b_n}\right)$$
$$\le \mathbb{P}\left(\delta(x_{G_n}^M, y) - d(G_n \cdot x, x_{G_n}^M) \le e^{-b_n}\right)$$
$$\le \mathbb{P}\left(\delta(x_{G_n}^M, y) - d(G_n \cdot x, x_{G_n}^M) \le e^{-b_n}, d(G_n \cdot x, x_{G_n}^M) < e^{-(\lambda_1 - \lambda_2)n + b_n}\right) + e^{-c\frac{b_n^2}{n}}$$
$$\le \mathbb{P}\left(\delta(x_{G_n}^M, y) \le e^{-b_n} + e^{-(\lambda_1 - \lambda_2)n + b_n}\right) + e^{-c\frac{b_n^2}{n}}$$

which concludes the proof of
$$(5.18)$$
.

As a consequence of Proposition 5.5, we get the following:

Proposition 5.6. Assume the conditions of Lemma 5.1. Then there exist constants c > 0 and $k_0 \in \mathbb{N}$ such that for all $n \ge k \ge k_0$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*),$

$$\mathbb{P}\left(\delta(G_n \cdot x, y) \leqslant e^{-b_k}\right) \leqslant e^{-c\frac{b_k^2}{k}}.$$
(5.21)

Moreover, there exist constants c > 0 and $n_0 > 0$ such that for any $n \ge n_0$ and $y \in \mathbb{P}(V^*)$,

$$\nu\left(x \in \mathbb{P}(V) : \delta(x, y) \leqslant e^{-b_n}\right) \leqslant e^{-c\frac{b_n^2}{n}}.$$
(5.22)

Proof. By using (5.18), the proof of (5.21) is similar to that of Lemma 3.5. Inequality (5.22) is a consequence of (5.18) and the fact that ν is the unique invariant measure of the Markov chain $(G_n \cdot x)_{n \ge 0}$.

Proof of Theorem 2.6. As a particular case of (5.21), by taking $b_k = k^{\beta}$ with $\beta \in (\frac{1}{2}, 1)$, we get that if **A2** holds and $\mu(\log N(g) > u) \leq \exp\{-u^{\frac{2\beta-1}{\beta}}a(u)\}$ for any u > 0 and for some function a(u) > 0 satisfying $a(u) \to \infty$ as $u \to \infty$, then there exist constants c > 0 and $k_0 \in \mathbb{N}$ such that for all $n \ge k \ge k_0$, $x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(\delta(G_n \cdot x, y) \leqslant e^{-k^{\beta}}\right) \leqslant \exp\left\{-ck^{2\beta-1}\right\}.$$

Letting $\alpha = \frac{2\beta - 1}{\beta}$, this implies that if **A2** holds and $\mu(\log N(g) > u) \leq$ $\exp\{-u^{\alpha}l_u\}$ for some $\alpha \in (0,1)$ and any u > 0, then there exist constants c > 0 and $k_0 \in \mathbb{N}$ such that for all $n \ge k \ge k_0, x \in \mathbb{P}(V)$ and $y \in \mathbb{P}(V^*)$,

$$\mathbb{P}\left(\delta(G_n \cdot x, y) \leqslant e^{-k}\right) \leqslant \exp\left\{-ck^{\alpha}\right\}.$$

This proves (2.14).

Now we prove (2.15). Taking k = n in (2.14), we get that there exist constants $c_0 > 0$ and $n_0 > 0$ such that for any $n \ge n_0$ and $y \in \mathbb{P}(V^*)$,

$$\nu\left(x \in \mathbb{P}(V) : \delta(x, y) \leqslant e^{-n}\right) \leqslant e^{-c_0 n^{\alpha}}.$$
(5.23)

Set $B_{n,y} := \{x \in \mathbb{P}(V) : e^{-(n+1)} \leq \delta(x,y) \leq e^{-n}\}$ for $y \in \mathbb{P}(V^*)$ and $n \geq 1$. From (5.23) we deduce that for any $\eta \in (0, c_0)$, uniformly in $y \in \mathbb{P}(V^*)$,

$$\int_{\mathbb{P}(V)} \exp\left(\eta |\log \delta(x, y)|^{\alpha}\right) \nu(dx)$$

$$\leqslant e^{\eta n_0^{\alpha}} + \sum_{n=n_0}^{\infty} \int_{B_{n,y}} \exp\left(\eta |\log \delta(x, y)|^{\alpha}\right) \nu(dx)$$

$$\leqslant e^{\eta n_0^{\alpha}} + \sum_{n=n_0}^{\infty} e^{-(c_0 - \eta)n^{\alpha}} < \infty, \qquad (5.24)$$

since $\alpha > 0$. This concludes the proof of (2.15).

Using (2.15) and the Markov inequality, one can easily get (2.16).

5.2. Proof of Theorem 2.5. To prove Theorem 2.5, we shall use Theorem 2.6 and the following Berry-Esseen bound for the norm cocycle $\sigma(G_n, x)$.

Lemma 5.7 ([15]). Assume **A2** and that $\int_{\mathrm{GL}(V)} \log^4 N(g) \mu(dg) < \infty$. Then, there exists a constant c > 0 such that for any $n \ge 1$, $t \in \mathbb{R}$ and $x \in \mathbb{P}(V)$,

$$\left| \mathbb{P}\left(\frac{\sigma(G_n, x) - n\lambda_1}{\sigma\sqrt{n}} \leqslant t \right) - \Phi(t) \right| \leqslant \frac{c}{\sqrt{n}}$$

The same result has been obtained in [37] under the slightly stronger moment condition $\int_{\mathrm{GL}(V)} \log^8 N(g) \,\mu(dg) < \infty$.

Proof of Theorem 2.5. We first prove (2.13). The lower bound is a direct consequence of Lemma 5.7 and the fact that $\log |\langle f, G_n v \rangle| \leq \log |G_n v|$: there exists a constant c > 0 such that for any $n \geq 1$, $t \in \mathbb{R}$, $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$I_n := \mathbb{P}\left(\frac{\log|\langle f, G_n v\rangle| - n\lambda_1}{\sigma\sqrt{n}} \leqslant t\right) \ge \Phi(t) - \frac{c}{\sqrt{n}}.$$
 (5.25)

The upper bound follows from Proposition 5.6 together with Lemma 5.7. Specifically, from the identity (3.8) and Theorem 2.6, we get that for $x = \mathbb{R}v$

and $y = \mathbb{R}f$ with ||v|| = ||f|| = 1,

$$I_{n} = \mathbb{P}\left(\frac{\log|\langle f, G_{n}v\rangle| - n\lambda_{1}}{\sigma\sqrt{n}} \leqslant t, \ \delta(y, G_{n} \cdot x) > e^{-k}\right) \\ + \mathbb{P}\left(\frac{\log|\langle f, G_{n}v\rangle| - n\lambda_{1}}{\sigma\sqrt{n}} \leqslant t, \ \delta(y, G_{n} \cdot x) \leqslant e^{-k}\right) \\ \leqslant \mathbb{P}\left(\frac{\log||G_{n}v|| - n\lambda_{1}}{\sigma\sqrt{n}} \leqslant t + \frac{k}{\sigma\sqrt{n}}\right) + e^{-c_{1}k^{\alpha}}.$$
(5.26)

Taking $k = \lfloor (\frac{1}{c_1} \log n)^{\frac{1}{\alpha}} \rfloor$, we get that there exists a constant c > 0 such that $e^{-c_1 k^{\alpha}} \leq \frac{c}{\sqrt{n}}$. By Theorem 4.9, we get

$$\mathbb{P}\left(\frac{\log\|G_nv\| - n\lambda_1}{\sigma\sqrt{n}} \leqslant t + \frac{k}{\sigma\sqrt{n}}\right) \leqslant \Phi\left(t + \frac{k}{\sigma\sqrt{n}}\right) + \frac{c}{\sqrt{n}} \\
\leqslant \Phi(t) + \frac{c\log^{\frac{1}{\alpha}}n}{\sqrt{n}}.$$
(5.27)

The desired bound (2.13) follows by combining (5.25), (5.26) and (5.27).

5.3. **Proof of Theorem 2.7.** In this subsection we establish Theorem 2.7 using Theorem 2.6 and Lemma 5.1.

Proof of Theorem 2.7. By Lemma 4.4 of [36], it suffices to prove the following moderate deviation asymptotics: for any t > 0, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\lim_{n \to \infty} \frac{n}{b_n^2} \log \mathbb{P}\left(\frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{b_n} \ge t\right) = -\frac{t^2}{2\sigma^2},\tag{5.28}$$

$$\lim_{n \to \infty} \frac{n}{b_n^2} \log \mathbb{P}\left(\frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{b_n} \leqslant -t\right) = -\frac{t^2}{2\sigma^2}.$$
 (5.29)

We first prove (5.28). The upper bound is an easy consequence of Lemma 5.1. Since there exists a constant $\alpha \in (0,1)$ such that $\mu(\log N(g) > u) \leq c \exp\{-u^{\alpha}\}$ for any u > 0, clearly $\int_{\mathrm{GL}(V)} \log^2 N(g) \,\mu(dg) < \infty$. Moreover, by taking $(b_n)_{n \geq 1}$ such that $\frac{b_n}{\sqrt{n}} \to \infty$ and $b_n = o(n^{\frac{1}{2-\alpha}})$ as $n \to \infty$, we get

$$\limsup_{n \to \infty} \frac{n}{b_n^2} \log \left[n\mu \left(\log N(g) > b_n \right) \right] = \limsup_{n \to \infty} \frac{n}{b_n^2} \log \left[\mu \left(\log N(g) > b_n \right) \right]$$
$$\leqslant \limsup_{n \to \infty} \left(-\frac{n}{b_n^{2-\alpha}} \right) = -\infty.$$
(5.30)

Therefore, from Lemma 5.1 it follows that for any t > 0,

$$-\frac{t^2}{2\sigma^2} \leqslant \liminf_{n \to \infty} \frac{n}{b_n^2} \log \inf_{x \in \mathbb{P}(V)} \mathbb{P}\left(\frac{\sigma(G_n, x) - n\lambda_1}{b_n} \geqslant t\right)$$
$$\leqslant \limsup_{n \to \infty} \frac{n}{b_n^2} \log \sup_{x \in \mathbb{P}(V)} \mathbb{P}\left(\frac{\sigma(G_n, x) - n\lambda_1}{b_n} \geqslant t\right) \leqslant -\frac{t^2}{2\sigma^2}.$$
 (5.31)

Hereafter, $(b_n)_{n\geq 1}$ is any sequence of positive numbers satisfying $\frac{b_n}{\sqrt{n}} \to \infty$ and $b_n = o(n^{\frac{1}{2-\alpha}})$ as $n \to \infty$. By (5.31) and the fact that $\log |\langle f, G_n v \rangle| \leq \sigma(G_n, x)$ for $x = \mathbb{R}v \in \mathbb{P}(V)$ with ||v|| = ||f|| = 1, we get the desired upper bound: for any t > 0, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\limsup_{n \to \infty} \frac{n}{b_n^2} \log \mathbb{P}\left(\frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{b_n} \ge t\right) \leqslant -\frac{t^2}{2\sigma^2}.$$
(5.32)

The lower bound can be deduced from Lemma 5.1 together with Theorem 2.6. Specifically, by (2.14), there exist constants $c_1 > 0$ and $k_0 \in \mathbb{N}$ such that for any $n \ge k \ge k_0$, any $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\begin{split} I_{n} &:= \mathbb{P}\left(\frac{\log|\langle f, G_{n}v\rangle| - n\lambda_{1}}{b_{n}} \geqslant t\right) \\ &\geqslant \mathbb{P}\left(\frac{\log|\langle f, G_{n}v\rangle| - n\lambda_{1}}{b_{n}} \geqslant t, \ \log\delta(G_{n} \cdot x, y) > -k\right) \\ &\geqslant \mathbb{P}\left(\frac{\sigma(G_{n}, x) - n\lambda_{1}}{b_{n}'} \geqslant t, \ \log\delta(G_{n} \cdot x, y) > -k\right) \\ &\geqslant \mathbb{P}\left(\frac{\sigma(G_{n}, x) - n\lambda_{1}}{b_{n}'} \geqslant t, \ \log\delta(G_{n} \cdot x, y) > -k\right) \end{split}$$

$$(5.33)$$

where $b'_n = b_n + \frac{k}{t}$ and t > 0. We take

$$k = \left\lfloor \left(c_2 \frac{b_n^2}{n} \right)^{\frac{1}{\alpha}} \right\rfloor,\tag{5.34}$$

where $c_2 > 0$ is a constant whose value will be chosen large enough. Since $\frac{b_n}{\sqrt{n}} \to \infty$ and $\frac{b_n}{n} \to 0$ as $n \to \infty$, from $b'_n = b_n + \frac{k}{t}$ and (5.34), we get that as $n \to \infty$,

$$\frac{b'_n}{\sqrt{n}} \to \infty \quad \text{and} \quad \frac{b'_n}{n} = \frac{b_n}{n} + \frac{k}{tn} \leqslant \frac{b_n}{n} + \frac{c}{t} n^{-\frac{1-\alpha}{2-\alpha}} \to 0.$$

From (5.31) it follows that for any t > 0 and $\varepsilon > 0$, there exists $n_0 \in \mathbb{N}$ such that for any $n \ge n_0$ and $x \in \mathbb{P}(V)$,

$$\mathbb{P}\left(\frac{\sigma(G_n, x) - n\lambda_1}{b'_n} \ge t\right) \ge e^{-\frac{(b'_n)^2}{n}\left(\frac{t^2}{2\sigma^2} + \varepsilon\right)}.$$

Substituting this into (5.33), we obtain

$$I_n \ge e^{-\frac{(b'_n)^2}{n} \left(\frac{t^2}{2\sigma^2} + \varepsilon\right)} \left[1 - e^{-c_1k^\alpha + \frac{(b'_n)^2}{n} \left(\frac{t^2}{2\sigma^2} + \varepsilon\right)}\right].$$

Choosing $c_2 > 0$ in (5.34) to be sufficiently large, one gets $\frac{(b'_n)^2}{n} (\frac{t^2}{2\sigma^2} + \varepsilon) < c_1 k^{\alpha}$, so that there exists a constant $c_3 > 0$ such that

$$I_n \geqslant e^{-\frac{(b'_n)^2}{n} \left(\frac{t^2}{2\sigma^2} + \varepsilon\right)} \left(1 - e^{-c_3 k^\alpha}\right).$$

Since $k = \lfloor (c_2 \frac{b_n^2}{n})^{\frac{1}{\alpha}} \rfloor \to \infty$ and $1 \leq \frac{b'_n}{b_n} = 1 + \frac{k}{tb_n} \leq 1 + c \frac{b_n^{\frac{2-\alpha}{\alpha}}}{n^{\frac{1}{\alpha}}} \to 1$ as $n \to \infty$, it follows that

$$\liminf_{n \to \infty} \frac{n}{b_n^2} \log I_n \geqslant \liminf_{n \to \infty} \frac{n}{b_n^2} \Big[-\frac{(b_n')^2}{n} \Big(\frac{t^2}{2\sigma^2} + \varepsilon \Big) \Big] = -\Big(\frac{t^2}{2\sigma^2} + \varepsilon \Big).$$

Letting $\varepsilon \to 0$, the desired lower bound follows: for any t > 0, uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\liminf_{n \to \infty} \frac{n}{b_n^2} \log \mathbb{P}\left(\frac{\log |\langle f, G_n v \rangle| - n\lambda_1}{b_n} \geqslant t\right) \geqslant -\frac{t^2}{2\sigma^2}.$$

This, together with the upper bound (5.32), concludes the proof of (5.28). The proof of (5.29) can be carried out in the same way.

6. PROOF OF CRAMÉR TYPE MODERATE DEVIATION EXPANSION

6.1. Smoothing inequality. For any integrable function $h : \mathbb{R} \to \mathbb{C}$, denote its Fourier transform by $\hat{h}(u) = \int_{\mathbb{R}} e^{-iuw}h(w)dw$, $u \in \mathbb{R}$. If \hat{h} is integrable on \mathbb{R} , then by the Fourier inversion formula we have $h(w) = \frac{1}{2\pi} \int_{\mathbb{R}} e^{iuw} \hat{h}(u)du$, for almost all $w \in \mathbb{R}$ with respect to the Lebesgue measure on \mathbb{R} .

Now we fix a non-negative density function ρ on \mathbb{R} with compact support [-1,1], whose Fourier transform $\hat{\rho}$ is integrable on \mathbb{R} . For any $0 < \varepsilon < 1$, define the scaled density function $\rho_{\varepsilon}(w) = \frac{1}{\varepsilon}\rho(\frac{w}{\varepsilon}), w \in \mathbb{R}$, which has a compact support on $[-\varepsilon^{-1}, \varepsilon^{-1}]$.

For any $\varepsilon > 0$ and non-negative integrable function ψ on \mathbb{R} , set

$$\psi_{\varepsilon}^{+}(w) = \sup_{|w-w'| \leqslant \varepsilon} \psi(w') \quad \text{and} \quad \psi_{\varepsilon}^{-}(w) = \inf_{|w-w'| \leqslant \varepsilon} \psi(w'), \quad w \in \mathbb{R}.$$
(6.1)

We need the following smoothing inequality shown in [23]. Denote by $h_1 * h_2$ the convolution of functions h_1 and h_2 on the real line.

Lemma 6.1 ([23]). Assume that ψ is a non-negative integrable function on \mathbb{R} and that ψ_{ε}^+ and ψ_{ε}^- are measurable for any $\varepsilon \in (0, 1)$. Then, there exists

a positive constant $C_{\rho}(\varepsilon)$ with $C_{\rho}(\varepsilon) \to 0$ as $\varepsilon \to 0$, such that for any $w \in \mathbb{R}$, $\psi_{\varepsilon}^{-} * \rho_{\varepsilon^{2}}(w) - \int_{|u| \ge \varepsilon} \psi_{\varepsilon}^{-}(w-u)\rho_{\varepsilon^{2}}(u)du \le \psi(w) \le (1+C_{\rho}(\varepsilon))\psi_{\varepsilon}^{+} * \rho_{\varepsilon^{2}}(w).$

For sufficiently small constant $s_0 > 0$ and $s \in (0, s_0)$, let

$$\psi_s(w) = e^{-sw} \mathbb{1}_{\{w \ge 0\}}, \quad w \in \mathbb{R}.$$

With the notation $\psi_{s,\varepsilon}^{-}(w) = \inf_{|w-w'| \leq \varepsilon} \psi_s(w')$ (cf. (6.1)), we have that for any $\varepsilon \in (0,1)$,

$$\psi_{s,\varepsilon}^{-}(w) = e^{-s(w+\varepsilon)} \mathbb{1}_{\{w \ge \varepsilon\}}, \quad w \in \mathbb{R}.$$
(6.2)

By elementary calculations, for any $s \in (0, s_0)$ and $\varepsilon \in (0, 1)$, the Fourier transform of $\psi_{s,\varepsilon}^-$ is given by

$$\widehat{\psi}_{s,\varepsilon}^{-}(u) = \int_{\mathbb{R}} e^{-iuw} \psi_{s,\varepsilon}^{-}(w) dw = e^{-2\varepsilon s} \frac{e^{-2i\varepsilon u}}{s+iu}, \quad u \in \mathbb{R}.$$
 (6.3)

6.2. An asymptotic expansion of the perturbed operator. The goal of this section is to establish the precise asymptotic behaviors of the perturbed operator $R_{s,it}$. This asymptotic result will play an important role for establishing the Cramér type moderate deviation expansion for the coefficients $\langle f, G_n v \rangle$ in Theorem 2.8. In the sequel, for any fixed t > 1, we shall choose s > 0 satisfying the following equation:

$$\Lambda'(s) - \Lambda'(0) = \frac{\sigma t}{\sqrt{n}}.$$
(6.4)

For brevity we denote $\sigma_s = \sqrt{\Lambda''(s)}$. By [45], the function Λ is strictly convex in a small neighborhood of 0, so that $\sigma_s > 0$ uniformly in $s \in (0, s_0)$.

Proposition 6.2. Assume conditions A1 and A2. Let s > 0 be such that (6.4) holds. Then, for any $\varepsilon \in (0,1)$ and any positive sequence $(t_n)_{n \ge 1}$ satisfying $t_n \to \infty$ and $t_n/\sqrt{n} \to 0$ as $n \to \infty$, we have, uniformly in $s \in (0, s_0), x \in \mathbb{P}(V), t \in [t_n, o(\sqrt{n})], \varphi \in \mathscr{B}_{\gamma}$ and $|l| = O(\frac{1}{\sqrt{n}})$,

$$\left| s\sigma_s \sqrt{n} \int_{\mathbb{R}} e^{-iuln} R^n_{s,iu}(\varphi)(x) \widehat{\psi}^-_{s,\varepsilon}(u) \widehat{\rho}_{\varepsilon^2}(u) du - \sqrt{2\pi} \pi_s(\varphi) \right| \\ \leqslant c \left(\frac{t}{\sqrt{n}} + \frac{1}{t^2} \right) \|\varphi\|_{\infty} + c \left(|l|\sqrt{n} + \frac{1}{\sqrt{n}} \right) \|\varphi\|_{\gamma}.$$
(6.5)

Proof. Without loss of generality, we assume that the target function φ is non-negative on $\mathbb{P}(V)$. By Lemma 4.2, we have the following decomposition: with $\delta > 0$ small enough,

$$s\sigma_s\sqrt{n}\int_{\mathbb{R}}e^{-iuln}R^n_{s,iu}(\varphi)(x)\widehat{\psi}^-_{s,\varepsilon}(u)\widehat{\rho}_{\varepsilon^2}(u)du =: I_1 + I_2 + I_3, \tag{6.6}$$

where

$$I_{1} = s\sigma_{s}\sqrt{n} \int_{|u| \ge \delta} e^{-iuln} R_{s,iu}^{n}(\varphi)(x) \widehat{\psi}_{s,\varepsilon}^{-}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du,$$

$$I_{2} = s\sigma_{s}\sqrt{n} \int_{|u| < \delta} e^{-itln} N_{s,iu}^{n}(\varphi)(x) \widehat{\psi}_{s,\varepsilon}^{-}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du,$$

$$I_{3} = s\sigma_{s}\sqrt{n} \int_{|t| < \delta} e^{-iuln} \lambda_{s,iu}^{n} \Pi_{s,iu}(\varphi)(x) \widehat{\psi}_{s,\varepsilon}^{-}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du$$

For simplicity, we denote $K_s(iu) = \log \lambda_{s,iu}$ and choose the branch where $K_s(0) = 0$. Using the formula (4.7), we have that for $u \in (-\delta, \delta)$,

$$K_s(iu) = \Lambda'(s+iu) - \Lambda'(s) - iu\Lambda'(s).$$

Since the function Λ is analytic in a small neighborhood of 0, using Taylor's formula gives

$$K_s(iu) = \sum_{k=2}^{\infty} \frac{\Lambda^{(k)}(s)}{k!} (iu)^k, \quad \text{where } \Lambda(s) = \log \kappa(s)$$
(6.7)

and

$$\Lambda'(s) - \Lambda'(0) = \sum_{k=2}^{\infty} \frac{\gamma_k}{(k-1)!} s^{k-1}, \text{ where } \gamma_k = \Lambda^{(k)}(0).$$
 (6.8)

Combining (6.4) and (6.8), we get

$$\frac{\sigma t}{\sqrt{n}} = \sum_{k=2}^{\infty} \frac{\gamma_k}{(k-1)!} s^{k-1}.$$
(6.9)

Since $\gamma_2 = \sigma^2 > 0$, from (6.9) we deduce that for any t > 1 and sufficiently large n, the equation (6.4) has a unique solution given by

$$s = \frac{1}{\gamma_2^{1/2}} \frac{t}{\sqrt{n}} - \frac{\gamma_3}{2\gamma_2^2} \left(\frac{t}{\sqrt{n}}\right)^2 - \frac{\gamma_4\gamma_2 - 3\gamma_3^2}{6\gamma_2^{7/2}} \left(\frac{t}{\sqrt{n}}\right)^3 + \cdots$$
 (6.10)

For sufficiently large $n \ge 1$, the series on the right-hand side of (6.10) is absolutely convergent according to the theorem on the inversion of analytic functions. Besides, from (6.4) and $t = o(\sqrt{n})$ we see that $s \to 0^+$ as $n \to \infty$, so that we can assume $s \in (0, s_0)$ for sufficiently small constant $s_0 > 0$.

Estimate of I_1 . By Lemma 4.3, for fixed $\delta > 0$, there exist constants c, C > 0 such that

$$\sup_{s \in (0,s_0)} \sup_{|u| \ge \delta} \sup_{x \in \mathbb{P}(V)} |R_{s,iu}^n \varphi(x)| \leqslant C e^{-cn} \|\varphi\|_{\gamma}.$$
(6.11)

From (6.3) and the fact that ρ_{ε^2} is a density function on \mathbb{R} , we see that

$$\sup_{u \in \mathbb{R}} |\widehat{\psi}_{s,\varepsilon}^{-}(u)| \leqslant \widehat{\psi}_{s,\varepsilon}^{-}(0) = \frac{1}{s} e^{-2\varepsilon s}, \quad \sup_{u \in \mathbb{R}} |\widehat{\rho}_{\varepsilon^{2}}(u)| \leqslant \widehat{\rho}_{\varepsilon^{2}}(0) = 1.$$
(6.12)

Using (6.11) and the first inequality in (6.12), and taking into account that the function $\hat{\rho}_{\varepsilon^2}$ is integrable on \mathbb{R} , we obtain the desired bound for I_1 :

$$|I_1| \leqslant C e^{-cn} \|\varphi\|_{\gamma}. \tag{6.13}$$

Estimate of I_2 . Using the bound (4.8), we have that uniformly in $s \in (0, s_0), u \in (-\delta, \delta)$ and $x \in \mathbb{P}(V)$,

$$|N_{s,iu}^{n}(\varphi)(x)| \leq \|N_{s,iu}^{n}\|_{\mathscr{B}_{\gamma} \to \mathscr{B}_{\gamma}}\|\varphi\|_{\gamma} \leq Ce^{-cn}\|\varphi\|_{\gamma}.$$

This, together with (6.12), implies the desired bound for I_2 :

$$|I_2| \leqslant C e^{-cn} \|\varphi\|_{\gamma}. \tag{6.14}$$

Estimate of I_3 . For brevity, we denote for any $s \in (0, s_0)$ and $x \in \mathbb{P}(V)$,

$$\Psi_{s,x}(u) := \Pi_{s,iu}(\varphi)(x)\widehat{\psi}_{s,\varepsilon}^{-}(u)\widehat{\rho}_{\varepsilon^{2}}(u), \quad -\delta < u < \delta.$$
(6.15)

Recalling that $K_s(iu) = \log \lambda_{s,iu}$, we decompose the term I_3 into two parts:

$$I_3 = I_{31} + I_{32}, (6.16)$$

where

$$I_{31} = s\sigma_s \sqrt{n} \int_{n^{-\frac{1}{2}} \log n \le |u| \le \delta} e^{nK_s(iu) - iuln} \Psi_{s,x}(u) du,$$

$$I_{32} = s\sigma_s \sqrt{n} \int_{|u| < n^{-\frac{1}{2}} \log n} e^{nK_s(iu) - iuln} \Psi_{s,x}(u) du.$$

Estimate of I_{31} . By (4.8), there exists a constant c > 0 such that for any $s \in (0, s_0), u \in [-\delta, \delta]$ and $x \in \mathbb{P}(V)$,

$$\Pi_{s,iu}(\varphi)(x)| \leqslant c \|\varphi\|_{\gamma}.$$
(6.17)

This, together with (6.12), yields that there exists a constant c > 0 such that for all $s \in (0, s_0)$, $|u| < \delta$, $x \in \mathbb{P}(V)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|\Psi_{s,x}(u)| \leqslant \frac{c}{s} \|\varphi\|_{\gamma}.$$
(6.18)

Using (6.7) and noting that $\Lambda''(s) = \sigma_s^2 > 0$, we find that there exists a constant c > 0 such that for all $s \in (0, s_0)$,

$$\Re(K_s(iu)) = \Re\left(\sum_{k=2}^{\infty} \frac{K_s^{(k)}(0)(iu)^k}{k!}\right) < -\frac{1}{8}\sigma_s^2 u^2 < -cu^2.$$

Combining this with (6.18), we derive that there exists a constant c > 0such that for all $s \in (0, s_0), x \in \mathbb{P}(V)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|I_{31}| \leqslant c\sqrt{n} \|\varphi\|_{\gamma} \int_{n^{-\frac{1}{2}} \log n \leqslant |u| \leqslant \delta} e^{-cnu^2} du \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}.$$
 (6.19)

Estimate of I_{32} . By a change of variable $u' = \sigma_s \sqrt{n}u$, we get

$$I_{32} = s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \exp\left\{\sum_{k=3}^{\infty} \frac{K_s^{(k)}(0)(iu)^k}{\sigma_s^k \, k! \, n^{k/2-1}}\right\} e^{-iul\sqrt{n}/\sigma_s} \Psi_{s,x}\left(\frac{u}{\sigma_s\sqrt{n}}\right) du$$
$$= I_{321} + I_{322} + I_{323},$$

where

$$\begin{split} I_{321} &= s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \left[\exp\left\{ \sum_{k=3}^{\infty} \frac{K_s^{(k)}(0)(iu)^k}{\sigma_s^k \, k! \, n^{k/2-1}} \right\} - 1 \right] e^{-iul\sqrt{n}/\sigma_s} \Psi_{s,x} \left(\frac{u}{\sigma_s \sqrt{n}} \right) du \\ I_{322} &= s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \left[e^{-iul\sqrt{n}/\sigma_s} - 1 \right] \Psi_{s,x} \left(\frac{u}{\sigma_s \sqrt{n}} \right) du \\ I_{323} &= s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \Psi_{s,x} \left(\frac{u}{\sigma_s \sqrt{n}} \right) du. \end{split}$$

Estimate of I_{321} . By simple calculations, there exists a constant c > 0 such that for all $|u| \leq \sigma_s \log n$ and $s \in (0, s_0)$,

$$\left| \exp\left\{ \sum_{k=3}^{\infty} \frac{K_s^{(k)}(0)(iu)^k}{\sigma_s^k \, k! \, n^{k/2-1}} \right\} - 1 \right| \leqslant c \frac{|u|^3}{\sqrt{n}}.$$

This, together with (6.18) and the fact $|e^{-iul\sqrt{n}/\sigma_s}| = 1$, implies that

$$|I_{321}| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}. \tag{6.20}$$

Estimate of I_{322} . Since $|e^{-iul\sqrt{n}/\sigma_s} - 1| \leq |ul\sqrt{n}/\sigma_s| \leq c|l|\sqrt{n}|u|$, combining this with (6.18) gives

$$|I_{322}| \leqslant c|l|\sqrt{n}\|\varphi\|_{\gamma}.$$
(6.21)

Estimate of I_{323} . We shall establish the following bound for I_{323} : there exists a constant c > 0 such that for all $s \in (0, s_0)$, $x \in \mathbb{P}(V)$, $t \in [t_n, o(\sqrt{n})]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\left|I_{323} - \sqrt{2\pi}\pi_s(\varphi)\right| \leq cs \|\varphi\|_{\infty} + \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma} + \frac{c}{t^2} \|\varphi\|_{\infty}.$$
 (6.22)

Now let us prove (6.22). For brevity, denote

$$u_n = \frac{u}{\sigma_s \sqrt{n}}.$$

In view of (6.15), we write

$$\Psi_{s,x}(u_n) = h_1(u_n) + h_2(u_n) + h_3(u_n) + h_4(u_n),$$

where

$$h_1(u_n) = \left[\Pi_{s,iu_n}(\varphi)(x) - \pi_s(\varphi) \right] \widehat{\psi}_{s,\varepsilon}^-(u_n) \widehat{\rho}_{\varepsilon^2}(u_n),$$

$$h_2(u_n) = \pi_s(\varphi) \widehat{\psi}_{s,\varepsilon}^-(u_n) \left[\widehat{\rho}_{\varepsilon^2}(u_n) - \widehat{\rho}_{\varepsilon^2}(0) \right]$$

$$h_3(u_n) = \pi_s(\varphi) \left[\widehat{\psi}_{s,\varepsilon}^-(u_n) - \widehat{\psi}_{s,\varepsilon}^-(0) \right] \widehat{\rho}_{\varepsilon^2}(0),$$

$$h_4(u_n) = \pi_s(\varphi) \widehat{\psi}_{s,\varepsilon}^-(0) \widehat{\rho}_{\varepsilon^2}(0).$$

With the above notation, the term I_{323} can be decomposed into four parts:

$$I_{323} = J_1 + J_2 + J_3 + J_4, (6.23)$$

where for j = 1, 2, 3, 4,

$$J_j = s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} h_j(u_n) du$$

Estimate of J_1 . By Lemma 4.2, we have $|\Pi_{s,iu_n}(\varphi)(x) - \pi_s(\varphi)| \leq c \frac{|u|}{\sqrt{n}} ||\varphi||_{\gamma}$, uniformly in $x \in \mathbb{P}(V)$, $s \in (0, s_0)$ and $|u| \leq \sigma_s \log n$. Combining this with (6.12) gives $|h_1(u_n)| \leq c \frac{|u|}{s\sqrt{n}} ||\varphi||_{\gamma}$, and hence

$$|J_1| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}. \tag{6.24}$$

Estimate of J_2 . It is easy to verify that $|\hat{\rho}_{\varepsilon^2}(u_n) - \hat{\rho}_{\varepsilon^2}(0)| \leq c \frac{|u_n|}{\varepsilon^4}$. This, together with (6.12), leads to $|h_2(u_n)| \leq \frac{c}{\varepsilon^4} \frac{|u|}{s\sqrt{n}}$, and therefore,

$$|J_2| \leqslant \frac{c}{\varepsilon^4} \frac{1}{\sqrt{n}} \|\varphi\|_{\infty} \leqslant \frac{C}{\sqrt{n}} \|\varphi\|_{\infty}.$$
 (6.25)

Estimate of J_3 . By the definition of the function $\widehat{\psi}_{s,\varepsilon}^-$ (see (6.3)), we have

$$\begin{split} \widehat{\psi}_{s,\varepsilon}^{-}(u_n) - \widehat{\psi}_{s,\varepsilon}^{-}(0) &= e^{-2\varepsilon s} \left(\frac{e^{-i\varepsilon u_n}}{s+iu_n} - \frac{1}{s} \right) \\ &= e^{-2\varepsilon s} e^{-i\varepsilon u_n} \left(\frac{1}{s+iu_n} - \frac{1}{s} \right) + e^{-2\varepsilon s} \frac{1}{s} \left(e^{-i\varepsilon u_n} - 1 \right) \\ &= e^{-2\varepsilon s} \left(e^{-i\varepsilon u_n} - 1 \right) \frac{-isu_n - u_n^2}{s(s^2 + u_n^2)} \\ &+ e^{-2\varepsilon s} \frac{-isu_n - u_n^2}{s(s^2 + u_n^2)} + e^{-2\varepsilon s} \frac{1}{s} \left(e^{-i\varepsilon u_n} - 1 \right) \\ &=: A_1(t) + A_2(t) + A_3(t). \end{split}$$

Since $\hat{\rho}_{\varepsilon^2}(0) = 1$, it follows that $J_3 = J_{31} + J_{32} + J_{33}$, where

$$J_{3j} = s\pi_s(\varphi) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} A_j(u) du, \quad j = 1, 2, 3.$$

To deal with J_{31} , we first give a bound for $A_1(u)$. Using the basic inequality $|e^z - 1| \leq e^{\Re z} |z|, z \in \mathbb{C}$, we get

$$\begin{aligned} A_1(u) &|\leqslant e^{-2\varepsilon s} |u_n| \frac{s|u_n| + u_n^2}{s(s^2 + u_n^2)} \\ &= e^{-2\varepsilon s} \frac{u_n^2}{s^2 + u_n^2} + e^{-2\varepsilon s} \frac{|u_n|}{s} \frac{u_n^2}{s^2 + u_n^2} \\ &\leqslant c \frac{u^2}{t^2 + u^2} + c \frac{|u|}{t} \frac{u^2}{t^2 + u^2} \\ &\leqslant c \frac{u^2}{t^2} + c \frac{|u|^3}{t^3}. \end{aligned}$$

Then, recalling that $s = O(\frac{t}{\sqrt{n}})$ and $|\pi_s(\varphi)| \leq c ||\varphi||_{\infty}$, we obtain that there exists a constant c > 0 such that for all $n \geq 1$, $s \in (0, s_0)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|J_{31}| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\infty}.$$
(6.26)

For J_{32} , using again $s = O(\frac{t}{\sqrt{n}})$ and the fact that the integral of an odd function over a symmetric interval is identically zero, by elementary calculations we deduce that there exists a constant c > 0 such that for all $n \ge 1$, $s \in (0, s_0)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|J_{32}| = \left| e^{-2\varepsilon s} \pi_s(\varphi) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \frac{u_n^2}{s^2 + u_n^2} du \right| \leqslant \frac{c}{t^2} \|\varphi\|_{\infty}.$$
 (6.27)

For J_{33} , using again the inequality $|e^z - 1| \leq e^{\Re z} |z|, z \in \mathbb{C}$, we see that there exists a constant c > 0 such that for all $n \geq 1$, $s \in (0, s_0)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|J_{33}| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\infty}.$$
(6.28)

Consequently, putting together the bounds (6.26), (6.27) and (6.28), we obtain

$$J_3 \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\infty} + \frac{c}{t^2} \|\varphi\|_{\infty}.$$
(6.29)

Estimate of J_4 . It follows from (6.3) and $\hat{\rho}_{\varepsilon^2}(0) = 1$ that

$$J_4 = \pi_s(\varphi) e^{-2\varepsilon s} \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} du.$$
(6.30)

Since there exists a constant c > 0 such that for all $s \in (0, s_0)$,

$$\sqrt{2\pi} > \int_{-\sigma_s\log n}^{\sigma_s\log n} e^{-\frac{u^2}{2}} du > \sqrt{2\pi} - \frac{c}{n},$$

we get

$$J_4 = \sqrt{2\pi}\pi_s(\varphi)e^{-2\varepsilon s}\left[1 + O\left(\frac{1}{n}\right)\right].$$

Note that $s = O(\frac{t}{\sqrt{n}})$ with y > 1. It follows that

$$\left|J_4 - \sqrt{2\pi}\pi_s(\varphi)\right| \leqslant \frac{ct}{\sqrt{n}} \|\varphi\|_{\infty}.$$
(6.31)

In view of (6.23), putting together the bounds (6.24), (6.25), (6.29) and (6.31), and noting that $\|\varphi\|_{\infty} \leq \|\varphi\|_{\gamma}$, we obtain the desired bound (6.22). Combining (6.20), (6.21) and (6.22), we derive that there exists a constant c > 0 such that for all $s \in (0, s_0)$, $x \in \mathbb{P}(V)$, $t \in [t_n, o(\sqrt{n})]$, $\varphi \in \mathscr{B}_{\gamma}$ and $|l| = O(\frac{1}{\sqrt{n}})$,

$$\left|I_{32} - \sqrt{2\pi}\pi_s(\varphi)\right| \leqslant c\left(\frac{t}{\sqrt{n}} + \frac{1}{t^2}\right) \|\varphi\|_{\infty} + c\left(|l|\sqrt{n} + \frac{1}{\sqrt{n}}\right) \|\varphi\|_{\gamma}.$$
 (6.32)

Putting together (6.13), (6.14), (6.19) and (6.32), we conclude the proof of Proposition 6.2. \Box

For $s \in (-s_0, 0)$ where $s_0 > 0$ is sufficiently small, let

$$\phi_s(w) = e^{-sw} \mathbb{1}_{\{w \le 0\}}, \quad w \in \mathbb{R}.$$

With the notation in (6.1), for $\varepsilon \in (0, 1)$, the function $\phi_{s,\varepsilon}^+$ is given as follows: $\phi_{s,\varepsilon}^+(w) = 0$ when $w > \varepsilon$; $\phi_{s,\varepsilon}^+(w) = 1$ when $w \in [-\varepsilon, \varepsilon]$; $\phi_{s,\varepsilon}^+(w) = e^{-s(w+\varepsilon)}$ when $w < -\varepsilon$. By calculations, one can give the explicit expression for the Fourier transform of $\phi_{s,\varepsilon}^+$:

$$\widehat{\phi}_{s,\varepsilon}^+(u) = \int_{\mathbb{R}} e^{-iuw} \phi_{s,\varepsilon}^+(w) dw = 2 \frac{\sin(\varepsilon u)}{u} + e^{i\varepsilon u} \frac{1}{-s - iu}, \quad u \in \mathbb{R}.$$
 (6.33)

In the sequel, for any fixed t > 1, we choose s < 0 satisfying the equation:

$$\Lambda'(s) - \Lambda'(0) = -\frac{\sigma t}{\sqrt{n}}.$$
(6.34)

Proposition 6.3. Assume conditions A1 and A2. Let $\phi_{s,\varepsilon}^+$ be defined in (6.33). Suppose that s < 0 satisfies the equation (6.34). Then, for any $0 < \varepsilon < 1$ and any positive sequence $(t_n)_{n \ge 1}$ satisfying $\lim_{n \to \infty} t_n = +\infty$ with $t_n = o(\sqrt{n})$, we have, uniformly in $s \in (-s_0, 0)$, $x \in \mathbb{P}(V)$, $t \in [t_n, o(\sqrt{n})]$, $\varphi \in \mathscr{B}_{\gamma}$ and $l \in \mathbb{R}$ with $|l| = O(\frac{1}{\sqrt{n}})$,

$$\begin{aligned} \left| -s\sigma_s\sqrt{n}\,e^{nh_s(l)}\int_{\mathbb{R}}e^{-itln}R^n_{s,iu}(\varphi)(x)\widehat{\phi}^+_{s,\varepsilon}(u)\widehat{\rho}_{\varepsilon^2}(u)du - \sqrt{2\pi}\pi_s(\varphi) \right| \\ &\leqslant c\left(\frac{t}{\sqrt{n}} + \frac{1}{t^2}\right)\|\varphi\|_{\infty} + c\left(|l|\sqrt{n} + \frac{1}{\sqrt{n}}\right)\|\varphi\|_{\gamma}. \end{aligned}$$

Proof. Since the proof of Proposition 6.3 can be carried out in an analogous way as that of Proposition 6.2, we only sketch the main differences.

Without loss of generality, we assume that the target function φ is non-negative. From Lemma 4.2, we have the following decomposition: with $\delta > 0$ small enough,

$$-s\sigma_s\sqrt{n}\int_{\mathbb{R}}e^{-iuln}R^n_{s,iu}(\varphi)(x)\widehat{\phi}^+_{s,\varepsilon}(u)\widehat{\rho}_{\varepsilon^2}(u)du = I_1 + I_2 + I_3, \qquad (6.35)$$

where

$$I_{1} = -s\sigma_{s}\sqrt{n} \int_{|u| \ge \delta} e^{-itln} R_{s,iu}^{n}(\varphi)(x) \widehat{\phi}_{s,\varepsilon}^{+}(t) \widehat{\rho}_{\varepsilon^{2}}(u) du,$$

$$I_{2} = -s\sigma_{s}\sqrt{n} \int_{|u| < \delta} e^{-iuln} N_{s,iu}^{n}(\varphi)(x) \widehat{\phi}_{s,\varepsilon}^{+}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du,$$

$$I_{3} = -s\sigma_{s}\sqrt{n} \int_{|u| < \delta} e^{-iuln} \lambda_{s,iu}^{n} \Pi_{s,iu}(\varphi)(x) \widehat{\phi}_{s,\varepsilon}^{+}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du.$$

Similarly to the proof of (6.9), from (6.34) one can verify that

$$-\frac{\sigma t}{\sqrt{n}} = \sum_{k=2}^{\infty} \frac{\gamma_k}{(k-1)!} s^{k-1},$$
(6.36)

where $\gamma_k = \Lambda^{(k)}(0)$. For any y > 1 and sufficiently large n, the equation (6.36) has a unique solution given by

$$s = \frac{1}{\gamma_2^{1/2}} \left(-\frac{t}{\sqrt{n}} \right) - \frac{\gamma_3}{2\gamma_2^2} \left(-\frac{t}{\sqrt{n}} \right)^2 - \frac{\gamma_4\gamma_2 - 3\gamma_3^2}{6\gamma_2^{7/2}} \left(-\frac{t}{\sqrt{n}} \right)^3 + \cdots . \quad (6.37)$$

The series on the right-hand side of (6.37) is absolutely convergent, and we can assume that $s \in (-s_0, 0)$ for sufficiently small constant $\eta > 0$.

Estimate of I_1 . By Lemma 4.3, there exist constants c, C > 0 such that

$$\sup_{s \in (-s_0,0)} \sup_{|u| \ge \delta} \sup_{x \in \mathbb{P}(V)} |R_{s,iu}^n \varphi(x)| \le C e^{-cn} \|\varphi\|_{\gamma}.$$
(6.38)

From (6.33) and the fact that ρ_{ε^2} is a density function on \mathbb{R} , we see that

$$\sup_{u \in \mathbb{R}} |\widehat{\phi}_{s,\varepsilon}^{-}(u)| \leqslant \widehat{\phi}_{s,\varepsilon}^{-}(0) = \frac{1}{-s} + 2\varepsilon, \quad \sup_{u \in \mathbb{R}} |\widehat{\rho}_{\varepsilon^{2}}(u)| \leqslant \widehat{\rho}_{\varepsilon^{2}}(0) = 1.$$
(6.39)

From (6.38) and the first inequality in (6.39), the desired bound for I_1 follows:

$$|I_1| \leqslant C e^{-cn} \|\varphi\|_{\gamma}. \tag{6.40}$$

Estimate of I_2 . Using the bound (4.8) and (6.39), one has

$$|I_2| \leqslant C e^{-cn} \|\varphi\|_{\gamma}. \tag{6.41}$$

Estimate of I_3 . For brevity, we denote for any $s \in (-s_0, 0)$ and $x \in \mathbb{P}(V)$,

$$\Psi_{s,x}(u) := \Pi_{s,iu}(\varphi)(x)\widehat{\phi}^+_{s,\varepsilon}(u)\widehat{\rho}_{\varepsilon^2}(u), \quad -\delta < u < \delta.$$
(6.42)

Recalling that $K_s(iu) = \log \lambda_{s,iu}$, we decompose the term I_3 into two parts:

$$I_3 = I_{31} + I_{32}, (6.43)$$

where

$$I_{31} = -s\sigma_s\sqrt{n} \int_{n^{-\frac{1}{2}}\log n \le |u| \le \delta} e^{nK_s(iu) - iuln} \Psi_{s,x}(u) du,$$

$$I_{32} = -s\sigma_s\sqrt{n} \int_{|u| < n^{-\frac{1}{2}}\log n} e^{nK_s(iu) - iuln} \Psi_{s,x}(u) du.$$

Estimate of I_{31} . Using (4.8) and (6.39), we get that there exists a constant c > 0 such that for all $s \in (-s_0, 0), |u| < \delta, x \in \mathbb{P}(V)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|\Psi_{s,x}(u)| \leqslant \frac{c}{-s} \|\varphi\|_{\gamma}.$$
(6.44)

Similarly to the proof of (6.19), it follows that there exists a constant c > 0 such that for all $s \in (-s_0, 0), x \in \mathbb{P}(V)$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$|I_{31}| \leqslant c\sqrt{n} \|\varphi\|_{\gamma} \int_{n^{-\frac{1}{2}} \log n \leqslant |u| \leqslant \delta} e^{-cnu^2} du \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}.$$
(6.45)

Estimate of I_{32} . Making a change of variable $u' = u\sigma_s\sqrt{n}$, we get

$$\begin{split} I_{32} &= -s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \exp\left\{\sum_{k=3}^{\infty} \frac{K_s^{(k)}(0)(iu)^k}{\sigma_s^k \, k! \, n^{k/2-1}}\right\} e^{-iul\sqrt{n}/\sigma_s} \Psi_{s,x}\left(\frac{u}{\sigma_s\sqrt{n}}\right) du \\ &= (-s) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \left[\exp\left\{\sum_{k=3}^{\infty} \frac{K_s^{(k)}(0)(iu)^k}{\sigma_s^k \, k! \, n^{k/2-1}}\right\} - 1 \right] e^{-iul\sqrt{n}/\sigma_s} \Psi_{s,x}\left(\frac{u}{\sigma_s\sqrt{n}}\right) du \\ &+ (-s) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \left[e^{-iul\sqrt{n}/\sigma_s} - 1 \right] \Psi_{s,x}\left(\frac{u}{\sigma_s\sqrt{n}}\right) du \\ &+ (-s) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \Psi_{s,x}\left(\frac{u}{\sigma_s\sqrt{n}}\right) du \\ &=: I_{321} + I_{322} + I_{323}. \end{split}$$

For I_{321} and I_{322} , in a similar way as in the proof of (6.20) and (6.21), we have

$$|I_{321}| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}, \qquad |I_{322}| \leqslant c |l| \sqrt{n} \|\varphi\|_{\gamma}. \tag{6.46}$$

For I_{323} , we shall establish the following bound: there exists a constant c > 0 such that for all $s \in (-s_0, 0), x \in \mathbb{P}(V), t \in [t_n, o(\sqrt{n})]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\left|I_{323} - \sqrt{2\pi}\pi_s(\varphi)\right| \leqslant c \frac{t}{\sqrt{n}} \|\varphi\|_{\infty} + \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma} + \frac{c}{t^2} \|\varphi\|_{\infty}.$$
 (6.47)

For brevity, denote $u_n = \frac{u}{\sigma_s \sqrt{n}}$. In view of (6.42), we write

$$\Psi_{s,x}(u_n) = h_1(u_n) + h_2(u_n) + h_3(u_n) + h_4(u_n),$$

where

$$h_1(u_n) = \left[\Pi_{s,iu_n}(\varphi)(x) - \pi_s(\varphi) \right] \widehat{\phi}_{s,\varepsilon}^+(u_n) \widehat{\rho}_{\varepsilon^2}(u_n),$$

$$h_2(u_n) = \pi_s(\varphi) \widehat{\phi}_{s,\varepsilon}^+(u_n) \left[\widehat{\rho}_{\varepsilon^2}(u_n) - \widehat{\rho}_{\varepsilon^2}(0) \right]$$

$$h_3(u_n) = \pi_s(\varphi) \left[\widehat{\phi}_{s,\varepsilon}^+(u_n) - \widehat{\phi}_{s,\varepsilon}^+(0) \right] \widehat{\rho}_{\varepsilon^2}(0),$$

$$h_4(u_n) = \pi_s(\varphi) \widehat{\phi}_{s,\varepsilon}^+(0) \widehat{\rho}_{\varepsilon^2}(0).$$

Then I_{323} can be decomposed into four parts:

$$I_{323} = J_1 + J_2 + J_3 + J_4, (6.48)$$

where for j = 1, 2, 3, 4,

$$J_j = -s \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} h_j(u_n) du.$$

Estimates of J_1 and J_2 . Similarly to the proof of (6.24) and (6.25), one can verify that

$$|J_1| \leq \frac{c}{\sqrt{n}} \|\varphi\|_{\gamma}, \qquad |J_2| \leq \frac{c}{\varepsilon^4} \frac{1}{\sqrt{n}} \|\varphi\|_{\infty} \leq \frac{C}{\sqrt{n}} \|\varphi\|_{\infty}.$$
(6.49)

Estimate of J_3 . By the definition of the function $\hat{\phi}^+_{s,\varepsilon}$ (see (6.33)), we have

$$\hat{\phi}_{s,\varepsilon}^+(u_n) - \hat{\phi}_{s,\varepsilon}^+(0) = 2\left(\frac{\sin\varepsilon u_n}{u_n} - \varepsilon\right) + \left(e^{i\varepsilon u_n}\frac{1}{-s - iu_n} - \frac{1}{-s}\right)$$
$$= 2\left(\frac{\sin\varepsilon u_n}{u_n} - \varepsilon\right) + \frac{e^{i\varepsilon u_n} - 1}{-s - it_n} + \left(\frac{1}{-s - iu_n} - \frac{1}{-s}\right)$$
$$=: A_1(u) + A_2(u) + A_3(u).$$

Since $\hat{\rho}_{\varepsilon^2}(0) = 1$, it follows that $J_3 = J_{31} + J_{32} + J_{33}$, where

$$J_{3j} = -s\pi_s(\varphi) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} A_j(u) du, \quad j = 1, 2, 3.$$

For J_{31} , since $|A_1(u)| \leq c |u|^2/n$ and $|\pi_s(\varphi)| \leq c ||\varphi||_{\infty}$, we have

$$|J_{31}| \leqslant c \frac{-s}{n} \|\varphi\|_{\infty} \leqslant \frac{C}{n} \|\varphi\|_{\infty}.$$
(6.50)

For J_{32} , using the inequality $|e^z - 1| \leq e^{\Re z} |z|, z \in \mathbb{C}$, we get

$$|A_2(u)| \leqslant \frac{\varepsilon |u_n|}{|-s - iu_n|} \leqslant \frac{\varepsilon |u_n|}{-s}.$$

Hence,

$$|J_{32}| \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\infty}.$$
(6.51)

For J_{33} , note that $A_3(u) = \frac{-isu_n - u_n^2}{-s(s^2 + u_n^2)}$ and $s = O(\frac{-t}{\sqrt{n}})$. Using the fact that the integral of an odd function over a symmetric interval is identically zero, by elementary calculations we derive that

$$|J_{33}| = \left| \pi_s(\varphi) \int_{-\sigma_s \log n}^{\sigma_s \log n} e^{-\frac{u^2}{2}} \frac{u_n^2}{s^2 + u_n^2} du \right| \leqslant \frac{c}{t^2} \|\varphi\|_{\infty}.$$
 (6.52)

Putting together (6.50), (6.51) and (6.52), we obtain

J

$$J_3 \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\infty} + \frac{c}{t^2} \|\varphi\|_{\infty}.$$
(6.53)

Estimate of J_4 . Similarly to the proof of (6.31), one has

$$\left|J_4 - \sqrt{2\pi}\pi_s(\varphi)\right| \leqslant c \frac{t}{\sqrt{n}} \|\varphi\|_{\infty}.$$
(6.54)

In view of (6.48), combining (6.49), (6.53), and (6.54), we obtain the desired bound (6.47) for I_{323} . Putting together the bounds (6.40), (6.41), (6.45), (6.46) and (6.47), we finish the proof of Proposition 6.3.

6.3. **Proof of Theorem 2.8.** The goal of this section is to establish Theorem 2.8. To this aim we first prove the moderate deviation expansion in the normal range $y \in [0, o(n^{1/6})]$ for the couple $(G_n \cdot x, \log |\langle f, G_n v \rangle|)$ with a target function φ on $G_n \cdot x$.

Theorem 6.4. Assume A1 and A2. Then, as $n \to \infty$, uniformly in $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$ with ||v|| = ||f|| = 1, $t \in [0, o(n^{1/6})]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\{\log|\langle f, G_n v\rangle| - n\lambda_1 \ge \sqrt{n}\sigma t\}}\right]}{1 - \Phi(t)} = \nu(\varphi) + \|\varphi\|_{\gamma}o(1),$$
$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\{\log|\langle f, G_n v\rangle| - n\lambda_1 \le -\sqrt{n}\sigma t\}}\right]}{\Phi(-t)} = \nu(\varphi) + \|\varphi\|_{\gamma}o(1).$$

In order to establish Theorem 6.4, we need the exponential Hölder regularity of the invariant measure ν (Lemma 4.5 with s = 0) and the following moderate deviation expansion for the norm cocycle $\sigma(G_n, x)$ proved in [45].

Lemma 6.5 ([45]). Assume A1 and A2. Then, we have, as $n \to \infty$, uniformly in $x \in \mathbb{P}(V)$, $t \in [0, o(\sqrt{n})]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\sigma(G_n, x) - n\lambda_1 \ge \sqrt{n}\sigma t\right\}}\right]}{1 - \Phi(t)} = e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + \|\varphi\|_{\gamma}O\left(\frac{t+1}{\sqrt{n}}\right)\right],$$
$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\sigma(G_n, x) - n\lambda_1 \le -\sqrt{n}\sigma t\right\}}\right]}{1 - \Phi(t)} = e^{-\frac{t^3}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + \|\varphi\|_{\gamma}O\left(\frac{t+1}{\sqrt{n}}\right)\right].$$

Proof of Theorem 6.4. Without loss of generality, we assume that the target function φ is non-negative. We only show the first expansion in Theorem 6.4 since the proof of the second one can be carried out in a similar way.

The upper bound is a direct consequence of Lemma 6.5. Specifically, since $\log |\langle f, G_n v \rangle| \leq \sigma(G_n, x)$ for $f \in V^*$ with ||f|| = 1, $x = \mathbb{R}v \in \mathbb{P}(V)$ with ||v|| = 1, using the first expansion in Lemma 6.5, we get that there exists a constant c > 0 such that uniformly in $f \in V^*$, $x = \mathbb{R}v \in \mathbb{P}(V)$ with ||v|| = ||f|| = 1, and $t \in [0, o(\sqrt{n})]$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \ge \sqrt{n\sigma t}\right\}}\right]}{1 - \Phi(t)} \leqslant e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + c\|\varphi\|_{\gamma}\frac{t+1}{\sqrt{n}}\right].$$
(6.55)

The lower bound follows from Lemmas 4.5 and 6.5. By Lemma 4.5 with s = 0, we have that for any $\varepsilon > 0$, there exist constants c, C > 0 such that for all $n \ge k \ge 1$, and $f \in V^*$ with ||f|| = 1, $x = \mathbb{R}v \in \mathbb{P}(V)$ with ||v|| = 1,

$$\mathbb{P}\Big(\log|\langle f, G_n v\rangle| - \sigma(G_n, x) \leqslant -\varepsilon k\Big) \leqslant Ce^{-ck}.$$

Using this inequality, we get

$$\mathbb{E}\left[\varphi(G_{n}\cdot x)\mathbb{1}_{\left\{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}\geqslant\sqrt{n}\sigma t\right\}}\right] \\
\geq \mathbb{E}\left[\varphi(G_{n}\cdot x)\mathbb{1}_{\left\{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}\geqslant\sqrt{n}\sigma t\right\}}\mathbb{1}_{\left\{\log|\langle f,G_{n}v\rangle|-\sigma(G_{n},x)>-\varepsilon k\right\}}\right] \\
\geq \mathbb{E}\left[\varphi(G_{n}\cdot x)\mathbb{1}_{\left\{\sigma(G_{n},x)-n\lambda_{1}\geqslant\sqrt{n}\sigma t+\varepsilon k\right\}}\mathbb{1}_{\left\{\log|\langle f,G_{n}v\rangle|-\sigma(G_{n},x)>-\varepsilon k\right\}}\right] \\
\geq \mathbb{E}\left[\varphi(G_{n}x)\mathbb{1}_{\left\{\sigma(G_{n},x)-n\lambda_{1}\geqslant\sqrt{n}\sigma t+\varepsilon k\right\}}\right] - Ce^{-ck}\|\varphi\|_{\infty}.$$
(6.56)

Take $k = \lfloor A \log n \rfloor$ in (6.56), where A > 0 is a fixed sufficiently large constant. Denote $t_1 = t + \frac{\varepsilon k}{\sigma \sqrt{n}}$. By Lemma 6.5, we have, as $n \to \infty$, uniformly in $x \in \mathbb{P}(V), t \in [0, \sqrt{\log n}]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\sigma(G_n, x) - n\lambda_1 \ge \sqrt{n\sigma t + \varepsilon k}\right\}}\right]}{1 - \Phi(t_1)} = \nu(\varphi) + \|\varphi\|_{\gamma} O\left(\frac{t_1^3 + 1}{\sqrt{n}}\right). \quad (6.57)$$

We claim that uniformly in $t \in [0, \sqrt{\log n}]$,

$$1 > \frac{1 - \Phi(t_1)}{1 - \Phi(t)} = 1 - \frac{\int_t^{t_1} e^{-\frac{u^2}{2}} du}{\int_t^\infty e^{-\frac{u^2}{2}} du} > 1 - c \frac{t+1}{\sqrt{n}} \log n.$$
(6.58)

Indeed, when $y \in [0,2]$, the inequality (6.58) holds due to the fact that $t_1 = t + \frac{\varepsilon k}{\sigma \sqrt{n}}$ and $k = \lfloor A \log n \rfloor$; when $t \in [2, \sqrt{\log n}]$, we can use the inequality $e^{\frac{t^2}{2}} \int_t^\infty e^{-\frac{u^2}{2}} du \ge \frac{1}{t} - \frac{1}{t^3} > \frac{1}{2t}$ to get

$$1 - \frac{\int_t^{t_1} e^{-\frac{u^2}{2}} du}{\int_t^{\infty} e^{-\frac{u^2}{2}} du} > 1 - \frac{(t_1 - t)e^{-t^2/2}}{\frac{1}{2t}e^{-t^2/2}} > 1 - c\frac{t+1}{\sqrt{n}}\log n.$$

Hence (6.58) holds. It is easy to check that $\frac{t_1^3+1}{\sqrt{n}} = O(\frac{t^3+1}{\sqrt{n}})$, uniformly in $t \in [0, \sqrt{\log n}]$. Consequently, we get that uniformly in $x \in \mathbb{P}(V)$, $t \in [0, \sqrt{\log n}]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\sigma(G_n, x) - n\lambda_1 \ge \sqrt{n\sigma t + \varepsilon k}\right\}}\right]}{1 - \Phi(t)} \ge \nu(\varphi) - c\|\varphi\|_{\gamma} \frac{t+1}{\sqrt{n}}\log n.$$

This, together with (6.56) and the fact that $e^{-ck}/[1-\Phi(t)]$ decays to 0 faster than $\frac{1}{n}$, implies that uniformly in $f \in V^*$ with ||f|| = 1, $x = \mathbb{R}v \in \mathbb{P}(V)$ with ||v|| = 1, $t \in [0, \sqrt{\log n}]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \ge \sqrt{n\sigma t}\right\}}\right]}{1 - \Phi(t)} \ge \nu(\varphi) - c\|\varphi\|_{\gamma} \frac{t+1}{\sqrt{n}}\log n. \quad (6.59)$$

It remains to prove the lower bound when $t \in [\sqrt{\log n}, o(n^{1/6})]$. We take $k = \lfloor At^2 \rfloor$ in (6.56), where A > 0 is a fixed sufficiently large constant. In the same way as in (6.57), we get that, with $t_1 = t + \frac{\varepsilon k}{\sigma \sqrt{n}}$, uniformly in $x \in \mathbb{P}(V), t \in [\sqrt{\log n}, o(n^{1/6})]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\sigma(G_n, x) - n\lambda_1 \ge \sqrt{n\sigma t + \varepsilon k}\right\}}\right]}{1 - \Phi(t_1)} = \nu(\varphi) + \|\varphi\|_{\gamma} O\left(\frac{t_1^3 + 1}{\sqrt{n}}\right). \quad (6.60)$$

Using the inequality $\frac{1}{t} \ge e^{\frac{t^2}{2}} \int_t^\infty e^{-\frac{u^2}{2}} du \ge \frac{1}{t} - \frac{1}{t^3}$ for t > 0, by elementary calculations, we get that uniformly in $t \in [\sqrt{\log n}, o(n^{1/6})]$,

$$1 > \frac{1 - \Phi(t_1)}{1 - \Phi(t)} \ge \frac{t}{t_1} \left(1 - \frac{1}{t_1^2}\right) e^{\frac{t^2}{2} - \frac{t_1^2}{2}} > \left(1 - \frac{c}{t^2}\right) \left(1 - \frac{ct^3}{\sqrt{n}}\right).$$
(6.61)

Taking into account that $\frac{t_1^3+1}{\sqrt{n}} = O(\frac{t^3+1}{\sqrt{n}})$ and that $e^{-cAt^2}/[1-\Phi(t)]$ decays to 0 faster than $\frac{1}{n}$ (by taking A > 0 to be sufficiently large), from (6.56), (6.60)

and (6.61) we deduce that uniformly in $f \in V^*$ with ||f|| = 1, $x = \mathbb{R}v \in \mathbb{P}(V)$ with ||v|| = 1, $t \in [\sqrt{\log n}, o(n^{1/6})]$ and $\varphi \in \mathscr{B}_{\gamma}$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \ge \sqrt{n\sigma t}\right\}}\right]}{1 - \Phi(t)} \ge \nu(\varphi) - c\|\varphi\|_{\gamma} \left(\frac{1}{t^2} + \frac{t^3}{\sqrt{n}}\right). \quad (6.62)$$

Combining (6.55), (6.59) and (6.62) finishes the proof of Theorem 6.4.

Now we apply Propositions 6.2 and 6.3 to establish the following moderate deviation expansion when $t \in [n^{\alpha}, o(n^{1/2})]$ for any $\alpha \in (0, 1/2)$.

Theorem 6.6. Assume A1 and A2. Then, for any $\varphi \in \mathscr{B}_{\gamma}$ and $\alpha \in (0, 1/2)$, as $n \to \infty$, we have, uniformly in $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$ with $\|v\| = \|f\| = 1$, and $t \in [n^{\alpha}, o(\sqrt{n})]$,

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \ge \sqrt{n\sigma t}\right\}}\right]}{1 - \Phi(t)} = e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + o(1)\right], \quad (6.63)$$

$$\frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_n v\rangle| - n\lambda_1 \leqslant -\sqrt{n\sigma t}\right\}}\right]}{\Phi(-t)} = e^{-\frac{t^3}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})} \left[\nu(\varphi) + o(1)\right].$$
(6.64)

Proof. As in Section 4.3 we define a partition of the unity. Let U be the uniform distribution function on the interval [0,1]. Let $a \in (0,\frac{1}{2}]$ be a constant. For any integer $k \ge 0$, define

$$U_k(t) = U\left(\frac{t - (k - 1)a}{a}\right), \qquad h_k(t) = U_k(t) - U_{k+1}(t), \quad t \in \mathbb{R}.$$

Note that $U_m = \sum_{k=m}^{\infty} h_k$ for $m \ge 0$ and for any $t \ge 0$ and $m \ge 0$,

$$\sum_{k=0}^{\infty} h_k(t) = 1, \quad \sum_{k=0}^{m} h_k(t) + U_{m+1}(t) = 1.$$
(6.65)

For any $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$, set

$$\chi_k^y(x) = h_k(-\log\delta(y, x)) \quad \text{and} \quad \overline{\chi}_k^y(x) = U_k(-\log\delta(y, x)). \tag{6.66}$$

From (6.65) we have the following partition of the unity on $\mathbb{P}(V)$: for any $x \in \mathbb{P}(V), y \in \mathbb{P}(V^*)$ and $m \ge 0$,

$$\sum_{k=0}^{\infty} \chi_k^y(x) = 1, \quad \sum_{k=0}^m \chi_k^y(x) + \overline{\chi}_{m+1}^y(x) = 1.$$
 (6.67)

Denote by $\operatorname{supp}(\chi_k^y)$ the support of the function χ_k^y . It is easy to see that for any $k \ge 0$ and $y \in \mathbb{P}(V^*)$,

$$-\log \delta(y,x) \in [a(k-1), a(k+1)] \quad \text{for any } x \in \text{supp}(\chi_k^y). \tag{6.68}$$

As in Lemma 4.10 we show that there exists a constant c > 0 such that for any $\gamma \in (0, 1]$, $k \ge 0$ and $y \in \mathbb{P}(V^*)$, it holds $\chi_k^y \in \mathscr{B}_{\gamma}$ and

$$\|\chi_k^y\|_{\gamma} \leqslant \frac{ce^{\gamma ka}}{a^{\gamma}}.\tag{6.69}$$

Without loss of generality, we assume that the target function φ is nonnegative. We first establish (6.63). Since the upper bound of the moderate deviation expansion for the couple $(G_n \cdot x, \log |\langle f, G_n v \rangle|)$ has been shown in (6.55), it remains to establish the following lower bound: for any $\varphi \in \mathscr{B}_{\gamma}$ and $\alpha \in (0, 1/2)$, uniformly in $x = \mathbb{R}v \in \mathbb{P}(V)$ and $y = \mathbb{R}f \in \mathbb{P}(V^*)$ with ||v|| = ||f|| = 1, and $t \in [n^{\alpha}, o(\sqrt{n})]$,

$$\liminf_{n \to \infty} \frac{\mathbb{E}\left[\varphi(G_n \cdot x)\mathbb{1}_{\{\log|\langle f, G_n v \rangle| - n\lambda_1 \ge \sqrt{n}\sigma t\}}\right]}{e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})}[1 - \Phi(t)]} \ge \nu(\varphi).$$
(6.70)

Now we are going to prove (6.70). From the change of measure formula (4.3) and the fact $\lambda_1 = \Lambda'(0)$, we get

$$A_{n} := \mathbb{E}\left[\varphi(G_{n} \cdot x)\mathbb{1}_{\left\{\log|\langle f, G_{n}v\rangle| - n\lambda_{1} \geq \sqrt{n}\sigma t\right\}}\right]$$

$$= r_{s}(x)\kappa^{n}(s)\mathbb{E}_{\mathbb{Q}_{s}^{x}}\left[(\varphi r_{s}^{-1})(G_{n} \cdot x)e^{-s\sigma(G_{n},x)}\mathbb{1}_{\left\{\log|\langle f, G_{n}v\rangle| \geq n\Lambda'(0) + \sqrt{n}\sigma t\right\}}\right].$$
(6.71)

For brevity, we denote

$$T_n^x = \sigma(G_n, x) - n\Lambda'(s), \qquad Y_n^{x,y} := \log \delta(y, G_n \cdot x).$$

Choosing s > 0 as the solution of the equation (6.4), from (6.71) and (3.8) it follows that

$$A_{n} = r_{s}(x)e^{-n[s\Lambda'(s)-\Lambda(s)]}\mathbb{E}_{\mathbb{Q}_{s}^{x}}\left[(\varphi r_{s}^{-1})(G_{n}\cdot x)e^{-sT_{n}^{x}}\mathbb{1}_{\left\{T_{n}^{x}+Y_{n}^{x,y}\geq0\right\}}\right].$$

Using (6.4), one can verify that

$$s\Lambda'(s) - \Lambda(s) = \frac{t^2}{2n} - \frac{t^3}{n^{3/2}} \zeta\Big(\frac{t}{\sqrt{n}}\Big), \tag{6.72}$$

where ζ is the Cramér series defined by (2.4). Thus A_n can be rewritten as

$$A_n = r_s(x)e^{-\frac{t^2}{2} + \frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \mathbb{E}_{\mathbb{Q}_s^x} \left[(\varphi r_s^{-1})(G_n \cdot x)e^{-sT_n^x} \mathbb{1}_{\left\{ T_n^x + Y_n^{x,y} \ge 0 \right\}} \right].$$
(6.73)

Since the functions φ and r_s are positive, using the partition of the unity (6.67) and (6.68), we have that for $M_n = \lfloor \log n \rfloor$ and $a \in (0, 1/2)$,

$$A_{n} \geq r_{s}(x)e^{-\frac{t^{2}}{2} + \frac{t^{3}}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \sum_{k=0}^{M_{n}} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \left[(\varphi r_{s}^{-1}\chi_{k}^{y})(G_{n} \cdot x)e^{-sT_{n}^{x}} \mathbb{1}_{\{T_{n}^{x} + Y_{n}^{x,y} \geq 0\}} \right]$$
$$\geq r_{s}(x)e^{-\frac{t^{2}}{2} + \frac{t^{3}}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \sum_{k=0}^{M_{n}} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \left[(\varphi r_{s}^{-1}\chi_{k}^{y})(G_{n} \cdot x)e^{-sT_{n}^{x}} \mathbb{1}_{\{T_{n}^{x} - a(k+1) \geq 0\}} \right].$$

$$(6.74)$$

Let

$$\varphi_{s,k}^y(x)=(\varphi r_s^{-1}\chi_k^y)(x),\quad x\in\mathbb{P}(V),$$

and

$$\psi_s(w) = e^{-sw} \mathbb{1}_{\{w \ge 0\}}, \quad w \in \mathbb{R}.$$

It then follows from (6.74) that

$$A_n \ge r_s(x)e^{-\frac{t^2}{2} + \frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \sum_{k=0}^{M_n} e^{-sa(k+1)} \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{s,k}^y(G_n \cdot x)\psi_s(T_n^x - a(k+1)) \right],$$

which implies that

$$\frac{A_n}{e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})}[1-\Phi(t)]} \ge r_s(x)\sum_{k=0}^{M_n}\frac{e^{-sa(k+1)}\mathbb{E}_{\mathbb{Q}_s^x}[\varphi_{s,k}^y(G_n\cdot x)\psi_s(T_n^x-a(k+1))]}{e^{\frac{t^2}{2}}[1-\Phi(t)]}.$$

From Lemma 6.1, it follows that for any small constant $\varepsilon > 0$,

$$\psi_s(w) \ge \psi_{s,\varepsilon}^- * \rho_{\varepsilon^2}(w) - \int_{|u| \ge \varepsilon} \psi_{s,\varepsilon}^-(w-u) \rho_{\varepsilon^2}(u) du, \quad w \in \mathbb{R},$$

where $\psi_{s,\varepsilon}^{-}$ is given by (6.2). Using this inequality we get

$$\frac{A_n}{e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})}[1-\Phi(t)]} \ge r_s(x)\sum_{k=0}^{M_n}\frac{B_{n,k}-D_{n,k}}{e^{\frac{t^2}{2}}[1-\Phi(t)]},\tag{6.75}$$

where

$$B_{n,k} = e^{-sa(k+1)} \mathbb{E}_{\mathbb{Q}_s^x} \Big[\varphi_{s,k}^y(G_n \cdot x) (\psi_{s,\varepsilon}^- * \rho_{\varepsilon^2}) (T_n^x - a(k+1)) \Big],$$

$$D_{n,k} = e^{-sa(k+1)} \int_{|w| \ge \varepsilon} \mathbb{E}_{\mathbb{Q}_s^x} \Big[\varphi_{s,k}^y(G_n \cdot x) \psi_{s,\varepsilon}^- (T_n^x - a(k+1) - w) \Big] \rho_{\varepsilon^2}(w) dw$$

Since $B_{n,k} \ge D_{n,k}$ and $\sup_{x \in \mathbb{P}(V)} |r_s(x) - 1| \to 0$ as $n \to \infty$, by Fatou's lemma, we get

$$\liminf_{n \to \infty} \frac{A_n}{e^{\frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})}[1 - \Phi(t)]} \ge \sum_{k=0}^{\infty} \liminf_{n \to \infty} \frac{B_{n,k} - D_{n,k}}{e^{\frac{t^2}{2}}[1 - \Phi(t)]} \mathbb{1}_{\{k \le M_n\}}.$$

Estimate of $B_{n,k}$. Since the function $\hat{\rho}_{\varepsilon^2}$ is integrable on \mathbb{R} , by the Fourier inversion formula, we have

$$\psi_{s,\varepsilon}^- * \rho_{\varepsilon^2}(w) = \frac{1}{2\pi} \int_{\mathbb{R}} e^{iuw} \widehat{\psi}_{s,\varepsilon}^-(u) \widehat{\rho}_{\varepsilon^2}(u) du, \quad w \in \mathbb{R}.$$

Substituting $w = T_n^x - a(k+1)$, taking expectation with respect to $\mathbb{E}_{\mathbb{Q}_s^x}$, and using Fubini's theorem, we get

$$B_{n,k} = \frac{1}{2\pi} e^{-sa(k+1)} \int_{\mathbb{R}} e^{-iua(k+1)} R^n_{s,iu}(\varphi^y_{s,k})(x) \widehat{\psi}^-_{s,\varepsilon}(u) \widehat{\rho}_{\varepsilon^2}(u) du, \quad (6.76)$$

where

$$R_{s,iu}^n(\varphi_{s,k}^y)(x) = \mathbb{E}_{\mathbb{Q}_s^x}\left[\varphi_{s,k}^y(G_n \cdot x)e^{iuT_n^x}\right], \quad x \in \mathbb{P}(V).$$

Applying Proposition 6.2 with $l = \frac{a(k+1)}{n}$ and $\varphi = \varphi_{s,k}^y$, by simple calculations we deduce that uniformly in $x \in \mathbb{P}(V)$, $y \in \mathbb{P}(V^*)$, $s \in (0, s_0)$, $0 \leq k \leq M_n$ and $t \in [n^{\alpha}, o(\sqrt{n})]$,

$$\begin{split} &\int_{\mathbb{R}} e^{-iua(k+1)} R^n_{s,iu}(\varphi^y_{s,k})(x) \widehat{\psi}^-_{s,\varepsilon}(u) \widehat{\rho}_{\varepsilon^2}(u) du - \pi_s(\varphi^y_{s,k}) \frac{\sqrt{2\pi}}{s\sigma_s\sqrt{n}} \\ &\geqslant -C\left(\frac{t}{sn} + \frac{1}{st^2\sqrt{n}}\right) \|\varphi^y_{s,k}\|_{\infty} - C\frac{\log n}{sn} \|\varphi^y_{s,k}\|_{\gamma}. \end{split}$$

Note that $\sigma_s = \sqrt{\Lambda''(s)} = \sigma[1+O(s)]$. From (6.10), we have $\frac{t}{s\sigma\sqrt{n}} = 1+O(s)$, and thus $\frac{t}{s\sigma_s\sqrt{n}} = 1+O(s)$. Using the inequality $\sqrt{2\pi}te^{\frac{t^2}{2}}[1-\Phi(t)] \leq 1$ for any t > 0, it follows that

$$\frac{\int_{\mathbb{R}} e^{-iua(k+1)} R_{s,iu}^{n}(\varphi_{s,k}^{y})(x) \widehat{\psi}_{s,\varepsilon}^{-}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du}{e^{\frac{t^{2}}{2}} [1 - \Phi(t)]} - \pi_{s}(\varphi_{s,k}^{y}) \frac{2\pi t}{s\sigma_{s}\sqrt{n}}$$

$$\geq -C\left(\frac{t^{2}}{sn} + \frac{1}{st\sqrt{n}}\right) \|\varphi_{s,k}^{y}\|_{\infty} - C\frac{t\log n}{sn} \|\varphi_{s,k}^{y}\|_{\gamma}$$

$$\geq -C\left(\frac{t}{\sqrt{n}} + \frac{1}{t^{2}}\right) \|\varphi_{s,k}^{y}\|_{\infty} - C\frac{t\log n}{sn} \|\varphi_{s,k}^{y}\|_{\gamma}.$$
(6.77)

Using the construction of the function $\varphi_{s,k}^y$ and (6.69) give that uniformly in $s \in (0, s_0), w \in \mathbb{P}(V^*), \varphi \in \mathscr{B}_{\gamma}$ and $0 \leq k \leq M_n$,

$$\|\varphi_{s,k}^y\|_{\infty} \leqslant c \|\varphi\|_{\infty} \tag{6.78}$$

and

$$\|\varphi_{s,k}^{y}\|_{\gamma} \leq c \|\varphi\|_{\gamma} + c \frac{e^{\gamma ka}}{a^{\gamma}} \|\varphi\|_{\infty}.$$
(6.79)

Recalling that $t \in [n^{\alpha}, o(\sqrt{n})]$ and taking $\gamma > 0$ sufficiently small such that $\frac{e^{\gamma ka}}{a^{\gamma}} < n^{\alpha/2}$, from (6.77) we deduce that

$$\lim_{n \to \infty} \frac{\int_{\mathbb{R}} e^{-iua(k+1)} R_{s,iu}^n(\varphi_{s,k}^y)(x) \widehat{\psi}_{s,\varepsilon}^-(u) \widehat{\rho}_{\varepsilon^2}(u) du}{e^{\frac{t^2}{2}} [1 - \Phi(t)]} \ge \nu(\varphi_{0,k}^y) \times 2\pi$$

As s = o(1) as $n \to \infty$ for any fixed $k \ge 1$ and $a \in (0, \frac{1}{2})$, it holds that $\lim_{n\to\infty} e^{-sa(k+1)} = 1$. Then, in view of (6.76), it follows that

$$\lim_{n \to \infty} \frac{B_{n,k}}{e^{\frac{t^2}{2}} [1 - \Phi(t)]} = \nu(\varphi_{0,k}^y).$$

This, together with (4.18), implies the desired lower bound:

$$\sum_{k=0}^{\infty} \liminf_{n \to \infty} \frac{B_{n,k}}{e^{\frac{t^2}{2}} [1 - \Phi(t)]} \mathbb{1}_{\{k \le M_n\}} \ge \sum_{k=0}^{\infty} \nu(\varphi_{0,k}^y) = \nu(\varphi).$$
(6.80)

Estimate of $D_{n,k}$. We shall apply Fatou's lemma to provide an upper bound for $D_{n,k}$. An important issue here is to find a dominating function, which is possible due to the integrability of the density function ρ_{ε^2} on the real line. More specifically, in the same way as in the proof of (6.76), we use the Fourier inversion formula and the Fubini theorem to get

$$D_{n,k} = \frac{1}{2\pi} e^{-sa(k+1)} \\ \times \int_{|w| \ge \varepsilon} \left[\int_{\mathbb{R}} e^{-iu(a(k+1)+w)} R_{s,iu}^n(\varphi_{s,k}^y)(x) \widehat{\psi}_{s,\varepsilon}^-(u) \widehat{\rho}_{\varepsilon^2}(u) du \right] \rho_{\varepsilon^2}(w) dw.$$

We decompose the integral in $D_{n,k}$ into two parts:

$$\frac{D_{n,k}}{e^{\frac{t^2}{2}}[1-\Phi(t)]} = \frac{1}{2\pi} e^{-sa(k+1)} \left\{ \int_{\varepsilon \leqslant |w| < \sqrt{n}} + \int_{|w| \geqslant \sqrt{n}} \right\} \\
\times \frac{\int_{\mathbb{R}} e^{-iu(a(k+1)+w)} R_{s,iu}^n(\varphi_{s,k}^y)(x) \hat{\psi}_{s,\varepsilon}^-(u) \hat{\rho}_{\varepsilon^2}(u) du}{e^{\frac{t^2}{2}}[1-\Phi(t)]} \rho_{\varepsilon^2}(w) dw \\
=: E_{n,k} + F_{n,k}.$$
(6.81)

Estimate of $E_{n,k}$. Since $k \leq M_n$ and $|w| \leq \sqrt{n}$, we have $|l| := |a(k+1) + w|/n = O(\frac{1}{\sqrt{n}})$. Note that $\frac{t}{s\sigma_s\sqrt{n}} = 1 + O(s)$ and $e^{\frac{t^2}{2}}[1 - \Phi(t)] \geq \frac{1}{\sqrt{2\pi}}(\frac{1}{t} - \frac{1}{t^3})$, t > 1. Applying Proposition 6.2 with l = (a(k+1) + w)/n, we get that uniformly in $\varepsilon \leq |w| < \sqrt{n}$,

$$\lim_{n \to \infty} \frac{\int_{\mathbb{R}} e^{-iu(a(k+1)+w)} R_{s,iu}^n(\varphi_{s,k}^y)(x) \widehat{\psi}_{s,\varepsilon}^-(u) \widehat{\rho}_{\varepsilon^2}(u) du}{e^{\frac{t^2}{2}} [1 - \Phi(t)]} = 2\pi \times \pi_s(\varphi_{0,k}^y).$$

As above, for any fixed $k \ge 1$ and $a \in (0, \frac{1}{2})$, we have $\lim_{n\to\infty} e^{-sa(k+1)} = 1$. Since the function ρ_{ε^2} is integrable on \mathbb{R} , by the Lebesgue dominated convergence theorem, we obtain that there exists a constant c > 0 such that

$$\lim_{n \to \infty} E_{n,k} \mathbb{1}_{\{k \leqslant M_n\}} = \nu(\varphi_{0,k}^y) \int_{|w| \ge \varepsilon} \rho_{\varepsilon^2}(w) dw \leqslant c \varepsilon \nu(\varphi_{0,k}^y).$$

This, together with (4.18), implies that

$$\sum_{k=0}^{\infty} \lim_{n \to \infty} E_{n,k} \mathbb{1}_{\{k \leq M_n\}} \leq c\varepsilon \sum_{k=0}^{\infty} \nu(\varphi_{0,k}^y) \leq c\varepsilon \nu(\varphi).$$
(6.82)

Estimate of $E_{n,k,2}$. Notice that there exists a constant c > 0 such that for any $n \ge 1$,

$$\left| \int_{\mathbb{R}} e^{-iu(a(k+1)+w)} R^n_{s,iu}(\varphi^y_{s,k})(x) \widehat{\psi}^-_{s,\varepsilon}(u) \widehat{\rho}_{\varepsilon^2}(u) du \right| \leq \|\varphi^y_{s,k}\|_{\infty} \int_{\mathbb{R}} \widehat{\rho}_{\varepsilon^2}(u) du \leq c \|\varphi^y_{s,k}\|_{\infty}.$$

Using the fact that $t = o(\sqrt{n})$ and $\rho_{\varepsilon^2}(u) \leq \frac{c_{\varepsilon}}{u^2}$, and again the inequality $e^{\frac{t^2}{2}}[1-\Phi(t)] \geq \frac{1}{\sqrt{2\pi}}(\frac{1}{t}-\frac{1}{t^3}), t > 1$, we get

$$\limsup_{n \to \infty} F_{n,k} \mathbb{1}_{\{k \le M_n\}} \le c_{\varepsilon} \limsup_{n \to \infty} t \int_{|w| \ge \sqrt{n}} \rho_{\varepsilon^2}(w) dw \le c_{\varepsilon} \lim_{n \to \infty} \frac{t}{\sqrt{n}} = 0.$$

Hence

$$\sum_{k=0}^{\infty} \limsup_{n \to \infty} F_{n,k} \mathbb{1}_{\{k \leqslant M_n\}} = 0.$$
(6.83)

Since $\varepsilon > 0$ can be arbitrary small, combining (6.81), (6.82) and (6.83), we get the desired bound for $D_{n,k}$:

$$\sum_{k=0}^{\infty} \limsup_{n \to \infty} \frac{D_{n,k}}{e^{\frac{t^2}{2}} [1 - \Phi(t)]} \mathbb{1}_{\{k \le M_n\}} = 0.$$
 (6.84)

Putting together (6.80) and (6.84), we conclude the proof of (6.70) as well as the first expansion (6.63).

The proof of the second expansion (6.64) can be carried out in a similar way. As in (6.71) and (6.73), using (6.67), we have

$$\begin{split} & \mathbb{E}\left[\varphi(G_{n}\cdot x)\mathbb{1}_{\left\{\log|\langle f,G_{n}v\rangle|-n\lambda_{1}\leqslant-\sqrt{n}\sigma t\right\}}\right] \\ &= r_{s}(x)e^{-\frac{t^{2}}{2}-\frac{t^{3}}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})}\sum_{k=0}^{M_{n}}\mathbb{E}_{\mathbb{Q}_{s}^{x}}\left[(\varphi r_{s}^{-1}\chi_{k}^{y})(G_{n}\cdot x)e^{-sT_{n}^{x}}\mathbb{1}_{\{T_{n}^{x}+Y_{n}^{x,y}\leqslant0\}}\right] \\ &+ r_{s}(x)e^{-\frac{t^{2}}{2}-\frac{t^{3}}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})}\mathbb{E}_{\mathbb{Q}_{s}^{x}}\left[(\varphi r_{s}^{-1}\overline{\chi}_{M_{n}+1}^{y})(G_{n}\cdot x)e^{-sT_{n}^{x}}\mathbb{1}_{\{T_{n}^{x}+Y_{n}^{x,y}\leqslant0\}}\right] \\ &=:A_{n}'+A_{n}'', \end{split}$$

where this time we choose $M_n = \lfloor A \log n \rfloor$ with A > 0, and s < 0 satisfies the equation (6.34). The main difference for handling the first term consists in using Proposition 6.3 instead of Proposition 6.2. For second term, we have

$$\mathbb{E}_{\mathbb{Q}_{s}^{x}}\left[\left(\varphi r_{s}^{-1}\overline{\chi}_{M_{n}+1}^{y}\right)\left(G_{n}\cdot x\right)e^{-sT_{n}^{x}}\mathbb{1}_{\left\{T_{n}^{x}+Y_{n}^{x,y}\leqslant0\right\}}\right] \\ \leqslant c\|\varphi\|_{\infty}\mathbb{E}_{\mathbb{Q}_{s}^{x}}\left[\overline{\chi}_{M_{n}+1}^{y}\left(G_{n}\cdot x\right)e^{sY_{n}^{x,y}}\right] \\ \leqslant c\|\varphi\|_{\infty}e^{-saA\log n}\mathbb{Q}_{s}^{x}\left(-\log\delta(y,G_{n}\cdot x)\geqslant aA\log n\right) \\ \leqslant \frac{c}{n}\|\varphi\|_{\infty}, \tag{6.85}$$

where in the last inequality we use Lemma 4.5 and choose A large enough. Using (6.85), the inequality $te^{\frac{t^2}{2}}\Phi(-t) \ge \frac{1}{\sqrt{2\pi}}$ for all t > 0 and the fact that $t = o(\sqrt{n})$, we get

$$\frac{A_n''}{e^{-\frac{t^3}{\sqrt{n}}\zeta(-\frac{t}{\sqrt{n}})}\Phi(-t)} \leqslant \frac{c}{n} \|\varphi\|_{\infty} \frac{1}{e^{\frac{t^2}{2}}\Phi(-t)} \leqslant \frac{ct}{n} \|\varphi\|_{\infty} \leqslant \frac{c}{\sqrt{n}} \|\varphi\|_{\infty}.$$

This finishes the proof of the expansion (6.64).

Proof of Theorem 2.8. Theorem 2.8 follows from Theorems 6.4 and 6.6. \Box

7. PROOF OF THE LOCAL LIMIT THEOREM WITH MODERATE DEVIATIONS

The goal of this section is to establish Theorem 2.9 on the local limit theorems with moderate deviations for the coefficients $\langle f, G_n v \rangle$.

The following result which is proved in [45] will be used to prove Theorem 2.9. Assume that $\psi : \mathbb{R} \to \mathbb{C}$ is a continuous function with compact support in \mathbb{R} , and that ψ is differentiable in a small neighborhood of 0 on the real line.

Lemma 7.1 ([45]). Assume conditions **A1** and **A2**. Then, there exist constants $s_0, \delta, c, C > 0$ such that for all $s \in (-s_0, s_0)$, $x \in \mathbb{P}(V)$, $|l| \leq \frac{1}{\sqrt{n}}$, $\varphi \in \mathscr{B}_{\gamma}$ and $n \geq 1$,

$$\left| \sigma_s \sqrt{n} e^{\frac{nt^2}{2\sigma_s^2}} \int_{\mathbb{R}} e^{-itln} R_{s,iu}^n(\varphi)(x) \psi(t) dt - \sqrt{2\pi} \pi_s(\varphi) \psi(0) \right|$$

$$\leqslant \frac{C}{\sqrt{n}} \|\varphi\|_{\gamma} + \frac{C}{n} \|\varphi\|_{\gamma} \sup_{|t| \leqslant \delta} \left(|\psi(t)| + |\psi'(t)| \right) + C e^{-cn} \|\varphi\|_{\gamma} \int_{\mathbb{R}} |\psi(t)| dt. \quad (7.1)$$

We also need the result below, which is proved in [48, Lemma 6.2].

Lemma 7.2 ([48]). Assume A1 and A2. Let p > 0 be any fixed constant. Then, there exists a constant $s_0 > 0$ such that

$$\sup_{n \ge 1} \sup_{s \in (-s_0, s_0)} \sup_{y \in \mathbb{P}(V^*)} \sup_{x \in \mathbb{P}(V)} \mathbb{E}_{\mathbb{Q}_s^x}\left(\frac{1}{\delta(y, G_n \cdot x)^{p|s|}}\right) < +\infty.$$

Using Lemmas 4.5, 7.1 and 7.2, we are equipped to prove Theorem 2.9.

Proof of Theorem 2.9. It suffices to establish the second assertion of the theorem since the first one is its particular case. Without loss of generality, we assume that the target functions φ and ψ are non-negative.

By the change of measure formula (4.3), we get that for any $s \in (-s_0, s_0)$ with sufficiently small $s_0 > 0$,

$$I := \mathbb{E}\Big[\varphi(G_n \cdot x)\psi(\sigma(G_n, x) - n\lambda_1 - \sqrt{n\sigma t})\Big]$$

$$= r_s(x)\kappa^n(s)\mathbb{E}_{\mathbb{Q}_s^x}\Big[(\varphi r_s^{-1})(G_n x)e^{-s\sigma(G_n, x)}\psi(\log|\langle f, G_n v\rangle| - n\lambda_1 - \sqrt{n\sigma t})\Big].$$
(7.2)

As in the equation (6.4), for any $|t| = o(\sqrt{n})$ (not necessarily t > 1), we choose $s \in (-s_0, s_0)$ satisfying the equation

$$\Lambda'(s) - \Lambda'(0) = \frac{\sigma t}{\sqrt{n}}.$$
(7.3)

Note that $s \in (-s_0, 0]$ if $t \in (-o(\sqrt{n}), 0]$, and $s \in [0, s_0)$ if $t \in [0, o(\sqrt{n}))$. In the same way as in the proof of (6.72), from (7.3) it follows that for any $|t| = o(\sqrt{n})$,

$$s\Lambda'(s) - \Lambda(s) = \frac{t^2}{2n} - \frac{t^3}{n^{3/2}} \zeta\Big(\frac{t}{\sqrt{n}}\Big),$$

where ζ is the Cramér series defined by (2.4). For brevity, denote

$$T_n^x = \sigma(G_n, x) - n\Lambda'(s), \qquad Y_n^{x,y} = \log \delta(y, G_n \cdot x).$$

Hence, using (3.8), we have

$$I = r_s(x)e^{-n[s\Lambda'(s) - \Lambda(s)]} \mathbb{E}_{\mathbb{Q}_s^x} \Big[(\varphi r_s^{-1})(G_n \cdot x)e^{-sT_n^x} \psi \Big(T_n^x + Y_n^{x,y} \Big) \Big]$$

= $r_s(x)e^{-\frac{t^2}{2} + \frac{t^3}{\sqrt{n}}\zeta(\frac{t}{\sqrt{n}})} \mathbb{E}_{\mathbb{Q}_s^x} \Big[(\varphi r_s^{-1})(G_n \cdot x)e^{-sT_n^x} \psi \Big(T_n^x + Y_n^{x,y} \Big) \Big].$

Notice that $r_s(x) \to 1$ as $n \to \infty$, uniformly in $x \in \mathbb{P}(V)$. Thus in order to establish Theorem 2.9, it suffices to prove the following asymptotic: as $n \to \infty$,

$$J := \sigma \sqrt{2\pi n} \mathbb{E}_{\mathbb{Q}_s^x} \Big[(\varphi r_s^{-1}) (G_n \cdot x) e^{-sT_n^x} \psi \Big(T_n^x + Y_n^{x,y} \Big) \Big] \to \nu(\varphi) \int_{\mathbb{R}} \psi(u) du.$$
(7.4)

We shall apply Lemmas 4.5 and 7.1 to establish (7.4). Recall that the functions χ_k^y and $\overline{\chi}_k^y$ are defined by (6.66). Then, using the partition of the unity (6.67) as in the proof of Theorem 6.6, we have

$$J =: J_1 + J_2, \tag{7.5}$$

where, with $M_n = \lfloor A \log n \rfloor$ and a sufficiently large constant A > 0,

$$J_1 = \sigma \sqrt{2\pi n} \mathbb{E}_{\mathbb{Q}_s^x} \Big[(\varphi r_s^{-1} \overline{\chi}_{M_n}^y) (G_n \cdot x) e^{-sT_n^x} \psi \Big(T_n^x + Y_n^{x,y} \Big) \Big]$$

$$J_2 = \sigma \sqrt{2\pi n} \sum_{k=0}^{M_n - 1} \mathbb{E}_{\mathbb{Q}_s^x} \Big[(\varphi r_s^{-1} \chi_k^y) (G_n \cdot x) e^{-sT_n^x} \psi \Big(T_n^x + Y_n^{x,y} \Big) \Big].$$

Upper bound of J_1 . In order to prove that $J_1 \to 0$ as $n \to \infty$, we are led to consider two cases: $s \ge 0$ and s < 0.

When $s \ge 0$, since the function ψ has a compact support, say $[b_1, b_2]$, we have $T_n^x + Y_n^{x,y} \in [b_1, b_2]$. Noting that $Y_n^{x,y} \le 0$, we get $T_n^x \ge b_1$, and hence $e^{-sT_n^x} \le e^{-sb_1} \le c$. Since the function ψ is directly Riemann integrable on \mathbb{R} , it is bounded and hence

$$J_1 \leqslant c\sqrt{n} \, \mathbb{Q}_s^x \Big(Y_n^{x,y} \leqslant -\lfloor A \log n \rfloor \Big).$$

Applying Lemma 4.5 with $k = \lfloor A \log n \rfloor$ and choosing A sufficiently large, we obtain that, as $n \to \infty$, uniformly in $s \in [0, s_0)$,

$$J_1 \leqslant C\sqrt{n} \, e^{-c\lfloor A \log n \rfloor} \to 0. \tag{7.6}$$

When s < 0, from $T_n^x + Y_n^{x,y} \in [b_1, b_2]$, we get that $e^{-sT_n^x} \leq e^{-sb_2 + sY_n^{x,y}}$. Hence, by the Hölder inequality, Lemmas 4.5 and 7.2, we obtain that, as $n \to \infty$, uniformly in $s \in (-s_0, 0]$,

$$J_1 \leqslant C\sqrt{n} \left\{ \mathbb{E}_{\mathbb{Q}_s^x} \left(\frac{1}{\delta(y, G_n \cdot x)^{-2s}} \right) \mathbb{Q}_s^x \left(Y_n^{x, y} \leqslant -\lfloor A \log n \rfloor \right) \right\}^{1/2} \\ \leqslant C\sqrt{n} e^{-c\lfloor A \log n \rfloor} \to 0,$$

where again A is large enough.

Upper bound of J_2 . Note that the support of the function χ_k^y is contained in the set $\{x \in \mathbb{P}(V) : -Y_n^{x,y} \in [a(k-1), a(k+1)]\}$. Therefore on $\operatorname{supp} \chi_k^y$ we have $-a \leq Y_n^{x,y} + ak \leq a$. For any $w \in \mathbb{R}$ set $\Psi_s(w) = e^{-sw}\psi(w)$ and, according to (6.1), define $\Psi_{s,\varepsilon}^+(w) = \sup_{w' \in \mathbb{B}_{\varepsilon}(w)} \Psi_s(w')$, for $\varepsilon \in (0, \frac{1}{2})$. Let also

$$\varphi_{s,k}^y(x) = (\varphi r_s^{-1} \chi_k^y)(x), \quad x \in \mathbb{P}(V).$$
(7.7)

With this notation, choosing $a \in (0, \varepsilon)$, it follows that

$$J_{2} \leqslant \sigma \sqrt{2\pi n} \sum_{k=0}^{M_{n}-1} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \Big[\varphi_{s,k}^{y}(G_{n} \cdot x) e^{-sY_{n}^{x,y}} \Psi_{s,\varepsilon}^{+}(T_{n}^{x}-ak) \Big]$$
$$\leqslant \sigma \sqrt{2\pi n} \sum_{k=0}^{M_{n}-1} e^{-sa(k-1)} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \Big[\varphi_{s,k}^{y}(G_{n} \cdot x) \Psi_{s,\varepsilon}^{+}(T_{n}^{x}-ak) \Big].$$

Since the function $\Psi_{s,\varepsilon}^+$ is non-negative and integrable on the real line, using Lemma 6.1, we get

$$J_2 \leqslant (1 + C_{\rho}(\varepsilon)) \sigma \sqrt{2\pi n} \sum_{k=0}^{M_n - 1} e^{-sa(k-1)} \\ \times \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{s,k}^y(G_n \cdot x) (\Psi_{s,\varepsilon}^+ * \rho_{\varepsilon^2}) (T_n^x - ak) \right]$$

where $C_{\rho}(\varepsilon) > 0$ is a constant converging to 0 as $\varepsilon \to 0$. Since the function $\hat{\rho}_{\varepsilon^2}$ is integrable on \mathbb{R} , by the Fourier inversion formula, we have

$$(\Psi_{s,\eta,\varepsilon}^+ * \rho_{\varepsilon^2})(T_n^x - ak) = \frac{1}{2\pi} \int_{\mathbb{R}} e^{iu(T_n^x - ak)} \widehat{\Psi}_{s,\varepsilon}^+(u) \widehat{\rho}_{\varepsilon^2}(u) du.$$

By the definition of the perturbed operator $R_{s,iu}$ (cf. (4.5)), and Fubini's theorem, we obtain

$$J_{2} \leq (1 + C_{\rho}(\varepsilon))\sigma \sqrt{\frac{n}{2\pi}} \sum_{k=0}^{\infty} \mathbb{1}_{\{k \leq M_{n}-1\}} e^{-sa(k-1)}$$
$$\times \int_{\mathbb{R}} e^{-iuak} R^{n}_{s,iu}(\varphi^{y}_{s,k})(x) \widehat{\Psi}^{+}_{s,\varepsilon}(u) \widehat{\rho}_{\varepsilon^{2}}(u) du.$$
(7.8)

To deal with the integral in (7.8), we shall use Lemma 7.1. Note that $e^{\frac{Ck^2}{n}} \to 1$ as $n \to \infty$, uniformly in $0 \leq k \leq M_n - 1$. Since the function $\widehat{\Psi}_{s,\varepsilon}^+ \widehat{\rho}_{\varepsilon^2}$ is compactly supported on \mathbb{R} , applying Lemma 7.1 with $\varphi = \varphi_{s,k}^y$, $\psi = \widehat{\Psi}_{s,\varepsilon}^+ \widehat{\rho}_{\varepsilon^2}$ and $l = \frac{ak}{n\sigma}$, we obtain that there exists a constant C > 0 such that for all $s \in (-s_0, s_0)$, $x \in \mathbb{P}(V)$, $y \in \mathbb{P}(V^*)$, $0 \leq k \leq M_n - 1$, $\varphi \in \mathscr{B}_{\gamma}$ and $n \geq 1$,

$$\left| \sigma \sqrt{\frac{n}{2\pi}} \int_{\mathbb{R}} e^{-itak} R^n_{s,iu}(\varphi^y_{s,k})(x) \widehat{\Psi}^+_{s,\varepsilon}(u) \widehat{\rho}_{\varepsilon^2}(u) du - \widehat{\Psi}^+_{s,\varepsilon}(0) \widehat{\rho}_{\varepsilon^2}(0) \pi_s(\varphi^y_{s,k}) \right| \\ \leqslant \frac{C}{\sqrt{n}} \|\varphi^y_{s,k}\|_{\gamma}.$$

Using (6.79) and choosing a sufficiently small $\gamma > 0$, one can verify that the series $\frac{C}{\sqrt{n}} \sum_{k=0}^{M_n-1} \|\varphi_{s,k}^y\|_{\gamma}$ converges to 0 as $n \to \infty$. Consequently, we are allowed to interchange the limit as $n \to \infty$ and the sum over k in (7.8).

Then, noting that $\hat{\rho}_{\varepsilon^2}(0) = 1$ and $\hat{\Psi}^+_{0,\varepsilon}(0) = \int_{\mathbb{R}} \sup_{w' \in \mathbb{B}_{\varepsilon}(w)} \Psi_0(w') dw$, we obtain that uniformly in $v \in V$ and $f \in V^*$ with $\|v\| = 1$ and $\|f\| = 1$,

$$\limsup_{n \to \infty} J_2 \leqslant (1 + C_{\rho}(\varepsilon)) \int_{\mathbb{R}} \sup_{w' \in \mathbb{B}_{\varepsilon}(w)} \Psi_0(w') dw \sum_{k=1}^{\infty} \nu\left(\varphi_{0,k}^y\right) \\
= (1 + C_{\rho}(\varepsilon)) \nu(\varphi) \int_{\mathbb{R}} \sup_{w' \in \mathbb{B}_{\varepsilon}(w)} \Psi_0(w') dw, \tag{7.9}$$

where in the last equality we used (4.18). Letting $\varepsilon \to 0, n \to \infty$, and noting that $C_{\rho}(\varepsilon) \to 0$, we obtain the desired upper bound for J_2 : uniformly in $v \in V$ and $f \in V^*$ with ||v|| = ||f|| = 1,

$$\limsup_{n \to \infty} J_2 \leqslant \nu(\varphi) \int_{\mathbb{R}} \psi(u) du.$$
(7.10)

Lower bound of J_2 . Since on the set $\{-Y_n^{x,y} \in [a(k-1), a(k+1)]\}$, we have $-a \leq Y_n^{x,y} + ak \leq a$. Set $\Psi_s(w) = e^{-sw}\psi(w)$, $w \in \mathbb{R}$ and $\Psi_{s,\varepsilon}^+(w) = \inf_{w' \in \mathbb{B}_{\varepsilon}(w)} \Psi_s(w')$, for $\varepsilon \in (0, \frac{1}{2})$. Then, with $a \in (0, \varepsilon)$,

$$J_{2} \geq \sigma \sqrt{2\pi n} \sum_{k=0}^{M_{n}-1} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \Big[\varphi_{s,k}^{y}(G_{n} \cdot x) e^{-sY_{n}^{x,y}} \Psi_{s,\varepsilon}^{-}(T_{n}^{x}-ak) \Big]$$
$$\geq \sigma \sqrt{2\pi n} \sum_{k=0}^{M_{n}-1} e^{-sak} \mathbb{E}_{\mathbb{Q}_{s}^{x}} \Big[\varphi_{s,k}^{y}(G_{n} \cdot x) \Psi_{s,\varepsilon}^{-}(T_{n}^{x}-ak) \Big].$$

By Fatou's lemma, it follows that

$$\liminf_{n \to \infty} J_2 \geqslant \sum_{k=0}^{\infty} \liminf_{n \to \infty} \sigma \sqrt{2\pi n} e^{-sak} \mathbb{E}_{\mathbb{Q}_s^x} \left[\varphi_{s,k}^y (G_n \cdot x) \Psi_{s,\varepsilon}^- (T_n^x - ak) \right].$$

Since s = o(1) as $n \to \infty$, we see that for fixed $k \ge 1$, we have $e^{-sak} \to 1$ as $n \to \infty$. Since the function $\Psi_{s,\varepsilon}^-$ is non-negative and integrable on the real line, by Lemma 6.1, we get

$$\liminf_{n \to \infty} J_2 \geqslant \sum_{k=0}^{\infty} \liminf_{n \to \infty} \sigma \sqrt{2\pi n} \mathbb{E}_{\mathbb{Q}_s^x} \Big[\varphi_{s,k}^y (G_n \cdot x) (\Psi_{s,\varepsilon}^- * \rho_{\varepsilon^2}) (T_n^x - ak) \Big] \\
- \sum_{k=0}^{\infty} \limsup_{n \to \infty} \sigma \sqrt{2\pi n} \int_{|w| \ge \varepsilon} \mathbb{E}_{\mathbb{Q}_s^x} \Big[\varphi_{s,k}^y (G_n \cdot x) \Psi_{s,\varepsilon}^- (T_n^x - ak - w) \Big] \rho_{\varepsilon^2}(w) dw \\
=: J_3 - J_4.$$
(7.11)

Lower bound of J_3 . Proceeding as in the proof of the upper bound (7.9) and using Lemma 7.1, we obtain

$$J_3 \ge \int_{\mathbb{R}} \inf_{w' \in \mathbb{B}_{\varepsilon}(w)} \Psi_{0,\varepsilon}^{-}(w') dw \sum_{k=0}^{\infty} \nu\left(\varphi_{0,k}^y\right).$$
(7.12)

Taking the limit as $\varepsilon \to 0$ and $n \to \infty$, we get the lower bound for J_3 : uniformly in $v \in V$ and $f \in V^*$ with ||v|| = 1 and ||f|| = 1,

$$\liminf_{n \to \infty} J_3 \geqslant \nu(\varphi) \int_{\mathbb{R}} \psi(u) du.$$
(7.13)

Upper bound of J_4 . By Lemma 6.1, we have $\Psi_{s,\varepsilon}^- \leq (1 + C_{\rho}(\varepsilon))\Psi_{s,\varepsilon}^+ * \rho_{\varepsilon^2}$. Applying Lemma 7.1 with $\varphi = \varphi_{s,k}^y$ and $\psi = \widehat{\Psi}_{s,\varepsilon}^+ \widehat{\rho}_{\varepsilon^2}$, it follows from the Lebesgue dominated convergence theorem that

$$J_4 \leqslant (1 + C_{\rho}(\varepsilon)) \sum_{k=0}^{\infty} \nu\left(\varphi_{0,k}^y\right) \widehat{\Psi}_{0,\varepsilon}^+(0) \widehat{\rho}_{\varepsilon^2}(0) \int_{|w| \ge \varepsilon} \rho_{\varepsilon^2}(w) dw, \qquad (7.14)$$

which converges to 0 as $\varepsilon \to 0$.

Combining (7.11), (7.13) and (7.14), we get the desired lower bound for J_2 : uniformly in $v \in V$ and $f \in V^*$ with ||v|| = 1 and ||f|| = 1,

$$\liminf_{n \to \infty} J_2 \ge \nu(\varphi) \int_{\mathbb{R}} \psi(u) du.$$
(7.15)

Putting together (7.5), (7.6), (7.10) and (7.15), we obtain the asymptotic (2.24). This ends the proof of Theorem 2.9.
