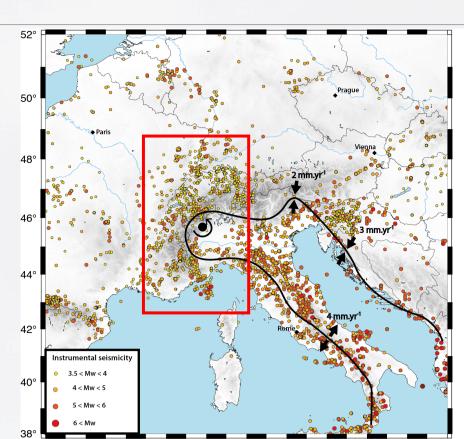
Estimation of the present-day deformation of the Western Alps

Introduction

The Western Alps is one of the most seismically active regions in western Europe with a large density of earthquakes and some historical damaging earthquakes (example: Bâle earthquake, 1356). The seismic strain computed from focal mechanisms shows a E-W to NW-SE extension in the French Alps, and a N-S extension in Southern Switzerland (Delacou et al., 2004).

The identification of robust strain rate patterns in the Western Alps is made difficult by the low deformation rate in the region, hard to distinguish from the noise (Masson et al., 2019b; Walpersdorf et al., 2018. the precise characterization of present-day strain rate, and its spatial variability, is a crucial point to understand the origin of deformation. The main goal of this study is to identify a robust strain rate model by the re-evaluation of the GNSS horizontal velocities with recent data and the comparison of different datasets to identify common signals. We bring a comparison analysis on three velocity fields computed from three different networks.

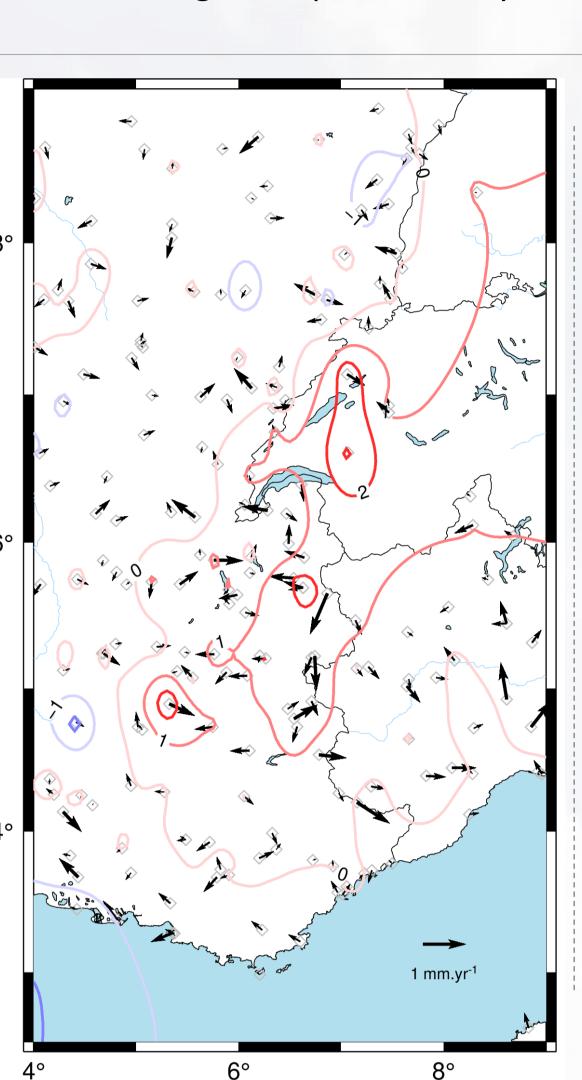

Géosciences Montpellier (GM)

- Computed by Christine Masson (Masson et al., 2019)
 - 925 stations
- From 1998 to 2016 (mean duration of 7.9 years)
- Computed in a IGb08 reference frame*

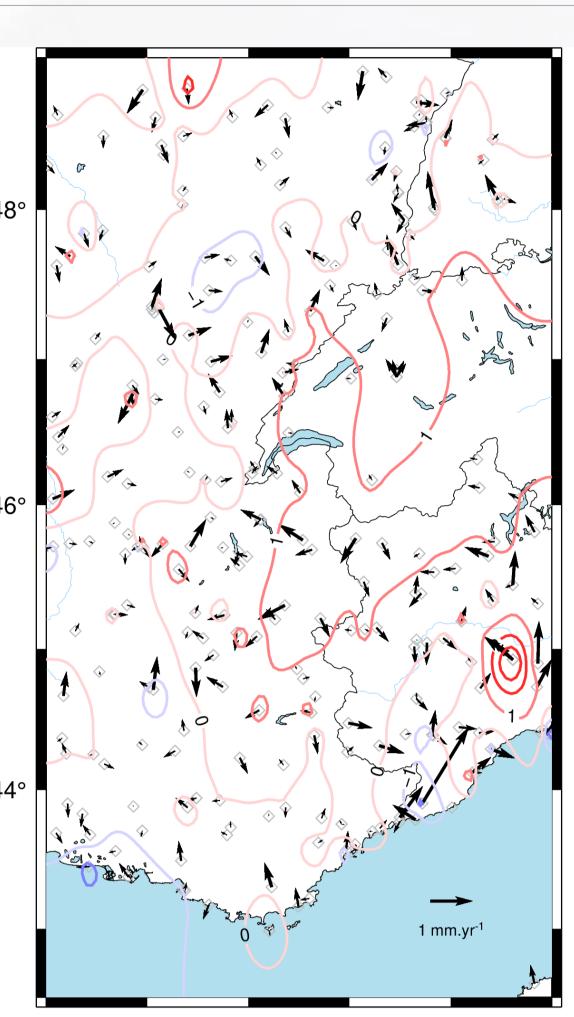
*Vertical velocities (represented with lines) have been corrected from their different reference frame to be compared



Nevada Geodetic Laboratory

(NGL)

- Computed by Juliette
 Grosset for this study from the NGL position time series (Blewitt, 2018)
 - 1123 stations
- From 1998 to 2021 (mean duration of 10 years)
- NGL data computed using JPL product in a IGS14 reference frame*

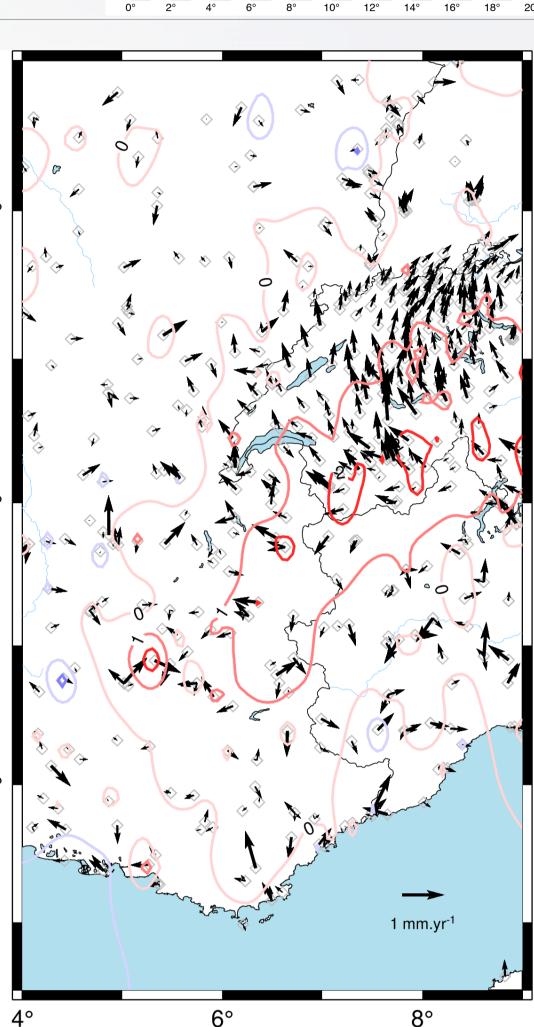

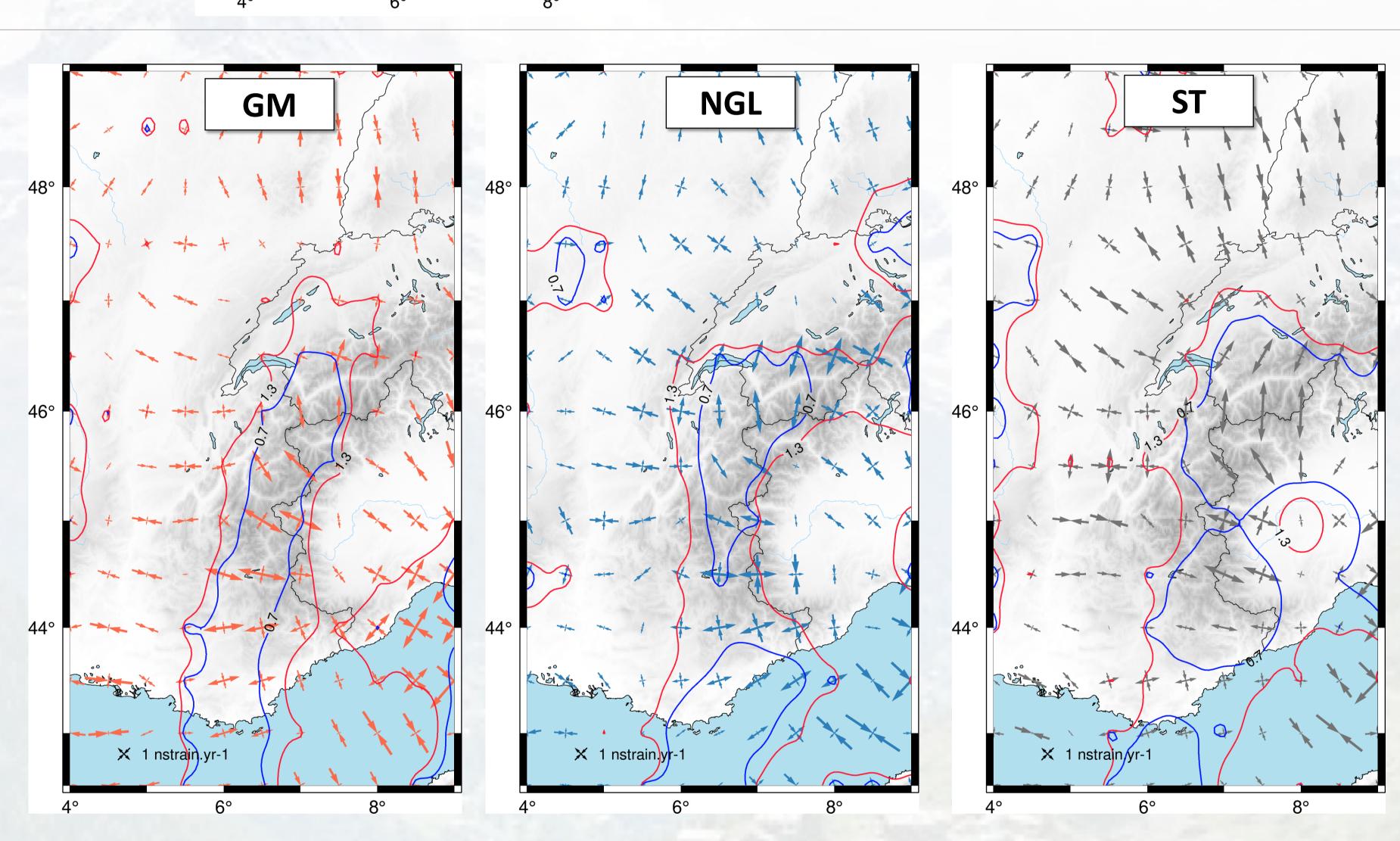

Strain rates

- Extension and strike-slip strain rates in the inner Alps, and shortening rates in the foreland.
- ➤ A N-S extension rate area is present on the three maps on the France-Switzerland-Italy border, from about 1.7 to 2.3 × 10–9 yr-1
- The extension rate is associated in the French Alps with strike-slip (GM, NGL)
- ➤ Very low deformation rates in northern Switzerland.



Extension < 0.7 < Strike - slip < 1.3 < Shortening

Synthesis

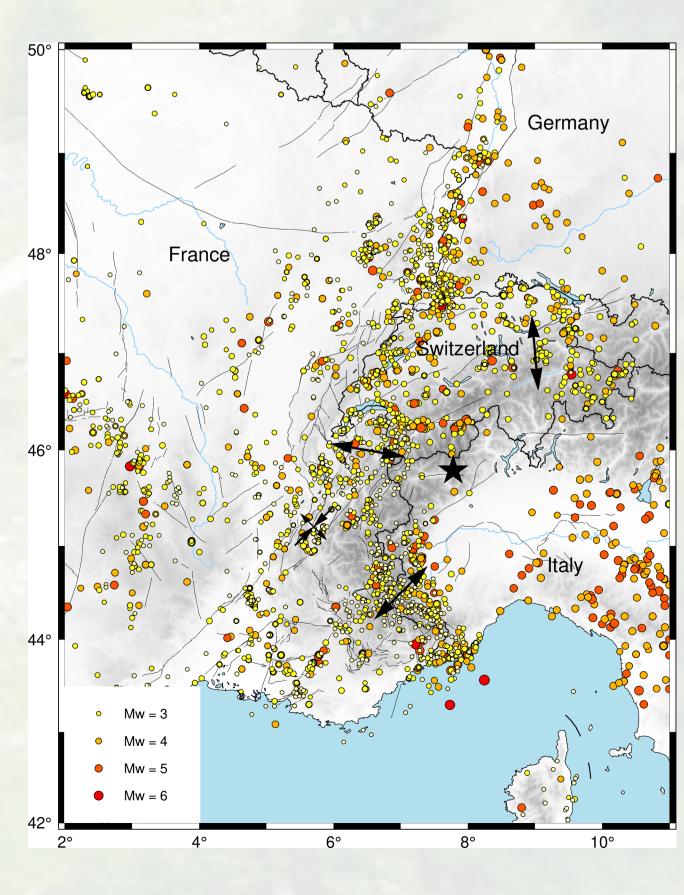
First-order synthetic strain rate map interpreted from the comparison of the 3 GNSS datasets.

Demarcated area and arrows amplitude are extracted from the 3 strain rate map.

What are the processes of deformation in the Western Alps?

- ➤ Uplift and extension rates are first-order consistent with isostatic adjustment processes, such as GIA (Mey et al., 2016, Grosset et al., submitted) or erosion (Vernant et al., 2013).
- French Alps extension rate/strike-slip could be influenced by Adria/Eurasia rotation (D'Agostino et al., 2008)
- None of these processes explained completely the shortening in the foreland.
