Weighted posets and the enriched monomial basis of QSym

Abstract. Gessel's fundamental and Stembridge's peak functions are the generating functions for (enriched) *P*-partitions on labelled chains. They are also the bases of two significant subalgebras of formal power series, respectively the ring of quasisymmetric functions (QSym) and the algebra of peaks. Hsiao introduced the monomial peak functions, a basis of the algebra of peaks indexed by odd integer compositions whose relation to peak functions mimics the one between the monomial and fundamental bases of QSym. We show that the extension of monomial peaks to any composition is a new basis of QSym and generalise Hsiao's results including the product rule. To this end we introduce a weighted variant of posets and study their generating functions.

Résumé. Les fonctions de Gessel et de Stembridge sont les fonctions génératrices des *P*-partitions (enrichies) sur des chaînes étiquetées. Ce sont aussi les bases de deux sous-algèbres des séries formelles, l'anneau des fonctions quasisymétriques (QSym) et l'algèbre des pics. Hsiao a introduit les monômes de pic, une base de l'algèbre de pics indexée par des compositions d'entier impaires dont la relation aux fonctions de pics imite celle entre les bases monomiales et fondamentales de QSym. Nous montrons que leur extension à n'importe quelle composition est une nouvelle base de QSym et généralisons les résultats de Hsiao, inclus la règle du produit. A cette fin, nous introduisons une variante pondérée des posets et étudions leurs fonctions génératrices.

Keywords: Quasisymmetric functions, P-partitions, peak functions

1 Introduction

1.1 Compositions and permutation statistics

Let $\mathbb{P} = \{1, 2, 3, ...\}$, $\mathbb{N} = \{0, 1, 2, ...\}$, and $[n] = \{1, 2, ..., n\}$ for any $n \in \mathbb{N}$. A *composition* $\alpha = (\alpha_1, \alpha_2, ..., \alpha_p)$ of an integer n is a finite sequence of $\ell(\alpha) := p$ positive integers such that $|\alpha| := \sum_i \alpha_i = n$. An *odd composition* is a composition containing only odd integers. We let Comp(n) and Odd(n) denote the sets of compositions and odd

compositions (respectively) of *n*.

Let S_n be the symmetric group on [n]. Given a permutation $\pi \in S_n$, we look at two significant statistics. The *descent set* $Des(\pi)$ and the *peak set* $Peak(\pi)$ of π are the subsets of [n-1] defined as

$$Des(\pi) = \{1 \le i \le n - 1 | \pi(i) > \pi(i+1)\},\$$
$$Peak(\pi) = \{2 \le i \le n - 1 | \pi(i-1) < \pi(i) > \pi(i+1)\}.$$

A subset of [n - 1] that neither contains 1 nor contains two consecutive integers is called *peak-lacunar*. The peak set of a permutation is peak-lacunar.

There is a natural bijection between compositions of *n* and subsets of [n-1]. Namely, for a composition $\alpha = (\alpha_1, \alpha_2, ..., \alpha_p) \in \text{Comp}(n)$, let $\text{Des}(\alpha)$ be the subset of [n-1] defined as

$$Des(\alpha) = \{\alpha_1, \alpha_1 + \alpha_2, \dots, \alpha_1 + \alpha_2 + \dots + \alpha_{p-1}\}$$

As a result, $|\text{Comp}(n)| = 2^{n-1}$. Odd compositions of n, on the other hand, are in one-to-one correspondence with peak-lacunar subsets of [n-1]. This bijection may be stated as follows (see [7]). For $\alpha = (2i_1 + 1, 2i_2 + 1, ..., 2i_p + 1) \in \text{Odd}(n)$, let

$$\widehat{\alpha} = (\underbrace{2, \ldots, 2}^{i_1}, 1, \underbrace{2, \ldots, 2}^{i_2}, 1, \ldots, \underbrace{2, \ldots, 2}^{i_p}, 1).$$

If

$$\widehat{\alpha} = (\overbrace{1,\ldots,1}^{j_1}, 2, \overbrace{1,\ldots,1}^{j_2}, 2, \ldots, \overbrace{1,\ldots,1}^{j_l}, 2, 1, \ldots, 1),$$

then we set

$$\operatorname{Peak}(\alpha) = \left\{ \sum_{m=1}^{s} (j_m + 2) | 1 \le s \le l \right\}.$$

Example 1.1. Let $\alpha = (1, 1, 3, 3, 1) \in \text{Odd}(9)$. Then, $\text{Des}(\alpha) = \{1, 2, 5, 8\}$. Furthermore, one has $\widehat{\alpha} = (1, 1, 2, 1, 2, 1, 1)$ and $\text{Peak}(\alpha) = \{4, 7\}$.

Finally, a permutation $\pi \in S_n$ may be written as a word $\pi = \pi_1 \pi_2 \dots \pi_n$ with $\pi_i = \pi(i)$. This is called the *one-line notation* of π . Given two permutations $\pi \in S_n$ and $\sigma \in S_m$, let $\pi \sqcup \sigma$ be the subset of S_{n+m} consisting of all shuffles of the words $\pi = \pi_1 \pi_2 \dots \pi_n$ and $n + \sigma = (n + \sigma_1)(n + \sigma_2) \dots (n + \sigma_m)$ (that is, of all permutations in S_{n+m} that contain π and $n + \sigma$ as subwords in their one-line notation).

1.2 Quasisymmetric functions

Fix a commutative ring **k** and consider the ring **k** [[X]] of formal power series in countably many commuting variables $X = \{x_1, x_2, x_3, ...\}$. In [2], Gessel introduces the *quasisymmetric functions*, i.e., the bounded-degree formal power series in **k** [[X]] such that for any non-negative integers $\alpha_1, \alpha_2, ..., \alpha_p$ and any strictly increasing sequence of distinct indices $i_1 < i_2 < \cdots < i_p$ the coefficient of $x_1^{\alpha_1} x_2^{\alpha_2} \cdots x_p^{\alpha_p}$ is equal to the coefficient of $x_{i_1}^{\alpha_1} x_{i_2}^{\alpha_2} \cdots x_{i_p}^{\alpha_p}$. The set of all quasisymmetric functions is a **k**-subalgebra of **k** [[X]], denoted by QSym and called the *ring of quasisymmetric functions*. For any $n \in \mathbb{N}$ and any composition $\alpha = (\alpha_1, \alpha_2, ..., \alpha_p) \in \text{Comp}(n)$, the *monomial quasisymmetric function* M_{α} and the *fundamental quasisymmetric function* L_{α} indexed by α are defined as

$$M_{\alpha} = \sum_{i_1 < \cdots < i_p} x_{i_1}^{\alpha_1} x_{i_2}^{\alpha_2} \cdots x_{i_p}^{\alpha_p}, \qquad L_{\alpha} = \sum_{\substack{i_1 \leq \cdots \leq i_n; \\ j \in \mathrm{Des}(\alpha) \Rightarrow i_j < i_{j+1}}} x_{i_1} x_{i_2} \cdots x_{i_n}$$

Example 1.2. *As an example, for* n = 3*, we have*

$$M_{(2,1)} = \sum_{i < j} x_i^2 x_j = x_1^2 x_2 + x_1^2 x_3 + x_2^2 x_3 + x_1^2 x_4 + x_2^2 x_4 + x_3^2 x_4 + \dots,$$

$$L_{(2,1)} = \sum_{i \le j < k} x_i x_j x_k = x_1^2 x_2 + x_1^2 x_3 + x_1 x_2 x_3 + x_2^2 x_3 + x_1^2 x_4 + x_1 x_2 x_4 + x_2^2 x_4 + \dots.$$

The sets $\{M_{\alpha}\}_{n \in \mathbb{N}, \alpha \in \text{Comp}(n)}$ and $\{L_{\alpha}\}_{n \in \mathbb{N}, \alpha \in \text{Comp}(n)}$ are two bases of the **k**-module QSym. They are related through

$$L_{\alpha} = \sum_{\substack{\beta \in \operatorname{Comp}(n); \\ \operatorname{Des}(\alpha) \subseteq \operatorname{Des}(\beta)}} M_{\beta}.$$
 (1.1)

1.3 Peak and monomial peak functions

In [10], Stembridge studies another significant family of quasisymmetric functions. Given an $n \in \mathbb{N}$ and an $\alpha \in \text{Odd}(n)$, we define

$$K_{\alpha} = \sum_{\substack{i_1 \leq \cdots \leq i_n; \\ j \in \text{Peak}(\alpha) \Rightarrow i_{j-1} < i_{j+1}}} 2^{|\{i_1, i_2, \dots, i_n\}|} x_{i_1} x_{i_2} \cdots x_{i_n}.$$

The K_{α} are quasisymmetric functions named *peak functions* because of their relation to the peak statistic on permutations (see Section 1.4). The set $\{K_{\alpha}\}_{n \in \mathbb{N}, \alpha \in \text{Odd}(n)}$ is a basis of a subalgebra of QSym named the *algebra of peaks* (Π in [10]). Hsiao defines in [7] another basis of the algebra of peaks called the *monomial peak functions*. For any odd composition $\alpha = (\alpha_1, \alpha_2, ..., \alpha_p) \in \text{Odd}(n)$, let

$$\eta_{\alpha} = (-1)^{(n-\ell(\alpha))/2} \sum_{i_1 \le \dots \le i_p} 2^{|\{i_1, i_2, \dots, i_p\}|} x_{i_1}^{\alpha_1} x_{i_2}^{\alpha_2} \cdots x_{i_p}^{\alpha_p}.$$
(1.2)

An identity similar to Equation (1.1) relates peak and monomial peak functions:

$$K_{\alpha} = \sum_{\substack{\beta \in \text{Odd}(n);\\ \text{Peak}(\beta) \subseteq \text{Peak}(\alpha)}} \eta_{\beta}.$$
(1.3)

Hsiao shows that the monomial peak functions η_{α} form a basis of the algebra of peaks and gives closed-form formulas for their expression in terms of the classical bases of QSym, their antipode, product and coproduct. His proof relies on Equation (1.3) and uses the fact that the compositions are actually odd ones.

Nevertheless, one may extend Equation (1.2) to **any** integer composition (to the exception of the factor $(-1)^{(n-\ell(\alpha))/2}$ that is not well-defined if *n* and $\ell(\alpha)$ are not of the same parity). Whether this extension preserves the nice properties of the monomial peak functions appears as a natural question. We give it a **positive** answer by showing that the extended monomial peak functions form a basis of QSym and generalising the results of Hsiao. We call this new basis of QSym the *enriched monomial basis*. Our methods involve various algebraic and combinatorial arguments including the introduction of a new variant of posets and *P*-partitions whose generating functions generalise the monomial, fundamental, peak and enriched monomial functions as well as other classical variants of quasisymmetric functions. Before stating these results, we recall classical results for (enriched) *P*-partitions.

Part of this material will appear in [4] (work in progress).

We note that the K_{α} basis of the algebra of peaks can also be extended to a larger family in QSym although this extension is not a basis of QSym; this is done in a recent work of Khesin and Zhang [8] (which also extends QSym further by introducing two extra variables x_0 and x_{∞}).

1.4 Posets and *P***-partitions**

One of the main motivations for studying the power series L_{α} and K_{α} is their relation to descent and peak statistics on permutations. These relations are proved through the study of (enriched) *P*-partitions. In this section, we recall the definition and main results without proofs and refer the reader to [9, 2, 10] for further details.

Definition 1.3 (Labelled posets). *A* labelled poset $P = ([n], <_P)$ *is an arbitrary partial order* $<_P$ *on the set* [n].

Definition 1.4 (*P*-partition). Let $P = ([n], <_P)$ be a labelled poset. A *P*-partition is a map $f : [n] \longrightarrow \mathbb{P}$ that satisfies the two following conditions:

- (i) If $i <_P j$, then $f(i) \le f(j)$.
- (ii) If $i <_P j$ and i > j, then f(i) < f(j).

(The relations \langle and \rangle with no subscript stand for the classical total order on \mathbb{P} .)

Definition 1.5. We let \mathbb{P}^{\pm} be the set $\{-,+\} \times \mathbb{P}$ consisting of all pairs of a sign and a positive integer. The pair $(\pm, n) \in \mathbb{P}^{\pm}$ will be denoted by $\pm n$; its absolute value $|\pm n|$ is defined to be n. We equip the set \mathbb{P}^{\pm} with a total order given by $-1 < 1 < -2 < 2 < -3 < \ldots$. We embed \mathbb{P} into \mathbb{P}^{\pm} by identifying each n with +n; we also let $-\mathbb{P} \subseteq \mathbb{P}^{\pm}$ be the set of all -n for $n \in \mathbb{P}$.

Definition 1.6 (Enriched *P*-partition). Let $P = ([n], <_P)$ be a labelled poset. An enriched *P*-partition is a map $f : [n] \longrightarrow \mathbb{P}^{\pm}$ that satisfies the following two conditions:

(i) If
$$i <_P j$$
 and $i < j$, then $f(i) < f(j)$ or $f(i) = f(j) \in \mathbb{P}$.

(ii) If $i <_P j$ and i > j, then f(i) < f(j) or $f(i) = f(j) \in -\mathbb{P}$.

Note that *P*-partitions are the same as enriched *P*-partitions with no negative values (i.e., no values of the form -n). A more general concept was defined in [3]:

Definition 1.7 (\mathcal{Z} -enriched P-partition). Let \mathcal{Z} be a subset of the totally ordered set \mathbb{P}^{\pm} . Let $P = ([n], <_P)$ be a labelled poset. A \mathcal{Z} -enriched P-partition is an enriched P-partition $f : [n] \longrightarrow \mathbb{P}^{\pm}$ with $f([n]) \subseteq \mathcal{Z}$. Let $\mathcal{L}_{\mathcal{Z}}(P)$ denote the set of \mathcal{Z} -enriched P-partitions.

Consider the alphabet (i.e., set of indeterminates) $X = \{x_1, x_2, x_3, ...\}$, a labelled poset $P = ([n], <_P)$, and a subset \mathcal{Z} of \mathbb{P}^{\pm} . Define the \mathcal{Z} -generating function of P as the formal power series

$$\Gamma_{\mathcal{Z}}([n], <_P) = \sum_{f \in \mathcal{L}_{\mathcal{Z}}([n], <_P)} \prod_{1 \le i \le n} x_{|f(i)|}.$$
(1.4)

Given a permutation $\pi \in S_n$, let $P_{\pi} = ([n], <_{\pi})$ denote the labelled poset on the set [n], where the order relation $<_{\pi}$ is such that $\pi_i <_{\pi} \pi_j$ if and only if i < j (see Figure 1).

 $\pi_1 \longrightarrow \pi_2 \longrightarrow \dots \longrightarrow \pi_n$

Figure 1: The labelled poset associated to permutation. An arrow from π_i to π_{i+1} means that π_{i+1} covers π_i in the poset.

Proposition 1.8 ([2, 10]). Set $L_{\pi} = \Gamma_{\mathbb{P}}([n], <_{\pi})$ and $K_{\pi} = \Gamma_{\mathbb{P}^{\pm}}([n], <_{\pi})$. The function L_{π} is equal to the fundamental quasisymmetric function L_{α} indexed by the unique composition α such that $\text{Des}(\alpha) = \text{Des}(\pi)$. Similarly, K_{π} is equal to the peak function K_{α} indexed by the unique odd composition α such that $\text{Peak}(\alpha) = \text{Peak}(\pi)$.

This description leads to easy product formulas for both fundamental and peak quasisymmetric functions. Indeed, one has the following proposition.

Proposition 1.9 ([2, 10]). *Given two permutations* $\pi \in S_n$ *and* $\sigma \in S_m$ *, the product of the generating functions* $\Gamma_{\mathcal{Z}}([n], <_{\pi})$ *and* $\Gamma_{\mathcal{Z}}([m], <_{\sigma})$ *is given by*

$$\Gamma_{\mathcal{Z}}([n], <_{\pi})\Gamma_{\mathcal{Z}}([m], <_{\sigma}) = \sum_{\gamma \in \pi \sqcup \sigma} \Gamma_{\mathcal{Z}}([n+m], <_{\gamma}).$$
(1.5)

Using the notation of Proposition 1.8, specialisations of Equation (1.5) to $\mathcal{Z} \in \{\mathbb{P}, \mathbb{P}^{\pm}\}$ give the classical results

$$L_{\pi}L_{\sigma} = \sum_{\gamma \in \pi \sqcup \sigma} L_{\gamma}, \qquad K_{\pi}K_{\sigma} = \sum_{\gamma \in \pi \sqcup \sigma} K_{\gamma}.$$

2 The enriched monomial basis of QSym

2.1 The enriched monomial functions

We proceed with the definition of our extension of Hsiao's monomial peak functions η_{α} to arbitrary compositions α of n. When $\alpha \in \text{Odd}(n)$ our definition of η_{α} coincides with the one given in [1, (6.1)] and differs only in sign from the one given in [7] and Equation (1.2). Indeed, we remove the factor $(-1)^{(n-\ell(\alpha))/2}$ that is not well-defined if α is not odd.

Definition 2.1 (Enriched monomials). *For any* $n \in \mathbb{N}$ *and any composition* $\alpha \in \text{Comp}(n)$ *, we define a quasisymmetric function* $\eta_{\alpha} \in \text{QSym}$ *by*

$$\eta_{\alpha} = \sum_{\substack{\beta \in \operatorname{Comp}(n);\\\operatorname{Des}(\beta) \subseteq \operatorname{Des}(\alpha)}} 2^{\ell(\beta)} M_{\beta}.$$
(2.1)

Example 2.2. (a) Setting n = 5 and $\alpha = (1, 3, 1)$ in this definition, we obtain

$$\begin{split} \eta_{(1,3,1)} &= \sum_{\substack{\beta \in \text{Comp}(5);\\ \text{Des}(\beta) \subseteq \text{Des}(1,3,1)}} 2^{\ell(\beta)} M_{\beta} = \sum_{\substack{\beta \in \text{Comp}(5);\\ \text{Des}(\beta) \subseteq \{1,4\}}} 2^{\ell(\beta)} M_{\beta} \qquad (\text{since } \text{Des}(1,3,1) = \{1,4\}) \\ &= 2^{\ell(5)} M_{(5)} + 2^{\ell(1,4)} M_{(1,4)} + 2^{\ell(4,1)} M_{(4,1)} + 2^{\ell(1,3,1)} M_{(1,3,1)} \\ &= 2M_{(5)} + 4M_{(1,4)} + 4M_{(4,1)} + 8M_{(1,3,1)}. \end{split}$$

(b) For any positive integer n, we have $\eta_{(n)} = 2M_{(n)}$ (since the composition (n) satisfies $\text{Des }(n) = \emptyset$). Likewise, the empty composition $\emptyset = ()$ satisfies $\eta_{\emptyset} = M_{\emptyset}$.

The following are easy to see from our definition of η_{α} :

Proposition 2.3. *Let* $n \in \mathbb{N}$ *and* $\alpha \in \text{Comp}(n)$ *. Then,*

$$\eta_{\alpha} = \sum_{\substack{i_1 \leq i_2 \leq \cdots \leq i_n; \\ i_j = i_{j+1} \text{ for each } j \in [n-1] \setminus \text{Des}(\alpha)}} 2^{|\{i_1, i_2, \dots, i_n\}|} x_{i_1} x_{i_2} \cdots x_{i_n}$$

Proposition 2.4. Let $n \in \mathbb{N}$ and $\alpha = (\alpha_1, \alpha_2, \dots, \alpha_p) \in \text{Comp}(n)$. Then,

$$\eta_{\alpha} = \sum_{i_1 \leq i_2 \leq \cdots \leq i_p} 2^{|\{i_1, i_2, \dots, i_p\}|} x_{i_1}^{\alpha_1} x_{i_2}^{\alpha_2} \cdots x_{i_p}^{\alpha_p}.$$

We can also write the η_{α} in the fundamental basis (generalizing [7, Proposition 2.2]): **Proposition 2.5.** *Let n be a positive integer. Let* $\alpha \in \text{Comp}(n)$ *. Then,*

$$\eta_{\alpha} = 2 \sum_{\gamma \in \operatorname{Comp}(n)} (-1)^{|\operatorname{Des}(\gamma) \setminus \operatorname{Des}(\alpha)|} L_{\gamma}.$$

This proposition can be proved using the following simple identity:

Lemma 2.6. Let S and T be two finite sets. Then,

$$\sum_{I\subseteq S} (-1)^{|I\setminus T|} = \begin{cases} 2^{|S|}, & \text{if } S\subseteq T;\\ 0, & \text{otherwise.} \end{cases}$$

2.2 The η_{α} as a basis

Theorem 2.7. Assume that 2 is invertible in **k**. Then, the family $(\eta_{\alpha})_{n \in \mathbb{N}, \alpha \in \text{Comp}(n)}$ is a basis of the **k**-module QSym.

This follows easily from the definition of η_{α} by a triangularity argument. Using Möbius inversion, we can "turn (2.1) around", obtaining an explicit expansion of the monomial quasisymmetric functions M_{β} in the basis $(\eta_{\alpha})_{n \in \mathbb{N}, \alpha \in \text{Comp}(n)}$:

Proposition 2.8. Let $n \in \mathbb{N}$. Let $\beta \in \text{Comp}(n)$ be a composition. Then,

$$2^{\ell(\beta)}M_{\beta} = \sum_{\substack{\alpha \in \operatorname{Comp}(n);\\ \operatorname{Des}(\alpha) \subseteq \operatorname{Des}(\beta)}} (-1)^{\ell(\beta) - \ell(\alpha)} \eta_{\alpha}.$$

2.3 The antipode of η_{α}

The *antipode* of QSym is a certain **k**-linear map $S : QSym \rightarrow QSym$ that is part of the Hopf algebra structure of QSym (see [5, Chapter 5]), but can also be defined directly. Namely, $S : QSym \rightarrow QSym$ is the unique **k**-linear map that satisfies

$$S(M_{\alpha}) = (-1)^{\ell} \sum_{\substack{\gamma \in \operatorname{Comp}(n);\\ \operatorname{Des}(\gamma) \subseteq \operatorname{Des}(\alpha_{\ell}, \alpha_{\ell-1}, \dots, \alpha_{1})}} M_{\gamma}$$

for any $n \in \mathbb{N}$ and any $\alpha = (\alpha_1, \alpha_2, ..., \alpha_\ell) \in \text{Comp}(n)$. Also, for each composition α , we have $S(L_{\alpha}) = (-1)^{|\alpha|} L_{\omega(\alpha)}$, where $\omega(\alpha)$ is a certain composition known as the *complement* of α . See [5, Theorem 5.1.11 and Proposition 5.2.15] for details and proofs. Note that *S* is a **k**-algebra homomorphism and an involution (that is, $S^2 = \text{id}$).

Definition 2.9. If $\alpha = (\alpha_1, \alpha_2, ..., \alpha_\ell)$ is a composition, then the reversal of α is defined to be the composition $(\alpha_\ell, \alpha_{\ell-1}, ..., \alpha_1)$. It is denoted by rev α .

Proposition 2.10. *Let* $n \in \mathbb{N}$ *and* $\alpha \in \text{Comp}(n)$ *. Then, the antipode S of* QSym *satisfies*

$$S(\eta_{\alpha}) = (-1)^{\ell(\alpha)} \eta_{\operatorname{rev} \alpha}$$

Proposition 2.10 follows easily from Proposition 2.5. It generalizes [7, Proposition 2.9].

2.4 The coproduct of η_{α}

Next, consider the coproduct Δ : QSym \rightarrow QSym \otimes QSym of the Hopf algebra QSym (see [5, §5.1]). We claim the following formula for Δ (η_{α}) that generalizes [7, Cor. 2.7].

Theorem 2.11. Let $\alpha = (\alpha_1, \alpha_2, \dots, \alpha_p)$ be a composition. Then,

$$\Delta(\eta_{\alpha}) = \sum_{k=0}^{p} \eta_{(\alpha_{1},\alpha_{2},\ldots,\alpha_{k})} \otimes \eta_{(\alpha_{k+1},\alpha_{k+2},\ldots,\alpha_{p})}$$

3 The product rule for the enriched monomial basis

To get a closed form formula for the product of two enriched monomial functions, we introduce a variant of enriched *P*-partitions with additional weights on the posets.

3.1 Weighted posets

Definition 3.1. A labelled weighted poset is a triple $P = ([n], <_P, \epsilon)$ where $([n], <_P)$ is a labelled poset and $\epsilon : [n] \longrightarrow \mathbb{P}$ is a map (called the weight function).




Figure 2: A 5-vertex labelled weighted poset. Arrows show the covering relations.

In a labelled weighted poset each node is marked with two numbers: its label $i \in [n]$ and its weight $\epsilon(i)$ (see Figure 2 for an example). For any set $\mathcal{Z} \subseteq \mathbb{P}^{\pm}$, we define the

generating function $\Gamma_{\mathcal{Z}}([n], <_P, \epsilon)$ of the labelled weighted poset $([n], <_P, \epsilon)$ by

$$\Gamma_{\mathcal{Z}}([n], <_P, \epsilon) = \sum_{f \in \mathcal{L}_{\mathcal{Z}}([n], <_P)} \prod_{1 \le i \le n} x_{|f(i)|}^{\epsilon(i)}.$$
(3.1)

Remark 3.2. The difference between Equations (3.1) and (1.4) is the exponent $\epsilon(i)$ in $x_{|f(i)|}^{\epsilon(i)}$.

3.2 Universal quasisymmetric functions

Definition 3.3. Let $\alpha = (\alpha_1, \alpha_2, ..., \alpha_n)$ be a composition. Let $\pi = \pi_1 ... \pi_n$ be a permutation in S_n . Let $P_{\pi,\alpha} = ([n], <_{\pi}, \alpha)$ denote the labelled weighted poset composed of the labelled poset

 $([n], <_{\pi})$ and the weight function sending the vertex labelled π_i to α_i (see Figure 3). We define the universal quasisymmetric function $U_{\pi,\alpha}^{\mathcal{Z}}$ as the generating function

$$U_{\pi,\alpha}^{\mathcal{Z}} = \Gamma_{\mathcal{Z}}([n], <_{\pi}, \alpha).$$

$$(3.2)$$

Lemma 3.4. Let $n \in \mathbb{N}$. Let id_n and $\overline{id_n}$ denote the two permutations in S_n given by $id_n = 1 \ 2 \ 3 \dots n$ and $\overline{id_n} = n \ n - 1 \ n - 2 \dots 1$ (in one-line notation). Denote further (1^n) the composition of n with n entries equal to 1. Let $\pi \in S_n$. Then,

$$U_{\pi,(1^n)}^{\mathbb{P}} = L_{\pi}, \qquad U_{\pi,(1^n)}^{\mathbb{P}^{\pm}} = K_{\pi}, \qquad U_{\overline{id}_n,\alpha}^{\mathbb{P}} = M_{\alpha}, \qquad U_{\overline{id}_n,\alpha}^{\mathbb{P}^{\pm}} = \eta_{\alpha}.$$
(3.3)

As one might expect, the product of two universal quasisymmetric functions can be computed in a similar way as the product of two fundamental quasisymmetric functions. To state this result, we need to define the *coshuffle* of two pairs (π , α) and (σ , β).

Definition 3.5. Let $\pi \in S_n$ and $\sigma \in S_m$ be two permutations. Let α and β be two compositions with respectively n and m entries. The coshuffle of (π, α) and (σ, β) , denoted $(\pi, \alpha) \sqcup (\sigma, \beta)$, is the set of pairs (τ, γ) where

- $\tau \in S_{n+m}$ is a shuffle of π and $n + \sigma$ (that is, $\tau \in \pi \sqcup \sigma$), and
- γ is a composition with n + m entries, obtained by shuffling the entries of α and β using the same shuffle used to build τ from the letters of π and $n + \sigma$.

Example 3.6. (132, (2, 1, 2)) is a coshuffle of (12, (2, 2)) and (1, (1)).

Theorem 3.7. Let \mathcal{Z} be a subset of \mathbb{P}^{\pm} . Let π and σ be two permutations in S_n and S_m , and let $\alpha = (\alpha_1, \ldots, \alpha_n)$ and $\beta = (\beta_1, \ldots, \beta_m)$ be two compositions with n and m entries. The product of two universal quasisymmetric functions is given by

$$U_{\pi,\alpha}^{\mathcal{Z}} U_{\sigma,\beta}^{\mathcal{Z}} = \sum_{(\tau,\gamma)\in(\pi,\alpha)\sqcup(\sigma,\beta)} U_{\tau,\gamma}^{\mathcal{Z}}.$$
(3.4)




Figure 4: Decomposition of a double chain weighted poset into two posets with one incomparable pair less.

Proof (*sketch*). First notice that the product $U_{\pi,\alpha}^{\mathcal{Z}} U_{\sigma,\beta}^{\mathcal{Z}}$ is equal to the generating function of the labelled weighted poset $([n + m], <_{\pi,\sigma}, (\alpha, \beta))$ depicted on the left-handside of Figure 4 (do not pay attention to the blue arrows). Then the computation of $\Gamma_{\mathcal{Z}}([n + m], <_{\pi,\sigma}, (\alpha, \beta))$ is performed recursively by looking at the first incomparable pair $((\pi_1, \alpha_1), (n + \sigma_1, \beta_1))$ (blue arrows) and splitting the sum in the generating function across the following two mutually exclusive cases:

- (i) $f(\pi_1) < f(n + \sigma_1)$ or $f(\pi_1) = f(n + \sigma_1) \in \mathbb{P}$,
- (ii) $f(n + \sigma_1) < f(\pi_1)$ or $f(n + \sigma_1) = f(\pi_1) \in -\mathbb{P}$.

Thus, $\Gamma_{\mathcal{Z}}([n+m], <_{\pi,\sigma}, (\alpha, \beta))$ equals the sum of the generating functions of the two labelled weighted posets on the right-hand-side of Figure 4. Iterate the process until there are no more incomparable pairs to get (3.4).

As a final remark, we note that using sequences of 0's and 1's instead of (1^n) in Lemma 3.4, our work also covers the case of weak composition quasisymmetric functions (see [6]).

3.3 Product of enriched monomials

We compute the product of two enriched monomials. Let α and β be two compositions with *n* and *m* entries. We have from Equations (3.3) and (3.4):

$$\eta_{\alpha}\eta_{\beta} = U_{id_{n},\alpha}^{\mathbb{P}^{\pm}} U_{id_{m},\beta}^{\mathbb{P}^{\pm}} = \sum_{(\tau,\gamma)\in(id_{n},\alpha)\sqcup(id_{m},\beta)} U_{\tau,\gamma}^{\mathbb{P}^{\pm}}.$$
(3.5)

We need the following definitions.

Definition 3.8. Let $\alpha = (\alpha_1, ..., \alpha_n)$ be a composition with *n* entries. For any integer $2 \le i \le n-1$, we let $\alpha^{\downarrow\downarrow i}$ denote the following composition with n-2 entries:

$$\alpha^{\downarrow\downarrow i} = (\alpha_1, \ldots, \alpha_{i-2}, \alpha_{i-1} + \alpha_i + \alpha_{i+1}, \alpha_{i+2}, \ldots, \alpha_n)$$

Furthermore, for any peak-lacunar subset $I \subseteq [n-1]$ *, we set* $\alpha^{\downarrow\downarrow I} = \alpha$ *if* $I = \emptyset$ *and*

$$\alpha^{\downarrow\downarrow I} = \left(\left(\cdots \left(\alpha^{\downarrow i_k} \right) \cdots \right)^{\downarrow i_2} \right)^{\downarrow i_1}$$

where i_1, i_2, \ldots, i_k are the elements of $I \neq \emptyset$ in increasing order.

The enriched monomial basis of QSym

Example 3.9. Let $\alpha = (2, 1, 4, 3, 2)$. We have $\alpha^{\downarrow\downarrow3} = (2, 8, 2)$ and $\alpha^{\downarrow\downarrow\{2,4\}} = (12)$.

We expand any $U_{\pi,\alpha}^{\mathbb{P}^{\pm}}$ in terms of enriched monomials.

Theorem 3.10. Let α be a composition with *n* entries and π a permutation in S_n . We have

$$U_{\pi,\alpha}^{\mathbb{P}^{\pm}} = \sum_{I \subseteq \operatorname{Peak}(\pi)} (-1)^{|I|} \eta_{\alpha \sqcup I}.$$
(3.6)

Proof (sketch). From the definition of $U_{\pi,\alpha}^{\mathbb{P}^{\pm}}$ one can obtain without too much trouble that

$$U_{\pi,\alpha}^{\mathbb{P}^{\pm}} = \sum_{\substack{i_1 \le i_2 \le \dots \le i_n; \\ j \in \text{Peak}(\pi) \Rightarrow \neg (i_{j-1} = i_j = i_{j+1})}} 2^{|\{i_1, i_2, \dots, i_n\}|} x_{i_1}^{\alpha_1} x_{i_2}^{\alpha_2} \dots x_{i_n}^{\alpha_n}.$$

By the inclusion-exclusion principle, this can be rewritten as

$$U_{\pi,\alpha}^{\mathbb{P}^{\pm}} = \sum_{I \subseteq \operatorname{Peak}(\pi)} (-1)^{|I|} \underbrace{\sum_{\substack{i_1 \leq i_2 \leq \dots \leq i_n; \\ j \in I \Rightarrow i_{j-1} = i_j = i_{j+1} \\ (by \operatorname{Proposition 2.4)}}}_{=\eta_{\alpha} \downarrow \downarrow I} 2^{|\{i_1, i_2, \dots, i_n\}|} x_{i_1}^{\alpha_1} x_{i_2}^{\alpha_2} \dots x_{i_n}^{\alpha_n}.$$

We may now state our final theorem: a product rule for the enriched monomial basis.

Theorem 3.11. Let $\alpha = (\alpha_1, ..., \alpha_n)$ and $\beta = (\beta_1, ..., \beta_m)$ be two compositions. Given a composition γ obtained by shuffling α and β (we shall denote this by $\gamma \in \alpha \sqcup \beta$), let $S_{\beta}(\gamma)$ be the set of the positions of the entries of β in γ . Denote further $S_{\beta}(\gamma) - 1 = \{i - 1 | i \in S_{\beta}(\gamma)\}$. Then,

$$\eta_{\alpha}\eta_{\beta} = \sum_{\substack{\gamma \in \alpha \sqcup \beta;\\ I \subseteq \left(S_{\beta}(\gamma) \setminus (S_{\beta}(\gamma) - 1)\right) \setminus \{1\}}} (-1)^{|I|} \eta_{\gamma \downarrow \downarrow I}.$$
(3.7)

The sum ranges not over compositions γ but over ways to shuffle α with β . Thus, the same γ can appear in several addends of the sum.

Proof (*sketched*). Recall (3.5), and rewrite the right-hand side using (3.6). Let (τ, γ) be a coshuffle in $(id_n, \alpha) \sqcup (id_m, \beta)$. The index *i* belongs to $\text{Peak}(\tau)$ if and only if τ_i is a letter of $n + id_m$ and τ_{i+1} is a letter of id_n and we have i > 1. That is, if and only if *i* is the index of an entry of β in γ and i + 1 is the index of an entry of α . Thus, $\text{Peak}(\tau) = (S_{\beta}(\gamma) \setminus (S_{\beta}(\gamma) - 1)) \setminus \{1\}$. Therefore, we obtain (3.7).

Remark 3.12. According to the proof of Theorem 3.11, the j^{th} entry of $\gamma^{\downarrow\downarrow I}$ in (3.7) is a sum of u_j parts of α and v_j parts of β for some integers u_j , v_j with $|u_j - v_j| = 1$. Indeed, as τ in Equation (3.5) is a shuffle of id_n and $n + id_m$, "successive" peaks (i.e. at a distance of only two positions) in τ occur whenever γ contains a sequence of successive parts of β and α preceded by either an entry of α or β . As an example, if n = 3 and m = 2, $\alpha = (2, 1, 2)$ and $\beta = (1, 1)$, then $\tau = 14253$ is a shuffle of id_3 and $3 + id_2$ whose coshuffle is $\gamma = (2, 1, 1, 1, 2)$. In this case $\gamma^{\downarrow\downarrow\{2,4\}} = (7)$, $\gamma^{\downarrow\downarrow2} = (4, 1, 2)$ and $\gamma^{\downarrow\downarrow4} = (2, 1, 4)$.

Example 3.13. *As an example, one has*

$$\begin{split} \eta_{(1,1)}\eta_{(2,3)} &= \eta_{(1,1,2,3)} + \eta_{(1,2,1,3)} - \eta_{(4,3)} + \eta_{(2,1,1,3)} + \eta_{(1,2,3,1)} \\ &\quad - \eta_{(1,6)} + \eta_{(2,1,3,1)} - \eta_{(2,5)} + \eta_{(2,3,1,1)} - \eta_{(6,1)}, \\ \eta_{(1,2)}\eta_{(2)} &= \eta_{(2,1,2)} + 2\eta_{(1,2,2)} - \eta_{(5)}. \end{split}$$
