# <u>Trace metal elements vaporization and phosphorus recovery during sewage</u> sludge thermochemical treatment, a review

#### Abstract

Phosphorus (P) plays essential roles in crops growth. Natural mineral sources of phosphate are non-renewable, overexploited and unevenly distributed worldwide, making P a strategic resource for agricultural systems. The search for sustainable ways to secure P supply for fertilizer production has therefore become a critical issue worldwide. Sewage sludge (SS) is an organic waste material considered as a key alternative source of P. Switzerland and the European Union are is about to make it mandatory to recover P from SS or its treatment residues. Among the many technical options to achieve this objective, SS thermochemical treatments spiked with Cl-donors appear as a promising approach to recover P from SS and separate it from mineral pollutants such as trace metal elements (TME). The purpose of Cl-donor additives is to fix P within the mineral residues, possibly in bioavailable P species forms, while promoting TME vaporization by chlorination mechanisms. This review paper compares the various thermochemical treatments investigated worldwide over the past two decades. The influence of process conditions and Cl-donor nature is discussed. The presented results show that, except for nickel and chromium, most TME can be significantly vaporized during a high temperature treatment (over 900 °C) with Cl addition. In addition, the fixation rate and solubility of P is increased when a Cl-donor such as MgCl<sub>2</sub> is added.

#### 1. Introduction

Phosphorus (P) is a vital element for all life forms that cannot be substituted [1]. It is a component of key biomolecules such as deoxyribonucleic acid (DNA), ribonucleic acid (RNA), adenosine triphosphate (ATP), etc. At the cellular level, phosphate bounds biosynthesis and hydrolysis are universal mechanisms for energy exchanges in all living beings' metabolism [2]. At a more macroscopic level, P availability is often a limiting factor for plants growth in natural ecosystems [3]. Agriculture therefore uses P as a key fertilizing element to stimulate crops development and increase production yields. In natural ecosystems, P fluxes occur in a quasi-closed loop, with negligible runoffs [4]. Anthropic pressures however induce dramatic alterations of P biogeochemical cycles through unbalanced inflows and outflows massive intensification. In agriculture for example, crops are exported from the agricultural sites to distant food processing units, which then further distribute food products to consumption places all over the world. Herbicides, fungicides and insecticides massive use also strongly affects phosphorus dynamics in agricultural soils [4–6]. Consequently, Prich fertilizer continual application has become necessary, to compensate for its exportation in crops and food production [1–3,5–11]. P has therefore become a strategic resource that needs to be available in high amounts for industrial-scale fertilizer production [1,2,7,9,12–14].

P is the 11th most abundant element in the earth crust [9]. It is distributed around the world mostly under mineral forms (aluminum/iron and calcium phosphate) contained in sedimentary rocks [15]. Phosphate rocks (PR) deposits containing enough P to be economically exploitable (13-14wt%) are however scarce and non-renewable resources [1]. Few prospects exist for new discoveries [15]. Even if the scientific community is split about whether or not the reserve depletion will occur within 50 or 300 years, there is a general consensus on (i) the uneven distribution of PR deposits around the world (around 70% of the world total reserves are in Morocco and Western Sahara only), (ii) the decreasing quality of remaining PR resources and (iii) the increasing extraction processing and shipping costs [1,2,9,16]. Finding alternatives to secure P for fertilizer production has therefore become one of the objectives for sustainable development in the next decades [2,7,10,17–20].

The major option to slowdown PR deposits depletion is to reduce P wastage [2,14,17,21]. According to Daneshgar et al. [2], only about 16% of the mined P is actually consumed by humans in the current anthropogenic P cycle. Most of it is lost by leaching from cropland, improper animal waste disposal and food waste production [2]. Several studies proposed solutions to limit P leaking from the anthropogenic cycle [6,7,14,17,18,21–24], with highly positive environmental impacts by limiting eutrophication phenomenon [2,25,26].

The second option is to increase P recycling from human and animal waste materials [27–32]. Among the waste materials of concern, sewage sludge (SS) contains the second strongest amount of P, after bone meal [27,33,34]. It is a complex heterogeneous mixture of microorganisms, undigested organics such as paper, plant residues, oils, fecal materials, inorganic materials and moisture [35,36]. It has been estimated that the sludge produced by developed countries in the world exceeds 30 million tons per year (dry sludge), and this amount is still rising [36]. SS is a potential resource for nutrients and energy [35]. The most common treatments currently applied are (i) direct land spreading applications, (ii) production by composting of an organic soil conditioner, and (iii) production of heat or other energy vectors by thermochemical or anaerobic biological processes [37–39].

SS direct (or after composting) land spreading allows to recycle P and other nutrients [33]. However, due to the presence of potentially toxic trace metal elements (TME), organic pollutants and possibly microbial pathogens this practice is strongly regulated [27,29,34]. Thermochemical

processes such as incineration, gasification and pyrolysis allow to recover energy from SS while neutralizing microbiologic and organic pollutants through high temperature treatment [37–40]. However, poorly volatile TME such as chromium (Cr), copper (Cu), nickel (Ni), zinc (Zn), etc. concentrate in the solid residues, which may induce environmental limits or constraints to their use or disposal [33]. In addition, high temperature thermochemical treatments can induce small amounts of P and other nutrients vaporization, which are then lost from the solid residues [41,42]. Finding a way to recover both nutrients and energy from SS is therefore a scientific and technical challenge [8,29].

One of the solutions under investigation is to operate thermochemical treatments with controlled additions of various additives [37,39,40], in the purpose of producing energy and bioavailable P-rich solid residues that may be used in the formulation of fertilizers or soil conditioners. Cl-based compounds such as MgCl<sub>2</sub>, CaCl<sub>2</sub>, polyvinyl chloride (PVC), NaCl and KCl are the most frequently used additives [43–78]. Their role is to help fix and form bioavailable P species in the solid residues (interaction with Mg, Ca, Na, K, etc.) while promoting TME vaporization through the gas phase (chlorination mechanisms). The thermochemical treatments with Cl-donor can be performed either in one [62,63,65] or two steps [45–47]. In the two-step processes, SS is first thermochemically treated without additives for energy production and waste volume reduction (classic incineration, pyrolysis or gasification processes), and the resulting ashes are further thermochemically post-treated at high temperature with Cl-based additives [38].

In 2026 in Switzerland, it will be mandatory to recover 50 to 80% of the P contained in SS before final disposal. Germany, France and the EU may follow before 2030. Along with other P recovery or removal technologies, SS thermochemical treatments with Cl-donor may therefore develop strongly in the coming years. In general, these processes allow almost all P to remain within the solid residues. The primary scientific/industrial issue is therefore to enhance TME removal through the gas phase. The impact of SS thermochemical treatments on TME vaporization properties with Cl-donors [43–78] and without additives [79–94] have been extensively studied these past decades. However, only small paragraphs in review papers have a special focus on both TME vaporization and P recovery [8,34,94,95].

The objective of this synthesis article is therefore to provide an in-depth critical review aggregating reported findings about TME vaporization rates improvement and bioavailable P fixation in solid residues during SS or SS ashes thermochemical treatments. A focus is first made on the TME removal efficiency during classic SS thermochemical treatment without additives. Then, thermochemical processes with Cl-donors are extensively explored with a focus on the effects of the additive's nature, processes and operating conditions on TME vaporization. It is important to note that, in this review paper, only three thermochemical treatments are considered: incineration, pyrolysis and gasification. The Cl-donors influence on the bioavailability of P species is finally discussed.

#### 2. Sewage sludge and trace metal elements

# 133 2.1. <u>Sewage sludge use and disposal</u>

SS is a waste material produced in high amount all over the world [36]. It is generated all along the wastewater treatment process, with various composition depending on the water origin and the treatment steps [33]. According to Rulkens et al. [36], SS is a complex heterogeneous mixture characterized by six groups of components:

- Water (content varying from 1-2 to more than 95%),

- Nontoxic organic carbon compounds (≈60% on a dry basis), mostly from biological origin,
- Nitrogen (N) and phosphorus containing components,
- Toxic inorganic and organic pollutants:

- TME such as Zn, lead (Pb), Cu, Cr, Ni, cadmium (Cd), mercury (Hg), and arsenic (As) (contents from < 1 to > 1000 mg/kg),
- o Polychlorinated biphenyls (PCBs), polycyclic aromatic hydrocarbons (PAHs), dioxins, pesticides, linear-alkyl-sulfonates, nonyl-phenols, polybrominated fire retardants, etc.
- Pathogens and other microbiological pollutants,
- Inorganic compounds, such as silicates, aluminates, calcium and magnesium containing compounds.

Although SS is considered as a waste material, two components can technically and economically be recycled from SS: nutrients (primarily N and P) and energy (directly linked to carbon content) [35]. Depending on their origin and composition different recovery processes are therefore possible: agricultural spreading or composting (nutrients recovery) or thermochemical treatment (energy recovery). In 2019 in France, 30% of the SS were co-composted with green/organic waste, 40% directly spread on fields, 28% incinerated and 2% buried. The disposal pathways differ strongly from country to country in the EU [78]. For example, in Germany, more than 55% of the produced sludge are incinerated, while for the Netherlands and in Switzerland 100% are thermochemically treated (incineration mostly) [38].

SS direct use as fertilizers or soil conditioners is highly regulated and therefore limited in EU due to TME, pathogens, microbiological and organic pollutants presence in the raw material [38]. **Table 1** presents the European, French, German and Swiss regulations concerning the maximal TME contents in recycled fertilizer products. Arsenic, cadmium, chromium, copper, lead, mercury, nickel and zinc are the 8 TME concerned by these regulations. Furthermore, SS is produced all year long while fertilizers are applied to fields only once or twice a year. Storage is therefore necessary and can be complicated due to fermentation processes [33]. To limit this issue, SS can be composted or cocomposted with other organic waste materials, for further use in agricultural spreading and by nurserymen and municipalities. However, neither the TME nor all the pathogens, microbiological and organic pollutants are eliminated by composting. Only a dilution effect can occur so that cocomposting processes comply with the regulations.

As explained previously, an important part of SS is energetically recovered (55% of the produced SS in Germany) [40]. Three thermochemical processes are suitable: incineration, gasification and

pyrolysis [39]. In addition to energy recovery, they allow to neutralize microbiologic and organic pollutants through high temperature treatment. The most used is by far SS incineration [37]. Its goal is to burn the organic part of SS to produce energy and significantly reduce the waste volume [38]. In 2020 in Germany, about half of the thermally treated sludge was mono-incinerated and the other half co-incinerated with coal, in cement kilns or waste incineration plants. Pyrolysis and gasification treatments are for now limited and mostly tested at the bench or pilot scale [38].

Ashes produced after classic thermochemical processing are difficult to further reuse. Indeed, most TME are concentrated along with P and other nutrients in the solid residues [33]. To recover P, thermochemical post-treatments at high temperature (800 to 1200 °C) gathered scientists' interest during the last two decades [43–55,57,59,64,66,67,71–76]. They are based on various Cl-donors use such as MgCl<sub>2</sub>, CaCl<sub>2</sub>, PVC, NaCl and KCl. Indeed, their addition help fix and form bioavailable P species in the solid residues thanks to interaction with Mg, Ca, Na and K, while promoting TME vaporization through the gas phase via chlorination mechanisms [45–47]. The main limitation of such thermochemical post-treatments, is that the overall SS recovery process is carried out in two steps, limiting the energy efficiency (energy input is required for the thermochemical post-treatment step). To limit this issue, the thermochemical ash treatment step can be integrated into a waste incinerator, as in the CT-Fluapur®-process [52]. The hot gases produced during incineration step can thus be mixed with HCl from the incinerator's acid scrubber and used as both a heat and Cl sources for the ashes post-treatment. However, according to Nowak et al. [52], the system complexity and the costly equipment required currently limit the process development.

Single step (or direct) SS thermochemical treatments are also suitable, with the same additives than for two-step processes [42,56,58,60–63,65,68–70,77,78]. In such processes, SS is directly treated with MgCl<sub>2</sub>, CaCl<sub>2</sub>, PVC, NaCl and/or KCl, either by incineration, pyrolysis or gasification, with the combined aim to recover energy and P. Despite advantages of single industrial installation, fewer studies focus on the single step SS thermochemical treatments in comparison with two-step processes.

**Fig. 1** was built thanks to literature data [43–78]. It allows to have a broad view of the works investigating the impact of SS or SS ashes thermochemical treatment with Cl-donors on the TME vaporization properties and/or P bioavailability. The figure (alluvial diagram) shows the number of publications (for a total of 37) dealing with the following parameters: (i) the initial materiel form (SS, SS ashes or synthetic SS), (ii) the Cl-donor used (MgCl<sub>2</sub>, CaCl<sub>2</sub>, (...) and/or FeCl<sub>3</sub>), (iii) the thermochemical treatment performed (incineration, pyrolysis or gasification), (iv) the TME vaporization properties reported (As, Cu, (...) and/or Hg) and (v) whether or not the P bioavailability is studied. It is important to note that multiple parameters can be studied in only one work.

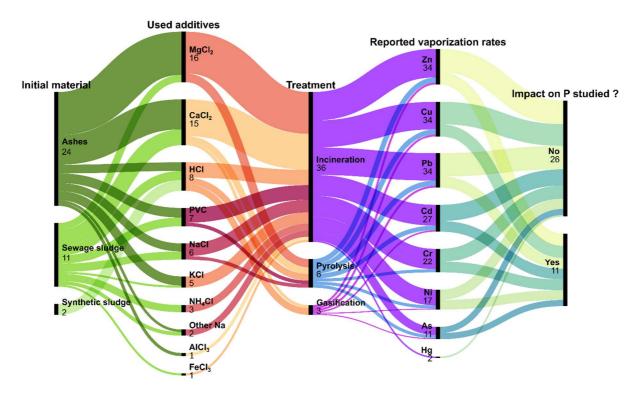


Figure 1 – Alluvial diagram built thanks to literature data [43–78] and showing the number of publications (for a total of 37) dealing with the following parameters: (i) the initial material form, (ii) the Cl-donor used, (iii) the thermochemical treatment performed, (iv) the TME vaporization properties reported and (v) whether or not the P bioavailability is studied

**Fig. 1** shows that, in 24 of the 37 publications selected, SS ashes are used, almost always incinerated and preferentially with MgCl<sub>2</sub> or CaCl<sub>2</sub> as Cl-donor (in 16 and 15 works respectively). Direct SS treatment with other Cl compounds by pyrolysis or gasification is only little studied. Regarding the TME, Zn, Cu and Pb are the most often studied (34 publications) while only 2 and 11 works investigate Hg and As behavior respectively. Finally, only 11 of the 37 publications deal with the question of P bioavailability in the solid residues obtained after treatment. In addition to the works compiled in **Fig. 1** dealing with thermochemical treatment with Cl-donors [43–78], the TME vaporization properties also have been extensively studied during SS or SS ashes thermochemical treatment without Cl-donor [79–94] and thanks to thermodynamic simulations tools [43–45,66,68,69,74–77,96–99]. The results from these works are further discussed.

Either during one or two-steps SS thermochemical treatments, TME removal rates and P species formed are highly dependent on the following operating conditions that are extensively studied in the next parts of this paper:

- Initial material nature (raw SS or SS ashes) and composition (major elements contents),
- Additives nature: MgCl<sub>2</sub>, CaCl<sub>2</sub>, PVC, NaCl, KCl, etc. and amount added (Cl concentration),
- Type of reactor used: fixed-bed, rotary kiln, fluidized bed and material residence time,
- Treatment temperature,

- Treatment gas composition (depends on the chosen thermochemical processes, i.e. incineration, pyrolysis or gasification): oxidative or reductive atmosphere, H₂O presence, etc.

# 2.2. <u>Trace metal elements speciation in sewage</u> sludge

During SS or SS ashes thermochemical treatment and depending on the operating conditions, the TME can be vaporized though the gas phase. In this part, a special focus on the vaporization

properties of the 8 TME whose contents are regulated for recycled fertilizers (**Table 1**) is therefore made.

As detailed previously, SS is a complex heterogeneous mixture [36]. Indeed, its composition depends on various parameters such as the sludge origin (industrial and/or municipal wastewater) and pretreatments performed (biological treatment, Al or Fe based coagulants use, etc.). In addition, SS can be mixed with municipal solid waste before thermochemical treatment. It results in high variation in elemental composition and speciation for the treated materials [78]. In SS, the TME are generally not under elemental state but under various forms (oxides, chlorides, sulphates, sulphides, carbonates, organic, combined with major elements, etc.). **Table 2** thus presents the most common forms in SS for the 8 TME of interest according to Udayanga et al. [94], and their physical properties (melting and boiling points) [88,89,94].

In elemental form, Hg has the lowest vaporization temperature under normal pressure (357 °C) followed by As and Cd (615 and 767 °C respectively). Zn vaporizes at 907 °C and Pb at 1749 °C. Cu, Cr and Ni have higher vaporization temperatures of 2562, 2671 and 2913 °C respectively (**Table 2**). The TME vaporization properties in SS can however be divided into three categories, as reported by Fraissler et al. [43]:

- Cd, Hg and Pb are "easily volatile TME". The low Cd boiling point of 767 °C and the Pb fusion temperature of 327 °C allow removal to the gas phase at low temperature (in droplet form for Pb). Hg can also be classified as an easily volatile TME due to its low vaporization temperature of 357 °C.
- Zn, Cu and As are "semi-volatile TME". Zn vaporizes at 907 °C and, for Cu, even if the element has a high boiling point (2562 °C), its high mobility allows the formation of more easily volatile species during thermochemical treatment (chloride, sulfide, etc.). For As, although it should vaporize "easily" at 615 °C, its strong interactions with SS major elements [77] lead to variable vaporization properties [62,77,90].
- Cr and Ni are "low-volatile TME". Their vaporization temperatures are high (2671 and 2913 °C respectively), and the two species present a low mobility.

Regarding the normal boiling point changes between different TME forms presented in **Table 2**, it is clear that the TME volatilities are highly impacted by their speciation. For example, Cu in elemental form vaporizes at 2562 °C while CuCl<sub>2</sub> normal boiling point is at 993 °C. It is interesting to note that, except for Cd, the chlorides species most of the time have the lowest vaporization temperature. It explains why the addition of Cl-compounds combined with a high temperature treatment is particularly interesting to promote TME vaporization. It is further extensively discussed.

# 3. Sewage sludge thermochemical treatment without additives

**Table S1** gathers results from [52,62,65,69,77,81,85,90–92] and presents the TME removal rates during classic SS thermochemical treatment without additives under various operating conditions. The TME removal rates were replicated from the various works explored (values extracted from graphs most of the time). The variations of the following parameters are reported:

- Feed material nature and composition (dried SS or ashes and CaO or SiO<sub>2</sub>-rich),
- Residence time (1.5 to 1440 min) and reactor type (fixed-bed, fluidized bed and rotary kiln),
- Treatment gas nature (air, H<sub>2</sub>O and N<sub>2</sub> i.e. oxidative or reductive treatment conditions),
- Process temperature (300 to 1200 °C).

Because of its high volatility (vaporization temperature of 357 °C, **Table 2**), Hg behavior during SS thermochemical treatment is most of the time not explored. It is always considered to be vaporized significantly irrespective of treatment conditions [99]. Temperature seems to be the most important parameter for Hg removal in the gas phase [99].

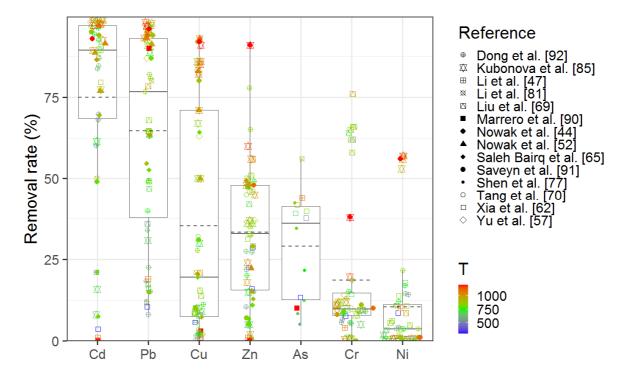


Figure 2 – Boxplots compiling data from Table S1 and representing the reported Cd, Pb, Cu, Zn, As, Cr and Ni removal rates as a function of the treatment temperature (color scale) and the reference studied (shape scale). The mean (dotted horizontal line) and median (horizontal line) removal rates for each TME are also shown, along with the first and third quartiles (black rectangles) and the 95% confidence interval (black vertical line).

To ease the reading and subsequent discussions, the principal results from literature concerning TME removal rates during classic SS thermochemical treatment without additives are also presented in **Fig. 2**. The figure is a box plot and was built with the results compiled in **Table S1**. It represents the removal rates for each TME. The different references studied are visible via the points shape while the treatment temperature is represented by the color scale (blue at 300, green at 750 and red at 1200 °C). The mean (dotted horizontal line) and median (horizontal line) removal rates for each TME

are also shown, along with the first and third quartiles (black rectangles) and the 95% confidence interval (black vertical line). **Fig. 2** is widely discussed afterwards.

As visible in **Fig. 2**, reported TME removal rates confirm the classification as high-volatile for Cd and Pb, semi-volatile for As, Cu and Zn, and low-volatile for Cr and Ni [43].

The TME removal rates compiled in **Table S1** and **Fig. 2** allow to investigate the impact of the operating conditions on their vaporization properties during SS classic thermochemical treatment without additives. The general trends and the most relevant parameters influencing TME removal are summarized in **Table 3** and are further discussed for each TME. **Table 3** was also built thanks to results from various thermodynamic simulations experiments [43–45,66,68,69,74–77,96–99]. In these works, SS thermochemical treatments under various operating conditions (temperature, atmosphere, initial composition) were explored via simulation tools such as FactSage, ChemSheet or HSC Chemistry.

# 300 3.1. <u>High-volatile TME – Cd and Pb</u>

Reported Cd removal rates during SS thermochemical treatment without additives varied from 0 to 99%, depending on operating conditions, with a 75% mean vaporization rate (**Fig. 2**) [52,62,85,92]. According to Fraissler et al. [43], during thermochemical treatment, Cd vaporizes under Cd(OH)<sub>2</sub>, CdO and Cd gas forms. The authors also reported that to increase removal rate, temperature is the most important parameter followed by SiO<sub>2</sub> absence (Si-rich sludge leads to CdSiO<sub>3</sub> formation which is a stable compound), H<sub>2</sub>O presence (to promote Cd(OH)<sub>2</sub> production) and a long treatment residence time. It is confirmed in **Fig. 2** showing that the highest Cd removal rates are mostly observed for treatment temperatures above 800 °C (orange and red points).

Lead vaporization varies from 10 to 99% depending on operating conditions, with a 65% mean vaporization rate (**Fig. 2**). It is temperature dependent and promoted under oxidative conditions (**Tables 3 and S1**) [92]. Indeed, Pb removal rates higher than 80% were most of the time reported when the treatment temperature was above 800 °C (orange and red points, **Fig. 2**) [52,81,85,90,92]. The residence time also seems to be an important parameter for Pb removal with rates ranging from 53 to 97% when it increases from 60 to 120 min, as reported by Saleh Bairq et al. [65] (**Table S1**). On the contrary, pyrolysis and  $H_2O$  gasification treatments have a strong negative impact on Pb vaporization, with removal rates below 20%, as reported by Xia et al. [62] and Saveyn et al. [91] and visible in **Table S1**. Indeed, in reductive conditions, lead vaporization is limited as no  $O_2$  is available to interact with Pb and form volatile oxides [43].

# 3.2. Semi-volatile TME – As, Cu and Zn

Reported As removal rates are most of the time below 50% (29% mean vaporization rate, **Fig. 2**) [62,77]. According to the simulations performed by Shen et al. [77] and Liu et al. [98], it is due to As interaction with the major inorganic elements initially present in SS. Indeed, stable As-based compounds such as Ca<sub>3</sub>(AsO<sub>4</sub>)<sub>2</sub>, KAsO<sub>2</sub> and AlAsO<sub>4</sub> can be formed, with decomposition temperatures above 1000 °C [77]. It means that As vaporization properties are mostly controlled by the major elements initial contents in treated SS. According to Liu et al. [98], SiO<sub>2</sub> rich SS may thus significantly help for As removal. Expect for temperature, the other operating parameters seem to have low impact on As vaporization properties (**Table 3**).

In several works, Cu vaporization properties are below 20% (median removal rate of 20%, **Fig. 2**) [62,69,92]. However, Kuboňová et al. [85] and Nowak et al. [52] reported Cu removal rates above 80% for treatment temperatures higher than 900 °C (orange and red points in **Fig. 2**). Interestingly, the same raw material was used in the two works, i.e. municipal solid waste fly ash with a high Cl content as alkali (sodium and potassium) chlorides [52,85]. Furthermore, according to the thermodynamic simulations performed by Fraissler et al. [43], regardless of SS initial composition, Cu removal at temperatures below 1000 °C without chlorine addition is nearly impossible. Cl presence may therefore explain the high Cu removal rates observed in [52,85], as well as the long residence time used [65], the high treatment temperature, CaO predominance in sludge and the oxidative conditions used [52,85,92]. These parameters seem therefore to have a positive impact on Cu vaporization properties during classic SS thermochemical treatment (**Table 3**).

Zinc seems to be slightly more volatile than Cu, with equal mean and median vaporization rates of 33% (Fig. 2). The treatment temperature seems to be the most relevant parameter influencing Zn vaporization properties (Fig. 2 and Table 3). Removal rates above 50% are thus reported for treatment temperatures higher than 1000 °C (orange and red points, Fig. 2) [69,85]. Below 1000 °C, Zn is however hard to volatilize. Indeed, according to Fraissler et al. [43], Zn behaves similarly to Cu. Its vaporization is therefore highly dependent on chlorine addition and availability. It may explain the high removal rates observed by Liu et al. and Kuboňová et al. [69,85]. Two parameters seem to have a negative influence on Zn vaporization properties: the use of a rotary kiln (compared to fixed-bed reactors) [52,85] and oxidative combustion conditions [92] (**Table 3**).

#### 3.3. Low-volatile TME – Cr and Ni

Except in the work of Liu et al. [69], reported Cr removal rates are below 20% (**Fig. 2**) [62,85,92]. High treatment temperatures seem to enhance Cr volatility (see red points in **Fig. 2**), but even with a treatment at 1200 °C, obtained removal rates are below 40% [85]. The highest vaporization rates (62% at 550 °C) observed by Liu et al. [69] are difficult to explain and not commented by the authors. It may be due to a high SiO<sub>2</sub> content (28wt%), Cl presence and the fact that the treated SS was dehydrated prior to thermochemical treatment (**Table S1**). Indeed, according to Fraissler and al. [43], SiO<sub>2</sub>-rich sludge can promote Cr vaporization during thermochemical treatment as well as Cl presence when no H<sub>2</sub>O is involved during treatment (to promote volatile CrO<sub>2</sub>Cl<sub>2</sub> production) (**Table 3**). Such high Cr removal rates, however, have only been reported in this study to our knowledge.

Reported Ni removal rates are most of the time below 10% (**Fig. 2**), except in Kuboňová et al. work, where the authors reported removal rates around 50% for experiments in a rotary kiln (**Table S1**) [85]. They explained the observed results by enhanced mass transfers between solid and gas phase due to rotary kiln use [85]. These results are however questionable as such high removal rates were not further observed, to our knowledge. The other parameters that seem to slightly positively impact Ni vaporization are the treatment temperature, residence time and oxidative conditions (combustion) (**Table 3**) [69,92]. Finally, according to Fraissler et al. [43], H<sub>2</sub>O presence in the flue gas may negatively impact Ni removal.

Regarding the results reported in **Table 3**, **S1** and **Fig. 2**, it seems that classic SS thermochemical treatment without additives is not efficient to vaporize all TME for direct use of the ashes as recycled fertilizers [38]. It is particularly the case for elements like Cu, Zn, As, Ni and Cr whose removal rates remain most of the time below 50% during classic SS thermochemical treatment.

# 4. Sewage sludge thermochemical treatment with various Cl-donors

# 4.1. <u>Chlorination mechanisms with various Cl-donors</u>

To go further and enhance stable TME (Cu, Zn, As, Ni and Cr) vaporization properties, SS or SS ashes thermochemical treatments with Cl-based compounds developed in the past two decades [43–78]. The Cl-donors lead to chlorination mechanisms. The general principle is to convert the TME initially present in various forms (metallic, oxide, alloys, associated with Si, Fe, Al, S, CO<sub>3</sub><sup>2-</sup>, etc.) in raw SS or SS ashes into chlorides, in order to form species with lower boiling points and higher vapor pressures (Table 2).

Several reaction pathways are possible to vaporize TME by chlorination [53]. Indeed, CI can be applied during thermochemical treatment either as gaseous CI<sub>2</sub> and HCI [48], or as solid chlorine-donor (MgCl<sub>2</sub>, CaCl<sub>2</sub>, KCl, NaCl, PVC, etc.) [44,45,63]. Furthermore, each CI-donor can react differently

during thermochemical treatment depending on operating conditions [44]. According to Nowak et al. [52], the best Cl-donor is Cl<sub>2</sub>, but it requires expensive equipment for safe handling and can lead to the chlorination of non-hazardous elements like Ca or Fe. To our knowledge, no publication therefore detailed its direct use in SS or SS ashes thermochemical treatment. Solid chlorine-donors are mostly used [43–65,78,79]. For industrial processes they offer the advantages of low cost, easy availability, low toxicity and trouble-free handling during the chlorination process [43].

Chlorination reaction steps between TME and Cl are suggested as follows by Jeon et al. [53], with M: TME, MO: TME oxides, X: metals, X–Cl<sub>2</sub>: Cl-donors, MCl<sub>2</sub>: chlorinated TME, X–O: metal oxides.

Depending on the operating conditions and the Cl-donor used, the TME can react with chlorine either directly ("direct chlorination", eqn. (1)) or indirectly. In this case, the Cl-donors react with  $O_2$  or  $H_2O$  to produce  $Cl_2$  or HCl, which in turn react with TME ("indirect chlorination", eqn. (2) to (5)). According to Nowak et al. [50] and Jeon et al. [53], for indirect chlorination processes,  $Cl_2$  or HCl formation reactions are considered as the limiting step for the TME removal (eqn. (2) and (4)) and not TME chlorination itself (eqn. (3) and (5)).

In the next parts of the review, the chlorination mechanisms and efficiency with MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, HCl gas, PVC, KCl and NH<sub>4</sub>Cl are detailed. Data from different works are compiled in **Tables S2 to S5**, in order to investigate the impact of different operating conditions (feed material type and major elements composition, residence time, treatment gas, reactor type, Cl-concentration and treatment temperature) on the TME vaporization properties during SS or SS ashes thermochemical treatment with Cl-donor. The replicated removal rates were obtained from the various works explored (values extracted from graphs most of the time). In the case where no removal rates were given by the authors, the TME contents in the solid residues after thermochemical treatment were instead given.

# 4.2. <u>Magnesium chloride – MgCl</u><sub>2</sub>

The most common Cl-donor used to promote TME vaporization during SS or SS ashes thermochemical treatment is MgCl<sub>2</sub>. It is an abundant, cheap, safe and non-toxic compound that has been extensively studied [44,45,47,49,53,57,62,63,65,75].

MgCl<sub>2</sub> is considered as a low temperature Cl-donor and as both an indirect and direct chlorination agent, the indirect pathway being kinetically and thermodynamically favored [44]. Most of the time, MgCl<sub>2</sub> is used in powder hexahydrate form (MgCl<sub>2</sub>.6H<sub>2</sub>O) and milled or mixed with SS (or SS ashes) prior to thermochemical treatment [44,52,57,62]. The Cl-donor can also be solubilized in water before being added to SS [45,55]. The preparation methods for the mixtures are however only poorly detailed in most papers.

According to Yu et al. [57], MgCl $_2$ ·6H $_2$ O decomposition under air can be divided into three stages:

- 421 At a temperature lower than 150 °C, MgCl<sub>2</sub>·6H<sub>2</sub>O is first dehydrated, with MgCl<sub>2</sub>·xH<sub>2</sub>O (x = 2 and 4) and H<sub>2</sub>O as main products,
  - Between 150 and 500 °C, an intermediate compound, Mg(OH)Cl, is formed by hydrolysis reaction, leading to HCl production as early as 150 °C,
  - At a temperature higher than 500 °C, Mg(OH)Cl is converted to MgO with HCl formation.

Under N<sub>2</sub> atmosphere (pyrolysis), chlorination mechanisms are slightly different according to Xia et al. [62]. In their work, they detected both HCl (above 500 °C) and Cl<sub>2</sub> (as early as 100 °C) production. The proposed reactions explaining these two compounds production are as follows:

Table S2 compiles the results from [44,45,47–49,53,57,62,63] and presents the TME removal rates obtained during SS or SS ashes thermochemical treatment with MgCl<sub>2</sub> addition. The results are discussed in the next part of the paper (section 5.).

# 4.3. <u>Calcium chloride – CaCl</u><sub>2</sub>

The second most common Cl-donor used to promote TME vaporization during SS or SS ashes thermochemical treatment is CaCl<sub>2</sub>. As MgCl<sub>2</sub>, it is an abundant, cheap, safe and non-toxic compound that has been extensively studied as chlorinating agent [43,44,50–53,62,63,74,75].

According to Fraissler et al. [43,71],  $CaCl_2$  is both a direct and indirect chlorinating agent. However, the thermodynamic calculation performed by the authors seem to indicate that  $CaCl_2$  reaction with  $H_2O$  and  $O_2$  is thermodynamically and kinetically favored compared to direct chlorination, which can occur as a second pathway. The authors also showed that a higher surface area leads to higher reaction rates with  $H_2O$  and/or  $O_2$  thus, milled  $CaCl_2$  may improve TME removal more than  $CaCl_2$  in flake form [43].  $CaCl_2$  is therefore most of the time used in powder form  $(CaCl_2.2H_2O)$  and milled with SS (or SS ashes) prior to thermochemical treatment [44,50,52]

Vogel et al. [75] compared  $MgCl_2 \cdot 6H_2O$  and  $CaCl_2 \cdot 2H_2O$  thermal decomposition under  $O_2$  thanks to thermogravimetry coupled with an infrared detector. After dehydration around 150 °C, the thermal decomposition of  $CaCl_2 \cdot 2H_2O$  follows a different pathway than the one of  $MgCl_2 \cdot 6H_2O$ . Indeed, no HCl gas was detected. According to the authors, only  $Cl_2$  gas (not visible in FTIR spectra) was formed during  $CaCl_2 \cdot 2H_2O$  thermal degradation in absence of gaseous  $H_2O$ , while for  $MgCl_2 \cdot 6H_2O$ , both  $Cl_2$  and HCl were formed. However, in contact with water, both Cl-donors react similarly and produce HCl during thermochemical treatment [52,71]. Depending on the presence or absence of water in the atmosphere, the two possible chlorination reactions of  $CaCl_2$  are therefore the followings:

During pyrolysis under N<sub>2</sub> atmosphere, according to Xia et al. [62], both HCl and Cl<sub>2</sub> gases are produced, following the proposed reactions:

Table S3 compiles the results from [43,44,48,50–53,62,63] and presents the TME removal rates obtained during SS or SS ashes thermochemical treatment with CaCl<sub>2</sub> addition. The results are discussed in the next part of the paper (section 5.).

# 463 4.4. Sodium chloride – NaCl

NaCl is another common, abundant, cheap, safe and non-toxic salt that can be used as Cl-donor during SS or SS ashes thermochemical treatment. However, it has not been studied as much as CaCl<sub>2</sub> or MgCl<sub>2</sub>, due to its high vapor pressure [44,53,62,69]. Indeed, depending on the operating conditions, NaCl can evaporate in high quantities without reacting, especially when a rotary kiln or a fluidized bed reactor is used [44].

NaCl is considered as both a direct and indirect chlorination agent. However, unlike MgCl<sub>2</sub> and CaCl<sub>2</sub> and according to Nowak et al. [44], the direct pathway is thermodynamically and kinetically favored over the reaction with H<sub>2</sub>O and O<sub>2</sub>. Under N<sub>2</sub> atmosphere (pyrolysis), according to Xia et al. [62], the chlorination mechanisms are the followings:

- 476 Similar reaction pathways were also proposed by Liu et al. [69] for incineration experiments.
- **Table S4** compiles the results from [44,53,62,69] and presents the TME removal rates obtained during SS or SS ashes thermochemical treatment with NaCl addition. The results are discussed in the next part of the paper (section 5.).
- 480 4.5. Other Cl-based compounds: KCl, PVC, HCl gas, NH<sub>4</sub>Cl
- 481 KCl, NH<sub>4</sub>Cl and FeCl<sub>3</sub> have also been tested as Cl-donors [49,53,68,70]. KCl is considered as a high 482 temperature Cl-donor (> 800 °C) [49] but only few information on the chlorination mechanisms are 483 available for these compounds as they have not been studied as much as MgCl<sub>2</sub>, CaCl<sub>2</sub> or NaCl.
  - Gaseous hydrochloric acid (HCl) can also be used for SS or SS ashes thermochemical treatment [45,48,72]. In this case, the reaction mechanisms are simple. Direct chlorination is possible as long as HCl is available for reaction with the TME according to the following equation:

To allow a good interaction between HCl gas and SS, the thermochemical treatment needs to be carried out either in a rotary kiln or in a fluidized bed reactor [48].

Finally, Cl-rich waste materials like polyvinyl chloride (PVC) are suitable to enhance TME vaporization properties during SS or SS ashes thermochemical treatment [46,47,62,67,69,73,77]. PVC is the third most produced synthetic plastic polymer in the world. About 40 million tons of PVC are produced each year. Most of it can be recycled after use, but there are still streams of used PVC which are not and need to be valued [46]. PVC has a high Cl content of 52-53 wt% and a high heat energy of approximately 18 MJ/kg [46]. For these reasons, PVC can be used as a cheap organic chlorinating agent and as an energy carrier for SS or SS ashes thermochemical treatment.

Vogel et al. [46] studied PVC thermal decomposition in air thanks to thermogravimetric experiments coupled with infrared. The obtained results show an important mass loss (65wt%) around 220  $^{\circ}$ C corresponding to HCl production from PVC. Cl<sub>2</sub> may also be formed at this stage but is

not visible in FTIR spectra [75]. PVC is therefore considered as a low temperature and indirect Cldonor. During pyrolysis (under  $N_2$  atmosphere), according to Xia et al. [62], both  $Cl_2$  and HCl are produced during thermochemical treatment, according to the following equations:

**Table S5** compiles the results from [46-49,53,62,68-70,77] and presents the TME removal rates obtained during SS or SS ashes thermochemical treatment with PVC, HCl, NH<sub>4</sub>Cl, FeCl<sub>3</sub> or KCl addition. The results are discussed in the next part of the paper (Section 5.).

#### 5. Trace metal elements removal

The TME removal rates compiled in **Tables S2 to S5** allow to investigate the impact of various Cldonors and operating conditions on their vaporization properties during SS or SS ashes thermochemical treatment. The general trends and the most relevant parameters influencing TME removal are compiled in **Table 4** and are further discussed for each TME.

It is important to note that in this part, when no additives are used ("no Cl" column in **Table 4**), the vaporization rates reported in Kubuňová et al. [85], Nowak et al. [52] and Liu et al. [69] were excluded due to high Cl contents in the raw SS and SS ashes. Indeed, the surprisingly high removal rates for Cu, Zn, Cr and/or Ni observed in these studies may be due to Cl presence. The goal of this part being to study Cl addition impact (use of Cl-donors), these works may thus interfere. It explains the differences in the calculated mean and median removal rates when no additives are used between **Tables 3 and 4**.

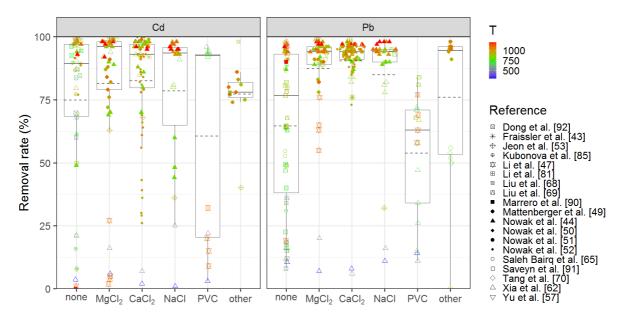


Figure 3 – Boxplots compiling data from Tables S1 to S5 and representing the reported Cd and Pb removal rates as a function of the treatment temperature (color scale), the reference studied (shape scale) and the used Cl-donor (none, MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, PVC and other Cl-based). The mean (dotted horizontal line) and median (horizontal line) removal rates for each TME are also shown, along with the first and third quartiles (black rectangles) and the 95% confidence interval (black vertical line).

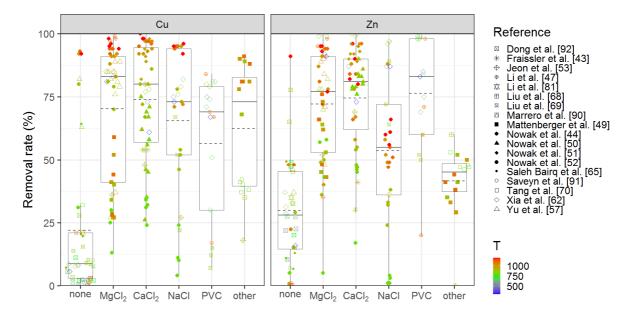


Figure 4 – Boxplots compiling data from Tables S1 to S5 and representing the reported Cu and Zn removal rates as a function of the treatment temperature (color scale), the reference studied (shape scale) and the used Cl-donor (none, MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, PVC and other Cl-based). The mean (dotted horizontal line) and median (horizontal line) removal rates for each TME are also shown, along with the first and third quartiles (black rectangles) and the 95% confidence interval (black vertical line).

For ease of reading and further discussion, the main results from literature concerning TME removal rates during SS thermochemical treatment with various Cl-donors compiled in **Tables S2 to S5** are also presented in **Figs. 3 to 6** and **Figs. S1 to S4. Figs. 3 to 6** represent the reported removal rates (for Cd and Pb in **Fig. 3**, for Cu and Zn in **Fig. 4**, for Cr and Ni in **Fig. 5** and for As in **Fig. 6**) as a function of the treatment temperature (color scale: blue at 300, green at 750 and red at 1200 °C), the reference studied (shape scale) and the used Cl-donor (none, MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, PVC and other Cl-based). The mean (dotted horizontal line) and median (horizontal line) removal rates for each TME are also shown (and compiled in **Table 4**), along with the first and third quartiles (black rectangles) and the 95% confidence interval (black vertical line). **Figs. S1 to S4** (Cd and Pb in **Fig. S1**, Cu and Zn in **Fig. S2**, Cr and Ni in **Fig. S3** and As in **Fig. S4**) present boxplots constructed with the same database but this

time with a color scale representing the CI concentration (green for 0, red for 150 and black for 250 g CI/kg raw material) instead of the treatment temperature. It therefore allows to study the impact of increasing CI content with the various CI-donors studied. It is important to note that only the studies reporting TME removal rates were used to build these figures. Some authors only gave TME contents in solid residues and were therefore not included (see **Tables S2 to S5**). Their results are however discussed in the text.

#### 5.1. Cadmium and lead

As previously discussed, Cd and Pb are easily volatile TME. Indeed, during classic SS or SS ashes thermochemical treatments (without Cl addition), these elements are most of the time vaporized at rates above 80% when the treatment temperature reaches 800 °C or higher (see section 3.1.). It is also the case during thermochemical treatment with Cl-donors as visible in **Fig. 3**. Indeed, the figure shows higher Cd and Pb removal rates for treatment temperatures above 800 °C (orange and red points in **Fig. 3**).

The differences in removal rates between thermochemical treatment of SS or SS ashes with and without additives (Cl-donors) are small for Cd (**Fig. 3**). The additives seem to have neither a positive nor a negative impact on Cd vaporization properties, except for PVC (negative impact due to high C and H contents according to Li et al. [47], **Fig. 3**). Therefore, Cl addition does not impact Cd removal. This result is in good agreement with the thermodynamic simulations performed by Fraissler and al. [43] and Liu et al. [68], showing neither positive nor negative interactions between Cd and Cl. It is also confirmed in **Fig. S1** with no visible correlation between Cd removal and increasing Cl content during thermochemical treatment. Cd removal is therefore controlled by the treatment temperature.

Low Cd vaporization rates are however observed in Li et al. [47] and Jeon et al. [53] works for treatment temperatures above 800 °C (**Fig. 3** and **Tables S2 to S5**). According to Li et al. [47], it is due to the following reaction mechanism:

# $Al_2O_3 \cdot 2SiO_2 + CdO \rightarrow CdO \cdot Al_2O_3 \cdot 2SiO_2 \tag{18}$

 $CdO \cdot Al_2O_3 \cdot 2SiO_2$  is a stable product with a low volatility. It can be formed during SS incineration prior to Cl addition due to the high  $Al_2O_3$  content in the raw SS [47]. The absence of water (due to SS ashes use) may also explain the low removal rates observed in these works. Indeed, according to Fraissler et al. [43],  $H_2O$  presence promotes  $Cd(OH)_2$  production and therefore Cd vaporization.

For lead, the compiled data show mean removal rates of 87, 90, 85, 54 and 76% when MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, PVC or KCl are respectively used for thermochemical treatment (**Fig. 3** and **Table 4**). Except with PVC, Cl addition therefore promotes Pb removal trough the gas phase (**Fig. 3**). As visible in **Fig. S1**, low Cl contents (from 50 g Cl/kg raw material) allow to reach high Pb removal rates. Interestingly, under reductive conditions (pyrolysis), Pb vaporization rate is high when Cl is involved (vaporization rate of 90% with MgCl<sub>2</sub> against 16% without at 700 °C according to Xia et al. [62], **Tables S1 and S2**). It is due to Pb interaction with chlorine to form PbCl<sub>2</sub>, a compound that vaporizes significantly below 800 °C [69]. In comparison, without Cl addition, under reductive conditions, lead vaporization is limited as no O<sub>2</sub> is available to interact with Pb and form volatile oxides (**Table S1**) [43].

When PVC is used as Cl-donor, the reported Pb removal rates are slightly lower than with classic salts (**Fig. 3** and **Table S5**). According to Liu et al. [69], it is due to a change in the chlorination mechanisms. Indeed, the authors reported that when NaCl is used as Cl-donor, PbCl<sub>2</sub> is predominantly produced during thermochemical treatment while when PVC is involved, PbCl<sub>2</sub>, Pb(ClO<sub>4</sub>)<sub>2</sub> and PbCl<sub>2</sub>O<sub>4</sub> are detected. For Li et al. [47], the reduced Pb removal rates observed with PVC are related to the high C and H contents in PVC. Nevertheless, even with PVC as Cl-donor, lead vaporization rates are above 60% in several cases (**Fig. 3** and **Table 4**).

As a conclusion for Cd and Pb, it seems that for Cd, the vaporization properties are neither positively nor negatively changed when Cl-donors are involved during treatment (**Fig. 3**). For Pb, they are enhanced thanks to chlorination mechanisms, except when PVC is used as additive (**Fig. 3**). Cd removal is therefore temperature dependent while Pb is both temperature and Cl-donor dependent (**Table 4**).

# 5.2. Copper and zinc

Copper and zinc are considered as semi-volatile TME [43]. Their vaporization properties are limited under classic thermochemical treatment conditions (no additives) but highly enhanced during thermochemical treatments with Cl addition, as presented in **Fig. 4** (as a function of temperature) and **Fig. S2** (as a function of Cl content). Indeed, these two compounds present good mobility and therefore can interact easily with the Cl-donors to form volatile species like ZnCl<sub>2</sub>, CuCl, CuCl<sub>2</sub> or (CuCl)<sub>3</sub> [44,69]. **Fig. 4 and S2** also allow to compare the various Cl-donors impact on Cu and Zn removal rates. Thus, MgCl<sub>2</sub> and CaCl<sub>2</sub> are the most efficient Cl-donors for Cu, while for Zn, MgCl<sub>2</sub>, CaCl<sub>2</sub> and PVC are better suited. It is further discussed.

As it can be seen in **Fig. 4, S2** and **Tables S2 to S5**, it can be generally stated that Cu vaporization properties are highly enhanced by (i) an increase in the treatment temperature (orange and red points in **Fig. 4**), (ii) Cl addition in high amounts (red and dark-red points in **Fig. S2**) and (iii) a long material residence time:

- (i) Nowak et al. [44] reported Cu removal rates of 30 and 91% at 800 and 1000 °C respectively, with 150 g Cl/kg SS ashes as MgCl<sub>2</sub> (**Table S2**). Xia et al. [62], Adam et al. [45], Yu et al. [57] and many other authors also reported significantly higher Cu vaporization rates with increasing treatment temperature (orange and red points in **Fig. 4**) [43,49,63]. In general, it can be stated that at least 900 °C are required to obtain Cu removal rates higher than 80% during SS or SS ashes thermochemical treatment with Cl-donors (**Table 4**).
- (ii) With CaCl<sub>2</sub> as Cl-donor, Yang et al. [63] detected 208 ppm of Cu in the solid residues obtained after thermochemical treatment at 900 °C with 1 wt% Ca while only 17 ppm were remaining after a treatment with 10% Ca (**Table S3**). The authors noticed the same behavior with MgCl<sub>2</sub> addition in different amounts [63]. The same trend (Cu removal increase with increasing Cl content) is in general observed, except when PVC is used as Cl-donor (red and dark-red points in **Fig. S2**). Indeed, it seems that adding too much PVC (more than 200 g Cl/ kg SS ashes) inhibits Cu

vaporization [46,47]. According to Li et al. [47], it can be attributed to the C and H contents in PVC, promoting Cu transformation into Cu₃P, which is a more stable compound. Classic salts like MgCl<sub>2</sub> or CaCl<sub>2</sub> (indirect chlorination agents) are therefore considered as the most effective Cldonors for Cu removal [45], as confirmed in Fig. 4. It is however difficult to tell which one allows to obtain the highest vaporization properties. Indeed, Xia et al. [62] and Nowak et al. [44] showed that MgCl<sub>2</sub> use allows slightly higher Cu removal rates than CaCl<sub>2</sub> while Yang et al. [63] and Jeon et al. [53] observed the opposite behavior. As for the other Cl-donors, NaCl, PVC and KCl seem slightly less efficient to enhance Cu vaporization properties while NH<sub>4</sub>Cl and FeCl<sub>3</sub> present low impacts (Fig. 4 and Tables S4 and S5). To understand these differences, it is interesting to focus on the experiments performed with HCl gas (Table S5 and [48,56,58,72]). Vogel et al. [48] detected 1093 ppm of Cu in the solid residues obtained after thermochemical treatment at 1000 °C without HCl while only 39 ppm were remaining after a treatment with HCl at 178 g Cl/kg SS ashes. These results mean that copper easily interacts with HCl, as also reported by Fraissler et al. [43]. It may explain why indirect chlorinating agents like MgCl<sub>2</sub> and CaCl<sub>2</sub> generally present the highest impact on Cu vaporization during SS or SS ashes thermochemical treatments (Fig. 4).

634 (iii) Nowak et al. [52] observed that increasing the residence time during the treatment of municipal solid waste fly ash with CaCl2 at a concentration of 170 g Cl/kg raw material in a rotary kiln increases significantly Cu removal rates (Table S3). The authors thus reported a Cu vaporization of only 23% at 1000 °C for a 10 min residence time against 44% at the same temperature when the ashes are kept 45 min in the kiln [52]. In another work, they also reported an increase from 26 to 67% for Cu removal rate when the residence time increases from 10 to 30 min at 850 °C with a concentrations of 150 g Cl/kg raw material [50].

Low Cu removal rates can be observed in some works even at high temperature, with a high Cl content and a long residence time (Fig. 4). For example, Jeon et al. [53] reported Cu vaporization rates of 36 and 48% with MgCl<sub>2</sub> and CaCl<sub>2</sub> respectively, for fly ashes treated at 950 °C under air for 30 min and with 100 g Cl/kg ashes. Nowak et al. [52] also observed less than 30% removal for fly ashes treatment under air at 1050 °C for 45 min with 120 and 170 g Cl/kg ashes as CaCl<sub>2</sub> (Table S3). The authors claim that the low vaporization rates are due to the chosen operating conditions leading to important HCl and Cl<sub>2</sub> loss in the gas phase without interaction with Cu [52]. It was subsequently corrected in their works, leading to high Cu removal rates reported in [44,51]. The data from Nowak et al. in [52] concerning Cu removal were therefore excluded from the box plot in Fig. 4. Finally, Yu et al. [57] also reported lower Cu vaporization rates under reductive conditions than under oxidative conditions (37 against 89% at 1000 °C with MgCl2 at 150 g Cl/kg raw material, Table S2). It was however not confirmed by Xia et al. [62].

Concerning Zn, (i) the treatment temperature (orange and red points in Fig. 4) (ii), the Cl-content (red and dark-red points, Fig. S2) and donor nature (Fig. 4) (iii) and the residence time also seem to be the most important parameters to promote its vaporization during SS or SS ashes thermochemical treatment:

For temperature, Nowak et al. [44] showed that, with MgCl<sub>2</sub> as Cl-donor, increasing the (i) temperature from 900 to 1200 °C allows Zn removal rates to shift from 36 to 93% with a constant CI content of 100 g CI/kg ashes. Adam et al. [45] reported Zn contents in solid residues of 922, 654, 391 and 85 ppm after thermochemical treatment with MgCl<sub>2</sub> as Cl-donor at 750, 800, 900 and 1000 °C respectively (Table S2). Increasing the treatment temperature therefore enhances Zn vaporization properties (orange and red points in Fig. 4). In general, it can be stated that at least 900 °C are required to obtain Zn removal rates higher than 80% during SS or SS

- ashes thermochemical treatments with Cl-donors (**Table 4**). Under reductive conditions with Cl addition (MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl or PVC), 80% Zn vaporization can even be reached with a treatment temperature as low as 300 °C [62]. Indeed, when no O<sub>2</sub> is involved during thermochemical treatment, ZnCl<sub>2</sub> formation is favored in comparison to ZnO [46].
- Increasing the CI content during thermochemical treatment seems to have a highly positive 668 669 impact on Zn removal (red and dark-red points, Fig. S2). Liu et al. [69] reported vaporization 670 rates of 49, 64, 72 and 89% when respectively 0, 1, 3 and 5% of Cl is added to dehydrated SS as 671 NaCl and treated at 850 °C under air (Table S4). Yang et al. [63] detected Zn concentrations in 672 solid residues of 1215, 359, 109, 50 and 35 ppm after thermochemical treatment at 1000 °C with 673 0, 1, 2, 5 and 10% of Ca (as CaCl<sub>2</sub>) respectively (Table S3). Concerning the different Cl-donors, as 674 visible in Fig. 4, it seems that CaCl2, PVC and MgCl2 are more efficient to vaporize Zn than the other Cl-donors. For KCl, the low removal rates reported are likely to be due to its high thermal 675 676 stability limiting Zn and Cl interaction [49,70].
- Concerning the residence time, Nowak et al. [52] showed important increase in Zn removal rates when the fly ashes reactor residence time goes from 10 to 45 min (**Table S3**). Indeed, in the chlorination process, kinetics is the limiting step and longer residence time therefore allows higher removal rates.

- Zn removal rates below 50% can be observed in some works from Fraissler et al. [43], Jeon et al. [53], Nowak et al. [44,52] and Mattenberger et al. [49] (**Fig. 4**). Different mechanisms can be involved. For example, Vogel et al. [76] showed that sulfur rich SS ashes can lead to the formation of the solid and stable ZnS compound, limiting zinc removal as ZnCl<sub>2</sub>. Oxidative conditions can also limit chlorination mechanisms by favoring ZnO formation instead of ZnCl<sub>2</sub> [46]. Finally, operating conditions leading to Cl vaporization to the gas phase without reacting with SS (high gas velocity in a fluidized bed reactor or a rotary kiln and/or use of a volatile Cl-donor such as NaCl) can also limit Zn removal [44,52].
- As a general conclusion on Cu and Zn removal during SS or SS ashes thermochemical treatment, their vaporization can be considered as Cl-donor dependent. Indirect chlorination agents such as MgCl<sub>2</sub> and CaCl<sub>2</sub> (about 100-150 g Cl/kg raw material) seem to be the best Cl-donors and treatment temperatures above 900 °C are required to reach removal rates higher than 80% (**Fig.4** and **Table 4**).

# 5.3. Chromium and nickel

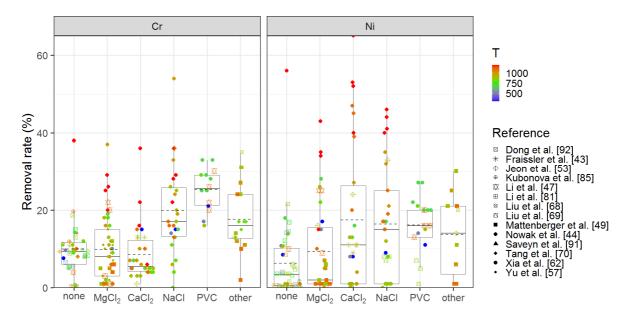


Figure 5 – Boxplots compiling data from Tables S1 to S5 and representing the reported Cr and Ni removal rates as a function of the treatment temperature (color scale), the reference studied (shape scale) and the used Cl-donor (none, MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, PVC and other Cl-based). The mean (dotted horizontal line) and median (horizontal line) removal rates for each TME are also shown, along with the first and third quartiles (black rectangles) and the 95% confidence interval (black vertical

Chromium and nickel are considered as low-volatile TME [43]. Achieving high vaporization rates during SS or SS ashes thermochemical treatment is therefore challenging (Fig. 5). Indeed, with only a few exceptions, the reported Cr and Ni removal rates are most of the time below 40%, as visible in Fig. 5 and Tables S2 to S5. It can however be noticed in Fig. 5 that, for Ni, high treatment temperatures (above 1000 °C, red points) combined with CaCl<sub>2</sub> or NaCl use seem to slightly enhance the vaporization rates in comparison with the other Cl-donors. PVC may also be promising for treatment at lower temperatures (Fig. 5). For Cr, NaCl and PVC seem to be the most efficient Cl-donors (Fig. 5). However, due to a lack of data for these Cl-donors, Fig. S3 does not allow to see visible correlations between Cr and Ni removal rate and increasing Cl content.

For Cr, the works reporting removal rates above 40% during SS or SS ashes thermochemical treatments are scarce:

- Liu et al. [69] reported removal rates above 60% without Cl addition at a temperature as low as 550 °C (**Table S1**). These results are quite surprising as Cr is considered as a low volatile element (section 3.3.). The obtained removal rates of 72 and 71% during thermochemical treatment at 850 °C with NaCl and PVC respectively are also difficult to explain and were unfortunately not much discussed by the authors (**Tables S4 and S5**) [69]. They were therefore excluded from the database used to build **Figs. 5 and S3**.
- Yang et al. [63] showed that 10% Ca addition (as CaCl<sub>2</sub>) and a thermochemical treatment at 1000 °C allows to decrease the Cr content in the obtained solid residues from 126 ppm when no CaCl<sub>2</sub> is involved to 70 ppm (**Table S3**). However, according to the authors, Cr cannot be removed by chlorination and the decrease in Cr content was attributed to the dilution effect by the added CaCl<sub>2</sub> [63].
- Nowak et al. [44] reported a 54% vaporization rate for Cr when fly ashes are treated at 1000
   °C with NaCl in high amounts (200 g Cl/kg fly ashes, Table S4). In comparison with MgCl<sub>2</sub> and

CaCl<sub>2</sub>, NaCl and PVC seem to be the only Cl-donor slightly enhancing Cr removal (**Fig. 5 and S3**). According to the authors, when  $MgCl_2$  and  $CaCl_2$  are used during thermochemical treatment,  $CaCr_2O_4$  and  $MgCr_2O_4$  stable compounds can be formed, with a negative impact on Cr vaporization properties [44]. Kurashima et al. [72,73] also observed that Mg-based compounds addition during thermochemical treatment can lead to the formation of  $(MgO)(Cr_2O_3)$  and limit Cr removal at high temperature.

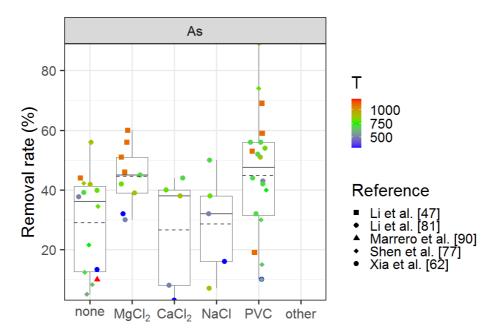
- Thermodynamic simulations performed by Fraissler et al. [43] show that Cr removal at temperatures lower than 1000 °C is theoretically possible in only one scenario (not verified experimentally): Si predominance in the raw SS ash, H<sub>2</sub>O absence in the flue gas and high Cl content of at least 10wt%.

For Ni, the works reporting removal rates above 40% during SS or SS ashes thermochemical treatments are the followings:

- As detailed in a previous section (section 3.3.), Kuboňová et al. [85] reported Ni removal rates above 50% during thermochemical treatment in a rotary kiln without Cl addition. The authors explained the observed results by enhanced mass transfers between solid and gas phase due to rotary kiln use, and a high Cl content in the raw fly ashes [85]. The results are however questionable and were not further confirmed for other experiments with rotary kilns [43,45,48]. They were therefore excluded from the database used to build **Figs. 5 and S3**.
- Nowak et al. [44] reported nickel vaporization rates of 47 and 65% for thermochemical treatment with 200 and 150 g Cl/kg fly ash as CaCl<sub>2</sub> at 1100 and 1200 °C respectively (**Table S3**). CaCl<sub>2</sub> addition in high amounts combined with a high temperature treatment therefore seems to slightly enhance Ni vaporization properties, but it was not observed again.
- According to the thermodynamic simulations performed by Fraissler et al. [43] and Liu et al. [78], nickel vaporization at temperatures below 1000 °C is challenging. Like for chromium, Cl presence in amounts above 10wt% can enhance nickel vaporization, but only in H<sub>2</sub>O absence in the flue gas (Cl<sub>2</sub> formation rather than HCl) [43]. Fe shows a negative influence on Ni volatilization because of the stable ferrite NiFe<sub>2</sub>O<sub>4</sub> formation.

Cr and Ni removal during SS or SS ashes thermochemical treatment is difficult, even with chlorination (**Table 4**). From the boxplots presented in **Fig. 5 and S3**, it can however be stated that PVC and NaCl seem to be the most promising Cl-donors for Cr and Ni removal combined with high treatment temperatures (≥ 1000 °C) and Cl contents (> 150 g Cl/kg raw material). Unfortunately, only few works focused on these two compounds vaporization, which results in a lack of data and little information on the reaction mechanisms.

# 5.4. Arsenic

Arsenic vaporization properties during SS or SS ashes thermochemical treatment has not been much explored in comparison with the other TME (Figs. 6 and S4). Only few works determined its content in the obtained solid residues [45–48,62,77,81,90]. During thermochemical treatment, the As vaporization rates remain most of the time below 60% (Fig. 6). Xia et al. [62] thus reported removal rates of 7, 39 and 38% for SS treatment at 900 °C with 80 g Cl/kg SS as NaCl, MgCl<sub>2</sub> and CaCl<sub>2</sub> respectively (Tables S2 to S4). Vogel et al. [48] showed that 150 g Cl/kg SS ashes addition (as CaCl<sub>2</sub>) and a thermochemical treatment at 1000 °C allows to slightly decrease the As content in the obtained solid residues from 34 ppm when no CaCl<sub>2</sub> is involved to 21 ppm (Table S3). The reported vaporization rates are in the same order of magnitude as those observed during simple thermochemical treatment without additives (Fig. 6). It therefore seems that Cl addition has no significant impact on As removal. Indeed, as reported by Shen et al. [77] and Liu et al. [98], and according to thermodynamic simulations, the interaction between As and Cl is low as arsenic preferentially interacts with the major elements present in the sludge. It is confirmed in Fig. S4 showing no visible correlations between As removal rates and Cl addition in high amounts during thermochemical treatment.

Arsenic removal rates above 50% were reported in some works. Li et al. [47] reported 60 and 69% vaporization rates for As after thermochemical treatment at 1100 °C with MgCl<sub>2</sub> (100 g Cl/kg SS ashes) and PVC (250 g Cl/kg SS ashes) respectively (**Tables S2 and S5**). The high removal rates are likely to be due to the combination of the high treatment temperature (1100 °C) and the Si-rich SS ashes used as raw material (section 3.2.). Xia et al. [62] reported As removal rates of 56% at 700 °C when PVC is used as Cl-donor (**Table S5**). In the work of Shen et al. [77], vaporization rates as high as 74 and 89% were reported for a treatment with PVC (5% Cl) at 800 and 850 °C respectively (**Table S5**). PVC use as Cl-donor during SS or SS ashes thermochemical treatment may therefore help for

arsenic removal (as also visible in **Fig. 6**). No reaction mechanisms were however suggested and the lack of data for this element limits the extent of the conclusions.

# 6. Phosphorus recovery

So far, the focus has been on how to vaporize TME during SS or SS ashes thermochemical treatment by optimizing the operating conditions and the Cl-donor nature. However, the impact on P of these parameters has not yet been discussed. This part is therefore dedicated to the impact of the thermochemical treatments on the forms and solubility of P (note that this has been studied in relatively few papers [45–48,53,62,63,65,78]).

**Table 5** compiles data from literature and presents the impact of the thermochemical treatment conditions on P fixation rates, P forms and P solubility in 2% citric acid (P<sub>cit</sub>) and in neutral ammonium citrate (P<sub>NAC</sub>). P solubility is a good indicator of its bioavailability for plants. The Cl-donors investigated are the followings: MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, KCl, PVC, AlCl<sub>3</sub> and HCl [45–48,53,62,63]. Results with other additives such as MgCO<sub>3</sub>, MgO, Na<sub>2</sub>SO<sub>4</sub>, Na<sub>2</sub>CO<sub>3</sub>, NaOH, K<sub>2</sub>SO<sub>4</sub>, K<sub>2</sub>CO<sub>3</sub> and KOH were also reported [78].

First, it is interesting to focus on the P forms initially present in the raw SS used. During wastewater treatment, P must be separated from the outflow of the treatment plant to avoid eutrophication phenomena [27]. Enhanced biological P removal treatment is predominantly used [26]. It is a multistep process alternating aerobic and anaerobic stages. According to Cieslik et al. [27], during biological treatment, most of the P is stored in the activated sludge flora cells as organic adenosine triphosphates ( $C_{10}H_{16}N_5O_{13}P_3$ ). Al and Fe based coagulants (AlCl<sub>3</sub>, Al<sub>2</sub>(SO<sub>4</sub>)<sub>3</sub>, FeCl<sub>3</sub>, Fe<sub>2</sub>(SO<sub>4</sub>)<sub>3</sub>) can also be added during wastewater treatment, resulting in the precipitation of P in iron and aluminum forms [8]. In raw SS, P can therefore be found in organic but also inorganic forms, depending on the sludge origin. Unfortunately, the initial forms of P were not reported in the reviewed literature. Xia et al. [62] only determined a  $P_{NAC}$  of 15% for the raw SS used (**Table 5**).

During classic SS thermochemical treatments such as incineration, pyrolysis or gasification (without Cl-donors), the organic P forms initially present in the SS are converted to inorganic forms (Table 5). Xia et al. [62] thus detected FePO<sub>4</sub> as the predominant crystalline form of P after pyrolysis treatment at 700 °C. Adam et al. [45] and Vogel et al. [46,48] showed that the ashes obtained after incineration were enriched with Ca<sub>3</sub>(PO<sub>4</sub>)<sub>2</sub> and AlPO<sub>4</sub>. Yang et al. [63] showed that with increasing combustion temperature, Fe/Al-P species (Ca<sub>9</sub>Fe(PO<sub>4</sub>)<sub>7</sub> and AlPO<sub>4</sub>) transform into Ca-P species. It is confirmed by Meng et al. [8], who show that SS incineration leads to the formation of apatite (Ca<sub>5</sub>(PO<sub>4</sub>)<sub>3</sub>[OH, Cl, F]) from Al and Fe phosphates and amorphous Ca phosphate phases. Concerning P fixation rates, Yang et al. [63] showed that increasing the incineration temperature from 800 to 1000 °C improves P fixation in solid residues from 69 to 82%, with a maximum of 89% at 950 °C (**Table 5**). According to the authors, high temperature treatment stimulates the transformation of Fe/Al-P species to Ca-P, which is beneficial for P fixation since Ca-P species are more stable than Fe/Al-P ones [63]. An increase in Pcit with increasing treatment temperature was also reported by Yang et al. [63], because Ca-P species are more soluble than Fe/Al-P ones (Table 5). Xia et al. [62] showed that pyrolysis at 700 °C increases P<sub>NAC</sub> from 15% (for raw SS) to 39% (Table 5). SS classic thermochemical treatments therefore seem to enhance both P fixation rates and solubility.

When Cl-donors are added to SS or SS ashes, the fixation rate and the solubility of P are in most cases greatly enhanced (**Table 5**). Yang et al. [63] thus reported an improvement in P fixation rate at 800 °C, from 69% without additive to 94 and 98% when MgCl<sub>2</sub> (3% Mg) and CaCl<sub>2</sub> (10% Ca) are respectively added (due to Mg and Ca addition and interaction with P, **Table 5**). Furthermore, the authors also reported a significant increase in P<sub>cit</sub>, from 6% without Cl-donor to 64 and 56% with MgCl<sub>2</sub> (3% Mg) and CaCl<sub>2</sub> (10% Ca) respectively. Similar trends were observed in most publications (**Table 5**). Adam et al. [45] reported a P<sub>cit</sub> of 97% when SS ashes are treated at 1000 °C with 150 g Cl/kg as MgCl<sub>2</sub>. Vogel et al. [46] showed an increase in P<sub>NAC</sub> from 14% for raw ashes to 37% when a mixture of PVC (150 g Cl/kg) and MgO (95 g/kg) is used for thermochemical treatment at 950 °C. Finally, Xia et al. [62] observed a shift in P<sub>NAC</sub> from 15% for raw SS to 74% for the ashes after pyrolysis at 700 °C with 80 g Cl/kg SS as CaCl<sub>2</sub>.

Interestingly, the various Cl-donors used to promote TME vaporization seem to have different impacts on P solubility after thermochemical treatment (**Table 5**). In the work of Jeon et al. [53], the obtained  $P_{cit}$  are of 72, 63, 52, 28 and 45% when MgCl<sub>2</sub>, CaCl<sub>2</sub>, NaCl, KCl and AlCl<sub>3</sub> are respectively used as Cl-donors in the same amounts. Vogel et al. [48] reported a  $P_{cit}$  of 71, 64, 53 and 71% with MgCl<sub>2</sub>, CaCl<sub>2</sub>, HCl and a mixture of MgCO<sub>3</sub> and HCl respectively. It therefore seems that to increase P solubility, MgCl<sub>2</sub> is the best Cl-donor, followed by CaCl<sub>2</sub>. It is due to the presence of Mg and its reaction with P to form highly soluble P forms such as Mg<sub>3</sub>(PO<sub>4</sub>)<sub>2</sub> (below 1000 °C) and Ca<sub>4</sub>Mg<sub>5</sub>(PO<sub>4</sub>)<sub>6</sub> (above 1000 °C) [45]. It also explains why, when mixtures of MgCO<sub>3</sub> and HCl or of MgO and PVC are used as additive, high P solubility is also reported by Vogel et al. [46,48] (**Table 5**). When CaCl<sub>2</sub> is involved during thermochemical treatment, Ca-P-Cl species such as Ca<sub>5</sub>(PO<sub>4</sub>)<sub>3</sub>Cl, Ca<sub>5</sub>(PO<sub>4</sub>)<sub>3</sub>F<sub>0.09</sub>Cl<sub>0.88</sub> and Ca<sub>2</sub>PO<sub>4</sub>Cl are detected (**Table 5**) [53,63]. Finally, the other Cl-donors (NaCl, KCl, PVC, AlCl<sub>3</sub>) do not seem to have a significant impact on P solubility [46,48,53].

High P<sub>NAC</sub> are observed in the work of Xia et al. [63], during pyrolysis treatments with Mg-free additives (72, 74 and 74% with NaCl, PVC and CaCl<sub>2</sub> respectively). Furthermore, the highest P<sub>NAC</sub> are observed in the work of Herzel et al. [78], when additives without Cl are used. P<sub>NAC</sub> of 95, 90 and 85% were thus reported with Na<sub>2</sub>SO<sub>4</sub>, Na<sub>2</sub>CO<sub>3</sub> and NaOH respectively, leading to a fertilizing effect comparable to triple superphosphate. Unfortunately, no mechanism is proposed to explain how these additives react with the phosphate species in the SS ashes to form new P-containing mineral species with high solubility. Furthermore, the reported TME removal rates are not as high as when Cl-donor are used for thermochemical treatment, especially for Cu, Cr, Ni, Pb and Zn [78]. However, MgCl<sub>2</sub> and Na<sub>2</sub>SO<sub>4</sub> mixtures and/or reductive treatment conditions may be interesting to test, to combine high impacts on TME and P.

# 7. Conclusion and research perspectives

Phosphorus is a non-substitutable element necessary for plant growth whose supply is increasingly limited and currently controlled by very few countries. The EU Commission has classified P as a critical raw material in 2014 and recovery processes need to develop in the coming decades. According to Schnell et al. [38], in Germany, with upcoming regulations on P recovery restricting SS co-incineration disposal route, the most expected strategy is the development of new capacities for SS mono-incineration plants with downstream P recovery from produced ashes.

To that extend, SS ashes thermochemical treatment with Cl-donor may be a particularly relevant solution. Indeed, it allows an efficient removal of TME by the gas phase while enriching P in the solid residues in highly soluble forms. Metal chlorides such as MgCl<sub>2</sub>, CaCl<sub>2</sub> and NaCl are mostly used as Cl-donors, offering the advantages of low costs, easy availability, low toxicity and trouble-free handlings

during the chlorination process.  $MgCl_2$  appears to be the most interesting Cl-donor because it has a combined impact on TME vaporization and P solubility. SS ashes thermochemical treatment under air with 100-150 g Cl/kg as  $MgCl_2$  at 950-1000 °C thus allows, in average, removal rates of 40-50, >90, 10-20, >90, 10-20, >90 and >80% for As, Cd, Cr, Cu, Hg, Ni, Pb and Zn respectively and a  $P_{cit}$  around 80-90%. For the downstream recovery of P from SS ashes, the development of such thermochemical treatments may therefore be particularly relevant.

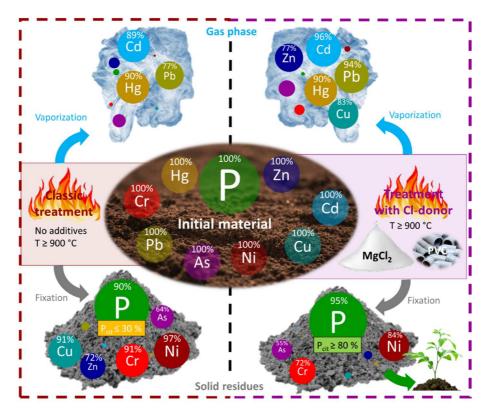


Figure 7 – Summary graph comparing the impact on TME vaporization and P bioavailability of a classic SS thermochemical treatment (no additives) and a thermochemical process with  $MgCl_2$  and/or PVC (for As, Cr and Ni removal) as Cl-donors. The circle size is related to the content in the different phases and was build thanks to the median removal rates compiled in Tables 3 and 4.

 As discussed in detail in this review, the studied TME have different vaporization properties. Fig. 7 summarizes the present results and compares the impact on TME vaporization and P bioavailability of a conventional SS thermochemical treatment without additives and a thermochemical process with MgCl<sub>2</sub> (for Cd, Cu, Hg, Pb and Zn) or PVC (for As, Cr and Ni) as Cl-donor. Thus, for materials with high Hg, Cd and/or Pb contents (and low contents for the other TME), a conventional thermochemical treatment without additives at a temperature above 900 °C is most of the time satisfying to produce P-rich solid residues that may be directly recovered as fertilizers or soil conditioners. High Zn and/or Cu contents require chlorine addition, preferentially in the form of MgCl<sub>2</sub> and a thermochemical treatment above 900 °C. It is interesting to mention that the use of MgCl<sub>2</sub> generally enhances the bioavailability of P in the solid residues obtained. For materials containing high As, Cr or Ni contents, thermochemical treatments may not be the best technical solutions at this time.

Some limitations require further research and discussions. First the reported removal rates for Cr, Ni and As are so far below 50%. Therefore, other additives and treatment conditions need to be investigated with a focus on these three elements. Another limitation is the high Cl-contents used to achieve high removal rates. They are mostly above 100 g Cl/kg SS ashes which is a large excess (50 to

100 times more) compared to the TME concentrations in SS ash. Not many works trying to optimize the CI-TME contacts in order to minimize CI addition were reported. Finally, few studies have addressed on the impact of mixtures with different Cl-donors during thermochemical treatment, when this could be a solution to improve As, Cr and Ni removal while preserving high vaporization properties for the other TME. Moreover, despite many advantages (single industrial installation, higher energy yields, combined P and energy recovery, high TME removal rates), direct SS thermochemical treatments by incineration, pyrolysis or gasification with Cl-donors are currently only poorly studied.

Therefore, many questions need to be addressed such as the impact of the CI-rich gases produced during the treatment process (corrosion issue on the reactor and pipes), the overall energy efficiency, the TME removal rates and P solubility under various unexplored operating conditions, the fate of the TME and their possible treatment after removal by the gas phase, the leachability of the remaining TME in the solid residues, the organic matter influence, the impact of scaling up (batch to continuous mode, lab to pilot and industrial scale), etc.
