# Total Synthesis of Phenanthropiperidine Alkaloids by Sequential Alkylation of *N*,*N*-Dibenzylaminoacetonitrile

Abstract: Two representative members of the phenanthropiperidine alkaloid family, tylophorine (1) and cryptopleurine (2), were synthesized by a bidirectional alkylation strategy employing dibenzylaminoacetonitrile as a substrate. This approach relies on the unprecedented condensation of metallated  $\alpha\text{-aminonitriles}$  with bromomethylphenanthrenes to provide fully substituted  $\alpha\text{-aminonitriles}$  that are submitted to a NaBH4-mediated reductive decyanation process to form homobenzylic amines. From these intermediates, a terminal leaving group was introduced by simple chemical manipulation, and its displacement by a free primary amine under two favourable cyclization processes led to the formation of the future E-ring of both alkaloids in high yields. Finally, a late Pictet–Spengler cyclization ensured the formation of a D-ring for the alkaloids 1 and 2.

#### Introduction

Phenanthropiperidine alkaloids represent a small group of pentacyclic natural products (Figure 1) that have been used in folk medicine for untold centuries. These compounds have been isolated from plants found throughout India, Africa and Australia. Tylophorine (1) was first isolated in 1935 by Rathnagiriswaran and Venkatachalam from the roots and leaves of *Tylophora asthmatica*,<sup>[1]</sup> whereas cryptopleurine (2) was isolated in 1947 by de la Lande from the bark of *Cryptocarya pleurosperma*, an evergreen tree indigenous to Australia.<sup>[2]</sup>

Phenanthropiperidines present marked biological properties [3] such as antiproliferative effects against various cell lines [4] or have been shown to selectively inhibit hypoxia-inducible factor-1 (HIF-1) in several human cancer lines. [5] Phenanthrene-based derivatives also interact with the nuclear factor-kappa B (NF- $\kappa$ B) signaling pathway [6] or present anti-inflammatory activity by reducing the production of tumor necrosis factor-alpha (TNF $\alpha$ ). [7] Many derivatives are also potent inhibitors of hepatitis C and tobacco mosaic virus replication. [8] In addition, cryptopleurine together with various small molecules inhibits protein synthesis in eukaryotic cells by targeting mRNA and tRNA binding sites of the ribosome. [9]

These significant biological properties have incited chemists to propose numerous syntheses. The most recent racemic approaches to alkaloids **1** and **2** rely on various methodologies, including iterative Suzuki–Miyaura reaction of boronic acids, [10] intramolecular aza-Diels–Alder condensation, [11] free radical cyclizations, [12] Cp\*Co<sup>III</sup> or Rh<sup>III</sup>-catalysed annulation of terminal alkynes, [13] Pd-catalysed aryne annulation by o-halostyrenes, [14] Stevens rearrangement of a nitrile stabilized ylide, [15] or Negishi cross-coupling reaction. [16] Several well-designed approaches utilizing chiral catalysts have also led to the synthesis of title alkaloids with high enantiomeric ratios. [17] Similarly, successful asymmetric syntheses have been carried out through chiral auxiliary-based approaches, [18] or via chemical manipulation of enantiopure amino acids. [19]

Despite their apparent similarities, phenanthropiperidine alkaloids exhibit several distinguishable features. First, these compounds display phenanthrene rings that differed in their number and position of methoxy groups. Second, compounds 1 and 2 possess saturated nitrogen-containing heterocycles of indolizidine and quinolizidine, respectively. Thus, for the present work, it was necessary to develop a general and modular access to phenanthropiperidine alkaloids, which is delineated retrosynthetically in Scheme 1.

For the synthesis of tylophorine, the central feature of our approach is based on the condensation of  $\alpha$ -aminonitrile **5a** (n = 1) with known bromide **11a** to form the future C13a–C14 bond of the target molecule. Accordingly, the synthesis of cryptopleurine can be carried out by a proper selection of the alkyl chain length (n = 2) of **5** and the substitution pattern of the phenanthrene moiety. Then, the construction of the future pyrrolidine ring (E ring) of **1** should be performed through a favoured 5-exo-tet cyclization process between N-10 and a terminal cyclizing group, while a 6-exo-tet annulation process

should form the piperidine ring of **2**. It is worth noting that in both alkaloids, we planned that the future C8b-C9 bond should be realised by late Pictet–Spengler cyclomethylenation.

#### **Results and Discussion**

#### Synthesis of $\alpha$ -aminonitriles 4, 5.

Our synthesis began with the condensation of chloroacetonitrile and dibenzylamine, which was carried out in acetonitrile in the presence of a catalytic amount (up to 5% in mass) of n-tetrabutylammonium iodide (Bu<sub>4</sub>NI) and diisopropylethylamine (DIPEA, Hünigs base) as the proton scavenger (Scheme 2). After treatment and removal of the DIPEA hydrochloride salt by filtration,  $\alpha$ -aminonitrile 4 was obtained in 88% yield after slow crystallization in a mixture of diethyl ether and petroleum ether.

With the required derivative in hand, we turned to the deprotonation of 4 in the presence of a strong base. Scrutinizing the literature data revealed that studies devoted to the reactivity of lithiated  $\alpha$ -aminonitrile 4 are scarce. Nevertheless, in the continuation of the seminal work of Stork in 1978, [21] Husson reported the double deprotonation of 4 to synthesize cyclohexylaminonitriles, [22] whereas Rychnovsky described a sequential process aimed at the preparation of fully substituted  $\alpha$ aminonitriles.[23] In these studies, primary alkyl bromides and iodides were used as electrophiles, while Mangeney condensed several aldehydes to synthesize a set of  $\beta$ -aminoalcohols with a high level of diastereoselectivity. [24]  $\alpha$ -Aminonitrile **5** was synthesized in two steps: deprotonation of 4 and condensation of the resulting  $\alpha$ -aminocarbanion on the requisite electrophile. Based on our previous experience in  $\alpha$ -aminonitrile chemistry, we believe that LDA should be the base of choice and THF the preferred solvent.[25]

Thus, treatment of a 0.4 M THF solution of  $\alpha$ -aminonitrile 4 cooled to -80 °C by 1.20 equivalents of LDA provided the rapid formation of a deep red anion solution that was warmed to -30 °C over a 1.5 h period. The solution was next cooled to -80 °C, and 1.10 equivalents of bifunctional iodide **3a** were added at this temperature. After aqueous work-up,  $\alpha$ -aminonitrile **5a** was obtained in 78% yield after chromatographic purification (Scheme

2). It is important to mention that common additives such as TMEDA or DMPU were ineffective or had a detrimental effect. When similar experiments were carried out with iodide 3b, the expected  $\alpha$ -aminonitrile 5b was obtained in 83% yield, indicating that the length of the carbon chain and the presence of a tethered OTHP group did not affect the anion alkylation.

#### Synthesis of bromides 11.

With an efficient route to  $\alpha$ -aminonitriles 5, we turned to the synthesis of bromides 11, which was carried out according to a known reaction sequence. [26] However, problems associated with the oxidative coupling of acrylic esters 7, prompted us to report our own results.

The synthesis began with the preparation of acrylic acid **6a** by condensing homoveratric acid and veratraldehyde in the presence of 3.6 equivalents of freshly distilled triethylamine and 5.5 equivalents of acetic anhydride (Scheme 3).

The reaction mixture was refluxed under an argon atmosphere at 80 °C for 24 h, and a simplified treatment (see the experimental section for details) afforded the expected 2,3-

diphenylacrylic acid **6a** in 71% yield. Similarly, compound **6b** was obtained in 70% yield, but the synthesis required a much shorter reaction time for the reaction to be complete. The <sup>1</sup>H and <sup>13</sup>C spectra were consistent with the proposed structures and indicated that acids **6** were isolated as single isomers.<sup>[27]</sup> Then, Fisher esterification produced acrylic esters **7** in nearly quantitative yields. Efforts were next directed to the synthesis of phenanthrenes **8**, which were thought to be readily available through a dehydrogenative cross-coupling reaction (Scheme 4).

Our initial attempts to cyclize acrylic ester **7a** were carried out according to existing methods (Table 1, entries 1–2) and failed to produce the expected phenanthrene **8a**. [28] Only the starting material was recovered from the reaction mixture, and this lack of reactivity under these specified reaction conditions was puzzling

and prompted us to investigate alternate procedures. We continued our study with inspiration from the work of Rathore, who reported the oxidative coupling of polymethoxy biaryl units in the presence of dichloro-dicyano-benzoquinone (DDQ) as the preferred oxidant.<sup>[29]</sup> Notably, quinones are redox-active organic molecules that are involved in many oxidative processes that are found in vivo and in the laboratory.[30] As recently highlighted by Hammes-Schiffer, the E<sup>0</sup> values of quinones can be increased by the presence of electron-withdrawing substituents.[31] For example, 1,4-benzoquinone (BQ) displayed an  $E^0$  redox potential of + 0.65 V vs NHE, whereas tetrachloro-1,4-benzoquinone (chloranil) and DDQ were shown to have a more elevated  $E^0$ values of 0.70 V and 0.99 V vs NHE, respectively.[32] Our first experiment (entry 3) was carried out in a dichloromethane (DCM) solution of ester 7a under conditions defined by Rathore (DCM/MeSO<sub>3</sub>H) but with chloranil (entry 3) as the selected guinone and, once again, only the starting material was recovered. In sharp contrast, the addition of a stoichiometric amount of DDQ (entry 4), led to an immediate colouration of the reaction mixture. which turned dark green after a few minutes. A basic aqueous treatment with sodium carbonate allowed the selective removal of DDQH<sub>2</sub> and afforded the expected phenanthrene 8a in a 95% isolated vield. Upon comparing entries 4 and 5, one can see that the concentration of acid had an influence on the kinetics of the reaction. Indeed, when the experiment was carried out in a 99:1 mixture of dichloromethane and methane sulfonic acid, the reaction was half-completed after 1 h of stirring at 0 °C. Complementing the synthetic efforts mentioned above, we turned to the synthesis of phenanthrene 8b. Thus, when a 120 mmol solution of ester 7b (entry 7) in a mixture of dichloromethane and methane sulfonic acid (9:1) was treated with 1.1 equivalent of DDQ, the solution immediately turned dark green, providing evidence that a redox reaction also took place. Stirring was continued for 30 minutes, and standard aqueous work-up afforded a complex reaction mixture from which no detectable amount of phenanthrene 8b could be detected.

This surprising result prompted us to examine several protocols that would hopefully form ester **8b**. We also reasoned (Scheme 5) that in the case of **7a**, the formation of a new carbon to carbon bond should be carried out according to the ionic properties of cation radical **A** (R = OMe), whereas in the case of ester **7b**, the radical properties of cation radical **A'** (R = H) ought to dominate.  $^{[33, 34]}$  With these considerations in mind, a new experiment was undertaken under more diluted conditions.

Hence, the addition of 1.1 equivalent of DDQ to a 15 mmol solution of ester 7b (entry 8) in a mixture of dichloromethane and methane sulfonic acid (50:1) resulted in the isolation of 8b in 66% yield after chromatographic purification. Structural determination of **8b** was straightforward. In the <sup>1</sup>H NMR spectrum recorded in CDCl<sub>3</sub>, H-2 exhibits a characteristic doublet of doublets ( ${}^{3}J = 8.7$ ,  $^4J$  = 2.3 Hz) at  $\delta$  = 7.22 ppm, and in the  $^{13}$ C NMR spectrum, 19 independent resonance lines were found between  $\delta = 52.0$  ppm and 168.2 ppm. Moreover, upon close examination of the reaction mixture, we detected the presence of the more polar bisphenanthrene 9, which was easily isolated (10% yield) by column chromatography. As shown in the supplementary material, the <sup>1</sup>H NMR spectrum of compound 9, well resolved, displayed 8 singlets ( $\delta$  = 2.79–4.19 ppm), which were attributed to nonequivalent methoxymethyl groups, providing the first evidence that 9 is unsymmetrical. In addition, examination of the coupling patterns revealed that the <sup>4</sup>J coupling constant formerly observed in 8b could not be detected in the spectrum for 9, indicating that the 2 and 4' positions (Scheme 4) were mutually occupied by a phenanthrene ring.[35] To gain further insight into the formation of 9, several experiments were undertaken. First, stirring ester 8b in the presence of DDQ afforded 9 in a poor 20% yield. Entries 9 and 10, however, clearly show the effect of the stoichiometry of the coupling promoter. When a 10 mmol solution of ester 8b in a mixture of dichloromethane and trifluoroacetic acid (9:1) was treated with 1.1 equivalents of VOF3, basic treatment yielded a mixture of compounds 7b/8b/9 in a 20:35:45 ratio, whereas the addition of an excess of VOF3 (entry 10) provided dimer 9 in a satisfactory 85% yield. Taken together, these results show that the chemical outcome of the oxidation process, can be controlled by the proper selection of the concentration, stoichiometry and chemical structure of the coupling agent.

Next, the synthesis of the expected bromides 11 proceeded by the hydride reduction of esters 8 followed by bromination of the intermediary alcohols 10 in the presence of  $PBr_3$  (Scheme 6). Bromide 11a was purified by slow crystallization in a dichloromethane/diethyl ether biphasic system, while its homologue 11b should be used rapidly due to a marked tendency to polymerize. [36]

Scheme 6. Synthesis of bromides 11. Reagents and conditions: a) LiAlH<sub>4</sub>, THF, 0 °C, then rt, 12 h; b) PBr<sub>3</sub>, DCM, 0 °C, then rt, 3 h.

#### Synthesis of alcohols 16.

With bromides **11** available in good yields, we turned to the synthesis of  $\alpha$ -aminonitriles **12** (Scheme 7). Thus, treatment of  $\alpha$ -aminonitriles **5** with LDA generated the corresponding nitrile anions, which readily displaced the primary bromide. The reaction was monitored by proton NMR spectroscopy, which clearly showed the disappearance of the diagnostic singlet signal at  $\delta$  = 4.99 ppm, which is easily attributed to the benzylic protons of bromides **11**. After an independent aqueous treatment, the reaction mixtures were stirred in diethyl ether for approximately 1 h to afford quaternary  $\alpha$ -aminonitriles **12** in yields ranging between 70% and 80%.

The reductive decyanation of  $\alpha$ -aminonitriles consists of the neat replacement of the nitrile group by a hydrogen atom. [37] In light of our previous experiences, this process can be efficiently performed by stirring a mixture of  $\alpha$ -aminonitrile **12a** and NaBH<sub>4</sub> in ethanol at ambient temperature for 12 h. After treatment, the expected tertiary amine **13a** was recovered in a poor 30% yield, and these findings suggest that the cleavage of the C–CN bond does not provide the intermediary iminium ion. However, rapid procedural optimization provided more consistent yields. Indeed, prolonged stirring of  $\alpha$ -aminonitrile **12a** in ethanol with a subsequent reflux period led to better results due to the presence of adventitious borane salts formed *in situ*. In this way, the hydride reduction of intermediary iminium salts bond was efficiently achieved, and compounds **13a** and **13b** were recovered in 83% and 75% yields, respectively.

The hydrogenolysis of simple benzylamines is a common process that is generally carried out at ambient temperature in the presence of various Pd/C or 20% Pd/(OH)<sub>2</sub> (Pearlman's catalyst) catalysts. The first experiment was carried out with Pearlman's catalyst (10% in mass) under a hydrogen pressure of 5 bars, with 13a as the substrate, which was dissolved in a 70:30 mixture of methanol and ethanol. The resulting suspension was stirred for 48 h, and after treatment, only the starting material was recovered. Prolonged stirring (up to 120 h) did not significantly modify the conversion. This result prompted us to examine alternate procedures and revealed that the best yields and reaction rates

were obtained when the reaction was carried out at 70 °C under the same hydrogen pressure within the same period of time. In this way, primary amines **14** were obtained cleanly and reproducibly in nearly quantitative yields and could be used in the next step without purification.

For our further synthetic purposes, we believe that the primary amine should be protected as an N-Boc group. This operation was carried out by simply stirring amines 14 in dichloromethane in the presence of one equivalent of  $Boc_2O$ , and carbamates 15 were obtained in high yields after chromatographic purification. In the next step, THP removal was carried out through an acetal exchange process by heating a methanolic solution of carbamates 15 at 50 °C in the presence of a catalytic amount of pyridinium p-toluene sulfonate (PPTS). In this case, the formation of primary alcohols 16 readily occurred without affecting nitrogen protection.

#### Synthesis of alkaloids 1 and 2.

Our operating strategy rested on the assumption that construction of the nitrogen-containing heterocyclic ring system of

alkaloids 1 and 2 should be carried through the displacement of a terminal leaving group by a nucleophilic nitrogen atom through favoured 5-exo-dig and 6-exo-dig ring-closure processes, respectively. We also postulated that such processes can be efficiently carried out upon deprotonation of carbamates 17 (Scheme 8). With these considerations in mind, the mesylation of alcohols 16 was efficiently accomplished in dichloromethane in the presence of triethylamine, and catalytic amounts (up to 20%) of dimethylaminopyridine and mesylates 17 were obtained in high yields after rapid chromatographic purification. Our initial cyclization procedure was carried out with mesylate 17a, which was treated with an excess (up to 5 equivalents) of NaH in DMF. After the evolution of hydrogen had ceased, the mixture was stirred for 12 h at ambient temperature. Unfortunately, the starting compound was recovered in nearly quantitative yield, and prolonged stirring did not modify the conversion. From the literature data this result was not predictable. [18c] and the presence of the tBu group may be responsible for a sterically encumbered environment between the mesyl group and the nitrogen atom.

Because it appeared to be difficult to cyclize carbamates 17, we reasoned that such operation can be efficiently carried out in the presence of a sterically less demanding primary amine. To this end, prolonged stirring of carbamates 17 in a 2 M HCl dioxane solution provided the expected hydrochlorides 18, which were isolated in quantitative yield after filtration over a sintered glass funnel. It is worth noting that these salts proved to be stable in a laboratory atmosphere and could be stored for months without loss of quality. The deprotonation sequence was carried out at

ambient temperature on a DCM suspension of each salt upon the addition of an excess of DIPEA to provide a clear solution that was stirred for an additional 12 h period. The cyclization was monitored by proton NMR spectroscopy and was judged to be complete after the disappearance of the singlet at  $\delta$  = 3.11 ppm, which is attributable to the terminal methane sulfonyl resonance signal. After one hour of stirring, it appeared that the cyclization process for hydrochloride **18b** was half-completed, whereas that for **18a** went to completion after a few minutes. Aqueous

treatment of the crude reaction mixtures and removal of DIPEA in excess, afforded secondary amines **19** in high yield.

Finally, the Pictet–Spengler annulation of both amines **19** was carried out according to a formerly reported procedure in which the amines were refluxed in formic acid in the presence of an excess of paraformaldehyde (up to 9 equivalents).<sup>[38]</sup> Under

these reaction conditions, the title alkaloids **1** and **2** were obtained in 95% and 86% yields, respectively, and the proton and carbon spectroscopy data were found to be consistent with that reported in the literature. [10a, 18c]

#### Conclusion

In summary, new and efficient syntheses for tylophorine and cryptopleurine, adaptable to the elaboration of a set of phenanthropiperidine alkaloids, were developed. The key steps involved a) a new utilization of the readily available dibenzylaminoacetonitrile in alkaloid synthesis, b) the unprecedented condensation of bromomethyl-phenanthrenes with metallated  $\alpha$ -aminonitriles, c) the efficacy of a 5- or a 6-exotet to form pyrrolidine or piperidine rings, and d) the general high yields of the reported processes. Further developments are in progress and will be reported in due course.

#### **Experimental Section**

#### General Techniques.

Purification by column chromatography was performed with 70–230 mesh silica gel. TLC analyses were carried out on alumina sheets precoated with silica gel 60 F254;  $R_{\rm I}$  values are given for guidance. The <sup>1</sup>H NMR spectra were recorded with a 500 MHz, a 400 MHz or a 300 MHz spectrometer. The <sup>13</sup>C NMR spectra were recorded with a 125 MHz, a 100 MHz or a 75 MHz spectrometer. Positive-ion mass spectra were recorded

on an orthogonal acceleration quadrupole time-of-flight mass spectrometer equipped with a standard electrospray probe. Melting points were measured on a Kofler apparatus, the values reported in °C, and were uncorrected. For air-sensitive reactions, the glassware was oven-dried (90 °C) for 24 h and cooled under a stream of argon before use. All commercially available reagents were used as supplied and THF was distilled over sodium benzophenone ketyl. Diisopropylamine was distilled from solid potassium hydroxide.

2-(3-lodopropoxy)tetrahydro-2H-pyran (3a). Step 1. Synthesis of 3iodopropan-1-ol. From an adapted procedure reported in the literature. [39] A 250 mL round-bottom flask, equipped with a reflux condenser and a magnetic bar, was flushed with argon and successively charged with 150 mL of acetone, 10.60 mL (12.00 g, 126.81 mmol, 1.0 equiv.) of 3chloropropan-1-ol and 28.50 g (190.14 mmol, 1.5 equiv.) of Nal. The resulting mixture was refluxed under argon for 72 h under a vigorous stirring. The resulting suspension was cooled to room temperature and sodium chloride (ca. 7.5 g) was removed by filtration over a fritted glassware. The filtrate was concentrated under reduced pressure and the resulting paste was taken-up with 150 mL of diethyl ether. The excess of Nal (ca. 8.5 g) was removed by a filtration on a fritted glassware and the ethereal solution was concentrated in vacuo to afford an oily brown residue (23.3 g) which was stirred for 30 minutes in a biphasic mixture of dichloromethane (150 mL) and water (100 mL) containing 3.0 g of sodium sulfite. The organic phase was dried over MgSO4, and concentrated to afford a slightly yellow oily residue which was distilled under reduced pressure (50 °C, 10<sup>-2</sup> mbar, 75.10<sup>-4</sup> Torr) to afford 21.90 g (93%) of 3iodopropan-1-ol as a colorless oil. R<sub>f</sub> = 0.50 (petroleum ether/diethyl ether, 50:50). <sup>1</sup>H NMR (CDCl<sub>3</sub>, 300 MHz)  $\delta$  = 1.71 (s, broad, 1 H), 2.04 (quint, J

From an adapted procedure reported in the literature. [40] A 200-mL, one necked Schlenk tube, fitted with a magnetic stirring bar, and connected to an argon inlet tube was successively charged with 50 mL of dichloromethane, 28.60 g (153.8 mmol, 1.0 equiv.) of 3-iodopropan-1-ol, 16.80 mL (15.57 g, 185.14 mmol, 1.2 equiv.) of 3,4-dihydro-2H-pyran and 2.85 g (11.34 mmol, 10% in mass, 7% in mole) of pyridinium ptoluenesulfonate (PPTS) and reaction mixture was stirred at room temperature for 24 h. The solvent was removed under reduced pressure and the material was taken-up in 100 mL of diethyl ether and stirred vigorously with an aqueous solution (0.1 M) of sodium sulfite for 30 minutes. The solvent was removed under reduced pressure and the crude reaction mixture was distilled under reduced pressure (65 °C, 10-2 mbar,  $75.10^{-4}$  Torr) to afford 36.50 g (88%) of iodide **3a** as a slightly yellow oil. The analytical data were in agreement with those reported in the literature.[41]

2-(4-lodobutoxy)tetrahydro-2H-pyran (3b). Protocol 1 (from 4chlorobutan-1-ol, 78% overall yield). From an adapted procedure reported in the literature. [42] A 250 mL round-bottom flask, was successively charged with 120 mL of dichloromethane, 4.60 mL (5.00 g, 46.10 mmol, 1.0 equiv.) of 4-chlorobutan-1-ol, 5.03 ml (4.66 g, 55.43 mmol, 1.2 equiv.) of 3,4dihydro-2H-pyran, 0.92 g (3.66 mmol, 8% in mole) of pyridinium ptoluenesulfonate (PPTS) and the resulting mixture was stirred at ambient temperature for 24 h. The organic phase was stirred with 100 mL of water for 15 minutes and the organic phase was dried over MgSO<sub>4</sub>, and concentrated to afford 8.45 g (95%) of 2-(4-chlorobutoxy)tetrahydro-2Hpyran as a slightly yellow oil which was used in the next step without purification. <sup>1</sup>H NMR (CDCl<sub>3</sub>, 300 MHz)  $\delta$  = 1.50–1.95 (m, 10 H), 3.59–3.54 (m, 2 H), 3.58 (t, J = 6.50 Hz, 2 H), 3.74 - 3.89 (m, 2 H), 4.58 (t, J = 3.0 Hz, 1 H). <sup>13</sup>C NMR (CDCl<sub>3</sub>, 75 MHz)  $\delta$  = 19.6 (s), 25.5 (s), 27.1 (s), 29.7 (s), 30.7 (s), 45.0 (s), 62.3 (s), 66.6 (s), 98.8 (t). A 250 mL round-bottom flask, equipped with a reflux condenser and a magnetic bar, was flushed with argon and successively charged with 190 mL of acetone, 8.00 g (41.52 mmol) of 2-(4-chlorobutoxy)tetrahydro-2H-pyran, 9.31 g (62.11 mmol, 1.5 equiv.) of Nal and 0.43 g (4.05 mmol, 0.10 equiv.) of sodium carbonate. The resulting mixture was refluxed under argon for 72 h under a vigorous stirring. The resulting suspension was cooled to room temperature and sodium chloride (ca. 3.4 g) was removed by filtration over a fritted glassware. The filtrate was concentrated under reduced pressure and the resulting paste was taken-up with 150 mL of diethyl ether. The excess of Nal (ca. 3.0 g) was removed by a filtration on a fritted glassware and the ethereal solution was stirred with 100 ml of water containing 5.0 g of sodium sulfite. The organic phase was dried over MgSO<sub>4</sub>, and concentrated to afford a slightly yellow oily residue which was poured into a chromatographic column prepared with 120 g of silica and 90:10 petroleum ether/ethyl acetate. The combined fractions were collected and concentrated to afford 9.60 g (81%) of iodide 3b as a slightly yellow oil. [43] A 200-mL, one necked Schlenk tube, fitted with a magnetic stirring bar, and connected to an argon inlet tube was successively charged with 115 mL of dry tetrahydrofuran and 1.79 g (47.31 mmol) of NaBH<sub>4</sub>. The flask was cooled to 0 °C, and 24.00 g (94.56 mmol) of iodine dissolved in 40 mL of tetrahydrofuran were added dropwise over a 1 h period. Stirring was continued for 24 h and the solution was poured in a mixture of dichloromethane (150 mL) and water (100 mL) containing  $5.0\ \mathrm{g}$  of sodium sulfite. The resulting biphasic system was stirred for 30

minutes and the organic phase was dried over MgSO<sub>4</sub> and concentrated to afford a crude residue which was distilled under reduced pressure (60 °C, 10<sup>-1</sup> mbar, 75.10<sup>-3</sup> Torr) to afford 14.0 g (37%) of 4-iodobutan-1-ol as a yellow oil.  $R_f = 0.50$  (petroleum ether/diethyl ether, 30:70). <sup>1</sup>H NMR (CDCl<sub>3</sub>, 300 MHz)  $\delta$  = 1.67 (quint, J = 5.90 Hz, 2 H), 1.92 (quint, J = 5.90 Hz, 2 H), 2.56 (s, 1 H), 3.24 (t, J = 6.70 Hz, 2 H), 3.67 (t, J = 6.70 Hz, 2 H). lodide 3b. The synthesis was as reported for the synthesis of 2-(4chlorobutoxy)tetrahydro-2H-pyran by stirring a mixture of 19.0 g (95.00 mmol, 1.0 equiv.) of 4-iodobutan-1-ol, 0.50 g (1.99 mmol, 2% in mole) of pyridinium p-toluenesulfonate (PPTS), 10.50 ml (9.73 g, 115.71 mmol, 1.2 equiv.) of 3,4-dihydro-2H-pyran, in 200 ml of dichloromethane for 24 h. Aqueous work-up followed by a chromatographic purification afforded 21.5 g (80%) of iodide 3b as a slightly colored viscous oil. Protocol 3 (from 1,4butanediol, overall 30% yield). A 250 mL round-bottom flask, was successively charged with 250 mL of dichloromethane, 9.83 mL (10.00 g, 111.26 mmol, 1.0 equiv.) of 1,4-butanediol, 2.79 g (11.10 mmol, 10% in mole) of pyridinium p-toluenesulfonate (PPTS) and 10.5 ml (9.73 g, 115.71 mmol, 1.0 equiv.) of 3,4-dihydro-2H-pyran. The resulting mixture was stirred at ambient temperature for 72 h. The solvent was evaporated and the crude reaction mixture was poured onto into a chromatographic column prepared with 100 g of silica and 50:50 petroleum ether/diethyl ether. The less polar 1,4-bis((tetrahydro-2H-pyran-2-yl)oxy)butane ( $R_f = 0.7$ ) eluted first, followed by 4-((tetrahydro-2H-pyran-2-yl)oxy)butan-1-ol which was obtained as a colorless oil (7.00 g, 35%). The analytical data were in agreement with those reported in the literature. [44] Synthesis of iodide 3b. A 200-mL, one necked Schlenk tube, fitted with a magnetic stirring bar, and connected to an argon inlet tube was successively charged with 150 mL of dichloromethane, 6.50 g (37.30 mmol) of 4-((tetrahydro-2*H*-pyran-2-yl)oxy)butan-1-ol, 5.00 g (73.44 mmol, 2.0 equiv.) of imidazole, 12.70 g (48.42 mmol, 1.3 equiv.) of triphenylphosphine. The resulting solution was cooled to 0 °C, then, molecular iodine (13.25 g, 52.20 mmol, 1.4 equiv.) were added portion wise over a 20 minutes period. The resulting orange solution was warmed up to ambient temperature and stirring was continued for 2 hours before the addition of 100 mL of water containing 3.5 g of sodium sulfite. The biphasic system was vigorously stirred for 30 minutes and the organic phase was washed with 50 mL of water (x 3), dried over MgSO<sub>4</sub> and concentrated to yield a colorless solid which was taken-up in a mixture (100 mL) of petroleum ether and diethyl ether (75:25) until the precipitation of triphenylphosphine oxide which was removed by filtration over a sintered glass filter. The filtrate was concentrated to yield (10.7 g) a colorless paste which was poured into a chromatographic column (30 x 2.5 cm, petroleum ether/diethyl ether 90:10) filled with 100 g of silica. The combined fractions were evaporated in vacuo at a temperature of 40 °C to afford 9.2 g (87%) of iodide 3b as a yellowish oil.

2-(Dibenzylamino)-acetonitrile, 4. From an adapted procedure reported in the literature.[22] An oven dried, 250-mL Schlenk tube, fitted with a magnetic stirring bar, was flushed with argon and was successively charged with 100 mL of acetonitrile, 39.0 mL (40.00 g, 202.83 mmol, 1.0 equiv.) of dibenzylamine, 15.30 mL (18.25 g, 241.77 mmol, 1.2 equiv.) of chloroacetonitrile, 42.40 mL (31.67 g, 245.05 mmol, 1.2 equiv.) of diisopropylethylamine (Hünig's base) and 2.00 g (5% in mass) of Bu<sub>4</sub>NI. The resulting homogeneous solution was stirred in the dark under an argon atmosphere for 72 h at room temperature. The solvent and the excess of diisopropylethylamine were removed under reduced pressure to afford an orange paste which was taken-up with 300 mL of diethyl ether until the complete precipitation of the diisopropylethylamine hydrochloride which was removed by filtration over a fritted glassware. The ethereal solution was stirred with 100 mL of a 0.2 M aqueous solution of sodium sulfite for 30 minutes, and dried over MgSO<sub>4</sub>. The solvent was evaporated under reduced pressure to afford a vellow paste (44.0 g) which was immediately dissolved in 200 mL of a mixture of petroleum ether/diethyl ether (9:1). The

resulting solution was kept at 5 °C for 24 hours until the complete crystallization of  $\alpha\text{-aminonitrile}$  **4** (38.0 g, 79%) which was obtained as beige flakes. The remaining solution was concentrated and the brown residue (*ca.* 5.0 g) was poured into a chromatography column (30 x 5.0 cm, petroleum ether/diethyl ether, 80:20). The combined fractions were evaporated to afford 4.2 g of  $\alpha\text{-aminonitrile}$  **4** in an overall 88% yield. #### 2-(Dibenzylamino)-5-((tetrahydro-2H-pyran-2-yl)oxy)pentanenitrile,

5a. New compound. An oven-dried, one necked 200-mL Schlenk tube, fitted with a magnetic stirring bar, connected to an argon inlet tube was flushed with argon and was successively charged with 20 mL of dry THF and 3.80 mL (2.73 g, 26.90 mmol, 1.35 equiv.) of diisopropylamine. The flask was then cooled to -80 °C (ethanol/liquid nitrogen bath) and 15.0 mL (24.00 mmol, 1.2 equiv.) of *n*-butyllithium (1.6 M in hexane) were slowly added to the previous solution. Stirring was continued for 30 min and the solution was stirred at 0 °C (ice bath) for an additional 30 minutes period at that temperature. The LDA solution was rapidly transferred (via a cannula) into a 200-mL Schlenk tube cooled to -80 °C containing 4.72 g (19.97 mmol, 1.0 equiv.) of  $\alpha$ -aminonitrile 4 dissolved in 30 mL of dry THF. The solution turned rapidly deep red and was allowed to warm to -30 °C for 1.5 hours and cooled to  $-80~^{\circ}\text{C}$ . Then, 5.90 g (21.84 mmol, 1.1 equiv.) of iodide 3a were added to the anion solution and the reaction mixture was warmed to 0 °C over a 1.5 hours period. The reaction was quenched by the addition of 10 mL of ethanol and the solvents were evaporated under reduced pressure to afford a yellow paste which was poured into a mixture of diethyl ether (100 mL) and water (50 mL). The ethereal layer was separated, dried over MgSO<sub>4</sub> and concentrated to afford a yellow viscous oil (6.95 g) which was dissolved in 10 ml of a 50:50 mixture of petroleum ether and diethyl ether and poured on a chromatography column (30 x 5.0 cm, petroleum ether/diethyl ether, 80:20) filled with 50 g of silica. 2-(Dibenzylamino)-6-((tetrahydro-2H-pyran-2-yl)oxy)hexanenitrile, 5b. New compound. The synthesis was as reported for 5a but with 4.68 g (19.80 mmol, 1.0 equiv.) of  $\alpha$ -aminonitrile 4 and 6.20 g (21.82 mmol, 1.1 equiv.) of iodide 3b as the alkylating agent. The crude oily residue (8.30 g) was diluted in 10 mL of a mixture or petroleum ether and diethyl ether (50:50) and poured into a chromatographic (30 x 5.0 cm, petroleum ether/diethyl ether, 70:30) filled with 50 g of silica. 2,3,6-Trimethoxy-11,12,13,14,14a,15-hexahydro-9H-dibenzo[f,h]pyrido[1,2-b]isoquinoline, cryptopleurine, 2. The synthesis of cryptopleurine was carried out according to the same procedure than that followed for tylophorine but with 0.15 g (0.41 mmol) of piperidine 19b, 2.5 mL of formic acid, and 0.12 g (4.00 mmol, 9.7 equiv.) of paraformaldehyde. After work-up, the crude reaction mixture was dissolved in 3 mL of dichloromethane and poured on a chromatographic column (30 × 2.0 cm) prepared with 10 g of silica, and 40:40:6 diethyl

ether/dichloromethane/methanol. The fractions were collected and concentrated to afford 0.13 g (86%) of cryptopleurine. Beige powder. Mp = 190 °C (dec.).  $R_{\rm f}$  = 0.5 (diethyl ether/dichloromethane/methanol, 45:45:7).

## **Entry for the Table of Contents**

Tylophorine (1) and cryptopleurine (2) were synthesized by the condensation of metallated  $\alpha$ -aminonitriles with bromomethylphenanthrenes to provide fully substituted  $\alpha$ -aminonitriles that are submitted to a reductive decyanation to form homobenzylic amines. From these intermediates, the E-and D-rings of alkaloids 1 and 2 were formed through the displacement of a terminal leaving group and by a late Pictet-Spengler condensation, respectively.
