- 10 Abstract

11 Infinite dilution thermodynamic properties of organic solutes dissolved in four 12 bis(sulfonyl)imide ionic liquids namely 1-butyl-1-methylpyrrolidynium bis(fluorosulfonyl)imide, N-propyl-N-methylpyrrolidynium bis(fluorosulfonyl)imide, 1-ethyl-13 14 1-methylimidazolium bis(fluorosulfonyl)imide and 1-methyl-1-propylpiperidinium bis(fluorosulfonyl)imide were measured in a large range of temperature using inverse gas 15 16 chromatography. The characterization of ILs using the Abraham solvation model indicates 17 that the cation has an impact on the polarizability and on the acidity of the solvent. The 18 derived Abraham model correlations rigorously describe the experimental partition coefficient 19 data to within 0.09 (or fewer) log units. In addition, the activity coefficient at infinite dilution 20 of organic solutes in these ILs were predicted using the conductor-like screening model for 21 real solvents (COSMO-RS). It was found that COSMO-RS give a reasonable representation 22 of experimental data. Then, selectivity and capacity at infinity dilution have been determined 23 for the separation problems (thiophene/water), (benzene/water), (acetone/water), (1butanol/water), (acetonitrile/water) and (pyridine/water) at 323.15 K. 24

#### 1 Introduction

2 Ionic liquids were found to be efficient solvents for different numerous separation problems
3 present in industrial processes.

4 This last decade, environmental laws impose a strong reduction of industrial discharge but 5 also enforce a "zero discharge" policy for certain pollutants that are known or suspected to be 6 persistent bioaccumulative. In chemical industry, the main separation and purification 7 processes are based on liquid-liquid extraction. This technique easy to implement has the 8 main drawback to use volatile and toxic organic solvents. In view of the current situation, 9 industrials and scientists have to rethink industrial manufacturing processes. One key should 10 be the use of cleaner extraction solvents in future extraction processes. Ionic liquids can be 11 described as the LEGO Molecules for Chemists while their physico-chemical properties are 12 adjustable by choosing an appropriate set of ions. [1-2] Nevertheless, this family of solvents 13 has also some disadvantages such as high viscosity, thermal instability and especially 14 significant toxicity. [3] Indeed, it is now well established that numerous ILs are toxic in nature 15 and their toxicities strongly depend on their structure. It was found that the anion has not an 16 important impact excepted for [Tf<sub>2</sub>N]. [4-5] ILs with long alkyl chain length have significant 17 toxicity that may be reduced by introducing functional polar groups to this chain. From 18 toxicology and microbial degradation points of view, pyridinium ILs are more environmental 19 friendly than imidazolium ILs.

The use of ILs still required physico-chemical properties measurement for a better understanding of these solvents in solution but also the implementation of new quantitative properties-structure relationships. Our team have determined the activity coefficients at infinite dilution of solutes dissolved in several 1,3-dialkylimidazolium [6–16], tetraalkylammonium [17-18], N-alkylpyridininium [16], N,N-dialkylpyrrolidinium [19-20], N,N-dialkylpiperidinium [14,15], tetraphosphinium [21,22], N-alkylquinuclidinium [23], and

1 1,2,3-tris(diethylamino)- cyclopropenylium [24] ILs. Our previous contributions 2 demonstrated that numerous ILs could replace conventional fluids in desulfurization or 3 denitrogenation processes in petroleum industry but also in liquid-liquid extraction of organic 4 compounds from various media. For example, bis (trifluoromethylsulfonylm)imide, 5 hexafluorophosphate and bis(fluorosulfonyl)imide based ILs were found to be efficient for the 6 extraction phenols [25-27], phenolic acids [28], carbohydrates [29-30], caprolactam [31], 7 furfural [32-33], other organic compounds [34-35] from aqueous solution and the recovery of 8 rare earth elements (36). Domanska et al have demonstrated that ILs such as trihexyl-9 tetradecyltricyanomethanide 1-decyl-3phosphonium [P<sub>6,6,6,14</sub>][TCM] [37], 10 methylimidazolium tetracyanoborate [DMIM][TCB] [38], 11 dimethyldodecylphenoxyethylammonium dicyanamide [N<sub>1,1,12,20Ph</sub>][DCA] and 12 dimethyldodecylphenoxyethylammonium bis{(trifluoromethyl)sulfonyl}imide  $[N_{1,1,12,20Ph}]$ 13 [Tf<sub>2</sub>N] [39] present a specific interest for the extraction of butanol from aqueous solution.

In this work, activity coefficients of organic compounds and water in 1-butyl-1-15 16 methylpyrrolidynium bis(fluorosulfonyl)imide [BMPyr][FSI], Ν Ν propyl 17 methylpyrrolidynium bis(fluorosulfonyl)imide [PrMPyr][FSI], 1-ethyl-1-methylimidazolium 18 bis(fluorosulfonyl)imide [EMIM][FSI] and 1-methyl-1-propylpiperidinium 19 bis(fluorosulfonyl)imide [MPrPip][FSI] were measured by inverse gas chromatography in a 20 range of temperature from 323.15 K to 373.15K. The molecular structures of these ILs studied 21 in this work are given in Table 1. To our knowledge, only one chromatographic study was 22 published on this family of ionic liquids [40]. Experimental data were compared with results 23 obtained using COSMO-RS. Then, experimental gas-to-IL partition coefficients were 24 correlated using the Linear Solvation Energy Relationship.

#### 2 **2. Experimental Methods**

#### 3 2.1. Ionic liquid synthesis and solute probes

4 1-butyl-1-methylpyrrolidynium bis(fluorosulfonyl)imide [BMPyr][FSI], N-propyl-N-5 methylpyrrolidynium bis(fluorosulfonyl)imide [PrMPyr][FSI], 1-ethyl-1-methylimidazolium 6 bis(fluorosulfonyl)imide [EMIM][FSI] and 1-methyl-1-propylpiperidinium 7 bis(fluorosulfonyl)imide [MPrPip][FSI] were purchased from Solvionic with a purity of 8 99.9% (mass percent). Test solutes were purchased from Sigma-Aldrich at a purity 99.5% 9 (mass percent) and were used without further purification.

#### 11 **2.2.** *Vibrating-tube densimeter and density measurement*

Densities of the ILs were measured using an Anton Paar DMA<sup>TM</sup> 4500 M digital vibrating-tube densimeter in the temperature range from 293.15 to 393.15 K at atmospheric pressure. The detailed procedure was given in our previous work [6-9]. All experimental data are given in Table 2.

#### 17 **2.3.** Chromatographic instrumentation and experimental procedures

Thermodynamic properties at infinite dilution were determined using procedures 18 19 described in previous works [6-9]. In summary, the measurements were conducted by using a 20 Bruker 450 gas chromatograph equipped with a heated on-column injector, a thermal 21 conductivity detector (TCD) and a flame ionization detector (FID). The injector and detector 22 temperature was fixed at 250°C. Helium carrier gas flow rate was measured using an Alltech 23 Digital Flow Check Mass Flowmeter. The temperature of the oven was measured with a Pt 24 100 probe and controlled to within 0.1 K. Retention data were collected and treated with 25 Galaxie software.

1 The preparation of the packed columns was described in detail in our previous articles 2 [1-20]. Packed columns of 1-meter length containing between 30 and 50% IL stationary phase 3 coated onto an 80-100 mesh Chromosorb WHP support material were prepared by a rotary evaporation method. Briefly, IL was dissolved in ethanol in the presence of a precise mass of 4 5 Chromosorb WHP. Ethanol was then removed from the mixture using rotary evaporation. The 6 support was equilibrated at 343 K under vacuum during 6 h. Then, the conditioning of the 7 packed columns was performed at 373 K over 12 h using a gas flow rate of 20 cm<sup>3</sup> min<sup>-1</sup>. The 8 estimated uncertainty for activity coefficients was 3%, taking into account the possible 9 uncertainties in determining the retention data, the solute thermodynamic properties, and the column loading. 10

#### 12 **3.** Theoretical Basis for Thermodynamic Quantities

13 Retention data were used to calculate the activity coefficient at infinite dilution of 14 solute 1 in IL 2 ( $\gamma_{1,IL}^{\infty}$ ) using the following expression [41-43]:

16 where  $n_{\rm IL}$  is the mole number of the IL stationary phase component inside the column, *R* is the 17 ideal gas constant, *T* denotes the temperature of the oven, V<sub>N</sub> is the net retention volume,  $B_{11}$ 18 refers to the second virial coefficient of the solute in the gaseous state at temperature T,  $B_{13}$ 19 represents the mutual virial coefficient between the solute 1 and the carrier gas helium 20 (denoted 3), and  $P_1^{0}$  is the probe vapor pressure at temperature *T*.

The gas-to-IL partition coefficients *K* used in the LSER model were calculated from
activity coefficients at infinite dilution using Eq. 2:

3 From the  $\gamma_{1,IL}^{\infty}$  values, the partial molar excess enthalpy,  $\Delta H_1^{E,\infty}$  and entropy at infinite dilution 4  $\Delta S_1^{E,\infty}$  can be calculated assuming a van't Hoff relation holds:

8 It follows from Eq. (3) that if the logarithm of the activity coefficient at infinite dilution is 9 plotted against 1/T, a straight line having a slope of  $\Delta H_1^{E,\infty}/R$  and an intercept of  $\Delta S_1^{E,\infty}/R$ 10 is obtained.

11 The solubility parameter of the ionic liquid,  $\delta_2$ , can be calculated using the following 12 equation [43]:

15 Where  $\chi_{12}^{\infty}$  characterizes interactions between the solute and the stationary phase,  $\delta_1$  and  $\delta_2$ 16 are solubility parameters of the solute and of the ionic liquid, respectively. If the left-hand 17 side of the equation (4) is plotted against  $\delta_1$ , a straight line having a slope of  $2\delta_2 / RT$  and an 18 intercept of  $-\delta_2^2 / RT$  is obtained. The solubility parameter of the ionic liquid,  $\delta_2$ , can be 19 calculated from the slope or the intercept of the straight line.

#### 21 **3.1 Linear Solvation Energy Relationship Model.**

22

Linear Solvation Energy Relationship (LSER) model developed by Abraham et al. is a useful
tool for the characterization of stationary phases and their interaction with solutes. [45-48]
The original version of LSER model thermodynamic properties related to Gibbs free energy.

In this study, retention data are used to calculate the gas-to-IL partition coefficients, *K*. The
most recent representation of the LSER model is given by Eq. (5):

6 The capital letters represent the solutes properties and the lower case letters the complementary properties of the ionic liquids. The solute descriptors are the excess molar 7 8 refraction E, dipolarity/ polarizability S, hydrogen bond acidity basicity, A and B, 9 respectively, the gas-liquid partition coefficient on n-hexadecane at 298 K, L. These solute 10 descriptors of about 4000 were measured using experimental procedure or calculated using group contribution. [45-52] The coefficients  $c_{IL}$ ,  $e_{IL}$ ,  $s_{IL}$ ,  $a_{IL}$ ,  $b_{IL}$  and  $l_{IL}$  are not simply fitting 11 12 coefficients, but they reflect complementary properties of the solvent phase. All solute 13 descriptors used in this work are given in Table 1S supporting information.

#### 16 **4. Results and Discussion**

#### 17 **4.1** Activity coefficients at infinite dilution

The  $\gamma_i^{\infty}$  values of selected organic compounds and water in the four bis(fluorosulfonyl)imide 18 19 based ILs are given in Tables 3-6. The behavior of solutes with [FSI] based ILs are guite 20 similar than those observed in previous works on other ILs. In homologous series, the 21 solubility of compounds decreases with an increase of the chain length. In this work, this 22 trend is observed with alkanes or alkanols. Then, the solubility of solutes is related to their 23 polarity and their capacity to form hydrogen bond. Compounds containing nitro functionals 24 group (see nitroalkanes), cyano group (acetonitrile), carbonyl group, dioxane tetrahydrofuran 25 and pyridine have a good solubility in [FSI] based ILs. As expected, the lowest solubility in

1 [FSI] based ILs is observed with the heaviest apolar compounds, tetradecane at 323K (  $\gamma_i^{\infty}$ =570.25 in N-propyl-N-methylpyrrolidynium bis(fluorosulfonyl)imide, 362.56 in 1-butyl-2 1-methylpyrrolidynium bis(fluorosulfonyl)imide at 333.15K, 501.54 in 1-methyl-1-3 4 propylpiperidinium bis(fluorosulfonyl)imide at 323.15K and 1135.03 in 1-ethyl-1-5 methylimidazolium bis(fluorosulfonyl)imide. Figure 1 presents activity coefficients at infinite 6 dilution of benzene, 1-propanol, thiophene, butanone and water in [EMIM][FSI] studied in 7 this work. The solubility of alkanes, alkenes, alcohols and water increases with an increase of 8 temperature. The opposite trend is observed with the other polar compounds studied in this 9 work.  $[Tf_2N]$  and [FSI] anions are two anions with quite similar structures. From previous 10 works [19,53], we can conclude that the solubility of organic compounds is more important in 11 dialkylimidazolium [Tf<sub>2</sub>N] than in dialkylimidazolium [FSI]. The tendency is reversed with 1-Alkyl-1-methylpyrrolidinium cations. As expected, an increase of the alkyl chain length 12 13 increases the hydrophobicity of ILs. This behavior is observed with dialkylpyrrolidinium 14 based ILs. [19-20] Activity coefficients of various organic compound on 1-butyl-1methylpyrrolidynium bis(fluorosulfonyl)imide were published recently by the team of 15 16 Domanska [40]. A deviation of about 16% is observed between data published previously and 17 this work at 353.15K. The largest deviations are observed with light alkanes. In all cases,  $\gamma_i^{\infty}$  values measured in this work are smaller than those measured by Domanska and 18 Karpinska. This difference may be explained by the different purity of the ionic liquid used in 19 20 both studies. Full data are given in Table 2S.

The partial molar excess Gibbs free energy  $\Delta G_1^{E,\infty}$ , enthalpy  $\Delta H_1^{E,\infty}$  and entropy  $\Delta S_1^{E,\infty}$  at infinite dilution for 51 solutes in [FSI] ionic liquids at 323.15 K are given in Tables 3S-5S. [FSI] based ILs behave similarly than other [Tf<sub>2</sub>N] based ILs. [6,7] Indeed, numerous binary mixtures {organic compound+[FSI] IL} present a positive deviation from Raoult's. Few exceptions are observed with light ketones (acetone and 2-butanone) and acetonitrile for all

[FSI] ILs and 1,4- dioxane, chloroform, dicholoromethane, nitromethane, thiophene and 1 tetrahydrofuran excepted for [EMIM]. The largest negative values of  $\Delta G_1^{E,\infty}$  (negative 2 deviations from Raoult's law) was found for acetonitrile (-1.81 kJ·mol<sup>-1</sup>for [PrMPyr][FSI], -3 1.73 kJ·mol<sup>-1</sup> for [EMIM][FSI], 1.64 kJ·mol<sup>-1</sup> for [BMPyr][FSI] and -1.53 kJ·mol<sup>-1</sup> for 4 [MPrPip][FSI]). As expected, the largest positive deviations ( $\Delta G_1^{E,\infty} > 0$ ) are obtained with 5 alkanes (17.05 kJ·mol<sup>-1</sup> for [PrMPyr][FSI], -18.9 kJ·mol<sup>-1</sup> for [EMIM][FSI], 16.7 kJ·mol<sup>-1</sup> for 6 [MPrPip][FSI]). The positive  $\Delta H_1^{E,\infty}$  values observed with alkanes, alkenes, alkynes, CCl<sub>4</sub>, 7 8 trimethylamine and water indicates that these compounds have no particular affinity with [FSI] based ILs. Then, the positive  $T\Delta S_1^{E,\infty}$  values observed with alcohols and water confirm 9 their weak interaction with the IL. 10

#### 13 **4.2 Selectivity and capacity**

The selectivity  $s_{12}^{\infty} = \gamma_{13}^{\infty} / \gamma_{23}^{\infty}$  and capacity  $k_2^{\infty} = 1 / \gamma_{23}^{\infty}$  of ILs studied in this work but 14 15 also others published in the literature [53-67] are presented in Table 7 for separation problems 16 of organic compounds from aqueous solution such as thiophene (1)/water (2), benzene (1)/water (2), Acetone (1)/water (2), 1-butanol (1)/water (2), acetonitrile (1)/water (2) and 17 pyridine (1)/water (2) at 323.15 K. In the case of the extraction of thiophene from aqueous 18 solution, the  $s_{12}^{\infty}$  values obtained with ILs range from 0.22 to 12.01 while the  $k_2^{\infty}$  values vary 19 20 between 0.79 ([BMPYR][FAP]) to 1.55 ([EMIM][FAP]). It seems to be difficult to propose a relationship between selectivity and the cation. Indeed, the  $s_{12}^{\infty}$  values obtained increase 21 22 according to [EMIM]<[PrMPyr]<[BMPyr]<[MPrPip] with [FSI] ILs, [BMPyr]< [EMIM] 23 with [FAP] ILs and [BMPyr]<[MPrPip] with [Tf<sub>2</sub>N]. Analysis of results concerning the 24 separation of benzene from aqueous solution shows that the worst performing ILs is [EMIM][SCN] ( $s_{12}^{\infty} = 0.08$  and  $k_2^{\infty} = 0.29$ ) and the more efficient appears to be 25

1 [EMIM][FAP] ( $s_{12}^{\infty} = 12.89$  and  $k_2^{\infty} = 1.66$ ) in term of selectivity and [EMIM][FSI] ( $s_{12}^{\infty} = 2.8$  and  $k_2^{\infty} = 1.75$ ) in term of capacity. [FSI] ILs present the largest selectivity values with 3 the separation problems related to acetone and acetonitrile.

As shown in table 7, the largest values of selectivity for the most separation problems studied in this work were obtained with [EMIM][FSI]. ILs constitutes of [FSI] anion and an appropriate cation should be potentially suitable solvents for the separation of the organic compounds from water in comparison with other ILs.

#### 9 4.3 COSMO-RS model.

10 Klamt and his coworkers modified the dielectric continuum solvation methods used in 11 quantum chemical to propose the conductor-like screening model (COSMO). The conductor-12 like screening model for real solvents (COSMO-RS) is the extension of COSMO beyond the 13 dielectric limits. This approach combines statistical thermodynamics and the COSMO quantum chemical calculations to evaluate thermodynamic properties. [69-72] The power of 14 COSMO-RS is its good ability to predict the thermodynamic properties of compounds 15 16 without the need of experimental data. The COSMO-RS model was found to be suitable for 17 the estimation of physico-chemical properties of pure ILs, deep eutectic solvents but also their 18 phase diagrams with organic solvents [84-87]. In this study, all calculations were performed 19 using the COSMOtherm package [73] purchased from COSMOlogic GmbH & Co. KG (Leverkusen, Germany). The conformations and COSMO files of bis(fluorosulfonyl)imide 20 21 anion. 1-ethyl-3-methylimidazolium, N-propyl-N-methylpyrrolidynium, 1-butyl-1-22 methylpyrrolidynium, 1-methyl-1-propylpiperidinium and all the solutes come from 23 COSMObaseIL and COSMObase BP\_TZVP\_FINE\_COSMO\_C30\_1601 compilation, 24 respectively. Activity coefficients at infinite dilution of organic compounds and water in the 25 four [FSI] ILs studied in this work were predicted using COSMO-RS in the range of temperature from 323.15 K to 373.15 K. All results are presented in Table 6S-9S. The
 predictive power of COSMO-RS model is evaluated through the average absolute relative
 deviation (AARD) and the root mean square error (RMSE) defined as:

9 AARD and RMSE values obtained for all solutes and selected families of compounds in the 10 four ILs studied are given in Table 8. Results obtained on bis(fluorosulnyl)imide ILs are of 11 the same magnitude as those obtained on other families of ILs. [87] The best results are 12 obtained with [MPPip][FSI] with an AARD of 18.52%. Nevertheless, it is important to mention that  $\gamma_{1,IL}^{\infty}$  values of dichloromethanes are poorly predicted (AARD = 201.09%). 13 Concerning [FSI] ILs, large AARD is observed with aromatics and dichloroalkanes. Figure 2 14 shows that COSMO-RS approach is not efficient for the prediction of  $\gamma_{1,IL}^{\infty}$  of heavy apolar 15 16 compounds.

17 Conformations of molecules also play an important role in the quality of COSMO-RS 18 prediction. In Cosmotherm, bis(fluorosulfonyl)imide anion has 1 conformer while [EMIM], 19 [MPPyr] and [BMPyr] cations are represented by 3, 2 and 2 conformers, repectively. 20 Therefore, an IL is represented as a mixture of different IL molecule conformers in COSMO-21 RS. The impact of the cation and the solute conformations on the prediction of  $\gamma_{1,IL}^{\infty}$  of 22 selected solutes are presented in Table 10S. Analysis of results led to the conclusion that the 23 best predictions are obtained when the most stable conformation of the cation is used.

4.4 Solubility parameters. The solubility parameters  $\delta_2$  of the four ionic liquids studied in 1 this work are listed in Table 9. It was found that temperature has no a significant influence on 2 3  $\delta_2$ . Therefore,  $\delta_2$  values given in Table (9) are average values obtained between 323.15 and 373.15 K. Analysis of results show that the solubility parameters of [FSI] based ILs decrease 4 5 in the following order: [EMIM] > [PrmPyr] > [BmPyr] > [MPrPip]. This suggests that solubility parameter values are directly related to the size of the ILs. According to 6 Marciniak's works [89-90], solubility parameter values of ILs vary from 17.9 MPa<sup>1/2</sup> for 7 [OMIM][Cl] to 30.7 MPa<sup>1/2</sup> for [BMPIP][SCN]. In this work, the highest value of  $\delta_2$  was 8 9 observed with the [EMIM] cation, while the minimum was obtained with [MPrPip]. This confirms a significant influence of the cation on the solubility parameters. From the  $\delta_2$  values, 10 11 standard enthalpy of vaporization ( $\Delta_{vap}$ H) at 298 K were estimated using equation (8):

14 Where v is the molar volumes of the IL determined from densities given in Table 2. The 15 calculated  $\Delta_{vap}$ H values from retention data but also from molecular dynamic are listed in 16 Table 9. [88] [PrmPyr] [FSI], [BmPyr] [FSI] and [MPrPip] [FSI] have quite similar  $\Delta_{vap}$ H 17 values and [EMIM] cation presents a lowest average  $\Delta_{vap}$ H value of 140.4 kJ·mol<sup>-1</sup>. The 18 difference observed between experimental values and those calculated from molecular 19 dynamic for [PMPyr][FSI] and [EMIM][FSI] are 9.2 and 5.8 kJ·mol<sup>-1</sup>, respectively.

#### 21 **4.5 LSER characterization.**

The gas-to-IL partition coefficients  $K_L$  of solutes in ILs required for the LSER model were calculated using equation 2. All data are presented in Table 11S-14S. The coefficients  $c_{IL}$ ,  $e_{IL}$ ,  $s_{IL}$ ,  $a_{IL}$ ,  $b_{IL}$  and  $l_{IL}$  coefficients describing the ILs obtained by multiple linear regression of log K<sub>L</sub> of organic compounds are given in Table 10. Large squared correlation coefficients ( $R^2$ ) and Fischer F-statistic values with small deviation (SD) indicate that LSER correlations are able to estimate log K of organic compounds in these four [FSI] ILs. The quality of correlations obtained for the four ILs studied in this work at 323.15 K is illustrated in Figure 3.

6 Analysis of LSER characterization of the four ionic liquids studied in this work points out that 7 the dipolarity  $(s_{IL})$  and hydrogen bond basicity  $(a_{IL})$  are quite similar for these four [FSI] ILs. 8 This observation indicates that the cation and the alkyl chain length have weak impact on the 9 basic character and the polarity of [FSI] ILs. The polarizability expressed by the  $e_{IL}$  parameter 10 in LSER model is strongly sensitive to the structure of the IL. As an example, changing 1methyl-1-propylpiperidinium by 1-butyl-1-methylpyrrolidinium leads to a  $\Delta e_{IL}$  of 0.115. The 11 12 hydrogen bond acidity of bis(fluorosulfonyl)imide based ILs is also strongly depending on the 13 structure of the solvent. Results indicate that the highest hydrogen-bond acidity value is 14 observed with imidazolium based ionic liquid. In this work, the acidity of FSI ILs decreases 15 according to [EMIM]>[MPrPip]> [PrMPyr]> [BMPyr]. It can be noted that  $b_{IL}$  parameter 16 values are inversely proportional to the alkyl chain length. The  $l_{IL}$  parameter values of ILs are 17 ranking to their size: [MPrPip]> [BMPyr]> [PrMPyr]> [EMIM]. The increasing of the 18 temperature in gas chromatography reduces the retention times of solutes and their 19 interactions with the stationary phase (here IL). Figure 4 shows that there are linear 20 relationships between LSER parameters and the temperature. Therefore, we can propose 21 temperature dependent LSER model in which  $c_{IL}$ ,  $e_{IL}$ ,  $s_{IL}$ ,  $a_{IL}$ ,  $b_{IL}$  and  $l_{IL}$  can be expressed as 22 followed:

1 The constants  $x_0$  and  $x_1$  for each LSER coefficients are given for the four ILs studied in this 2 work in Table 11. Low standard deviation on logarithm of partition coefficients obtained 3 using the temperature dependent LSER model indicates that these correlations could be used 4 to predict logK of volatile organic compounds not taken into account in the databank.

In Table 12, LSER parameters of ILs studied in this work and published in the literature [11,12,14,74,75,77,79-83] are given at 323K. The LSER parameters of ILs are ranged  $0 < e_{IL} < 0.86$ ;  $0 < s_{IL} < 5.15$ ;  $0.91 < a_{IL} < 7.27$ ;  $0 < b_{IL} < 1.81$  and  $0.35 < l_{IL} < 1.51$ . Compared to the scales of LSER parameters, we can conclude that [FSI] ILs are moderately polar and basic (  $e_{IL}$ ,  $s_{IL}$  and  $a_{IL}$  of about 0.25, 2.5 and 2.2, respectively). It is also important to note that [FSI] ILs have low acidity.

#### 12 **5. Conclusion**

13 this 1-butyl-1-methylpyrrolidynium In work, four [FSI] based ILs namely bis(fluorosulfonyl)imide, N-propyl-N-methylpyrrolidynium bis(fluorosulfonyl)imide, 1-ethyl-14 15 1-methylimidazolium bis(fluorosulfonyl)imide 1-methyl-1-propylpiperidinium and 16 bis(fluorosulfonyl)imide characterized gas were using inverse chromatography. Thermodynamic properties at infinite dilution ( $\gamma_i^{\infty}, \Delta G_1^{E,\infty}, \Delta H_1^{E,\infty}$  and  $\Delta S_1^{E,\infty}$ ) calculated 17 18 from retention data for 51 solutes in these ILs allow having a better understanding of solute-19 IL interactions. LSER analysis have shown that the dipolarity and hydrogen bond basicity of 20 [FSI] ILs are not affected by the cation and/or the alkyl chain length. However, the polarizability is strongly sensitive to the structure of the IL. The predicted  $\gamma_i^{\infty}$  values by 21 22 COSMO-RS model are in good agreement with our experimental data for light compounds. It 23 must be pointed out that the best results are obtained with the lowest energy conformations of 24 the cation and of the solute. In the end, [FSI] based ILs appear to be efficient solvents for the extraction polar organic compounds from aqueous solution. 25
