Abstract

Since the DeepWater Horizon oil spill and the use at 1450m depth of dispersant as a technical response, the need of relevant ecotoxicological data on deep-sea ecosystems becomes crucial. In this context, this study focused on the effect of high hydrostatic pressure (10.1 MPa) on turbot hepatocytes isolated from fish exposed either to chemically dispersed oil, mechanically dispersed oil or dispersant alone. Potential combined effects of oil/dispersant and hydrostatic pressure, were assessed on cell mortality (total cell death, necrosis and apoptosis), cell viability and on hepatocyte oxygen consumption (MO₂). No change in cell mortality was observed in any of the experimental conditions, whereas, the results of cell viability showed a strong and significant increase in the two oil groups independently of the pressure exposure. Finally, oil exposure and hydrostatic pressure have additive effects on oxygen consumption at a cellular level. Presence of dispersant prevent any MO₂ increase in our experimental conditions. These mechanistic effects leading to this increased energetic demand and its eventual inhibition by dispersant must be investigated in further experiments.

1. Introduction

Deep-seas above 1000m depth represent the large majority of the biosphere (Jannasch & Taylor, 1984) and have been out of reach for human kind for centuries. This situation is changing, the exploitation of deep-seas is now technically feasible and starts to be economically relevant. In particular, offshore deep-water areas represent an increasing part of the new oil exploration/production areas (Maddahi & Mortazavi, 2011). Discharge of chemicals, whether chronical or accidental, could upset the balance of these sensitive ecosystems. Therefore, there is a need to increase available relevant data offering a better understanding of potential environmental risks of anthropic activities in deep-sea areas (Mestre *et al.*, 2013).

The example of the *Deepwater Horizon* accident in the Gulf of Mexico in April 2010, one of the largest oil spills in the history, has been the most striking demonstration of this need. During this accident, about 780 000 m³ of oil were released into the environment at 1500 meters depth (Griffiths, 2012), and for the first time, dispersant (7 000m³) was injected directly in the deep-sea environment (Kujawinski *et al.*, 2011) to limit the rise of oil to the surface. Since dispersants are designed in order to be used on an oil slick at the sea surface to stabilize the oil in the water as a plume of droplets, their effects in deep-seas are clearly missunderstood.

Additionally to in-field ecological studies, experimental approaches in laboratory can provide relevant data to assess and understand the new field of deep-sea ecotoxicology. Even if, to date, few data are available, several approaches can be used to explore this new topic (Lemaire *et al.*, 2017). One of this approach is to study the impact of contaminants at atmospheric pressure on piezotolerant species.

This type of study has already been carried out on three cold-water coral species: Paramuricea sp., Callogorgia delta and Leiopathes glaberrima (DeLeo et al., 2016) or on a giant benthic amphipod Eurythenes gryllus (Olsen et al., 2016). Nevertheless, in order to have a better understanding of the potential impact of a chemical in deepsea environment, it is necessary to develop experimental protocols that reproduce as closely as possible the preponderant abiotic parameters of this area, and in particular the hydrostatic pressure (HP). The piezoecotoxicology also called ecobarotoxicology, i.e. the use of hyperbaric chamber to assess the potential impact of chemicals at simulated depth, offers a relevant way to understand this new domain of ecotoxicology. This approach has been applied on several classes such as the polychaete *Pomatoceros lamarcki* (Vevers et al., 2010), the marine shrimp *Palaemon* varians (Domingues, 2015), the mussel Mytilus galloprovincialis (Pinheiro et al., 2019) or different fish species: Pagellus bogaraveo (Kopecka-Pilarczyk & Coimbra, 2010a); Anguilla Anguilla (Kopecka-Pilarczyk & Coimbra, 2010b); Dicentrarchus labrax (Dussauze et al., 2017; (Lemaire et al., 2016) or Scophthalmus maximus (Dussauze et al., 2016) at pressures ranging from 10 to 40 MPa. An in vitro approach has also been applied exposing liver slices of rock grenadier Coryphaenoides rupestris to 0.1, 5 and 15 MPa (Lemaire et al., 2012). However, as far as we know, the use of isolated cells for piezoecotoxical studies has not been explored yet.

In this context, and in order to increase our understanding of the combined effects of oil/dispersant and hydrostatic pressure, this study focused on the effect of a 10.1 MPa exposure on turbot hepatocytes isolated from fish exposed either to chemically dispersed fuel oil, mechanically dispersed oil or dispersant alone. The main objective of this study is to assess the effects of these chemicals on hepatocyte

oxygen consumption (MO₂) under high hydrostatic pressure. In order to be able to link a potential modification of MO₂ with cellular mortality, cell viability was evaluated using two classical methods after the pressure exposure.

2. Materials and Methods

This experiment followed the subsequent steps: 1/ animal contamination, 2/ hepatocyte isolation, 3/ cell exposure to high hydrostatic pressure and finally 4/ biological analyses.

2.1 Fish contamination

2.1.1 Animals

Juvenile turbot (*Scophthalmus maximus*, n=32, weight from 150 to 200g) used in this experiment were hatched in the aquaculture facility of *France turbot* (Trédarzec, France). In the laboratory, fish were acclimatized in a 300 L seawater tank for two weeks. Photoperiod was according to the season (12:12). Oxygen saturation (> 90%), pH (8.10 \pm 0.16) and temperature (maintained at 17°C) were measured daily. Turbots were fed daily with dried commercial pellets provided by the hatchery. The experiments have been validated by the local Ethic Committee and authorized by the french "Ministère de l'Enseignement Supérieur et de la Recherche".

2.1.2 Chemicals

The petroleum oil used in the study was a crude oil from the Lula oil-field (25°30'0"S 43°30'0"W). This offshore oil field is located in Ultra Deep water at approximately

2000m depth. This oil contained 54% saturated hydrocarbons, 10% polar compounds and 36% aromatic hydrocarbons. Finasol OSR 52, a commercial formulation from TOTAL Fluides (Puteaux, France), was used as dispersant. It is a third generation oil-based dispersant combining surfactants (amphiphilic molecules) and solvents. Components of Finasol OSR52 were: docusate sodium 20-25%; Hydrocarbons, C1-C14, n-alkanes, ioalkanes, cylics, <2%; aromatics 15-20%; (2-methoxymethylethoxy)propanol 15-20%; Carboxylic acids, diC6-12 compounds, with ethanolamine, boric acid compound with ethanolamine 0-2%; Ethanolamine 0-1%.

2.1.3 Animal contamination

Turbot contaminant exposure was realized in a high-density polyethylene tank of 50 liters following a method fully described in Milinkovitch et al. (2011). Each of these tanks was equipped with a submersible pumping system allowing continuous water homogenization. After 24h without feeding, eight fishes were randomly allocated to each of the following experimental conditions: control (C), mechanically dispersed oil (MD), chemically dispersed oil (CD) and dispersant alone (D) and placed in the 50L exposure tanks for 48 hours without water renewal. In the case of the MD and CD conditions, 4g of oil were poured into 50L seawater tanks (for a nominal concentration of 80mg/L), in the CD condition 0.2g of dispersant were also added (dispersant / oil ratio: 1/20). For the D condition, 0.2g of dispersant were added to 50L of seawater. At the end of the 48h exposure, fishes were killed by cerebral dislocation. Livers and gallbladders were then sampled. After their sampling, the gallbladders were frozen in

liquid nitrogen and stored at -80°C; the livers were extemporaneously used for cells isolation.

2.1.4 Measurements of Total Petroleum Hydrocarbon in seawater.

Total petroleum hydrocarbon (TPH) concentration was measured after 12h, 24h, 36 and 48h during the exposure period for the four experimental conditions.

The total petroleum hydrocarbon concentrations were measured in triplicate. Samples of 100mL of water were extracted three times with 10 mL of dichloromethane (Carlo Erba Reactifs, SDS). The combined organic phases were dried on anhydrous sulphate and the absorbance was measured at 390 nm (UVeVis spectrophometer, Unicam, France) as described by Fusey and Oudot (1976). The results were expressed in mg/L, and the linearity of the response was checked between 0.5 and 100 mg/L.

2.1.5 Fixed wavelength fluorescence analysis of bile

Gallbladders were used for semi-quantitative analysis of PAH biliary metabolites (Vuorinen *et al.*, 2006). The bile was diluted in absolute ethanol (1/2000). Measurements were performed with a Jasco FP-6200 (Tokyo, Japan). The measurements were taken at two wavelengths pairs: 380:430nm characteristic of benzo[a]pyrene type metabolites and 343:383nm characteristic of 1-hydroxy-pyrene type metabolites. Values were expressed as arbitrary units (Lin *et al.*, 1996; Aas *et al.*, 2000).

2.2 Hepatocyte Isolation

Cells were isolated by collagenase digestion as adapted from Olivier *et al.* (2006). Briefly, a cannula was inserted into the hepatic portal vein and the liver perfused with 10 mL of a 320 mosm/kg standard isosmotic solution (152 mM NaCl, 3.4 mM KCl, 0.8 mM MgSO₄·7H2O, 0.33 mM Na₂HPO₄·2H₂O, 0.44 mM KH₂PO₄, 5 mM NaHCO₃, 10 mM Hepes; pH 7.63) at a flow rate of 0.5 mL/min. The liver was then perfused with the same volume of iso-osmotic solution enriched with 0.6 mM EDTA at 0.5 mL/min, and finally with 15 mL of a collagenase solution (type IV, 1 mg/mL in iso-osmotic solution) at 0.34 mL/min. The liver was scrapped off with a scalpel blade and filtered through 200, 85 and 48 µm nylon mesh screens. Cells were centrifuged for 4 min at 500 rpm at 4 °C, and resuspended in 5 mL of iso-osmotic solution enriched with 5 mM glucose and 1.5 mM CaCl₂. Cells were maintained under gentle agitation at least for 1 h at 17 °C prior to use.

2.3 Cell exposure to high hydrostatic pressure

2.3.1 High Hydrostatic Pressure Exposure System

The experimental system (previously described in Dussauze *et al.* 2016) consisted in four PMMA hyperbaric tanks connected to a HPLC pump with PEEK tubing. These tanks had in their center a 1.5 mL chamber where the cell suspension was introduced. The homogenization of the chamber was performed thanks to a magnetic stirring bar. The sealing of each chamber was realized with a rubber O-rings and a screwed 4 mm thick PMMA cover. The temperature control of the system (at 17°C) was ensured with a water circulation surrounding the body of the chamber. The hydrostatic pressure was increased forcing isosmotic solution through an adjustable counter-pressure generator. The hydrostatic pressure generated in the system was recorded continuously with a pressure gauge.

2.3.2 Protocol of cell exposure to HP

Between 3 and 4 million cells (suspended in isosmotic solution) were placed into each chamber well. The chambers were sealed, connected to the pressurizing system and maintained 40 min at atmospheric pressure. During each experiment, two chambers were kept at atmospheric pressure (0.1 MPa) and two chambers were exposed to high hydrostatic pressure. In both pressurized chambers, the pressure was increased at a speed of 1 MPa/min up to 10.1 MPa; the pressure was then maintained 40 minutes and the chambers decompressed at 10 MPa/min.

2.4 Biological analyses

2.4.1 Oxygen consumption measurement under high hydrostatic pressure

Oxygen partial pressures in the chamber well were recorded all along the experimentation (as described Dussauze *et al.* 2016) using an oximeter Oxy-4 (Presens, Regensburg, Germany). The oxygen sensor spots were placed on the top of the chamber well on the internal face of the PMMA covers.

The measurements were performed during the pressure exposure at 10 MPa, and during the same time in the control 0.1 MPA chambers. After analysis of the protein content of the cell suspension (Bradford method), the oxygen consumption was expressed in μ mol $O_2/\mu g$ of protein/min.

2.4.2 Hepatocyte mortality

The determination of total cell death, necrosis and apoptosis was performed thanks to propidium iodide (PI) and annexin V – FITC staining (Miltenyi Biotec, 130-092-052

Kit) accordingly to the recommendations of use. After the pressure exposure in the high-pressure chambers at 10.1 MPa (or after an equivalent stay in the control chambers at atmospheric pressure), these analyses were performed in duplicate on 10⁶ cells. Fluorescence was measured at two wavelengths pairs: 490/525nm for annexin V – FITC and 535/617 nm for PI on a plate reader (SAFAS FLX-Xenius). The measurement of cell viability was determined using the "Realtime-glo mt cell viability" (from Promega) accordingly to the recommendations of use. In this kit, the viability is indirectly evaluated via the reducing activity of the hepatocytes: the reduction of an organic substrate coupled to a luciferase. Briefly, duplicates of 2.5x10⁵ cells were placed in a 96-well photometric plates, 20μl were added in each well, after 30 min of incubation the bioluminescence was evaluated on a plate reader (SAFAS FLX-Xenius). After analysis of the protein content of the cell suspension (Bradford method), the reducing capacity of the cells were expressed in arbitrary units per μg of protein/min.

2.5 Statistical analyses

Statistical analyses were performed with the Statistica® software. ANOVA and post hoc tested were used when needed. When the data appeared not to follow the conditions of normality (Shapiro-Wilk test) and of homoscedasticity (Levene test), Wilcoxon tests were performed and eventually followed by Mann-Whitney tests. Data were expressed as median \pm interquartile ranges (med \pm iq). Differences were considered significant when p <0.05.

3. Results

3.1 Total Hydrocarbon concentration in seawater

The total hydrocarbon concentration (THC) has been determined thanks to the triplicate sampling performed every 12h during the 48h contamination period. In the control and dispersant conditions THC was below the calibration limits (< to 0.5 mg/L). In the mechanical dispersion condition THC was 34.3 ± 3.7 mg/L and 43.6 ± 4.5 mg/L for the chemical dispersion of the oil.

3.2 Biliary fluorescence

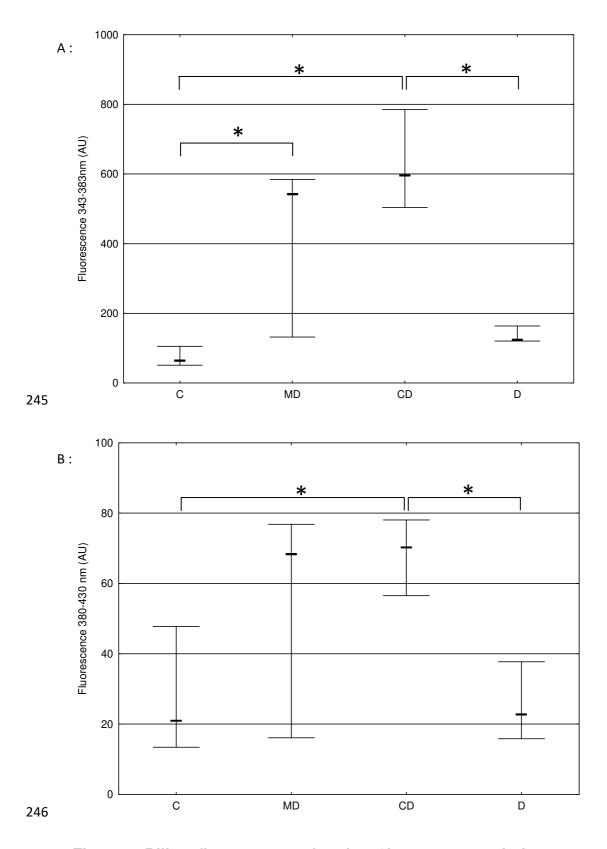
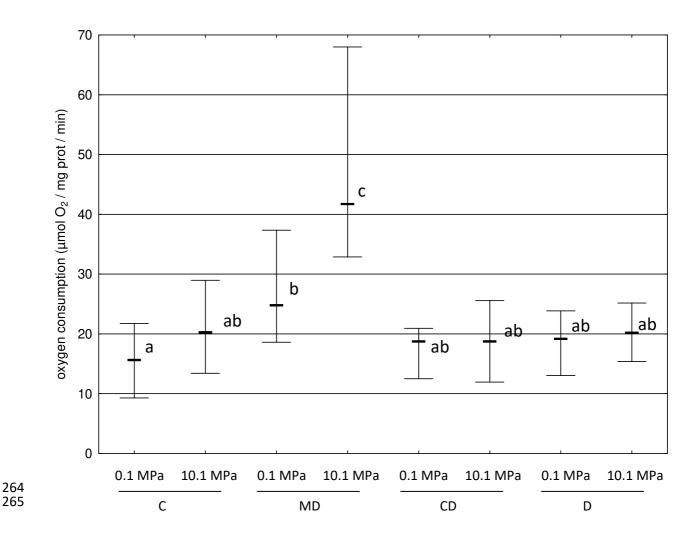


Figure 1: Biliary fluorescence after the 48h exposure period.

Biliary fluorescence intensities at 380:430nm 343:383nm, after the 48h contamination period are presented in **Figure 1**. In the MD group, 1-hydroxy-pyrene type metabolites (343:383nm) were significantly increased when compared to the control group. In the CD group both benzo[a]pyrene (380:430nm) and 1-hydroxy-pyrene (343:383nm) type metabolites were increased when compared both to the control and dispersant groups. In the dispersant group the biliary fluorescence was not significantly modified when compared to the control group.

3.3 Cellular oxygen consumption

Hepatocyte oxygen consumptions were measured at atmospheric pressure and under high hydrostatic pressure (see **Figure 2**). Exposure to 10.1 MPa induced a significant increase of oxygen demand as well as contamination did (ANOVA p<0,001 and p<0,01 respectively). In the control group, exposure to HP induced a non-significant 30% increase of MO₂. At 0.1 MPa, exposure to mechanically dispersed oil induced a nearly 60% increase of MO₂ in comparison of control group, and, when pressure was applied on hepatocytes, the MO₂ variation between C and MD increased at 170%. Dispersant use (alone or in presence of oil) appeared to prevent any increase of oxygen consumption either at atmospheric pressure or at 10.1 MPa.

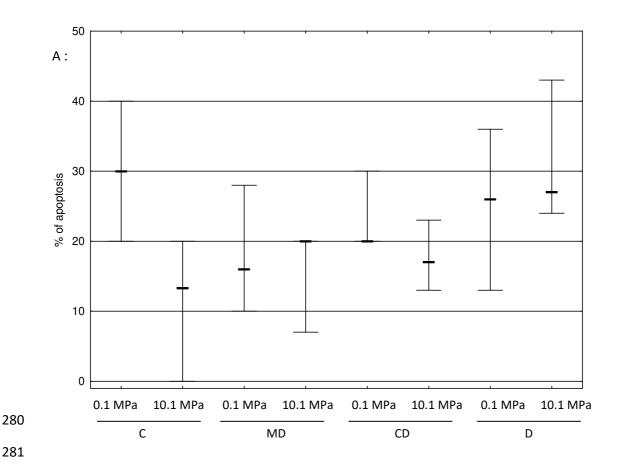


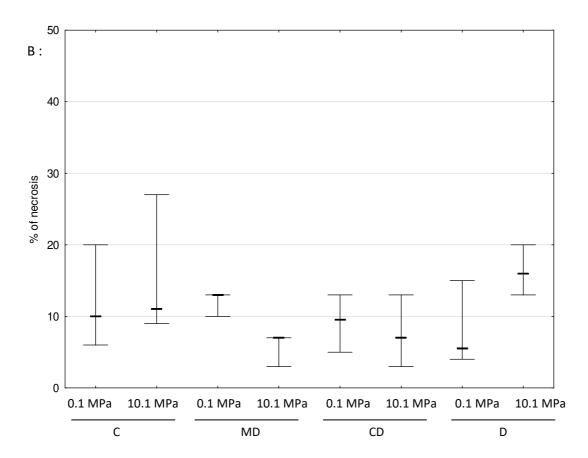
267 Figure 2: Oxygen consumption

3.4 Cell death, apoptosis & necrosis

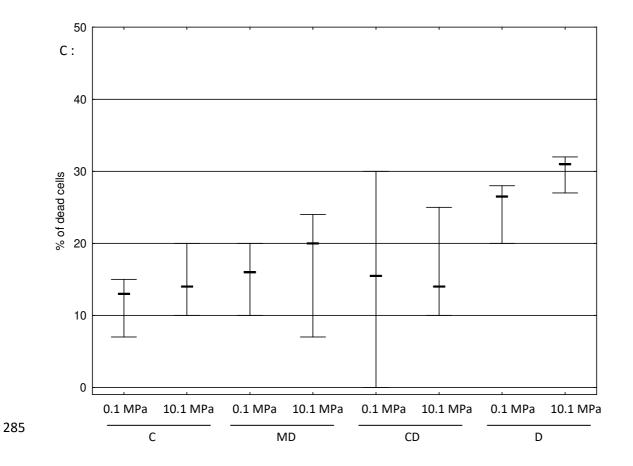


Figure 3: Apoptosis, Necrosis and cell death

After hepatocytes staining with PI and Anexin V, cell mortality, apoptosis and necrosis were calculated (**Figure 3**). In our experimental conditions, even if total mortality seems to be slightly higher after exposure to the dispersant alone, none of these parameters were significantly modified by contamination or hydrostatic pressure exposure.

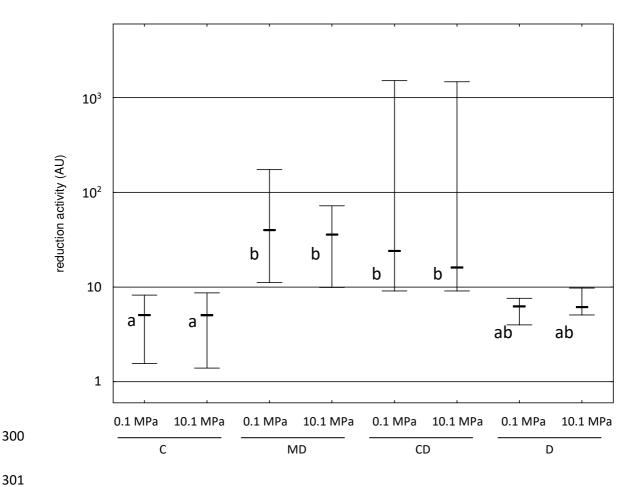


Figure 4: Hepatocyte reducing capacity

The reducing activity of the hepatocytes measured with the "Realtime-glo mt cell viability" (Promega) were significantly increased by the oil exposure (either in MD or CD groups) and was not modified by exposure to 10.1 MPa (**Figure 4**). The results obtained in the case of the D group were intermediate and not significantly different from C nor MD and CD groups.

4. Discussion

In the context of the development of the piezoecotoxicology, the goal of this study was to increase our understanding of the potential combined effects of oil/dispersant and hydrostatic pressure at a cellular level using turbot hepatocytes.

The choice of the turbot was based on several reasons. First, turbot is one of the model fish for ecotoxicological test for OSPAR commission (OSPAR Protocols on Methods for the Testing of Chemicals Used in the Offshore Oil Industry). But more interestingly, turbot is present in coastal, estuarine and continental shelf areas from the surface to at least 200 meters of depth and in all the European marine water from Mediterranean Sea to Arctic circle (Imsland et al., 2001). These various turbot habitats demonstrate the strong adaptive capacities of this teleost species. The use of a model species living in shallow and coastal but with good adaptive capacities has been successfully used in other piezoecotoxicological studies. Firstly using decapods, the shrimp, Palaemon varians was used in several studies performed at different hydrostatic pressure and at lethal and sub-lethal cadmium concentrations (Domingues, 2015). Secondly using fish, the seabass *Dicentrarchus labrax* has been used during hyperbaric challenges coupled with oil exposure (Dussauze et al., 2017). Studies were also performed at cellular level: fish hepatocytes were exposed to 3methylcholanthrene at several hydrostatic pressure (Lemaire et al., 2016).

The first steps of this study aimed to obtain turbot hepatocytes isolated from fish exposed either to chemically dispersed oil, mechanically dispersed oil or dispersant alone. The measurements of THC in the water and of the biliary fluorescence made it possible to assess fish contamination. Neither control nor dispersant alone exhibited oil contamination (THC in the water was below the detection limit and biliary fluorescence were far below the exposed groups).

In this experimentation, the choice of the nominal concentration of dispersed oil (80mg/L) was based on measurement made at sea after dispersant use on an oil spill where THC can reach 50mg/L in the upper slice of the water column (Humphrey *et*

al., 1987). For both MD and CD conditions, the THC values (respectively $34,3 \pm 3.7$ mg/L and $43,6 \pm 4,5$ mg/L) are lower than the nominal oil concentration (80mg/L) but this difference can be explained by the oil adherence on the different surfaces of the experimental system. Hence, our THC value even with a high nominal concentration can be considered as realistic and more precisely in the upper range of oil concentrations observed *in situ* during an oil spill.

The biliary fluorescence at 343-383 nm increases significantly in the MD group when compared to control fish demonstrating the effectiveness of the contamination. In the case of the chemical dispersion of the oil, the THC is 43.6 ± 4.5 mg/L and the biliary fluorescence is increased at the two-wavelength couple analysed. Even if there is no statistical difference between MD and CD groups, these results are compatible with an increased bioavailability due to the dispersant use (Ramachandran *et al.*, 2004).

This study was designed to assess the effects of oil contamination on hepatocyte

oxygen consumption under high hydrostatic pressure. The analysis of cell death / cell survival, apoptosis and necrosis were performed in order to be able to link an eventual modification of MO_2 to cellular mortality. The first point to consider, before analyzing the hepatocyte oxygen consumption, is the strong divergence of results obtained with the two techniques used to evaluate cell survival. The results from annexin V and PI staining show no change in apoptosis, necrosis nor cell death in any of the conditions tested. In contrast, the results of cell viability (determined with the "Realtime-glo mt cell viability" kit) show a strong and significant increase in the MD and CD group independently of the

pressure exposure. In the case of this last kit, the cellular viability is indirectly evaluated via the reducing activity of the hepatocytes; the measurement is based on the reduction of a proprietary organic substrate by the cellular metabolism. The subsequent increase of luminescence is classically interpreted as an index of cell survival (see for example Hsieh et al., 2017). In our case, the strong increase of response in the presence of oil can hardly be analyzed as an increase of cell survival since oil is clearly known to be hepatotoxic (Farmen et al., 2010; Au DWT, 2004) and since direct measurement of cell death (PI) and apoptosis (annexin V) were not modified. We hypothesise that the observed modification of luminescence is due to the enzymatic induction linked to the oil exposure of the fish. Polycyclic aromatic hydrocarbon exposures are indeed known to induce (via the Aryl Hydrocarbon receptor) the activation of a set of electron transport enzymes leading to their biotransformation and metabolization (Gelboin, 1980; van der Oost et al., 2003). The induction of biotransformation enzymes in vivo during the contamination process could led to an increased capacity of isolated hepatocytes to reduce the proprietary molecule independently of any change in cell survival. The analysis of this hypothesis could benefit from the knowledge of the proprietary organic substrate structure (unfortunately unavailable). PI and annexin V staining being direct methods of cell apoptosis and cell death, the discussion of hepatocyte oxygen consumption will be done considering no statistical changes in cell survival between the tested conditions.

Hydrostatic pressure exposure is known to induce a strong increase of aerobic metabolism in a number of species including fish and crabs and this increase is classically interpreted as the result of an increase of motor activity (Sébert *et al.*, 1995). Hydrostatic pressure is also known to alter mitochondrial activity in trout (a

shallow-water species) but not in silver eel (a species facing HP during its life cycle) (Sébert and Theron, 2001). As far as we know, the direct effect of HP on aerobic metabolism of fish cells had never been measured. Our results show a significant increase of the oxygen consumption in control hepatocytes exposed to HP (ANOVA p<0,001): an effect similar to the one observed at the level of the whole animal. Due to the lack of literature on cell metabolism under HP, it is difficult to propose a relevant hypothesis explaining the observed increase of the cellular energy demand. Oil exposure at atmospheric pressure also induced an increase of the hepatocyte MO₂ (ANOVA p<0.01). It is likely that during the contamination process of fish, the induction of hepatic biodegradation (van der Oost et al., 2003) results in an increase of the energetic cost at a cellular level and that this cost itself results in an increase of the aerobic metabolism. When HP is applied on hepatocytes from turbots previously exposed to the mechanical dispersion of oil, the oxygen consumption sharply increases 2.7 times from 15.6 µmolO₂/mg prot/min (in the group control 0.1 MPa) to 41.8 µmolO₂/mg prot/min (in the group MD 10.1 MPa). This result clearly evidences that oil contamination and HP exposure have at least additive effects on the cellular energetic demand. Interestingly dispersant use prevented any increase of oxygen demand either after HP exposure and oil contamination. Previous experiments had shown that exposure to dispersant induces an important reduction of the activity of the mitochondrial respiratory chain in cardiac permeabilized muscle fibers in seabass Dicentrarchus labrax (Tissier et al., 2015) but not in polar cod Boreogadus saida (Dussauze et al., 2014). Based on the seabass result, and even if this study is performed on hepatocytes, we could hypothesise that in the case of the turbot, the dispersant prevents the increase of oxygen consumption by reducing the capacities

of energy production by the mitochondria and not by reducing the cellular energy demand.

If this hypothesis is correct, it should have functional consequences at a higher degree of integration. In particular, the ability of the turbot to cope with an acute HP exposure should be reduced by an oil contamination in presence of dispersant (because of a concomitant increased energy demand and reduced mitochondrial capacity). Interestingly, this hypothesis is coherent with a previous study of Dussauze *et al.* (2017) where we demonstrated reduced capacity of juvenile seabasses exposed to dispersed fuel oil to face HP exposure.

5. Conclusion

The analysis of oxygen consumption from turbot hepatocytes at atmospheric pressure and at 10.1 MPa after fuel oil contamination and/or chemical dispersant demonstrates that fuel oil contamination and hydrostatic pressure have additive effects on oxygen consumption at a cellular level and that dispersant prevents any MO₂ increase. These results appear to be in good coherence with the reduced capacity of juvenile turbots to face HP exposure after exposure to a chemically dispersed fuel oil. The mechanisms leading to this increased energetic demand and its eventual inhibition will have to be investigated in further experiments.
