1	Age-Related Neuromuscular Fatigue and Recovery after Cycling: Measurements in

26 Abstract

27 Studies have suggested that older individuals are more fatigable than young adults when power loss, measured during single-joint contractions, is considered the fatigue index; 28 29 however, age-related differences in fatigue considering power measurements during multi-30 joint movements (e.g., cycling) have not been fully elucidated yet. This study examined 31 age-related differences in dynamic and isometric measures of fatigue in response to three 32 cycling exercises. Ten young  $(27 \pm 4 \text{ yrs.})$  and ten old  $(74 \pm 4 \text{ yrs.})$  men performed 33 exercises on different days, 30-s Wingate, 10-min at severe-intensity, and 90-min at 34 moderate-intensity. Dynamic measures-maximal power, torque, and velocity-were 35 assessed after cycling and during recovery (1-8 min post-exercise) through 7-s cycling 36 sprints and isometric force and fatigue etiology (central and peripheral components) 37 through isometric contractions. There were no age-related differences in the relative 38 reduction of dynamic and isometric measures following the Wingate and moderate-39 intensity tasks. Maximal power, isometric force, and indices of peripheral function (e.g., 40 high-frequency doublet) decreased more in young compared with older individuals after the 41 severe-intensity exercise (all p < 0.05). The only observed age-related difference in the recovery of NM fatigue was a slower recovery of power and torque from 1 to 8 min (p <42 43 (0.05) and at 4 min (p = 0.015), respectively, in younger males after the Wingate. Age-44 related fatigue and recovery depend on the fatiguing exercise intensity and duration and on

46 neuromuscular fatigue responses to multi-joint dynamic exercises performed at different 47 intensities and durations. 48 49 Keywords: Aging; Central fatigue; Contractile properties; Muscle; Peripheral fatigue; 50 Power output. 51 52 **1. Introduction** 53 Although reductions in both isometric force and power output are indicative of 54 neuromuscular (NM) fatigue, we have recently shown that these assessments are not 55 interchangeable (Krüger et al., 2019). In other words, isometric force and power output are 56 often decreased by different levels after a given exercise task. The distinction between 57 isometric force and power output responses is particularly important when examining age-58 related NM fatigue (Krüger et al., 2018). For instance, while older individuals present a 59 greater decline in power output following fatiguing tasks (Dalton et al., 2010b; Dalton et 60 al., 2012; Power et al., 2012; Wallace et al., 2016; McNeil and Rice, 2007), isometric 61 maximal voluntary contraction (IMVC) is usually decreased by the same extent in both 62 groups after fatigue induced by slow-velocity contractions (Dalton et al., 2012; Power et 63 al., 2012), and more depressed in younger individuals following maximal fast-velocity 64 movements (Yoon et al., 2013; Dalton et al., 2010b). Despite the fact that these findings 65 have been contradicted by other studies (Senefeld et al., 2017; Lanza et al., 2004;

the fatigue assessment mode. This study provides novel information on age-related

66 Thompson et al., 2015; Yoon et al., 2015), our meta-analysis study showed that older

individuals demonstrate a greater reduction in power after fatigue induced by either

69 people when fatigue is induced by dynamic exercises (Krüger et al., 2018).

70 The importance of measuring NM fatigue during dynamic contractions (e.g., 71 walking, rising from a chair, climbing stairs) relies on the fact that these movements are 72 incorporated into activities of daily living. Any age-related decrease in the ability to 73 produce high levels of power during dynamic movements can affect the performance of 74 activities of daily living and, for example, increase the number of falls (Foulis et al., 2017). 75 Because power output measurements are more representative of human's ability to 76 overcome fatigue during dynamic exercises, several studies in the past have included this 77 measurement in combination with IMVC to explore the effects of aging on NM fatigue 78 (Dalton et al., 2010b; Dalton et al., 2015; Dalton et al., 2012; Power et al., 2012; Yoon et 79 al., 2015; Yoon et al., 2013; Callahan and Kent-Braun, 2011). The decrements in power output after NM fatigue have been quantified during isotonic (Dalton et al., 2015; Dalton et 80 81 al., 2010b; Dalton et al., 2012; Power et al., 2012; Wallace et al., 2016; Yoon et al., 2015; 82 Yoon et al., 2013) or isokinetic (Callahan and Kent-Braun, 2011; Dalton et al., 2015) 83 contractions using the corresponding dynamometers.

Differently, the present study proposed to assess age-related differences in dynamic measures of NM fatigue from cycling sprints. The advantage of using this novel approach resides in three main factors: (i) it requires the activation of the knee extensors, which are essential contributors to power output production during the cycling downstroke phase (Driss and Vandewalle, 2013) and are an extremely important muscle group for daily living; (ii) it does not require velocity or force to be held constrained during the sprints; and
(iii) it allows measurements of force production capacities over the entire range of
velocities, which facilitate the determination of maximal torque (Tmax), velocity (Vmax),
and power (Pmax) (Driss and Vandewalle, 2013) through the associated torque-velocity (TV) and power-velocity (P-V) relationships obtained during a sprint protocol (Samozino et
al., 2007).

95 The first aim of the present study was to assess age-related differences in dynamic 96 measures of NM fatigue through the alterations of Pmax, Vmax, and Tmax induced by 97 different intensities and durations of cycling exercises and during recovery (from 1 to 8 min 98 after). The cycling fatiguing exercises consisted of: a Wingate test (WING); a severe-99 intensity, but long-duration task (SEV); and a moderate-intensity and longer duration task 100 (MOD). In accordance with the previous literature (Krüger et al., 2018; Wallace et al., 101 2016; Callahan and Kent-Braun, 2011; Dalton et al., 2010b; Dalton et al., 2012; Power et 102 al., 2012), we hypothesized that Pmax, Vmax, and Tmax would be reduced to a greater 103 extent in older individuals in comparison with their younger counterparts. Additionally, it 104 was expected that older participants would present a down and leftward shift on T-V 105 relationship curve at baseline (PRE) and after fatigue (POST) compared with young adults. 106 It remains to be explored if different intensities and durations of exercise will elicit distinct 107 age-related NM fatigue responses. It was hypothesized that Pmax, Vmax, and Tmax 108 recovery kinetics would not be affected by aging as a few studies have shown no age-109 related differences in these outcomes during the recovery of fatigue (Dalton et al., 2015; 110 Yoon et al., 2015; Yoon et al., 2013).

111	The second aim of this study was to examine age-related differences in isometric
112	measures of NM fatigue magnitude and etiology (central and peripheral fatigue) following
113	the same fatiguing tasks and during recovery. We hypothesized that WING exercise would
114	elicit greater decrease in IMVC and peripheral fatigue in young when compared with older
115	individuals while there would be no significant age-related difference in IMVC reductions
116	after the other exercise conditions. Although we have previously reported no age-related
117	difference in IMVC loss after dynamic fatiguing exercises (Krüger et al., 2018), some
118	studies showed greater IMVC decrements in young individuals following maximal
119	dynamic contractions (Yoon et al., 2013; Dalton et al., 2010b). It has been suggested that
120	older individuals (> 65 yrs. old) have a delayed isometric force recovery due to a slower
121	recovery of central mechanisms (e.g., delayed recovery of motor units firing rate) after
122	isometric fatiguing exercises (Dalton et al., 2010a; Hunter et al., 2008; Yoon et al., 2013;
123	Yoon et al., 2012). It remains to be explored if IMVC recovery is age-dependent after
124	multi-joint lower limb movement induced NM fatigue.

### 126 **2. Materials and Methods**

#### 127 2.1 Participants

Ten young  $(27 \pm 4 \text{ yrs.})$  and ten old  $(74 \pm 4 \text{ yrs.})$  men were recruited from local community centers and from the University of Calgary active living facilities. Part of the data reported from the young participants was previously published in a different study that aimed to compare dynamic and isometric measures of fatigue (Krüger et al., 2019). In the present study, the data from the young participants is used as a control group to identify age-related 133 NM fatigue responses to cycling. The participants were excluded from the study if: (i) their 134 resting electrocardiogram (ECG) showed any abnormality; (ii) their resting heart rate (HR) 135 > 90 bpm and/or a resting blood pressure >144/94 mmHg; (iii) they had any history of 136 severe disease that could increase the risk of developing cardiac arrhythmias and stroke; 137 and (iv) they had joint soreness that made biking difficult. Participants were cleared to 138 participate according to the "Physical Activity Readiness Questionnaire (PAR-Q)". 139 Physical activity status was assessed through the leisure-score index (LSI) obtained from 140 the "Godin-Shephard Leisure-Time Physical Activity Questionnaire (GSLTPAQ)" (Godin, 141 1997). Leisure-score index (LSI) was calculated as shown:  $(9 \times \text{Strenuous}) + (5 \times \text{Strenuous})$ 142 Moderate) + (3 × Light) (Godin, 1997). All the participants were classified as physically 143 active according to the LSI (> 24) (Godin, 1997). Young and older participants were 144 individually matched by their physical activity level. Participants were instructed to refrain 145 from consuming caffeine and alcohol for at least 12 h prior to experimental sessions and 146 participating in any intense exercise for 24 h before testing. Written informed consent was 147 obtained from each participant before the beginning the study. This study was approved by 148 the Conjoint Health Research Ethics Board of the University of Calgary (REB #15-2430) 149 and it was conducted according to the guidelines of the Declaration of Helsinki, except for 150 registration in a database.

152 2.2 Experimental design

Participants were required to visit the laboratory in seven different occasions. Visit 1consisted of screening measurements, a maximal incremental cycling test, and a

155	familiarization with the assessments. In each of the visits 2-7, the participants were
156	randomly assigned to perform one of the three fatiguing tasks in combination with either a
157	T-V relationship or a NM function protocol. The three exercises were a Wingate (WING)
158	test, a 10-min cycling at 5% above the second ventilatory threshold (VT2) (SEV), and a 90-
159	min cycling at 20% below the first ventilatory threshold (VT1) (MOD). The experimental
160	sessions were separated by at least 48 h to avoid residual effects of NM fatigue. Participants
161	were instructed to cycle at a constant cadence (60-80 rpm) during the fixed intensity
162	exercises (SEV and MOD). If they were not able to keep the cadence above 60 rpm during
163	the SEV exercise due to the task intensity, power output was slightly reduced (by 10 W) so
164	that they could finish the exercise ( $n = 3$ young and 3 old). There was no statistical
165	difference between the mean power output developed during the WING performed in the
166	T-V relationship and the WING performed in the NM function protocols for young ( $p =$
167	0.092) and older ( $p = 0.231$ ) individuals.

#### 169 2.2.1 Visit 1: incremental exercise and familiarization

170 All participants completed the questionnaires (PAR-Q and GSLTPAQ). The older

171 participants underwent a screening procedure composed by the assessment of resting HR,

blood pressure, and ECG. Then, vastus lateralis (VL) and rectus femoris (RF) cross-172

173 sectional areas (CSA) were measured using real-time B-mode ultrasonography (Philips

174 M2540A, Bothell, United States). After that, the participants performed an incremental

175 exercise test to the limit of tolerance to determine VT1, VT2, and  $\dot{V}O_2$  peak. The

176 incremental exercise consisted of cycling on a recumbent cycling ergometer while having

177	oxygen uptake measured by an open circuit spirometry system (Quark CPET, COSMED,
178	Rome, Italy). The initial power output was 90 W for the young participants and 25 W for
179	the older participants. During the test, power output increased was by 15 W every minute.
180	HR and ECG were continuously monitored for participants older than 75 yrs. by a certified
181	exercise physiologist (CSEP-CEP). Finally, participants were familiarized with the
182	electrical stimulation and practiced isometric and dynamic contractions on the recumbent
183	cycling ergometer powered by Velotron Coaching Software (Racermate Inc) (Figure 1,
184	panel D) (Doyle-Baker et al., 2018).
185	
186	2.2.2 Visits 2-7: fatiguing exercises
187	Upon arrival to the laboratory, electromyography (EMG) electrodes (10-mm diameter;
188	Meditrace 100, Covidien, Mansfield, United States) were placed on the VL and biceps
189	femoris (BF) and the reference electrode over the patella bone. Recording electrode
190	locations were based on SENIAM recommendations (Hermens et al., 2000). The cathode
191	stimulating electrode (10-mm diameter; Meditrace 100, Covidien) was placed on the
192	femoral nerve (inguinal triangle) and the anode electrode on the gluteal fold (Doyle-Baker
193	et al., 2018). After the electrodes placement, participants were adjusted on the recumbent
194	cycling ergometer seat with the knees and hips flexed at $90^{\circ}$ to determine the femoral nerve
195	electrical stimulation intensity, as previously described (Doyle-Baker et al., 2018) and
196	secured by chest and hip straps. Then, a 5-min cycling warm-up was performed (30% of
197	$\dot{V}O_2$ peak for 3 min, 45% for 1 min, and 60% for 1 min). After 3 min of rest, T-V
198	relationship or NM function protocol was performed twice (see below). After that, one of

199the three fatiguing exercises was performed. The testing protocol was repeated at ten200seconds (POST) as well as +1 min, +2 min, +4 min, and +8 min after the exercise201termination. There was no difference in the POST delay assessment between the T-V202relationship and NM function protocols  $(10.1 \pm 1.4 \text{ vs. } 10.4 \pm 3.6 \text{ s, respectively, } p =$ 2030.752).

205 2.2.3 Dynamic measures of NM fatigue

206 The T-V and P-V relationships were determined from 7-s sprints on the same recumbent 207 cycling ergometer (Velotron). The aim of this testing protocol was to characterize lower 208 limb force production capacities over an entire functional movement (i.e., a lower limb 209 extension) at different velocities. This ergometer is equipped with an eddy current braking 210 system, which allows control of the flywheel resistance directly from the software. During 211 the 7-s sprints, the participants were vigorously encouraged to pedal as fast as possible 212 while remaining seated on the saddle and secured by chest and hip straps. Exactly 10 s after 213 the end of each sprint, a single twitch contraction (Pt, one stimulus) was delivered on the 214 femoral nerve when the pedals were locked (Figure 1, panel A). The Pt delivery delay was 215 matched between the T-V relationship and NM function protocols ( $26.8 \pm 2.3$  vs.  $25.4 \pm 4$ 216 s, respectively, p = 0.151). This ~26 s of interval comprises the 10-s delay from the exercise 217 cessation to beginning of the sprint, the sprint time, and about 10-s delay from the end of 218 the sprint to the Pt delivery.

Individual braking force during cycling sprints was determined in the first visit
based on the goodness of fit of the T-V and P-V relationships (Figure 1, panel B). The

goodness of fit criteria were a high coefficient of determination ( $R^2 > 0.9$ ), a great range of 221 222 area covered by velocities obtained from pedal downstrokes, and an equal number of points distributed to both sides of the P-V relationship curve (Dorel, 2018). Therefore, the ideal 223 224 individual resistance would allow the participants to achieve maximal power at about 50% 225 of the sprint duration at baseline (PRE). For that, young participants performed two 7-s 226 sprints against a resistance equivalent to 5 and 7% of body weight applied to the flywheel, 227 while older participants cycled against an equivalent resistance of 3 and 4% of body 228 weight. These resistances are lower than the optimal resistance usually used for T-V 229 relationship tests (7.5% of body weight) (Driss and Vandewalle, 2013) since the cycling 230 sprints in the present study were performed on a cycle ergometer presenting different 231 position (recumbent cycling ergometer) and flywheel (inertia and radius) characteristics 232 different than usual cycle ergometers. As indicated above, the applied resistance during the 233 T-V relationship test affects several properties of the T-V and P-V relationship (Dorel, 234 2018). As older participants were weaker and less powerful compared with young 235 participants (see Table 1), the resistance set to older participants was lower to assure T-V 236 relationship goodness of fit.

238 2.2.4 Isometric measures of NM fatigue

239 The NM function protocol consisted in performing 5-s IMVC coupled with a high

240 frequency doublet electrical stimulation (Db100, 10-ms inter-stimulus interval) evoked

241 during the IMVC force plateau. Three seconds after the IMVC, a Db100, a low frequency

doublet (Db10, 100-ms inter-stimulus interval), and a Pt were delivered on the relaxed

muscle. These three stimuli were interspaced by 3-s intervals. Before and after the fatiguing
exercises, the participants performed two 5-s knee flexion IMVCs to assess co-activation.

#### 246 2.3 Data analysis

247 2.3.1 Dynamic measures of NM fatigue

248 The sprints were recorded with a video camera (Fujifilm FinePix XP80 Waterproof Digital 249 Camera with 2.7-Inch LCD, Tokyo, Japan) with a 240 Hz sampling frequency. Reflective 250 markers were placed on the crank and pedal to measure angular displacement during the 251 sprint. The camera was synchronized with the Labchart 8 software (ADInstruments, Bella 252 Vista, Australia) with a light signal. The instantaneous torque at the pedal crank was 253 obtained from the instrumented pedals (tangential force relative to the circular path) and 254 recorded at 240 Hz in the Imago Record (version 8.50; Radlabor GmbH, Freiburg, 255 Germany) software and the instantaneous angular velocity was calculated from camera and 256 Kinovea® software after tracking the crank angular displacement at each 4.17 ms (240 Hz). 257 Power was then calculated as the product of instantaneous torque and angular velocity. 258 Resultant torque, angular velocity, and power output were averaged from each pedal 259 downstroke of the acceleration phase (Samozino et al., 2007). Individual linear T-V 260 relationship was determined from pedal downstroke averaged values using an inverse linear 261 regression as previously described for multi-joint movements (Bobbert et al., 2016; 262 Samozino et al., 2010; Samozino et al., 2012). T-V relationship was extrapolated to obtain 263 Tmax (theoretical maximal torque lower limbs could produce) and Vmax (theoretical 264 maximal velocity until which lower limbs could still produce torque) as the intercepts of the

265	T-V relationship with the force and velocity axis, respectively. Pmax was determined as the
266	product of Tmax and Vmax divided by 4 (Vandewalle et al., 1987). When T-V relationship
267	fit is linear, the P-V relationship is fitted by a second order polynomial regression with
268	maximal value reached for $T = Tmax/2$ and $V = Vmax/2$ (Vandewalle et al., 1987;
269	Samozino et al., 2012). After the MOD condition, some individuals (1 young and 3 old)
270	could not achieve optimal velocity during the T-V relationship tests. The lower ability to
271	rapidly overcome the flywheel resistance after NM fatigue compromised the dynamic
272	properties assessment. Consequently, Vmax was highly extrapolated from the T-V
273	relationship curve, which increased the inaccuracy of Vmax and Pmax computations and
274	led to irrelevant values. Because of this, those participants were considered outliers and
275	were excluded from the analyses.
276	

277 2.3.2 Isometric measures of NM fatigue

278 All the variables were analyzed in Labchart 8 software (ADInstruments). VA was assessed 279 by the interpolation twitch technique using the amplitude of superimposed and resting 280 Db100 (Merton, 1954). Since in some cases the Db100 was not applied during the IMVC 281 plateau, the magnitude of VA was calculated using a corrected formula for all the 282 individuals:  $%VA = 100 - D \times (Fb/IMVC) / Db100 \times 100$  (Strojnik and Komi, 1998), 283 where Fb is the force level just before the Db100 and D is the difference between Fb and 284 the maximum torque during the Db100. The highest amplitude of IMVC, VA, Db100, and 285 Pt was considered for the baseline analysis. Db10 amplitude was only considered for the

low-frequency fatigue (LFF) assessment, which was measured by the ratio between Db10
and Db100 (Db10:100) (Verges et al., 2009).

Pt properties assessment involved time to peak torque (TPT) (time between the beginning of the contraction to the peak), half relaxation time (HRT) (the time period taken for Pt to decline by 50%), maximal rate of force development (MRFD), and maximal rate of force relaxation (MRFR), i.e., maximal and minimal values of the force-time derivative, respectively, expressed in N·s<sup>-1</sup>.

293 The EMG data was recorded with the PowerLab data acquisition system (16/35, 294 ADInstruments). EMG activity was filtered with a Blackman -61 dB band-pass filter 295 between 10–500 Hz, amplified (bi-polar differential amplifier, input impedance =  $2 M\Omega$ , 296 common mode rejection ratio > 110 dB min, gain  $\times$  1000, noise > 5  $\mu$ V), and analog-to-297 digitally converted (12 bit). Peak-to peak M-wave amplitude and M-wave area were 298 assessed using surface EMG of the VL muscle. The maximal root mean square EMG 299 (RMS) obtained during IMVC was normalized to M-wave amplitude (Mmax) to assess 300 maximal central motor drive (Place et al., 2007). BF EMG RMS recorded during knee 301 extension IMVCs was normalized to maximal BF EMG RMS obtained during 5-s knee 302 flexions IMVCs (the one with the highest RMS was considered) to assess co-activation. 303 This approach allows the calculation of the percent of BF activation during KE IMVC.

304

305 2.3.3 Gas exchange and ventilatory variables

 $\dot{VO}_2$  peak was considered as the highest  $\dot{VO}_2$  value computed over 30 s of the  $\dot{VO}_2$  plateau or at the end of the ramp-incremental test. VT1 was identified as the minimum workload at

309	increment in the ventilatory equivalent ratio for carbon dioxide ( $\dot{V}E/\dot{V}CO_2$ ) (Dekerle et al.,
310	2003; Wasserman and McIlroy, 1964). VT2 was determined as the lowest intensity where
311	both $\dot{V}E/\dot{V}O_2$ and $\dot{V}E/\dot{V}CO_2$ increased (Dekerle et al., 2003; Wasserman and McIlroy,
312	1964). VT1 and VT2 were analyzed by visual inspection of graphs by two independent
313	appraisers (R.L.K and L.M.J.). Disagreements were solved by a third reviewer (G.Y.M).
314	
315	Muscle cross-sectional area
316	Participants rested in a supine position for 10 min before the data collection. Three VL and
317	RF muscles high-quality images were recorded at a depth of 5 cm from the transducer
318	surface that was positioned transversally to the muscle fibers at 50% of the distance
319	between the lateral condyle of femur and the greater trochanter (Baroni et al., 2015). The
320	images were recorded by applying consistent and minimal pressure in the muscle using the

328 2.4 Statistical analyses

329 Data was described as mean and standard deviation (mean ± SD), and 95% CI. The 330 Shapiro-Wilk test was used to assess the data normality for each variable. Levene's test was 331 used to test the homogeneity of variance and Mauchly's test to access sphericity 332 assumption. Greenhouse-Geisser correction factor was applied if the sphericity was not 333 assumed. Reliability of the dependent variables was assessed through coefficient of 334 variation (CV, intertrial SD divided by the mean of the two trials) and calculation of typical 335 error of measurement (TEM) (Hopkins, 2000) across values obtained for each age group at 336 baseline (PRE). It was completed by a one-way analysis of variance (ANOVA) to test the 337 differences in the dependent variables among the three sessions (WIN, MOD, and SEV). 338 Independent sample t-tests were performed to assess the difference in the mean of the 339 dependent variables at PRE between young and older participants.

340 Two different statistical approaches were used to test NM fatigue responses at 341 POST and during recovery. This is because we were interested in analyzing these two 342 parameters independently and the inclusion of all the time-points in the same ANOVA 343 would increase the number of independent t-tests and Bonferroni corrections, which would 344 enhance the possibility of type II error (i.e., failure to reject the false null hypothesis). To 345 assess the effect of aging on NM fatigue, independent t-tests on relative values (% of PRE) 346 were performed to compare the difference across the age groups at POST of each exercise 347 condition. Changes in T-V relationship curves with fatigue were assessed through a three-348 way ANOVA (instantaneous torque and velocity  $\times$  age group  $\times$  time). If there was an 349 interaction, multiple independent sample t-tests (age difference) and paired t-tests (time 350 difference) followed by Holm-Bonferroni correction were conducted. To assess the effects

351 of age on NM fatigue recovery kinetics (difference from POST to +1, +2, +4, and +8 min), 352 a two-way mixed ANOVA (age group  $\times$  time) followed by Bonferroni post-hoc test on 353 relative values (% of PRE) was performed. If there was an interaction, multiple 354 independent sample t-tests followed by Holm-Bonferroni correction were performed to 355 assess the difference between young and older males at +1, +2, +4 and +8 min of recovery. 356 Additionally, we combined young and older individual's data to explore the association 357 between mean power output sustained during the exercise trials and the decrements in 358 dynamic measures of NM fatigue (% of PRE) using Pearson's correlation coefficient to 359 support some of the findings of this study. Effect sizes were reported as Cohen's D (Cohen, 360 1988). For hypothesis testing, 95% CI was predetermined as the minimum criterion to 361 denote a statistical difference ( $p \le 0.05$ ). The data was analyzed using the Statistical 362 Package for Social Sciences (SPSS) version 24 (SPSS Inc., Chicago, IL). The data that 363 support the findings of this study are available from the corresponding author upon request. 364

#### 365 **3. Results**

#### 366 3.1 Age-related differences at baseline (variables recorded at PRE)

367 Reliability data is presented in SuppInfo 1 and 2. There was no difference in the baseline

368 responses of the dependent variables among the three exercise conditions (WING, SEV and

MOD) for young and older individuals (all p > 0.05). The differences between young and

370 old individuals for the outcomes measured at baseline are shown in Table 1. VL and RF

- 371 CSAs were significantly smaller in the older participants ( $p \le 0.001$ , d = 2.84 and p =
- 372 0.004, d = 2.38, respectively). Older participants had 20% lower IMVC force (p = 0.013, d

373 = 3.96) and were less powerful (Pmax) and weaker (Tmax) than their younger counterparts 374 (p = 0.001, d = 1.83 and p = 0.021, d = 1.15, respectively). The muscle force per muscle 375 cross-sectional area was also lower in older individuals (p < 0.001, d = 3.16). Older males 376 also presented ~40% lower Pt and Db100 in comparison with young adults (both p < 0.001, 377  $d \ge 4.22$ ). MRFD and MRFR were 60% and 74% lower, respectively (both p < 0.001,  $d \ge$ 3.27), while CT was 13% longer for the old vs young individuals (p = 0.01, d = -1.00).

#### 380 3.2 Exercise characteristics

- 381 Older individuals presented lower  $\dot{V}O_2$  peak, peak power output, and power output at
- ventilatory thresholds (VTs) in comparison with young participants (all p < 0.001,  $d \ge 1.15$ ,
- 383 Table 2). The exercise intensity and total work were also lower for older individuals during
- the WING, SEV and MOD conditions (all p < 0.024,  $d \ge 1.11$ , Table 2). Results from the
- association between mean power output sustained during the exercise trials and the
- 386 decrements in dynamic measures of NM fatigue (Pmax, Vmax and Tmax expressed in % of
- 387 PRE) showed a negative correlation between mean power output and Pmax (r = -0.843, p <
- 388 0.001), mean power output and Vmax (r = -0.833,  $p \le 0.001$ ), and mean power output and
- 389 Tmax (r = -0.508, p < 0.001) when considering young and older individual's data.

- 391 3.3 Wingate
- 392 Dynamic measures of NM fatigue
- 393 No age-related differences were observed in the reduction of Pmax (young:  $58 \pm 12\%$  and
- 394 old:  $63 \pm 10\%$  of PRE, p = 0.281, Figure 2a), Vmax (young:  $71 \pm 10\%$  and old:  $77 \pm 5\%$  of

395	PRE, $p = 0.106$ , Figure 2b), and Tmax (both: $82 \pm 9\%$ of PRE, $p = 0.980$ , Figure 2c) after
396	the WING. There was an interaction between T-V relationship variables (i.e., instantaneous
397	torque and velocity) $\times$ time $\times$ age in the WING condition, which suggests an overall down
398	and leftward shift in the T-V relationship curve with aging and fatigue $(F(1,19) = 42.397, p)$
399	< 0.001, $d = 1.91$ , Figure 3a). Instantaneous torque and velocity decreased after the WING
400	for both groups (all $p < 0.001$ , $d \ge 3.01$ ). During the recovery, there was a time × age
401	interaction for Pmax ( $F(4,72) = 3.088$ , p = 0.021, d = 0.84, Figure 2a) and Tmax ( $F(4,72) =$
402	4.451, $p = 0.003$ , $d = 1.00$ , Figure 2c). Young individuals had a slower recovery of Pmax
403	from +1 to +8 min of recovery (all $p \le 0.026$ , $d \le -1.37$ ) and Tmax at +4 min ( $p = 0.015$ , $d$
404	= -1.51) compared with older participants. There was no difference in Vmax recovery
405	pattern between young and older males (all $p > 0.05$ ).

#### 407 Isometric measures of NM fatigue

408 Young and older individuals presented similar levels of NM fatigue measured in isometric 409 mode after the Wingate (all p > 0.05). IMVC decreased to  $81 \pm 8\%$  in young and  $76 \pm 8\%$ 410 of PRE in older individuals (p = 0.177, Figure 4a). There were no differences between the 411 age groups for VA (young:  $100 \pm 3\%$  and old:  $101 \pm 4\%$  of PRE, p = 0.915, Figure 5a), Db100 (young:  $79 \pm 15\%$  and old:  $80 \pm 7\%$  of PRE, p = 0.884, Figure 5b), and Db10:100 412 413 (young:  $73 \pm 12\%$  and old:  $79 \pm 19\%$  of PRE, p = 0.433, Figure 5c) after the WING. M-414 wave area did not change from baseline for both young and older individuals (young:  $108 \pm$ 415 9% and old:  $100 \pm 14\%$  of PRE, p = 0.145, Figure 5d). Electromyography (EMG) and co-416 contraction responses as POST were similar across the age groups after this condition (all p

- 7 > 0.05, data not shown). During the recovery, there was no time  $\times$  age interaction for
- 418 IMVC, VA, Db100, Db10:100, and M-wave after the WING (all p > 0.05). These results
- 419 suggest the kinetics of recovery of these variables was similar between young and older
- 420 individuals in this condition.
- 421

422 Pt properties

- 423 All the Pt properties changed similarly after NM fatigue (i.e., at POST) in young and older
- 424 individuals (all p > 0.05). During the recovery, there was an interaction between time × age

425 for HRT (F(4,56) = 3.292, p = 0.017, d = 1.00, *data not shown*), suggesting higher HRT

- 426 values for young than older individuals. Additionally, MRFR was lower in young
- 427 participants during the WING recovery (age effect: F(1,16) = 4.737, p = 0.045, d = -1.09,
- 428 *data not shown*). No age-related difference was observed for the other Pt properties during
- 429 the recovery of the WING (all p > 0.05).

#### 431 3.4 Severe-intensity exercise

- 432 Dynamic measures of NM fatigue
- 433 In the SEV condition, Pmax losses were greater in young than in older individuals (young:
- 434 74 ± 8% and old: 90 ± 12% of PRE, t(18) = 3.399, p = 0.003, d = -1.57, Figure 2d), but
- there was an absence of age-related significant difference in the decrease of Vmax (young:
- 436 87 ± 11% and old: 96 ± 11% of PRE, p = 0.068, Figure 2e) and Tmax (young: 87 ± 15%
- 437 and old:  $94 \pm 12\%$  of PRE, p = 0.281, Figure 2f). There was no interaction between the T-V
- 438 relationship variables  $\times$  time  $\times$  age in this condition (p = 0.182). However, there was a main

439 effect of time (F(1,2) = 25.931, p < 0.001, d = 1.36) and age (F(1,20) = 7.560, p = 0.012, d)440 = 0.57, Figure 3b), suggesting a down and leftward shift in the T-V relationship curve with 441 fatigue and aging. During the SEV exercise recovery, Pmax was significantly lower in 442 young compared with older males (age effect: F(1,18) = 12.650, p = 0.002, d = -1.67, 443 Figure 2d). Vmax and Tmax recovery patterns were similar in young and older males (all p 444 > 0.05). 445 446 Isometric measures of NM fatigue 447 IMVC decrements were greater in young than in older individuals after the SEV condition 448  $(62 \pm 12\% \text{ vs } 81 \pm 10\% \text{ of PRE}, \text{ respectively}, t(18) = 2.511, p = 0.022, d = -1.72$ , Figure 449 4b). There was no difference between the age groups for VA (young:  $92 \pm 11\%$  and old: 92

450  $\pm$  7% of PRE, *p* = 0.932, Figure 5b). Young individuals presented greater reductions of

451 Db100 (young:  $67 \pm 12\%$  and old:  $92 \pm 17\%$  of PRE, t(18) = 3.812, p = 0.001, d = -1.70,

452 Figure 5b) and Db10:100 (young:  $69 \pm 15\%$  and old:  $84 \pm 15\%$  of PRE, t(18) = 2.315, p =

453 0.033, d = -1.00, Figure 5c) after the SEV task. There was no difference in M-wave area

between young and older individuals (young:  $113 \pm 7\%$  and old:  $111 \pm 15\%$  of PRE, p =

455 0.720, Figure 5d). Electromyography (EMG) and co-contraction responses were similar

456 across the age groups (*all p* > 0.05, *data not shown*). During the recovery, there was an age

457 effect for IMVC (F(1,18) = 14.470, p = 0.001, d = 1.80, Figure 4b) and Db100 (F(1,18) =

458 18.120, *p* < 0.001, *d* = 2.00, *data not shown*). VA, Db10:100, and M-wave responses were

459 not different between young and older males during the recovery of the SEV exercise (all p

460 > 0.05).

- 463 Young individuals demonstrated a greater decrease in Pt amplitude (t(17) = 2.365, p = 0.03,
- 464 d = -1.09 and TPT (t(18) = -2.294, p = 0.034, d = -1.51, Table 3) in the T-V relationship
- 465 test day after SEV task. In contrast, after the NM function test, TPT decrease more in older

466 individuals (t(17) = 2.640, p = 0.045, d = 0.99, Table 3). HRT, MRFD and MRFR

- 467 properties changed similarly after NM fatigue in young and older individuals (all p > 0.05).
- 468 During the recovery, there was only an age effect for Pt (F(1,18) = 5.365, p = 0.033, d =
- 469 1.09, *data not shown*). No age-related differences were observed for Pt properties during

470 the recovery of the SEV task (all p > 0.05).

471

#### 472 3.5 Moderate-intensity exercise

- 473 Following the MOD task, there were no age-related differences in Pmax (young:  $94 \pm 10\%$
- 474 and old:  $98 \pm 7\%$  of PRE, p = 0.405, Figure 2g), Vmax (both  $103 \pm 9\%$  of PRE, p = 0.974,
- 475 Figure 2h), and Tmax (young:  $91 \pm 7\%$  and old:  $95 \pm 8\%$  of PRE, p = 0.291, Figure 2i).
- 476 There was a significant interaction between the T-V relationship variables × time × age

477 (F(1,21) = 5.700, p = 0.026, d = 0.43, Figure 3c). Instantaneous torque decreased after the

- 478 MOD task for both groups (all p = 0.006, d = 0.81). Pmax, Vmax, and Tmax recovery
- 479 patterns were similar in young and older males (all p > 0.05).
- 480

481 Isometric measures of NM fatigue

482 IMVC decreased similarly in young and older individuals after the MOD task (young: 79 ± 483 13% and old:  $82 \pm 10\%$  of PRE, p = 0.623, Figure 4c). There was no difference between 484 the age groups for VA (young:  $91 \pm 11\%$  and old:  $92 \pm 9\%$  of PRE, p = 0.819, Figure 5a). 485 Db100 decreased more in young individuals (young:  $84 \pm 10\%$  and old:  $98 \pm 21\%$  of PRE, 486 t(17) = 4.692, p < 0.001, d = -0.85, Figure 5b), but Db10:100 levels were similar in young 487 and older males after the MOD exercise (young:  $87 \pm 8\%$  and old:  $91 \pm 10\%$  of PRE, p =488 0.302, Figure 5c). M-wave area was more depreciated after the MOD task in young when 489 compared with older males (young:  $83 \pm 6\%$  and old:  $96 \pm 10\%$  of PRE, t(18) = 3.558, p =490 0.002, d = -1.58, Figure 5d). These effects of age represent lower values—relative to PRE—in young 494 individuals during the recovery in comparison with older males. VA and Db10:100 levels 495 were similar in young and older individuals during the recovery period (all p > 0.05). 496 497 Pt properties

498 MRFD was lower in young individuals in the T-V relationship test (t(17) = 2.182, p =

499 0.043, d = -1.01, Table 3). During the recovery, only MRFD was significantly lower in

- 500 young individuals throughout the recovery period (F(1,17) = 5.409, p = 0.033, d = -1.15,
- 501 *data not shown*). No age-related differences were found for other Pt properties after fatigue
- 502 and during the recovery period (all p > 0.05).

#### 504 **4. Discussion**

505 The findings of this study refute the hypothesis that Pmax, Vmax, and Tmax would be 506 reduced to a greater extent in older males. Different than expected, Pmax levels were more 507 reduced in young compared with older individuals after the SEV task. Our results support, 508 however, the hypothesis that older individuals present a down and leftward shift in the T-V 509 relationship curve at PRE and POST in comparison with their younger counterparts. 510 Additionally, this study refutes the hypothesis that WING exercise would induce greater 511 decrease in IMVC and peripheral fatigue in young when compared with older individuals. 512 These differences between age-groups were actually found for the SEV exercise. Young 513 males presented greater levels of NM fatigue in this condition when IMVC and evoked 514 forces (Db100 and Db10:100) were considered the fatigue index. No age-related difference 515 in Pmax, Vmax, and Tmax recovery kinetics was expected; however, our results showed 516 that young males present a slower recovery of Pmax and Tmax after the WING. These 517 results demonstrate that age-related differences in NM fatigue after dynamic cycling tasks 518 with large muscle mass are influenced by the exercise intensity and duration.

#### 520 4.1 Age-related differences in NM fatigue

521 The great amount of work and power output sustained during the SEV task by young 522 individuals may, at least partly, explain the higher decrease in IMVC and greater peripheral 523 fatigue (Db100 and Db10:100) observed in young, when compared with older males, in this 524 condition. While total work and mean power output were ~30% greater in young when 525 compared with older males during the WING, these differences were much higher during the SEV and MOD tasks (total work and power output were ~67% and ~87%, respectively, greater in young individuals). The lower differences between young and older individuals in total work and mean power output developed during the WING may support the absence of age-related difference in NM fatigue in this trial.

530 The lower ability of older individuals to produce and sustain high levels of power 531 output during cycling exercises can be explained by both neuromuscular and cardiovascular 532 age-related changes. In respect of the neuromuscular system, muscle maximal force and 533 mass decrements with aging (see IMVC and CSA age-related differences in Table 1) are 534 primarily related to the loss of motor units' number and atrophy of the survivor ones 535 (Andersen et al., 1999; Power et al., 2010). When motor units' axons deteriorate, single 536 muscle fibers can either lose their functionality or be sprouted by collateral axons (Hepple 537 and Rice, 2016). This last process leads to an increase in myosin heavy chain (MHC) co-538 expression in the skeletal muscle fiber population (Hepple and Rice, 2016) and in the 539 number of fibers expressing MHC isoforms I (Andersen et al., 1999), which are slower and 540 weaker than MHC II isoforms (Bottinelli et al., 1994). Even when young and older 541 individuals are matched by physical activity status, older adults still present higher relative 542 abundance of MHC I and lower MHC II in the VL when compared with young adults 543 (Sundberg et al., 2018b). Another consequence of aging in the skeletal muscle system is the 544 decrease in muscle quality (i.e., IMVC:CSA, see Table 1). This aging process has been 545 associated with molecular alterations at the myosin structure level and with lower percent 546 of myosin strongly attached to actin in muscle fibers in rats (Canepari et al., 2010), and 547 reductions in muscle protein quantity in humans (Power et al., 2014). From a

548 cardiovascular perspective, there is a reduction in maximal aerobic capacity with aging 549 because of the natural age-related decrease in maximal heart rate and cardiac output 550 responses during exercise (Grey et al., 2015) (see Table 2). Impairments in cardiac output 551 with aging impact muscle O<sub>2</sub> delivery and, consequently, power output production during 552 exercise as cardiac output plays an important role in blood flow distribution and  $O_2$ 553 transport to active muscles (Betik and Hepple, 2008). In fact, it has been shown that the 554 age-related downward shift in the power-duration during exercise is associated with 555 reduced O<sub>2</sub> transport and utilization (Poole et al., 2016). This impacts our results because 556 the MOD and SEV exercises were prescribed based on the power output achieved at VT1 557 and VT2, respectively. As older individuals produced less power output during this test, the 558 absolute power output at VT1 and VT2 was lower in older individuals when compared with 559 their younger counterparts and, therefore, older males sustained lower power output levels 560 during the exercise conditions.

561 These natural age-related neuromuscular and cardiovascular changes during the 562 lifespan have a direct impact in motor performance (Hunter et al., 2016). The reduction in 563 the capacity to perform motor activities with aging is often marked by a lower ability to 564 produce and/or sustain high levels of force and power during dynamic exercises or even 565 during activities of daily living (Casas-Herrero et al., 2013). Briefly, the age-related 566 responses in NM fatigue during cycling exercises can be examined using two main 567 methods. The first approach consists of asking young and older individuals to cycle against 568 the same absolute intensity (e.g., 100 W). In this scenario, it is evident that older 569 individuals would present greater levels of NM fatigue because they would cycle at higher

relative intensities than young individuals (see Table 1 and Weavil et al., 2018 for more
details). In the second approach, both age groups cycle at the same relative intensity (e.g.,
10% above VT2). When using this last method to induce NM fatigue, young individuals
produce and sustain greater levels of force during the exercise task, which can lead to
greater levels of NM fatigue in this population (Weavil et al., 2018).

575 Interestingly, the only other study to date that examined age-related NM fatigue 576 after cycling also found a greater IMVC loss in young vs older individuals after both age 577 groups cycled at the same relative intensity (80% of peak power output) (Weavil et al., 578 2018). Specific new insights from the present study are the use of a different method to 579 determine exercise intensity (based on the VTs). Furthermore, this study shows, for the first 580 time, that age-related NM fatigue after cycling depends on the exercise intensity and 581 duration. Young and older individuals presented similar overall levels of NM fatigue after 582 the WING and MOD tasks, but not after the SEV exercise. It is also important to note that 583 exercise intensities should ideally not be prescribed using a relative percent of peak power 584 output as peak power output determination depends on the exercise protocol (Keir et al., 585 2018). This approach can be problematic as it assumes that exercises performed at a certain 586 percent of  $\dot{V}O_2$  peak elicit similar metabolic demands between individuals (Keir et al., 587 2018). For example, if the MOD exercise was performed at 70% of  $\dot{V}O_2$  peak, young males 588 would be exercising at intensities slightly below VT1 whereas older males would be 589 exercising at intensities slightly above VT1 (see Table 2). Therefore, although our approach 590 has a few limitations too (Keir et al., 2018), it might be a more suitable method to 591 determine exercise intensity and age-related differences in NM fatigue.

592	The greater absolute intensity sustained during the SEV exercise by young males
593	implies greater force applied to the pedal. It has been established that higher absolute force
594	production during high-intensity cycling exercises leads to great accumulation of
595	metabolites with fatigue (Black et al., 2017). This could explain the great decrements in
596	force and power levels in young participants following the SEV exercise. To test this
597	hypothesis, we explored the association between mean power output sustained during the
598	exercise trials and the decrements in dynamic measures of NM fatigue (% of PRE). Our
599	findings outline that the greater the mean power output sustained during the task, the
600	greater the reduction in Pmax, Tmax, and Vmax levels after the task (i.e., greater levels of
601	fatigue).

602 Although muscle metabolites (e.g., inorganic phosphate) were not measured in this 603 study, we suspect the higher absolute PO sustained during the SEV task by young males led 604 to a greater metabolites' accumulation in young than in older individuals. This presumption 605 can be further supported by the greater levels of force reduction and LFF in young 606 compared with older males. The combination of acidosis and inorganic phosphate (Pi) is an 607 important mediator of muscle fatigue in humans because it causes a dissociation between 608 myosin and actin and, therefore, reverses force generation (Debold, 2012; Sundberg et al., 2018a). When Pi concentrations are increased due to fatigue, Pi can bind to Ca<sup>2+</sup> inside the 609 sarcoplasmic reticulum and decrease Ca<sup>2+</sup> availability (Fryer et al., 1995). The reduction in 610 Ca<sup>2+</sup> for muscle contraction leads to excitation-contraction coupling failure, which is 611 612 reflected by greater LFF (Jones, 1996).

Intramuscular metabolites are not expected to significantly accumulate during MOD exercises (Black et al., 2017). Thus, the cellular mechanisms behind the lower levels of Db100, M-wave, and MRFD observed in young individuals in MOD exercise remain to be elucidated. It should be considered, however, that the lower sample size in this condition might have reduced the power of these findings. Four participants (1 young and 3 old) were excluded from the dynamic measures of fatigue analyses in the MOD condition.

#### 620 4.2 Age-related differences in NM fatigue recovery

621 Despite the absence of age-related differences in NM fatigue at POST WING, young males 622 presented a slower recovery of Pmax, Tmax, and HRT in this condition. These results 623 suggest that Pmax and Tmax recovery may be at least partially limited by factors related to 624 prolongation of muscle relaxation time (Jones et al., 2006) caused by a slower cross-bridge 625 detachment rate in young individuals (Edwards et al., 1975). The recovery of Pmax after a 626 WING is commonly associated with muscle metabolites re-synthesis, such as PCr 627 (Bogdanis et al., 1995). Nevertheless, strong evidences suggest that oxidative capacity in 628 the knee extensors measured through PCr recovery kinetics is slower in older individuals 629 when compared with young adults (Fitzgerald et al., 2016). Therefore, although the slow 630 Pmax and Tmax recovery after the WING in young is a very interesting novel finding of 631 this study, the responsible mechanisms for the delayed recovery in young individuals 632 should be further explored. 633 Different from what has been found after isometric tasks (Dalton et al., 2010a;

634 Yoon et al., 2013; Yoon et al., 2012), our results suggest that NM fatigue recovery kinetics

assessed in isometric mode is overall not affected by age after fatigue induced by dynamic
movements. Some studies have suggested that the delayed recovery of force in older
individuals is 25-35% explained by a slower recovery of central neural drive (i.e., VA
recovery) (Hunter et al., 2008; Dalton et al., 2010a; Yoon et al., 2013; Yoon et al., 2012).
However, we did not find any age-related significant difference in IMVC and VA during
the recovery period across the exercise conditions.

#### 642 4.3 Limitations

643 Because the exercises were not performed to volitional exhaustion, participants did not 644 achieve maximal rate of perceived exertion at the end of the trials (e.g., mean of rate of 645 perceived exertion was 18 out of 20 after the SEV task). There was, however, a clear 646 evidence of large NM fatigue in both age groups, which is notable by the decrease in IMVC 647 following all the exercise trials. In addition, young and older participants cycled at the same 648 relative intensity during the three exercises (i.e., maximal intensity for WING and same 649 percentage of VTs for the other two submaximal exercises). Another limitation is the 650 absence of exercise-related metabolites measurements, which could have supported the 651 presumption of greater accumulation of by-products in the SEV exercise in young vs older 652 participants. It should also be addressed that the redistribution of joint torques with aging 653 can impact T-V relationship assessments. Furthermore, the T-V relationships plotted during 654 7-s cycling sprints represent the force production capacities of all the lower limbs' extensor 655 muscles (Elmer et al., 2011). Differently, during IMVC the quadriceps muscles are mainly 656 recruited during the contraction (Bampouras et al., 2017).

#### 658 **5. Conclusion**

659 In conclusion, by using a novel methodological approach to assess Pmax (i.e., during multi-660 joint lower limb movements), our results add new information to the current literature as 661 we showed that age-related NM fatigue depends on the exercise intensity and duration and 662 that young males are as fatigable-for the WING and MOD exercise-or more fatigable-663 for SEV exercise—than older participants. These results partially confirm previous findings 664 as we showed greater IMVC loss in young adults when young and older individuals cycled 665 at the same relative intensity in the SEV condition. Additionally, we inferred that the 666 mechanism responsible for the greater fatigability response in young individuals in the SEV 667 condition was a greater metabolites accumulation. Interestingly, the only age-related 668 difference in the recovery of NM fatigue was a slower recovery of Pmax, Tmax, and HRT 669 in young males after the WING. These findings suggest that NM recovery in young males 670 may be at least partially limited by factors related to prolongation of muscle relaxation time 671 in this condition.
