Abstract

The extremely halophilic archaeon *Halobacterium salinarum* strain ETD5 was previously isolated from the solar saltern of Sfax (Tunisia) and shown to encode and express halocin S8. The Hbt. salinarum ETD5 culture supernatant was shown here to exhibit high antimicrobial activity against several halophilic archaea and bacteria of different genera, showing a crossdomain inhibition. The antimicrobial activity was destroyed by proteases, thus pointing to halocins. A bioguided purification procedure was applied using two chromatography steps and antimicrobial assays directed against Halorubrum chaoviator ETR14. In-gel screening assay showed the presence of two antimicrobial bands of approximately 8 and 14 kDa, for which characterization was investigated by N-terminal sequencing and mass spectrometry. The full-length form of halocin S8 that contains 81 amino acids and differs from the 36 amino acid short-length halocin S8 previously described from an uncharacterized haloarchaeon S8a, was identified in the 8 kDa halocin band. A novel halocin that we termed halocin S14 was found in the 14 kDa band. It exhibits amino acid sequence identities with the N-terminally truncated region of the archaeal Mn-superoxide dismutase. These results show that Hbt. salinarum ETD5 produces multiple halocins, a feature that had not been described until now in the domain Archaea.

1. Introduction

Microorganisms, which are qualified as extremophiles, are able to colonize extreme environments that are hostile to life and grow thanks to specific mechanisms of adaptation they have developed to survive and face up to severe extreme conditions [1]. Hypersaline environments are extreme habitats that harbor high microbial diversity which varies according to several environmental factors, including salt concentration [2, 3]. These environments are either natural ones, such as coastal lagoons, salt deserts, salt lakes, deep submarine basins and sebkhas, or artificial ones, such as solar salterns built by man for the commercial exploitation of salt [4]. Previous molecular and metagenomic studies conducted for a thorough understanding of the biodiversity and ecology of microorganisms within these environments have shown that microbial life is dominated by members of halophilic archaea belonging to the class Halobacteria [4, 5]. Halobacteria require very high salt concentrations, ranging between 1.5 and 5.8 M NaCl for growth [5]. Interestingly, many halophilic archaea have been demonstrated to produce antimicrobial compounds, among which antimicrobial peptides called halocins [6, 7, 8, 9, 10]. Antimicrobial peptides are universally produced by the three domains of life and act as defense molecules [11]. They are a key element of the innate immune system in eukaryotes and particularly mammals [12, 13]. Antimicrobial peptides are involved in microbial competitions in natural ecosystems. Their production is a common strategy in many Grampositive and -negative bacterial genera to grow at the expense of their competitors [14, 15]. In archaea, several antimicrobial peptides have been identified until now, but only a handful of them have been characterized [7]. Those include halocins and sulfolobicins produced by members of the class *Halobacteria* and the order *Sulfolobales*, respectively. The role of halocins in ecosystems is poorly documented and somewhat controversial. Their production is considered a defense mechanism used by halophilic archaea to inhibit and

dominate competitors of the microbial community in hypersaline environments, essentially in case of nutritional deficiency and lack of niche space [16]. Therefore, these halocins are active essentially against phylogenetically related microorganisms, as also pointed for bacteriocins [15], and also against other prokaryotic species living in the same environment. However, among ninety halophilic archaea and bacteria sampled from different geographically distant hypersaline environments, antimicrobial interactions were found mainly between strains from distant locations, suggesting that hypersaline environments in the world would shelter similar microorganisms with the potential to produce antimicrobial agents [6].

The halocin genes are expressed at the transition between the exponential and stationary

phases of growth [7], except in the case of halocin H1, which is produced during the exponential phase of growth [17]. Currently, only nine halocins have been either potentially identified, or produced and partially characterized from different halophilic archaea [7, 10], while studies have suggested the production of halocins is a universal feature of all members of halophilic archaea [11, 18]. Among them, only four have been purified and more deeply characterized. This is presumably due to difficulties in purifying antimicrobial peptides from halophilic archaea, owing to the presence of the high salt concentrations required in the cultures, which make their isolation a real challenge compared to other bacteriocins. Those four halocins are halocin H4 with a molecular mass of 34.9 kDa produced by *Haloferax* mediterranei R4 isolated from a solar saltern in Spain [19], halocin S8 (HalS8) initially purified from an unidentified haloarchaeal strain S8a, isolated from the Great Salt Lake (Utah, United States) and described to have a molecular mass of 3.6 kDa [20], halocin C8 (HalC8) of 7.4 kDa purified from *Natrinema* sp. AS7092 isolated from a salt lake in China [21] and halocin HA3 (HalHA3) of 13 kDa recently shown to be produced by Haloferax larsenii HA3 isolated from the Pachpadra salt lake (Rajasthan, India) [10].

Previously we have isolated and characterized archaeal and bacterial strains exhibiting antimicrobial activity against halophilic microorganisms from two ponds of different salinity in the solar saltern of Sfax. Among them, we have identified two halophilic archaeal strains *Halobacterium salinarum* ETD5 and *Hbt. salinarum* ETD8, which exhibited a strong antimicrobial activity of peptidic nature and displayed and expressed the gene encoding HalS8 [8]. The aim of the present study was to characterize further the peptides associated with the antimicrobial activity in *Hbt. salinarum* ETD5 using gene analysis, heterologous expression, as well as peptide purification from culture supernatants and characterization. We demonstrate the presence of several halocins produced by *Hbt. salinarum* ETD5, among which the previously identified HalS8 as an 8.6 kDa peptide, and a novel halocin termed halocin S14 (HalS14) that showed amino acid sequence identities with the archaeal Mn-superoxide dismutase (Mn-SOD).

2. Materials and methods

2.1. Archaeal and bacterial strains and growth conditions

Halophilic archaea, *Hbt. salinarum* strain ETD5 (producer strain of HalS8 and HalS14), *Hbt. salinarum* strain ETD8 (producer strain of HalS8), *Halorubrum chaoviator* ETR14 (target strain for the antimicrobial assays) and *Hrr. chaoviator* ETD3 (control strain for SOD activity assay) were isolated from a cristallizer pond of the solar saltern of Sfax in Tunisia (pond TS18; 390 g L⁻¹ total salts) and cultivated in Sea Water medium 25 (SW 25, 3.4 M NaCl, pH 7.2, 37°C), as described previously [8]. Other strains from different genera of halophilic archaea and bacteria, non-halophilic Gram-positive and -negative bacteria used as target strains for antimicrobial assays are from the collection of the laboratory Molecules of Communication and Adaptation of Microorganisms (UMR 7245 CNRS-MNHN), or from

international collections (Japan Collection of Microorganismes, JCM; Deutsche Sammlung 137 von Mikroorganismen und Zellkulturen, DSMZ; Centre de Ressources Biologique de 138 l'Institut Pasteur, CIP). Fungi used as target strains are from the Collection of fungal strains of 139 140 the National Museum of Natural History, Paris, France (LCP), which belongs to the European Culture Collection Organization (ECCO). All these strains are listed in Table 1 [8, 16, 22-45]. 141 For antimicrobial assays, DSMZ Halobacteria medium (M372, 3.4 M NaCl, pH 7, 37°C) 142 (http://www.dsmz.de) was used for the haloarchaeal strains, Trypticase Soy Broth (TSB, 1.7 143 M NaCl, pH 7, 37°C) (Becton Dickinson) and BD Marine Broth (MB, 1.3 M NaCl, pH 7, 144 37°C) (Becton Dickinson) for the halophilic bacteria Nesterenkonia halophila DSM16378 and 145 146 Halomonas sabkhae DSM19122, respectively. A malt extract-sodium chloride medium (malt extract 20 g L-1, 1.2 M NaCl, pH 7, 37°C) was used for the antifungal assays. 147

2.2. Antimicrobial activity assays

- The antimicrobial activity of the halocins was detected by the agar-well diffusion assay, as
 described previously [8]. The antimicrobial activity was determined after two-weeks
 incubation, by the formation of clear inhibition zones around the wells that were measured in
 mm.
- 2.3. Cultivation of Hbt. salinarum ETD5 for production of halocins and treatment of the

Optimal production growth phase of antimicrobial activity by *Hbt. salinarum* ETD5 was determined previously [8]. Briefly, a stationary stage preculture of strain ETD5 was used to inoculate a 2-liter culture in SW25 medium supplemented with 3.4 M NaCl. The culture was incubated for 72 h (stationary phase of growth) at 37°C with continuous 200 rpm shaking and further centrifuged for 45 min at 8000 g. The crude supernatant (CS) was then dialyzed with

Spectra-Por® 3, MWCO 3.5 kDa membrane against 1.7 M NaCl for 24 h at 4°C to obtain dialysed culture supernatant (DCS). The DCS was concentrated under reduced pressure (Rotavapor®) for 3 h at 50°C and a pressure of 60 mPa, until a final volume of 500 mL (concentrated culture supernatant, CCS) and filtered through 0.22 µm filters (Sartorius), to generate filtered culture supernatant (FCS). The antimicrobial activity was tested against the susceptible strain *Hrr. chaoviator* ETR14. The FCS was further subjected either to various treatments or to the purification procedure (see below).

- 2. 4. .Susceptibility of Hbt. salinarum ETD5 antimicrobial activity to detergents, variations of
 the NaCl concentration and proteolytic enzymes
- The *Hbt. salinarum* ETD5 crude supernatant was used for susceptibility assays of the antimicrobial agents to the different treatments. After each treatment, the antimicrobial activity was tested against *Hrr. chaoviator* ETR14.
- 172 For the susceptibility to detergents, the *Hbt. salinarum* ETD5 supernatant was treated with Tween-20 or Triton X-100 at different concentrations (1 to 10%) and incubated for 1 h at 173 37°C. For the susceptibility to NaCl concentration, the supernatant was dialyzed with 174 Spectra/Por® 6 MWCO 1 kDa membrane against Tris-HCl 10 mM, pH 7 buffer to fully 175 remove NaCl. Different NaCl concentrations from 0.5 to 4 M were then prepared starting 176 from the desalted supernatant. For the susceptibility to proteases, the supernatant was treated 177 with chymotrypsin, thermolysin or endoproteinase GluC (Sigma-Aldrich) at 20 ng µL-1 in 178 ammonium bicarbonate buffer 50 mM, pH 8, overnight at 37°C. Antimicrobial assays were 179 180 performed as described above.

2.4. DNA sequence of the HalS8 precursor gene

Total DNA was extracted from the cell pellet of a 40 mL stationary phase culture from 182 Hbt. salinarum ETD5, as previously described [8]. PCR reactions were carried out on a Veriti 183 Thermal Cycler (Applied Biosystems) as previously reported [8]. Oligonucleotide primers 184 were designed according to the analysis of the sequence of the gene encoding the HalS8 185 precursor (Genbank AF276080) in the unidentified haloarchaeon S8a [20]: halS8-F (5'-186 CGCATATCGGATAAAGACAGC-3') halS8-R (5'and 187 GAATTCACCAGAAGCTAGTCCATTCAT-3'). Amplified products were submitted to 188 electrophoresis on 1% (w/v) agarose gels in Tris-acetic acid-EDTA buffer containing 1X 189 GelRed® (Biotium, VWR) and visualised under UV light. Amplicons were purified using the 190 191 Gene CleanH Turbo kit (MPBio) and cloned into the pGEM-T Easy vector (Promega) following the manufacturer's instructions. Plasmid DNA from positive clones was extracted 192 using the QuickLyseH kit (Qiagen, France) and sequenced by Eurofins MWG Operon 193 194 (Germany). The sequences were compared with the GenBank database using the BlastN algorithm. Nucleotide sequence of the halS8 gene has been deposited under accession number 195 KR611165. 196

197 2.5. Purification of the Hbt. salinarum ETD5 halocins

A two-steps procedure including (i) hydrophobic interaction chromatography and (ii) ion exchange chromatography was applied to the *Hbt. salinarum* ETD5 FCS prepared as described above. Antimicrobial activity was monitored throughout the purification procedure using *Hrr. chaoviator* ETR14, as described above. (i) The FCS was submitted to a fast protein liquid chromatography FPLC (AKTATM Purifier system, GE Healthcare) using a Phenyl-Sepharose 6 Fast Flow XK 16/20 column (GE Healthcare) previously equilibrated with 150 mL of 25 mM Tris-HCl, 3.5 M NaCl, pH 8 (buffer A). After injection of 500 mL of the sample, the column was washed with buffer A to a stable OD at 214 nm and the fractions

were eluted at a flow rate of 1 mL min⁻¹ using a gradient of 0 to 80% acetonitrile (ACN) in buffer A. The proteins were detected at 214 nm and 1 mL fractions were automatically collected and submitted to antimicrobial assays using the agar well diffusion method. Active fractions were concentrated to 0.5 mL using a SpeedVac® (Savant) and further pooled. (ii) 1 mL of the active fractions obtained from the Phenyl-Sepharose step was loaded onto a MonoQ HR 5/5 column (GE Healthcare) previously washed with 5 mL of 25 mM Tris-HCl buffer, pH 8 (buffer B) and equilibrated with 10 mL of 25 mM Tris-HCl buffer, 1.5 M NaCl, pH 8. The column was washed with 5 mL of buffer B before injection of the sample and fractions were eluted at a flow rate of 0.25 mL min⁻¹ with a step-increasing gradient from 25 to 500 mM NaCl. The proteins were detected at 214 nm and 1 mL fractions were automatically collected and concentrated using a SpeedVac® (Savant). The fractions were stored at 4°C until analysis.

2.6. Polyacrylamide gel electrophoresis and antimicrobial in-gel assay

The purification fractions were analyzed by sodium dodecyl sulfate polyacrylamide gel electrophoresis (SDS-PAGE) on 17% SDS Tris-tricine polyacrylamide gels. PageRuler low range unstained protein ladder (Fermentas) or Ultra-low range molecular weight marker (Sigma-Aldrich), or low range rainbow molecular weight marker (GE Healthcare) were used as molecular weight standards. For the in-gel assay, 20 µL of a purified fraction were loaded onto two lanes of a 17% SDS Tris-tricine polyacrylamide gel. Following separation, the first part of the gel containing the PageRuler molecular weight marker was fixed with 40% (v/v) methanol, 7% (v/v) acetic acid and stained with silver nitrate. After staining, the gel was visualized using a Fusion-FX7 system (Viber Lourmat). The second part of the gel containing the colored low range rainbow molecular weight marker was fixed for 30 min in 15% (v/v) isopropanol and 10% (v/v) acetic acid and washed with MilliQ® water (Merck Millipore)

overnight. This unstained gel was then deposited on SW agar and overlaid with 10 mL SW soft agar inoculated with 100 μ L of a *Hrr. chaoviator* ETR14 preculture at the end of the exponential phase of growth. Plates were incubated at 37°C for two weeks and examined for inhibition halos.

2.7. SOD assay

Intracellular protein extracts were obtained from cultures of Hbt. salinarum ETD5, Hbt. salinarum ETD8 or Hrr. chaoviator ETD3, in 50 mL of SW 25 medium. After centrifugation of 5 mL of the culture, cell pellets were resuspended in 2 mL of lysis buffer (25 mM Tris-HCl 2 mM EDTA, pH 7.6) supplemented with 1.7 M NaCl. The mixtures were incubated with 0.25 mg.mL⁻¹ lysozyme (Sigma-Aldrich) for 20 min at room temperature. The cell walls were destroyed by ultrasound sequences (8 times for 15 s at 30% amplitude in ice) using a sonicator (Branson Digital Sonicator). Cell debris were centrifuged for 10 min at 10 000 g. The SOD activity was revealed on a 12% gel under native conditions containing riboflavin (Sigma-Aldrich) and 4-nitro-blue tetrazolium chloride (NBT) (Sigma-Aldrich), according to a protocol optimized from [46] and [47]. After 3 h of 90 V pre-electrophoresis in 10% migration buffer (0.19 M Tris-HCl, 1 mM EDTA, pH 8.8) to remove N, N, N', N'tetramethylethylenediamine (TEMED) and ammonium persulfate, either 100 ng of intracellular proteins extracted from the cell pellets of Hbt. salinarum ETD5, Hbt. salinarum ETD8 or Hrr. chaoviator ETD3 used as control, or the Phenyl-Sepharose fraction were submitted to electrophoresis. The gel was first stained with a solution containing 2.45 mM NBT, 1.7 M NaCl, 50 mM sodium phosphate buffer, pH 7.4 for 15 min in the dark. The solution was emptied and the gel was further stained with a second solution of 28 mM TEMED and 0.06 mM riboflavin in the same buffer and incubated for 15 min in the dark. Finally, the gel was illuminated with a fluorescent lamp for 15 min to initiate the

photochemical reaction. All procedures were carried out at room temperature and the SOD positive bands were visualized as clear white regions in the blue formazan background.

2.8. Extraction of halocins from SDS-PAGE gels

The 8 kDa- and 14 kDa-bands from the Phenyl-Sepharose purified fractions were excised from an SDS-PAGE gel stained with Blue Safe (LabSafeTM Gel Blue, G-Biosciences), washed with MilliQ® water (Merck Millipore), ground and Speedvac® (Savant) dried for Edman sequencing and mass spectrometry analysis. For Edman sequencing, the bands were incubated at 37°C overnight with agitation in 100 mM Tris-HCl, 3.5 mM SDS, 100 mM NaCl, pH 8 transfer buffer. A polyvinylidene fluoride membrane was activated by methanol for 60 s, rinsed with MilliQ® water (Merck Millipore) and incubated with the bands at 37°C for 24 h for peptide transfer before being submitted to protein sequencing. For mass spectrometry, the bands were excised from the gel and subjected to reduction and alkylation, using two successive incubations with 10 mM DTT (Sigma-Aldrich) for 1 h at 57°C and 55 mM iodoacetamide (Sigma-Aldrich) for 1 h at room temperature in the dark. The bands were then treated as described previously [48], with the exception that the digestion was performed with chymotrypsin (Sigma-Aldrich) at 20 ng μ L⁻¹. The digests were analyzed by liquid chromatography - mass spectrometry (LC-MS).

271 2.9. Edman sequencing

N-terminal sequencing was carried out by automated stepwise Edman degradation using a
Procise Model 492 protein sequencer (Applied Biosystems) according to the manufacturer
protocol.

2.10 Mass spectrometry

Sequence analyses of the chymotrypsin digests of the 8 kDa- and 14 kDa-bands were conducted by LC-MS/MS on an Ultimate U3000 Micro-LC system (Thermo Scientific) connected to an ESI-Q-TOF mass spectrometer (Q-STAR Pulsar, Sciex). The separation was carried out on a C18 Uptisphere 5WTF micro-column (1x150 mm, 5 µm, Interchim), using the following gradient of mobile phase A (ultra-pure water/0.1% formic acid) and B (HPLCgrade acetonitrile/0.08% formic acid) over a total run time of 55 min: linear increase from 10% B to 60% B for 40 min, linear increase to 100% B for 5 min, decrease to 10% B for 1 min, at a flow rate of 40 µL min⁻¹. The MS instrument was operated in positive ion mode using information-dependent acquisition, a mode which completes a series of 1-s survey scans (m/z detection range 250-1,300) followed by two 2-s MS-MS experiments on the two most intense peaks from the survey scan, as long as they have not been fragmented in the last 2 min (m/z detection range 50–500). The data generated were analyzed with MASCOT MS-MS ion search engine [49]. For precise mass measurement of the 8 kDa-band, the samples were analyzed by LC-MS on a ultra-high performance LC system (UHPLC, Ultimate 3000 RSLC, Thermo Scientific) connected to a high-resolution ESI-Q-TOF mass spectrometer (Maxis II ETD, Bruker Daltonics). Separation was achieved on a Jupiter C4 column (1x250 mm, 5 µm, 300 Å, Phenomenex) at a flow rate of 200 μL.min⁻¹, using the following gradient of solvent A and solvent B' (HPLC-MS-grade acetonitrile/0.08% formic acid) over a total run time of 22 min: isocratic elution with 5% B' for 2 min, linear increase from 5% to 95% B' for 10 min, isocratic elution with 95% B' for 3 min, linear decrease to 5% B' for 0.1 min. The MS spectra were acquired in positive ion mode in the mass range m/z 300–3000. The source parameters were as follows: nebulizer gas 26 psi, dry gas 8 L/min, capillary voltage 4500 V, end plate offset 500 V, temperature 200°C.

3. Results

3.1. Spectrum of activity of Hbt. salinarum ETD5

The extreme halophilic *Hbt. salinarum* ETD5 isolated from the crystallizer pond TS18 of the solar saltern of Sfax has been shown previously to inhibit the growth of several halophilic strains from the same environments [8]. We examined further the spectrum of activity of this strain by antimicrobial assays conducted with the ETD5 culture supernatant against various halophilic archaea, halophilic and non-halophilic bacteria and fungi (Table 2). *Hbt. salinarum* ETD5 exhibited a broad spectrum of activity directed against both several halophilic archaea of different genera, and particularly *Halobacterium*, *Haloarcula*, *Haloterrigena* and to a lesser extent *Natrinema*, as well as against halophilic bacteria, such as *Salinibacter ruber* and *Lentibacillus halophilus*. Unexpectedly, one non-halophilic human pathogen, *Pseudomonas aeruginosa* was inhibited by *Hbt. salinarum* ETD5 supernatant. Antimicrobial assays performed against other non-halophilic bacteria and halophilic fungi were negative. At this stage, the results point that *Hbt. salinarum* ETD5 has a broad spectrum of activity that not only targets tightly related archaea.

- 3.2. Effects of proteolytic enzymes, NaCl concentration and detergents on the Hbt.

 3.1. Salinarum ETD5 antimicrobial activity
 - The sensitivity of the *Hbt. salinarum* ETD5 antimicrobial activity to proteolytic enzymes, NaCl concentration and detergents was examined to both estimate the stability of the potential halocins toward these factors and direct the optimization of the purification procedure. The activity was assayed against *Hrr. chaoviator* ETR14, an haloarchaeon we previously isolated from the saline of Sfax with optimal sensitivity in the antagonistic assays [8] (Table 3).
 - Treatments of the *Hbt. salinarum* ETD5 supernatant with chymotrypsin, thermolysin or endoproteinase GluC resulted in a total loss of activity against *Hrr. chaoviator* ETR14, indicating unambiguously the proteinaceous nature of the compounds involved. It could thus

be deduced that the production of one or several halocins was related to the *Hbt. salinarum* 325 ETD5 activity. As regard the effects of the NaCl concentration, the inhibition halos were 326 significantly lower (from 32 [\pm 0.8] mm to 18 [\pm 1.6] mm) upon dialysis against MilliQ[®] water 327 (Merck Millipore) and 0.5 M NaCl was not sufficient to restore the initial activity (Table 3). 328 Increasing NaCl concentration allowed better antimicrobial activity, with an optimum 329 between 1.5 and 4 M NaCl (Table 3). Such a requirement of a NaCl concentration threshold 330 331 to remain active is a characteristic already described for other halocins [7]. Finally, the ETD5 supernatant was treated with detergents at concentrations between 1%o and 10%o. Significant 332 lower inhibition halos were observed with the different concentrations of Tween-20 or Triton 333 334 X-100. They were only 12 (\pm 1.6) and 13 (\pm 0.8) mm in diameter at 10% Tween 20 and Triton X-100, respectively, compared to the control untreated supernatant which exhibited a 335 $32 (\pm 0.8)$ mm diameter (Table 3). Sensitivity of the supernatant activity to proteases suggests 336 337 that the antimicrobial compounds produced by Hbt. salinarum ETD5 can be attributed to halocins. In addition, these results point that detergents have to be prohibited for their 338 purification. 339

3.40 *3.3. Sequence of the HalS8 precursor gene* halS8

We had previously shown that *Hbt. salinarum* ETD5 encodes and expresses HalS8 [8], but the complete *halS8* gene had not been sequenced. To determine the predicted amino acid sequence of the HalS8 antimicrobial peptide, the complete sequence of the *halS8* gene was determined here. PCR amplification using primers designed to be localized upstream and downstream the nucleotide sequence of *halS8* that encodes the HalS8 precursor and the DNA extracted from *Hbt. salinarum* ETD5 as template, showed amplification of a fragment of 1824 bp. The amplicons were cloned and sequenced. The translation of the 1824 bp-fragment exhibited an open reading frame of the expected size (936 bp) for the gene encoding the

HalS8 precursor. Analysis of the predicted complete amino acid sequences confirmed that the genome of *Hbt. salinarum* ETD5 contains a complete *halS8* gene, with an amino acid sequence almost identical to that of strain S8a, initially described as producing HalS8 [20]. Along the 311 residues of the HalS8 precursor, a single substitution of a valine at position 185 in strain S8a for isoleucine in *Hbt. salinarum* ETD5 was observed (Fig. 1). Moreover, the amino acid sequence deduced from the *halS8* gene located on megaplasmid 2 of *Halobacterium* sp. GN101 [7] which has been shown to produce halocin R1 [18], is identical to that deduced from the *halS8* gene sequence of *Hbt. salinarum* ETD5 (Fig. 1).

3.4. Pre-purification of halocins from Hbt. salinarum ETD5 cultures

All attemps for heterologous expression of HalS8, either in a halophilic archaeal strain, *Haloferax volcanii* H98 [50] or in *Escherichia coli* were unsuccessful (data not shown). In parallel, classical methods for production and purification of the halocins produced by *Hbt. salinarum* ETD5 were conducted. Optimal culture conditions in terms of culture medium and phase of growth for maximal antimicrobial production by strain ETD5 determined previously [8] were applied. Cultures of 0.5 to 2 L grown in SW25 medium supplemented with 3.4 M of NaCl were used to compare the efficiency of several chromatography techniques in permitting the isolation of the antimicrobial peptides. Solid phase extraction on SepPak® C18 cartridges of the FCS showed activity in the 80% ACN fraction only, pointing the highly hydrophobic nature of the peptides. Reversed-phase C8 HPLC, gel filtration on Sephadex G25, or chromatography on Phenyl Sepharose were applied, but only the Phenyl Sepharose procedure allowed recovering a significant activity (data not shown). It was thus retained as the first step of purification and for obtaining a pre-purified halocin fraction.

3.5. Purification of halocins

Hbt. salinarum ETD5 halocins were purified in a two-step procedure including successive hydrophobic interaction and anion exchange chromatographies, using Phenyl Sepharose and MonoQ columns, respectively. The purification was guided by antimicrobial assays against Hrr. chaoviator ETR14. At the level of the first step (Supplemental Fig. S1A and Supplemental Fig. S1C), 27 fractions which revealed antimicrobial activity with diameters of 8 to 22 mm, were further pooled and named fraction P3. SDS-PAGE analysis on a 17% polyacrylamide gel and silver nitrate staining revealed a quite complex mixture of proteins, among which a major one around 8 kDa, several others between 12 and 14 kDa and one at about 24 kDa. Two of the bands, which were observed at approximately 8 and 14 kDa (Fig. 2A), led to a strong inhibition of the growth of Hrr. chaoviator ETR14 overlaid in an in-gel screening assay (Fig. 2B). No band was observed below 8 kDa, thus excluding the presence of significant amounts of a peptide of 3.6 kDa that could correspond to the 36-residue HalS8 previously described [20].

A second purification step was carried out on the fraction P3 by anion exchange chromatography (Supplemental Fig. S1B). The antimicrobial assays revealed only two active fractions, E6 and E7. When analyzed on Tris-tricine SDS-PAGE gel stained with silver nitrate, two bands at about 8 and 14 kDa of almost similar intensity were observed in fraction E6, while a main band at about 14 kDa was observed in fraction E7 (Fig. 2C). The 8 kDa- and 14 kDa-bands, corresponding to proteins with antimicrobial activity as detected with the ingel assay, corresponded to halocins. These active fractions highly enriched in halocins were used for further characterization.

3.6. Characterization of the 8 kDa halocin band

Edman sequencing identified SDCNINXNT as the nine N-terminal amino acids of the 8 kDa halocin band (Fig. 3A). They were in agreement with those previously determined by

Price and Shand for the HalS8 peptide from the unidentified strain S8a [20]. Undigested 8 kDa halocin band excised from SDS-PAGE gel was analyzed by LC-MS (Fig. 4), which revealed [M+nH]ⁿ⁺ species with charge states 8+ to 13+. This corresponded to the theoretical mass of 8589 Da calculated for a full-size 81 amino acid HalS8 containing 8 oxidized cysteines, as expected from the amino sequence deduced from the precursor nucleotide sequence. Consequently, as opposed to HalS8 from strain S8a, the amino acid sequence of HalS8 from Hbt. salinarum ETD5 did not appear to involve a cleavage of the precursor in the C-terminal region (Fig. 3A). This result suggests that HalS8 is produced by *Hbt. salinarum* ETD5 under a full-size 81 amino acid peptide, while the 36 amino acid peptide described by [20] from strain S8a is not detected in strain ETD5. To analyze further the amino acid sequence of the 8 kDa halocin band, the chymotrypsin digest was also analyzed by LC-MS/MS. However, no peptide corresponding to HalS8 could be clearly identified, while analysis revealed peptides assigned to flagellin B2 and an hypothetical protein VNG_2044H deduced from the genome of Halobacterium salinarum NRC-1(data not shown). The lack of detection of HalS8 chymotrypsic peptides could be due to its compact structure linked to the presence of 4 disulfide bridges, which would not allow chymotrypsin to access its digestion target sites, despite the reduction and alkylation treatments we used before digestion.

3.7. Characterization of the 14 kDa halocin band

Edman sequencing identified the twelve first amino acids GALGDVQXNGII in the N-terminal region of 14 kDa halocin band from the SDS-PAGE gel (Fig. 3B). Analysis of the chymotrypsin digest by LC-MS/MS allowed identifying the sequences of three peptides (Fig. 3B), for which homology searches in the GenBank database by BlastP algorithm revealed similarity to the 200 residue Mn-superoxide dismutase (Mn-SOD) of *Hbt. salinarum* NRC-1 (UniProt n° P09737) (Fig. 4B). Remarquably, the N-terminal sequence identified by Edman

analysis also presented 75% identity to a sequence found in the Mn-SOD. Such a N-terminal end would yield a protein of approximately 14 kDa, consistent with the mass on SDS-PAGE. Besides the Mn-SOD peptides, we also found digestion peptides assigned to flagellins and the hypothetical protein VNG_2044H deduced from the genome of *Halobacterium salinarum* NRC-1 (data not shown), as also observed for the 8 kDa halocin band, which were attributed to contaminants.

Taken together these results suggest that the 14 kDa halocin band, to which antimicrobial activity is associated, contains a novel halocin that presents similarities to Mn-SOD enzymes, and that we termed HalS14. It appears that one of the four manganese-binding sites of the catalytic site of Mn-SOD from *Hbt. salinarum* NRC-1, which is located in the N-terminal region is lost in the HalS14 amino acid sequence (H29), while the three other sites (H73, D158, H162) are still present (Fig. 3B).

3.8. Antioxidant and antimicrobial activities of Hbt. salinarum ETD5

Because HalS14 amino acid sequence displayed similarities to Mn-SOD enzymes from other halophilic archaea and particularly *Hbt. salinarum* NRC-1, the SOD activity was tested. The fraction from Phenyl-Sepharose enriched in HalS14, and the whole intracellular proteins extracted from cell pellets of *Hbt. salinarum* ETD5, *Hbt. salinarum* ETD8 and *Hrr. chaoviator* ETD3 [8, 51] were submitted to the NBT assay (Supplemental Fig. S2). Native gel electrophoresis showed that together with *Hrr. chaoviator* ETD3 and *Hbt. salinarum* ETD8, *Hbt. salinarum* ETD5 whole intracellular protein extract exhibited strong SOD activity (Supplemental Fig. S2). By contrast, the HalS14-enriched fraction did not display such activity (Supplemental Fig. S2). Parallel determination of the antimicrobial activity showed it strongly inhibited *Hrr. chaoviator* ETR14 (data not shown). Altogether these results indicate that whole intracellular proteins from *Hbt. salinarum* ETD5 exhibit both SOD and

antimicrobial activities, in agreement with the presence of the SOD enzyme in strain ETD5, and that HalS14 is associated to the antimicrobial activity against strain ETR14, but devoid of SOD activity.

4. **Discussion**

This study aimed at identifying the halocins responsible for the antagonistic properties exhibited by the extreme haloarchaeon Hbt. salinarum ETD5 isolated from the crystallizer pond TS18 in the solar saltern of Sfax [8]). Here we used a procedure optimized for Hbt. salinarum ETD5 that associated dialysis of the supernatant to decrease NaCl concentration until reaching the threshold that allows the activity to be preserved, concentration under reduced pressure, and a separation protocol using hydrophobic interaction and ion exchange chromatographies. However, due to low production yields of the antimicrobial peptides and the lack of usable archaeal tools for obtaining recombinant halocins in spite of tenacious efforts, we only obtained tiny amounts of partly purified HalS8 and HalS14 that were used for further characterization. The complete amino acid sequence of the HalS8 precursor determined in this study shows identity with predicted amino acid sequences of the HalS8 precursors from the uncharacterized haloarchaeon S8a isolated from the Great Salt Lake [20] and Halobacterium sp. GN101, with only one substitution among the 311 residues. In a pioneer study, HalS8 was identified as a 36 amino acid peptide produced by strain S8a [20]. This short-length form of the halocin would require a double proteolytic processing of the 311-amino acid precursor encoded by the gene halS8 [7]. The first processing would occur at an N-terminal site to release a leader peptide, similar to what is usually observed for bacteriocins and microcins [52]. The second processing would release the 45 amino acid C-terminal region. In bacteriocins and archaeocins, a double precursor processing leading to two fragments with different functions is a rare and original feature. It was observed for the first time for HalC8, which maturation leads both to the halocin and the immunity protein that protects the strain against its antimicrobial toxin [21]. The mature 76 residue HalC8 is produced by release from the N-terminus of a 40 amino acid Tat signal peptide, followed by a 167 amino acid immunity protein, and there is no cleavage at the C-terminus. Therefore, similar to what happens for HalC8, it could be hypothesized here that the 230 amino acid N-terminal region released from the HalS8 precursor could contain a short leader or signal peptide, followed by an immunity protein.

Here we have shown that in *Hbt. salinarum* ETD5 HalS8 is likely produced under a full-length 81 amino acid peptide that results from a single proteolytic cleavage. Since the maturation processes observed in strains S8a and *Hbt. salinarum* ETD5 appear distinct, the question is raised of the hypotheses that could explain the occurrence of two different maturation processes leading to two different forms of this halocin, depending on the archaeon strain. This could either come from i) a different maturation in the two strains having different genetic and ecological backgrounds, ii) a different growth state of the strains when the cultures were harvested that could favor a single or a double processing, or iii) a purification process that could induce the supplementary C-terminal cleavage or favor the purification of one form over the other. Further work comparing the two strains would bring data allowing to strengthen either of these hypotheses and evidence if two different maturation processes can coexist in halophilic archaea for the production of short-length or/and longer forms of a given halocin.

The newly identified halocin HalS14 exhibits amino acid sequence similarities to the Mn-SOD of *Hbt. salinarum* and its molecular weight, as determined on SDS-PAGE, is consistent with a proteolytic processing of the Mn-SOD at the N-terminal extremity. To cope with harsh conditions and combat reactive oxygen species (ROS) halophilic archaea use enzymatic

degradation systems, among which SOD. These metalloenzymes catalyze the dismutation of the superoxide anion to dioxygen and hydrogen peroxide [53, 54]. The presence and expression of genes encoding proteins of the SOD family are found in various species of halophilic archaea [55]. Interestingly, the genomes of Halobacterium strains were found to contain two copies of divergent paralogous SOD-encoding genes, among which the expression of only one was induced by oxidative stress [56]. In Hbt. salinarum ETD5, SOD would be produced to play this protecting role against ROS, but also it would be processed to produce HalS14. Alternatively, HalS14 may be derived from the expression of the copy of the SOD gene that is not dependent on oxidative stress. Thus, HalS14 may contribute to the competition strategies in concert with HalS8. This could explain the higher antimicrobial activity exhibited by Hbt. salinarum ETD5 compared to Hbt. salinarum ETD8, a strain we identified in the same crystallizer pond of the saline of Sfax and that also expresses the halS8 gene similar to Hbt. salinarum ETD5 [8]. The production of more than one bacteriocin, with two or more being quite common, has already been described in both Gram-positive and negative bacteria [57, 58, 59]. However, there is little understanding of the reasons why multiple production of bacteriocins and microcins encoded in the same bacterial strain is not so rare. It could increase the competitiveness of the strain, confer a selective advantage in different environments, or decrease the evolution of resistance to the bacteriocin [60], but none of these hypotheses has been tested experimentally. By contrast, and although it was suggested previously [9, 61], this is the first time in this study that such a co-occurrence of several archaeocins in a single halophilic archaeal strain is clearly evidenced. Therefore, strain ETD5 would be particularly well equipped to occupy the niche and outcompete many other haloarchaeal strains in the solar saltern. This could explain the broad spectrum of activity of the strain, which inhibits the growth of different genera of halophilic archaea (Halobacterium, Haloarcula, Natrinema, Haloterrigena) and bacteria (Salinibacter and

Lentibacillus). This result is interesting, because halocins are expected to be active essentially on closely related archaea, although cross-domain inhibitions have been documented in previous studies [6]. In this study, *Hbt. salinarum* ETD5 culture supernatant also appeared capable of inhibiting *P. aeruginosa*. However, to be able to estimate the importance of this result, it is necessary first to delineate the respective roles of HalS8 and HalS14, and other potential antimicrobial compounds in the activity against this pathogen.

HalS14 may derive from a proteolytic processing of the *Hbt. salinarum* Mn-SOD that would eliminate an N-terminal 60-residue region to lead to the 140 amino acid antimicrobial peptide HalS14. Such a feature, an antimicrobial peptide resulting from the processing of a major protein endowed with a vital function would represent a completely novel finding in archaea. By contrast, few examples among a lot can be reported in eukaryotes. A short antifungal peptide was found produced in the shrimp *Litopenaeus vannamei* by cleavage of hemocyanin [62], the respiratory pigment serving the role of hemoglobin in crustaceans. Similarly, antimicrobial peptides derive from hemoglobin in mammals [63]. Other antimicrobial peptides are processed from histones [64], milk proteins [65], or matrix proteins [66]. Interestingly, the C-terminal region of the human extracellular SOD leads to a cationic heparin-binding peptide that shows a broad antimicrobial spectrum against bacteria and fungi [67]. It is the first time here that such a processing, which is to our knowledge not observed in bacteria, could be hypothesized in archaea, similarly to eukaryotes.

In conclusion, this study has demonstrated for the first time the co-occurrence of different halocins that could act in concert in a haloarchaeal strain. We have shown that HalS8 is produced by *Hbt. salinarum* under its full-length 81 amino acid peptide. Furthermore, we showed that the second halocin, HalS14 could derive from the *Hbt. salinarum* SOD through a specific proteolytic cleavage, which would make a major *Halobacterium* protein endowed with a vital function in the archaeon also able to ensure a function of defense or competition.

Further studies will have to evaluate if the two halocins have different and complementary spectra of activity and if they act in synergy or not, in order to better appreciate their roles in nature. Taken together these results show that the *Hbt. salinarum* strain ETD5 is particularly well equipped for microbial competitions and open new tracks to deeper determine the importance and the roles of microorganisms in extreme environments and particularly those of halophilic archaea, which are a source of active biomolecules with many functions, and particularly antimicrobial and antioxidant factors.

Tris-tricine SDS PAGE and detection of the antimicrobial activity of the fractions eluted from the Phenyl-Sepharose and the MonoQ columns. (A) Analysis of the Phenyl-758 Sepharose fractions, gel stained with silver nitrate; M: molecular mass standard (PageRuler 759 760 low range unstained protein ladder); lanes 1 and 2: active fractions D7 and D8 from peak P3, respectively. (B) unstained gel, overlaid with Hrr. chaoviator ETR14 cells inoculated in SW 761 soft agar; M: molecular mass standard (colored marker low range rainbow molecular weight); 762 lane 1: purified fraction P3 from Phenyl-Sepharose. Localization of the peptides obtained by Edman degradation (white boxes) and LC/MS-MS of the chymotrypsin digests (grey boxes) in the 770 amino acid sequences of (A) the HalS8 precursor and (B) the Mn-SOD from Hbt. salinarum 771 772 NRC-1 (UniProt entry n° P09737). Vertical lines indicate proteolytic processings of the

halocin precursors: (A) N-terminal processing (black double arrow) common to this study and 773 [20] and C-terminal processing (dotted line) hypothesized by [20]; the residue in bold has not 774 been identified in Edman sequencing; stars point the eight cysteines. 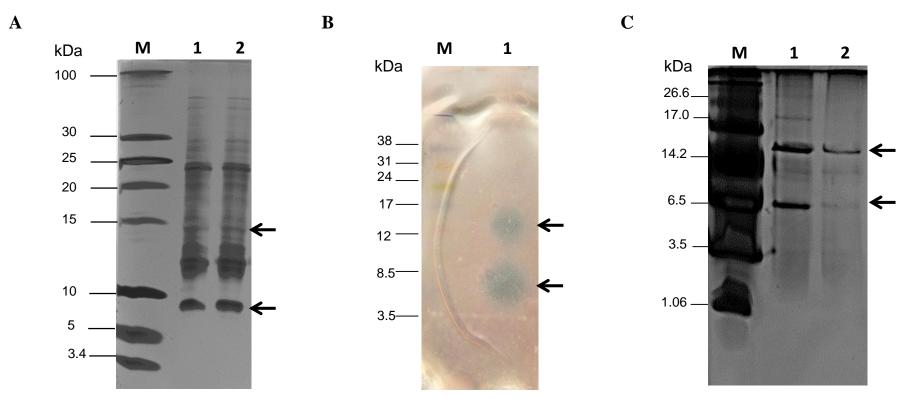

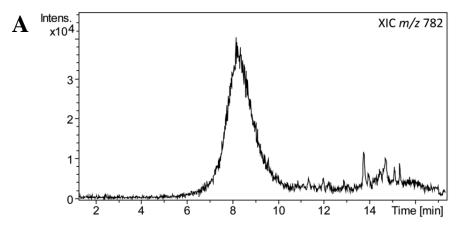

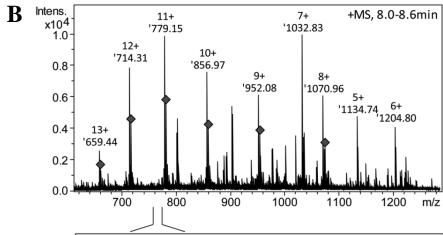

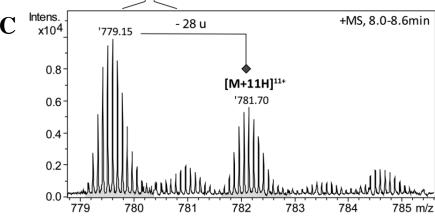
