# Triterpenoid saponins from *Calliandra calothyrsus* Meisn. and their antiproliferative activity against two digestive carcinoma human cell lines

#### ABSTRACT

The chemical investigation of the flowers and twigs of *Calliandra calothyrsus* (Fabaceae) led to the isolation of three new oleanane-type triterpenoid saponins, named calothyrsusosides A–C (1–3). Their structures were established by direct interpretation of their spectral data, mainly HRESIMS, 1D NMR and 2D NMR (<sup>1</sup>H, <sup>1</sup>H-NMR DOSY, <sup>13</sup>C-NMR, COSY, HSQC, HMBC, HSQC-TOCSY and NOESY) and by comparison with literature data. Compounds **1** and **2** were tested for their antiproliferative activity against two digestive carcinoma human cell lines: Hep3B (hepatocellular carcinoma) and Caco-2 (epithelial colorectal adenocarcinoma). Both compounds exhibited an antiproliferative activity against the Hep3B cell line, with IC<sub>50</sub> values of 6.0 and 6.5  $\mu$ M, respectively, while no effect was detected against the epithelial colorectal adenocarcinoma Caco-2 (CC<sub>50</sub> > 25  $\mu$ M).

### **1. Introduction**

The genus *Calliandra* (Fabaceae) is made up of about 140 species native to tropical and subtropical regions of the Americas. Calliandra calothyrsus Meisn. is a small leguminous tree of the Fabaceae family that is widely distributed throughout Central America and southern Mexico [1,2]. It is usually 13 to 20 feet (4 to 6 m) high but might reach 40 feet (12 m) under favorable conditions. The leaves are suitable for forage and give a higher yield than other shrub legumes, especially when grown on acid soil [3]. It has been introduced into many tropical regions where it is used in agroforestry systems for fuelwood, plantation shade, as an intercropping hedgerow and more recently as livestock forage. Acetonic extracts of the leaves of C. calothyrsus exhibited in vitro negative effects on eggs and larvae of Haemonchus contortus parasite of ruminants [4]. Previous phytochemical studies of C. calothyrsus revealed the presence of glycosylflavonoids of its leaves [5]. No previous phytochemical study has been reported on saponins from this plant, but studies on related species of this genus revealed the presence of triterpenoid saponins, consisting mainly of glycosides of oleanolic acid and echinocystic acid as aglycon with an Ara-<sup>2</sup>Ara-<sup>6</sup>GlcNAc-<sup>3</sup>Agly oligosaccharidic sequence commonly encountered [6-12]. In this paper, we describe the isolation and structure elucidation of three new triterpenoid saponins designated as calothyrsusosides A-C (1-3). Compounds 1 and 2 were tested for their antiproliferative effects on two digestive cancer cell lines, i.e. Hep3B (hepatocellular carcinoma) and Caco-2 (epithelial colorectal adenocarcinoma).

#### 2. Experimental

#### 2.1. General experimental procedures

Optical rotations were measured on a Jasco P-2000 polarimeter. NMR experiments were performed at 298 K in pyridine-d5 and D<sub>6</sub>MSO on a Bruker AVANCE 500MHz spectrometer equipped with a 5 mm Z-gradient TCI cryoprobe. HRESIMS spectra were recorded using a UHPLC-DAD-LTQ Orbitrap XL instrument (Thermo Fisher Scientific, UK) equipped with an

electrospray ionization source (ESI). Isolations were carried out using a medium-pressure liquid chromatography (MPLC) system [Buchi Pump manager C-615, Buchi Pump module C-605, Column Buchi, borosilikat (460 x 25 mm and 460 x 15 mm)] and column chromatography (CC) on reversed-phase RP-18 silica gel 60 (25-40  $\mu$ m). Thin layer chromatography (TLC) was performed on precoated silica gel plates (60 F<sub>254</sub>, Merck) using the system solvent *n*-BuOH-AcOH-H<sub>2</sub>O, 60:15:25 as eluent. Vacuum-liquid chromatography (VLC) was carried out using RP-18 silica gel 60 (25-40  $\mu$ m) and silica gel 60 (15-40  $\mu$ m and 40-63  $\mu$ m). The spray reagent for saponins was vanilin reagent (10% mixture of conc. H<sub>2</sub>SO<sub>4</sub> soln. and 1% vanilin in EtOH).

#### 2.2 Plant Material

The flowers and branches of *Calliandra calothyrsus* Meisn. were harvested at Nkolbisson, Yaoundé peripheral quarter, in Cameroon in June 2017 under the guidance of Mr. Paul Nana, botanist of the National Herbarium of Cameroon (NHC), where one specimen (52065/HNC) was deposited.

#### 2.3. Extraction and Isolation

The methanolic extract (122 g) of the flowers of *C. calothyrsus* (750 g) was suspended in 200 mL of H<sub>2</sub>O and partitioned successively with hexane, ethyl acetate and *n*-BuOH sat.H<sub>2</sub>O. The *n*-BuOH-soluble fraction (23.5 g) was precipitated in 400 mL H<sub>2</sub>O for 48h to separate the saponins from the tannins. After filtration, the *n*-BuOH soluble phase was evaporated to dryness to afford (6g) brown gum residue and dissolved in 10 mL of H<sub>2</sub>O and then submitted to vacuum-liquid chromatography (VLC) using RP-18 silica gel 60 (25-40  $\mu$ m) eluted with a gradient of MeOH-H<sub>2</sub>O (100% H<sub>2</sub>O to 100%MeOH). The 65-85% MeOH fraction (3.32 g) was subjected to MPLC using silica gel 60 (15-40  $\mu$ m) eluted with gradient system of CHCl<sub>3</sub>-MeOH-H<sub>2</sub>O (70:30:5 and 65:35:10, lower phase) to give six main subfractions (B1-B6). Subfraction B6 (1.7 g) was purified by MPLC using gradient system (70:30:5 and 65:35:10, lower phase) to give ten other

subfractions Fr1 to Fr 10. Fr 7 (113 mg) and Fr 8 (150 mg) were purified by MPLC using silica gel 60 (15-40  $\mu$ m) eluted with gradient system of CHCl<sub>3</sub>-MeOH-H<sub>2</sub>O (70:30:5 and 65:35:10, lower phase) to give **1** (19.7 mg) and **2** (30.0 mg).

The methanolic extract (10 g) of the branches of *C. calothyrsus* (300 g) was suspended in 200 mL of H<sub>2</sub>O and partitioned successively with hexane, ethyl acetate and *n*-BuOH sat.H<sub>2</sub>O. The n-BuOH-soluble fraction (1.8 g) were dissolved in 10 mL of H<sub>2</sub>O and then submitted to vacuum-liquid chromatography (VLC) using RP-18 silica gel 60 (25-40  $\mu$ m) eluted with a gradient of MeOH-H<sub>2</sub>O (100% H<sub>2</sub>O $\rightarrow$ 100%MeOH). The 65-85% MeOH fraction (500 mg) was subjected to MPLC using silica gel 60 (15-40  $\mu$ m) eluted with gradient system of CHCl<sub>3</sub>-MeOH-H<sub>2</sub>O (70:30:5 and 65:35:10, lower phase) to give eleven main subfractions (F1-F11). Subfraction F9 (20 mg) was purified by CC using reversed-phase RP-18 silica gel 60 (25-40  $\mu$ m) eluted with isocratic system MeOH-H<sub>2</sub>O (60:40) to give compound **3** (3 mg).

### 2.3.1. Calothyrsusoside A (1)

White amorphous powder; <sup>1</sup>H NMR (C<sub>5</sub>D<sub>5</sub>N, 500 MHz) and <sup>13</sup>C NMR (C<sub>5</sub>D<sub>5</sub>N, 125 MHz) data, see Table 1 and 2; HR-ESI-MS m/z 1974.8572 [M+Na]<sup>+</sup> (calcd for C<sub>87</sub>H<sub>141</sub>NO<sub>47</sub>Na<sup>+</sup>, 1974.8571).

#### 2.3.2. Calothyrsusoside B (2)

White amorphous powder; <sup>1</sup>H NMR (C<sub>5</sub>D<sub>5</sub>N, 500 MHz) and <sup>13</sup>C NMR (C<sub>5</sub>D<sub>5</sub>N, 125 MHz), see Table 1 and 2; HR-ESI-MS: m/z 1812,8122 [M + Na]<sup>+</sup> (cacld for C<sub>81</sub>H<sub>131</sub>NO<sub>42</sub> Na<sup>+</sup>, 1812.8043).

### 2.3.3. Calothyrsusoside C(3)

White amorphous powder; <sup>1</sup>H NMR (D<sub>6</sub>MSO, 500 MHz) and <sup>13</sup>C NMR (D<sub>6</sub>MSO, 125 MHz), see Table 1 and 2; HR-ESI-MS: m/z 1872.8255 [M + Na]<sup>+</sup> (calcd 1872.8254 for C<sub>83</sub>H<sub>135</sub>NO<sub>44</sub>Na<sup>+</sup>).

2.4. Acid hydrolysis and sugar analysis

Each saponin (2 mg in MeOH) was hydrolyzed with 2 ml of 2 M HCl at 85 °C during 2 h. After cooling, the solvent was removed under reduced pressure. The sugar mixture was extracted from the aqueous phase (10 ml) and washed with CH<sub>2</sub>Cl<sub>2</sub> (3x 5 ml). The combined CH<sub>2</sub>Cl<sub>2</sub> extracts were washed with water to give after evaporation the aglycone moiety. The sugars were first analyzed by TLC over silica gel (CHCl<sub>3</sub>–MeOH–H<sub>2</sub>O, 8:5:1) by comparison with standard samples. The absolute configuration of each monosaccharide was determined from GC–MS analysis of their trimethylsilylated derivatives by comparison with authentic samples using the method previously described [13]. The following sugars were detected: D-glucose, D-xylose, L-arabinose, L-rhamnose and N-acetylglucosamine.

### 2.5. Antiproliferative bioassays

The antiproliferative activity of compounds **1** and **2** was assessed against the human hepatocarcinoma cell line Hep3B. Hep3B cells were grown in a sterile medium DMEM supplemented with 10% of heat inactivated fetal bovine serum, L-glutamine, sodium pyruvate and non-essential amino acids, at 37°C in humidified 5% CO<sub>2</sub> atmosphere. Hep3B cells were seeded as 5000 cells per well in 96-well microplates. After 24h, Hep3B cells were incubated for 48h with the isolated compounds with a concentration range from 0.001 to 100  $\mu$ g/mL containing 0.1% of DMSO. The antiproliferative activity was then evaluated by luminescence using the ATPlite assay (Perkin Elmer) according to the previous described method [14]. Inhibitory concentrations at 50% (IC<sub>50</sub>) of cell growth were calculated with the GraphPad Prism 6.0 software, compiling 3 independent experiments.

The evaluation of the cytotoxicity of compounds **1** and **2** against the Caco-2 cell line (human epithelial cell line, Sigma-Aldrich) was done according to Mosmann method with slight modifications. Briefly, cells ( $1.10^5$  cells/mL) in 100 µL of complete medium, [DMEM High Glucose supplemented with 10% fetal calf serum (FCS), 2 mM L-glutamine, 1X NEAA and antibiotics (100U/mL penicillin and  $100 \mu g/mL$  streptomycin)] were seeded into each well of 96-

well plates and incubated at 37 °C in a humidified 5% CO<sub>2</sub> with 95% air atmosphere. After a 24 h incubation, 100  $\mu$ L of medium with various compound's concentrations and appropriate controls (DMSO, 0.5% final) were added and the plates were incubated for 72 h at 37 °C. Each plate-well was then microscope-examined for detecting possible precipitate formation before the medium was aspirated from the wells. 100  $\mu$ L of MTT solution (0.5 mg/mL in DMEM) were then added to each well. Cells were incubated for 2 h at 37 °C. After this time, the MTT solution was removed and DMSO (100  $\mu$ L) was added to dissolve the resulting formazan crystals. Plates were shaken vigorously (300 rpm) for 5 min. The absorbance was measured at 570 nm with a microplate spectrophotometer. DMSO was used as blank and doxorubicin (purchased from Sigma Aldrich) as positive control. CC<sub>50</sub> were calculated by non-linear regression analysis processed on dose–response curves, using Table Curve 2D V5 software. CC<sub>50</sub> values represent the mean value calculated from three independent experiments.

### 3. Results and discussion

The methanolic extract of the flowers and branches of *C. calothyrsus* was purified by multiple chromatographic steps over silica gel and reversed phase. This purification yielded three undescribed saponins, calothyrsusoside A (1), calothyrsusoside B (2) and calothyrsusoside C (3) (Fig. 1). Their structures were established by extensive analysis of NMR techniques, mainly 1D NMR (<sup>1</sup>H, <sup>13</sup>C) and 2D NMR (COSY, NOESY, HSQC, HSQC-TOCSY and HMBC) experiments, HRESIMS and by comparison with the literature data.

Compound **1** was obtained as a white amorphous powder. The HRESIMS (positive-ion mode) exhibited a pseudomolecular ion peak at m/z 1974.8572 [M+Na]<sup>+</sup>, (calcd for C<sub>87</sub>H<sub>141</sub>NO<sub>47</sub>Na 1974.8571) indicating a molecular formula of C<sub>87</sub>H<sub>141</sub>NO<sub>47</sub>. Extensive analysis of 1D and 2D-NMR spectra (<sup>1</sup>H-NMR, <sup>1</sup>H-NMR DOSY, <sup>13</sup>C-JMOD, COSY, NOESY, HSQC, TOCSY and HMBC) indicated the presence of seven tertiary methyl groups at  $\delta_H$  0.94 (s, H-25), 1.02 (s, H-29), 1.03 (s, H-30), 1.05 (s, H-24), 1.17 (s, H-26), 1.27 (s, H-23) and 1.87 (s, H-27) showing correlations in the HSQC spectrum with their corresponding carbons at  $\delta_C$  15.5 (C-25),

33.0 (C-29), 24.4 (C-30), 16.9 (C-24), 17.2 (C-26), 27.9 (C-23) and 27.1 (C-27), respectively. Furthermore, other characteristic signals were observed such as one olefinic proton at  $\delta_{\rm H}$  5.67 (1H, brs, H-12) showing HSQC correlation with  $\delta_{\rm C}$  122.4 (C-12) and one quaternary carbon at  $\delta_{\rm C}$  144.6 (C-13) and one oxymethine protons at  $\delta_{\rm H}$  3.40 (brd, J=13.7 Hz, H-3), in accordance with the typical signals of an olean-12-ene skeleton. The downfield position of the axial group at C-14 (Me-27,  $\delta_{\rm C}$  1.87) in the <sup>1</sup>H NMR spectrum, implied an additional axial ( $\alpha$ ) hydroxyl group at C-16. The locations of oxygenated methines were deduced to be at C-3 and C-16 also by HMBC cross peaks at  $\delta_H 1.27$  (H-23)/  $\delta_C 89.9$  (C-3), and COSY cross peak at  $\delta_H 2.04$  (H-15)/  $\delta_H 5.24$  (H-16). NOESY cross peaks at  $\delta_H$  3.40 (H-3)/  $\delta_H$  0.88 (d, J = 12.5 Hz, H-5),  $\delta_H$  2.04 (H-15)/  $\delta_H$  1.17 (H-26),  $\delta_H$  4.61 (H-16)/  $\delta_H$  2.04 (H-15), revealed the  $\alpha$ -orientation of H-3 and  $\beta$ -orientation of H-16, confirming the stereochemistry of the aglycone. The aglycone moiety of 1 was thus recognized to be echinocystic acid by <sup>1</sup>H NMR and <sup>13</sup>C NMR analyses (Table 1) using the correlations observed in COSY, NOESY, HSQC, and HMBC spectra, and was in full agreement with literature data [15-17]. The chemical shifts of C-3 ( $\delta_{\rm C}$  89.9) and C-28 ( $\delta_{\rm C}$  176.3) (Table 1) indicated that 1 is a bidesmosidic glycoside [18-20] of echinocystic acid with sugar chains linked to C-3 and C-28 of the aglycone through an an glycosidic bond and acylglycosidic bond, respectively. The sugar moieties of 1 were determined to be D-glucose (Glc), L-rhamnose (Rha), D-acetamidoglucose (GlcNAc), D-xylose (Xyl) and L-arabinose (Ara) by acid hydrolysis followed by GC analysis of their trimethylsilylated derivatives and comparison with authentic samples (Section 2). The <sup>1</sup>H NMR spectrum of the sugar portion of compound 1 showed ten anomeric signals at  $\delta_{\rm H}$  5.11 (d, J=7.1 Hz, GlcNAc H-1), 5.06 (d, J = 6.2 Hz, Ara I H-1), 5.04 (d, J = 7.5 Hz, Ara II H-1), 5.13 (d, J = 6.7 Hz, Ara III H-1), 4.99 (d, J = 7.5 Hz, Xyl I H-1), 6.07 (d, J = 7.8 Hz, Glc I H-1), 5.89 (brs, Rha H-1), 5.54 (d, J = 7.5 Hz, Xyl II H-1), 5.23 (d, J = 7.9 Hz, Xyl III H-1) and 5.35 (d, J = 7.8Hz, Glc II H-1), which correlated with ten anomeric carbon atom resonances at  $\delta_{\rm C}$  104.4, 102.2, 105.2, 102.0, 105.4, 94.8, 101.7, 103.9, 105.4 and 104.7, respectively in the HSQC spectrum (Table 2). All proton signals of the sugar moieties were identified by careful analysis of the COSY, HSQC-TOCSY and NOESY spectra. Carbon assignment was based on HSQC and further confirmed by HMBC spectrum (Table 2). The sugar unit with anomeric signal at  $\delta_{\rm H}$  5.11 (J=7.1 Hz) was assigned to a 2-acetamido-2-deoxy- $\beta$ -D-glucose unit. The characteristic signals were at  $\delta_{\rm H}$ 9.28 (d, J = 8.0 Hz, NHAc) and at  $\delta_{\rm H}$  2.35 (s, NHCO-CH<sub>3</sub>) [15]. This was supported by the HMBC correlation observed between  $\delta_{\rm H}$  4.61 (H-2) of GlcNAc and the carbonyl signal at  $\delta_{\rm C}$  172.3 (NH-CO-CH<sub>3</sub>). Data from the above experiments indicated that Glc, GlcNAc, Xyl and Ara were in their pyranose form. The anomeric proton of Xyl I, II and III was determined to have the  $\beta$ orientation based on its relatively large <sup>3</sup>J<sub>H-1, H-2</sub> value 7.5, 7.6 and 7.9 Hz, respectively. The remaining anomeric protons of Glc, GlcNAc were determined to have  $\beta$  anomeric configuration and  $\alpha$  anomeric configuration for Ara, based on their relative large  ${}^{3}J_{\text{H-1, H-2}}$  values (6.2 -7.5 Hz) in their pyranose form. The sequencing of the glycoside chains was achieved by analysis of HMBC and NOESY experiments. The cross-peak correlations observed in the HMBC correlations between H-1 of GlcNAc ( $\delta_{\rm H}$  5.11 J=7.1 Hz) and C-3 of the aglycone ( $\delta_C$  89.9), and in the NOESY spectrum between H-1 of GlcNAc ( $\delta_H$  5.11, J=7.1 Hz) and H-3 of echinocystic acid ( $\delta_H$  3.40, J=13.7 Hz), suggested that GlcNAc is directly attached to C-3 of the aglycone. Moreover, the HMBC correlation observed between H-1 of Ara I ( $\delta_{\rm H}$  5.06, J=6.2 Hz) and C-6 of GlcNAc ( $\delta_{\rm C}$ 69.0) established the connectivity between the two sugar units, which was confirmed by the NOESY correlation observed between H-6 of GlcNAc ( $\delta_{\rm H}$  4.60) and H-1 of Ara I ( $\delta_{\rm H}$  5.06, J=6.2 Hz). HMBC correlation observed between H-1 of Ara II ( $\delta_{\rm H}$  5.04, J=7.5 Hz) and C-2 of Ara I ( $\delta_{\rm C}$ 79.5) allowed us to locate Ara II at C-2 of Ara I. This was supported by the NOESY correlation observed between H-1 of Ara II ( $\delta_{\rm H}$  5.04, J=7.5 Hz) and H-2 of Ara I ( $\delta_{\rm H}$  4.54). This Ara II was substituted at its C-2 by Ara III, as evidenced by the direct and reverse correlations observed in the HMBC spectrum between H-1 of Ara III ( $\delta_{\rm H}$  5.13, J=6.7 Hz) and C-2 of Ara II ( $\delta_{\rm C}$  79.8) and between H-2 of Ara II ( $\delta_{\rm H}$  4.50) and C-1 of Ara III ( $\delta_{\rm C}$  102.0). This was supported by the NOESY correlation observed between H-1 of Ara III ( $\delta_{\rm H}$  5.13 J=6.7 Hz) and H-2 of Ara II ( $\delta_{\rm H}$  4.50). Furthermore, HMBC correlation observed between H-1 of Xyl I ( $\delta_{\rm H}$  4.99, J = 7.5 Hz) and C-2 of Ara III ( $\delta_{\rm C}$  79.8) allowed us to locate Xyl I at C-2 of Ara III. This was supported by the NOESY correlation observed between H-1 of Xyl I ( $\delta_{\rm H}$  4.99, J = 7.5 Hz) and H-2 of Ara III ( $\delta_{\rm H}$  4.52). The terminal position of Xyl I was evidenced by the absence of any <sup>13</sup>C NMR glycosylation shifts for this sugar moiety. Thus, the pentasaccharide  $\beta$ -D-xylopyranosyl-(1 $\rightarrow$ 2)- $\alpha$ -L-arabinopyranosyl-(1 $\rightarrow$ 2)- $\alpha$ -L-arabinop

For the sugar chain attached at C-28 of the aglycone, the cross peak observed in the HSQC spectrum at  $\delta_{\rm H}$  6.07/  $\delta_{\rm C}$  94.8 (Glc I H-1/C-1) suggested that this sugar should be directly attached to C-28 of the aglycone through an acylglycosidic bond. Moreover, the HMBC correlation observed between H-1 ( $\delta_{\rm H}$  6.07, J = 7.8 Hz) of Glc I and C-28 ( $\delta_{\rm C}$  176.3) of the aglycone supported this location. The direct correlation observed in the HMBC spectrum between H-1 of Rha ( $\delta_{\rm H}$  5.89) and C-2 of Glc I ( $\delta_{\rm C}$  77.7) and the NOESY correlation observed between H-1 of Rha ( $\delta_{\rm H}$  5.89) and H-2 of Glc I ( $\delta_{\rm H}$  4.09) allowed us to locate Rha at C-2 of Glc I. Moreover, the HMBC correlation observed between H-1of Xyl II ( $\delta_{\rm H}$  5.54, J = 7.5 Hz) and C-4 of Rha ( $\delta_{\rm C}$  77.9) permitted us to attach Xyl II at C-4 of Rha. This was supported by the NOESY correlation observed between H-1of Xyl II ( $\delta_{\rm H}$  5.54 J = 7.5 Hz) and H-4 of Rha ( $\delta_{\rm H}$  4.07). The direct and reverse correlations observed in the HMBC spectrum between H-1 of Xyl III ( $\delta_{\rm H}$  5.23, J = 7.9 Hz) and C-3 of Xyl II ( $\delta_C$  87.4) and between H-3 of Xyl II ( $\delta_H$  4.19) and C-1 of Xyl III ( $\delta_C$  105.4), and the NOESY correlation observed between H-1 of Xyl III ( $\delta_{\rm H}$  5.23, J = 7.9 Hz) and H-3 of Xyl II  $(\delta_{\rm H} 4.19)$  allowed us to locate Xyl III at C-3 of Xyl II. The terminal position of Xyl III was evidenced by the absence of any <sup>13</sup>C NMR glycosylation shifts for this sugar moiety. Moreover, the HMBC correlation observed between H-1 ( $\delta_{\rm H}$  5.35, J = 7.6 Hz) of Glc II and C-3 ( $\delta_{\rm C}$  82.3) of Rha permitted us to attached Glc II at C-3 of Rha. Thus, the pentasaccharide  $\beta$ -D-xylopyranosyl- $(1\rightarrow 3)-\beta$ -D-xylopyranosyl- $(1\rightarrow 4)[-\beta$ -D-glucopyranosyl- $(1\rightarrow 3)]-\alpha$ -L-rhamnopyranosyl- $(1\rightarrow 2)-\beta$ -Dglucopyranosyl moiety was established to be attached at C-28 of the aglycone (Fig. 2). Based on the above evidences, the structure of compound 1 was established as 3-O-[ $\beta$ -D-xylopyranosyl $(1\rightarrow 2)-\alpha$ -L-arabinopyranosyl- $(1\rightarrow 2)-\alpha$ -L-arabinopyranosyl- $(1\rightarrow 2)-\alpha$ -L-arabinopyranosyl- $(1\rightarrow 6)$ ]-2-acetamido-2-deoxy- $\beta$ -D-glucopyranosyl] echinocystic acid 28-O-[ $\beta$ -D-xylopyranosyl- $(1\rightarrow 3)-\beta$ -D-xylopyranosyl- $(1\rightarrow 4)$ [- $\beta$ -D-glucopyranosyl- $(1\rightarrow 3)$ ]- $\alpha$ -L-rhamnopyranosyl- $(1\rightarrow 2)-\beta$ -Dglucopyranosyl ester.

Compound 2 was obtained as a white amorphous powder. The HRESIMS (positive-ion mode) exhibited a pseudomolecular ion peak at m/z 1812,8122 [M + Na]<sup>+</sup> (cacld for  $C_{81}H_{131}NO_{42}Na$  1812.8043) indicating a molecular formula of  $C_{81}H_{131}NO_{42}$ . Analysis of the <sup>1</sup>Hand <sup>13</sup>C-NMR spectra of 2 and comparison with compound 1 and literature data allowed the identification of echinocystic acid as aglycone (Table 1). The presence of nine monosaccharide units was suggested by the nine anomeric protons at  $\delta_{\rm H}$  5.05 [d, J = 7.8 Hz, acetamidoglucose (GlcNAc)], 5.06 (d, J = 4.6 Hz, Ara I H-1), 5.02 (d, J = 6.8 Hz, Ara II H-1), 5.13 (d, J = 5.1 Hz, Ara III H-1), 4.96 (d, J = 7.5 Hz, Xyl I H-1), 6.12 (d, J = 7.8 Hz, Glc I H-1), 6.35 (brs, Rha H-1), 5.20 (d, J = 7.5 Hz, Xyl II H-1), and 5.14 (d, J = 7.0 Hz, Xyl III H-1), which correlated in the HSQC spectrum with  $\delta_{\rm C}$  104.6, 102.2, 105.5, 102.2, 105.7, 94.6, 101.0, 105.8, and 105.6, respectively. Comparison of the NMR spectra of compounds 1 and 2 revealed that the sugar moiety at C-3 was identical to that of 1. These two compounds differ slightly only by the sugar chain attached at C-28 of the aglycone, which showed the disappearance of the signals of the glucopyranosyl unit previously attached at C(3) of Rha (Table 2) ( $\delta_{\rm C}$  82.3) in compound 1 as evidenced from the observation of the shielded signal (-10.2 ppm) of C-3 of Rha in compound 2 ( $\delta_{\rm C}$  72.1) in comparison to C-3 of Rha ( $\delta_{\rm C}$  82.3) in compound 1. From these data and by comparison of the NMR data with literature values [6-9], the structure of 2 was elucidated as 3-O- $[\beta$ -D-xylopyranosyl- $(1\rightarrow 2)$ - $\alpha$ -L-arabinopyranosyl- $(1\rightarrow 2)$ - $\alpha$ -L-arabinopyranosyl- $(1\rightarrow 2)$ - $\alpha$ -Larabinopyranosyl- $(1\rightarrow 6)$ ]-2-acetamido-2-deoxy- $\beta$ -D- glucopyranosyl] echinocystic acid 28-O- $[\beta$ -D-xylopyranosyl- $(1\rightarrow 3)$ - $\beta$ -D-xylopyranosyl- $(1\rightarrow 3)$ - $\alpha$ -Lrhamnopyranosyl- $(1 \rightarrow 2)$ - $\beta$ -Dglucopyranosyl ester.

Compound 3 was obtained as a white amorphous powder. Its molecular formula C<sub>83</sub>H<sub>135</sub>NO<sub>44</sub> was deduced from its HRESIMS in positive-ion mode which exhibited a pseudomolecular ion peak  $[M+Na]^+$  at m/z 1872.8255 (calcd 1872.8254 for C<sub>83</sub>H<sub>135</sub>NO<sub>44</sub>Na). Comparison of the <sup>1</sup>H and <sup>13</sup>C NMR signals due to the aglycone part of **3** to those of **1** and **2**, revealed that the aglycone of compound **3** was also echinocystic acid. The <sup>1</sup>H NMR spectrum of the sugar portion of compound 3 showed nine anomeric signals at  $\delta_{\rm H}$  4.29 [d, J = 8.2 Hz, acetamidoglucose (GlcNAc)], 4.48 (d, J = 4.5 Hz, Ara I H-1), 4.26 (d, J = 7.3 Hz, Ara II H-1), 4.42 (d, J = 8.0 Hz, Glc I H-1), 5.30 (d, J = 7.6Hz, Glc II H-1), 4.95 (brs, Rha H-1), 4.67 (d, J =7.6 Hz, Xyl I H-1), 4.39 (d, J = 5.2 Hz, Xyl II H-1) and 4.40 (d, J = 7.8 Hz, Glc II H-1), which correlated with nine anomeric carbon atom resonances at  $\delta_{\rm C}$  103.8, 101.5, 105.1, 103.5, 93.7, 100.7, 103.2, 104.8 and 103.8, respectively in the HSQC spectrum (Table 2). The cross-peak correlations observed in the HMBC correlations between H-1 of GlcNAc ( $\delta_{\rm H}$  4.29 J=8.2 Hz) and C-3 of the aglycone ( $\delta_C$  88.3) of echinocystic acid ( $\delta_H$  3.06, J=13.6 Hz), suggested that GlcNAc was directly attached to C-3 of the aglycone. Moreover, the HMBC correlation observed between H-1 of Ara I ( $\delta_{\rm H}$  4.48, J = 4.5 Hz) and C-6 of GlcNAc ( $\delta_{\rm C}$  68.4) established the connectivity between the two sugar units. HMBC correlation observed between H-1 of Ara II ( $\delta_{\rm H}$  4.26, J = 7.3Hz) and C-2 of Ara I ( $\delta_C$  79.4) allowed us to locate Ara II at C-2 of Ara I. The terminal position of Ara II was evidenced by the absence of any <sup>13</sup>C NMR glycosylation shifts for this sugar moiety. Moreover, the HMBC correlation observed between H-1 ( $\delta_{\rm H}$  4.42, J = 8.0 Hz) of Glc I and C-3 ( $\delta_{\rm C}$ 77.5) of Ara I permitted us to attached Glc I at C-3 of Ara I. Thus, the tetrasaccharide  $\alpha$ -Larabinopyranosyl- $(1\rightarrow 2)[-\beta$ -D-glucopyranosyl- $(1\rightarrow 3)]-\alpha$ -L-arabinopyranosyl- $(1\rightarrow 6)$ -2-acetamido-2-deoxy- $\beta$ - D -glucopyranosyl moiety was established to be linked at C-3 of the aglycone (Fig 4). Moreover, comparison of the NMR spectra of compounds 1 and 3 revealed that the sugar moiety at C-28 was identical in both compounds. Thus, the tetrasaccharide  $\beta$ -D-xylopyranosyl- $(1\rightarrow 3)$ - $\beta$ -D-xylopyranosyl- $(1\rightarrow 4)$ [ $\beta$ -D-glucopyranosyl- $(1\rightarrow 3)$ ]- $\alpha$ -L-rhamnopyranosyl- $(1\rightarrow 2)$ - $\beta$ -Lglucopyranosyl moiety was established to be attached at C-28 of the aglycone (Fig. 4). Based on the above evidences, the structure of compound **3** was established as 3-O-[ $\alpha$ -L-arabinopyranosyl- $(1\rightarrow 2)$ [- $\beta$ -D-glucopyranosyl- $(1\rightarrow 3)$ ]- $\alpha$ -L-arabinopyranosyl- $(1\rightarrow 6)$ -2-acetamido-2-deoxy- $\beta$ -D-glucopyranosyl] echinocystic acid 28-O-[ $\beta$ -L-xylopyranosyl- $(1\rightarrow 3)$ - $\beta$ -D-xylopyranosyl- $(1\rightarrow 4)$ [- $\beta$ -D-glucopyranosyl- $(1\rightarrow 3)$ -]- $\alpha$ -L-rhamnopyranosyl- $(1\rightarrow 2)$ - $\beta$ -D-glucopyranosyl ester.

Since compound **3** was not obtained in sufficient quantity to perform the biological tests, only compounds **1** and **2** were tested for their antiproliferative and cytotoxic effects on both human carcinoma cell lines Hep3B (hepatocellular carcinoma) and Caco-2 (epithelial colorectal adenocarcinoma), respectively (Table 3). Both compounds exhibited an antiproliferative activity against the Hep3B cell line, with IC<sub>50</sub> values of 6.0 and 6.5  $\mu$ M, respectively, which are in the range of the one of sorafenib, one of the most clinically used molecule [21]. However, none antiproliferative activity had been detected for the same compounds on the Caco-2 cell line (CC<sub>50</sub> > 25  $\mu$ M).

#### 4. Conclusion

Three new oleanane-type triterpenoid saponins were isolated from the flowers and twigs of *Calliandra calothyrsus*. Their structures were established from spectral data, mainly HR-ESI-MS, 1D NMR, and 2D NMR and by comparison with the literature. Compounds **1** and **2** were evaluated for their antiproliferative activity against two human digestive cancer cell lines, i.e. Hep3B and Caco-2 cells. Both compounds exhibited a moderate antiproliferative activity against Hep3B cells, though in the range of the palliative molecule sorafenib. In contrast, none effect has been seen against the Caco-2 cells at the tested concentrations. As a perspective, we project to test compounds **1** and **2** against a wider range of cancer cell lines to assess their possible selectivity against hepatocarcinoma cells. This could contribute to identify specific molecular targets of this cancer type and promote the use of this plant for traditional medicine purpose. However, from a chemotaxonomic point of view, our results represent a valuable contribution to the knowledge of the chemistry of plants of the genus *Calliandra* of the Mimosaceae subfamily, some of which have

revealed the presence of oleanane-type triterpenoid saponins. These saponins present the N-acetylglucosamine directly attached to the C-3 of the aglycone as well as the sugar sequence Ara-<sup>2</sup>Ara-<sup>6</sup>GlcNAc-<sup>3</sup>Agly. These characteristics are consistently encountered in all the isolated saponins of the genus *Calliandra* [6-12]. Comparing our saponins with those previously isolated from the genus *Calliandra*, it appears that they share the same C-3 oligosaccharide sequence but with one and two additional sugars, respectively. This could therefore be a specificity of the saponins of the *Calliandra calothyrsus* species.

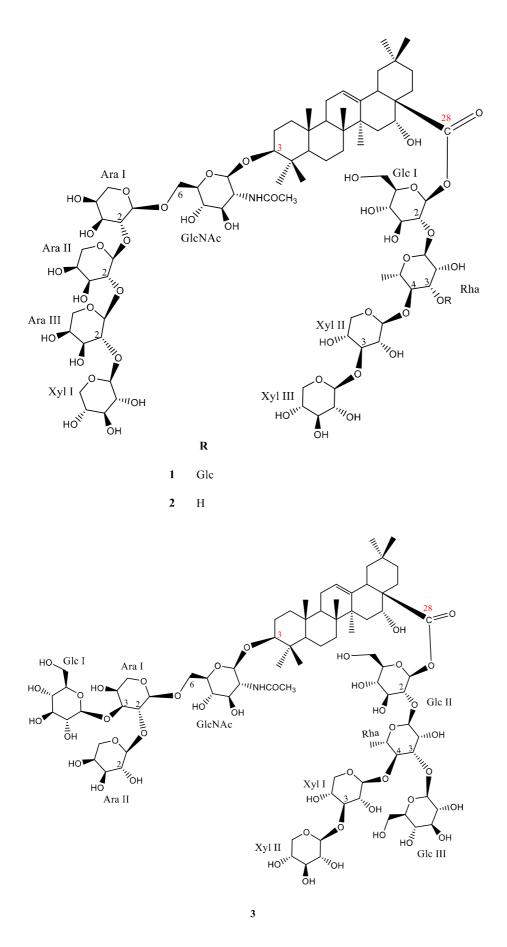


Fig. 1. Chemical structures of compounds 1-3.

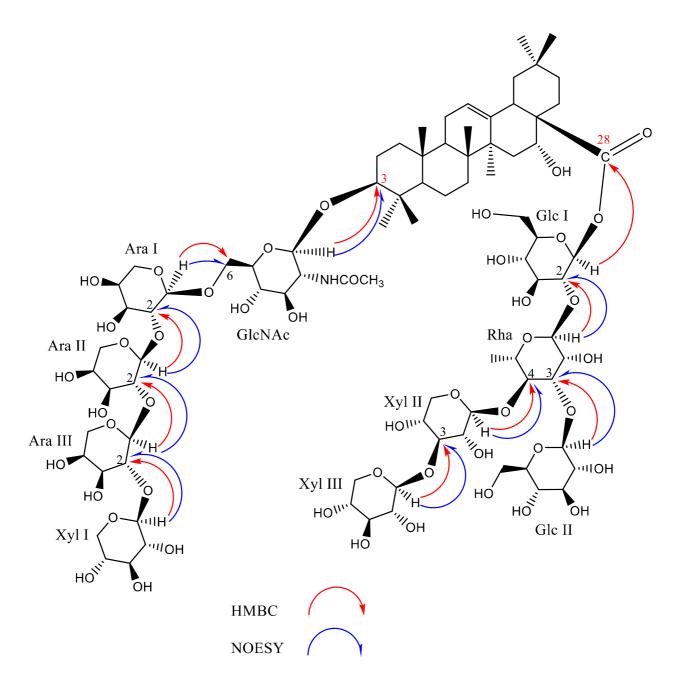


Fig. 2. Key HMBC and NOESY correlations of compound 1

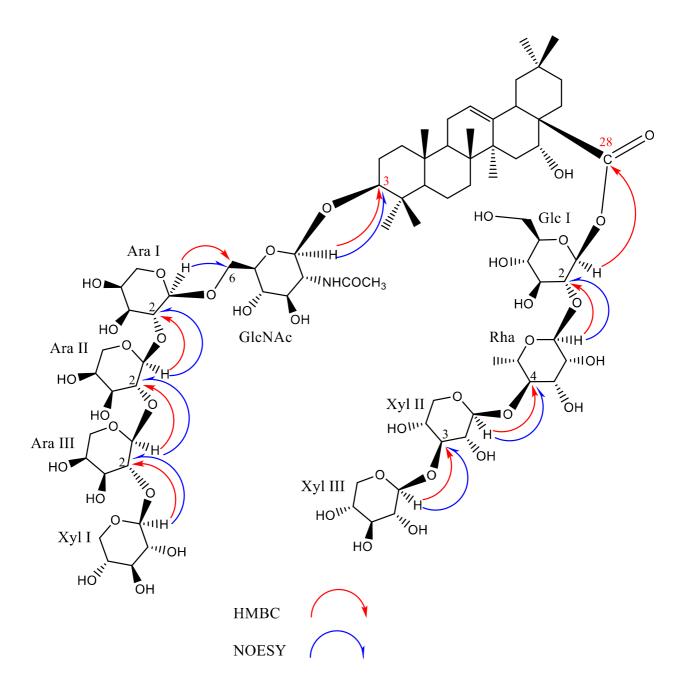


Fig. 3. Key HMBC and NOESY correlations of compound 2.

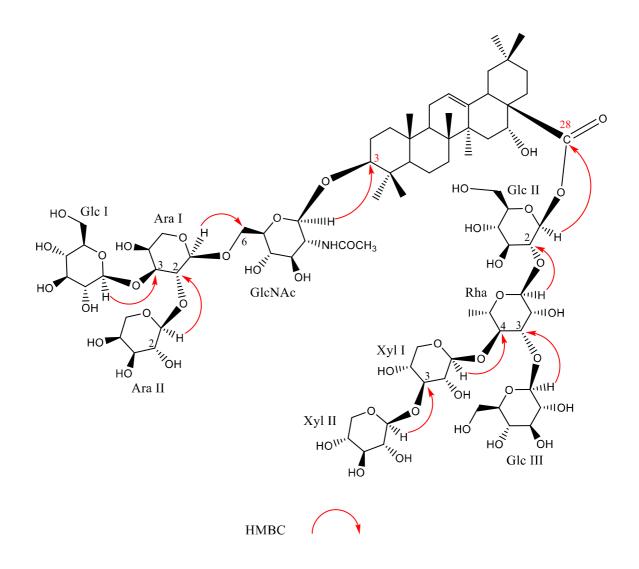


Fig. 4. Key HMBC correlations of compound 3.
