<u>Superficial Siderosis of the Central Nervous System</u> <u>associated with Hemophilia A: a case report.</u>

Case Report

A 61-year-old man was referred to our consultation because of progressively worsening gait disorders, hearing impairment, lower limbs pain and saddle anesthesia. His medical history was marked with mild congenital hemophilia A (factor VIII activity: 20I U DL⁻¹), bladder polyp removal, ongoing smoking, and alcohol misuse. At the age of 37-year-old, he underwent an audiometric testing following a work-related accident which revealed a bilateral subclinical sensorineural hearing loss. At the age of 57 years old, he noticed lower back pain radiating throughout his lower limbs, along with progressive gait disorders. The diagnosis of lumbar spinal stenosis was evoked and, as medical management failed, surgery was suggested. Presurgical spinal Magnetic Resonance Imaging (MRI) was then interpreted as unremarkable apart from multiple hernia and mild lumbar stenosis (Figure 1). Immediately after the lumbar spinal stenosis surgery (laminectomy and lumbar arthrodesis from L2 to L5), he developed a sudden paraplegia with bladder and sphincter disorders and severe lower limbs pain. An MRI revealed an epidural hematoma (Figure 2) which was surgically drained, unfortunately only partially improving his symptoms as the patient still displayed lower back pain and mild gait disturbances on discharge. A year later, because of worsening symptoms with reduced ability to walk and increasing back pain and sphincter disorders, a new surgery was considered (spinal recalibration with extended arthrodesis to L1-S1). During pre-surgical screening, spinal and brain MRI demonstrated an extensive hypo-intensity on fast 2D gradient-echo-weighted sequences, along the spinal cord, posterior fossa's structures and cerebral cortex for which our expertise was requested (Figure 3).

On admission, clinical examination showed cerebellar ataxia, pyramidal syndrome with bilateral extensor plantar response and brisk reflexes of the four limbs, saddle anesthesia and bilateral hearing impairment. Neuropsychological assessment revealed mild cognitive impairment including memory, attention and concentration disorders. The diagnosis of Superficial Siderosis of the CNS was made.

Comprehensive etiological investigations were performed including laboratory work-up, conventional cerebral and medullar angiography, and were all unremarkable. A treatment with high doses of steroids (IV infusion of 1000mg of methylprednisolone once, followed by 80mg of prednisone for a week with a gradual withdrawal over a month) was initiated. Limbs pain were relieved and a significant clinical improvement of the patient in terms of mobility and quality of life was observed. Unfortunately, within a month after steroids were stopped, symptoms reappeared with comparable intensity.

Discussion

Superficial Siderosis of the Central Nervous System (SSCNS) is a condition secondary to the deposition of hemosiderin within the subpial layers of central nervous system leading to its progressive degeneration[1]. Clinically, it is most frequently characterized by the association of hearing impairment, cerebellar ataxia and pyramidal syndrome but patients often also display cognitive decline, bladder and sphincter disorders or sensory symptoms. Since Iwanonowski's and Noetzel's experiments in the 60's, Superficial Siderosis (SS) is known to be secondary to a chronic bleeding within the central nervous system (CNS)[2], although some reports suggest that an acute bleeding might be sufficient to generate the disease. Hence, many disorders can be responsible for SSCNS, including aneurysm rupture, chronical subdural hematoma, cerebral amyloid angiopathy, cerebral vasculitis, all kind of neurosurgical procedures, all vascular malformations within the CNS, cerebral tumors or head traumas[3]. Yet, 6 to 35% of SSCNS are considered idiopathic without obvious source of chronic bleeding identified despite extensive investigations[3].

Regarding our patient, although his spinal surgery might appear as the obvious cause for his SS at first sight, his history clearly suggests that his disorder was not caused but worsened and revealed by the surgery. Indeed, 20 years before the procedure, he was already suffering from subclinical neurosensory hearing impairment. Furthermore, reinterpretation of his first presurgical spinal MRI revealed pre-existing T2* hypo-intensity of the spinal cord, with mild lumbar spinal stenosis (Figure 1). It is then most likely that his lower limbs pain and gait disturbances were already caused by the SS of his spinal cord, as it is known that this disorder may initially present itself as a progressive myelopathy[4].

Thus, this raises the question of the etiology of his SS. As in many other cases, our investigations did not identify any obvious source of chronic hemorrhage despite including laboratory work-up with antibodies known to be associated with vasculitis, and dedicated imaging to detect vascular malformations with both CT cerebral angiography and medullar angiography. For these patients with negative findings, it has been hypothesized that the chronic bleeding may be impossible to visualize through common imaging[5] and that it may be facilitated by increased permeability of meningeal arteries[6]. Thus, the concurrent presence of a clotting disorder such as hemophilia A should worsen and facilitate this process, adding thinner blood to altered vascular permeability and may be sufficient to generate chronic bleeding and SS.

Congenital Hemophilia A is a hereditary X-linked recessive bleeding disorder secondary to mutations in the factor VIII gene leading to the deficiency or absence of this fundamental clotting protein. Affecting 1 out 5000 live births, it is responsible for acute, spontaneous or post-traumatic muscular or joint hemorrhages[7]. Neurological complications of the disease include post-traumatic hematomas leading to peripheral nerve damage, spinal cord compression and various lesions of the central nervous system[8].

Regarding SSCNS, our report is the second ever published case in a patient with Hemophilia A without any apparent cause[9]. In their own report, López-Blanco and Bartolomé-Villar describe a very similar story with comparable clinical presentation. Hence our report reinforces the hypothesis that Hemophilia A might be a new cause of SSCNS which would be critical for patients follow-up. Indeed, physicians should be aware of the appearance of gait disorders, hearing impairment or cognitive decline in patients with hemophilia A and not hesitate to perform an MRI with adequate sequences with T2* or Susceptibility Weighted Imaging in order to detect a SSCNS at its earlier stages.

Different therapeutic approaches have been tried in SS including surgery[10] or iron chelation, specifically with Deferiprone[11] as it has been proven to be safe and well tolerated while offering the benefit of crossing the brain-blood-barrier. Unfortunately, although surgery may prevent further worsening of the symptoms when the source of chronic bleeding is identified, medical therapies have all failed to prove any reproducible efficiency to date.

Regarding steroids, other articles have reported its use with moderate benefit that has been already argued as probably associated with other underlying conditions or temporary booster-effect[12]. In our case, high doses led to a quick and significant clinical improvement. This dramatic effect might be correlated to the unusually extensive aspect of our patient's siderosis, generating higher microglial activation, reactive gliosis, and arachnoiditis, making steroids and their anti-inflammatory effects so effective. Unfortunately, our patient became quickly steroids dependent as cessation of the treatment irrevocably led the resumption of his symptoms.

Conclusion

This report highlights the need for awareness for physicians when managing patients with medical history of congenital Hemophilia A and symptoms suggestive of SSCNS, and encourages them to perform cerebral and spinal MRI with T2* or SWI (Susceptibility Weighted Imaging) sequences to help in diagnosing this condition. Better understanding of the disease pathophysiology should offer new therapeutic prospects in the future.
