Laparoscopic adnexectomy Under Regional Anesthesia: it is possible!

#### Abstract:

At present, the majority of laparoscopic operations are performed under general anesthesia, as it controls surgical pain and improves patient comfort using pneumoperitoneum and the Trendelenburg position. However, some laparoscopic procedures, such as adnexectomies, can potentially be performed under epidural anesthesia with a purposefully selected and motivated patient managed by prepared surgical and anesthesia care teams working together effectively. This study reports the case of a 63-year-old female patient with major respiratory failure who underwent laparoscopic bilateral adnexectomies under epidural anesthesia.

#### Introduction

Laparoscopic surgery has advanced remarkably in recent years, resulting in reduced morbidity and shorter hospital stays compared with open surgery. Despite challenges from the expanding array of laparoscopic procedures performed with the use of pneumoperitoneum, anesthesia has remained poorly changed.

Currently, most laparoscopic operations are performed under general anesthesia, which controls surgical pain and improves patient comfort via pneumoperitoneum and the Trendelenburg position. However, several large, retrospective studies have questioned the widely held belief that general anaesthesia is the best anaesthetic method for laparoscopic surgery, instead suggesting that regional anaesthesia could be a reasonable choice in certain settings (1–4). The present work reports the specifics of a case that demonstrates the feasibility of conducting laparoscopic adnexectomies under epidural anesthesia.

# **Materials and Methods**

A 63-year-old patient, who had poliomyelitis during childhood with sequelar major respiratory failure, was seen in our hospital for a suspected large right ovarian cyst suspicious to be a borderline ovarian tumour. After concertation between the surgical

and anaesthesia care teams, we decided to proceed to laparoscopic exploration and surgery under loco-regional analgesia.

#### Results

Combined spinal epidural anaesthesia was performed at the L4-L5 level; 5 mg of hyperbaric bupivacaine and 2.5 µg of sufentanil were injected by spinal needle. An epidural was then inserted and anaesthesia was continued by lidocaine infusion. Oxygenation was given throughout the surgery by high-flow humidified nasal oxygenotherapy (Optiflow©). No intravenous sedation was necessary.

Pneumoperitoneum was initiated using an open entry technique at the umbilicus and

achieved with slowly increasing low pressure from 6 to 8 mm Hg. The patient was placed in a minimal Trendelenburg position (10–15°). We placed then three operative trocars under the umbilicus, and in right and left iliac fossae. Laparoscopic examination revealed a large right ovarian cyst, while the uterus and left adnexa appeared normal. Two peritoneal nodules with possible carcinomatosis were also noted. The right diaphragmatic cupola was sprayed with 20 mL of ropivacaine. All the surgery was realized with a 8 mm Hg pressure. The two peritoneal nodules were easily removed, and the bilateral adnexectomies were performed laparoscopically. The suspicious right ovarian cyst was placed into an endoscopic bag and extracted by enlarging the suprapubic incision (3–4 cm). The surgery was uncomplicated, and the post-operative course was uneventful. The postoperative pain was evaluated, and was inconsiderable (EVA always < 3). The recovery was really fast, and the patient was accordingly discharged home on postoperative Day 1. Pathological analysis revealed a borderline tumor of the right ovary; the remaining analysis did not reveal any malignancies. The patient had no complaints at the post-operative consultation, and was really satisfied.

### **Discussion**

The well-known benefits of regional anaesthesia include reduction of general anaesthetic side effects, which include nausea, vomiting, sore throat, dental injury, sedation, postoperative atelectasis and hypoventilation. This allows for earlier cognitive recovery in the immediate postoperative period.

Most reports of spinal anaesthesia in laparoscopic surgery involve laparoscopic cholecystectomy (1,3–6), with few cases of appendectomy or hysterectomy presented (1,7). However, data on laparoscopic cholecystectomy are not completely applicable to gynaecologic surgery given that the former requires a reverse Trendelenburg position to achieve favorable pulmonary dynamics. Conversely, the Trendelenburg position needed for most gynaecologic laparoscopic procedures can inhibit adequate ventilation. Indeed, it might be difficult for patients to breathe against the pneumoperitoneum and viscera, particularly those with major respiratory insufficiency. During conventional laparoscopic surgery under general anesthesia, surgeons depend on muscle relaxants and paralysis to facilitate peritoneal insufflation and maintain a steady field for surgery. Epidural anaesthesia can provide muscle relaxation as well, but not to the level achieved with paralytic agents.

It is also important to use the least possible degree of Trendelenburg. In our experience, a 10–15° tilt is sufficient to retract the bowel and provide correct visualisation. To minimise shoulder pain and decrease respiratory function, low CO<sub>2</sub> flow and low pressure (< 6 mmHg) were initially used before slowly being increased to high flow and higher pressure (8 mmHg). In the literature, low-pressure (< 10 mmHg) insufflation is generally preferred (3), with some researchers recommending a markedly low pressure, such as 4 mmHg (2). Scott and Slawson (8) detected no significant changes in minute volume, PaCO<sub>2</sub> or blood pH during gynaecologic open surgery under epidural anaesthesia in the horizontal Trendelenburg position.

 No data are available concerning the appropriate levels of epidural anaesthesia to be used in gynaecologic laparoscopic surgery. In laparoscopic cholecystectomy, a satisfactory analgesic effect was obtained with epidural anaesthesia up to the level of Th7 with concurrent general anaesthesia [11]. Our data suggest that epidural anaesthesia up to the level of Th8 provides sufficient analgesic for gynaecologic laparoscopic surgery.

Right shoulder pain was also prevented by spraying ropivacaine on the undersurface of the diaphragm, as we always do for all laparoscopic procedures (9).

Successful laparoscopic pelvic surgery under regional anaesthesia also depends on appropriate management of pain, anxiety and expectations. In the present case, communication with an empathetic anaesthesiologist, nurses and surgeon during the surgical process may have helped reduce the patient's anxiety. Additionally, the operating room staff kept traffic and noise levels to a minimum during the procedure.

One of the most recent gynaecologic procedures realized under epidural analgesia was an hysterectomy, which was due to the patient's preference (10). However, there was no choice in the present case as it was necessary to avoid general anaesthesia and tracheotomy intubation given the patient's respiratory dysfunction.

The cost-effectiveness of such a surgical procedure should be evaluated. In our case reported, the surgery was uneventful and lasted the usual duration for adnexectomy, but more data about the cost-effectiveness of laparoscopic procedures under epidural analgesia should be analyzed.

**Conclusion:** Laparoscopic adnexectomies under epidural anaesthesia seem to be a feasible procedure in a purposefully selected and motivated patient. However, such procedures need be carefully managed by a prepared surgical team and anaesthesia care team, with efficient and effective collaboration between the two.
