# Solving Some Affine Equations over Finite Fields

> Abstract. Let $l$ and $k$ be two integers such that $l \mid k$. Define $T_{l}^{k}(X):=$ $X+X^{p^{l}}+\cdots+X^{p^{k-2 l}}+X^{p^{k-l}}$ and $S_{l}^{k}(X):=X-X^{p^{l}}+\cdots+(-1)^{(k / l-1)} X^{p^{k-l}}$, where $p$ is any prime.
> This paper gives explicit representations of all solutions in $\mathbb{F}_{p^{n}}$ to the affine equations $T_{l}^{k}(X)=a$ and $S_{l}^{k}(X)=a, a \in \mathbb{F}_{p^{n}}$. The case $p=2$ was solved very recently in [10]. The results of this paper reveal another solution.

Keywords: Affine equation • Finite field • Zeros of a polynomial • Linearized polynomial.

## 1 Introduction

Let $\mathbb{F}_{p^{n}}$ be the finite field of $p^{n}$ elements where $p$ is a prime and $n \geq 1$ is a positive integer. A polynomial $L(X) \in \mathbb{F}_{p^{n}}[X]$ of shape

$$
L(X)=\sum_{i=0}^{t} a_{i} X^{p^{i}}, a_{i} \in \mathbb{F}_{p^{n}}
$$

is called a linearized polynomial over $\mathbb{F}_{p^{n}}$ or a $p$-polynomial over $\mathbb{F}_{p^{n}}$. An affine equation over $\mathbb{F}_{p^{n}}$ is an equation of type

$$
\begin{equation*}
L(X)=a \tag{1}
\end{equation*}
$$

where $L$ is a linearized polynomial and $a \in \mathbb{F}_{p^{n}}$.
Affine equations arise in many different problems and contexts (e.g. [4-7, 9-15]). In particular, those involving the trace functions are crucial in many

[^0]contexts of cryptography and error-correcting codes [1-3]. However, to find explicit solutions is often challenging and it is the ultimate goal to achieve.

Let $k$ and $l$ be positive integers such that $l \mid k$. Define two $p-$ polynomials over $\mathbb{F}_{p}:$

$$
T_{l}^{k}(X):=\sum_{i=0}^{\frac{k}{l}-1} X^{p^{l i}}
$$

and

$$
S_{l}^{k}(X):=\sum_{i=0}^{\frac{k}{l}-1}(-1)^{i} X^{p^{l i}}
$$

In this paper, we study the following two affine equations

$$
\begin{equation*}
T_{l}^{k}(X)=a, a \in \mathbb{F}_{p^{n}} \tag{2}
\end{equation*}
$$

and

$$
\begin{equation*}
S_{l}^{k}(X)=a, a \in \mathbb{F}_{p^{n}} \tag{3}
\end{equation*}
$$

It is well-known that a linearized polynomial induce a linear transformation of $\mathbb{F}_{p^{n}}$ over $\mathbb{F}_{p}$. In particular, if $x_{1}$ and $x_{2}$ are two solutions in $\mathbb{F}_{p^{n}}$ to Equation (1), then their difference $x_{1}-x_{2}$ is a zero of $L$ in $\mathbb{F}_{p^{n}}$, that is, their difference lies in the set $\left\{x \in \mathbb{F}_{p^{n}} \mid L(x)=0\right\}$, that we call the kernel of $L$ in $\mathbb{F}_{p^{n}}$. Determination of the $\mathbb{F}_{p^{n}}$ - solutions to Equation (1) can therefore be divided into two problems: to determine the kernel of $L$ in $\mathbb{F}_{p^{n}}$ and to find a solution $x_{0}$ in $\mathbb{F}_{p^{n}}$ of the affine equation. Indeed, if those two problems are solved then the set of all $\mathbb{F}_{p^{n}}$-solutions to Equation (1) is $x_{0}+\left\{x \in \mathbb{F}_{p^{n}} \mid L(x)=0\right\}$.

In this paper, we solve these two problems for the linearized polynomials $T_{l}^{k}$ and $S_{l}^{k}$. We firstly determine the kernels of $T_{l}^{k}$ and $S_{l}^{k}$ in Section 3. Next, we give explicit representations of particular solutions to Equation (2) and Equation (3) in Section 4. As by-product of those results, we also characterize the elements $a$ in $\mathbb{F}_{p^{n}}$ for which Equation (2) and Equation (3) has at least one solution in $\mathbb{F}_{p^{n}}$ in Section 4.

Remark 1. In [10], we considered the particular case of $p=2$ for which $T_{l}^{k}(X)=$ $S_{l}^{k}(X)$. Interestingly, Theorem 1 and Theorem 4 in this paper provide another solution for this particular case.

## 2 Preliminaries

Throughout this paper, we maintain the following notation (otherwise, we will point it out at the appropriate place).

- $\quad p$ is any prime and $n$ is any positive integer.
- $\quad a$ is any element of the finite field $\mathbb{F}_{p^{n}}$.
- $\quad k$ and $l$ are any positive integers such that $l \mid k$.
- We denote the greatest common divisor and the smallest common multiple of two positive integers $u$ and $v$ by $(u, v)$ and $[u, v]$, respectively.
- $d:=(n, k), e:=(n, l)$ and $L:=[d, l]$.

We now present a lemma that will be heavily used throughout this paper.
Lemma 1. For any positive integers $k, l$ and $m$ with $m|l| k$ the following holds:

1. $T_{l}^{k} \circ T_{m}^{l}(X)=T_{m}^{k}(X)$ is an identity. Also, $T_{l}^{k} \circ S_{m}^{l}(X)=S_{m}^{k}(X)$ if $l / m$ is even and $S_{l}^{k} \circ S_{m}^{l}(X)=S_{m}^{k}(X)$ if $l / m$ is odd.
2. $S_{l}^{k} \circ T_{l}^{2 l}(X)=S_{k}^{2 k}(X)=X-X^{p^{k}}$ if $\frac{k}{l}$ is even and $S_{l}^{k} \circ T_{l}^{2 l}(X)=T_{k}^{2 k}(X)=$ $X+X^{p^{k}}$ if $\frac{k}{l}$ is odd.
3. $T_{l}^{k} \circ S_{l}^{2 l}(X)=S_{k}^{2 k}(X)$.
4. $T_{k}^{[n, k]}(x)=T_{(n, k)}^{n}(x)$ for any $x \in \mathbb{F}_{p^{n}}$. Furthermore, if $\frac{[n, k]}{k}$ is even, then $S_{k}^{[n, k]}(x)=S_{(n, k)}^{n}(x)$ for any $x \in \mathbb{F}_{p^{n}}$.
5. If $\frac{k}{l}$ is even, then $S_{l}^{k}(x)+S_{l}^{k}(x)^{p^{l}}=0$ for any $x \in \mathbb{F}_{p^{k}}$.

Proof. The first three assertions are obtained by easy straightforward calculations. Hence, we give proofs only for the last two assertions.

Since $n \cdot k=[n, k] \cdot(n, k)$, one has $\frac{n}{(n, k)}=\frac{[n, k]}{k}$ and $\{j \cdot(n, k) \mid 0 \leq j \leq$ $\left.\frac{n}{(n, k)}-1\right\}=\left\{i k \bmod n \left\lvert\, 0 \leq i \leq \frac{[n, k]}{k}-1\right.\right\}$ because $n$ divides $i k$ if and only if $i$ is a multiple of $\frac{n}{(n, k)}=\frac{[n, k]}{k}$. Therefore $T_{k}^{[n, k]}(x)=T_{(n, k)}^{n}(x)$.

Furthermore, if $\frac{[n, k]}{k}=\frac{n}{(n, k)}$ is even, then $\frac{k}{(n, k)}$ is odd since it is prime to $\frac{n}{(n, k)}$. Thus, when two integers $i$ and $j$ are such that $j d \equiv i k(\bmod n)$, then they have the same parity. This proves $S_{k}^{[n, k]}(x)=S_{(n, k)}^{n}(x)$ if $\frac{[n, k]}{k}$ is even.

Finally, the last assertion is proved as follows: by Assertion 1 (with $2 l$ at the place of $l$ and with $l$ at the place of $m$ ), we have $S_{l}^{k}(X)=S_{l}^{2 l} \circ T_{2 l}^{k}(X)$. Let $x \in \mathbb{F}_{p^{k}}$. Then $y:=T_{2 l}^{k}(x) \in \mathbb{F}_{p^{2 l}}$. Hence $S_{l}^{k}(x)+S_{l}^{k}(x)^{p^{l}}=S_{l}^{2 l}(y)+S_{l}^{2 l}(y)^{p^{l}}=$ $\left(y-y^{p^{l}}\right)+\left(y-y^{p^{l}}\right)^{p^{l}}=0$.

It is well known that the set of $p$-polynomials over $\mathbb{F}_{p}$ forms an integral domain under the operations of symbolic multiplication (composition of polynomials) and ordinary addition (e.g. see page 115 in [8]). Therefore, under the symbolic multiplication, any two $p$-polynomials over $\mathbb{F}_{p}$, involving $T_{l}^{k}$ and $S_{l}^{k}$, are commutative.This fact will be implicitly used throughout this paper.

## 3 On the Kernels of $T_{l}^{k}$ and $S_{l}^{k}$

To determine the kernels of $T_{l}^{k}$ and $S_{l}^{k}$ in $\mathbb{F}_{p^{n}}$, we begin by determining the zeros of $T_{l}^{k}$ and $S_{l}^{k}$ in the algebraic closure $\overline{\mathbb{F}_{p}}$.

Lemma 2. It holds:
1.

$$
\left\{x \in \overline{\mathbb{F}_{p}} \mid T_{l}^{k}(x)=0\right\}=S_{l}^{2 l}\left(\mathbb{F}_{p^{k}}\right)=\left\{x-x^{p^{l}} \mid x \in \mathbb{F}_{p^{k}}\right\} .
$$

2. When $\frac{k}{l}$ is even,

$$
\left\{x \in \overline{\mathbb{F}_{p}} \mid S_{l}^{k}(x)=0\right\}=T_{l}^{2 l}\left(\mathbb{F}_{p^{k}}\right)=\left\{x+x^{p^{l}} \mid x \in \mathbb{F}_{p^{k}}\right\} .
$$

3. When $\frac{k}{l}$ is odd,

$$
\left\{x \in \overline{\mathbb{F}_{p}} \mid S_{l}^{k}(x)=0\right\}=S_{k}^{2 k} \circ T_{l}^{2 l}\left(\mathbb{F}_{p^{2 k}}\right)=\left\{\left(x+x^{p^{l}}\right)-\left(x+x^{p^{l}}\right)^{p^{k}} \mid x \in \mathbb{F}_{p^{2 k}}\right\} .
$$

Proof. For $x \in \mathbb{F}_{p^{k}}$, by Assertion 3 of Lemma $1, T_{l}^{k} \circ S_{l}^{2 l}(x)=x-x^{p^{k}}=0$ proving the inclusion of $S_{l}^{2 l}\left(\mathbb{F}_{p^{k}}\right)$ in $\left\{x \in \overline{\mathbb{F}_{p}} \mid T_{l}^{k}(x)=0\right\}$. We then conclude the equality from the fact that the two sets have the same cardinality $p^{k-l}$. The second assertion is similarly proved by using Assertion 2 of Lemma 1. The third assertion can be proved similarly by using Assertions 2 and 3 of Lemma 1.

Corollary 1. The following holds:
1.

$$
\operatorname{ker}\left(T_{l}^{k}\right) \subset \mathbb{F}_{p^{k}}
$$

2. 

$$
\operatorname{ker}\left(S_{l}^{k}\right) \subset\left\{\begin{array}{l}
\mathbb{F}_{p^{k}}, \text { if } \frac{k}{l} \text { is even }, \\
\mathbb{F}_{p^{2 k}}, \text { if } \frac{k}{l} \text { is odd }
\end{array}\right.
$$

Based on the lemma above, we can determine the kernels of $T_{l}^{k}$ and $S_{l}^{k}$ in $\mathbb{F}_{p^{n}}$. For the reader's convenience, we present our results as three statements, each of them corresponding to an assertion of Lemma 2.

Theorem 1. The following holds true:

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid T_{l}^{k}(x)=0\right\}= \begin{cases}\mathbb{F}_{p^{d}}, & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ S_{e}^{2 e}\left(\mathbb{F}_{p^{d}}\right), & \text { otherwise } .\end{cases}
$$

Consequently,

$$
\#\left\{x \in \mathbb{F}_{p^{n}} \mid T_{l}^{k}(x)=0\right\}= \begin{cases}p^{d}, & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ p^{d-e}, & \text { otherwise } .\end{cases}
$$

Proof. By Assertion 1 of Lemma 2,

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid T_{l}^{k}(x)=0\right\}=S_{l}^{2 l}\left(\mathbb{F}_{p^{k}}\right) \cap \mathbb{F}_{p^{n}} \subset \mathbb{F}_{p^{(n, k)}}=\mathbb{F}_{p^{d}}
$$

By Assertion 1 of Lemma 1 we have $T_{l}^{k}(X)=T_{L}^{k} \circ T_{l}^{L}(X)$ and therefore

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{n}} \mid T_{l}^{k}(x)=0\right\} & =\left\{x \in \mathbb{F}_{p^{d}} \mid T_{l}^{k}(x)=0\right\} \\
& =\left\{x \in \mathbb{F}_{p^{d}} \left\lvert\, \frac{k}{L} T_{l}^{L}(x)=0\right.\right\}
\end{aligned}
$$

Thus, if $p \left\lvert\, \frac{k}{L}\right.$, then

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid T_{l}^{k}(x)=0\right\}=\mathbb{F}_{p^{d}}
$$

and if $p \nmid \frac{k}{L}$, then

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{n}} \mid T_{l}^{k}(x)=0\right\} & =\left\{x \in \mathbb{F}_{p^{d}} \mid T_{l}^{L}(x)=0\right\} \\
& =\left\{x \in \mathbb{F}_{p^{d}} \mid T_{e}^{d}(x)=0\right\} \text { (by Assertion } 4 \text { of Lemma 1) } \\
& =S_{e}^{2 e}\left(\mathbb{F}_{p^{d}}\right)(\text { by Assertion } 1 \text { of Lemma 2) }
\end{aligned}
$$

Theorem 2. Suppose that $\frac{k}{l}$ is even.

1. If $\frac{d}{e}$ is even, then

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}= \begin{cases}\mathbb{F}_{p^{d}}, & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ T_{e}^{2 e}\left(\mathbb{F}_{p^{d}}\right), & \text { otherwise }\end{cases}
$$

and consequently

$$
\#\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}= \begin{cases}p^{d}, & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ p^{d-e}, & \text { otherwise } .\end{cases}
$$

2. If $\frac{d}{e}$ is odd, then

$$
\begin{aligned}
& \left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=\mathbb{F}_{p^{d}} \\
& \#\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=p^{d}
\end{aligned}
$$

and consequently

Proof. By Assertion 2 of Lemma 2, when $\frac{k}{l}$ is even, we know that $\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=\right.$ $0\}=T_{l}^{2 l}\left(\mathbb{F}_{p^{k}}\right) \cap \mathbb{F}_{p^{n}} \subset \mathbb{F}_{p^{d}}$ and thus

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=\left\{x \in \mathbb{F}_{p^{d}} \mid S_{l}^{k}(x)=0\right\}
$$

Now, suppose that $\frac{d}{e}=\frac{d}{(d, l)}=\frac{L}{l}$ is even. Then, by Assertion 1 of Lemma 1

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{d}} \mid S_{l}^{k}(x)=0\right\} & =\left\{x \in \mathbb{F}_{p^{d}} \mid T_{L}^{k} \circ S_{l}^{L}(x)=0\right\} \\
& =\left\{x \in \mathbb{F}_{p^{d}} \left\lvert\, \frac{k}{L} S_{l}^{L}(x)=0\right.\right\}
\end{aligned}
$$

Therefore, if $p \left\lvert\, \frac{k}{L}\right.$, then

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=\mathbb{F}_{p^{d}}
$$

and if $p \nmid \frac{k}{L}$, then

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\} & =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{l}^{L}(x)=0\right\} \\
& =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{e}^{d}(x)=0\right\} \text { (by Assertion } 4 \text { of Lemma 1) } \\
& =T_{e}^{2 e}\left(\mathbb{F}_{p^{d}}\right)(\text { by Assertion } 2 \text { of Lemma 2) }
\end{aligned}
$$

Suppose now that $\frac{d}{e}=\frac{L}{l}$ is odd. In this case, $\frac{k}{L}$ is even as $\frac{k}{l}=\frac{k}{L} \cdot \frac{L}{l}$ is even by the assumption. Thus, we have

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\} & =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{l}^{k}(x)=0\right\} \\
& =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{L}^{k} \circ S_{l}^{L}(x)=0\right\} \text { (by Assertion 1 of Lemma 1) } \\
& =\mathbb{F}_{p^{d}}
\end{aligned}
$$

because $S_{l}^{L}(x) \in \mathbb{F}_{p^{d}} \subset \mathbb{F}_{p^{L}}$ for $x \in \mathbb{F}_{p^{d}}$.
Theorem 3. Suppose that $\frac{k}{l}$ is odd.

1. When $\frac{n}{d}$ is odd,

$$
\begin{aligned}
& \left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=\{0\} \\
& \#\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=1
\end{aligned}
$$

and consequently
2. When $\frac{n}{d}$ is even,

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}= \begin{cases}S_{d}^{2 d}\left(\mathbb{F}_{p^{2 d}}\right), & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ S_{d}^{2 d} \circ T_{e}^{2 e}\left(\mathbb{F}_{p^{2 d}}\right), & \text { otherwise }\end{cases}
$$

and consequently

$$
\#\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}= \begin{cases}p^{d}, & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ p^{d-e}, & \text { otherwise } .\end{cases}
$$

Proof. First of all, note that $\frac{L}{l}$ and $\frac{k}{L}$ are odd since both of them are divisors of $\frac{k}{l}$ which is odd. Then by Assertion 3 of Lemma 2 one has

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=S_{k}^{2 k} \circ T_{l}^{2 l}\left(\mathbb{F}_{p^{2 k}}\right) \cap \mathbb{F}_{p^{n}}=\left\{x \in \mathbb{F}_{p^{(n, 2 k)}} \mid S_{l}^{k}(x)=0\right\}
$$

Suppose that $\frac{n}{d}$ is odd. Then, $(n, 2 k)=d$ and we have

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\} & =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{l}^{k}(x)=0\right\} \\
& =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{L}^{k} \circ S_{l}^{L}(x)=0\right\} \text { (by Assertion } 1 \text { of Lemma 1) } \\
& =\left\{x \in \mathbb{F}_{p^{d}} \mid S_{l}^{L}(x)=0\right\} \\
& =\left\{S_{L}^{2 L} \circ T_{l}^{2 l}(\beta) \in \mathbb{F}_{p^{d}} \mid \beta \in \mathbb{F}_{p^{2 L}}\right\} \text { (by Assertion 3 of Lemma 2). }
\end{aligned}
$$

Now, if $S_{L}^{2 L} \circ T_{l}^{2 l}(\beta) \in \mathbb{F}_{p^{d}}$ for $\beta \in \mathbb{F}_{p^{2 L}}$, then we have

$$
\begin{aligned}
\left(S_{L}^{2 L} \circ T_{l}^{2 l}(\beta)\right)^{p^{L}}=S_{L}^{2 L} \circ T_{l}^{2 l}(\beta) & \Longleftrightarrow-S_{L}^{2 L} \circ T_{l}^{2 l}(\beta)=S_{L}^{2 L} \circ T_{l}^{2 l}(\beta) \\
& \Longleftrightarrow S_{L}^{2 L} \circ T_{l}^{2 l}(\beta)=0
\end{aligned}
$$

Thus, in that case

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=\{0\}
$$

Now, suppose that $\frac{n}{d}$ is even. Then, $(n, 2 k)=2 d$ and

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=\left\{x \in \mathbb{F}_{p^{2 d}} \mid S_{l}^{k}(x)=0\right\}
$$

Since $\frac{L}{l}$ is odd, from by Assertion 5 of Lemma 1 it follows

$$
\begin{equation*}
S_{l}^{2 L}(x)+S_{l}^{2 L}(x)^{p^{L}}=0 \tag{4}
\end{equation*}
$$

for every $x \in \mathbb{F}_{p^{2 d}}$.
Also, $\frac{k}{d}$ is odd since $\frac{n}{d}$ is even and $\left(\frac{n}{d}, \frac{k}{d}\right)=1$. This implies $\frac{L}{d}$ odd as well since it is divisor of $\frac{k}{d}$. Therefore, for every $x \in \mathbb{F}_{p^{2 d}}$, it holds

$$
\begin{aligned}
& x^{p^{L}}=\left(x^{p^{\frac{L-d}{d} \cdot d}}\right)^{p^{d}}=x^{p^{d}}, \\
& x^{p^{k}}=\left(x^{p^{\frac{k-d}{d} \cdot d}}\right)^{p^{d}}=x^{p^{d}}
\end{aligned}
$$

and hence

$$
\begin{equation*}
S_{L}^{2 L}(x)=S_{d}^{2 d}(x) \text { and } T_{k}^{2 k}(x)=T_{d}^{2 d}(x) \tag{5}
\end{equation*}
$$

Moreover, since $\frac{L}{d}=\frac{[d, l]}{d}$ is odd, one has $(2 d, l)=(d, l)=e$ and $[2 d, l]=\frac{2 d l}{(2 d, l)}=$ $2 \frac{d l}{(d, l)}=2[d, l]=2 L$. Therefore, by Assertion 4 of Lemma 1, for every $x \in \mathbb{F}_{p^{2 d}}$ we have $S_{l}^{2 L}(x)=S_{l}^{[2 d, l]}(x)=S_{(2 d, l)}^{2 d}(x)=S_{(d, l)}^{2 d}(x)=S_{e}^{2 d}(x)$, that is,

S_{l}^{2 L}(x)=S_{e}^{2 d}(x) \tag{6}
\end{equation*}
$$

Then, for every $x \in \mathbb{F}_{p^{2 d}}$ one has

$$
\begin{aligned}
S_{d}^{2 d} \circ S_{l}^{k}(x) & =S_{L}^{2 L} \circ S_{l}^{k}(x)(\text { by }(5)) \\
& =S_{L}^{2 L} \circ S_{L}^{k} \circ S_{l}^{L}(x)(\text { by Assertion } 1 \text { of Lemma 1) } \\
& =S_{L}^{k} \circ S_{L}^{2 L} \circ S_{l}^{L}(x) \\
& =S_{L}^{k} \circ S_{l}^{2 L}(x)(\text { again by Assertion } 1 \text { of Lemma 1) } \\
& =\frac{k}{L} S_{l}^{2 L}(x)(\text { by }(4)) \\
& =\frac{k}{L} S_{e}^{2 d}(x)(\text { by }(6))
\end{aligned}
$$

that is,

$$
S_{l}^{k}\left(S_{d}^{2 d}(x)\right)= \begin{cases}0, & \text { if } p \left\lvert\, \frac{k}{L}\right.  \tag{7}\\ S_{e}^{2 d}(x), & \text { otherwise } .\end{cases}
$$

Thus, when $p \left\lvert\, \frac{k}{L}\right.$, it holds

$$
\left\{x \in \mathbb{F}_{p^{2 d}} \mid S_{l}^{k}(x)=0\right\} \supset S_{d}^{2 d}\left(\mathbb{F}_{p^{2 d}}\right)=\operatorname{ker}\left(T_{d}^{2 d}\right)
$$

where the equality is from Assertion 1 of Lemma 2. On the other hand, by (5) and Assertion 2 of Lemma 1, $T_{d}^{2 d}(x)=T_{k}^{2 k}(x)=T_{l}^{2 l} \circ S_{l}^{k}(x)$ for every $x \in \mathbb{F}_{p^{2 d}}$ and therefore $\left\{x \in \mathbb{F}_{p^{2 d}} \mid S_{l}^{k}(x)=0\right\} \subset \operatorname{ker}\left(T_{d}^{2 d}\right)$. Hence, when $p \left\lvert\, \frac{k}{L}\right.$, we get

$$
\left\{x \in \mathbb{F}_{p^{n}} \mid S_{l}^{k}(x)=0\right\}=S_{d}^{2 d}\left(\mathbb{F}_{p^{2 d}}\right)
$$

On the other hand, if $p \nmid \frac{k}{L}$, then by (7)

$$
\begin{aligned}
\left\{x \in \mathbb{F}_{p^{2 d}} \mid S_{l}^{k}(x)=0\right\} & \supset\left\{S_{d}^{2 d}(x) \mid S_{e}^{2 d}(x)=0, x \in \mathbb{F}_{p^{2 d}}\right\} \\
& =\left\{S_{d}^{2 d} \circ T_{e}^{2 e}(\beta) \mid \beta \in \mathbb{F}_{p^{2 d}}\right\} \text { (by Assertion } 2 \text { of Lemma 2) } \\
& =\operatorname{ker}\left(S_{e}^{d}\right) \text { (by Assertion 3 of Lemma } 2 \text { since } \frac{d}{e}=\frac{L}{l} \text { is odd). }
\end{aligned}
$$

Also, when $x \in \mathbb{F}_{p^{2 d}}$, we can write

$$
S_{l}^{k}(x)=\frac{k-L}{2 L} S_{l}^{2 L}(x)+S_{l}^{L}(x)
$$

because $\frac{k}{L}$ is odd. By (6) and (7), $S_{l}^{k}(x)=0$ implies $S_{l}^{2 L}(x)=0$ and therefore if $S_{l}^{k}(x)=0$, then $S_{l}^{L}(x)=0$ for $x \in \mathbb{F}_{p^{2 d}}$. Then one has

\left\{x \in \mathbb{F}_{p^{2 d}} \mid S_{l}^{k}(x)=0\right\} \subset \operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{2 d}}
$$

Thus, to conclude the theorem, thanks to Assertion 3 of Lemma 2 it is sufficient to prove:

$$
\begin{equation*}
\operatorname{ker}\left(S_{e}^{d}\right)=\operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{2 d}} \tag{8}
\end{equation*}
$$

To begin with, let us show

$$
\operatorname{ker}\left(S_{e}^{d}\right) \subset \operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{2 d}}
$$

In fact, if $y \in \operatorname{ker}\left(S_{e}^{d}\right)$ or equivalently $y=S_{d}^{2 d} \circ T_{e}^{2 e}(\beta)$ for some $\beta \in \mathbb{F}_{p^{2 d}}$, then

$$
\begin{aligned}
S_{l}^{L}(y) & =S_{l}^{L} \circ S_{d}^{2 d} \circ T_{e}^{2 e}(\beta) \\
& =S_{l}^{L} \circ S_{L}^{2 L} \circ T_{e}^{2 e}(\beta)(\text { by }(5)) \\
& =S_{l}^{2 L} \circ T_{e}^{2 e}(\beta)(\text { by Assertion } 1 \text { of Lemma } 1) \\
& =S_{e}^{2 d} \circ T_{e}^{2 e}(\beta)(\text { by }(6)) \\
& =S_{2 d}^{4 d}(\beta)(\text { by Assertion } 2 \text { of Lemma } 1) \\
& =0\left(\text { since } \beta \in \mathbb{F}_{p^{2 d}}\right) .
\end{aligned}
$$

Next, we prove

$$
\# \operatorname{ker}\left(S_{e}^{d}\right)=\#\left\{\operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{2 d}}\right\}
$$

which will conclude (8). Let $A:=\operatorname{ker}\left(S_{e}^{2 d}\right)=T_{e}^{2 e}\left(\mathbb{F}_{p^{2 d}}\right)$. Then, by (6), $A=$ $\operatorname{ker}\left(S_{l}^{2 L}\right) \cap \mathbb{F}_{p^{2 d}}$, and since $S_{l}^{2 L}=S_{L}^{2 L} \circ S_{l}^{L}$ by Assertion 1 of Lemma 1,

$$
\operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{2 d}} \subset A
$$

Hence, now we determine $S_{l}^{L}(A)$ which will make it possible to compute $\#\left\{\operatorname{ker}\left(S_{l}^{L}\right) \cap\right.$ $\left.\mathbb{F}_{p^{2 d}}\right\}$. Since $S_{d}^{2 d}\left(S_{l}^{L}(A)\right) \stackrel{(5)}{=} S_{L}^{2 L}\left(S_{l}^{L}(A)\right)=S_{l}^{2 L}(A)=\{0\}$, it holds

$$
\begin{equation*}
S_{l}^{L}(A) \subset \mathbb{F}_{p^{d}} \tag{9}
\end{equation*}
$$

Then, since $\frac{d}{e}=\frac{L}{l}$ is odd, by Assertion 2 of Lemma $1, S_{e}^{d}(A)=S_{e}^{d} \circ T_{e}^{2 e}\left(\mathbb{F}_{p^{2 d}}\right)=$ $T_{d}^{2 d}\left(\mathbb{F}_{p^{2 d}}\right)=\mathbb{F}_{p^{d}}$. The obvious fact $S_{e}^{d}(A) \subset A$ yields

$$
\begin{equation*}
\mathbb{F}_{p^{d}} \subset A \tag{10}
\end{equation*}
$$

Now, let us prove that $S_{l}^{L}$ is a permutation on $\mathbb{F}_{p^{d}}$. In fact, if $y \in \mathbb{F}_{p^{L}}$ is an element in $\operatorname{ker}\left(S_{l}^{L}\right)$, then by Assertion 3 of Lemma 2 we can write $y=S_{L}^{2 L} \circ T_{l}^{2 l}(\beta)$ for some $\beta \in \mathbb{F}_{p^{2 L}}$ and one has $y=y^{p^{L}}=\left(S_{L}^{2 L} \circ T_{l}^{2 l}(\beta)\right)^{p^{L}}=-S_{L}^{2 L} \circ T_{l}^{2 l}(\beta)=-y$, i.e. $y=0$. Therefore, $\operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{L}}=\{0\}$ and $S_{l}^{L}$ is a permutation on $\mathbb{F}_{p^{L}}$ and subsequently on $\mathbb{F}_{p^{d}}$. Applying $S_{l}^{L}$ on both sides of (10) we get

$$
\begin{equation*}
\mathbb{F}_{p^{d}} \subset S_{l}^{L}(A) \tag{11}
\end{equation*}
$$

Combining (9) and (11) proves

$$
S_{l}^{L}(A)=\mathbb{F}_{p^{d}}
$$

From this equality, considering $x \mapsto S_{l}^{L}(x)$ as an $\mathbb{F}_{p}$-linear transformation of the $\mathbb{F}_{p}$-subspace $A$, it follows that

$$
\#\left\{\operatorname{ker}\left(S_{l}^{L}\right) \cap \mathbb{F}_{p^{2 d}}\right\}=\# A / p^{d}=p^{(2 d-e)-d}=p^{d-e}=\# \operatorname{ker}\left(S_{e}^{d}\right) .
$$

## 4 On particular solutions of $T_{l}^{k}(X)=a$ and $S_{l}^{k}(X)=a$

In this section, we give particular solutions for each of the two equations (2) and (3) as well as characterizations of the $a$ 's in $\mathbb{F}_{p^{n}}$ for which the equations (2) and (3) have at least one solution in $\mathbb{F}_{p^{n}}$. As in Section 3, we present these results in three statements. Each of them corresponds to one of the three cases of Lemma 2.

Theorem 4. Let $\delta \in \mathbb{F}_{p^{n}}^{*}$ and $\delta_{1} \in \mathbb{F}_{p^{d}}^{*}$ be any elements such that $T_{d}^{n}(\delta)=1$ and $T_{e}^{d}\left(\delta_{1}\right)=1$.

1. When $p \left\lvert\, \frac{k}{L}\right.$, there exists a solution in $\mathbb{F}_{p^{n}}$ to the equation $T_{l}^{k}(X)=a, a \in \mathbb{F}_{p^{n}}$, if and only if $T_{d}^{n}(a)=0$. In that case,

$$
x_{0}=S_{l}^{2 l}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}\right)
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $T_{l}^{k}(X)=a$.
2. When $p \nmid \frac{k}{L}$, there exists a solution in $\mathbb{F}_{p^{n}}$ to the equation $T_{l}^{k}(X)=a, a \in$ $\mathbb{F}_{p^{n}}$, if and only if $S_{e}^{2 e} \circ T_{d}^{n}(a)=0$. In that case,

$$
x_{0}=y_{0}+\frac{L}{k}\left(a-T_{l}^{k}\left(y_{0}\right)\right) \delta_{1},
$$

where

$$
y_{0}=\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} S_{l}^{2 l}(a)^{p^{k i}}
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $T_{l}^{k}(X)=a$.

Proof. Let $a=T_{l}^{k}\left(x_{0}\right)$ for some $x_{0} \in \mathbb{F}_{p^{n}}$. Then

$$
\begin{aligned}
T_{d}^{n}(a) & =T_{d}^{n} \circ T_{l}^{k}\left(x_{0}\right) \\
& =T_{d}^{n} \circ T_{L}^{k} \circ T_{l}^{L}\left(x_{0}\right)(\text { by Assertion } 1 \text { of Lemma } 1) \\
& =T_{L}^{k} \circ T_{l}^{L} \circ T_{d}^{n}\left(x_{0}\right) \\
& =T_{L}^{k} \circ T_{e}^{d} \circ T_{d}^{n}\left(x_{0}\right) \text { (by Assertion } 4 \text { of Lemma 1) } \\
& \left.=T_{L}^{k} \circ T_{e}^{n}\left(x_{0}\right) \text { (by Assertion } 1 \text { of Lemma } 1\right) \\
& =\frac{k}{L} T_{e}^{n}\left(x_{0}\right)\left(\text { since } T_{e}^{n}\left(x_{0}\right) \in \mathbb{F}_{p^{e}} \subset \mathbb{F}_{p^{L}}\right) .
\end{aligned}
$$

Thus, if $p \left\lvert\, \frac{k}{L}\right.$, then $T_{d}^{n}(a)=0$, and if $p \nmid \frac{k}{L}$, then $S_{e}^{2 e} \circ T_{d}^{n}(a)=\frac{k}{L} S_{e}^{2 e} \circ T_{e}^{n}\left(x_{0}\right)=$ $\frac{k}{L} S_{n}^{2 n}\left(x_{0}\right)=0$ where we applied Assertion 3 of Lemma 1. In other words, if $p \left\lvert\, \frac{k}{L}\right.$, then

$$
\begin{equation*}
T_{l}^{k}\left(\mathbb{F}_{p^{n}}\right) \subset\left\{a \in \mathbb{F}_{p^{n}} \mid T_{d}^{n}(a)=0\right\}, \tag{12}
\end{equation*}
$$

and if $p \nmid \frac{k}{L}$, then

$$
\begin{equation*}
T_{l}^{k}\left(\mathbb{F}_{p^{n}}\right) \subset\left\{a \in \mathbb{F}_{p^{n}} \mid S_{e}^{2 e} \circ T_{d}^{n}(a)=0\right\} \tag{13}
\end{equation*}
$$

By Theorem 1 we have:

$$
\# T_{l}^{k}\left(\mathbb{F}_{p^{n}}\right)=p^{n} / \#\left\{\operatorname{ker}\left(T_{l}^{k}\right) \cap \mathbb{F}_{p^{n}}\right\}= \begin{cases}p^{n-d}, & \text { if } p \left\lvert\, \frac{k}{L}\right. \\ p^{n-(d-e)}, & \text { otherwise } .\end{cases}
$$

On the other hand, by the well-known nature of the trace mapping one knows

$$
\#\left\{a \in \mathbb{F}_{p^{n}} \mid T_{d}^{n}(a)=0\right\}=p^{n-d}
$$

and

$$
\#\left\{a \in \mathbb{F}_{p^{n}} \mid S_{e}^{2 e} \circ T_{d}^{n}(a)=0\right\}=\#\left\{a \in \mathbb{F}_{p^{n}} \mid T_{d}^{n}(a) \in \mathbb{F}_{p^{e}}\right\}=p^{n-(d-e)}
$$

Thus, we conclude that the inclusions (12) and (13) are actually equalities. That is, the if and only if conditions for $T_{l}^{k}(X)=a \in \mathbb{F}_{p^{n}}$ to have a solution in $\mathbb{F}_{p^{n}}$ are proved.

Let us check the validity of the given particular solutions. If $T_{d}^{n}(a)=0$, we have

$$
\begin{aligned}
& T_{l}^{k} \circ S_{l}^{2 l}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}\right) \\
& =S_{k}^{2 k}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}\right)(\text { by Assertion 3 of Lemma 1) } \\
& =\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}-\sum_{i=1}^{\frac{n}{d}-1} \sum_{j=i+1}^{\frac{n}{d}} \delta^{p^{k j}} a^{p^{k i}} \\
& =\sum_{j=1}^{\frac{n}{d}-1} \delta^{p^{k j}} a-\sum_{i=1}^{\frac{n}{d}-1} \delta^{p^{\frac{k}{d} n}} a^{p^{k i}} \\
& =\sum_{j=1}^{\frac{n}{n}-1} \delta^{p^{k j}} a-\sum_{i=1}^{\frac{n}{n-1}-1} \delta a^{p^{k i}} \\
& =\sum_{j=0}^{n-1} \delta^{p^{k j}} a-\sum_{i=0}^{n_{d}^{d}-1} \delta a^{p^{k i}} \\
& =T_{k}^{[n, k]}(\delta) a-\delta T_{k}^{[n, k]}(a) \\
& =T_{d}^{n}(\delta) a-\delta T_{d}^{n}(a)(\text { by Assertion } 4 \text { of Lemma 1) } \\
& =a\left(\operatorname{since} T_{d}^{n}(\delta)=1 \text { and } T_{d}^{n}(a)=0\right) .
\end{aligned}
$$

This proves case 1 .
Now, suppose that $p \nmid \frac{k}{L}$ and $S_{e}^{2 e} \circ T_{d}^{n}(a)=0$, i.e., $T_{d}^{n}(a) \in \mathbb{F}_{p^{e}}$. Then, $S_{l}^{2 l}\left(T_{d}^{n}(a)\right)=T_{d}^{n}(a)-T_{d}^{n}(a)^{p^{l}}=0$, and for $y_{0}=\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} S_{l}^{2 l}(a)^{p^{k i}}$, it holds

$$
\begin{aligned}
S_{k}^{2 k}\left(y_{0}\right) & =\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} S_{l}^{2 l}(a)^{p^{k i}}-\sum_{i=1}^{\frac{n}{d}-1} \sum_{j=i+1}^{\frac{n}{d}} \delta^{p^{k j}} S_{l}^{2 l}(a)^{p^{k i}} \\
& =S_{l}^{2 l}(a)-\delta T_{d}^{n}\left(S_{l}^{2 l}(a)\right)=S_{l}^{2 l}(a)-\delta S_{l}^{2 l}\left(T_{d}^{n}(a)\right) \\
& =S_{l}^{2 l}(a) .
\end{aligned}
$$

Since $S_{k}^{2 k}\left(y_{0}\right)=S_{l}^{2 l}\left(T_{l}^{k}\left(y_{0}\right)\right)$ (by Assertion 3 of Lemma 1), we get

$$
\beta:=a-T_{l}^{k}\left(y_{0}\right) \in \operatorname{ker}\left(S_{l}^{2 l}\right) \cap \mathbb{F}_{p^{n}} \subset \mathbb{F}_{p^{l}} \cap \mathbb{F}_{p^{n}}=\mathbb{F}_{p^{e}}
$$

Now, $\beta \delta_{1} \in \mathbb{F}_{p^{d}} \subset \mathbb{F}_{p^{L}}$ and therefore

$$
\begin{aligned}
T_{l}^{k}\left(\beta \delta_{1}\right) & =T_{L}^{k} \circ T_{l}^{L}\left(\beta \delta_{1}\right)(\text { by Assertion } 1 \text { of Lemma } 1) \\
& =\frac{k}{L} T_{l}^{L}\left(\beta \delta_{1}\right)\left(\text { since } T_{l}^{L}\left(\beta \delta_{1}\right) \in \mathbb{F}_{p^{L}}\right) \\
& =\frac{k}{L} T_{e}^{d}\left(\beta \delta_{1}\right)(\text { by Assertion } 4 \text { of Lemma } 1) \\
& =\frac{k}{L} \beta T_{e}^{d}\left(\delta_{1}\right)\left(\text { since } \beta \in \mathbb{F}_{p^{e}}\right) \\
& =\frac{k}{L} \beta
\end{aligned}
$$

That is, we get $T_{l}^{k}\left(\frac{L}{k}\left(a-T_{l}^{k}\left(y_{0}\right)\right) \delta_{1}\right)=a-T_{l}^{k}\left(y_{0}\right)$, or equivalently,

$$
T_{l}^{k}\left(y_{0}+\frac{L}{k}\left(a-T_{l}^{k}\left(y_{0}\right)\right) \delta_{1}\right)=a
$$

Theorem 5. Let $p \neq 2, \frac{k}{l}$ even, $\delta \in \mathbb{F}_{p^{n}}^{*}$ be any element such that $T_{d}^{n}(\delta)=1$. When $\frac{d}{e}$ is even, let $\delta_{1} \in \mathbb{F}_{p^{d}}^{*}$ be any element such that $T_{2 e}^{d}\left(\delta_{1}\right)=1$.

1. When $\frac{d}{e}$ is odd, or, when $\frac{d}{e}$ is even and $p \left\lvert\, \frac{k}{L}\right.$, there exists a solution in $\mathbb{F}_{p^{n}}$ to the equation $S_{l}^{k}(X)=a$ if and only if $T_{d}^{n}(a)=0$. In that case,

$$
\begin{equation*}
x_{0}=T_{l}^{2 l}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{k^{k j}} a^{p^{k i}}\right) \tag{14}
\end{equation*}
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $S_{l}^{k}(X)=a$.
2. When $\frac{d}{e}$ is even and $p \nmid \frac{k}{L}$, there exists a solution in $\mathbb{F}_{p^{n}}$ to the equation $S_{l}^{k}(X)=a$ if and only if $T_{e}^{2 e} \circ T_{d}^{n}(a)=0$. In that case,

$$
x_{0}=y_{0}+\frac{L}{2 k}\left(a-S_{l}^{k}\left(y_{0}\right)\right) \delta_{1}
$$

where

$$
y_{0}=\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}}
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $S_{l}^{k}(X)=a$.
Proof. Suppose that $S_{l}^{k}\left(x_{0}\right)=a$ for some $x_{0} \in \mathbb{F}_{p^{n}}$. When $\frac{d}{e}=\frac{L}{l}$ is odd, $\frac{k}{L}$ is even since $\frac{k}{l}=\frac{L}{l} \cdot \frac{k}{L}$ was assumed to be even. Then, we have

$$
\begin{aligned}
T_{d}^{n}(a) & =T_{d}^{n} \circ S_{l}^{k}\left(x_{0}\right) \\
& =T_{d}^{n} \circ S_{L}^{k} \circ S_{l}^{L}\left(x_{0}\right) \quad(\text { by Assertion } 1 \text { of Lemma } 1) \\
& =S_{L}^{k}\left(S_{l}^{L} \circ T_{d}^{n}\left(x_{0}\right)\right) \\
& =0\left(\text { since } S_{l}^{L} \circ T_{d}^{n}\left(x_{0}\right) \in \mathbb{F}_{p^{d}} \subset \mathbb{F}_{p^{L}} \text { and } \frac{k}{L}\right. \text { is even) }
\end{aligned}
$$

and thus

$$
\begin{equation*}
S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right) \subset\left\{a \in \mathbb{F}_{p^{n}} \mid T_{d}^{n}(a)=0\right\} \tag{15}
\end{equation*}
$$

On the other hand, when $\frac{d}{e}=\frac{L}{l}$ is even, one has

$$
\begin{aligned}
T_{d}^{n}(a) & =T_{d}^{n} \circ S_{l}^{k}\left(x_{0}\right) \\
& =T_{d}^{n} \circ T_{L}^{k} \circ S_{l}^{L}\left(x_{0}\right)(\text { by Assertion } 1 \text { of Lemma } 1) \\
& =T_{L}^{k} \circ S_{l}^{L} \circ T_{d}^{n}\left(x_{0}\right) \\
& =T_{L}^{k} \circ S_{e}^{d} \circ T_{d}^{n}\left(x_{0}\right)(\text { by Assertion } 4 \text { of Lemma } 1) \\
& =\frac{k}{L} S_{e}^{d} \circ T_{d}^{n}\left(x_{0}\right)\left(\text { since } S_{e}^{d} \circ T_{d}^{n}\left(x_{0}\right) \in \mathbb{F}_{p^{d}} \subset \mathbb{F}_{p^{L}}\right) .
\end{aligned}
$$

Therefore, if $p \left\lvert\, \frac{k}{L}\right.$, then (15) still holds true, and if $p \nmid \frac{k}{L}$, then it holds

$$
\begin{aligned}
T_{e}^{2 e} \circ T_{d}^{n}(a) & =\frac{k}{L} T_{e}^{2 e} \circ S_{e}^{d} \circ T_{d}^{n}\left(x_{0}\right) \\
& =\frac{k}{L} S_{d}^{2 d} \circ T_{d}^{n}\left(x_{0}\right)(\text { by Assertion } 2 \text { of Lemma 1 }) \\
& =0\left(\text { since } T_{d}^{n}\left(x_{0}\right) \in \mathbb{F}_{p^{d}}\right)
\end{aligned}
$$

and thus

$$
\begin{equation*}
S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right) \subset\left\{a \in \mathbb{F}_{p^{n}} \mid T_{e}^{2 e} \circ T_{d}^{n}(a)=0\right\} \tag{16}
\end{equation*}
$$

By Theorem 2 we have:
$\# S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right)=p^{n} / \#\left\{\operatorname{ker}\left(S_{l}^{k}\right) \cap \mathbb{F}_{p^{n}}\right\}= \begin{cases}p^{n-d}, & \text { if } \frac{d}{e} \text { is odd, or, } \frac{d}{e} \text { is even and } p \left\lvert\, \frac{k}{L}\right. \\ p^{n-(d-e)}, & \text { otherwise. }\end{cases}$
On the other hand, by the well-known nature of the trace mapping one knows

$$
\#\left\{a \in \mathbb{F}_{p^{n}} \mid T_{d}^{n}(a)=0\right\}=p^{n-d}
$$

and if $d / e$ is even then

$$
\#\left\{a \in \mathbb{F}_{p^{n}} \mid T_{e}^{2 e} \circ T_{d}^{n}(a)=0\right\}=p^{n-(d-e)}
$$

Therefore the inclusions (15) and (16) are indeed equalities. That is, the if and only if conditions for $S_{l}^{k}(X)=a$ to have an $\mathbb{F}_{p^{n}}$-solution are justified.

Since $S_{l}^{k} \circ T_{l}^{2 l}=S_{k}^{2 k}$ (Assertion 2 of Lemma 1), it can be checked by the same computation as in the proof of the first assertion of Theorem 4 that under the condition $T_{d}^{n}(a)=0$,

$$
x_{0}=T_{l}^{2 l}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}\right)
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $S_{l}^{k}(X)=a$. This proves case 1.

Now, assuming that $\frac{d}{e}=\frac{L}{l}$ is even, let us suppose that $p \nmid \frac{k}{L}$ and $T_{e}^{2 e} \circ$ $T_{d}^{n}(a)=0$, i.e., $T_{d}^{n}(a)^{p^{e}}=-T_{d}^{n}(a)$. Then, $\frac{l}{e}$ is odd since it is prime to $\frac{n}{e}=$ $\frac{d}{e} \cdot \frac{n}{d}$ which is even. Hence, $T_{l}^{2 l}\left(T_{d}^{n}(a)\right)=T_{d}^{n}(a)+T_{d}^{n}(a)^{p^{l}}=0$, and for $y_{0}=$ $\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}}$, it holds

$$
\begin{aligned}
S_{k}^{2 k}\left(y_{0}\right) & =\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}}-\sum_{i=1}^{\frac{n}{d}-1} \sum_{j=i+1}^{\frac{n}{d}} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}} \\
& =T_{l}^{2 l}(a)-\delta T_{d}^{n}\left(T_{l}^{2 l}(a)\right)=T_{l}^{2 l}(a)-\delta T_{l}^{2 l}\left(T_{d}^{n}(a)\right) \\
& =T_{l}^{2 l}(a) .
\end{aligned}
$$

Since $S_{k}^{2 k}\left(y_{0}\right)=T_{l}^{2 l}\left(S_{l}^{k}\left(y_{0}\right)\right)($ Assertion 2 of Lemma 1), letting $\beta:=a-$ $S_{l}^{k}\left(y_{0}\right)$, we have

$$
\beta \in \operatorname{ker}\left(T_{l}^{2 l}\right) \cap \mathbb{F}_{p^{n}} \subset \mathbb{F}_{p^{2 l}} \cap \mathbb{F}_{p^{n}} \subset \mathbb{F}_{p^{2 e}} \subset \mathbb{F}_{p^{d}}
$$

and

$$
\begin{aligned}
S_{l}^{k}\left(\beta \delta_{1}\right) & =\frac{k}{L} S_{l}^{L}\left(\beta \delta_{1}\right)\left(\text { since } \frac{L}{l} \text { is even }\right) \\
& =\frac{k}{L} S_{e}^{d}\left(\beta \delta_{1}\right)(\text { by Assertion } 4 \text { of Lemma } 1) \\
& =\frac{k}{L} S_{e}^{2 e}\left(T_{2 e}^{d}\left(\beta \delta_{1}\right)\right)(\text { by Assertion } 1 \text { of Lemma } 1) \\
& =\frac{k}{L} S_{e}^{2 e}\left(\beta T_{2 e}^{d}\left(\delta_{1}\right)\right)\left(\text { since } \beta \in \mathbb{F}_{p^{2 e}}\right) \\
& =\frac{k}{L} S_{e}^{2 e}(\beta)=\frac{k}{L}\left(\beta-\beta^{p^{e}}\right)
\end{aligned}
$$

On the other hand, since $\operatorname{ker}\left(T_{l}^{2 l}\right) \cap \mathbb{F}_{p^{2 e}}=S_{e}^{2 e}\left(\mathbb{F}_{p^{2 e}}\right)$ (see Theorem 1), $\beta \in$ $\operatorname{ker}\left(T_{l}^{2 l}\right) \cap \mathbb{F}_{p^{n}}$ means that $\beta=\alpha-\alpha^{p^{e}}$ for some $\alpha \in \mathbb{F}_{p^{2 e}}$, and therefore we get $\beta+\beta^{p^{e}}=\left(\alpha-\alpha^{p^{e}}\right)+\left(\alpha-\alpha^{p^{e}}\right)^{p^{e}}=0$ and hence

$$
S_{l}^{k}\left(\beta \delta_{1}\right)=\frac{2 k}{L} \beta
$$

or equivalently,

$$
S_{l}^{k}\left(y_{0}+\frac{L}{2 k}\left(a-S_{l}^{k}\left(y_{0}\right)\right) \delta_{1}\right)=a .
$$

Theorem 6. Let $p \neq 2, \frac{k}{l}$ odd, $\delta \in \mathbb{F}_{p^{n}}^{*}$ and $\delta_{1} \in \mathbb{F}_{p^{2 d}}^{*}$ be any elements such that $T_{d}^{n}(\delta)=1$ and $T_{2 e}^{2 d}\left(\delta_{1}\right)=1$.

1. When $\frac{n}{d}$ is even and $p \left\lvert\, \frac{k}{L}\right.$, there exists a solution in $\mathbb{F}_{p^{n}}$ to the equation $S_{l}^{k}(X)=a$ if and only if $S_{d}^{n}(a)=0$. In that case,

$$
x_{0}=T_{l}^{2 l}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{k^{k i}}(-1)^{i}\right)
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $S_{l}^{k}(X)=a$.
2. When $\frac{n}{d}$ is even and $p \nmid \frac{k}{L}$, there exists a solution in $\mathbb{F}_{p^{n}}$ to the equation $S_{l}^{k}(X)=a$ if and only if $T_{e}^{2 e} \circ S_{d}^{n}(a)=0$. In that case,

$$
x_{0}=y_{0}+\frac{L}{2 k} S_{d}^{2 d}\left(\left(a-S_{l}^{k}\left(y_{0}\right)\right) \delta_{1}\right),
$$

where

$$
y_{0}=\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}}(-1)^{i}
$$

is a particular $\mathbb{F}_{p^{n}}$-solution to the equation $S_{l}^{k}(X)=a$.
3. When $\frac{n}{d}$ is odd, the equation $S_{l}^{k}(X)=$ a has a unique $\mathbb{F}_{p^{n}}$-solution:

$$
x_{0}=\frac{T_{l}^{2 l} \circ S_{k}^{[n, k]}(a)}{2}
$$

Proof. Suppose $a \in S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right)$, i.e., $a=S_{l}^{k}\left(x_{0}\right)$ for some $x_{0} \in \mathbb{F}_{p^{n}}$.
Let us assume that $\frac{n}{d}$ is even. In this case, $\frac{k}{d}$ and its divisor $\frac{L}{d}$ are odd since $\left(\frac{n}{d}, \frac{k}{d}\right)=1$. One has

$$
\begin{aligned}
S_{d}^{n}(a) & =S_{d}^{n} \circ S_{l}^{k}\left(x_{0}\right) \\
& =S_{d}^{n} \circ S_{L}^{k} \circ S_{l}^{L}\left(x_{0}\right)(\text { by Assertion } 1 \text { of Lemma 1) } \\
& =S_{d}^{2 d} \circ T_{2 d}^{n} \circ S_{L}^{k} \circ S_{l}^{L}\left(x_{0}\right)(\text { again by Assertion } 1 \text { of Lemma 1) } \\
& =S_{L}^{2 L} \circ T_{2 d}^{n} \circ S_{L}^{k} \circ S_{l}^{L}\left(x_{0}\right)\left(\text { by }(5) \text { since } T_{2 d}^{n} \circ S_{L}^{k} \circ S_{l}^{L}\left(x_{0}\right) \in \mathbb{F}_{p^{2 d}}\right) \\
& =S_{L}^{k} \circ S_{L}^{2 L} \circ S_{l}^{L} \circ T_{2 d}^{n}\left(x_{0}\right) \\
& =S_{L}^{k} \circ S_{l}^{2 L} \circ T_{2 d}^{n}\left(x_{0}\right)(\text { by Assertion } 1 \text { of Lemma 1) } \\
& =\frac{k}{L} S_{l}^{2 L} \circ T_{2 d}^{n}\left(x_{0}\right)(\text { by (4)) } \\
& =\frac{k}{L} S_{e}^{2 d} \circ T_{2 d}^{n}\left(x_{0}\right)\left(\text { by }(6) \text { since } T_{2 d}^{n}\left(x_{0}\right) \in \mathbb{F}_{p^{2 d}}\right) \\
& =\frac{k}{L} S_{e}^{n}\left(x_{0}\right)=\frac{k}{L} S_{e}^{2 e} \circ T_{2 e}^{n}\left(x_{0}\right)(\text { once again by Assertion } 1 \text { of Lemma 1). }
\end{aligned}
$$

Therefore, if $p \left\lvert\, \frac{k}{L}\right.$, then it holds

$$
\begin{equation*}
S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right) \subset\left\{a \in \mathbb{F}_{p^{n}} \mid S_{d}^{n}(a)=0\right\} \tag{17}
\end{equation*}
$$

and if $p \nmid \frac{k}{L}$, then it holds

$$
\begin{equation*}
S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right) \subset\left\{a \in \mathbb{F}_{p^{n}} \mid T_{e}^{2 e} \circ S_{d}^{n}(a)=0\right\} \tag{18}
\end{equation*}
$$

since $T_{e}^{2 e} \circ S_{d}^{n}\left(S_{l}^{k}\left(x_{0}\right)\right)=T_{e}^{2 e} \circ S_{e}^{2 e} \circ T_{2 e}^{n}\left(x_{0}\right)=0$. By the second assertion of Theorem 3, if $p \left\lvert\, \frac{k}{L}\right.$ then the size of $S_{l}^{k}\left(\mathbb{F}_{p^{n}}\right)$ equals the degree of $S_{d}^{n}$ and when $p \nmid \frac{k}{L}$ then it equals the degree of $T_{e}^{2 e} \circ S_{d}^{n}$. It follows that the inclusions (17) and
(18) are actually equalities. That is, the if and only if conditions for $S_{l}^{k}(X)=a$ to have an $\mathbb{F}_{p^{n}}$-solution are justified.

If $S_{d}^{n}(a)=0$, then for $x_{0}=T_{l}^{2 l}\left(\sum_{i=0}^{\frac{n}{a}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}(-1)^{i}\right)$,

$$
\begin{aligned}
S_{l}^{k}\left(x_{0}\right) & =T_{k}^{2 k}\left(\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}(-1)^{i}\right)(\text { by Assertion } 2 \text { of Lemma 1) } \\
& =\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} a^{p^{k i}}(-1)^{i}+\sum_{i=1}^{\frac{n}{d}-1} \sum_{j=i+1}^{\frac{n}{d}} \delta^{p^{k j}} a^{p^{k i}}(-1)^{i-1} \\
& =a-\delta S_{d}^{n}(a)=a .
\end{aligned}
$$

This finishes the proof of case 1.
Now, suppose that $T_{e}^{2 e} \circ S_{d}^{n}(a)=0$, i.e., $S_{d}^{n}(a)^{p^{e}}=-S_{d}^{n}(a)$. Then, $\frac{l}{e}$ is odd since it is prime to $\frac{n}{e}=\frac{d}{e} \cdot \frac{n}{d}$ which is even, and hence $T_{l}^{2 l}\left(S_{d}^{n}(a)\right)=$ $S_{d}^{n}(a)+S_{d}^{n}(a)^{p^{l}}=0$. Thus, for $y_{0}=\sum_{i=0}^{\frac{n}{a}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}}(-1)^{i}$ one has

$$
\begin{aligned}
T_{k}^{2 k}\left(y_{0}\right) & =\sum_{i=0}^{\frac{n}{d}-2} \sum_{j=i+1}^{\frac{n}{d}-1} \delta^{p^{k j}} T_{l}^{2 l}(a)^{k^{k i}}(-1)^{i}+\sum_{i=1}^{\frac{n}{d}-1} \sum_{j=i+1}^{\frac{n}{d}} \delta^{p^{k j}} T_{l}^{2 l}(a)^{p^{k i}}(-1)^{i-1} \\
& =T_{l}^{2 l}(a)-\delta S_{d}^{n}\left(T_{l}^{2 l}(a)\right)=T_{l}^{2 l}(a)
\end{aligned}
$$

Since $T_{k}^{2 k}\left(y_{0}\right)=T_{l}^{2 l} \circ S_{l}^{k}\left(y_{0}\right)$ (by Assertion 2 of Lemma 1), we have

$$
\beta:=a-S_{l}^{k}\left(y_{0}\right) \in \operatorname{ker}\left(T_{l}^{2 l}\right) \cap \mathbb{F}_{p^{n}} \subset \mathbb{F}_{p^{2 e}} \subset \mathbb{F}_{p^{2 d}}
$$

Now,

$$
\begin{aligned}
S_{l}^{k}\left(S_{d}^{2 d}\left(\beta \delta_{1}\right)\right) & =S_{l}^{k}\left(S_{L}^{2 L}\left(\beta \delta_{1}\right)\right)(\text { by }(5)) \\
& =S_{L}^{k} \circ S_{l}^{L}\left(S_{L}^{2 L}\left(\beta \delta_{1}\right)\right) \quad \text { (by Assertion } 1 \text { of Lemma 1) } \\
& =S_{L}^{k} \circ\left(S_{l}^{2 L}\left(\beta \delta_{1}\right)\right) \quad(\text { by Assertion } 1 \text { of Lemma 1) } \\
& =\frac{k}{L} S_{l}^{2 L}\left(\beta \delta_{1}\right)(\text { by (4)) } \\
& =\frac{k}{L} S_{e}^{2 d}\left(\beta \delta_{1}\right)(\text { by }(6)) \\
& =\frac{k}{L} S_{e}^{2 e} \circ T_{2 e}^{2 d}\left(\beta \delta_{1}\right)(\text { by Assertion } 1 \text { of Lemma 1) } \\
& =\frac{k}{L} S_{e}^{2 e}\left(\beta T_{2 e}^{2 d}\left(\delta_{1}\right)\right)=\frac{k}{L} S_{e}^{2 e}(\beta)=\frac{k}{L}\left(\beta-\beta^{p^{e}}\right)
\end{aligned}
$$

Since $\beta \in \operatorname{ker}\left(T_{l}^{2 l}\right) \cap \mathbb{F}_{p^{2 e}}=S_{e}^{2 e}\left(\mathbb{F}_{p^{2 e}}\right)$ (Theorem 1), it holds $\beta+\beta^{p^{e}}=0$ and thus we get

$$
S_{l}^{k}\left(S_{d}^{2 d}\left(\beta \delta_{1}\right)\right)=\frac{2 k}{L} \beta
$$

That is,

$$
S_{l}^{k}\left(y_{0}+\frac{L}{2 k} S_{d}^{2 d}\left(\left(a-S_{l}^{k}\left(y_{0}\right)\right) \delta_{1}\right)\right)=a
$$

This finishes the proof of case 2 .
If $\frac{n}{d}=\frac{[n, k]}{k}$ is odd, then by Theorem $3, S_{l}^{k}$ is a permutation on $\mathbb{F}_{p^{n}}$ and the equation $S_{l}^{k}(X)=a$ has a unique $\mathbb{F}_{p^{n}}$-solution. In fact, applying Assertion 2 of Lemma 1 twice yields

$$
S_{l}^{k}\left(T_{l}^{2 l} \circ S_{k}^{[n, k]}(a / 2)\right)=T_{k}^{2 k} \circ S_{k}^{[n, k]}(a / 2)=T_{[n, k]}^{2[n, k]}(a / 2)=a .
$$

## 5 Conclusion

We explicitly determined the sets of preimages of linearized polynomials

$$
\begin{aligned}
T_{l}^{k}(X) & :=\sum_{i=0}^{\frac{k}{c}-1} X^{p^{i i}}, \\
S_{l}^{k}(X) & :=\sum_{i=0}^{\frac{k}{l}-1}(-1)^{i} X^{p^{l i}},
\end{aligned}
$$

over the finite field $\mathbb{F}_{p^{n}}$ for any characteristic $p$ and any integer $n \geq 1$. In particular, another solution for the case $p=2$, which was solved very recently in [10], was obtained in Theorem 1 and Theorem 4.
