15 Abstract

16 Infectious hematopoietic necrosis virus (IHNV) is a pathogen of importance for salmonid aquaculture. In this study, we aimed to characterize virus behavior and defense mechanisms 17 developed in rainbow trout (RT, Oncorhynchus mykiss) experimentally infected with isolates 18 belonging to the five described genotypes of IHNV, i.e. L, U, M, E and J. Mortality was 19 monitored for two months, and blood and target organs were sampled at different times post-20 infection to assess viral load and cellular and humoral immune responses. Profiles of 21 22 virulence were highly linked to precocious viral replication but also to the innate and specific immunity elicited in the host. Seroneutralization test (SNT) used for specific antibodies 23 detection exhibited reliable results, with efficient cross-neutralization observed in 24 heterologous systems except for the Asian representative. These data bring new insights about 25 IHNV/RT interaction and reinforce the interest of SNT as preventive and epidemiological 26 27 tool.

1. Introduction

Infectious hematopoietic necrosis virus (IHNV) is responsible for infectious hematopoietic 40 necrosis (IHN) in a large number of aquatic animal species, and is notifiable to the World 41 Organization for Animal Health (OIE) and to the European Union (Council Directive 2006/88 42 EC). IHN mainly affects salmonid species, such as salmon and rainbow trout, and can 43 represent a serious concern for aquaculture production, due to high mortality rates in juvenile 44 stages of development (Kim et al., 1999; Enzmann et al., 2010). Usually, adults infected by 45 the virus can develop a chronic form of the disease or become healthy carriers (Wolf 1988; 46 Kim et al., 1999). The first outbreaks were reported in the United States in the middle of the 47 48 1950s, in Washington and Oregon states, affecting sockeye salmon (Oncorhynchus nerka) hatcheries (Rucker et al., 1953). IHNV became endemic for this species in Alaska, potential 49 origin of the virus, in the 1970s (Grischkowsky and Amend, 1976), and was also detected 50 sporadically in this period in stocks of rainbow trout, steelhead trout, Chinook salmon and 51 kokanee salmon. The virus is now considered to be endemic from Alaska to California 52 (Garver et al., 2003). In the 1970s, the virus was also identified in Asia, and more precisely in 53 Japan, where sockeye and kokanee salmon were the species with the first described outbreak 54 of IHN in the country. The import of infected eggs from Alaska and commercial trade flows 55 56 were thought to be responsible for this geographical spread (Sano et al., 1977). The virus later disseminated to numerous Asian countries, among which Korea (Park et al., 1993) and China 57 (Niu and Zhao, 1988). It was also detected in Russia, notably in Kamchatka, in 2007 58 (Rudakova et al., 2007), the isolates showing high similarity with those circulating in the 59 northeast Pacific of North America. The same scenario was observed in Europe, where 60 outbreaks of IHN were reported in 1987 in France and Italy (Baudin Laurencin, 1987, Bovo 61 1987), and a few years later in Germany (Enzmann 1992). IHNV has since been identified in 62 several western European countries such as Switzerland, Belgium, and the Netherlands 63

(Haenen et al., 2016). Lastly, the virus was also detected in a rainbow trout farm in Finland 64 (Holopainen et al., 2018). In North America, Pacific salmon (genus Oncorhynchus) remain 65 the main natural hosts for IHNV, which can be responsible for high mortality in farms rearing 66 sockeye salmon (Oncorhynchus nerka), Chinook salmon (Oncorhynchus tshawytscha), but 67 also steelhead and rainbow trout (Oncorhynchus mykiss). In Europe rainbow trout represents 68 the main species susceptible to the disease (Cieslak et al., 2017). Atlantic salmon (salmo 69 salar) seems to be occasional host and, the salmon industry, predominant in the North of 70 Europe, remains free from this listed virus (2006/88/EC, 2006). 71

IHNV, belonging to the *Rhabdoviridae* family, is a single stranded RNA virus and has a bullet 72 73 shaped virion. Its genome, like that of viral hemorrhagic septicemia virus (VHSV), as members of the genus Novirhabdovirus, encodes six proteins along its 11,000 nucleotide long 74 genome: nucleoprotein (N), phosphoprotein (P), matrix protein (M), glycoprotein (G), non-75 76 virion protein (NV), and RNA polymerase (L) (Morzunov et al., 1995). The roles played by some of these proteins have already been partially elucidated. For instance, the M protein 77 appears not only to be involved in viral replication and budding, but also in pathogenicity 78 (Chen et al., 2019), like glycoprotein G which is able to induce humoral and cellular 79 immunity, in particular through specific protein glycosylation sites (Jia et al., 2019). The NV 80 protein may also be involved in viral replication and pathogenicity (Thoulouze et al., 2004; 81 Wu et al., 2018). On the basis of the considerable genetic diversity of the glycoprotein gene, 82 IHNV isolates can currently be clustered into five groups. Genogroups U, M, and L correlate 83 with the geographic distribution of IHNV isolates in the upper, middle and lower regions of 84 North America (Kurath et al., 2003; Purcell et al., 2009; Ammayappan et al., 2010). 85 Genogroup E, derived from genogroup M, comprises isolates detected in European countries 86 (Enzmann et al. 2010; Cieslak et al., 2017). Genogroup J, which shares a common origin with 87

genogroup U, mainly includes isolates from Japan, China and South Korea (Kim et al., 2007;
Xu et al., 2019 ; Park et al., 2010).

Various virulence profiles have been described for IHNV in the literature, with differences 90 dependent on the host and viral genotype. For instance, genogroup M strains were shown to 91 be highly virulent for rainbow trout, but induced only slight mortality in salmon (Wargo et al., 92 2010; 2017; McKenney et al., 2016). The opposite was described for isolates from the U or L 93 genotypes, with high mortality rates reported in Pacific salmon but not in rainbow trout 94 (Garver, Batts, and Kurath 2006; Penaranda et al., 2011; Kell et al., 2014). More precisely, U 95 isolates were more virulent in sockeye salmon but to a lesser extent in Chinook, and the 96 opposite was observed for L isolates. This genotype specific virulence could be the result of a 97 coevolution of the virus and its host. Some mutations specific to the host could have involved 98 better adaptation for the virus. This phenomenon of virulence depending of the genotype does 99 100 not occur in Atlantic salmon, which did not coevolve with the virus (Kurath at al., 2016). However, fewer data are available on the virulence profiles of genogroups E (Ahmadivan et 101 102 al., 2017; Dupuy et al., 2019; Jalali et al., 2019) and J (Jia et al., 2018). The potential origin of 103 these typical virulence profiles is partially documented in the literature. Experimental in vivo challenges have highlighted that a higher virulence was usually correlated with a higher 104 replication rate, as well as longer persistence of the virus in the infected host, even though 105 genes involved in the immune response were up-regulated (Purcell et al. 2009). In vitro assays 106 performed on the RTG-2 rainbow trout cell line confirmed these results, showing that 107 unknown host factors could be involved in the different reductions of replication rates and 108 109 transcriptional levels of viral U strain genes (Park et al., 2010).

110 Moreover, the occurrence of disease in fish depends on interactions between pathogen 111 virulence, host resistance, and the environment (Sniezko et al., 1974). More recently, Wargo 112 et al. (2010) described a correlation between *in vivo* fitness and the virulence profile. It seems that the viral replication rate may contribute to the virus spreading in the host, enabling it toelude the elicited immune response (Penaranda et al., 2011).

Fish defenses depend on innate but also acquired immune system. The innate immune system 115 116 includes physical defenses, humoral components like lysozymes, complement and interferon, and cellular processes like phagocytosis (Fletcher & Secombes, 1999; Magnadóttir, 2006). 117 Therefore, an inflammatory reaction generated by the fish immune system is critical to the 118 efficiency of innate and subsequent adaptive response to viral infections (Hussell and 119 120 Goulding, 2010). The inflammatory reaction is characterized by the systemic release of specific pro-inflammatory cytokines such as interleukin 1β (IL- 1β), which organizes the 121 immune system by activating lymphocytes and tumor necrosis factor α (TNF α), thus 122 controlling respiratory burst activity and phagocytosis (Zou et al., 2003). Additionally, toll-123 like receptors (TLRs) trigger the innate immune system by activating multiple transcription 124 125 factors, and consequently stimulate the expression of type I interferon (IFN), which ultimately establishes an antiviral state and inhibits viral replication (Zou & Secombes, 2011). Previous 126 127 studies have shown that IHNV rapidly affected interferon responses, the alternative 128 complement pathway, apoptosis, phagocytosis, T-cell activation, and cellular immunity (Purcell et al., 2006, 2010; Miller et al., 2007; Landis et al., 2008). Moreover, survivors of 129 IHNV challenge typically develop specific immunity, which is often associated with anti-130 virus antibodies secreted in plasma (Lorenzen & LaPatra, 1999). Nevertheless, specific as 131 well as innate immune responses could be associated with potential specific genetic patterns 132 involved in the differences in resistance observed between rainbow trout infected with IHNV 133 strains belonging to different genotypes. 134

The aim of the present study was to characterize the virus behavior and immune response in rainbow trout infected with isolates belonging to five described genotypes of IHNV. Mortality was monitored for eight weeks, and blood and target organs were sampled at different times post-infection to assess viral load and immune response in individual fish. Optimization of a seroneutralization test (SNT) (Hattenberger-Baudouy et al. 1995a, Hattenberger-Baudouy et al. 1995b, Hattenberger-Baudouy et al. 1989), formalized through the repealed French Standard NF U-47-022 to assess strains from genotype E, was performed to define test performance, determine possible cross-reactions, and reinforce the use of this kind of indirect method to assess a population status regarding the regulated IHNV.

145 **2.** Materials and methods

146 2.1. Fish

A total of 3,600 specific pathogen-free (SPF) juvenile rainbow trout were taken from the protected and monitored facilities of the ANSES Plouzané laboratory site (France) to perform this experiment. The fish used were nine months old (mean weight around 40 g). Before the experiment, some individuals underwent bacteriological and virological analyses to confirm the absence of culturable agents. Throughout the experiment, they were fed with commercial dry pellets at 2% body weight (T-PRIMA4, Le Gouessant Aquaculture) once a day.

154 2.2. Cells and virus

Epithelioma Papulosum Cyprini (EPC), Rainbow Trout Gonad (RTG₂) and Chinook Salmon
Embryo (CHSE₂₁₄) cells were used in this project. They were maintained in a homemade
Eagle medium (Glasgow MEM in powder (Pan Biotech), with Tris-HCl 0.19M and HCO₃Na
(Sigma) ; pH 7.6) supplemented with 10% fetal bovine serum (Eurobio), 1X antibiotics (100
IU.mL⁻¹ penicillin G, 0.1 mg.mL⁻¹ streptomycin) and L-glutamine (HyClone).

Strains FR0031 (genotype L), RU1 (unique U genotype strain from Russia), WRAC
(genotype M), and RtNag0a (genotype J), kindly provided by the OIE laboratory for IHNV
(Western Fisheries Research Center, Seattle), and N61 (genotype E), used as the French

reference strain, were selected to perform this research (Table 1). They were grown on an *Epithelioma Papulosum Cyprini* (EPC) cell monolayer at $14^{\circ}C \pm 2^{\circ}C$ for 6 to 8 days. Once the cytopathic effect was complete, cell culture supernatants were centrifuged (4,360 g, 10 mins, 5°C ± 3°C) and stored at -65°C. An aliquot of each viral suspension was titrated using the 50% tissue culture infective dose (TCID₅₀) endpoint method in 96-well plates, and calculated as described by Karber (1931). The infectious titers of the viral production were found to be between 7.11x10⁷ and 7.11x10⁸ TCID₅₀.mL⁻¹.

- 171 2.3. Experimental design

2.3.1. Authorization to conduct research and ethical aspects

This study was conducted in accordance with European Commission Recommendation 173 2007/526/EC on revised guidelines for the accommodation and care of animals used for 174 experimental and other scientific purposes. The ANSES Plouzané site is authorized to conduct 175 experiments on fish at its facilities according to Administrative Order No. C29-212-3 issued 176 by the Prefecture of the Finistère département. Furthermore, procedure was approved by the 177 local ethics committee on animal experimentation (COMETH ANSES/ENVA/UPC No. 16), 178 and was authorized by the French Ministry for Education, Higher Education and Research 179 180 under No. 09/06/15-3B.

2.3.2. Experimental system

The experimental system consisted of six similar units composed of one resin tank of 400 L and two smaller tanks of 40 L (Figure 1). Fresh river water was continuously added to each tank (open circuit) to maintain optimal water conditions for the fish throughout the experiment (oxygen saturation > 80%, pH close to 8, water free of nitrates and nitrites). The tanks were maintained in a natural light/dark cycle (14 hrs/10 hrs in winter, approximately) in a room with air volume changed every hour. Water temperature was continually cooled to 189 $11^{\circ}C \pm 2^{\circ}C$ and recorded with a wireless probe (Cobalt, Oceasoft[®]) coupled with an 190 acquisition system (ThermoClient 4.1.0.24).

2.3.3. Viral challenge conditions

The 3,600 fish were randomly distributed into the six units of the experimental system at a 193 rate of 100 fish in the 40 L tanks to monitor mortality in duplicate, and 400 fish in the largest 194 tank to perform sampling. After five days of acclimation, fish in five units were challenged 195 with the five different IHNV strains by bath infection. For three hours, the fish were 196 challenged in 25 L (for the 40 L tanks) or 100 L (for the 400 L tanks) of static freshwater with 197 a high oxygenation rate containing 10⁴ TCID₅₀.mL⁻¹, and the water inlet was then set up at a 198 flow rate of 0.3 m³.h⁻¹. The trout in the last unit were immersed with non-infected EPC cell 199 200 supernatant, and used as negative controls.

During the viral challenge, general behavior, possible specific clinical signs of rhabdovirosis, and mortalities were recorded twice a day. Dead individuals were stored at -20°C for viral examination. Eight weeks post-infection, survivors were sacrificed using a lethal dose of Eugenol (100 ppm).

2.3.4. Samples and sampling date

There were four sampling dates in the six conditions, i.e. after the acclimation period (D0; n = 5), three days post-infection (dpi) (D3; n = 5 for control and n=10 for infected fish), four dpi (D4; n = 5 for control and n=10 for infected fish), and fifty nine dpi (D59; n = 40 for control and n=40 for infected fish) (Figure 1). For the last sampling point, 30 control and infected fish were sampled additionally to assess the seroneutralization test (SNT).

For each sample, fish were anesthetized with Eugenol (20 ppm) and a maximum of blood was 212 withdrawn from the caudal vein with a lithium heparinized vacutainer (BD Vacutainer LH 213 85 IU). The blood and fish were kept on ice until processing. For flow cytometry analysis, 0.2 214 mL of blood collected from each fish were immediately diluted with 7 mL of Leibovitz 15 215 medium (L15, Eurobio) containing 7 U of lithium heparin (Sigma). Whole blood was then 216 taken for hematologic analysis, while the remaining blood samples were centrifuged (1,200 g, 217 10 mins, 4°C), and plasma was stored at -80°C for spectrophotometry analysis. The fish were 218 219 killed after blood collection by percussive stunning on the top of the head. The spleen was removed, weighed and stored at -65°C for molecular immune analyses. The head kidney as 220 well as brain (only at D59) were taken individually, shredded, and diluted to 10^{-1} in cell 221 culture medium before being centrifuged, and supernatants were kept for viral quantification 222 analyses. 223

2.4. Analytical methods

226 2.4.1. Viral examination in fish by cell culture and RT-qPCR amplification

227 The presence and concentration of virus were checked individually in dead fish (4 to 8 dpi depending on the condition of infection) and from fish collected at each sampling date. 228 Extracted and target organs (head kidney or brain) were crushed with sterile sand, diluted to 229 10⁻¹ with Eagle's solution containing antibiotics (200 IU.mL⁻¹ penicillin G, 0.2 mg.mL⁻¹ 230 streptomycin and 0.2 mg.mL⁻¹ kanamycin), and the resulting samples were centrifuged (2,000 231 g, 15 mins, 5°C \pm 3°C). Then, 100 µL of the supernatant were inoculated onto 24-well plate 232 233 cultures of EPC, CHSE₂₁₄, and RTG₂ cell lines, and plates were incubated at $14^{\circ}C \pm 2^{\circ}C$. An immunofluorescence antibody test (IFAT) was performed following observation of cytopathic 234 effects using specific monoclonal antibody Mab BIO285 (Bio-X Diagnostics, Belgium). At 235

the end of the experiment, for the head kidney and brain samples, supernatants collected weretitered using the TCID₅₀ endpoint method in 96-well plates (Kärber, 1931).

In parallel, for samples taken at D59, RNA was extracted from supernatants using the 238 NucleoSpin RNA virus kit (Macherey-Nagel, France), following the manufacturer's 239 recommendations. Negative as well as positive controls were included in each session. The 240 partial nucleoprotein gene (N gene) was amplified with the following primers, 5'-241 AGAGCCAAGGCACTGTGCG -3', antisense primer 5'- TTCTTTGCGGCTTGGTTGA -3' 242 and the minor grove binding (MGB) probe [FAM]TGAGACTGAGCGGGACA, as described 243 by Purcell (Purcell et al. 2013). Reverse-transcription (RT) and amplification were performed 244 with the SuperScript III One-Step RT-qPCR System (Invitrogen, France) using the following 245 mix: 5 µL of extracted RNA was added to 900 nM of each primer, 200 nM of probe, 0.5 µL of 246 Invitrogen RT mix, 12.5 µL of reaction mix (2X) and water in a final volume of 25 µL. 247 248 Moreover, to assess the effectiveness of the whole analytical process, samples were spiked with a known amount of external exogenous control (RNA bacteriophage MS2) before lysis 249 250 and nucleic acid extraction, and specific RT-qPCR (Ninove et al., 2011) were performed in 251 parallel of IHNV RT-qPCR. The RT-PCRs were conducted in a CFX96 (Bio-Rad, USA), with an initial step at 50°C (30 min) followed by one step at 95°C (15 min), then 40 cycles at 252 94°C (15 s) and 60°C (60 s). Results were expressed through cycle threshold (Ct), and Ct 253 obtained for MS2 were systematically reported in predefined control cards to validate the 254 analyses. 255

2.4.2. Cellular immune parameters

Red blood cell (RBC) and white blood cell – (WBC) counts were performed with a Thoma
cell hemocytometer with whole blood diluted to 1/200 in a Giemsa solution, according to the

260 method of Kekic et al. (1982). Cell counts were expressed as T.L⁻¹ for RBCs and G.L⁻¹ for 261 WBCs, where $T = 10^{E12}$ and $G = 10^{E9}$.

For WBC analysis by flow cytometry, cells were extracted with a Ficoll gradient (Histopaque[®] 1077, Eurobio) and several centrifugations, according to Danion et al. (2011). The proportion of each type of WBC, phagocytosis activity, and WBC mortality were analyzed with a FACSCalibur flow cytometer (Becton Dickinson), using methods previously described (Danion et al., 2011).

2.4.3. Humoral immune parameters

Plasma lysozyme concentration was determined using a turbidimetric assay (Grinde et al., 1988) and adapted to microtitration plates (Danion et al. 2011). The optic density reading was taken at a wavelength of 450 nm every 15 s for 3 min, and lysozyme concentrations for samples were converted to mg.mL⁻¹ of plasma using the reference curve established with hen egg-white lysozyme (Sigma).

Determination of the alternative pathway of plasma complement activity was carried out by hemolytic assay with rabbit red blood cells (RRBC, bioMérieux), as published by Yano (1992). This analysis was adapted to microtitration plates (Danion et al., 2012) with some changes, such as 1/32 dilution of rainbow trout plasma samples in EGTA-Mg-GVB buffer to prevent natural hemolytic activity.

A non-specific plaque reduction assay to assess the global humoral response was conducted on plasma sampled at D3 and D4. After one hour of heat inactivation at 45°C, plasma was diluted from 1/20 to 1/2,560 in duplicate. Dilutions were transferred to 24-h-old confluent CHSE214 cells in 96-well plates and incubated at 20°C for 24 hours. Supernatant was removed and 100 μ L of an infectious pancreatic necrosis virus (IPNV) suspension was added (around 500 TCID₅₀/well). Plates were incubated at 14°C ± 2°C for 3 to 4 days before fixation and coloration by crystal violet-ethanol 0.26% (Sigma, France). The possible setting up of a
humoral response was assessed by evaluating the potential protection of the cells from the
infection by IPNV, after incubation with plasma. The global humoral response was expressed
as the inverse of the plasma dilution corresponding to 50% protection compared to control
wells (infected cells not submitted to plasma incubation).

The detection and quantification of trout anti-IHNV antibodies were performed in plasma 290 collected on D59 on 30 fish per condition, using a SNT. SNT was not only performed 291 292 according to the repealed standard NF U-47-022, using an N61 viral suspension, but also with each viral strain tested in our experimental design. Plasma was heat inactivated at $45^{\circ}C \pm 2^{\circ}C$ 293 for 30 minutes and then two-fold serially diluted from 1/40 to 1/5,120 in a final volume of 294 30 µL of Eagle medium using round-bottom 96-well microplates (NUNC, USA). An equal 295 volume of viral suspension supplemented with rainbow trout complement (final dilution 296 1/160) at $7x10^3$ to $3x10^4$ TCID₅₀.mL⁻¹ (corresponding to 350 to 1,500 TCID₅₀ of virus/well) 297 was added to each well containing the diluted plasma to be tested. Plates were stirred for 5 298 minutes before being incubated overnight (about 18 hours) at $5^{\circ}C \pm 3^{\circ}C$ for the plasma 299 neutralization reaction. Control plates were prepared simultaneously, each one containing 300 wells for: cell control (wells containing cell culture medium only, and wells containing cell 301 culture medium with rainbow trout complement), IHNV reference virus (viral suspension 302 used in the test), negative plasma (without IHNV antibodies), and positive plasma (with 303 IHNV antibodies), two-fold diluted. Titration of the IHNV virus suspension used in the SNT 304 was also included. Each plasma was analyzed in duplicate. After overnight incubation, 50 µL 305 of the plasma and virus mixture were transferred onto 24-h-old confluent EPC cell 306 307 monolayers and the microplates were incubated for 5 to 6 days at $14^{\circ}C \pm 2^{\circ}C$. Plates were fixed with crystal violet-ethanol 0.26% (Sigma, France) for at least 1 hour, after which any 308 clear cytopathic effects could be observed by light microscopy. The neutralizing titer was 309

defined as the inverse of the initial plasma dilution, giving 50% neutralization of the reference
virus compared to the control virus and the negative plasma. A sample was considered
positive if its antibody titer was equal to or greater than 80.

The plasma from the 10 fish sampled at D59 which underwent sampling for viral quantification, gene expression and immune response were also analyzed with standard SNT (see supplementary data).

2.4.4. Molecular immune parameters

Total RNA was isolated using an RNeasy Plus kit (Qiagen) from 20 mg of spleen sampled at 318 D3, and all samples were treated with the RTS DNase Kit (Mobio) to prevent DNA 319 contamination. Concentrations of RNA samples were determined using a NanoDrop 1000 320 spectrophotometer (Thermo Scientific), the purity was assessed using the ratios A260/A230 321 and A260/A280, and RNA integrity was checked via gel migration (E-gel 1.2%, Invitrogen). 322 For each sample, RT was carried out using 1 µg total RNA with a RevertAid H minus First 323 324 Strand cDNA Synthesis Kit (Thermo Fisher Scientific) and an iCycler System (Bio-Rad). In 325 addition, an RT was carried out using a mixture of RNA samples stemming from each experimental condition used as a control in each run of real-time PCR. mRNA was quantified 326 for the following four genes: interleukin 1 β (*Il-1\beta*), interferon (*IFN*), tumor necrosis factor α 327 $(TNF\alpha)$, and toll-like receptor 3 (TLR3). In addition, the elongation factor gene (Ef) was 328 included in the analysis as a housekeeping gene. Primers are available in Dupuy et al. (2019) 329 as well as the characteristics of the quantitative real-time PCR (qPCR) reactions performed in 330 the CFX96 real-time PCR System (Bio-Rad). Relative expression of the target gene was 331 calculated with the Pfaffl formula (2001). The ratio of a target gene was expressed in a sample 332 versus a control, in comparison to a reference gene. 333

2.5. Statistical analysis 335

336 Survival curves were estimated using the Kaplan–Meier method and were compared by a log rank analysis using the online platform BiostaTGV. Firstly, survival curves for each replicate 337 338 within condition of infection were compared, and if no significate difference was observed, the two series were pooled to represent the viral infection condition. In case of significant 339 difference, each replicate was analysed separately and compared to the other conditions of 340 infection. In addition, Mean Day to Death (MDD) was calculated by Kruskal-Wallis test 341 combined with a Dunn's post hoc test to compare the 5 infected conditions (XLSTAT 2020). 342 Statistical analyses were performed using XLSTAT statistical software (2019), with a 343 344 significance level of 5%. Immune parameters of control and infected fish were evaluated using a two-way analysis of variance (ANOVA), taking into account the strains and sampling 345 date for each sample. Interaction effects between factors were always tested. Newman-Keuls 346

significant difference tests were performed a posteriori to detect differences between means. Viral load values were compared between the two different sampling times D3 and D4 for 348 349 each strain assessed, using a Mann-Whitney non-parametric test.

- 351 1. Results
- 352 1.1. Mortality

No mortality, clinical symptoms, or lesions were recorded in the control condition. 353

The distribution of cumulative mortality was significantly different between infected groups 354 (Figure 2). The comparison of survival curves obtained for the different conditions of 355 infection enabled to divide strains into three groups: isolates FR0031 and RU1 curves did not 356 show significant difference (p-value 0.89), and the same phenomenon was observed for the 357 isolates WRAC and N61 (p-value 0.41). However, FR0031 and RU1 were different from 358 WRAC and N61 (p-value 1.11x10⁻¹⁶). Regarding the RtNag0a, the replicates exhibited 359

significate difference (p-value 0.004), so that survival curve corresponding to each replicate 360 was compared to the other conditions of infection, and significant difference was observed 361 with all the other strains (p-value $<1x10^{-14}$). Cumulative percent survival (CPS) varied across 362 strains from high (FR0031 - 90% and RU1 - 90%), medium (N61 - 47%, WRAC - 58%) and 363 low (RtNag0a - 8%). Onset of mortality ranged from 4 - 7 dpi and mean day to death from 364 10.4 for the virulent strain RtNag0a to 31.4 for the low virulent strain FR0031. No significant 365 differences were noticed between strains FR0031 and RU1 (p-value 0.491), which appeared 366 significantly different from the three other strains (p-value $< 4.9 \times 10^{-4}$). Mortality stabilized 367 after 20 dpi but some mortality continued past 40 dpi in the group infected with RtNag0a 368 (Figure 2). Classical signs of IHN disease (darkening of the skin, petechial hemorrhage in the 369 visceral fatty tissues and in the eye around the pupil, swollen abdomen, and anemia of the 370 internal organs) occurred with strains from the E, M, and J genotypes. Clinical signs 371 372 associated with nervous function (erratic swimming) were observed from 18 dpi in survivors of WRAC and RtNag0a challenges. 373

375 1.2. Infection parameters

Viral examination revealed that mortality that occurred during the challenges was associated with the virus. In fact, fish tested at the beginning of mortality events presented titers greater than 1×10^9 TCID₅₀.g⁻¹ irrespective of the condition of infection considered, except fish infected by FR0031 which exhibited a lower titer (4×10^5 TCID₅₀.g⁻¹).

At 3 - 4 dpi, viral prevalence by cell culture ranged from 70 - 100% in the groups infected with E, M, and J strains (Table 2). In contrast, prevalence in the U group ranged from 50 to 60% and the L group lacked detection at any time point (Table 2). At 59 dpi, no virus could be detected by cell culture in head kidney and in only a low proportion of fish infected by N61 and RtNag0a in the brain samples (Table 2). The RTqPCR enabled to detect the virus in a higher proportion of fish (10 to 50% in the head kidney samples), and positive brain samples
exhibited earlier Ct compared to head kidney ones (Table 2).

1.3. Cellular immune parameters

RBC counts, cell mortality, and phagocytosis activity were not altered in fish infected with IHNV (Table 3). At D3, WBC counts decreased in fish infected with WRAC and RtNag0a compared to controls, and this difference became significant at D4, where infected fish presented 9.4 \pm 6.3, and 7.6 \pm 5.1 G.L⁻¹, respectively, compared to negative controls (41.8 \pm 17.4 G.L⁻¹) (Figure 3-A). No further significant difference in WBC counts was noted at D59 (Figure 3-A). Regarding more specifically macrophage proportions, this parameter was not affected compared to controls (Figure 3-B).

1.4. Humoral immune parameters

Lysozyme concentration was not altered in fish infected with IHNV (Table 3). At D3, the complement activity (ACH) was significantly higher in fish infected with WRAC (18.7 ± 7.5 U.mL⁻¹) or RtNag0a (18.6 ± 5.8 U.mL⁻¹) compared to controls (10.4 ± 7.2 U.mL⁻¹). No further significant differences in ACH₅₀ were noted at D4 or D59 (Table 3).

Initial global humoral response was detected at D3 (Table 4), with only a few positive fish infected with RtNag0a (30%), whereas 100% of the sampled fish from that condition revealed positive signals at D4. Interestingly, 50% of fish infected by the WRAC strain also exhibited a positive signal at D4. Only one fish was positive for the RU1 condition, and none of the sampled fish infected by N61 and FR0031 exhibited a positive signal.

407 Standard seroneutralization test was validated through the absence of positive plasma for the 408 negative control condition. Antibodies were detected regardless of the strain of infection 409 considered, with various proportions of seropositive fish and titer values ranging from 80 to 5,120 (Figure 4, Table S1). More precisely, 87% and 60% of plasma from fish infected by
N61 and WRAC, respectively showed positive signals. Lower proportions were positive for
fish infected by RU1, FR0031 and RtNag0a (with 30%, 13% and 57% of seropositive fish,
respectively, Figure 4). Focusing on the titer values, 31% of the N61 condition, 100% of the
FR0031, 13% of the RU1, 59% of the WRAC, and 12% of the RtNag0a condition exhibited
high titers greater than or equal to 640 (Figure 4, Table S1).

416 SNT performed using the RU1 strain showed results comparable with the N61 test (Figure 4, 417 Table S1). SNT performed using the WRAC strain exhibited lower seropositive rates, regardless of the genotype considered, and no seropositivity was detected for the RU1 group 418 (Figure 4, Table S1). However, while the FR0031 SNT showed only positive results for the 419 fish infected with N61 and WRAC (20% and 17%, respectively), and more slightly with 420 FR0031 and RtNag0a infected fish (13% and 3% respectively), the RtNag0a SNT was 421 422 positive only for homologous samples (with 70% seropositive plasma from fish infected with RtNag0a, with titers ranging from 80 to 1,280, and only 5% high titers) (Figure 4, Table S1). 423

425 1.5. Molecular immune parameters

While no significant differences were detected in the immune gene expression levels in fish 426 infected with FR0031, the other viral challenges affected molecular immune responses 427 (Figure 5). In fact, IFN expression was significantly increased four-fold during the N61 and 428 RU1 challenges, and eight- to ten-fold during the WRAC and RtNag0a challenges compared 429 to controls (Figure 5). $Il-1\beta$ expression was significantly increased in infected fish compared 430 431 to controls during the N61 challenge (four-fold), and even more during the WRAC, and RtNag0a challenges (ten-fold) (Figure 5). $TNF\alpha$ expression was increased six-fold in fish 432 infected with WRAC and RtNag0a compared to controls (Figure 5). While TLR3 expression 433

was increased in fish infected with N61, RU1, and RtNag0a (between two- and three-fold), a
two-fold decrease was observed in fish infected with WRAC compared to controls (Figure 5).

437 **2.** Discussion

438

The purpose of this study was to provide new information on innate and specific immune 439 response involved in the resistance of rainbow trout exposed to IHNV challenge with strains 440 belonging to the five described genotypes. Changes in viral loads as well as several immune 441 parameters were assessed through this experiment, focusing on innate immune response 442 through sampling at three and four days post-infection, and adaptive response at eight weeks 443 post-infection. The seroneutralization test developed by the French national reference 444 laboratory (NRL) in the 1990s was also assessed specifically regarding cross-reactions 445 between the five genogroups not only using the standard method, but also by performing 446 heterologous tests with all the other strains used. 447

448 First, three kinds of virulence profiles were defined after the viral challenges, i.e. slightly 449 virulent strains (FR0031 and RU1 from genotype L and U, respectively), averagely virulent (WRAC and N61 from genotypes M, and E, respectively), and highly virulent (RtNag0a from 450 genotype J). The lower level of virulence observed for the genotype L in rainbow trout is 451 consistent with previous studies or epidemiologic data; the strains belonging to this group 452 being mostly isolated from Chinook salmon (Oncorhynchus tshawytscha). The typical strains 453 from genotype U, mostly isolated from sockeye salmon (Oncorhynchus nerka), have also 454 been described as avirulent on rainbow trout, those strains being non-adapted to this host 455 (Kurath et al., 2003; Emmenegger et al., 2000). Here, even if the RU1 strain included in the 456 457 study was isolated on rainbow trout in an experimental farm near Moscow and thus, is not fully representative of the genogroup U, only a low level of virulence could be observed. 458

Inversely, strains from genotype M are thought to have derived from genotype U by hostjumping and usually reveal better adaptation to successfully infect rainbow trout.

Through the testing performed here, we reported no virus at all in fish infected by FR0031 461 (genotype L) at 3 and 4 days post-infection strengthening the hypothesis that genotype L 462 strains may not be readily able to enter and replicate in the rainbow trout host. The route of 463 entry into the host chosen in this study, i.e. by bath, cannot explain the low level of virulence 464 as demonstrated by Wargo et al (2010; 2011), which showed that a difference in the 465 production of viral particles remained even when bypassing the host entry step with 466 challenges performed by intraperitoneal injection. On the other hand, IHNV strains have 467 already been described as exhibiting various levels of fitness for a particular host species 468 (Penaranda, Wargo, and Kurath 2011). In fact, strains representative of the U genotype were 469 shown to have lower fitness for rainbow trout and exhibited a lower virulence profile, whereas 470 471 the strain representative of the M genotype seemed to be more virulent, which correlated with stronger fitness for this species (Garver et al, 2006). 472

473 Moreover, the higher replication rate displayed by the virulent strains from the M or J genotypes could contribute to the infectiousness of the virus, which appears to take advantage 474 of the host responding in an inefficient manner with its innate immune response (Peñaranda, 475 Purcell, and Kurath 2009). In our study, we recorded the innate immune response at three and 476 four dpi. A WBC count decrease mirrored the infection of fish by the two more virulent 477 strains, i.e. RtNag0a and WRAC. While this disruption is temporary, it seems to affect the 478 development of innate and specific immune responses, and consequently the mortality 479 480 rate. Moreover, TLR-3, Il-1 β , TNF α , and IFN gene expression, well known to be involved in the innate immune response (Robertsen 2008; Zou and Secombes 2011; Purcell, Laing, and 481 482 Winton 2012) was mainly overexpressed in fish infected by virulent or moderate strains, but did not exhibit any significant change in fish infected by the avirulent FR0031 strain from 483

genotype L. More precisely, in accordance with Purcell (2011), the overexpression of specific 484 pro-inflammatory cytokines such as $II1\beta$ and $TNF\alpha$, associated with the increase of 485 macrophage proportions observed at D3, clearly indicated a preliminary inflammatory process 486 only in fish infected by virulent and intermediate strains (RtNagOa and WRAC). In fact, both 487 organize the immune system by activating lymphocytes and, thus controlling respiratory burst 488 activity and phagocytosis (Zou et al., 2003; Lepen Pleić et al., 2013; Collet, 2014; Secombes, 489 2016). Similarly, toll-like receptors (TLR3), activated by the presence of double-stranded 490 RNA (dsRNA), induce downstream the activation of several signaling pathways involved in 491 immunity, including interferon (IFN), a key protein of antiviral defense (Rodriguez et al., 492 2005; Sen and Sarkar 2005). The dsRNA structure is specific to viruses and was produced 493 transiently during the viral IHNV infection, more precisely during the replication of this 494 negative-sense single-stranded RNA. In our study, at D3, the up-regulation of TLR3 was 495 496 correlated with an overexpression and higher titers of IFN observed at D4 for the virulent strain RtNag0a. More surprisingly, TLR3 was down-regulated in fish infected by WRAC 497 498 compared to control fish and here there was no correlation with IFN levels. Even though upregulation of TLR3 expression has already been described in the literature at 3 dpi, transient 499 down-regulation was also reported after 1 dpi, probably due to the migration of cells outside 500 the lymphoid organs (Rodriguez et al. 2005). A higher number of sampling dates should be 501 502 used in future studies to have an overall view of the activation of this protective system. Moreover, a combination of transcriptomic and proteomic approaches appears to be a 503 beneficial solution, increasing the amount of information produced at different levels. 504

The alternative complement pathway, by its important role in non-specific humoral immunity but also in antibody-mediated virus neutralization, is a relevant biomarker to determine immune disturbance in fish (Cooper and Nemerow, 1984; Boshra et al., 2006). Surprisingly, the complement activity exhibited an increase only for the WRAC and RtNag0a conditions at

three dpi. These results are in discrepancy with other published findings in fish infected with 509 IHNV that highlight a reduction in the hemolytic activity of the complement explained by a 510 drop in the synthesis of the complement components or strong consumption of complement 511 512 components to inactivate the virus particles, resulting in reduction of viral titers (Byrne et al., 2008; Sakai et al., 1992). In fact, viral neutralization can be enhanced by the action of the 513 complement, which allows the coating of immunoglobulin on virus particles, the aggregation 514 of particles, as well as possible virolysis (Daniels 1975). In our study, at D59, the virus was 515 516 detected in a small proportion of fish, with nonetheless 50% positive results in those infected by the virulent strain RtNag0a, and only 2 out of 10 fish infected by FR0031 or RU1, 517 considering RTqPCR detection. Earlier Ct were obtained for N61 and RtNag0a brain samples 518 compared to kidney samples, matching with higher viral loads. Compared to the very high 519 proportion of fish exhibiting positive signals at three and four dpi, these results revealed 520 521 partial removal and possible hiding of the virus in the brain from the host by setting up several specific immune responses by survivor fish. 522

The seroneutralization test (SNT), used in the French NRL as an accredited tool, consists in evaluating the level of production of specific antibodies targeting one pathogen by putting the virus in contact with individual plasma, so that the presence of neutralizing antibodies will prevent the virus from infecting a cell layer. Glycoprotein G corresponding to the viral envelope has been shown to be involved in the secretion of neutralizing antibodies by the host, as well as ensuring some immune protection, especially in young fish (Engelking and Leong 1989).

The standard test using the N61 strain was assessed first and various proportions of fish exhibited seropositive signals depending on the strain they were infected with. These results suggested that specific antibodies secreted by fish infected by strains belonging to the five different genotypes are neutralizing or at least partially neutralizing to the N61 strain. Then,

we decided to perform SNT regarding cross-reactions between the five IHNV genogroups 534 because this phenomenon was already demonstrated for VHSV with different profiles of 535 virulence (Bernard, Bearzotti-Le Berre, and Kinkelin 1985). Kurath et al. (2010) showed that 536 537 cross-neutralization occurred with sera from most fish, while we observed other differences between the capacity of neutralizing antibodies to recognize IHNV strains belonging to 538 another genogroup. Here, seroneutralization using strains RU1 (genotype U, not 539 representative) and WRAC (genotype M) displayed profiles of neutralization quite similar 540 with the one exhibited by standard N61 test, with however lower rates of seropositive plasma 541 whatever condition is considered. This could be explained regarding the evolution of the 542 543 virus, genotype E derivating from M, originating from U. Nevertheless, those results have to be mitigated since viruses used for the SNT displayed different capacity to efficiently infect 544 EPC cell line, so that percentage of seropositive fish could be partly biased. Moreover, we 545 546 noted that antibodies secreted after infection with virus strains from genotypes E, M, L and U 547 did not display any potential to neutralize the RtNag0a strain from genotype J. This could be 548 partially explained by the partial sequence of the G gene: the tested genotype J strain 549 displayed more sequence variation with a maximum of 94.2% nucleotide identity and 93.1% amino acid identity respectively with the RU1 and N61 strains (on 570 nucleotide long 550 sequences, data not shown). By contrast, the avirulent strain FR0031 exhibited a very 551 different pattern, with a low rate of seropositives but very high antibody titers, specifically for 552 the standard test, suggesting an effective specific adaptive immune response. Surprisingly, the 553 virus was only detected in 2 fish out of 10 sampled at 59 dpi. This observation suggests that 554 when the virus succeeds in entering host cells and replicates, it can persist in the host and be 555 targeted by the adaptive immune system by secretion of specific antibodies. Interestingly, the 556 557 2 positive fish infected by FR0031 exhibited also seropositive signal by Standard SNT with high titers (5120). Nevertheless, this correlation between the detection of virus at 59 dpi and 558

the presence of neutralizing antibodies could not be found for the other conditions of infection (Table S2). In the same way, a study including comparisons of plasma neutralization titers between fish exhibiting a "neurotropic" form versus a hematopoietic form of IHN had already concluded on the absence of a significant difference (LaPatra et al., 1995).

564 **5.** Conclusion

565

A clear correlation was reported between innate immune responses and the virulence of IHNV strains, regardless of the genotype considered. The standard SNT exhibited reliable results, with neutralizing action of antibodies "specific" to strains from other genogroups. The tests performed with homologous viruses were not as conclusive. Clues for genetic divergence between genotype J and the others were strengthened when the test with the RtNagOa strain was found to be entirely specific to its genogroup.

IHNV is no longer detected in most infected fish after 50 dpi, but it could persist in a potential 572 573 latent form in the host and be reactivated in a context of immunosuppression (Drolet et al., 1995). Because of potential persistence, and in a context of eradication attempts of the two 574 listed rhabdoviruses in France, it is particularly important to have an indirect reliable testing 575 method. Hence the importance of using the SNT method, based on the presence or absence of 576 specific antibodies, with the aim of monitoring the status of fish farms, in parallel to 577 virological examinations. The availability of a reliable method is also important because the 578 new upcoming Animal Health Law to be applied in 2021, and in which IHNV is likely to be 579 downgraded to category C, means that the disease would be of relevance only to some 580 member states and the overall monitoring context would be less restrictive. 581

infection. "n" indicates the number of fish sampled per condition at each sampling date.

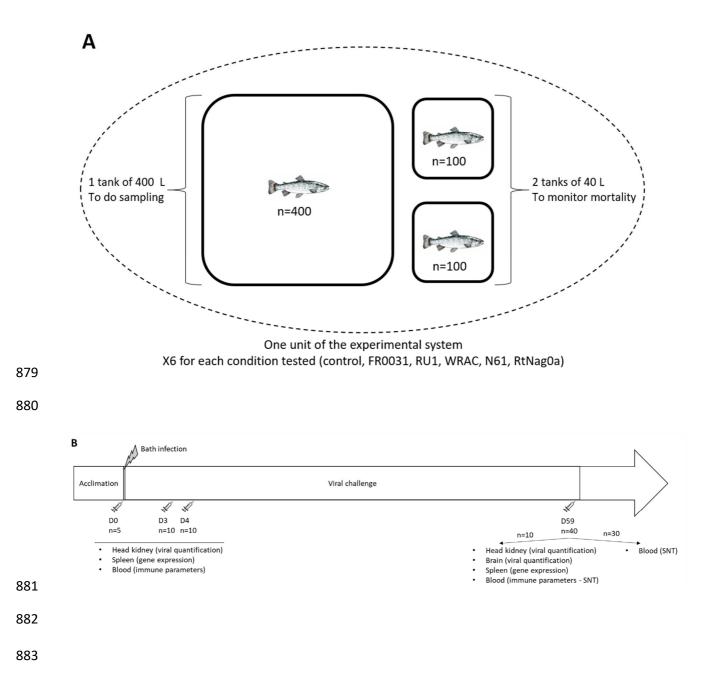


Figure 2: Survival (%) of negative control fish (white circle) and infected fish with IHNV strains FR0031 (white cross), RU1 (black cross), WRAC (black square), N61 (white square), and RtNag0a (white triangle). Each challenge was performed with 100 fish per tank, in duplicate.

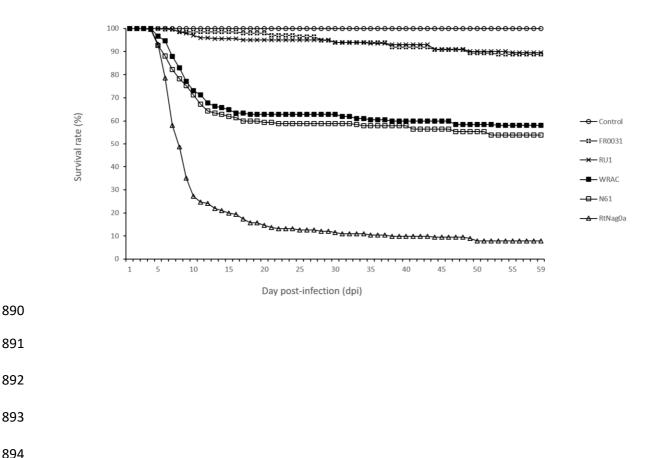
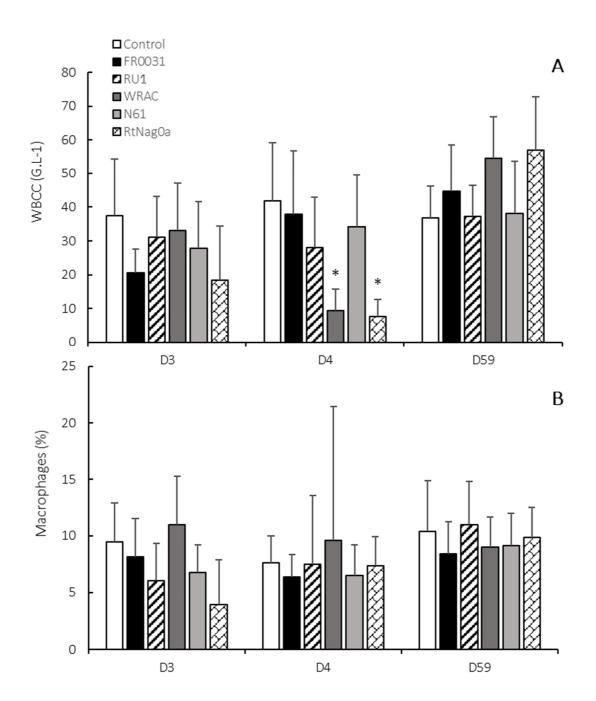


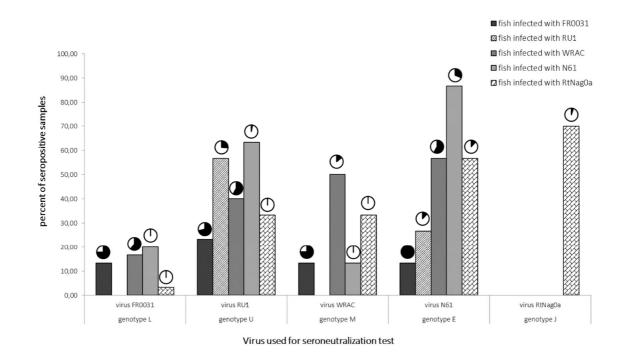


Figure 3: Mean values \pm SD obtained for WBC counts (A) and macrophage percentage (B) in control or infected fish at D3, D4 and D59. For each date, 10 individuals per condition were analyzed. An asterisk indicates a statistical difference between the conditions for a given sampling date (ANOVA; Newman–Keuls, *p*<0.05).

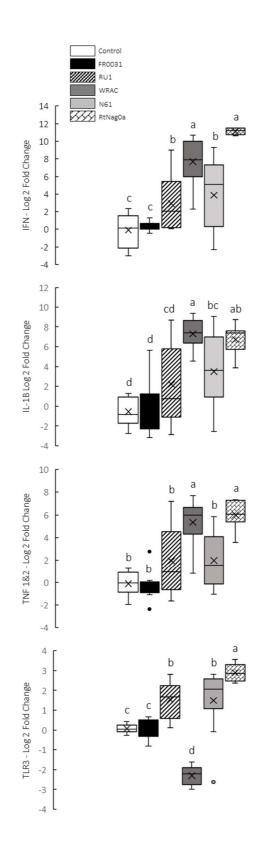
