Short-term association of in-vehicle ultrafine particles and black carbon concentrations with respiratory health in Parisian taxi drivers

16 Abstract

17 Introduction

Professional drivers are exposed inside their vehicles to high levels of air pollutants due to the considerable time they spend close to motor vehicle emissions. Little is known about ultrafine particles (UFP) or black carbon (BC) adverse respiratory health effects compared to the regulated pollutants.

22 **Objectives**

We aimed to study the short-term associations between UFP and BC concentrations inside vehicles and (1) the onset of mucosal irritation and (2) the acute changes in lung function of Parisian taxi drivers during a working day.

26 Methods

An epidemiological study was carried out on 50 taxi drivers in Paris. UFP and BC were measured inside their vehicles with DiSCmini® and microAeth®, respectively. On the same day, the frequency and the severity of nose, eye, and throat irritations were self-reported by each participant and a spirometry test was performed before and after the work shift. Multivariate analysis was used to evaluate the associations between in-taxis UFP and BC concentrations and mucosal irritation and lung function, after adjustment for potential confounders.

33 **Results**

34 In-taxis UFP concentrations ranged from 17.9 to 37.9 x10³ particles/cm³ and BC concentrations from 2.2 to 3.9 μ g/m³, during a mean of 9 ± 2 working hours. Significant dose-response 35 relationships were observed between in-taxis UFP concentrations and both nasal irritation and lung 36 function. The increase of in-taxis UFP (for an interquartile range of 20×10^3 particles/cm³) was 37 38 associated to an increase in nasal irritation (adjusted OR = 6.27 [95% CI: 1.02 to 38.62]) and to a 39 reduction in forced expiratory flow at 25-75 % by -7.44 % [95% CI: -12.63 to -2.24], forced 40 expiratory volume in one second by -4.46 % [95% CI: -6.99 to -1.93] and forced vital capacity by -41 3.31 % [95% CI: -5.82 to -0.80]. Such associations were not found with BC. Incident throat and eye 42 irritations were not related to in-vehicle particles exposure; however, they were associated with 43 outdoor air quality (estimated by the Atmo index) and in-vehicle humidity, respectively.

44 Conclusion

45 To our knowledge, our study is the first to show a significant association, within a short-period of

46 time, between in-vehicle UFP exposure and acute respiratory effects in professional drivers.

48 **1. Introduction**

49 Occupational respiratory diseases reached the third spot among the top three fatal work-related 50 illnesses, according to the Workplace Safety and Health Institute (WSHI, 2017). Outdoor workers 51 have been identified to be at high risk of developing respiratory health problems owing to their 52 continuous exposure to traffic related air pollutants (TRAP) during long period of time close to 53 vehicular emissions (HEI, 2010; Knibbs and Morawska, 2012). The respiratory health effects of 54 particulate matter with aerodynamic diameter ≤ 10 (PM₁₀) and ≤ 2.5 micrometers (PM_{2.5}), carbone 55 monoxide (CO), nitrogen dioxide (NO₂) and sulfur dioxide (SO₂) on traffic policemen, bus drivers, 56 motorcycle taxi drivers, subway drivers are well documented in the literature (Arphorn et al., 2018; 57 Bener et al., 1997; Bigert et al., 2011; Brant et al., 2014; Choudhary and Tarlo, 2014; Jones et al., 58 2006; Karita et al., 2004; Lawin et al., 2018; Mbelambela et al., 2017; Santos et al., 2016; Shakya et 59 al., 2016; Zhao et al., 2015; Zhou et al., 2001). Higher prevalence of respiratory symptoms (phlegm, 60 wheezing, short breath, chest pain, throat pain, cough) (Jones et al., 2006; Mbelambela et al., 2017; 61 Zhou et al., 2001) and lower lung function (FVC - forced vital capacity, FEV₁- forced expiratory 62 volume in one second) (Jones et al., 2006) are observed in outdoor workers compared to control groups (non-exposed to TRAP). However, very little is known on the effect of TRAP on taxi 63 64 drivers' respiratory health, even though they are highly exposed to air pollutants inside their 65 vehicles during a significant proportion of their daily time (Hachem et al., 2019).

66 Recently, the focus has shifted towards ultrafine particles (UFP) and black carbon (BC), both 67 emitted by combustion processes, especially by combustion engines (particularly diesel) in urban areas (Janssen et al., 2012; Morawska et al., 2008). UFP (≤ 100 nm) are small enough to reach 68 69 alveoli. They contribute to a large surface area with high deposition efficiency, which facilitates 70 their penetration through the epithelium and thus translocation to the circulatory system (Gulati and 71 Cullen, 2017; HEI, 2013; Leikauf et al., 2020; Morawska et al., 2019). BC is mainly harmful 72 through carrying a mix of toxic chemicals deeply into the lungs (Janssen et al., 2012). 73 Epidemiological studies investigating the link between short-term exposure either to UFP or BC 74 and respiratory health are still inconclusive. This is due to : (1) the absence of standard methods to 75 measure UFP, making results difficult to compare (Morawska et al., 2019); (2) the challenges 76 encountered in assessing TRAP exposure by considering the mixture of traffic pollutants (difficulty 77 to dissociate specific pollutant effect) and by taking into account all the determinants that may 78 affect their levels. However, there is some evidence of their adverse health effects on 79 cardiopulmonary hospital admissions, acute respiratory and cardiovascular morbidity, etc. (HEI, 80 2013; Janssen et al., 2012; Knibbs et al., 2011; Paunescu et al., 2019a; Paunescu et al., 2019b).

In this respect, the aim of this study is to investigate the short-term associations between in-vehicle exposure of taxi drivers to UFP and BC during a working day and respiratory health, in particular mucosal (nose, throat, and eye) irritation symptoms and lung function.

84 **2. Methods**

85 **2.1. Study design and participants**

As part of PUF-TAXI project, this observational study was carried out in Paris between 1st of February 2019 and 10th of January 2020, on 50 volunteer taxi drivers recruited prospectively by two taxi trade unions, and *via* advertising in taxi magazines/seminars. The taxi drivers included had to be over 18 years of age and to work on full-time day shift with more than 6 months of experience in their jobs.

At the first visit, all participants underwent a physical examination free of charge to evaluate their
general health status in the Occupational and Environmental Diseases Service at Hôtel-Dieu
Hospital in the city of Paris.

At the second visit, they were invited to participate in a measurement campaign which consisted of (1) measuring UFP and BC inside their vehicles throughout a normal working day and (2) evaluating the occurrence of nose/throat/eye irritation symptoms and the changes in lung function parameters pre- and post- pollutant sampling period, during the same day (Figure A.1). One work shift was monitored for each participant.

99 PUF-TAXI has been declared to the National Commission for Data Protection and Liberties
100 (2172757v0) and registered in ClinicalTrial.gov (NCT03839537). It was approved by the French
101 Institutional Review Board (Île-De-France III Ethics Committee 3593-RM; Research Ethics
102 Number: 2018-A00811-54). Informed written consent was obtained from all participants.

103 **2.2. Exposure measurements**

104 Particle pollutants and the comfort parameters (temperature, humidity, carbon dioxide (CO₂)) were 105 all measured inside taxi vehicles during a typical working day without any restrictions given to the 106 driver (ventilation settings, destinations, working hours, etc.). UFP count were recorded by the Diffusion Size Classifier Miniature (DiSCmini®, Wohlen, Switzerland and commercialized by 107 108 Testo SE &Co. KGaA, Titisee-Neustadt, Germany); BC concentrations by the microAeth[®] Model AE51 (Aethlabs, San Francisco, California, USA) and temperature, humidity, and CO₂ 109 concentrations by CP11[®] (Michel Instruments, Lyon, France). All the devices were placed in a 110 111 carry case, on the shelf under the rear window of all the 50 taxi vehicles.

The outdoor air quality on the sampling day was estimated using the Atmo index from the Paris air quality monitoring network "Airparif" (www.airparif.asso.fr). Atmo index is determined from four sub-indices based on the ambient concentrations of SO₂, NO₂, ozone (O₃) and PM₁₀ measured by all the background monitoring stations in Paris area (Paris and suburbs). In short, the Atmo index is scaled from 1 (very good) to 10 (very bad) corresponding to the highest sub-index of the four pollutants.

2.3. Health data

During the medical visit, a standardized examination was carried out by an occupational physician at Hôtel-Dieu Hospital. A skin prick test (SPT) was performed to detect sensitization to the most common inhalant allergens. The participant's health data (chronic and current respiratory or allergic diseases) was collected using a standardized medical questionnaire based on the European Community Respiratory Health Survey II questionnaire (ECRHS II) and the Epidemiological Study of the Genetics and Environment of Asthma questionnaire (EGEA).

125 On the sampling day – when UFP and BC were measured inside taxis, the occurrence of nose, eye, and throat irritation symptoms was self-reported by each participant at the start and during the 126 127 working day and scored from 0 to 10 using a symptom intensity scale. A spirometry test was also performed by the same experienced technician, pre- and post- pollutant sampling period in every 128 129 participant, unless contraindicated (hemoptysis, pneumothorax, unstable cardiovascular status, thoracic, abdominal or cerebral aneurysms, recent eye/thoracic/abdominal surgery) (Graham et al., 130 2019). A portable spirometer (Spirobank II®, MIR, Italy) was used according to the American 131 Thoracic Society and the European Respiratory Society (ATS/ERS) guidelines (Miller et al., 2005). 132 133 After explaining the appropriate technique of the test procedure, each driver performed in a sitting position wearing a nose clip, at least three satisfactory maneuvers. Following these guidelines, the 134 135 lung function parameters of the best expiratory flow-volume curve were chosen. The predicted 136 values for FVC, FEV₁, forced expiratory flow at 25–75% (FEF₂₅₋₇₅) and peak expiratory flow (PEF) were determined based on sex, age, height and ethnicity (Miller et al., 2005). 137

2.4. Potential confounders and effect modifiers

At the medical visit, sociodemographic data (age, sex); anthropometric data (height, weight); smoking status (smokers/ex-smokers/never smokers); comorbidities (gastroesophageal reflux disease (GERD), hypertension, diabetes, asthma, allergic rhinitis, atopy assessed by a positive SPT) and work characteristics (job tenure, working hours per day, working hours per week, etc.) were recorded on a standardized questionnaire by the physician. All along the pollutant sampling day, details of each trip (duration, ventilation settings, smoking,etc.) were self-reported by the participants on a standardized form.

146 **2.5. Statistical analyses**

147 The health and job-related characteristics of the taxi drivers were described, and the distribution of148 particle pollutant concentrations was graphically presented by boxplots.

149 The prevalence and the intensity of the nose/throat/eye irritation reported by the taxi drivers were compared pre- and post- working day using McNemar's test and paired sample t-test, respectively. 150 151 We should note that if the participant reported that he did not experience any symptom his response was coded as 0. Therefore, an incident irritation was defined as the nasal, throat or eye irritation 152 153 occurring during the working day or getting worse compared to the start of the day (the symptom 154 intensity scale during the working day > the symptom intensity scale at the start of the working 155 day). Regarding lung function, all spirometry parameters measured at the start and at the end of the working day were compared using paired sample t-test. The relative change in lung parameter was 156 157 calculated as the difference between the post- and pre-working values reported to the pre-working 158 parameter.

159 The short-term associations of in-vehicle UFP and BC concentrations with both incident irritation 160 (nose, throat and eye) and relative changes in lung function parameters during a working day were 161 studied using single- and multiple- pollutant logistic and linear regression models, respectively, adjusted for potential confounders. Relevant covariates were chosen for each model according to 162 the literature, to the directed acyclic graphs (DAGs) version 3.0 (Figure A.2, Figure A.3) and to the 163 bivariate analysis (p-value of ≤ 0.20): age of the taxi driver (years); sex; body mass index (BMI) 164 165 (kg/m²); having a GERD (yes/no); the outdoor air quality index (Atmo); exposure duration (hours); 166 temperature in-taxi (°C); humidity in-taxi (%); ventilation settings (the duration in minutes of opening windows and air-conditioning activation). Results were expressed as adjusted odd ratios 167 168 (ORa) or beta coefficients (βa) and their 95% confidence intervals (CI) for an interquartile range (IQR) increase in UFP and BC concentrations. 169

Potential modification effects by comorbidities (atopic/respiratory diseases and GERD) were tested
by introducing multiplicative interaction terms in the models. All analyses were conducted using
STATA® /SE (version 15.1) (StataCorp, College Station, Texas, United-States). The statistical
significant level was p<0.05.

174 **3. Results**

175 **3.1. Participants**

The mean age of the participants was 51.5 ± 7.3 years, the majority were men (92%) and less than a quarter of the drivers were current smokers (18%). Out of 50 taxi drivers, 20 (40%) reported having at least one chronic respiratory or allergic disease (29% allergic rhinitis, 16% asthma and 16% eczema) of whom 12 (60%) had a positive skin prick test (SPT) to at least one inhalant allergen (Table 1). Most of the taxi drivers (69%) declared experiencing nose (42%) and/or eye (38%) and/or throat irritation (36%) during the last 12 months. The job-related characteristics of the taxi drivers are presented in table 2.

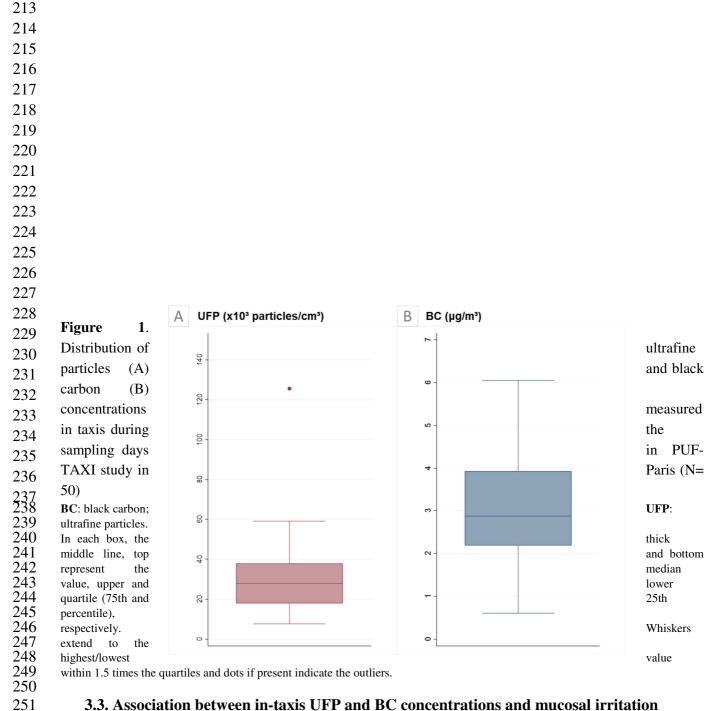

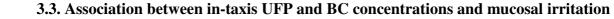

3.2. UFP and BC concentrations inside taxi vehicles

- In-taxis concentrations ranged from 17.9 to 37.9 x10³ particles/cm³ for UFP and from 2.2 to 3.9 209
- μ g/m³ for BC (Figure 1), during a mean of 9.4 ± 1.6 working hours. UFP and BC were moderately 210
- 211 positively correlated (r= 0.43; p < 0.01). The average temperature, humidity and CO₂ levels
- 212 recorded in taxis were 23.4 ± 3.7 °C, 41.6 ± 11.5 % and 1125 ± 603 ppm, respectively.





- 252 Overall, the prevalence and the intensity of the reported eye/nose/throat irritation increased during
- 253 the working day significantly compared to the start of the day: 27 (54%) vs 17 (34%), p = 0.01; 254 geometric mean of the intensity irritation score: 4.1 vs 3.8, p = 0.04.
- Incident nose irritation was significantly associated with UFP and BC concentrations inside taxis, when tested in single pollutant models. However, in two-pollutants models only the association with
- in-taxis UFP concentrations remained statistically significant (Table 3A). In addition, results
 showed significant positive association between nose irritation and working duration. In contrast,
 nose irritation was inversely associated with temperature inside vehicles. No interaction was found
 with respiratory/allergic diseases.
- 262 Incident throat irritation was not associated with in-taxis UFP and BC concentrations, but increased
- with poor outdoor air quality (Table 3B), this association being modified by GERD (Table A.1).
- 264 Throat irritation in relation with outdoor air quality greatly increased in taxi drivers suffering from
- 265 GERD. Incident eye irritation was not associated to air pollutants (neither outdoor nor inside taxis)
- and appeared to only depend on humidity levels inside taxis (Table 3C). Incident eye irritation
- 267 increased with the dryness of the atmosphere.

3.4. Associations between in-taxis UFP and BC concentrations and relative change in lung function parameters

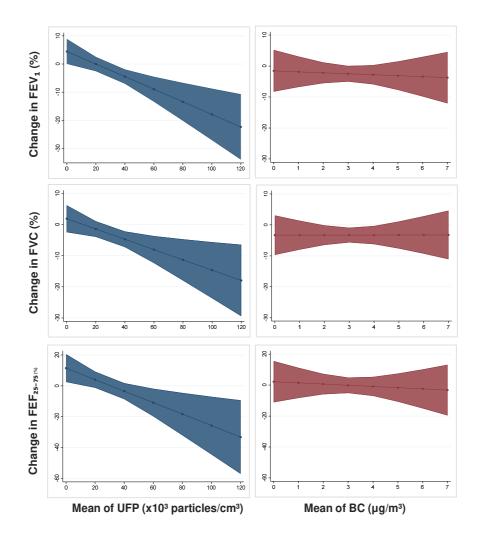


Figure 2. Relative changes in FEV_1 , FVC and $FEF_{25-75\%}$ before and after work shift according to in-taxis UFP and BC concentrations measured throughout the working day in PUF-TAXI project (N=50)

271 During the working day, increasing in-taxis UFP concentrations (for an IQR of 20 x 10^3 272 particles/cm³) were associated with a significant reduction in FEF₂₅₋₇₅ (-7,44 % [95% CI: -12.63 to -2.24]), FEV₁ (-4,46 % [95% CI: -6.99 to -1.93]) and FVC (-3,31 % [95% CI: -5.82 to -0.80]) 273 (Figure 2). At the end of the work shift, 21% (n=10) of the taxi drivers had a reduced FVC more 274 275 than 5%, 30% (n=14) a reduced FEV₁ more than 5% and 19% (n=9) a reduced FEF_{25-75%} more than 13% compared to at the start of the work shift. No significant association was found between in-276 277 taxis BC concentrations and relative changes in lung function parameters measured pre- and post-278 working day. No interaction was found with respiratory/allergic diseases.

4. Discussion

4.1. Key results

This study offers new insights into the associations of short-term exposure to in-vehicle UFP and BC concentrations with acute mucosal irritation and lung function variation of Parisian taxi drivers during a working day. The most notable findings were the increase in incident nasal irritation and the reduction of FEV₁, FVC and FEF₂₅₋₇₅ after short-term exposure to in-vehicle UFP. No association was found with BC concentrations. Incident throat and eye irritations were not related to in-vehicle particles exposure; however, they were associated with outdoor air quality and in-vehicle humidity, respectively.

4.2. Strengths and limitations

296 To our knowledge, this is the first study to address the link between in-vehicles UFP and BC 297 exposure and acute respiratory effects. A major advantage of this research is to study real-world working conditions, without any restrictions given to the taxi drivers, using individual 298 299 measurements of particle concentrations inside each taxicab during a working day. Pollutants were 300 recorded (every minute) for all participants using the same devices placed in the same position 301 inside taxis. As for health data, they were also carefully collected following precise standard 302 operating procedures. The medical examination was performed by a single physician and the 303 spirometry tests before and after work shift were carried out by the same investigator who 304 underwent a specific training prior to the study. The use of single and two-pollutant regression 305 models allowed to discern the specific association of each pollutant with the health outcomes. 306 However, this study has a few limitations. Randomization of taxi drivers was not possible due to the 307 inaccessibility to an exhaustive sampling frame. Therefore, the recruitment of participants was 308 based on volunteering resulting in a potential selection bias. Taxi drivers' motivation to participate 309 in the study might be related to their particular sensitivity to indoor air issues. Therefore, it was 310 important to complete the reporting of symptoms by objective measurements of lung function 311 parameters, each participant acting as his own control for health outcomes before and after work 312 shift comparisons. There were few women participants (n=4) which is somehow in line with their 313 low representation in this occupation, and we performed sensitivity analysis with and without 314 women. Results remained unchanged.

315 4.3. Adverse short-term respiratory effects of in-vehicle exposure to traffic related air 316 pollutants

We found that a significant proportion of taxi drivers (around 50%) reported having a least one chronic respiratory/allergic disease and suffering from mucosal irritation during the last year (42% nose irritation; 38% eye irritation; 36% throat irritation). Occupational epidemiological studies were consistent with our findings. Professional drivers in Congo (Mbelambela et al., 2017), in Shanghai (Zhou et al., 2001) and in the United Arab Emirates (Bener et al., 1997) (taxi drivers, bus drivers, motorcycle taxi drivers) had significant higher prevalence of adverse respiratory effects (asthma, allergic rhinitis, dyspnea, nasal catarrh, cough, phlegm, throat pain) than non-exposed groups (manual/office/storage workers, high school teachers).

325 Regarding acute respiratory symptoms, this study showed significant dose-response relationships 326 between in-vehicle UFP and BC exposure and incident nasal irritation. However, when using the 327 two-pollutant models, it appears that the effect of UFP on nasal mucosa is more robust than that of 328 BC. Our results are biologically plausible. The major exposure route of particles is via inhalation. 329 Particles in the range of 1 to 10 μ m, including BC < 2.5 μ m, tend to deposit in the extra-thoracic 330 region (nose, pharynx, larynx). Smaller particles $< 1 \mu m$, in particular UFP, deposit in nasal and 331 alveolar regions due to diffusion (HEI, 2013; Oberdörster et al., 2005). Thus, during nasal 332 breathing, the nose mucosa plays a significant role in cleaning the inspired air by increasing mucus 333 production and ciliary beating, resulting in nasal discomfort (Brant et al., 2014; ICRP, 1994; 334 Oberdörster et al., 2005; Riechelmann et al., 2003). Furthermore, Brant et al. (2014) showed that non-smoking commercial motorcyclists, in an urban city in Brazil, presented a decreased nasal 335 336 mucociliary clearance in relation with exposure to air pollutants (Brant et al., 2014). They also 337 found an increase in sino-nasal symptoms. Cole-Hunter et al. (2013) reported an increase in nasal irritation related to high exposure to UFP $(29.5 \times 10^3 \text{ particles/cm}^3)$ in healthy participants during 338 339 commuting by bicycle (Cole-Hunter et al., 2013), which is consistent with our results. Otherwise, 340 UFP appear to be cleared less quickly than larger particles. Indeed, UFP may penetrate through a 341 layer of relatively low viscosity surrounding the cilia or they deposit in areas in which mucous is 342 reduced or absent (HEI, 2013; Schürch et al., 1990). Consequently, the lack of UFP clearance may 343 lead to their accumulation, which may explain the robust association found between UFP and nasal 344 irritation but not with BC.

345 As for throat irritations, they were not associated with in-vehicle UFP and BC concentrations during 346 the working day. This outcome was expected given the deposition and the clearance mechanisms of the corresponding pollutants in the respiratory tract. UFP tend to deposit either in the nose or in the 347 348 alveoli but not in the pharynx nor in the larynx. BC appears to be cleared easily from the upper 349 airways (Oberdörster et al., 2005). Conversely, throat irritation was related to outdoor air pollution. 350 This is consistent with the United States Environmental Protection Agency (US EPA) publication, 351 reporting that O₃ can cause sore or scratchy throat (EPA, 2020). Interestingly, we found that 352 outdoor air pollution may be differently associated with incident throat irritation depending on whether the taxi driver is suffering from GERD or not. In fact, GERD refers to the passage of gastric contents into the esophagus reaching the laryngeal and pharyngeal resulting in mucosal injury, which manifests by extra-esophageal symptoms, including dry and sore throat (Issing and Karkos, 2003; Tauber et al., 2002). In that respect, a possible explanation for our result is that having an irritated mucosa could increase the effects of outdoor air pollutants.

Regarding eye irritation, it was not associated neither with in-vehicle particles nor with ambient air pollution. Nevertheless, we found that taxi drivers experienced more eye irritation with the decreasing in humidity inside cabs. The literature supports our result. There is a growing evidence linking eye irritation to low relative humidity mainly by lacrimal hyper-osmolarity inducing instability of the lacrimal film (2007; Doan, 2009; Hwang et al., 2016; Wolkoff, 2018). Sunwoo et al. (2006) showed that under 30% of relative humidity, the subjects reported that their eyes became drier (Sunwoo et al., 2006).

365 Most attention related to the lung function of professionals exposed to air pollution has focused on 366 its association with regulated pollutants (PM₁₀, PM_{2.5}, NO₂ and CO) (Bigert et al., 2011; Brant et 367 al., 2014; Jones et al., 2006; Zhao et al., 2015). In São Paulo, outdoor workers (including taxi 368 drivers) exposed to high concentrations of PM_{2.5} (> 39.6 µg/m³) had lower FVC (-12.2%; CI% 95: -369 20% to -4.4%) and FEV₁ (-9.1 %; CI% 95: -19.1% to -0.9%) compared to those exposed to low $PM_{2.5}$ concentrations (< 25 µg/m³) (Santos et al., 2016). In Benin, motorcycle taxi drivers exposed 370 371 to CO concentrations above the US EPA air quality standard for 8 hours per day (9 ppm) had lower 372 PEF (-10%, p=0.02) compared to less exposed group < 9 ppm (Lawin et al., 2018). However, less is 373 known about UFP and BC. As far as we know, no team has assessed the effect of UFP on 374 professional drivers' health. Our main findings suggested that short-term exposure to in-vehicle 375 UFP concentrations during a working day reduced lung function in taxi drivers at the end of the shift compared to its start. Hence, the association between respiratory effect and UFP exposure 376 377 might be considered as a continuum since it initiates with nasal irritation. Regarding BC, there was 378 no association with changes in lung function during a working day. Only Shayka et al. (2016) 379 investigated respiratory effect of BC exposure in traffic policemen (Shakya et al., 2016). Contrary 380 to our study, they found that personal occupational BC exposure was negatively correlated with 381 FEV₁ (r= - 0.36, p<0.05). This may be due to the high BC concentrations (range from 12.4 to 28.4) μ gC/m³) traffic policemen were exposed to, much higher than those we measured inside Parisian 382 383 taxi vehicles (range from 2.2 to 3.9 µg/m³) (Shakya et al., 2016). Our results are biologically 384 plausible. In fact, larger particles appear to be cleared easily from the respiratory tract, whereas 385 smaller particles tend to remain longer, which may lead to their accumulation in airway tissues 386 (HEI, 2013; Oberdörster et al., 2005). This phenomenon may cause acute reduction in airway

caliber by increasing airway secretions or stimulating airway smooth muscle or pulmonary vasoconstriction (Batalha et al., 2002; Brook et al., 2002; Pietropaoli et al., 2004). However, the specific mechanism remains unknown (HEI, 2013). Nevertheless, this could explain the deterioration of Parisian taxi driver's lung parameters (FVC, FEV₁, FEF_{25-75%}) associated with UFP but not with BC, at the end of the working day, although the circadian rhythm of lungs improves the pulmonary function in the late afternoon (Medarov et al., 2008; Nosal et al., 2020). Hence, the associations we observed might have been underestimated.

394 Lastly, the clinical significance of lung function results must be questioned. According to the 395 ATS/ERS publication, a real change in lung function is significant if FVC and FEV₁ varied $\geq 5\%$ 396 and $\text{FEF}_{25-75\%} \ge 13\%$ within a day in normal subjects (Pellegrino et al., 2005). In our study, the 397 mean variations of lung parameters were below these thresholds. However, 36% of drivers 398 presented significant changes of at least one of the lung parameters. We should note, though, that 399 reduction in FEF₂₅₋₇₅ and in FEV₁ suggest obstruction in the small and central airways (Pellegrino et 400 al., 2005; Pietropaoli et al., 2004). Porsbjerg et al. (2015) reported that decline in FEV₁ is associated with incident asthma in adults (Porsbjerg et al., 2015). Moreover, some evidence has shown that 401 402 exposure to air pollutants can trigger the adult onset of asthma or exacerbate existing asthma 403 (Guarnieri and Balmes, 2014). Our results need to be confirmed by further studies.

404 **5.** Conclusion

In conclusion, this study has shown a significant association, within a short period of time, between in-vehicle UFP exposure and acute respiratory effects (nasal irritation, lung function) of professional drivers. Given the considerable time professional drivers spend inside vehicle, further studies are needed to investigate the adverse respiratory effects of UFP and BC in occupational population. Such research could further help policy makers to define appropriate limit values for UFP and BC, not regulated to this day.
