27 Abstract

This study aimed to combine cellular and molecular analyses for better detail the effects of 28 29 various stresses on a sentinel species of freshwater invertebrate. For this purpose, the 30 hemocytes of the zebra mussel, Dreissena polymorpha, were exposed to different stresses at two different intensities, high or low: chemical (cadmium and ionomycin), physical 31 (ultraviolet B), or biological ones (Cryptosporidium parvum and Toxoplasma gondii). After 32 exposure, flow cytometry and droplet digital PCR analyses were performed on the same 33 34 pools of hemocytes. Several responses related to necrosis, apoptosis, phagocytosis, production of nitric oxide and expression level of several genes related to the antioxidant, 35 detoxification and immune systems were evaluated. Results showed that hemocyte integrity 36 was compromised by both chemical and physical stress, and cellular markers of 37 phagocytosis reacted to ionomycin and protozoa. While cadmium induced oxidative stress 38 and necrosis, ionomycin tends to modulate the immune response of hemocytes. Although 39 both biological stresses led to a similar immune response, C. parvum oocysts induced more 40 41 effects than T. gondii, notably through the expression of effector caspases gene and an 42 increase in hemocyte necrosis. This suggests different management of the two protozoa by the cell. This work provides new knowledge of biomarkers in the zebra mussel, at both 43 cellular and molecular levels, and contributes to elucidate the mechanisms of action of 44 45 different kinds of stress in this species.

55 **1. Introduction**

Over the last years, ecotoxicology has gained increasing interest to assess the impact of anthropogenic contaminants on organisms and ecosystems. Among the tools developed for environmental risk assessment, biomarkers are of great interest, especially for their potential as early warning indicators of contamination [1]. These tools are therefore increasingly developed on sentinel organisms to better characterize the potential effects of contaminants. In conjunction with chemical and biocenotic analyses, biomarkers contribute to being aware of the global impact of this contamination on ecosystems.

However, this risk prediction requires a good knowledge of the biomarkers used as well as an explanation of the mechanical bases of xenobiotic effects on well-known sentinel species [2]. It is therefore essential to understand the modes of action of the various xenobiotics at infra-individual levels (cellular, molecular) before being able to extrapolate to the scale of the population or the community.

Among biomarkers, those linked to the immune system can reflect the state of health of an 68 organism under stress. Indeed, the immune system is responsible for the integrity of 69 70 organism, protects it against infections and parasitism and is linked to various other biological functions, such as nervous or endocrine systems [3-6]. These immune markers are 71 often i) functional and assessed at the cellular level, such as the capacity or the efficiency of 72 phagocytosis, ii) structural in terms of the integrity of the immune effector cells, or iii) linked to 73 74 the expression of genes coding for immune proteins. They are therefore mainly assessed on two levels of biological organization: the cell and the molecule. The analysis of multi-level 75 markers has several advantages. First, it allows a more complete diagnosis of contamination 76 effects on an organism and can allow their extrapolation on a population [7, 8]. Then, this 77 multi-level analysis can provide information on the impact kinetics of a contamination within 78 79 an organism [9]. Finally, it can be used to determine whether the responses are due to the exposure or only due to a homeostatic modification [10]. 80

In this study, cellular and molecular analyses were combined to understand the effects of 81 various stress on a sentinel species of freshwater invertebrate, the zebra mussel Dreissena 82 polymorpha. This invasive species is known to have colonized several regions in the 83 northern hemisphere (America, Europe) and to have negatively impacted the invaded 84 ecosystems [11]. Our objective was to understand the immune response capabilities of 85 hemocytes of the zebra mussel to various stresses (chemical, physical and biological), via 86 cellular and molecular markers. For this purpose, several parameters were set upstream of 87 88 the study. First, bivalves were chosen because they have several advantages to be used in biomonitoring programs as sentinel species [12-15]: i) these animals are directly in contact 89 with the contamination (water and sediment) and can accumulate pollutants [16]; ii) they are 90 sessile, making possible a spatial and temporal assessment of surrounding contamination 91 92 [13, 14, 17]. For freshwater biomonitoring, Dreissena polymorpha is a good sentinel species since it occupies a large geographical area, it resists to variations in external conditions and 93 is considered to be the counterpart of *Mytilus edulis* for ecotoxicological studies [18-20]. 94 95 Second, cellular and molecular markers were evaluated on the same measurement scale, 96 namely on hemocytes. In bivalves, hemocytes are the effector cells of immunity. Exposures to various stresses were conducted in ex vivo conditions to overcome the complexity of the 97 whole organism and to minimize the exposure bias. Third, all analyses (cellular and 98 99 molecular ones) were performed on the same samples to provide a better comprehension of 100 stressors' modes of action. This criterion required to work with pools of hemolymph to obtain enough biological material for analysis. Finally, hemocytes from D. polymorpha were 101 exposed to various stresses (chemical, physical and biological), whose expected effects are 102 known. Hemocytes were exposed to i) cadmium, a cytotoxic metal [21]; ii) ionomycin, an 103 104 antibiotic which induces apoptosis and alters immune functions [22, 23]; iii) ultra-violet B (UVb) which are known to be cytotoxic and immune suppressor [24, 25]; and iv) two 105 106 protozoa, Cryptosporidium parvum and Toxoplasma gondii, whose effects on the hemocytes of mussels have already been evaluated [26]. 107

108 Regarding mussel immunity, two processes have been studied *via* cellular and molecular
109 markers, namely:

Phagocytosis, through the internalization of microbeads (capacity, efficiency and avidity of phagocytosis) and the indirect stimulating action of nitric oxide (NO, [27]) for cellular markers, as well as by the expression of several genes involved in this response: the complex *arp 2/3*, involved in the regulation of cytoskeleton actin; *cdc 42*, involved in cell migration and endocytosis; and *gal 2*, a galactose-binding lectin, playing many roles including cell adhesion and signalling [28-30].

Apoptosis, *via* the study of the cellular activation of an effector with cysteine effector,
caspases 3/7, and the expression of its gene. Galectin-2 also plays a role in apoptosis by
being part of anti-apoptotic molecules [31].

The molecular markers were selected in accordance with the work of Leprêtre *et al.* [32] who observed the involvement of the proteins encoded by these genes in the cell compartment of the hemolymph of the zebra mussel.

122 Cell necrosis marker, detoxification and antioxidant systems were also evaluated, by flow 123 cytometry and droplet digital polymerase chain reaction (ddPCR). This latter technology is 124 based on the massive fragmentation of the genetic material, which facilitates the analysis of low-expressed genes [33, 34]. ddPCR was preferred to other PCR techniques because of 125 126 the low expression levels of certain genes such as cdc 42 or casp 3/7, as well as being able 127 to express the absolute result in a number of copies per hemocyte. Thanks to the partitioning 128 of the sample and Poisson's law, ddPCR makes possible to express the quantification results directly as the number of copies of the target DNA per µL, or in our case as the number of 129 copies per cell. This technique improves the measurement accuracy without the need for a 130 131 prior calibration curve [34, 35]. This simplifies quantification and reduces the risk of error. Compared to other PCR techniques, it offers other advantages such as high accuracy and an 132 increase in the signal-to-noise ratio [34, 36]. This strategy, developed and used in medicine, 133 is pioneer in ecotoxicology. This opportunity to assess cellular and molecular markers on the 134

same scale, namely the hemocyte, allows a better understanding of the response capacitiesof these cells to stress.

138 2. Materials and methods

139 *2.1. Mussel and hemolymph collection*

Zebra mussels (3.18 ± 0.41 g; 2.72 ± 0.16 cm) were collected on 25th August 2017 from Der 140 141 lake (51290 Giffaumont-Champaubert, France, N 48°33'35"; E 4°45'11") and brought back to 142 the laboratory, where they were maintained in 20 L aerated glass tanks in Cristaline Aurele drinking water (14.41 ± 0.67 °C; pH 7.47 ± 0.07; 570 ± 40 mS/cm; spring Jandun, France). 143 Four weeks of acclimation were respected before ex vivo experiments. Throughout the study, 144 mussels were fed, twice per week, with two microalga species: Scenedesmus obliguus and 145 *Chlorella pyrenoidosa* (10⁶ microalgae of each species per mussel and per day). Water (6 L) 146 147 was changed every week, after assessment of nitrites (0.12 \pm 0.02 mg/L), nitrates (34.32 \pm 13.16 mg/L), and ammonium concentrations $(0.03 \pm 0.01 \text{ mg/L})$. 148

Hemolymph recovery was realised before feeding to not compromise cytometric analyses. 149 Hemolymph from ten mussels was withdrawn from adductor muscle with 0.3 mL syringes (30 150 G x 8 mm, Becton Dickinson, NJ, USA), kept on ice and pooled to obtain enough hemolymph 151 volume for both flow cytometric and ddPCR analysis. Cell concentration was determined with 152 KOVA slide (KOVA International, CA, USA), then adjusted to 375,000 cells per mL and 153 154 samples were separated into microplate (U-bottom, VWR, PA, USA) for flow cytometry and into tubes for ddPCR. To discard cell debris and dead cells caused by sampling and starting 155 with healthy samples, plasma was removed after 20 minutes of hemocyte sedimentation (16 156 °C, in the dark [37]). Then, 190 µL (or 200 µL for UVb exposure) of modified Leibovitz 15 157 158 medium (L15, Sigma-Aldrich, MO, USA) were added for flow cytometry [38, 39]. For ddPCR analyses, samples were placed into three 1.5 mL tubes with phosphate buffer saline (Sigma-159 160 Aldrich) q.s. 500 µL per tube.

162 *2.2. Nature of stress and exposure*

Stresses of different natures were selected: two chemical ones, represented by cadmium 163 164 chloride (Agilent technologies, CA, USA) and an antibiotic from *Streptomyces conglobatus* named ionomycin (VWR); a physical stress with exposure to ultraviolet B (UVb, 254 nm, at a 165 distance of 10 cm, tubes or plates closed to prevent evaporation and kept on ice, Camag, 166 NC, USA). Finally, two human protozoan parasites were selected as biological stressors, 167 Toxoplasma gondii (generously gifted by J.P. Dubey, USDA, Beltsville, USA) and 168 169 Cryptosporidium parvum (INRAE, Val de Loire research center, France). Hemocytes were submitted to the different stress conditions for four hours (Table 1): i) to each solvent for 170 control conditions, ii) to cadmium chloride (in phosphate buffer saline, Sigma-Aldrich), to 171 ionomycin (in phosphate buffer saline with 0.2 % dimethylsulfoxide, ThermoFisher Scientific, 172 173 MA, USA) or to protozoan solutions (in phosphate buffer saline), and iii) hemocytes were exposed to a UVb light for 0 (control), 3 or 10 minutes. 174

179 2.3. Flow cytometric analyses

180 Analyses with flow cytometer were based on Barjhoux *et al.* [37] protocol with minor 181 modifications. Briefly, hemocyte samples were placed in nine wells (three stress conditions x

three analyses), at 75.000 cells per well. After UVb exposure or immediately after adding 182 other stressors, hemocytes were incubated four hours according to the following conditions: 183 184 i) 2 µm diameter yellow-green fluorescent latex microbeads with a cell:bead ratio of 1:50 (16 °C, in the dark, Polysciences Inc., PA, USA, [37]), ii) 0.5 µM caspases 3/7 green flow 185 cytometric reagent (30 min, 16 °C, in the dark, Thermofisher Scientific), and iii) with 5 µM of 186 4-amino-5-methylamino-2',7'-difluorofluorescein diacetate (DAF-fm, 30 min, 16 °C, in the 187 dark, Thermofisher Scientific). Ten minutes before analyses, cells were removed into new 188 189 wells with an anti-aggregate solution (Trypsin-EDTA solution, 0.0625 % final, Sigma-Aldrich [37]). Just before flow cytometric analyses, propidium iodide (PI, 1 % final, Sigma-Aldrich) 190 was added to mark dead cells in double labeling with microbeads. The oocysts were 191 removed from flow cytometry analyses by their size, complexity and autofluorescence, 192 different from those of hemocytes, as previously describes [26]. Flow cytometric data were 193 evaluated with 10,000 cells counted for each suspension sample thanks to Accuri™ C6 194 SORP flow cytometer (Becton Dickinson, N.J., USA, with BD Accuri™ C6 software 195 196 (v1.0.264.21)).

197 All immune markers and their corresponding method of analysis are described in Table 2.

202 2.4. Gene expression analysis

2.4.1. RNA extraction and quantification

After exposure, the supernatant was removed from the sample after centrifugation (3,000 g, 5 min, 4 °C), and hemocytes were lysed with trizol reagent (Molecular Research Center Inc., OH, USA). At this stage, samples were frozen (-80 °C) for several weeks until resumption of RNA extraction.

208 After thawing, chloroform (VWR) was added and vortexed with samples and then incubated 15 minutes at room temperature. The following steps have been carried out on ice to better 209 preserve the integrity of the biological material. The aqueous phase containing the nucleic 210 material was recovered after centrifugation (12,000 g, 8 min, 4 °C). Total RNA was 211 precipitated using isopropanol (10 minutes on ice, VWR) and the supernatant was kept after 212 centrifugation (12,000 g, 8 min, 4 °C). RNA was washed with 70 % ethanol (Charbonneaux-213 Brabant Chimie, Reims, France), removed from the sample by centrifugation (7,500 g, 5 min, 214 4 °C). To remove ethanol, the pellet was air-dried on ice for about thirty minutes and was 215 then mixed with RNAse free water (40 µL, United States Biological, MA, USA). A water bath 216 step was then respected (15 min, 57 °C) to dissolve RNA in water. RNA quantification was 217 assessed using Genova Nano spectrophotometer (Jenway, Staffordshire, United Kingdom), 218 and samples were homogenized at 100 ng RNA / µL. Quality index (absorbance ratio 219 220 OD₂₆₀/OD₂₈₀) was checked and samples that did not meet quality standards were removed from the analyses. RNA purity was observed after electrophoresis and UV revelation (1.5 % 221 agarose gel and TBE buffer (0.5 X, Euromedex, Souffelweyersheim, France)). RNA samples 222 223 were frozen (-20 °C) until reverse transcription polymerase chain reaction.

225 2.4.2. Reverse transcription polymerase chain reaction

The reverse transcription was performed with 400 ng of total RNA using Verso cDNA Synthesis Kit (ThermoFisher Scientific). The reaction was conducted at 42 °C for 30 min followed by 2 minutes at 95 °C (Eppendorf Mastercycler EP Gradient S, Eppendorf France, Montesson, France). Reverse transcription polymerase chain reaction was not coupled with PCR to reduce final variability [35].

- 232 2.4.3. Droplet digital polymerase chain reaction analyses

All primers were obtained from Eurogentec (Liège, Belgium). All characteristics concerning

cDNA samples, diluted to the tenth, were combined according to the manufacturer's instructions on ice with a mix of primers (final concentration of 150 nM), Eva Green solution (QX200 ddPCR EvaGreen Supermix RXN, BioRad, CA, USA) and osmosed water. Droplet formation was then automatized with BioRad apparatus. PCR was then performed within 40 cycles (BioRad thermocycler). All reads with less than 13,000 accepted droplets were removed from results [35]. The results are then expressed in gene copies per hemocyte, with reference to the count carried out on each pool.

According to the Lievens *et al.* [35] study, many criteria for validating ddPCR data have been taken into account and are presented in annex 1 (the number of accepted partition; the number of outliers; the results of NTC, the mean number of copies per partition; the percentage of "rain" and the maximum threshold).

255 2.5. Statistical analysis

Statistical analyses were performed using R 3.4.1 software. An analysis of variance 256 257 (ANOVA) was performed and normality and variance homogeneity were tested on its residuals thanks to Shapiro-Wilk and Levene tests respectively ($\alpha \le 5$ %). If normality and 258 homoscedasticity were respected, results from ANOVA were kept and followed by a post-hoc 259 test to discriminate significant differences inside each group (TukeyHSD with Holm 260 correction, $\alpha \leq 5$ %). If one of these criteria was not respected, ANOVA was replaced by a 261 262 Kruskal-Wallis test followed by Nemenyi post-hoc test ($\alpha \le 5$ %). Statistics were performed 263 on ten biological replicas (pool).

265 **3. Results**

266 *3.1. Chemical stress (cadmium and ionomycin)*

Both chemical stresses were cytotoxic. While cadmium induced hemocyte necrosis from medium intensity, only the highest concentration of ionomycin was cytotoxic (Table 4). Contrary to cadmium exposure, ionomycin induced other effects. First, a significant increase 270 of 3/7 caspases activation was observed when the hemocytes were exposed to 10 μ M ionomycin compared to the control condition (evolution rate on means: +118.0 %, p-value = 271 272 8.40 x 10⁻³, Table 4). Then, at this concentration, ionomycin also induced a decrease in all cell markers linked to phagocytosis (the capacity (-23.7 %), efficiency (-56.6 %) and avidity (-273 51.7 %) of this immune process, *p*-value = 4.30×10^{-2} ; *p*-value = 1.00×10^{-2} ; *p*-value = 1.00×10^{-2} ; 274 10⁻², respectively, Table 4). The intermediate concentration of cadmium chloride induced a 275 276 higher sod gene expression compared to the control condition (evolution rate: -62.8 %, pvalue = 1.67×10^{-2} , Table 5) while no significant change was observed for the highest 277 278 concentration. No significant effect on gene expression was observed after ionomycin exposure. Nonetheless, both chemical stressors tended to modify some gene expressions 279 (Figure 1). At the highest concentrations, opposite effects on gene expression were observed 280 between cadmium and ionomycin exposures compared to their control. While cadmium 281 would tend to decrease the gene expression of sod (-49.8 %), gst (-34.0 %), and arp 2/3 (-282 56.5 %), ionomycin would increase it (*sod* (+163.7 %), *gst* (+152.3 %), *casp 3*/7 (+141.2 %) 283 284 and arp 2/3 (+1075.7 %)). This is also observable when the ratios of the two stress intensities 285 is carried out with respect to the control condition for each pool (Figure 1).

295 *3.2. Physical stress (UVb)*

From the intermediate intensity (3 min), ultraviolet B induced significant necrosis and apoptosis (*via* the activation of 3/7 caspases, Table 4). These effects persisted at the highest intensity (10 min). The phagocytic avidity can be impaired by UVb exposure, after 3 (-26.9 %) and 10 minutes (-34.3 %) exposure (*p*-value = 3.04×10^{-2} and *p*-value = 8.36×10^{-3} compared to control, respectively, Table 4).

302 3.3. Biological stress (<u>C. parvum</u> and <u>T. gondii</u>)

Contrary to C. parvum, oocysts of T. gondii did not induce hemocyte necrosis (Table 4). 303 These two protozoa, at the highest stress intensity, disrupted phagocytic parameters: i) 304 phagocytic capacity (evolution rate: -20.3 %, *p-value* = 2.26 x 10⁻³ for *T. gondii* and -27.5 %, 305 p-value = 1.20×10^{-2} for C. parvum compared to control), ii) efficiency (-41.0 %, p-value = 306 2.10 x 10⁻² for C. parvum compared to control), and iii) avidity (-24.2 %, p-value = 7.78×10^{-3} 307 for *T. gondii* and -29.0 %, *p*-value = 3.47×10^{-2} for *C. parvum* compared to control, Table 4). 308 Finally, exposure to both biological stress at the highest stress intensity induced higher NO 309 basal production than without stress (evolution rate: +126.8 %, p-value = 2.50 x 10⁻³ and 310 +41.5 %, *p*-value = 1.24×10^{-2} , for *T. gondii* and *C. parvum* respectively, Table 4). 311

In addition to cellular effects, exposure to *C. parvum* oocysts, at the highest stress intensity, induced increase of caspases 3/7 gene expression (+282.3 %, *p-value* = 3.50×10^{-2} compared to control, Table 5). No effect on gene expression was observed after *T. gondii* oocyst exposure.

332 **4. Discussion**

4.1. Chemical stress induced different effects

334 Many authors have investigated the effects of cadmium on animals, including bivalves. 335 These organisms are known to accumulate high doses of this metal, and thus are used as sentinel species for metallic biomonitoring [40, 41]. The effects of Cd on mussel physiology 336 are numerous and complex, depending on the dose and bioavailability of metal as well as the 337 size and reproductive status of mussels [41, 42]. Nonetheless, several effects on bivalve 338 339 hemocytes are often highlighted by authors. Cadmium has deleterious effects on hemocyte viability, on the one hand being pro-apoptotic, and on the other hand by inducing necrosis 340 [43-45]. This impact was observed in this study with an increase in necrosis following 341 hemocyte exposure to 25 µg/L Cd and more, but no effect on hemocyte apoptosis (assessed 342 by activation of caspases 3/7) was reported contrary to the literature [43-45]. Nevertheless, 343 the conditions for exposing cells to cadmium were different. Also, Sokolova et al. [43] have 344 reported the induction of apoptosis after exposure to Cd without caspase activation. Cd²⁺ 345 would induce apoptosis in a caspase-independent manner [46]. Disturbance of SOD 346 347 production after exposure to Cd is a common feature, highlighted in our study and by several authors [44, 45, 47]. Cadmium can also alter immune functions in bivalves. Indeed, this metal 348 can disturb cytoskeletal actin and thus modify adhesion and phagocytic process, leading 349 sometimes to immune suppression [48-50]. No significant effect of Cd on D. polymorpha 350 351 immune function was reported in this study, probably explained by several factors. First, Cd concentrations were higher than those of other studies with effects on immune functions [48, 352 353 50]. Then, exposure conditions and duration were different (ex vivo versus in vivo), and finally the necrosis and phagocytosis double-labelling allowed to remove dead cells for 354 355 phagocytic parameters. It should be noted that despite the importance of inter-pool 356 variations, the highest concentration of cadmium seemed to decrease the expression of part of the genes studied. The expression levels of sod, gpx, gst, arp 2/3 and gal2 decreased at 357 the highest concentration of Cd. 358

Results obtained after exposure of hemocytes to ionomycin are consistent with those of the 359 literature. Ionomycin is a Ca²⁺ ionophore that increases intracellular Ca²⁺, leading to pH 360 361 modifications inside cells, such as hemocytes [51-54]. These effects induce the phenomenon of programmed death, named apoptosis. This was revealed in our study, with a dose-362 dependent activation of caspases 3/7 inside hemocytes and with an increase of casp 3/7 363 gene expression, as revealed in several studies [51-53]. Ionomycin induces the intrinsic 364 pathway of apoptosis by stimulating the activation of the initiator caspase 9 and executor 365 366 caspases (caspases 3 and 7) as well as the release of cytochrome c from mitochondria, thus limiting the anti-apoptotic factors [52]. These authors highlighted that three hours after 367 ionomycin exposure is enough to induce apoptosis and necrosis, as compared to our results 368 [52, 55]. Few studies, however, have observed a decrease in phagocytosis after cell 369 exposure to this antibiotic, contrary to our results. These decreases of phagocytic 370 parameters assessed in mussel hemocyte can be explained by several hypotheses. First, it 371 has been noticed that a part of phagocytosis can be Ca²⁺-dependent, at least in human 372 373 neutrophils [56-58]. Ca²⁺ would act as a second messenger for phagocytosis and superoxide 374 anion formation [59]. The disruption in intracellular transport caused by ionomycin may thus alter this immune function. Secondly, apoptotic hemocytes, rapidly ingested after ionomycin 375 376 exposure [55], can be preferred to microbeads by viable hemocytes. Finally, although 377 propidium iodide-labelled hemocytes (in necrosis) are removed from the phagocytosis assay, 378 those labelled with caspase 3/7 reagent are not. The increase of apoptotic cells after exposure to ionomycin may directly lead to a decrease in phagocytosis of the microbeads. 379 This hypothesis was supported by a tendency to increase the expression level of caspases 380 381 3/7 when the ionomycin concentration rises up. This was also observed with other genes 382 under study, such as sod, gst, arp 2/3 and gal2, with induction factor compared to control condition from 2 to 11 for arp 2/3. 383

Cellular activities are coordinated by the information contained in genetic material. This creates a close link between gene expression and protein activity. However, many stages of gene regulation exist. In eukaryotes, they are found at the level of chromatin structure,

transcription, maturation of mRNAs and their temporal stability, at the level of translation and 387 post-translational modifications that can also impact the activity of encoded protein [60]. In 388 389 this study, no significant correlation between gene expression (casp 3/7 on one side and arp 390 2/3, cdc 42 and gal 2 on the other) and protein or cellular activity (activation of caspases 3/7 and phagocytosis, respectively) had been observed. However, the comparison of the results 391 392 obtained by flow cytometry and by ddPCR can provide information on the synergy of action 393 of different studied stress. Indeed, the higher mortality rate (necrosis and apoptosis analysed 394 by flow cytometry), caused by high concentrations of cadmium and ionomycin, could explain the modifications, although not significant, of the gene expressions (sod [p-value = 1.67×10^{-1} 395 ²], gst and arp 2/3 for cadmium at 250 µg/L; sod, gst, casp 3/7, and arp 2/3 for ionomycin at 396 10 μ M). Both stress, at the highest intensities, had opposite effects. Cadmium tends to 397 decrease gene expression while ionomycin would increase it (Figure 1). Despite a similar 398 cytotoxic effect, this suggests that these two chemical stressors do not have the same 399 modes of action. Cadmium is known to induce oxidative stress in cells and this oxidative 400 401 stress would certainly impair the integrity of hemocytes. This could be the cause of the insignificance of the results in gene expression for the highest concentration of cadmium. 402

Otherwise, activation of calcium channels ultimately leads to cell apoptosis by ionomycin further impacts immune cell functions and could induce the expression of genes linked to phagocytosis. Nevertheless, *arp 2/3, cdc 42* and *gal 2* have other functions than those related to phagocytosis. *cdc 42* and *arp 2/3* play roles in the cellular cycle and maintaining cellular integrity, while Gal 2 regulates the inflammation, cell homeostasis and cell growth processes [28, 61, 62].

Regarding caspases 3/7, no similarity of effect was observed between the results obtained in cytometry and in ddPCR. It is likely that the stress exerted on the hemocytes only influenced the inactive procaspases already present in the hemocytes without inducing modulation of their gene expression. Ionomycin, which induced significant activation of 3/7 caspases at the highest concentration, also seemed to induce the gene expression of these caspases. However, this induction was just a trend. A larger number of biological replicas could improvethe discernment of these effects.

417 *4.2. A cytotoxic physical stress*

The physical stress, ultraviolet B, induced hemocyte necrosis and apoptosis as well as 418 decrease of phagocytic avidity. These effects are in agreement with those reported by 419 420 several studies. Clydesdale et al. [63] have synthetized effects of ultraviolet on human cells, 421 such as apoptosis and necrosis induction and immunomodulatory effects. These effects have been also reported on aquatic invertebrates, such as crustaceans [64, 65], and bivalves [66, 422 67]. Apoptosis caused by UVb light seems to be activated by the intrinsic way, via DNA 423 fragmentation, caspases activation, modulation of cytoplasmic calcium, increase in 424 mitochondrial membrane potential, and modifications of pro- and anti-apoptotic gene 425 expression [64-67]. UV are thus immune toxic as well as genotoxic, as observed by Rank 426 and Jensen [68] on hemocytes of Mytilus edulis with the same emission wave length (254 427 nm). 428

4.3. Different protozoa, different interactions?

Few studies are looking at protozoan:hemocyte interaction when the host is paratenic. Previously, we have described the effects of *C. parvum* and *T. gondii* oocysts on hemocytes of two bivalves, *D. polymorpha* and *M. edulis* [26]. The vast majority of effects previously observed have been also reported in this study. We observed a decrease of phagocytic parameters after exposure to both protozoa and an increase of basal NO production after exposure to *C. parvum* oocysts [26].

437 Decreases of phagocytosis can be explained by the establishment of immune process by
438 hemocytes. Palos Ladeiro *et al.* [15] have reported that hemocytes of zebra mussels are able
439 to engulf *C. parvum* oocysts. This protozoan has been used as a marker of phagocytosis for

Crassostrea virginica [69]. The T. gondii oocyst being about twice the size of that of C. 440 parvum, it seems unlikely that it can be ingested. Nevertheless, immune cells of zebra 441 442 mussels can aggregate around the oocysts to realize the phenomenon of encapsulation [70]. These immune functions are accompanied by an overproduction of NO, which can be 443 produced against microorganisms [71]. Not observed in previous studies [26, 70], oocysts of 444 C. parvum induced hemocyte necrosis. Although the number of activated caspases 3/7 did 445 446 not differ among the condition of C. parvum exposure, this protozoan induced gene 447 expression of these enzymes. Terahara and Takahashi [72] have reported an over-448 expression of caspase genes as an immune response of mollusc host against parasite infection. Induction of apoptosis with parasitic exposure was often highlighted in edible 449 bivalves [73-75]. If this exposure is prolonged, apoptosis can even be suppressed [75, 76]. 450 Nonetheless, these results were reported with specific hosts (i.e. Crassostrea virginica for 451 Perkinsus marinus) and not for paratenic hosts. We previously evidenced that T. gondii was 452 able to activate caspases 3/7 in hemocytes of the blue mussel [26]. Functional changes in 453 454 the immunity of *Dreissena polymorpha* after exposure to both protozoa were more numerous 455 than changes in the expression of genes linked to the immune system. T. gondii and C. parvum oocysts did not significantly impact immune gene expression in hemocytes of zebra 456 457 mussels. Many authors have reported over-expression of genes following the exposure of 458 molluscs to parasites, particularly lectins MTs or GSTs [77-81]. However, a big difference 459 between these results and ours is that all of these studies were focused on a specific host, 460 which could be subject to infection by the parasite. Recently, Leprêtre et al. [82] compared the protein expression profiles on the hemolymphatic compartments of zebra mussels 461 between unexposed samples and others exposed to C. parvum. The changes in protein 462 463 expression after exposure to this protozoan were mainly located at the cell level, and included proteins linked to cell motility, to the internalization and destruction of pathogens, 464 apoptosis, and immune signalization, including an up-regulation of arp 2/3 complex, cdc 42 465 and a galectin proteins, confirming our results obtained in flow cytometry. Nonetheless, 466 Leprêtre et al. [82] emphasized the importance of the plasma compartment in the immune 467

responses of the zebra mussel. Some immune proteins have been up or down modulated 468 after a 4-hour exposure to C. parvum, including arp 2/3, galectin, serine, clathrin and 469 470 complement-like proteins. In our study, no correlation between the disturbances of phagocytosis by hemocytes exposed to both biological stressors and the expression of 471 genes potentially linked to this process (arp 2/3, cdc 42, gal 2) has been reported. This can 472 be explained by the fact that phagocytosis included several immune processes, such as 473 474 vesicle transport, cell motility, cell adhesion, cytoskeleton organisation, etc., and by a large 475 number of genes and proteins involved in this defence system [32, 83]. The complementarity between the two hemolymphatic compartments (plasma and hemocytes) is significant. Thus, 476 the exposure to the various stresses carried out without plasma may block this 477 478 complementarity, in particular for the recognition of pathogens [32]. It would be interesting to expose the hemolymph of the zebra mussels as a whole before separating plasma and cells. 479 The cellular and molecular markers studied on hemocytes after this protocol may be different 480 from those analysed without the plasma-hemocyte complementarity. 481

4.4. Improvements and future tracks

It is important to note the high variability of gene expression among pools. This variability 484 was reported between pools inside a condition (SEM) and between stress conditions (Table 485 5). This variability was not identical according to the studied genes. Comparing gene 486 487 expression for control conditions of each exposure, ratio of 2 (cat) to 30 (arp 2/3) were reported. Expression levels of casp 3/7, cat, gal 2 and mt seemed to be less variable than 488 those of *sod*, *gpx*, *gst*, *arp 2/3* and *cdc 42* genes. This strong variability can be explained by 489 490 three hypotheses. The main reason for explaining this variation would be linked to 491 interactions between hemocytes from different individuals within the same pool. We decided to work with pool to have enough hemocytes to expose the same sample and analyse all the 492 markers on the same group. Barjhoux et al. [37] have observed a reduction in the variability 493 of the immune markers analysed by flow cytometry in this species. However, the interaction 494

between hemocytes from different individuals may have caused this strong variability in
molecular markers. Volume improvements on the hemolymph sample for this species would
make it possible to analyse the expression of several genes individually.

498 Although the production of proteins in response to external stimuli comes from a rapid expression of genes, the regulatory steps induce a strong variation in the kinetics between 499 500 gene expression and expression of the protein formed [84]. This is especially important when 501 studying a biological process (i.e. phagocytosis), involving a large number of molecules [85]. 502 Thus, after exposure to a xenobiotic, the expression profiles vary depending on the post-503 exposure period at which analyses are carried out [86]. The kinetics of analysis can also modify our gene expression results. In our study, hemocytes were exposed for four hours 504 before genetic material extraction. However, this duration may be too long to observe a 505 modulation of gene expression. Morga et al. [80] highlighted over-expression of several 506 507 genes (gst, p450 cytochrome, galectin and lysozyme) in hemocytes of Ostrea edulis after 508 one hour in vitro exposure to Bonamia ostreae. These expressions were returned to basic 509 levels 2 or 4 hours after exposure [80]. The kinetics of exposure (four hours exposure) could 510 explain that the stress had more effects on the hemocyte functions than on the gene 511 expression. On the other hand, this modulation of gene expression can appear later than four hours post-stress. Indeed, Farcy et al. [87] reported, in C. gigas, an over-expression of genes 512 513 coding for stress proteins 4 to 8 hours after heat shock, this expression returning to basic 514 levels after 48 hours. Correlatively, the expression of immune genes from the same bivalve 515 (C. gigas) was stimulated after 24 to 48 hours after exposure to a virus (Ostreid herpesvirus 1 mVar), and the return to baseline levels took place after 120 hours [88]. Nonetheless, these 516 517 two studies were conducted in vivo. Although the 4-hours post-stress exposure period was 518 established in previous work [26], this sampling time is ideal for cytometric analyses and to keep healthy cells. However, for the analysis of gene expression, it would be interesting to 519 follow the kinetics of post-exposure expression over several hours to confirm our results. 520

521 These biases are mainly due to a narrow vision of the complex processes involved in the 522 response to stress. In the last decade, the omics approaches (from genomics to

interactomics) permit to obtain the entire toxicological signature of a xenobiotic. These 523 approaches would allow a larger view of the interaction between chemical, physical and 524 525 biological stress and hemocytes. Even if the mechanisms which govern remains unclear, 526 they are mainly controlled at the protein level (i.e. cytokines, immune recognition factors, etc.). The proteomic approach would answer several questions: i) do the reductions in 527 phagocytosis parameters following exposure to biological stress and ionomycin have the 528 529 same mechanisms? and ii) despite fairly similar cellular effects, are the oocysts of T. gondii 530 and *C. parvum* managed in the same way by cell (recognition, destruction, etc.)? Finally, proteomics, flow cytometry and ddPCR could be performed jointly on proteins, activities and 531 genes of interest previously chosen, during post-exposure kinetics to characterize the links 532 between the different levels of organization. 533

535 **5. Conclusion**

One of the challenges of ecotoxicology today is to be able to link molecular biomarkers, 536 cellular biomarkers and pathophysiological 'endpoints' with higher level ecological 537 consequences [89]. This requires a good understanding of the effects of various xenobiotics 538 539 as well as the responses of the organisms subjected to them. This study aimed to understand the immune response capabilities of zebra mussel hemocytes to various stresses 540 (chemical, physical and biological), via cellular and molecular markers. Ultraviolet b are 541 cytotoxic since they induced necrosis, apoptosis and reduced the phagocytosis of 542 hemocytes. The oocysts from both protozoa induced nitric oxide production by exposed 543 hemocytes and phagocytic parameters decreases, as already reported. Nonetheless, 544 545 hemocytes appear to be more affected by oocysts of C. parvum, suggesting a difference in the management of these two protozoa. New gene sequences related to the immune system 546 547 of zebra mussels were obtained in connection with apoptosis and cell motility and phagocytosis. Omics approaches could provide more details on the links between gene 548 549 expression and cellular activity, particularly for complex processes such as phagocytosis. It would be interesting to encompass the entire immune system by taking into account the plasma compartment. Indeed, plasma contains immune proteins which can play an important role in defence against xenobiotics [90, 91]. These two compartments could work together to eliminate some microorganisms [92]. The responses obtained on the entire hemolymphatic compartment may be different than those assessed exclusively at the cellular level.
