# ON THE COHOMOLOGY OF LINE BUNDLES OVER CERTAIN FLAG SCHEMES II 

LINYUAN LIU AND PATRICK POLO

To Jens Carsten Jantzen on the occasion of his 70th birthday


#### Abstract

Over a field $K$ of characteristic $p$, let $Z$ be the incidence variety in $\mathbb{P}^{d} \times\left(\mathbb{P}^{d}\right)^{*}$ and let $\mathscr{L}$ be the restriction to $Z$ of the line bundle $\mathscr{O}(-n-d) \boxtimes \mathscr{O}(n)$, where $n=p+f$ with $0 \leq f \leq p-2$. We prove that $H^{d}(Z, \mathscr{L})$ is the simple $\mathrm{GL}_{d+1}$-module corresponding to the partition $\lambda_{f}=(p-1+f, p-1, f+1)$. When $f=0$, using the first author's description of $H^{d}(Z, \mathscr{L})$ and Jantzen's sum formula, we obtain as a by-product that the sum of the monomial symmetric functions $m_{\lambda}$, for all partitions $\lambda$ of $2 p-1$ less than ( $p-1, p-1,1$ ) in the dominance order, is the alternating sum of the Schur functions $S_{p-1, p-1-i, 1^{i+1}}$ for $i=0, \ldots, p-2$.


Introduction. This paper is an addition to the first author's paper [Liu19b]. We now consider the group scheme $G=\mathrm{SL}_{d+1}$ over an arbitrary field $K$ of characteristic $p>0$. For $m, n \in \mathbb{N}$, set $\mu_{m, n}=m \omega_{1}-(n+d) \omega_{d}$ and write simply $\mu_{n}$ instead of $\mu_{n, n}$. We describe the $H^{i}\left(\mu_{m, n}\right)$ when $p>n$ (thus recovering and extending [Liu19b], Cor. 2) and for $n=p+f$ with $0 \leq f \leq p-2$ we prove that $H^{d}\left(\mu_{n}\right)$ is the simple $G$-module $L\left(\lambda_{f}\right)=$ $L\left(f \omega_{1}+(p-2-f) \omega_{2}+(f+1) \omega_{3}\right)$. Further, when $f=0$ we express the character of $L\left(\lambda_{f}\right)$, using Jantzen sum formula, as an alternating sum of Weyl characters. Comparing this with the character of $H^{d}\left(\mu_{p}\right)$ given in [Liu19b], Cor. 3, we obtain as a by-product that the sum of the monomial symmetric functions $m_{\lambda}$, for all partitions $\lambda$ of $2 p-1$ less than $\lambda_{f}$ in the dominance order, is the alternating sum of the Schur functions $S_{p-1, p-1-i, 1^{i+1}}$ for $i=0, \ldots, p-2$.
1.1. Notation. We keep the notation of [Liu19b], except that we now consider the group scheme $G=\mathrm{SL}_{d+1}$ over an arbitrary field $K$ of characteristic $p>0$ and denote simply by $P$ the maximal parabolic subgroup $P_{1}$. Let $W_{P}$ be the Weyl group of $(P, T)$ and define $W_{Q}$ similarly. Let ch $V$ denote the character of a $T$-module $V$. For each simple root $\alpha_{i}$, let $s_{i} \in W$ be the corresponding simple reflection. Let $w_{0}$ (resp. $w_{P}$, resp. $w_{Q}$ ) be the longest element of $W$ (resp. $W_{P}$, resp. $W_{Q}$ ) and set $N=\ell\left(w_{Q}\right)$. Then $\ell\left(w_{P}\right)=N+d-1$.

Let $\rho_{Q}$ (resp. $\rho_{P}$ ) denote the half-sum of the positive roots of $Q($ resp. $P)$. Then one has:

\begin{equation*}
2 \rho_{Q}=(2-d)\left(\omega_{1}+\omega_{d}\right)+2 \sum_{i=2}^{d-1} \omega_{i}, \quad 2 \rho_{P}=(1-d) \omega_{1}+2 \sum_{i=2}^{d} \omega_{i} . \tag{1.1.1}
\end{equation*}
$$

Recall that, since $2 \rho-2 \rho_{Q}=d\left(\omega_{1}+\omega_{d}\right)$, the dualizing sheaf on $Z=G / Q$ is $\mathscr{L}\left(-d \omega_{1}-d \omega_{d}\right)$. Hence, by Serre duality on $G / Q$, one has

\begin{equation*}
H^{d}\left(\mu_{m, n}\right) \simeq H^{d-1}\left(-(m+d) \omega_{1}+n \omega_{d}\right)^{*} . \tag{1.1.2}
\end{equation*}
$$

Further, let $\tau$ be the (involutive) automorphism of ( $G, T$ ) induced by the automorphism of the Dynkin diagram which swaps $\alpha_{i}$ and $\alpha_{d+1-i}$ for $i=$ $1, \ldots, d$. Note that $\tau$ also acts on $X(T)$ and preserves $X(T)^{+}$. For any $G$-module $V$, let ${ }^{\tau} V$ denote the corresponding module twisted by $\tau$. For example, for a Weyl module $V(\lambda)$ (resp. a simple module $L(\lambda)$ ), one has ${ }^{\tau} V(\lambda) \simeq V(\tau \lambda)\left(\right.$ resp. $\left.{ }^{\tau} L(\lambda) \simeq L(\tau \lambda)\right)$. Then, (1.1.2) can be rewrited as:

H^{d}\left(\mu_{m, n}\right) \simeq H^{d-1}\left(\tau \mu_{n, m}\right)^{*} . \tag{1.1.3}
\end{equation*}
$$

Recall (see [Jan03], II.4.6 and its proof) that if $P^{\prime} \subset P^{\prime \prime}$ are parabolic subgroups containing $B$ and if $V$ is a $P^{\prime}$-module, one has for all $i \geq 0$ :

\begin{equation*}
H^{i}\left(P^{\prime \prime} / B, V\right) \simeq H^{i}\left(P^{\prime \prime} / P^{\prime}, V\right) . \tag{1.1.4}
\end{equation*}
$$

This will be used several times, without always mentioning it.
1.2. A description of $H^{i}\left(\mu_{m, n}\right)$. For each $i \in \mathbb{N}$, we denote by $H_{Q}^{i}(-)$ the functor $H^{i}(Q / B,-)$ and define $H_{P}^{i}(-)$ similarly. Since $-\mu_{m, n}$ is trivial and $\mu_{m, n}-2 \rho_{Q}$ is anti-dominant with respect to the Levi subgroup of $Q$ one has:

H_{Q}^{i}\left(-\mu_{m, n}\right) \simeq \begin{cases}-\mu_{m, n} & \text { if } i=0,  \tag{1.2.1}\\ 0 & \text { if } i>0\end{cases}
$$

and, using Serre duality on $Q / B$ :

$$
H_{Q}^{i}\left(\mu_{m, n}-2 \rho_{Q}\right) \simeq \begin{cases}0 & \text { if } i<N,  \tag{1.2.2}\\ H_{Q}^{0}\left(-\mu_{m, n}\right)^{*} \simeq \mu_{m, n} & \text { if } i=N\end{cases}
$$

Consider induction from $B$ to $P$. Thanks to (1.2.2), the spectral sequence of composite functors (see [Jan03], I.4.5) degenerates and gives (together with (1.1.4) applied to $P^{\prime}=Q$ and $P^{\prime \prime}=P$ ) isomorphisms for each $i \geq 0$ :

\begin{equation*}
H_{P}^{i}\left(\mu_{m, n}\right) \simeq H_{P}^{i+N}\left(\mu_{m, n}-2 \rho_{Q}\right) \tag{1.2.3}
\end{equation*}
$$

and since $\mu_{m, n}-2 \rho_{Q}=(m+d-2) \omega_{1}-2 \sum_{j=2}^{d-1} \omega_{j}-(n+2) \omega_{d}$ is anti-dominant with respect to $P$, the latter group is zero unless $i+N=\operatorname{dim}(P / B)$, i.e. $i=$ $d-1$. Moreover, by Serre duality on $P / B$, one has:

\begin{aligned}
H_{P}^{N+d-1}\left(\mu_{m, n}-2 \rho_{Q}\right) & \simeq H_{P}^{0}\left(-\mu_{m, n}+2 \rho_{Q}-2 \rho_{P}\right)^{*} \\
& =H_{P}^{0}\left((1-m) \omega_{1}+n \omega_{d}\right)^{*} .
\end{aligned}
$$

Set $\nu_{m, n}=(1-m) \omega_{1}+n \omega_{d}$ and $\pi_{m, n}=-w_{P} \nu_{m, n}$. Since $w_{P}=s_{2} \cdots s_{d} w_{Q}$, one has

$$
\begin{equation*}
\pi_{m, n}=(m-n-1) \omega_{1}+n \omega_{2} \tag{1.2.4}
\end{equation*}
$$

and since $H_{P}^{0}\left(\nu_{m, n}\right)^{*}$ is isomorphic with $V_{P}\left(\pi_{m, n}\right)$, the Weyl module for $P$ with highest weight $\pi_{m, n}$, one obtains:

Lemma 1.2.1. For each $m, n \in \mathbb{N}$ and $i \in \mathbb{N}$, one has

$$
H_{P}^{i}\left(\mu_{m, n}\right) \simeq \begin{cases}V_{P}\left(\pi_{m, n}\right) & \text { if } i=d-1 \\ 0 & \text { if } i \neq d-1\end{cases}
$$

Now, consider induction from $B$ to $G$. Thanks to the lemma, the spectral sequence of composite functors degenerates and gives (together with (1.1.4) applied to $P^{\prime}=P$ and $P^{\prime \prime}=G$ ) isomorphisms $H^{i}\left(\mu_{m, n}\right) \simeq H^{i-d+1}\left(V_{P}\left(\pi_{m, n}\right)\right)$ for each $i \geq 0$. Since the former is zero for $i \notin\{d-1, d\}$ (see [Liu19b], Section $2)$, this gives:
Proposition 1.2.2. For each $m, n \in \mathbb{N}$ and $i \in \mathbb{N}$, one has

$$
H^{i}\left(\mu_{m, n}\right) \simeq \begin{cases}H^{0}\left(V_{P}\left(\pi_{m, n}\right)\right) & \text { if } i=d-1 \\ H^{1}\left(V_{P}\left(\pi_{m, n}\right)\right) & \text { if } i=d \\ 0 & \text { if } i \neq d-1, d\end{cases}
$$

This allows us to recover and extend the result of [Liu19b], Corollary 2:
Corollary 1.2.3. Suppose that $p>n$.
(i) If $m \geq n$, then $H^{d}\left(\mu_{m, n}\right)=0$ and $H^{d-1}\left(\mu_{m, n}\right) \simeq H^{0}\left(\pi_{m, n}\right)$. In particular, $H^{i}\left(\mu_{n}\right)=0$ for all $i \geq 0$.
(ii) If $n \geq m$, then $H^{d-1}\left(\mu_{m, n}\right)=0$ and

$$
H^{d}\left(\mu_{m, n}\right) \simeq H^{1}\left(\pi_{m, n}\right) \simeq H^{0}\left(\pi_{n, m}\right)
$$

(iii) Furthermore, if $p>m \geq n$ then $H^{d-1}\left(\mu_{m, n}\right) \simeq L\left(\pi_{m, n}\right) \simeq H^{d}\left(\mu_{n, m}\right)$.

Proof. Suppose $p>n$. Then $V_{P}\left(\pi_{m, n}\right)$ is irreducible as a $P$-module, being isomorphic as a module over the Levi subgroup of $P$ to the $\mathrm{GL}_{d}$-module $S^{n} K^{d}$ which is irreducible since $n<p$. Therefore, $V_{P}\left(\pi_{m, n}\right) \simeq H_{P}^{0}\left(\pi_{m, n}\right)$. Thus, the proposition gives for all $i \geq 0$ that

$$
H^{i}\left(\mu_{m, n}\right) \simeq H^{i-d+1}\left(\pi_{m, n}\right)
$$

If $m \geq n$ then $\pi_{m, n}$ belongs to $\mathscr{C}:=X(T)^{+}-\rho$ and hence $H^{j}\left(\pi_{m, n}\right)=0$ for $j>0$ (and also for $j=0$ if $m=n$ ). This proves (i).

If $m<n$, then $H^{0}\left(\pi_{m, n}\right)=0$. Further, $\pi_{n, m}=(n-m-1) \omega_{1}+m \omega_{2}$ belongs to $\mathscr{C}$ and one has $\pi_{m, n}=s_{\alpha_{1}} \cdot \pi_{n, m}$. Since $0 \leq\left(\pi_{n, m}+\rho, \alpha_{1}^{\vee}\right)=n-m<p$, one has $H^{1}\left(\pi_{m, n}\right) \simeq H^{0}\left(\pi_{n, m}\right)$ (see [Jan03], II.5.4), which proves (ii).

Suppose now that $p>m \geq n$. By (i) and Serre duality on $G / Q$, one has

$$
H^{0}\left(\pi_{m, n}\right) \simeq H^{d-1}\left(\mu_{m, n}\right) \simeq H^{d}\left(-(m+d) \omega_{1}+n \omega_{d}\right)^{*}=H^{d}\left(\tau \mu_{n, m}\right)^{*}
$$

Now, using the automorphism $\tau$ of $(G, T)$, one deduces from (ii) that

$$
\left.H^{d}\left(\tau \mu_{n, m}\right)\right)^{*} \simeq H^{0}\left(\tau \pi_{m, n}\right)^{*}
$$

Since the latter is the Weyl module $V\left(\pi_{m, n}\right)$, one obtains that $H^{0}\left(\pi_{m, n}\right) \simeq$ $L\left(\pi_{m, n}\right)$. This proves (iii).

Our goal in the next subsection is to determine $H^{d}\left(\mu_{p}\right)$. Since for $d=2$ the $\mathrm{SL}_{3}$-modules $H^{2}(m,-n-2)$ have been described in [Liu19a], where it is proved in particular (see [Liu19a], Th. 3) that $H^{2}(p,-p-2)$ is the Weyl module $V(0, p-2)$, which is simple, we will henceforth assume that $d \geq 3$.
1.3. Computation of $H^{d}\left(\mu_{n}\right)$ for $p \leq n \leq 2 p-1$. Suppose now that $d \geq 3$ and $n=p+f$ with $0 \leq f \leq p-1$. For each weight $\nu$ which is dominant (resp. dominant with respect to $P$ ), denote by $L(\nu)$ (resp. $L_{P}(\nu)$ ) the irreducible $G$-module (resp. $P$-module) with highest weight $\nu$. Let

$$
\lambda_{f}= \begin{cases}f \omega_{1}+(p-2-f) \omega_{2}+(f+1) \omega_{3} & \text { if } f \leq p-2  \tag{1.3.1}\\ (p-1) \omega_{1}+(p-2) \omega_{3}+\omega_{4} & \text { if } f=p-1\end{cases}
$$

(with the convention $\omega_{4}=0$ if $d=3$ ), and set $L_{f}=L\left(\lambda_{f}\right)$ and $N_{f}=L_{P}\left(\lambda_{f}\right)$.
Proposition 1.3.1. One has $H^{d-1}\left(\mu_{n}\right) \simeq L_{f} \simeq H^{d}\left(\mu_{n}\right)$.
Remark 1.3.2. This generalizes Corollary 3 in [Liu19b], which was the case $f=0$. Note that if $f>0$ and $d>p-f+1$ then $\mu_{p+f}$ does not belong to the closure of the facet containing $\mu_{p}$. Indeed, denoting by $\alpha_{1}, \ldots, \alpha_{d}$ the simple roots and setting $\beta=\alpha_{1}+\cdots+\alpha_{p-f+1}$, one has $\left\langle\mu_{p}+\rho, \beta^{\vee}\right\rangle=2 p-f+1$ whereas $\left\langle\mu_{p+f}+\rho, \beta^{\vee}\right\rangle=2 p+1$. Hence the result for $\mu_{p+f}$ cannot be deduced from the one for $\mu_{p}$ by applying a functor of translation.
Proof. Set $\pi_{n}=-\omega_{1}+n \omega_{2}$ and $M=V_{P}\left(\pi_{n}\right)$. According to Doty [Dot85], $\S \S 2.3-2.4$, one has exact sequences of $P$-modules:

and

$$
\begin{equation*}
0 \longrightarrow C \longrightarrow H_{P}^{0}\left(\pi_{n}\right) \longrightarrow N_{f} \longrightarrow 0 \tag{1.3.3}
\end{equation*}
$$

where $C=L_{P}\left(\pi_{n}\right)$. Applying the functor $H^{0}$ to (1.3.3) and using that:

$$
\begin{equation*}
H^{i}\left(H_{P}^{0}\left(\pi_{n}\right)\right)=H^{i}\left(\pi_{n}\right)=0 \tag{1.3.4}
\end{equation*}
$$

for all $i \geq 0$, one obtains $H^{0}(C)=0$ and isomorphisms $H^{i}(C) \simeq H^{i-1}\left(N_{f}\right)$ for all $i \geq 1$. Taking this and Proposition 1.2.2 into account and applying the functor $H^{0}$ to (1.3.2), one obtains isomorphisms:

$$
\begin{equation*}
H^{d-1}\left(\mu_{n}\right) \simeq H^{0}(M) \simeq H^{0}\left(N_{f}\right) \tag{1.3.5}
\end{equation*}
$$

an exact sequence:

$$
\begin{equation*}
0 \longrightarrow H^{1}\left(N_{f}\right) \longrightarrow H^{d}\left(\mu_{n}\right) \longrightarrow H^{0}\left(N_{f}\right) \longrightarrow H^{2}\left(N_{f}\right) \longrightarrow 0 \tag{1.3.6}
\end{equation*}
$$

and isomorphisms

$$
\begin{equation*}
H^{i}\left(N_{f}\right) \simeq H^{i+1}(C) \simeq H^{i+2}\left(N_{f}\right) \tag{1.3.7}
\end{equation*}
$$

for $i \geq 1$. Since $H^{i}\left(N_{f}\right)=0$ for $i>\left|R^{+}\right|$, one obtains $H^{i}\left(N_{f}\right)=0$ for all $i \geq 1$. Together with (1.3.6) and (1.3.5), this gives isomorphisms:

$$
\begin{equation*}
H^{d}\left(\mu_{n}\right) \simeq H^{0}\left(N_{f}\right) \simeq H^{d-1}\left(\mu_{n}\right) \tag{1.3.8}
\end{equation*}
$$

On the other hand, by [Liu19b], Cor. $4, \lambda_{f}$ has multiplicity 1 in $H^{d}\left(\mu_{n}\right)$, which is therefore non-zero. Thus $H^{d}\left(\mu_{n}\right) \simeq H^{d-1}\left(\mu_{n}\right) \simeq H^{0}\left(N_{f}\right)$ is a non-zero submodule of $H^{0}\left(H_{P}^{0}\left(\lambda_{f}\right)\right)=H^{0}\left(\lambda_{f}\right)$.

Now, using the automorphism $\tau$ of $(G, T)$, one obtains that $H^{d}\left(\mu_{n}\right) \simeq$ $H^{d-1}\left(\tau \mu_{n}\right)^{*}$ is a quotient of $H^{0}\left(\tau \lambda_{f}\right)^{*} \simeq V\left(\lambda_{f}\right)$. Since any non-zero morphism $V\left(\lambda_{f}\right) \rightarrow H^{0}\left(\lambda_{f}\right)$ has image $L_{f}$ (see [Jan03] II.6.16 Remark), then (1.3.8) gives that $H^{d}\left(\mu_{n}\right) \simeq L_{f} \simeq H^{d-1}\left(\mu_{n}\right)$.

Remark 1.3.3. ${ }^{1}$ Seitz has shown ([Sei87], Prop. 6.1) that if a simple $\mathrm{SL}_{d+1^{-}}$ module $L(\mu)$ with $\mu$ p-restricted has one-dimensional weight spaces then either $\mu$ is a fundamental weight $\omega_{i}$ or a multiple of $\omega_{1}$ or $\omega_{d}$, or $\mu=$ $a \omega_{i}+(p-1-a) \omega_{i+1}$ for some $i \in\{1, \ldots, d-1\}$ and $a \in\{0, \ldots, p-1\}$. Since $\lambda_{f}$ is not in that list when $f>0$, it follows that $H^{d}\left(\mu_{p+f}\right) \simeq L\left(\lambda_{f}\right)$ never has all its weight spaces of dimension 1 when $f>0$. This improves on Remark 3 (2) of [Liu19b].
1.4. Jantzen sum formula and consequences. Now, consider the case $f=0$, i.e. $n=p$. Then $\lambda_{0}=(p-2) \omega_{2}+\omega_{3}$. We shall use Jantzen sum formula ([Jan03], II.8.19) to express ch $L_{0}$ in terms of Weyl characters. Set $r=\min (d, p)$. In addition to $\lambda_{0}$, define for $i=1, \ldots, r-2$ the dominant weights: ${ }^{2}$

\begin{equation*}
\lambda_{i}=i \omega_{1}+(p-2-i) \omega_{2}+\omega_{3+i} \tag{1.4.1}
\end{equation*}
$$

(with the convention $\omega_{d+1}=0$ ) and set $L_{i}=L\left(\lambda_{i}\right)$ and $N_{i}=L_{P}\left(\lambda_{i}\right)$. In other words, if $d>p$ the sequence ends with $\lambda_{p-2}=(p-2) \omega_{1}+\omega_{p+1}$ whilst if $d \leq p$ it ends with

$$
\lambda_{d-2}=(d-2) \omega_{1}+(p-d) \omega_{2}+\omega_{d+1}=(d-2) \omega_{1}+(p-d) \omega_{2}
$$

Lemma 1.4.1. Consider $\mathrm{SL}_{n+1}$ for some $n \geq 2$ and for $k=1, \ldots, n$ consider the weight $\theta_{k}=\omega_{1}-k \omega_{k}+(k-1) \omega_{k+1}$. Note that $\theta_{1}=0$.
(i) For $k \geq 2$, one has $s_{k} \cdot \theta_{k}=\theta_{k-1}$.
(ii) For $k \geq 2$, one has $\omega_{1}-k \omega_{k}+k \omega_{k+1}=s_{k} \cdots s_{2} \cdot \omega_{k+1}$.

Proof. One has $s_{k} \cdot \theta_{k}=\theta_{k}+(k-1) \alpha_{k}=\theta_{k-1}$. Thus $s_{2} \cdots s_{k} \cdot \theta_{k}=\theta_{1}=0$, whence $\theta_{k}=s_{k} \cdots s_{2} \cdot 0$. Next, for any weight $\lambda$ and $w \in W$, one has $w \cdot \lambda=w \lambda+w \cdot 0$, which equals $\lambda+w \cdot 0$ if $w \lambda=\lambda$. Applying this to $w=s_{k} \cdots s_{2}$ and $\lambda=\omega_{k+1}$ gives assertion (ii).

For $\alpha \in R^{+}$let $\alpha^{\vee}$ be the corresponding coroot. Then, for $m \in \mathbb{Z}$, let $s_{\alpha, m p}$ be the affine reflection defined for all $\lambda \in X(T)$ by $s_{m, \alpha}(\lambda)=$ $\lambda-\left(\left(\lambda, \alpha^{\vee}\right)-m\right) \alpha$. Further, one sets $s_{\alpha, m} \cdot \lambda=s_{m, \alpha}(\lambda+\rho)-\rho$.

For each Weyl module $V(\lambda)$, Jantzen has defined a decreasing filtration $V(\lambda) \supset V(\lambda)_{1} \supset V(\lambda)_{2} \supset \cdots$ and one has the following character formula ([Jan03], II.8.19):

\sum_{i \geq 1} \operatorname{ch} V(\lambda)_{i}=\sum_{\alpha \in R^{+}} \sum_{\substack{m \\ 0<m p<\left(\lambda+\rho, \alpha^{\vee}\right)}} v_{p}(m) \chi\left(s_{\alpha, m p} \cdot \lambda\right)
$$

where $v_{p}$ denotes the $p$-adic valuation and $\chi$ is the Weyl character. Recall that $\chi(\mu)=0$ if $\mu$ is singular for the dot action of $W$, i.e. if there exists $\alpha \in R^{+}$such that $\left(\mu+\rho, \alpha^{\vee}\right)=0$, and otherwise there exists a unique couple $\left(w, \mu^{+}\right) \in W \times X(T)^{+}$such that $\mu=w \cdot \mu^{+}$and then $\chi(\mu)=$ $(-1)^{\ell(w)} \operatorname{ch} V\left(\mu^{+}\right)$. In particular, if the right-hand side, to which we shall refer as "Jantzen's sum" (relative to $\lambda$ ), equals ch $L$ for some simple module $L$ (resp. equals 0 ), then one has $\operatorname{ch} V(\lambda)=\operatorname{ch} L(\lambda)+\operatorname{ch} L($ resp. $V(\lambda)=L(\lambda))$.

[^0]Proposition 1.4.2. For $i=0, \ldots, r-2$ one has the equality:

$$
\begin{equation*}
\sum_{\ell \geq 1} \operatorname{ch} V\left(\lambda_{i}\right)_{\ell}=\sum_{j=i+1}^{r-2}(-1)^{j-i-1} \operatorname{ch} V\left(\lambda_{j}\right) \tag{1.4.2}
\end{equation*}
$$

and the exact sequences:

$$
\begin{equation*}
0 \longrightarrow L_{i} \longrightarrow H^{0}\left(\lambda_{i}\right) \longrightarrow L_{i+1} \longrightarrow 0 \tag{1.4.3}
\end{equation*}
$$

and

$$
\begin{equation*}
0 \longrightarrow N_{i} \longrightarrow H_{P}^{0}\left(\lambda_{i}\right) \longrightarrow N_{i+1} \longrightarrow 0 \tag{1.4.4}
\end{equation*}
$$

with the convention $L_{r-1}=0=N_{r-1}$. Therefore, one has exact sequences:

$$
\begin{equation*}
0 \rightarrow L\left(\lambda_{0}\right) \rightarrow H^{0}\left(\lambda_{0}\right) \rightarrow H^{0}\left(\lambda_{1}\right) \rightarrow \cdots \rightarrow H^{0}\left(\lambda_{r-2}\right) \rightarrow 0 \tag{1.4.5}
\end{equation*}
$$

and

$$
\begin{equation*}
0 \rightarrow L_{P}\left(\lambda_{0}\right) \rightarrow H_{P}^{0}\left(\lambda_{0}\right) \rightarrow H_{P}^{0}\left(\lambda_{1}\right) \rightarrow \cdots \rightarrow H_{P}^{0}\left(\lambda_{r-2}\right) \rightarrow 0 \tag{1.4.6}
\end{equation*}
$$

Proof. Fix $i \in\{0, \ldots, r-2\}$ and for $1 \leq j \leq k \leq d$, set $\alpha_{j, k}=\alpha_{j}+\cdots+\alpha_{k}$ and $c_{i, j, k}=\left(\lambda_{i}+\rho, \alpha_{j, k}^{\vee}\right)$. We are going to prove that all terms in Jantzen's sum (for both $G$ and $P$ ) are zero, except the ones given in (1.4.2). Fix $j \leq k$ such that $c_{i, j, k}>p$, let $m \in \mathbb{N}^{*}$ such that $m p<c_{i, j, k}$ and set $t=c_{i, j, k}-m p$ and $\nu_{m}=s_{\alpha_{j, k}, m p} \cdot \lambda_{i}=\lambda_{i}-t \alpha_{j, k}$. There are four cases to consider.

Case 1: $c_{i, j, k}=k-j+1$ (this occurs only $j>i+3$ and $k \geq j+p$ ). Then the expression of $\nu_{m}$ in terms of the fundamental weights contains the "sequence" $-t \omega_{j}-t \omega_{k}$, the coefficients of the $\omega_{\ell}$ for $j<\ell<k$ being 0 , and hence $\nu_{m}+\rho$ is orthogonal to both $\alpha_{j, j+t-1}^{\vee}$ and $\alpha_{k-t+1, k}^{\vee}$. Therefore $\nu_{m}$ gives no contribution to Jantzen's sum, neither for $G$ nor for $P$.

Case 2: $c_{i, j, k}=k-j+2$ (this occurs only if $j \leq i+3 \leq k$, including the case $k=i+3, j=2$ and $i=p-2)$. Assume first that $j<i+3<k$. Then the expression of $\nu_{m}$ in terms of the fundamental weights contains the "sequence" $-t \omega_{j}+\omega_{i+3}-t \omega_{k}$, the coefficients of the $\omega_{\ell}$ for $j<\ell<k$ and $\ell \neq i+3$ being 0 .
For $s=0, \ldots, i+2-j, i+3-j, \ldots, k-j-1,\left(\nu_{m}+\rho, \alpha_{j, j+s}^{\vee}\right)$ takes all the values from $1-t$ to $k-j+1-t$, except $i-j+4-t$. Since $1-t \leq 0$ and $k-j+1-t>0$ (since $t \leq k-j+2-p \leq k-j$ ), the value 0 is obtained unless $t=i-j+4$.
Similarly, for $s=0, \ldots, k-i-4, k-i-3, \ldots, k-j-1,\left(\nu_{m}+\rho, \alpha_{k-s, k}^{\vee}\right)$ takes all the values from $1-t$ to $k-j+1-t$, except $k-i-2-t$. Hence the value 0 is obtained, unless $t=k-i-2$. This shows that $\nu_{m}+\rho$ is singular, except possibly if $t=i-j+4=k-i-2$. But in this case one has $2 t=k-j+2$ and hence:

$$
\left(\nu_{m}+\rho, \alpha_{j, k}^{\vee}\right)=k-j+2(1-t)=0 .
$$

Consider now the "boundary" cases $j=i+3$ or $k=i+3$. If $j=i+3$ then, since $k-t+1>j$, one has $k-t+1>i+3$ and hence $\left(\nu_{m}+\rho, \alpha_{k-t+1, k}^{\vee}\right)=0$. If $k=i+3$, then $j+t-1<k=i+3$ and hence $\left(\nu_{m}+\rho, \alpha_{j, j+t-1}^{\vee}\right)=0$. Thus, in any case $\nu_{m}$ gives no contribution to Jantzen's sum, neither for $G$ nor for $P$.

To close this case, note that since $i+3 \leq p+1 \leq k-j+2$, the case $k=i+3$ can occur only if $j \leq 2$, in which case $c_{i, j, k}=k-j+2$ implies $i=p-2$.

Case 3: $j=2$ and $c_{i, j, k}=k+p-2-i$ and $i<p-2$. (Note that $c_{i, 2, i+2}=p-1$ hence the hypothesis $c_{i, 2, k}>p$ implies $k \geq i+3$.) Then one has $\nu_{m}=(i+t) \omega_{1}+(p-2-i-t) \omega_{2}+\omega_{i+3}-t \omega_{k}+t \omega_{k+1}$.

For $s=0, \ldots, i, i+1, \ldots, k-3,\left(\nu_{m}+\rho, \alpha_{2,2+s}^{\vee}\right)$ takes all the values from $p-i-1-t$ to $p+k-i-3-t$, except $p-t$. Since the last value taken is $\geq p-1>0$, the value 0 is obtained except if $t=p$ or if the initial value $p-i-1-t$ is $>0$, i.e. $t \leq p-i-2$.

Similarly, for $s=0, \ldots, k-i-4, k-i-3, \ldots, k-3,\left(\nu_{m}+\rho, \alpha_{k-s, k}^{\vee}\right)$ takes all the values from $1-t$ to $k-1-t$, except $k-i-2-t$. Moreover one has $1-t \leq 0<k-1-t$, hence the value 0 occurs unless $t=k-i-2$.

Thus, $\nu_{m}+\rho$ is singular except possibly if $t=k-i-2$ belongs to $\{1, \ldots, p-i-2\}$ or if $t=k-i-2=p$. In the latter case, one has $2 t=p+k-i-2$ and hence

$$
\left(\nu_{m}+\rho, \alpha_{2, k}^{\vee}\right)=k-2+p-i-2 t=0
$$

In the former case, one has $k=i+2+t$ with $t=1, \ldots, p-i-2$, whence $m=1$. In fact, since $k=i+2+t$ is $\leq d$, we have $t \in\{1, \ldots, r-i-2\}$, recalling that $r=\min (p, d)$. For $t=1, \ldots, r-i-2$, set
$\theta_{t}^{\prime}=s_{\alpha_{2, i+2+t, p}} \cdot \lambda_{i}=(i+t) \omega_{1}+(p-2-i-t) \omega_{2}+\omega_{i+3}-t \omega_{i+2+t}+t \omega_{i+3+t}$.
Using Lemma 1.4.1 with a shift of $i+2$ in the indices, one obtains that $\theta_{1}^{\prime}=\lambda_{i+1}$ and that $\theta_{t}^{\prime}=s_{i+2+t} \cdots s_{i+4} \cdot \lambda_{i+t}$ for $t \geq 2$.

Denote by $G_{P}$ the Levi subgroup of $P$ containing $T$ and recall ([Jan03], II.5.21) that $V_{P}\left(\lambda_{i}\right)$ is just the corresponding Weyl module for $G_{P}$ on which the unipotent radical of $P$ acts trivially. Therefore, applying Jantzen's sum formula for $G_{P}$, one already obtains the equality:

$$
\begin{equation*}
\sum_{\ell \geq 1} \operatorname{ch} V_{P}\left(\lambda_{i}\right)_{\ell}=\sum_{t=1}^{r-i-2}(-1)^{t-1} \operatorname{ch} V_{P}\left(\lambda_{i+t}\right) \tag{1.4.7}
\end{equation*}
$$

To prove the analogous equality for $G$ we must consider the last case, where $j=1$.

Case 4: $j=1$. Note that the assumption $c_{i, 1, k}>p$ implies $k \geq 3$. If $k \leq i+3$ then $c_{i, 1, k}=p+k-2+\delta_{k, i+3}$ is $\leq 2 p$ (since $i \leq p-2$ ), hence $m=1$ and $t=k-2+\delta_{k, i+3}$ and the expression of $\nu_{m}$ in terms of the fundamental weights contains the "sequence" $(p-i-2) \omega_{2}-(k-2) \omega_{k}$, the coefficients of the $\omega_{\ell}$ for $2<\ell<k$ being 0 . Then $\left(\nu_{m}+\rho, \alpha_{3, k}^{\vee}\right)=0$ hence $\nu_{m}$ gives no contribution to Jantzen's sum.

Suppose now that $k>i+3$. Then $c_{i, 1, k}=k-1+p$ and

$$
\nu_{m}=(i-t) \omega_{1}+(p-2-i) \omega_{2}+\omega_{i+3}-t \omega_{k}+t \omega_{k+1}
$$

For $s=0, \ldots, k-i-4, k-i-3, \ldots, k-3,\left(\nu_{m}+\rho, \alpha_{k-s, k}^{\vee}\right)$ takes all the values from $1-t$ to $k-1-t$, except $k-i-2-t$. Moreover one has $1-t \leq 0 \leq k-1-t$, hence the value 0 occurs unless $t=k-i-2$.

Let us assume henceforth that $t=k-i-2$. Then $t>p$, for otherwise one would have $k-i-2 \leq p$ hence $k \leq 2 p$ (since $i \leq p-2$ ) whence $m \leq 2$;
but $m=1$ gives $k-i-2=t=c_{i, 1, k}-p=k-1$, a contradiction, whereas $m=2$ gives $k-i-2=t=c_{i, 1, k}-2 p=k-p-1$, a contradiction too, since $i \leq p-2$.

Now, for $s=0, \ldots, i, i+1, \ldots, k-3,\left(\nu_{m}+\rho, \alpha_{1,2+s}^{\vee}\right)$ takes all the values from $p-t$ to $p+k-2-t$, except $p+i+1-t$. Moreover since $p<t \leq k-1$, the initial term is $<0$ and the final term $>0$, hence the value 0 occurs unless $t=p+i+1$. Now, if $t=k-i-2=p+i+1$ then $2 t=p+k-1$ and hence

$$
\left(\nu_{m}+\rho, \alpha_{1, k}^{\vee}\right)=p+k-1-2 t=0
$$

Thus, in any case $\nu_{m}$ gives no contribution to Jantzen's sum. This proves (1.4.2).

It follows from (1.4.2) that $H^{0}\left(\lambda_{r-2}\right)=L_{r-2}$; then for $\lambda_{r-3}$ the Jantzen sum equals ch $L_{r-2}$ hence $\operatorname{ch} H^{0}\left(\lambda_{r-3}\right)=\operatorname{ch} L_{r-3}+\operatorname{ch} L_{r-2}$. By decreasing induction one obtains that $\operatorname{ch} H^{0}\left(\lambda_{i}\right)=\operatorname{ch} L_{i}+\operatorname{ch} L_{i+1}$ for $i=r-3, \ldots, 0$, whence the exact sequences (1.4.3). Similarly, using (1.4.7) one obtains that $H_{P}^{0}\left(\lambda_{r-2}\right)=N_{r-2}$ and $\operatorname{ch} H_{P}^{0}\left(\lambda_{i}\right)=\operatorname{ch} N_{i}+\operatorname{ch} N_{i+1}$ for $i=r-3, \ldots, 0$, whence the exact sequences (1.4.4). This completes the proof of Proposition 1.4.2.

Let us derive the following corollary (which is not used in the sequel).
Corollary 1.4.3. For $i=0, \ldots, r-2$, one has $H^{0}\left(N_{i}\right)=L_{i}$ and $H^{j}\left(N_{i}\right)$ $=0$ for $j>0$.
Proof. Applying the functor $H^{0}$ to each exact sequence (1.4.4) gives an exact sequence:

$$
0 \longrightarrow H^{0}\left(N_{i}\right) \longrightarrow H^{0}\left(\lambda_{i}\right) \longrightarrow H^{0}\left(N_{i+1}\right) \longrightarrow H^{1}\left(N_{i}\right) \longrightarrow 0
$$

and isomorphisms $H^{j}\left(N_{i+1}\right) \simeq H^{j+1}\left(N_{i}\right)$ for $j \geq 1$. Since $H^{j}\left(N_{0}\right)=0$ for $j \geq 1$, one obtains $H^{j}\left(N_{i}\right)=0$ for all $i \geq 0$ and $j \geq 1$, hence the previous exact sequence becomes:

$$
\begin{equation*}
0 \longrightarrow H^{0}\left(N_{i}\right) \longrightarrow H^{0}\left(\lambda_{i}\right) \longrightarrow H^{0}\left(N_{i+1}\right) \longrightarrow 0 \tag{1.4.8}
\end{equation*}
$$

Since $H^{0}\left(N_{0}\right) \simeq L_{0}$, the exact sequences (1.4.3) then imply, by induction on $i$, that $H^{0}\left(N_{i}\right) \simeq L_{i}$ for $i=0, \ldots, r-2$.

On the other hand, in [Liu19b], Cor. 3 and 4, the first author proved, using a result of Suprunenko pointed out by one of the referees, that the dominant weights of $L\left(\lambda_{0}\right)$ (resp. of $L\left(\lambda_{0}^{\prime}\right)=L\left((p-2) \omega_{1}+\omega_{2}\right)$ ) are exactly the dominant weights $\leq \lambda_{0}$ (resp. $\lambda_{0}^{\prime}$ ), each occuring with multiplicity one. Let us now switch to representations of $\mathrm{GL}_{d+1}$ and identify each $\lambda_{i}$ (resp. $\left.\lambda_{i}^{\prime}=(p-2-i) \omega_{1}+\omega_{2+i}\right)$ with the partition $\left(p-1, p-1-i, 1^{i+1}\right)$ (resp. ( $p-$ $\left.1-i, 1^{i+1}\right)$ ). Recall that (see for example [McD95], Chap. I) for a dominant weight $\lambda$ of $\mathrm{GL}_{d+1}$, identified with a partition with at most $d+1$ parts, the Weyl character ch $V(\lambda)$ (resp. the orbit sum $\sum_{\nu \in W \lambda} e^{\nu}$ ) corresponds to the Schur function $S_{\lambda}$ (resp. the monomial symmetric function $m_{\lambda}$ ). Let us assume that $d \geq 2 p-2$, then the dominant weights smaller than $\lambda_{0}$ correspond to all partitions of $2 p-1$ which are smaller than $(p-1, p-1,1)$ in the dominance order. Thus, one deduces from Propositions 1.4.2 and 1.3.1 (or Corollary 3 in [Liu19b]) the following:

Corollary 1.4.4. For each prime number $p$, one has the equality:

$$
\sum_{\lambda \leq(p-1, p-1,1)} m_{\lambda}=\sum_{i=0}^{p-2}(-1)^{i} S_{\left(p-1, p-1-i, 1^{i+1}\right)}
$$

and

$$
\sum_{\lambda \leq(p-1,1)} m_{\lambda}=\sum_{i=0}^{p-2}(-1)^{i} S_{\left(p-1-i, 1^{i+1}\right)}
$$

where the sum on the left hand-side of the first equality (resp. second equality) is taken over all partitions $\lambda$ of $2 p-1$ (resp. p) such that $\lambda \leq$ $(p-1, p-1,1)(r e s p . \lambda \leq(p-1,1))$ in the dominance order.
Remark 1.4.5. One may conjecture that the previous equality holds for any integer $n \geq 2$ (not only for prime numbers). Using a Sage program, we have checked this up to $n=23$. ${ }^{3}$
