# **First gas and thermal measurements at the frequently erupting Gamalama volcano (Indonesia) reveal a hydrothermally dominated magmatic system**

# **Highlights**

- 15 Gamalama a frequently erupting volcano but poorly studied
	- A volcanic system dominated by hydrothermal manifestation
	- A remarkable shift of volcanic activity from the crater center to the peripheral fractures zones
	- Fractures have weakened the hydrothermal seal leading to recurrent phreatic eruptions

# 20 **Abstract**

 The first gas and thermal measurements at the summit of the Gamalama volcano indicate that the system is dominated by hydrothermal processes. This is highlighted by the prevalence of H<sub>2</sub>S over SO<sub>2</sub>  $(H<sub>2</sub>S/SO<sub>2</sub> = 2-8)$ , a high  $CO<sub>2</sub>/SO<sub>2</sub>$  ratio (76-201), and a low heat transfer (3.0 MW) to the surface. A relative variation in gas composition is observed along the degassing fracture zone, possibly due to partial S 25 scrubbing. Despite this surface hydrothermal signature, the system exhibits high gas equilibrium temperatures (425-480°C), indicating that fluids are not exclusively derived from a boiling hydrothermal aquifer, but also sourced by cooling and crystallizing basaltic magma at deep that continues to inject magmatic fluids into the system. This hydrothermally dominated activity on Gamalama possibly persisted over the last two decades, during which a high number of eruptive events were witnessed. The period 30 coincides with the opening of large fractures at the summit that subsequently shifted the volcanic activity from the crater center to the peripheral fractures zones. These fractures that possibly developed in response to the regional geodynamics, have weakened the hydrothermal seal, allowing the pressure developed by the hydrothermal-magmatic system and promoted by the high annual rainfall, to rapidly exceeds the tensile strength of the seal leading to the numerous phreatic eruptions.

#### **1. Introduction**

 Gamalama is a stratovolcano with a near-perfect cone-shape having a subaerial diameter of 12 km. Located off the coast of Halmahera island, this 1715 m high volcano is one of the 5 active volcanoes of the

- 40 Halmahera arc (Fig.1). Since 1510, Gamalama has experienced 66 confirmed eruptions, producing dense columns of ash and incandescent material, voluminous lava flows, pyroclastic flows as well as lahars (GVP, 2013). The volcano hosts a city of about 200,000 inhabitants on its southeastern flank (Fig.1) – a perfect illustration of a City on Volcano. In 1988, 3500 inhabitants were evacuated out of the island in response to a strong eruptive event. In 1983 and 2011, thousands of inhabitants were displaced from exposed zones to
- 45 safer areas (GVP, 2013). Due to abundant ash emissions, the Sultan Babullah International airport was regularly forced to close. This was the case on July 18, 2005, on Aug. 3-4, 2017, and on Oct. 4, 2018 (GVP, 2013). About 11% of the eruptive events are classified as moderate-to-large eruptions with VEI 3, whilst 70% are considered as moderate eruptions with VEI 2 (GVP, 2013). A major eruptive event on Gamalama in September 1775, formed the Tolire maar, burying the village of Soela Takomi, and killing 141
- 50 inhabitants (Dasar, 2011, Mei et al., 2016). More recently, in 2011, a lahar event claimed 4 deaths (GVP, 2013), thus a total of 145 direct victims are recorded from Gamalama volcanic activities over the last two and a half centuries.

The particularity on Gamalama volcano, according to the Center of Volcanology and Geological Hazard Mitigation (CVGHM), the institution in charge of the volcano monitoring in Indonesia, is its capacity to

- 55 develop eruptive events with very short precursory signals and only a few volcanic quakes before eruptions (volcano news: www.vsi.esdm.id). Such a character constitutes a huge challenge for Gamalama volcano observatory who is struggling to provide timely warnings to inhabitants. To gain insights into the recent volcanic activity of Gamalama, a field investigation was carried out at the summit on September 21, 2018, during which crater temperature distribution and radiant flux, as well as the chemical composition of the gas
- 60 plume, were characterized for the first time. Here we present the results of this field investigation.

#### **2. Methodology**

 Gas composition on Gamalama was measured using a Multi-component Gas Analyser System 65 (Multi-GAS; Aiuppa et al., 2005; Shinohara, 2005). This portable instrument measures the concentrations of CO2, SO2, H2S, H2, as well as the pressure (P), the temperature (T), and the relative humidity (RH). This latter is converted into plume H2O concentrations using the formula outlined in Buck (1981):

 $H_2O = 6.1121^{*}(1.0007 + 3.46P^{-6})^{*}exp((17.502^{*}T)/249.97 + T)^{*}RH^{*}104^{*}P^{-1}$ . H<sub>2</sub>O is the water vapor content in ppm. P is the pressure in mbar. T is the air temperature in  $\mathrm{^{\circ}C}$ 

70 The CO<sub>2</sub> gas is detected by near dispersive infrared spectroscopy (range 0-3,000 ppm) while SO<sub>2</sub>, H<sub>2</sub>S, H<sub>2</sub> gases were quantified using specific electrochemical sensors models (range 0-200 ppm). Data were processed and analyzed using ratiocalc software (Tamburello, 2015). During field measurements, the Multi-GAS was positioned at 3 different degassing points at the summit of the Gamalama volcano (Fig.3). First,

the instrument was positioned on the rim and recorded a gas that diffused through a fumarolic area of ~500

- $75$   $\,$  m<sup>2</sup>. Then the multiGAS was moved into the plume released by the upper part of the southwest fracture and was placed ~40 m from the main degassing point. Finally, the instrument was positioned less than 5 m above the main degassing point of the southern part of this southwest fracture. The relative humidity of >80% in the morning, during the first of recording at MG1, has dropped to 30% at MG2 and MG3 at around mid-day, whilst the air temperature increased from <20°C to 30°C.
- 80 To characterize temperature distribution and heat flux on the summit of the Gamalama, a PI640 OPTRIS infrared camera was deployed on the crater rim. This miniature infrared camera weighs 320g, including a lens of 62°x49° FOV, f=8 mm, and a dynamic range equivalent to the radiant temperature of -20°C to 900 °C. The detector has 640x480 pixels and the operating waveband is 7.5-13 µm. The maximum frame rate is 80 Hz. The radiant flux (Q<sub>rad</sub> in W) estimation is obtained using the following equation: Q<sub>rad</sub> = Aεσ(T<sub>s</sub><sup>4</sup> – T<sub>a</sub><sup>4</sup>),
- 85 where A is the hot surface (in m<sup>2</sup>),  $ε$  is the emissivity (0.9 for basalt), σ is the Stefan-Boltzmann constant  $(5.67 \times 10^{-8} \text{ W m}^{-2} \text{ K}^{-4})$ , T<sub>s</sub> and T<sub>a</sub> correspond to the hot surface an ambient temperature (in K) respectively. Thermal results are corrected for oblique viewing angle, following the approach detailed in Harris (2013) and the temperature values are corrected for atmospheric influence relying on ACPC models (https://atmcorr.gsfc.nasa.gov/) and validated with closer thermal recording. The radiant flux was calculated
- 90 at 5 different temperature ranges (32-35°C; 36-40°C, 41-45°C, 46-50°C, and >50°C) then summed for the entire zone of interest (Table 1). The values below 32°C were difficult to discriminate from the background and therefore considered as background.

## 95 **3. Result**

 The thermal infrared camera survey on Gamalama indicates that the heat dissipation is relatively confined to the western part of the crater and extends outside the crater along the southwest fracture zone (Fig.2), where the maximum temperature of ~125°C is recorded. The heated surface in the main crater is equivalent to ~4500 m<sup>2</sup>, whilst along the southwest fracture zone, ~310 m<sup>2</sup> of the surface is heated above 100 the background level (Table 1). The total radiant flux calculated for these heated surfaces is 3.0 MW, including 2.7 MW of heat through the crater and 0.3 MW through the southwestern fracture zone. However, this latter value should be considered minimum since the area is the main degassing zone, thus gas may strongly alter the thermal radiation, as seen on Etna by Sawyer and Burton (2006). From visual observation, gas released from the crater was negligible, compared to the more consistent degassing 105 through the southwestern fracture zone.

The Multi-GAS measurement results obtained on Gamalama highlight different gas compositions for the three recording points (Fig.3, Table 2). At MG1, the highest elevation recording position (1698 m), results indicate a strongly diluted gas with  $H_2O$ ,  $CO_2$ ,  $SO_2$ ,  $H_2S$ , and  $H_2$  concentrations of 7000-14000, 450-770, 0.05-0.13, 0.3-0.4, and 2.0-4.0 ppm v respectively. There is no correlation between these gas components,

110 thus no acceptable gas ratio can be obtained at MG1. However, the near absence of  $SO_2$ , and H<sub>2</sub>S (Fig.3)

that contrasts with the relatively high abundance of  $CO<sub>2</sub>$  and H<sub>2</sub> reflects a prevalent gas origin from relatively "cold" crater floor emissions of diffusing gas to the surface. In these diffuse, cold emissions,  $CO<sub>2</sub>$ and  $H_2$  are typically more abundant (and can persist to the surface) because of their lower reactivity (compared to S compounds that are easily scavenged by subsurface reactions with rocks and water) (Rye

- 115 2005, Ohmoto and Rye 1979; Rye 1993; Giggenbach 1997; Symonds et al., 2001). At the recording point MG2, situated ~20 m below MG1, the H<sub>2</sub>O, CO<sub>2</sub>, SO<sub>2</sub>, H<sub>2</sub>S, and H<sub>2</sub> concentrations correspond to 3000-12000, 395-550, 0.2-1.2, 0.4-6.5, and 0.6-4.0 ppm v respectively. There is a notable decrease in H<sub>2</sub>O, CO<sub>2</sub>, and  $H_2$  concentrations from MG1 to MG2, whilst  $SO_2$  and  $H_2S$  show a parallel increase in concentration. The gas is less diluted compared to MG1, thus good correlations are obtained between gas components,
- 120 giving H2O/SO2, CO2/SO2, H2S/SO2, and H2/SO2 ratios of 5895±2979, 201±50, 7.9±0.9, and 1.4±0.9 respectively. At the measurement point MG3, located more than 50 m below MG1, the gas has the lowest concentration of H<sub>2</sub>O (1000-7000 ppm v) and the highest  $SO_2$  content (0.3-1.6 ppm v). The  $CO_2$  (360-490 ppm v),  $H_2S$  (0.1-0.9 ppm v), and  $H_2$  (0.0-3.5 ppm v) concentrations decrease, compare to MG2. The gas to  $SO_2$  ratios at MG3 (Fig.4) correspond to 3169±1144, 76±12, 2.5±0.3 and, 1.2±1.0 for H<sub>2</sub>O/SO<sub>2</sub>, CO<sub>2</sub>/SO<sub>2</sub>,
- 125  $H_2S/SO_2$ , and  $H_2/SO_2$  respectively. Assuming that this less diluted gas at MG3 is the most representative of the magmatic system, given the highest  $SO<sub>2</sub>$  concentrations, then we infer the Gamalama gas as H<sub>2</sub>O-rich (97.5% of the plume content), with other gas components represent 2.3%, 0.03%, 0.08% and 0.04% for CO<sub>2</sub>, SO<sub>2</sub>, H<sub>2</sub>S, and H<sub>2</sub> respectively.

# 130 **4. Discussion**

# **4.1. Combined hydrothermal and magmatic fluids**

Our gas measurements indicate a prevalence of H<sub>2</sub>S over SO<sub>2</sub> with the H<sub>2</sub>S/SO<sub>2</sub> ratio of 2 to 8 (Table 2, Fig.4) suggesting an effective conversion from SO2 to H2S at hydrothermal conditions. Oxidizing (SO2-rich) magmatic gases can be converted into H2S in the reducing hydrothermal envelope by a variety 135 of gas-gas and gas-liquid reactions, such as (Holland, 1965): SO2+4H2O→H2S + 3H2SO4. Besides, upon its ascent, deeply rising volatiles also interact with hydrothermal rock surfaces, during which SO<sub>2</sub> is reduced by FeO in mineral phases, according to Giggenbach (1987):  $SO_{2+}6(FeO) + H_{2}O \rightarrow H_{2}S + 6(FeO_{1.5})$ . The efficiency of the rock buffer in converting the SO<sub>2</sub> into H<sub>2</sub>S is likely to be a function of the intensity and duration of fluid-rock interactions (Giggenbach, 1987). As such, the high H2S/SO2 ratio on Gamalama 140 suggests prolonged fluid-rock interactions, which contrasts with other volcanic systems in Indonesia in which faster rising magmatic fluids through well-defined channels (Gamkonora, Saing et al.,2020) or open vents (Bromo, Aiuppa et al., 2014; Dukono, Bani et al., 2018) have led to low H2S/SO2 ratios. A shallow magma or magmatic dyke emplacement can also induce a low  $H_2S/SO_2$  ratio. The high  $CO_2/SO_2$  ratios of

76-201 obtained on Gamalama are also well above the magma value of 6-9 or 4 obtained on Merapi 145 (Fischer, 2008) and Bromo (Aiuppa et al., 2014) respectively. Such high CO2/SO2 values are common in hydrothermal systems given the lower sensitivity to magmatic gas scrubbing of CO<sub>2</sub> that results from its lower (relative to SO<sub>2</sub>) aqueous solubility and reactivity (Symonds et al., 2001). Gamalama degassing

during the period studied in this work is thus dominated by hydrothermal processes. This is additionally supported by the gas compositions measured at of MG2 and MG3 sites when plotted in the  $CO<sub>2</sub>$ -H<sub>2</sub>O-S<sub>T</sub>

- 150 diagram (Fig.5). The gases plot along the H2O-CO2 axis, within the area of hydrothermal gas composition, comparable to the Papandayan hydrothermal system (Fischer and Chiodini, 2015). Gas from other Indonesian volcanoes, including Bromo (Aiuppa et al., 2015), Sirung (Bani et al., 2017), Dukono (Bani et al., 2018), and Gamkonora (Saing et al., 2020), all plot at S-richer compositions, typical of the magmatic compositional field. Gas composition at MG3, situated about 35 m below MG2, displays relatively lower
- 155 ratios of H2O/SO2, CO2/SO2, H2S/SO2, and H2/SO2 (Table 2, Fig.4). This relative distinct gas compositions between MG2 and MG3 is possibly due to slower fluid ascent to the surface, and consequently more effective S scrubbing (Symonds et al., 2001) at MG2. In contrast, the periodically strong degassing dynamic visible at MG3, compared to continuous degassing at MG2 (Fig.3), indicates an over-pressured gas discharge system, and possibly a deeper source area that enables relatively faster gas ascent to the 160 surface. Note that this MG3 point is situated towards the end of the southwestern fracture, where the gas
- flow path to the surface is likely less defined (Fig.3). This hydrothermal character of Gamalama is coherent with the low heat flux of 3 MW obtained in this work (Table 1) and 5 MW highlighted by MODVOLC on Aug. 4, 2003, outside eruptive periods (http://modis.higp.hawaii.edu/). For comparison, these values are far lower than those measured on other
- 165 volcanoes, including the hydrothermal system of Vulcano Island, where Harris and Maciejewski (2000) obtained 45-67 MW of heat flux. However, during the September 2012 eruption of Gamalama (GVP, 2013), MODVOLC established a heat flux of 44 MW, which thus indicates that thermal energy at the surface of Gamalama is subjected to change with the activity. Indeed Gamalama has experienced strong magmatic activities in the recent past, highlighted by ejections of incandescent juvenile pyroclastic materials in 1980,
- 170 1983, 1990, and 1993 (GVP, 2013), and lava flows in 1983 and 2014 (GVP, 2015). DOAS gas measurements carried out during the July 2015 eruption indicate a strong magmatic degassing with a mean SO<sub>2</sub> flux of 1235 t d<sup>-1</sup> (Table 3). This figure is much higher than the magmatic degassing at Dukono, consider as the strongest and permanent  $SO<sub>2</sub>$  source in Indonesia (820 t  $SO<sub>2</sub>$  d-1; Bani et al., 2018). Unfortunately, we did not have a DOAS at disposal for  $SO<sub>2</sub>$  flux measurements in 2018. However the
- 175 degassing, although consistent, produced a relatively small-scale plume, comparable in size to the plume of the nearby Gamkonora volcano (Saing et al., 2020). It is thus likely that the 2018 manifestations on Gamalama, as observed in this work, were possibly sustained by a progressively cooling stored magma. The gas equilibrium temperatures, obtained by resolving together the  $SO_2/H_2S$  vs. H<sub>2</sub>/H<sub>2</sub>O redox equilibria
- (Giggenbach, 1987; Aiuppa et al., 2011; Moussallam et al., 2017), corresponds to 425-480°C, much higher 180 than the maximum temperature observed with the infrared camera (Fig.2, Table 1). Such high equilibrium temperatures likely reflect quenched equilibrium conditions, reached below the surface as hot fluid ascends
- through, and interact with, the surrounding rocks. Assuming that the above equilibrium gas temperatures are representative of the system, we then infer that the gas released at Gamalama may not exclusively be derived from boiling hydrothermal aquifers, whose temperatures are generally below 300°C (Giggenbach,

185 1980; Chiodini and Marini, 1998). Instead, we propose that the emitted gas is sourced by combined contributions from a magmatic cooling dike and hydrothermal processes within a cooling edifice. This partial but detectable magmatic gas contribution is supported by the low but detectable  $SO<sub>2</sub>$  in the plume that is inconsistent with an exclusive hydrothermal origin. Contrasting the gas temperatures against the  $CO_2/S_T$  ratios of 22-23 (where  $S_T$  corresponds to  $SO_2 + H_2S$ ), the Gamalama gas plots in the "mixed" gas 190 field (Fig.5; Aiuppa et al, 2017), confirming a contribution from the magma, similar to Papanayan (Fischer and Chiodini, 2015).

Bulk compositions of the fresh rock sampled in 2018 (this work) and analyzed using ICP AES at the LMV (Laboratoire Magmas et Volcan) indicates that Gamalama is sustained by a basaltic magma (Fig.6). The 1907 lava flow and the ejected material of the 1990 eruption are also issued from a basaltic magma 195 (Mawardi et al., 1991).

## **4.2. Fractures and phreatic events**

- On October 4, 2018, 23 days after our field campaign at the summit, Gamalama underwent an eruptive event with no precursory signals (GVP, 2018). Such a sudden and short-lived eruptive events are 200 typical of phreatic eruptions (Stix and de Moor, 2018). The event lasted 3 days and released 30 t  $d^1$  of SO<sub>2</sub> (GVP, 2018), much lower than the 1235 t  $d<sup>-1</sup>$  of the 2015 eruption (Table 3), in accord with the phreatic nature of the event. Since 1510, Gamalama has experienced two phases of elevated activity, as marked by an increased eruptive frequency (Fig.7). A first increase was reported in the mid-19th-Century but, being concomitant with the establishment of the Dutch colony, it's statistical significance is unclear as it may 205 merely reflect improved observation and reporting (Dasar, 2011). The second phase of heightened activity commenced in 2003, with 9 reported (7 confirmed) eruptions. Six out of the 9 eruptions (in 2007, 2008, 2012, 2014, 2016, 2018) displayed a phreatic signature with low intensity (VEI 1) and short duration (1-7 days) (GVP, 2013), whilst 3 other eruptions (in 2003, 2011 and 2015) were of relatively higher intensity (VEI 2) and lasted between 18 and >60 days (GVP, 2013) suggesting a possible involvement of magma
- 210 inputs. These hydrothermal and magmatic behavior of Gamalama over the last 17 years contrasted with the systematic magmatic manifestations observed between the first detailed eruptive report in 1980 and 2003 (GVP, 2003). Note however that there is no detailed study on the recent eruptive products, thus the so-called phreatic events could as well be phreatomagmatic (Miyagi et al., 2020) but this is yet to be validated. There has been no significant magma source evolution at Gamalama between 1907, 1990, and
- 215 2018, as highlighted by relatively uniform rock chemistry (Fig.6), which suggests no significant change in magma supply. Degassing of mafic magma at depth may supply the required magmatic volatiles to sustain the surface fumarolic activity and the recurrent eruptions, similar to Aso and Ontake volcanoes (Stix and de Moor, 2018). When magmatic fluid is injected into the hydrothermal system, it condenses and vaporizes the liquid hydrothermal water. Such a process that occurs at high temperatures may induce host rock alteration
- 220 and formation of sulfur precipitates (Christenson et al., 2010), ultimately leading to the development of a hydrothermal seal (Fig.8, Stix and de Moor, 2018). This latter may play a direct role in driving the

explosivity of phreatic eruptions. When the seal is in place, overpressure can be achieved as driven by the accumulation of ascending mixed hydrothermal-magmatic fluids, finally driving the volcano to erupt in a phreatic or phreatomagmatic event. On Gamalama, this hydrothermal seal has possibly been (at least

- 225 partially) disrupted by the large fractures, formed at the summit between 2002 and 2011, according to the series of cloud-free satellite pictures available from google earth (Fig.7). Indeed, the summit morphology of Gamalama has evolved from a well circular central crater in 2002 to a fractured crater in its present state. The main active zone has subsequently shifted from the central to the peripheral fracture zones over the same period (Fig.7). This morphology evolution coincides with the increase of eruptive events, supporting
- 230 the hypothesis of hydrothermal seal disruption. Hence, pressure build-up within the Gamalama hydrothermal system, caused by rising magmatic gases and by infiltrating meteoric water (the annual rainfall is >2000 mm), may rapidly exceed the tensile strength of the weakened, partially disrupted seal, leading to an increased number of phreatic events (Houghton et al., 2015). Periodically, overpressure development in the deep magma storage zone leads to intermittent magmatic eruptions (Stix and de Moor, 235 2018).
- It is still unclear how the summit fractures are formed, however, these are common by-products of volcanic activity (Lanzafame et al., 2003). They are generally made up of extensional fractures and normal faults, associated with dike emplacements (Rubin and Pollard, 1998; Opheim and Gudmundsson, 1989; Mastin and Pollard, 1988; Peacock and Parfitt, 2002; Lanzafame et al., 2003). The 2003 eruptive event on
- 240 Gamalama which lasted for more than 2 months with a series of strong explosions, ashy columns up to 2 km, and reported pyroclastic flow, may have been associated with the fracture formation. When considering the faultlines of the entire Gamalama edifice (Fig.9), one can notice that the summit southwest fracture that constitutes the main degassing zone, is associated with the NNE-SSW faults that extend over the entire volcano. Similarly, the large lava flow of 1907 was originated from a NNE-SSW fault. It is thus likely that
- 245 these NNE-SSW faults constitute the surface manifestation of a larger fault that intersects the Gamalama volcano and subsequently facilitate shallow dyke emplacement. Such a fault direction can be associated with the eastward thrusting of the North Maluku region in response to the convergence within the Molucca Sea (Hamilton, 1979; Cardwell et al., 1980; Hinschberger et al., 2005; Passarelli et al., 2018). This latter geodynamic context triggers more than 150 seismic events (M≥4) per year within the 200 km radius 250 around Gamalama (https://earthquake.usgs.gov/), with possible influence on Gamalama activity (Sinaga et
- al., 2017).

#### **5. Conclusion**

 The gas composition obtained at the summit of the Gamalama volcano indicates a prevalent 255 hydrothermal origin, as highlighted by the prevalence of H<sub>2</sub>S over SO<sub>2</sub> (H<sub>2</sub>S/SO<sub>2</sub> = 2-8) and a high CO<sub>2</sub>/SO<sub>2</sub> ratio of 76-201. A relative variation in gas composition at different measurement points is observed, due to spatial heterogeneities in the extent of S scrubbing along the degassing fracture zone. The heat transferred to the surface by the system corresponds to only 3.0 MW, in accord with the dominance of hydrothermal

processes. However, the high gas equilibrium temperature of 425-480°C, and the presence of low but 260 measurable SO2, indicate that ascending fluids are not exclusively derived from a boiling hydrothermal aquifer, but rather require a continuous fluids supply from the basaltic magma to the system. Surface degassing activity on Gamalama has persisted for nearly two decades, a period during which an elevated number of eruptions were witnessed on the volcano. We propose that the large summit fractures, developed since 2002, possibly in response to the regional geodynamics may have weakened the 265 hydrothermal seal, ultimately allowing the pressure build-up in the hydrothermal system, promoted by ascending magmatic gases and by the high annual rainfall, to more easily (and rapidly) exceed the tensile strength of the seal, leading to frequent phreatic eruptions.

- **Figure 1.** Gamalama is one of the active volcanoes of Indonesia, highlighted by the red dots (A). It is one of the five active volcanoes of the Halmahera arc, including Dukono, Ibu, Gamkonora and Makian (B). Situated of the coast of Halmahera island (C), Gamalama is a 12 km width volcano off the coast of Halmahera island. The volcano hosts a large city of Ternate with its ~200,000 inhabitants (D). The summit cone of Gamalama is ~1 km in diameter and culminates at 1715 m (E)
- **Figure 2.** Heat distribution at the summit of Gamalama volcano (A) is highlighted by the by thermal mosaic pictures. The heated surface is confined to the western part of the crater (B). The position of the IR camera is provided with the viewing direction to the north at IR\_pt1 and to the south at IR\_pt2 (C). The 385 bottom picture (C) shows the southern fracture zone. The associated thermal image imphasize the gas influence on the thermal radiation. The temperature near the degassing vents fluctuated around 100°C whilst the thermal image show a relatively cold fracture zone.
- **Figure 3.** (A) Variation of gas concentrations obtained at 3 different points (MG1, MG2, and MG3) at 390 Gamalama summit (B). The first increase occurred in the mid-19th-Century in concomitant with the establishment of the Dutch colony may merely reflect improved observation and reporting. The second and most recent increase coincides with the fracture formation between 2002 and 2019, in which red bars correspond to magmatic event whilst yellow bars emphasize the phreatic events. (B) The main active zone has shifted over the same period, from the central unique active vent to the peripheral fractured active zones. The charts are made based on available satellite pictures in Google Earth.
- **Figure 8.** The magmatic fluid injected into the hydrothermal system may lead to rock alteration and sulfur precipitates, leading to the formation of a hydrothermal seal that subsequently controls the eruptive activity on Gamalama. - **Figure 9.** Faultlines on Gamalama volcano, highlighted by google relief map, clearly emphasize that the summit southwest fracture zone (small red line) that constitutes the main degassing zone, is associated with large NNE-SSW faults.
