Impact of chronic exposure of rainbow trout, *Oncorhynchus mykiss*, to low doses of glyphosate or glyphosate-based herbicides

Abstract

Glyphosate is an herbicidal active substance (AS) entering in the composition of a large di-8 versity of pesticide products (glyphosate-based herbicides; GBH) used in modern intensive 9 agriculture. This compound has a favorable environmental safety profile but was suspected 10 to induce deleterious effects in aquatic organisms, with a potential effect of some associ-11 ated co-formulants. This study aimed to assess the impact of direct and chronic exposure 12 to glyphosate on the health status of rainbow trout, Oncorhynchus mykiss. A total of 36 13 genitors were exposed daily for 10 months to a dose of glyphosate representative of envi-14 ronmental concentrations (around $1 \ \mu g \ L^{-1}$) using the AS alone or two GBHs formulations 15 (i.e. Roundup Innovert[®] and Viaglif Jardin[®]) and findings were compared to an unexposed 16 control group (n = 12). The effects of chemical exposure on the reproductive capacities, 17 hemato-immunologic functions, energetic metabolism, oxidative stress and specific biomark-18 ers of exposure were analyzed over a period of 4 months covering spawning. A limited 19 mortality between 15 and 30% specific to the spawning occurred under all conditions. No 20 differences were observed in reproduction parameters i.e. mean weights, relative fertility and 21 fecundity. Red blood cell count, hematocrit index, mean corpuscular volume and white 22 blood cell counts were similar for all the sampling dates. Significant changes were observed 23 two months before spawning with a 70% decrease of the proportion of macrophages in trout 24 exposed to Viaglif only and a reduction of 35% of the phagocytic activity in fish exposed to 25 the two GBHs. Trends towards lower levels of expression of tumor necrosis factor- α (between 26 38 and 66%) were detected one month after the spawning for all contaminated conditions 27 but without being statistically significant. Biomarkers of exposure, i.e. acetylcholine esterase 28 and carbonic anhydrase activities, were not impacted and none of the chemical contaminants 29 disturbed the oxidative stress or metabolism parameters measured. These results suggest 30 that a 10 months exposure of rainbow trout to a concentration of $1 \ \mu g \ L^{-1}$ of glyphosate ad-31 ministered using the pure active substance or two GBHs did not significantly modify their 32 global health including during the spawning period. The immunological disturbances ob-33 served will need to be further explored because they could have a major impact in response 34 to infectious stress. 35

1. Introduction

In the context of rapid human population growth, a major challenge for agriculture is 9 to meet food production demand by using sustainable practices that protect both human 10 health and the environment [80]. Modern intensive agriculture is economically highly de-11 pendent on the use of agrochemical products [83]. Among the broad range of substances 12 available on the market, glyphosate is one of the most widely used herbicide compounds in 13 the world. Its massive use, enhanced by the development of genetically modified glyphosate-14 resistant crops [79, 82], has resulted in high prevalence of the compound in the environment. 15 Glyphosate is found in different environmental compartments, including surface water. Al-16 though higher concentrations are detected in countries where farming of glyphosate-resistant 17 crops is authorized (e.g. levels from 2 to $430 \,\mu g \, L^{-1}$ in United states in stream and river wa-18 ter), glyphosate is present in water sources in Europe where levels above regulatory limits 19 have been observed [86]. In France, between 2007 and 2017, glyphosate and aminomethyl 20 phosphonic acid (AMPA, the first metabolite of its degradation pathway) have been de-21 tected in 43.1 to 74.4% of environmental samples with mean maximal annual concentrations 22 ranging from 2.4 to 70.2 μ g L⁻¹ and 8.4 to 67.8 μ g L⁻¹, respectively [2]. The ubiquity of this 23 herbicide compound has raised particular concern for its effects on human health and the 24 environment. 25

The physico-chemical properties of glyphosate associated with its specific action on 5-26 enolpyruvoylshikimate 3-phosphate synthase, an enzyme present exclusively in plants and 27 some micro-organisms, suggest a favorable environmental safety profile [30]. In a report 28 of the European Food Safety Authority (EFSA) [25], half maximal effective concentration 29 (EC50) of 38 and 306 mg L^{-1} where reported for rainbow trout (RT) exposed to glyphosate 30 and a commercial formulation, respectively, considering mortality during an exposure of 31 96 h. Reported value of chronic toxicity, for RT exposed during 85 days to glyphosate, 32 was a no observed effect concentration (NOEC), based on growth, of $9.6 \,\mathrm{mg}\,\mathrm{L}^{-1}$ [25]. As a 33

result, EFSA has classified the impact of glyphosate on aquatic organisms as "limited" [25]. 1 However, the number of studies reporting deleterious effects of this herbicide on aquatic 2 organisms has increased, and a strong need to focus on environmentally relevant chronic low 3 dose exposures have been pointed out (reviewed by Annett et al. [3]). In addition, there has 4 been considerable debate in the context of the re-registration of glyphosate in the European 5 Union (EU) concerning the potential toxic effects of the active substance (AS), but also of the 6 co-formulants integrated into finished products called glyphosate-based herbicides (GBHs) 7 to increase efficacy. Some co-formulants have already been shown to be more toxic than the 8 AS and synergistic interactions among the different chemicals present in formulations may 9 occur [3, 79]. 10

Pesticides can act at different levels of biological organization [61]. At the molecular level, 11 inhibition of carbonic anhydrase (CA), a key respiration enzyme involved in blood transport 12 of CO_2 , has been demonstrated to be a target of chemical contaminants ([10, 39, 53, 78]; 13 reviewed by Lionetto et al. [44]). Sulukan et al. [78] showed that inhibition of this enzyme 14 could be associated with respiratory acidosis in zebrafish (Danio rerio) larvae exposed to a 15 GBH with a concentration of glyphosate comprised between 1 to $100 \,\mathrm{mg}\,\mathrm{L}^{-1}$, resulting in 16 adverse effects such as apoptosis and malformations during development. Pure glyphosate 17 has a capacity to inhibit acetylcholine esterase (AChE) activity in vitro, however only at 18 relatively high concentrations [21]. Glyphosate, associated or not to co-formulant, have been 19 shown to inhibit fish AChE at concentration ranging from 0.2 to 20 mg L^{-1} for GBH [9, 56, 31, 20 33] and from 1 to 30 mg L^{-1} for AS [54]. Muscle hyperactivity induced by AChE inhibition 21 could generate oxidative radicals inducing oxidative damage such as lipid peroxidation [9, 56]. 22 Oxidative stress is known to be activated by environmental contaminants such as pesticides, 23 through direct and indirect mechanisms [48]. Furthermore, several studies have pointed out 24 that the toxic mode of action of glyphosate alone or GBHs in non-targeted species might be 25 directly or indirectly associated with the generation of oxidative stress [47, 61, 9, 78]. 26

These types of changes in the equilibrium of cellular physiology could have adverse effects 27 at higher levels of biological organization. In particular, energetic metabolism plays a key 28 role in the tolerance of an organism to environmental stressors [76]. Several studies indicate 29 that glyphosate AS and/or GBHs could impact the metabolism of fish [43, 77, 74, 51, 65, 30 31, 85, 33]. Particularly, Topal et al. [81] observed a reduction of swimming performance 31 possibly due to the dysregulation of energy metabolism in rainbow trout exposed short or 32 long term to a GBH at concentrations of glyphosate comprised between 2.5 to $10 \,\mathrm{mg}\,\mathrm{L}^{-1}$. 33 Disruptions of energy production and key metabolic pathways could result in a trade-off in 34 the allocation of energy used for fitness dependent functions such as growth, survival, and 35 reproduction [76]. Therefore, the impact of glyphosate on reproduction, using fecundity and 36 fertility indices, is of particular interest. More specific processes, such as the steroidogenic 37 biosynthesis pathway, can also be altered as suggested for zebrafish [84]. 38

Innate and acquired immunity play a crucial role in the survival of individuals facing infectious diseases. Several hematologic and immunologic blood parameters were shown to be altered [49, 50, 41] in fish exposed to glyphosate, potentially resulting in higher susceptibility to bacterial infections [42], but the immunotoxicity potential of this AS is still poorly defined.

The present study investigated the impact of a chronic exposure to environmentally 43

relevant low doses of glyphosate on the overall health of genitors of rainbow trout O. mykiss, 1 a species particularly sensitive to several aquatic contaminants and commonly produced in 2 Europe for food consumption [23, 60]. Toxicity of the AS was compared to that of two GBHs 3 (Roundup Innovert[®] and Viaglif Jardin[®]) across different levels of organization including 4 reproduction, immunity, and antioxidant defense systems. 5

2. Materials and methods

2.1. Ethics Statement

All animal studies were carried out in strict accordance with the European guidelines and recommendations on animal experimentation and welfare (European Union Directive 2010/ 9 63). All animal experimental procedures were approved by the ethics committee on animal 10 experimentation ANSES/ENVA/UPC No. 16 and were authorized by the French Ministry 11 of Research, under the number APAFIS#2017090117104091. Blood sampling and stripping 12 were done on fish anesthetized with 2% eugenol (4-allyl-2-methoxyphenol). Euthanasia 13 involved addition of a lethal dose of 100 ppm of Eugenol into tank water. Compassionate 14 euthanasia was planned for animals showing lesions (damaged fins, wounds) or abnormal 15 behavior during the experiment. 16

2.2. Fish maintenance

Forty-eight specific pathogen free (SPF) rainbow trout including a mixture of three-18 year-old males and females from the protected and monitored fish facilities of the ANSES Plouzané Laboratory site (France) were used. Fish were placed in four 400 L tanks. All 20 tanks have been grouped in the same room and maintained identically to limit inter-tank 21 variability as much as possible. Fish were maintained under continuous flow-through condi-22 tions $(300 \,\mathrm{L}\,\mathrm{h}^{-1})$ and oxygen levels were maintained above 60% of saturation with aeration. 23 Fish were fed daily with appropriate food at 1.5% of the biomass. Fish were submitted to 24 the natural photoperiod occurring in Brest (France) throughout the time of the experiment 25 and a temperature increasing from 9 to 21 °C between April and July and decreasing from 26 21 to 8 °C between July and November. 27

2.3. Chemical exposure

Four conditions of contamination were tested, each including 12 RT (proportion of 1 29 male for 2 females): control (C; non-exposed RT), glyphosate (G; Sigma-Aldrich, ref. 45521, 30 CAS Number 1071-83-6), Roundup Innovert[®] (R; Agrilisa - for professional use) and Viaglif 31 Jardin[®] (V; Agrilisa - for home gardens). G had a purity of 98%, while the concentration of 32 R and V were 360 and $420 \,\mathrm{g}\,\mathrm{L}^{-1}$ of glyphosate, respectively. The nature and concentrations 33 of the co-formulants of the two commercial products, R and V, are unknown. Concentrated 34 solutions of each product $(4 \text{ mg } \text{L}^{-1})$ were prepared and stored under appropriate conditions 35 (darkness, controlled temperature). From January to November 2018 (i.e. 10 months), 36 every working day (generally 5 days a week), a volume of 100 mL of each of these respective 37 solutions was added to the tanks hosting the fish for which the freshwater flow was stopped 38 for one hour. After one hour of contact, regulated water flow was set up for the rest of the 39

day at $135 \text{ L} \text{ h}^{-1}$, allowing for the gradual dilution of glyphosate. Theoretical kinetics of ¹ glyphosate concentrations in contaminated tanks are presented in Figure 1 and have been ² calculated from the equation 1. The integrated mean theoretical concentration of glyphosate ³ for each contamination day was approximately 123 ng L^{-1} (the area integrated is represented ⁴ by a blue zone on the theoretical dilution curve in Figure 1). ⁵

2.4. Sampling date and spawning of RT

2.4.1. Water sampling

Two sampling dates were performed in February and November, respectively at the ⁸ beginning and at the end of the exposure period, to measure glyphosate concentrations in ⁹ water tanks. The first samples were analyzed using the ELISA method and the second by ¹⁰ HPLC. For each sampling date, 150 mL water samples were taken in each tank using sterile ¹¹ glass bottles. They were stored at -20 °C until the ELISA test or directly sent, at 4 °C, to ¹² the external provider for HPLC analysis. ¹³

2.4.2. Fish sampling

Non-invasive sampling was carried out two and one months before spawning (2mbs and 1mbs) by withdrawing 2mL of blood from the caudal vein with a lithium heparin vacutainer 16 (Greiner ref. KG454244). For flow cytometry analyses, 300 µL of blood collected from 17 each fish were immediately diluted with 10 mL of Leibovitz 15 medium (L15, Eurobio) 18 containing 8 mg L^{-1} of lithium heparin (Sigma-Aldrich ref. H0878). Whole blood was used 19 for hematologic analyses, while the remaining blood samples were centrifuged (1,200 x g, 10 m)20 min, 4°C) and plasma was stored at-80°C for immunological analysis. One month after 21 spawning (1mas), another blood sample was taken and fish were euthanized. Then, the liver, 22 spleen, gills and brain were sampled, flash-frozen in liquid nitrogen and stored at -80 °C for 23 future analyses. 24

2.4.3. Spwaning

The spawning period occurred in November 2018 and the maturation of fish was tested 26 every week by exerting manual abdominal stripping to ensure spawning on a day when most 27 of the fish were mature. Stripping events were done twice over the spawning period to 28 collect eggs and sperm from the most mature fish, with approximately two weeks between 29 them. For each stripping event, sperm of all mature males were used to fertilize eggs of 30 mature females belonging to the same experimental condition. After the stripping, females 31 were weighed before and after stripping to measure the total weight of eggs. A fraction 32 of eggs for each mature female was sampled in modified Gilson's solution (as described by 33 Friedland et al. [26], without nitric acid) for egg numbering and weighing. Relative fecundity 34 was considered as the number of eggs divided by the weight of each respective female after 35 stripping [11]. 36

2.4.4. Survival of the eggs

Eggs of each female were independently fertilized with the pool of sperm collected for 2 each respective chemical condition. Embryonic development was conducted in tank, con-3 taining approximately 300 L, continuously renewed with a river water flow (approximately 4 $300 \,\mathrm{L\,h^{-1}}$). Temperature during embryonic development was maintained at $8 \,\mathrm{^{\circ}C} \pm 2 \,\mathrm{^{\circ}C}$. 5 Water quality parameters were monitored as described for adult fish. Fertility was consid-6 ered to be the proportion of eggs surviving at five days post fertilization [11]. To perform 7 this measurement, 4, 7, 7 and 5 females were considered for the C, G, R and V respectively. 8 Survival of eggs was assessed daily for each female on a fraction of approximately 200 eggs 9 isolated in plastic breeding boxes. 10

2.5. Chemical analysis

Quantification of glyphosate using direct competitive ELISA assay (Novakits, ref. 1500086) was done at two times of the daily kinetics (i.e. just before the water flow reopening, wfr, and 13 2 hours after wfr) in all tanks, following supplier's instructions. Briefly, $50 \,\mu\text{L}$ of river water 14 was filtered and derivatized, before to be transferred into wells of a microplate coated with 15 goat anti-rabbit antibodies. Sample was diluted at 1/2 with rabbit anti-Glyphosate antibody 16 reagent and competitive reaction with enzyme conjugate solution lasted 1 h. After a step 17 of washing, the colored reaction was started by adding 150 µL of substrate solution to the 18 wells. The reaction was stopped after 25min, and plates were read at 450 nm on a TECAN 19 Spark 10M microplate spectrophotometer. The development of the color is inversely pro-20 portional to the concentration of AS in the sample. Standard curve has been realized using 21 the four-parameter log-logistic function, LL.4, of the R package "drc" [75]. Quantification 22 was done by reporting the OD value obtained for the sample to the quantification standard 23 curve obtained for each assay. 24

Quantification of glyphosate and AMPA by HPLC/fluorometric methods (Method ref. 25 ANA-I10.MOA.69.B) was done by an external provider (Labocea, France) at different times 26 of the daily kinetics (i.e. just before wfr and 1, 2 and 3 hours after wfr), in the tank 27 contaminated with the AS. 28

2.6. Hematologic and immunologic parameters

The hematocrit index was measured using microhematocrit capillary tubes after 5 min-30 utes centrifugation at $12,000 \times g$. Counting of red and white blood cells was performed on 31 a Thoma cell hemocytometer using whole blood diluted to 1/200 in Giemsa solution [38]. 32 Mean corpuscular volume (MCV) was expressed as the ratio of the hematocrit index to the 33 number of erythrocytes per unit of volume. Blood leukocyte populations were analyzed by 34 flow cytometry using a FACSCalibur flow cytometer (Becton Dickinson). Leukocytes were 35 extracted on a Ficoll gradient (Histopaque[®] 1077, Eurobio) after several centrifugation cy-36 cles according to Danion et al. [15]. For each sample, cell parameters were analyzed on 37 15,000 events. Two leukocyte populations, lymphocytes and macrophages, were differenti-38 ated according to their scatter properties. Phagocytic activity was measured with a solution 39 of leukocytes with 2.7×10^9 fluorescencebeads/mL (FluoroSpheres[®] carboxylate-modified 40 microspheres, diameter 1 µm, molecular probes, ThermoFisher Scientific) after 1 hour of 41

incubation at room temperature. Phagocytic capacity was considered to be the proportion of leukocytes that presented a fluorescence intensity equal to or greater than two beads (modified from Brousseau [7]). Note that due to a technical problem, phagocytic activity could not been obtained at 1mbs. The alternative pathway of plasma complement activity was measured according to Danion et al. [16]. Results were expressed using the formula described by Costabile [13].

2.7. Gene expression analysis

Total RNA was isolated using an RNeasy Plus kit (Qiagen) from 20 mg of spleen sampled 8 at 1mas, and all samples were treated with the RTS DNase Kit (Mobio) to prevent DNA 9 contamination. For each sample, RT was carried out using 1 µg total RNA with a RevertAid 10 H minus First Strand cDNA Synthesis Kit (Thermo Fisher Scientific) and an iCycler System 11 (Bio-Rad). mRNA was quantified for the following four genes: complement (C3-1 and 12 C3-4), interleukin-1 β (IL - 1 β) and tumor necrosis factor- α (TNF- α). In addition, the 13 elongation factor gene EF was included in the analysis as a housekeeping gene. Primers 14 were obtained from the literature and are based on sequences available in GenBank (http: 15 //www.ncbi.nlm.nih.gov/genbank/; Table 1). The characteristics of the quantitative real-16 time PCR (qPCR) reactions performed in the CFX96 real-time PCR System (Bio-Rad) are 17 available in [20]. Relative expression of the target gene was calculated with the Pfaffl formula 18 (equation 2; [69]). The ratio of a target gene was expressed in a sample versus a control, in 19 comparison to a reference gene. 20

2.8. Bio-markers, metabolic parameters and oxidative stress

All organs were homogenized in phosphate buffer (0.1 M, pH 7.8) with 20% glycerol and 0.2 mM phenylmethylsulfonyl fluoride as a serine protease inhibitor using the tissue homogenizer Precellys 24 (Bertin Technologies, France). Protein concentrations in the extracts were measured using the Pierce BCA protein assay kit (ThermoFisher Scientific). Each 25

assay measurement was performed in triplicate. All enzymatic reactions were monitored ¹ using a TECAN Spark 10M microplate spectrophotometer. Metabolic parameters were calculated using the slope of the curve optical density = f(time) and the Beer-Lambert law $(A = \epsilon lc)$. Oxidative stress activities were calculated using calibration curves generated using standards. All results were expressed in specific activities (IU mg⁻¹).

. Choline esterases (ChE) were measured in brain following a protocol adapted from Ellman tet al. [22]. Briefly, 20 μL of extract were assayed in 140 μL of a reaction solution with the acetylthiocholine iodide and dithiobis-2-nitrobenzoic acid. The variation in optical density was recorded at 412 nm.

. Carbonic anhydrase (CA) was assayed in gill following a protocol adapted from Verpoorte tet al. [87] using a reaction solution with 4-nitrophenyl acetate and acetazolamide (AZM) to r dimethyl sulfoxide (DMSO) (total esterase activity without or with CA activity, respectively). The enzymatic reaction was monitored spectrophotometrically at 405 nm.

. Citrate synthase (CS), Cytochrome c oxidase (CCO), Lactate dehydrogenase (LDH) and Glucose-6-phosphate dehydrogenase (G6PDH) metabolic parameters were measured in liver at, respectively, 412 nm, 550 nm, 340 nm and 340 nm, following an adaptation of the procedures described by Gauthier et al. [28].

. Thiobarbituric acid reactive substances (TBARS) were quantified by their reactivity with thiobarbituric acid in acidic conditions according to Espín et al. [24].

. Total activity of superoxide dismutase (totalSOD) and manganese-dependent superoxide dismutase (MnSOD) activity were measured in liver according to Espín et al. [24], Mesa-Herrera et al. [55]. Briefly, samples were assayed in a solution of pyrogallol and the rate of pyrogallol autoxidation was measured with a spectrophotometer at 325 nm. MnSOD activity was calculated by substrating the activity of totalSOD by the activity of SOD measured in presence of an inhibitor of MnSOD, the sodium cyanide 25

. Gluthathione Peroxidase (GPx) activity was determined in liver using 15 μL of diluted sample according to the Paglia method [63]. Cumene hydroperoxide was used as the substrate and enzymatic activity was assessed at 340 nm. 28

. Catalase (CAT) was assayed in liver using the method of Aebi [1]. Briefly, the assay ²⁹ mixture consisted of phosphate buffer (100 mM, pH 7) and H2O2 (28 mM). The variation ³⁰ of H2O2 absorbance was measured with a spectrophotometer at 225 nm. ³¹

2.9. Data processing and statistical analyses

Data processing and statistical analyses were conducted with R software [71], except ³³³ for normalized gene expressions that were obtained with Bio-RAD CFX Manager[™]Software ³⁴⁴ (Bio-Rad). Figures were produced using the ggplot2 package [89]. All the data were tested ³⁵⁵ for normality and homoscedasticity. In the case of normal and homoscedastic data, one-way ³⁶⁶ Anova tests were used to compare means, followed by a post-hoc test of Dunnett [19]. In the ³⁷⁷ case of normal and heteroscedastic data, modified one-way Anova tests were used to compare means [88], followed by a post-hoc test of Tamhane-Dunnett [59]. In the case of non-normal data, a Kruskal-Wallis test was used to compare means, followed by a post-hoc test of Dunn [18]. Differences between survival and fecundity percentages were compared with a Chisquared test. A p-value of 0.05 was used as the threshold for statistical significance. A test of correlations between variables was carried out using the lmrob R function (R package robustbase; Wilcox [90]).

3. Results

3.1. Concentration assays

Glyphosate and AMPA were not detected in control tank throughout the experiment. 10 AMPA was never detected in any of the exposure tanks. Using ELISA assay, concentrations 11 of glyphosate ranged between 1.05 and $1.45 \,\mu g \, L^{-1}$ in all exposure tanks one hour after the 12 addition of the chemical (Figure 1). The glyphosate concentration measured by HPLC was 13 approximately 30 to 40% lower $(0.77 \,\mu g \, L^{-1})$ at the same point of the kinetic. Two hours 14 after restarting the water flow, glyphosate concentrations were similar (between 0.24 and 15 0.55 instead of the modeled concentration of $0.51 \,\mu g \, L^{-1}$ predicted by the theoretical dilution 16 curve) regardless of the method used. 17

3.2. Survival and growth parameters

No mortality was recorded before the spawning period. However, spawning induced mortality rates between 15 and 30 % (data not shown), without significant differences between the exposure conditions, that were randomly distributed across all treatment groups.

Mean ratios of weights before and after the spawning period were 1.14, 1.11 and 1.15 for control, glyphosate and Viaglif, respectively, while a ratio of 1.03 was found for the Roundup condition. No statistical differences were found among the means of the four exposure conditions.

3.3. Reproductive parameters

High fertility was observed for RT in all conditions. Relative fecundity and fertility between control and contaminated fish were not significantly different (Table 2).

3.4. Hematologic and immune blood parameters

No statistically significant change was observed among hematologic parameters (i.e. ³⁰ RBCC, HT, MCV and WBCC) of adult trout exposed to glyphosate or GBHs compared to ³¹ controls (Table 3) before, during and after the spawning period (Table 3). ³²

Considering the proportion of macrophages (Figure 2), the only statistically significant change was a reduction of approximately 70% for Viaglif condition ($\chi^2 = 12.2$; degrees of freedom, df = 3; p-value = 0.007) compared to the control two months before the spawning. At the same period, phagocytic capacity (Table 3) was significantly lower for fish exposed to GBHs compared to controls ($\chi^2 = 19.7$; df = 3; p-value = 0.0002). ACH₅₀ activity was not significantly altered in adult trout exposed to glyphosate or GBHs (Table 3).

3.5. Immune gene expression in spleen

No significant differences between mean expressions were found one month after spawning 2 for C3-1, C3-4 and $IL1 - \beta$. An overall significant difference of means was observed for 3 $TNF-\alpha$ expression ((f = 19.7; df = 3; p-value = 0.045; Table 4), with a decrease of 38, 4 56 and 66% in the glyphosate, Roundup and Viaglif groups, respectively, compared to the 5 control. A post-hoc test revealed no significant difference for TNF- α between chemically 6 exposed conditions and control. A positive correlation was observed between the proportion 7 of macrophages and the expression of $IL1 - \beta$ (adjusted R-squared: 0.1571, p = 0.001) but 8 not with TNF- α (adjusted R-squared: -0.02838, p = 0.46). 9

3.6. Biochemical parameters and oxidative stress in liver

No significant difference was noted in metabolic activities between contaminated and ¹¹ control fish one month after spawning (Table 5). Means of CS/CCO ratio values were ¹² 1.4 ± 0.07 , 1.3 ± 0.08 , 1.1 ± 0.05 and 1.2 ± 0.11 for control, glyphosate, Roundup and Viaglif ¹³ conditions, respectively. For LDH/CS ratio, they were of 15.5 ± 0.38 , 17.3 ± 0.42 , 18.6 ± 0.95 ¹⁴ and 16.9 ± 0.93 respectively. No significant difference was noted in any of these metabolic ¹⁵ ratios between contaminated and control trouts. ¹⁶

No significant modification of the AChE and CA activities was observed one month after spawning in the brain and the gills of adult trout, respectively (Figure 3).

No significant difference was measured for MDA concentrations or CAT, GPx, SODmn, ¹ SODtotal and TBARS activities regardless of the chemical treatment occurred (Table 6) ² one month post-spawning. ³

4. Discussion

This study aimed to investigate the effect of long term exposure to low and environmentally relevant concentrations of glyphosate, the most widely used herbicide in the world, on the overall health status of rainbow trout, *Oncorhynchus mykiss*, a non-target species. In addition, another point of interest lay in the provision of data on the potential modulation of the toxicity of glyphosate by co-formulants of two commercial glyphosate-based herbicides (GBHs).

Our complex experimental design, studying chemical contamination over several months 8 with a low environmentally relevant dose of glyphosate on sexually mature genitors, is partic-9 ularly useful to understand the complexity of the toxic effects of this herbicide in the aquatic 10 environment. In this study, only one tank per chemical treatment has been allocated to in-11 tegrate the ethical rules of reducing the number of animals and the logistics constraints of 12 keeping fish in good conditions throughout a prolonged period. To compensate the possible 13 "tank effect", we maximized the number of fish sampled to have a relevant overview of the 14 individual variability occurring inside each tank in response to a specific contaminant. To 15 minimize the inter-tank variability, the experimental conditions were strictly managed (i.e. 16 all tanks were positioned in the same room and received the same water at the same temper-17 ature in open circuit). As these precautionary measures could not completely prevent the 18 apparition of a "tank effect", exposure reiteration will be necessary to confirm our results 19 and hypothesis. 20

Levels of glyphosate contamination observed were relatively in phase with our theoretical 21 kinetics, with a maximum variation of the expected concentration of glyphosate of approx-22 imately 23% for the HPLC method and 45% for the ELISA assay. The lower specificity of 23 the ELISA compare to the HPLC method could explain the overestimation of glyphosate 24 concentrations measured for several points of the kinetics. The first degradation metabolite 25 of glyphosate, AMPA, was not detected in our contaminated tanks, probably because the 26 water renewal prevented any accumulation of metabolites. No traces of glyphosate or AMPA 27 were found in the control tank either, demonstrating that no external source of glyphosate 28 was introduced into our experimental system. Glyphosate is known to have low biocon-29 centration factors in animal tissues [25, 37], and we therefore did not quantify the AS in 30 fish. Nevertheless, a study of bio-markers of exposure has shown that the compound can be 31 distributed at low doses in fish (reviewed by Annett et al. [3]). 32

Several authors have hypothesized that glyphosate, combined or not with co-formulants 33 in GBHs, can cause toxicity through altering AChE and CA (AChE: [9, 56]; CA: [78]). AChE 34 has been shown to be inhibited by concentrations of pure glyphosate of at least 1 mg L^{-1} and 35 both enzymes were impacted by $0.2 \,\mathrm{mg}\,\mathrm{L}^{-1}$ and $1 \,\mathrm{mg}\,\mathrm{L}^{-1}$ of glyphosate formulated in several 36 GBHs different from those tested here, respectively [9, 54, 56, 31]. Activation of AChE have 37 also been reported during chronic exposure in freshwater stinging catfish (Heteropneustes 38 fossilis) or in common carp (Cyprinus carpio) after a recovery period [17, 9] as well as hybrid 39 situations coupling inhibition and activation, like in the mussel (*Mytilus galloprovincialis*) 40 [52]. The development of a dynamic compensatory response in these aquatic organisms facing 41 the stress induced by chemical exposure could explain the slight activation and inhibition of 42 AChE observed in the brains of our RT exposed to glyphosate and GBHs. Nevertheless, the 1 dose of glyphosate exposure used was probably too low to induce changes in AChE activity. 2 In vitro and in vivo inhibitions of CA have also been reported after exposure to a GBH, 3 and it has been suggested that this inhibition could be responsible for other toxic effects at 4 higher levels of biological organization [39, 78]. Although inhibition of the activity in animals 5 contaminated with Viaglif seems to be emerging one month after spawning, no significant 6 effect was measured in our study regardless of the condition. Complementary investigations 7 will be necessary to confirm if this tendency lasts and grows with the exposure time. 8

Several enzymes implicated in both energy metabolism and antioxidant defenses have 9 been monitored in livers of RT to assess the effect of chemical contamination in this organ 10 that has been demonstrated to be the main target of glyphosate toxicity [47, 51]. Among 11 them, malondialdehyde (MDA), an indicator of oxidative damage to lipids, was of partic-12 ular interest as glyphosate and GBH have been described to induce oxidative stress and 13 increase lipid peroxidation in fish [32, 58, 47, 61, 9, 78]. Most of the previous data on oxida-14 tive stress was obtained with glyphosate concentrations above $1 \text{ mg } \text{L}^{-1}$ (i.e. a concentration 15 1000 times greater to the dose we used in the present study) and exposures were conducted 16 with co-formulated products only. At lower concentrations, Persch et al. [68] no impact 17 on TBARS levels was observed in different tissues of Catfish (Rhamdia quelen) juveniles 18 exposed to concentrations of a GBH comprised between 18 and $144 \,\mu g \, L^{-1}$ but reduction 19 of glycogen and total lipid and protein contents occurred in this study. An increase of 20 the CAT activity was also observed, particularly in gills at concentration above $36 \,\mu g \, L^{-1}$. 21 Under our conditions, we obtained only slight and no significant variations in activities of 22 enzymes involved in defenses against oxidative stress. This is likely due to the fact that 23 glyphosate concentrations used might be insufficient to induce an antioxidant response and 24 damage in adult trouts. Previous authors had already reported that after a first phase 25 of response with anti-oxidant enzymes induced in liver of the neotropical fish (*Prochilodus*) 26 *lineatus*) contaminated by a GBH, a subsequent phase occurred were enzymatic activities 27 returned to baseline levels without an increase in oxidative damage [56]. Applied to our 28 study, this means that adaptations occurring in the first phase of the chemical contami-29 nation might not be revealed by the pattern of oxidative stress defenses observed later in 30 the experiment but also that, at the time of sampling, fish were protected from oxidative 31 stress. G6PDH helps to protect against oxidative damage and is also recognized as being 32 a relevant marker of anabolism [64]. G6PDH activity of our control group showed consid-33 erable interindividual variability, and the contaminants studied appeared not to influence 34 the regeneration capacity of NADPH implicated in oxidative stress defenses, nor anabolic 35 capacity. Several discrete disruptions were observed in chemically exposed fish for three 36 liver enzymes that play key roles in metabolic pathways. LDH activity appeared not to 37 be particularly influenced by chemical contamination, suggesting that fish did not increase 38 anaerobic metabolism as a compensatory mechanism against loss of aerobic capacity [76]. 39 Activities of enzymes involved in aerobic metabolism, CCO and CS, were not impacted by 40 the chemical contamination. Some tendencies were observed when CS/CCO and LDH/CS 41 ratios of activities were considered but further studies are needed to confirm these results. 42 Higher LDH/CS could indicate a transition from aerobic to anaerobic metabolism [70], while 43 a lower CS/CCO ratio could reveal mitochondrial dysfunction [35]. Craig et al. [14] observed 1 that Cu exposure affected this ratio in the liver of the gilthead seabream (Sparus aurata) and 2 suggested that it could, therefore, affect normal mitochondrial biogenic processes. GBHs 3 have been shown to generate mitochondrial dysfunction in isolated mitochondria [65], cells 4 [46], and fish [66] and mitochondrial impairments were reported in the brain of zebrafish 5 (*Daion rerio*) sub-chronically exposed to a GBH at concentration as low as $65 \ \mu g \ L^{-1}$ Pereira 6 et al. [66]. Interestingly, mitochondrial effects and neurotoxicity did not seem to be linked 7 to glyphosate or co-formulant concentrations. 8

Seasonal variations in hematologic parameters resulting in erythrocytosis or leukopenia 9 are well documented in RT and explained by physiological adaptation to external conditions 10 [57, 36] or to breeding cycles with gonad maturation [8]. Disturbance in hematologic param-11 eters can also be induced by acute, sub-chronic or chronic exposure to GBHs, as reported in 12 various fish species [41, 31, 29, 74, 56, 40]. We showed that hematological parameters had a 13 tendency to fluctuate during the sexual maturation and the spawning period but chemical 14 contamination with glyphosate or GBHs had no impact on these parameters. At the spawn-15 ing time, RT contaminated with Viaglif showed a lower, but not significantly different from 16 the control, hematocrit index associated with a lower MCV. The hematocrit value reflects the 17 capacity of blood to transport oxygen and low hematocrit could have been associated with 18 lower physiological performances [27]. The proportion of different leukocyte populations in 19 fish exposed to GBHs presented a smaller proportion of macrophages and, consequently re-20 duced phagocytic activity before the spawning period. These kinds of changes have already 21 been reported after exposure to GBHs, and several authors have hypothesized that this 22 could be the consequence of the oxidative stress induced by chemical contaminants which 23 increases production of reactive oxygen species and damage cell membranes [62, 42, 41]. The 24 present study does not allow the validation of this hypothesis and further investigations will 25 be necessary to demonstrate the involvement of oxidative stress in the toxicity of glyphosate 26 and its co-formulants regarding immuno-hematological cell functions. 27

The complement system is an important component of innate immunity in teleost fish 28 and can be affected by various abiotic stresses [6], including chemical exposure [72]. Differ-29 ent effects of GBHs on fish complement have been reported, depending in particular on the 30 exposure dose. Kreutz et al. [41] found no impact of sub-chronic exposure to a concentra-31 tion of $0.730 \,\mathrm{mg}\,\mathrm{L}^{-1}$ of a GBH on complement hemolytic activity in the serum of goldfish 32 (Carassius auratus), while Ma et al. [49] reported that chronic exposure to doses of 52.08 33 and $104.15 \,\mathrm{mg}\,\mathrm{L}^{-1}$ of a GBH reduced both the expression and the content of complement 34 (C3) in the kidney of common carp (*Cyprinus carpio*). At our level of contamination, no 35 impact in hemolytic activity of alternative complement pathway was detected. 36

Cytokines are secreted proteins that are important for the development and regulation ³⁷ of fish immune responses. Among them, TNF- α and $IL1 - \beta$ act in inflammation and ³⁸ regulation of immune cells [73]. The expression of both these cytokines showed a decreasing ³⁹ (non-significant) trend in fish exposed to GBHs and this trend was also observed to a lesser ⁴⁰ extent for fish exposed to the AS. As some of these cytokines, like $IL1 - \beta$, are produced ⁴¹ by macrophages [34, 73], there can be a direct correlation between their level of expression ⁴² and variations in the population of these immune cells. Disruption of the specific immune ⁴³ response set up to fight against an infectious agent could be detrimental for fish health and complementary studies must be done to confirm these tendencies.

Outside of the spawning period, where mortality events occurred in control and contam-3 inated groups, no abnormal behavior or clinical signs were observed. Reproduction periods 4 mobilize a large amount of energy and are frequently associated with greater fragility, mak-5 ing fish more sensitive to external aggression (e.g. pathogens, sampling events; [11]). No 6 significant differences between conditions occurred in ponderal growth during the period of 7 gonad maturation and spawning. Fish exposed to Roundup showed slightly lower weights, 8 which could suggest an increase in energy demand due to detoxification and repair processes, 9 leaving less energy available for growth and reproduction [76]. The lower growth observed 10 for the Roundup condition could be the result of an investment of the extra-energy pro-11 duced in reproduction rather than in growth. This phenomenon has already been observed 12 in RT, and different trade-offs can be seen depending on stress events [11]. Fecundity and 13 fertility were studied using different markers on mature adult RT, and no impact of chemical 14 exposure was shown. If a specific mechanism of reproductive toxicity occurred, such as hor-15 mone disruptions, it did not affect reproductive parameters measured here. Uren Webster 16 et al. [84] reported effects on steroidogenic biosynthesis pathways in zebrafish (Danio rerio), 17 but no disruption of spermatogenesis and fertilization after simple or complex exposure at 18 $10 \,\mathrm{mg}\,\mathrm{L}^{-1}$ of glyphosate. In their study, egg production was impacted with pure glyphosate 19 but not with GBH, which could act to maintain or restore the estrogen signaling pathway. 20 Even though, in the present study, the very low environmentally relevant exposure of adult 21 RT to glyphosate and GBHs might not affect reproductive parameters, it would be interest-22 ing to investigate if an impact may still occur on F1 generation due to exposure of gametes 23 during gametogenesis. 24

5. Conclusions

This study investigated the impact of long-term chronic exposure to a low-dose of 26 glyphosate in adult rainbow trout through the observation of a wide variety of parameters 27 e.g. reproduction, oxidative response, energetic metabolism and immune system, including 28 a comparison between the AS and two GBHs. The results obtained revealed no major 29 changes for the majority of markers analyzed except, occasionally, some elements of the im-30 mune response such as the proportion of macrophages in the blood or phagocytic capacities. 31 Interestingly, these significant modifications were observed only for the formulated products, 32 suggesting a potential role of the co-formulants in the induced effect. The environmentally 33 relevant exposure concentration of glyphosate of less than $1 \ \mu g \ L^{-1}$ we used is probably too 34 low to induce detectable changes over the 10-month period in adult fish. It is important 35 to note that although our experimental conditions were optimal for the physiology of RT, 36 the toxicity of glyphosate and GBH co-formulants in the real aquatic environment could 37 be enhanced by biotic and abiotic stressors, and interaction with other chemicals - i.e. a 38 cocktail effect. Complementary studies are ongoing on F1 and F2 generation derived from 39 the RT used in this study to explore the potential effects of a direct interaction of chemicals 40 with germinal cells but also of a transgenerational exposure. 41
