### The Diffusion of Rock Crystal Carving Techniques in the Fāțimid Mediterranean

The art of carving rock crystal was unknown in Europe from the fall of Rome until the thirteenth century. Theophilus Presbyter, who wrote in Cologne in *circa* 1125, knew how, using abrasive sand and abrasive stones, rock crystal gems could be sawn (secare), ground (limare) into shape and polished (*polire*), but he believed that in order to carve (*sculpere*) the stone it had first to be heated in the cardiac cavity of a newly slaughtered goat.<sup>1</sup>

The earliest evidence that rock crystal vessels were being carved in Europe comes from legislation governing the guild of rock crystal workers and lapidaries — des Cristaliers et des Perriers de pierres natureus — issued by Étienne Boileau, one of the first known provosts of Paris, in 1268.<sup>2</sup> The earliest carved rock crystal objects attributed to Paris are given the same date.<sup>3</sup> At about the same time, documents first refer to a scola et artes cristellariorum in Venice,<sup>4</sup> while the first rock crystal vessels to be attributed to Venetian craftsmen are dated to the fourteenth century.<sup>5</sup>

The small group of gemstones and other objects produced for the Carolingian court in the ninth century, such as the Lothair Crystal in the British Museum, is the one securely attested exception,<sup>6</sup> to which we shall soon return. Two further *possible* exceptions are the European outposts of Islam in the Iberian Peninsula and Sicily where local traditions of carving rock crystal may — or may not — have developed. We shall discuss Sicily at some length,<sup>7</sup> but discussion of the putative rock crystal production of al-Andalus must await another occasion.

The many rock crystal objects imported from Byzantium and the Islamic world before 1250 attest to the demand by European consumers.<sup>8</sup> Both written sources, such as Theophilus Presbyter, and the ubiquitous use of plain polished rock crystal gems in early medieval regalia, sacred objects and jewellery, suggest that sources of raw rock crystal in the European Alps were regularly exploited. It follows that the only reason why European craftsmen did not carve rock crystal was because they did not know how to do so.

From the Islamic world, literary sources report that raw rock crystal was imported into Basra and Cairo — two principal centres of production in the late tenth and eleventh centuries from Western Arabia and the Hijaz, the islands of the Indian Ocean (Madagascar, the Maldives and Sri Lanka), the Maghrib specifically Morocco, Central Asia, Armenia, China, and 'the Lands of the Franks'. They also describe other centres of production in Ghaznavid Afghanistan and Marīnid Morocco that used local sources of rock crystal.<sup>9</sup> We ourselves have not yet been able to establish the provenance of the rock crystal used to make complete vessels.<sup>10</sup> Archaeology has so far yielded little evidence of trade or production of rock crystal. The small numbers of rock crystal beads and bead-wasters, and minute fragments of waste from bead production, found in

archaeological contexts at Kilwa, Manda, Shanga and other East African coastal sites do not justify claims that an international trade-route began far inland at Tsavo, Kitui, or even the Kerio Valley in the Central Rift, and terminated in the workshops of Başra and Cairo. It contradiction to what is often claimed, no Arabic source reports that rock crystal came from mainland East Africa.<sup>11</sup> The raw rock crystal found on coastal sites is perhaps most likely to have been imported by sea from sources in the Indian Ocean; at the same periods, chlorite-schist vessels were imported from Madagascar,<sup>12</sup> and it has been suggested that the techniques used on the coast to manufacture rock crystal beads themselves originated in south India or Sri Lanka.<sup>13</sup>

The extreme hardness of rock crystal (Mohs scale 7.0), together with its homogenous crystalline structure, make it impossible to sculpt with the percussive tools — the hammer and point — used by the stonemason or sculptor. Instead, the crystal must be ground away using an abrasive, such as powdered corundum or diamond, mixed with a liquid lubricant such as oil or water. Different tools were used as vectors to carry the abrasive powder to the surface of the crystal: hand-held wires or metal saws to rough out the vessel; a *vertical* bow-drill driving a tubular drill to start hollowing out the vessel; and a *horizontal* bow-lathe driving first a succession of gouges to complete the interior cavity, and then a series of grinding disks, cutting wheels and drill bits to shape the exterior of the vessel and carve the decoration. For this last process, the carver held the vessel in his hands and presented its surface to the vector rotating on the horizontal lathe, applying the abrasive mixture that actually did the cutting. Only objects small enough to be constantly manipulated by the craftsman against the carving tool on the fixed bow-lathe can be produced by this technique.

The techniques of carving rock crystal could have been transferred from one centre of production to another only by craftsmen experienced in all aspects of the craft, not by descriptive accounts, still less by the vessels themselves. Nonetheless, it has been proposed that both Carolingian glyptic, and the putative rock crystal production of Norman Sicily, developed not by the migration of expert lapidaries but rather by the adaptation of techniques from different

technologies to carving rock crystal.

Genevra Kornbluth insists that the decoration of the small group of Carolingian gemstones and other objects, such as the Lothair Crystal in the British Museum, only exhibit smooth continuous curves, and never the segmented curves characteristic of Byzantine and Islamic carving — that is, curves made up of short lengths of intersecting straight lines.<sup>14</sup> She believes that the smooth curves of Carolingian engraving must have been made by a cutting disk with rounded sides or by a ball-shaped drill. She hypothesizes that such rounded tools were used by the engravers who made the dies for the high quality portrait-issue coins of the Carolingian renovatio imperii, and that these techniques were adapted to engraving hard-stone. She therefore concluded that the tecniques used to engrave Carolingian hard-stones were not imported by migrant craftsmen from the East.

This hypothesis fails on all levels. Carolingian dies — like all ancient and medieval dies - were engraved with burins and punches, not wheel-cut. Cutting disks with rounded sides do not make continuous curves, but only segmented curves. And, most importantly, the curves on Carolingian crystals are segmented curves, exactly like those made by Byzantine or Islamic carvers. Three lessons are to be drawn from this example.

First, Carolingian hard-stone objects were carved using techniques originally imported to the Rhineland by migrant craftsmen from the East, presumably from Byzantium. Second, the style of the Carolingian decoration is local not Byzantine, demonstrating that style need not indicate the origin of the technique of production. And, third, conclusions based upon outdated analyses — such as Kornbluth's reliance in 1995 upon relatively low magnification — may need to be reassessed in the light of more up-to-date archaeometrical methods.

Turning to Sicily, there is no conclusive evidence that any rock crystal object was carved on the island under Muslim or Norman rule. The hypothesis seems to rest upon the presence in Sicily of two objects — the sword-pommel in Enna,<sup>15</sup> and the cylindrical flask in Agrigento<sup>16</sup> that are decorated with the same simplified version of a Fatimid half-palmette that is used to represent the whiskers on the Karlsruhe lionhead.<sup>17</sup> That lionhead is compared to lionheads in other media from Norman Sicily: on the Mantle of Roger II,<sup>18</sup> in the painted ceilings of the Cappella Palatina,<sup>19</sup> on an anepigraphic follis attributed to King William II,<sup>20</sup> and — most importantly — on the porphyry sarcophagus carved in Palermo for King Roger II before 1145. now the Tomb of Frederick II.<sup>21</sup> Because porphyry is approximately as hard as rock crystal (Mohs scale 6–7), the hypothesis assumes that the existence in Palermo of a workshop of porphyry sculptors strengthens the case that rock crystal, too, was carved in Norman Sicily as if the technology used to sculpt porphyry could have been adapted to carve rock crystal.

Again, this cannot be so. Although porphyry is almost as hard as rock crystal, its crystaline structure is fundamentally different. While a block of raw rock crystal is a single

homogenous crystal, porpyhry is composed of many large-grained crystals dispersed in a finegrained matrix, and can be sculpted using the percussive techniques of hammer and point. While saws and abrasive powder were used to shape the Sicilian sarcophagi, tubular drills and abrasive powder were used to hollow out their troughs, and the high polish of their surfaces was achieved by the use of abrasive stones and powders, only these techniques were shared with rock crystal carving. The sarcophagi and their supports are far too big and heavy to have been held in the hands of the carver and presented to the grinding-wheel or cutting-disk driven by a horizontal bow-lathe. The plastic decoration on the sarcophagi — such as the lionheads — was made with the traditional tools of the sculptor — the hammer and point, and the drill — and not by the techniques used to carve rock crystal. (Incidentally, the techniques of sculpting porpyhry were imported to Norman Palermo, presumably by craftsmen from Rome.<sup>22</sup>)

If rock crystal was indeed carved in Norman Sicily then the technology must have been imported by expert craftsmen, probably from  $F\bar{a}$ tmid Egypt. This is certainly possible: the Norman kings imported a wide range of craftsmen and their techniques — mosaicists and textile workers from Byzantium; masons and sculptors from France and mainland Italy; scribes and painters from  $F\bar{a}$ timid Egypt — to achieve their multicultural royal art and architecture. But there is no conclusive evidence that they did import rock crystal carvers.

The present tendency to attribute whole classes of unattributed artefacts to Norman Sicily — including faceted rock crystal vessels without decoration,<sup>23</sup> and the so-called "Hedwig Beakers"<sup>24</sup> — rests heavily upon the false assumption that the techniques of sculpting porphyry could have been adapted to carving rock crystal and, thence, to wheel-cutting glass. Our growing database of medieval Islamic rock crystal carving may one day produce evidence to support the hypothesis of rock crystal production in Norman Sicily, but it has not done so yet. Much of the argument for the unity of Mediterranean culture in the tenth to twelfth centuries rests upon arthistorical comparisons and stylistic similarities; too little attention is paid to the technological divides that, especially before the thirteenth century, separated the Islamic from the Christian Mediterranean, and — *a fortiori* — from sub-Saharan Africa.
