### FREE PRE-LIE ALGEBRAS OF FINITE POSETS

#### M. AYADI

ABSTRACT. We first recall the construction of a twisted pre-Lie algebra structure on the species of finite connected topological spaces. Then, we construct a corresponding non-coassociative permutative (NAP) coproduct on the subspecies of finite connected  $T_0$  topological spaces, i.e., finite connected posets, and we prove that the vector space generated by isomorphism classes of finite posets is a free pre-Lie algebra and also a cofree NAP coalgebra. Further, we give an explicit duality between the non-associative permutative product and the proposed NAP coproduct. Finally, we prove that the results in this paper remain true for the finite connected topological spaces.

## 1. Introduction

In this paper, we introduce a twisted non-associative permutative algebra structure on the species of finite connected posets. We recall the definition of a non-associative permutative algebra (in short NAP algebra), and the dual definition of a non-coassociative permutative coalgebra (in short NAP coalgebra). A (left) NAP algebra is a vector space V equipped with a bilinear product  $\cdot$  satisfying the relation:

$$(1.1) a \cdot (b \cdot c) = b \cdot (a \cdot c), \text{ for all } a, b \text{ and } c \in V.$$

We note also that the notion of NAP algebra has emerged from the reference [15] by M. Livernet. It has also been previously defined in [11] by A. Dzhumadil'daev, and C. Löfwall under the name of "left commutative algebra". Dually a (left) NAP coalgebra is a vector space V equipped with

a bilinear coproduct  $\delta: V \to V \otimes V$  satisfying the relation:

$$(1.2) (Id \otimes \delta)\delta = \tau^{12}(Id \otimes \delta)\delta.$$

We recall the following rigidity theorem [15]: any pre-Lie algebra  $(V, \triangleright)$ , together with a non-associative permutative connected coproduct  $\delta$  satisfying the distributive law

$$\delta(a \triangleright b) = a \otimes b + (a \otimes 1 + 1 \otimes a) \triangleright \delta(b),$$

is a free pre-Lie algebra and a cofree NAP coalgebra.

We recall also in this paper the description of the free pre-Lie algebra in terms of rooted trees given in [10]. We define a new bilinear product  $\bigcirc$  in the species of finite connected posets  $\mathbb{U}$  by: for all  $P \in \mathbb{U}_{X_1}$  and  $Q \in \mathbb{U}_{X_2}$ , where  $X_1$  and  $X_2$  are two finite sets

$$P \hookrightarrow Q = \sum_{v \in \min(Q)} P \searrow_v Q,$$

where  $P \searrow_{v} Q$  is obtained from the Hasse graphs  $G_1$  and  $G_2$  of P and Q by adding an (oriented) edge from v in  $G_2$  to any minimal vertex of  $G_1$  [3].

We show that the bilinear product  $\bigcirc$  verifies (1.1) in the monoidal category of species, and therefore endows the species  $\mathbb{U}$  with a NAP algebra structure.

For any finite set X, we define the coproduct  $\delta$  by:

$$\delta: \mathbb{U}_X \longrightarrow (\mathbb{U} \otimes \mathbb{U})_X = \bigoplus_{Y \sqcup Z = X} \mathbb{U}_Y \otimes \mathbb{U}_Z$$
 
$$P \longmapsto \frac{1}{|min(P)|} \sum_{I \otimes P} I \otimes P \backslash I,$$

where  $I \otimes P$  means that I is a subset of P such that:

- $I_{-}$  is a singleton included in min(P),
- and *I* is a connected component of the set  $\{x \in P, I_- <_P x\}$ .

with the set  $I_{-}$  is equal to the space  $\{x \notin I, \text{ there exists } y \in I \text{ such that } x \leq_{P} y\}$ .

We prove that the coproduct  $\delta$  is a twisted NAP coproduct, i.e., (1.2) is verified in the monoidal category of species.

M. Livernet in [15] proved the following rigidity theorem: for any pre-Lie algebra  $(V, \triangleright)$  together with a NAP connected coproduct  $\delta$  satisfying relation (1.3), V is the free pre-Lie algebra generated by Prim(V).

Later in this paper, we prove a compatibility relation between the pre-Lie  $\searrow$  structure and the coproduct  $\delta$  by proving the twisted version of (1.3) namely:

$$\delta(P \setminus Q) = P \otimes Q + (P \otimes \mathbf{1} + \mathbf{1} \otimes P) \setminus \delta(Q),$$

for any pair (P, Q) of finite connected posets, where the unit 1 is identified to the empty poset.

Applying Aguiar-Mahajan's bosonic Fock functor  $\overline{\mathcal{K}}$  [2] and M. Livernet's rigidity theorem [15] leads to the main result of the paper:  $(\overline{\mathcal{K}}(\mathbb{U}), \setminus)$  endowed with the coproduct  $\delta$  is a free pre-Lie algebra and a cofree NAP coalgebra.

We end up Section 3 by proving that the NAP product  $\bigcirc$  and the NAP coproduct  $\delta$  are dual to each other, and we show that  $(\mathcal{K}(\mathbb{P}), \Delta_{\searrow})$  is a coassociative cofree coalgebra, where  $\Delta_{\searrow}$  is the coassociative coproduct defined in [3].

In the last section, we prove that the results in this paper remain true for the finite connected topological spaces, with a small change on the definition of the coproduct  $\delta$ .

#### 2. Basics of finite topologies

A partial order on a set X is a transitive, reflexive and antisymmetric relation on X. A finite poset is a finite set X endowed with a partial order  $\leq$ . Let  $P = (X, \leq_P)$  and  $Q = (X, \leq_Q)$  be two posets. We say that P is finer than Q if:  $x \leq_P y \Longrightarrow x \leq_Q y$  for any  $x, y \in X$ . The Hasse diagram of poset  $P = (X, \leq_P)$  is obtained by representing any element of X by a vertex, and by drawing a directed edge from a to b if and only if  $a <_P b$ , and, for any  $c \in X$  such that  $a \leq_P c \leq_P b$ , one has a = c or b = c. We can say that I is an upper ideal of P ( $I \subset P$ ) if, for all  $x, y \in P$ ,  $(x \in I, x \leq_P y) \Longrightarrow y \in I$ . We denote J(P) the set of upper ideals of P.

Recall [1,12] that a finite topological space is a finite quasi-poset and vice versa. Any topology  $\mathcal{T}$  (hence any quasi-order on X) gives rise to an equivalence relation:

$$(2.1) x \sim_{\mathcal{T}} y \iff (x \leq_{\mathcal{T}} y \text{ and } y \leq_{\mathcal{T}} x).$$

Equivalence classes will be called bags here. This equivalence relation is trivial if and only if the quasi-order is a (partial) order, or equivalently, if the corresponding topology is  $T_0$ . Any topology T on X defines a poset structure on the quotient  $X/\sim_T$ , corresponding to the partial order induced by the quasi-order  $\leq_T$ . More on finite topological spaces can be found in [4, 9, 12, 18].

Recall [2, 14] that a linear (tensor) species is a contravariant functor from the category of finite sets **Fin** with bijections into the category **Vect** of vector spaces (on some field **k**). Let  $\mathbb{E}$  be a linear species. We note  $\overline{\mathcal{K}}(\mathbb{E}) = \bigoplus_{n \geq 0} \mathbb{E}_n/S_n$ , where  $\mathbb{E}_n/S_n$  denotes the space of  $S_n$ -coinvariants of

 $\mathbb{E}_n$ . The functor  $\overline{\mathbb{K}}$  from linear species to graded vector spaces is intensively studied in [2, chapter 15] under the name "bosonic Fock functor".

The species  $\mathbb{T}$  of finite topological spaces is defined as follows: for any finite set X,  $\mathbb{T}_X$  is the vector space freely generated by the topologies on X. For any bijection  $\varphi: X \longrightarrow X'$ , the isomorphism  $\mathbb{T}_{\varphi}: \mathbb{T}_{X'} \longrightarrow \mathbb{T}_X$  is defined for any topology  $\mathcal{T}$  on X', by the following relabelling:

$$\mathbb{T}_{\varphi}(\mathfrak{T}) = \{ \varphi^{-1}(Y), Y \in \mathfrak{T} \}$$

It is well-known that the species  $\mathbb{T}$  of finite topological spaces is a twisted commutative Hopf algebra [12]: the product m is given by disjoint union, and the coproduct  $\Delta$  is a natural generalization of the Connes-Kremier coproduct on rooted forests. We defined another twisted Hopf

algebra structure in [3] by replacing  $\Delta$  with the coproduct

$$\Delta_{\searrow}: \mathbb{T}_X \longrightarrow (\mathbb{T} \otimes \mathbb{T})_X = \bigoplus_{Y \sqcup Z = X} \mathbb{T}_Y \otimes \mathbb{T}_Z$$

$$\mathfrak{T} \longmapsto \sum_{Y \in \mathfrak{T}} \mathfrak{T}_{|Y} \otimes \mathfrak{T}_{|X \setminus Y}.$$

Where  $Y \in \mathcal{T}$ , stands for

- $Y \in \mathcal{T}$ .
- $\mathfrak{T}_{|Y} = \mathfrak{T}_1...\mathfrak{T}_n$ , such that for all  $i \in \{1, ..., n\}$ ,  $\mathfrak{T}_i$  is connected and  $(\min \mathfrak{T}_i = (\min \mathfrak{T}) \cap \mathfrak{T}_i$ , or there is a single common ancestor  $x_i \in \overline{X \setminus Y}$  to  $\min \mathfrak{T}_i$ ), where  $\overline{X \setminus Y} = (X \setminus Y) / \sim_{\mathfrak{T}_{|X \setminus Y}}$ .

If we apply the functor  $\overline{\mathbb{K}}$ , we therefore two commutative graded connected Hopf algebras  $\overline{\mathbb{K}}(\mathbb{T}, m, \Delta)$  and  $\overline{\mathbb{K}}(\mathbb{T}, m, \Delta)$ .

**Definition 2.1.** [8, 16] A left pre-Lie algebra over a field k is a k-vector space A with a binary composition  $\triangleright$  that satisfies the left pre-Lie identity:

$$(2.2) (x \triangleright y) \triangleright z - x \triangleright (y \triangleright z) = (y \triangleright x) \triangleright z - y \triangleright (x \triangleright z),$$

for all  $x, y, z \in A$ . The left pre-Lie identity rewrites as:

(2.3) 
$$L_{[x,y]} = [L_x, L_y],$$

where  $L_x: A \longrightarrow A$  is defined by  $L_xy = x \triangleright y$ , and where the bracket on the left-hand side is defined by  $[x, y] = x \triangleright y - y \triangleright x$ . As a consequence this bracket satisfies the Jacobi identity.

In fact, as mentioned in [3], the structure  $\searrow$  on the species of connected finite topological spaces  $\mathbb{V}$  defined by: for all  $\mathcal{T}_1 = (X_1, \leq_{\mathcal{T}_1})$  and  $\mathcal{T}_2 = (X_2, \leq_{\mathcal{T}_2})$  two finite connected topological spaces as:

$$\mathfrak{I}_1 \searrow \mathfrak{I}_2 = \sum_{v \in X_2} \mathfrak{I}_1 \searrow_v \mathfrak{I}_2,$$

is a pre-Lie structure, where  $\mathcal{T}_1 \searrow_{\nu} \mathcal{T}_2$  is obtained from the Hasse graphs  $G_1$  and  $G_2$  of  $\mathcal{T}_1$  and  $\mathcal{T}_2$  by adding an (oriented) edge from  $\nu$  in  $G_2$  to any minimal vertex of  $G_1$ .

We denote by  $\mathbb{P}$  the sub-species of  $\mathbb{T}$  consisting in partial order (i.e.,  $T_0$ -topologies). The binary product m (resp.  $\searrow$ ) restricts to finite posets (resp. finite connected posets), as well as both coproducts  $\Delta$  (resp.  $\Delta_{\searrow}$ ). Hence the triple  $(\mathbb{P}, m, \Delta)$  is a twisted Hopf subalgebra of  $(\mathbb{T}, m, \Delta)$ , the triple  $(\mathbb{P}, m, \Delta_{\searrow})$  is a twisted Hopf subalgebra of  $(\mathbb{T}, m, \Delta_{\searrow})$  and  $(\mathbb{P}, \searrow)$  is a twisted pre-Lie subalgebra of  $(\mathbb{T}, \searrow)$ .

# 3. Free Pre-Lie algebras and cofree coalgebras

3.1. Free pre-Lie algebras and rooted trees. Let T be the vector space spanned by the set of isomorphism classes of rooted trees and H = S(T). Grafting pre-Lie algebras of rooted trees were studied for the first time by F. Chapoton and M. Livernet [10], although the use of rooted trees can be traced back to A. Cayley [5]. The grafting product is given, for all  $t, s \in T$ , by:

$$(3.1) t \to s = \sum_{s' \text{ vertex of } s} t \to_{s'} s,$$

where  $t \to_{s'} s$  is the tree obtained by grafting the root of t on the vertex s' of s. In other words, the operation  $t \to s$  consists of grafting the root of t on every vertex of s and summing up.

We note T(n) the linear span of rooted trees of degree n. For a vector space V, we denote by T(V) the space  $\bigoplus T(n) \otimes V^{\otimes n}/S_n$ . This is the linear span of rooted trees decorated by a basis

of V. Here  $S_n$  is the symmetric group on n elements. Following the notation of Connes and Kreimer [6], any tree t writes  $t := B(v, t_1, t_2, ..., t_n)$  that is decorated by v, and  $t_1, ..., t_n$  are trees.

We notice that, if using the pre-Lie product  $\rightarrow$  in T(V), one has:

$$B(v, t_1, ..., t_n) = t_n \rightarrow B(v, t_1, ..., t_{n-1}) - \sum_{0 < k < n} B(v, t_1, ..., t_n \rightarrow t_k, ..., t_{n-1})$$

**Proposition 3.1.** [10] Equipped by  $\rightarrow$ , the space T is the free pre-Lie algebra with one generator.

**Proposition 3.2.** [15] Let V be a vector space. Then, T(V) together with the coproduct

$$\delta(B(v,t_1,t_2,...,t_n)) = \sum_{0 < k < n+1} t_k \otimes B(v,t_1,...,\hat{t}_k,...,t_n),$$

is the cofree NAP connected coalgebra generated by V.

- 3.2. **Twisted NAP algebras of finite connected posets.** Let P be a finite connected poset, and I be a subset of P. We denote by  $I_-$  the set  $\{x \notin I, \text{ there exists } y \in I \text{ such as } x \leq_P y\}$ . We note  $I \otimes P$  whenever:
  - I<sub>\_</sub> is a singleton included in min(P),
  - and *I* is a connected component of the set  $\{x \in P, I_- <_P x\}$ .

**Lemma 3.1.** For any finite connected poset P, and any subsets I, J of P, we have:

- 1- if  $I \otimes P$  and  $J \otimes P$ , then I = J or  $I \cap J = \emptyset$ .
- 2- If  $I \otimes P$ , then  $min(P \setminus I) = min(P)$ .
- 3- *If*  $I \otimes P$ , then  $P \setminus I$  is a connected poset.
- *Proof.* 1- Let P be a finite connected poset and I, J two subsets of P, such that  $I, J \odot P$ . So, we have two possible cases: either  $I_- \neq J_-$  or  $I_- = J_-$ .
- If  $I_- \neq J_-$ , with  $I_- = \{y\}$ , and  $J_- = \{z\}$ , then I is a connected component of the set  $E_1 = \{x \in P, y <_P x\}$  and J is a connected component of the set  $E_2 = \{x \in P, z <_P x\}$ . So I and J is a connected component of the set  $E_1 \sqcup E_2$ , then I = J or  $I \cap J = \emptyset$ . Gold  $I_- \neq J_-$ , then  $I \neq J$ . Hence  $I \cap J = \emptyset$ .
- If  $I_- = J_- = \{y\}$ , then I and J is two connected components of the set  $\{x \in P, y <_P x\}$ , then: I = J or  $I \cap J = \emptyset$ .
- 2- If there exists  $x \in \min(P) \cap I$ , then  $I_- <_P x$ , which is absurd. Thus,  $\min(P) \cap I = \emptyset$ . Then,  $\min(P \setminus I) = \min(P)$ .
- 3- If  $I \otimes P$ , then I is a connected component of the set  $E = \{x \in P, I_- <_P x\}$ . We have  $P \setminus I$  is a connected poset if and only if, for all  $x, y \in P \setminus I$  there exist  $a_1, ..., a_n \in P \setminus I$  such that  $x \Re a_1 ... \Re a_n \Re y$ , where  $\Re$  is defined by:  $t_1 \Re t_2 \iff (t_1 <_P t_2 \text{ or } t_2 <_P t_1)$ . We assume that  $x, a_1, ..., a_n, y$  is the smallest chain that connects x to y.
- If  $P \setminus I$  is not connected, there is  $k \in [n]$  such that  $a_k \in I$ . By choosing k appropriately we can also assume that  $a_{k-1}$  or  $a_{k+1}$  are not in I, then we have four possible cases:

- First case;  $a_{k-1} \leq_P a_k \leq_P a_{k+1}$ . Then this chain is not the smallest chain that connects x to y, which is absurd.
- Second case;  $a_{k-1} \ge_P a_k \ge_P a_{k+1}$ , the proof is similar.
- Third case;  $a_{k-1} \ge_P a_k \le_P a_{k+1}$ . Since  $a_k \in I$ , then  $I_- <_P a_k$ . Moreover  $<_P$  is transitive, then  $I_{-} <_{P} a_{k-1}$ , so  $a_{k-1} \in E$ . Then we obtained:  $(a_{k-1}, a_k) \in E \times I$ , I is a connected component of E and  $a_k <_P a_{k-1}$ . Hence  $a_{k-1} \in I$ , and similarly  $a_{k+1} \in I$ . Then  $a_{k-1} \in I$  and  $a_{k+1} \in I$ , which is in contradiction with the assumptions.
- Fourth case;  $a_{k-1} \leq_P a_k \geq_P a_{k+1}$ . In this case we have  $a_{k-1} \in I_-$  and  $a_{k+1} \in I_-$ , so  $a_{k-1} = a_{k+1}$ . Then this chain is not the smallest chain that connects x to y, which is absurd.

Hence,  $P \setminus I$  is a connected poset.

**Definition 3.1.** The bilinear product  $\bigcirc$  is defined in the species of finite connected posets  $\mathbb{U}$  as follows: for all  $P \in \mathbb{U}_{X_1}$  and  $Q \in \mathbb{U}_{X_2}$ , where  $X_1$  and  $X_2$  are two finite sets:

$$P \bigcirc \rightarrow Q = \sum_{v \in min(Q)} P \searrow_v Q.$$

**Proposition 3.3.** The bilinear product  $\bigcirc$  endows the species  $\mathbb{U}$  with a twisted NAP algebra structure i.e., the following identity is verified:

$$P \bigcirc \rightarrow (O \bigcirc \rightarrow R) = O \bigcirc \rightarrow (P \bigcirc \rightarrow R)$$

for any three finite connected posets P, Q and R.

*Proof.* Let P, Q and R be three finite connected posets, we have:

$$P \hookrightarrow (Q \hookrightarrow R) = \sum_{\nu \in \min(R)} P \hookrightarrow (Q \searrow_{\nu} R)$$

$$= \sum_{u \in \min(Q \searrow_{\nu} R)} \sum_{\nu \in \min(R)} P \searrow_{u} (Q \searrow_{\nu} R),$$

and since  $\min(Q \searrow_{v} R) = \min(R)$ , for all  $v \in \min(R)$  then:

$$P \hookrightarrow (Q \hookrightarrow R) = \sum_{v, u \in \min(R)} P \searrow_u (Q \searrow_v R),$$

Which is symmetric on P and Q. Correspondingly, we obtain:

$$P \bigcirc \rightarrow (Q \bigcirc \rightarrow R) = Q \bigcirc \rightarrow (P \bigcirc \rightarrow R).$$

**Corollary 3.1.** [2, Chapter 17] Applying the functor  $\overline{\mathbb{K}}$  gives that  $(\overline{\mathbb{K}}(\mathbb{U}), \bigcirc \rightarrow)$  is a NAP algebra.

**Definition 3.2.** [15] Let  $(V, \delta)$  be a coalgebra, i.e. be a vector space V together with linear map  $\delta: V \longrightarrow V \otimes V$ . The following defines a filtration on V:

• 
$$Prim(V) = V_1 = \{x \in V, \delta(x) = 0\}$$

• 
$$Prim(V) = V_1 = \{x \in V, \delta(x) = 0\},$$
  
•  $V_n = \{x \in V, \delta(x) \in \bigoplus_{0 < k < n} V_k \otimes V_{n-k}\}.$ 

The coalgebra  $(V, \delta)$  is said to be connected if  $V = \bigcup_{k \geq 0} V_k$ .

**Proposition 3.4.** The coproduct  $\delta : \mathbb{U} \longrightarrow \mathbb{U} \otimes \mathbb{U}$  defined for any finite set X by

$$\delta: \mathbb{U}_X \longrightarrow (\mathbb{U} \otimes \mathbb{U})_X = \bigoplus_{Y \sqcup Z = X} \mathbb{U}_Y \otimes \mathbb{U}_Z$$

$$P \longmapsto \frac{1}{|min(P)|} \sum_{I \in P} I \otimes P \backslash I,$$

is a twisted connected NAP coproduct, i.e. the following identity is verified

$$(Id \otimes \delta)\delta = \tau^{12}(Id \otimes \delta)\delta,$$

where  $\tau^{12} = \tau \otimes Id$ ,  $\tau$  is the flip.

*Proof.* Let *P* be a finite connected poset. We have

$$(Id \otimes \delta)\delta(P) = \frac{1}{|min(P)|} \sum_{I \otimes P} I \otimes \delta(P \setminus I)$$

$$= \frac{1}{|min(P)|} \sum_{\substack{I \otimes P \\ J \otimes P \setminus I}} \frac{1}{|min(P \setminus I)|} I \otimes J \otimes ((P \setminus I) \setminus J)$$

$$= \frac{1}{|min(P)|^2} \sum_{\substack{I, J \otimes P \\ I \cap J = \emptyset}} I \otimes J \otimes (P \setminus (I \sqcup J))$$

$$= \tau^{12} (Id \otimes \delta)\delta(P).$$

By the Definition 2.6 in [15] and the definition of the coproduct  $\delta$ , it is clear that the coalgebra  $(\mathbb{U}, \delta)$  is connected. Hence,  $(\mathbb{U}, \delta)$  is a twisted connected NAP coalgebra.

Example 3.1. 
$$\delta(\wedge) = 0$$
 
$$\delta(\vee) = 2 \cdot \otimes \mathbb{I}$$
 
$$\delta(\wedge) = \frac{1}{2} \cdot \otimes \wedge$$
 
$$\delta(\wedge) = 2 \cdot \otimes \mathbb{I}$$

**Corollary 3.2.** [2, Chapter 17] Applying the functor  $\overline{\mathbb{X}}$  gives that  $(\overline{\mathbb{X}}(\mathbb{U}), \delta)$  is a NAP coalgebra.

3.3. Free twisted pre-Lie algebras of finite posets. In this subsection, we prove the compatibility relation [15, Theorem] between the pre-Lie product  $\searrow$  and the NAP coproduct  $\delta$ .

**Theorem 3.1.** Let P, Q be two finite connected posets. We have the following identity

$$\delta(P \setminus Q) = P \otimes Q + (P \otimes 1 + 1 \otimes P) \setminus \delta(Q),$$

where the unit 1 is identified to the empty poset.

*Proof.* Let  $P = (X_1, \leq_P)$ ,  $Q = (X_2, \leq_Q)$  be two finite connected posets, we have:

$$\delta(P \searrow Q) = \sum_{v \in X_2} \delta(P \searrow_v Q)$$

$$= \sum_{\substack{v \in X_2 \\ I \otimes (P \searrow_v Q)}} \frac{1}{|min(P \searrow_v Q)|} I \otimes ((P \searrow_v Q) \backslash I)$$

$$= \sum_{\substack{v \in X_2 \\ I \otimes (P \searrow_v Q)}} \frac{1}{|min(Q)|} I \otimes ((P \searrow_v Q) \backslash I)$$

$$= \frac{1}{|min(Q)|} \left( \sum_{\substack{v \in X_2, v \in min(Q) \\ I \otimes (P \searrow_v Q)}} I \otimes ((P \searrow_v Q) \backslash I) + \sum_{\substack{v \in X_2, v \notin min(Q) \\ I \otimes (P \searrow_v Q)}} I \otimes ((P \searrow_v Q) \backslash I) \right),$$

we notice that

- if  $v \in \min(Q)$ , then  $\{I, I \otimes (P \searrow_{v} Q)\} = \{P\} \cup \{I, I \otimes Q\}$ , and

- if  $v \notin \min(Q)$ , then  $\{I, I \circledcirc (P \searrow_v Q)\} = \{P \searrow_v J, J \circledcirc Q, v \in J\} \cup \{J, J \circledcirc Q, v \notin J\}$ . Then

$$\delta(P \searrow Q) = \frac{1}{|min(Q)|} \left( \sum_{v \in X_2, v \in min(Q)} P \otimes Q + \sum_{v \in X_2, v \in min(Q)} I \otimes (P \searrow_v (Q \backslash I)) \right) + \frac{1}{|min(Q)|} \left( \sum_{v \in X_2, v \notin min(Q) \atop J \otimes Q, v \in J} (P \searrow_v J) \otimes Q \backslash J + \sum_{v \in X_2, v \notin min(Q) \atop J \otimes Q, v \notin J} J \otimes (P \searrow_v (Q \backslash J)) \right),$$

we notice that

$$\sum_{\substack{v \in X_2, \, v \not\in \min(Q) \\ J \otimes Q, \, v \in J}} (P \searrow_v J) \otimes Q \backslash J = \sum_{J \otimes Q} (P \otimes \mathbf{1}) \searrow (J \otimes Q \backslash J),$$

and

$$\sum_{\substack{v \in X_2, \, v \notin \min(Q) \\ J \otimes Q, \, v \notin J}} J \otimes (P \searrow_v (Q \backslash J)) = \sum_{\substack{v \in X_2, \, v \notin \min(Q) \\ J \otimes Q}} J \otimes (P \searrow_v (Q \backslash J)),$$

then

$$\sum_{\substack{\nu \in X_2, \nu \in \min(Q) \\ I \otimes Q}} I \otimes (P \searrow_{\nu} (Q \backslash I)) + \sum_{\substack{\nu \in X_2, \nu \notin \min(Q) \\ J \otimes Q, \nu \notin J}} J \otimes (P \searrow_{\nu} (Q \backslash J)) = \sum_{\substack{J \otimes Q}} (\mathbf{1} \otimes P) \searrow (J \otimes Q \backslash J),$$

accordingly

$$\delta(P \searrow Q) = \frac{1}{|min(Q)|} \left( \sum_{v \in X_2, v \in min(Q)} P \otimes Q + \sum_{J \otimes Q} (P \otimes \mathbf{1}) \searrow (J \otimes Q \backslash J) + \sum_{J \otimes Q} (\mathbf{1} \otimes P) \searrow (J \otimes Q \backslash J) \right).$$

Hence,

$$\delta(P \searrow Q) = P \otimes Q + (P \otimes \mathbf{1}) \searrow \delta(Q) + (\mathbf{1} \otimes P) \searrow \delta(Q).$$

**Corollary 3.3.** Applying the functor  $\overline{\mathbb{K}}$  gives that,  $(\overline{\mathbb{K}}(\mathbb{U}), \searrow)$  endowed with the coproduct  $\delta$  is a free pre-Lie algebra and a cofree NAP coalgebra.

*Proof.* This is a direct consequence of Theorem 3.1 and M. Livernet's rigidity theorem [15, Theorem].

**Corollary 3.4.**  $\overline{\mathbb{X}}(\mathbb{U})$  is generated as a pre-Lie algebra by  $Prim(\overline{\mathbb{X}}(\mathbb{U}))$ .

*Proof.* Let  $\overline{\mathcal{K}}(\mathbb{U})_1 = \operatorname{Prim}(\overline{\mathcal{K}}(\mathbb{U})) = \{P \in \overline{\mathcal{K}}(\mathbb{U}), \delta(P) = 0\}$ , and let  $\overline{\mathcal{K}}(\mathbb{U})_n = \{P \in \overline{\mathcal{K}}(\mathbb{U}), \delta(P) \in \sum_{0 < k < n} \overline{\mathcal{K}}(\mathbb{U})_k \otimes \overline{\mathcal{K}}(\mathbb{U})_{n-k}\}$ , we notice that  $\overline{\mathcal{K}}(\mathbb{U}) = \bigcup_{k > 0} \overline{\mathcal{K}}(\mathbb{U})_k$ , i.e. the vector space  $(\overline{\mathcal{K}}(\mathbb{U}), \delta)$  is connected. By appling Corollary 3.9 in [15], we obtain that  $\overline{\mathcal{K}}(\mathbb{U})$  is generated as a pre-Lie algebra by  $\operatorname{Prim}(\overline{\mathcal{K}}(\mathbb{U}))$ .

**Example 3.2.** Here are the posets in  $Prim(\overline{\mathfrak{X}}(\mathbb{U}))$  up to four vertices:

3.4. **Duality relation between**  $\bigcirc \rightarrow$  **and**  $\delta$ **.** In this subsection, we prove that the NAP product  $\bigcirc \rightarrow$  and the NAP coproduct  $\delta$  are dual to each other modulo a symmetry factor.

**Definition 3.3.** Let G be a group acting on X. For every  $x \in X$ :

- we denote by  $G \cdot x := \{g \cdot x, g \in G\}$  the orbit of x,
- we denote by  $G_x = \{g \in G, g \cdot x = x\}$  the stabilizer subgroup of G with respect to x.

**Proposition 3.5.** Let G be a group acting on X, if G and X is finite, then the orbit-stabilizer theorem, together with Lagrange's theorem [19, Theorem 3.9], gives:

$$|G \cdot x| = [G_x : G] = \frac{|G|}{|G_x|}.$$

In particular, the cardinal of the orbit is a divisor of the group order.

**Definition 3.4.** For any poset P on a finite set X, we denote by Aut(P) the subgroup of permutations of X which are homeomorphisms with respect to P. The symmetry factor is defined by  $\sigma(P) = |Aut(P)|$ . Let  $X_1, X_2$  two finite sets, we define the linear map  $\langle , \rangle : \mathbb{U}_{X_1} \otimes \mathbb{U}_{X_2} \longrightarrow \mathbb{K}$  by:

$$\langle Q, R \rangle = \begin{cases} \sigma(Q) \text{ if } Q \approx R, \\ 0 \text{ otherwise.} \end{cases}$$

*In other terms,*  $\langle Q, R \rangle$  *is the number of isomorphisms between Q and R.* 

**Theorem 3.2.** Let P, Q and R three finite connected posets. We have the following identity

$$\langle \delta(P), Q \otimes R \rangle = \frac{1}{|min(P)|} \langle P, Q \hookrightarrow R \rangle.$$

*Proof.* Let P, Q and R three finite connected posets.

$$\langle \delta(P), Q \otimes R \rangle = \frac{1}{|\min(P)|} \sum_{\substack{I \otimes P \\ I \approx Q \\ P \setminus I \approx R}} \sigma(Q) \sigma(R) = \frac{1}{|\min(P)|} |A|$$

with

$$A = \{(I, \sigma_1, \sigma_2) \mid I \circledcirc P, \ \sigma_1 : I \overset{\sim}{\longrightarrow} Q, \sigma_2 : P \setminus I \overset{\sim}{\longrightarrow} R\}$$

and:

$$\langle P, Q \bigcirc \to R \rangle = \sum_{\substack{v \in \min(R) \\ O \searrow R \approx P}} \sigma(P) = |B|$$

with

$$B = \{(v, \sigma) \mid v \in \min(R), \ \sigma : P \xrightarrow{\sim} Q \searrow_{v} R\}.$$

Let us define now a map  $\phi: A \longrightarrow B$ . Let  $(I, \sigma_1, \sigma_2) \in A$ . We put  $w = I_-$ . As  $I \otimes P$ ,  $w \in \min(P \setminus I)$ , so  $v = \sigma_2(w) \in \min(R)$ . As  $I \otimes P$ ,  $P = I \setminus_w (P \setminus I)$ , so we obtain an isomorphism  $\sigma: P \longrightarrow Q \setminus_v R$  by taking

$$\sigma(x) = \begin{cases} \sigma_1(x) \text{ if } x \in I, \\ \sigma_2(x) \text{ otherwise.} \end{cases}$$

We then put  $\phi(I, \sigma_1, \sigma_2) = (v, \sigma)$ .

Now, we define a map  $\psi : B \longrightarrow A$ . If  $(v, \sigma) \in B$ , we put  $I = \sigma^{-1}(Q)$ . As  $Q \otimes Q \searrow_{v} R$ ,  $I \otimes P$ . Moreover,  $\sigma_{1} = \sigma_{|I|}$  is a graph isomorphism from I to Q and  $\sigma_{2} = \sigma_{|P\setminus I}$  is a graph isomorphism from  $P \setminus I$  to R. We put  $\psi(v, \sigma) = (I, \sigma_{1}, \sigma_{2})$ .

Let  $(v, \sigma) \in B$ . We put  $\psi(v, \sigma) = (I, \sigma_1, \sigma_2)$  and  $\phi \circ \psi(v, \sigma) = (v', \sigma')$ . Then,  $I = \sigma^{-1}(Q)$  and  $w' = I_- = w$ , so  $v' = \sigma(w) = v$ . Moreover,

$$\sigma'_{|I} = \sigma_1 = \sigma_{|I},$$
 $\sigma'_{|P\setminus I} = \sigma_2 = \sigma_{|P\setminus I},$ 

so  $\sigma' = \sigma$ . Hence,  $\phi \circ \psi = \mathrm{id}_B$ .

Let  $(I, \sigma_1, \sigma_2) \in A$ . We put  $\phi(I, \sigma_1, \sigma_2) = (v, \sigma)$  and  $\psi \circ \phi(I, \sigma_1, \sigma_2) = (I', \sigma'_1, \sigma'_2)$ . Then  $I' = \sigma^{-1}(Q) = I$ , by construction of  $\sigma$ . Even more,

$$\sigma'_1 = \sigma_{|I} = \sigma_1,$$
  
$$\sigma'_2 = \sigma_{|P\setminus I} = \sigma_2.$$

So  $\psi \circ \phi = \mathrm{id}_A$ . Finally, A and B are in bijection and we obtain:

$$\langle \delta(P), Q \otimes R \rangle = \frac{1}{|\min(P)|} \langle P, Q \hookrightarrow R \rangle.$$

**Remark 3.1.** As mentioned in the paper [3], the binary product  $\nearrow$  on the species  $\mathbb{U}$  of finite connected posets, defined by  $P \nearrow Q := j(j(P) \searrow j(Q))$  for any pair (P,Q) of finite connected posets, is a pre-Lie product, where j is the involution which transforms  $\leq$  into  $\geq$ . Similarly,

$$P \odot \rightarrow Q := j(j(P) \odot \rightarrow j(Q)), \qquad (\textit{resp.} \quad \tilde{\delta} = (j \otimes j)\delta \circ j)$$

endows the species  $\mathbb{U}$  with a twisted NAP algebra (resp. twisted connected NAP coalgebra) structure.

**Notation.** Let *E* be any finite set, and let  $\pi, \rho$  be two partitions of *E*. We denote by  $j(\pi, \rho)$  the rational number

$$j(\pi, \rho) := \frac{1}{|E|} \sum_{\substack{\alpha \text{ is a block of } \pi \\ \beta \text{ is a block of } \rho}} |\alpha \cap \beta| \frac{|\beta|}{|\alpha|}.$$

**Proposition 3.6.** Let P, Q and R three finite connected posets. We denote by  $E = \{v, v \in min(R) \mid P \approx Q \searrow_v R\}$ . Let  $\pi$  be the partition of E into Aut(P)-orbits, and let  $\rho$  be the partition of E into Aut(R)-orbits. We have the following identity

$$j(\pi, \rho) = 1.$$

*Proof.* Let P, Q and R be three finite connected posets. In fact: firstly,

$$\langle P, Q \bigcirc R \rangle = \sum_{v \in \min(R)} \langle P, Q \searrow_v R \rangle$$

$$= \sum_{\substack{v \in \min(R) \\ P \approx Q \searrow_v R}} \sigma(P)$$

$$= \sigma(P)|E|.$$

On the other hand

$$\langle \delta(P), Q \otimes R \rangle = \frac{1}{|\min(P)|} \sum_{\substack{I \otimes P \\ I \approx Q, P \setminus I \approx R}} \langle I, Q \rangle \langle P \setminus I, R \rangle$$

$$= \frac{1}{|\min(P)|} \sum_{\substack{I \otimes P \\ I \approx Q, P \setminus I \approx R}} \sigma(Q) \sigma(R)$$

$$= \frac{1}{|\min(R)|} \sum_{\substack{I \otimes P \\ I \approx Q, P \setminus I \approx R}} \sigma(Q) \sigma(R)$$

$$= \frac{1}{|\min(R)|} \sum_{\substack{V \in \min(R) \\ I \approx Q, P \setminus I \approx R}} \sum_{I \otimes P, I_{-} = \{v\} \\ I \approx Q, P \setminus I \approx R}} \sigma(Q) \sigma(R)$$

$$= \frac{1}{|\min(R)|} \sum_{\substack{V \in \min(R) \\ V \in \min(R)}} N_{V}(P, Q, R) \sigma(Q) \sigma(R),$$

where  $N_{\nu}(P,Q,R)$  := the number of branches I of P above  $\nu$  isomorphic to Q such that  $P \setminus I$  isomorphic to R.

We notice that, for all  $v \in min(R)$ :

- if  $P \not\approx Q \searrow_{V} R$ , then  $N_{V}(P, Q, R) = 0$ ,
- if  $P \approx Q \searrow_{v} R$ , then  $N_{v}(P, Q, R) = N_{v}(Q, R) :=$  the number of branches of  $Q \searrow_{v} R$  above v isomorphic to Q.

Accordingly

$$\begin{split} \langle \delta(P), Q \otimes R \rangle &= \frac{1}{|min(R)|} \Big( \sum_{\substack{\nu \in \min(R) \\ P \approx Q \searrow_{\nu} R}} N_{\nu}(P, Q, R) \sigma(Q) \sigma(R) + \sum_{\substack{\nu \in \min(R) \\ P \neq Q \searrow_{\nu} R}} N_{\nu}(P, Q, R) \sigma(Q) \sigma(R) \Big) \\ &= \frac{1}{|min(R)|} \sum_{\substack{\nu \in \min(R) \\ P \approx Q \searrow_{\nu} R}} N_{\nu}(P, Q, R) \sigma(Q) \sigma(R) \\ &= \frac{1}{|min(R)|} \sum_{\substack{\nu \in \min(R) \\ P \approx Q \searrow_{\nu} R}} N_{\nu}(Q, R) \sigma(Q) \sigma(R). \end{split}$$

By using the orbit-stabilizer theorem, as well as Lagrange's theorem for the group  $(Aut(R), \circ)$  endowed with the law of composition, we therefore have:

$$|Aut(R) \cdot v| = \frac{|Aut(R)|}{|Aut(R)_v|}, \quad i.e. \quad |Aut(R) \cdot v| = \frac{\sigma(R)}{\sigma_v(R)}.$$

We notice that, for all  $v \in \min(R)$ :  $\sigma_v(Q \searrow_v R) = \sigma(Q)\sigma_v(R)N_v(Q, R)$ . Then

$$\langle \delta(P), Q \otimes R \rangle = \frac{1}{|min(R)|} \sum_{v \in E} \sigma(Q) \sigma_v(R) |Aut(R) \cdot v| N_v(Q, R)$$

$$= \frac{1}{|min(R)|} \sum_{v \in E} \sigma_v(P) |Aut(R) \cdot v|$$

$$= \frac{1}{|min(R)|} \sum_{v \in E} \sigma(P) \frac{|Aut(R) \cdot v|}{|Aut(P) \cdot v|}$$

$$= \frac{1}{|min(R)|} \sigma(P) S,$$

where

$$S = \sum_{v \in F} \frac{|Aut(R) \cdot v|}{|Aut(P) \cdot v|}.$$

Let  $\pi$  be the partition of E into Aut(P)-orbits, and let  $\rho$  be the partition of E into Aut(R)-orbits. We denote by  $\alpha \in \pi$  (respectively,  $\beta \in \rho$ ), if  $\alpha$  is a block of  $\pi$  (respectively, if  $\beta$  is a block of  $\rho$ ). So

$$S = \sum_{v \in E} \frac{|Aut(R) \cdot v|}{|Aut(P) \cdot v|}$$

$$= \sum_{v \in E} \sum_{\substack{\alpha \text{ is a Aut(P)-orbit of } v \\ \beta \text{ is a Aut(R)-orbit of } v}} \frac{|\beta|}{|\alpha|}$$

$$= \sum_{\substack{\alpha \text{ is a Aut(P)-orbit} \\ \beta \text{ is a Aut(R)-orbit}}} |\alpha \cap \beta| \frac{|\beta|}{|\alpha|}$$

$$= j(\pi, \rho),$$

then  $\langle \delta(P), Q \otimes R \rangle = \frac{1}{|\min(R)|} \sigma(P) j(\pi, \rho)$ . Correspondingly,

$$\langle \delta(P), Q \otimes R \rangle = \langle P, Q \bigcirc R \rangle \frac{j_{P,R}(\pi, \rho)}{|\min(P)|}.$$

By appling Theorem 3.2, we obtain:

$$\langle \delta(P), Q \otimes R \rangle = \frac{1}{|min(P)|} \langle P, Q \hookrightarrow R \rangle = \langle P, Q \hookrightarrow R \rangle \frac{j(\pi, \rho)}{|min(P)|}.$$

Conclusion: for P, Q and R three finite connected posets, if we denote by  $E = \{v, v \in min(R) \mid P \approx Q \searrow_v R\}$ , and for  $\pi$  (resp.  $\rho$ ) the partition of E into Aut(P)-orbits (resp. the partition of E into Aut(R)-orbits). Then we obtain

$$j(\pi, \rho) = 1.$$

**Remark 3.2.** We do not have  $j(\pi, \rho) = 1$  in general for two partitions of a finite set E. Indeed: let E be the finite set  $\{1, 2, 3, 4\}$ ,  $\pi = \{\{1, 2\}, \{3, 4\}\}$  and  $\rho = \{\{1, 2, 3\}, \{4\}\}$ . Then we obtain  $j(\pi, \rho) = \frac{5}{4}$  and  $j(\rho, \pi) = 1$ . This interesting index does not seem to be present in the literature.

3.5. **Free Lie algebras of finite posets.** F. Chapoton in [7] showed that free pre-Lie algebras are free as Lie algebras i.e., if  $(V, \triangleright)$  is a free pre-Lie algebra. Then it is a free Lie algebra for the Lie bracket [,] defined by  $[a, b] = a \triangleright b - b \triangleright a$ . This result has been obtained before with different methods by L. Foissy [13, Theorem 8.4].

**Proposition 3.7.** [7, 13] For any vector space V, the free pre-Lie algebra on V is isomorphic as a Lie algebra to the free Lie algebra on some set X(V) of generators.

**Application** [17] Let H be a Hopf algebra and  $H^0$  the graded dual of H. The primitive element algebra of the graded dual  $H^0$  with the bracket [,] is a Lie algebra. We denote by  $\star$  the Grossman-Larson product on the dual of H [3]. This product restricted to  $H^0$  is the graded dual of the coproduct  $\Delta_{\searrow}$  [3]. Applying the general setting above to the case  $H = \overline{\mathcal{K}}(\mathbb{P})$  we are studying, we obtain:

 $(\overline{\mathcal{K}}(\mathbb{U}), \searrow) = (Prim(H^0), \searrow)$  is a free pre-Lie algebra, then it is also a free Lie algebra, therefore  $U(PrimH^0) = (S(PrimH^0), \star)$  is a free associative algebra. Then,  $(S(PrimH^0), \star)^0 = (H, \Delta_{\searrow})$  is a coassociative cofree coalgebra.

## 4. Generalization to finite topological spaces

All the results in this paper remain true for the finite connected topological spaces, with a small change on the definition of the coproduct  $\delta$ . Indeed: let  $\Im = (X, \leq_{\Im})$  be a finite connected topological space. We define

$$\delta(\mathfrak{T}) = \frac{1}{|min(\mathfrak{T})|} \sum_{Y \in \mathfrak{T}} \mathfrak{T}_{|Y} \otimes \mathfrak{T}_{|X \setminus Y},$$

where  $Y \otimes \mathcal{T}$  means that  $Y \in \mathcal{T}$  such that:

- $\overline{Y}_{-}$  is a singleton included in min( $\overline{\mathfrak{T}}$ ),
- and Y is a branch of the set  $\{x \in X, \text{ such that for all } y \in Y_-, \text{ we have } y <_{\mathfrak{T}} x \text{ and } y \not\geq x\}.$

Here, the set  $Y_-$  equal to the space  $\{x \notin Y, \text{ there exists } y \in Y \text{ such that } x \leq y\}$ ,  $\overline{\mathcal{T}} = (X/\sim_{\mathcal{T}}, \leq)$  is the poset defined on  $X/\sim_{\mathcal{T}}$  corresponding to the partial order  $\leq$  induced by the quasi-order  $\leq_{\mathcal{T}}$ , and  $\overline{Y_-} = Y_-/\sim_{\mathcal{T}_{|Y_-}}$ . Let  $\mathrm{Aut}(\mathcal{T})$  be the subgroup of permutations of X which are homeomorphisms with respect to  $\mathcal{T}$ , and let  $G = \{g \in Aut(\mathcal{T}), g \cdot \overline{v} = \overline{v} \text{ for all } v \in X\}$ . We notice that  $G \subseteq Aut(\mathcal{T}), G$  is a normal subgroup and  $Aut(\overline{\mathcal{T}}) = Aut(\mathcal{T})/G$ .

We notice that the results obtained in Lemma 3.1 also work for  $Y, Z \otimes \mathcal{T}$ . From  $Y, Z \otimes \mathcal{T}$  and Lemma 3.1, we get that both  $\overline{Y}, \overline{Z} \otimes \overline{\mathcal{T}}$ , then  $(\overline{Y} = \overline{Z} \text{ or } \overline{Y} \cap \overline{Z} = \emptyset)$ , and  $\min(\overline{\mathcal{T}}_{|X \setminus Y}) = \min(\overline{\mathcal{T}})$ . Then  $Y \cap Z = \emptyset$  and  $\min(\mathcal{T}_{|X \setminus Y}) = \min(\mathcal{T})$ .

Hence to show that the proposition 3.4 also works in topological cases, it suffices to change I,  $J \otimes P$  by Y,  $Z \otimes T$  in the proof of proposition 3.6. To show that the result of Theorem 3.1 also works in connected finite topological spaces, we change  $I \otimes P$  by  $Y \otimes T$  in the Proof 3.3.

Finally we prove the existence of a relation between  $\delta$  and  $\bigcirc$  in the topological case. Exactly: for  $\mathcal{T}, \mathcal{T}'$  and  $\mathcal{T}''$  three finite connected topological spaces, we have

$$\langle \delta(\mathfrak{T}), \mathfrak{T}' \otimes \mathfrak{T}'' \rangle = \frac{1}{n |\min(\mathfrak{T})|} \langle \mathfrak{T}, \mathfrak{T}' \circlearrowleft \mathfrak{T}'' \rangle,$$

where *n* is the number of items in any bag  $\overline{v} \in \min(\overline{\mathfrak{I}''})$ , such as  $\mathfrak{T} \approx \mathfrak{T}' \searrow_{v} \mathfrak{T}''$ . The proof is similar to the proof of Theorem 3.2. Indeed:

$$\langle \delta(\mathfrak{T}), \mathfrak{T}' \otimes \mathfrak{T}'' \rangle = \frac{1}{|\min(\mathfrak{T})|} \sum_{\substack{Y \otimes \mathfrak{T} \\ \mathfrak{T}_{|Y} \approx \mathfrak{T}', \\ \mathfrak{T}_{|Y|} \approx \mathfrak{T}''}} \sigma(\mathfrak{T}') \sigma(\mathfrak{T}'') = \frac{1}{|\min(\mathfrak{T})|} |A|$$

with

$$A = \{(Y, \sigma_1, \sigma_2) \mid Y \odot \mathcal{T}, \ \sigma_1 : \mathcal{T}_{|Y} \overset{\sim}{\longrightarrow} \mathcal{T}', \sigma_2 : \mathcal{T}_{|X \setminus Y} \overset{\sim}{\longrightarrow} \mathcal{T}''\}.$$

On the other hand

$$\begin{split} \langle \mathfrak{T}, \mathfrak{T}' & \bigcirc \rightarrow \mathfrak{T}'' \rangle = \sum_{\nu \in \min(\mathfrak{T}'')} \langle \mathfrak{T}, \mathfrak{T}' \searrow_{\nu} \mathfrak{T}'' \rangle \\ &= \sum_{\substack{\nu \in \min(\mathfrak{T}'') \\ \mathfrak{T} \approx \mathfrak{T} \searrow_{\nu} \mathfrak{T}''}} \sigma(\mathfrak{T}) = |B|, \end{split}$$

with

$$B = \{(v, \sigma) \mid v \in \min(\mathfrak{T}''), \ \sigma : \mathfrak{T} \xrightarrow{\sim} \mathfrak{T}' \searrow_{v} \mathfrak{T}''\}.$$

Let

$$C = \{(u, \sigma) \mid u = \overline{v}, v \in \min(\mathfrak{T}''), \ \sigma : \mathfrak{T} \stackrel{\sim}{\longrightarrow} \mathfrak{T}' \searrow_{v} \mathfrak{T}''\}.$$

We notice that for all  $u, u' \in C$ , we have |u| = |u'|. Hence  $\frac{|B|}{|C|}$  is the number of items in any bag  $\overline{v} \in \min(\overline{\mathfrak{T}''})$ , such as  $\mathfrak{T} \approx \mathfrak{T}' \searrow_{v} \mathfrak{T}''$ . We define

$$f: A \longrightarrow C$$
$$(Y, \sigma_1, \sigma_2) \longmapsto (u, \sigma),$$

where  $u = \overline{v} = \overline{\sigma_2(Y_-)}$  and  $\sigma$  is a graph isomorphism from  $\mathfrak{T}$  to  $\mathfrak{T}' \searrow_{v} \mathfrak{T}''$  defined by

$$\sigma(x) = \begin{cases} \sigma_1(x) \text{ if } x \in Y, \\ \sigma_2(x) \text{ otherwise.} \end{cases}$$

Now, we define a map

$$g: C \longrightarrow A$$
  
 $(u, \sigma) \longmapsto (Y, \sigma_1, \sigma_2),$ 

where  $Y = X_{\sigma^{-1}(\mathfrak{I}')}$ ,  $\sigma_1 = \sigma_{|\mathfrak{I}_{|Y}|}$  is a graph isomorphism from  $\mathfrak{T}_{|Y|}$  to  $\mathfrak{I}'$  and  $\sigma_2 = \sigma_{|\mathfrak{I}_{X\setminus Y}|}$  is a graph isomorphism from  $\mathfrak{T}_{|X\setminus Y|}$  to  $\mathfrak{I}''$ .

Let  $(u, \sigma) \in C$ , we put  $g(u, \sigma) = (Y, \sigma_1, \sigma_2)$ , where  $Y = X_{\sigma^{-1}(\mathcal{T}')}$ ,  $\sigma_1 = \sigma_{|\mathcal{T}'|}$  and  $\sigma_2 = \sigma_{|\mathcal{T}'|}$ . Then  $f \circ g(u, \sigma) = (u', \sigma')$ , with  $u' = \overline{w} = \overline{\sigma_2(Y_-)}$  and  $\sigma'$  is a graph isomorphism from  $\mathcal{T}$  to  $\mathcal{T}' \searrow_w \mathcal{T}''$  defined by

$$\sigma'(x) = \begin{cases} \sigma_1(x) \text{ if } x \in Y, \\ \sigma_2(x) \text{ otherwise.} \end{cases}$$

Then,  $u' = \overline{\sigma_2(Y_-)} = u$  and  $\sigma' = \sigma$ . Hence  $f \circ g = Id_C$ .

Let  $(Y, \sigma_1, \sigma_2) \in A$ , we put  $f(Y, \sigma_1, \sigma_2) = (u, \sigma)$ , with  $u = \overline{v} = \overline{\sigma_2(Y_-)}$  and  $\sigma$  is a graph isomorphism from  $\mathcal{T}$  to  $\mathcal{T}' \searrow_{\mathcal{V}} \mathcal{T}''$  defined by

$$\sigma(x) = \begin{cases} \sigma_1(x) \text{ if } x \in Y, \\ \sigma_2(x) \text{ otherwise.} \end{cases}$$

Then,  $g \circ f(Y, \sigma_1, \sigma_2) = (Y', \sigma_1', \sigma_2')$ , with  $Y' = X_{\sigma^{-1}(\mathfrak{I}')}$ ,  $\sigma_1' = \sigma_{|\mathfrak{I}_{|Y'}}$  is a graph isomorphism from  $\mathfrak{T}_{|Y'}$  to  $\mathfrak{T}'$  and  $\sigma_2' = \sigma_{|\mathfrak{I}_{|X\setminus Y'}}$  is a graph isomorphism from  $\mathfrak{T}_{|X\setminus Y'}$  to  $\mathfrak{T}''$ . Then,  $Y' = X_{\sigma^{-1}(\mathfrak{I}')} = Y$  and

$$\begin{cases} \sigma_{1}^{'} = \sigma_{|\mathfrak{I}_{|Y'}} = \sigma_{1}, \\ \sigma_{2}^{'} = \sigma_{|\mathfrak{I}_{|X\setminus Y'}} = \sigma_{2}. \end{cases}$$

So  $g \circ f = Id_A$ .

Finally, A and C are in bijection. Hence

$$\langle \delta(\mathfrak{I}), \mathfrak{I}' \otimes \mathfrak{I}'' \rangle = \frac{1}{|\min(\mathfrak{I})|} |A| = \frac{1}{|\min(\mathfrak{I})|} |C| = \frac{1}{|\min(\mathfrak{I})|} |C| \frac{|B|}{|B|} = \frac{|C|}{|B||\min(\mathfrak{I})|} \langle \mathfrak{I}, \mathfrak{I}' \circlearrowleft \mathfrak{I}'' \rangle.$$

**Remark.** All the results in this paper remain true for the posets (resp. topological spaces) decorated by F, that is to say pairs (A, f), where  $A = (A, \leq_A)$  is a poset (resp. topology) and  $f : A \to F$  is a map.
